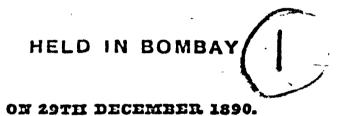
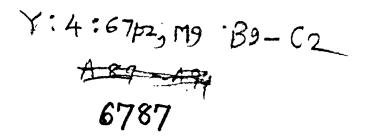

APPENDIX A.

SUMMARY OF THE REPORTS OF SOCIAL REFORM ASSOCIATIONS.

BOMBAY.

It was mentioned in the last year's report that the question of excommunicating Dr. Bhandarkar for having given in marriage his wildowed daughter was referred to the Shankaracharya of the Saraswat Brahmins. It is reported that the Shankaracharya has since excommnicated Dr. Bhandarkar, his daughter and his son-in-law. But the decision has not been accepted by a considerable portion of the community, and it has not yet been publicly announced at a caste meeting. A widow marriage was celebrated in Bombay some days ago amongst the Gujarathi community. It was also an intermarriage.

Mr. Sewaklal Karsondas, Secretary of the Arya Samaj at Bombay, reports that himself and the missionaries of the Samaj have delivered lectures at Bombay, Chinchni, Tarapur, Daman, Broach, Surat, and Bhavnagar, on different topics connected with social reform, such as seavoyage, evils of caste system, female education, and prevention of early marriages.

DHARWAR.

The Mitra Samaj and the Hindu Sammilani Sabha directed their efforts to the exposure of the custom of celebrating the festival of Kama, the god of love, and singing obscene songs before him at the time of the Shimga. One of the members read a paper in English on the subject, which was afterwards translated into Marathi and Kanarese, and the translations were distributed among the people. Mr. V. A. Maigarkar was elected a delegate to attend the Social Conference at Allahabad. Babu Dinanath Ganguli of the same place has come to take part in the Conference.

NASIK.

At Nasik the Marvadi Jains and Kayastha Prabhus held large meetings for the promotion of social reform in their respective communities.

SECUNDERABAD.

The Social Reform Association has not done much work during the year, and its Secretary, P. Ramchandra Pillay, reports that his time was chiefly taken up in collecting funds for a Public Hall, which has been recently erected in that place chiefly through his endeavours.

MATHURA.

Mr. Radha Gocharan Swami of Brindavan has published a treatise on the advantages of visiting other countries. Following the example of the Kayasthas, the Bhargavas held a Conference at Mathura in December 1892, and resolutions abolishing marriages of boys below 16 and curtailing extravagant expenditure at marriage festivaties were passed. Thakur Kishon kam presided at this Conference and he has maintained argirl school at Mathura, where English and Sanscrit are taught. Munshi Naural Kishon gave 100 Rs. as donation to the Bhargava education Fund.

BERAR.

The number of members of the Berar Social Reform Association has risen from 138 to 208 during the year, out of which 92 could only pledge themselves to marry their daughters at the age of not less than 8 years, and 57 to marry their sons at the age of not less than 15 years. Six ladies from Berar attended for the first time the National Social Conference at Nagpur. Mrs. Radhabai Mudholkar set apart 1500 Rupees for the encouragement of female education at the time of her death. Scholarships have been founded for the encouragement of female education out of the fund raised to commemorate the connexion of Sir D. FitzPatrick with the Provinces. These events show the slow but steady progress which Berar is making. At the annual meeting of the Berar Social Reform Association, held under the presidency of Bao Saheb V. M. Mahajani on 11th November 1892, Mr. D. V. Bhagwat was elected delegate for the Allahabad Social Conference.

AHMEDABAD,

At the Annual General meeting of the Ahmedabad Social Beform Association held on 25th June 1892, Rao Bahadur Lalshankar Umuashankar was appointed President, and Mr. Keshavlal Motilal, Secretary of the Association. Fourteen members joined the Association during the year. Five Hindu youths belonging to some of the leading families at Ahmedabad proceeded to England for purposes of study last year with the full consent of the caste. The preacher Shastri Nageshavar Jeshthram held public meeting at Ahmedabad, Godhra, Petlad, Palanpur, Amod, Sanand and other places, and discoursed on various topics connected with social reform. He also delivered lectures against the vice of drinking.

Rao Bahadur Lalshankar, Bao Saheb A. V. Kathavate, and Mr. Narsinh Bholanath and others meet occasionally to discuss the ways and means of promoting social reform.

The Hon'ble R. B. Ranchodlal Chotalal has set apart Rs. 12000 for the establishment of a girl school.

The Rayakwad Brahmins of Ahmedabad have started a fund for the promotion of late marriages in their community. It is intended to give prizes from the proceeds thereof to such students as remain unmarried till their seventeenth year of age.

There are 400 houses of Trevadi Mavada Brahmins at Ahmedabad, which are divided into four sects on account of differences arising between them. An Association was established to promote union and good feeling amongst the members of this caste.

The Audichya Bramhins held their annual Conference this year at Wadhwan for the promotion of social reform and education in their community. A large sum was subscribed for the latter purpose among the leaders of the community.

BAREILLY.

The Fifth Conference of the Kayastha community was held at Bareilly in the spacious compound of the local Collège in the Christmas week, 1891. It was attended by the members of the local community, and a large number of gentlemen, who had attended as delegates from outstations.

An attempt was made to record the names and addresses of the Kayastha gontlemen present at the meeting, but owing to press of numbers no more than 1726 names could be registered; and these were classified as below: viz., Oudh 45, Panjab 45, Behar 8, Central Provinces 13, Rajputana 4, Bombay 1, Agra Division and Gwalior State 47, Allahabad Division 9, Benares Division 14, Meerut Division 13, Rohilkhund Division 1518. These comprised the representatives of eleven out of the twelve Sub-Divisions of the Kayastha caste, distributed as below:--Mathur 45, Saksena 1456, Sri Vastavýa 106, Nigam 7, Aishthana 19, Bhatmigar 83, Gaur 1, Kulsharisht 2, Ambasht 5, Valimik 1; Karan 1. The Suraj Dhwajas were conspicuous by their absence, although it was reported that one of them had taken part in the processings incognilo. Bareilly and its adjacent town's are the home of

the Saksena brotherhood, and this accounted for their preponderence at this Conference. For a similar reason the third Conference at Bankipur was marked by an unusually large attendance of the Sri Vastavyas, as Behar and the Eastern portions of Upper India are their chief habitation. With the exception of the Suraj Dhwajas, who claim a superior status and whose number is very small, all the rest, in virtue of their common descent and profession. meet with one another on terms of social equality, eat public khana (food fried in butter) together, and smoke of the same narial (pipe). The younger genera. tion is eager to weld the community into one, and to do away with the distinction of public and kacha khana, the latter of which is at present restricted to members of the same sub-division. They gave definite expression to their desire by printing and circulating a collection of opinions on the subject, and by insisting on the subject being introduced into the deliberations of the Conference. And although for fear of creating dissensions in the Conference camp it was deemed inexpedient to give effect to their wishes at this stage of the development of public opinion, the discussion that followed was a fair indication of the current in which the popular thought was drifting.

Simultaneously with organizing a regular Reception Committee, the Secretary made a tour in the Rohilkhund Division to invite help and co-operation from the brotherhood. His appeals were generally successful as would appear from the subscriptions raised for the Conference Fund at the different localities visited by him. He was followed by Munshi Sankatha Prasad, the Inspector of the Kayastha Provincial Sabha, Benares, who was specially deputed by the Sadar Sabha for India as an Honorary Inspector to preach the Conference cause in Rohilkhund. The latter made an extended lecturing tour, acquainting the public with the aims and objects of the Conference movement. During these two tours upwards of ten thousand Urdu, one thousand Hindi, and one thousand English pamphlets on Conference subjects were distributed. These served to enlist general sympathy, and to secure a large attendance at the Conference.

The delegates began to arrive on the 25th December 1891, and departed by the 1st of January 1892. The Conference work commenced on the morning of the 27th December, when an Executive Oommittee of the Sadar Sabha for India was held to arrange for the Annual meeting of the Sabha the same evening. The meeting in the evening was attended by the delegates present as well as the leading Kayasthas of Bareilly. The Sadar Sabha is the exeoutive body of the Conference, and as such collects statistics to show how far effect has been given to the resolutions passed at the previous Conferences. Owing to the unavoidable absence of Rai Jayanti Prasad, Deputy Collector and President of the Sadar Sabha, Munshi Hargovind Dayal, M. A., Government Pleader at Lucknow and Founder of the Conference, presided at the meeting. The Secretary, Munshi Lakshmi Narain, Barrister-at-law at Lahore, read the Annual Report, and with it presented an interesting resume of the social reform work done in India during the year. The Report was generally approved, and a special vote of thanks was accorded to him for the trouble he had taken in preparing it. The meeting dissolved at a late hour, the chief work done by it being the passing of the Annual Report, the election of office-bearers for the next year, and the passing of the Annual Budget.

The Local and the Provincial Sabhas, as well as individual members of the community had, sometime before the sitting of the Conference, sent a large number of resolutions to be discussed at the Conference. To digest these, and to facilitate the deliberations at the Conference, it was deemed advisable to select a Subject Committee, and, as usual, one was formed out of the delegates present. It consisted of 206 gentlemen, and had to deal with one hundred and thirty one proposals. It held its sitting on the 25th December. Some forty-two proposals were considered, and out of these materials were found for the resolutions which were ultimately considered by the Conference on the 29th and 30th December.

The proceedings of the Conference proper opened with an address by Munshi Durga Prasad, Rai Bahadur, President of the Reception Committee. He touched briefly on the successful crusade made by the community against the use of intoxicating liquors on occasions of caste dinners. As to the progress which the community had made in adopting temperate habits, Munshi Baldeo Prasad, the Secretary of the Conference, said there could be no better proof of it than the one displayed in the Conference hall, viz, the avidity they had shown in pinning on to their breast the white cloth flowers intended to distinguish total abstainers from the rest of the audience. He had got only two hundred of such flowers prepared, and was glad to find that if he had indented for double the number he would still have been unable to meet the demand made for them. Babu Gajadhar Prasad Ambasht, Pleader, Land Owner and Municipal Commissioner of Bankipur, was, on the motion of Mr. Roshan Lal, B. A., Barrister-at-Law at Allahabad, seconded by Munshi Raghunandan Prasad, B. A., Vakil and Municipal Commissioner at Benares, unanimously elected President,

The President paid a just tribute to the memory of Munshi Kali, Prasad, the founder of the Kayastha Pathashala at Allahabad, for his generosity in endowing it with property valued at over five lacs of supces. Munshi Lakshmi Narain, Secretary to the Sudder Sabha, then read the report of the Sudder Sabha, thanking the Provincial and Local Committees for their co-operation in giving effect to the reforms sanctioned at the previous Conferences, namely, the abolition of infant marriages, money payments exacted on the occasion of marriages, disuse of hquor at feasts, and the putting down of extravagant expenditure at weddings, &c.

The following resolutions were, among others, discussed and passed :--

1.—That political subjects and religious belief, excepting the observance of *Dwij dharmi* practices, be hereby excluded from the discussions of the Conference and of the Sabhas thereunder.

II.—That, in the opinion of the Conference, the following means among others are suitable for the curtailment of extravagant expenses in marriages and on other festive occasions.

(1.) That every member of the community individually, and every Subha collectively should prepare a list of such expenses as, in his or its opinion, require curtailment or total abandonment; that such lists be published in the national papers, and a copy thereof be forwarded to the Provincial Sabha Office; that an abstract thereof be read at the General Meeting of the Provincial Sabha, and subsequently circulated widely in the community.

(2.) That ever, Sabha and Sub-Division of the community should prepare a Dastur-ul-Amal (code of rules and bye-laws to regulate expenses in marriages, &c.), and enforce it within its jurisdiction or sub-division; that these Dastur-ul-Amals be published in the national papers, and a copy thereof be forwarded to the Provincial Sabha; that an abstract of these Dastur ul-Amals be appended to the Provincial Sabha report; and that, when a sufficient number of them have been received, a draft Dastur-ul-Amal be prepared for general enforcement, and be read at the annual meeting of the Provincial Sabha, and when approved by the latter, be published and widely circulated.

(3.) That expenses be limited, 1st with respect to the average annual income, (e. g., not more than six months' income should be spent on the marriage of a son, one year's on that of a daughter, and so on); or 2nd with respect to grades of marriages, (e. g., in the first class, marriage expenses may not exceed Rs. 1,000; in the second, Rs. 500; and in the third, Rs. 150); or 3rd that expenses on the different ceremonies be laid down at certain amounts which should not be exceeded, (e. g., Rs. 5 for Barrichha, Rs. 50 for Tilak, $s \exists d so on$).

N. B.-The examples given above are only illustrative, and not authoritative; regard should be had only to the principles underlying them. (4.) That members and office bearers of the Sabha should try their best to see within their respective jurisdictions that the rules thus framed are not violated; they should adopt all persuasive means to induce people to conform to them, e, g, they should join their feasts, explain to them the advantages of their action, and otherwise use their influence to check breaches of the rules.

(5.) That in the first instance pressure be brought to bear on people of position and wealth, and the office-bearers of the Sabhas should take the lead in observing the rules.

(6.) That gentlemen conforming to the Dastur-ul-Amals promu_b 'ed by the Sabhas should be publicly honoured; and their names favorably noticed in the national papers, and further their names should be recorded in a register kept for the purpose and read at the annual meeting.

(7.) That with a view to attract the attention of the community and the Sabhas towards the enforcement of the several methods indicated above, short pamphlets should be published pointing out the evils of extravagant expenses on marriages, and be distributed gratuitously.

V.—That every Sabha should take interest in the Kayastha Pathashala at Allahabad, and secure for it Life-Members on payment of Rs. 100 in lump, or ordinary Members on payment of Rs. 12 annually.

¹¹I.—That the Nigam Sub-Division in Oudh and N. W. Provinces should be thanked for effecting reforms among their communities by holding a Nigam Conference.

X.—That the next Conference should be held in Rajputana, the place to be notified hereafter. (A Conference was accordingly held at Ajmere during the Christmas of 1892. A detailed report of its proceedings will appear in the next Report.)

Silver medals provided by the liberality of the Agra Provincial Sabhs and Bai Jayanti Prasad, Deputy Collector, were then presented to the two Kayastha students who headed the list of successful students in the late Entrance and the Intermediate examinations of the Allahabad and the Punjab Universities respectively.

As in the previous year, an evening party was held on the termination of the day's work, accompanied with a sweet discourse of music and recitation of patriotic songs and short compositions in relation to Conference subjects. It was largely attended and very much relished. Its free and easy proceedings were in striking contrast with the restraints of a large aud packed up assembly, and it no doubt afforded a scene of real relaxation to the delegates who were not a little tired after three days protracted sittings in the Conference hall. The total amount of Subscription collected in 1891 for the Bareilly Conference was contributed as below : -

The balance was left in the hands of the Secretary, and this, by a resolution of the Reception Committee, was to form part of the fund for founding a Girls' school in honour of the Conference at Bareilly.

BENGAL.

The most remarkable event during the year was that the Pandits have, under the auspices of Kumar Binoya Krishna Bahadar and Pandit Mabesh Chandra Nyayaratna and others, declared that a Hindu, who undertakes a distant sea-voyage or resides in a foreign country without committing any heirous transgression, does not thereby render himself liable to excommunication. The agitation on this subject was kept up all the year round, and large meetings were held and a number of publications were issued to popularize the subject among all classes.

The Sanjivani newspaper also drew pointed attention to the evils of polygamy still current among the Kulin Bramhins.

Pandit Mahesh Chandra Chakravarti, who is employed by Mr. Dayaram Gidumal to do work as preacher, visited 26 towns and 50 villages in Bengal, and addressed the people not only on different topics of social reform, but on various superstitions and injurious customs prevalent in the society.

RAJPUTANA.

The Walterkrit Rejputra Hitakarini Sabha is doing good work in the way of raising the marriageable age of girls and boys, and curtailing marriage and funeral expenses. Four Kayastha Temperance Societies were started in Rejputana last year, and most strenuous efforts were made to suppress the evil custom of drinking. About eight other Associations have been started to check early marriages and extravagant expenses.

The Raja of Ulwar has passed a rule prohibiting all persons from spending more than 500 Rupees on marriages and 200 Rupees on funerals. There was a famine in Rajputana during the early part of this year, and in Jeypur and other Native States forcible measures were taken for the curtailment of such expenses during the continuance of the famine.

The work of social reform is largely promoted by the Arya Samajists in Bajputana.

BÁRODA.

The Mahajans of Baroda, representing about thirty castes, have resolved that no parent or guardian shall marry a girl before she completes her 10th year except with the permission of the Mahajans; (2) that the bridegroom shall be older than the bride; (3) and that those who infringe these rules shall be punished by the caste, or the Mahajan, and the Nagarshet is authorised to apply to the State for help to recover fines for the infringement of the above rules. Dewan Bahadur Manibhai Jasbhai and Rao Bahadur Hargovandas have rendered great assistance to the Mahajans in carrying out this movement. The Mahajans have applied for State help in the enforcement of these rules.

SIND.

The work of the Sind Social Reform Association is continued unostentatiously, but steadily. Three female schools are supported by the Association, and two magazines advocating the cause of reform are published under its auspices.

PUNJAB.

Two widow marriages have been celebrated amongst Hindus. The leaders of the Arya Samaj and the Dev Samaj movements in Punjab promote social reform, although their principal mission is to advance the cause of religion.

POONA.

The agitation between reformers and their opponents, noticed in the previous year's report, has not yet ended, and the work of the Social Reform Association at Poona was, therefore, somewhat slack during 1891. Towards the close of the year, efforts were made to secure the adhesion of more pledged members. Excluding 11 Mahomodans, one Parsi, one Jew, and 4 Native Christians, 1499 took pledges up to the end of 1890. Those who have since signed pledgesheets number 264. One of them is a Native Christian and employed as a Head Clerk in the Deputy Commissioner's Office at Yeotmal in Berar, and 23 persons have not written their names legibly or have merely written "yes" or "no" under different heads instead of signing under them. These 23 persons will be requested to send fresh pledgesheets duly signed and legibly written. Excluding these 24 persons, the total number of those who have thus taken pledges is 1739.

Of these, about 53 gentlemen from Ashta in the Satara District suggest that the Shankaracharya should be made President of the Association, and 16 gentlemen of Peint in the Nasik District wish that the Association should not seek to enforce its pledges by legislation. About 1700 persons have bound themselves to be members of the Association, and 39 gentlemen reserve their decision on the point, till rules are framed for the working of the Association. Persons who have taken pledges since 1890 fairly represent different classes,77 being Government servants, 31 pleaders, 15 Inamdars and landholders, and 8 priests have joined the Association. Among the notable acquisitions may be montioned Vidya Bhaskar Pandit Lal Chandra M, A. R. S. (London), Garu to His Highness Kishor Singhji, Commander in Chief and the brother of the Maharaja of Jodhpur, and an educated Hindu lady (wife of a High Court pleader practising in Berar), who has taken a pledge not to marry her sons before they reach the age of 20 years and her daughters before the age of 14 years.

Of 1739 persons who have bound themselves by pledges, 1258 are Brahmins, 126 Parbhus, Kayasthas and Kahatriyas, 33 Vaishyas, 59 Marathas, 16 Brahmos, 6 Aryas, 10 Sikhs, and 12 Jains. While 88 have described themselves as Hindus without specifying the subdivision, and 131 have not given their castes.

Classifying them according to their occupations, 630 are Government servants, 143 students, 123 Barristers and Pleaders, 119 merchants contractors or artizans, 21 pensioners, 20 doctors, 9 Professors, and 136 Inamdars and land holders. One Chief, 3 Sirdars, 3 Dewans and Karbharies, 4 Judges, including a Covenanted Civilian, and 67 Priests have joined the Association. The remaining 460 either belong to other professions in small numbers, or have not specified their professions.

653 have not pledged themselves to limit the expense of marriages of their sons to six months income, while 1086 have pledged themselves to do so. Two of the latter have taken expense to mean useless expense, and two wish to exclude ornaments from the amount specified.

1075 have consented to limit the expenses of marriages of their daughters to one year's income. Out of 664 who do not bind them. selves to do so, three have promised to do their best to keep the pledge, and one has undertaken to do the same as long as his income is not reduced below Rs. 200 per mensem.

944 have pledged themselves not to get their sons married below the age of 16, 244 below that of 18, and 175 below that of 20, and two have promised to leave it to their sons to get themselves married or not. The remaining 374 have taken no pledge under any of these sub-heads. A few gentlemen who have taken pledges under this and the next head have promised to enforce the rules in the case of wards under their guardianship.

981 have undertaken not to get their daughters married before the age of 10, 188 before the age of 12, 112 before the age of 14, while one has undertaken to keep his daughter unmarried till the 18th year of her age. Although 457 have taken no pledge under any of these subheads, two of them promise not to marry their daughters below the age of 10 years, unless compelled by unexpected pressure.

Out of 1739 persons, who have taken pledges, only 272 have not taken the pledge not to marry a second wife in the life-time of the first and the pledge does not apply to three lady members. Of the remaining 1464 persons, two promise never to marry again, and 1432 have taken the pledge absolutely, while 30 have done so under certain circumstances, which, as stated by some of them, are want of issue by the first wife, her incapacity or her consent.

Of 1599 persons, who have pledged themselves not to marry after 50 years of age, two undertake not to marry after 35, and one after 40. Of the remaining, two promise to marry widows only, if they at all marry after that age, and two promise to keep the pledge if they have progeny at that period of life, and two undertake to do the same, unless compelled to act otherwise by any extraordinary circumstances or for valid reasons, while 134 take no pledge under this head.

While 60 persons pledge themselves not to use liquor under any circumstances, 1495 promise not to do so except under medical advice, and two take the pledge substituting the words "except on grounds of health" for the qualification in the pledge proposed. Only 182 have not taken the pledge. Thus the proportion of those who have not bound themselves by the pledge under this head to those who have bound themselves is nearly 12 per cent, the same as in 1890.

Under the last head, 1281 have taken the pledge to do their utmost to further the education of their daughters, while 28 have done so to a limited extent only, which is denoted by such qualifications as "ordinary vernacular" or "Sanscrit education," or "as far as is required for domestic purposes," or "until marriage." The number of those who do not take this pledge is 430. The proportion of those who do not appreciate the benefits of female education to those who are disposed to help it on is 32 per cent against 35 per cent at the end of 1890. There is thus a small improvement under this head.

A few persons have added pledges either to promote the marriages of child-widows, or not to give or receive money in consideration of the marriages of their sons or daughters, or not to smoke tobacco, but as these pledges are not entered in pledgesheets, no detailed account needs be given thereof.

Their Highnesses the Maharaja Gaikwad and the Maharaja Holkar are the patrons of the Association. His Highness Shrimant Bala Saheb Patwarhan, Chief of Miraj, has not only consented to be the President of the Association, but has signed the pledgesheet, and become a member thereof.

MYSORE

At the last Dasara gathering the Dewan announced to the people that the Mysore Durbar proposed to prohibit by legislation the marriages of girls below 8 years, and of men over 50 years with girls holow 14. The Durbar has also showed its interest in the Conference by deputing Paudit Rangacharya to assist its deliberation on the sea-voyage questions.

TRAVANCOBE.

His Highness the Maharaja and the Dewan of Travancore also take interest in the work of social reform.

GULBURGA.

This town in the Nizam's territories was at one time the capital of the now defunct Bahamani Kingdom. There are half a dozen State Schools under the superintendence of Mr. A. Venu Gopal Pillai, and nine girl schools attended by over 400 girls. All these girl schools are the outcome of the single-handed efforts of Mr. T. Shrinivasacharya. Every opportunity is taken by him to explain to the people the need of social reform. About 20 gentlemen have already signed the pledgesheets of the Poona Association. These signs of intellectual awakening are more than sufficient to encourage the continuance of efforts in the cause of social reform. Three widow marriages were celebrated during the year, and it is a matter for congratulation that they evoked the sympathies of very old, and in some quarters of orthodox friends. A new Association has been started of earnest workers in the cause of social reform, who have pledged themselves to show their sympathy by action.

MALABAR.

The Malabar marriage Bill has been sent up by the Madras Government to the Government of India for their approval. The Madras Government are opposed to laying down marriageable age limits, but they favour registration of marriages and divorce.

APPENDIX C.

At a public meeting held in the Congress Shamiana within the compound of the Lowther eastle, Allahabad, on the 25th December 1892, under the presidency of the Hon. Babu Ramkali Chowdhari, Rao Buhadur M. G. Ranade gave an address on the subject of "Social Evolution." The address was intended to be an introduction to the regular work of the Conference, which held its meeting later on.

Rao, Bahadur Ranade, having been introduced to the audience by the President in a few preliminary remarks, commenced his address thus :--

"Mr. President and Gentlemen/ once more we meet in this busy week of December, this time in your historical and holy city, to take stock of our year's achievements, to count our losses and gains, and to pledge ourselves to help each other in the unceasing struggle to better our condition. When from our distant provinces we start on these annual pilgrimages, we are often twitted for our pains by those who take credit to themselves for superior wisdom, and the question is often asked, what mad freak lays hold of so many earnest minds in the country, which leads them to pursue this mirage of national elevation, which recedes further from our grasp the more eagerly we run after it. This same irreverent doubt also weighs down some among our own body in our weak moments, and it seems to me very necessary. before we enter upon more serious work, to purify ourselves by the discipline of a rigorous course of self-examination for the struggle. Nothing strikes our critics, both European and Native, as more manifestly absurd than this our faith that these annual gatherings will prove helpful in attaining the objects we seek. Progress in the art of self-government, both in its national and individual bearings, it is urged by some of our native friends. can never be secured by these half-confused gatherings of races and creeds and interests, and the jumble of tongues, and the tame imitation of methods not our own. Our European critics are more wise in their generation, and some of the wisest among them have demonstrated to their own satisfaction that all Oriental races have had their day, and that nothing is now left to them but to vegetate and die, and make way for their betters. Political elevation, and social emancipation, religious or spiritual enlightment,-these gifts have not been, and will never be, according to their philosophers, vouch-safed any more to the Indian races. If these black forebodings were really inspired prophecies, our outlook would be dark indeed. Happily for us these prophecies are not true, and what is more, it is in our power to falsify them. History does not countenance them, and the teachings of science are not in their favour. No earnest prayer, no self-denying aspiration, no sincere battling with falsehood and ignorance, can ever, under God's Providence. end in failure. The methods may have to be changed, but the struggle is ever the same, and none need despair. It is not the gains that you make outside of you, it is not what you have, but what you yourselves become, that makes or mars a man's or a nation's desitny. Particular reforms may be out of our reach, or may not be for our advantage: but the earnest desire for reform, and sincere efforts of selfsacrifice directed towards their attainment. cannot but elevate us above our weaknesses, and strengthen our strong points, and plant the banner of union in hearts torn with centuries of strife and disunion. This is the moral interest of the struggle, and those who cannot appreciate this invaluable privilege of fighting in the ranks in such a struggle are,-what shall I call them-superior persons living in a Paradise of their own. If indeed history and science both declared against us, we might find it necessary to pause. But the history of this great country is but a fairy tale, if it has not illustrated how each invasion from abroad has tended to serve as a discipline of the chosen race, and led to the gradual development of the nation to a higher ideal if not of actual facts, at least of potential capabilities. The nation has never been depressed beyond hope of recovery, but after a temporary submerging under the floods of foreign infinences, has reared up its head-absorbing all that is best in the alien civilization and polity and religions. The testimony of science points in the same direction-If the environments determine the growth, a change in the environments must bring about a change in the political and social organism. There is thus no cause for despair if we only remember one great lesson of history and science, namely, that no development of the body politic is possible, unless the new heat animates all our powers, and gives life and warmth to all our activities.

When we meet at these annual gatherings to seek our political elevation, we must not lose sight of the fact that our social emaucipation should go along with it, if we desire to be an individual consistent whole, with a just balance of power in all our movements. In other words, the social evolution must take place side by side, if it should not precede, the political growth that we desire to achieve. What is it, some of you will ask, that you require of us to do in this work of internal freedom? I would reply, the evolution that we should seek is a change from constraint to freedom—constraint imposed by our own weaker nature over the freedom of our higher powers. It is a change from credulity to faith, from credulity which behoves without grounds to faith which builds itself upon a firm foundation. Our station in life, our duties, and our limits of action are certainly fixed for most of us by circumstances over which we have no control. voluntarily contract that margin, and bind ourselves by fetters, and glory in them as the Mahomedan fakir in Bombay, who thinks himself specially favoured because he bears heavy iron chains. The change which we should all seek is thus a change from constraint to freedom, from credulity to faith, from status to contract, from authority to reason, from organized to unorganized life, from bigotry to toleration, from blind fatalism to a sense of human dignity. This is what I understand by social evolution, both for individuals and societies in this country. Even if we accept the evolution view to be correct. it should not be forgotten that the environments which surround us have changed, and are not the same that they were a hundred years ago. Peace and order reign throughout the land instead of the old disturbances which made the preservation of life one's chief care. Instead of our country being a sealed book, we are now a part of the community of nations, feeling joy and sorrow in their prosperity or distress. In our own country distance and local barriers which so long separated us have been removed, and we are made more mobile and coherent than we ever were before. These are only physical changes. More important still is the discipline afforded us by the example and teaching of the most gifted and free nation in the world, whose rule guarantees to us a long continuance of these favourable conditions. The reign of law is supreme. Human skill and human sympathies are busy at work to correct all our failings, and it cannot well be that all this should have happened as a mere accident in human story. The European philosophers themselves admit that wholesale migration and infusion of new blood can alone revive the old effete oriental races. I contend that the changed order of things described above are the new environments in which, without change of place, we have been forced to migrate, they infuse new blood into our views, and they bring down from heaven the spiritual fire which has strength enough to purge us of our grosser selves, if we only will do our duty. On their own theory, therefore, there is no cause for the despair which European thinkers feel. The process of growth is always slow, where it has to be a sure growth. The best natures naturally want to shorten this long process in their desire to achieve the work of a century in a decade. This temptation has to be resisted, and in this respect the teachings of the evolution doctrine have great force, because they teach that growth is structural and organic, and must take slow effect in all parts of the organism, and cannot neglect any, and favour the rest. There are those amongst us who think that, in this connection, the work of the reformer is confined only to a brave resolve to break with the past, and do what our individual reason suggests as proper and fit. The power of longformed habits and tendencies is however ignored in this view of the

matter. "The true reformer has not to write upon a clean slate. His work is more often to complete the half-written sentence. He has to produce the ideal out of the actual, and by the help of the actual." We have one continuous steam of life flowing past us, and "we must accept as valid the acts which were noted in the past, and on the principles of the past," and seek to turn the stream with a gentle bend here, and a gentle bend there, to fructify the land; we cannot afford to dam it up altogether, or force it into a new channel. It is this circumstance which constitutes the moral interest of the struggle, and the advice so frequently given-that we have only to shake our bonds free and they will fall off themselves,-is one which matured and larger experience seldom supports. We cannot break with the past altogether; with our past we should not break altogether, for it is a rich inheritance, and we have no reason to be ashamed of it. The society to which we belong has shown wonderful elasticity in the past, and there is no reason for apprehending that it has ceased to be tractable and patient and persistent in action. While respecting the past, wo must over seek to correct the parasitical growths that have encrusted it, and sucked the life out of it. This is, at least, the spirit in which the societies and associations which are represented at the Social Conference seek to work. They seek no change for its own sake, or because it is fashionable elsewhere. They seek their inspiration in the best traditions of our own past, and adjust the relations of the past with the present in a spirit of mutual forbearance. The Shastras they revere, but they respect the spirit more than the letter of the old law. The road is difficult and beset with dangers, but as it is the only sure road, there is no choice. Looked at in this spirit, we may now review the work of the past year, and although, as in the political sphere of our activity, we have both gamed and lost ground, there is, on the whole, no cause for thinking that we have wasted our opportunities during the year that is about to close. Being in touch with friends in all parts of the country, I can speak with some authority, and I am glad to testify to the fact that it cannot be laid at the door of the different local Associations that they have been idle all the year round. In the Bengal Presidency an agitation initiated by Kuwar Viuaya Krishna Bahadur, and supported by such men as Sir Romesh Chandra Mitra and Pandit Mahesh Chandra and Babu Surendranath Bannerjee, has been carried on in the matter of removing hindrances in the way of the free admission of men who go to foreign countries. Vyavasthas numerously signed by Pandits and others, have advanced the solution of that question to a sensible extent. In the N. W. Provinces and Ondh. the Kayastha Associations and their Conference have done a great deal for that community in the way of checking intemperance and extravagance, and promoting education. In the Punjab, the healthy activity of the local Arya Samajas has given to that body a position

of great usefulness in the education and training of the community of the country. Two re-marriages, one in high life and the other in consonance with the old practices, have taken place with the apparent approval of many orthodox leaders. Lower down in Rajputana the Walter Krit Bajputra Sabha has developed its organization, and enforced its rules with greater success than before, and the movement is now spreading among other classes of the community. The leading Native States are lending their support to the cause of reform officially. In Gujerath, in our own Presidency, His Highness the Maharaja Gaikwar has been appealed to for help by the Mahajans of thirty leading sub-castes to help them in raising the limit of marriageable age, and checking extravagance. In the British territory in the same province, the Kunbi population has been similarly profiting by the operation of the rules framed under the Infanticide Acts. In the rest of the Presidency, the Marwadi Jains at Nusik and the Kayastha Prabhus have held conferences for the promotion of reform in their own community. In Bombay a re-marriage was celebrated the other day which was also an inter-marriage. In Poona, owing to local distractions, much has not been done, but the Poona Association has received several more pledges, and some of the highest families in the city have arranged mutual marriage alliances, the actual celebration of marriage being postponed till the girls arrive at puberty. Even the local distraction had a bigher moral interest than what people, looking superficially, would be prepared to admit. As the question is, however, still undecided. it would be premature to prophesy the final results. But there are evident signs that the struggle has commenced in earnest, and it will end in a compromise creditable to both the parties. In Mysore His Highness the Maharaja's Government is prepared to undertake legislation in respect of marriage reform, and has been good enough to show His Highness's appreciation of the work of the Conference by deputing a learned shastri of his court to help us in our deliberations, In Malabar the proposed legislation of marriage among Nairs has made some progress. In the Madras Presidency, three remarriages took place, one of them being an inter-marriage. A new association of earnest workers has also been formed there, which represents the young Madras party, and promises the happiest results. Two of our most prominent workers undertook missionary tours in the Punjab, in the Central Provinces, and in the Berars, at great self-sacrifice. In the Central Provinces a Native Christian taken back into his caste by the leading Pandits of Jabalpore. Taking things as they are, this is not I hope, a very unsatisfactor account of the year's work and it shews that the conscience of the country is touched in all great centres, and with better organization, greater courage of conviction, and more faith in Provulence, we may hope that this process of social regeneration or evolution, if you like so to call it, will continue to grow in strength and in power. To help that growth, by bringing all workers together once a year to exchange views and sympathies, is the object with which we meet here. Last time the people of Allahabad gladly welcomed our efforts, and we feel quite sure of a similar welcome on this occasion.

APPENDIX D.

SOCIAL REFORM IN BARODA.

(The following letter was addressed to the members of the Sixth National Social Conference.)

Gentlemen, it gives me much pleasure to inform you, of an important step, recently taken in the direction of social reform, at the capital of H. H the Maharaja Gaikwar. The resolutions passed by the Mahajan of Baroda, which represents about thirty castos, are to the following effect :---

(1) No parent or guardian, shall marry a girl before she completes her 10th year.

Proviso-If a girl is to be married before that age, permission of the Mahajan should be previously obtained, through the caste to which belong the parties concerned.

(2) The bridegroom shall be older than the bride, at least he shall not be younger than the bride.

(3) Those who infringe these rules, shall be punished by the caste. If the caste fails to do its duty, or if the decision of the caste is disregarded by the parties concerned, the Mahajan should take notice of them.

(4) The Nagarshet, or the Head of the Mahajan, is authorized to apply to the Government for help, in recovering fines, if the guilty parties refused to pay them.

I may say a word in passing about the constitution of the Mahajan. It is a powerful combination or guild, of a number of trading communties, existing as it does from time immemorial, in each town of Gujerath. It is thoroughly representative in its character, and it wields unlimited powers in social matters over its constituents. Instances of the political part, which the Mahajan has played from time to time, are not few in the history of Gujerath.

Dewan Bahadur Manibhai Jasabhai, the Minister of the Baroda State, and Rao Bahadur Hargovandas D. Kantawala, Director of Vernacular Instruction, deserve much credit for the support, they have privately given to the Mahajan. Great credit is, also due to the principal leaders of the Mahajan, especially Nagarshet Maganbhai, who belongs to the well known family of Hari-Bhakti, I am told the Nagarshet has already sent in an application to the Minister. It is hoped that His Highness the Maharaja, who is a true reformer himself and who has been doing so much for the wellbeing of his subjects, will readily give his helping hand to the Maha. jan. I also hope that Mahajan of other towns and communities not belonging to the Mahajan will soon follow the laudable example set by the Mahajan of Baroda.

APPENDIX E

SEA-VOYAGES AMONGST HINDUS.

A largely-attended public meeting of the Hindus representing all sections of the community, was held on 19th August 1892, at the late Maharaja Komul Krishna Bahadur's residence at Calcutta, to consider the question of sea-voyage among Hindus.

The Hon'ble Sir Romesh Chunder Mitter moved the following Resolution :--

"That in the opinion of this meeting, having regard to the state of public opinion in the matter, the time has come for taking a practical step for the settlement of the question as to whether sea-voyage may be undertaken by Hindoos without loss of caste, and in this view the meeting resolve to appoint a Committee consisting of the following gentlemen, viz., Maharaja Bahadoor Sir Narendra Krishna, K. C. L. B., the Hon'ble Dr. Justice Guru Dass Bannerji, Mahamahopadhya, Pundit Mohesh Chunder Navaratna. C. I. E., Chunder Sekhar Churamoni, Sir Romesh Chunder Mitter, Knight, Babu Norendra Nath Sen Nayalankar, Pundit Nilmony Mukeri. M. A., B. L., Roy Jotendra Nath Chowdhury, M. A., B. L., Kumar Rameswar Mulia, Babu Kirun Chandra Ray, Dr. Omesh Chandra Mitter, Babu Naba Gopal Mitra, Dr. Surivo Kumar Sarbadhikari. Pundits Krishna Kumal Bhattacheriya, Kamakhya Nath Tarkabagish. Madhusudun Smritiratna, and Maharaj Kumar Benova Krishna Bahadur, as Honorary Secretary, with power to add to their number, to ascertain the following points :---(1) Whether sea-voyages on the part of Hindoos and residence in foreign countries involve the loss of caste, if they conform to Hindoo usages and customs; (2) whether it is practicable for Hindoos to undertake sea-voyages and reside in foreign countries, and yet conform to Hindoo usages; and (3) whether Hindoo public opinion will generally support the movement in support of sea-voyages.

Mahamahopadhya Pundit Mohesh Chunder Nayaratna, c. 1. E., Principal of the Sanskrit College, in seconding the above Resolution, said that he had thoroughly studied the question, and had come to the deliberate conclusion that there was nothing in the *Shastras*, opposed to sea-voyages or residence in foreign countries, if Hindoo usages were observed.

Rai Bahadur Kailas Chunder Mukerji supported the Resolution.

Babu Suresh Chunder Dutt, B. A., Head Master of the Calcutta Institution, then read a very able paper on "Sea-Voyages amongst Hindoos," and many gentlemen took part in the discussion that followed.

The following Vyavasthas given by the Brahmin Pundits of Bengal were also read out at the meeting :

Question I.-Is a person, who makes a Sea-Voyage in a sea-going vessel without committing any heinous transgression, involving degradation, to be considered fallen (patita) ?

Question II.-Is a person, who resides temporarily in England and other foreign countries without committing any heinous transgression involving degradation, to be considered fallen (patita) ?

Anneers.

Vyrrastha I .-- As Sea-voyage does not come within the category of heinous transgressions, involving degradation (patitya), and heavy penances are not provided for it, and there is nothing even by parity of reasoning to consider it a heinous transgression, a person, who makes a Sea-voyage without committing any heinons' transgression, should not be considered fallen (patita).

other foreign Vyavastha II.-As residence in England and countries does not come within the category of heinous transgressions, involving degradation (patitya), and heavy penances are not provided for it, and there is nothing even by parity of reasoning to consider it a heinous transgression, a person, who resides in England and other foreign countries, without committing any heinous transgression, should not be considered fallen (patita).

I.; and the late Pandit Khetter Pal Smritiratna also expressed the same views in separate Vyavastha.

Mahamahopadhya Dinabandhu Nayaratna of Konenagore further observes that Sea-voyage, instead of being considered a great transgression, is grouped with such light transgressions as going to Sri Khetter (Puri) by sea, for which little or no penance is required. As to residence in England and other foreign countries, he adds that no penance is provided for it in the Shastras.

The following instances may be noticed here in the Bombay Presidency of gentlemen who travelled to and resided in Europe and were readmitted into caste. Mr. Ganesh Sitaram Golvalkar, an officer in the service of His Highness Tukojirao Holkar, who had gone to England, was readmitted into his caste in 1872, under the orders of the Sankaracharya of Sankeshvar near Kolbapur. Mr. Krishnarae Gopal Deshmukh, who had gone to England to study for the Bar, was admitted, under the orders of the Sankaracharya of Kaira in Guzerath. The decision in both these cases were passed with the concurrence of learned Shastris of Benares, Indore, Poona, Satara, and other places. These decisions have been published and largely circulated. Mr. Shripad Babaji Thakur, who went to England and passed the Civil Service Examination, was also received into his caste.

Messrs. Shamji Krishna Varma, Ramdas Chabildas, Ravji Bhavanrao Pavgi, and Harilal H. Dhruva have been admitted into their castes. His Highness the Maharaja Gaikwar and those Hindu officers, who went to England and other countries in Europe with him, have been similarly admitted into their respective eastes. Only a few days ago Mr. Purmanand Bhatt was unanimously admitted by all the members of his caste in Guzerath.

APPENDIX F.

THE VIEWS OF THE LEGAL MEMBER OF THE COUNCIL OF THE GOVERNMENT OF INDIA ON THE QUESTION OF LEGISLATION AGAINST BENGAL POLYGAMY.

We have the honor to acknowledge the receipt of your letters Nos. 1647 to 1651 T, dated Deerjeeling, 22nd August 1866, to our respective address, and we beg to submit the following reply.

We understand that the Hon'ble the Maharajah of Burdwan, and some 21,000 other Hindoo inhabitants of Lower Bengal prayed for an enactment to prevent the abuses attending the practice of polygamy amongst the Hindoos in Lower Bengal; that His Honor the Lieutenant Governor was in favour of the measure of bringing the said practice strictly within the limits of ancient Hindoo law; that on the other hand, His Excellency the Governor General in Council was of opinion that the Hindoo inhabitants of Lower Bengal were not prepared, either for the suppression of the system of polygamy, nor yet for that strict limitation of it which His Honor the Lieutenant Governor of Bengal recommended, but desired only a remedy for the special abuses practised by the sect of Koolia Brahmins; that His Excellency would, therefore, be prepared to take into consideration any deliberate measure which His Honor the Lieutenant-Governor might, in consultation with some of the ablest of the leading native gentlemen in Bengal, think fit to recommend for the suppression of the special abuses above named, provided that such measure had not, on the one hand, the effect of restricting the general liberty now possessed by all Hindoos to take more than one wife, and that it did not, on the other hand, give the express sanction of English legislation to the system of polygamy. and that to us has been committed the duty of reporting on the best means of giving practical effect to the wishes of his His Excellency the Governor General in Council, and of framing and submitting a Draft Bill for that purpose.

In order that it may be seen exactly what we understand that system to be, for which we are instructed to suggest a remedy, we think it necessary briefly to trace the history of Koolinism back, to state how it arose, and what it was, and what we believe it to be, and what, in the main, are declared to be those evils to which it has given rise, and what it perpetuates.

In the Institutes of Manu we do not find any distribution of the sect of the Brahmins into distinct denominational classes, but we find it declared that certain Brahmins were by conduct and acquirements entitled to higher respect than other Brahmins, whose conduct was not so strict, and whose learning was not so great, and this declaration may possibly have laid the foundation of that distribution of the Brahmins into denominational classes, which subsequently was made.

It was not until the time of the Hindoo king Bullalee Sen, who reigned some 284 years before the Mahomedan conquest, or about 877 A. D, that any distribution into denominational classes took place. This distribution was confined to the descendents of those Brahmins who had migrated from Kanouj into Bengal on the invitation of the Rajah Adisa, and it is stated that the cause of this distribution was the fact that the sect of Brahmins generally had fallen off in knowledge and in practice of the Hindoo Shastras.

There were two chief divisions of Koolins, namely, the Barendro of what was then known as the geographical division of Barendrobhoom and the Rushis of Burdwan and other places.

The Koolins of Barendrobhoom were divided into two classes-

1st. Koolins, and 2nd Kaips,

but as it is not amongst the Barendro Koolins that any abuse of the system of polygamy exists, we shall not further refer to these Koolins.

The Rushi Koolins were also divided into two classes :-1st. The Koolins; 2nd, Shrotryos and subsequently to these classes was added a 3rd, the Bhonghsho, the origin of which is somewhat obscure.

The Koolin class was an order of merit and was composed of those Brahmins who had the nine qualifications :---

- 1st of observance of Brahmin duties
- 2nd of meekness
- 3rd of learning
- 4th of good report
- 5th of a disposition to visit holy places
- 6th of devotion
- 7th of a dislike to receive gifts from the impure
- 8th of asceticism and
- 9th of liberality

The Shrotryo was composed of those Brahmins who had gone through the 10 Sunskaras, had read part of the Vedas, and were supposed to have eight only of the nine qualifications of the Koolins. When the above classes were first created, a peculiar Code of laws, the bulk of which has in process of time swelled, and which is called by the Koolins the Kooliena Shashtra, was laid down for the guidance of the Koolins.

It would seem, however, that almost immediately after the creation of the class of Koolins, disorders sprung up, principally by reason of irregular marriages, and a class, called the Ghatak, came into being, a class which was composed of persons whose employment was that of contracting marriages for others.

If it were possible, it would be superfluous to trace the history of the Koolins from the time above mentioned up to the present time; it is sufficient that we should now state, not in its numerous ramifications and complications, but in its main features only, what we believe to be the present condition of the Koolin class or of Koolins and Koolinism as last known by these terms. We are speaking of the Rushi division of Brahmins, and we believe we are right in stating that the chief distinctive classes among them at the present day are four in number and these are viz :--

The Koolins or 1st Class Bhongho Koolins or 2nd Class Bhongshoj Koolins or 3rd Class Shrotryo-Brahmins or 4th Class

The first Class is composed of persons, who are supposed to possess the nine qualifications of the order of merits, and who at any rate are presumed never to have forfeited their title to that order by intermarriages out of their own class.

These men, it is said, usually marry two wives, one out of their own class and one out of the class of the Shrotryos, and they take a consideration from the bride on the occasion of all intermarriages with the Shrotryos, and also of all intermarriages amongst themselves, except in cases where there is an exchange of daughters.

The 2nd Class is composed of Koolins of the 1st Class, who have ...llen from the latter class by intermarriages with the daughters of families in the 2nd and 3rd classes.

This second Class is again subdivided into :

1st Swakrito Bhongho Koolins.

- 2nd Bhongho Koolins of the 2nd generation.
- 3rd Bhongho Koolins of the 3rd generation.
- 4th Bhongho Koolins of the 4th generation,

The male members of this 2nd class contract an unlimited number of marriages during the life-time of the first wife and except in cases of exchange, whether these marriages are contracted with Koolin women of their own class or with the dauhters of parents in the 3rd class, a consideration is given by the parents or family of the bride to the bridegroom.

In the generation after the first act by which a Koolin of the Ist class has fallen into the 2nd class *i. e.*, has become a Bhongho-Koolin, he falls into the 3rd class, *i. e.*, he becomes a Bhonghsho Koolin, and the 4th class, the Shrotryo, is composed of persons who have never been Koolins at all.

It will be most convenient here to state that the marriages most sought after are marriages with Bhongho-Koolins of the 1st and 2nd subdivisional classes, *i. e.*, the Swakrito and the Bhongho Koolins of the 2nd generation; and that the daughters of the class of Bhongho Koolins generally are not permitted without degradation to marry beneath their class.

We will now describe some of the main customs in the matter of marriage, which to the best of our knowledge and of the statements made in petitions to the Legislative Council, obtain amongst the Bhongho-Koolins, and we will state what are declared in papers before us to be the evil results of some of these customs :----

lst. In addition to the presents usually given amongst all classes of Hindoos on the occasion of marriage, a Bhongho-Koolin always, except when he gives his daughter to a brother Bhongho and takes in exchange that brother Bhongho's daughter, exacts a consideration for marriage from the family of the bride.

2nd. A present is often given in addition on the occasion of any visit made to the house of the father-in-law.

Srd. If the daughters of the 1st and 2nd sub-divisional classes of Bhongho-Koolins cannot be given in marriage to busbands of their own classes, they must remain unmarried.

4th. The number of wives, including those of the same class, is said to be often as many as 15,20,40, 50, and 80.

5th. Polygamy is said to be resorted to as a sole means of subsistence by many Bhongho-Koolins.

6th. Marriage, it is said, is contracted quite in old age, and the husband often never sees his wife, or only at the best visits her once in every 3 or 4 years or so.

7th. As many as three and four marriages have been known to have been contracted in one day. 8th. Sometimes a man's all daughters and his unmarried sisters are given in marriage to one and the same individual.

9th. It is so difficult to find husbands in the proper class for Koolin women that numbers, it is said, remain unmarried.

10th. The married or unmarried daughters and the wives of Koolins are said to hve in the utmost misery; and it is alleged that crimes of the most heinous nature such as adultery, abortion, and infanticide, and prostitution are the common results of the system of Bhongho Koolin marriages generally.

11. Cases are cited of men who have married 82, 72, 65, 60 and 42 wives, and have had 18, 32, 41, 25 and 32 sons, and 26, 27, 25, 15 and 16 daughters.

12th. Lists have been adduced of families in the Burdwan and Hooghly Districts alone, showing the existence of a plurality of wives on the above scale and in numerous cases.

13th. The principle on which Koolinism was perpetuated visthat of preventing intermarriages between certain classes, is violated.

14th. Families, it is said, are ruined in providing the large sums requisite to give a consideration on the occasion of their daughters' marriages, or are unable to marry their daughters at all for want of means to procure such consideration.

15th. Marriages are, it is said, contracted simply for this consideration, and the husbands do not even care to enquire what becomes of their wives, and have never even had any intention of fulfilling any one of the marriage duties.

16th. The crimes that are said to result from the Koolin system of marriage are said to be habitually concealed by them and by their neighbours, and this so as to baffle the efforts of the Police at discovery.

17th. No provision is made for the maintenance of one wife before marriage with an unlimited number of others.

The above are said to be some of the customs, and are declared to be some of the evils said to result from the system of polygamy as practised by the sect of Bhongho Koolins, and the evils may thus be briefly summed up:

1st. The practical deprivation of the indulgence of zoural ties and desires in the female sex in a legitimate manuar; 2⁻¹ the virtual sometimes the actual desertion of the wife by her zoural and regal protector, the husband; 3rd, the encouragement of the practice of celibacy amongst the female sex; 4th, the non-maintenance of the wife by the husband; 5th the supersession or abandonment of the wife at the mere pleasure of the husband; 6th the formation of the contract of marriage for money considerations simply; 7th the denial of nuptial intercourse except upon special monetary consideration given; 8th the ruin in a property point of view of families; 9th the contraction of the marriage tie avowedly without any intention even on the part of the husband of fulfilling any one of the duties of that tie; 10th the binding down the female sex to all the obligations of the marriage state, whilst yet withholding from that sex every one of the advantages of that state; 11th prostitution; and lastly, 12th the encouragement of the actual crimes of adultery, abortion, and infanticide and of the habit and practise of the concealment of such crimes.

The customs detailed above, as obtaining amongst Bhongho Koolins in the matter of marriage, have on the whole, we think, been accurately detailed. The evils said to result from these customs are, we have reason to believe, greatly exaggerated, and the abuse of the permission to take a plurality of wives is, we believe, on the decrease; yet we do not doubt but that great evils exist, and those evils divide themselves naturally into two classes; first, that class which is contrary to religion and morality, and that which is contrary to established law.

We think that the following extracts, containing a brief view of the Hindoo system of religion and morality as applied to the mar. riage state, will show that the system of polygamy, to whatever extent it is abused by the Bhongho-Koolins, is opposed to the ordinances of the Hindoo Code of Religion and Morality.

Brahmins are to shun the allurements of sensual gratification. Indulgence in sensual pleasure incurs certain guilt; abstinence from it secures heavenly bliss. Neither the Vedas nor liberality nor sacrifices, nor strict observances nor pious austerities ever procure felicity for the man contaminated by sensuality. The husband is to approach. his wife in due season; he is to honor and adorn, her; when he honors her, the deities are pleased, when he dishonors her, religious acts are fruitless; a wife, unless guilty of deadly sin, must not be deserted; the husband who does not approach his wife in due season is reprehensible, he is one person with her, and she cannot by desertion be separated from him; once a wife is given in marriage the step is irrevocable; only after a wife has treated a husband with aversion for a whole year can he cease to cohabit with her; immorality, winking spirituous liquors, affliction with any incurable or loathsoma diseas, mischievousness, waste of property, barrenness alter eight years' cohatination, death of all children after ten years of cohabitation, the production of only female children after eleven years of cohabitation, and speaking unkindly are the sole grounds for supersession of a wife; desertion of a blameless wife is penal; substraction of conjugal rights is denounced with heavy penalties; supersession of the wife is justifiable on grounds which regard the temper, conduct or health of the wife, and is tolerated on these grounds, and where neither justified nor tolerated, it is illegal; the abandonment of a blameless and efficient wife without cause given, or without her consent, is illegal; the principles peculiar to the Brahmin forms of marriage are those of mutual consent and disinterersted motives; immemorial custom, regulating marriage in general and in its different forms and the relations of husband or wife, is to be observed, and non-observance leads to forfeiture of the fruits of the Vedas.

The above texts clearly seem to us to indicate that the Bongho Koolins, to what extent they marry out of motives of mensuality only, or do not cohabit with, or abandon without any cause or anpersede or neglect or do not maintain their wives or disregard the sanctity of the marriage tie generally, act contrary to the plainest injunctions of the Hindoo Shastras.

To the extent that system of intermariages amongst the Bhongho Koolins encourages celibacy amongst women and exacts a consideration for the contract of marriage, it is questionable whether there is practice which is at variance with the letter at least of the Hindoo Shastras.

In the matter of celibacy, the whole tenor of the Hindoo system of marriage does certainly advocate the marriage of women even before they have arrived at puberty; penalties are prescribed for those fathers and families who neglect to marry their daughters before arrival at puberty, and daughters had formerly even the privilege of giving themselves in marriage in case of protracted neglect on the part of the others to give them in marriage, yet, on the other hand, perpetual celibacy is inculcated rather than the act of giving the daughter in marriage "to a bridegreen void of excellent qualities"-Manu, Chapter IX Sec. 89.

And a father is prohibited from receiving any gratuity however small, for giving his daughter in marriage on the principla, that he who through avarice takes such a gratuity is a seller of his offspring-Manu Chapter III Section 51. The case, however, that we have to contemplate is that of a father who gives—not one who takes—a grutuity for the marriage of his daughter, and who is not actuated by avarice, but by what the Hindoo law declares to be the laudable desire of marrying his daughter early in life, and to a Brahmin of excellent qualities, and there is no text that we know of that prohibits a person from taking a consideration on the occasion of marriage of his offspring, appertaining to the bestower of the gift—Mann, Chapter XI, Section 5.

The utmost that can be said against the taking of this consideration is, that it is contrary to the principle on which the four first forms of marriage, which are peculiar to the Brahmins, are based, viz. that both parties to the marriage should be actuated by disinterested motives—Macnaghten, Volume I pp. 59, 60.

Looking at the subject generally, however, there cannot be a doubt but that the system of polygamy as practised by the Bhongho-Koolins is opposed to the strict ordinances of the Hindoo Shastras, and it is also said to be productive of the special offences against the law which we have named, and we are instructed, if we can, subject to the restrictions imposed upon us by His Excellency the Governor General in Council, to suggest legislative measure by which the system may be suppressed.

The root of the evil is in that custom by which Bhongho-Koolins of the inferior grades eagerly offer, and Bhongho-Koolins of the higher grades as eagerly accept, valuable considerations for the marriage of a woman of the former.class to a man of the latter class.

A law could, of course, be passed rendering such contracts illegal under penalties on both contracting parties.

But in the first place it is not clear that the letter of Hindoo law is not rather in favour of than against such contracts, and in the second place, in a case such as this, where both parties are interested to conclude the contract in question, it is evident that either the provisions of any law prohibiting such contracts would be evaded, or that violations of any such law would be effectually concealed.

Systems of registration of marriages, of fines increasing in amount for every marriage after the first, of certificates of all marriages after the first to be taken out in the Civil Courts, and such like schemes have been suggested, and have suggested themselves to us, but in all these schemes, even if they were not otherwise objectionable, there would, it seems to us be an element which would, indirectly at least, affect that "general liberty, which is now possessed by all Hindoos to take more than one wife" with which we are instructed not to interfere.

The scheme which has at first sight seemed most feasible is that of framing a declaratory Law, setting forth what the law is on the subject of polygamy and prohibiting any infraction of it under penalties.

Such a declaratory Law would certainly regulate polygamy amongst the Hindoo inhabitants of Lower Bengal "generally," and we are not quite certain, therefore, that in proposing such a law, we should not be transgressing that part of our instructions which forbids us to "give the express sanction of English legislation to two Hindoo system of polygamy," but for the sake of considering the subject, we will suppose that we are not prohibited from proposing a declaratory Law.

Now such a law must, in our judgments clearly be declaratory of what the Hindoo system of polygamy is and nothing more and nothing less; if it be more or less, then it ceases to be simply declaratory, and becomes enactive.

The following is that which, after consultation of the best authorities, we find to be the law, which strictly taken should regulate the practice of polygamy amongst the Hindoos.

We find that according to one of the ordinances of Manu, a Bishmin is enjoined to marry one wife, and this a woman of his own caste, but that, if he be so inclined, he is permitted to marry more than one wife, during the life time of his first wife, and he is recommended to select a second, a third, and a fourth wife in the order of the classes, viz. out of the Kshatriya, the Vaisya, and the Sudra classes respectively, and consecutively—Manu, Chapter III, Sections 12, 13.

This was an ordinance of the time of Manu, but we are now in the Iron-Age of the Hindoo system, and so a Brahmin is now forbidden to marry any but a woman of his own caste.

It is contended, however, by the advocates of polygamy that the permission to marry a plurality of wives, which formerly extended to women of all the four classes, is to be constructed, not so as to abelish polygamy altogether, but simply so as to confine it to intermarriages amongst the various classes.

To this opinion Strange so far seems to incline, in that he states that it does not appear how many wives a Hindoo is competent to have at one and the same time (chapter II, p. 56); and in Section 204 Chapter VIII, Manu, there is a case in which it is evidently contemplated that a man may be the husband of two persons of the same caste at one and at the same time, though in this instance the permission was evidently only accorded under circumstances of an exceptional nature; and again in Section 161 Chapter IV there is a general maxim, allowing the widost margin conceivable to the effect that any act, though not prescribed, if it be not prohibited, is law (m), provided that it gratifies the mind of him who performs it.

Macnaghten, on the other hand, points out the illogical nature of the deduction made from the texts quoted, and states that the scion taken in the matter of marriages from this deduction is con.d.red by the Pundits to be reprehensible—Volume I pp. 58, 59.

In our view the texts 8, 12, 13 Chapter III, Manu, relbd on, must be held to be obsolete and inapplicable. Those texts refer to an era in the Hindoo system in which it was permitted to a Brahmin to marry out of his own seet, and thus prescribed the order, and put no restraint upon the circumstances under which he might contract such marriages, but we are now presumed to be living in a purer era, when, marriages of this looser kind, which were before permitted, are now prohibited, and the logical deduction seems to us to be that those texts, which had for their main object the regulation of such marriages have, with the marriages themselves, become obsolete.

- We turn, therefore, to those other authorities, which seem to us to declare most definitely the Hindoo system of polygamy.

Immemorial custom, which is defined to be good usage long established, is declared to regulate the laws concerning marrings and the relationship of husband and wife—Manu, Chapter 1, Sections 100, 112, 125, and Chapter II, Sections 10, 18.

A Brahmin who has not violated the rules of his order, who has read certain portions of the Vedas, who has obtained the consent of his spiritnal guide, and who has performed certain ceremonial ablations, may then espouse a wife of the same class as himself, who is endowed with certain qualities—Manu, Chapter III, Sections 3, 4, 7 to 11.

On the decease of the wife, the husband may, after performance of sacrifice and the funeral rites, marry again-Manu, Chapter III Section 168.

If a wife drink spirituous liquors, if she acts immorally, if she shows aversion to her husband, if she be afflicted with any loath-some or incurable discease, if she be mischievous, if she wastes her husband's property, if she be afflicted with a blemish of which the husband was not aware when he married her, if she have been given in marriage fraudulently, if before marriage she have been unchaste, if after seven years of married life she has remained barren, if in the ton years of marriage her children be all dead, if after ten years of marriage she has produced only 'daughters, and if she has spoken unkindly to her husband, she may in some of these contingencies he altogether abandoned, and in all superseded by her husband--Manu, Chapter VIII, Sections 72, 77, 80, 81.

But the wife who is beloved and virtuous, though she be afflicted with disease, may yet not be superseded by another wife without her cwn consent—Manu, Chapter VIII, Section 82.

These causes are accepted by Strange as those which lead to separation (chapter 2, p. 47), and he remarks upon the latitude which is ey give to the will and caprice of the husband, whenever there is in hi a the disposition to take advantage of the letter of the law.

AX, further on he points out that where supersession of the wife is not justifiable nor permissible under, we would suppose, any one of the above contingencies, there it is illegal, and he defines illegal supersession to be the abandoning, with a view to another wife, a blameless and efficient wife who has given neither cause nor consentpp. 52 to 54, Chapter II.

If we have rightly quoted, and if Mr. Justice Strange has rightly interpreted the law, then in any Bill declaratory oŧ law. WO should have to propose to give the sanction of English legislation to supersession of a wife on grounds the most trivial and inadequate, to say that she might be superseded, because she was found blemished (perhaps within the meaning of Sections 7 to 11, Manu, Chapter III) or was mischievous (whatever that may mean) or had spoken unkindly or was barren (and who is to say where the fault of barrenness lies, for if it is with the husband, then under Section 79 Chapter IX. Manu, there is no supersession), or for many other causes more or less ridiculous or incapable of proof.

On these considerations, we find that it is not in our power to suggest the enactment of any declaratory Law, neither can we think of any legislative measure that, under the restricted instructions given for our guidance, will suffice for the suppression of the abuses of the system of polygamy, as practised by the Koolin Brahmins, and we beg to report to that effect.

APPENDIX G.

Extracts from the Report of Babu Mohesh Chandra Chakravarti, the Social Reform Preacher for Bengal.

In December 1891, I entered upon my work as Preacher of Social Reform in Bengal. During the course of the year 1892 I visited 26 towns and about 50 villages in Bengal. I held a meeting in one place, an evening party in another, and now and then I addressed large public gatherings and delivered open air addresses. During the year I could avail myself of 18 occasions to deliver public lectures on Social Reform. The lying-in-rooms, the high price paid for brides and bridegrooms, the heavy expenses in marriages, childmarriage, remarriage in old age, polygamy and the Kowlinya system in society--these generally formed the subjects of my lectures and discussions.

KULIN POLYGAMY.

The late patriotic and far-famed Pundit Iswar Chundra Vidyasagar published a work on the mischiefs of polygamy, and we are glad to see that his efforts are now being crowned with success. The gradual diminution of the plurality of wives is now observed in the Kulin society in Bengal. In Vikrampur the principal settle. ment of the Kulins, I saw, some 15 or 16 years back, such prevalence of polygamy as is now-a-days not to be found there. The mischiefs of polygamy seem to have been brought home to the mind of the educated people. But still I do not mean to say that polygamy is now not prevalent in the country, or that the reduction in the number of wives married at one time by a man foreshadows its rapid overthrow. I only mean to say that my impression is that it has abated to a considerable extent. Those that enquire into this matter or ponder over it will, I believe, fall in with my views on this point. We used to hear formerly of 100 or 150 wives of a man, and saw with our own eyes 50 or 60, but now it is generally seen that a man does not accept more than 10 or 12 wives. The Editor of the Sanjivani and the Somoy, the two vernacular papers, took great pains to publish a list of the polygamists with their ages, dwelling place, position and the number of wives each has got, which evidently proves that polygamy is still practised in this country, but we are also told that the number of wives now ranges from 2 to 25. So it has been diminished to a great extent. There are many untoward circumstances which compel a man to accept two

or more wives simultaneously. It may be from the fact that the first wife proves barren, or that she does not agree well with her husbandher father-in-law, or her mother-in-law. But the kulin Brahmins of high education are compelled to accept two or more wives by the custom of the caste for which they are not responsible. As for instance, it happens sometime that a kulin Brahmin can not give in marriage his own sister, unless be accepts a bride or two from the family of his would be brother-in-law. But I do not think it worth my while to deal with the subject here at length. Those that are acquainted with the customs of the kulins of the country will readily understand my meaning. But nevertheless it must be said that polygamy is after all a very injurious custom, whatever cause may lead to it, and that the sconer this mischief is obliterated from kulin society, the better it is for the country and the kulins themselves.

RE-MARRIAGE OF HINDU WIDOWS :---

The late Pundit Iswar Chandra Vidyasagar was the chief or rather the only man who endeavoured to introduce remarriage of widowed girls in accordance with the Hindu Shastras, but it is a matter of deep regret that even at the expense of his superhuman energy and enormons wealth, he could not bring about the desired effect. After him there is now no such great man in Bengal, who can with a firm resolution follow in his track in removing bitterness from the life of widowed girls. However the endeavours of the venerable Vidvasagar have not been utterly useless. So many of the bigotted Hindus are now heard to talk in favour of the widow marriage, and though they have not the moral courage to act in the way they think proper yet their words indicate their inner feelings. Those that would severely chastise any word on widow-marriage some 10 years back are now found to sympathise with widowed girls. But there is now no active agitation in this direction. Though the educated few of the country entertain favourable opinions on this matter, yet they can do very little in effect. Some years ago a Hindu widow marriage was to be solemnized in the town of Mymensingh, under the suspices of Babu Gajendranath Vidyabhushan, Deputy Magistrate and Editor of the Aryadarsan. But those, that promised to favour its proceedings by their presence in the ceremony even before the day of marriage. were not to be seen at the proper moment. This couple now has found protection in the Brahmo Samaj. But such marriages, I believe, will not do any good to the Hindu society. I have much pleasure to record the following instance of the re-awakening of the spirit of social reform in Bengal which may be distinctly traced to be the result of the agitation made last year. On the 24th November 1892

a widow-marriage has been celebrated with Hindu rites in the house of the late venerable Pandit Vidvasagar. The bridegroom is Babu Tinkari Ghose, a renound Pleader of Colberiah in H w. sh,and the bride is srimati Rajrani, widowed daughter of late Aghornath Datta Neogi of Amta. The mothers of both the bride and bridegroom approved the marriage and joined the ceremony, and many men of position and rank attended the ceremony. Babu Naram Chandra Vidyaratha, the worthy son of the Vidyasagar, took the leading part. It is expected that Pundit Narain Chandra will follow the footsteps of his father. In Dacca a marriage of this sort took place in some kayastha family, which now lives under the protection of the Hindu society. In a village in Palena I saw a couple married in this way, who lived under the kind protection of the late venerable Vidyasagar, whose lamented death has now rendered it most miserable. But the widow-marriages. which lead to excommunication and persecution of the parties concerned, are only had examples to frighten away the advocates of social reform.

EXTRAVAGANT MARRIAGE EXPENSES.

Babu Jay Chandra Sannyal of Jalpaiguri has been, for the last few years, agitating against accepting high price for brides and bridegrooms among the Brahmins of Barendra class, and for the introduction of intermarriage between the three different clans of the Barendra class. Babu Rash Behari Mukhopadhyaya, a kulin Brahmin of East Bengal, has been trying head and heart from a long time to break down the mischievous covenant of the kulins, to introduce intermarriage between the several classes of kulin Brahmins and thus to deal a deadly blow to polygamy. His attempts have been successful to some extent at least. Some kulin Brahmins of Pulena also tried to introduce amongst themselves intermarriages between their several clans, and published a pamphlet in which they vividly set forth the miseries of the society. The Dharmasabha in Rungpur sometimes moves against the high price of brides. In Calcutta about 600 men of high education and position met last year, and resolved to abolish several burdensome customs from amongst themselves, three of which may be noticed here .--

(1) that an invitation letter must be accompanied by a brazen pot,

(2) that an invitation letter must be responded to with a certain sum of money, and

(3) That presents must be given in feasts.

The native press is for the most part active in agitating against the several superstitions social customs of the country. In the end I am very giad to say that I was always encouraged by the educated and even by the old people, whenever I was with them in connection with my work, and for this I feel myself highly obliged to the pleaders, muktiars, schoolmasters, professors, Government officers, educated zemindars and other gentlemen of the country. So I offer my best thanks to them, and hepe that their help and co-operation will inspire me with greater enthusiasm to resume my work next year.

APPENDIX H.

MEMORIAL SUBMITTED TO GOVERNMENT FOR THE AMENDMENT OF ACT 21 OF 1860 AND SECTION 26 OF ACT 6 OF 1882.

Sir,

In accordance with a Resolution (copy annexed) passed at the last National Social Conference, I have the honor to bring to the notice of the Government of India, the necessity of amending the law regarding the registration of Associations not formed for profit.

2 •The Government of India in their letter No. 1628 dated 8th October 1886, Home Department, to the address of the Bombay Government, replying to a memorial for the amendment of Act XXI of 1860 admitted that the provisions of that Act " were defective in many respects," and that if the Act were to be amended it would " probably require to be thoroughly examined and extensively altered. " The Government did not think that time opportune for " such an extensive revision, " and advised the Memorialists to get their social reform Association registered under section 26 of the Companies' Act VI of 1882.

3 Over six years have elapsed since the above Resolution was passed, but the defects in the Act have not yet been remedied, and the Act still continues inapplicable to Social Reform Associations. I am to request that if the revision of the whole Act (21 of 1860) cannot be taken in hand, at least a couple of words "social reform" may be added to the list of objects mentioned in section 20, and the necessary change made in the preamble. The Act even as it now stands affords a cheaper and more convenient means for the registration of non-mercantile Associations than Act VI of 1882, and it is hard that Social Reform Associations alone should be compelled to resort to the latter Act.

4 If however for any reason this proposal cannot be agreed to at: present, I am to request that Section 26 of Act VI of 1883 may be so amended as to remove the hardships, which are now experienced and which deter Social Reform Associations from registering themselves under its provisions. These hardships are as follows :--

(a) The memorandum and articles of association registered under Act XXI of 1860 require no stamp. Those registered under Section 26 of Act VI of 1882 require a stamp of Rs. 40 at least—so the Registrar of Joint Stock Companies in Bombay acting on the opinion of the Advocate General has held.

(b) Registration under Act XXI of 1860 can be effected on payment of a fee of Rs. 50, but registration under Act VI of 1882 involves besides the payment of this sum, several other fees. For example, Rs. 5 have to be paid for the registration of the Articles, and copying fees etc. have to be paid in addition.

(c) If the articles are in any way modified or added to, a further fige of Rs. 5 has to be paid on each occasion (see section 79 of Act Σ of 1882 and Table C). No such fee is leviable under Act $\Sigma \Sigma$ of 1860.

(d) An Association registered under Act VI of 1882 is bound to provide itself with a registered office; and to give notice of its entuation, as also of any change therein to the Registrar under sections 63 and 64. The Registrar charges a fee of Rs. 5 on every such notice, as Table C directs him to levy this sum not only for registering any document (other than the Memorandum of Association) required or authorised to be registered by the Act, but also for making a record of any fact authorized or required to be recorded by him. There are no such provisions in Act XXI of 1860.

(c) Further, Associations registered under Act VI of 1882 have to pay a fee of Rs. 5 on filing with the Registrar every year in obedience to section 74 a balance-sheet, containing a summary of their liabilities and property. The levy of this periodical fee is hardly justifiable in the case of Associations not formed for profit, but for promoting objects of public utility.

(f) Besides these extra fees, Associations registered under section 26 of Act VI of 1882 are subject to obligations from which Associations registered under Act XXI of 1860 are free. For example, they have to keep their registered officer open at least for 2 hours every day in order to allow the inspection, of their register of members (section 55,) otherwise they are punishable with a fine. Such a provision is certainly useful in the case of mercantile companies, but it is difficult to understand its usefulness in the case of Associations not formed for profit.

(g) Act VI of 1882 consists of 256 sections besides several schedules, the first of which, Table A; contains no less than 97 re-

gulations. Section 38 of the Act lays down that "in the case of a company limited by shares, in so far as the articles do not exclude or modify the regulations contained in the Table A in the first schedule hereto, the last mentioned regulations shall, so far as the same aro applicable, be deemed to be the regulations of the company." As Associations registered under section 26 have all the privileges and obligations of limited companies, they are subject to these regulations, unless they take care to go through them and exclude or modify them in their articles. All this entails an enormous amount of trouble and often results in considerable confusion and uncertainty.

(h) There are several penal Sections in Act VI of 1882, from the operation of which disinterested associations formed for doing good to the public, should be exempted. For example, it is a penal offence not to forward a copy of the memorandum and articles of Association to a member at his request on payment of certain fees (Section 42), and it is a penal offence not to keep the register of members in a particular form (Section 47) etc. Associations registered under Act XXI of 1860 are subject to no such liabilities.

(i) There are other provisions in Act VI of 1882, like those relating to the rectification of the register of members (Section 58), the forms to be used (Section 95) etc., which though less objectionable, are yet hardly in keeping with the constitution and character of nonmercantile associations. None of such provisions is to be found in Act XXI of 1860.

5 It is therefore humbly prayed that the Government of India will be pleased to take this representation into its consideration, and amend Section 26, (a) by exempting Associations licensed and registered under that Section from the fees, which companies are liable to pay, excepting the registration fee of Rs. 50, and (b) by exempting such Associations from the obligations mentioned in clauses (f_i to (i) above, or at least empowering Local Governments to exemptsuch Associations from any obligations imposed on companies. I am 'also to request that pending such legislation the Government of India may be moved to remit the fees mentioned in clause (a) by exercising its power in that behalf under the Stamp Act I of 1879, and the fees mentioned in clauses (b) to (e) by exercising its power under the Companies Act. I may add that similar remissions have been made on many occasions.

APPENDIX I.

EXTRACTS FROM THE REPORT OF THE GENERAL COMMITTEE OF THE WALTERKRIT RAJPUTRA HITKARINI SABHA FOR 1892.

PRESIDENT'S' REMARKS.

THAKURS AND GENTLEMEN,

7

Your sixth Annual Report shows again satisfactory progress in the reforms watched over by this Sabha. The rules you have laid down have been so well observed on the whole that, according to the returns received from the several local Committees, breaches of them amount, as regards Marriage expenses, to only 1.5 per cent.; as regards the distribution of Tyàg (or money given to Charans, Raos, etc.) to 81 per cent; and under the head of Funeral expenses to 1.18 per cent. But the most wholesome, and indeed the most important of all your rules, viz., that the bridegroom must be not less than 18' and the bride not less than 14 years of ages, has been broken in 155' cases out of 2,711, which gives an average of rather more than 6' per cent.

I see that the highest number of these breaches of rules [Viz. 80] occurred in Marwar and the next highest (viz. 22) in Bikanir. It is possible that these figures are due to more effective efforts to ascertain and check breaches of rule and secure honest returns rather than to a want of interest in this great reform; on that point I can pronounce no opinion. I can only say that unless such efforts are made and unless your returns are reliable, the progress we now hail with the greatest satisfaction will one day be subjected to a very serious dis." count. which will detract from the credit you have hitherto won. In making this remark I have no reason to suspect the returns that have been furnished ; I only wish to put you on your guard against criticism that might be provoked by the results exhibited in them. For instance, it might be asked why Jeypore should show 991 marriages and only 5 against rule; Marwar 420 with 85 against rule, and Meywar 167 with only 1 against rule. The differences between these figures suggest perhaps varying degrees of success in ascertaining the number and circumstances of the marriages which took place in those States. At any rate you will all acknowledge the necessity for making your returns represent as far and as correctly as possible every marriage

among Rajputs that takes place. The Sabha is now five years old, and strong enough, I hope, to bear and be thankful for criticism that exposes defects. The movement that originated it having been a genuine one from within should in a few years require but little aid from the Chiefs and the local Committees, but at present we must continue to solicit from the Durbars a continuance of the support that has kept it going hitherto.

You know how I have desired for some time past to see marriage and funeral expenses reduced, especially among the cultivators to whom they are often a burden for generations, and a chief cause of their indebtedness to the bohras, who lend at very high interest. I am₀ therefore, greatly pleased at that passage in your address which notices what has lately been done in this respect in Bikanir and what is going forward elsewhere. Your next annual report will, I trust, show how the reforms required have been introduced among the agricultural Population of Jeypore and other States.

You note that in Bikanir all the chief castes have framed rules for restricting their marriage and funeral expenses, and you have referred to the useful reforms advocated by the Kayastha Conference. Your sympathy with other than Bajput communities in the great cause of social reform is, I have reason to believe, highly appreciated. I congratulate you and the Durbars whom you represent most heartily upon the successful results recorded in your report. And now, gentlemen, I need only add one word more.

You have alluded to the death, two months ago, of my predecessor, Colonel Walter, who at your request was the first President of this Society, and gave to its formation and the benefits it was designed to promote the advantage of a wide influence, personal as well as official, which you have acknowledged in the grateful expression of condolence you have asked me to convey to his widow, Mrs. Walter.

Knowing as I do how deep an interest Colonel Walter took in this Sabha and how proud he was to have his name permanently associated with it, it will be a melancholy satisfaction to me to comply with your request. Assuredly the good done by Colonel Walter in connection with the social reforms he had so much at heart will live after him, and in that thought he justly took delight.

(THE GENERAL REPORT.)

3. The returns of marriages and deaths have been received from all the States of Rajputana (excepting Bhurtpore) and placed before the General Committee. A reference to the general statement which accompanies thi report will show that the total number of marriages performed among the Bajputs during the last year was 2,810. Some of these are under enquiry, the particulars concerning them having not yet been received. The cases in which the Committee's rules have been transgressed may be detailed as under:---

37 in respect to expenditure,

155 in respect to age.

20 in respect to Tyag,

The number of funerals during the last year comes to 2,649, of which in 29 cases only the expenditure incurred exceeded the usual limit. In many of the cases entered above as breaches of the age rule, the age of the marrying couple was less only by one or two years.

4. Some breaches of engagement have been noticed and the local Committees concerned have taken proper steps to prevent a recurrence. Instances of a second or third marriage in the lifetime of the first or second wife have also come to the Committee's notice in some States. viz., Karowli, Jodhpore, Pertabgarh, and Bundi. In Karowli suitable measures have been taken to deal with such cases. In Jodhpore permission of the Committee was granted in 4 out of 6 cases; the remainig two are being investigated. The Bundi Committee also gave permission in two cases for a second marrige on being satisfied that the first wife was barren. In Pertabgarh State a Jagirdar married a second and third time in a month's interval without obtaining the Committee's permission; the matter is, however, being investigated by the Sabha of the State and the result will be shown in next year's report. Besides the reduction in expenditure on marriage and funeral ceremonies and Tyág, some of the local Committees have endeavoured to put down the use of intoxicating drugs. The objectionable practice of accepting "reet" * money has been greatly discouraged.

5. The strict and consistent adherence to rule 3 of 1883 on the subject of Tyàg is exceptionally satisfactory and shows how successfully the Committee is working. The distribution of Tyâg, a custom which told heavily upon rich and poor alike, and to some extent compelled the father of the bride to yield to the temptation of accepting "reet" money, was virtually the real source of bringing this Sabha into existance.

6. The result of the last year's working as compared with that of 1891, is as follows :---

This shows that the Sabha has made still further progress during the year 1892.

7. Modern advocates of social reforms have to face a good many difficulties in removing evil customs which crept into society thousands of years ago, and have since been eating up its very vitals. We also laboured under apprehensions of similar difficulties at the outset, but thanks to Colonel Walter and those who have been helping us by their good advice, she Sabha has been able within so short 'a period to effect a more marked improvement than could ever have been expected. This reform is not limited to the Rajputa only. A perusal of reports received from local Committees shows that almost all the communities living under the protection of Native Chiefs in Rajputana are awakened to the advantages which Rajputs are deriving from the rules prescribed by the Walterkrit Rajputra Hitkarini Sabha. There is hardly any principal caste in Bikanir State which has not adopted some rules for restricting their marriage and funeral expenses. The Jats, who form the agricultural population in Bikanir have lately agreed to bind themselves to a set of rules which, it is hoped, will prove very beneficial to their community. Arrangements

· for framing rules for Zemindars in other States are also being made. His Highness the Maharajah Saheb of Jeypore is bestowing much attention on this point. His Highness has ordered that from the rules published in the General Committee's report for 1891 and those which the Thikana of Chomoo has drafted, as also W. R. H. Sabha's rules, a regulation limiting marriage and funeral expenses etc., should be prescribed for the Zemindars of Jeypore State. The Jeypore Sabha has, therefore, prepared a draft, and asked the Zemindar " Punches " as to the limit of age. These rules, it is hoped, will shortly be brought into force. The Kayasth and Saraogi communities of Jeypore have also submitted a draft of rules to His Highness. The Jodhpore Committee has been urged by His Highness the Maharajah of Jodhpore to frame such rules for all castes living in that State. Ulwar and Karowhi are also exerting towards the improvement of castes other than Rajputs and have succeeded in introducing rules among Brahmans and Mahajans. The Kishengarh Durbar after consulting the communities concerned has ordered that if any banker advances money to cultivators in H. H.'s dominion for preparing any dainties other than "lapsi" (a preparation of wheat, sugar and ghae) in the "Nukta" (a feast given after the funeral ceremonies are over) without a certificate of permission from the Committee, a suit for the recovery of the amount thus advanced will not be entertained in the Kishengarh Courts.

8. The returns of marriage and funeral ceremonies performed among Bajputs in Dholpore State have also been received this year. As the Sabha's rules have been recently brought into force in this State, the result of the year has been shewn separately in the general statement.

9. The Committee feels much indebted to you for the kind attention you have been pestowing on its work, and we hope that you will not only yourself continue this attention, but will also persuade other officers to always enlighten us by their advice, so that we may be able to do more justice to the work we have in hand.

10. Munshi Shunker Lal, our Secretary, also deserves thanks from us. He is working very carefully and in a praise-worthy manner, and we are all greatly satisfied with him.

Proceedings of the 6th Meeting of the General Committee of the Walterkrit

Rajputra Hitkarini Sabha held at Ajmeer from 25th February to 1st of March 1893.

The following resolutions were unbnimously passed in the meeting:-

111. A copy of the report of the Indian National Social Con. ference was placed before the meeting, who proposed that their thanks may be conveyed to the Secretary of the Conferences

IV. A petition from the leading members of the Charan community, proposing that the money which the Charans receive as "Tyag" may be utilized in setting up a school for Charan boys, to be called "Jijman Patshala," was placed before the meeting by Kaviraj Morardanji for their consideration, and, after considerable discussion, the Committee thinking the petition to be proper, as it bore on the subject of education; which is liked by all, decided "that if the Charans' will take upon themselves the responsibility of managing the work, the General Committee of the W. R. H. Sabha can have no objection to its being undertaken." The work should commence when the rules have been prescribed and enforced, but it should be understood that at the time of marriage the Charans themselves will have to go to receive the "Tyagi"

V. The papers relating to Kayastha Conference were placed before the meeting, who resolved---

"That this Sabha is glad to hear that the Kayastha Conference has been busy in its endeavours" to introduce useful sorial reforms among the Kayastha Community! Any society which seeks to promote the education of women as well as of men, to prevent early marriages and useless expenditure at marriage feasts, to check intemperance and litigations, is deserving of sympathy from this Sabha, which occordingly desires to congratulate the Kayastha Conference, and to wish it every success in carrying out the aims above mentioned."

VI. The Committee proposed that a message may be sent to Kaviraj Shamval Dasji of Odeypore, stating that his absence through sickness has been greatly felt by the Committee, and it is hoped that they will soon hear of this recovery.
