NOTE

This pamphlet is one of a short series issued by the Information Section of the Secretariat of the League of Nations on various aspects of League work. It contains the text of the Covenant, which constitutes the first twenty-six Articles of the Treaty of Versailles and other Peace Treaties, together with the amendments adopted by the Second Assembly (1921).

It should be noted that Article 26, unamended, provides that :

"Amendments to this Covenant will take effect when ratified by the Members of the League whose Representatives compose the Council and by a majority of the Members of the League whose Representatives compose the Assembly.

"No such amendment shall bind any Member of the League which signifies its dissent therefrom, but in that case it shall cease to be a Member of the League."

By January 23rd, 1924, although a large number of ratifications had been deposited, none of the amendments had received the total ratifications required for its entry into force.

Other pamphlets in this series deal with the constitution and organisation of the League, the Permanent Court of International Justice, political activities, the reconstruction of Austria, financial and economic work, the financial administration of the League and allocation of expenses.
