WITH reference to your letter of the 15th instant, further relative to the Banda and Kirwee Booty, I am directed by the Lords Commissioners of Her Majesty's Treasury to acquaint you, that my Lords can find nothing in the Report of Mr. Baring's speech in the House of Commons, on the 25th July last, to which you refer, to warrant the interpretation which you have put upon it, and when you reiterate the expression, "of the rule of law and precedent," as applicable to the Grant of Prize Money, my Lords have merely to observe, that you, with the other Prize Agents of General Whitlock's force, admitted in the Memorial to this Board (in which the grounds of your claim were fully and fairly stated), that which is indisputable, namely, that "this treasure, like all other prize of war, is the absolute property and creature of the Crown, which can deal with it entirely at its own pleasure."

With respect to your request that the case may be referred to the High Court of Admiralty, under the Act 3 & 4 Vic. c. 65, I am desired to state, that my Lords have already had under their consideration a suggestion to that effect, contained in the opinion of Sir Hugh Cairns and Dr. Phillimore, which was submitted to this Board in November last by the Prize Agents, and their Lordships are not of opinion that the circumstances of the present case are such as to require that Her Majesty should be advised to adopt a course unusual and

inapplicable to the present claim.

My Lords have already, by their letter of the 10th instant, stated their Received views as to the principle on which the booty in question should be distributed, 16th March. subject to any observations the Prize Agents of General Whitlock's Force may have to offer on the statements of Lord Clyde and Sir R. Hamilton, and they await the answer of the Prize Agents to that letter.

Extract from Memorandum for the Consideration of His Excellency the Governor-General by His Excellency the Commander-in-Chief in India, dated

GOVERNMENT HOUSE, CALCUTTA, 18th October, 1857.

"A MATTER of the greatest consequence, the organization and movement of columns of march through Central India, during the next cold season, has not escaped my attention.

"The special destination of the various corps now en route from England having been ascertained by the Mail, which arrived on the 15th instant, with

sufficient exactness.

"I am of opinion that the time has now arrived for the serious consideration of this very important subject.

"That a column consisting of—

Three battalions of Infantry
One regiment of Cavalry
Twenty-four field guns,

Six siege guns, to be raised by the addition of the native troops of Madras, to the largest amount that can be furnished by that Presidency should be formed, this column should be put in movement with all convenient dispatch towards Nagpore, a demonstration being made en route through the Nizam's territory.

"The march of this column would be directed ultimately on Jubbulpore.

"15. It might be disposed in—

Two divisions of Infantry, A brigade of Artillery, A brigade of Cavalry, A brigade of Engineers,

the commands of these bodies being left at the disposal of the Madras Government, under directions from the Right Honourable the Governor-General.

"16. It appears to me that much advantage would accrue to the State if Lieutenant-General Sir Patrick Grant, K.C.B., Commander-in-Chief of the Madras Army, were invited to take personal command; and that unity and strength would be gained by investing his Excellency with the power of an Agent of the Governor-General, until the country through which he might pass be reduced to order.

"17. A communication would of course be opened by this column with

that coming from Mhow towards Saugor."

By Order of the Commander-in-Chief. Memorandum by the Chief of the Staff for the guidance of Major-General Whitlock, Commanding Saugor Nerbudda Force.

HEAD QUARTERS, within 6 miles of Jellalabad, 27th April, 1858.

"MAJOR-GENERAL WHITLOCK is informed that it is the opinion of the Governor-General and the Commander-in-Chief, that the native portion of his force should be cantoned at Bandah till after the rains, while the European portion of it might proceed to Allahabad to occupy quarters.

"Major-General Whitlock is begged to give an opinion as to whether

this would be prudent with respect to the constitution of his force.

"At the present moment Sir Hugh Rose is advancing on Calpee.

"If the country in the vicinity of Bandah and to the eastward is sufficiently pacified to admit of the absence of General Whitlock's force from where he now is for three weeks, he is directed to march up the right bank of the Jumna, to co-operate with Sir Hugh Rose, and then to retrace his steps immediately after the reduction of Calpee.

"However, before giving execution to this order, General Whitlock must well weigh the state of the country according to his information, as he alone is capable of estimating the prudence with regard to the aspect of affairs in his neighbourhood, and the general condition of the country to the eastward since

his late successes.

"He is requested to acknowledge the receipt of this by telegraph, viâ Futtehghur, addressed to the care of Brigadier Seaton, C.B., the Commander-in-Chief having proceeded into Rohilcund, and being, therefore, removed from the wire.

Extract from a Letter from Sir Hugh Rose to the Chief of the Staff, dated

" CAMP CALPEE, 30th May, 1858.

"In a communication which I received to-day, from Major-General Whitlock, he tells me that he expects immediately his 2nd Brigade, under Brigadier MacDuff; that he would then reinforce me with a brigade efficient in all arms.

"General Whitlock wrote this, not knowing that Calpee had fallen, and he thought he should have to assist at the siege. I had already written to General Whitlock that I did not require his assistance, as Calpee was ours. He had not received this letter.

"May I be permitted to suggest, that the difficulties as to garrisoning Calpee and Jhansi, and sending troops to Chandairee, would be solved, if Brigadier MacDuff were to garrison Calpee, leaving a detachment at Humeerpore, which would be supported by the troops of its own division in Bandah and Calpee on both its flanks. Brigadier MacDuff's brigade is quite fresh.

"General Whitlock's division would then guard the line of the Jumna, and his rear, with a force imposing by its numbers, its efficiency, and the

complete state of its several arms including siege-train.

"The garrisons of Calpee and Jhansi would be strong enough to keep up

mutual communication, and to clear the roads.

"There is only one further suggestion, founded on my practical experience, which I would venture to make; and that is, that Saugor should be included in Central India; the Betwa is almost impassable in the monsoon, intervenes between Jhansi and the Chandairee district, consequently, the Officer commanding the Central India Field Force cannot put down efficiently disorder in Chandairee district, unless he can direct the operations of the troops in the Saugor district, which surrounds the Chandairee district.

"Saugor is now under General Whitlock, but as nearly the whole of his force is concentrated at Bandah, it would be far better that the very few troops he has left at Saugor, which is about 180 miles from Banda, should join him, and that Saugor should be placed in Central India, to which it, as being north

of the River Nerbudda, geographically and strategetically belongs.

Extract of a Letter from the Chief of the Staff to Colonel Birch, C.B., Secretary to Governor of India, Military Department.

"HEAD QUARTERS, FUTTEGHUR, 2nd June, 1858.

SIR,

"I HAVE the honour, by the desire of the Commander-in-Chief, to forward for submission to the Right Honourable the Governor-General, two despatches received by me from Sir Robert Hamilton, Bart., and Major-General Sir Hugh Rose, K.C.B., late Commanding Central India Field Force, together with my replies.

"It is obvious from the tone of the former, that Sir Robert Hamilton and Sir Hugh Rose do not appreciate the calls made for troops in other parts of the empire, beyond the sphere of their immediate observation. This is very natural, and not a subject of remark, excepting that the attention of the

Governor-General should be drawn to the circumstance.

"Sir Hugh Rose dwells on the fact of his having had no reserves. This is hardly an accurate statement. The troops at Mhow and the Rajpootana column gave him an effectual support on his left flank, and kept his direct communications by the Agra road free, as shown by the detachment of one of Major-General Robert's Brigades to Jubbulpore," under the orders of his Lordship, when Sir Hugh Rose became alarmed for his rear.

"On his right flank he was in like manner assured by the laborious march of Major-General Whitlock's Brigades, which actually operated in Banda in time to render the capture of Calpee, aided, as Sir Hugh was, by a column formed in the Doab to co-operate with him from the left bank of the Jumna, comparatively easy of accomplishment.

By Order of the Commander-in-Chief. Memorandum by the Chief of the Staff for the guidance of Major-General Sir George Whitlock, K.C.B., and Brigadier Wheeler.

"HEAD QUARTERS,

"12th September, 1859.

"1. A Memorandum from the Quarter-Master-General is annexed, showing the arrival of troops in the Saugor Division, which will take place during September and October. These troops are intended for the eventual relief of the Madras regiments now serving in the Division. The latter will not depart for their own Presidency until the operations about to take place shall have

been completed.

- "2. Sir George Whitlock is aware that the first object of Government is to clear the line of railway, and the adjacent country stretching from 'Jubbulpore' to 'Entawah;' that having been done, it is necessary to reduce all the district stretching to Shahghur to absolute tranquillity. It is proposed, therefore, that the line in rear, along the direction of the railway, shall be occupied by military and police posts, while a general advance in line of numerous small columns shall take place from 'Kalinger' on the right to Huttah on the left, in the direction of 'Patowree Ghuree' and 'Shahghur. When the arrangements for this advance in line have been made, and it is about to commence, moveable columns will issue from 'Nowgong' and 'Jhansi,' for the purpose of coming down on Putowree and Shahghur respectively. Sir George Whitlock will give the necessary order for the moveable column from 'Nowgong,' and Brigadier-General Sir H. Napier will be instructed to do the like with respect to the column from 'Jhansi.'
- "3. It is desirable that every column, however small, may be commanded by a very good officer. Lord Clyde accordingly desires that Colonel Turner, Her Majesty's 97th Foot, Lieut.-Colonel Primrose, Her Majesty's 43rd Light Infantry, Lieut. Colonel Oakes, 12th Lancers, Lieut.-Colonel Ross, Camel Corps, Colonel Nott, of Madras Service, may respectively be put in command of columns, independent of the central one, with which Brigadier Wheeler, who commands the whole, will proceed himself.

"4. Her Majesty's 43rd and 97th Regiments will each furnish considerable

detachments for the contemplated service.

"5. An immediate report will be sent, showing where Brigadier Wheeler's head-quarters will be on the 15th of October, and the constitution of the various columns and their points of assembly which may be decided on by Sir George Whitlock and Brigadier Wheeler, after consulting with Captain Osborne, Political Agent.

"6. The Commander-in-Chief considers that no column need exceed in strength—

"The service on which the troops are about to be employed is not one where concentration is required. On the contrary, it is one demanding a combined advance of numerous small columns, by which the country shall be so thoroughly swept that the rebels may not know where to fly to as they retire before the advance 'in line,' the ground in rear being taken up by posts, as the advance is made. The rebels have been so beaten and hurried already, that resistance is nowhere to be looked for, although there must be a great deal of rapid and hard marching to break them up thoroughly. To effect this the ground must be traversed and retraversed, and no fatigue must be spared.

"7. A small train of light mortars must be prepared at 'Saugor,' for use

at 'Putowree Gurhee,' or at any other fort.

W.

"8. Sir G. Whitlock will use his discretion in attaching field artillery to the column; but it must be recollected that it may be cause of considerable delay in the jungly and hilly country which is about to be traversed, and that

guns are unnecessary for the defeat of the enemy in the open field.

"9. As the troops arrive in the district, according to the annexed memorandum, they may be directed to the points where the columns will be formed under Sir G. Whitlock's direction, the new-coming regiments being used for that purpose, and the Madras Corps, which are shortly to return to their Presidency, being employed to hold the posts in the rear, 'as per paragraph 2. A sketch map is inclosed showing the direction to be pursued in the advance.

"10. Sir G. Whitlock will recollect the constitution of the Camel Corps, which will reach Saugor on the 10th October. This corps should act on the

flanks, not being divided into more than two portions.

"11. Lord Clyde hopes that all the columns will be in their positions to commence the forward movement by the 25th of October at the very latest. There must then be rest for neither man nor beast until the service is accomplished. His Excellency is sanguine of this being terminated by the end of November, and that it may be his pleasing duty to report to that effect to his Excellency the Viceroy.

"No. 12. No time was lost in moving Sir Hugh Rose on 'Gwalior.' I June, 1858 assisted him with a Brigade from the far South, drawn by the 'Rajpootana' force and with a strong detachment from 'Agra,' which lies to the north of 'Gwalior,' while he was directed to march straight on at it from 'Calpee.'

"The concentration succeeded well, and Sir Hugh Rose, as usual, did

"The concentration succeeded well, and Sir Hugh Rose, as usual, did justice to the troops under his orders. Scindiah was replaced on his throne, and that hunt of the rebel leaders in Central India commenced in June, 1858, which was finally brought to a successful conclusion by the capture of Tantia

Topee in April, 1859.

"No. 13. Thus had two great causes of anxiety, 'Gwalior' and 'Rohilcund,' been removed which had so weighed on me in January, 1858, when the Governor-General decided on the seige of Lucknow in preference to other operations. In the meantime the hot weather campaign proceeded in every direction, and if certain points had been won and occupied at vast distances from one another, the insurrection was still general and violent, although its aim and purpose was rapidly disappearing, and its initiative was entirely lost. Sir Hugh Rose's march through 'Central India;' Sir E. Lugard's through 'Oude' into 'Behar;' General Walpole's through that province into 'Rohilcund;' Sir Hope Grant's in the neighbourhood of 'Lucknow;' General Whitlock's from 'Saugor' to 'Bandah,' in 'Bundelkund,' had been entirely successful as marches, but nothing more, the whole population was armed and hostile, and closed round the rear of each column, like the sea in a ship's wake. It was the constant hunting, the never-ceasing marching and combination of different columns, the working of them all at the same time, in spite of weather, sickness, and fatigue in all seasons, which finally reduced the country eight or nine months later."

On reflection, however, and perusing the late Lord Clyde's memorandum, dated London, 8th February, 1862, regarding the Memorial of the Prize Agents of the Madras Column to the Lords Commissioners of Her Majesty's Treasury, a copy of which his Lordship sent to me, I come to the conclusion that that must be the part of the Parliamentary papers referred to by you. In the appendix of that memorandum I find there is an extract marked C, which I take to be the same as that enquired about by the Madras Government. If I am correct in this conclusion, I would mention that in my opinion, the extract marked C is merely the record of a private jotting, kept by his Lordship for his own information, at the time that the operations in question were proceeding.

It was not my habit to furnish such small memoranda to the lamented Commander-in-Chief; those drawn by myself as Chief of the Staff either at his order or for his information, having an official form, which it will be observed is altogether wanting in extract C. I am therefore confident that the original was never in my possession, of which extract C is a copy. I shall shortly be in Bombay, and will make enquiries for the Parliamentary papers in the Military Secretariat, and will communicate further in case I should make

any discovery.

And we do hereby authorise and empower and require him, the said Francis, Earl of Moira, as Commander-in-Chief as aforesaid, to the utmost of his skill and power to do and perform all such offices and services as appertain to the post of Commander-in-Chief of all our military forces in the East Indies, subject to such removal or recall as can or may be made by any law now in force, and subject also to any such rules, orders, and instrutions, as he shall, from time to time, receive from the Court of Directors of us, the said United Company of Merchants of England trading to the East Indies, in writing, or under the hands of thirteen or more of them, or from the Governor-General in Council of our Presidency at Fort William in Bengal, or from our Presidents and Councils of Fort St. George and Bombay respectively, when-soever he shall be present at any of those Presidencies, or at any settlements or places subordinate thereto, according to the rules and discipline of war, in pursuance of the trust hereby reposed in him; and we do hereby strictly require and command all commissioned officers, non-commissioned officers, soldiers, and others belonging to our military forces in the several places before-mentioned, to yield him, the said Francis, Earl of Moira, as their Commander-in-Chief, during his residence at such places as aforesaid, due obedience accordingly. And we do hereby revoke and annul all and every commission and commissions, to any person or persons whomsoever, to act as Commander-in-Chief of our forces in the East Indies, from the time that the said Francis, Earl of Moira, shall take upon him the said office of Commander-in-Chief, under or by virtue of these presents. We the said Company reposing especial trust and confidence in you, Lieutenant-General Sir Henry Somerset, do by these presents constitute and appoint you to be Commander of all our Military Forces belonging to, and under the Presidency of Bombay in the East Indies, except such forces as are or may be employed in our service within the fort, garrison and town of Bombay, to take the said office upon you from the date of your receipt of these presents, and to hold the same during our will and pleasure; and you are to the utmost of your skill and power to do and to perform all such offices and services as appertain to the post of Commander of our Military Forces belonging to, and under the said Presidency, except as before is excepted, subject however to all such rules, orders and instructions as you shall at any time receive from the Court of Directors of us the said India Company, in writing under the hands of the majority or more of them, or under the hands of the majority or more of them, or under the hands of the Chairman and Deputy Chairman, and of the Senior Member of the said Court, or of any two of them, countersigned by our Secretary or Deputy Secretary for the time being, or from the Governor in Council of Bombay, or from the Governor-General of India in Council, or from the Commander-in-Chief of all our forces in the East Indies for the time being, when he shall be resident within the Presidency of Bombay aforesaid, or within any settlement or place subordinate thereto, according to the rules and discipline of War, in pursuance of the trust hereby reposed in you; and we do hereby strictly require, charge and command all Commissioned Officers, Non-Commissioned Officers, Soldiers and others belonging to our Military Forces, under the Presidency of Bombay before-mentioned to yield you as their Commander due obedience accordingly: and we do hereby revoke and annul all and every former Commission and Commissions to any person or persons to act as Commander-in-Chief of our Forces under the said Presidency of Bombay, except as is before excepted, from the time that you shall take the said office upon you and by virtue of this present

The Right Honourable the Governor-General in Council is pleased to direct that whenever troops from the Presidencies of Fort St. George and Bombay shall be employed to co-operate, directly or indirectly, with troops of the Presidency of Bengal, the officers in command of the troops of the several Presidencies shall report their operations to the Commander-in-Chief in the East Indies, for the information of the Government of India, independently of, and in addition to, any reports, which, under the regulations of the Service, such officer may be required to make to the Commander-in-Chief and the Government of the Presidency to which they immediately belong.

No. 51. 303

Extract from the Rules of the Imperial Austrian Army, obtained through Her Majesty's Ambassador at Vienna.

All booty taken by the troops in actual fighting in the open country, or on the field of battle, whether public or private property, belongs to the troops, if it is not beyond a doubt the property of another federal state or its subjects.

The quota of each man and of each contingent must be determined by the

rules of each state.

All money, material, provisions, necessaries, and other things captured in any way from or abandoned by the enemy elsewhere than on the field of battle belong to the body of troops which brings them in. The officer in command may grant rewards therefrom.

Extract from the Regulations of the French Army, furnished to the Rev. A. Kinloch from the War Department at Paris.

Article 119 de l'Ordonnance sur le Service des Armées en Campagne (3 Mai 1832).

Ministère de la guerre.

Les prises faites par les partisans leur appartiennent, lorsqu'il a été reconnu qu'elles ne se composent que d'objets enlevés à l'ennemi; elles sont jugées et vendues par les soins du chef de l'état-major et de l'intendant ou sous-intendant au quartier du général qui a ordonné l'expédition, et, autant que possible, en présence d'officiers et de sous-officiers du détachement. Si la troupe n'est pas rentrée, les fonds sont versés chez le payeur, pour être distribués à qui de droit. Quand les prises sont envoyées dans une place, le commandant de cette place supplié au chef de l'état-major.

Les armes et les munitions de guerre ou de bouche ne sont jamais partagées ni vendues; le général en chef détermine l'indemnité à allouer à ceux

qui les ont prises.

Les officiers supérieurs ont chacun cinq parts; les capitaines, quatre; les lieutenants et les sous-lieutenants, trois; les sous-officiers, deux; les caporaux, brigadiers, et soldats, une; le commandant de l'expédition en a six en sus de celles que lui donne son grade.

Quand, dans une prise, il se trouve des chevaux ou d'autres objets apparte-

nant aux habitants, ils leur sont rendus.

Ces diverses dispositions s'appliquent à tout détachement isolé qui fait une prise.

Of Booty.

- § 193. The right to make booty in war can only be obtained with the consent of the State.
- § 194. Those to whom the State has conceded this right become possessed of the articles of booty by the mere act of taking possession of them.
