

Act No. I. of 1865.

PASSED BY THE GOVERNOR OF BOMBAY IN COUNCIL.

[Received the assent of the Governor on the 18th October 1864, and of the Governor General on the 6th January 1865, and published by the Governor of Bombay on the 21st January 1865.]

An Act to provide for the survey, demarcation, assessment and administration of lands held under Government, in the Districts belonging to the Bombay Presidency, and for the registration of the rights and interests of the occupants of the same.

WHEREAS a moderate assessment of Land Revenue is equally conducive Preamble. to the interests of Government and the well-being of its subjects; and whereas it has been and is the desire of Government to equalise assessments, to ascertain and settle the obligations, and to record the rights, interests and privileges of persons and classes owning and occupying land; and whereas it is proper to maintain by law, during their currency, all existing settlements which have been made under the authority of Government; and whereas it is necessary to continue and introduče Revenue Surveys wherever they may be required, in the Presidency of Bombay; It is enacted as follows:—

I. This Act shall be called the "Bombay Survey and Settlement Title and commence. Act," and shall take effect from the date on which the ment of the Act. assent of the Governor General of India thereto shall be published in the Government Gazette of Bombay.

II. The following words or expressions used in this Act are declared to Interpretation. Interp

(c) "Survey Officer" means the Superintendent of Survey, or
 "Survey Officer."
 the Officer in charge of a Survey for the time being, or any person acting under the orders of either.

(d) "Village" includes all lands belonging to any village or "Village." township.

(e) An "alienated village" is a village, held and managed by "Alienated Village." private individuals, exempt from payment of land revenue, or under Act II. or VII. of 1863 of the Council of the Governor of Bombay, or under a grant or lease fixing the Government demand in perpetuity.

(f) "Estate" means any land or interest in land, wherever situated, vested in any person or body of persons, and separately recognised in the public accounts.

(g) "Field" or "Number" means a Revenue Survey division of "Field." "Number." the village lands, of a specified area, upon which a distinct assessment is or may be recorded under a Number in the Survey Register, and in the public accounts of the village.

 (h) "Holding" means the aggregate of the Fields or Numbers in any village entered in the public accounts in the name of one person or body of persons.

 (i) "Recognised share of a Field" means the portion of a Field
 "Recognised share of a entered in the name of any one in the Survey papers Field." or other public accounts.

(j) " Occupant"

(j) "Occupant" is the person whose name is entered authorisedly in the Survey papers, or other public acounts, as responsible to Government for payment of the assessment due upon any Field, or recognised share of a Field.

(k) "Superior holder" is the person having the highest right under
 "Superior holder." Government recognised by the custom of the country, or resting on specific grant, to hold
 land or engage with Government for the land revenue due on account
 of any village or estate.

 (1) "Tenant" is the person holding under an occupant or superior holder, by a right derived from him, and otherwise than by ownership or inheritance.

III. Existing Survey settlements of Land Revenue made, approved, Maintenance of existing settlements of Land Revenue. Maintenance of existing settlements of Land Revenue made, approved, and confirmed under the authority of the Governor in Council shall be, and are hereby declared to be, in force, subject to the provisions of this Act.

IV. It shall be lawful for the Governor in Council, whenever such a Government may direct the extension of a Revenue Survey to any part of the Presidency. to the record and preservation of proprietory and other rights connected with the soil, and such Survey shall be called a Revenue Survey.

V. The control of a Revenue Survey and Settlement, in any part of the Control of Revenue Survey and Settlement, and appointment of Presidency, shall vest in and be exercised by the Governor in Council, who may, from time to time, subject to the general control of the Governor General of India in Council, appoint, for the purpose of carrying out such Survey and Settlement, public servants, under the designation of Commissioner of Survey and Settlement, Superintendent of Survey and Settlement, Settlement Officer, and Assistant, or under such other designation as may seem requisite.

VI. The Governor in Council may confer upon Commissioners, and Government may confer on Survey and Settlement Officers, any of the powers of a Collector, within any

ment Officers the powers of a Collector or Assistant Collector.

any specified charge, and in like manner upon Assistant Superintendents or other Officers, appointed under Section V. of this Act, any of the powers of an Assistant Collector.

The appointment of all subordinate members of the establishment VII.

Appointment, &c. of subordinate members of the Survey establishment.

for Survey and Settlement shall, under such rules as the Governor in Council may from time to time sanction, rest with the Commissioners, Superintendents of Survey

and Settlement, and Settlement Officers, who may at any time, after inquiry recorded in writing, fine, dismiss, suspend or reduce any members of their respective establishments so appointed who shall be remiss or negligent in the discharge of duty, or unfit, from any cause, for the discharge of the same.

Commissioner and Superintendent of Survey and Settlement Officers vested with cognisance of Survey matters and with adjustment of boundary disputes.

VIII.

Subject to the orders of the Governor in Council and to the powers reserved by law to the Revenue Commissioners and Collectors, the Commissioners, Superintendents of Survey and Settlement Officers are vested with the cognisance of all matters connected with Survey and Assessment, and with the adjustment of boundary

disputes according to the provisions hereinafter enacted.

IX. All the proceedings and orders of subordinate Survey Officers are appealable to their respective immediate superiors, and Proceedings and orders all the proceedings and orders of Assistants, or other of subordinate and su. perior Officers appealable. superior Survey Officers, are appealable to the Superintendent of Survey, whose proceedings and orders are subject to the direction and decision of the Commissioner of Survey, or other Officer specially authorised on that behalf, under the general control of the Governor in Council.

X. It shall be lawful for the Superintendent or Officer authorised by

Survey Officer may require by general notice, or by summons, suitable service from owners of land, &c.

him to require by general notice, or by summons, the attendance of owners or occupants of land, in person or by legally constituted agent, duly instructed and able to answer all material questions, and the presence

of Talook and Village Officers, who in their several stations, and capacities, are legally, or by usage, bound to perform service in virtue of their respective offices, and to require from them such assistance in the operations of the Survey,

Survey, and such service in connection therewith, as may not be inconsistent with the position of the individual so called on.

XI. In any district in which a Revenue Survey has been or may be Duly authorised Officers may enter upon lands for purposes connected with Survey and Settlement. and Settlement, any lands, whether belonging to Government or to private individuals, and whether assessed to the public revenue or partially or wholly exempt from assessment.

XII. Clause 1st. It shall be lawful for any Survey Officer, authorised by a Superintendent of Survey, or Settlement Officer, to cause to be erected or repaired, boundary marks of villages or fields, whether cultivated or uncultivated, and to assess all charges incurred thereby on the owners, occupants, or others having an interest therein.

Clause 2nd. Nothing in the preceding Clause shall prevent such Officer Requisition on occupants to erect or repair boundary marks. for mrequiring owners or occupants of land to erect or repair their boundary marks, and, in that case, it shall be competent for him to issue a notification which shall be posted in the Chowree or other public place in the village, directing the owners or occupants of fields to erect or repair, within a specified time, the boundary marks of their respective fields, and, on their failure to comply with the requisition so made, the Survey Officer shall then erect or repair them, as provided in the Clause last preceding; and may recover from the owners or occupants the expenditure made in so doing.

Clause 3rd. A general notification, issued in the manner prescribed in the A general notification held to be good and sufficient notice of requisition. Last Clause, shall be held to be good and sufficient notice to each and every person having any interest in any field within the limits of the village in which such notification is published.

Clause 4th. The size, material, and description of boundary marks shall 2 r be

Description of boundary marks. be such as may be deemed necessary by the Superintendent of Survey, according to the requirements of soil and climate.

XIII. It shall be the duty of every owner or occupant of land, whether Owners of land to point out the boundaries of their holdings. Subject to the payment of land revenue or not, to point out to the Survey Officer, at the time of measurement and of classification, the boundaries of his holding.

If the owner or occupant, or his duly constituted agent, fail to do so, it shall be competent to the Survey Officer, in the absence of the said owner, occupant or agent, to fix the boundary on such other evidence as may be available.

XIV. Clause 1st. In conducting an inquiry respecting boundaries as The Survey Officer may inspect title deeds, &c. when making inquiry respecting boundaries. Survey, or other Officer authorised by him, to call on any owner, occupant, or agent of the owner or occupant, to produce for inspection, all sunnuds, kowls, and leases, and all other title deeds and documents whatever, relating to his land, and if, within a reasonable period, to be fixed in writing by the said Survey Officer, the said owner, occupant or agent fail to produce such documents, the boundaries of the land may forthwith be determined on such evidence as may beavailable.

XVII. When the Patells and other village Officers of any two or Village boundaries may more adjoining villages, and, in cases in which the be settled by agreement. revenues of either village do not belong to Government, the holder thereof or his duly constituted agent, shall voluntarily agree to any given line of boundary as the boundary common to their respective villages, the Survey Officer shall require the said parties to execute an agreement (*razeenama*) to that effect, and shall then mark off the boundary in the manner agreed upon. And any village boundary fixed in this manner shall be held to be formally and finally settled, unless it shall appear on inquiry that the agreement has been obtained by fraud, intimidation, or any illegal means.

XVIII. If the Patells and other village Officers, and, in cases Procedure in cases of where the revenues of either village do not belong disagreement or dispute. to Government, the holder thereof or his duly constituted agent, do not agree to fix the boundaries of their respective villages, in the manner prescribed in the preceding Section, or if there be any pending dispute, then the Survey Officer shall make a survey and plan of the the ground in dispute, exhibiting the land claimed by the contending parties, and all particulars relating thereto, and shall inquire into the claims of the said parties, and thereafter make an award in the case, and such award shall be final, unless reversed or modified on appeal as hereinafter provided. If, however, the revenue of either of the villages concerned be wholly or partially alienated, an award made by a Survey Officer shall not be final unless made or confirmed by the Superintendent of Survey.

XIX. When there is a boundary dispute between a village be-Settlement of boundary disputes between British and Foreign villages. belonging to a Foreign or Native State, the dispute shall be settled in such manner as may be agreed upon by the two Governments, and any settlement so made shall be final.

XX. Clause 1st. If the several parties concerned in a boundary dispute Settlement of boundary disputes by arbitration. agree to submit the settlement thereof to a *punchayet* or arbitration committee, and make application to that effect in writing, the Survey Officer shall require the said parties to nominate a committee of not less than three persons, within a specified time, and if within a period to be fixed by the Survey Officer, the committee so nominated arrive at a decision, such decision, when confirmed by the Superintendent of the Survey, shall be final.

Clause 2nd. Provided that the Superintendent of the Survey shall have power to remit the award, or any of the matters referred to arbitration, to the reconsideration of the same committee, for any of the causes set forth in Section 323 of the Code of Civil Procedure.

Clause 3rd. If the committee appointed in the manner aforesaid fail to effect a settlement of the dispute within the time specified, it shall be the duty of the Survey Officer, unless he see fit to extend the time, to settle the same as otherwise provided in this Act.

XXI. It shall be lawful for the Survey Officer to require the attendance

ACT No. II. of 1865.

PASSED BY THE GOVERNOR OF BOMBAY IN COUNCIL.

- [Received the assent of the Governor of Bombay on the 30th March 1865, and of the Governor General on the 10th May 1865, and published by the Governor of Bombay on the 1st June 1865.]
- An Act to provide for the management of the Municipal affairs of the City of Bombay, and to make better provision for the conservancy and improvement of the City, and for the levying of rates and taxes therein.

WHEREAS it is expedient to consolidate and amend the law relating to the Preamble. provement of the City, and for the levying of rates and taxes therein: It is enacted as follows:--

I. Act XIV. of 1856, (for the conservancy and improvement of the Laws repealed. Money due under the repealed laws may be recovered under the Act. Towns of Calutta, Madras, and Bombay, and the several stations of the Settlement of Prince of Wales' Island, Singapore, and Malacca,) Act XXV. of 1856, (to comprise in one Act the provisions necessary for the assessment and collection of Municipal rates and taxes, in the Towns of Calcutta, Madras, and Bombay, and the several stations of the Settlement of Prince of Wales' Island Singapore, and Malacca,) and Act XVI. of 1860, (to amend Act XIV. of

1856,) so far as they-relate to the City of Bombay, and Act XXV. of 1858, (for appointing Municipal Commissioners, and for raising a fund for Municipal purposes in the Town of Bombay), Act XX. of 1861, (to amend Act XXV. of 1858,) (Bombay) Act VIII. of 1862 (to abate the nuisance arising from the smoke of furnaces in the Town and suburbs of Bombay,) (Bombay) Act XIII. of 1863 (The Vehar Water Works' Act), and (Bombay) 9r Act I. of 1864, (to amend Section VI. of Act XXV. of 1858,) are hereby respectively repealed, except so far as they repeal the whole, or any part of any other Act, and except as to any assessment which shall have been made, or to any act or offence which shall have been done or committed, or to any fine or penalty which shall have been incurred, or to any money which shall have become due, or to any proceedings which shall have been commenced, before this Act shall come into operation. Any sum of money due, or which may become due, under any of the said Acts, may be levied and recovered under the provisions of this Act.

II. The f	ollowing words and expressions in this Act shall have the meanings hereby assigned to them, unless there be something in the subject or context repugnant to such construction :—

"Oath." The word "Oath" shall include any affirmation or declaration lawfully substituted for an oath.

The word "Owner" shall mean the person for the time being receiving the "Owner." rent of the land or premises in connection with which the word is used, whether on his own account, or as agent or trustee for any other person, or who would so receive the same if such land or premises were let to a tenant : Provided that no person receiving the rent of land or premises as agent for another person shall be liable to do anything, by this Act required to be done by the owner of such land or premises, unless he have sufficient funds of the owner to pay for the same; nor shall he be subject to any penalty for omitting to do such act, if he can prove that the default was occasioned by reason of his not having funds of the owner sufficient to defray the expense of doing the act required.

THE CORPORATION OF THE JUSTICES OF THE PEACE FOR THE CITY OF BOMBAY.

III. All Justices of the Peace for the Town and Island of Bombay resident in the City of Bombay, shall, by the name of "The Justices of the Peace for the City of Bombay," be a body corporate.
a common seal, and have power to hold land, and by such name shall sue and be sued.

books, plans, maps, papers, effects, moneys, securities, and other property, moveable and immoveable, of what nature or kind soever, and all interest therein, whether vested, contingent, or in remainder, which shall, on the date when this Act comes into operation, be vested in, or held in trust for the Municipal Commissioners appointed under the said Act XXV. of 1858, or which would have been vested in or held in trust for such Municipal Commissioners but for the passing of this Act, and all such estate and interest of and in the same respectively as shall then be or would have been in, or in trust for the said Municipal Commissioners, or any of them, with all rights of way and other rights and easements now used and enjoyed by the said Municipal Commissioners, shall, on and from the date when this Act comes into operation, be vested in the Justices; and all persons who shall then owe any money to the said Municipal Commissioners, or to any person on behalf of the Municipal Commissioners, shall pay the same to the Commissioner on behalf of the Justices; and all moneys which shall be then due and owing by, or recoverable from the Municipal Commissioners, and all contracts, agreements, mortgages, bonds, covenants, and securities made or entered into before this Act comes into operation, to, with, or in favour of, or by or for the said Municipal Commissioners or any previous Municipal Commissioners for the City of Bombay, or any of them, or any person on behalf of such Municipal Commissioners respectively, and all rights of action and suit arising out of contract or otherwise, shall take effect, and may be proceeded on and enforced, as near as circumstances will admit, in favour of, by, against, and with reference to the Justices, in such manner as the same would have taken effect, and might have been proceeded on and enforced in favour of, by, against, and with reference to the said Municipal Commissioners respectively, or any of them, if this Act had not been passed.

V. No action, suit, prosecution, or other proceeding, whatsoever, com-

take effect both in favour of and against the Justices in the same manner in all respects as the same would have continued and taken effect in relation to the said Municipal Commissioners, or any of them, if this Act had not been passed; and all decrees and orders made, and all fines and penalties imposed and incurred respectively, previously to the coming into operation of this Act, shall and may be enforced, levied, recovered, and proceeded for, and all administrative proceedings commenced previously to the coming into operation of this Act, shall and may be continued, proceeded with, and completed in such or the like manner as if this Act had not been passed, the Justices being, in reference to the matters aforesaid, in all respects aforesaid, in the place of the said Municipal Commissioners.

THE MUNICIPAL FUND.

VI. All moneys received by or on behalf of the Justices by virtue of this or any other Act, all rates, taxes, fines, fees, and penalties paid to or levied by them under this Act, and all moneys which may be assigned by Government for purposes of conservancy or improvement in the City, shall constitute a fund which shall be called "The Municipal Fund of the City of Bombay," and shall, together with all property of what nature or kind soever which may become vested in the Justices, be under the direction, management, and control of the Justices, in the manner hereinafter provided, and shall be held and applied by them as Trustees for the purposes of this Act.

VII. The Municipal Commissioner, as hereinafter appointed, shall pay Annual payment on account of the Vehar Water-works. to the Governor in Council out of the Municipal Fund an annual sum not less than one hundred and seventy-five thousand Rupees on account of the expense which has been incurred by Government in the construction of the works called the Vehar Water-works, in the manner hereinafter provided; and such annual payment shall continue to be made until the whole of the expense so incurred, (except such portion thereof, as shall be defrayed by Government out of the public revenue, as hereinafter provided,) with interest thereon, at the rate of four per cent. per annum, shall have been repaid.

The Municipal Commissioner, as hereinafter appointed, shall, VIII. until the complete system of sewerage and drainage within the said City agreed upon between the Governor works. in Council and the Bench of Justices shall have been completed, and all the expenses thereof have been defrayed, and all moneys borrowed for the payment of such expenses and interest thereon shall have been repaid, set apart for the purposes above mentioned, out of the Municipal Fund, an annual sum not less than two hundred and fifty thousand Rupees. If such system of sewerage and drainage has been completed and all the expenses thereof have been defrayed, and all moneys borrowed for the payment of such expenses and interest thereon have been repaid, before the expenses incurred by Government for the construction of the said Vehar Water-works shall have been repaid, the said annual sum of two hundred and fifty thousand Rupees shall be added to the sum of one hundred and seventyfive thousand Rupees directed by the preceding Section to be appropriated annually to the repayment of the expenses of the said works.

The Municipal Commissioner, as hereinafter appointed, shall keep an account of all moneys received and expended on behalf of the Accounts of Lighting and Police rates Lighting rate, and also of all moneys received and expended and other accounts on account of the Police rate, apart and distinct from to be kept separately from each other. each other and from any other accounts to be kept under this Act.

X. All money received by the Justices in respect of the Municipal Fund, and all fines, fees, and penalties levied by them or Where the Fund shall be lodged and their Officers under this Act shall be lodged with the Bank how drawn against. of Bombay or such other Bank as may hereafter be appointed to conduct the business of Her Majesty's Treasury in Bombay. All cxpenses to be incurred and paid for by the Municipal Commissioner under this Act shall be discharged out of the Municipal Fund, and all orders or cheques against the said Fund shall be signed by the Municipal Commissioner, and countersigned by the Controller of Municipal Accounts, and it shall be lawful for the said Bank to pay all orders or cheques against the said Fund which are signed and countersigned as aforesaid.

Appointment of a Commissioner as Executive Officer for the purposes of the Act.

XI.

The entire executive power and responsibility for the purposes of this Act shall be vested in one Commissioner, who shall be appointed by the Governor in Council, for a term of three years, and shall be eligible for re-appointment, provided that he shall always be removeable from office by the

Governor in Council for misconduct, or neglect of, or incapacity to perform, his duty, or at the recommendation of not less than two-thirds of the Justices of the Peace, present at a Special General Meeting of the Justices.

XII. The said Commissioner shall be styled "Municipal Commissioner for the City of Bombay." He shall receive such allowances out of the Municipal Fund, to be raised under this Act, as shall from time to time be fixed by the Justices : Provided that these allowances shall not be less than three thousand Rupees a month. He shall not hold any other appointment, nor follow any other occupation, and shall devote his whole time and attention to the duties of his office.

XIII. The Governor in Council shall also appoint a Controller of Muni-

Appointment and remuneration of a Controller of Municipal Accounts.

cipal Accounts, who shall generally supervise the receipts and disbursements of the Municipal Fund, and shall have charge of all Municipal Accounts. The Controller's countersignature shall be necessary upon all cheques drawn

against the Municipal Fund, and he shall have power to correspond direct with the Justices and with the Governor in Council : Provided that should he refuse his countersignature to any cheque drawn by the Commissioner, he shall be bound to report the same with full reasons within six hours to the Justices, and to the Governor in Council. The Controller shall be appointed for a term of three years and shall be eligible for re-appointment, provided that he shall always be removeable from office by the Governor in Council for misconduct, or neglect of, or incapacity to perform, his duty, or at the recommendation of not less than two-thirds of the Justices of the Peace, present at a Special General Meeting of the Justices. The said Officer shall receive such allowances out of the Municipal Fund as shall from time to time be fixed by the Justices : Provided that these allowances shall not be less than one thousand

five hundred Rupees a month. He shall not hold any other appointment and shall devote the whole of his time and attention to the duties of his office.

XIV. The Governor in Council shall also appoint an Executive Engineer, who shall be in all things under the immediate Appointment and remuneration of an orders of the Municipal Commissioner. The said Officer Executive Engineer. shall be appointed for a term of three years, and shall be eligible for re-appointment, provided that he shall always be removeable from office by the Governor in Council for misconduct, or neglect of, or incapacity to perform, his duty, or at the recommendation of not less than two-thirds of the Justices of the Peace, present at a Special General Meeting of the Justices. The said Officer shall receive such allowances out of the Municipal Fund of Bombay as shall from time to time be fixed by the Justices: Provided that these allowances shall not be less than two thousand Rupees a month. The said Officer shall not hold any other appointment, and shall devote the whole of his time and attention to the dutics of his office.

XV. The Governor in Council shall also appoint a proper person, being a legally qualified Medical Practitioner, to be and Appointment and remuneration of a to be called the Consulting Officer of Health, who shall Consulting Officer of be appointed for a term of three years, and shall be eligible Health. for re-appointment, provided always that he shall be removeable by the Governor in Council for misconduct, neglect of, or incapacity to perform, his duty, or at the recommendation of the Commissioner, or of the Justices; and he shall afford such advice to the Commissioner for the sanitary improvement of the City of Bombay as his experience and observation may indicate. The said Officer shall not be precluded from holding any other appointment or office which may not interfere with the performance of his duty as aforesaid, and he shall receive a salary of not less than five hundred Rupees a month from the Municipal Fund.

The Commissioner may, from time to time, appoint such Assistant Commissioners, Collectors of Taxes, Assessors, Appointment and remuneration of As-Overseers, Clerks and subordinate Officers and servants as sistantCommissioners, Collectors of Taxes, he shall think necessary and proper to assist in the execu-

Assessors, Overseers, tion of this Act, and may, from time to time, remove any Clerks, and suborof such persons and appoint others in their place; and dinate Officers and servants. out of the Municipal Fund he may, with the sanction of the Justices at a Special General Meeting, pay such allowances to the said persons respectively as he shall think reasonable, or in case of absence on leave, such portion thereof, as is hereinafter provided : Provided that no office shall be created, nor any person removed from any office, the monthly salary of which in either case exceeds three hundred Rupees, without the sanction of the Justices at a Special General Meeting.

The Commissioner shall, with the sanction of the Justices and of XIX. the Governor in Council, in the manner hereinafter provided. Allowances during absence on leave. make bye-laws authorising or restricting the payment to Officers of allowances during absence on leave granted under the last preceding Section: Provided that, in the case of Officers appointed by the Governor in Council under this Act, the Governor in Council shall fix the allowance to be paid during such absence on leave as shall to him seem proper; and provided that no greater expenditure from the Municipal Fund shall be in any case incurred in the whole, by reason of any such allowance, than would have been incurred had no leave been granted.

MODE OF TRANSACTING BUSINESS.

XXII. There shall be four Quarterly Meetings in every year, at which the Justices shall meet for the transaction of general busi-Time for holding Quarterly Meetings. ness, and it shall be necessary to give notice of the business to be transacted at such Meetings. The Quarterly Meetings shall be held on the first Monday in the months of January, April, July and October, or as soon after as shall seem expedient to the Chairman of the Justices. Notice of the business to be transacted at such Meetings shall be published in the Government Gazette, and in at least one of the daily English newspapers, and in two Vernacular newspapers published in Bombay, at least seven days before the Meeting.

XXIII. The Chairman of the Justices may, whenever he thinks fit, and shall, upon a written requisition signed by any five Justices, General Special Meetings may be call a Special General Meeting of the Justices. Previcalled. ously to any such Meeting being held, at least seven days' clear notice, specifying the time and place of such intended Meeting, and the purpose for which it is to be held, shall be given by advertisement in the Government Gazette, and in at least one of the daily English newspapers, and in two Vernacular newspapers published in Bombay.

XXIV. No business shall be brought before or transacted at any Meeting, other than the business specified in the notices given under the two preceding Sections: Provided always that Meetings.

yond the matters mentioned in the notice given of such Meeting, if he shall have given previous notice of his intention to do so, by leaving a copy of the Resolution at the office of the Clerk of the Justices of the Peace, to be published in at least one of the daily English newspapers and in two Vernacular newspapers in Bombay, not less than four days before the said Meeting.

XXV. All acts authorized or required to be done by the Justices, and all All questions to be decided at Meetings by majority of votes. Quarterly or Special General Meeting before which the matter may be brought.

XXVI. The Chairman of the Justices shall preside at every such Meeting, Who to preside at Meetings of the Justices. Meeting shall have a second or casting vote in all cases of equality of votes. In the absence of the Chairman, the Justices present at any Meeting shall choose some one of their number to

preside, who shall for that Meeting have all the power of the Chairman. The President of any Meeting at which a quorum of the Justices shall be present, may, with the consent of the Meeting, adjourn the Meeting from time to time and from place to place; but no business shall be transacted at any adjourned Meeting, other than the business left unfinished at the Meeting from which such adjournment took place.

XXVII. No business shall be transacted at any Meeting unless a quorum

What shall constitute a quorum. of Justices be present; that is to say, unless at least seven Justices be present at a Quarterly Meeting, and unless at least twenty-five Justices be present at a Special General

Meeting: Provided always that, if at any Meeting of the Justices there shall not be a sufficient number of Justices present to form a quorum, the President (whether he be the Chairman of the Justices or not) shall adjourn the Meeting to such convenient time and place as he shall think fit, and the business which would would have been brought before the original Meeting had there been a quorum present, shall be brought before, and disposed of by the adjourned Meeting in the usual manner, whether there be a quorum of Justices present at such adjourned Meeting or not.

XXVIII. Minutes of the proceedings of all Meetings of the Justices shall Minutes of Proceedings of Justices to be kept, and to be open for inspection. be open at the office of the Clerk of the Justices of the President after times, be open at the office of the Clerk of the Justices of the Peace to the inspection of any Justice without charge, and of any other person on payment of a fee of eight annas.

as follows (that is to say):-(1) Any contract which, if made between private .persons, would by by law required to be in writing, and, if made according to English law, to be under seal, may be made on behalf of the Justices in writing under the common seal of the Justices, and such contract may in the same manner be varied or discharged. (2) Any contract which, if made between private persons, would be by law required to be in writing and signed by the parties to be charged therewith, may be made on behalf of the Justices in writing signed by the Municipal Commissioner, and such contract may in the same manner be varied or discharged. (3) Any contract, which, if made between private persons, would by law be valid, although made verbally only and not reduced into writing, may be made verbally on behalf of the Justices by the Municipal Commissioner, and such contract may in the same way be varied or discharged. And all contracts made according to the provisions herein contained shall be effectual in law, and shall be binding upon the Justices and their successors and all other parties thereto, their heirs, executors, administrators or representatives, as the case may be.

ESTIMATES OF INCOME AND EXPENDITURE; AND AUDIT.

XXXIII. At a Special General Meeting of the Justices, to be held under

The Commissioner to submit an annual Budget of Income and Expenditure to the Justices. this Act in the month of October in each year, the Municipal Commissioner shall lay before the Justices a Budget or Estimate, prepared by him, of the income and expenditure of the Municipality for the year commencing on the

1st of January then next succeeding, in such detail and form as the Justices shall, from time to time, by order passed at a Special General Meeting, direct : Provided always that such Budget shall be completed and printed, and a copy thereof sent by post or otherwise to each of the Justices of the Peace resident within the City, and published in the *Government Gazette*, at least seven days prior to the Meeting before which the Budget is to be laid.

XXXIV. The Budget shall show what expenditure it is proposed to Budget of Expenditure. in which it is proposed to meet such expenditure.

XXXV. It shall be in the discretion of the Justices to pass, or to reject, Revision and passing of estimates. No new work, not budgeted for, the esti-

mated cost of which exceeds Rs. 500, to be commenced without the sanction of the Justices. or series of works, not provided for in the Budget, the estimated cost of which shall exceed five hundred Rupees, shall be commenced without the sanction of the Justices previously obtained.

XXXVI. The accounts of the receipts and expenditure of the Muni-

Accounts to be audited and examined. Remuneration of Auditors. cipal Commissioner on behalf of the Justices shall be audited and examined once every year, at the least, at such time and by such Auditors as shall from time to time be appointed by the Justices. For the purposes of any audit and

examination of accounts under this Act, the Auditors may. by summons in writing, require the production before them of all books, deeds, contracts accounts, vouchers, and all other documents and papers which they may deem necessary, and may require any person holding or accountable for any such books, deeds, contracts, accounts, vouchers, documents or papers, to appear before them at any such audit and examination, or adjournment thereof, and to make and sign a declaration with respect to the same; and if any such person neglect or refuse so to do, or to produce any such books, deeds, contracts, accounts, vouchers, documents, or papers, or to make or sign such declaration, he shall be liable, for every neglect or refusal, to a penalty not exceeding one hundred Rupees. All Auditors acting under this Act shall, in respect of each audit, be paid out of the Municipal Fund such reasonable remuneration as

the Justices shall, from time to time, determine: Provided that always before each audit and examination of accounts

under this Act the Municipal Commissioner shall give ten days' notice of the time and place at which the same will be made, by advertisement in the *Government Gazette*, and in at least one of the daily English newspapers, and in two Vernacular newspapers, published in Bombay, and a copy of the accounts to be audited and examined shall be deposited in the office of the Commissioner, and be opened during office hours thereat to the inspection of all persons interested, for seven days before the audit and examination; and all such persons shall be at liberty to take copies of, or extracts from the same, without the payment of any fee; and within fourteen days after the audit and examination shall have been completed, the Auditors shall report upon the accounts audited and examined, and shall deliver such report to the Justices at a Meeting, who shall cause the same to be deposited in the office of the Commissioner, and to be published in the Government Gazette, and in some one or more of the said newspapers.

LEVY OF RATES AND TAXES.

XXXVII. It is hereby enacted that any sum of money, which would have become due from any owner or occupier in respect of the Rates due under any previous Act may assessments due under any previous Act, may be levied and be recovered by the Commissioner. recovered by the Municipal Commissioner in like manner as the same might have been levied and recovered if this Act had not been passed, unless the Justices shall impose and levy any other rate under the provisions of this Act as hereinafter provided.

XXXVIII. At the Special General Meeting, to be held in accordance with Section XXXIII., the Justices shall fix the rates at Rates and taxes to be fixed at the Special which such rates and taxes as are leviable under this Act General Meeting in October in each year. shall be levied for the year commencing on the first day of January next ensuing. The rates and taxes so fixed shall not be altered before the next succeeding month of October.

TAXES ON CARRIAGES, HORSES, PONIES AND MULES.

XXXIX. A tax shall be levied on all carriages, carts, hackeries, horses, ponies, and mules, kept within the said City, and Tax on Carriages, upon all carts and hackeries plying for hire within the &c. said City, or let for hire and used within the said City, and kept at any place beyond the limits thereof, at the rates specified in Schedule (A), and shall be payable quarterly by the owners or persons having charge of the same : Provided that the Justices may reduce, alter, or modify this tax, as they may deem

Proviso. fit, but may not increase the rates specified in the said Schedule, and provided that this Section shall not apply to or include gun-carriages, or Ordnance carts, or waggons, Artillery and Cavalry horses, or horses of the Mounted Police, or the respectively authorized number of horses belonging to Officers doing Staff, Regimental, or other duty at the Presidency, of vehicles, horses, ponies, or mules belonging to the Government; or to the Corporation

Corporation of the Justices of the Peace for the City of Bombay, or vehicles kept for sale, and not used for any other purpose, if kept by bond fide dealers in such vehicles: Provided also that, with the exception of labour-carts, all conveyances licensed under (Bombay) Act VI. of 1863, and all animals bond fide kept for drawing such conveyances, shall be subject only to one-half of the rates chargeable in respect of such conveyances or animals.

Every person who may have owned or had charge of any vehicle XL. or animal kept within the said City for any portion of a quarter, shall be liable for the whole tax of that quarter : Possession for a part of a quarter in-Provided that in case any such person has kept or had volves liability for the whole quarter. charge of any vehicle or animal for a period less than thirty Proviso. days, the Commissioner shall remit two-thirds of the tax for the quarter.

The Schedule shall be filled up in writing and signed and dated, and returned to the office of the Commissioner by every person to whom it has been sent, whether or not liable to the payment of such taxes; and whoever refuses, neglects, or omits duly to fill up and return such Schedules within one week from the receipt thereof, or knowingly gives therein any incorrect or false return, shall be respectively liable, on conviction before a Magistrate, to the penalties provided by Sections 176 and 177 of THE INDIAN PENAL CODE.

XLV. It shall be lawful for the Commissioner, or any person or persons

Power to inspect stable, &c., and to summon persons liable to the payment of the tax. appointed by him for that purpose, at any time, between sunrise and sunset, to enter and inspect any stable or coach-house, or any place wherein he may have reason to believe that there is any vehicle or animal liable to taxation under Section XXXIX. of this Act; and the Commissioner

may summon any person whom he has reason to believe to be liable to the payment of any tax under the last mentioned Section, or any servant of such person, and may examine such person or servant as to the number and description of the horses and carriages in respect of which such person is liable to be taxed.

XLVI. Whoever on being summoned under the preceding Section

Penalty for disobeying summons, or hindering the Commissioner. fails, without lawful excuse, to appear in pursuance of the summons, shall be liable, on conviction before a Magistrate, to the penalty provided by Section 174 of THE INDIAN PENAL CODE; and whoever hinders or obstructs the Com-

missioner, or any person appointed by him as aforesaid, from entering or inspecting or leaving any such stable, coach-house, or place, shall be liable, on conviction before a Magistrate, to the penalty provided by Section 186 of the aforenamed Code for obstructing a public servant.

RATES ON HOUSES, BUILDINGS, AND LANDS, AND LIGHTING RATE.

XLVII. An annual rate of five per centum of their annual value shall be levied upon houses, buildings, and lands in the said City, and shall be payable by the owners thereof in quarterly instalments: Provided that it shall be lawful for the Governor in Council, on a resolution passed by the Justices at a Special General Meeting, to fix, from time to time, in lieu of the said annual rate of of five per centum, any higher annual rate not exceeding ten per centum. Any rate so fixed shall be published in the Government Gazette before the commencement of the year in which such rate is to have effect.

XLVIII. In estimating the annual value of any houses or buildings

liable to be rated under Section XLVII. of this Act, whenever the owner of any such houses or buildings lets the same to any tenant who sublets the same at a higher rent than he pays to such owner, such owner shall only be liable to be rated under Section XLVII. upon the gross amount of rent which he is entitled to receive from such tenant, and as to difference between such last mentioned rent and the gross amount of rent payable to such tenant by his sub-tenant or sub-tenants, such tenant shall, for the purposes of being rated under Section XLVII., be deemed to be the owner.

Buildings exclusively devoted to public worship or charitable XLIX. purposes, and buildings owned by Government, or by the Corporation of the Justices of the Peace for the City of Exemptions. Bombay, shall be exempt from the rate.

L. When any house shall have been vacant for sixty consecutive days during any year, the Commissioner shall remit so much of Remission on account of vacant houses. the rate for that year as may be proportionate to the number of days the said house may have remained unoccupied: Provided that the

owner of such house, or his agent, shall have given notice in writing of the vacancy thereof to the Commissioner; and

that the amount of rate to be remitted shall be calculated from the date of the delivery of such notice.

The Commissioner shall provide lamps, lamp-posts, and such other means as he may deem necessary for lighting such of the Lighting of public public streets as he shall consider to require lighting, and streets. shall cause the said lamps to be kept in fit order, and shall

employ a sufficient number of persons to cleanse, prepare, and light the same, and and shall also, from time to time, increase or otherwise alter the number and situation of the said lamps, as to him shall appear necessary.

LII. To provide for the lighting of the public streets of the City by gas,

Lighting rate. the Justices may, as soon as gas can be provided for the same or any part thereof, levy an annual lighting rate upon the occupiers of all houses, buildings, and lands in the City, and such rate shall be payable by such instalments and at such times as the Justices shall direct, and shall be assessed and levied in the manner hereinafter mentioned :

LIII. The Commissioner shall, as soon as gas can be provided, cause the

Gross proceeds of lighting rate to be applied for purposes of lighting. public streets of the City to be sufficiently lighted therewith, and the sum applicable annually to the current expenses of so lighting the said streets shall be the gross proceeds of the said lighting-rate and no more ; but the Commis-

sioner may expend out of the Municipal Fund such further sums as may from time to time be requisite for the purchase, setting up and maintaining of lamps, lamp-posts, pipes and other necessary apparatus.

LIV. Every occupier shall be liable to the lighting-rate for the time of his occupation; and when any person shall have been an occupier liable to the rate for time of occupation. Occupier liable to the rate for time of occupation. during which he Proviso. LIV. Every occupier shall be liable to the lighting-rate for the time of his occupation; and when any person shall have been an occupier for a part only of any quarter, the Commissioner shall charge him with only so much of the rate for that quarter as may be proportionate to the number of days buildings exclusively devoted to public worship or charitable purposes, and buildings occupied for public purposes

by Government or the Corporation of the Justices of the Peace for the City of Bombay, and Government buildings occupied by European and Native Officers and Soldiers in the service of Her Majesty doing Regimental duty in the Garrison of Bombay, shall be exempt from the rate.

LV. When any house, or building, or any land is unoccupied, or is let by owner when liable. the owner in apartments, flats, or portions, the owner shall be liable to pay the lighting-rate instead of the occupiers.

LVI. When any person rents any house or building or any land from the owner thereof, and sub-lets the same in apartments, flats, or portions, such person, for the purpose of the lighting rate, shall be held to be the occupier.

LVII. If, during the course of any quarter, the Commissioner shall have reason to believe that any person who, if the current quarter had come to an end, would be liable to pay the house-rate had come to an end, would be liable to pay the house-rate or the lighting rate for that quarter is about to remove from the City during a quarter, may be made at once to pay such rate up to date.

LIX. For the purpose of such assessment as aforesaid, the Commissioner

Valuation to be made and entered in a book. shall, from year to year, cause a valuation to be made of all houses, buildings, and lands liable to the said rates; such valuation estimated as hereinbefore provided shall be entered in a book, to be kept in the Office of the Com-

missioner, and to be called "the Assessment Book," wherein shall also be written in such form as the Commissioner shall direct, the name of the owner of the property, or if the occupier, and not the owner, is the person liable to pay the rate, the name of the occupier, a designation of the property, either by name or number, sufficient to identify the same, together with the name of the street or district in which such property is situate, and the amount of the rate assessed thereon.

Provise. and assessment shall be given in the manner prescribed in Section LXIII. of this Act; and the provisions of the said Section, and of the three following Sections shall be applicable to the valuation and assessment, and to the book or books in which it is contained.

LXVIII. Appeals against any rate or tax assessed under the provisions

LXX. The assessment by the Commissioner of any rate or tax when Assessment, when no appeal is made, to be final. Adjudications under Section 68 also final.

LXXI. When any rate or tax is due the Commissioner shall cause bill to be presented. Bill to be presented. bill for the sum due, which shall also contain a statement of the period, and a description of the property or thing for which the rate or tax is charged. If the bill be for any tax, it shall also contain a notice of the time within which an appeal against such tax may be preferred.

LXXII. If the bill is not paid by the person liable to pay the same within Notice of demand. Notice of demand. in the form contained in the Schedule (B) to this Act, or to the like effect; and if he do not, within five days from the service of such notice of demand, pay the sum due, or show sufficient cause for non-payment of the same to the satisfaction of the Commissioner, and if no appeal shall have been preferred, such sum with all costs may be levied by distress and sale of the goods and chat-

Distress. tels of the defaulter; or if the defaulter be the occupier of any house, building, or land, in respect of which a rate is due, by distress and sale of any goods and chattels found on the premises, under a warrant in the form in the Schedule (C), or to the like effect, to be issued for that purpose by the Commissioner. For every notice of demand under this Section which the Commissioner shall cause to be served upon any person, a fee not exceeding one Rupee, the amount of which shall be in each case fixed:

fixed by the Commissioner, shall be paid by such person. Such fee shall be added to the amount of the rate in respect of which the notice is given, and if not duly paid, shall be levied in the same manner as such rate may be levied.

LXXXI. The Vehar Lake in the Island of Salsette and all land

The Vehar Lake and Works vested in the Justices. adjacent thereto up to the level of the embankment on the southern side thereof, and included within the limits delineated in a plan deposited in the Office of the Secretary

to the Government of Bombay, and authenticated by the signatures of the Governor and Members of Council, and marked A, and all the land and other immoveable property which is necessary for the purpose of conveying the water of the said Lake by pipes into the Town of Bombay, and there distributing the same, and which, being the property of Government, has ordinarily been applied to, or employed for, the purposes aforesaid, and which is now vested for a term of 99 years, commencing on the 1st day of July 1863, in the Municipal Commissioners for the Town and Island of Bombay, shall, from and after the day on which this Act comes into operation, be vested for the residue of the said term in the Justices, in trust for the purposes of this Act and subject to the conditions hereinafter provided; and it shall be lawful for the Governor in Council at the end of the period of 99 years aforesaid to order that the said property shall vest, and the same shall in such case vest in the said Justices on the conditions and for the purposes aforesaid for such further period not exceeding 99 years from the day on which the said term shall expire as shall seem expedient : Provided that

Proviso.

on the expiration of the said first term of 99 years, or of

any further term for which the Governor in Council may have ordered that the said property shall vest in the said Justices, all rights and every power conveyed to the said Justices under this Act shall forthwith cease and determine, and the said property shall revert to and become vested in the Governor in Council as the same were vested in the said Governor in Council before the 1st day of July 1863.

LXXXII. From and after the date when this Act comes into operation, the said Water Works and the business thereof shall be exclusively managed and conducted by the Commissioner, who shall be bound to keep the said Water Works and the property pertaining thereto in good repair and effective for the proper purposes of the same, and the Commissioner shall make such extensions, improvements, and alterations in the said Water Works and property as may be necessary, and for such purposes may. with the sanction of the Justices, expend such sums as may be necessary out of the Municipal Fund, subject however to such prohibitions and limitations as the Governor in Council may in any case think fit to prescribe.

It shall be lawful, whenever the same may be necessary in LXXXIII. order to repair, improve, extend, renew, or examine the Access to land and Lake, conducting pipes, or any other portion of the Water conduits. &c. Works aforesaid, for the Commissioner and his scrvants,

having authority either general or special in writing from the Commissioner. at all reasonable times, to enter upon and pass through any land or other property adjacent to the same or in the neighbourhood thereof, in whomsoever such property may be vested, and to convey into and through the said land or other property such materials, tools, and instruments as may be necessary for the purposes aforesaid; and any person obstructing such entrance or passage, or conveyance, shall, on conviction before any Magistrate, be liable to a fine not exceeding fifty Rupees, commutable, if not paid, to one month's simple imprisonment: Provided that all damage

done to land or other property by the said Commis-Proviso. sioner or his servants in the exercise of the powers by this Section conferred, shall be made good by the Commissioner on behalf of the Justices to the owners of the same.

LXXXIV. Whereas a sum in excess of the original estimate of twentyfive lakhs of Rupees has been expended in the construc-All sums expended on the Vehar Water tion of the Vehar Lake and Water Works, and in purchas-Works in excess of a certain sum to be deing up the interests of the tenants or occupants of the site fraved from Public of the said Lake and Works, and whereas it has been Revenue. The sum due to Government agreed that one-half of all sums so expended in excess of on account of the Works on the 1st twenty-five lakhs of Rupees shall be defrayed out of the July 1863 how to be Public revenue, it is hereby enacted that all sums in excess

of Rupees forty-five lakhs forty-two thousand three hundred and ninety-four, expended for the Vehar Water Works as aforesaid, shall be held to have

been defrayed out of the Public revenue, and that the sum of Rupees thirty. seven lakhs thirty thousand and fifty-three shall be held to have been the sum due to the Governor in Council on account of the said works on the 1st day of July 1863; and the said sum of Rupees thirty-seven lakhs thirty thousand and fifty-three, with simple interest at the rate of four per cent. per annum from the 1st day of July 1863, together with all sums advanced by Government in connection with the said works since the said 1st day of July 1863, with simple interest thereon at the rate of four per cent. per annum, shall be repaid by the Commissioner on behalf of the Justices to the Governor in Council in annual sums as in Sections VII. and VIII. of this Act provided, which annual sums shall be appropriated, first, to the payment of the interest accrued on account of the said sum of Rupees thirty-seven lakhs thirty thousand and fifty-three from the 1st day of July 1863; secondly, to the payment of interest on all sums subsequently advanced as aforesaid, and lastly, to the payment of all sums subsequently advanced as aforesaid, and then to the liquidation of the said principal sum of Rupees thirty-seven lakhs thirty thousand and fifty-three: Provided that all sums received by

the Governor in Council on account of the said Water Works, under the provisions of Sections XXX, and XXXI.

of Act XXV. of 1858, after the said 1st day of July 1863, and before this Act comes into operation, shall be credited to the said Justices as having been paid on their account and received by the Governor in Council in liquidation of the amount payable as aforesaid by the Commissioner on their behalf, and provided that if the Commissioner shall in any year fail, on behalf of the Justices, to pay to the Governor in Council on or before the 1st day of July, such sums as are in Sections VII. and VIII. of this Act prescribed, and shall, after notice in writing signed by one of the Secretaries to Government, requiring payment of the same, has been served upon him, and has been published in the *Government Gazette* for at least two months, still fail to make such payment on behalf of the Justices, the said Vehar Water Works and all the moveable and immoveable property appertaining thereto hereby vested in the Justices, shall cease so to vest and shall forthwith become vested in the Governor in Council in trust for the purposes for which it was previously vested in the Justices.

LXXXV.

Water-rates may be levied by the Municipal Commissioner.

LXXXV.

From and after the day upon which this Act comes into operation, it shall be lawful for the Commissioner with the consent of the Justices and the sanction of the Governor in Council to impose such annual or other periodical water rates for the supply of water from the said Vehar Water

Works as may be sufficient for the maintenance, repair, extension, improvement, and other expenses connected with the said works as hereinafter provided, upon the occupiers of houses, wharves, and other structures, and of all works and places whatsoever so supplied with water, and thereafter with the like consent and sanction so to alter the said rates as may be necessary or expedient, and such rates shall be assessed and levied by the Commissioner in like manner as other rates payable under the provisions of this Act.

LXXXVI. It shall be lawful for the Commissioner to supply water to any

Commissioner may supply water by measurement and by contract.

person from the said Water Works, in such quantities and on such terms and conditions as shall seem fit, and to contract for the supply of such water for any purpose whatever to any person without measurement at a

reasonable fixed rate, and all moneys due to the Commissioner on behalf of the Justices on account of any water so supplied shall be recoverable in like manner as the other rates payable under the provisions of this Act.

Penalty for fraudulent disposal of water.

LXXXVII. Every person liable to the payment of any rate or price to the Commissioner on behalf of the Justices for any water supplied to him from the said Vehar Water Works upon certain conditions as to theuse of the same, who shall fraudulently dispose of such water to other persons or for

purposes in violation of the said conditions, shall be liable, on conviction before any Magistrate, to a fine not exceeding one hundred Rupees, and in default of payment of such fine, shall be punished with simple imprisonment for a period not exceeding one month.

LXXXVIII. The Commissioner shall at all reasonable times permit all persons appointed by the Governor in Council on that Inspection of Works by Government Offibehalf, to enter upon, and inspect, and take account cers. of all the property by this Act vested, or which, in

virtue of the same, may become vested in the Justices; and the persons

so appointed as aforesaid shall be entitled to enter upon and pass through any property adjacent to, or in the neighbourhood of, the said Vehar Lake and Water Works, or any part thereof, subject to the same conditions as the Commissioner, and if from the report of any person appointed as aforesaid it shall appear that the said Lake or Water Works or any portion of the same are not in a sound and effective condition, it shall be lawful for the Governor in Council by notice, under the signature of a Secretary to Government, to call upon the said Commissioner on behalf of the Justices to repair, improve, and make effective the said Lake or Works or portion thereof within such a period as may seem reasonable, and the said Commissioner shall be bound within such period to comply with such requisition. failing which the Governor in Council may immediately, on the expiration of such period, order the said Lake or Works or portion thereof to be repaired, improved, and made effective, in such manner and by such means as shall seem fit, and the Commissioner shall, on behalf of the Justices, in any such case, be bound forthwith to pay to the Governor in Council the cost of the work so performed, in addition to any other sums payable by him on their behalf.

LXXXIX. The Commissioner shall keep accounts of all receipts and Municipal Commis-

sioner to keep accounts. Statement of accounts to be published.

disbursements on behalf or by reason of the said Vehar Water Works, apart and distinct from any other accounts. and shall annually present to Government and cause to be published in the Government Gazette, a statement of such accounts, and the said accounts shall at all reasonable times

be open to examination and audit by any person appointed on that behalf by Government, and if upon the report of the person so appointed it shall appear that the said accounts are falsely, erroneously, or negligently kept, it shall be lawful for the Governor in Council to order the same to be corrected, and to be kept in future with due diligence according to such plan as Government may prescribe, and the Commissioner shall be bound to conform to such order.

XC. If from any such annual report of the Commissioner or any Disposal of surplus report of an examiner appointed by the Governor in funds. When water Council as aforesaid, it shall appear that after paying rates may be reduced.

to Government the sums due under this Act, and after providing for the repairs and maintenance of the Lake and Water Works and the payment of necessary salaries, there remains in the hands of the Commissioner or his agents, any surplus of moneys received on account of the Water Works leviable under this Act, it shall be lawful for the Commissioner with the sanction of the Justices to expend the same in such extensions and improvements of the said Works and of the apparatus connected therewith as the Governor in Council may sanction, and if such improvements or extensions shall appear to be necessary, it shall be lawful for the Governor in Council to require that the same may be made; and if it shall appear that the surplus, after providing for such payments to Government and for such expenses of repairs and maintenance as aforesaid, has in any year exceeded the sum of fifty thousand Rupees, the Commissioner may, with the consent of the Justices and with the sanction of the Governor in Council, forthwith impose a new scale of rates and prices, so calculated as to reduce the annual receipts on account of the said Water Works, either by the whole amount by which the same exceed the necessary disbursements on account thereof, or by such sum as shall remain after providing for the extensions and improvements which may properly be made out of the said surplus or profits, and in failure thereof the Governor in Council may order such new scale to be made, or may prescribe a new scale calculated as aforesaid, which new scale the Commissioner shall forthwith adopt, and shall thereafter recover such demands only for supplies of water as are in accordance therewith.

XCI. From and after the day upon which this Act comes into operation, it shall not be lawful for any person to erect any building, &c., within the limits of the water-shed prohibited. building, shed, or other structure, for the purposes of dwelling or manufacture, trade or agriculture, within the limits of the water-shed of the Vehar Lake, as defined in a

plan marked B, and deposited in the Office of the Secretary to the Government of Bombay, and authenticated by the signatures of the Governor and Members of Council, or to extend or alter any such structure heretofore existing within the said limits, or to apply the same to purposes different from those to which it has heretofore been usually applied; and it shall not be lawful within the said limits for any person to carry on any operation of manufacture manufacture, trade, or agriculture, in any manner whereby any injury may arise to the said Lake, or the waters of the same may be fouled or rendered less wholesome; and any person so offending shall, at the prosecution of the Commissioner, on behalf of the Justices, be liable, on conviction before any Magistrate, to imprisonment of either description for any period not exceeding one month, or to a fine of one hundred Rupees, or to both; and it shall further be lawful for the Magistrate in case of any such conviction as aforesaid, to order the immediate removal of such building or structure, and the discontinuance of such operation or use of the land as aforesaid; and in case of disobedience to remove such structure and to prevent such operation or use, and for any opposition to such removal or other disobedience of such order as aforesaid, the offender shall be liable, in each instance, to imprisonment of either description for any period not exceeding one month, or to a fine of one hundred Rupees, or to both.

XCII. All public tanks, reservoirs, cisterns, wells, aqueducts, conduits, tunnels, pipes, pumps, and other water-works existing at the time this Act comes into operation or afterwards made, laid, or erected, and whether made, laid, or erected at the cost of the Justices or otherwise, and all bridges, buildings, engines, works, materials, and things connected therewith, or appertaining thereto, and also any adjacent land (not being private property) appertaining to any public tank, shall be vested in and belong to the Justices.

XCIII. The Commissioner may cause all existing public tanks, reservoirs, Construction and maintenance of works for supply of water. Act, to be continued, maintained and supplied with water, or he may close up such works and substitute other such works, and may cause them to be maintained and supplied with water; and the Commissioner from time to time, with the consent of the Justices, and of the Governor in Council, may construct aqueducts for bringing water into the Town, and may provide any number of new tanks, reservoirs, cisterns, wells, and other such water-works for the purposes aforesaid.

XCIV. No rate shall be charged for the supply of water from any public well, tank, reservoir or the like, from which the public Public wells or tanks free from rate. may or shall ordinarily have drawn water without payment. and the public shall, subject to the Bye-laws authorized under this Act, have free access thereto, and may draw water therefrom without hindrance or payment of any fee whatever.

XCV. Whoever wilfully or carelessly injures any water-works belonging

to the Justices, or unlawfully draws off, diverts, or Injuring watertakes water from any such water-works; or from any works, or diverting or wasting water. waters or stream belonging to the Justices by which such water-works are supplied, shall be punished with fine which may extend to one hundred Rupees.

XCVI. The Commissioner shall cause all necessary works, machinery. engines and assistance for procuring an efficient supply Provision for supof water in cases of fire, to be provided and maintained, ply of water in cases of fire. and shall, with the sanction of the Justices, prepare the

necessary Bye-laws, and shall, further, with the same sanction, arrange Schedules of salaries and rewards in furtherance of the above object.

The Commissioner may cause any number of moveable or Dust-boxes in fixed dust-boxes, or other convenient receptacles, wherein streets. dust, dirt, ashes, and rubbish shall be temporarily deposited, until removed and carried away, to be provided and placed in proper and convenient situations, and may require, by beat of battakee, the occupiers of houses in streets to cause all such matters as aforesaid to be deposited, daily or otherwise, periodically in the said receptacles. Every person who, after such such receptacles have been provided, and after such requisition, as above mentioned, has been made in the street, shall deposit, or cause or permit to be deposited, any such matter in any street, except in such receptacles, shall be punished with fine which may extend to ten Rupees.

CXV. Whoever deposits, or permits his servants to deposit, any dust, dirt, dung, ashes, garden, kitchen, or stable refuse, or filth of any kind, or any animal matter, or any broken glass, or earthenware, or other rubbish, in any street, or on any public quay, jetty, or landing place, or on any part of the sea-shore, whether above or below high water mark, except in such places and in such manner, and at such hours as shall be fixed by the Commissioner, shall be liable to a penalty not exceeding ten Rupees for each offence.

CXVI. Whoever causes or allows the water of any sink or sewer, or any Allowing sewage to other offensive liquid or other matter from his premises, flow on streets. or being on his land, to run, drain, or be thrown or put upon any street, or to soak through a wall in any street, or causes or allows any offensive matter from any sewer or privy to run, drain, or 'be thrown into a surface drain in any street, or allows or causes any water to run on the street, without the permission, in writing, of the Commissioner, shall be punished with fine which may extend to fifty Rupees, and shall also be liable to a further fine of ten Rupees for every day after conviction during which the offence is continued.

CXVII. Whoever, being the occupier of a house in or near any Penalty on occupier of a house for not removing filth. street, keeps or allows to be kept for more than twenty-four hours, or otherwise than in some proper receptacle, any dirt, dung, bones, ashes, night-soil, filth, or any noxious or offensive matter, in or upon such house, or in or upon any out-house, yard, or ground attached to and occupied with such house, or suffers such receptacle to be in a filthy or noxious state, or neglects to employ proper means to remove the filth therefrom and to cleanse and purify the same, shall be liable to a penalty not exceeding fifty Rupees for each offence, and to a further fine of ten Rupees for every day after conviction during which each such offence is continued.

CXXIV. Whoever displaces, takes up or makes any alteration in the Taking up pavements. pavement, gutters, flags, or other materials, or in the fences or posts of any public street, without the consent in writing

of the Commissioner, or without other lawful authority, shall be punished with fine which may extend to fifty Rupees, and shall pay any expense which may be incurred in restoring the street.

CXXV. Every person who wishes to make or lay out any new street shall give notice in writing thereof to the Commissioner, such notice to be accompanied by plans and sections show-

ing the intended level, direction and width of such street. and the level, direction and width of every such street shall be fixed or approved by the Commissioner; and whoever lays out, makes, or builds upon any such streets, otherwise than in accordance with the level, directions, and width so fixed or approved, shall be punished wth fine which may extend to five hundred Rupees, and the Commissioner may, if he thinks fit, cause any such street laid out or made in a direction, or at a level or width otherwise than in accordance with the level, direction or width so fixed or approved as aforesaid, to be altered, or may cause any building erected in any such street otherwise than in accordance with such level and width, to be altered, or if necessary removed, and the expense thereby incurred shall be paid to him by the offender, and be recoverable as hereinafter provided. If no such level or width be fixed, and no approval or disapproval of the level or width proposed be signified by the Commissioner within one month, the intended street may be laid out and made upon the level, in the direction, and of the width specified in the notice : Provided always that no new street, being a carriage

Erection of new huts to be under the control of the Commissioner.

It shall not be lawful for any person to erect any range or block of huts or sheds, whether to be used as dwellings or stables or for any other purposes, on any plot or parcel of ground not previously built upon, or on which no huts

are standing, or to add any hut or huts to any range or block of huts or sheds already existing when this Act comes into operation without previous notice

to

to the Commissioner; and the Commissioner shall require such huts or sheds to be built so that they may stand in regular lines with a free passage or way in front of each line, of such width as the Commissioner may think proper for salutary ventilation, and to facilitate scavengering, and at such a level as will admit of sufficient drainage, and shall require such huts to be provided with a necessary or necessaries which must be maintained in proper order. And if any such huts or sheds be built without giving such notice to the Commissioner, or otherwise than as required by the Commissioner, the Commissioner shall give notice to the builder or builders thereof to take down and remove the same within one month, and if such huts or sheds be not taken down or removed according to such notice, the Commissioner shall cause the same to be taken down and removed, and the expense incurred in doing so shall be paid by the said builder or builders, and shall be recoverable as hereinafter provided.

CXXVII. Whenever the Commissioner is satisfied that any huts or sheds, whether used as dwellings or stables or for any Power of the Commissioner as to existother purposes, and whether existing at the time when this ing huts. Act comes into operation or subsequently erected, are, by

reason of the manner in which the huts or sheds are crowded together, or of the want of drainage and the impracticability of scavengering, attended with risk of disease to the inhabitants or the neighbourhood, he shall cause a notice to be affixed to some conspicuous part of such huts or sheds requiring the owners or occupiers thereof, or at his option the owner of the land on which such huts are built, within such reasonable time as may be fixed by the Commissioner for that purpose, to execute such operations as the Commissioner may deem necessary for the avoidance of such risk. And in case such owners or occupiers shall refuse or neglect to execute such operations within the time appointed, the Commissioner may cause the said huts or sheds to be taken down, or such operations to be performed in respect of such huts or sheds as the Commissioner may deem necessary to prevent such risk. If such huts or sheds be pulled down, the Commissioner shall cause the materials of each hut or shed to be sold separately, if such sale can be effected; and the proceeds shall be paid to the owner of the hut or shed, or if the owner be unknown, or the title disputed; shall be held in deposit by the Commissioner until the person

person interested therein shall obtain the order of a competent Court for the payment of the same. The Court of Small Causes for Bombay shall be deemed a competent Court for that purpose if such proceeds shall not exceed

of the premises fronting, adjoining, or abutting upon, such parts thereof as may need to be levelled, paved, metalled, flagged, channelled, or scwered, require them to level, metal, pave, flag, channel, or sewer the same within a time to be specified in such notice; and upon non-compliance, the Commissioner may, if he think fit, execute the works mentioned or referred to therein; and the expenses incurred by him in so doing shall be paid by the owners in default according to the frontage of their respective premises, and in such proportion as shall be settled by the Commissioner, or in case of dispute, as shall be settled in the manner hereinafter provided for the settlement of disputes respecting damages and expenses; and such expense shall be recoverable as hereinafter provided : Provided always, that, after such street shall have been

so levelled, paved, metalled, flagged, channelled, and Proviso. sewered, on the requisition of the Commissioner, or by the Commissioner as aforesaid, at the expense of the owners, such owners shall have a right to require that the street shall be declared a public street, to be from time to time repaired by the Commissioner out of the Municipal Fund.

CXXIX. If any street (not being a public street) be levelled, paved,

metalled, flagged, channelled, and sewered to the satisfaction of the Commissioner, he may, by notice in writing put up in any part of such street, declare the same to be a public street, and thereupon the same shall become a public street, and be from time to time repaired by him out of the Municipal Fund: Proviso. Provided that no street shall become a public street as last

aforesaid, if, within one month after such notice in writing,

the owner of such street, or any one of the owners, shall, by notice in writing to the Commissioner, object thereto.

CXXX. The Commissioner may, upon such terms as he thinks fit, allow any house or building to be set forward for improving the line of any public street in which such house or building is situated.

CXXXI. When any house or building, any part of which projects beyond Projecting houses when taken down to be set back. the regular line of a public street, or beyond the front of the house or building on either side thereof, has, either entirely or in greater part, been taken down, burned

down or has fallen down, the Commissioner may require the same, when being rebuilt, to be set back to or towards the line of the street or the line of the adjoining houses or buildings, and the portion of land added to the street by so setting back the house or building shall thenceforth be deemed part of the public street and be vested in the Justices: Provided always, that

Proviso. the Commissioner shall make full compensation to the owner of any such house or building for any damage he may thereby sustain; and if any dispute shall arise touching the amount of such compensation, the same shall be ascertained and determined in the manner hereinafter provided.

CXXXII. The Commissioner shall, from time to time, cause to be put up or painted on a conspicuous part of such house, building, wall, or place at or near each end, corner or entrance of every street, the name by which such street is to be known; and whoever destroys, pulls down, or defaces any such name, or puts up any name different from that put up by order of the Commissioner, shall be liable to a penalty not exceeding twenty Rupees for each offence.

CXXXIII. The Commissioner may from time to time fix a number in a conspicuous place on the outer side of any house or building, or at the entrance of the enclosure thereof fronting the the street, and whoever destroys, pulls down, or defaces any such number, shall be liable to a penalty not exceeding twenty Rupees for each offence.

CXXXIV. All ground-floor doors, gates, bars, and windows, put up after this Act comes into operation, which open upon any Ground-floor doors public street, shall be hung or placed so as not to open not to open outwards. outwards except when the same are hung or placed in such manner as, in the judgment of the Commissioner, to cause no obstruction

in any such street, and if (except as aforesaid) any such

Exception.

door, gate, bar, or window be hung or placed so as to open outwards on any such street, the owner of the premises to which the same is attached shall, within eight days after notice from the Commissioner to that effect, cause the same to be altered so as not to open outwards, and in case he neglects so to do, the Commissioner may make such alteration and the expense thereof shall be paid by such owners, and shall be recoverable as hereinafter provided.

Ground-floor doors opening outwards to be altered.

CXXXV. If any ground-floor door, gate, bar, or window put up before this Act comes into operation is hung or placed so as to open outwards upon any public street, the owner of the premises to which the same is attached shall, within eight

days after notice from the Commissioner to that effect, cause the same to be altered so as not to open outwards, and in case he neglects so to do, the Commissioner may make such alteration, and the expense thereof shall be paid by such owners, and shall be recoverable as hereinafter provided.

CXXXVI. The owner of every house or building in any public street

Troughs and pipes to be fixed to houses.

shall within one month after notice from the Commissioner to that effect, put up and keep in good condition, proper troughs and pipes for catching and carrying the water

from the roof and other part of such house or building and for discharging the same in such manner as the Commissioner may direct, so that it shall not fall upon the persons passing along the street; and in default of compliance with such notice within the period aforesaid, such owner shall be liable to a fine, which may extend to ten Rupees for every day that he shall so make default.

CXXXVII.

CXXXVII. The Commissioner may give notice in writing to the owner or occupier of any house or building to remove or alter Projections from any projection, encroachment, or obstruction, which, after houses not to be allowed. this Act comes into operation, shall be erected or placed against or in front of such house or building, if the same overhangs, or juts into, or in any way projects or encroaches upon, or is an obstruction to the safe and convenient passage along any public street, or obstructs, or projects, or encroaches into or upon any uncovered aqueduct, drain, or sewer in such street; and such owner or occupier shall within fourteen days after the service of such notice upon him, remove such projection, encroachment, or obstruction, or alter the same in such manner as shall have been directed by the Commissioner; and in default thereof shall be liable to a fine which may extend to two hundred Rupees; and the Commissioner in such case may remove such projection, encroachment, or obstruction; and the expense of such removal shall be recoverable as hereinafter provided : Provided that, when the

expense shall have been paid by the occupier, except in Proviso. the case in which such projections, encroachments, or obstructions were made or put up by him, such occupier shall be entitled to deduct the expense of removing or altering the same from the rent payable by him to the owner of the house or building.

CXXXVIII. The Commissioner may give notice in writing to the owner or occupier of any house or building to remove Removal of existing projections. or alter any projection, encroachment, or obstruction, which although erected before this Act comes into operation, shall have been erected or placed against or in front of such house or building, if the same overhangs or juts into or in any way projects or encroaches upon any public street, so as to be an obstruction to the safe and convenient passage along such street, or if the same projects or encroaches into or upon any uncovered aqueduct, drain, or sewer in such street so as to obstruct or interfere with such aqueduct, drain, or sewer, or the proper working thereof, and such owner or occupier shall within thirty days after the service of such notice remove such projection, encroachment, or obstruction, or alter the same in such manner as shall have been directed by the Commissioner, and in default thereof

thereof the Commissioner may remove such projection, encroachment or obstruction; and if such projection, encroachment, or obstruction shall have been lawfully made, the Commissioner shall make reasonable compensation to every person who suffers damage by such removal or alteration; and if any dispute shall arise touching the amount of such compensation, the same shall be ascertained and determined in the manner hereinafter provided.

CXXXIX. The Commissioner may give permission in writing to Projecting verandahs, &c. may be made in streets not less than 36 feet wide. feet, to put up open verandahs, balconies, sun-shades. weather-frames and the like, to project from any upper-story thereof over the street to an extent not exceeding four feet beyond the line of the plinth or basement wall.

The external roof and walls of huts, or other buildings crected CXL. or renewed in or near any street after this Act comes into Roofs and external walls not to be of operation, shall not be made of wood, cloth, canvas, grass, inflammable mateleaves, mats, or other such inflammable matters, unless rials. with the consent in writing of the Commissioner, and it shall not be lawful for the owner of any hut or other building in or near any street now having an external roof or wall made of any such material, and which is contiguous to or adjoining to any other building, to suffer such roof or wall to remain for a longer time than one month after this Act comes into operation, unless with the consent in writing of the Commissioner; and whoever makes any external roof or wall of such materials, or suffers any roof or wall made of such materials to continue contrary to the provisions herein contained, and who shall not remove or alter the same within one month after notice given to him for that purpose by the Commissioner, shall be liable to a penalty not exceeding ten Rupees for every day that such roof or wall shall continue. Any person may give information and institute a prosecution under this Section, and all expenses incurred in such prosecutions shall be recoverable from the owner of such hut or other building as hereinafter provided.

CXLI. If, in any street, any house, building, or wall, or any thing Houses in a ruinous and dangerous state. Houses in a ruinous affixed thereon, be deemed by the Commissioner to be in a ruinous state or likely to fall, or in any way dangerous to

the inhabitants of such house or building, or to the neighbouring houses or buildings, or the occupiers thereof, or to passengers, he shall immediately, if it appears to him to be necessary, cause a proper hoard or fence to be put up for the protection of passengers; and shall cause notice in writing to be given to the owner or occupier, requiring such owner or occupier forthwith to take down, secure, or repair such house, building, wall, or thing affixed thereon as the case shall require; and if such owner or occupier do not begin to repair, take down, or secure the same within three days after such notice, and complete such work with due diligence, the Commissioner shall cause all or so much of such house, building, wall, or thing, as he shall think necessary, to be taken down, repaired, or otherwise secured; and all the expenses incurred by the Commissioner shall be paid by the owner or occupier of the premises, and shall be recoverable as hereinafter provided.

CXLII. If any such house, building, or wall, or any part of the same,

Sale of materials of ruinous houses.

be pulled down by virtue of the powers aforesaid, the Commissioner may sell the materials thereof or of so much of the same as shall be taken down, and apply the proceeds of such

sale in payment of the expenses incurred, and shall, on demand, restore any overplus arising from such sale to the owner of such house, building, or wall: Provided always that in case no demand for such overplus as aforesaid shall, within twelve months, be made, by any person entitled to call for the same, the Commissioner shall be at liberty to pay the amount of such overplus to the credit of the Municipal Fund, and shall be freed from any liability to pay or answer for or in respect of such unclaimed overplus. The Commissioner, although he sell such materials for the purposes aforesaid, shall have the same remedies for compelling the payment of so much of the said expenses as may remain due after the application of the proceeds of such sale as by this Act are given to him for compelling the payment of the whole of the said expenses.

CXLIII. If any building, or land, by reason of abandonment of disputed

Power to shut up and secure deserted houses.

ownership or other cause, shall remain untenanted and thereby be a resort of idle and disorderly persons, or be complained of by any two or more of the neighbours as a nuisance, the Commissioner, after due inquiry, may cause notice

notice in writing to be given to the owner, or to the person claiming to be the owner if he be known and resident within the limits of his jurisdiction, and shall also cause such notice to be put on the door of the building or some conspicuous part of the premises, requiring the persons concerned therein, whoever they may be, to secure or enclose the same; and if such notice shall not be complied with within eight days, the Commissioner shall cause the necessary work to be executed, and all expenses thereby incurred shall be paid by the owner of the premises and shall be recoverable as hereinafter provided.

CXLIV. Whoever, being the owner or occupier of any house, building, Filthy houses, &c. or land, in or near any street, whether tenantable or otherwise, suffers the same to be in a filthy and unwholesome state, or, in the opinion of the Commissioner, a nuisance to those in the neighbourhood, or overgrown with rank and noisome vegetation, and who shall not within twenty-four hours after notice in writing by the Commissioner to cleanse, clear or otherwise put the same in a proper state, have complied with the requisition contained in such notice, shall be liable to a penalty not exceeding fifty Rupees, and to a penalty not exceeding five Rupees for every day after conviction for such offence during which the offence is continued: Provided that if the state of the house or building be such as in the judgment

Proviso. of the Commissioner to render it unfit for human habitation, he may further prohibit the using thereof for that purpose until it is so rendered fit.

CXLV. It shall be lawful for the Commissioner, on the recommendation Power to enter and of the Health Officer, any time between sunrise and sunset, cleanse houses and by himself or his servants, on giving such notice as hereinafter provided to enter into and inspect all houses and buildings, and hy an order in writing to direct all or any part to be forthwith internally and externally lime-washed or otherwise cleansed for sanitary reasons; and if the owner or occupier of such house or building neglect to do so, within eight days from the time when such order shall have been served upon him, the Commissioner may cause the same to be done, and the expenses incurred shall be paid by the owner or occupier, and shall be recoverable as hereinafter provided.

CXLVI.

Health Officer may, when he considers it desirable, take steps to abate overcrowding of dwelling houses.

CXLVI.

Whenever the Health Officer shall certify to the Commissioner that any house is so overcrowded as to be dangerous or prejudicial to the health of the inhabitants, and the inhabitants shall consist of more than one family, the Commissioner shall cause proceedings to be taken before

a Magistrate to abate such overcrowding, and the Magistrate shall thereupon make such order as he may think fit, and the person permitting such overcrowding shall be liable to a penalty not exceeding twenty Rupees for each day after the date of such order during which such overcrowding shall continue.

CXLVII. The Commissioner may give notice to the owner or occupier

Power to trim hedges and trees bordering or overhanging roads. of any land so to trim or prune the hedges thereof bordering any public road or street, that the said hedges may not exceed the height of five feet from the level of

the road, and to cut and trim all trees so overhanging any public road or street, as by their stems, branches, leaves, or fruit to endanger or obstruct the passage thereof, or to cause damage thereto: and in the event of such notice not being complied with within eight days from the date thereof, the Commissioner may cause the said hedges and trees to be cut and trimmed in the manner required; and the expense incurred by the Commissioner in respect thereof shall be paid to him by the owner or occupier, and shall be recoverable as hereinafter provided.

CXLVIII. Whoever keeps any pig-stye to the front of any street, not Keeping swine, &c. being shut out therefrom by a sufficient wall or fence, in or near any street. or who shall keep any swine in or near any street, so as, in the opinion of the Commissioner, to be a nuisance to the neighbourhood ; or who shall keep sheep, goats, horned cattle or horses in or near any street, so as to be a nuisance to the neighbourhood, shall be punished with fine which may extend to fifty Rupees, and shall be liable to a further penalty not exceeding ten Rupees for every day during which such offence is continued.

CXLIX. All public sewers and drains, and all sewers, drains, tunnels, Sewers, drains, &c. culverts, gutters and watercourses in alongside, or under vested in the Justices. any street existing at the time this Act comes into operation or afterwards to be made, and whether made at the cost of the Justices or 22r otherwise, othrewise, and in all works, materials, and things appertaining thereto, shall by vested in and belong to the Justices.

The Commissioner shall from time to time cause to be made CL. such main and other sewers, drains and watercourses as he Commissioner to may judge necessary for the effectual draining of the City; make public sewers. and, if needful, he may carry them through, across, or under any street, or any place laid out as or intended for a street, or any cellar or vault which may be under any of the streets, and (after reasonable notice in writing in that behalf) into, through, or under any inclosed or other lands whatsoever, doing as little damage as may be, and making full compensation for any damage done, and if any dispute shall arise touching the amount or apportionment of compensation, the same shall be settled in the manner hereinafter provided for the settlement of disputes respecting damages and expenses.

CLI. The Commissioner shall maintain and from time to time Commissioner to repair and alter and discontinue sewers. by this Act; and may discontinue, close up, or destroy, such of them as he

by this Act; and may discontinue, close up, or destroy, such of them as he may deem useless or unnecessary: Provided always, that the discontinuance,

closing up, or destruction of any of them shall be so done as not to create a nuisance; and if by reason thereof, or of

any such alteration as hereinbefore mentioned, any person is deprived of the lawful use of any sewer, drain, culvert, gutter, or watercourse, the Commissioner shall with due diligence provide some other as effectual as the one of which he is so deprived.

CLHI. The Commissioner shall cause the sewers, drains, culverts, gutters and watercourses belonging to the Justices to be so constructed, maintained, and kept, as not to be a nuisance or injurious to health, and to be properly cleared, cleansed, and emptied; and for the purpose of flushing, cleansing, and emptying the same, he may construct and place, either above or under under ground, such reservoirs, sluices, engines, and other works as may be necessary; and he may also with the sanction of the Justices and of the Government cause all or any of such sewers, drains, culverts, gutters and watercourses to communicate with and be emptied into the sea or other fit place; or he may cause the refuse from the same to be conveyed by a proper channel to the most convenient site for its deposit, and may sell the said refuse for any agricultural or other purposes as may be deemed most expedient, but so that it shall not become a nuisance.

CLIII. Whoever, without the written consent of the Commissioner Penalty for making unauthorized drains into public sewers. Hundred Rupees; and the Commissioner may cause such drain to be demolished, altered, re-made, or otherwise dealt with as he may think fit, and all the expense incurred thereby shall be paid by the person making such drain, and shall be recoverable as hereinafter provided.

CLIV. No building shall be newly erected over any sewer, drain, Buildings over sewers &c. not to be erected without consent of Commissioner. Act, without the written consent of the Commissioner, and if any building be so erected, the Commissioner may cause the same to be pulled down, or otherwise dealt with as he may think fit; and the expenses thereby incurred shall be paid by the person offending and be recoverable as hereinafter provided.

CLV. If any house or building, in or near any street, be at any time not drained to the satisfaction of the Commissioner by a sufficient drain or pipe communicating with some sewer, or drain, or with the sea, or some other place at which the Commissioner is empowered to empty the sewers, and if there be such means of drainage within

one hundred feet of any part of such house or building, the Commissioner may, after giving such notice as is herineafter provided, construct or lay from such house or building a covered drain or pipe of such materials, of such size, at such level, and with such fall as he thinks necessary for the draining

of such house or building; and the expenses incurred by the Commissioner in respect thereof, if not forthwith paid by the owner, shall be recoverable as hereinafter directed.

may cause such drain or privy to be altered, repaired, and put in good order; and the expense incurred by the Commissioner in respect thereof shall be paid by the owner, and shall be recoverable as hereinafter provided.

CLXX. If any such drain, or privy, be constructed, after this Act comes

ed by him to be demolished or stopped up, or not to be made, every person so doing shall be liable to a penalty not exceeding fifty Rupees; and the Commissioner sioner may cause such amendment or alteration to be made in any such drain or privy as he may think fit; and the expense thereof shall be paid by the person by whom such drain or privy was improperly constructed, rebuilt, or unstopped, and shall be recoverable from him as hereinafter provided.

buildings with such assistants and workmen as are necessary, and cause the ground to be opened where he or they may think fit, doing as little damage as . may be, and if upon such inspection it appears that the drain or privy is not in good order and condition, or that it has been constructed after this Act comes into operation contrary to the provisions thereof, the expenses of such inspection shall be paid by the person to whom such drain or privy may belong, and shall be recoverable as hereinafter provided; but if the drain or privy be found to be in proper order and condition, and not to have been constructed in violation of the provisions of this Act, the Commissioner or Officer as aforcsaid shall cause the ground to be closed and made good as soon as may be, and the expense of opening, closing and making good such drain or privy shall in that case be defrayed by the Commissioner.

CLXXII. Whoever, except as permitted by the Commissioner under Section CLXXIV. of this Act, bathes in any stream, tank, or reservoir, well, cistern, conduit, or aqueduct belonging to the Justices, Fouling water by or washes or causes to be washed therein any horse, dog, or other animal, or any wool, cloth, wearing apparel, or any utensils for cooking or other purposes, or leather, or the skin of Bathing, any animal or other foul or offensive thing; or throws, puts, or casts, or causes to enter therein any animal, or any gravel, stone, dust, or rubbish, or any dirt, filth, or other noisome or Washing, offensive matter or thing, or causes or suffers to run, drain, or be brought thereinto, the water of any sink, sewer, drain, engine, or boiler, or any other unwholesome or offensive liquid Throwing rubbish, matter or thing belonging to him, or flowing from &c. any house or building or from any ground occupied

by

by him, or does any thing whatsoever whereby any such water shall be in any degree fouled or corrupted, shall be liable, on Allowing drains, conviction before a Magistrate, to the penalty provided &c. to flow. for fouling the water of any public spring or reservoir by Section 277 of the Indian Penal Code.

CLXXIII.

Whoever, being the proprietor or manager of any gas works, or being engaged or employed in the manufacture or supply of gas, or being the occupier or proprietor of any place where an offensive trade or manufacture is carried

on, wilfully does any act connected with the said business whereby the any tank, reservoir, well, cistern, conduit, aqueduct, or water in other water-works belonging to the Jutices, is fouled or corrupted, shall be punished with fine which may extend to one thousand Rupees, and to a further penalty not exceeding five hundred Rupees for every day while the offence is continued after twenty-four hours' notice in writing from the Commissioner on this behalf; and the Commissioner may after twenty-four hours' notice in writing, lay open and examine any pipes, conduits, and works belonging to such person; and if, upon such examination, it appears that the water has been fouled or corrupted by any thing proceeding from or contained in the pipes, conduits,* or works examined, the expenses of such examination shall be paid by the person to whom such pipes, conduits, or works belong, or under whose management or control they may be, and be recoverable from him as hereinafter provided. But if it appear that the water has not been so fouled or corrupted, then such expenses and all reasonable damages occasioned by the examination, shall be paid by the Commissioner from the Municipal Fund. In all cases when land is required for the purpose of carrying out the provisions of this Act, such purpose shall be and be deemed to be a public purpose within the meaning of Act VI. of 1857.

CLXXIV. The Commissioner shall set apart sufficient public places, or any part of the seashore (not being private property) for The Commissioner the purpose of being used as bathing places; and shall may set apart bathing places, &c. also provide or set apart a sufficient number of convenient tanks

tanks or runs of water for the inhabitants to bathe in; and shall also set apart tanks or reservoirs or runs of water for washing animals or clothes, and for all purposes connected with the health, cleanliness, and comfort of the inhabitants.

CLXXV. When any private tank or low marshy ground, or any waste

Power to fill up unwholesome tanks on private premises.

or stagnant water being within any private enclosure, appears to the Commissioner to be injurious to health, or to be offensive to the neighbourhood, the Commissioner

shall require, by notice in writing, the owner of the said premises to cleanse or fill up such tank or marshy ground, or to drain off or remove such stagnant water; and if the said owner shall refuse or neglect to comply with such requisition during eight days from the service thereof, the Commissioner, his officers. and workmen, shall enter into the said premises and do all necessary acts for all or any of the purposes aforesaid; and the expense incurred thereby shall be paid by the owner of such premises, and shall be recoverable as hereinafter provided.

CLXXVI. The Commissioner is hereby empowered, from time to time as Power to drain off and cleanse stagnant pools in open places. he shall see fit, to drain off into any sewers, and cleanse and fill up or otherwise abate, any stagnant pool, ditch, tank, pond, or other receptacle of water (the same not being within

any private enclosure) which shall appear to him to be likely to prove injurious to the health of the inhabitants, whether the same be the private property of any persons or otherwise ; and the Commissioner, his officers, and workmen, may do all necessary acts for effecting any of the purposes aforesaid; and the expenses incurred thereby shall be paid by the owner, and shall be recoverable as hereinafter provided.

CLXXVII. The Commissioner, in executing any works directed or Commissioner in executing works to provide roads, &c. where existing ones injured. The Commissioner, in executing any works directed or authorized by this Act to be made, shall provide and make a sufficient number of convenient ways, watercourses, drains, and channels, in the place of such as may be interrupted, injured, or rendered useless by reason of the

execution of such works; and the Commissioner shall make reasonable compensation to any person who suffers damage by reason of the same, and the

amount

amount of such compensation, in case of dispute, shall be ascertained and determined in the manner hereinafter provided.

CLXXVIII. Commissioner breaking up street to restore the same with all convenient speed. When the pavement or surface of any street, or when any sewer or drain shall be opened or broken up by the Commissioner, his officers, or servants, he shall, with all convenient speed, complete the work on account of which the same shall have been broken up, and fill in the ground

and make good the pavement and surface, and the sewer or drain so opened or broken up, and carry away the rubbish occasioned thereby; and shall, in the meantime, cause the place where such pavement or surface shall be so opened or broken up to be fenced and guarded, and sufficiently lighted during the night.

distance of four feet at least from the nearest part of any such water-pipe, unless in case where it shall be unavoidably necessary to lay the gas-pipe across or nearer to any water-pipe, in which case the said gas-pipe shall wherever practicable, be laid over and above the said water-pipe at the greatest practicable distance therefrom, and shall form therewith a right angle, or as near thereto as the situation will admit; and in every such case the gas-pipe so crossing shall be at least nine feet in length, so that no joint of any gas-pipe shall be nearer to any water-pipe than four feet at the least where the width of the road will admit, and every such gas-pipe, so crossing the water-pipe, shall for the whole length thereof be sufficiently bedded in with good sound clay or other fit materials of a proper consistence, and well worked and rammed into the trench all round the said gaspipe; and if any pipe for the conveyance of gas be laid in any respect contrary to the provisions of this Section, the person ordering the same to be laid, or to whom the management of laying the same is entrusted, shall be liable to a penalty not exceeding one thousand Rupees; and the Commissioner may cause such alteration to be made with respect to such pipe as he may think

think necessary for the purposes of this Act, and the expenses thereof shall be paid by the person liable to the said penalty, and shall be recoverable as hereinafter provided.

CLXXX. If the Commissioner deem it necessary, for the purposes

Situation of gas and water-pipes to be altered at the expense of the Justices.

of this Act, to raise, sink, or otherwise alter the situation of any water-pipe or gas-pipe, or other water-works or gasworks laid in any of the streets, he may, from time to time. by notice in writing, require the person to whom any such

pipes or works belong, or under whose control they may be, to cause forthwith or as soon as conveniently may be, any such pipes or works to be raised. sunk, or otherwise altered in position in such manner as the Commissioner directs: Provided that such alteration be not such as to prevent the water

or gas from flowing as freely and conveniently as may be, having regard to the provisions of this Act, and the expenses attending such raising, sinking, or altering, and

full compensation for the damage done thereby shall be paid by the Commissioner to the persons to whom such pipes or works belong. And if any dispute shall arise touching the amount or apportionment of such compensation, the same shall be ascertained and determined in the manner hereinafter provided.

CLXXXI. If the person to whom any such pipes or works belong, or under whose control they may be, do not proceed forth. with, or as soon as conveniently may be after the receipt of If owner, &c. nesuch notice, as in Section CLXXX. mentioned, to cause the glect to make alterations, the Commissame to be raised, sunk, or altered, in such manner as the sioner may cause the same to be done. Commissioner may require, the Commissioner may himself cause such pipes or works to be raised, sunk, or altered as

he think fit; provided that such alteration be not such as to prevent the water or gas from flowing as freely and conveniently as may be, having regard to the provisions of this Act.

CLXXXII. Every person intending to build or take down any building,

Hoards to be set up during repairs.

or to alter or repair the outward part of any building where any street or footway will by means of such work be obstructed or rendered unsafe or inconvenient, shall, before

before beginning the same, and having first obtained a license in writing from the Commissioner so to do, cause sufficient hoards or fences to be put up, in order to separate the building where such works are being carried on from the street or footway, and shall continue such hoard or fence standing. and in good condition to the satisfaction of the Commissioner during such time as the public safety or convenience requires, and shall cause the same to be sufficiently lighted during the night, and every such person who begins to build, or take down, or alter or repair, any building contrary to the provisions of this Section, or who, without license, erects or sets up any hoard, scaffolding, or fence whatsoever, or who, being licensed, fails to put up such fence or hoard, shall be liable to a penalty not exceeding five hundred Rupees, and to a further penalty not exceeding fifty Rupees for every day after conviction during which the offence is continued, and every such person who being licensed, fails to continue such hoard, scaffolding, or fence, standing and in good condition as aforesaid during the time aforesaid, or who does not, while the said hoard or fence is standing keep the same sufficiently lighted during the night, or who does not remove the same when directed by the Commissioner, within a reasonable time afterwards, shall be liable to a penalty not exceeding fifty Rupees for every day during which the offence is continued, after twenty-four hours' notice in writing from the Commissioner.

CLXXXIII. The Commissioner shall, during the construction or repair

Bars to be erected across streets during repairs, and lights placed at night.

of any of the streets, sewers, or drains vested in the Justices, take, proper precaution for guarding against accident, by shoring up and protecting the adjoining houses, and shall cause such bars, chains, or posts to be fixed across or in any of the streets or roads to prevent the

passage of carriage, carts, or other vehicles, cattle or horses, while such works are carried on, as to him shall seem proper, and the Commissioner shall cause any sewer or drain or other works in streets, during the construction or repair thereof, to be sufficiently lighted and guarded during the night; and whoever takes down, alters, or removes any of the said bars, chains, or posts, or extinguishes any light, without the authority or consent of the Commissioner, shall be punished with fine which may extend to fifty Rupees.

CLXXXIV. No person shall deposit any building materials or make a hole in any street, without the permission, in writing, of the Commissioner; and such permission shall be terminable Penalty for not fencing and lighting depoat the discretion of the Commissioner; and when such sits of building matepermission is granted to any person, he shall, at his own rials or excavations. expense, cause such materials or such hole to be sufficiently fenced and enclosed until the materials are removed, or the hole is filled up or otherwise made secure, to the satisfaction of the Commissioner, and shall cause the same to be sufficiently lighted during the night; and whoever deposits materials, or makes a hole without such permission, or fails to fence or enclose and light such materials or hole, or does not remove such materials or fill up such hole, or otherwise make it secure in the manner aforesaid, when the permission has been withdrawn, shall be punished with fine which may extend to fifty Rupees, and shall also be liable to a further penalty not exceeding fifty Rupees for every day while the offence is continued, after twenty-four hours notice in writing from the Commissioner.

Dangerous places near streets to be repaired or enclosed.

CLXXXV. If any building, tank, well, quarry of sand, carth, stone or rock, or place for blasting stone or rock, or hole, or other place, be, for want of sufficient repair, protection, or enclosure, in the opinion of the Commissioner, dangerous

to passengers, the Commissioner shall give notice in writing to the owner thereof to repair, protect, or enclose the same within twenty-four hours, so as to prevent danger therefrom, and on failure to comply, the Commissioner shall forthwith cause the same to be so repaired, protected or enclosed; and the expenses of such repair, protection, or enclosure shall be paid to the Commissioner by such owner, and in default, shall be recoverable as herein. after provided.

CONSTRUCTION, MAINTENANCE, AND REGULATION OF PUBLIC MARKETS.

CLXXXVI.

Public markets vested in the Justices. What to be deemed public markets.

The public markets in the City are hereby vested in the Justices, and all markets which are, when this Act comes into operation, repaired and maintained in the said City out the Municipal Fund, shall be deemed to be public markets.

CLXXXVII.

Commissioner may purchase lands for opening new markets and improving old ones.

CLXXXVII.

The Commissioner may, from time to time, with the sanction of the Justices, purchase on their behalf any land or premises for opening any new market in the said City, or for enlarging or otherwise improving any market in the said City by this Act vested in the Justices, and any por-

tion of the land or premises so purchased, which shall not be required for that purpose, may with the like sanction be sold, and the proceeds shall be carried to the credit of the Municipal Fund.

CLXXXVIII. The Commissioner may, with the sanction of the Commissioner may construct new markets. The Commissioner to alter and improve public markets. shall also, from time to time, alter and improve any of the public markets in the said City.

CLXXXIX. The Commissioner may, with the sanction of the Jus-Commissioner may close markets and sell the grounds and premises. The Commissioner may, with the sanction of the Justices, close any of the public markets in the said City, and if the ground and premises vacated shall not be required for any of the purposes of this Act, the same or any part thereof may, with the like sanction, be sold, and the proceeds of such sale shall be carried to the credit of the Municipal Fund.

CXC. The Commissioner shall either take stallage rents in respect Commissioner may of the use by any person of any market vested in the let stalls. Justices, or he may, from time to time, sell, by public auction, or otherwise, the privilege of occupying any stall or space in the said markets, for such terms and periods, and subject to such conditions, as shall, with the sanction of the Justices, be fixed by the Commissioner.

CXCI. Every person who shall, without the permission or license Selling articles in markets without Commissioner's permission. under this Act, shall be punished with fine not exceeding fifty Rupees for each offence.

CXCII.

REGULATION OF OFFENSIVE AND DANGEROUS TRADES, AND OF BURIAL AND BURNING GROUNDS,

CXCII. No place shall be used as a slaughter-house within the Slaughter-houses to be licensed: City, unless a license in writing for the use thereof as a slaughter-house has been obtained from the Commissioner, who is hereby empowered, at his discretion, from time to time to grant such licenses; and whoever, without such license, uses as a slaughterhouse any place within the City, shall be punished with fine which may extend to two hundred Rupees, and to a further penalty not exceeding fifty Rupees for every day after the conviction for such offence, during which the said offence is continued.

CXCIII. The Commissioner may, from time to time, if he shall think Commissioner provide places slaughter-houses. to for in Council, provide places for the purpose of being used as slaughter-houses, and he shall in the manner hereinafter provided make bye-laws for and with respect to the management and charges for the use of such places.

CXCIV. Every owner, occupier, or farmer of any market for the sale of butcher's meat, poultry, fish, fruit or vegetables, Markets, slaughterhouses, &c. to be proor of any slaughter-house within the City, shall cause perly drained. such drains to be made therein as shall be considered sufficient by the Commissioner, and (if required so to do by the Commissioner) shall cause all the floors and drains to be paved with stone or burnt brick, and shall also cause a supply of water to be provided, sufficient for keeping such market or slaughter-house in a clean and wholesome state; and if such owner, occupier, or farmer, after notice in writing given to him by the Commissioner that such market or slaughter-house is defective in any of the said particulars, and requiring him to remedy the defect specified within a reasonable time, makes default therein, he shall be liable to a penalty not exceeding fifty Rupees for every day during which such default is continued.

CXCV.

Commissioner may make bye-laws for the inspection of slaughter-houses.

CXCV. The Commissioner may, in the manner hereinafter provided, make bye-laws for the inspection of all such markets and of all slaughter-houses within the City, and for the management and conduct of the business therein, and for keeping the same in a cleanly and proper state, and for removing filth at least once in every twenty-four hours.

CXCVI. It shall be lawful for any Magistrate, on the application

Sale of unwholesome food or drink.

slaughter

of the Commissioner or any of his officers, setting forth that there is just cause to believe that any article which has been rendered, or has become, or is noxious or unfit

for use, as food or drink for man, is in the possession of any person for the purpose of being sold or offered, or exposed for sale within the City as food or drink for man, to grant a warrant to enter upon the premises of such person, and to search for and seize such article, and if it appear to the said Magistrate upon sufficient evidence that the same is noxious or unfit for such use, he shall order such article to be forfeited and disposed of in such way as to him shall seem proper.

CXCVII. The Commissioner, or any person appointed by him for that purpose, may at all reasonable times, with or without Commissioner may assistants, enter into and inspect any market, building, enter and inspect houses, shop, stall, or place used for the sale of butcher's meat, shops, &c. and seize unwholesome articles poultry, fish, or vegetables, or as a slaughter-house. exposed for sale. and may examine any animal, carcase, meat, poultry,

game, flesh, fish, fruit, vegetable, corn, bread, flour, or pulse, which may be therein; and in case any animal, carcase, meat, poultry, game, flesh, fish. fruit, vegetable, corn, bread, flour or pulse, appear to be intended for the food of man, and to be unfit for such food, may seize the same; and if it appear to a Magistrate, upon sufficient evidence that such animal carcase, meat, poultry, game, flesh, fish, fruit, vegetable, corn, bread, flour, or pulse is unfit for the food of man, he shall order the same to be destroyed, or to be so disposed of as to prevent its being exposed for sale or used for such food, and the owner thereof, or the person in whose possession the same is found, shall be liable to the penalty provided by Section 273 of THE INDIAN PENAL CODE.

The Magistrate, before whom any person is convicted of CXCVIII. an offence contrary to the provisions of this Act relating Suspension or revocation of license, &c. to slaughter-houses, or of the non-observance of any of the bye-laws relating thereto made by virtue of this Act, in addition to the penalty imposed on such person under the authority of this Act, may suspend for any period not exceeding two months the license granted to such person under this Act; or in case such person be the owner or occupier of any registered slaughter-house, may forbid, for any period not exceeding two months, the slaughtering of cattle therein; and the Magistrate, upon the conviction of any person for a second or other subsequent like offence, in addition to the penalty imposed under the authority of this Act, may declare the license granted under this Act revoked; or if such person be the owner or occupier of any registered house, may forbid absolutely the slaughtering of cattle therein.

CXCIX. Whoever, during the period for which any such license is

Penalty for using slaughter-houses during suspension or revocation of license. suspended or after the same is revoked as aforesaid, slaughters cattle or allows cattle to be slaughtered in the slaughter-house to which such license relates, and whoever, during the period that the slaughtering of

cattle in any such registered slaughter-house is forbidden as aforesaid, or after such slaughtering has been absolutely forbidden therein, slaughters cattle, or allows cattle to be slaughtered in any such registered slaughterhouse, shall be liable to a penalty not exceeding five hundred Rupees, and to a further penalty not exceeding one hundred Rupees for every day after conviction during when the said offence is continued.

CC. The owner or occupier of every place within the City used, at the time this Act comes into operation, for any of the Offensive and dangerous trades existing within certain limits to be registered.

drying wool, or as a soap-house, oil-boiling-house, dyeing-

house, tannery, brick, pottery, or lime kiln, sago manufactory, gunpowder manufactory, manufactory of fire-works, or other manufactory or place of business from which either offensive or unwholesome smells arise, or used for any purposes which are calculated to be dangerous to life, or used as a yard or depôt for hay, straw, wood, or coal, shall, within three months after this Act comes into operation, register the same at the office of the Commissioner in a book to be kept by him for that purpose; and whoever, after the expiration of the said three months, and after eight days' notice in writing from the Commissioner, uses any such place without the same being registered, shall be liable to a penalty not exceeding one hundred Rupees for every day during which the offence is continued.

CCI. No place shall, after this Act comes into operation, be established

and used within the said City for any of the purposes Penalty for establishing such trades mentioned in the preceding Section, except under a without license. license from the Commissioner, who is hereby empowered, at his discretion, from time to time to grant such licenses; and whoever, without a license, uses any such place for such purpose, shall be liable to a penalty not exceeding five hundred Rupees, and a further penalty not exceeding fifty Rupees for every day after the conviction for such offence during which the said offence is continued.

The Commissioner may, in the manner hereinafter provided, CCII. make bye-laws for the inspection of every place within Commissioner may make bye-laws for the City used for any of the purposes mentioned in the management of such trades and places. Section CC. and the following Section, and for the management and conduct of such business, whether the same be newly established or not, in such manner as he may think necessary and proper, in order to prevent or diminish the noxious, injurious, offensive or dangerous effect thereof.

Commissioner may, in certain cases, order the use of slaughterhouses, and the carrying on of dangerous and offensive trades to be discontinued.

CCIII. If it be shown, to the satisfaction of the Commissioner. that any place registered or licensed under the preceding Sections of this Act, is a nuisance to the neighbourhood or injurious to health, he may give notice in writing to the occupier to discontinue within one month the use of such place, and whoever, after the expiration of that

time, uses such place, or permits it to be used, in such manner as to be a nuisance to the neighbourhood or injurious to health, shall be liable to a penalty penalty not exceeding two hundred Rupees for every day during which it shall be so used.

From and after the date when this Act comes into operation. CCIV.

every furnace employed or to be employed in the City of

Furnaces used for any trade to consume their own smoke.

Bombay in any works or buildings used for the purposes of any trade or manufacture whatsoever within the City of Bombay, whether a steam-engine be or be not used or employed therein, shall in all cases be constructed or altered so as to consume or burn the smoke arising from such furnace; and if any person shall after the date when this Act comes into operation use any such furnace which shall not be constructed or altered so as to consume or burn its own smoke, or shall so negligently use any such furnace as that the smoke arising therefrom shall not be effectually consumed or burnt, every person so offending, being the owner or occupier of the premises, or being an agent or other person employed by such owner or occupier for managing the same, shall, upon conviction before any Magistrate, be liable to a penalty not exceeding one hundred Rupees, and upon a second conviction the sum of two hundred Rupees, and for each subsequent conviction a sum double

the amount of the penalty imposed for the last preced-Proviso. ing conviction: Provided that nothing in this Section shall be held to apply to locomotive engines used for the purpose of traffic upon any Railway.

The Commissioner may, if he think fit, cause a survey and CCV.

Burial and burning grounds to be registered.

measurement to be made of every burial ground and every place used as such; and every such place, and every burning ground, and place for the exposure of the dead, existing at the time this Act comes into operation,

shall, within one month after this Act shall have come into operation, be registered by the owner or the person having the control thereof; or if there be no owner or person authorized to control the same, by order of the Commissioner, in a book to be kept by him for that purpose; and whoever, after the expiration of the said time, knowingly buries, burns or exposes, or causes, procures, or suffers to be buried, burned or exposed, any corpse in or on any ground other than such registered burial or burning ground or place for the exposure

exposure of the dead, shall be liable to a penalty not exceeding one hundred Rupees for each offence.

CCVI. No vault or grave shall be made, or interment permitted, within the walls of, or underneath any church or chapel, No new vault or burial or burning or other place of public worship now built, or which place to be constructed without leave. may be built after this Act comes into operation, without the special sanction of the Governor in Council, and no burial or burning ground, or place for the exposure of the dead, whether public or private, shall, after this Act comes into operation, be opened, made, or formed, without a license describing the extent and boundaries thereof first obtained from the Commissioner, who is hereby empowered, at his discretion, from time to time to grant such licenses; and whoever shall bury, burn, or expose or cause, permit, or suffer to be buried, burned, or exposed, any corpse in any vault, grave, burial or burning ground, or place for the exposure of the dead, opened, made, or formed without such license, or contrary to the terms thereof, shall be liable to a penalty not exceeding five hundred Rupees for each offence.

CCVII. If, upon the evidence of competent persons, the Commissioner, with the sanction of the Governor in Council, Commissioner to issue certificates proshall certify that any burial-ground or place of burial, hibiting improper burial places. or any place used for the burning or exposure of corpses, is in such a state as to be offensive, or dangerous to the health of persons living in the neighbourhood thereof, or that any church or other place of public worship is dangerous to the health of persons frequenting the same, by reason of the state of the vaults or graves within the walls of or underneath the same, or in any churchyard or burial-ground adjacent thereto, it shall not be lawful, after a time to be named in such certificate, not being less than two months after the publication of the same as hereinafter provided, to bury, burn, or expose, or permit or suffer to be buried, burned, or exposed, any corpse in, upon, within, or under the place, ground, church, or place of worship to which the certificate relates; and whoever, after due-publication of such certificate as hereinafter provided, buries, burns, exposes, or causes, permits, or suffers to be buried, burned, or exposed, any 27 + corpse

corpse contrary to this enactment, shall be punished with fine which may extend to one thousand Rupees for each offence : Provided always that every such certificate shall be published in the *Government Gazette* and in one or more

Proviso. Proviso. of the public English and in two Vernacular newspapers published in Bombay, and that a copy of such certificate with a translation thereof in the Murathi and Goozerati languages shall, in the case of a burial or burning ground, or place for the exposure of the dead, be affixed conspicuously on some part of the said ground or place.

CCVIII. The Commissioner shall, from time to time, as may be Commissioner to provide places to be used as burial or burning grounds, or for exposing the dead. COMMISSIONER TO provide places to be used as burial or burning grounds, or for the exposure of the dead.

CCIX. The Commissioner may, in manner hereinafter provided make bye-laws for the inspection and regulation of burial and burning grounds, and

Commissioner may make bye-laws for regulation of burial and burning grounds. may thereby prescribe rules as to the depth of graves and places of interment, and generally as to all matters connected with the good order of burial and burning grounds, and places for the exposure of the dead, due regard being

had to the religious usages of the several classes of the community.

REGISTRATION OF BIRTHS AND DEATHS, AND THE TAKING OF A CENSUS.

CCX. The Commissioner shall keep in his office a register of all births

Commissioner to keep a register of births and deaths, and appoint Registrars of births.

and deaths in the City, and for this purpose he shall divide the City into such and so many districts as he shall think fit, and for every such district he shall appoint a person to be Registrar of births within such district.

CCXI. Every Registrar shall reside within the district of which he is Registrar, and shall cause his name, with the addition of "Registrar for the district" for which he shall be so appointed, to be placed in some conspicuous place on or near the outer door of his own dwelling house; and the Commissioner

Commissioner shall cause to be printed and published a list, containing the name and place of abode of every Registrar in the City.

CCXII. The Commissioner shall cause to be prepared and printed

Commissioner to have Register Books prepared and numbered.

a sufficient number of Register Books for making entries of all births and deaths which may take place in the City, according to the forms prescribed in Schedules (G) and (H), to this Act annexed, and the pages of

such book shall be numbered progressively from the beginning to the end.

Registrar to inform · himself of, and register births and deaths.

CCXIII. Every Registrar shall inform himself carefully of every birth and if required to do so of every death which shall happen in his District after this Act comes into operation, and shall learn and register, as soon as conveniently may be after the event, without fee or reward, the particulars

required to be registered, according to the forms in the said Schedules (G) and (H) respectively, touching every such birth and every such death, as the case may be, which shall not have been already registered, every such entry being made in order from the beginning to the end of the book.

The father or mother of every child born in the City, or in CCXIV. case of the death, illness, absence, or inability of the Information of father and mother, the occupier of the house or tenement birth to be given in which such child shall have been born, shall, within one within one week.

week next after the day of every such birth, give information to the Registrar of the District, according to the best of his or her knowledge and belief, of the several particulars hereby required to be known and registered touching the birth of such child. Any person whose duty it shall be to give information to a Registrar under this Section, who shall refuse or neglect to give such information, shall be liable to a penalty not exceeding one hundred Rupees for each offence.

CCXV. Information of the several particulars hereby required to be

Information. of death to be given at place-of funeral.

registered concerning the death of every person dying in the City shall be given in writing if the informant can write, otherwise orally, to the Policeman or other person appointed to receive it at the place of burial, burning or exposure, exposure, as the case may be, by some one of the persons present at the death or in attendance in the last illness, or, in case of disability, or default of all such persons, by the undertaker or other person conducting the funeral. and every one of these may be required thus to give or cause to be given the information, and to attest its correctness to the best of his knowledge and belief by the signature of his name, his designation, and residence. Every Policeman or other person whose duty it shall be to receive information at the funeral places concerning deaths shall truly register the same, and shall every morning render or cause to be rendered at the office of the Commissioner of Police the completed and signed register made by him during the preceding twenty-four hours. The Commissioner of Police shall immediately on receiving all the reports of the preceding day transmit them to the Municipal Commissioner, to be embodied according to districts in English form in his Register Book, and to be reduced to such tabular forms as may be most useful for sanitary and other purposes. Any person who shall refuse or neglect to give any information which it is his duty to give under this Section, shall be liable to a penalty not exceeding one hundred Rupces for each offence.

CCXVI. Every person by whom the information contained in any Person giving information to sign the register. register. Register of births or deaths under this Act shall have been given, shall, if he can write, sign in the register his name, description, and place of abode, and if he cannot write, shall put his mark in the Register to his name, description, and place of abode, and no such registration shall be deemed to be complete or of any effect until such person shall have so signed or put his mark to it.

CCXVII. At such time and in such manner as shall be directed, from Enumeration of inhabitants. time to time, by the Commissioner, with the sanction of the Justices and of the Governor in Council, an enumeration shall be made of the persons who at the time of making such enumeration shall be within the City: Provided always that one clear month previous to such enumeration being commenced, notice of the intention to make the same, with the date or dates upon or within which it is intended to be made, and all other necessary particulars, shall be published in the *Government*

Government Gazette, and in such English and Vernacular newspapers in Bombay as to the Governor in Council shall seem fit.

- CCXVIII. The Commissioner shall superintend the taking of such enumeration, and shall appoint such Enumerators, and make such to Commissioner arrangements generally as may seem to him necessary for superintend the enumeration.

the purpose of such enumeration, and all expenses incurred in respect of such enumeration shall be defrayed out of the Municipal Fund.

CCXIX. Each Enumerator or other subordinate Officer appointed under this Act shall, agreeably to his instructions, leave at each Delivery _ of Schedules and Returns. house or place of residence within his District, four days 'at least before the time appointed for the collection of the completed Returns or Census, a blank Schedule or Return, to be of such form, and containing such particulars as the Governor in Council may approve, to be duly filled up and signed by the owner, tenant, or principal occupant of the said house or place of residence.

Any person wilfully neglecting or refusing correctly to fill up CCXX.

Occupier of house, &c. to furnish required information.

and affix his signature to any such Schedule or Return so left at his house or place of residence, or who shall neglect or refuse to return the same to the Enumerator or other Officer when called upon so to do, or to furnish the neces-

sary information to an Enumerator to fill up the same for him, if he do not know how to write, shall be liable to a penalty not exceeding two hundred Rupees, and may also be detained in custody until he shall have correctly filled up and signed the said Schedule or Return : Provided that it shall be the duty of the

Enumerator, if required, to fill up all Schedules or Returns for those who are unable to write.

CCXXI. Any Enumerator or other subordinate Officer employed in the collection of such Schedules or Returns, if he shall find Occupier to amend Returns if found deany of the same defective, or in any respect improperly fective. filled in, shall return the same to the occupant of the house

or residence to which they relate; together with a written or printed notice requiring that the same be duly filled in or amended within a specified period not less than twenty-four nor more than forty-eight hours, and if such occupant shall 28 -

shall then fail so to fill in or amend any such Schedule or Return, he shall, on conviction, be liable to a fine not exceeding two hundred Rupces, and may also be detained in custody until he shall correctly fill in or amend the said Schedule or Return.

CCXXII. Any Military or Naval Officers in command of bodies of Military or Naval men, or of vessels of war, or any Master of a Military and Naval Officers and certain merchant vessel, or Nacodah, or Tindal of a vessel or boat, others, if required, to act as Enumerators. or any person in charge of a Lunatic Asylum, Hospital, or Prison, or of any public or private, charitable or scholastic institution, or any keepers of Hotels or Lodging-houses, shall, if required, act as Enumerators for the purpose of taking account of persons under their command or charge, or abiding in their houses, on the night immediately preceding the day to be appointed for the making of such enumeration, every person so required to act as an Enumerator shall receive and conform to all instructions in writing which may be issued to him by the Commissioner in that behalf.

CCXXIII. The Commissioner shall obtain by such ways and means as shall appear to him best adapted for the purpose, Returns of houseless persons. and as shall be sanctioned by the Governor in Council, Returns of the particulars required by this Act, with respect to all houseless persons, and all persons who, during the said night preceding the day to be appointed for the making of such enumeration were on out-door night duty, or for any other reasons were not abiding in any house of which account is to be taken by the Enumerators.

MUNICIPAL POLICE.

CCXXIV.

Expense of Police.

The annual expenses of the Police of the City of Bombay shall be paid out of the Municipal Fund: Provided that no reduction in the total annual amount required for the maintenance of the Force shall be made without the sanction of the Governor in Council.

CCXXV. The Police Commissioner to be under the authority of the Mu-

CCXXVI.

CCXXVI. Any Police Officer may arrest any person committing in Police to arrest his view any offence against any of the provisions of this Act if the name and address of such person be unknown to him, or if such person decline to give his name and address, or if the Police Officer in question shall have reason to doubt the accuracy of such name and address, if given; and such person may be detained at the Station-house until his name and address shall be correctly ascertained:

Provise. Provise. Provise. Provise. Provise. Provided that no person arrested under the provisions of this Act shall be detained in any way without the order of some Magistrate longer than shall be necessary for bringing him before a Magistrate, or than forty hours at the utmost.

CCXXVII. To provide for the annual expense of the Police, and for Police Rate. The prevention of mischiefs from fires, an annual rate of two per centum of their value shall be imposed by the Justices upon the occupiers of all houses, buildings, and lands in the City, which shall be assessed and levied in the manner hereinbefore provided in regard to the rate on houses, buildings and lands: Provided that the

Proviso. Justices may increase this rate to three per centum, if it should be found necessary for the prescribed purposes.

GENERAL PROVISIONS FOR CARRYING OUT THE PURPOSES OF THE ACT.

CCXXVIII. When any notice is required by this Act to be given to the owner of notice on owners and occupiers of buildings and lands. When any notice is require of any house, building, or land, such notice addressed to the owner or occupier as the case may require, may be served on the occupier of such house, building, or land, or left with some adult male member or servant of his family, or if the notice cannot be so served, or if there be no occupier, may be put up on some conspicuous part of such house, building, or land; and it shall not be necessary in any such notice to name the occupier or the owner : Provided always that when the owner and his residence are known to the Commissioner

Proviso. Proviso. Proviso. it shall be his duty, if such owner be residing within the City, to cause every notice required to be given to the owner of any house, building, or land to be served on such owner, or left with some some adult male member or servant of his family; and if the owner be not resident within the City, he shall send every such notice by the post addressed to his residence.

CCXXIX. Whenever, under the provisions of this Act, any work is Commissioner in default of owner or occupier may execute works and recover expenses. Whenever, under the provisions of this Act, any work is required to be executed by the owner or occupier of any house, building, or land, and default is made in the cxecution of such work, the Commissioner, whether any penalty is or is not provided for such default, may cause

such work to be executed; and the expenses thereby incurred shall be paid to him by the person by whom such work ought to have been executed, and shall be recoverable as hereinafter provided.

If the defaulter be the owner of the house, building, or land, CCXXX. the Commissioner may, by way of additional remedy, wheto levy Power charges on occupier, ther an action or proceeding has been brought or taken who may deduct the against any such owner or not, require the payment of same from his rent. all or any part of the expenses payable by the owner for the time being from the person who then, or at any time thereafter, occupies the house, building, or land under such owner; and in default of payment thereof by such occupier on demand, the same may be levied by distress of the goods and chattels of such occupier; every such occupier shall be entitled to deduct from the rent payable by him to his landlord so much as is so paid by or recovered from such occupier in respect of any such expenses.

CCXXXI. No occupier of any house, building, or land shall be liable

pay the same to his landlord has accrued and become payable by him, unless he neglect or refuse, upon application made to him for that purpose by the Commissioner, truly to disclose the amount of his rent, and the name and the address of the person to whom such rent is payable; but the burden of proof that the sum demanded of any such occupier is greater than the rent which

was due by him at the time of such demand, or which has since accrued, shall be upon such occupier : Provided further that nothing herein contained shall

be taken to affect any special contract made between any such person, owner, or occupier, respecting the pay-

ment of the expense of any such works as aforesaid.

CCXXXII.

Occupier in default of owner may execute works and deduct expenses from his rent. Whenever default is made by the owner of any house, building, or land, in the execution of any work required to be executed by him, the occupier of such house, building, or land may, with the approval of the Commissioner, cause such work to be executed, and the expense thereof shall be

paid to him by the owner, or the amount may be deducted out of the rent from time to time becoming due from him to such owner.

CCXXXIII. If the occupier of any house, building or land prevent the

Proceedings if an occupier opposes the execution of theAct. owner thereof from carrying into effect, in respect of such house, building, or land, any of the provisions of this Act, after notice of his intention so to do has been given by the owner to such occupier, the Court of Petty Sessions,

upon proof thereof, and upon application of the owner, may make an order in writing requiring such occupier to permit the owner to execute all such works, with respect to such building or land as may be necessary for carrying into effect, the provisions of this Act, and may also, if it think fit, order the occupier to pay to the owner the costs relating to such application or order; and if after the expiration of eight days from the date of the order, such occupier continue to refuse to permit such owner to execute such works, such occupier shall for every day during which he so continues to refuse, be liable to a penalty not exceeding fifty Rupees; and every such owner, during the continuance of such refusal, shall be discharged from any penalties to which he might otherwise have become liable by reason of his default in executing such works.

CCXXXIV. The Commissioner shall, for the purposes of this Act, have

Power to enter upon lands for the purposes of the Act. power by himself or any officer authorized by him for the purpose, between sunrise and sunset, to enter into and upon any house, place, works, building, or land, as well for the purpose of making any survey or inspection which he

may

may be entitled to make, as for the purpose of executing any work authorized by this Act to be executed by him, without being liable to any legal proceedings or molestation whatsoever on account of such entry, or of anything done in any part of such house, place, works, building or land, in pursuance of this Act: Provided that, except when herein otherwise provided, the Commissioner or

his said officers shall not enter upon any house, place, works, Proviso. building, or land, which may be occupied at the time, unless with the consent of the occupier thereof, without previously giving the said occupier twenty-four hours' notice in writing of his or their intention to do so.

Notice to be given betore entry of houses to enable females to retire.

CCXXXV.

Whenever, under the provisions of this Act, the Municipal Commissioner or others acting under his orders or authority, or having themselves authority under this Act, shall enter into any house for purposes of inspection or for any other purpose, sufficient notice must be given to

enable the females or occupants of any zenama or apartments appropriated to females to remove to another part of the building which either has been inspected or is not required to be inspected, and in all cases of inspection, due regard, compatible with the exigencies of this Act, shall be paid to the prejudices of caste.

CCXXXVI. Commissioner may enter on lands adjacent to works. The Commissioner or his officers or servants authorized by him for the purpose may enter upon the land of any persons adjoining to or being within the distance of one hundred yards, of any works by this Act authorized to be made, for

the purpose of depositing upon such land, any soil, gravel, sand, lime, brick, stone, or other materials, or for any other purposes connected with the formation of the said works without making any previous payment, tender, or deposit: Provided that the Commissioner shall make compensation for such occupation of the said land and for any damage done to the owner and occupier thereof; and if any dispute shall arise touching the amount or apportionment of such compensation, the same shall be ascertained and determined in the Proviso. CCXXXVII. The Commissioner may direct any prosecution for any nuisance whatsoever, and may order proceedings to be taken for the recovery of any penalties and for the punishment of

any persons offending against the provisions of this Act, and may order the expenses of such prosecution or other proceedings to be paid out of the Municipal Fund: Provided that any inhabitant of a place may

Proviso. complain of the existence of a nuisance before the Court

of Petty Sessions, and the Court may inquire into the complaint so made, and may make an order upon the Commissioner to put in force the provisions of this Act for abating or remedying the same, which the Commissioner shall be bound to obey; and the said Court may, if it sees fit direct the Commissioner, and he shall in such case pay to the complainant, out of the Municipal Fund, the costs of and relating to the said application and order, including compensation for the complainant's loss of time.

What are to be CCXXXVIII. The word "Nuisances" under this deemed Nuisances. Act shall include—

- Any thing likely to occasion annoyance, inconvenience, harm or damage, to the public, as well as anything which may be injurious to the public health;
- Any Premises in such a state as to be a Nuisance or injurious to the public health;
- Any Pool, Ditch, Gutter, Watercourse, Privy, Urinal, Cesspool, Drain, or Ashpit, so foul as to be a Nuisance or injurious to the public health ;

Any Animal so kept as to be a Nuisance or injurious to the public health;

Any accumulation or deposit which is a Nuisance or injurious to the public health.

CCXXXIX. Nothing in this Act shall be construed to render lawful any act or omission on the part of any person which is or but for this Act would be deemed to be a nuisance at Common law, nor to exempt any person guilty of nuisance at Common law from from prosecution or action in respect thereof.: Provided that if any person convicted of an offence under this Act shall have paid the whole amount adjudged to

Proviso. be paid under such conviction, and the costs thereof in every such case, he shall be released from all further criminal responsibility for the same offence.

CCXL. No writ or process shall be issued against or served upon the Commissioner or any of his officers, or any person acting under the direction of the Commissioner, for any thing done or intended to be done under the powers of this Act, until the expiration of one month next after notice in writing shall have been delivered or left at the office of the Commissioner, or at

the place of abode of the intended defendant, stating with reasonable certainty the cause of such action, and the name and the place of abode of the intended plaintiff and of his attorney or agent in the cause; and upon the trial of any such action, the plaintiff shall not be permitted to go into evidence of any cause of action, except such as is stated in the notice so delivered, and unless such notice be proved, the Court shall find for the defendant; and every such action shall be commenced within three months next after the accrual of the cause of action and not afterwards; and if any person to whom such notice of action is given shall, before action brought, tender sufficient amends to the complainant, such complainant shall not recover in any such action when brought, and the defendant shall be entitled to be paid his costs as between attorney and client by the complainant, and if no such tender shall have been made, it shall be lawful for the defendant in such action, by leave of the Court where such action shall be pending, at any time before issue framed, to pay into court such sum of money as he shall think fit, and thereupon such proceedings shall be had as in other cases, where defendants are allowed to pay money into Court.

CCXLI. The Commissioner may, with the sanction of the Justices, make compensation out of the Municipal Fund to all persons sustaining any damage by reason of the exercise of any of the powers vested in the Commissioner, his officers or servants, under and by virtue of this Act.

CCXLII.

When any license is granted by the Commissioner under the CCXLII. provisions of this Act, authorizing the use of any place for Fees for certain licenses. any of the purposes herein described, and when permission is given by the Commissioner for making any temporary erection, or for putting up any projection, the Commissioner may charge a fee for such license or permission, and the rates of the fees to be so charged shall be from time to time adjusted by the Commissioner, with the sanction of the Justices and of the Governor in Council, provided that no such fee shall exceed the sum of fifty When permission or license is given for the temporary occupation of Rupees. any ground belonging to the Justices, the Commissioner may charge rent for such ground, according to the time the occupation may continue, at such rates as may from time to time be fixed by him.

served in case of the Commissioner by delivering to himself the original or copy thereof, or leaving the same at his office, and in case of any other person by delivering the original or a copy thereof to the person summoned, or by leaving the same at his usual place of abode with some adult male member or servant of his family. Upon the appearance of the parties, or, in the absence of any of them, upon proof of due service of the summons, it shall be lawful for such Court to hear and determine such question, and for that purpose to examine such parties or any of them and their witnesses on oath; and the cost of every such inquiry shall be in the discretion of such Court, who shall determine the amount thereof, and by whom and in what proportions the same shall be paid.

CCXLV.

CCXLV. If the amount of compensation, damages, cost, or expenses, Recovery of damages by distress. ascertained in the manner above described, be not paid by the party liable to pay the same within seven days after demand, such amount may be recovered under a warrant from the said Court by distress and sale of the goods and chattels of the Justices or of such other party, as the case may be, and the overplus arising from the sale thereof, after satisfying such amount and the cost of the distress and sale, shall be returned on demand to the party whose goods shall have been distrained.

CCXLVI. Instead of proceeding by distress and cale, or in case of A suit may be brought on failure to realize by distress. the same may be sued in any Court of competent jurisdiction.

CCXLVII. No distress levied by virtue of this Act shall be deemed Distress not unlawful for want of form. unlawful, nor shall any party making the same be deemed a trespasser on account of any defect or want of form in the summons, conviction, warrant of distress, or other proceeding relating thereto, nor shall such party be deemed a trespasser *ab initio* on account of any irregularity afterwards committed by him; but all persons aggrieved by such irregularity may recover full satisfaction for the special damage in any Court of competent jurisdiction.

CCXLVIII. Every fine or penalty imposed under or by virtue of this Recovery of fines and penalties. Act or of any bye-law made in pursuance thereof may, except in cases otherwise provided for, be recovered by summary proceeding before a Magistrate of Police on information exhibited by order of the Commissioner, and in default of payment of such fine or penalty the same may be levied under the warrant of such Magistrate by distress and sale of the goods of such offender : Provided that offences under Sections LXXXIII., LXXXIX., and XCI., committed beyond the limits of the City, may be tried before any Magistrate having jurisdiction in the place where the offence was committed.

CCXLIX.

Fines and penalties to be credited to the Municipal.Fund.

CCXLIX. All fines and penalties, and all sums levied or payable under this Act shall be paid to the Commissioner, to be carried by him to the credit of the Municipal Fund.

No person liable to fine or penalty unless complaint be made within two months after the offence is committed.

No person shall be liable to any fine or penalty under this Act, for any offence made cognizable before a Magistrate, unless the complaint respecting such offence shall have been made before a Magistrate within two months next after the commission of such offence.

CCLI. If through any act, neglect, or default, on account whereof any person shall have incurred any penalty imposed Damage to the Jusby this Act, any damage to the property of the Justices tices' property to be made good in addition shall have been committed by such person, he shall be liable to make good such damage as well as to pay such

penalty, and the amount of such damage shall, in case of dispute, be determined by the Magistrate by whom the party incurring such penalty shall have been convicted, and on non-payment of such damage on demand, the same shall be levied by distress, and such Magistrate shall issue his warrant accordingly.

CCLII. Whenever the Commissioner shall have incurred any expense in executing any of the works which under this Recovery of ex-Act the owners of any houses, buildings, or lands, are penses on account of improvement to prirequired to execute, the Commissioner may either recover vate property. the amount of such expenses in the manner hereinbefore

provided, or if he think fit may take engagements from the said owners for the quarterly payment of such sums as will be sufficient to defray the whole amount of the said expenses, with interest thereon at the rate of nine per centum per annum, within a period not exceeding five years, and such sums when due may be recovered by the same process by which rates may be recovered under this Act.

CCLIII. It shall be lawful for the Justices with the sanction of the Governor in Council to borrow on mortgage as herein-The Justices may borrow on security of after mentioned such sums of money or any part of rates and taxes. such sums as may be necessary for defraying any expenses already

already incurred or thereafter to be incurred in the execution of any works under this Act, and with the like sanction to fix such rates of interest, and such periods for the repayment of the sums borrowed with interest as they shall think fit, and for the purpose of securing the repayment of the sums so borrowed with interest as aforesaid the Justices may mortgage and assign over to the person or persons by or on behalf of whom such sums or any part thereof may be advanced, the rates and taxes imposed and levied under this Act or the portion thereof upon the credit of which. any such sums shall be borrowed: Provided always that any money borrowed Proviso. under the authority of this Act shall be borrowed only to defray the expenses of works of a permanent character and shall not at any time exceed in the whole ten times the average annual sum received and collected on account of such rates and taxes during the last preceding three years, and that no mortgage under this Act shall be entitled to any preference one over another by reason of some of such mortgages being prior in date to others of them.

CCLIV. Every mortgage of rates, or taxes authorized to be made under the provisions of this Act shall be by deed duly stamped, Mortgages to be by in which the consideration shall be truly stated, and every deed. such deed shall be under the common seal of the Justices,

and may be according to the form in the Schedule (I) to this Act annexed, or to the like effect.

CCLVI. If the Justices can at any time borrow or take up any sum of money at a lower rate of interest than any securities When and how given by them and then being in force shall bear, they may Justices may pay off borrow such sum at such lower rate as aforesaid in order to

pay off and discharge the securities bearing such higher rate of interest, and may charge the rates and taxes which they are authorized to mortgage under this Act or any part thereof with payment of such sum and such lower rate of interest in such manner and subject to such regulations as are herein contained with respect to other moneys borrowed on mortgage.

CCLVII. In order to discharge the principal money borrowed as aforesaid on security of any rates or taxes the Justices shall every year appropriate and set apart out of such rates and taxes respectively a sum equal to at least one-twentieth

part of the sums so borrowed respectively as a sinking fund to be applied in paying off the respective principal moneys so borrowed, and shall from time to time cause such sinking, fund to be invested in the purchase of Government securities, and to be Increased by accumulation in the way of compound interest or otherwise, and which interest shall when it amounts to a sufficient sum in like manner be invested until the principal sum and interest respectively shall be of the first ficient amount to pay off the principal debts respectively to which such sinking fund shall be applicable or some part thereof which the Justices shall think ought then to be paid off, at which time the same shall be so applied in paying off the same in manner hereinafter mentioned.

CCLVIII. Whenever the Justices shall be enabled to pay off one or Order of payment more of the mortgages which shall be then payable and of mortgages may in certain cases be decided by lot. Shall not be able to pay off the whole of the same class, they shall decide the order in which they shall be paid off by lot among the class to which such one or more of the mortgages belong, and shall cause a notice signed by their clerk to be given to the persons entitled to the money to be paid off pursuant to such lot, and such notice shall express the principal sum proposed to be paid off, and that the same will be paid together with the interest due thereon at a place to be specified, at the expiration of six months from the date of giving such notice.

POWER TO MAKE BYE-LAWS.

The Commissioner may from time to time make such byc-CCLIX. as he thinks fit for the several purposes for laws Commissioner may which he is hereinbefore empowered to make bye-laws, make bye-laws. and from time to time repeal, alter, or amend any such bye-laws, provided such bye-laws be not repugnant to any law now in force or which at the time when such bye-laws come into operation shall be in force or to the provisions of this Act, and provided also such bye-laws be reduced into writing and have affixed thereto the signature of the Commissioner; and if affecting other persons than the Officers or servants of the Commissioner, be confirmed and published as herein provided.

CCLXI. No bye-laws made by the Commissioner, under the authority of this Act, except such as relief solely to the Bye-laws not relating to the Commis-Commissioner or his Officers or servants shall come sioner or his subordinates to be confirmed into operation until the same be confirmed by the Justices by the Justices and at a Special General Meeting, and thereafter by the Governor in Council.

CCLXIV. Such bye-laws when confirmed by the Governor in Council shall be published in the Government Gazette and in at least one of the 'daily English newspapers and two Vernacular newspapers circulating within the City, and such bye-laws shall be printed, and the officer of the Commissioner appointed by him for the purpose shall deliver a

printed copy thereof to every person applying for the same without charge, and a copy thereof shall be printed or placed on boards which shall be hung up on the front or in some conspicuous part of the principal office of the Commissioner, and also on some conspicuous part of the works or locality to which the same relate, and such boards with the bye-laws thereon shall be from time to time renewed as occasion requires, and shall be open to inspection without fee or reward, and any officer or servant of the Commissioner who does not allow the same to be inspected at all reasonable times shall for every such offence be liable to a penalty not exceeding fifty Rupees.

CCLXV. Such bye-laws when so confirmed and published shall be binding upon and be observed by all parties, and shall Bye-laws to be binding upon all perbe sufficient to justify all parties acting under the same. sons, and to be taken judicial notice of. and all Courts and Magistrates shall take judicial notice of such bye-laws and of the confirmation and publication of the same.

CCLXVI. A

Penalty for injuring copies of bye-laws kept for public inspection.

Any person who destroys, pulls down, injures, or defaces any boards on the premises of the Commissioner on which any bye-law of the Commissioner is printed or placed, shall for every such offence be liable to a penalty not exceeding fifty Rupees.

CCLXVII. The Governor in Council notwithstanding that any bye-law has been confirmed and published as hereinbefore provided,

Government may repeal bye-laws. Such repeal to be published. has been confirmed and published as hereinbefore provided, may at any time subsequent to such confirmation and publication, if he shall see fit, repeal any such bye-law

and in case of such repeal of any bye-law, the same shall at once cease to have any operation except as to any act done or a breach of such bye-law committed before such repeal thereof, and every such repeal of any bye-law shall be published in the *Government Gazette* and in at least one of the daily, English newspapers and two Vernacular newspapers published in Bombay, and all Courts and Magistrates shall take judicial notice of such repeal of any bye-law under this Section.

Existing bye-laws to continue in force till repealed.

CCLXVIII.

All bye-laws made under the provisions of Act XIV. of 1856 or any other Act repealed by this Act, and which bye-laws are in force at the time when this Act comes into operation, shall continue to be in force, and judicial

notice shall continue to be taken thereof by all Courts and Magistrates until the same shall be repealed, altered, or amended; and such repeal, alteration, or amendment, when it takes place, shall be effected in the manner provided for the repeal, alteration, and amendment of bye-laws made under this Act.

CCLXIX. The Commissioner shall publish short particulars of the seve-Publication of penaral offences for which any penalty is imposed by this Act, alties under the Act. or by any bye-law made under this Act, or by Act XIII. of 1856 or Act XLVIII. of 1860, and of the amount of every such penalty, and shall cause such particulars, in English and in the Vernacular languages chiefly in use, to be painted or placed on boards which shall be hung up in some conspicuous part of the office of the Commissioner. CCLXX. The Commissioner shall, as soon after the first day of Commissioner to prepare an annual statement of Municipal receipts and disbursoments and an annual report. Fund for the year ending the 31st December last past, and also a report of his proceedings during that year; and such statement and report shall within three months from the 1st January be printed and submitted to the Justices, and subsequently published for general information.

CCLXXI. This Act may be cited for all purposes as "the Bombay Short title. Municipal Act of 1865."

CCLXXII. This Act shall commence and take effect on and after Commencement of the first day of July A. D. 1865, and in case the assent the Act. of the Governor General to this Act be not published by the Governor on or before the day and year last aforesaid, of which publication, when it takes place, all Courts and Magistrates shall take judicial notice, then on and after the first day of October A. D. 1865.

An.Act to amend Act XXI. of 1848 (for avoiding Wagers).

WHEREAS it is expedient, so far as regards the Presidency of Bombay,

to amend Act XXI. of 1848 (for avoiding Wagers); It is enacted as follows :—

I. All contracts,

Contracts made to assist the entering into agreements by way of gaming or wagering, and contracts by way of security for the performance of such contracts, to be null and void. No suit to be allowed on such contracts. whether by speaking, writing, or otherwise, knowingly made to further or assist the entering into, effecting, or carrying out agreements by way of gaming or wagering, and all contracts by way of security or guarantee for the performance of such agreements or contracts, shall be null and void; and no suit shall be allowed in any Court of Justice for recovering any sum-

of money paid or payable in respect of any such contract or contracts, or any such agreement or agreements as aforesaid.

II. No suit shall be allowed in any Court of Justice for recovering any

PASSED BY THE GOVERNOR OF BOMBAY IN COUNCIL.

[Received the assent of the Governor of Bombay on the 5th of June 1865, and of the Governor General on the 17th August 1865, and published by the Governor of Bombay on the 1st September 1865.]

An Act for the regulation of Mofussil Gaols and the enforcement of discipline therein.

WHEREAS it has become necessary, in consequence of the alterations which Preamble. Preamble. Procedure, that the laws relating to Gaols in this Presidency, other than within the local limits of the ordinary original jurisdiction of the High Court of Judicature of Bombay, and the custody and punishment of prisoners, should be consolidated and amended; It is enacted as follows :---

I. Section XXVI. and Clause 5 of Section XXX. of Regulation II. of Laws repealed. A.D. 1827, Section XLII. and Clause 2, so far as it has been left unrepealed by Section I. of Act XVII. of 1862, and Clauses 3 and 4 of Section XLIII., and Sections XLIV., XLV. and XLVI. cf Regulation XIII, of A.D. 1827, Sections I., II., and III. of Regulation XVI. of A.D. 1828, and Act XI. of 1840 are hereby repealed.

II. From and after the date on which this Act shall come into operation there shall be two classes of Gaols established in the territories subordinate to the Presidency of Bombay; including Aden and the Province of Sind :--

(1.) Civil Gaols for the confinement of persons committed to prison or custody in a Civil Gaol, or under process of any Civil Court, or by order of any other Court, in cases in which the law directs that persons so committed to prison or custody shall be confined in the Civil Gaol.

(2.) Criminal Gaols, for the execution of punishments under Section 53 of THE INDIAN PENAL CODE, (Act XLV. of 1860,) and for the confinement of persons committed to custody 'or imprisonment by any Court of criminal jurisdiction, in all cases in which the law does not expressly direct that such persons shall be confined in the Civil Gaol.

III. There shall be a Civil Gaol for each District at the scat of the A Civil Gaol to be at the seat of each District Court, and may be at other places. District Court, provided that it shall be in the power of the Governor in Council to establish Civil Gaols at other convenient places.

IV. The Nazir of the District or of the Civil Court shall be *ex-officio* keeper of the Civil Gaol, and shall be responsible for the safe custody of the prisoners, and for the preservation of cleanliness and good order in the Gaol and among the prisoners, and shall have such establishment under him as the District Judge, with the sanction of the Governor

in Council, may direct.

V. The District Judge or his Assistant shall visit the Civil Gaol at least The District Judge to visit the Civil Gaol. once in each month, and shall issue such orders connected with the economy of the Gaol, the good management, health, and accommodation of the prisoners, as he may think fit. He shall record the date of his visit, and any remarks he may have to make, in a book to be called "the Visitor's Book," and shall bring any special cases to the special notice of Government.

VI. The Civil Surgeon of the Station shall attend the Civil Gaol, and shall be bound to offer such advice to the District Judge as may seem expedient to him with regard to the sanitary state of the Gaol and of the prisoners. He shall also administer remedies at the expense of the Government to the sick, provided that nothing contained

in this Section shall prevent a prisoner in a Civil Gaol from employing any medical man he may think fit to consult.

VII. The Civil Gaol shall be opened daily for the admission of those Strangers may be admitted to the Civil Gaol. wishing to visit prisoners from one hour after sunrise until one hour before sunset, and no stranger shall on any account be allowed to sleep in the Civil Gaol.

VIII. Prisoners in the Civil Gaol may either make their own arrange-

Subsistence of prisoners in the Civil Gaol. ments with their friends for their subsistence, or may, within the amount of subsistence money or batta furnished by the party at whose suit they are detained,

require the Nazir to furnish their food and other necessaries out of the subsistence money fixed for them by the Court by which they are committed, provided that excess in the use of intoxicating liquors or drugs be strictly prohibited. A Tariff of prices approved by the District Judge on the first day of each month shall be kept in the Gaol, accessible to all the prisoners.

IX. Whenever à prisoner shall die in the Civil Gaol, the Nazir shall Disposal of the corpse of a prisoner dying in the Civil Gaol. immediately report such death to the nearest Magistrate or Subordinate Magistrate, who shall thereupon inquire into the cause of such death, and make a written report thereon to the Inspector General of Prisons, and the corpse of the prisoner so

dying shall, after the Civil Surgeon has certified to his death, be made over to his friends, or, in failure of their taking the corpse, it shall be buried at the expense of the Civil Gaol Fund, as hereinafter provided.

XII. Clause 1st.—Temporary Subordinate Gaols may be established by Temporary and Permanent Subordinate Country as occasion may require, and may also, as oc-Gaols. Casion requires, be removed, from time to time, to other places. They may also, if special reasons exist, be established by the Superintendent of the District or Subordinate Gaol, in anticipation of the sanction of the Governor in Council.

Clause 2nd.—Subordinate Gaols, when not expressly declared to be temporary, shall be deemed permanent, and shall be established wherever the Governor in Council may direct.

XIII. All persons committed by Criminal Courts for safe custody, and What persons to be confined in District and Subordinate Gaols. Gaol, whichever may be the nearer to the place where sentence is passed upon the convict, or where the order is given for the culprit's detention.

XIV. District Gaols shall be established at the seats of the Courts of the District Gaols. District Gaols. District Gaols. District Gaols. Session Judges, and may be established at the seats of Assistant Judges at detached Stations, and all convicts sentenced by the Courts of Session, and all others, not specially ordered or required by the last preceding Clause to be imprisoned in another Gaol, shall be imprisoned in the District Gaol. Nothing however in this Section is to be held as interfering with the power of the local Government to direct the removal of prisoners from one Gaol to another, or to prevent a Central and a District Gaol being united in one Gaol.

XV. Central Gaols may be established at any places the Governor in Central Gaols. Central Gaols. Council may think fit, and prisoners shall be sent to those Gaols under such general rules as the Governor in Council may, from time to time, issue.

Gaols to be in charge of Gaolers, to whom warrants for confinement are to be addressed.

XVI. Every Gaol shall be in charge of a Gaoler, to whom all warrants for the confinement of prisoners shall be addressed. The Gaoler responsible for the safe custody of prisoners, and for due execution of warrants.

XVII.

The Gaoler shall be responsible for the safe custody of the prisoners from the time they are received into the Gaol, until they are discharged by lawful authority. He shall also be liable for the due execution of all warrants and orders, which he may receive, regarding prisoners and their punishment.

XVIII. Subject to the provisions hereinafter contained, every Criminal Criminal Gaols to be under Superintendents, to whom the Gaolers are to be subordinate. Gaol shall be governed and superintended by a person to be appointed by order of the Governor in Council, who shall be called the Superintendent of the Gaol, and to whom the Gaoler shall be subordinate.

XIX. The Gaoler of District and permanent Subordinate Gaols shall Appointment of Gaol. be appointed by the Superintendent of the Gaol, subject ers. to the approval of the Inspector General of Prisons, and the Gaolers of Central and temporary Subordinate Gaols shall be appointed by the Inspector General of Prisons, provided that it shall be competent for the Governor in Council to declare by Notification in the Government Gazette that certain Officers are ex-officio Superintendents of or Gaolers of Subordinate Gaols.

XX. No Gaoler shall receive any prisoner into custody without the warrant of a Court or Officer having authority to commit to prisoner without warrant. mit to prison or custody, or, in the case of a prisoner sentenced by Court Martial, without an authenticated copy of the sentence or order required by Articles 87 and 88 of Act XXIX. of 1861, or without the warrant of a Court or Officer having authority to transfer a prisoner from one Gaol to another.

XXI. All clothing and other property and money delivered with, or

Clothing and property belonging to a prisoner to be taken charge of by the Gaoler. Disposal of property found in possession of prisoner after his admission to Gaol. found upon the person of a criminal prisoner on his admission into Gaol, shall be taken charge of by the Gaoler, under such rules for its safe custody as the Superintendent of the Gaol may make, and the prisoner shall have no claim thereto until his discharge. In the event of the prisoner's death while he is undergoing his sentence, such property shall be made over to whomsoever he may appoint to receive it, and, failing such appointment, it shall be made over to the Civil Court under Chapter II. of Regulation VIII. of A.D. 1827, as if there were no heir or executor competent or willing to take possession of such property, provided that any property or money found in the possession of a criminal prisoner, at any date subsequent to his admission, shall be forfeited to Government.

XXII. Such clothing, bedding, and other household articles as are necessary for prisoners in Criminal Gaols, shall be sup-Necessary clothing &c., to be supplied at the expense of Government. by the Superintendent of the Gaol, under the direction of the Inspector General of Prisons.

XXIII. All prisoners confined in Criminal Gaols shall be subsisted at Subsistence of prisoners in Criminal Gaols. the expense of the Government, the allowance, which shall always be of food and not of money, being regulated by the Superintendent of the Gaol, under the

direction of the Inspector General of Prisons.

XXIV. Male prisoners shall always, and in all Gaols, be kept separate from female prisoners, and those sent to Gaol for punishment from those sent there for safe custody. Sick prisoners shall always be sent to the Hospital, which may

be either a separate Gaol, or a building distinct from the Gaol, and prisoners sent to Hospital shall be detained there until the Surgeon direct that they may be returned to Gaol, and with regard to any further sub-division of prisonerc, the Gaoler shall attend to any orders on the subject that he may receive from the Superintendent of the Gaol, provided that, consistently with the objects of this Act, due care is taken in regard to religious prejudices, and to protect the trivial offender from, of necessity, associating with the vicious and heinous offender.

XXV. The Gaoler shall be careful to prevent drunkenness, gaming, and

The Gaoler to prevent misconduct, &c., on the part of prisoners. immoral or disorderly conduct of any sort within the Gaol, and to report to the Superintendent of the Gaol all instances of such misconduct, as well as all prisoners guilty of disobedience, or of violent or refractory conduct, or of using insulting or abusive language, or of refusing or wilfully neglecting to perform the work, or of wilfully mismanaging the work allotted to them, or of malingering, or of wilfully disabling themselves, or of the breach of any rules prescribed for the good management or economy of the Gaol.

XXVI. The Superintendent of the Gaol, on such report being made to him, Punishment for breach of Gaol discipline. and being satisfied of the fact, or when any misconduct of the nature described in the preceding Section is committed or occurs in his presence, may punish such misconduct or breach of discipline by solitary confinement for a period not exceeding seven days, by confinement in the stocks for a period which may extend to twelve hours, or by corporal punishment not exceeding twenty-five stripes with a rattan of not more than three-eighths of an inch diameter : Provided always that corporal punishment shall not be inflicted on anymale prisoner unless the Medical Officer of the Gaol shall state that the prisoner can bear it without danger to his general health, and that such corporal punishment shall not be inflicted except in the the presence of the Superintendent of the Gaol, and that corporal punishment shall in no case be inflicted on any female prisoner.

XXVII. The Superintendent of the Gaol shall keep a book, to be called "the A "Punishment Book," Punishment Book," in which shall be recorded the prito be kept. Soner's name, the breach of prison discipline of which he was guilty, the date on which it was committed, the punishment inflicted, and the date.

XXVIII. Whoever, without due permission, takes or attempts to take, or

Punishment for taking prohibited articles into Gaol, &c. introduces or attempts to introduce, or throws or attempts to throw, into any part of a Gaol, any article prohibited by the rules to be made under this Act, or communicates or attempts to communicate with any prisoner in any

mode contrary to such rules, shall be liable to be apprehended and brought before a Magistrate, and, on conviction, shall be punished with fine, which may extend to fifty Rupees, or with imprisonment of either description, which may extend to two months.

XXIX. The Civil Surgeon of the Station shall attend the Gaol, and administer remedies to the sick, removing such as reprisoners. quire it to the Hospital. In the event of a Surgeon being specially appointed to the Gaol, or of the Civil Surgeon being appointed under Section XVIII. or XIX. to be Superintendent of a Gaol, he shall himself attend, as Medical Officer, and administer remedies to the sick.

XXX. When a sentence has been fully executed, the Gaoler shall make

Procedure on the expiration of the term of a prisoner's sentence. over to the prisoner the clothing taken from him under Section XXI., and receive from him the clothing and other articles with which he was furnished at the expense of the Government, and shall endorse upon the

warrant a statement of how it has been executed, and shall then take the warrant and the prisoner before the Superintendent of the Gaol, and there, in presence of the Superintendent of the Gaol, discharge the prisoner. The Superintendent of the Gaol shall then, countersign the endorsement, and the Gaoler shall return the warrant with the endorsement thereon to the Officer from whom he received it.

A prisoner's personal property to be returned to him on his discharge. time of discharging the prisoner, the Gaoler shall make over to him any other property or money he may have received with the prisoner, or found on him and taken charge of, as directed in Section XXI., and shall take

his receipt for the same; and the receipt, when countersigned by the Superintendent, shall be deemed to be, and is a good acquittance and release from all claims by the prisoner or his representatives against the Gaoler for such property.

XXXII. When a prisoner is released, the Superintendent of the Gaol

XXXIII. No

Disposal of prisoner in Hospital on the expiration of his sentence.

No prisoner, being in Hospital on the expiration of his sentence, shall be discharged from the Hospital, except at his own request, or unless the Surgeon certify that he can be discharged without endangering his life or protracting his illness; the Superintendent shall explain

to him that his sentence has expired, and shall direct all restraint to be

removed, and, on the Surgeon reporting the late prisoner convalescent and about to leave the Hospital, the Superintendent of the Gaol may grant him, if necessary, subsistence money, as provided in the last Section.

XXXIV. If any prisoner shall die in Gaol before full execution of his sentence, the Gaoler shall immediately report such death Procedure if a prisoner dies in Gaol before full execution of his sentence. to the nearest Magistrate or Subordinate Magistrate, who shall thereupon inquire into the cause of such death,

and make a written report thereon to the Inspector General of Prisons, and upon such death taking place, the warrant shall be returned by the Gaoler to the Officer who issued it, with an endorsement showing how far it had been executed, and with a certificate attached to it from the Surgeon certifying to the prisoner's death.

XXXV. If any prisoner make his escape from Gaol, the Gaoler shall endorse on his warrant to what extent his sentence had been carried out, and the date of the escape, and shall return the warrant to the Officer who issued it, and the warrant and endorsement shall be proof in every Court that the prisoner was convicted, that he underwent the extent of punishment endorsed on the warrant, and that he effected his escape from confinement on the day stated.

XXXVI. The Inspector General of Prisons shall, from time to time with the sanction of Government, promulgate such rules and orders as may appear necessary for the supervision, employment, custody, clothing, dieting, treatment, and classification of prisoners, and for the management of Gaols.

XXXVII. The Magistrate of the District, or his Assistant or Deputy, shall, once in every week, visit the District Gaol and Hospital, to hear complaints, and to see that considerations of cleanliness, health, and security are attended to,

and a proper management maintained in all respects. He shall examine the Punishment Book, and record his proceedings and observations in a book. to be called "the Visitor's Book." He shall bring any special cases to the special notice of the Inspector General of Prisons, or, if necessary, of the Government, and he may direct petitions from prisoners to Government to be 38r prepared and forwarded, the Superintendent of the Gaol being likewise at liberty, for special reasons, to allow a prisoner to send a petition to Government.

XXXVIII. Visitors for Central and Subordinate Gaols shall be appointed by the Government, for the purposes contemplated in Section XXXVII., to the provisions of which they shall in all respects conform.

XXXIX. This Act shall be read with (Bombay) Act X. of 1862, and nothing contained in this Act shall be construct as interfering with the power vested in the Governor in Council, under Act VIII. of 1856, of control of all Gaols, and to appoint persons to inspect and superintend Gaols, and to vest in them such power and authority, for the purpose, as to the Governor in Council may seem proper.

XL. The following words and expressions in this Act shall have the Interpretation. meaning hereby assigned to them, unless there be some thing in the context repugnant to such construction :--

The words "Inspector General of Prisons" shall mean the Officer appointed under the provisions of Section II. of Act VIII. "Inspector General of Prisons." of 1856, to inspect and superintend the Gaols in the Bombay Presidency, subject to the orders of the Governor in Council.

The words "Magistrate of the District" shall mean the chief Officer "Magistrate of the charged with the executive administration of a District District." or place in criminal matters, by whatever designation such Öfficer is called.

"Magistrate." The word "Magistrate" shall include all persons exercising all or any of the powers of a Magistrate.

[Received the assent of the Governor of Bombay on the 2nd September 1865 and of the Governor General on the 22nd September 1865, and published by the Governor of Bombay on the 14th October 1865.]

An Act to authorize the Punishment of Whipping, in certain cases, in the Bombay House of Correction.

WHEREAS it is expedient to invest the Committee of Management of the Bombay House of Correction with the power of inflicting the punishment of whipping on prisoners who are guilty of certain gross breaches of prison discipline; It is enacted as

follows :---

I. It shall be lawful for the majority of the Committee of Management Gross breaches of prison discipline may be punished with whipping. I. It shall be lawful for the majority of the Committee of Management of the House of Correction, in substitution for any punishment which they are authorized by law to inflict, to order that the punishment of whipping

shall be inflicted on any prisoner under sentence in the House of Correction who is guilty of grossly immoral or disorderly conduct of any sort, or of obstinate disobedience to lawful orders, or of grossly violent and refractory conduct, or of repeatedly using insulting or abusive language, or of obstinately refusing or neglecting to perform the work, or of wilfully and repeatedly mismanaging the work allotted to him, or of wilfully disabling himself from working, or of the wilful and repeated breach of any rule or bye-law made by the Committee for the good management or economy of the House of Correction.

II. When any breach of prison discipline as described in the preceding

An Act to authorize the destruction of Useless Records in certain Courts of the Bombay Presidency.

WHEREAS doubts have arisen respecting the power of the Judges of the Preamble. High Court at Bombay to order the destruction of useless records in the Courts in the Presidency of Bombay, and whereas also it is expedient to indemnify all persons who may have destroyed any papers or records in pursuance of the Circular Order issued by the late Sudder Court at Bombay on the 30th of November 1858, prescribing rules for the destruction of useless records; It is enacted as follows :---

I. It shall be lawful for the Chief Justice and Judges of Her Majesty's

Judges of the High Court may make rules for the destruction of useless records in subordinate Courts.

An Act to authorize taxation in the Province of Sind for objects of public local utility and improvement.

WHEREAS it is expedient to provide funds for local works of public Preamble. in the Province of Sind; It is enacted as follows :---

I. It shall be lawful to levy for the purposes of this Act from all lands in the Province of Sind a cess not exceeding one anna on every rupee assessable to the ordinary land revenue, and such cess shall be levied in the same manner, and under the same rules, as the ordinary land revenue: Provided that in all cases where an

VIII.
