## ACT No. I of 1895.

PASSED BY THE GOVERNOR GENERAL OF INDIA IN COUNCIL.

(Received the assent of the Governor General on the, 4th January, 1895)

An Act to amend the Presidency Small Cause Courts Act, 1882.

V of 1882.

WHEREAS it is expedient to amend the Presidency Small Cause Courts Act, 1882; It is hereby enacted as follows:--

1. (1) This Act may be called the Presidency Title and Small Cause Courts Act, 1895; and

During any absence of the Chief Judge the Local Government may appoint any of the Judges of the Court who may be qualified for the appointment of Chief Judge to perform the duties of Chief Judge, and may appoint some other duly qualified person to act as a Judge of the said Court until the Chief Judge has returned from such absence, and during any absence of a Judge of the said Court the Local Government may appoint a duly qualified person to act as a Judge of the said Court, and every person so appointed shall be authorized to perform the duties of a Judge of the said Court until the return of the absent Judge or until the Local Government shall see cause to cancel the appointment of such acting Judge."

Procedure and pactice of Small Cause Court. 5. For section 9 of the said Act the following shall be substituted, namely:—

- "9. (1) The High Court may from time to time, by rules having the force of law,—
  - (a) prescribe the procedure to be followed and the practice to be observed by the Small Cause Court either in supersession of or in addition to any provisions which were prescribed with respect to the procedure or practice of

the Small Cause Court on or before the thirty-first day of December, 1894, in or under this Act or any other enactment for the time being in force, and

- (b) cancel or vary any such rule or rules.
- "Rules made under this section may provide, among other matters, for the exercise by one or more of the Judges of the Small Cause Court of any powers conferred on the Small Cause Court by this Act, or any other enactment for the time being in force.
- "(2) The law, and any rules and declarations made, or purporting to be made, thereunder, with respect to procedure or practice, in force or treated as in force in the Small Cause Court on the thirty-first day of December, 1894, shall be in force, unless and. until cancelled or varied by rules made by the High Court under this section."

Whenever the Court finds that for want of jurisdiction it cannot finally determine the question at issue in the suit, it may at any stage of the proceedings return the plaint to be presented to a Court having jurisdiction to determine the question. When the Court so returns a plaint, it shall comply with the provisions of the second paragraph of section 57 of the Code of Civil Procedure XIV of 1882. and make such order with respect to costs as it may think just, and the Court shall for the purposes of the Indian Limitation Act, 1877, be deemed to have xv of 1877. been unable to entertain the suit by reason of defect of jurisdiction. When a plaint so returned is afterwards presented to a High Court, credit shall be given to the plaintiff for the amount of the court-fee paid in the Small Cause Court in respect of the plaint in the levy of any fees which according to the practice of the High Court are credited to the Government."

#### "CHAPTER VI.

#### "NEW TRIALS AND APPEALS.

"37. Save as otherwise provided by this Chapter General final-or by any other enactment for the time being in force, ity of decrees and orders of every decree and order of the Small Cause Court in a Small Cause suit shall be final and conclusive.

"38. - "(2) Unless the Judge is of opinion that the application has been made solely for the purpose of delay, the applicant shall be entitled to such order as of right, but it shall be lawful for the Judge, if he shall think fit, in and by such order to require the applicant to give security to a reasonable amount to


be specified in the order for the payment of any costs which may become payable by him to the plaintiff in respect of the said suit, and such Judge may also, if he shall think fit, declare that the removal directed' by such order shall be conditional upon the completion of such security within a reasonable time to be prescribed in the order.

- "(3). If the applicant fail or neglect to complete the required security (if any) within the prescribed time (if any), the said order shall be discharged and the suit shall proceed in the Small Cause Court as if such order had never been made.
- "(4) If the plaintiff in any case which has been removed under this section into the High Court has abandoned a portion of his claim in order to be able to bring the suit within the jurisdiction of a Small Cause Court, he shall be permitted to revive the portion of his claim so abandoned.

Rules with respect to suits removed under the last foregoing section.

- "40. (1) When a suit has been removed into the High Court under the last foregoing section, it shall be heard and disposed of by such Court in the exercise of its original jurisdiction, and the said Court shall have all the same powers and jurisdiction in respect thereof as if it had been originally instituted in such Court.
- "(2) In every suit so removed as aforesaid the affidavit filed under section 39, sub-section (1), shall be treated as a written statement of the defendant tendered under section 110 of the Code of Civil Pro- XIV of 1882 cedure unless the Court shall otherwise order.

  - (b) whenever he becomes aware that any such boundary or survey-mark has been destroyed, injured or altered, to report immediately to the officer in charge of the nearest police-station or to the nearest Magistrate such destruction, injury or alteration."

PASSED BY THE GOVERNOR GENERAL OF INDIA IN COUNCIL. (Received the assent of the Governor General on the 8th Feb. ruary, 1895.)

An Act to amend the Indian Penal Code, Act. VI of 1864 and the Indian Post-office Act, 1866.

Whereas it is expedient to amend the Indian Penal Code, Act VI of 1864 and the Indian Post-IV of 1866. office Act, 1866; It is hereby enacted as follows:—

# Indian Penal Code.

1. For section 182 of the Indian Penal Code the substitution following shall be substituted, namely:—

- "182. Whoever gives to any public servant any False informinformation which he knows or believes to be false, ation, with intent to intending thereby to cause or knowing it to be likely cause public that he will thereby cause, such public servant—

- "(b) A falsely informs a public servant that Z has contraband salt in a secret place knowing such information to be false, and knowing that it is likely that the consequence of the information will be a search of Z's premises, attended with annoyance to Z. A has committed the offence defined In this section.
- "(c) A falsely informs a policeman that he has been assaulted and robbed in the neighbourhood of a particular village. He does not mention the name of any person as one of his assailants, but knows it to be likely that in consequence of this information the Police will make enquiries and institute searches in the village to the annoyance of the villagers or some of them. A has committed an offence under this section"

Addition of section to Chapter XII, Act XLV, 1860. Prohibition of fictitious stamps.

#### " 263A. (1) Whoever—

- (a) makes, knowingly utters, deals in or sells any fictitious stamp, or knowingly uses for any postal purpose any fictitious stamp, or
- (b) has in his possession, without lawful excuse, any fictitious stamp, or
- (c) makes or, without lawful excuse, has in his possession any die, plate, instrument or materials for making any fictitious stamp,

shall be punished with fine which may extend to two hundred rupees.

- "(2) Any such stamp, die, plate, instrument or materials in the possession of any person for making any fictitious stamp may be seized and shall be forfeited.
- "(3) In this section 'fictitious stamp' means any stamp falsely purporting to be issued by Government for the purpose of denoting a rate of postage, or any facsimile or imitation or representation, whether on paper or otherwise, of any stamp issued by Government for that purpose.

" (4) In

- "(4) In this section and also in sections 255 to 263, both inclusive, the word 'Government,' when used in connection with, or in reference to, any stamp issued for the purpose of denoting a rate of postage, shall, notwithstanding anything in section 17, be deemed to include the person or persons authorised by law to administer executive government in any part of India, and also in any part of Her Majesty's dominions or in any foreign country."

- (3) If the addressee or his agent shall fail to attend at the post-office within the time specified in such notice, or, having attended within such time, shall refuse to make known the name and address of the sender of the letter or article or to redeliver the article or portion thereof as required by sub-section (2), the same shall not be delivered to him, but shall be disposed of in such manner as may be directed by the Governor General in Council.
- (4) For the purposes of this section 'postage-stamp' shall include any impressed, embossed or affixed stamp for denoting any rate or duty of postage of any part of Her Majesty's dominions or of any foreign country."

WHEREAS it is expedient to amend sections 366 and 371 of the Code of Criminal Procedure, 1882; It is hereby enacted as follows:

1. For section 366 of the said Code the following substitution shall be substituted, namely:—

"368. (1) The judgment in every trial in any Mode of deli-Criminal Court of original jurisdiction shall be pro- vering judgnounced, or the substance of such judgment shall be ment explained,—

- (a) in open Court either immediately after the termination of the trial or at some subsequent time of which notice shall be given to the parties or their pleaders, and
- (b) in the language of the Court, or in some other language which the accused or his pleader understands:

Provided that the whole judgment shall be read out by the presiding Judge, if he is requested so to do either by the prosecution or the defence.

(2) The accused shall, if in custody, be brought .up, or, if not in custody, shall be required by the Court to attend, to hear judgment delivered, except where his personal attendance during the trial has been dispensed with and the sentence is one of fine only, only, in which case it may be delivered in the presence of his pleader.

- (3) No judgment delivered by any Criminal Court shall be deemed to be invalid by reason only of the absence of any party or his pleader on the day or from the place notified for the delivery thereof, or of any omission to serve, or defect in serving, on the parties or their pleaders, or any of them, the notice of such day and place.
- (4) Nothing in this section shall be construed to limit in any way the extent of the provisions of section 537."

33 & 34 Vict., WHEREAS by the Extradition Act, 1870, it is, among other things, enacted that the said Act, when applied by Order in Council, shall, unless it is otherwise provided by such order, extend to every British possession, but with the following among other modifications, namely :---

> No warrant of a Secretary of State shall be required, and all powers vested in, or acts authorized or required to be done under the said Act by, the Police Magistrate and the Secretary of State, or either of them, in relation to the surrender of a fugitive criminal, may be done by the Governor of the British possession alone:

And whereas by the said Act it is also enacted that, if by any law or ordinance made before or after the passing of the said Act by the Legislature of any British possession provision is made for carrying into effect within such possession the surrender of fugitive criminals who are in or are suspected of being in such possession, Her Majesty may, by the Order in Council applying the said Act in the case of any foreign State, or by any subsequent order, either—

- (7) The payment of such interest shall not operate as a reduction of the amount paid up on the shares in respect of which it is paid.

WHEREAS it is expedient to make better provision for the regulation of pilgrim ships; It is hereby enacted as follows:—

Provided that no ship carrying passengers other than pilgrims of the lowest class and having on board pilgrims of the lowest class in a less proportion than one pilgrim for every one hundred tons of the gross tonnage of the ship shall be deemed to be a pilgrim ship within the meaning of this Act:

Explanation.—A "pilgrim of the lowest class" is a pilgrim for whom no separate accommodation in any cabin, state-room or saloon is reserved:

Discretion as to grant of certificate.

- 16. (1) The officer authorized to grant a certificate under this Act in respect of a pilgrim ship shall not grant it unless he is satisfied that she has on board no cargo likely from its quality, quantity or mode of stowage to prejudice the health or safety of the pilgrims embarked.
- (2) But save as aforesaid, and subject to the provisions of sub-section (3), it shall be in the discretion of the officer to grant or withhold a certificate under this Act.

  - (a) the local limits within which, and the time and mode at and in which, pilgrims shall be embarked or discharged at any port or place appointed under this Act in that behalf; and
  - (b) the time within which a pilgrim ship shall depart or proceed on her voyage after commencing to take pilgrims on board.
- (3) In making a rule under this section the authority making it may direct that a breach of it shall be punishable with fine which may extend to two hundred rupees, and when the breach is a continuing breach with a further fine which may extend to twenty rupees for every day after the first during which the breach continues.
- (4) The power to make rules under this section is subject to the condition of the rules being made after previous publication.

# Pilgrim Ships. [ACT XIV, 1895.] (Supplemental.—Sections 59-60.)

Temporary continuance of existing rules. 59. All rules heretofore made under the Native X of 1887. Passenger Ships Act, 1887, shall, so far as consistent with this Act, continue to be applicable to pilgrim ships unless and until they shall be superseded or altered by rules under this Act.

Appointment of officers.

60. The Local Government shall appoint such persons as it may think fit to exercise and perform the powers and duties which are conferred and imposed by this Act or may be conferred and imposed thereunder.

Passed by the Governor General of India in Council (Received the assent of the Governor General on the 10th October, 1895.)

WHEREAS doubts have arisen as to the extent and operation of the Transfer of Property Act, 1882, and as to the power of the Crown to impose limitations and restrictions upon grants and other transfers of land made by it or under its authority, and it is expedient to remove such doubts; It is hereby enacted as follows:--

And whereas it is also expedient that certain formal amendments should be made in the enactments specified in the second schedule to this Act;

It is hereby enacted as follows:—

(Received the assent of the Governor General on the 10th October, 1895.)

An Act to validate certain marriages solemnized in the Civil and Military Station of Bangalore.

WHEREAS the Reverend James Gillings, a Minister of the Wesleyan Mission, was, in the year 1871, granted by the Governor of Madras in Council a license, under the provisions of section 8 of the Indian Marriage Act, 1865, to solemnize marriages between persons, one or both of whom professed the Christian religion, "within the territories subject to the Government of Madras";

And whereas the said James Gillings has, in the belief that he was duly authorised so to do by virtue of the said license, solemnized certain marriages in the Civil and Military Station of Bangalore between certain Christian subjects of Her Majesty;

And whereas the parties to the said marriages all boná fide believed that the said James Gillings was duly authorised to solemnize the same, and that such marriages were valid in law;

And whereas the said Civil and Military Station of Bangalore was not at the time when such marriages were solemnized, and is not, part of "the territories subject to the Government of Madras", and the said James Gillings had, therefore, no authority to solemnize the said marriages;

And whereas it is expedient that the said marriages, having been solemnized in good faith, should be validated;

#### Validation of Marriages [ACT XVII, 1895.] (Bangalore).

It is hereby enacted as follows:-

(Received the assent of the Governor General on the 19th October, 1895.)

An Act to incapacitate ex-King Thebay from binding himself by contract so as to give rise to any enforceable pecuniary obligation and to provide for an inquiry into his present state of indebtedness.

WHEREAS it is expedient to render Thebaw, formerly King of Burma, and now a State prisoner at Ratnagiri in the Presidency of Bombay (hereinafter called ex-King Thebaw) henceforth incapable of binding himself by contract so as to give rise to any enforceable pecuniary obligation;

And whereas divers pecuniary claims have been brought against ex-King Thebaw and the validity and amounts of the said claims or some of them are contested on his behalf:

And whereas ex-King Thebaw is possessed of certain moveable property and it is expedient that the same should be made available for the payment of the said claimants to the extent and in the manner hereinafter appearing;

It is hereby enacted as follows:—

1. This Act may be called ex-King Thebaw's Act, Title, extent 1895.

- (2) It extends to all persons and places for whom and for which the Governor General in Council has power to make laws; and
  - (3) It shall come into force at once.

- 3. (1) The Governor General in Council may nominate and appoint such person or persons as he may think fit to be a Commissioner or Commissioners for the purposes hereinafter mentioned.
- (2) The person or persons so nominated and appointed (hereinafter called "the Committee") shall continue to act as such during the pleasure of the Governor General in Council, and shall hold his or their sittings at such place or places and time or times as may seem to him or them fit.

Notice to claimants.

4. The Committee shall publish thrice in the Gazette of India in English, and in the Bombay Government Gazette in English and in such other mode and languages as may seem to it fit, a notice inviting all persons having claims against ex-King Thebaw or his property to notify the same in writing to the Committee within six months from the date of the earliest of such publications.

Presentation of claims.

- 5. (1) Every person notifying any claim in accordance with the said notice shall along with his claim present full particulars thereof.
- (2) Every document relied upon as the foundation of, or as evidence in support of, any such claim shall be delivered to the Committee along with such claim.
- (3) If any such document be an entry in any book, the claimant shall produce the book before the Committee, together with a copy of the entry on which he relies. The Committee shall mark the book for the purpose of identification, and, after examining and comparing the copy with the original, shall return the book to the claimant.
- (4) If any document in the possession or under the control of any claimant is not delivered or produced by him to the Committee along with the claim, the Committee may refuse to receive such document in evidence on the claimant's behalf at the inquiry into the claim.

(5) The

- (5) The Committee may, from time to time, call for further and more detailed particulars of any claim preferred under this Act, and may at its discretion refuse to proceed with the inquiry into the claim until such particulars are supplied.
- 6. (1) The Committee shall consider all claims (if any) presented under section 5 and shall make due and full inquiry in respect thereof and shall certify the result of such inquiry as hereinafter mentioned.

Consideration of claims.

(2) Every inquiry under this Act shall be conducted, as far as may conveniently be, as though it were a suit duly instituted in a Court of competent jurisdiction for the recovery of the debt claimed and the Committee were the Judge of such Court.

- (3) All the provisions of the Code of Civil Proced. ure applicable to such a suit shall, as far as may conveniently be, apply to every such inquiry, and the Committee shall have all the powers and authority of a Judge of a Civil Court in respect thereof.
- (4) Every inquiry conducted by the Committee with reference to any claim preferred under this Act. or to any matter connected with any such claim, shall be deemed a judicial proceeding within the meaning of the Indian Penal Code, and every statement made by any person examined by or before the Committee with reference to such inquiry, whether upon oath or otherwise, shall be deemed to be evidence within the meaning of the same Code.

- (3) The Committee shall in each case certify the amount of the award determined under this section to the Governor General in Council.

(4) No appeal against any such certificate, or the amount of the award thereby certified, shall lie to any Court or other authority whatsoever.

8. No creditor of ex-King Thebaw who has presented a claim to the Committee under this Act and supported it by evidence before the Committee, shall be capable of instituting or maintaining any suit or other proceeding against ex-King Thebaw or his property in respect of the debt which was the subject of such claim, except in accordance with the proviso, in that behalf hereinafter contained.

Satisfaction of claims.

9. (1) The Governor General in Council may, at any time within six months from the date of any such certificate as aforesaid, pay or tender to the claimant the amount so certified, and thereupon all claims of the claimant against ex-King Thebaw or his property in respect of the debt referred to in such certificate shall be satisfied and extinguished:

Provided that the Governor General in Council may, by notification in the Gazette of India, extend the said term of six months to such date as may be found necessary to enable the Committee to make a final and complete award on all the claims presented to it.

(2) If the Governor General in Council shall pay or tender to any claimant the amount of any such award as aforesaid, the property of ex-King Thebaw shall thereupon, to the extent in value of the sum so paid, vest in the Secretary of State for India in Council on behalf of Her Majesty, Her heirs and successors.

10. (1) If the total amount of the awards so certified as aforesaid appears to the Governor General in Council to be likely to exceed the value of the whole of the said moveable property of ex-King Thebaw, the Governor General in Council may cause

the said property to be valued in such manner as he may think fit, and thereupon the whole of the said property shall vest in the Secretary of State for India in Council on behalf of Her Majesty, Her heirs and successors. \*

- (2) If the Governor General in Council causes the provisions of sub-section (1) to be put in operation, and the amount of such valuation as aforesaid, after deducting the expenses thereof, equals or exceeds the total amount of such awards as aforesaid, he shall pay to the several claimants the amounts awarded to them respectively and shall pay the surplus (if any) to ex-King Thebaw or his assigns.
- (3) If the amount of such valuation as aforesaid after deducting the expenses thereof falls short of the total amount of such awards as aforesaid, the Governor General in Council shall distribute the amount of the said valuation among the claimants rateably in proportion to the awards obtained by them respectively, and thereupon all claims of all such claimants against ex-King Thebaw or his property in respect of all such debts as aforesaid shall be satisfied and extinguished.
