XXI of 1860. WHEREAS it is expedient to amend the Societies Registration Act, 1860, in manner hereinafter appearing;

AND WHEREAS the previous sanction of the Governor General required by section 5 of the Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

1. Notwithstanding anything contained in sec-Amendment XXI of 1860, tion 14 of the Societies Registration Act, 1860, of section hereinafter called "the said Act", it shall be lawful for the members of any society dissolved under section 13 of the said Act to determine by a majority of the votes of the members present personally or by proxy at the time of the dissolution of such society that any property whatsoever remaining after the satisfaction of all its debts and liabilities shall be given to Government to be utilised for any of the purposes referred to in section 1 of the said Act.

BOMBAY ACT No. III OF 1912.

(First published, after having received the assent of the Governor General, in the Bombay Government Gazette on the 6th June 1912.)

An Act to provide for the licensing of race-courses in the Bombay Presidency.

WHEREAS it is expedient to make provision for the regulation of horse-racing in the Bombay Presidency; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Short title Race-courses Licensing Act, 1912.
- (2) This section extends to the whole of the Bombay Presidency. The rest of the Act extends only to such areas as the Governor in Council may by notification in the Bombay Government Gazette direct.

2. In this Act-

- (a) "horse-race" means any race in which Definitions. any horse, mare or gelding runs or is made to run in competition with any other horse, mare or gelding for any prize of what nature or kind soever, or for any bet or wager made or to be made in respect of any such horse, mare or gelding or the riders thereof, and at which more than twenty persons shall be present.
- (b) "race-course" means any ground on which a horse-race can be held.
- 3. (1) No horse-race shall be held save on a Prohibition race-course for which a license for horse-racing against granted in accordance with the provisions of this horse-racing on Act is in force.

(2) The terms of such license shall be published in the Bombay Government Gazette.

- 4. (1) The owner, lessee or occupier of any race-course may apply to the Governor in Council for a license for horse-racing on such race-course.
- (2) The Governor in Council may withhold such license or grant it subject to such conditions and for such period as he may think fit.
- (3) The Governor in Council may at any time cancel any license granted under this section in the event of any breach of the conditions subject to which it was granted.

Penalty for in thorseunlicensed

5. Whoever takes part in any horse-race on taking part any race-course for which a license granted in accordance with the provisions of section 4 is not in force shall be punishable with fine which may race-course, amount to two hundred rupees.

Penalty for allowing racing in unlicensed place.

If any horse-race is held on any race-course owner, etc., for which a license granted in accordance with the provisions of section 4 is not in force, any person being the owner, lessee or occupier of such racecourse shall be punishable with fine which may amount to one thousand rupees.

Penalty for contravening conditions of license.

If any person to whom a license has been granted in accordance with the provisions of section 4 contravenes any of the conditions subject to which such license was granted, such person shall be punishable with fine which may amount to one thousand rupees.

Cognizance of offences under this Act.

8. No Court inferior to that of a Presidency Magistrate or of a Magistrate of the First Class shall try an offence under this Act.

Exemptions.

The Governor in Council may from time to time by general or particular order published in the Bombay Government Gazette exempt any horserace from the operation of this Act.

WHEREAS it is expedient to provide for the registration of medical practitioners in the Presidency of Bombay; AND WHEREAS the previous sanction of the Governor General required by section 5 of the Indian Councils Act, 1892, has been obtained for the passing of this Act; It is hereby enacted as follows:—

- 3. (i) The members of the Medical Council shall hold office for a term of five years, and shall be capable of re-appointment.

An Act for the abatement of nuisances arising from the smoke of furnaces in the Town and Island of Bombay and to provide for the extension thereof to other areas in the Bombay Presidency.

WHEREAS it is expedient to enact a law for the abatement of nuisances arising from the smoke of furnaces in the Town and Island of Bombay and to provide for the extension thereof to other areas in the Bombay Presidency; It is hereby enacted as follows:—

- 1. (1) This Act may be called the Bombay Short title Smoke-nuisances Act, 1912.

 and extent.
- (2) It extends in the first instance to the Town and Island of Bombay.
- 2. (1) Government may, by notification publish. Power ed in the Bombay Government Gazette and in such further other manner as Government may determine, Act. declare its intention to extend this Act to any specified area in the Bombay Presidency other than the Town and Island of Bombay:

Provided that, if a military cantonment is situated within any area to which it is proposed to extend this Act, no notification shall be published under this sub-section in respect of such area without the previous sanction of the Governor General in Council.

(2) Any inhabitant of an area to which it is proposed to extend this Act, may, if he objects to such extension, submit his objection in writing to Government within a period of three months from the publication of the said notification in the Bombay Government Gazette.

- (3) At any time after the expiration of the said period, and after considering the objections, if any, submitted under sub-section (2), Government may, by notification in the Bombay Government Gazette, extend this Act to the said area.
 - 3. In this Act-

Definitions.

- (1) "furnace" means any furnace or fireplace used—
 - (a) for working engines by steam, or
 - (b) for any other purpose whatsoever: Provided that no furnace or fireplace—
 - (i) used for the burning of the dead;
 - (ii) used in a private house for domestic purposes other than the purpose specified in clause (a);
 - (iii) used for the raising of steam on oceangoing steamers within such period prior to their leaving the port, or to their moving from one part to another thereof, as may be prescribed by rule made under clause (g) of sub-section (2) of section 11;

shall be deemed to be a furnace or fire-place within the meaning of this Act.

- (2) "Inspector" means a Chief Inspector of Smoke-nuisances, or an Assistant Inspector of Smoke-nuisances, appointed under this Act;
- (3) "the Commission" means the Bombay Smoke-nuisances Commission constituted under this Act;
- (4) "occupier" means any person for the time being paying, or liable to pay, to the owner the rent or any portion of the rent of the land or building in respect of which the word is used:
 - (5) "dwner"—
 - (a) when used in reference to a furnace, includes any agent or lessee using the furnace, and any foreman or other person superintending the working of the furnace;

- (b) when used in reference to any premises, has the meaning assigned to it in section 3 of the City of Bombay Municipal Act, 1888; and
- (6) "Magistrate" means a Presidency Magistrate, a Magistrate of the first class, or a Bench of Magistrates exercising first class powers under the Code of Criminal Procedure, 1898.
- (1) Government shall, by notification in the Constitu-Bombay Government Gazette, constitute a Commis-tion of Commission, to be called the Bombay Smoke-nuisances sion. Commission, to supervise and control the working of this Act.

- (2) The said Commission shall consist of a President nominated by Government and so many other members as Government may determine.
- (3) One-half of the members (exclusive of the President) shall be nominated by Government; and the remainder shall be elected, in such manner and for such period, as Government may direct, by bodies or associations whose interests are likely to be affected by this Act; and the appointment of all members, whether nominated or elected, shall be notified in the Bombay Government Gazette.
- (4) Where a casual vacancy occurs in the case of a nominated member Government shall make a fresh nomination, and where a casual vacancy occurs in the case of an elected member the election shall be made by the same body or association as that which elected the member whose place is to be filled; and a member so nominated or elected shall hold office so long as the member whose place he fills would have been entitled to hold office had the vacancy not occurred.
- (5) No act done by the Commission shall be questioned on the ground merely of the existence of any vacancy in, or any defect in the constitution of, the Commission.
- (1) Government may, by notification in the Appoint-Bombay Government Gazette, appoint a Chief In-ment of spector of Smoke-nuisances and so many Assistant Inspectors. Inspectors of Smoke-nuisances as they may think fit.

(2) Every Assistant Inspector appointed under sub-section (1) shall be subordinate to the Chief Inspector, and all Inspectors shall be subordinate to, and subject to the control of, the Commission.

Inspectors servants.

Every Inspector appointed under this Act to be public shall, for the purposes of this Act, be deemed to be a public servant within the meaning of the Indian Penal Code.

7. (1) Government may, by notification in the Power to prohibit the Bombay Government Gazette, prohibit within any erection of specified area-

kilns or furnaces, or the manufacture of coke, in specified areas: and to inflict penalties.

- (a) the erection of brick, tile or lime kilms,
- (b) the erection of furnaces to be used for the calcining or smelting of ores or minerals, or for the casting, puddling or rolling of iron or other; metals, or for the conversion of pig-iron into wrought-iron, or
- (c) the manufacture of coke in ovens or with special appliances, or
- (d) the making of coke without oversor special appliances;

Provided that where, prior to the issue of such notification, a license has been granted by the Municipal Commissioner under the provisions of section 394 of the City of Bombay Municipal Act, Bom, III 1888, for the erection of a furnace to be used for of 1888. any of the purposes mentioned in clauses (a) and (5), such notification shall not affect such furnace or

- (2) If any furnace or kiln be erected in contravention of any notification issued under sub-section (1), clause (a) or (b), the owner thereof shall be liable to fine which may extend to two hundred and fifty rupees.
- (3) If any person manufactures coke in contravention of any notification issued under sub-section (1), clause (c), he shall be liable to fine which may extend on first conviction to two hundred and fifty rupees, and on any subsequent conviction to five hundred rupees.

- (4) If any person makes coke in contravention of any notification issued under sub-section (1), clause (d), he shall be liable to fine which may extend on first conviction to twenty-five rupees, and on any subsequent conviction to fifty rupees.
- (5) If any coke is made in any building or place in contravention of a notification issued under subsection (1), clause (d), the owner or occupier of such building or place shall be liable to fine which may extend on first conviction to twenty-five rupees, and on any subsequent conviction to fifty rupees.
- (6) Where any coal is in process of being made or has been made into coke in contravention of a notification issued under sub-section (1), clause (d), an Inspector may seize such coal or coke, and report the seizure to a Magistrate, who may, after such enquiry as he thinks necessary, order such coke or coal to be confiscated, and to be sold in accordance with rules to be made by Government in this behalf under section 11.
- 8. (1) A Magistrate imposing a fine on any Power to person under sub-section (2) of section 7 may by order order direct such person to demolish the kiln or demolition of kilns or furnace within a period to be specified in the order. furnaces

- (2) Any such person failing to demolish any kiln unlawfully or furnace within the period prescribed in any such order, or within such longer period as the Magistrate may, for reasons to be stated, allow, shall be liable to fine which may extend to twenty rupees for every day thereafter during which such failure continues.

(1) If smoke be emitted from any furnace Penalty for in greater density, or at a lower altitude, or for a excessive longer time, than is permitted by rules made emission of under this Act, the owner of the furnace shall smoke. be liable to fine which may extend on first conviction to fifty rupees, on second conviction to one hundred rupees, and on any subsequent conviction to two hundred rupees.
- (2) Sub-section (1) shall not apply to any furnace which is used—

- (a) in connection with a brick, tile or lime kiln, or
- (b) for the purpose mentioned in clause (d) of sub-section (1) of section 7.

Powers of Inspectors.

- 10. (1) Any Inspector may, after giving reasonable notice in writing to the owner, manager, engineer or person in charge—
 - (a) enter and inspect; during working hours, any building or place which contains a furnace, and inspect such furnace;
 - (b) under the written authority of the Commission, use and test any appliance used for preventing the emission of smoke from such furnace; and
 - (c) under the written authority of the Commission, direct that any such furnace be worked or stoked experimentally, during his visit to such building or place, in any manner which he may consider suitable for preventing or reducing the emission of smoke, but not so as to interfere with the business carried on in such building or place further than is necessary for the purposes of the experiment.
 - (2) If any owner of a furnace in respect of which a direction is given under clause (c) of sub-section (1) fails to secure compliance with such direction, he shall be liable to fine which may extend to one hundred rupees:

Provided that where any Inspector has reason to believe that any offence under sub-sections (2), (3) or (4) of section 7 has been or is being committed on any premises it shall be lawful for him to enter on such premises without previous notice and without written authority from the Commission.

Rules.

11. (1) Government may, with the previous sanction of the Governor General in Council, and after previous publication, make rules to carry out the objects of this Act.

- (2) In particular, and without prejudice to the generality of sub-section (1), such rules may—
 - (a) regulate the transaction of business by the Commission;
 - (b) prescribe the powers and duties to be exercised and performed by the Commission and by Inspectors, respectively, and regulate the exercise and performance of those powers and duties;
 - (c) prescribe a scale for the purpose of determining the density of smoke;
 - (d) prescribe the degree of density of smoke that may be emitted from a furnace;
 - (e) prescribe the time during which smoke of such density may be emitted from a furnace;
 - (f) prescribe the altitude below which smoke may not be emitted from a furnace;
 - (g) prescribe the period during which, for the purpose of raising steam prior to leaving the port, or to moving from one part to another thereof, the furnaces of ocean-going steamers shall not be held to be furnaces within the meaning of this
 - (h) prescribe a procedure for the giving of warning to offenders before instituting a prosecution under this Act, and declare the minimum period which should be allowed to elapse in different classes of cases between the giving of such warning and the institution of a prosecution;
 - (i) fix the amount of fee payable to each or any member of the Commission attending a meeting of the Commission; and
 - (i) prescribe a procedure for the sale and disposal of the receipts of the sale of coke or coal confiscated under sub-section (6) of section 7.
 - (3) The date to be specified in accordance with clause (c) of section 24 of the Bombay General Clauses Act, 1904, as that after which a draft of rules proposed to be made under this section will be

taken into consideration, shall not be less than three months from the date on which the draft of the proposed rules was published for general information.

(4) Any rule to be made under this Act shall, before it is published for criticism under subsection (1) be referred to the Commission constituted under section 4, and the rule shall not be so published until the said Commission has reported as to the expediency of making the proposed rule and as to the suitability of its provisions.

- 12. A Magistrate may take cognizance of an of offences offence against this Act only-
 - (a) upon a complaint made by, or with the written authority of, the Chief Inspector, and
 - (b) within a period of two months from the date of the commission of the offence.

Disposal of fines.

13. All fines recovered under this Act shall be disposed of in such manner as Government may direct.

WHEREAS it is expedient further to amend the Bombay Port Trust Act, 1879 (Bom. VI of 1879); It is hereby enacted as follows:—

- (iii) No expenditure shall be charged by the Board to capital, except with the express sanction of Government."

Establishment of sinking fund.

"41A. Payments shall be made half-yearly to such sinking fund, and such payments shall be of such amount as shall with interest suffice to liquidate the loan within such period not exceeding sixty years from the date of the contracting of the same as the Governor General in Council may in each case direct.

Application of sinking fund.

(2) The Board may apply the whole or any part of the sums accumulated in the sinking fund in or towards the discharge of the moneys for the repayment of which the fund has been established, provided that they pay into the fund in each year, and accumulate until the whole of the moneys borrowed are discharged, a sum equivalent to the interest which would have been produced by the sinking fund, or the part of the sinking fund so applied.

The sums so set apart as a sinking fund shall be invested in public securities as defined in section 3 (12) or in such other securities as Government may approve in this behalf and shall be held in trust for the purposes of this Act by the Board.

41B. The sinking fund established for the Annual liquidation of any loan shall be subject to annual examination of sinking examination by the Accountant General, Bombay, fund. who shall ascertain whether the cash and the value of the securities at the credit of the fund are actually equal to the amount which would have been accumulated, had investments been regularly made, and had the rate of interest as originally estimated been obtained thereon. The Board shall pay forthwith into the sinking fund any amount which the Accountant General may certify to be deficient, unless the Governor General in Council specially sanctions a gradual re-adjustment."

(2) The Board shall upon the application of the holder of a stock certificate convert the same into debentures or securities of the loan to which it relates.

 - (a) the amounts for which stock certificates may be issued;
 - (b) the fees to be levied in respect of the issue of stock certificates;
 - (c) the mode in which payment of interest in respect of all debentures, stock certificates and other securities issued under the provisions of this Act is to be made, recorded and acknowledged;
 - (d) the circumstances in which such debentures and other securities must be renewed before further payment of interest thereon can be claimed;
 - (e) the fees to be levied in respect of the issue of renewed debentures or other securities;
 - (f) the form of transfer to be used, the formalities to be observed and the fees to be levied on a transfer of stock;
 - (g) the form in which debentures or other securities delivered for renewal are to be receipted;
 - (h) the proof to be produced by persons applying for duplicate debentures or other securities;

- (i) the circumstances and manner in which duplicate debentures or other securities may be issued in case of debentures and other securities alleged to have been wholly or partly lost or destroyed and the period after which interest may be paid, or a duplicate be issued, in the case of such debentures or other securities alleged to have been wholly or partly lost or destroyed, and the fees to be levied in respect of the issue of duplicate debentures or other securities;
- (k) the circumstances and manner in which duplicate stock certificates may be issued and the fees to be levied on any such issue;
- (I) the nature and amount of indemnity to be given by a person applying for the payment of interest on debentures or other securities alleged to have been wholly or partly lost or destroyed, or the issue of duplicate debentures or other securities;
- (m) generally the measures to be adopted for carrying out the purposes of this Part.
- (2) The Board may also from time to time, vary, alter or revoke any such rules so made by them.

No rule, or alteration or revocation of a rule, shall have effect until the same shall have been approved by Government, and such approval shall have been published in the Bombay Government Gazette; and no rule, or alteration or revocation of a rule, shall be approved by Government until the same shall have been published for three weeks successively in the said Gazette.

It shall be lawful for Government at any time by notification in the said Gazette to cancel any rule published under the provisions of this section.

Any person acquiring, by succession, of rights to survivorship, inheritance, partition, purchase, be reported mortgage, gift, lease or otherwise, any right as holder, occupant, owner, mortgagee, landlord or tenant of the land, or assignee of the rent or revenue thereof, shall report orally or in writing

his acquisition of such right to the village accountant within three months from the date of such acquisition, and the said village accountant shall at once give a written acknowledgment of the receipt of such report to the person making it:

Entries in the Recordof-rights to

"82. An entry in any Record-of-rights prepared or revised under this Part shall be relevant as evidence in any dispute as to the matters recorded, as evidence, and shall be presumed to be true until the contrary is proved or a new entry is lawfully substituted therefor:

> provided that no such entry shall be so construed as to limit any of the powers conferred on the Governor in Council by this Part.

Notice of suit to be given to the Collector.

"83. (1) In any suit or proceeding in which an entry made in any Record-of-rights prepared or revised under this Part is directly or indirectly called in question, the Court shall, before the final settlement of issues, give notice of the suit or proceeding to the Collector, and, if moved to do so by the Collector, shall make the Secretary of State for India in Council a party to the same.

Suits against Government.

(2) Save as provided in sub-section (1) no suit shall lie against Government in respect of anything done by the Collector, canal-officer or any other person acting under the orders of Government in the exercise of any power by this Part conferred on such Collector, canal-officer or other person or on Government.

Period of limitation.

(3) Any suit or proceeding in which an entry made in any Record-of-rights prepared or revised under this Part is directly or indirectly called in question shall be dismissed (although limitation has not been set up as a defence) if it has not been instituted within one year from the date of the publication under section 81 of the Record-of-rights containing the said entry, or, if one or more appeals bave been made against any order of a canal-officer with reference to any entry in such Record-of-rights, then from the date of any order passed by the final appellate authority, as determined according to this Part.

Obligation pairs.

- (3) When the appointment of a Municipal Subsequent Commissioner has been once made for a municipal subsequent pal district which contained at 'that time a population of not less than one hundred thousand inhabitants as ascertained in sub-section (2), such appointment shall not cease by reason only of the fact that the population of such municipal district has fallen short of one hundred thousand inhabitants.

- 186B. (1) A Municipal Commissioner shall Term of hold office for a period of three years, in the first office. instance, and thereafter for such further period as the Governor in Council may in each case determine.
- (2) A Municipal Commissioner may be removed Removal from office at any time by the Governor in from office Council if it shall appear to the Governor in Council that he is incapable of performing the duties of his office or has been guilty of any misconduct or neglect which renders his removal expedient.

(3) A Municipal Commissioner shall be forthwith removed from office by the Governor in Council on the application of the municipality in this behalf, provided that such application has been previously supported by not less than three-fourths of the whole number of councillors.

Salary of Municipal Commissioner.

186C. (1) A Municipal Commissioner shall receive from the municipal fund such monthly salary as the municipality shall, subject to the approval of the Governor in Council, from time to time determine.

Prohibition of engagement in other business.

(2) A Municipal Commissioner shall devote his whole time and attention to the duties of his office as prescribed in this Act or in any other enactment for the time being in force, and shall not engage in any other profession, trade or business whatsoever:

Provided that he may at any time, with the sanction of the municipality, serve on any committee constituted for the purpose of any local inquiry or for the furtherance of any object of local importance or interest.

Leave of absence.

186D. (1) The Governor in Council may, from time to time, with the assent of the municipality, grant leave of absence for such period as he thinks fit to a Municipal Commissioner.

Leave allowance.

(2) The allowance to be paid to a Municipal Commissioner, while absent on leave, shall be of such amount, not exceeding his salary, as shall be fixed by the Governor in Council:

Provided that, if the Municipal Commissioner is a salaried servant of Government, the amount of such allowance shall be regulated by the rules for the time being in force relating to the leave allowances of salaried servants of Government of his class.

Appointment of substitute.

(3) During any absence on leave, or other temporary vacancy in the office, of a Municipal Commissioner the Governor in Council may appoint a fit person to act as Municipal Commissioner. Every person so appointed shall exercise the powers and perform the duties conferred and

imposed by or under this Act or by any other enactment for the time being in force on the person for whom he is appointed to act, and shall be subject to the same liabilities, restrictions and conditions to which the said person is liable.

- 186E. (1) When a salaried servant of Govern-Contribument is appointed to be a Municipal Commistions from sioner, the municipality shall, unless specifically manici-exempted wholly or in part from liability by wards the Governor General in Council, contribute to pension and his pension and leave allowances to the extent leave allowrequired by proviso (b) to section 46.

Delegation of powers of Municipal Commissioner. 186M. (1) With the sanction of the municipality, the Municipal Commissioner may, by general or special order in writing, delegate to any municipal officer or servant any of the Municipal Commissioner's powers, duties or functions under this Act or under any rule or by-law made hereunder except such as are conferred or imposed upon or vested in him under the following sections, namely:—

(2) The exercise or discharge by any municipal officer or servant of any powers, duties or functions delegated to him under sub-section (1) shall be subject to such conditions and limitations, if any, as may be prescribed in the said order, and also to control and revision by the Municipal Commissioner.

- (f) the feregoing provisions of this section shall apply to every variation or discharge of a contract as to an original contract.

186-O. (1) Notwithstanding anything contained Mode of in sub-sections (6) and (7) of section 10, every executing contract entered into by a Municipal Commissioner on behalf of a municipality shall be entered into in such manner and form as would bind such Municipal Commissioner if such contract were on his own behalf, and may in the like manner and form be varied or discharged:

Provided that-

- (a) Where any such contract, if entered into by a Municipal Commissioner, would require to be under seal, the same shall be sealed with the common seal of the municipality, and
- (b) Every contract for the execution of any work or the supply of any materials or goods which will involve an expenditure exceeding five hundred rupees shall be in writing and shall be sealed with the common seal of the municipality and shall specify the work to be done or the materials or goods to be supplied,

- as the case may be, the price to be paid for such work, materials or goods and, in the case of a contract for work, the time or times within which the same or specified portions thereof shall be completed.
- (2) The common seal of the municipality shall not be affixed to any contract, or other instrument, except in the presence of two members of the Managing Committee, who shall attach their signatures to the contract or instrument in token that the same was sealed in their presence. The signatures of the said members shall be distinct from the signatures of any witnesses to the execution of any such contract or instrument.
- (3) No contract not executed in the manner provided in this section shall be binding on the municipality.

Tenders to be invited for contracts involving expenditure exceeding Rs. 1,000.

- 186P. (1) Except as is otherwise provided in sub-section (3), a Municipal Commissioner shall, at least seven days before entering into any contract for the execution of any work or the supply of any materials or goods which will involve an expenditure exceeding one thousand rupees, give notice by advertisement in the local newspapers, inviting tenders for such contract.
- (2) A Municipal Commissioner shall not be bound to accept any tender which may be made in pursuance of such notice, but may accept, subject to the provisions of clause (d) of section 186N, any of the tenders so made which appears to him, upon a view of all the circumstances, to be the most advantageous or may reject all the tenders submitted to him.
- (3) The municipality may authorise the Municipal Commissioner, for reasons which shall be recorded in their proceedings, to enter into a contract without inviting tenders as herein provided or without accepting any tender which he may receive after having invited them.
