Act No. I.—An Act to amend Section VI of Act XXV of 1858

Act No. II.—An Act to provide for the Periodical Survey of Steam Vessels in the Ports, Harbours, Rivers or Waters of the Presidency of Bombay

Act No. III.—An Act to repeal Clause 4 of Section II of Regulation V of 1830, and Section I. of Regulation VIII of 1831.

Act No. IV.—An Act to repeal certain Regulations and Acts relating to the offices of Hindoo and Mahomedan Law Officers, and to the office of Cazeer, in the Bombay Presidency.

Act No. V.—An Act to give Mamlutdars' Courts jurisdiction, in certain cases, to maintain existing possession, or to restore possession to any party dispossessed otherwise than by course of law

Act No. VI.—An Act for the better regulation of the Diet-money of persons imprisoned by the Bombay Court of Small Causes
