A casual examination of the personnel of the British Guiana Franchise Commission will reveal the important fact that the Minority Groups of the country had the majority of members on the Commission the majority of whom although con-tinuously absent at sittings of the Commission have signed the Majority Report. They seized the opportunity of protenting themselves at the expense and detriment of the bulk of the masses, and the majority groups of the colony. It is therefore considered that the recommendations of the Majority Report of the B. G. Franchise Commission is biased and prejudiced in regard to the granting of Universal Adult Suffrage forthwith to the masses. The groups to be affected would be principally Africans and Indians.

8 In view of the above observations. it is strongly urged that this Majority Report be set aside, as it does not reflect the true wishes of the mass of people of the Colony.

9 Under the circumstances, having faith and confidence in His Majesty's Secretary of State for the Colonies, we trust that he will grant to the people of this Colony as he has granted to the people of Jamaios, Universal Adult Suffrage forthwith.

RESOLUTION NO. 2

With regard to the Agricultural Sub-Station at Whim, the Director of Agriculture reports that its services are being extended, but it would be impracticable to establish a livestock farm there. The Agriculture Department is also extending its services at No, 63 Corentyne and in course of time other sub-stations will be established so that all agricultural centres can be satisfactorily served. It is hoped to send an Agricultural Instructor to Whim in the near future."

RESOLUTION NO. 3.

The request that a District Administration Office should be established in the mid-Corentyne area is receiving the sympathetic consideration of Government,

I have been taking a keen interest in the representations the Hon. J. A. Luckhoo, K. C., 'Nominated Member of the Legislative Council, has been making on behalf of the Indian Community, J wish to say that I am not impressed with them.

No one known what he has been doing in the Executive Council and on Advisory Committees, except his colleagues. Talking to some of his colleagues, I am not impressed with their replies as to what Mr Luckhoo is doing for the Indian Community.

We are told he represents Indians in the Executive Council. We are also told that the Hon, H,N, Critchlow represents Labour in the Executive Council. The representations of both these members as expressed by them in the Legislative Council on the franchise question is entirely against the labouring classes and the masses. They are against Universal Adult Suffrage, Mr Critchlow has changed his life long views and Mr Luckhoo does not think that the mass of the people are fit to exercise the vote. One wonders if the Luckhoos are from the mass of the people, and further one worders if their forefathers came from India as indentured labourers.

Mr Editor it is to be hoped that you will let the speople of the Colony understand what Mr J. A. Luckhoo is doing for their welfare in your widely read paper. The time has come when the mass of the people must be told the truth about their representatives and the Government must be made to understand that the public will not be fooled any longer.

Liberty, Equality and Fraternity

The recent debate on the Franchise question concerning Universal Adult Suffrage in the Legislative Council has shown how utterly backward are the majority of the present legislators of British Guiana, in the matter of grasping the trend of the world towards a better humanity.

The denial by the majority of members to concede Universal Adult Suffrage forthwith to the people is tantamount to a denial of liberty and equality among men.

British Juliana belongs to the inbabitants of the colony and its constitution must be framed to meet the
requirements of its people. The preseent composition of the Legislative is
not the people's choice and therefore

cannot speak for the people of British Guians.

Continued from page . T 592% are Indians. We therefore presume that about 40% of the balance of illiterates are Africans. It is there-fore urged that there should be no literacy test whatsoever as this would not only exclude a substantial section of the population but would also demoralise their aspirations and in terest in the welfare and advancement of the Colony. On the other hand it cannot be disputed that there is very little difference in the intelligence and mentality of individuals who can merely read or write. A SIMPLE SENTENCE IN ENGLISH AND SIGN THEIR NAMES "as compared with individuals who are illiterate, especially when one takes into consider pecially when one takes into consideration that these people live together; move together and think together, and are engaged in the same type of occupation, dwelling in the same environment, -

3. East Indian and African women would be denied the right to vote according to the qualifications recommended in the said Report both from the monetary and literary standpoint as it is a known fact that they do not earn \$10.00 per month if employed, while a great number taking care of the home earn nothing even though literate.

4. There is a definite fear impliedly a expressed in the majority Report according to paragraph 40 that Indians will predominate at elections and that Indians will swamp the polling booth resulting in a preponderance of Indians in the Legislative Council.

There is surely no ground for such fear or anxiety according to the present distribution of the Indian population, but in case of likely preponderance in any constituency the majority of the voters will certainly use their better judgment, in voting for the right candidates, be he Indian, African European Portuguese or others. This observation is supported by the fact that there was not a single Indian Member of the Legislative Coancil until the year 1918, and that the four Indian Elected Members of the Legis-Continued on page 4.
