Notes and News

The Late Rev. A. Lamont

The death of the Rev. Archibald Lamont which took place at the Durban Sanatorium last Monday afternoon at the age of 69 after an illness of two months removes from the life of Durban a very prominent figure. His death is mourned alike by Europeans and Indians. Before entering the political field Mr. Lamont was known and respected by Indians as an educationist. Long before the Sastri College came into existence there was the Marine College which was established by Mr. Lamont for higher education for Indians and many of the qualified Indians in Durban and who are at present studying in England have been matriculated under him. Mr. Lamont was Mayor of Durban from 1929 to 1931 and it could be safely said, in so far as the Indian community is concerned, that it has found no mayor more sympathetic than Mr. Lamont. During his office there was not a public function which he did not grace with his presence. All those who have had the pleasere of coming in touch with him have known, him both in his private and official capacity to be most sympathetic and obliging. Shortly before his death Mr. Lamont was returned to the Provincial Council as a Home Rule Party candidate for Greyville and the Indians anticipated a good friend in him. The Late Mr. Lamont leaves a widow and three sons, one of whom recently entered Glasgow University to study medicine. Our profound sympaty goes out to to them in their great loss.

Some Telling Figures

THE Agent of the Government of India headed a body of 16 members of, the South African Indian Congress who gave evidence before the Provincial Commission in Pretoria on Friday, Nov. 17. The Agent quoted fairly extensively from the South African Year Book for 1931-32 in regard to statistics of licences, serious crime, etc., which showed that for 1932, European insolvencies totalled \$,330 and Asiatic 229. In 1931 the figures were respectively 2,309 and 247. With an Asiatic population of hetween 10 and 11 per cent of the European population these figures the Agent said were if anything slightly in favour of the Asiatic. The figures for serious crime in 1931 were 2,303 Europeans and 225 Asiatics. Our figures are smaller than our popu-

lation would warrant," said the Agent, "for proportionately more Indians are illiterate than Europeans, and it is well-known that there is more crime among the illiterate than among the literate. There again the balance is on our side!"

S.A.P. Advocates Removal Of Provincial Barriers

A resolution urging the Government to introduce legislation to remove provincial restraint on the movement of Indians within the Union, sponsored by the Umbilo Branch, was passed at the South African Party Congress held recently at Maritzburg. Mr. J. T. Jackson, urging that Provincial barriers to Indians be removed, maintained that at the time of Union all the Provinces pooled their resources and agreed to share alike. It was no part of the con! tract that any one Province should continue to bear an excessive burden. According to the 1931 census, nine of the principal towns of the Union had a total of some 72,000 Asiatics among them. Of this number no fewer than 52,000 were in Durban, while Maritzburg's share was 7,000. Durban and Maritzburg between them had some 82 per cent. of the Asiatics in the nine towns. The people of Natal telt that they had not had a square deal.

Remove Illegal Entrants

THE Point Branch of the S.A.P. demanded that the Government take steps to remove from the Union any persons who might have entered illegally and whose presence had not been legally condoned.

A Vernacular School In Springs (1) 2 (10.26 To

A meeting of Indians in Springs (Transvas!) was held recently in the local Hindu Temple Hall under the chairmanship of Mr. B. Gangadeen. The necessity of opening a vernacular school for Indian children was stressed by the various speakers and a collection was made forthwith for the purpose, as a result of which, about £120 were promised on spot. A committee was formed which we understand is to go out to collect more funds for the establishment of a school in the district.

We congratulate our brethren in Springs for their gesture of self-help and we have no doubt every parent with any sense of responsibility for his children will not hesitate to help generously the cause of education. A similar move was recently made by Indians in Nigel (Heidelburg) recently but we are surprised that nothing further has been heard about it.

'White South Africa-Meaningless Phrase'

Mr. E. I. Patel, a leading Indian merchant of Johannesburg gave a banquet in honour of the Agent and the Kunwarani at the Langham Hotel on. Tuesday night Nov. 21. Mr. C. D. Don, editor of The Star in proposing the toast of "The Union of South Africa" at the above function made a noteworthy speech. Speaking of the present and the immediate future, Mr. Don pointed out that in a time of world economic stress South Africa could consider itself one of the luckiest countries on earth. "On the other hand," he said, "we have problems before us more intricate, more formidable, and of more farreaching significance than those of any other Dominion. They will test to the full our courage, the

quality of our statesmanship, our capacity for sacrifice, and the sincerity of the principles we profess. We talk of a white South Africa—surely a meaning-less phrase unless we mean by it that the highest ideals of European civilisation are what we, the dominant minority, should keep steadily before us. We have the power, and that power carries with it very great responsibilities and obligations. If we discharge them in a liberal spirit of justice and fair play to all, as well as of firmness and consistency, we need not fear the result."

Nour previous article we forgot to mention yell another Act that was passed in the presence of Mr. Sastri in this country as the first Agent. That was the Transvail Liquid Act. It has fidthing to do with drinking liquof but it prevents Indian's beilly simpleyed on licensed premises. It was designed indirectly to throw out of employment some hundreds of Indians working in hotels as waiters. Mr. Sastri had to leave the country before he could bring any relief but during Sir Kurnis Reddil's office as Mr. Sastri's successor he was able to get an exemption distribe introduced and Indian hotel employees in the Transvaal are at the mercy of the Minister in whose power it lies to grant them exemptions.

Together with it has been introduced the Government's White labour policy whereby hundreds of Indians in Municipalities, Railways, Mines and Sugar Estates are constantly being replaced by white labour.

All this happened during the time of Sir Kurnaa Reddi as the second Agent of the Government of India in this country:

Sir Kurma Reddi was however very fortunate to leave these shores without having had to actually blacken his hands: For he was able to get the Governor-General-in-Council's assent to the Transvaul Licenses (Control) Ordinance withheld and to postpone the passing of the Transvaul Asiatic Land Tenure Bill pending the revision of the Capetown Agreement.

His greatest schievement was the exemption clause in the Transvaal Liquor Act which saved hubbleds of thillians from being immediately thrown out of employment and the creation of the Sir Kurma Reddi Unemployment Relief Committee which he initiated with a donation of £25 from himself and which has brought relief to hundreds of suffering stills.

Be it said to the credit of Mr. Sastri whom we look upon with great reverence and do not wish in any way to belittle the work he has done at very great saorifice; that he has been responsible for many acts of self-help on the part of the Indian community which alone will enable them to live in this country as a self-respecting community. They are the Sastri College, the Social Service Committee and the Child Welfare Committee. He can well be proud of these institutions which are rendering useful service to the continuants.

So far there was little of surrendering of principles excepting in the acceptance of the assisted emigration scheme and much work was done

through self-help for the uplift of the community which was in keeping with its sense of honour and self-respect

Since the last Round Table Conference, however, and with the advent of Kunwar Sir Maharaj Singh as the third Agent, some evil spirit seems to have entered into us which is constantly dragging us downwards.

No sooner did the Round Table Conference end then the Transvast Asiatic Land Tenure Bill was passed and the Transvasi Licences (Control) Ordinance received the assent of the Governor-General-in-Council.

The Congress met in Conference in Johannesburg in August 1932 and condemned the action of the Government in passing the two obnoxious laws and heartily supported the resolution of the Transval Indian Congress to resist them: Now if the Congress claimed the right to speak in the name of the South African Indians it spoke in no uncertain terms on the Transval laws. The Agent who recognised the South African Indian Congress as the representative body of Indians should have taken note of its voice. But he did not. The Congress has hoodwinked the action of the Agent and has ignored its own resolution. Then came the colonization scheme.

The Congress was totally against sending South African Indians out of this country: It confessed its blunder in having been a party to the assisted emigration scheme after having viewed the working of it for five years and solemnly declared that it would not countenance the scheme any longer nor accept any substitue thereof.

The above signedificate which was reluctantly entered into did not these in any way that the principle of reducing the Indian population in the Union was agreed to. It only meant that India was going out on a mission to look for dutlets for her own increasing population assisted by the Government of South Africa and the Congress would co-operate with her in her mission and indirectly ascertain if there existed any good opportunities for South African Indians in such countries supported by India.

To agree to an assisted emigration or assisted colonization of assisted colonization of a reputification scheme and to migrate independently to a country which India has found for the settlement of her own increasing population are quite different things:

Now the present Inquiry Committee, not withstanding the fact that it is a prillimitary inquiry, has changed the position entirely. The work set out for it is, to explore the possibilities of a colonization scheme for settling South African Indians in other countries and to find out the extent to which Indians in the Union would participate therein.

The Congress leaders who spoke irresponsibly of there being no room for men of conscience and self-respect in this country and that their place was either in India or in gaol, the inference being that those that they claim to represent are men of no conscience of self-respect, are yet evidently possessed with a super-consciousness of their. "word of honour," their "solemn pledge." We thust confess that our small minds are too small to understand that philosophy. Our sense of honour tells us that "that is not what you desire, therefore in co-operating in such a thing you will be deceiving yourselves and those whom you offer your co-operation."

The Congress has, however, thought fit to flout public opinion and is going the wrong way, and thus in the vain hope of material gains is out to sell its own soul. The Congress has fallen to such depths that even now, when the present Colonization Committee has actually gone far beyond its scope of inquiry bound by its terms of reference, and is inquiring into the economic position of Indians, it is still slumbering.

It has fallen in with the view of the Agent so often given expression to that we have neither principles" nor "birthright" in this country and therefore it is no use talking about them. That the same thing applies to India and that if India had not consistently fought for her birthright as she has done for nearly fifty years she would never have reached the present stage, is completely forgotten. The Congress has become so weak and helpless that whereas in the past, it could face the Government independently and make its own representations, every deputation from the Congress now must be led by the Agent, a thing which did not happen even in the time of Mr. Sastri' or Sir Kurma Reddi. They introduced Congress deputations but did not lesd them. In its superconsciousness it is perhaps not able to see any loss of prestige or self-respect in it. While our brothers and sisters in the Motherland are growing out of serfdom the Congress is apparently growing into it. These are some of the causes which have led to the present unfortunate cleavage in the community.

The leaders in the past, although they have not been able to actively offer resistance, have never been a party to any surrendering of principles. Now they are heartily co-operating in surrendering them for any crumbs that may be offered them. If the leaders have fallen there is surely no hope for the community to rise.

We have personally nothing against the Agent. We admit that the position of the Agent is a very difficult one especially when he is an official. The past two Agents were non-officials. They were better able to understand the mind of the people, we felt some personal touch about them and even in their official capacity they would instinctively hesitate to do certain things which an official would instinctively not hesitate to do. The characteristic of an Indian official, be he an Indian or a European, is to play upon the weaknesses of the people and this is what happens to be the case at present. It pains us to offer these remarks and we would un-

reservedly withdraw them if we were convinced that they were groundless.

A self-respecting community will not play into the hands of the Agent, or, for that matter, any official. It will have its own mind and will feare lessly express it. That is no longer the case with the Congress.

We are passing through difficult times. With the Government's segregation 'policy' in the Transvest, which exists to a certain extent, it not in law in practice, also in Natal, with the pursuance of its white labour policy aggravated by the general depression makes the position of Indians in this country almost unbearable. But what is the remedy? Indeed not to sell one's soul. Mahatma Gandhi has said in one of his messages to South African Indians through Young India that "we are ultimately to win by our own endeavour which does not mean sharp practice. but self-purification, which again means reform from within and purging ourselves of evil oustomic and superstitions, educating our children, and contributing money for education as well as other measures of social reform." In other words it means that what we defined get from the Government without loss of self-respect we must try to schieve through self-help. If our poorer South African brethren are suffering the remedy does not lie in finding them another place to go to. Rather should the well-tt-do go out and make room for them or open up their purse strings and give them education which is denied them by the Government and explore the possibilities of a scheme whereby avenues could be opened up to give them work to earn their daily bread and live in peace and happiness in the land of their birth. Our salvation in this country lies entirely in self-help. Our co-operation in a policy of reducing our population will ultimately result in bringing about our total extinction.

South Africa And Non-White Races

The following letter appearing in the Rand Daily Mail above the nom de plume "Bless" is reproduced here because it requires to be while digested by all those who are suffering from the superiority complex.

Sir,—I am sure that the object of Mr. Hedley A. Chilvers's warning in his book, "The Yellow Man. Looks On," is not entirely that of soulless and selfish protection of the white races of South Africa.

I cannot for a moment imagine that Mr. Chilvers ever intended, in his book, to rouse petty national feelings of a very parochial character, which would

inevitably result in race-hatred or war.

South Africa must rise to the heights of doing what is right and just by her non-white people in order to ward off the great clash between the East and West. In the councils of the world-whether rightly or not, and whether South Africa merits it. or not—there is a strong feeling in all walks of life that South Africa does not play the game by her non-white subjects. That being so, the feelings of prejudice in the minds of the yellow man, the brown man and the black are so strong that one day South Africa will clash with the East.

The yellow man is not the only one who is looking on. There is the brown man (the Indian), being close to the yellow man who, with eager eyes, is watching the trand of events in this land. How can he avoid it—for his kith and kin are here and he

sees their sufferings?

Far back comes the black man, emerging from a state of barbarism into a state of civilisation. The black man, with eyes and ears open, is taking everything in; and he is thirsting for education, for he realises how essential it is for him to have knowledge, which means power. It is a weapon that he will be able to use one day to emancipate himself

In South Africa the white man only grudgingly allows the Bantu to progress, but in spite of this the Bantu is making rapid strides, and he will catch up to the white man. The Bantu in the territories north of South Africa is being given every opportunity, by a benevolent-white people, to develop his faculties, and the Bantu in the south knows it. So the position in Africa will be that the black man will not only look on, but he will be fully conscious of growth into real manhood, and will want to assert it one day by taking the stretched out hand of the East across the waters.

The Indian having wrested freedom from his rulers, Japan free already, China, stung by the treatment meted out to her by Japan and unable to prevent it because of having no discipline and no national unity—these three nations will ultimately be driven to the point at which, in order to maintain their position, they will unite and make common cause against Communism on the one hand, and on the other hand, against the flaunted boast of white

South Africa will be a strategic point for the brown and yellow man to secure for the realising of their ambitions, 4. يسم بالماء الما tit.

This picture may be only a dream, but it may .

become real.

If we were to follow the suggestions of Mr. Pellet and organise against the yellow man, then we should invite real trouble. No one can prevent any nation from selling its goods so long as there are plenty of buyers. South Africa may not see her folly now in her treatment of non-white people, but she is sowing seeds which her children will resp with bitter tears.

I think our attitude should be to take to heart the words of that great Indian poet, Rabindranath Tagore: "The East and West are alternate beats of the heart, and we need the help of the West as the West needs the help of the East."

Colonial-Born And Settlers Indian Association Clairwood Branch Report Of Work Done

Election Of Officials

A general meeting of the above Branch was held on the Clairwood Boy's School grounds on Sunday, Nov. 27, at 3-30 p.m. Over 200 people attended. Officials of the parent body wer-also present.

The joint Hon. Secretaries on behalf of the provisional committee submitted their report which stated that during the month of August 1922, a public meeting was convened when the officials of the parent body addressed the meeting on the advisability of forming a Branch. Unanimous resolutions were also passed at this meeting condemning the action of the Natal Indian Congress in connection with the Colonization Enquiry. It was then agreed that subsequent meeting be convened for the formation of branch and election of provisional officials.

During the month of September 1933 a general meeting was convened, when the branch was formed and Offlicers provisionally elected. Over 2,000 Indians were preents at this meeting and a unanimous vote of no confidence in the Congress was passed.

The Committee got busy in enrolling members and giving wide publicity to the establishment of the Branch and its aims and objects, and over 200 members have been enrolled. Several Committee meetings were held and important matters were discussed.

On October 8, a public meeting was convened by the Branch for the purpose of discussing the increased valuation by the Durban Corporation in the added areas. Over 300 Indians attended this meeting when various matters in connection with the increased valuations were discussed and the Associatiod undertook to help all those who intended to object and to appeal.

The Committee's thanks were expressed to Mr. B. Ramchander for kindly allowing the use of a portion of his premises and to Messrs. R. P. Das, G. M. Pillay and N. P. Naidoo for their kind assistance. Over 150 Indians have been attended to and their objections lodged.

Organising meetings were held in surrounding district and were addressed by Messrs. P. M. Pillay, L. Ganesh, L. Nanco, A. Singh, N. M. Pillay, P. R. Pather and J. M. Perumal, and Mr. H. S. Done was thanked for allowing the use of his School room.

After the adoption of the above report Mr N. P. Naidoo explained the meeting about the objections lodged with the Durban Corporation regarding valuation with the able assistance of Mesers. A. Christopher and P. R. Pather and the success they had acheaived.

Mr. R. P. Das moved a resolution highly appreciating the services rendered bp the Provisional Committee which was unanimquely carried.

The following office bearers were then elected:—Chairman: Mr. P. M. Pillay, Vice Chairman: Mr. L. Nanco, Joint Hon. Secretaries: Messrs. N. M. Pillay and P. R. Pather, Hon. Treasurer: Mr. L. Ganesh, and other Committee members were also elected.

Mr. A. Christopher spoke at length on the surject of worker's contination classes which he hoped would commence in the District in the very near future. He asked those present to take full advantage of those classes.

Among the other speakers were Messrs. M. M. Gandhi, S. P. Nicholas, A. Singh, and C. N. M. Khan.

Cancellation Of Swami Bhawani Dayal's Passport

Questions And Answers In Indian Assembly

Mr. Gaya Prasad Singh, M.L.A., asked the following questions in the Indian Legislative Assembly at Simla:—

(a) With reference to the reply of Government to my question regarding the cancellation of passport of Swami Bhawani Dayal Sannyasi to visit Fiji, that Swami Bhawani Dayal is a South African national and, therefore, the Government does not propose to make any enquiries; are Government aware that this gentleman possessed landed property in India and is a registered voter in the province of Bihar and Orissa? When and how has he lost his nationality or domicile in India, and what is the evidence in possession of the Government to show that he is a South African National?

(b) Have not the Government of India from time to time made representations on matters concerning South African Indians, who may be nationals in that country; and if so why have they refused to take action in the case of the cancellation of the passport of Swami Bhawani Dayal?

(c) Is it not one of the primary duties of the Indian Agent in South Africa to protect the rights of the South African Indians, whether they may be permanent residents in the colony or otherwise?

(d) Are Government aware that some time back Dr. Malan, the Minister of the Interior, described the Indians in South Africa as 'aliens' in the Union Parliament? If so, will the Government kindly define their attitude with regard to the Indians who may be in South Africa as nationals or as temporary residents?

Mr. Bajpai replied on behalf of the Government:

(a) Swami Bhawani Dayal Sannyasi is recorded as proprietor of certain villages in Bihar and Orissa, jointly with his brother, but is not a registered voter

in that Province.

(b) Swami Bhawani Dayal was born in South Africa, retains his domicile there and travels to India on a South African passport. Government are, therefore, justified in treating him as a South African national which appears to be supported by the definition of Nationals given in sub-section (a) of Section 1 of the Union Nationality Act No. 40 of 1927. According to the information given by the hon, member in his previous question the communication from the Fiji Government was addressed to the Union Government. It also relates to a passport granted by the Government of South Africa. The matter was, therefore, primarily one for the Governments of Fiji and South Africa.

(c) Yes. So far as the Government are aware, the Agent was never approached by the Swami.

(d) The answer to the first part of the question is in the affirmative. As regards the second part, the position of the Government of India in regard to the rights and privileges of the Indian community in South Africa has been repeatedly explained. They wish to see a progressive improvement of the status of the community and will always continue to work for this

[NOTE—Swami Bhawani Dayal, we learn, was a registered voter in the Province of Bihar and Orissa under the name of Bhawani Dayal Singh. Of course Mr. Bajpai could not be expected to know that that name has undergone several changes since but representing the same person. From Mr. Bhawani Dayal Singh it was changed to Pundi/Bhawani Dayal, at one time Sharma too, we understand, was affixed and then it was changed to Pundit Bhawani Dayal Sannyasi and at the present time it is Swami Bhawani Dayal Sannyasi. Like the Heavenly Father the name may change but He is The One.]

Resolutions Affecting Indians Outside India

The second session of the Indians Overseas Conference of Ajitmal (Etawah) was held in the Hindu Maha Sabha Pandal at Ajmer, under the president-ship of Mr. Chard Karan Sharda, B.A., L.L.B., Advocate, on October 18. Among the prominent persunages present were Bhai Parmanand, M.A., M.L.A., Mr. Jagat Narayan Lal, M.A., L.L.B., Pandit Jyoti Shanker Dikshit, Mr. Shrish Chaterjee, Mr. Govil of America, Mehta Jaimini, B.A., L.L.B., who is expected here shortly, Dr. Bhagatram from London, Mr. D. N. Sharma from Assam, Pandit Shrikrishna Sharma of Fiji and many delegates from Africa, Fiji, Mauritius, Trinidad and other Colonies. The following resolutions were passed:

- (1) This Conference appreciates and admires the bold stand taken by the Colonial Indians in facing the oppressive and prejudicial policy pursued by the various Colonial Governments and declares that Indians will always stand by them in their political, religious and ether struggles.
- (2) This Conference draws the attention of the Government towards the present situation of the Indians in Keays and South Africa and urges upon it to safeguard their interests and privileges against the unjust demands of the white settlers.
- (3) This Conference fully agrees with and appreciates the just demand for common electoral roll of the Indians of Fiji, the principle of which was enunciated by White Paper No. 3574 presented by the Secretary of State for Colonies and requests the Fiji Government to fulfil their demand and further adds that the Indian and British Governments will be pleased enough to look into the matter so that the principle of common franchise is granted to them.
- (4) That this Conference condemns the action of the Government regarding the refusal to grant permission and passports to Swami Bhawani Dayal Sannyasi and Pandit Shrikrishna Sharma to go to the Fiji Islands and demands the Government's reconsideration over the matter.
- (5) This Conference proposes to call the third conference at a suitable time and place in India in order to find out ways and means to assist in removing the grievathes of Indians abread.

It is most difficult to see from the forms whether or not there is a serious claim for vested rights-I had better use that expression -sometimes it is clear enough and in other cases it is obscure. In this case I find the only claim, for a vested trading right in this block i north of Minnaar Street is apparently relating to Stand No. 230 where the present occupant says he has been in occupation since 1912.

Mr. MACWILLIAM: Do I understand your lordship correctly; when your lordship says there is one claim for exemption, does it include the whole 12 stands?

CHAIRMAN: The claim for exemption must include the whole block. The only for a vested right so far as it appears on these forms appears in connection with Stand 239, which is the only trading stand occupied by Indians in this block. In other cases, residential claims are put in dating from a comparatively early period—some from 1912; a good many of these from 1912.
