FIRST PROVINCIAL CONFERENCE

OF THE COLONIAL BORN AND SETTLERS' INDIAN ASSOCIATION

Colonial Born and Settlers' Indian Association was opened at the Royal Picture Palace, Victoria Street, Durban, on Sunday, December 31 at 10-30 a.m.

Delegates were present from Maritzburg, Dundee, Newcastle, Verulam, Stanger, Chakaskraal, Clairwood, Seaview and other places representing every section of the community and almost every trade and employment. Besides the delegates the hall was full with a large number of spectators.

After prayers were offered Mr. D. S. Chetty, one of the jt. secretaries, read the messages. There were a great many regrets from distinguished Europeans for their non-attendance owing to holiday engagements but who had nevertheless sent their good wishes to the Conference.

Messages From Europeans

The following were among the messages read:—

Anything that will relieve the position of Indians in South Africa will have my support. I have always held that the policy of absolute justice in the only one that should be pursued towards every section of South Africa, irrespective of race, colour or creed. All men of goodwill should combine in trying to bring prosperity to our common country, and a policy of mutual understanding and respect, based upon justice, is the best one to create happiness and real prosperity in South Africa.

"I would say firstly that in wishing success to the new association, I hope that care will be taken to avoid the mistakes and pitfalls into which other organisations have been prone to fall in the past. Secondly, that I consider that the safekeeping and true progress of the community in South Africa lies with the rising generation and that the latter is well qualified and competent to advance that progress of the Union as a whole, provided that the spirit of sacrifice and renunciation be cultivated and our Indian youth be brought to realise that the welfare of each individual is involved in the well-being of the whole, of which each is but an integral part.

The tradition of self-sacrifice inculcated by Mahatma Gandhi is still sufficiently vital to be capable of expansion and to produce great and important results. That spirit is moreover innate in Indian character. If your association can by example and precept develop that spirit it will, quite apart, from its political and communal activities, have succeeded in doing a great work.

Welcome To Delegates

In the course of his speech Mr. Manilal M. Gandhi, Chairman of the Reception Committee said:

As you all know it is only a few months since our Association has been formed. There have been many causes that have been responsible for its having come into existence. It is not my purpose to enter into a discussion of them here. those causes may be there is sufficient justification for the formation of such a body in that those born and bred in this country and who know no other home in any other part of the world and those who have permanently settled here and made this country their own by adoption—and it is indeed they who form by far the largest population of our community have the unchallengeable right to speak for themselves and to decide what is good and what is bad for them. They are no longer in the helpless position of being spoonfed nor to have thrust into their throats what they do not like. They are sufficiently intelligent to know what is right or

"This Association has convened this first Natal Provincial Conference. There are many matters that we have to discuss. I do not wish to detain you by enumerating them here. You will, I am sure, find them all referred to in the Conference booklet that the Delegates will presently be

presented with.

"To put it in a nutshell this first Conference has been called in order to get into closer touch with one another in a great brotherhood, and to discuss the ways and means of our future welfare in this land of our birth and adoption,

You have all come from far distances at great inconvenience. I extend to you all a very hearty welcome and in doing so will ask you to make yourselves at home and overlook any shortcomings on our part which there are sure to be, this being our

first venture since our inception.

"I am pleased to see in our midst a large number of friends from other communities showing an interest in our affairs. It gives us hope and encouragement. On behalf of our Association I have great pleasure in thanking them for their presence and in wishing them the compliments the B0880D."

[NOTE.—No reply, we understand, was received to the above letter from the Agent. While fully appreciating the fact that the Agent may have had other important engagements it is certainly regrettable that he should not have considered the present occasion, when Colonial Born and Settler Indians had gathered to discuss matters vitally affacting their future in this country, as also one of great importance and worthy of his taking note of. If it was possible for the Agent to run down from the Rand to join the officials of the Natal Indian Congress when they submitted their statement to the Provincial Finance Committee, if it was possible for him to run down once again, just for a day, to tender evidence before the Colonization Enquiry Committee the present was surely an occasion when he should have at least sent his representative, if he was not able personally to come down.—Ed. I.O.]

Presidential Address

The following address was delivered by the President, Advocate A. Christopher, to the first Natal Provincial Conference of the Cononial Born and Settlers' Indian Association, held at Durban, on December 31, and January 1 :-

Ladies and Gentlemen,

We who are South African born Indians and permanent settlers in this land have come together to consider our life and our existence in this country. There have been let loose forces in this country which we fear will, as times go on, make our position worse than it is.

You know that for some years the Congress has been in existence and like its predecessors has worked on lines which did not make for the

advantage and improvement of all.

We who have been in the Congress and have worked in it have endeavoured to initiate movements for the betterment of all, but they have never been supported by those who were in a position to help. The attitude on the part of some has kept the community back. They have agreed whenever any trouble threatened us in this country to some scheme which had for its object the reduction of our community and we know that such reduction was effected by pressure of sconomic circumstances and illiteracy of our working class and others which forced them to leave the country

Colonization Enquiry

We have just now in this country a Colonization Enquiry which is ascertaining to what extent our people would go to other countries and for this purpose an investigation has been taking place into their economic conditions!

On that Committee of Enquiry the Congress is represented and yet no objection has been raised by it or its representative against the Committee conducting such an economic enquiry. But could we expect it to be otherwise?

The last Indian Delegation came to South Africa in response to the urgent call of the Transvaul

. . . .

....

Indians in connection with the thin Asiatic Land Tenure Bill, now an Act, but the Delegation found it could do nothing about the Bill and the Cape Town Agreement in itself was in danger, It then spoke of a Colonization mission which the India Government was to undertake to explore outlets for its surplus population, and suggested that Indians in South Africa should have no objection to cooperate in such an exploration as they would not in any way be bound by it, for the exploration in itself was to be undertaken on behalf of her surplus population and that the findings of such a mission rould be first submitted to the people of India and if it were found to be in any way favourable, it would then be for the Indians in South Africa to consider whether any of them would care to go to these new colonies of India.

The suggestion was agreed to subject to the following terms:

- The Congress agrees to co-operate with the Governments of India and the Union of South Africa in the former's mission to explore outlets for colonization in regard to her increas-ing population, provided that such co-operation on the part of the Congress as taken as inspired by patriotic motives, of the Congress is cased as suspense up positively and to ascertain whether there exists any good opportunities for South African Indians in the countries explored, and soot on the score of Indians being deemed undesirable in the Union or that the Indian population is to be reduced: provided also that the Assisted Emigration Scheme which formed part of the last Agreement is eliminated and the Congress will be free as part of its policy to oppose it.
- 2. The Congress also reserves the right to reject the Agreement and to withdraw its co-operation in the above Scheme should any points in the agreement or other subjects dealt with by the Round Table Conference not meet with the approval of the Congress.

But even this decision was not arrived at unanimously for every attempt was made by several of those who are still in the Congress to agree to co-operate unconditionally because this was what the India delegation required and which we were not prepared to give, and in the end they accepted the assurance of co-operation in the terms set out.

Therefore the terms of reference as announced by the Minister of Interior in June last came as a shock to us, for it was a vital departure from what was the understanding at the time of the last Round Table Conference. The terms of reference were published with the concurrence of the India Government whose Agent in South Africa in no way consulted our people before agreeing to such terms.

Instead of our people considering whether the colonies that India had found for her surplus population would suit us, it was now sought by the terms of reference to ascertain to what extent we would participate in a colonisation scheme.

The Congress has refused to consider the voice of the people in persisting in participating in an enquiry at which the Agent bimself has now declared that India has no money owing to the world's economic situation to finance any scheme of coloniaution, and yet, the world's financial position was worse at the time the delegation was in Capetown!

This admission of the Agent simply confirms the India Government's communique of 15th June last that the reference to colonization from India was merely a reproduction of the language of the agreement. It would appear therefore, that the Indian Government never at any time were seriously concerned with the idea of exploration to find outlets for her own surplus population.

Face The Position Fairly And Squarely

The time has now come for us who are born in this country and represent the fourth and fifth generations of them that came to this country in frail eniling vessels which were storm-toesed for months on the high seas before they could make for Durban and those of us who have adopted this

country as our homes must face our position in this country fairly and squarely.

We are the nationals of South Africa, we have to rork and live as befits citizens of this country. We have to work not only for economic equality in the evantry but for economic equality within the com-

Our ideal is to work for a common brotherhood in Bouth Africa, the members of which would help one another in all undertakings regardless of religious, language and other considerations.

Then only can we see a happy, contented Indian community in South Africa which by its character and its life will contribute not only to the prosperity of South Africa but to its culture.

There will come before you many questions of pressing importance, some of which I shall refer to bere.

Racial Discrimination

Unfortunately for us the Appellate Division, of the Supreme. Court has in the case of Rescol ve the Minister of Posts and Telegraphs decided that the discrimination between classes made under statutory anthorities is not per se bad because it is based on race or colour and that the person who challenges such a discrimination as allow wirst must show that it is partial or unequal in its operation as between the discriminated classes. Until this judgment was delivered we felt we were protected from such discrimination so long as a law in its terms was of general application and there could be no class legislation inless a law in its terms dealt with races or classes.

We are faced with this new development and while an appeal may be possible to the Privy Council we think the only way the status one can be finally restored is by an Act of Parliament, but will the Government of India be able to do anything in the matter?

Education Our people are in need of education. Within recent years there have been improvements, but the need is still there. The education of the masses, the education of the workers, the education of the farmers and the education of the girls, are all pressing

Our economic preition is such that, free education. would be a blessing to many. We must educate our girls if we wish to help our community to progress rapidly. Taki Laki

There are reforms required as to the standardisation and reduction of the number of books used in our schools and the cost of them, the exemption of poor children from payment of fees, the wasquak fees charged in Government Aided Indian Schools and their standardisation, and the question of taxation of students by teachers,

Unemployment -

But the greatest and the most pressing of all នៃកាលីស (ស៊ុស **ឃើ** 6ស្ ស្គ amodel is unemployment, and the White Lebour Policy is throwing our people out of work to make reom for Europeans. We have no objection to.
White Labour Policy as a standard but as a means of the displacement of Indian and other non-European labour, it is working great harm and suffering. This was a question which was discussed time and again with the last Indian Delegation and we appealed to it to work for its modification or elimination, but it admitted that it was powerless in the matter. We are helpless and we can but appeal to public opinion to work a change in the policy so that we who live and shall die in this country may have the chance of human beings.

The question of relief for our nuemoloyed was brought to the notice of Sir Kurma Reddi, the theu

Agent, and a Relief Committe was formed. This Committee carried on the work and when the present Agent came it was with difficulty that he was got to take action in the matter in co-operating to secure relief for the unemployed. To the Union Government and the Durban Corporation we are greatful for such relief as was afforded our people though such relief did not substantially touch them.

We see year by year the schools are sending out our children to seek for bread but where are the avenues' of employment." We are living without a thought for our children. Is it not time for us to consider what is to become of them in this country?

They have not the opportunity to work because the State would not employ them and encourages industries to employ White labour, and on the other hand it is next to impossibility for them to in any way because they cannot get licences. them to trade are they to do? They cannot get employmet and they cannot trade. Are they then to starve or to commit crime to live, for, to work without authorty is to work unlawfully.

We have the industrial laws but we suffer under them as we have not the same economic opportunities as the Europeans.

The Indian worker does not get an equal opportunity in the labour market notwithstanding the formation of trade unions among them.

Our unskilled workers on the mines, on the railways and on the estates and in the towns, are displaced by machinery and by white workers.

Our countrymen are not large employers of labour and the question of their absorption in the labour market is pressing.

Condition Of The Farmers
Our farmers live by the sweat of their brow. Year in and year out they toil but they do not to the full reap the fruits, of their labour but eke out a bare living. They work for the landlord, the dealer and all others to whom they have to make some kind of payment. They are mostly illiterate and do not know how or where to sell to their profit. Even the dealer finds that with lower railway rates from Delagoa Bay to the other provinces he finds it: difficult to sell Natal bananas against those from Delagoa Bay in the markets of those provinces.

Much requires to be done for the farmers to give them a chance of getting a return that will improve their methods of cultivation and the distribution of their products.

Personal Tax:

The Personal Tax bears hardly upon the poorer members of our community and the Provincial Executive of Natal will give great relief to them if exemption were granted to them: (1) | (2) |

Housing Loan people and her a content of the conten

From the Housing Loan granted for Indian housing the Durban Corporation was willing to grant building loans to Indians subject to the land being freehold and other conditions. This offer was not availed of by our people. We "would urge that advantage should be taken of this offer and better buildings erected. We would suggest that live fences in the suburbs would improve their properties.

In the erection of living quarters for Indian workers by Local Authorities and others, it would help the Indian workers to live in cottages instead of senement blocks which are not always convenient, and sesthetic. "We understand that the Durban Corporation will:

probably be building on its Cato Manor Estate Tenement blocks for its Indian Employees. We would appeal to them to build cottages on quarter acre sites,

as this land was bought at £50 odd per acre and thus enable its employees to live in botter conditions.

Penalty Interst

Indians in the added areas of the Borough of Durban are still liable for penalty interest imposed by the Heatlh Boards and it would be an act of grace for the Durban Corporation to wipe off this imposi-

Hospitals

We are in need of hospitals. Addington has never been popular with our people for its differential treatment. St, Aidan's has been serving a useful purpose but it is unable to cope with the demand. It is appealing for funds and those who are able should not hesitate to contribute. There is a Khan's Trust for hospitals and dispensaries but so far there has been no announcement by the Trustees as to when something would be done. Not long ago Mr. Andrew Weir of the India—Africa Line donated, it was understood, a sum of £6,000 for an Indian hospital. Nothing so far has been heard as to who s controlling the amount or what is being done with it. But the question is argent and we should not hesitate to appeal to the Provincial authorities for better and more satisfactory provision for Indians at Addington Hospital. Wherever possible we should do our bit to assist in the work of child-welfare.

Immigration

As Indian Immigration to South Africa has been stopped there should be no differentiated treatment of Indian passengers on the boats who are lawfully The treatment of Mr. entering South Africa. Quareshi, a first class Indian passenger recently, is a case in Point .

Provincial Barriers

Union of South Africa has not been a Union to us in so far as we have been confined to our respective provinces. In the well known Gandhi correspondence-reference is made by Mahatma Gandhi to our claim for the removal of the Provincial Barriers. This claim has been repeated—and when the India Delegation were last here we urged on them to ask for the removal of the barriers but to no avail. With such removal, will come our distribution throughout the Union and no longer would there be a fear of pressure from us in this Province. We are glad that the recent South African Party Congress in Natal resolved in favour of the removal of the barriers.

Indian Immigration Laws

No Indian immigrant, Hindu or Mahemedan, will be appointed as a Marriage Officer for his class of persons under the existing laws and the Protector of Indian Immigrants or a Magistrate acting under the Indian Immigration Laws is the Marriage Officer for Indian Immigrants. But a Passenger Indian may be appointed as a Marriage Officer for his class of persons. This creates an anomalous position and indicates the need for the repeal of the relative section so that a Hindu or Mahomedan can be appointed as a Marriage Officer for his co-religionists irrespective of whether they are Indian immigrants ior passenger Indians.

Marriages registered under Indian Immigration Laws between persons, one of whom was not an Indian immigrant, have been held by the Courts of Natal as invalid, causing loss and , suffering to the sorviving spouse and children.

We have made representations for the 'validation of such marriages.

The question, you will remember, was raised by appeal to the Privy Council by the late Govinda-

samy, a public-spirited Colonial-born Indian, whether Colonial-born Indians, the descendants of Indian immigrants, fell within that term, and unfortunately for Colonial-born Indians the Privy Council held that it did.

These Indian immigration laws were passed to meet the conditions prevailing under the indenture system and as those conditions no longer prevail, we think that the time has come for the repeal of

The Agent Of The Government Of India

We in this country are in a sense living under As nationals of South Africa two Governments. we are under the Union Government but the Agent to the Government of India is here. We have never been able to ascertain what were the duties of such an Agent in this country. We know that while there is a Capetown Agreement the Agent will be

We understood that he was to be here not to supersede the organisations of the Indian community but to support them. He stands by the Congrees so long as his views agrees with the Congress but the moment the Congress disagreed with him and passed resolutions opposing the Land Tenure Act, he at once ignored the existence of the South African and the Transvasi Indian Congresses and recognised a new body styled the Transvaal Indian Commercial Association as representing the Trans-▼aal Indian community and co-operated with it in giving evidence before the Feetham Commission in terms of the Asiatic Land Tenure Act. And having schieved his purpose has gone back to the Congress which, strangely enough, accepted him again notwithstanding they having resented his action in strong terms at the Transvaal Indian Provincial Conference,

The Agent finds in the Congress an ally for the support of the colonisation enquiry and disregarded the almost unanimous opposition of our community to the enquiry and thus once again works his in opposition to the community.

We hope that the official methods of India will

not be introduced to this country and that we may be allowed to grow into a homogenous community.

Franchise

We are now of this country. We are subject to its laws but we have no right to join in the election of lawmakers. We had the Parliamentary and Municipal franchise. Both have been taken away. There is discussion about representation being given to Coloureds and Natives but the question of representation for Indians has not even been mentioned. We appeal to the Government to restore to us our franchise rights and thus give us as South African Nationals full oitizenship rights.

Fellow South Africans: By our work, by our life and by our character, and by our contributions to the prosperity and advancement and culture of South Africa only can we prove that we are worthy citizens of a great South African Nation, the contribation of India to South Africa.

The Conference

The first Provincial Conference of the Colonial Born and Settlers' Indian Association took place last Sunday at Rawat's Bio, when the hall was almost packed—over 500 being present—representing nearly all the districts of Natal. Advocate Mr. A. Christopher, D.C.M., presided and the delegates were welcomed by Mr. Manilal M. Gandhi, the chairman of the Reception Committee. This Conference was an eye-opener to many. The arrangement was perfect and credit is certainly due to those stalwart workers who were instrumental in making it a huge success.

Mr. Gandhi pointed out the need for this Association and how it came to be an established fact: He emphasized how it was essential to form a brotherhood of the community who may devise ways and means for the betterment of their interests in this country. His speech was very effective and went right home, if one were to judge from the applause he received at the end of it.

The President

Mr. Christopher in his speech dwelt very ably on nearly all the questions which affect the position of Indians. He in a masterly style pointed out how from time to time we have been losing ground and how it was up to the Conference to protest in an unmistakable manner of this gradual dwindling of our rights in this country.— His address which might be found—in another

column, aredless for me to state, is well worth permal as it clearly gives an epitome of our grievances under which we are suffering. It would be seen that the Association has come to stay and it is up to the members to gird up their loins and face the issues ere it is too late.

The Adjournment

On the motion of Advocate Mr. B. Gabriel, the Conference adjourned for its session at the Tamil Institute. There was a muster of delegates when the session opened, representing all shades of opinion. After roll call a book containing close on 200 pages of matter was given to each of the delegates, some of whom preferred to pay 2.6, the cost of production. This book contained a budget of information of the activities of this newly-formed body. During the few months since its inception the volume would signify of the tremendous amount of work the Association has done for the uplifument of its compatriots. I congratulate those who were responsible in neither sparing time or labour in bringing about such a volume for the edification of the public.

The Subjects

It would be presuntuous on my part and in these columns to elaborately deal with the numerous subjects, the interesting debates—delegates vieing with each other in a brotherly spirit to put forward their view-point on the issues involved. The question of marriage officerative teaching of Afrikaans and the office of the Agent for India were questions which took considerable time be, cause there were men belonging to different schools of thought.

I shall if need be make comments in subsequent immes on these contentions matters.

It was, I might point out, through the tact of the President and Mr. Gandhi that a very strongly-worded resolution re the Agent was heavily defeated.

The End

In conclusion I might state that among those who took part in the Conference were prominent men such as doctors, barristers, journalists, persons belonging to different professions and trades. There is no doubt that the Conference which brought messages from Cabinet Ministers, editors and men of high rank, was a huge success. Soou, when the badges arrive and members giving each other the right salute, there would be a truer brotherhood among them—a factor to be reckoned with.
