## Notes and News

#### Government Must Define Its Attitude

After discussing the proposed eclonisation scheme and the attitude of the Congress towards it The Star (Johannesburg) concludes its leading article of Jan.

16 in the following words:-

It will be realised that the position—as regards future relations between India and the Union of South Africa-is delicate and may easily become The Union Government, instead of continuing a policy of drift, varied by acts or threatened acts of coercion and repression, must make up its mind what it means to do in the future. It must clearly define its attitude towards the Indian population in the light of the declaration of 1927. That declaration either means something or nothing, and the resident Indians, 80 per cent, of whom are South African born, are entitled to know just what it means. In this connection we would recall Sir Maharej Singh's recent appeal to the younger generation of South Africans to take a "broader view" of the subject. "It is partly a matter of ignorance and partly a matter of prejudice," said the Agent for Indis. "There is no more immigration." into South Africa, and surely you can let the Indians that are in this country—only 2½ per cent. cf the total pepulation—remain in peace. This is the only country in the whole world-I have travelled in thirty countries and I know—where the Indian is treated as he is. Remember that the enmity of 330,000,000—and add to that the 450,000,000 of China—is bad for you, so that for the sake of a population which in the Union numbers only a very small proportion, you are bound to lose valuable markets." Where other considerations fail to influence local public opinion, the economic argument may prove not ineffective."

# Newcastle Town Council Up In Arms

THE Town Council of Newcastle has received definite information from the Education Department, says Reuter, that the premises of the boys hostel, situated in the European residential area, are to be altered and converted into an Indian school. The hostel in question is now disused owing to the erection of new premises. A petition to the Administrator is now in circulation locally, protesting against this proposal, and at a recent Council's meet-

ing, the Council, in passing a resolution of opposition to the project, resolved to remind the Director of Education of his promise made at an interview with the Council, but what that promise was is not stated. The Council is very much up in arms about the matter, and one member suggested that, if the Provincial Executive persisted in going on with the proposed Indian school in that quarter, the Council should refuse to render services to the premises,

seeing that they are not rateable.

Not long ago the Agent of the Government of India Kunwar Sir Maharaj Singh, when he paid his. official visit to Newcastle, paid a very high tribute to [ Europeans of Newcastle for being broadminded. There is certainly not much of that spirit in the present instance where the Council grudges giving a worn-out building of the white boys for the use , istoreta Ta

of Indians.

#### Indian Paper On Mr. Qureshi's Incident

The Hindu (Madras) writes:—"The treatment accorded in South Africa to Mr. A. I. Qureshi, a research scholar deputed by the University Bureau of the Empire to study rural credit and marketing, is revealing. It is doubtless an everyday experience of the Indian community in South Africa, but Mr. Qureshi's case serves to focus public attention on the magnitude of the wrong daily being done to Indians Mr. Qureshi went there, not as an adventurer out for a career, but as a respected student of the Empire deputed by a well-known Empire organisation. If such a person could be subjected to indignities and insults of the kind of which Mr. /. Qureshi complains, one can imagine to what lengths the whites might not go in treating those resident in the country. Surely, it is time that South Africa was told that she could not long persist in her policy and yet claim to be reckoned as a fair-minded community. When will the white people of South Africa learn that righteousness alone exalteth a a nation?"

## old Bangles For Gandhiji's Autograph

MAHATMA GANDHI who is at present touring India in pursuance of his campaign to emancipate the untouchables of India is being welcomed by hundreds of thousands of people wherever he goes and financial support in the shape of cash and jewellery is pouring in. There are untoward incidents of orthodox Hindus trying to adopt obstructive methods by lying in front of Mahatma Gandhi's car and greeting him with black flags but they are insignificant in comparison to the wholehearted support he is getting from the nation. Recently in Madras he was welcomed at the station by no less than a hundred-thousand people. Here is just one of the very many instances of the affection for Mahatma Gandhi:

Gandhiji on his way to Madras was presented with a welcome address at some wayside station. The Taluk Board of Sulurpet presented an address and purse of Rs. 119 at Sulurpet Station. At Ponneri a lady offered Gandhiji a gold ring and four rupees and requested for his autograph. Gandhiji signed his name on the paper in Hindi, gave it to her and said he would sign in Tamil if her gold bangles were forthcoming. She immediately removed the bangles and gave them to Gandhiji,"

## FUTURE OF THE INDIAN

WARNING note has already been struck by the Natal Mercury that the Capetown Agreement is in danger. The Agreement when arrived at as a result of the first Round Table Conference in 1926 was described as the Gentleman's Agreement having no bargaining spirit behind it and so on, and yet it was never bound by the silken cord of love as one was made to believe at the time. It was a bargain pure and simple and, that too, not a fair one. In return for postponing legislative action—the Areas Reservation and the Immigration and Registration (Further Provision) Bill was threatening at the time—a very substantial reduction in the Union's Indian population was asked for and was given, without the implication of any stigma of racial inferiority, as Dr. Malan tried to explain to the Parliament. "The chief and most satisfactory method of dealing with the problem," Dr. Malan said, "was found in an approved scheme of assisted emigration to be initiated by the the Union Government with increased facilities and inducements, and with proper safeguards against possible abuse." The consoling feature of this scheme however was that it was supposed to be purely voluntary in addition o of there werer other hopeful features in the Agreement such as the upliftment clause. Side by side with the working of the assisted emigration scheme it was hoped that every opportunity would be given the Indians to enable them to conform to the western standards of life.

It was however found that the upliftment clause in the Agreement was there only as an ornament. Though the Areas Reservation and Immigration and Registration (Further Provision) Bill was supposed to have been postponed, ere the ink had dried on the Agreement, the Immigration Bill of 1927, which formed part of that Bill was passed and promulgated in the very presence of Mr. Sastri in this country as the first Agent of the Government of India. A little later another part of the same Bill referring to "Registration" was rushed into Parliament without the knowledge of anybody and was passed as the Immigration Act of 1931, depriving holders of Registration Certificates in the Transvaal of a right which they had earned after paying a heavy price for it. Even General Smuts described it as an unjust measure.

Sir Kurma Reddi, the second Agent, was able to afford no relief, in fact, he was also kept in the dark. Then within the period of five years of the working of the Agreement we were faced with the Transvaal Licences (Control) Ordinance and the Transvaal Asiatic Land Tenure Bill, the object of which was to segregate Indians in the Transvaal and deprive them of even the meagre rights they enjoyed of owning and occupying land and to restrict their trading rights, thus aiming at bringing about their ruination and consequent total extinction. The second Agent protested against these measures as being against the very spirit and the letter of the Agreement, until the time came to revise the Agreement.

This is what Indians received within the course of five years in return for the supposed postponement of the Areas Reservation and Immigration and Registration (Further Provision) Bill part of which

as we have already pointed out had already been passed; and the additional price we had to pay was the compromising of the birthrights of over 13,000 of our brethren who are undergoing unteld miseries in India.

When the Agreement came under revision at the Round Table Conference in January 1932 the delegation from India was found to be representing a very weak Government. Before its members could raise a voice against the assited emigration scheme the Union Government told them in plain words that the Scheme had not proved effective enough and unless they were prepared to put forward another scheme which would be more attractive to the Indians and would go to bring about a further reduction in their population they, the Union Government, were not prepared to discuss the Indian question with them. The outcome was the suggestion of exploring the possibilities of a Colonisation Scheme for settling South African Indians in other countries. When this was agreed to the Transvaal Asiatic Land Tenure Bill was the only subject that came under discussion and with slight modification the Bill was allowed to pass. This ended the matter and further discussion on the Agreement was postponed until after the exploration of the possibilities of a colonisation scheme.

It is too true that the Indian community in South Africa was very reluctant to oc-operate in this exploration and it offered its co-operation only on the ground that the Government of India was going on a mission to find outlets for its own population and that the representatives of the Indian community of South Africa would merely go to see if there were any good prospects for their brothern in such countries. They were not at all interested in the Government's policy of reducing the Indian population of the Union and did not wish for the second time to enter into a policy which meant the bartering away of the rights of a section for doubtful consessions for another. Unfortunately the Congress did not realise the strength of public opinion and out of fear of their rights being in jeopardy they went out of their way to co-operate with the Government in exploring the possibilties of such a scheme. But their attitude, as we have stated often enough, has been utterly inconsistent. We entirely agree with our contemporay that "the real issue has been obscured under a great outpouring of grievances," and that "there has been no genuine attempt on the part of responsible leaders to explore the possibilities of the above mentioned scheme." The Congress had stated from public platforms and made it clear even to the Government of India delegation that they were no longer going to countenance any scheme which had for its object the sending away of South African Indians to other countries and their attitude in trying to camouflage the issue has resulted in unpoparising that body.

The issue before us now is quite clear. If the Indian community has lost its manhood entirely it will certainly submit to any humiliations for the sake of material gain. Those who have vested interests in this country will be tempted to surrender the rights of their less favourably situated

brethren to refeguard their own interests. Tt would be an unpatriotic act on their part to do so. Any condemnation of such an act would not be too strong. On the other hand we would urge upon the ruling race in this country to view the question dispassionately and with a little broad mindedness, The door to further Indian immigration to this country is entirely closed. There is therefore no fear on the score of the country being flooded by Indians. Further it has been pointed out over and over again by the Agent of the Government of India, that the Indian population of the Union is only two and a half per cent, of the total population. Public Commissions and responsible Ministers of the Union have openly declared that the Indian population of the Union is a perceful and law-abiding community. They have proved their worth in the past when they were introduced to this country as labourers. If they are given the opportunity they will surely be on seet to this country. Is there not room enough in this wast land for a comparatively handful of people whose ancestors have given their life-blood in the development of it? Must they be perpetually threatened with measures of segregation and the deprivation of their elementary rights as human beings? It certainly does not behave any civilized Government nor any people who claim themselves to be civilized to so act.

# Discrimination In Post Offices

#### Question in Indian Assembly

Dr. Zianddin was informed by Mr. Bajpai, in the Assembly, that the Government were aware of the recent judgment of the Supreme Court of South Africa which held that the Postmaster-General had the right to direct tout Indians be not served at Post Office counters where Europeans are served, but the judgment merely recognised the legality of the existing practice which fortunately was not universal. The Agent to the Government of India in South Africa had already made representations to the Minister of Posts and Telegraphs. So far as the Government were aware, such discrimination was not practiced in other Dominions.

Bellying to a question whether the Government were prepared to take effective measures to retaliste, Mr. Bajpai mid that the Government think the policy they were now following deserved further trial, but the Government were prepared to examine any other practicable policy.

# Threat Of Retaliatory Measures

# Unless Indians Display More Vision Agreement Purely A Compromise

The Parliamentary correspondent of the Natati Macany in a message from Capetown dated January 17, states:—

Serious misgivings as to the feture trend of Indian affairs in the Union are held in certain responsible quarters and appear to be fully justified.

The Department Commission appointed by the Government last June to undertake a preliminary investigation scheme for settling Indians from India and South Africa in other countries has completed taking evidence and is busy framing its report.

#### Further Commission

This report will be sent to the Government of India, supposedly to be used by them as the basis for the work of a further joint Commission agreed upon by the two Governments in terms of the report of the 1932 Capetows Bound Table Conference.

The work of the present Union Departmental Commission appointed by Mr. J. H. Hofmeyr has, unfortunately, been pullified to some extent by several factors, and I am doubtful whether it will lead to any practical results.

In the first place the Indian community has seized upon the Commission as a means of spreading propaganda, and many of the real issues have been hidden and distorted under a great outpouring of grievances.

Temporary concessions have been misrepresented as inviolable rights, and there is real danger of the position being misunderstood by the community as a whole,

In Natal, at the close of the Great War, Indian competition had become so scute that a Commission was appointed by the Government which, in 1921, recommended the encouragement of volutary repatriation of Indians and the segregation of Asiatics.

A Bill was introduced to Parliament which failed to become law owing to various circumstances, and, shortly after the Nationalist Government assumed power, another Bill, known as the Class Areas Reservation Bill, was drafted. This measure was actively fought by the Indian community and resulted in the intervention of the Government of India.

#### "Purely A Compromise"

Ultimately it was agreed to hold the Round Table Conference in Capetown which ended in the Gentler men's Agreement of 1926.

What the Indian community in South Africa refuses to face at the present time is that the Agreement was purely a compromise and that the Union Government merely undertook to hold its legislative programme in abeyance while the experiment—that of assisted repatriation—was tried out as an alternative.

There were features of the 1926 compromise which were obnexious to the European community. Nevertheless, the people of South Africa loyally abided by that arrangement until the close of 1931, wher it was realised that the assisted repatriation scheme had definitely failed. There was then nothing to prevent the Union Government from allowing the Agreement to lapse and going shead with its legislative proposals, including the Class Areas Reservation Bill with modifications.

An influential school of opinion did, in fact, urge that this course should be adopted. However, it was decided to hold another conference, at which the suggestion was made by the Indian delegation that a way out might be found by means of a joint colonisation scheme. The Union Government agreed to carry on the 1926 Agreement while the prospects of such a scheme warm investigated.

of such a scheme were investigated,

#### Interest Lost

A delay then occured and both Governments appeared to have lost all interest. As a concession to public pressure expressed in Parliament, Mr. Hofmeyr appointed his present Departmental Commission last June, and a further delay has since taken place while the Commission has been at work.

Owing to the attitude adopted by a large section of the Indian community in the Union, it might easily be found impossible to undertake the proposed colonisation scheme or even the joint investigation, and the pressure of public opinion in South Africa would then be such as to compel the Government to take legislative steps to tackle the Indian menace without further temporising and delay.

Hence, in raising difficulties before the colonisation scheme, the Indian community is merely hastening the demand by the public for alternate steps, such as the Class Areas Bill, which were held in abeyance in 1926.

That the Indian problem constitutes an increasingly serious menace to the European community becomes more obvious every day to those who are in touch with the situation, and unless leaders of Indian opinion in South Africa display a little more vision they may easily hasten retaliatory measures.

Strong Plea By The Agent

In the course of a lecture on Modern India to von Bradis Branch of the Junior South African Party Club, recently the Agent of the Government of India Kunwar Sir Mahraj Singh after dwelling on the present situation in India spoke of the condition of Indians in Sonth Africa.
"I have often heard it said," he stated, "that it

was impossible to accord better treatment to Indians without raising difficulties for the other sections of the non-European population, how was it possible to give the municipal vote to Indians or free the Indians from the many restrictions from which

they are suffering in this country.

"Ladies and gentlemen, it is not for me to give the answer to this question. You know perfectly well that if a thing is right it has to be done. Do you really think that a country with 335 millions of people is going to sit silent for all time?

Are we not a country with a great civilisation. behind us. Can we not be differentiated from the natives of South Africa, who have only recently emerged from barbarism? It is always difficult for me to take that argument seriously—that we, the people of India, should be treated in the same manner as the natives of South Africa.

Are you really going to deprive us of our rights in South Africa?

"Please remember that 80 per cent, of the Indians in South Africa were born herey, and that number is going to increase year by year. The number in the Transvaal is three per cent. of the European population. Is that a menace?"

As for trde, the Kunwar continued, the volume of Indian trade, wholesale and retail in Johannesburg was only about five per cent. And in crime, in spite of the general lack of facilities for education, the proportion was less than among the Europeans.

"Magistrate after magistrate has told me that if

anything our community is too law-abiding," he said.

If the facts were studied and the Indians given a chance to develop, his countrymen would prove an increasing asset to this country, he concluded.

Indian Celebrations

Gulf Widens In Indian Community

Durban Mayor And Mr. Christopher Interviewed

On the 6th January the Natal Advertiser reported that on representations made by the Agent of the Government of India, Mr. Farrel, Private Secretary to the Prime Minister and Manager of the Royal Tour, wrote to the Durban Town Council to include in its programme, if possible, an "At Home" for the Indian community where its leaders may meet His Royal Highness. On the same day the Colonial Born and Settlers' Indian Association wrote to the Town Clerk and advised him of its intention to arrange a huge gathering where Indian farmers, workers, returned soldiers and others would meet the Prince. In this connection the Asso-ciation stated that the Natal Indian Teachers' Society was co-operating with it.

Last week the Town Council's programme of the Royal visit to Durban was published, and in it an item "Indian Celebrations at Albert Park" appeared. On enquiry the Association learned that the control of both the "At Home" and the "Indian celebrations" had been given to the Natal Indian Congress.

Interviewed by our representative on Thursday the Mayor of Durban, who was accompanied by his private secretary Mr. Burne, stated that the Committee had decided to hand the control of both the functions to the Congress. "By suggestions that had been made from time to time by people in authority," said the Mayor, "it was his intention in view of these suggestions to recognise the Natal Indian Congress. It has been definitely given to Indian Congress. It has been definitely given to me as correct that the Natal Indian Congress represents all sections of the Indian community in Natal.. There is no purpose in negotiating with any other body. If it could be proved that they were not represented by the Congress, I should be obliged to ask the Committee to reconsider their decision."

The Mayor appeared to be too busy and ancommunicative. When asked what authority he was guided by the Mayor refused to mention any names. He was not able to give much time but asked our representative to see his private seotetary.

It was learnt from the interview that the application of the Association was dated the 6th January whilst that of the Congress the 9th January, Mr. Burne maintaining however, that prior to the official application of the Congress, Messrs. Sorabjee Rustomjee and A. L. Kajee who were at Capetown at the time, were in constant telegraphic communication with the Town Council with regard to the celebrations. Neither of them was of course an official of he Natal Indian Con-

stated that his Association made the application on the 6th January. On that date the only item that the Kunwar, on behalf of the Congress, had asked was an "At Home" for "the leaders" of the Indian community. So far as he was aware there was no application by the Congress for a general celebration for the people. Immediately the full programme arranged by the Town Council was published, he, accompa ied by Mr. P. R. Pather, interviewed the Mayorand Mr. Burne, with the council was published. a view to ascertaining whether the Council had decided to grant the application of his Association. The Mayor told him that he had been bound down by Mr. Farrel's letter, which he claimed, indicated that he (the Mayor) should communicate with the Congress in connection with both the "At Home" and the "Indian celebrations" Mr. Christopher stated, however, that Mr. Farrel's letter to the Town Clerk refers to nothing but the "At Home" and his instruction to communicate with the ('ongress was in respect of that particular item. No reference to the Indian celebrations is made in his letter.

Continuing, Mr. Christopher stated that in his interview with the Mayor, he laid emphasis on the fact that on the occasion of the visit of His Royal Highness, his Association desired no split in the community, and he submitted that the action of the Council in handing over of the Indian celebrations to the Congress notwithstanding the prior application of the Association, tended to divide the Indian community. He maintaind that the Mayor, having regard to the fact that there existed two organsations should be impartial and suggested that the Council should give the control of the "At Home" to the Congress and the Indian Celebrations to his Association.

The Mayor asked Mr. Christopher to immediately address the Prime Minister on the matter, who, he said had the final say on the arrangement of the programme. If the Prime Minister wished to accede to the request of the Association, he, personally would have no objection to hand the control of the Albert Park Celebrations to the Association.

Mr. Christopher immediately sent a lengthy telegram to General Hertzog informing him that Mr Farrel's letter to the Town Clerk was being taken by the Mayor as an instruction to recognize the Congress only and 'that the Association had the support of the majority of the Indian community including the Farmers, Teachers, workers and sportsmen. The telegram made a request to hand the Albert Park Celebrations to the Association.

The Prime Minister immediately replied that the arrangement of the Programme was in the hands of the Town Council and that the Mayor had full discretion to decide. The Association immediately wrote to the Mayor enclosing a copy of its telegram to the Prime Minister and copy of his reply.

Mr. Christopher said that indirectly he had heard that the Mayor now states that the Sub-Committee in charge of the arrangement of the Programme had decided to hand the control of both the functions to the Congress. But strangely enough the Council has not as yet replied in the Association in writing.

# Asiatic Licences In Lichtenburg

#### Town Council Discussions

Lichtenburg's (Transvaal) Asiatic problem formed the subject of a full dress debate at the first meeting of the Town Council this year. So much public feeling has been aroused that the council chamber was crowded, and the Council spent some time hearing deputations from the chamber of commerce the Handhawers Bond, and the local vigilance association, all of whom had come armed with credentials from the bodies they represented opposing any granting of new licences to Asiatics, or the transfer of existing ones. The Mayor (Mr. J. P. J. Conradie) presided and the other Councillors present were Meesre. P. J. Huyser, I. Olen, C. J. Grove, A. I. Ludick, C. B. Maartens and C. de Klerk.

The matter arose as a result of seven applications (six from Asiatics) for new licences, all of which had been previously rejected by the health and building committee. Of these, those to which chief exception were taken were one by Mr. E. A. Kaka (Hadjee Bros.) for a new licence on the market square in a building still to be erected by Mrs. A. Delarey Morkel, and an application in respect of the premises known as London House, by Mr. M. Moosa. The building committee approved of the plan of the building for Mrs. Delarey Morkel, but intimated that there would be no guarantee that the licence would be granted.

The commercial viewpoint was set out in a letter from the chamber of commerce referring to a general meeting of members at which a resolution had been passed strongly protesting against the granting of new trading licences to Asiatics, "because not only are the number of Asiatic licensees entirely out of proportion to the European licenses, but also because the general effect of Asiatic trading tends to lower the standard of living of the white population which, in this country, is a matter of vital importance."

The chamber, proceeded the letter, objected most strongly to the granting of new licences or the transfer of others to Asiatics in respect of premises abutting on the market square, and, generally, "because it is not in the test interests of the town to permit more Asiatics to have business premises in the centre of the town." The secretary said various members of the chamber were considerable property owners and they naturally viewed with a deep concern any possibility of their property reflecting a decline in value.

Members of a deputation from the chamber made it clear that they did not wish to see Indians established in stores in the centre of the town, and pointed out that the Council was not legally entitled to consider any application until the building sought to be licensed had been completed. The secretary, Mr. J. Berman, said as a general principle that the chamber was not in agreement with the granting of further licences to Asiatics, applications from whom were out of all proportion to those made by Europeans.

If the Council continued to grant these applications, the European storekeepers would close up one by one. If the Council allowed an Indian in the centre of the town, then they would be compelled to let others follow them and consequently the whole of that portion would soon be occupied by Asiatic storekeepers.

Opposition from the Handhawers Bond was detailed in a speech by Mr. G. J. du Plessis, who congratulated those members of the Council who we taking a frm stand on the Asia is quisilous At

present, seventy per cent. of the local business went to the Asiatics.

The Council who heard Mr. J. A. Wagner, in support of the application of Hajee Bros., and Mr. B. L. Levi, on behalf of Mr. Mossa. Mr. Wagner and the Council should not be swayed by sentiment, but should treat the applications in a judicial manner. "You must consider whether the applicant is a fit and proper person in the eyes of the law, and not whether he is a Jew, Indian or Asiatic." Mr. Levi addressed the Council at length and maintained that it was unfair of the Council now to refuse the licence to Mr. Moosa, after it had been granted to his predecessor, (since decessed), for whom Mr. Moosa had managed the business.

The applications were not debated at any length:
The Mayor ruled that the application of Hadjee
Bros. could not be considered as the law required the building to be completed first. The applications of Mesers, Lala Echa, E. Gebbard and M. J. Anthony (fresh produce dealers), and of Mr. Mohamed Kabn (general dealer), were all refused, despite a protest from Mr. Hayser who considered that the application of Mr. Lela Beha (which was really a transfer) should be granted... Mr. Meartens asked why the application had been refused, and mid that he considered that if nothing were known against the applicant and the medical report was in order, the licence should be granted. He wished to support Mr. Huyser, but found that the matter had been disposed of.

Trouble Over Administrator's Letter

A letter from the Admistrator to the town clerk. in connection with the application made by Mr. Mooss, and a reply sent on December 28, in the absence of the majority of the councillors .led. to a heated debate, The Mayor said that although the town clerk had sent the reply he would take full responsibility for it. He explained that the letter, marked "Very urgent," had arrived during the Christmas vacation, and the Administraton asked whether, in refusing Mr. Moosa's application, the Council had done so solely on the grounds of overtrading. The town clerk had replied that from the debates it appeared that the Council had been actuated by motives of principle and that in any case the Administrator would grant the licence if he

so wished.

A spirited protest at the terms of the letter was made by Mr. Ludick. He asked whether the Mayor considered he was entitled to answer, it in that strain, and asked why no mention had been made of his (the speaker's) reference to overtrading. He maintained that it was wrong to have put forward only one point of view. Dr. Olen said the whole matter was "the greatest bluff that had ever taken place in the history of the Council." He suggested that a reply should be sent to the Administrator, that the letter was not official and did not represent the attitude of the Council, Replying to an interjection from Mr. Huyser that the Council, would probably be faced with legal actions for refusing the applications. Its Olen described the suggestion as languable tions, Dr. Olen described the suggestion as laughable and suggested that commeel's opinion should be obtained as to the Council's standing in the matter.
The suggestion was made by Mr., Martens that as

the letter had been sent to the Administrator, no further action should be taken until they received his, reply., Mr., Grove, said, that, the Mayor had certain powers, and he did not think he had exceeded these in his reply, because no one was committed in any, way. . He considered, however, that the Council should send a further reply to the effect that the Council had not refused the application

solely on the grounds of overtrading. Eventually the suggestion of Mr. Maartens that no further action be taken for the present was adopted by four votes to two, and no further decision was reached in regard to the London House application. At a previous meeting it was refused,—The Star,

# Indians' Reply To Springs Council

# Trade Record During Last 15 Years

The Springs Indian Commercial Association has submitted a memorandum to the Transvaal Asiatic Land Tenure Act Commission.

The memorandum is a reply to criticism levelled at Ariatic traders by the Springs Town Council, Ratepayers' Association and Chamber of Commerce,

The Association refutes amphatically that any congestion of traffic exists through native loiterers around shops tenanted by its members, and points out that loitering on the footpaths by pedestrains whether of white or black colour is under the control of the South African Police in virtue of traffic by-laws in force in Springs.

"In so far as the trading methods of the members of this Association are concerned," states the memorandum, "the records of the local court will serve to refute that charge. No prosecution and no conviction of an Asiatio in Springs for contravening any law or any ordinance governing the conduct of his trade has been brought before the court in the last 15 years.

"There is no "general belief" that the assistants of the Asiatics are underpaid and that this creates an unfair trading advantage in the competition of traders carrying out the term of the law. The members of the association conform to the requirement of the Wage Act and its relevant wage determination. There has been no prosecution and there has been no conviction of any member of this association for contravening the Wages Act.

"The Town Council of Springs suggests that members of this Association are guilty of lawlessness, thus rendering them as a 'general rule' undersirable traders in the eyes of the law-abiding traders. There is no record of any prosecution or conviction in the courts of any member of this Association for lawlessness.

"The Town Council of Springs asserts that it is 'generally recognised' that the Asiatic has developed a sense of resistance to and evasion of the law. This Association replies and states that there is no such general recognition and that the Asiatics in this municipality neither resist nor evade the law.

"The Association admits that Springs is a growing town and with the opening of the new mines it is progressing and developing rapidly. This progress and sure development is for ever closed to the members of this Association by reason of title secriction coupled with the Transvall Asiatic Land T nure Act. The Association being comprised of a tixens who are law-abiding, accept the position as they are compelled to do."
