Every Indian can and should give his bit even if he has to sacrifice a little of his comforts.

OT a single section of the Indian community was lacking in zeal in celebrating the visit of H. R. H. the Prince George. a full holiday for all school children. This announcement was followed by frenzied cheering.

At a banquet given in the Durban Light Infantry Hall in honour of H. R. H. the Prince George, by the Natal Indian Congress on Tuesday, in reply to the address presented to him, His Royal Highness said:—

"I am very pleased with the warmth of the reception you have given me here this evening, and I thank you sincerely for the kind sentiments contained in your address and for your gift, which I much appreciate and which I am very pleased to accept.

Questions In Parliament Mr. J H. Hofmeyr Explains

R. O. R. NEL (S.A.P., Newcastle) asked the Minister of the Interior in the House of Assembly whether he could state the official duties of the Agent-General for India in South Africa. Was the Agent-General, he asked, entitled to make representations to the Gorerenment or any Provincial or local authority on matters of South African domestic or political concern? If so, on what: grounds did the Government agree to the representative of the Indian Government having such powers in the Union? Had the Agent-General, to the knowledge of the Minister, actually made such representations? Had he at any time interceded with the Minister or any official of the Government regarding deportation orders or any other matters of a similar nature?

The Minister of the Interior (Mr. J. H. Hofmeyr) replied that as a result of the agreement arrived at between the Government of the Union and the Government of India at the Round Table Conference in 1926, the Government of the Union requested the Government of India to appoint an agent in the Union in order to secure continuous and effective co-operation between the two Governments. The Agent-General was intitled to make representations to the Union Governments on any point affecting in the Union arising out of matters dealt with in the agreement.

The Agent-General had actually made such representations and had interceded with the Minister in regard to deportation orders and other matters of a similar nature concerning Indians not born in the Epioni

1. Dresden: One scholarship at the Technical University of Dresdon, consisting of free tuition ... and pocket-money of RM 30.—(thirty marks) per month.

2. Hamburg: One scholarship at University of a Hamburg, consisting of free tuition and a pocketmoney of RM 30.—(thirty marks) per month, The candidate will be given free private coaching in the German language.

3. Hohenheim (Wurttemberg): One scholarship at the Agricultural University of Hohenheim, conconsisting of free tuition and free lodging.

4' and 5. Jena: Two scholarships at the University of Jena, consisting of free tuition and a pocket-" money of RM 30.—(thirty marks) per month for each scholarship.

6. Munchen: One scholarship at the University .. of Munchen, consisting of free tuition and lodging.

7. Stuttgart: One scholarship at the Technical University of Stuttgart, consising of free tuitton and

8. Tubingen: One scholarship at the University of Tubingen; consisting of free tuition and lidging.

 \mathcal{U} 111 9. One scholarship of RM 500.—(five hundred marks), the choice of the University being left to the candidate. This scholarship was placed at the disposal of India Institute of the Deutsche Akademie by the Allianz and Stuttgarter Lebensversicherungsbank A. G., Berlin.

These scholarships are tenable provisionally for two academic semesters only. The finest semester begins early in November 1934 and the second semester ends in July 1945,

Applicants for these stipends must be graduates of recognised Indian universities, preferable scholars possessing given research experience. Applications from non-graduates will be given consideration only if they have recognised literary or scientific achievements to their ceredit. Every applicant must possess good health and supply at least two recommendations from professors of Indian public men, about his scholarship and character. It is desired that the application should have fair knowledge of the German language, as all academic work in Germany is carried on through the medium of German.

No application will be given consideration, unless it is guaranteed for by some prominent professor or an otherwise wellknown Indian public man that the applicant is really earnest about his application and will certainly come to Germany before the 1st of September 1934, if a scholership is offered to him

September 1934, if a scholarship is offered to him. It is imperative that a stipped-holder should arrive at Munich by the 1st of September and stay in the city at his own cost till the scademic year begins in November, devoting these weeks to intensive study of German language in the German language courses for foreigners at the University of Munich, where he will be exempted from tuition-fees. It is however presupposed, that an applicant for a scholarship possesses working knowledge of German. We are forced to take these measures, because a student not having adequate, knowledge, of German, before beginning his academic work fails to get the benefit of his attending the University and often loses six months time.

We want to make it plear that apart from the scholarship the stipent-holder must be prepared to spend at least RM 100,—per month for the necessary

expenses not included in the different scholarships. All applications should reach India Institute of Die Deutsche Akademie before the 10th of April 1934. A special committee of experts will select his successful candidates, who will be promptly notified of the decision. Selection of successful candidates will be determined solely by the academic qualifications of applicants. Certificates and testimonials of applicants will not be returned.

Our London Letter

(From AGATHA HARRISON)
February 2nd, 1934.

DETAILED news of the Indian earthquake is now to hand, and the widespread damage andappalling, loss of life is worse than we feared. The airmail this week has brought in the first grim. pictures of the disaster, as well as a film taken of some of the stricken areas. No words are needed for these pictures speak for themselves. Meanwhile we know that men, women and children are in dire need. The Lord Mayor of London has issued a letter to the Press appealing for public support for his fund in aid of the Viceroy's Fund. This appeal has been made at the request of Sir Samuel Hoare and in co-operation with the High Commissioner for India, and has the support of the Archbishop of Canterbury, Lord Halifax (as we must now call Lord Irwin) Sir Stanley Jackson, Lord Linlithgow, Lord Lothian, Lord Sankey and many others.

The "Friends of India" have also issued an appeal. This has been signed by several British and Indian men and women, and the names include—C. F. Andrews, Horace Alexander, Rev. A. Helden, P. M. Gidwani, Agatha Harrison, Carl Heith, Edith Hunter, Laurence Housman, Robert Mennell, Harold Laski, Henry Nevinson, Naude Royden, Shoran Singha, Atma Kamlani, Reginald Reynolds etc. A meeting is called also at 112 Gower Street (The Indian Students' Union) to consider what steps can be taken to further the objects of the Indian Earthquake Relief Fund. This is being organised by Indian students and friends-Krisinas Menon being the Chairman, and the Treasurer M. Mahanti.

Mr. C. F. Andrews has received cables from Mr. Gandhi: Rabindrapath Tagore and Rijendra Prasad with detailed distormation of the terrible havou wiought, and imploring that everything be done here and in other countries to relieve the distress. It appears that the number of deaths have been underestimated, and it will be some time before the actual figures are known. The Lord Mayor of London broadcasted an appeal over the wireless, and the Manchester Guardian has a letter signed by the Lord Mayor of Manchester supporting the Lord Mayor of Loudon's appeal, and asking for "a substantial sum from Manchester" to demonstrate our practical sympathy with our Indian fellow sufferers and our goodwill towards our Indian fellow-subjects with whom we have such intimate relationship!" Mr. Andrews expects to go to Manchester this week.

These are bewildering days for so much has happened during the past week. Parliament reassembled on Monday and faces a difficult session of work—not only in domestic, but in international affairs. The unemployment question has occupied

much attention this week, and Disarmament, for Sir John Simon presented his Memorandum to the House. One paper described it as ",4 sober realisation of facts." It is early days to predict what the effect of this statement will mean-a Dehate will take place next week. Comments from other parts of the world are coming in, and are on the whole what was expected. The French press is not enthusiastic to say the least-though it is probable that the terms may be accepted, as a basis of discussion. German comment is more hopeful. Mr. Vernon Bartlett broadcasting last night was hopeful that this plan might give us a Disarmament Convention before the end of the year. Other stirring events have been the Pact signed by Germany and Poland, the formation of a new French Government, and Herr Litter's speeph on the occasion of the first anniversary of the present regime. The main points of the latter's speech were given here in the official wireless news and listeners suddenly heard a flood of German, for a record had been taken, and in the mirsculous way these things, how happen was able to relay here few hours later. The passion and intensity behind Herr Hitler's words were unmistakable-even to those who do not understand German.

THE JOINT SELECT COMMITTEE

In the middle of all this excitement, the above Committee has quietly seilled down to the work of drafting the report. Its members certainly have an arducus and difficult time ahead of them.

THE RETURN OF THE MEERUT. PRISONERS

Mr. Lester Hutching in and Mr. Ben Bradley have arrived in England. On January 27th a meeting was held in London to wolcome them, and to hear, their experiences. Mr. Harold Laski said he hoped these men would go up andadown; the country, especially to Lancashire. In his opinion the increasing political tension tended to draw the minds of the electorate away from the seriousness of the In lian issue, and Mr. Hutchinson and Mr., Bradley could help by presenting their serious case. On January 31st, the Meerut Committee of which Mr. Morgan Jones M.Pi is Chairman, entertained the two men at the House of Commons. Over tea opportunity was given for informal talk, and later a meeting was held at which Mr. Hutchinson and Brailley spoke, Both of them said they would still have been carried on here and elsewhere. The presence of Mr. and Mrs. Spratt, the father and mother of one of the men still in prison was a reminder that the work of the Committee is not ended. Several well known sympathisers with the Indian cause were present, amongst them Mr. C. F. Andrews, just returned from a veek-end in Paris, where he had been preaching at the Embassy Church. Disturbing accounts of the treatment, of prisoners from the first hand observers were given. Many present felt that the time was overdue for the appointment of the Committee of Inquiry advocated in the pamphlet recently issued by the Howard Lengue for Penul Reform that was mention in these columns a few weeks ago;

THE GUILDHOUSE AND MAHATMA GANDHI Looking down the list of Sunday services last week, I saw the notice of a meeting to be held at Dr. Maude Royen's Church—the subject being "Mahatma Gandhi" and the speaker Mr. Polak. This was well attended and the men and women present must have gone away with a very different impression of this impelling personality.

REPORT OF ALL-INDIA WOMEN'S CONFERENCE The full account of the proceedings, of the Culcutta Conference and the important resolutions that were passed have just reached us. This material has been summarised so that it can be made available for publicity and speaking purposes. Many of the women's organisation—the Indian Conciliation Group and others—are, doing all in their power to make the result of this Conference known in various circles here. The stand taken on the subject of the Franchise is particularly significant. The three women delegates to the Joint Select Committee made a deep impression when they were here last summer and can rest assured of support in the stand they are making from many quarters. A British woman visitor to the Calcutta Conference writes:— "That the women of India are not only determined

to manage their own affairs, but are also eminently capable of doing so, was again amply demonstrated in the All-India Women's Conference. An ontstanding impression left by the conference is of the strength, independence, foresight and efficiency of the senior leaders And there is boundless hope in the large numbers of fervent, zealous, sincere, efficient and emancipated younger women from all parts of the country from whose ranks will come the future leaders of one of the most remarkable movements of modern times".

When Mr. Gandhi was here for the second Round Table. Conference, he constantly referred to the part women were taking and would take in the struggle; for Indian, freedom, , He constantly; psed the phrase "the miracolous awakening of women,", Mr. O. F. Andrews has brought, back, the same impression, his opinion, being that the stand the women are taking an, the communal question, the removal of untouchability, and the great social questions is one of the greatest hopes for the future of India. The reports of the discussions at Calcutta certainly confirm the view taken by the Mahatma and Mr. C. F. Andrews on this subject.

KAUMUDI'S RENUNCIATION

Thas been my privilege, writes Mahatma Gandhi in Harijan (Jan. 19), to witness many touching and soul-stirring scenes during a busy life packed with a variety of rich experiences. But at the moment of writing this, I cannot recall a scene more touching than that of the Harijan cause. I had just finished my speech at Badagara. In it I had made a reasoned appeal to the women present for jewellery. I had finished speaking and was selling the presents received when gently walked up to the platform Kaumudi, a girl 16 years old. She teck out a bangle and asked me if I would give my autograph. I was preparing to give it, when off came the other bangle. She had only one on each hand, I said, 'You need not give me both. I shall give you the autograph for one bangle only.'

She replied by taking off her golden necklace. This was no easy performance. It had to be disengaged from her long plait of hair. But the Malabar girl that she is, she had no false modesty about performing the whole process before a wondering public counting several thousands of men and women. But have you the permission of your parents?' I asked. There was no answer. She had not yet completed her renunciation. Her hands automatically went to her ears and out came jewelled earings amid the ringing cheers of the public, whose expression of joy was no longer to be suppressed. I asked her again whether she had her parents' consent to the sacrifice. Before I could extract any answer from the shy girl, someone told me that her father was present at the meeting, that he was himself helping me by bidding for the addresses I was auctioning and that he was as generous as his daughter in giving to worthy causes. I reminded Kaumudi that she was not to have the ornaments replaced. She resolutely assented to the condition. As I handed her the autograph, I could not help prefacing it with the remark 'your renunciation is a truer ornament than the jewellery you have discarded.' May her renunciation prove to have been an earnest of her being a true Harijan Sevika.

"Greatest Man Of The Epoch"

Through the initiative of Mr. Subash Bose, an Association of Indian students has been formed at Milan. Welcoming the new Association at an inaugural gathering Senator Nantoli said the advent of Indian students at Milan for polytechnic was the beginning of greater relationship between the West and the East. Mr. Bose lecturing on India and Italy expressed admiration for Italy and Fascism and said he considered Mussolini the greatest man of the epoch.

Tata's Charity

It is learnt that the trustees of Sir Dorab Tata Charitable Trust have remitted to the Viceroy half a lake of rupees for earthquake relief work. This was in the little and the little rupees was made!

A Hindu professor at an exhibition of "philosophical control" at Mangalore, Madras, allowed himself to be hanged by the neck, completely buried underground, and run over by a steam roller all without a semblance of hurt or pain. He then went on to wash his hands in concentrated acids, drink the acids, and eat a meal of glass and live coals.

Mr. Devdas Gandhi's New Appointment It is stated that Mr. Devdas Gandhi has been appointed Director of the *Hindustan Times* Ltd. He will also act as Secretary to the Board of Directors of the Company.

Meeting Of Muslims In Lahore

At a public meeting of the Muslims of Lahore held outside Delhi Gate, Maulvi Mohammad Abdulla presided. A resolution was passed expressing anxiety at the ill-health of Dr. Saif-ud-Din Kitchlew and urging the Government to pay attention to his health.

The other resolution was adopted demanding immediate release of the Frontier Gandhi (Khan Abdul Ghuffar Khan).

Mahatma Gandhi's Appeal

MAHATMA GANDHI has issued a world-wide appeal through Reuter's Agency for relief in connection with the recent earthquake in Bibar: "In point of distress nothing perhaps has surpassed the Bibar calamity in India within living memory," he says. "Reluctant though I have always been to appeal to non-Indians for pecuniary help, not from any prudery, but out of delicate consideration, I gladly adopt Babu Rajendra Pravad's suggestion and invite numerous non-Indian friends in Europe, America and Africa and other parts of the world to render such help as they can." He states that the Indians living in different parts of the world will send the utmost they can. He has in mind especially his old friends and fellow-workers in South Africa. And merchants and others living in England and on the Continent Japan and America who are also requested to send their liberal contributions. Mahatma Gandhi has also sent special cables requesting for collections on behalf of Bihar to Mr. Romain Roland Mr Villeneuve (Switzerland), Mr. John Haynes Holmes (New York) Mr. C. F. Andrews (London) and Editor Indian Opinion, Natal (South Africa).

Dr. Rabindranath Tagore has sent the following telegram to the Maharaja of Nepal:—

"I am staggered at the detailed news of devastation of your land. Pray accept our most sincere sympathies in your terrible affliction."

Sardar Vallabhai Patel has written the following letter to Babu Rajendra Prasad from the Nasik Central Jail:—

"Grieved to learn that your province has been the object of a terrible divine wrath. I am helpless. Had I been out, I would have rushed to you at once. My heart has been weeping since the hearing of the distriction on fellow-countrymen of your province."

EARTHQUAKE IN BIHAR

GREATEST QUAKE EVER RECORDED

(BY BABU RAJENDRA PRASAD)

[Babu Rajendra Prasad, the well-known Nationalist leader of Bihar who is the treausurer of the Bihar Central Relief Committee, Patna, sends for publication the following heartrending account of the recent unprecedented earthquake calamity with the following covering letter:

"Dear friend,—I take the liberty of forward-

ing a note on the havor caused by the earth-quake in Bihar. I am also enclosing some cuttings, which will give you some idea of the vastness of the disaster. We are told by experts that it is one of the greatest 'quakes of which record is available and, perhaps, the severest if we take into account the way in which the surface of the soil has been changed in the vast tracts extending over nearly three thousand sonare miles. What were green fields are now converted into lakes (one of which is said to be several miles long) or desert covered with sand. The cost of reconstruction will go into many millions. We are trying only to give such relief as is immediately required to help the people to keep their body and soul together with the minimum of food and clothing and shelter and nothing that may be described as comfort or luxury, and even this which has to be continued until the people are helped to re-start in life, is likely to cost millions. One of our misfortunes is that the magnitude of this great disaster is not known to the world at large and even here in India it was not realised for several days. The stupendousness of the task is being brought home to us more and more as information comes in from those parts which have been inaccessible, or accessible with difficulty, till to-day, 4 weeks after the disaster.

I was ill for more than 6 months and was living in hospital as a prisoner for treatment when the 'quake came. I was released two days after it to enable me to recoup my health but have had to plunge head-long into the work of relief. 'Thank God I am not any the worse for it yet.—Yours sincerely, RAJENDRA PRASAD.]

HE great earthquake lasting for a little over three minutes, that shook India on the afternoon of January 15, 1934, was felt, with greater or lesser intensity, over six hundred thousand square miles, covering an area roughly bounded by Labore on the North-West, Bombay on the South-West, Beawada on the South East, and Shillong on the North-East. But its worst effects were felt in the northern portion of the province of Bihar, over an area of nearly thirty thousand square miles, comprising large portions of the districts of Darbhanga, Mussffepur, Champaran, Saran, Purnes and Bhangalapore, as also the town of Monghyr, when the devastation was most fearlul. The total population of the affected areas is nearly fifteen millions, out of which nearly six bundred thousand people live in towns. Six towns of this area viz, Monghyr (53,000), Musaffepur (43,000), Durbhanga (91,000), Motihari-(17,000), Sitamarhi (11,000) and Madhubani (19,000) have been totally destroyed, while ten others including Patna (160,000), Chapra (47,000), Arrah (49000), Barh (10,000) Bettish (28,000), Samastipur (10,000), Jamalpur (30,000), Khagaria (12,000) Lalganj (9,000), Hajipur (19,000) have aread; severely suffered. In some of these towns practically all the houses have fallen; and a few that are left standing. are in too dangerous a condition to be habitable and these towns present a pitiable sight of one vast ruin a fearful heap of bricks and debris. About Monghyr, the Government metalluigical Inspector says: "An area of two miles long by one mile wide is merely a mass of crumpled steel work, broken beams, smashed furniture, protruding piles of brick-work and debris."

..

Besides the towns, the country side too has been seriously affected, and, in an agricultural country, like ours, this presents a most difficult problems From the standpoint of fertility, North-Bihar has, been among the richest tracts of the country, and just before the earthquake it was laden, with valuable, crops of pulse, wheat, barley, sugar cane, etc., On a modest estimate, over three thousand square miles of such precious lands have been ruined.... Large, fissures and gushers have appeared everywhere, throwing up immense quantities of sand and water, and converting vast tracts into sandy deserts or lakes. The sandy deposits are from 6 inches to 6, feet in depth and at some places they are even 10 feet deep., Practically all the wells have been choked up with sand, many are altogether dry, white others have, only small quantities of muddy water, left in, them., The masonry of a considerable number, of them its irreparably damaged. The number of wells partially or wholly choked or damaged is estimated, to be, 60,000 at modest calculation. The result is that no. good drinking water is available and the villagers have to use the dirty water that may still be left, in the wells or what has been thrown up by the earth; quake. All sanitary arrangements have broken, down and there is an ever-present danger of, epidemics. Standing crops have been greatly damaged, being either covered with sand or flooded with water, and the condition of the sugar cane crops is particularly deplorable. There are fifteen sugar mills in the affected areas and ten out of them have been put out of action. Thus the sugar cane crop, valued at about one million pounds, is in imminent danger; of being rendered useless, unless we are able to arrange immediately for an adequate number of sugarcane crushing mills worked by bullocks, The, opening of the large power driven mills had brought these iuto desustude; and now with the destruction, of these mills, they are suddenly wanted again and, are available with difficulty at such short notice;

The serious disturbance of the level of the earth's surface is causing grave apprehension that rivers might change their courses and there may be heavy floods during the coming monsoon. No work of reconstruction can be taken up till the next rainy season is over, that is not before October next at their earliest. In the meanwhile the suffering of their people is intense. There have been repeated and most severe cold waves, made worse by untimely heavy rainfall. The survivors are living in wretched, improvised shelters made of straw, bamboo or clothy and many have been depending on doles from relief organisations. It was fortunate that the earthquake came in the day time. If it had been in the night,

the mortality would have been dreadful. Even so there have been at feat twenty thousand deaths. Popular estimates put the number much higher and exact figures are still unavailable. It is suspected that thousands of corpses are still lying buried under the debris. Mortality is heaviest among townsfolk, and that too among women and children, who being inside their homes at the time, when men were out at their work, were killed as the houses suddenly collapsed. There has been extensive damage of house property even in the countryside though the mud huts there were better able to stand the shock than the brick and stone buildings in the

The problems before us are various and of a most serious character and must be immediately tackled. Though the roads of the towns have been mostly cleared by Government agency, the houses are still lying in shapeless debris. These have to be cleared and buried corpses disposed of and buried property restored to the surviving owners. Valuable property like jewellery, money, utensils, clothes, etc. must be still lying buried in large quantities. They have to be rescued. Dwellings of a more substantial character than what have been improvised to give immediate shelter, able to stand the rains and last till permanent structures are put up, have to be erected before the rains set in.

The wells have to be cleaned, restored or replaced, so that good drinking water may again be available to the village folk." The destroyed houses, roads, bridges, etc. have to be rebuilt, so that the towns may once more grow up and all means of communication re-established. All lands rendered until by deposits of sand or collection of water have to be reclaimed for agricultural purposes. Humble middle class folk, who have lost their stock-in-trade or business, have to be helped to set up in life again. It may also be necessary for some persons from the villages to migrate elsewhere, if their lands are ultimately found to be destroyed and turned permanently into sandy wastes.

But above all there is a severe impending famine. Whatever the agriculturists in the countryside possessed in the form of stock of grain has been very largely destroyed, being swallowed by the earth through fissures or buried under debris or covered under sand or washed away by flood caused by the large volumes of water thrown out by the earthquake through these fissures. The earthquake came after a rainy season which had caused floods, destroying crops in large tracts. And now what with their stock of grain destroyed, what with their standing crops ruined and what with their land rendered useless on account of deposit of sand or collection of water, the agriculturists in the worst affected parts of the districts of Champaran, Muzaffarpur and Darbhanga are face to face with a famine of a most devastating nature. The population which has to face this calamity in a few weeks is not less than 22 millions. The problem of feeding and clothing this vast population will, far at least a year when some of their lands after the next rains may with the most optimistic calculation be expected to yield some crop; be a stupendous one and the cost will go into crores of rapees. As more information comes in the more gigantic appears the task before

The question of rents, revenues, cesses, taxes etc. has to be settled. Unless these are remitted, reconstruction work and return to normal life will become impossible. One can appreciate the difficulties of Government also. They have heavy expenses ahead as they will have to undertake the restoration of bridges, roads, public buildings etc., and all that will require money. But the people who have lost their all will not know where to get money to pay taxes and rents, for ruined buildings can pay no taxes and ruined fields can pay no rents. Then there is also the problem of the utilisation of the sugarcane crop to which I have already referred.

I have only touched the fringe of the problems; but this will enable friends all over the world to realise that millions of pounds and persistent patient endeavour, extending over a large number of years will be necessary before we can even hope to build up once again what was built in the course of depthries and reined in the twinkling of an eye.

May I hope you will be good enough to publish these facts through such organs of public opinion as you may consider most useful and suitable and appeal to all, on our behalf, for sympathy and sesistance in our dire distress?

Prince George's Visit To Pretoria

Special Treat For Indian Children

The request of the Commissioner of Asiatic Mr. P. F. Kincaid, that an entertainment should be organised for the Indian children of Pretoria, through the Indian Women's Association, has resulted in the Pretoria Municipality deciding to entertain 900 Indian children at Zoological Gardens on Wednesday March 14, the day that H.R.H. Prince George arrives in Pretoria. The committee of the National Zoological Gardens was approached with the request that the children might be allowed to use the gardens for the afternoon, and was kindly given its consent. The Zoo was decided on not only because the children are themselves very attracted to the animals and the gardens, but also on account of its relative proximity to the Asiatic location.

On arrival each child will receive a packet of sweets, and later will be given buns and mineral drinks. On their departure they will each be given an ice. The children will march four abreast from the schools in the location, carrying flags and banners, and will probably reach the Zoo gates at about 2.30.

The whole function will be under the direction of Mr. Pickles, principal of the Indian school, and his staff, and members of the Indian Women's Association, in conjunction with the teachers will be responsible for the care of the children during the afternoon, while several leading Indians have promised their services.

The Zoo caterer is arranging for the refreshments, and tea will be given by the members of the Indian Women's Association, of which Mrs. Bob Maharal is president.




