### To Be Treated As Confidential

7HILE the Indian community in South Africa is awaiting anxiously the report of the Colonization Enquiry Committee learn from the New Delhi correspondent of The Hindu (Madras) that it is quite possible that the Union Government may insist on treating the report as a confidential one and advise the Indian Government to that effect. In fact, says the correspondent, Kunwar Sir Maharaj Singh, Agent of the Government of Iridia in South Atrica has been in communication with the authoritles in Delhi on this matter and it is believed has also communicated the views of the South African Government to the Government of India suggesting the possibilty of the Union Government resolving ultimately to treat the report of the enquiry as a confidential one. The Hindu in an editorial note expresses the hope that the Government of India would protest against the reported desire of the South African Government to treat the report of the Colonisation Committee as confidential. The report in question says our contempory, is a preliminary one and it is intended to be referred to a Commission representative of both the Governments and the South African Indian community. The question whether the Government of India should co-operate in any further enquiry will depend upon the nature of the recommendations contained in the report, and the public in India and the Indian community in South Africa must be taken into the confidence of the Government of India before the latter take any action. The authorities would be assuming a great responsibity if, without consulting the public, they come to a decision regarding their participation in a commission. An opportunity should be provided to the Indian Legislature to consider the various aspects of the problem and the Emigration Committee of the Central Legislature should also be consulted. Such information as has leaked ont regarding the recommendations contained in the report is far from satisfactory from the standpoint of the Indian community. We hope that the Government of India will refuse to be a party to the hush-hush policy evidently favoured by the Union Government.

In all the above cases the applilications were for transfers and a transfer of a licence is considered to be a new licence and an Indian stands the remotest chance of getting a new licence. The Transvarl Municipalities, we understand, are gradually refusing Indian licences on a larger scale.

The Indian community did not like the Land Tenure Act Commission. The Agent of the Government of India who is in this country to see to the proper working of the Capetown Agreement said, 'Tis in the bond' and you shall have to fulfill it. Like honourable men Indians carried out the conditions of the bond. The Indian community did not like "the Colonization Inquiry Committee. The Agent again said: 'Tis in the bond' and like honourable, men the Congress yielded and fulfilled the terms of the bond. The Indian community did not ..like the Assisted Emigration Scheme. The Agent . again said: 'Tis in the bond,' and the Congress Frielded and suffered to see thousands of their brethren leaving these shores to undergo untold Boufferings in India.

Now the Indian community cries: But it is also stated in the bond that "the Union Government firmly believes in and adhere to the principle that it is the duty of every civilised Government to devise ways and means and to take all possible steps for the uplifting of every section of their permanent population to the full extent of their capacity and opportunities and accept the view that in the provision of educational and other facilities a considerable number of Indians who remain part of the permanent population should not be allowed to lag behind other sections of the people." It is also in the bond that in regard to , trading rights "the Union Government will give all due consideration to the suggestions made by the Government of India Delegation that the discretionary powers of the local authorities might , reasonably be limited in the following way (1) the grounds on which a licence may be refused should be laid down by statute (2) the reasons for which a licence is refused should be recorded, (3) there should be a right of appeal in cases of first applications and transfers, as well as in cases of renewals to the courts on to some other impartial vtribunals." The Indian community asks whether these terms of the bond are never to be fulfilled. The Agent in this country we expected would play the part of Portia if the Union Government played the Shylock. But to our utter disappointment we have seen three successive Agents to have watched in quiet acquiescence the tightening up of the licensing and other laws affecting Indians rather "than giving them opportunities for their uplistment to the full extent of their capacity. Not long ago a list of the Agent's achievements was published. Those achievements are like crambs which might go a little way just to keep the body but what he and his predecessors have failed to achieve will destroy the body as well as the soul of the community.

### Black And White Justice

We reproduce the following leading article from The Star (Johannesburg) which gives an idea of two codes of justice existing in this country:—

Several correspondents have written letters to us. both privately and for publication, calling attention to a recent case at Harrismith where a European who killed a native child and was found guilty of culpable homicide was sentenced by the judge-President to six months' imprisonment or a fine of £12. Over a long period of years we have frequently directed attention to the utter inadequacy or excessive severity of sentences imposed by judges and magistrates, in dealing with Europeans and natives, especially in case involving both, but so far there is no apparent improvement and it seems almost futile to continue to protest. And yet if no protest were made it would amount almost to a condonation of actions of which a great many citizens, who are far from being "negrophile," deeply disapprove. South Africa is free from the represch of mob violence and the kind of lynch law which is so discreditable and recurrent a feature of life in the southern States of America. On the other hand we have a "lynch law" of our own practised by individuals, instead of mobs. Also the more serious of these cases come before the courts, and there frequency suggests that the offenders are not deterred by any fear of the consequences. They count upon a jury drawn from their own race and class; and if they are well-to-do they are able to employ the best available counsel for the defence, whereas the prosecution is not expected to do more than state the case against the accused without unduly pressing it. There have been instances where defendinge ounsel has appealed to the jury on grounds which are highly improper in a court of law which is also supposed to be a court of justice. If the worst comes to the worst and the jury, on the evidence, cannot reasonably or conscientiously do other than pronouce a verdict of guilty, the accused hopes for a lenient sentence. It is in this respect that the Bench has a very considerable responsibility. A form of punishment which fits the crime cannot but have a deterrent effect, where as misplaced leniency merely encourages others to do likewise. And if we may judge by the number of cases of murder, culpable homicide or more or less serious cases of assault committed by Europeans on natives, we can scarcely escape the conclusion that there has been a good deal of misplaced leniency.

The particular case referred to by our correspondents is that which came before the Oriminal Court at Harrismith on April 16, when a European named Piet Jansen was charged with assaulting a young native lad in such a manner as to cause his death. The following is a summary of the proceedings:

Evidence was led that Mosea hit another little native over the head with a riem for letting the calf out of the kraal. Accused is then alleged to have hit Mosea with a whip, reversed his grip, and hit him on back of the head with the butt of thewhip, whereupon Mosea collapsed. Accused, however, continued to belabour with the whip. Mosea got up, staggered away a short distance and again collapsed and died almost immediately. The accused gave evidence and stated that the blow in-

)

tended for the shoulders of Mosea accidentally struck him behind the head. The jury returned a verdict of guilty of manslaughter with a strong recommendation of mercy. The judge sentenced Jansen to gay a fine of £12, or serve six months' hard labour.

The "strong recommendation to mercy" is not readily intelligible in view of the admitted facts. In any case the judge was not obliged to act upon it, Presumably he was disposed to agree with it, for on no other assumption can we explain his decision to give the prisoner the option of a fine, and a fine which, in view of the seriousness of the offence, was very small. By way of contrast we have the case referred to by a correspondent in Wednesday's Star. This correspondent, L, du Preez writing from Harrismith, save: "Some weeks ago two native children were each fined £10 for stealing a fowl. Last week a white man in this district was fined £12 for killing a native boy by striking him with a whip several times. The value of a native being just £2 more than that of a fowl, it would be interesting to know what would happen if a white child were clubbed to death by a native."

By way of future contrast, and with special reference to the point raised by our correspondent, L. du Preez, we have the cass reported in yesterday's Star. On the same day at Harrismith a native named Gatebe was charged with assault to commit murder, the complainant being one Marius van den Bosch. The evidence for crown was that Van den Bosch ordered Gatebe to leave at once as he had previously dismissed him. We give the following extract from the report:

The accused man went to his hut, took his clothes and his kerrie, and walked away. The complainant followed him, swore at him and at his mother, and kicked him. He then closed with the accused man and tried to take away his kerrie. The accused man hit him on the head, and when he fell to the ground he hit him again. The complainant could not give evidence of the assault, as he said that this mind was a complete blank in so far as the matter was concerned, and he would not deny that he had first kicked the accused man, and sworm at him before the accused man retailated.

The accusedman, who was not defended, was found guilty and sentenced by the Judge-President to three years' bard labour and three lashes. We have taken steps to ascertain whether our report of the case was a fair summary of the evidence, and we are informed that it is correct in every detail. The contrast between the sentences imposed upon Jansen for culpuble homicide and Gatebe for an assault under severe provocation cannot but create a painful impression upon the puplic mind. We are reluctant, for obvious reason, to criticise our judges, in the performance of their very difficult and arduous duties, but we also have duty to perform, and there are giroumstances in which comment is demanded in the public interest and to satisfy the public conscience. Such occasions have occurred before both in the Union and in Rhodesia, and no doubt will occur again. We can only

hope that as time goes on, and under pressure of a more enlightened public opinion, they will become less and less frequent.

## Germiston Indian Location Petition To Town Council

The following petition signed by about two hundred Indians resident in the Asiatic Bazaar at, Germiston was sent to the Germiston Town Council :-

We, the undersigned, Indians residing in the Bassar of the Germiston Town Council at Germiston pray that you will consider our grievances in regard; to the following matters:—

Our people have lived in this district since the; time of the Republican Government, and, to the best of our knowledge we have never at any time; caused the Council any trouble, in or about the year 1912 we were removed from the residences; to the present site of the Bazaar by the Town Council, and we were then definitely assured that this site, would be set aside as a permanent home and Bazaar, for the community of Germiston; being then out of the way of the European business and thoroughfare.

During the past three years: we have received numerous notices to vacate our premises unless we enter into a form of lease for six months, and subject to six months, notice. So, far we understand no other place has been set aside as at Bazaar in case any of us are ordered to remove from the present site; and no indication is given whether your Council will pay us compensation for our improvements; which have been effected with the knowledge and consent of your Council.

After the receipt of further notices dated sthed 16th March 1934, a meeting was held on the 18th April 1934, which was addressed by the Town Solicitor, Mr. Rose-Innes and by the Location Superintendent and we were then told that unless we sign the form of lease provided we should all be ejected from the Location.

Since May 1933 our usual rentals have been refused by the Superintendent. Legal proceedings for ejectment have been issued against some of us, and we are being forced to these leases by threats of ejectment.

If the Council give us the assurance and undertaking that we shall be given another Bazaar adjoining the Native Location when this Location is removed, in the same locality and at the distance as the present one is from the Native Location, as done in 1912, and will pay us full compensation for our buildings, etc., we are willing to sign the dease.

A number of our poorer members have to trade with the European community in the town of Germiston, and their needs should also be considered, as they will be forced into starvation if the Bazaar ob removed any distance from the town.

We humbly pray in the name of Justice and a Equity to give our case your grave consideration, and earnest and sincere thought, as we are helpless in your hands, with no voice or vote in the affairs of the Connoil; and without any power to advise or criticise in regard to our affairs as a community.

Kipling's Error Exposed

"If one read the translation by Alan Harris of Paul Cohen-Portheim's "The Message of Asia," one could not but come to the conclusion why such books were not translated ere now. This is a grave error on the part of Kipling. In his thesis he goes further to prove; and shows, that as all religion has sprung from Asia to deny Asiatic spirit is to repudiate all religion. One cannot ignore the profound rapproachment which he sees between Europe and Asia by instancing in particular the high honour in which the name of Tagore is held throughout Europe. For many a day arguments of this nature have not come our way and we could safely say how Kipling has erred

### White Child In Native Compound

The wife of one of the European employees of the mine found that an elderly native woman at the compound, was in charge of a little European boy about three years of age. On asking whose child it was, she was informed that he belonged to a native woman. Further inquires elicited the story that the naive in question, who is married to one of the native employees of the mine, was in the Volksrust district and took the child, then an infant in arms, from its mother who, said the native woman, intended to strangle the child; but she persuaded her to give it up to her. Ever since the child had been brought up entirely by this native couple who have treated it as their cwn. They have no other children and the child is well cared for and clothed, but speaks nothing but Zulu. There is no doubt that the child is pure Euro-pead." It is a bonny boy with fair straight hair and is stated to be particularly bright and intelligent.
When told that the child might be taken away from her the native woman was most distressed.

#### Protection Of Wild Birds

By-laws relating to the protection of wild birds in the Borough of Durban have been confirmed by the Administrator in Executive Committee, according to an announcement in the latest issue of the Natal Provincial Gazette. Under these new by-laws no person shall kill, catch or attempt to kill any wild bird by means of any trap or snare or by the use of lime or of any weapon or missile or by any other means or device whatever. No person shall take or remove the egg of any wild bird from a nest or take or remove any nests from any bird. No person shall dispose of by sale or acquire by purchase or barter or otherwise any wild bird, whether alive or dead or the egg of such bird, save in terms of a permit issued specifically for the purpose. Nothing, however, in these by-laws shall apply to the sale of those varieties of game birds which are ordinarily used for food.

#### A Land Of Desolation

My impressions are that what used to be for me a fair land I witnessed as a land of desolation. Mothiari, Hajipore, Lalganj and Muzaffarpore are places which I had visited before. Other places, which I visited this time, I have no recollection of having visited before. In Motihari I, lived, for several months, that being my headquarters during my stay in Champaran in 1917. To see in these places houses after houses, some of which I, knew so well, in a dilapidated condition or a heap of ruins was a heart-rending eight to me. Fields after fields covered with sand showed how difficult life must have become for the peasantry of several thousand acres of, land. The problem of restoring conditions to anything like pre-earthquake days is calculated to baffle the combined efforts of the best workers in the land. In the midst, however, of this desert, it was a matter of joy to me to meet representatives of different relief societies, including those representing the Government Relief Department, and to find, that they were working, more or less, in, consultation with one another, all having one end in view, namely, relief to the distressed people to the best of their ability."

World Buddhist Conference.

After a long discussion the meeting resolved to accept the invitation and decided to appoint , suitable delegates. The World Buddhist Conference is to be held under the auspices of the Japanese Imperial Government.

Smaller Nations Impatient with the smaller Nations' impatience at the delay, in the Disarmament Conference is revealed by a movement led by Sweden, which has comunicated to the League the text of proposals for hastening a substantial convention. Holland, Denmark, Norway, Spain and Switzerland have approved the proposals, which will be considered at the next meeting of the Bureau.

The Swedish memorandum suggests that a convention be limited to certain branches of armaments, leaving a comprehensive solution until later, and postponing naval considerations until 1935.

### The Coming Indian Tour

Doubts regarding India's ability to send a football team to South Africa have been set at rest. The Football League at a meeting decided definitely to make the tour and picked 22 men from whom 15 will be finally sellected.

... Owing to the clashing of dates with the Motherwell tour, the South African Indian Football Association has arranged provisional fixtures for the visiting Indian soccer team. This list in the main will be accepted as final but two of three matches will either have to be cancelled or substituted. The response by the frontier and Eastern Province Associations has been quite satisfactory but the Western Province has sent in a reply which conveys nothing. They are quite prepared to play the visitors and suggest three dates instead of the one allotted them, together with the information that they play on grounds which are not enclosed. The officials seem to forget that this tour involves a great dear of expense and the travelling to Capetown will be a coetly item. The South African Board has written quite definitely on this question and if no satisfactory response is obtained then the fixture may have to be cancelled.
