Swami Adhyanand In Durban

🔁 WAMI ADHYANAND, of the Ram Krishna Mission, who has been delivering very interesting lectures for the last few months before distinguished gatherings of both Indians and Europeans in Johannesburg is due to arrive in Durban on Saturday May 19. We extend to the Swamiji a very hearty welcome and hope that his lectures in this Province will be instructive and elevating to the people in general, even as they have been in the Transvaal. there was one thing which India could teach the world it was her philosophy" observed Swami Adhyanand in the course of a lecture in Pretoria recently. "To-day, in the midst of great crises in different sphere of life, politic, economic or social, India could give ideals which would not merely solve many problems, but would make for co-operation and mutual respect between the different creeds and nations. A contribution which India had made was a synthesis of all the existing religions. India, in spite of her ills to-day, sent out that idea of religious synthesis in thought, and showed warring humanity how real peace, based on spiritual idealism, might be attained. If there was to be any permanent peace in the world it could only be brought about by spiritual ideals. India had a message—the message of harmony among the warring creeds of the world. It did not consist of dogmas and doctrines, but was the experience of the human soul. The Swamiji will be welcomed on Sunday May 20, at 2, 30 p.m. at the Rayal Picture Palace, Victoria Street, Durban, by the South African Hindu Maha Sabab.

THE SLUM BILLS and star break

HE Indian community is much perturbed over the Slum Bill which is about to be passed, into law. In dealing with the question editorially in a recent issue we pointed out to the fact that slums are a disgrace to any civilised country, that it is the duty of every person to assist in their destruction and that we, at therefore, welcome any legislation with that object in view. We also pointed out that those to be affected by the Bill will be mainly Indians and Natives both voteless and voiceless, and extraordinary powers placed in the bands of Municipalities and local authorities are spt to be used unfairly against them The Durban Town Council, afraid of its powers being curtailed under the new Bill, rushed to Capetown to see Mr. Hofmeyr, Miaister of Health, cand the latter has agreed that the present powers of the Borough Council under its public health by laws No. 30, regarding procedure in closing down insanitary buildings, should, under a new section to be included in the Slum Bill, remain intact. The procedure to tackle undesirable housing under this by-law. is far speedier and far more effective than any ofthe provisions provided in the Slums Bill. Section: 29 of the Bill provides that a local authority may make regulations to prevent overcrowding, to control dwellings provided by the local authority, the fixing of the number of persons in certain dwellings, and so

on. The Minister, at the request of the Darban Town Council deputation has, it is reported, agreed to include in this Section 29 a permissive clause to enable a local authority to make regulations to provide for the licensing or registration of all dwellings situated within its area of inrisdiction, such licensing or registration not to be granted unless the owner of the dwellings is in possession of a certificate of approval from the Medical Officer of Health that the dwelling is from a public health and sanitary point of view, fit for human habitation.

While the powers of the Municipelity are thus being increased what protection have those against whom such powers are to be used. It is this that is causing great anxiety to the Indian community. We of course know that there are some amongst us who have known merely to collect rents from their tenants without the least concern as to how they live. But such men are not limited to the Indian community alone. Whatever race they may belong to they will be and will have to be brought to book, But what about those that have a real grievance—whose means are limited, who are hardly able to support themselves and their families. Are they just to be thrown on the streets because they cannot pay higher rents? What protection have they?

While we disagree entirely with Mr. D. C. Burnside, Labour member for Umbile, when he charges the Asiatic with not being amenable to discipline and with finding some means of avoiding the law—the fact has been that though the Indian may have tried to avoid the law, the law has never avoided the Indian—we fully agree with the following remarks made by him:

white men earning six shillings a day how much more difficult would it be to deal with the indian earning 1st od. or 2s. 6d. He had seen as many as air Indians in one room with six sewing machines and six beds, and the floor half ar inch thick, in filth...... There would be no solution of any social problem until we tackled the poverty question. Slums were an assential adjunct of poverty and they were starting at the wrong end by trying to abolish slums while leaving poverty untouched. The call of the stomach was a great deal more insistent and measure Home than that of a better house.

The Indian community fears that this is going to be but another, measure which will, he worked in such a way that it will result in staying them out of the country. As we have stated before we are fortunate in having Mr. Hofmey, as the Minister of Interior who has proved to be very broadminded and we sincerly hope he will consider favourably the representations made en behalf of the Indian community in this connection.

Goodwill Between India And South Africa

Pandit Metha Jalmini In Maritzburg

A hope that goodwill would be fostered between South Africa and India wal expressed unanimously at a meeting of the Natal Debating Society in Christie's tearoom Maritzburg. Dr. Metha Jaimini moyed a motion on these lines in an interesting speech.

Misunderstandings had caused distrust between the Europeans and the Indiaus, said the doctor. South Africans were trying to judge from ability and character of one per cent. of India's people the mentality and character of India as a whole. India was not a savage country—she has been a civilised land when Britain was peopled by men painted in word.

He outlined the work Indians were doing for comptries of their adoption in many parts of the world. Wherever Indians had gone in British; colonies they had by their diligence and honesty served the British to a remarkable extent.

He had heard gladly that the European putlook in South Africa was changing for the better towards the Indians. It was a sign for hope that better feelings was poming. Commercially he held that India eguld be most useful to South Africa.

A spirit of goodwill would be not only neeful to the Indians, but to Europeans, and he hoped to it both races would work towards the prosperity of the country by all means. A spirit of natited co-operation would bring peace and happiness to the country, and he knew the Indians would come forward and do their part for the Empire if ever there was the need.

Mr. John Linforth, the Premier, said that the Jadians in South Africa had no other, country. Then were here to stay, and it was obvious that a spirit of mitual goodwill must exist. Few people had the couries to stand up for their convictions, and he considered that India was to be admired for, producing a man such as the doctor, who was spending his life touring the world and sacrificing his livelihood to approad a spirit of goodwill.

Conneiller A. C. D. Johnston griefed the Papilities, in the vernacular, and announced, that although leader of the apposition he did not intend to appose the motion.

Mr. F. J. Lewis Minister of Lands and Public Works, outlined the disadvantages of Indian trading in South Africa, and remarked that if goodwill was to be promoted in this country the Indian merchant must do his bit as well as the European.

The Rev. Frank Oldrive said that intense feeling had existed in the past against the Indians in South Africa, but he thought that the position was improving. He had been in India at the time and knaw what the position had been. He could sympathise with the bitterness on the part of European traders in combating the wages and keen competition of the Indian traders.

The motion was carried unanimously. (* 1818)

Dr. Mott On Race Problems

At a large and enthusiastic meeting held under the auspices of the International Club at the Bantu Men's Social Centre, Johannesburg, on Monday, May 7, Dr. John R. Mott, Chairman of the International Missionary Council, addressed the meeting.

Dr. Mott, who received an enthusiastic ovation, spoke of the various aspects of the effect of patriotism on the race problems of the world. He said that he thought that patriotism was a good thing, and that the more it was suppressed the more it would be augmented. "I am a friend of the young men and women of all nations," he said. "I have visited 66 countries scattered all over the world, and I find myself at home among the people of every race. I find that the objects of the International Olub will not be achieved by chance. It is culy by sacrificial means that you can hope to fulfil your visions. The race problem is a world-wide one. You are fimiliar with it in South Africa, and we find it also in Europe, Asia and America. One of the chief reasons why the race problem has not been solved is the failure to recognise that it is a worldwide one. The world race problems is of great. urgency. There is a pleasant aspect of the , race question-racial patriotiem. I look upon this as the moving of a higher spirit. You cannot convince me that there is anything develop in patriotism. Another solution to the rapid question has been what is called amalgamation, that is, that we proceed on the lines of least resistance, but I don't believe inthat course. Its very weakness condems it. Others had tried segregation, but this had proved absolutely impossible."

Dr. Mott said that the true solution of the ragial problem lay in Christ's teachings "Love thy neigh," bour as thyenif," and "Love thine enemies." Umisteli Wa Bantu.

Government's Native Policy drait

Attacked By A Former Chief Justice Abouter attack on Government native policy was a made by Sir James Rose-Ipnes, former Chief Justice of the Union, in an address at the annual meeting of the Capa branch of the Joint Council, of Europeans

Sir James said that since Union the spirit of the north had tended more and more to dominate their native policy.

native policy. The keynote of that policy, it is in insight, must have not liberty, but repression," he declared. "The natives are under no circumstances to form part of our policy. They are to be a pegule apart to whom'the privileges of citizenship are to be forever denied. They are to he segregated territorially, politically and economically from the remainder of the population, whom they outnumber by three to one. That this policy can be put into full operation is very doubtful; that the result would be disastrous to our country is absolutely certain. Yet we are told by an energetic and forceful Minister that it is the hall-mark of the new South African culture. He regards it as necessary to the preservation of white significant on civilisation.

We are all agreed that in the interests of black to and white alike the civilization introduced by the white man must prevail in this country, but we think that it would best be preserved by including in its privileges and enlisting in its defence every class of inhabitant, irrespective of race, colour or

oreed. The Minister's policy is the negation of that? ideal. He aims at the dominance of the white man because he is white and the subservience of the black man because he is black. Sir James then dealt briefly with some of the broader aspects of native policy and the extent to which the Cape native franchise is affected by the Status Bill but careful study of the Bill satisfied him that the measure did not go beyond the resolution of the Imperial Conference of 1926, which was approved and ratified by the Statute of Westminster.

Miscrable Share

But since the introduction of white adult sufferage and the tightening up of the registration machinary the proportion of Bantu electors in the Cape province was now in the neighbourhood of three percent. In spite of that, the demand for the exclusion of the native from the ordinary electoral roll was certain to be pressed, not on the grounds of illiteracy or unfitness, but soley on the ground of colour.

"The natives as a body," he said, "are in a condition of dire economic distress and what do they get from the surplus? To them is allocated £78,000. They constitute three-quarters of the population and they are given less than one-fiftieth of the surplus which they have been mainly instrumental in creating." The natives were not adequately represented in the House. 1911

Sir James bitterly criticised the pass laws. The abolition of passes throughout the Union and the substitution of identification certification would save the State much expense, would prevent the mischievous manufacture of criminals, would gratify native sentiment, and would meet with strong support from many perhaps unexpected quarters.

A policy of repression, said Sir James in conclusion, was contrary to the best interests of South Africa,—The Star.

"Miracle Healer" At Ladysmith

Cures Of Chronic Paralysis An Indian's Claims

The Ladysmith correspondent of the Natal Wilness

states:—
"Miracle" cures, which are being effected in Ladysmith in case of chronic paralysis, are attracting wide
interest. Case of paralysis which, years and years
ago, were declared to be hopeless from a medical
science point of view, have responded to treatment
of the new "healer," and limbs that have grown
rigid in a couple of years are now being moved
freely.

The "healer," is an Indian, M. N. Naidoo, and his religion is the cult of the late Mrs. Annie Besant—Theosophy; but it is not on the basic ideals of religion that Naidoo effects his "cures." He claims to practise one of the most jealously guarded secrets known to only medical science of the East. With Naidoo there are no instantaneous cures. Daily, and with untiring patience, he works away in his secluded consulting rooms, skilfully massaging and bringing relief to lifeless limbs. Some days the

progress is slow, but there is always progress, and the patience and practitioner alike are happy.

Naidoo's early work was confined to alleviating the distress of his fellow countrymen, but soon news of his success spread and Europeans sought him out. Bringing cripple and deformed children, they asked for his help and it was given.

I went to see Naidoo to-day to, find out something of his work. Of Theosophy he did not have very much that was new to say. It was just a bland, "There is no religion higher than truth."

But of his "mission"— that of revealing to all who seek to know the potentialities of spiritual progress within themselves—he spoke with enthusiasm.

While there I was one of his most celebrated "miracles." The patience is the 20-years-old son of a wealthy and influential Indian, Mr. M. E. Seedat. In brief, the medical history of the case is as follows: The patience was prematurely born, and after a few months it was noticed that he was a hopeless cripple. His legs were intertwined and grew double up under him, and the arms were interlooked behind the head and the hands were clenched. The mouth was set open and incapable of being closed.

Year after year the child grew and the position seemed to be worse. Medical men who examined the patient stated the case to be hopeless. After 19 days in the hands of the Eastern "healer" the limbs and jaws have now been freed. The patient can move his fingers and for the first time in his life is able to free himself and generally manage for himself. The palate senses have been developed and the patient has been taught to say several words. With the aid of the sciences of his fathers, Naidoo claims to be able to fully develop Seedat's limbs and senses and to have him walking and permanently cured within a month.

The parents, who have wached the apparent hopelessness of the case for the past 20 years, are overjoyed at the progress. Relatives and friends tell of similar "cures effected in their immediate circles.

The Status Bill

Dr. Malan on May 9 at Mooreesburg has explained the terms of the Status Bill, briefly as follows:—

"The King is no longer King of a British Empire which includes the Dominions. We no longer have anything to do with the King as King of England or Canada or Australia, but as King of South Africa acting on the advice of his South African Ministers...

"South Africa is just as free as Great Britain to become a Republic at any time. Therefore we have the right of Secession....

"The King cannot declare war on our behalf,

we must do so ourselves or else remain neutral...
"Under present conditions no Covernment (of South Africa) could fly in the face of the anti-Imperialist feeling which has always existed in South Africa and which exists still. If it did, South Africa would become a Republic within 18 months....

"The passing of the Status Bill does not mean that the agreement between General Hertzog and the Head Committee of the Cape Nationalist Party has been fully carried out....

"One of the points of the agreement was that in future Governor-Generals of South Africa must be South Africans....

"Another point of the agreement was that the right of appeal to the Privy Council must be abolished....

"Thirdly—and this is the most important point—dual nationality must disappear frrom our Statute Book. We cannot be South Africans and British Subjects at the same time. We must be South Africans and South Africans alone....

"I am glad to see that the promise made by General Hertzog in this regard has been repeated during the recent debate in Parliament....

"The new Party must be an embodiment of Nationalism and its principles must be reconcilable with the principles of the Nationalist Party. There must be no restrictions. Any member of the Party who so desires should be at liberty, for instance, to make propaganda for a Republic.

"The Status Bills represent the greatest victory in the history of Nationalism..."

Arya Kanya Mahavidyalaya Baroda

The Arya Kanya Mahavidyalaya, one of the various activities of Arya Kumar Mahasabha was founded in Baroda in 1921. This Kumar Maha Sabha runs the following assistation.

Pandit Anandpriyaji, who is the chief promoter of all the above said activities, has together with his whole well educated family, dedicated their lives to this sacred cause.

Pandit Anandpriyaji, with 22 girls of the said Maha-vidyalaya, has been touring Kenya and Uganda for the last two months, and have visited all the important places. The propaganda work done by them by demonstration and lectures etc. were so facinating that not only the Indian public at all places, but Europeans as well, were highly impressed with the education imparted by this Mahavidyalaya. The party had been everywhere received with cordiality and the present need of proper education was no forcible that the present need of proper education was much appreciated and donations were given liberally.

At Elderet, Barrister Mr. Shaw had been kind enough to preside at the performance of feats. At Jinja the Provincial Commissioner was good enough to preside. When the party arrived at Kampala, a special show was also arranged for Europeans; His Excellency the Governor could not attend owing to illness, but the Hon. The Chief Secretary Major Scott was good enough to preside at the function and the audience was so pleased with the

performance that that they sat spell-bound upto 3 a.m. Even at this late hour Mrs. Scott gracefully distributed the prizes. Pandit Anandpriyaji mentioned on this occasion that his institution was aspiring to see that Indian Womanhood reached the lovel of education in all branches from swimming to flying as is the case in Europe. Mr. Nanjibhai has, over and above his mite of sb. 35,000/has, as voluntary gift to his party, donated Ba two lace to open a branch of this Mahavidyalaya at Porbunder, Kathiawar, his birth place, while other donations from Kenya and Uganda amounted to nearly sh. 150,000/- Major Scott at this juncture declared that he was much impressed with the feats of the girls and with the education given to them and he wished every success in the mission of Panditji saying that it will be a proud day for the British Empire when the Indian womanhood reached the level as anticipated by him. He further laid stress upon the fact that not only the Indian community, not only the Government could be proud of Mr. Nanjibhai, but the whole country is indebted to him.

.The audience was much impressed by discourses given by the girls about the present miserable and pitiable condition of Indian womanhood.

In remembrance of this tour, a nice arch made with two pieces of ivory with a plate with all the names of the girls on tour attached, was presented by Sheth Nanjibhai; a welcome address; in salver coaket was also presented to Pandit Anandpriyaji, on behalf of Arya Samaj of Kampala, Jinja and Lugazi. A gold medai was given to each girl by Sheth Muljibhai, of Messrs. Vithaldas Haridas and Co. Ltd.

A silver flower-vase to each of 4 good speakers (glis) of the party were presented and a silver medal to each of the remaining were given by Mrs. Scott.

When this party was touring Uganda, even native girls were impressed with the propaganda by this party and they were invited by them to their school where they entertianed the party and presented them with their little saving from their gardening work.

After touring through Kenya and Uganda for nearly 6 weeks under the guidance of Sheth Nanjibhai, the party arrived at Lugazi, headquarters of Sheth Nanjibhai, where is situated his biggest augar factory. Here the party stayed for about 12 days and reached Kisumu, which was left out, as the party travelled by special motor-car arranged by Sheth Nanjibhai from Eidoret to Uganda-visiting all the places on the way. From Kisumu this party intends going via Victoria Like to Mwansa and other important places in Tanganyika reaching Dares Salaam in about the middle of May.

The Pannitji desires to extend this propaganda mission to South Africa. And if it can be made convenient for him to do so, he will be reaching in South Africa some time in June.

At present there are some 250 girls studing in this Mahayidyalaya, which can bardly accommodate this number and still there are more than 200 applications for admission. Owing to want of school rooms, the dormitory has to be used for this purpose.

It should be clearly understood that this tour is purely an educational one, with twofold intentions, firstly to see the forign countries and secondly to enlighten the Indian brethren about the quality of education which is imparted by this national institution.

It is hoped that the Indian public in South Africa will consider them their duty to welcome this party and look to their comfort and help them in every possible way.

Profess To Be But Not Christian

It is anti-Christ and the devils of Fear and Greed whom we collectively as a nation worship in fact and deed, and not the Christ whom we call our Lord.

Restoring Peace To Moslems

According to a telegram received at Cairo, in order to avoid fratricidal conflict among the Moslems, the Imam of Sansa has withdrawn from the disputed territory and has asked King Fuad to intervene and restore peace.

Ban On "Esquire"

The Turkish Government has decided that in future, no Turk may use the title of "Bey" (Esquire) or "Effendi" (Mr.). They are considered unsuitable for democracy. The word "Pasha" will still be allowed, as it has a military significance.

"Bey" and "Effendi" were also originaly military words. "Boy" was at first reserved for officers holding the rank of major or upwards, and "Effendi" was exclusive right of captains and lieutenants.

Gradually the two titles came into general use as the equivalent of the English "Esquire and "Mr."

Mussolini Sole Dictator

The Parliament, will pease on July, 1, when Mussolini's Co-operative State is inaugurated. All corporations will remain under the direct central of Mussolini, whose degrees will give, legislative effect to the decisions, of confederations, Mussolini, will appoint the presidents of corporations, and tell them exactly how to run certain branches of industry.

World War Certain In 19401

On his arrival in New York for a two weeks holiday visit Mr. H. G. Wells expressed the opinion that a world war in 1940 was a certainty. Mr. Wells said there were no danger spots in Europe at present and that he was uncertain about the Far East, but by 1940 the world would have made such progress in economic recovery that it would be ready for another major war.

Negroes' Status In U.S. A.

The position of the negro in the United States of America was the subject of an interesting address given by Dr. W. Brown (Professor of Sociology, University of Cincinnatti), in the Unitarian hall. Capetown. The American negro population numbered some 12,000,000, he said, and a man was tormed a negro even if he had the smallest trace of Negro blood in his veins. Among them were many "definite blondes," with blue eyes and fair hair, Socially they were negroes, but automatically they were "whites." Nothing but a sentimental bond connected the American negro with Africa. In his language, ideas, conception of his rights and reli-

gion, he was thoroughly American. In the Southern States the position of the negro was one of traditional subordination. "He still lives in the shadow, of slavery," said Dr. Brown. "Economically and socially he is still in a low-class group, with the white man assuming that this is as it should be, and the negro, in many pages, accepting it as inevitable.? In the South there was absolute segregation of the negro. He was put on the "other side" of the fonce and *as expected to stay there. In the north. however, although a colour bar existed, it was not so sharply defined. The fative competed with the whites in the skilled trades and professions. There were many negro dentists, because white dentists "don't like to probe into dark months," There were many elever negro doctors, ministers, teachers, lawyers and politicians; but, although there were 265

negro ne wanaperain the States, really clever negro journalists and artists were rare. Every year America turned out about 4,000 negro B.A.'s and only 10 per cent of the negro population was illiterate. There was no law against the sex relations of black and white; but there was a law against marriage.

Status Bill And Brilish Pledges

In the course of a debate in the House of Commons Mr. J. H. Thomas, Secretary of State for the Dominions, referring to the Status Bill, is reported to have stated that nothing trising out of the legislation of any sort would preclude the British Government from giving effect to its pledges. Sir Stafford Cripps asked if the Union Government accepted the view and Mr. Thomas replied: "I think I can go so far as to say that they accept that."

The result, of course, did not matter, but the game revealed unsuspected weakness in the City ranks, for example they did not anticipate such a feeble display as that given by the Durban backs and half-backs.
