Springfield Estate Indians

T a meeting held last Sunday under the ausnice of the auspices of the Springfield Estates Committee the tenants of Springfield and adjacent areas ventilated their grievance against the intended sale by the Durban Corporation of land at present occupied by Indian market gardeners, as a training track for race horses and other industrial purposes. The Estates Manager Mr. A. E. Mallison who was appointed to report on the subject has in no uncertain terms referred to the distressing conditions in which about 600 souls, whose only means of livelihood for generations has been to grow vegetables for the supply of Durban and district, would be placed, in the event of the land being leased or sold for the above mentioned purpose. As we have already stated, it will remain for the Durban Town Council now to choose between the importance of promoting the great attraction afforded by the Durban Turf Club and all the evils thereof and the importance of supplying vegetables to every household which is essential for our everyday food supply and which, incidentally, is an honest and the only means of livelihood to hundreds of poor souls. We sincerely trust the Durban Town Council will take into consideration the report of the Estates Manager as well as the cry of the poor and be moved to take the latter course.

Asiatic Question Not An Economic But A Racial Question

The anti-Asiatic propagandists' usual complaint against the Asiatic has been that the Asiatic's standard of living is lower than that of the European and that therefore he is able to sell cheaper than the European and consequently is ousting the white trader. That complaint, however, now seems to have been thrown overboard for at an anti-Asiatic meeting held at Lichtenburg (Transvaal), the other day, one of the speakers, Mr. W Basson of Zeerust, defied any man to prove that the Asiatic shopkeeper sold cheaper than the European If this is true, as undoubtedly it is true, the Asiatic question is no longer an economic question but is based purely and simply on race prejudice; and the wonder

of it is that it has the support of the Christian Church-a sad reflection on Christianity I

Proposed Ban on Non-European Chauffeura

A few days ago the Transvaal Provincial Council passed a motion requesting the Government to prohibit white girls working for Asiatics or Coloured persons. It has now passed another motion by 21 votes to 7 requesting the Government to empower Provincial Councils to introduce legislation providing that Coloured persons, Natives and Asiatics should not be allowed to drive motor vehicles for Europeans.

Free School Books

In the Provincial Council on May 21 Mr. S. J. Smith moved "That the executive committee be requested when framing next year's estimate to give consideration to the question of making provision for the restoration of the system of issuing free school books to children in provincial government schools." Mr. F. C. Hollander said the Executive Committee was prepared to accept the motion, which was unanimously passed.

While this will bring relief to children attending Government schools the position in aided schools, which is much more unsatisfactory, remains unaltered. Parents who send their children to aided schools are having to pay for the supply of books almost double the amount that they would have to pay in Government schools. Steps are badly needed to be taken to remedy this.

G. B. S.'s Advice to South Africa

Mr. George Bernard Shaw in an inter view at Capetown on the eve of his departure from South Africa gave some advice which, we are very doubtful, if South Africa will ever follow. Touching on the Native problem Mr. Shaw paid a compliment to the Natives by saying that they were better mannered than whites and that many of them were more efficient. Referring to the definition of the word Native Mr. Shaw asked: "What do you mean by the word Native? I have met a large number of white people who were born in South Aftica. Surely they are natives?" The only

way, in his opinion, to get over this confusion of terms was for all the races to fuse, said Mr. Shaw who advocated that the barriers between the races be broken down. There were several minor points where the European and Native races differed. There was the matter of polygamy Actually, Europeans were just as polygamous as the Natives, but they kept outside the law, said Mr.

Death Of Mr. M. E. Seedat

We deeply regret to note the sad news of the death of Mr. M. E. Seedat, father of Dr. K. M. Seedat of Durban, which took place on Friday, May 24, at his residence at Newcastle. The late Mr. Seedat was one of the oldest and highly respected residents of Newcastle having gone there in 1888 as a general dealer. The funeral was attended by a large number of prominent Indians from Dundee, Volksrust, Ladysmith, Dannhauser and Durban. We extend to Dr. Seedat and members of the bereaved family our heartfelt sympathy in the irreparable loss sustained by them.

Durban Student Proceeds To England

Mr. Laloobhai Dahyabhai Mistry, a student of the Sastri College, who has passed his Matriculation examination has sailed on Thursday by the Arundel Castle for England to study law. We wish young Mr. Mistry every success. Mr. Mistry was given a farewell reception by the newly formed Gujarati Literary Society.

White Farmer Brutally Assaults Young Native

Christoffel Jacobus Cordier, a young farmer, was found guilty by Mr. L. C. Barret in the Ventersdorp Magistrate's Court of assaulting a native, aged 15, by having him held to a wason and beating. him with a chain. According to the evidence of the district surgeon, the native had ten bruises, a lacerated wound between the shoulder blades two inches long, and another just below, apparently the imprint of a buckle, and a sceptic ulcer on the foot. John Mphute, the complainant, said that on Sunday, April 21, about sunrise, his employer complained that the morning coffee was late and struck him about six

blows with a sjambok. He informed his father, and on the Tuesday they went to Ventersdorp to report the matter to the police. On the way back they were overtaken by his employer, who ordered him to climb into his cart. When they reached the farm he attended to the horses and then Cordier called him. "He told me to pray, because he was going to hit me. He also told me to - take off my clothes." He ran away, but was brought back by another native, 'Michael, who also worked for Cordier. His employer knocked him down three times and hurt his chest and stomach. Cordier ordered him to go into the stable, and another native, Kiewiet, caught him and threw him into the stable. "My baas came with a borsketting (a chain forming part of the harness) and Kiewet put his foot behind my neck. He hit me with a riem and afterwards with a halter. He made me undress and had me held over the railing of the wagon by two natives, and hit me with the borsketting several times.' Cordier sent him to the house, where he called for a trek chain, which he bound to John's right ankle. John had to go to bed with the chain locked to his right foot, the other end being locked to a chest. The chain hurt his leg. The next day the chain was taken off and he was taken to the farm Opraap, some miles

In summing up, Mr. Barret said he had no hesitation in accepting John's version of the assault. "That means that the Court is prepared to accept the evidence of a little native in preference to that given by you, a white farmer of this district. It is a sad state of affairs when that sort of thing happens in a court of law. I wish you to understand that when you come into a Court of law before a magistrate or judge, that magistrate or judge is colour blind. I don't see white or black skins in front of me, and the mere fact that a human being has a black skin does not entitle you to knock him about like an animal. I can imagine the outcry there would have been if a native had treated a European child as you did this little native," Mr. Barrett added.

Cordier was fined £1 or 7 days for assaulting the native with a sjambok, and £10 or one month for striking him with a halter strap and chain.

In comparison with the crime and the strong, though well-deserved, comments by the Magistrate the punishment, we think, was altogether too light. Unless exemplary sentences are passed in such cases we will never see the end of these barbarous acts.

UNION DAY—WHAT IT MEANS TO INDIANS

HE Union of South Africa celebrates to-day its twentyfifth anniversary. It was twenty-five years ago, shortly after the Boer War that the two white races of this country, forgetting the cleavage and national differences, saw that the genuine alternative to chaos, ruin and retardation of national progress was by way of closer union made that union an accomplished fact. Though the raking up of old sores has in recent years somewhat disturbed that spirit of union the better elements have been constantly at work and have successfully counteracted the evil forces, and it is a proud day to-day for all those concerned to feel that they have passed peacefully and successfully a quarter of a century in that happy consummation. Congratulations from all quarters will go out to them and this journal heartily joins in that chorus of congratulations. It seems strange that being in this land and part and parcel of the Union we Indians should be congratulators instead of being the congratulated. But howsoever strange it may appear to be it is so. For how are we part and parcel of the Union of South Africa any more than we are part and parcel of the British Empire? The Union Flag me ns to us Indians nothing more than the Union Jack. We are under both the flags in this country but do we find any protection under either? The Union Flag has a little more awe in it for as, for if we fail to recognise and to respect that flag we might be running the risk of being thrown out of this country a little sooner.

Our point is that while the Union of South Africa means everything to the white races it means very little to the non-whites. The Union was the outcome of the tendency among the white races towards a greater concentration of forces, a greater centralisation of directing

influence, a greater economy of energy. The ideal of a great white South Africa transcended everything. The non-whites of South Africa, though they so largely preponderate in numbers, are regarded as an undesirable element in the picture. This is to be seen in the Union Government's Native policy as well as its Asiatic policy.

Be that as it may. The word "union" has its own significance. "Union is Strength" is an old adage. And it is for that and for the successful achievement of that for twenty-five years that this day is being celebrated as a day of joy and thanksgiving. Whatever selfish motive there may be underlying it the mere fact that that motive cannot be achieved without that union is a lesson in itself.

If the white races of South Africa find the need of union pressing how much more must the Indians, who are regarded, even though born in the sub-continent, as aliens, who can never be absorbed in the general population, who can never be induced to take a responsible share in the development of the State, whoso value as a national asset is profoundly ignored, realise the urgency of the need for combination amongst their scattered units? If we look back to the past we cannot but realise that we have gone at least twenty-five years backward, instead of forward. Communatism which was nil seems now to be growing, the breach between the home-born and the colonial-born is widening, and there is disunity in the community as there never was. It is true we have progressed economically and educationally. But strangely enough that has not improved us morally. It has taught us to imitate all that is bad in the Western civilisation but not to emulate and to develop what is good in our own. All this will lead us to distruction if we do not awake in time.

In order to secure this much needed unity in us, there must be an enormous growth in the spirit of duty animating South African Indians. They must banish for ever religious and territorial differences, and remember that the white South African does not and cannot distinguish between Indian

and Indian. To him all are baseborn alike. And it is in the face of this united opposition from the bulk of South African opinion that Indians must combine, if they value their self-respect, their national honour, their religious ideals It is an arduous task requiring the spirit of renounciation of the self entirely for the greater good of all. This is our message to our Indian brethren on this great occasion of the twenty-fifth anniversary of the Union of South Africa, with the hope that they may become true citizens commanding the respect of this and and the pride of their Motherland.

SPRINGFIELD FLATS INDIAN TENANTS

PROTEST MEETING AGAINST PROPOSED SALE OF LAND

THE Nagri Pracharni Sabha's Hall was filled to its utmost capacity when a meeting of the tenants of Springfield and adjacent areas was held on Sunday last at 2-30 p.m The meeting was called under the auspices of . the Springfield Estates Committee to protest against the proposed sale of land by the Durban Corporation, and to decide what action should be taken in order to safeguard their rather precarious position Mr. R. Heeralall presided and was supported on the platform by the following members of the Colonial born and Settlers Indian Association: Messrs. S. L. Singh, P. R. Pather, P G. Naicker, S. P. Nicholas, M. Beethasee Maharaj and Sewduth.

Advocate Albert Christopher dwelt at great length on the acute position created by the intended action of the Council. He stressed the fact that notwithstanding the sympathetic attitude of the Estates Manager Mr. A. E. Mallison, the Committee should not relax any

effort to place their case forcibly before the public and safeguard their tenancies.

Mr. S. L. Singh spoke in Hindi and exhorted his hearers to work confidently day and night till the present state of affairs was rectified. Mr. P. R. Pather speaking in Tamil said the Corporation's proposed action would bring untold suffering on a large part of the Indians resident in the areas affected, and if they were determined in their efforts the Committee would be able to a large extent to minimise the hardship likely to be caused.

Mr. T. M. Naicker, the President of the Natal Indian Farmers' Association drew their attention to the unfortunate situation, and endorsed the views expressed by the previous speaker, and assured them that they could rely on the efforts of his association in their behalf.

The following resolutions were passed unanimously:

"That this mass meeting of the Indian tenants of the Durban Corporation

Springfield Estates is alarmed at the action of the Durban Corporation in considering the disposal of a large tract of land for a Racecourse, Sewrage farm and Pape Factory in that the land thus affected has been in the hands of Indian market gardeners for a considerable number of years, and has been their only means of livelihood."

"This meeting respectfully appeals to the Durban Corporation to stay the disposal of the land either in freehold or in leasehold and thus prevent the deprivations of the livelihood of hundreds of Indians who from the growth out of the said land now supply a large portion of the City's vegetables."

"This meeting requests the Durban Town Council to grant an interview to a deputation from the tenants to be accompanied by representatives of the Colonial born and Settlers Indian Association and the Natal Indian Farmers' Association."

The meeting then terminated with a vote of thanks to the chair.

PROTECTION OF WORKMEN

COMPENSATION ACT PROVISIONS

THE Workmens Compensation Act, passed in the last Session of Parliament, has been proclaimed and will come into operation on July 1, 1935.

Mr. J. F. Malherbe, the Workmens Compensation Commissioner, who is attached to the Department of Labour and Social Welfare in Pretoria, in an interview pointed out the main implications of the new Act, which repeals previously existing legislation in regard to compensation to workmen. It makes provision for a more libral scale of compensation, including pensions to seriously disabled workmen. In the case of the death of a workman pensions are payable in respect of children who are under the age of 16 and in certain cases to children over that age.

Provision is also made for payment by the employer of the cost of transportation of badly injured workmen to hospital or to their residences and for the payment of medical, surgical and hospital treatment, skilled nursing services and the cost of artificial limbs up to an amount of £ 100. The cost of a constant help, where the workman is unable to perform the essential actions of life, is also provided for.

Native Compensation

Compensation is payable to Natives but on a scale different from that applying to non-Natives.

Employers are prohibited from deducting from the earnings of their workmen any part of any sum which such employers may become liable to pay as compensation.

A Workmens Compensation Commissioner has been appointed to whom all disputes must be referred before these can be dealt with by Magistrates This

officer must assist parties to bring about a settlement of their disputes by agreement and hear complaints from workmen and their representatives or from insurer employers in respect of claims for compensation.

A very important provision is that employers must within there months after the commencement of the Act, insure against the full extent of their potential liability to workmen employed by them. This does not apply to employers engaged in agriculture in respect of workmen employed in agriculture.

of workmen employed in agriculture.

Employers are liable to fine not exceeding £5 in respect of each uninsured workman, employed by them or in default of payment to imprisonment.

Subject to certain exceptions farm labourers and domestic servants are excluded from the provisions of the Act. There are other important provisions in the Act with which employers and workmen are advised to acquaint themselves.

MR. C. RAJAGOPALACHARI

A SHORT SKETCH OF HIS LIFE

Mr. C. Rajagopalachari, an ex-president of the Indian National Congress and an ardent follower of Mahatma Gandhi has decided to retire from public life. The following sketch of his career taken from the "Sind Observer" will, we have no doubt, be read with interest by our readers:

THIN, stooping, hawk-nosed, hollow-cheeked man, a man with coloured glasses, rather carelessly dressed, speaking in a low-pitched voice—that was C R. as I saw him first in the summer of 1918.

I have seen him hundreds of times since then, heard him speak from scores of platforms but somehow the impression of that first meeting lingers in my memory, writes 'Koi Hai' in the Sind Observer.

He comes from the soil of Salem in the South which has contributed two other outstanding personalities to the public . life of India—Mr. C. Vijayaraghavacharya, "the Napoleon of the Imperial Legislative Council" as

he is called and Mr. B. V. Narsinha Iyer who turned his back on a brilliant political career as a result of a series of stunning domestic calamities which made him a mendi-

Rajaji, like Pandit Motilal and Chittaranjan Das, had made his mark as an outstanding lawyer before he flung into the seething whirlpool of Gandhian politics. As a lawyer, his income was nearly Rs. 60,000 a year. Taking a keen interest in the civic politics of his place he gradually became the Chairman of the Municipality.

When He Shot a Man

C. R. was a man of versatile talents. He could handle a gun with as much proficiency as he could handle his tongue Once while travelling in a bullock cart through the thick blanket of the night with a money bag which he had collected as fees in a mofussil engagement he was rudely disturbed in his sleep by a toll-gate man. Rajaji awoke with a start and thinking he was face to face with a gang

of highway robbers he lay hand on the revolver he was carrying and quietly shot the intruder through the head. He was just arming himself to face further assaults when to his horror and consternation, he discovered he had shot the wrong man. Then lifting the man writhing in agony and huddling him in the ostling bullock cart, he nursed him back to health and made a present of the fee he had collected to the toll-gate keeper.

Mr. Rajagopalachari was also a well-known Freemason. Under Gandhi's Spell

How he came under the spell of the Mahatma is one of the romances of Indian history. It appears that this rising lawyer was introduced to the saint in the house of Mr. C. Vijayaraghavachari and it was a case of love at first sight on both sides.

He suspended his rich practice, threw his Freemasonry to the winds, put his firearms into cold storage and marched to prison in 1921. Since then, he has been to jail nearly halfa, dozen times.

As a member of the Civil Disobedience Committee, C. R. had unique opportunities of travelling throughout India and coming into contact with all sorts of men and he recommended boycott of Councils.

Heart and soul, he threw himself into the task of organising victory for Gandhian ideals. It was not the lure of All-India leadership that made him a worshipper at the Sabarmati When a battle royal was being waged at Gaya over the Council entry question, a slim figure clad in homely homespun and wrapped warmly against a chill wind wearing dark goggles, scorched Das and Nehru with a coldly intellectual


lifting the ban on Council entry. Pandit Motilal, usually smiling, got unusually peevish and

speech, shattering to pieces they were trying to establish for

attempted to browbeat the Gandhian crowd and their leader.

C. R. became the butt-end of Swarajist ridicule after Gaya. Das cynically called him the "the Mahant of the Mahatma" while an Andhra patriot characterised him as a part of Gandhi's anatomy. The Bombay Chronicle poured ridicule into his programme in that historic article

It has survived all this scorn and people who scoffed at him remained to pray.

His Determination

Dr. Johnson once said: "I will be conquered but I will not surrender." That is the temparament which inspires Rajaji. He has the courage of a platoon and the intelligence of a higher order. His capacity for augmentation and relentless logic are unsurpassed. His followers rather regard him with admiration than affection. He lacks the torrential rhetoric of Mrs. Naidu, he has not the explosive imagination of Mr. S. Srinivasa Iyengar but for a concise, trenchant, skilful summing up of a

case, either in attack or in defence, he is perfect,

He takes delight in being an intriguer. But many a time, it is not the plotter but the tactician in him that dominates.

There is very little eloquence in him. There may be the hot pungent word, the witty interjection, the solemn assertion which characterise men getting to business and know that facts count. Given will and courage and energy to make experience articulate even ordinary men can change the face of things. C R. has demonstrated this in the recent elections where he hounded the Justice Party from pillar to post and sent it to its doom.

He brings to his politics a sense of effective reality. He wants the standards which make democracy something more than a phrase in a peroration.

His Cynicism

C. R.'s supreme cynicism is a by-word in Congress politics His grasp of the fundamentals of Satyagraha has not profitted him to look upon success and failure with a sense of detachment. He is gluttonously anxious to woo and win the Muse of Success. How a man who is cynical can work himself to this state of feeling is the paradox of his temperament.

His pertinacity is his greatest asset. Gandhiji paid him the highest compliment by saying that C. R. is his only

follower who has studied the non-cooperation movement and followed him intelligently.

On another occasion, when Mahatma Gandhi was appointed Dictator with power to nominate his successor, a prominent leader asked the saint whom he will nominate in case he was arrested: Out came the reply in a flash: "Well, there is Rajaji."

The ex-Governor of Madras, Sir George

Stanley, had an equally high regard for him.

His career is an exemplification of the doctrine that it is sacrifice that makes patriotism a virtue. The virtue is greater in proportion to the magnitude of the sacrifice.

With Gandhiji out of politics C. R. must have felt like a fish out of water. Had he cared, he could easily have become the Prime Minister of Madras under the new reforms. But at the moment of his supremest triumph Rajaji

is turning his back to politics. It is, I think, the deadly routine, the utter boredom of the fleeting glories of a few victories, the aimlessness of Indian politics as is to day that has goaded him to his decision

Out of the seclusion of his Ashram he might achieve greater triumphs, which are of the soul.

He has already begun well with the Bhagvad Gita whose cardinal doctrine is: For work you have the right but not to the fruits thereof.

THE NATIVE BILLS

SOME CHALLENGING QUESTIONS

[Last week we published the criticisms of Dr. Edgar Brookes on the Native Bills, the same is now reduced by the author in the form of questions which gives a clear view of how the Government after considering for ten years intends solving the Native question—Ed. I.O.]

In trying to face the issues presented to the public by the Native Bills, I have been led to formulate them in a series of questions. It is right that those responsible for forming public opinion should be facing and endeavouring to answer questions of this kind. There is a great tendency for us to avoid unpleasant issues, and indeed to treat them for as long a period as possible as being non-existent. These issues, however, must be faced by those who take their citizenship seriously.

Before proceeding to put the questions, I should like to make clear that I appreciate the bona fides of those responsible for the Bills, and the difficulties with which they have been faced. I do not counsel an attitude of non-co-operation with regard to the Bills, but rather that they should be studied with the view of suggesting constructive amendments, and that if, unfortunately they should pass in their present form, they should be accepted and used in the hope of better things later. It is in that spirit of sanity and responsibility that I would ask those interested in native matters to consider some of the questions which follow.

Land Set Aside

- (1) Are you aware that the land set aside as possible native area in the new Bill is virtually the same as that proposed in 1926, and not very different from that proposed by the local committees of 1918?
- (2) Are you aware that in the Provinces of Natal and the Transvaal, land in these released areas may already be brought by administrative provision, and that therefore no material change in the actual situation is introduced by the new Bill?

- (3) Do you realize that the land is not given to natives, nor are they preferential purchasers, but they are merely allowed to compete in the open market with other buyers?
- (4) Do you realize that in the Cape Province the effect of the Bill will be to substitute for the right to buy anywhere the right to buy in a few restricted areas?
- (5) Have you studied the heads of revenue of the new Trust Fund, on which the success of the land policy depends? Do you think that they will be adequate for any progressive land policy?
- (6) What meaning do you attach to the term "segregation"?
- (7) Do you think that a policy which leaves the primary industries (mining and agriculture) entirely dependent on native labour, can be correctly described as a policy of segregation? If not, what is your view of the reliability of those authorities who inform you that the new policy is one of segregation?
- (8) Do you think the new policy as it stands will make any appreciable difference with regard to the problems of economic and social contact?

The Cape Franchise

- (9) Do you realise that the Cape natives have exercised their franchise for 80 years.
- (10) Do you think it conducive to loyalty to the Crown that the King's representative should be faced with the problem of giving his consent to their disfranchisement?
- (11) Do you remember that in 1926, the cape franchise was to be abolished because of its danger to the European public?
- (12) Have you noticed that in the recently published semi-official statement

on the Bills, we are told that the Cape franchise is to be abolished because it is of no use to the natives?

(13) Do you think that both these statements can be true at the same time? If not, which is true?

(14) Do you think that two members in the Senate and six members in the Natives Representative Council are a sufficient compensation to the Cape natives for the loss of their vote?

(15) Do you see any compelling reason why. Senators representing a purely Bantu constituency should have to be Europeans?

(16) Can you understand why the only Chief Native Commissioner's area which is not at the same time a voting area, is the Witwatersrand?

Natal Electoral College

- (17) Have you studied the composition of the Electoral College for the Province of Natal? Do you think it is equitable so far as educated natives are concerned?
- (18) Do you know any prominent native leaders in the province of Natal? If so, can you see any likelihood of their being elected on to the Electoral College for this Province?
- (10) Have you noticed the reference made to a new and more drastic Urban Areas Act to be introduced next year?
- (20 Can you see any reason why this Act should not be deferred until after the Constitution of the Natives Representative Council and the obtaining of an expression of opinion from it?
- (21) Do you think the present suggestions an improvement on those contained in the Bill of 1929, namely six Senators and three Members of the House of Assembly?
- (22) Would you have expected Fusion to produce a more or a less liberal native policy?
- (23) Do you honestly consider the Bills in their present form likely to convince the British public of the expediency of handing over the Protectorates to the Union, -

EUROPE DRIFTING INTO WAR

LEAGUE SERVILE INSTRUMENT OF BIG POWERS

CAUSE OF HILTERISM

VISCOUNT SNOWDEN SPEAKS OUT

CUROPE is drifting into war,"

States Viscount Snowden in an article in the London Daily Mail.

"The international policies which led to the war are being actively pursued now by European nations," he states, "and the result must inevitably be the same.

"The nations are preparing for war in the name of peace. Armaments are being increased to an unprecedented extent and the war provoking pacts are being made. The League appears to have become the servile instrument of the big Powers for the enforcement of their will The Kellog Pact is forgotten The Disarmament Conference merely proved that the nations did not intend to disarm.

"The Allies, after keeping Germany in a humiliating position, were blind to the implication of young Germany's response to Hitler. They are wholly responsible for Hitlerism, Germany attended the Disarmament Conference prepared to disarm 'to the last man and the last machine-gun.'

"They accepted a proposal giving them a large measure of equality in five years. When this was altered to eight years with conditions indefinitely postponing equality, Germany's self-respecting withdrawal from the League of Nations was endorsed by all Germans.

"The great Powers hypocritically deplored this, keeping open the door for a return, without offering different treatment if Germany did return. On the contrary, the Allies lost no opportunity of putting Germany in the wrong and inciting opinion against her. There is no mention of Italy's million bayonets, nor Russia's enormous armies nor France's vast military expenditure and her satellite States.

"The League Council's vote of censure against Germany will surely take its place in history as the greatest act of unctuous hypocrisy in diplomatic history. Though her policies might' be deplored as giving excuses to her ancient enemies, Germany's defiance of the

Treaty of Versailles broke no moral obligation. A treaty signed in the face of bayonets can have no binding equality, moral or juridical.

"Russia plays a sinister game in the Continental Powers encirclement of Germany. A courageous British spokesman at the conversations in Moscow would have reminded Litvinoff that the British taxpayer is still paying 1/6 in the pound for income tax on Russia's repudiated debts.

Mr. Macdonald's attack on Germany in the News Letter makes negotiations difficult indeed. What nation could be kicked into co-operation?

"Britain holds the key to peace; she can lead the nations in the right way if she avoids the error of 1914 and refuses to become the instrument of Continental policy and intrigues dividing Europe into two armed camps.

"Why not make friends with Germany and cease being dragged at the heels of France and Italy? Britain should listen to Germany's rightful claim to equality and even to the claim for colonies and mandates."

SOUTH AFRICAN NEWS IN BRIEF

Proposed Colour Bar For Non-

R. C. G. DU TOIT (Malanite Magaliesberg) moved in the Transvaal Provincial Council that the Council requist the Government to empower Provincial Councils to introduce legislation providing that coloured persons, natives and Asiatics should not be allowed to drive motor vehicles of Europeans. Mr. C. Hofmeyr (U. P., Pietersburg) secondid. Mrs C. C. E. Badenhorst (U. P., Vrededorp), in supporting the motion. declard that there were many Europeans in Juhannesburg who had no work but who would make admirable lorry-drivers. It was high time, she declared, that non-Europeans were forbidden to drive the motor vehicles of Europeans. division, the motion was carried by 21 votes to 7.

Indian Refused Clothing Manufacturer's Licence

Three appeals against the decision of the Licencing Officer came before the Durban Town Coucil at its last week's meeting when in each case the Council dismissed the appeal and upheld its Licensing Officer's decision. In one case Mr. H. H. Kemp appeared for the appelant, Mahomed Cassim Vawda who applied for a clothing manufacturer's licence in Prince Edward Street. Mr. Kemp mantianed that there was no overtrading in the clothing industry in Durban and that the Union spent over £1,000,000 each month in purchasing clothing materials overseas. He quoted the interesting comparative figures:—

Mr. Kemp, after a lengthy argument, declared that his client was a young min and fitted in every way to run the business. The application was opposed by Mr. E. H. Weston, President of Durban

Clothing Manufacturers Association, and Mr. Marriott, representing the Garment Workers Industrial Union. Mr. Weston sald that in Durban there were only three genuine clothing manufacturing businesses, the remainder—95 per cent.—were cut, make and trim firms. There was definite over-trading in the clothing businesse, so much so that number of employees were working on short time. After further evidence the Council adjourned and on returning to the Council coil Chamber the Mayor declared that the appeal was dismissed and the Licensing Officer's decision refusing the licence uphalol.

Indian Interpreter Retires After 34 Years' Service

Mr. Lutchman Morgan Naidoo, the Indian intreprter attached to the Magistrate's Office, Stanger, after 34 years' service, retired at the pensionable age of 60. During this service Mr. Naidoo has been attached to the magistracies of Howick, Marizburg, Dundee, Verulam, Umzinto, and during the last 10 years at Stanger. At a gathering of prominent members

of the Indian community, held at the Government School, the Headmaster on behalf of himself and staff presented Mr. Naidoo with a silver-mounted walking stick, suitably engraved. In the evening a reception was held in honour of Mr. Naidoo at the residence of Mr. P. Peters, also a teacher of the Indian School. At the Civil Court the Magistrate, Assistant Magistrate and staff, together with members of the legal fraternity, Police and Prisons Department gathered to bid Mr. Naidoo farewell. Speeches in eulogistic terms of his services were made.

Friday Night Shopping

Three deputations—two opposing and one advocating the stopping of Friday night shopping in Durban—were received by the General Purposes Committee of the Town Council. The Committee merely listened to the views of deputations, but did not debate the question. It will be considered at the next meeting. Deputations representing the Durban Retailers Association and the Natal Division of the South African Motor Traders Limited strongly opposed the proposal to end Friday night shopping.

Indian Scouts And Guides Rally

The Natal Indian Boy Scouts and Girl Guides Association has organised a fine programme for the Scout and Guide Rally, which is to be held in Albert Park, Durban, to-day. celebration will take the form of sports and a demonstration by Scouts and Guides, and the Unions Silver Jubilee will be commemorated by the presentation of the Union Flag by the Government. The Government will be represented by Mr. H. R. Tesgue, Principal Immigration Officer, Natal. It is anticipated that over 1,500 Scouts and Guides will participate in the celebrations, mainly from Schools in Durban and district. The Association extends a cordial invication to all Indian Schools to join the Rally. The function commences at 11 a.m.

Medicine And Drug Sales To Be Restricted To Chemists Only?

The following motion moved by Col. T. H. Blew (Durban, Beres, Natal) and seconded by. Mr. S. J. Smith was passed by the Natal Provincial Council. "That having regard to the desirability in the public interest of preserving the chemists' profession as a specialised one, this Council requests the Executive Committee to consider the advisibility of making recommendations to the Union Government to introduce legislation to provide (1) that no person or firm can obtain a patent medicine dealer's licence so long as the premises are within one mile of a licensed chemist's shop unless holding a chemist's licence, and (2) no 'dealer within the radius of one raile of a licensed chemist may sell a drug or medicine containing poison unless such dealer first obtains a chemist's licence."

Church Supporting Anti-Asiatic Propaganda

Speaking at a social in Lichtenburg (Transvaal) held under the auspices of the Kultuur Vereniging, Mr. P. Joynt, M.P.C. for Marioo is reported to have said, they at Zeerust realised the danger of the Asiatic general dealer, who was slowly but surely pushing out the white storekeeper. He was glad to say that the church council of the Dutch Reformed Church there had now taken the matter in hand, and the question was being fought tooth and nail. "The Government will not help us, so we must save ourselves. I call on you to combine in this great issue, and I am sure we will be victorious." Mr. Joynt further stressed the fact that town councils could definitely refuse the granting of new licences to Asiatics, and he called upon councils to use this weapon wherever and whenever they possibly could. Mr. W. Basson. of Zeerust defied any man to prove that the Asiatic shopkeeper sold cheaper than the European. He further pointed out that if the Asiatic stores were rep'aced by white shops the spectacle of seeing white men on the road working with pick and spade would be rare, and employment could then be given to thousands. The "Reddings Bond" was making considerable headway. Already 110 branches had been established over the Transvaal, with thousands of members. The result had been that as their support was denied to Asiatic storekeepers, quite a number had already closed. In thanking the two speakers, the Rev. T. D. Potgieter said that Lichtenburg was aware of the Asiatic trader menace, and the publie here was devising ways and means to fight this common danger. Mr. P. Roux who presided, stressed the fact that the Kultuur Vereniging was non-political. It was decided to establish a branch of the "Bond" in Lichtenburg. The Rev. C. S. van H. Steenkamp was elected president, and Mrs. G. Bosman, secretary.

A Lecture On "British In India" By Dr. Roux

The M. K. Gandhi Library, Durban, was crowded on Wednesday afternoon, May 15th. On account of the interest evinced in Mr. E. Thomas' lecture the previous week, a large number was present to hear Dr. E. R. Roux, M.Sc. (Wit.) Ph.D. (Camb.) speak on British Rule in India. Dr. Roux dealt with the subject extensively and the efficient manner which he spoke, was certainly convincing proof

of his wide reading on the subject. He dealt with the historical, social and more important, the economic aspect of the British bogey in the East. Economically, it was pointed out, a minimum of 75% of India's revenue was exhausted in the maintenance of the British Army and Navy in India as well as the pensions that were annually drawn from the same source. British Civil servants, a short while prior to their retirement were transferred to the Indian Civil service, and, in consequence, drew pensions, on retirement from the coffers of the Indian Exchequer. The so called Hindu-Moslem antagonism, too, Dr. Roux said, was not a real problem, but was grossly exaggerated as an item in British propaganda and was instigated very often, consciously or unconsciously by the British in India. Gandhi and the Passive-Resistance movement which he advocates, also came in for a certain measure of criticism. The lccturer felt that the best way of securing an independent status was to win over, the Indian sepoys to the side of the Swarsj party. Then, it was averred, the British would be in a futile and helpless position. Then again, would Indie, freed from the yoke of British Imperialism, be entirely free? The lecturer's views were in the negative. An India purged of British Rule would still ba a slave to the Indian Capitalist. The leture was intensely inter sting and provocative in the extreme, and a good deal of interesting discussion ensued. The lecture was given under the auspices of the Durban Indian Youth Movement, through the instrumentality of its president, Mr. Geo. Singh, Mr. George Bernard Shaw was present.—Con-

MAN CAN MOULD HIS DESTINY

POET TAGORE in the course of a discourse on the Bengali New Year's Day said:—The primitive man started his career with the false fear of an angry God and made before him offerings of blood by sacrificing not only animals but the lives of men as well All sorts of bloody rituals began thus to be practised to appease the relentless Divinity till there dawned on man the truth-greater than the mere biological fact of his life-that he has within him the power to conquer his fear and reveal the Invinsible man in him, the Hero, to whom the sorrows and sufferings of the world are only opportunities of proving his power to transcend them in his effort towards the fulfilment of the highest possibilities of his terrestrial existence. It is for the animal to remain satisfied with the mere acceptance of facts. But to man is given the privilege of creating those facts which build his history and civilisation. He is also given the vision of looking beyond and looking longer, the vision with which he can mould his destiny in whichever way he likes. The message of the New Year cannot be anything other than a call to us for renewing our endeavour to realise the truth of our life that man has in him a soul, eternal and indistructible, the source of light, power and bliss.

INDIA'S CONTRIBUTION TO THE WORLD'S PROGRESS

"It would be very difficult to visualise. the conditions of the World to-day had it not been for the civilising influences of ndia. India has been the birthplace of civilisation. An Indian made this claim on behalf of his country in an address in Selly Oak Institute recently when Mr. Sayed Abdul Huck discussed 'India's contribution to world progress,' Indian civilisation, he said, must be some 6,000 or 7,000 years old. He pointed out that sanskrit, the old Indian tongue, was the mother language of many modern languages "One of the greatest achievements of the Indian people was their social and political organisation and magnificent economic system. Even to-day the Western countries have not perfected their social and political organisation to the extent that the Indian people had perfected theirs some 3,000 years ago. You say that we in India are being tutored into democracy by the British Government and that when we are fit to take over we should be given self-government. But we were the fathers of democracy, much before Rome knew anything about civilisation. Rome is of yesterday compared with the civilisation of India." India had in the past the

great advantage of being practically immune from taxation. All modern sciences came from India—mathematics medicines, and surgery, chemistry, metallurgy, astronomy, architecture. The greatest contribution of India, he asserted, was in the world of spirituality. India was the most peace-loving country in the world.

INDIA BILL PROGRESS

The Committee stage of the India Bill will, it is anticipated, be completed in the House of Commons this week and there will be a general debate on the Third Reading on Tuesday and Wednesday next week. The Bill will then be sent to the House of Lords, where the formal first reading will be taken before the Whitsuntide recess.

'NEW INDIA' WILL BE REVIVED

The United Press learns that Dr. Annie Besant's defunct New India is being revived by Dr. Arundale who succeeded Dr Besant as president of the Theosophical Society. New India will appear as a political weekly under Dr. Arundale's editorship as the official organ of the Indian National League of which Dr. Arundale is the president. It might be recalled that the Indian National League was innugurated in last X'mas whose main object is to evolve a Swadeshi constitution for India

MANAGING EDITOR OF "THE PIONEER'

The proprietors of *The Pioneer* Lucknow, announce that Mr. Desmond Young, a wellknown figure in South African journalism (at one time the Editor of *Natal Witness*) and who was a delegate to the Empire Press onference in the Union, has been appointed managing editor of *The Pioneer*.

JUBILES OF FERGUSON COLLEGE

Sir C. V. Raman delivered, before a large and distinguished gathering of about 5,000 people an illuminating address, in connection with the celebration of the Jubilee of the Ferguson College, Sir Chandrashekhar, in the course of his speech, stressed the necessity of changing our national outlook towards life and of bringing about a reorientation in our educational system and the relations between the teacher and the taught. Mahatmaji in his message says: "I wish the forthcoming function every success. This is all I have time to send you."
