NOTES AND NEWS

The Whites In The Incorporated Areas

URBAN Corporation has issued over 750 writs of attachment to residents in the incorporated areas for failure to pay rates These writs have been mostly served on people for arrear rates since incorporation took place. The Corporation is empowered to issue writs and sell the property of persons who are more than two years behind in the payment of rates. The total amount of arrear rates outstand ing is approximately £6,000. These writs mean that if residents fail to meet the Corporation demands they must face the possibility of having their homes sold up Indians form a large proportion of those who are in arrears with their rates. The European residents of these areas are very much agitated and Mr. H. Wynne Cole, vice-president of the Umhlatuzana Civic Association and Mr. A, L Barnes, chairman of the Outer Areas Combined Wards' Association have raised a protest. Their contention is that many of them simply cannot pay. An instance of one is quoted whose sole income was about £2 10s a week out of which he had to provide for his family and normal living costs. Such cases it is said could be multiplied many times. If Europeans are in such distress might we not ask how much more difficult the position of Indians must be whose income in many cases, is not even so much as £2 108, a month. And besides they have no way to make their voice effectively heard. Perhaps their distress will now be better realised.

"A Boroug Duty"

The following letter by Mr J. R. Currie appears in the Natal Advertiser:
Sir,—You know as well as anyone that I am not a champion of Town Councillors, more of a critic, but I do object to your leading article in Monday's issue. It is the custom now for educated Indians and Natives to rush to newspaper offices with garbled stories of current events, and one cannot expect editors to run about investigating, so they are largely dependent on what they hear. You ask, "do we realise that had such a calamity come about, the deaths of its victims would have been on the

heads of this community." You say they live where they do, because they have no other choice I say they do not, because all those Indians who live on the banks of rivers and on swampy ground were time-expired indentured Indians (I know them all) who had been offered double their contract wages in my presence and were often urged by me to accept the certainty offered them, rather than the uncertainty of life and comfort in reed shackles or tin shanties. They know the risks and dangers and accepted them and settled down to lives of industry and thrift, just as I did when refused a magistracy because of its hackle. Because they eject to live in at mainer in competition with Euroans is no reason for you to charge us th manslaughter and neglect of human impathy. Those poor Indians do not charge us with such a crime, they are content to suffer in silence, knowing full well that we shall do what we can for them after the wealthy Indians who batten on them have done their duty.

Would Mr. Currie then like to suggest that because the poor Indians, all of whom he knows, refused to remain in shackles as he had desired them to do, they deserved their fate, and that the Borough owed no duty to an independent people, who lived thriftly and proved themselves to be useful citizens, notwithstanding the fact, the Borough took every possible advantage of them? We cannot imagine anything more inhuman.

Johannesburg Mayor Entertains Great Hopes

At a reception given recently in honour of Sir Sayed Raza Ali, Agent of the Government of India, by the Indo-European Council, Johannesburg, Mr. Maurice Freeman, the Mayor in the course of his speech expressed the hope that "very great strides will be made towards equality, politically speaking, of the different sections of the people inhabiting the country." He said that, as he saw it, the question that was known a few years ago as "the Indian problem' did not exist to-day, certainly not to the extent that it had then appeared to exist. Looking forward with great hopes, to the report of the Asiatic Land Tenure Commission, "engaged for many months on a vast work,'

Mayor welcomed the possibility that as a result of that report, the Government would be able to legalise not only Indian occupation of land, but also ownership. The fact that Indians forming themselves into a company might possess land while an individual might not was an anomaly. He trusted that this and others, would soon be swept away, and that the Indians, not only those who were bern in this country, would in all circumstanc; c regarded as nationals of the Union.

We wish we could share to hopes of the Mayor. But we do not see the future of Indians to be as bright as he does when the Johannesturg and other Town Councils are considerably refusing their trading licences, which is the only means of livelihood they have.

Mr. Pirow's Asiatic Policy

Mr Oswald Pirow, Minister of Railways and of Defence addressing a meeting at Ermelo (Transvaal) in reply to a questioner, said that he personally had always felt, and still advocated, that legislation should be passed to prohibit European girls from accepting employment under Asiatics. The trouble was that all the members of the Government and members of Parliament did not share that view with him. It seemed to him that it was really a matter for public opinion. The public should settle also the matter of buying from Indians. That too was not a matter for the Government, but South Africa was "a nation without organisation and without discipline

Very Clever Of Motor Transport - Workers!

A resolution addressed to the Trans vaal Provincial Council urging that only Parliamentary voters be allowed to obtain commercial transport vehicle licences was passed at a meeting of motor transport workers which was held in the Labour Party Club, Johannesburg. If this proposal were enforced, it was explained, it would do away with competition from natives and coloureds "

A very clever suggestion to the Provincial Council to prohibit with one stroke of the pen non Europeans driving taxis, buses and other motor vehicles for commercial purposes and to give the motor transport workers a monopoly of the trade. We cannot imagine the Provincial Council taking this suggestion at all seriously.

TOO LATE IN THE DAY

CONFERENCE was recently held in Pretoria under the chairmanship of Dr. P. J. S. de Klerk, to consider the question of native education and the relations between black and white in his country. Though this question does not directly touch the Indian community it is an important question of race relations and in that light we would not be out of court to make a few observations. The views expressed at the conference could be summed up as fo lows: "The white man had proceeded systematically to enforce his culture on the natives regardless of its suitability or otherwise. In the course of time the natives had come to think of their language as being of secondary importance, and while they were learning to conduct the business of everyd y life in the white man's languige their own was being hopelessly neglected. The native should be taught his own language, he should not be made a white .. man; he should be segregated and allowed to develop along his own lines; the worst mistake had been made in taking it for granted that the white man's civilisati n was the best for the blick man; this was clearly not the case and irreparable harm had been done by this assumption."

The waite man of South Africa seems to us to be waking up too late in the day, or is it not selfishness that is making him believe to be. a mistake which might possibly not be a mistake? He is regretting now that he ever brought his culture and civilisation to the native. Why is he regretting it? Because he finds him gradually becoming his equal in intelligence, in manners, in his mode of living and in everything else but in colour. The white man seems to worship more tuan anything else his colour and in that case would it not have been wiser for him to have kept the Bible which is responsible for having brought culture and civilisation to

the black man to himself. if the Bible was not brought to the black man and in its trail culture and civilisation of the white man the millions of black men would not have learnt to use forks and knives and to wear clothing and would not have acquired the capacity to spend; and then how would the white culture and civilisation have survived? Viewed in this light it becomes difficult to decide which was a mistake-to have brought civilisation to them or to have kept them in their primitive state.

In any case this consciousness has come to the white man too late in the day. He cannot have it both ways. A teacher who teaches his pupil cannot expect his pupil to remain always his pupil. Quite possibly the pupil might surpass his teacher and become a teacher himself. It would be futile for the teacher to regret such a state of affars

Another mistake the white man of South Africa is constantly harping on is that of having introduced the Indian into this country. Here again he did not introduce him with any philanthropic motive. The Indian was introduced as a cheap labourer to develop the land. It is only after he has been made full use of that it has dawnedon the white man that he made a mistake in ever introducing him. However this is by the way. To revert to the subject of the relations between the white and the black in this country we are reminded of the novel suggestion made by Mr George Bernard Shaw of intermarriage. We may laugh and jeer at G.B.S. and take him to be unhinged for making such a henious suggestion. But there is a great deal On the ground of race purity it might be argued that the time has not come yet to go the extent that G.B.S. has suggested though it is, of course, a question as

to what will be the deciding factor of race purity, colour or character. If it is to be character, the above argument holds no water and one need not be shocked to see Shakespeare's Othello depicted in its reality. However leaving aside for the moment the question of intermarriage we do think the time has come for the white men to throw aside their colour consciousness and if they truly profess Christianity to treat on a basis of equality all human beings irrespective of their colour. If the white man has failed to grasp or has forgotten Christ's teaching he might perhaps find those to whom he has brought the Bible following it in its true spirit and becoming an example to the white man. It is a forlorn hope for the white man to succeed in any attempt to make the black man unlearn what he has been taught.

St. AIDAN'S INDIAN MISSION HOSPITAL

HE spacious new buildings of the St. Aidan's Indian Mission Hospital which are now ready will be opened by Her Excellency the Countess of Clarendon on Thursday, July 4, at 3 p.m. As we have stated before, in the absence of proper treatment at the Government Hospital and of a national hospital of its own the St. Aidan's Hospital has been a blessing to the Indian We heartily concommunity. gratulate the Mission on the fulfilment of the great task it had taken on its shoulders-that of raising £7,200 for building the new premises. It is only another proof of what can be achieved if there is the will and the energy to be incessantly We un terstand that the question of equipment now remains and that though some kind friends have helped in this connection in kind the sum of £200 is still required. This seems too insignificant a figure in comparison with the great work that has already been achieved and if only a few generous friends were to come to the rescue there should be no difficulty in realising it. We hope that it will be realised.

WORKMEN'S COMPENSATION ACT

DETAILS OF CONDITIONS FOR EXEMPTION

THE conditions subject to which employers will be granted exemptions from taking out policies from insurance companies under the Workmen's Compensation Act are published in detail in the Government Gazette dated June 21.

An employer wishing to be exempted must apply to the Commissioner on a prescribed form and shall furnish full information regarding the fund to be established and maintained by him for compensation purposes, in terms of Section 74 (2) of the Act.

The employer will have to pay £5 a year for the exemption certificate, but if application is made after June 30 of any year the fee will be £2 10s. The certificates of exemption will expire at the end of each calendar year.

Every exempted employer shall pay to a Receiver of Revenue a sum of money equivalent to 1 per cent. of the total amount which he would have paid during the year had he taken out policies with an insurance society. This amount must be paid not later than 30 days after the end of each calend it year during which he has received exemption. The actual amount, calculated on the basis of the tariff of premiums charged by assurance companies, shall be fixed by the Commissioner.

Should an employer not wish to renew his certificate of exemption after its expiration, he must give notice to the Commissioner not later than September 30 of the year of issue.

Before a certificate of exemption is granted to any employer he will have to deposit with the treasury cash or securities approved of by the Minister to the value of £5,000. This applies to the first year or part of a year during which he is exempted: Thereafter he shall deposit no; later than January 31 in each year cash securities equal to the habilities of the employer as at December 31 of the preceeding year.

This will be calculated as follows:

(a) An estimate on a basis to be laid down by the Commissioner of the capitalised value of pensions payable by the employer under the Act; (b) An estimate on a basis to be laid down by the Commissioner of the amount required in respect of outstanding claims payable by the employer under the Act; (c) A sum to be determined by the Com-

missioner but not to be less than £5,000.

After an employer has ceased to be exempt from the operation of Section 74 (1) of the Act he will still remain liable in respect of all obligations to his workmen which have arisen or may arise in respect of the period during which he was exempt, and the amount of cash or securities deposited by him will not be released except in reduction of the liability of the employer, proved to the satisfaction of the Commissioner.

Any balance will be released upon proof that all liabilities of the employer have been discharged

Whenever compensation is payable by an exempted emloyer in a lump sum of money exceeding £200, or in the case of a minor £50, he must notify the Commissioner of the fact and furnish him with all available information of each case. Before making payment he shall await the directions of the Commissioner.

Every exempted employer must send to the Commissioner before January 15 in each year a certificated copy of his accounts, with a statement of pensions payable by him under the Act, a statement containing details of outstanding claims at December 31 of the preceding year and a statement on a prescribed form of wages paid during the preceding calendar year.

Exempted employers must further send to the commissioner within 14 days after the end of each month returns on prescribed forms, showing all claim payments made by him during the month.

Should an exempted employer fail to meet any claim for which he is liable under the Act, the Commissioner will have the right to withdraw from the deposit made by such employer whatever is necessary for such claims

Exempted employers shall keep all accounts and records of payment made by him in respect of workmens compensation separate from the records of his other business transactions.

The Minister of Labour, Mr. A. P. J. Fourie, in an interview gave an assurance that the public would be properly protected by the Government against whatever was regarded as unreasonable in the Workmen's Compensation Act.

The Minister said that the insurance companies were required to submit their scale of tariffs to the department.

"The scales will then be scrutinised by responsible officials, and if it appears prima facie, that these tariffs are unreasonable the Government will make representations to the insurance companies to have them rectified."

Mr. Fourie pointed out that they would be in a much better position to judge after the Act had been in operation for a year, and if it was found then that there were anomalies it would be necessary to have them removed.

ALTHOUGH Krishnamurti is not yet known to the masses in South Africa, he is nevertheless universally realised; yet his thought must be brought to everyone who thinks, for his Message of Freedom and Happiness compels Truth.

Liberation and Happiness through Truth is his slogan, and he tells us that he has attained it and that we may one and all attain it. He is out to set men free.

He has not come to proclaim this or that truth, but aims at letting us know that no personal God should govern our lives; no duty nor loyalty to anyone however great the spiritual authority, should turn our minds away from the true path of the Freedom of the Self.

"The goal for all human beings is Happiness," he explains. "There is no true happiness to be found in transient things. It does not depend upon outer circumstances, but on inner realisation. It must be achieved by every one for himself, by the attainment of individual perfection. Intelligent revolt is the means of reaching that freedom, and man must listen to no outside authority, finding that realisation himself."

He would have us know, and he makes us realise that no creed, authority, nor any roads made by others is necessary for one's own understanding, and that each of us should have this understanding, and courage to follow ourselves.

"To create greatly, to create lastingly, you must understand, and so I say, "Do not follow, do not obey, do not be loyal to any person except to yourself, and then you will be loyal to every passer-by."

This indeed is a great truth, and the best. Our own inner experiences should be "church" to us, without creed, without tenets, minus all illusions.

Always and everywhere Krishnamurti stresses the individual touch, not because he preaches individualism as many people think who have not grasped the Message, but because he looks for perfection in the individual, so that the individual can solve his own problems and in so doing create true order

and harmony in himself and around others, thus automatically solving the problems of the world in a truly enlightened and effective manner.

We are so s ayed by high people in the high places who have power. In other words: we submit to authority and prefer to be led by somebody we ourselves appoint above us. Individualism is so seldom expressed because we find it easier to be led by someone whom we think knows more—by a preacher, a philosopher, a Theosophist even. Krishnamurti stresses the breaking away from all that—it is second-hand at most,—and urges us to develop our own "individual uniqueness" and to

"stand in our own strength." We must be unfettered, creedless, free. Be free and of a fine courage! How much farther we could go, how much finer we were if we freed ourselves from set laws and rules, mass production ideas and ideals made by other men, for in matters spiritual there can be no laws, no set paths to follow. Yet we sit still and prefer like sheep to play a sort of "follow-my-leader" game; but there is no courage in these ideas and beliefs and it does not give one a chance to live life fully and effectively.

In his "Pathless Reality" we get the great thought of Krishnamurti, stressing that every man must act for himself to

attain human perfectibility and the Kingdom of Self. "The 'strug-le is 'purely an individual matter," he says 'I cannot tell you how to struggle; I cannot create for you new systems which will guide you in your struggless, nor give you comfort. You must be men, strong and free, not children always seeking shelter."

We must travel the Open Seas of Wisdom on our own feet, and the travelling must be done by oneself-alone. What is our direction to be and whither the destination? The Voice of Intuition will direct you and Life is the Goal. Take Life's experiences for development and listen to that small still voice within, which is Intuition. That is your only true compass to follow, but you must know how to read it, and many of us do not, especially when we begin to think about these things for the first time. Impulses, desires and cravings clammer for attention, but Intuitiont is not that. It is something peaceful, certain and impelling which acts instantly and truly when we have purified our minds and hearts.

Krishnamurti has come to give Light to a world in choas and darkness, and by his illuminated mind all problems are made clear. Let in the light which Krishnamurti brings and live life bravely. He has come like Moses to lead his people out of the retrograde world of materialism into a land flowing with milk and honey. The Jews did not accept Christ because they had not followed Moses. We will not understand Krishnamurti if we have not understood Christ; for what use is it for any to expect to understand a New Teaching if they have not understood the previous old.

Christ is the the Saviour of the Western World of civilization, Krishnamurti leads on the new race to its zenith and will save the world from its materialism and the powers of Satan—ourselves—once more. Egotism, selfishness, materialism, capitalism, geeed, industrial slavery, competition, etc. are all on the side of Darkness, but the New Race will be altruistic, truly, enlightened and of sound knowledge—not belief—showing mercy, freedom, love and co-operation, giving true happiness in the place of boredom and sorrow.

MASS MEETING OF INDIAN FARMERS FLOOD RELIEF COMMITTEE FORMED

The Tamil Institute, Cross Street, Duban, was a venue of a large gathering of Indian farmers from all parts of the Country on Saturday morning June 22. The Meeting was convened by the Natal Indian Farmers' Association and the Chair was occupied by its President, Mr. T. M. Naicker, supported by the Secretary Mr. A. B. Naidoo, the Treasurer, Mr. B. Maharaj, the Auditor, Mr. M. Y. Nainaar and other contracts.

Amongst other interested were Advocate Albert Christopher, and Messrs, P. S. Aiyar, C. R. Naidoo, and P. R. ather.

The President of the Association dwelt at length upon the distressing conditions in which the farmers were placed to-day, having suffered serious losses owing to the recent rains and flood. He said that the Indian farmers and the market gardners were the major sufferers and were now in great plight. Roads and transport facilities added to their difficulties and were now faced with ruination. At present there were

no provisions for relieving the distress in the differnt districts, hence it was necessary for the constitution of a Com mittee for the purposes of considering relief measures.

He was followed by Advocate Christo pher, who stated that the farmers had been the greatest sufferers and the formation of a Committee was very desirable and that concerted action should be taken, which was supported by Mr. P. S. Aiyer, who urged that the farmers should leave no stone unturned to protect the rights of their existence. He was aware that the conditions were appaling that it did not only deserved the sympathy but also the support of all well-wishers.

The matter was explained to the audience in the vernaculars and the following resolutions unanimously adopted.

"That this Mass Meeting held under' the auspic's of the Natal Indian Farmers' Association hereby resolves, that a Farmers' Flood Relief Committee be formed with power to Co opt or to Co-operate with other representative. Institutions and do everything necessary for the relief of the distressd."

A Committee of farmers was constituted representing the following Districts-

Sea Cow Lake, Newlands, Springfield, Clare Estate, Umgeni, Prospect Hall, Clairwood, Wentworth, Merebank, Isi pingo, Cato Manor, Stella Hill, Westville, Umhlatuzana, Escombe, Sea View, Cavendish, Umlass, Shallcross, Marrian-Hill, Wyebank, Kloof, Inanda and New Glasgow.

The Committee proposes to sail into action immediately and a fervent appeal is made to the public for its generous support.

EFFERING to anomalies in regard to legislation affecting Indians indicated by the Mayor of Johannesburg at a recent meeting of the Indo-European Council, the Agent of the Government of India, Sir Sayed Reza Ali said that the Aga Khan had been spending a portion of his millions in England and France. Was there any reason why His Highness should not spend some of that money in South Africa? There was this difficulty: if the cultured and wealthy Aga Khan wanted to come out to this country he would have to apply for a permit, and if a permit was not issued he would not be allowed to land in Durban or Capetown. When spplying for a permit, he would also have to state how long he intend to stay in the country. Among other recommendation of the sub-committee are: "All buildings to be erected in accortance with etock plans prepared together with estimated costs by the Borough Engineer, or to approved plans submitted by applicant; The Borough Engineer shall juvide public tenders at least once a month for the erection of such buil li ga; all contra tors irrespective of race shall have an opportunity of connecting; but the Council's conditions reparding fair wages for skilled and unskilled workers to be observed. Payresult shall be: (a) Fifty per cent. of value of work when antguard completed; (b) 50 per cent. value of work executed less pravious payment on completion of brickwork; (c) 75 per cent. of value of work erected less previous payment on completion of building; (d) balance of loan two months after completion."

Free Insurance to Air Travellers

An important concession to the public has been made by the South African Rulway Administration. From July 1 all presengers on multi-engined or single-engined aircraft operated by the South African Airways will be interested for £1,000 free of charge. In addressing the luge gathering, Dr. Field Goodsell, the executive vice-president of the American Board, who had specially come to South Africa for these celebrations, said he had brought heartfelt good wishes and felicitations from the officers of the Board, its committee, and its great body of corporate members scattered throughout the corporate States of the United States. They took pride in its history of the South African Mission. Dr. J. B McCord,

Mission Chairman, in welcoming the gathering, paid a ribute to the early colonists who in the beginning had assisted them in so many ways.

Dr Edgar Brookes, Principal of the Amanzimtoti Institute, said he felt it a privilege that day to welcome so many of their friends. He said he would take the liberty of giving them a text: "A three fold cord is not quickly broken." He lik ned the cord to religion, education and health, and to-day English, Ber and Banto To-day the English and Datch had united and he looked to the future for the welding in a three-fold cord of English, Datch and Bantu into a strong nature that could never be'broken. He left with them the hope that they would that day take a solemn pledge that they might bring together the different races for the good of South Africa. Mr. H. C. Lugg, Chief Native Commissioner for. Natal read the Governor-General's speech after which he presented the Rev. John L. Dube with His Majesty's Jubilee medal which was delayed owing to the recent floods.

The Rev. J. D. Taylor, D.D., gave a vivid and arresting history of the foundation and growth of the American Mission and of the early pioneers who struggled against native savagery and hardship. The London correspondent of the Natal Witness states:---
