Registration Of Indian Marriages RECENT case in the Ladysmith. Court, of a marriage between a Mahomedan and a Native woman converted to Maliomedanism solemnised in the Mosque by a Mahomedan priest, not having been duly registered in the Civil Court, has revealed the fact, says the Natal Advertiser's Ladysmith correspondent, that the provisions of the Relief Act of 1914 are being misconstrued by Indians generally and that they consider that the priests who solemnise these marriages are, by virtue of their religious recognition as priests, also marriage officers in terms of the Act. The actual position is that the 1914 Act provides for "the appointment from time to time by the Minister of the Interior of priests of any Indian religion to be marriage officers." But hitherto no such officers have been appointed, probably, because Indians did not pay much heed to the provision What happens, in the circumstances, is that in so far as immigrants and their descendants are concerned their marriages are supposed to be registered at the office of the Protector of Indian Immigrants while those of passenger Indians solemnised in this country are not registered, with the exception of some who have had their marriages registered at the Court in order to be saved from heavy death duties. Another anomaly is that if an immigrant Indian gets married to a passenger Indian woman and gets their marriage registered at the Protector's office their marriage is not recog nised by law. Now that the old Immigration laws affecting Indian immi grants and their descendants have become obselete it is time that this matter was looked into and the present anomalous position altered. It will be bene. ficial for all those concerned to get their marringess registered. Whether it is done at the Court or by special Indian marriage officers appointed under the 1914 Relief Act is for the leaders of the community to decide

White Labour Policy Evil

At a meeting of the West Rand Juvenile Affairs Board held at Krugersdorp recently Mr. I C. williams observed: "The time has come when we must look upon employment from the point of

view of the citizens of South Africa, whether they are black or white. At present with the substitution of European labour we are only changing the unemployed, not changing the unemployment. We are apt to lose sight of the other section who have to live, and are being deprived of the means of living. We must not lay ourselves open to doing an injustice." Mr. J. J. Resnick who was in the chair, speaking in support of Mr. Williams said, "as a member of the Juvenile Affairs Board, I agree that we must employ as many white youths as possible, but if we are to keep large native populations in our locations, we must also provide something for them. We tare putting the native out on the streets with nothing to do, and we are going to make him into a criminal. He must eat, and if necessary he will steal to do it.'

The same argument of course applies in the case of Indians and all non-Europeans and it is for this reason that Indians are protesting against the Union Government's white labour policy, but so far not with any satisfactory results.

Mr. Lucas's New Mission

Mr. F. N. W. Lucas, K.C. retired last Wednesday from the position of chairman of the Wage Board, and will resume practice at the Bar, which he gave up 10 years ago, all the time he can spare will be devoted to leading the crusade among the poorer classes in South Africa for the establishment of a more equitable economic system

"My experience on the Wage Board has shown me in a way that is open to few the extent of the appalling poverty and misery of the great mass of our white and black people in South Africa. he said in an interview. "I am certain that the solution of these problems is the same for both races. I hope to be able to devote all the time and energy I can spare from earning my living to getting the poor and dispossessed to unite with those among the privileged classes, who are willing, whatever the cost to their class, to change our economic system so as to make this country what it should be—a land flowing with milk and honey.

Working Of Wage Act Criticised

"There was one aspect of the Government's policy to which I was very much opposed," said Mr. Lucas. "The Wage Act lays down no colour bar and the board held very strongly that the only safe course to pursue was to lay down a wage for a job irrespective of the colour or race of the person performing that job It was felt that if an employee, whatever his colour, was able to do that job he was entitled to the correct wage. The policy of the labour Department, however, has been actively to bring to bear every kind of pressure possible on employers to oust natives and substitute Europeans, even if it was necessary to grant exemptions from the provisions of the industrial council agreements and wage determinations. Colonel Reitz evidently was not aware of this form of injustice when he made his speech in London recently and said that there was no injustice to natives in South Africa. I am satis fied that we shall not succeed in uplifting our own white brothers and sisters by means such as this."

We are glad to note that Mr Lucas is echoing the sentiments we have given expression to very often in regard to the working of the Wage Act. We wish Mr. Lucas well in his new activities.

Freehold Land For Natives

An appeal has been made to the Durban City Council to set aside land for sale to Natives in freehold. At its last meeting the Native Administration Committee considered a letter from a native, the Rev. N. M. Nduli, asking that natives be allowed to buy land in the same manner as Indians, who, he added, "arrived in this country only yesterday, finding us, the African people, already there with the White people. He suggests that the land sold be in half acre, or acre, lots for the use as vegetable gardens, occupiers to build according to approved plans. This, he states, would solve the slum problem and ameliorate the vagrancy and homelessness caused by the Land Act of 1915.

While we wholeheartedly sympathise with the appeal made on behalf of the Natives for the right to own land in

urban areas we are somewhat grieved to notice that the name of Indians is being used as though the natives were envious of them. The Native leaders at least, we should think, would be above being misled by mischievous propagandists. They have a strong and unchallengable case which they can fight on its own merits, without being unkind to Indians in their midst who are not more than three percent of the whole population and who have always and will always stand by them in their just cause.

Attack On Trading Rights

have reported in this journal numerous cases of applications by Indiaus for trading licences having been refused by the licensing authorities both in Natal and in the Transvaal. From the reported cases it would appear that such licences have been refused not because they happened to be in what are termed European localities for they were actually in areas which are supposed to be reserved for Asiatics, such as the Springs Asiatic Bazaar.

Recently there was a complaint that the Licensing Officer was refusing trading licences to Indians in the South Coast Junction area where there is a large indian population and there is scope for trading. In a recent issue it was reported that a forty year old Indian licence in West Street of Mahomed Abed was refused. In this issue are reported three cases of refusals in Maritzburg and two in Ventersdorp in the Transvaal We are informed that these are not the only cases of licences refused to Indians in the Transvaal. They are being refused in many other places. The Transvaal Licences (Control) Ordinance is being put into operation in full force. Another hardship imposed on Indian in regard to trading licences is that their licences are being endorsed restricting the licence holders to trade in certain things and with a certain class of people only. The underlying policy in the harsh administration of the licensing laws. quite obviously, is to deprive Indians of the only means of livelihood they have in this country. If this is to be the fate of Indians, eighty per cent. of whom are born in this country and form part of the permanent population of the Union, they may well exclaim, what worth is the Capetown Agreement to them and what the Government of India Agency, which has been established at a great cost, to implement the Agreement has been able to achieve? We are not nnmindful of the fact that the position of the Agent is very difficult in this country; not so very difficult in so far as dealing with Indians is concerned, but in so far as dealing with the Government is concerned. We admit too that the Government of India is too weak to protect the rights of its nationals who

have settled in the various parts of the British Empire. But then how long is this weakness to be hoodwinked. Why must each Agent of the Government of India just save his face and leave these shores either after completing his term of office or before. By openly declaring his weakness and that of his Government to deal with the situation here neither the Agent nor his Government will suffer humiliation but a greater, thing will be done and that is that the world will be able to see the naked truth about the attitude of the South African Government,

Let it not be misunderstood that in saying what we have said we-wish in any way to undestimate the work of the present Agent, Sir Syed Raza Ali, or the great task that lies before him. Our remarks are based generally on the Government of India and its Agency in in this country. We have had it preached to us that we should become South The fact is that Af. ican citizens. eighty per cent of us are by birth South African citizens but we are not accepted as such. It is for this reason that we have to look for help to India and so long as we have not been accepted as such the Government of India has a responsibility towards us. If it is too weak to fulfil that responsbility it will serve no good purpose to keep it any longer a secret. If one were to carefully examine the restrictive measures that have passed against Indians since the Capetown Agreement, one could not but come to the conclusion that the Government of India and its Agency in this country have been weak. For those measures are by no means in keeping with the "uplistment clause" of the Agreément which reads as follows:

"The Union Government firmly believe in and adhere to the principle that it is the duty of every civilised Government to devise ways and means and to take all possible steps for the uplifting of every section of their permanent population to the full extent of their capacity and opportunities' And the clause dealing with trading licences which forms the subject of this article reads:

"When the time for the revision of the existing trade licensing laws arrives, the Union Government will give all due consideration to the suggestions made by the Government of India Delegation, that the discretionary powers of the local authorities might reasonably be limited in the following way (1) the grounds on which a licence may be refused should be laid down by statute (2) the reasons for which licence is refused should be recorded (3) there should be a right of appeal in cases of first applications and transfers, as well as in cases of renewals, to the courts or some other impartial tribunal.

The trade licensing laws have been revised since the Capetown Agreement but instead of affording relief as promised above the laws have been made stricter and powers more arbitrary than ever have been placed in the hands of local authorities. These measures are surely not to uplift the Indian community but to crush them out of existence.

Sir Syed R. Ali, we know is working for the in the community. We know it is a difficult task and we fully sympathise with him. But we would assure him that in so far as the matters referred to above go there are no differences whatsoever in the community who would like to know what he and his Government have succeeded in doing in that connection. If nothing has been done is it not time to openly confess that the Agreement is a dead letter? The people are asking for bread and the elementary rights to live as self-respecting human beings and this is what they are being denied at every step.

THE WOLF AND THE LAMB

HE League of Nations, wounded at Corfu in 1923, and over whose corpse Japan seized Manchuria and the war in the Gran Chaco went on for years, should, now that the Abyssinian affair seems well on the way to its denouement, be buried, not so much in the interest of justice as of public health and decency. After several weeks of footless discussion the Italo Abyssinian Conciliation Commission gave up the ghost at Scheveningen. Although the purpose of the commission's negotiations had been peaceful settlement of the Italo. Abyssinian dispute, with particular reference to the affair at Ualual, the Italian delegates refused further mediation when Professor Gaston Jeze, in presenting Abyssinia's case, insisted on declaring that Ualual was in Abyssinian territory, as pertinent to the discussion. Although the creation of the League commission of four on May 25 provided, in the event of disagreement, for the selection of a fifth member who might bring about an adjudication, the commission adjourned without any proposals for further meetings. Abyssinia has now demanded that the dispute be brought before the League Council at its meeting in August, but even Emperor Haile Selassie must know, what the European countries are at no pains to conceal, on now frail a reed he is leaning when he suggests such further nego-

How pertinent is the old fable! It is predicted that the war will begin in September, when the rainy season has ended. Signor Mussolini declares that nothing shall stand in the way of his conquest of Abyssinial Rome considered the attempt of the American and French delegates at Scheveningen to prolong the discussion a plan to "wreck the commission." and Italian officials are unable to understand any suggestion that the United States might invoke the Kellog Pact, since this country "has no sphere of influence" in Abyssinia. Simple adherence to a treaty to which Italy and the United States were parties, and which attempted to make war impossible, is incomprehensible to a country bent on territorial aggrandizement at. whatever cost

As a result of Secretary Hull's latest discussions with the French, British and Italian ambassadors on July 11, at which, without actually invoking the pact to outlaw war, he expressed deep concern of the United States for the preservation of peace, it is not unlikely that further discussions will take place in an attempt to prevent hostilities But it would be idle to suppose that any such negotiations will be successful. The Duce is playing the game with all his cards on the table, and he is well aware that no country has given any indication of effectively challenging him, or is likely to do so. France, Great Britain, Japan, even Sweden are politely disassocia ing themselves from the affair, if not directly then by joining the embargo against the exportation of arms to

Abyssinia. A particularly ominous note has been struck in the declaration of the International Red Cross that it will not be able to be of aid to Abyssinia in the event of war, since the Emperor has not yet found it possible to give the necessary guarantee demanded by the Geneva Red Cross Convention of 1929. The lamb, in other words will be eaten; and not only will the slaughter take place without interference, but such wounds as it may suffer before its final demise will not be ministered to in the manner which has been demanded by humanity for more than half a century.

At least one thing should be eminently clear from the progress of the ltalo. Abyssinian struggle. Not only is the League of Nations shown-one may hope for the last time—to be hopelessly inadequate to deal with international disputes when these are projected by a determined and predatory government, but treaties to "outlaw war" are equally displayed to the world in all their futil lity. The system of economic sanctions, moreover, when it takes the form of the embargo on the exportation of arms to a belligerent or about to-be belligerenf. country, is shown to have its weaknesses. Italy, with a handsome corps of munitions factories to call upon, is not concerned, with the problem. Abyssinia must buy arms from other countries, and however admirable in principle may be their refusal to sell munitions of war, in fact this refusal contributes to the weakness of what is already incomparably the weaker nation. In the face of the time-honoured proces: of aggression, in short, our modern diplomacy is shown to have few advantages over the old system. It takes more than a signature on a treaty to stop a 'tyrant.

FURTHER INDIAN LICENCES REFUSED

S. NOHAR, an Indian, had applied for a baker's licence for premises at 200, Retief Street, Maritzburg The Licensing Officer, according to newspaper reports, refused to grant the licence owing to a technical breach of the law committed by the applicant by entering into an agreement with two Indians that they should conduct the baking under his licence.

On appeal to the City Council Mr. W. L. Howes, who appeared for the appell ant explained that Nohar had acted illegally but that he had not been aware of the fact at the time. That he had lost his licence for a year and surely that was sufficient penalty for a technical breach of the law.

The Council was evenly divided when the question was put to the vote, and the Mayor, Councillor A. T. Allinson, gave his casting vote in favour of upholding the Licensing Officer's decision in refusing the licence. A. D 'Paruk had applied for a transfer of his general dealer's licence from Lower Church Street to 102 Church Street The Licensing Officer refused his application. On appeal to the City Council, Mr. Brokenshaw, who appeared for the appellant said that Paruk was one of the traders who had been ejected from the Grand Theatre site in 1929 He had gone to Liwer Church Street, but this area was heavily overtraded, and he now sought to transfer to Upper Church Street within the Indian trading area. The appeal was dismissed and the Licensing Officer's decision was upheld.

M. D. Vather had applied against the decision of the Licensing Officer in refusing a general dealer's licence for premises at 96 Retief Street in the vicinity of the new Native Hall and Market. The hearing was postponed in this case to allow Vather to prepare a fresh plan of the buildings to be erected.

Ventersdorp Village Council Refuses Licence

Dawood Vally of Ventersdorp (Transvaal) applied for a certificate for a general dealer's licence to the Ventersdorp Village Council. The application was refused in last January. Another application was made on his behalf again which came up for hearing on August 20 and was again refused. The refusal was communicated to the applicant by the Town Clerk of the Village Council of Ventersdorp in the following manner:

"I beg to inform you that my Council has refused your application for a certificate for general dealer's licence on erf No. 92, Breede, Venters dorn."

The application of another Indian Jagjiwan Rama for a certificate for a general dealer's licence also came up for hearing at the same time and that too was refused by the above Council.

MR. GEORGE LANSBURY ON INDIA'S RIGHT TO FREEDOM

NLY the other day Mr James, a member of the Legislative Assembly representing the European sojourners in India, said that they were not foreigners but a part of the people of India like the children of the soil. . It was very condescending on his part to say so. Nevertheless it is a salsehood. pure and simple. Let us hear what Mr. Lansbury has to say on this point.

"When emigrants from country go to other ritish Dominions they settle there and identify themselves with the inhabitants. Their children grow up and are proud of being Australians, Canadians or New Zealanders. Not so in India. The Englishman or Scotsman goes there simply to make a living, whether as a Civil Servant, in the Army, or in trade and commerce. He never becomes or thinks of himself or of his children as Indian. He works to make sufficient money to enable him to retire and spend the remainder of his days in this country or, in the case of the Services, until the time has come when he can claim his pension payable, out of indian revenues. These pensions, spent entirely outside of India, amount to millions of pounds annually—a heavy drain on India."

The prevailing illiteracy in India has been often spoken of by Englishmen of various sorts as one of her main disqualifications for self-rule by a system of representative government. Now, are the people of India alone responsible for this shameful fact? Mr. Lansbury answers: ...

"The total literate population is just over 28,000,000, or about 8 per cent. Out of every hundred of the male population eighty-five can neither read nor write in any language. In the case of the female population ninety-seven out of every hundred can neither read nor write. Two-thirds of the villages has no schools. The responsibility for this appalling amount of illiteracy must rest to a very great extent on our shoulders. It we_ refer to the evidence given before a Committee of the whole House of Commons on the East India Company's affairs 120 years ago-on 12th April, 1813-which I have besides me as I write, we find that Colonel (afterwards Sir) Thomas Munro, who had then spent over thirty years in the East India Company's service, during which time he had lived in various parts of the peninsula, when asked about the

then civilization of India, said inhis evidence 'If a good system of agriculture, unrivalled manufacturing skill, a capacicy to produce whatever can contribute to conread venience of luxury; schools estabnot lished in every village for teaching reading, writing and arithmetic; the general practice of hospitality and charity amongst each other; and, above all, a treatment of the female sex, full of confidence, respect and delicacy, are among the signs which denote a civilised people, then the Hindus are not inferior to the nations of Europe; and if civilisation is to become an article of trade between the two countries, I am convinced that this country will gain by the import cargo."

It is only to be expected that a man of the people, a well wisher of the masses everywhere and a lover of liberty like the author should say of the anti-India Bill (now India Act.—Ed I.O.) now before the House of Lords:

"We believe that the Constitu. tion Act now proposed does little or nothing to enable the masses of . workers in India to secure for themselves through legislation better conditions. Provision must be made for the extension of the suffrage until there is full adult suffrage. This is quite possible even at present in the urban areas, it ought to be possible in a period of ten years at most all over British India. It is not possible for the workers even then to secure better conditions with the legislatures weighted as at present proposed by landowning and special interests."

What in his opinion ought to be

done? "India must again be given the chance to frame her own constitution, giving due consideration to the, various minorities, religions, etc. We believe that she must in this way work out her own salvation, and that she alone can do it "

The author quotes some score of British promises, pledges etc., relating to India, by various persons from Sovereigns downwards. His own opinion, quite rightly, is that all these cught to be fulfilled But the opinions of a Conservative commoner and a Conservative lord have been already quoted from his book to the effect that nothing is bind-

ing except an Act of Parliament. It is not, of course, for a subject people to ask whether King John's Magna Charta was an Act of Parliament, and whether all those Britishers who, down the cent. uries, have taken their stand on it as the great charter of English personal and political liberty were mistaken. It is true, no doubt, that King John signed the Great Charter under pressure. But is it true that whatever has been directly or indirectly promised to India has never been done under pressure of circumstance but has always been due to British generosity, pure and simple?

One great value of Mr. Lansbury's recital of British proclamations, pledges and the like is that he has given exact references to occasions and dates. I am not, of course, going to quote all that he has written. But since it has been said that nothing is binding except an Act of Parliament I quote the following from his book to show that the fulfilment of at least one Act of Parliament has been evaded:

"Indeed many Indians, not without reason, hold that the words written by the late Lord Lytton when Viceroy of India, in a Government of India despatch to the Secretary of State, Whitehall, on May and 1878, still hold good: The Act of Parliament's undefined and indefinite obligations on the part of the Government of India towards its native subjects are so obviously dangerous that no sooner was the Act passed than the Government began to devise means for pratically evading the fulfilment of it. Under the terms of the Act, which are studied and laid to heart by that increasing class of educated natives, whose developement the Government encourages, without being able to satisfy the aspirations of its existing members every such native, if once admitted to Government employment in posts previosly reserved to the covenanted service, is entitled to expect and claim appointment in the fair course of promotion to the higher posts in that service We all know that these expectations never can, or will, be fulfilled. We have had to choose bet ween prohibiting them and cheating them; we have chosen the least straigtforward course. . . . Since I am writing confidentially, I do not hesitate to say that both the Goveraments of England and of India appear to me, up to the present moment, unable to answer satisfactorily the charge of having taken every means in their power of breaking to the heart the words of promise they had uttered to the car." The Next Move Of The Congress

N the eve of the Congress Working Committee's Meeting an important statement was issued jointly by Doctor Ansari, Doctor B. C. Roy. Mr Asaf Ali and Chaudhri Khaliquzzaman. They hold that the Congress should contest the elections under the new Act and capture all places of power and vantage to assert the dominating will of the people. Admitting that the new constitution will only offer limited opportunities to Congres men, they think it can be utilized for the successful prosecution and furthering of the constructive programme of the Congress. While conscious of the risks and difficulties involved they advise the acceptance of office.

The statement which represents the views of quite an important section of the Congress, however, does not change the situation. And there is little doubt that the proposal to accept offices must be facing considerable hostility in the Working Committee. The opposition will be of course, by socialist who held a meeting of their Executive Committee at Benares and considered the attitude they should adopt towards the question. After prolonged discussions they reiterated their Nagpur decision that the Congres, on no account, should accept ministerial offices under the new constitution and suggesting that wherever it is in a majority it should make the working of the new reforms impossible, thereby rejecting the sham constitution It was felt that the acceptance of offices would strengthen the elements of constitutionalism in Congress.

The socialists are not in a majority in the Working Committee and, therefore, it is almost certain that acceptance of offices, with certain reservations, will be decided upon. What is needed is united action in accordance with whatever decision is arrived at and the determination that whether Congressmen accept offices or not they will ever keep the interests of the country at heart and not shirk their duty when it calls them to plunge again in the vortex of a struggle for the freedom of the nation.

Lahore Situation Improves

The situation at Lahore has improved. The Majlis-i-Ahrar, a popular and responsible body of nationalist Muslims, has issued a opportune and welcome statement calling upon the Musalmans to give up the unfortunate attitude they had adopted in connection with

the Shahidganj dispute. The Majlis-i-Ahrar is a well-known body of patriotic Musalmans and it is heartening to note that it rose to the occasion and gave the right lead to the Musalmans. In consequence of this appeal the jathas have been abandoned and the city is again returning to normal. It is also significant to note that several Ulema or religious heads of Musalmans have issued statements saying the Musalmans were doing no good to the cause of Islam by carrying on the futile agitation which could end in little else except spilling of blood and creation of biterness. It has now been suggested that the Muslims should try some more peaceful methods of arriving at a settlement with the Sikhs:

The situation briefly summed up is' this. The Sikhs had legal ownership of the mosque and complete liberity to do. what they liked with it. But were they justified in demolishing the mosque? No doubt they had the legal right to do so. But it is also true that by demolishing a house of God they served no good. purpose and on the contrary created. bitterness and hostility. Musalmans were equally to blame in adopting truculent methods to arrive at settlement. Ire will always beget ire and it is only reasonableness that can settle such delicate questions Even now it is not too late and the indications are that attempts that are being made to bring about conciliation will bear fruit The sooner the unfortunate affair is dead and buried in a revival of better communal relations the better it will be for Punjab and India. 📩

Sarat Bose Released

When the Congress contested the last Assembly elections and gained a smashing majority at all places one of the few candidates who got in unopposed without any need for an election was Sarat Chindra, Bose. The candidate, it will be recalled, was in jail. For what offence? None, for there had been no trial and no conviction. The police thought he should not be allowed to live freely and Mr. Sarat Chandra Bose, an eminent lawyer of Cal utta and the brother of Mr. Subhas Chandra Bose, found himself in jail Thousand and five hundred other Bengalis are also in similar detention without having theen ever tried or convicted before a court of law. The powers of the police under the emergency laws of Bengal are wide, too wide. They may send any one on the slightest pretext to detention with-. out giving the accused a chance to defend himself.

It was to protest against this system that Mr. Sarat Chandra Bose, though he was in defention, was elected to the Assembly. By electing one of the detenues unopposed the Bengal electors. effectively protested against the ordinance regime which is responsible for such detentions. Mr. Bose applied at the time of the last Assembly election to be allowed to attend the Assembly and to discharge the public duty that devolved upon him. The Government. refused to release him and this occasion was utilized by Conregssmen and other non-official members to censure the Government for their ordinances. Mr. Bose later resigned from the Assembly and a bye election was held again returning a (ongressman. And now suddenly Mr. Bose has been released without any conditions. It is to be hoped that the other gentleman would resign and Mr. Sarat Bose re-elected to the Assembly once again to voice the nation's protest.

Tilak Anniversary

India celebrated the fifteenth death anniversary of the great Indian patriot and leader, Lokmanya Bal Gangadhar Tilak who breathed his last on the last day of July 1920. Born in the year preceding the great Indian (so called) Mutiny, 1856, Tilak lived to the ripe age of 65. And even in his last years on this world he retained his bodily fitness and mental-vigour and to the last was engaged in political activities. One of the sturdiest patriots and incorruptible politician and an ardent social reformer he will live in the memories of Indians for ever and when the history of Indian nationalism comes to be written Tilak's name will be there in golden letters. One of his greatest virtues was his unflinching loyalty to the Indian National Congress. Nourishing it and the nationalist movement with his life blood he remained firm in his loyalty to it from the day of its inception to the day of his death. Indians of today have a great deal to learn from his life.

Quetta Still Needs Money

The refugees from Quetta still require money for their relief. The Central Relief Committee has again appealed for funds.

In this connection it is very gratifying to learn that Indians abroad and particularly in South Africa have not forgotten their brothers in distress and are collecting funds for the sufferers of Quetta as they did at the time of the Bihar earthquake.

On one day fifteen inches of rain fell and was followed by strong wind and flood in the river. A village was isolated and thousands of sheep washed away. The state authorities are making arrangements for the rescue of the villagers involved.

Calcutta papers publish the sensational story that the Howrah bridge over which thousands of persons pass every day is in grave danger of collapse which has been aggravated by the increased velocity of the tides. The structure of the bridge is very old and in a rotten state and a new bridge is being contemplated.

White Man's Country a Fallacy

General Smuts in opening the first Congress of the Border and Eastern Province Branches of the United National Party at East London on Aug. 21 referred to the ever-increasing difficulty of finding markets overseas for their agricultural produce and said that they would have to turn their attention more and more to internal markets, but principally to raising the standard of the life of the Native and White peoples of the country. It was a fallacy to say that South Africa was purely a White man's country, he said. The Native was part and parcel of South Africa and a very important part too, for it was to the 8,000,000 Native people that they would have to look for markets and therefore it was imperative to improve his economic life and give him greater purchasing power General Smuts maintained that the Status Act settled most of their controversial problems, because it laid down that South Africa should remain a member of the British Commonwealth, that South Africa owed allegiance to the King and that the King as settled by the British Ac: should be King of South Africa-The Status Act was a most solemn declaration of the ties that bound South Africa to the British Empire. The Empire, however, was not a separate entity. The Empire was a collection of countries each of which was a separate entity. The only unity was the King-one binding link between the various countries which were called the British Empire. The Dominions were not part of the Empire but partners in the Empire, as his Majesty himself had phrased it. Answering the question of whether the people had lost their British nationality, which the Dominion Party were making much of General Smuls said that the Nationality Act of 1926 was actually drawn up in England and recommended by Britain to all the Dominious The Act of 1927 merely laid down who was a Union citizen, and General Smu's said that Union citizenship was based on British nationality.

City Council Elections

Nomination day for the Durban Municipal elections is Monday, September 16, when the list closes at noon. Formerly municipal elections have been held on the first Wednesday of August throughout Natal, but this year for the first time Durban will have election on October 2.

Shop Hours In The Township Of Charlestown

In terms of Section 7 (1) of the Shor-Hours Ordinance, No 12, 1919, the Administrator in Executive Committee has been pleased to declare Charlestown a special place within the meaning of the said Ordinance, and to appoint the hours of 1 p.m. and 5 p.m. as closing hours on Wednesdays and Saturdays, respectively, for all shops within the Township.

Solicitor Turns Missionary

Mr. W. T. Clark, one of the prominent solicitors of Durban intends to dispose of his legal practice in the near future and enter the mission. He wishes it to be understood that his retirement does not mean that he holds the view that practising the legal profession was incompatible with Christian principles. He realises that in the profession one can be honest, straightforward and of help to one's fellowmen, but nevertheless he feels that he now has his call for work in the mission field.

Shepstone addressed the club on the ideals of a memunal endeavour. In opening the club, the Mayor complimented the organisers on including social welfare along with social enjoyment in their objects. Dr. Copley also commented on its freedom from politics. The Agent of the Government of India, Syed Sir Reza Ali, was invited but was not present owing to in-

disposition. It was announced that Mr. S. M. Naidoo had made a donation of £100 "to start the club off." Mr. P. G. Things In General

French Title for an Indian

THE President of the French Republique has conferred the title of Officier de la Legion d'Honneur on Mon de Zir Nayudu, Privy Councillor. He is the first Hindu and the second Indiau to get this high honour in French India. His other titles are: Chivalier de la Legion d'Honneur, Officer de l'Instruction Publique, Officer du Nichan D'Iffikhar (Fr. Africa) and Medaille du Bien Publique. He is the President of the Consultative Committee of Indian Jurisprudence.

American Woman Doctor On India

Dr. Rose McBride of Chicago who is on. a world tour whilst in Durban in the course of an interview with a press representative she made the following references about the conditions in India; She visited hospitals in India, where she was most impressed with the efforts being made to cope with difficulties in the outlying districts. Tuberculosis, she found rife in India, while in Colombo 800,000 people have died within the last months of malaria. The book "Mother India" which she has read, Dr. McBride feels, is authentic, but she is of opinion that the authoress has made more of the sordid side of conditions than is necessary She may lect tre on her experiences when she returns home.

Death Of Sir Basil Blackett

Sir Basil Blackett, who was Finance Member of the Executive Council of the Governor-General of India from 1922 to 1928, and who was responsible for having secured the stabilisation of the exchange at 13s 61 was killed says Reuter from Berlin, in a level crossing accident last week when a train crashed into the back of his car.

Conference of Universities

It is understood that a quinquennial conference of universities of the British Empire will be held at Cambridge from July 13 to 17, 1936, immediately after the celebration of the centenary of the University of London. Mr. Stanley Baldwin, Chancellor of the University of Cambridge has consented to act as President. The University of Calcutta will be represented at the Congress by Mr. Shyama Prasad Mukherjee, Vice:Chancellor, Dr. Bidhan Chandra Roy, Professor S. K. Mitra and Sir W. E. Greaves, an ex-Vice-Chancellor and ex-Judge of Calcutta High Court.

Suez Canal The Key

The Archbishop of York, writing to the Times submits the following considerations in regard to the Abyssinian orisis:—(1) We are bound by the covenant of the League. To fail now in loyalty to the League, because that loyaly might have grave consequences, would be sheer wickedness, involving an indelible disgrace, (2) The obligation of States as members of the League is joint, not several. We must make perfectly clear our adherence to the League and our purpose to make operative the terms of the covenant. But we retain our freedom if other Powers refuse to co-operate. (3) We have responsibility for leadership, partly because we enjoy a measure of detachment and partly because of our special position in relation to the Sues Canal. If at the direction of the Council of the League, the British and French fleets combine to close the Suez Canal to Italian ships, unless Italy agrees to submit the whole dispute to the League, it would be very difficult for Italy to continue her course of isolated action.

Alleged Arrest of British Indians

According to reports from Massawa, in Eritrea, 15 Indian British subjects have been arrested by the Italians following a dispatch the Indians are alleged to have sent to Aden advising their business associates not to ship any further merchandise to Massawa.

Indian Troops To The 'War Zone'

A simla message states that a small detachment of the Fifth Battalion of the 14th Punjabis is being dispatched from Bombay to reinforce the guard of the British Legation at Addis Ababa. A communique states that the question of reinforcement was recently considered by the Indian and British Governments with a view to facilitating the protection of British subjects. The steps mentioned are taken to ensure that the contingent will be available "in the near neighbourhood" in case of necessity.

Ireland Sides With Abyssinia

Abyssinia has found a new cham ion in Mr. de Valera, President of the frish Free State, who has decided to go to Geneva in September for the meeting of the Lesgue Council. He will express his Government's point of view on the Italo-Ethiopian dispute, and it is understood he will indicate his Government's readiness to co-operate to the fullest extent with the League in the efforts to preserve peace and the independence of Abyssinia.

What War Cost

K. R. Knickerbooker writes in the Natal Mercury:

The next World war may last as long as, or longer than, the so-called "Great War". That War, according to the figures compiled by the Swiss statistician Professor L. Hersch. cost no fewer than 41.435 000 lives. Thirteen million suldiers were killed or died. It should not be forgoiten that although American lost 116,000 soldiers, America lost 1,500,000

dead in the influenza epidemic, for which the War was directly responsible. Thus even the last War struck heaviest at the civilians, for out of the 41,435,000 dead, 27,379,000 were civilians who died of war-inspired disease. It is true that in this mighty holocaust 13,700,000 were only" Asiatics. It is soldon remembered that war plagues swept the East with a virulence even more devastating than in the West. Yet the Western World suffered the loss of over 26,000,000 soldiers and civilians, a population over half that of France, England or Italy. Nothing promises less, but everything promises more havee in the next war. Its havoc could only be reduced when, as the Danish Professor Joerg Joergensen puts it in his "Effect of War on Mentality and Morale," "by snitable means the civil population has been reduced to such a state of fear that they are seized with panic bordering on madness in which every trace of self-control is lost." Thus the choice is between near-madness and near-extermination. Some say ihe horror, what the Germans call the "Schrecklichkeit" of the next war will prevent it. But the horror of it is too little known. It was to make it known that this report on the next war's possibilities was written. We can only note that in the "Great Obsos" nobody will win. Everybody will lose. No merely atrong ration can stay out of it. Only an overwhelmingly strong nation can keep out of it. Strength to-day means airplanes. Nine million Englishmen voted "For Peace" in a ballot just held, but Europe is spenifing every day £2,500,000 for war. Down London's Picadilly walks to-day a melancholy sandwich man. His front reads: 44The next war will end in revolution. Make no mistake about that." His back reads: "Our dead in the last War would cover 1,000 miles. They went through hell. So will you."
