

GENERAL INTRODUCTION TO THE SERIES

The publication of a systematic series of practical and authoritative Manuals of Library Work, which shall survey Library polity and practice in their latest aspects, is a requirement of which administrators, librarians, and students alike have long been conscious, and is much overdue.

In the Library world not the Great War alone, with its aftermath of new conditions, but also the Library Act of 1919, have marked the termination of one long epoch and the commencement of a new and yet more prosperous era. The removal of the crippling limitation of the penny rate at once paved the way for a renaissance of the Library Movement, and remarkable extensions and innovations, both in buildings and in service, have ensued. The great work of the Carnegie Trustees in fostering the development of urban Public Libraries has now been largely diverted into fresh channels, and County and Rural Library Systems now cover the country from Land's End to John-o'-Groats. The public demand and appreciation of Libraries have increased enormously, and, in response, old methods have been revised and new ones introduced. The evolution of Commercial and Technical Libraries and the development of Business and Works Libraries would amply suffice to indicate this spirit of progress, but, during the last decade or so, the entire field of Library service has been subjected to review and experiment, and little, either in administration or routine, remains entirely unchanged.

It will, therefore, be sufficiently obvious that the old textbooks relating to Library practice can no longer serve, and that there is a real need for new manuals, written by persons of experience and authority, and treating of the new conditions in a full and thoroughly practical manner. It is this void that the series of Library Manuals is designed to fill, and the fact that these volumes are to be issued by Messrs. George Allen and Unwin Ltd. in conjunction with the Library Association, should afford adequate proof of the qualifications of the authors to treat of the subjects upon which they will write. NOTE.—The questions in these two groups are purposely varied so as to show without undue repetition the range and scope of library routine.

THE LIBRARY ASSOCIATION

Describe a satisfactory system of registering and indexing borrowers, and give the ruling and letterpress of an application card.

Show what guides you would provide in a closely classified open-access library to facilitate the finding of books. Illustrate your answer.

Describe two charging systems in vogue in open-access libraries, and the various kinds of appliances used in connection with them. Give a diagram of a card-tray with guides.

What do you know of "Information Bureaux" in public libraries?

Describe a satisfactory charging system for use in a reference library, and give the ruling and wording of a reference library application form.

What aids would you provide in a closely classified reference library to facilitate the quick finding of a book, and to account for the absence of one from the shelves?

In forming a local collection what material would you consider of sufficient importance to merit inclusion? State the system of classification you would adopt, and the kind of catalogue you would prepare, to render the collection useful to readers.

State the principles you would observe in selecting books for branch libraries, and the advantages of centralizing all cataloguing, classification, etc. Describe also any system of interchanging among central and branch libraries known to you.

How would you record the day's issues in a lending or reference library under the various classes? Give rulings of an issue book or sheet.

Show in what directions collections of pictures may be helpful to readers, and briefly describe how you would collect and arrange the material.

Describe a card-charging system suitable for the central office of a rural library system. Illustrate your answer.

Describe the aims and work of the National Central Library, and show how public libraries may co-operate advantageously with this institution.

Describe how you would organize a series of library lectures so as to avoid financial difficulties, and include a syllabus of six lectures suitable for adults and six for children.

What are University Extension Lectures? Show how public libraries may advantageously co-operate in their organization.

Enumerate the principal points you would include in a specification for bookbinding.

Describe the various processes a book withdrawn from circulation for binding goes through before its return to the shelves.

State what you consider to be the best methods of filing periodicals and newspapers, temporarily and permanently.

Set out the processes through which a book passes from the time of its receipt to its issue to a reader. Give the ruling and wording of a form denoting the various processes.

Describe some methods of conducting school libraries in connection with public libraries. Which do you consider the most satisfactory? Supply ruling and wording of the various labels, stock cards, etc., and show how issues are recorded.

Compile an annotated list of the principal routine duties of a lending-library staff.

Describe an adequate system of ordering, storing, and issuing stationery and other supplies.

In what ways can a library prove its value to the business community?

"It is decided to purchase books recommended by the British Broadcasting Corporation. How would you display these to the best advantage?

• What tests would you apply to discover whether additional books for a library already established were desirable or not, having regard to finance, supply, and demand?

Describe how you would prepare a list of books proposed for purchase, and the routine treatment of the list in committee and subsequently (exclusive of ordering).

In what form would you issue an order for new books, and what steps would you take to ensure that the books are correctly supplied?

Describe the routine of stocktaking in any kind of library, and give rulings for the form of check-list which you would employ for this purpose.

Write a short essay, with particular reference to routine methods, upon any one of the following subjects:

- (a) Commercial (or Technical) Libraries.
- (b) The National Central Library and Regional Cooperation.
- (c) Children's Libraries.

Explain (a) how overdue books are detected by any form of issue records, (b) what steps you would take to obtain the return of such books, and (c) a satisfactory system of receipts for fines.

Describe in detail the routine respecting (a) bespoke books, and (b) book renewing.

Briefly indicate the scope and purpose of a county library, and an effective charging system at the headquarters library.

1 Describe in detail a charging system suitable for a university or a school library.

Give a succinct account of office routine, with especial reference to the treatment of correspondence.

Describe two methods of checking the receipt of period-

icals, one by means of cards, and the other by any alternate method.

Outline the object and principal routine methods of municipally maintained commercial and technical libraries.

Regarding the accessions register as the centre of your system of stock records, explain how the other stock records supplement it and link up with it.

What is involved in "the preparation of books for the shelves"? Comment on the importance of the different processes. How would you secure that no step was omitted?

Describe the process of "charging" books in (a) an openaccess lending department, and (b) in a closed lending library with or without an indicator.

Discuss the relative values, for library binding purposes, of pigskin, skivers, sealskin, moroccos, basil, roan, and Persian leathers. Under what circumstances would you give preference to buckram or other cloth material as a covering for books?

Describe and discuss the following methods of sewing books: sewing two sheets on, overcasting, sawn-in sewing, and sewing all-along; and state under what circumstances you would approve overcasting.

How would you ensure, by means of administrative records:

(a) That every book purchased went into library stock?

- (b) That no book was paid for more than once?
- (c) That the yearly publications of Societies, and successive volumes of a work appearing at irregular
 intervals, are duly supplied and are charged for at the proper rate?

What means do librarians use to attract and maintain the interest of children?

How would you prepare the manuscript of a catalogue (or book list of any character) for publication? Give ten marks as used in the correction of printers' proofs, and state their meaning.
