## PREFACE.

---

THE strong encouragement which was successively given to the four editions of our New Criminal Court Manual, even outside of our Presidency has induced us to come out with the present edition for special use in the Bombay Presidency.

THIS edition has been thoroughly revised and enlarged and brought up to date by the incorporation of the latest decisions of all the High Courts in India.

THE New Criminal Procedure Code (Act V. of 1898) is added and such of the decisions as apply to the present sections in the new code have been retained, the rest that do not apply or have no bearing upon the sections having been omitted. The several alterations and additions that have been made in the new code have been pointed out by means of explanatory foot-notes. All the amendments in the Penal Code and other Acts have been carefully noted in their respective places.

To meet the requirements of the candidates of the Lower and Higher standard examinations as well as officers who are both Magistrates and Revenue Officers, more than a dozen non-criminal Acts of the Bombay Government have this time found place in the Supplement which is added at the end of the second volume.
