## Preface

There has been a general feeling among academicians as well as administrators engaged in the formulation and implementation of family planning programme in India that the impact of the programme on fertility has not been commensurate with the enormous inputs in terms of personnel, financial resources and time invested in the programme. Though India can take legitimate pride in the fact that it was the first country in the world to declare a national demographic goal, and to launch an official programme of family planning, the time by which the targetted birth rate of 25 per mille was to be reached had to be deferred to a later and later date in each successive five-year plan. The present demographic goal is to reach the birth rate of 25 per mille by 1984. If the recent trends in the performance of family planning programme continue in future it is unlikely that this goal will be realised even by 1984. Analysis with data on births averted because of a certain number of acceptors taking to modern methods of family planning within the programme indicates that the observed birth rate declines do not match with births averted and the former are less than the latter.

In Karnataka State, it is found that the birth rate has been declining rather quite slowly, coming down from an estimated level of 40 in 1951 to about 35 in 1975. The bulk of this reduction appears to be due to structural changes in the population in age-sex distribution, and the real reductions in marital fertility appear to be only 5 to 6%. Computations reveal that the reductions in marital fertility that can be expected because of couples accepting family planning methods from within the programme should be of the order of 10%. There appears to have developed a situation wherein the potential fertility rates of married women in the State are changing or have changed in the past generation in the context of modernization.

The Mysore Population Study that was carried out in the then State of Mysore in 1951 and the Bangalore Population Study carried out by the Population Centre, Bangalore, in 1975 in an overlapping area of Karnataka State offer a unique opportunity for comparing the fertility patterns of the women in the Mysore Population Study, in different geographical regions, with the fertility patterns of women living in the same terrains in 1975, almost a

generation later. Comparision of findings from these two studies provides a rare data-base to study changes in the fertility patterns, attitudes to family size, knowledge and practice of family planning methods of couples in the reproductive ages in the area over a period of one generation. The findings indicate that while there has been a substantial increase in the knowledge and practice of modern methods of family planning in the area, attitudes to number of children desired and ideal family size have not changed to the same extent. It is also observed that the practice of traditional methods of family planning which was quite well prevalent before 1950 has declined very sharply with very few couples practising, nay, even aware of, by the year 1975, of these methods. Modernization seems to have set in motion a chain of changes in the socio-cultural practices of the population and has tended to release some of the traditional checks on fertility and this appears to be a major factor responsible for only a marginal decline in the marital fertility rates of women, even in the context of a strong family planning programme.

This monograph is the second in the series of Occasional Papers published by the Population Centre, and it is hoped that it will be useful in stimulating discussions on the extent to which modernization can contribute to an increase in the potential fertility of women in a society where culture and social conditions have exercised strong checks on fertility, either directly or indirectly, for long time in the past.

The authors wish to thank their colleagues in the Population Centre, especially the Research Assistants and Field Investigators who were responsible for the collection of data, under trying circumstances in the field, for the Bangalore Population Study. Special thanks are due to H.S. Surendra, Keshava, G. B. Venkatesha Murthy, Sholapurkar and Manjula Devi who assisted us in the presentation of tables.

# Chapter I

#### INTRODUCTION

In 1975, the Population Centre, Bangalore, undertook a large-longitudinal sample survey (LSS) of about 5,200 households. The setting of the survey, which is here called the Bangalore Population Study (BPS), is the Bangalore revenue division consisting of 5 districts namely, Bangalore, including Bangalore city, Chitradurga, Kolar, Shimoga and Tumkur in Karnataka State, India. It is the same as the geographic area covered by the India Population Project, Karnataka. The BPS, as already mentioned, is longitudinal in design. Its objectives are to (1) determine the levels of, and trends in, fertility mortality, and knowledge, attitudes and practice of family planning, (2) identify core variables associated with fertility, (3) assess the impact of additional family planning inputs provided under the auspices of the India Population Project, and (4) examine the structure of demand for family planning services.

The collection of data in the first round began in May 1975 and was completed by December 1975. A detailed analysis of the data collected in the first round of the study is in progress. The availability of data from the Mysore Population Study (United Nations, Sales No. 61.:XII. 3), conducted about a generation ago in almost the same geographic area in which the BPS has been conducted, provides an unique opportunity to attempt an interesting and important comparision of fertility, knowledge, attitudes and practice of family planning, and opinions regarding desired and ideal family size.

The Mysore Population Study (MPS), jointly undertaken by the United Nations and the Government of India, was designed as a pilot project in the use of survey methods for obtaining information on the trends of population, factors which influence them, and their social and economic consequences. The collection of data for the MPS began in the middle of December 1951 and was completed by September 1952. Thus the gap between the MPS and BPS is about 24 years, almost a generation.

We thought it would be more interesting to make a quick study of changes, if any over a generation in important population parameters on the basis of the data available from the MPS and BPS rather than wait till the full findings of the BPS are published. Hence the monograph.

The objectives of this monograph are as follows:

- 1. To study changes in the population structure of the area (on the basis of the data available from the 1951 and 1971 censuses);
- 2. To study changes in fertility levels;
- 3. To study changes in the desired number of children by married women and their hubsands:
- 4. To study changes in the opinions of married women and their husbands regarding ideal family size; and
- 5. To study changes in the knowledge and practice of various family planning methods.

## Chapter II

#### DESCRIPTION AND COMPARABILITY OF THE TWO STUDIES

This chapter describes the Mysore Population Study (MPS) and the Bangalore Papulation Study (BPS), and examines comparability of the findings of the two studies in terms of (1) geographic areas covered by the two studies, (2) sampling design and (3) type of schedules administered and persons interviewed.

#### 1. Geographic Areas

The geographic area covered by the MPS encompassed not only the present Bangalore revenue division in Karnataka State (Until November 1, 1973 known as the Mysore State) but also few other districts, either partly or wholly, in the State. But the present Bangalore revenue division accounted for the major part of the geographic area covered by the MPS. The BPS is confined only to the Bangalore revenue division.

Table I presents information on comparable geographic areas covered by the MPS and BPS. Zone I of the MPS covered parts of the rural areas of Chickmagalur, Hassan and Shimoga districts, and Zone II covered parts of the rural areas of Hassan. Chickmagalur, Shimoga and Mysore districts. The rural Shimoga district covered by the BPS is compared with zone I and Zone II of the MPS. Zone III of the MPS included the rural areas of Bangalore, Kolar and Tumkur districts as well as parts of the rural areas of Hassan and Mandya districts. The rural areas of Bangalore, Kolar and Tumkur districts covered by the BPS are compared with Zone III of the MPS. Among the rural areas, this is the largest geographic area covered by both the studies. Zone IV and Zone V of the MPS consisted of parts of the rural areas of Mysore and Mandya districts. Since the BPS has not covered either Mysore district or Mandya

district, no comparison is made with Zone IV and Zone V of the MPS. Zone VI of the MPS encompassed the rural areas of Chitradurga district and parts of the rural areas of Chikmagalur and Shimoga districts. The rural Chitradurga district covered by the BPS is comparable with Zone VI of the MPS, but no comparison is made because the MPS did not conduct the survey in Zone VI.

The MPS had in its universe all the towns with a population of 10,000-25,000 in 1941. For reasons explained elsewhere (Reddy et al, 1975), the BPS confined itself to the four district headquarter-towns of Chitradurga, Kolar, Shimoga and Tumkur. These four district headquarter-towns, each of which had a population of 10,000-25,000 in 1941, were included in the universe of towns of the MPS. Hence the towns of the MPS are compared with the four district headquarter-towns of the BPS.

Both the studies covered Bangalore city. Thus an analysis of changes over a generation in important parameters of population of Bangalore city poses no problem. Bangalore city is the largest urban area covered by both the studies.

The map of Karnataka State on the adjoining page shows the geographic areas covered by the MPS and BPS, as well as comparable areas of the two studies.


#### 2. Sampling Design

For the selection of geographic areas for the study, the MPS first divided the then entire Mysore State into several Zones on the basis of degree of urabanization, geographical terrain (hilly areas or plains), source of irrigation for agriculture and development of public health activites. The rural areas were divided into 6 zones on the basis of rainfall, type of irrigation, principal crops grown and location of anti-malarial operations. Thus Zone I and Zone II included rural hills with and without large-scale anti-malarial operations respectively. Zone III comprised of rural plains with tank-irrigated areas. Zone IV and Zone V also comprised of rural plains with canal-irrigated areas and with and without large-scale anti-malarial operations respectively. Zone VI, too, covered rural plains but with dry-farming areas.

The towns were divided into 3 groups on the basis of population size; 5,000-10,000 formed the first group, 10,000-25,000 formed the second group and 25,000-50,000 formed the third group.

Bangalore city was divided into 5 starta on the basis of religious composition and literacy of the population. Muncipal divisions in which Muslims accounted for 35 per cent or more formed one stratum, those in which Christains accounted for 35 per cent or more formed another stratum, and those in which Hindus belonging to Scheduled Castes accounted for 35 per cent or more formed the third stratum.

The remaining Muncipal divisions were divided into two strata - one in which literates accounted for 60 percent or over in the age group 5 and above and the other in which they accounted for less than 60 per cent.

It may be noted that for some practical reasons the MPS did not cover all the rural zones and all the 3 groups of towns. "To carry out the study in all zones of the State would have involved a greater expenditure for field work than could have been justified in view of the amount of funds available and the fact that the study was planned mainly as pilot project for testing (survey) methods. It was therefore decided to make the field survey only in Bangalore City, the towns of 10,000 to 25,000 population, and the villages in rural Zones I, II and III, that is, the rural hills and the tank-irrigated areas of the plains" (United Nations, 1961: 14)

The MPS adopted a two-stage stratified sampling design, selecting villages in the rural areas and census blocks in the urban areas at the first stage, and households at the second stage. The sampling design adopted by the study is as follows:

#### "(1) For each of the three rural Zones:

- (a) Selection of a constant proportion (1 in a) of villages, at random, from each of six strata estblished by dividing the villages by population size, viz., under 100-299, 300-499, 500-999, 1,000-1,999, and 2,000-4,999
- (b) Selection of a constant proportion (1 in b) of households, at random, in each village to be surveyed.

### (2) For the towns of 10,000 to 25,000 inhabitants taken as a group:

- (a) Selection of a constant proportion (1 in a) of census blocks, at random, in each of the fifteen towns lying within the surveyed areas
- (b) Selection of a constant proportion (1 in b) of households, at random, in each selected block

## (3) For each of the five strata of Bangalore City:

- (a) Selection of a proportion (1 in a) of census blocks, at random, from those belonging to the given stratum.
- (b) Selection of a constant proportion (1 in b) of households, at random, in each selected block " (United Nations, 1961:21).

are contiguous and each block consists of about 130 households. The investigator units were numbered on the map in concentric circular fashion. From the list of total number of households in all the investigator units in each of the 4 district headquarter-towns and in Bangalore city, samples of investigator units were drawn systematically with probability proportional to the number of households. Since the number of households did not vary significiently from one block to another, blocks within the selected investigator units were selected at random. All the households in each of the selected blocks were enumerated and 2 independent and interpenetrating samples of households were selected by simple random method without replacement.

Table 2 presents details of sampling in the MPS and Table 3 in the BPS. Although the two tables are self-explanatory, it may be noted that on the whole the MPS covered 10,663 households, as compared with 5,142 covered by the BPS. The number of currently married women aged 18-33 and their husbands interviewed in the MPS accounted for 1,403 and 1,116 respectively, while in the BPS they accounted for 2,145 and 2,043.

#### 3. Type of Schedules Used and Persons Interviewed:

Table 4 presents information on the type of schedules used and persons interviewed in the MPS and BPS. The household schedule in both the studies was administered by male interviewers to heads of households or, in their absence to responsible adult members of the households. In the MPS, fertility and attitude schedules were administered by female interviewers to currently married women aged 18-33 and married atleast 3 years prior to the survey. The attitude schedule in the MPS was also administered by male interviewers to the husbands of the currently married women. Thus the men and women to whom the attitude schedule in the MPS was administered were their own husbands and wives. But the fertility schedule in the BPS was administered by female inteviewers to ever married women aged 15-49. The attitude schedule in the BPS was administered by female interviewers to currently married women aged 15-44 in 50 per cent of the selected households and by male interviewers to husbands of currently married women aged 15-44 in the other 50 per cent of the selected households. Thus the men and women to whom the attitude schedule was administered were not spouses. This is not expected to provide any problem for comparative purposes. The problem posed by differences mainly in the broad age groups of currently married women is largly overcome by further subdividing them into various groups and focussing attention on the women belonging to the same age groups.

It must be remembered that the purposes for which the MPS and BPS were conducted were different. There is no one-to-one correspondence between the two studies. There were differences in the geographic areas covered by the two studies,

in the definitions of some of the terms used and in the structure of sentences in the interview schedules. Keeping all these problems in mind, an attempt is made in the monograph to study changes over a generation in a limited number of population parameters. Caution has been exercised wherever necessary.

## Chapter III

#### **ANALYSIS AND RESULTS**

# A. Structural Changes in the Population as Obtained from the 1951 and 1971 censuses

Before proceeding to analyse the data obtained from the two studies in the area, it seems worthwhile to gauze the major structural changes in the population of the area during the period 1951-1971 on the basis of the results from the 1951 and 1971 censuses. It is possible to make very elaborate comparison of demographic and socio-economic characteristics of the population and changes in these over time. But such a detailed comparison is not attempted in this monograph since the main objective here is to compare changes in fertility, family planning practice and related attitudinal variables in the population over a generation as could be gathered from a comparative analysis of the data available from two large scale studies. A comparison of the data available from the two censuses is carried out mainly to provide a background of the broad changes in the population against which specific changes in fertility and related variables could be studied.

A few tables, Tables 5 to 8, present some of the salient characteristics of the population of the area such as the age distribution and growth, occupational structure, literacy rates and composition by religion and caste as obtained from the two censuses. From Table 5 it can be seen that in broad age groups 0-14, 15-25 and 25+, there appear to be no significant snifts in the age distribution of the population of males and females during the two decades of 1951-1971, either in the rural plains or in Bangalore city. In the rural plains as well as in Bangalore city the population in the age group 0-14 has recorded a marginal increase of less than 3 per cent, the percentages incregsing from 40.31 to 41.89 in rural plains and from 34.73 to 37.47 in Bangalore city.

The age group 15-24 has recorded a small decline of about 4 per cent in the rural plains and 2 per cent in Bangalore city; the age group 25+ has recorded an increase of about 2 per cent in rural plains, while it has recorded a decrease of about one per cent in Bangalore city.

The increase in the proportion of children in the population is mostly due to the effects of rapid decline in child mortaility during the two decades, even in the presence of declining fertility. Though the declines in fertility could have contributed to a substantial decrease in the proportion of children below 15 years, the decline in mortality has been of such a scale in this age group that not only have the effects of fertility been counteracted but a net marginal increase in the proportion of children has been observed. The possibility of differential errors in the reporting of ages by the population in the two censuses cannot, however, be ruled out.

With regard to the growth, the population of rural plains appears to have increased at an airthmetic rate of 1.66 per cent per year and at a geometric rate of 1.44 per cent per year; Bangalore city has grown at an arithmetic rate of 4.89 per cent per year and a geometric rate of 3.47 per cent per year. The high rate of growth in Bangalore city is mostly due to migration from rural areas. The population growth appears to have been the maximum among children below 15 years and the minimum among the adolescents and young adults of the age group 15-24.

Table 6 presents the proportion of the workers in the rural plains and Bangalore city in 1951 and 1971 according to the sector of activities of the workers. The primary sector is essentially made up of agricultural labourers, tenant cultivators, and owner cultivators and those employed in mining, forestry, etc. The secondary sector is made up of those employed in industries, including the household industries and production other than cultivation and the tertiary sector is made up of construction workers and those employed in trade, commerce, transport, communication and other public services. From Table 6, it can be seen that there is practically no change either in the rural areas or in the urban areas in the three broad categories of the occupational structure the population. There is a marginal increase in the proportion population employed in the primary sector, namely, agriculture from 1951 to 1971 and a marginal increase in those employed in the secondary sector in Bangalore city. The proportion employed in the tertiary sector has recorded a marginal decline in both the This table reveals that there has been no significant transfer of population from agriculture to industries in the rural areas.

Table 7 provides rates of literacy among men and women in rural plains and Bangalore city in 1951 and 1971. The overall literacy rate, literacy being defined as the ability to read and write in at least one language, has increased from 14 to 24 per cent in the rural plains and from 43 to 59 per cent in Bangalore city. The increase in literacy as a percetage to the base figure is substantially higher among women both in rural areas

and in urban areas, the percentage increasing from 5 to 13 in rural areas and from 31 to 51 in Bangalore city. However, even in 1971 the proportion literate is significantly higher among men than among women in rural plains as well as in Bangalore city.

Table 8 provides the distribution of the population by different religious denominations and by major caste groups within Hindus in 1951 and 1971 in rural plains and Bangalore city. There does not appear to be any major changes in the religious distribution of the population in the area excepting that the proportion of non-Hindu population in rural plains and Bangalore city has recorded a marginal decrease possibly because of migration to other areas. The Hindu population has increased from 93.5 per cent in 1951 to 94.2 per cent in 1971 in the rural plains and from 73.9 to 77.0 per cent in Bangalore city. Among Hindus, there is a marginal decrease in the proportion of scheduled castes and scheduled tribes, from 21.3 to 20.9 per cent in rural plains and 11.7 to 9.9 per cent in Bangalore city. The changes in the definition of schedule castes between 1951 and 1971 and differential migration might have contributed to these changes. From an analysis of the population reporting Kannada as their mother tongue in 1951 and 1971, it is found that this proportion has significantly increased during the two decades, from 59.0 to 75.0 per cent in rural plains and 23.8 to 31.8 per cent in Bangalore city.

#### B. Comparison of Results from the Two studies:

Tables 9-26 present comparable data on selected indicators of current fertility, cohort fertility, survivorship-ratios and selected attitudinal variables of the population as obtained from the Mysore Population Study (1951) and the Bangalore Population Study (1975). Though the two studies have given rise to a large number of tables relating to fertility, mortality, family planning practice, etc., for a comparative analysis, tables have to be selected with a great deal of caution because of definitional differences of the terms used in the two studies and consequent lack of comparability of the results. Geographical comparability was achieved by identifying overlapping areas of rural hills, rural plains, towns and Bangalore city in the two studies as described in the earlier chapter. The process of selection of tables with comparable results from both the studies could yield information only on a few variables, objective as well as attitudinal, and the present monograph aims only at a comparison of variables relating to fertility and family planning practice and selected knowledge and attitudinal variables relating to these factors.

Tables 9-11 provide data on current fertility levels, at the two points of time surveyed in 1951 and 1975, and the correction factors applied to the estimates in the MPS, Tables 12 to 15 on the number of children born, number alive and survivorship-ratios in broad age groups as obtained from the two studies, Tables 16 to 20 on the attitudes regarding ideal family size and desire for additional children and motives for family

planning as obtained from the two studies, and Table 21 to 26 on the extent of knowledge and practice of family planning in the two studies.

#### **Current Fertility**

Tables 9 and 10 present comparable data on selected indices of current fertility available from the Mysore Population Study (1951) and the Bangalore Population Study (1975). Table 9 presents the various estimates of fertility such as, the crude birth rate, general fertility rate, general marital fertility rate, general ever-married fertility rate (for ever-married women) and age specific marital fertility rates, separately for rural hills, rural plains, towns and Bangalore city based on the data available from the two studies. From this table it can be seen that in the crude birth rate there has been a decline of 7.6 points in the rural hills, 2.0 points in the rural plains, 4.5 points in the towns and 2.6 points in Bangalore city over the 24-year period. These declines in fertility are small considering the fact that the time lapsed is almost area has been the venue of implementation of a generation and that the intensive programme of family planning for over a decade from 1962-63. If we consider the general fertility rate, based on all women aged 15-44, there is a substantial decline in the index in all the areas - rural hills, rural plains, towns and Bangalore city - while with regard to general marital fertility rate or general ever-married fertility rate there is hardly any decline. The general fertility rate has declined by 17 per cent in the rural hills and 19 per cent in the towns; the general marital fertility rate has declined only by 6 per cent and 5 per cent in these two areas. This indicates that even small decline observed in the crude birth rate can be attributed. assuming data to be reliable, mostly to changes in the age-marital status distribution of the population than to change in marital fertility.

Computation with the number of couples protected in 1974-75 by various family planning methods adopted within the programme in the earlier years and the births averted by them indicate that even the programme acceptors would have contributed to a 10 per cent decline in marital fertility rate or about 4 points in the crude birth rate of 1951, without assuming any additional effects due to structural changes in the population. We have to, also, add to this the effects of acceptance outside the programme and the fertility effects of non-programme factors. Thus we are faced with a paradoxical situation wherein the declines in the marital fertility rates that could be expected because of couples accepting family planning methods, even from within the programme from 1961 have not been observed from a comparision of the marital fertility rates in the two studies. Where have the effects of family planning programme gone?


It is possible that the birth rates in different areas in the Bangalore division in 1951 could have been underestimated by the Mysore Population Study, or in the present

Bangalore Population Study could have been overestimated. Or, there could have been set in operation during the past two decades a set of forces that had contributed to an increase in the potential fertility of the married women in the area even in the presence of a strong family planning programme. More than one of the above three factors could have been in operation simultaneously or sequentially during the past two decades. Available evidence from the nature of social and cultural changes taking place in the population indicates that the most likely set of factors responsible for this small decline in the birth rate during the past 24-year period is the fertility increasing effects of modernization in the particular socio-cultural context and an almost total eradication of malaria from the region and improvements in the general health conditions of the people.

In the study area, for a long time in the past, there had been in operation a large number of traditional checks on fertility placed by cultural and social factors. They include prolonged abstinence by couples after the birth of a child owing to the mother going to her parents' home for delivery and remaining there for a considerable length of time, taboos regarding sexual intercourse on certain days of the month for religious or for social reasons, prolonged breast feeding, prohibition of widow remarriage, etc. Many of these cultural or social checks on fertility can be expected to be loosened because of modernization and in the absence of higher rate of adoption of modern methods of family planning with greater effectiveness, the potential fertility of the population can be expected to increase. Also, from the available records it is found that the population of the Bangalore divison has been subjected to frequent epidemics of malaria over a number of decades in the past and many hill tracks of the area have been declared endemic for malaria. It is well known that malaria could reduce the fecundity of the population and contribute to increased secondary sterility. Massive anti-malarial programmes which have been implemented in this area during the '50s and '60s could have contributed to an increase in the fertility of married couples.

The above hypothesis that modernization has contributed to an increase in the potential fertility of the couples is empirically validated from a comparison of age specific marital fertility rates obtained from the two studies and presented in Table 9. A graphic presentation of the age patterns of fertility in 1951 and 1975 in Bangalore city and towns is given in Charts 1 and 2 respectively. In the rural hill areas, there has been an increase in marital fertility in all the age groups excepting 25-29 during the period 1951-1975. In the rural plains, towns and Bangalore city there has been an increase in the marital fartility rates in the age group 15-19 and 20-24 and excepting in rural plains there has been an increase even in the age group 25-29 in the other two areas. In towns and Bangalore city, there has been a substantial decrease in the marital fertility rates of older women of 30 years and above. This indicates that the fertility declines observed in towns and cities are mostly among older women caused essentially by fertility limitation practices as judged from the wide acceptance of sterilization among the acceptors of



modern methods of contraception. An analysis of the extent of acceptance of various methods of family planning from the various service centres operated under the official programme of family planning, during 1962 to 1975, when intensive family planning programme was in operation throughout the country, including the state, reveals that in Bangalore division almost 80 per cent of the new acceptors of modern method of family planning had accepted sterilization. The increase in the marital fertility rate among the younger age groups can be taken to be indicative of a possible reduction in the spacing of children caused by relaxation of the traditional checks which wer responsible in the past to an increased spacing of children. In this connection it is worthwhile pointing out that an increase in the marital fertility rate of women in the age group 15-19 is consistent with an increase in age at marriage, from 14 to 17 for girls from 1951 to 1975. The effects of social and cultural practices prevalent in

the area have been largely to increase spacing between births rather than to limit the number of births, for which the traditional methods are ineffective. Modrenization, by removing these checks, can be expected to shorten the average interval between children and the extent such couples adopt limitation practices later can be expected to alter the age specific fertility patterns, as observed in the data, by increasing fertility rates in the younger ages and by reducing in the older ages. known that the intervals between successive births in India have been consistently long with an average of 36 months as obtained from various studies in the '50s and '60s and one of the reasons for such long intervals is the prolonged lactation and low fecundability caused by cultural and religious taboos regarding sexual intercourse and possibly due also to malnutrition and diseases. One implication of this comparative analysis is that even in the presence of a strong family planning programme it is possible that the marital fertility rate or crude birth rate need not record a substantial decline when the fertility decreasing effects of planning methods are counteracted by the couples adopting family increasing effects of modernization which tend to release the traditional checks on

fertility. For some years, it is possible that as a consequence of these two opposing effects of modernization, fertility may decline rather slowly or even fluctuate around a level of 35 and only when the relaxation of the traditional checks on fertility are fully counter-balanced by a sizeable number of acceptors of modern methods of family planning, that a steady decline in the birth rate This phenomenon seems to be unique for countries where could be expected. there have been strong traditional socio-cultural checks on fertility and when family planning programme is implemented in the context of modernization which tends to loosen these traditional checks. The Western experience of contraception with modern methods causing a steady decline in the crude birth rates or specific marital fertility rates does not appear to be relevant in the cultural contexts of countries like India. Various anthropological studies carried out India seem to substantiate the view that modernization tends to loosen the traditional social and cultural checks on fertility.

The Mysore Population Study (1951: 135-137) identified a number of popular opinions reflecting traditional checks on fertility. These related to the discouragement of women from having any more children when their own sons and daughters start having children, long periods of abstinence after the birth of a child and long intervals between births. But recent anthropological studies show that traditional checks on fertility are becoming weak as a result For example, Karve (1968: 269) observes, "A girl generally goes modernization. to her parents' house in the 7th month of her pregnancy and returns to husband's home when the baby is three months old. Besides this there numerous other occasions on which a married woman visits her parents' home and stays there with her children. During the first few years of marriage such visits are numerous and prolonged.... In olden days when large joint families were common such a procedure did not incommode the husband too greately; but now-a-days when husband and wife live together in a small house with husband serving as a Government servant or in a mill as a labourer, the wife's departure and long absences compel the husband to cook for himself. field work throughout the south and in Maharashtra I found such people again and again in their lonely unkempt houses cadging for a meal at the houses their friends and tired of cooking for themselves." When they are tired of cooking for themselves, men call back their wives from their parents' home earlier. This naturally results in earlier resumption of sex relations and earlier conception.

Widow remarriage was not common in the olden days. But in recent years, widow remarriage is legally permitted in India and socially in many communities. Karve (1968: 382) says, "..... now Brahmin widows can marry without the fear of social ostracism as far as the bigger cities are concerned."

Mandelbaum (1974: 60-75) has made a succinct analysis of various traditional patterns of behaviour which led to reduction in fertility. It should be mentioned, however, that the manifest aim of many of the traditional patterns of behaviour was not reduction in fertility. But they resulted in unintended reduction in fertility, mainly through longer birth intervals which were caused by temporary separations between men and their wives due to the latter going away to their parents' homes for confinements, and prolonged breast-feeding of children. But modernization seems to shorten birth intervals and result in a spurt in fertility. On the basis of analysis of NSS data, Mandelbaum (1974: 26-27) observes: "A marked shortening of birth intervals seems to have occurred in recent decades. Rural women who had been married before 1941 showed an average interval of 40.80 months in a large nationwide sample; those married after 1941 averaged 33.47 months. The comparable figures for the samples, of urban women were 37.60 and 30.97 months."

Some traditional patterns of behaviour were directly aimed at reduction in fertility. When a woman's daughter or daughter-in-law gives birth to a child, she develops what is called "grand-mother complex" and tries to be sexually passive so as to avoid pregnancy; otherwise, she is subject to such community criticism as "She is now competing with her daughter to have a child "or "It is time she showed less interest in wordly pleasures" (United Nations, 1961: 133). Mandelbaum (1974: 29) makes a similar observation: "A woman whose children are old enough to be having children of their own may feel herself demeaned if she becomes pregnant again, particularly if there is a daughter-in-law in the house." Such popular opinions led to reduction in fertility.

Table 10 presents information on selected fertility indices by occupational groups in rural areas (rural plains and rural hills combined) in the two studies. The index has been computed by taking the fertility rate for all occupational groups as 100 and computing, the rates for each specific group as a related measure. This was necessary since the Mysore Population Study (1951) presented data in such a format. From this table, it can be seen that the fertility of labourers or temporary tenants engaged in agriculture has recorded a relative increase as judged by all the fertility measures, and the increase has been quite striking in the general fertility rate where it has jumped from 84 in 1951 to 114 in 1975, that is, by 36 per cent. For those engaged in other agricultural occupations, there has been a small decline in all the fertility measures and for those engaged in non-agricultural occupations there has been very little change. The findings from this table are relevant only to the area under study and cannot be generalised for the whole population.

Table 11 presents estimates of corrected and uncorrected birth and death rates for different zones in the Mysore Population Study. The table is presented mainly to illustrate the fact that the rates published in the Mysore Population Study have been obtained after application of necessary correction factors computed

by comparison of survey data with those obtained from another independent survey or registered records. With regard to birth rate, there has been an increase of almost 3 to 4 points in most of the zones because of the application of the correction factors and any errors in the application of the correction factors could have altered the estimates and such a possibility has to be borne in mind while comparing the results of 1951 study with those of the 1975 study.

### 2. Cohort fertility and survivorship of children

Tables 12-15 provide data on the mean number of children born, mean survivorship-ratios and differentials by religion and number living. obtained from the two studies. Table 12 provides data on the mean number of children born to women in different age groups in the rural hills, rural plains, towns and Bangalore city as obtained from the two studies. The surprising result that one gets from this table is that in the rural hills and rural plains there has been an increase, not to be considered small, in the average number of children born The 1975 study has revealed that in the towns, to women in every age group. too, the average number of children born per woman in all the age groups, with the exception of 25-34, is the same as or higher than that born per woman as revealed by the 1951 study. In Bangalore city there has been an increase in all The increase appears to be substantial in the older age groups. It can be hypothesised that this increase in total fertility can be attributed to the combined effects of the following two factors:

- A relatively greater under-enumeration of children in the Mysore Population Study; and
- ii) A real increase in the potential fertility of the women during the period 1951-1975 as an effect of modernization relaxing some of the traditional checks on fertility as explained earlier.

The possibility that there has been a substantial under-enumeration of children, especially of the older women in the rural areas, rural hills and rural plains, in the Mysore Population Study (1951) arises from the fact that the number of children born to women in the age groups 35-44 and 45+ are much lower than the number of children born to women in these two age groups in towns and Bangalore city, though the urban areas have reported much lower current fertility rates compared to the rural areas. It is also possible that there has been some omission in the number of children ever born in the urban areas as well, in the 1951 study though the omission appears to be much less than in the rural areas. Since the Bangalore Population Study adopted a detailed pregnancy history schedule with a number of check questions and the trends in the number of children born to women in different age groups are consistent with the age patterns of cumulative fertility curve, it can be expected that the estimates

of the number of children born obtained from the Bangalore Population Study are very close to the true values. However, the fact that the cumulative fertility curve in rural and urban areas even in the Bangalore Population Study in 1975 does not show much difference is indicative of the small changes in fertility differentials that exist between the rural and urban areas in terms of cohort fertility measures. This finding has to be analysed in the light of the observation made earlier that there has been substantial rural-urban differentials in terms of current fertility measures. It is also to be recognised that the fertility-increasing effect of modernization, as described in the earlier section, could have counteracted the effects of family planning even in terms of cohort measures as in the case of current measure of fertility and that the traditional checks can be expected to be liberalized more in the urban areas than in the rural areas.

Table 13 provides data on the mean number of children living for women in different age groups in rural hills, rural plains, towns and Bangalore city. The differentials in the case of number of children born presented in Table 12. For example, in rural hills, the mean number of children born per woman in the age group 25-34 according to the 1951 and 1975 studies was 3.5 and 4.1 respectively; the mean number of children living according to the two studies was 2.3 and 3.5 respectively. The increase in differential can be mainly attributed to a substantial decline in mortality during the 24-year period, which is found to be more in rural areas than in the urban areas. For example, in Bangalore city, in the same age group 25-34, the average number of children born, as reported in the two studies, was 3.2 and 3.4 respectively, while the average number of children living was 2.4 and 2.9 respectively. The average number of children reported for women of 45+ years in all the areas in the Mysore Population Study is much lower than the average number of children living for women of the age group 35-44, suggesting a strong under-reporting of children of the older women in the study.

Table 14 presents data on the survivorship-ratios of children living to children born in different geographical zones in the two studies. This table dramatically presents the decline in mortality and the consequent increase in the survivorship-ratios of children for women in every age group. There does not appear to be any age differential in the proportionate increase in the survivorship-ratios between the two studies. It is possible that the survivorship-ratios of children of women of older ages have been relatively over-estimated since for older women there is the likelihood of a greater under-reporting of the number of children living, which will be in the numerator. This positive bias can be expected to be more in the earlier study and whenever necessary corrections for such a bias are made, it can be expected that the relative increase in the survivorship-ratios would be higher among older women than among the younger women.

Table 15 provides data on the mean number of children born in different geographic zones in the two studies classified by religion and caste of the household. It can be seen, as noted earlier in Table 12, that in every religious group, as well as in caste group among Hindus, there has been a substantial increase in the average number of children born between the two studies indicating an increase in fertility. This increase is found to be substantial among scheduled castes and backward castes, indicating partly a higher level of under-reporting of children in these two castes in the earlier study and partly increased potential fertility because of various health and social welfare programmes launched with special focus on these communities during the past two decades. For example, the average number of children born for ever-married woman in the age group 15-49 for scheduled castes surveyed in towns, in the Mysore Population Study in 1951, was found to be 2.8 and for the same category of women surveyed in the Bangalore Population Study in 1975 it was found to be 3.5. Similarly, for a backward caste woman the figures were found to be 2.9 in the Mysore Population Study and 3.5 in Bangalore Population Study. The fact that the increase in the average number of children born during the past two decades is found to be larger among women from lower socio-economic strata substantiates the point made earlier that with public health programme, essentially the anti-malarial and immunization programmes, the potential fertility of the population seems to have increased. In both the studies, the average number of children born is significantly higher among the Muslims than among the other religious groups.

### 3. Opinions and Values Regarding Family Size

Tables 16-20 present comparable data on the opinions of married women and their husbands on selected fertility-related variables as obtained from the two studies. Table 16 provides information on the ideal family size or the average number of children desired by currently married women and their husbands as reported in the two studies. In this connection it may be pointed out that there have been differences in the method of obtaining the opinion on ideal family size or desired family size between the two studies. In the Mysore Population Study, each woman was asked on the ideal number of children a couple should have without any special reference to the number of children the respondent had at the time of the survey. In the Bangalore Population Study, each woman was asked on the additional number of children she would like to have and this figure was added to the number of children she has already had at the time of the survey in order to obtain the desired family size. The latter procedure can be expected to give a higher value than the former ideal family size, since a woman already having a large family will automatically have a higher desired family size and this may not be the case according to the procedure adopted in the Mysore Population Study. Further, while in the Mysore Population Study the husbands and wives in the same selected households were interviewed separately by male and female interviewers, in the Bangalore Population Study the husbands and wives were interviewed in alternate households in the sample.

Table 16 reveals that even according to the procedure adopted in the Bangalore Population Study, which tends to give a higher estimate for the desired number of children, the desired family size according to the Bangalore Study (1975) is lower than what was reported in the Mysore Population Study (1951), indicating a fall in the number of children desired during the span of 24 years. For example, the ideal family size reported in rural plains according to the women interviewed in Mysore Population Study was 4.7, while the desired number of children according to the Bangalore Population Study was 4.2, which itself is an over-estimate. Thus there is indirect indication from this table that the ideal family size of the population has fallen over the 24-year period.

Table 17 provides data on the ideal family size according to the Mysore Population Study and the desired family size according to the Bangalore Population Study classified by the educational level of the wives, educational level of the husbands and the economic status and religion of the respondents. The data have been provided as available from the two studies. The differentials of ideal and desired family size between the two studies indicate that the differential by education are larger among the husbands than among the wives. For example, high school educated husbands had an ideal family size of 3.9 in the Mysore Population Study and a desired family size of 3.2 in the Bangalore Population Study. On the other hand, the middle school or high school educated wives had an ideal family size of 3.7 in the Mysore Population Study compared to 3.4 in the Bangalore Population Study. The differentials according to economic status indicate that the desired family size has fallen in all occupational groups. There does not appear to be any change in the desired family size of the Muslims between the two study periods, while for Hindus there has been a reduction in the desired family size.

Table 18 presents data on the proportion of women and their husbands who desired any more children at the time of the Mysore Population Study compared with similar information from the Bangalore Poulation Study, classified according to the parity (number of live births) of the respondents in rural plains and Bangalore city. As in the case of ideal family size, even here there was a subtle difference between the method of questioning adopted in the two studies. When the woman in the sample household was pregnant at the time of enquiry, the Mysore Population Study, enquired of the respondent's desire for additional children including the current pregnancy. On the other hand, the Bangalore study has enquired of the desire for additional children excluding the current pregnacy. The latter procedure can be expected to provide a lower proportion of the respondents desiring additional children than the former procedure and any observed difference between the two studies should take into account this under-estimation in the latter study.

In Bangalore city, of all the women respondents interviewed in the Mysore Population Study, while only 43 per cent did not desire any additional children, in the Bangalore Population Study. 64 per cent of the same category of respondents did not desire any additional children; while among those with large family, that is, 4 to 6 children, in the Mysore Population Study 72 per cent of the women did not desire additional children, in the Bangalore Population Study, 92 per cent did not desire any additional children. With regard to the males interviewed in the two studies, while only 28 per cent of all the husbands interviewed in the Mysore Population Study in 1951 did not desire any additional child, 60 per cent of those interviewed in the Bangalore Study in 1975 did not desire any additional children; and among those with large family, 4 to 5 children, while 56 per cent of the husbands interviewed in 1951 did not desire to have any more children, 87 per cent of the husbands interviewed in 1975 did not desire further children.

In the rural plains, among women respondents while 31 per cent of the women interviewed in 1951 did not desire any additional children, 46 per cent of those interviewed in 1975 did not desire any additional children. Among those with large family, that is, 4 to 6 children, while 59 per cent of those interviewed in 1951 did not desire any additional children, 71 per cent of those interviewed in 1975 did not desire any additional children. Similarly, among the husbands interviewed while only 20 per cent of those interviewed in 1951 did not desire any additional children, in 1975 this percentage has incresed to 51 and among those with large family, 4 to 6 children, the increase was from 48per cent to 74 per cent. Further, it may be seen from the table that the proportion giving vague or indifferent answers to the question "Do you desire more children", has dropped almost to a zero level in 1975 from about 8 to 10 per cent in 1951. This may be taken to be an indication of development of definitive ideas for additional children among the population. Thus both in Bangalore city as well as in rural plains, among wives as well as husbands, there is a substantial increase during the period 1951 to 1975 in the proportion of the couples in reproductive ages who do not desire any additional children. This increase is found in every parity group as well as among the wives and husbands. The increase in the number of respondents who desired no more children is found to be relatively higher among the husbands than among the wives.

However, as mentioned earlier, part of this difference could be attributed to differences in the questioning of the pregnant women covered by the two studies. It is necessary to understand the extent of the real differences, excluding artifacts introduced by questioning procedures. Since there was no difference in the questioning procedure for the non-pregnant women, comparison of responses regarding desire for an additional child from non-pregnant women in the two studies can be expected to be more valid than comparison of responses from all women. The differences in the results from the two studies appear to be considerably narrowed down in such a case. Table 19 provides data on the

proportion of wives and husbands who desired to have at least one additional child reported pregnacy status of the wife at the time of the survey in classified by the In Bangalore city, the proportion desiring an additional child at the two studies. the time of the survey has come down from 46 per cent to 32 per cent among all women, 49 percent to 43 percent among women with 1-3 children, from 17 to 9 among women with large family of 4 to 6 living children. Among the husbands interviewed in the city, the proportions have changed from 57 to 38 per cent among all husbands, 64 to 50 amongst those with 1 to 3 living children, and from 22 to 12 among those with 4 to 6 living children. In rural plains the differences in the percentages between the two studies are still narrower for women; from 59 to 55 for all women; a slight increase from 63 to 71 among women with 1 to 3 children, and 33 to 31 among women with 4-6 children. Among the husbands the change is slightly more pronounced; from 73 to 48 among all men, 81 to 67 among men with 1-3 living children and from 35 to 26 among men with 4-6 living child-It would have been more appropriate to compare such proportions for women of ren. husbands classified by the actual number of living children than grouping them as those with 1-3, 4-6 etc. Any changes in the actual distribution of women within each class intervel, between the two studies, can add to or mask the real differences. be concluded from this analysis that the desire for additional children has generally declined among men and women of all parities between the two studies, the decline is relatively more among husbands than among wives but not dramatic enough, as could be expected initially, in the context of a strong family planning programme since the sixties.

Table 20 provides the percentage distribution of married women and their husbands who did not desire any additional children by motives. The motives have been classified into three broad groups viz., economic motives, non-economic motives including health and other personal reasons, and others including ill-defined motives. The table reveals that even in 1951 in Bangalore city as well as in rural areas, the economic motives were dominant for those who did not desire any additional children. As could be expected economic motive was more prevalent among the husbands than among the wives. Non-economic motives such as the health motives were expressed mostly by the wives. In 1951 not one husband interviewed in the rural area expressed health motive for wishing for no more children. By 1975 there has been a substantial increase in the economic motives as the basis for not desiring any additional children both among the husbands as well as among the wives. For example, in Mysore Population Study, in 1951, 68 percent of the husbands interviewed stated economic motives for not desiring any additional children; in 1975, this proportion has increased to 85 per cent. These data are strongly indicative of increasing economic aspirations of the people and added perception of the linkage between family size and economic well-being. In Bangalore city as well as in rural areas, among husbands, the proportion with the ill-defined motives has declined substantially while, among women, there seems to be an increase in the proportion giving ill-defined motives.

#### 4. Knowledge and Practice of Family Planning

Tables 21-25 provide comparable data from the two studies, on the knowledge of various family limitation methods in Bangalore city and rural plains and the proportion reporting use of various methods. Since the term "family limitation methods" has been used in the Mysore Population Study to indicate both spacing and limitation methods, the same term has been used in this report. Table 21 provides data on the percentage of married women and their husbands reporting knowledge of any family limitation methods in the two studies. In Bangalore city, in 1951 only 37.6 per cent of the women interviewed reported to have knowledge of some method of family planning; by 1975, this proportion has increased to 70.5 per cent. In the rural plains, the proportion with knowledge has increased remarkably from 10.7 per cent in 1951 to 90.5 in 1975 among the married women. Among the husbands interviewed the increase is from 37.8 per cent in 1951 to 80.9 per cent in 1975 in Bangalore City, and from 37.8 per cent in 1951 to 80.9 per cent in 1975 in Bangalore city, and from 14.9 percent in 1951 to 93.2 per cent in the rural plains. This table reveals that, while in 1951 only a small proportion ( 10 to 15 per cent) of the husbands or wives in the rural plains of the area had any knowldge of family planning methods in 1975 this proportion was over 90 per cent. It is interesting to note that while in 1951 the proportion of couples having knowledge about family plannig was higher in Bangalore city than in cural areas, the picture has changed by 1975 with a higher proportion of rural population reporting knowledge of family limitation methods than the urban population. This is possibly because of the fact that mass sterilization camps have been coudcted in rural areas in large numbers since 1965 and the sterilization programmes were more well known to the population in the rural areas than This table reveals the extent or explosion in the knowledge in the urban areas. of family planning during the past 24 years, which is a great tribute to the mass educational activities undertaken under the National Family Planning Programme.

Tables 22 - 24 are confined only to Bangalore city. Table 22 presents the percentages of married women and their husbands with knowledge of specified methods of family limitation by age of the respondent, as obtained in the two Among female respondents, while 9.2 per cent of those interviewed in the studies. 1951 study had knowledge of safe period or withdrawal; in the 1975 study, proportion was found to be 9.0 per cent indicating practically no change in On the other hand, with regard to knowledge knowledge of these natural methods. of condom, the increase is from 9.0 per cent in 1951 to 63.2 per cent in 1975; with regard to knowledge of vasectomy from 8.6 per cent to 67.3 per cent; with regard to knowledge of tubectomy from 26.2 per cent to 67.8 per cent and with regard to knowledge of other conventional methods of contraception like diaphragm and jelly etc. from 5.8 per cent to 10.8 per cent, There has been really an explosion of knowledge of modern methods of family planning among women without any significant increase in the knowledge of natural methods.

Among the males interviewed in the two studies, a similar picture emerges with much greater increase in the knowledge of the modern methods of family For example, the proportion of husbands reporting knowledge of condoms increased from 10.5 per cent in 1951 to 81.1 per cent in 1975; of vascectomy from 16.9 per cent to 77.3 per cent and of tubectomy from 25.7 per cent to 78.5 per cent. But among males the proportion having knowledge of safe period or withdrawal decreased from 11.4 per cent in 1951 to 4.7 per cent in 1975. Thus both among the females as well as among the males there has been an explosion of awareness and knowledge of various modern methods of family planning. All the age groups seem to have uniformly experienced this knowledge explosion. On the other hand, among husbands there seems to be a decline in the proportion of those having knowledge of safe period or withdrawal suggesting that the traditional methods of abstinence or controlled sexual life as methods of spacing or limitation are disappearing from the population.

Table 23 presents the data from the two studies on knowledge of different methods of family planning among husbands and wives, classified by literacy levels-Among women respondents in 1951, knowledge of safe peried or withdrawal method was diretly proportional to literacy level. The proportion of women with such knowledge increased from 3.1 per cent among illiterates to 45.5 per cent among those with high school or university education. By 1975 this sharp defferential by education has been considerably narrowed down with the proportion of women having knowledge of safe period or withdrawal is 5.5 per cent among illiterates and only 10.8 per cent among high school or college educated women. On the other hand, with regard to the modern methods of contraception such as condoms, vasectomy, tubectomy and other conventional contraceptives, while these were substantial defferentials in the proportion having knowledge according to the educational status of the women in 1951, these differentials have been narrowed down considerably (practically wiped out) by 1975 with substantial increase in knowledge in all educational categories. The knowledge differentials among educational categories are lower with regard to sterilization than condoms. The increase in the knowledge of sterilization method among the uneducated is really striking. For example, with regard to vasectomy while only 1.5 per cent of the illiterrte women had any knowledge of the method in 1951, by 1975 this proportion has jumped to 62.2 per cent Similarly, while only 7.8 per cent of the husbands who were illiterate reported knowledge of vasectomy in 1951, this proportion increased to 65.8 per cent by 1975. The sharp differentials in the knowledge of modern methods of family planning which were observed both among the husbands and wives in 1951 are not seen by 1975 and it is a credit to the family plenning programme in the country and in the region to have broughd awareness and knowledge of modern methods of family planning to illiterate people in rural areas within two decades.

Table 24 presents data on the percentage of husbands of currently married women with knowledge of specified methods of family limitation by occupation of

the husbands in Bangalore city. It can be seen that in all occupational classes the proportion reporting knowledge of safe period or withdrawal has declined during the period 1951 - 1975. For example, among proffessionals the proportion reporting knowledge of the method was 24.4 per cent in 1951 and this has come down to 8.3 per cent in 1975. On the other hand, the proportion having knowledge of modern methods of contraception, namely, condoms vasectomy and tubectomy has increased significantly in all occupational groups and whatever differentials by occupation were observed in 1951 had been practically removed by 1975. example, among high and low grade manual workers the proportion having knowledge of condoms increased from 5.6 per cent to 81.7 per cent, of vasectomy from 6.3 to 87.3 per cent, and of tubectomy from 18.2 to 86.6 per cent during the It is interesting to note that among professional occupational period 1951 1975. groups even as early as 1951, 34.8 per cent of the husbands interviewed in Bangalore city had knowledge of tubectomy as a method of family limitation, 25.0 per cent had knowledge of vasectomy and 16.8 per cent had knowledge of other methods of contraception.

Tables 25 provides percentage distribution of married women and their husbands reporting use of family limitation methods, in Bangalore city and in rural plains, from the two studies. The proportion of married women who reported to have used any method of contraception was 9.5 per cent in 1951 and this has increased to 31.5 per cent in 1975. Among those in the rural plains, the porportion reported to have used any method has increased from 2.3 per cent in 1951 to 16,7 per cent in 1975. Among the husbands interviewed in Bangalore city, the proportion who ever practised contraception had increased from 5.8 per cent to 34.1 per cent and in rural plains from 0.6 per cent during 1951 to 1975. Analysis by different methods reveals that the proportion who had reported practice of abstinence as a method of family planning has declined almost to a zero level by 1975, compared to 1951. For example, in Bangalore city while 6.7 per cent of the women had reported practice of abstinence as a method of family planning in 1951, by 1975 this percentage has dropped to 0.3 per cent. On the other hand, the proportion of women in Bangalore city who reported to have used any modern methods of family planning increased from 2.8 per cent in 1951 to 31.2 per cent in 1975.

Table 26 provides, for Bangalore city, an analysis of the reported proportion of husbands and wives using abstinence or other methods of family limitation in 1951 and 1975, classified by different socio-economic variables, ie., educational level of the wife, educational level of the husband, economic status of the respondent, type of family, age of the wife and age of the husband. The following two observations can be made on this table:

- i) There has been a substantial increase in the proportion reporting practice of modern methods of family limitation in all socio-economic and age categories during the 24-year period. However, there are strong differentials in practice dy educational status of the wife, persisting even in 1975. For example, while only 0.7 per cent of the illiterate women of Bangalore city had reported use of any method of contraception other than abstinence in 1951, this proprtion has increased to 14.0 per cent in 1975. On the other hand, among high school and university educated women, the increase is from 25.4 per cent to 44.4 per cent during the The differentials with regard to the proportion using contraception, same period, by educational status of women, seem to be larger than the differentionals with regard to knowledge (Table 13) indicating that use of a family limitation method is related more to socio-economic category of the couple than to knowledge of the method. There has been an increase in the proportions practising contraception among couples living in all occupational categories and type of family and of different age groups. But the increases in the proportions of couples practising contraception are higher among those with wives in older age groups, living In nuclear families and with husbands with higher education.
- ii) It is noticed that the proportion practising abstinence as a method of contraception has significantly fallen in every socio-economic group and is practically dying out as a method of contraception. This in indicative of the extent to which modernization has been removing some of the traditional checks on fertility such as abstinence and other natural methods, substantiating the earlier hypothesis that with modernization the traditional checks on fertility will be relaxed and potential fertility of the population will be increased for a temporary period of time.

## Chapter IV

#### SUMMARY AND CONCLUSIONS

The Mysore Population Study conducted in 1951 in the then state of Mysore and the Bangalore Population Study conducted in 1975 in Karnataka State under the auspices of the India Population Project have in common a number of attitudinal and behavioural variables relating to fertility and family planning and also have a sizable overlapping geographical area. Comparison of the findings on selected fertility and family planning parameters of the population from the two studies offers a rare opportunity for investigating the type of changes that have taken place in fertility, current well as cumulative, opinions and values regarding family size and knowledge and practice of different methods of family planning in the population of selected areas of Karnataka State over a generation, 1951 to 1975. It is rarely that two large scale sample studies of this magnitude, pertaining population parameters, have been conducted in the same population with a gap of 24years.

Before providing the relevent results on the basis of the comparison of the data from the two studies, a detailed description of the geographical area covered, sample size, sample design adopted and the nature of questions included in both the studies have been discussed. From such an analysis data with regard to comparable geographical areas are compiled from the two studies and analysed in this monograph. The analysis has been presented only for fertility and related variables, including attitudes to family planning and contraceptive practice, since information on these variables is considered to be more reliable in both the studies. The analysis has been made separately for rural hills, rural plains, towns and Bangalore city, a startification based on geographical terrain adopted in the Mysore Population Study.

A brief analysis of the structural changes in the population during the period 1951 to 1971 as obtained from the two censuses in the area conducted in these two years has been presented. Comparison has been made on salient characteristics of the

population of the area such as the age distribution and growth, literacy rates and composition by religon and caste as obtained from the two censuses. A study of the distributions of the population in these characteristics in the years 1951 and 1971 reveals that there has been very little change in the structural characieristics of the population. With regard to age distribution there is a marginal increase in the proportion of chidren below 15 year of age during the 20-year period, which is mostly due to the effect of rapid decline in child mortality during the two decades, even in the presence of small decline in fertality, There are virtually no changes with regard to occupational structure and religious composition of the population. The levels of literacy among men as well as women recorded a significant increase during the 20-year period, the proportion literate being significantly higher among men than among women in rural as well as in urban areas. There has been a significant increase in the proportion of population speaking Kannada, the official State language, both in rural areas as well as in Bangalore city.

An analysis of the levels of current fertility in 1951 and 1975, as obtained from the two studies, reveals that the crude birth rate has recorded a decline of 7.6 points in the rural hills, 2.0 points in rural plains, 4.5 points in towns and 2.6 points in Bangolore city over the 24-year period. These declines in fertility are small considering the fact that time lapsed is almost a generation and that the area has been the venue of implementation of intensive programmes of family planning for over a decade 1962-63. The reduction considerd in terms of general marital fertility rate is much smaller, of the order of 5 to 6 per cent, indicating that a good portion of even the small reduction in the crude brith rate can be attributed to structral changes in the population, mainly changes in the age distribution.

Computations based on the number of couples protected in 1974-75, by various family planning methods adopted from within programme in the earlier years, and the birth averted by them, indicate that even the programme acceptors would have contributed to a 10 per cent decline in general marital fertility. Thus a paradoxical situation has arisen where the decline in marital fertility actually observed is found to be less than what could be expected on the basis of the performance of the family planning programme. It is possible that the potential fertility rates of married women in the study area have changed, recording an increase, during the period 1951 to 1975, because of relaxation of various social and cultural restrictions of the population, which have directly and indirectly influenced fertility, and also possibly because of improvements in the health status of the population, especially the eradication of malaria from the area. The population of the area has, from time immemorial, been subjected to a number of cultural and social practices which have tended to reduce fertility. For example, the practice of pregnant woman going to her mother's home for delivery and staying there for a number of months after delivery, the practice of

abstinence on a number of days in a month for social or religious reasons, the protonged breast feeding of children and strong social taboos on widow remarriage have all tended to keep the brith rate low, for below the biological maximum. With modernizational, many of these practices are not being observed and the traditional checks on fertility are being removed one by one. Thus the potential fertility of married women seems to have gone up evevn in the presence of family planning programme.

This is empirically validated from a comparison of age patterns of marital fertility in 1951 and 1975 as obtained from the two studies. While there has been a considerable reduction in the age specific fertility rates of married women aged above 30. The fertility of married women aged below 30 years has recorded a substantial increase in rural areas as well as in Bangalore city, indicating that the spacing between children has narrowed down during the past two decades and whatever reduction in marital fertility that has been recorded has been achieved mainly through limitation, primarily due to sterilization of couples in the older age grouds. Sociological and anthropological studies conducted in the country support the hypothesis that modernization has weakened certain traditional checks on fertility.

An analysis of the average number of children born, number living and survivorship ratios for women in different age groups, based on data from the two studies, indicates that there has been a small increase in the number of children ever born for women in different age groups between 1951 and 1975 and the difference is wider in the case of number of children living because of substantial decline in mortality of children during the period. The survivorship ratios of number of children living to number born have recorded considerable increase during 1951 and 1975. These ratios are analysed by education of the husband and wife as well as by the religious composition of the sample studied.

An analysis is also carried out of the opinions of the married women and their husbands on selected fertility-related variables as obtained from the two studies. The definitional differences in the concepts of ideal family size and desired number of children, as used in the two studies, have caused some difficulties in the interpretation of the data However, the finding suggest that there has been a decline in the number of children desired by the couple over the 24-year period but the decline does not appear to be as high as one would have expected over a generation. Analysis of the responses by motives for not desring additional children indictes that the economic motives, have become increasingly preponderant in the population and non-economic motive, such as health reasons, were expressed mostly by wives in 1975.

A study of the knowledge and practice of various methods of family planning in 1951 and 1975 indicates that there has been a marked increase in the proportion of

couples having knowledge of modern methods of family planning such as sterilisation condoms, IUD, etc.. For example, among the married women in the rural plains, the proportion having knowledge of one or more modern methods of family planning has increased from 10.7 per cent in 1951 to 90.5 per cent in 1975. Similarly, there has been an increase, though not of the same magnitude, in the proportion of couples practising modern methods of family planning. On the other hand, the proportion of couples having knowledge of or practising natural methods of family planning has decreased markedly during this period. For example, among professionals, the proportion reporting knowledge of safe period as a method of family planning in Bangalore city was 24.4 per cent in 1951 and this has come down to 8.3 per cent in 1975. Such differentials are analysed for different educational-occupational groups and also by rural and urban areas separately.

The study suggests a plausible reason for the tardy decline in the birth the area over the past 24 years. Ιt indicates the possibility of the birth rate convinuing at the present level of 35 per mille for some more years or declining only very slowly because of the tendency of the potential fertility of married women to increase as a consequence of modernization, liberalizing some of the age-old social and cultural checks on fertility. In the absence of a strong family planning programe to compensate for and counteract the fertility increasing effects of modernization, it is likely that the birth rate in the area may even The family planning progromme has to meet the twin up in the near future. challenges. One is that it should meet the needs of those who wish to substitute traditional methods of family planning by modern methods without any change in the desired family size. The other is that it should meet the needs of those who wish to have a family size smaller than the one prescribed by social norms. both the objectives are met simultaneously, it may not be possible to achieve a substantial reduction in the birth rate. Such phenomenon seems to be unique to countries which, for a long time in the past, have had strong social and cultural checks on fertility, either intentionally or unintentionally. The present study reveals that the Western experience of a continuous, smooth and steady decline in the birth rate need not be reproduced in such developing countries, and the assumption usually made in demographic circles that once the birth rate starts on its downward slope, the trend will continue unabated, may not be valid for all the developing nations.
