INTRODUCTION

What is Social Justice? The question is as old as history and generations to come will repeat the question. Justice is in its nature social, for it consists in the right relation of individuals one to another. But when we speak of Social Justice we are thinking of the collective expression given to the idea of justice through the laws and customs, the orders and the social provisions which express the will of the community. To find the answer to what is Social Justice, we must try to form a complete idea of the community, seeing the manifold relations within it, each of which contributes to the sum of Social Justice. The Republic of Plato has given the world for all time a wonderful picture of the State as expressing the idea of justice. Others have from time to time presented in their pictures of Utopia the semblance of an answer to the question of what is Social Justice. There is value in these efforts to present the ideal. Their concrete forms challenge the question how far they express what is necessary to the progress of human society. But they are only a first step in the search for Social Justice. Mankind goes on striving to enrich and enlarge the answer and to bring into the picture of organised society the manifold elements in the developed form of Social Justice.

Now it is by the patient analysis of the experience of society in its various types and by critical reflection on the evidence before us that we can make more complete the picture of the Community as the expression of Social Justice. In doing so, the question has to be repeated constantly, 'Does this or that measure contribute something which is necessary to a just order of society? We have come to a stage in history when the materials of social evidence are accumulating so rapidly that a large number of workers is needed to sift out, classify and compare the data for the guidance of public policy. In particular, we must examine what is taking place in the most highly developed states of the

modern world. For we can see the nature of a thing best, as Aristotle said, in its most completely developed form. And it is by examining the very highly developed communities in the modern world that we can see farthest into the problem. The complexity of the times in which we live adds to the difficulty, but gradually the eye begins to see order in our changing social system. And as we compare one State with another, and mark their common elements and distinctive features, the concept of Social Justice grows steadily more complete. But we must seek to see the question steadily and to see it as a whole. And while we examine the development of the idea in this or that State, we must not forget that it is only through an international order that the full conception of Social Justice can be realised.

Social Justice, it may be said, has been the aim of every age. How far is this true? It is difficult to answer because it is so hard to recapture the temper and feeling of bygone ages. We may have before us the annals of history and yet how far we are from being able to judge the well-being not simply of the ruling class but of the whole society! Some bygone periods seem in their simpler order of life, in the closer personal relationships between classes, in the more easy provision of at least subsistence for their more limited population to present a sense of Social Justice which contrasts favourably with the conditions of our modern society. But despite its many shortcomings and its often glaring inequalities our age marks a growingly conscious pressure towards a universal realisation of a just order. This age is often said to be very material, yet in it there is also great spirituality and there are wide and deep movements of public 'feeling after justice.'

The significance of each generation lies in the effort it makes towards the realisation of a higher measure of justice among its members. There are dead periods—winter and night—in history, as well as times of light and quickening. We live in a period of great change. It is far more complex than everything that has been before, and far more difficult of interpretation and of direction. But that which alone can give order and cohesion to the efforts of society is the controlling idea of Social Justice.

We cannot yet discern with certainty the character of our own times. We can see them more or less darkly against the ages

which have gone before, but we can only dimly speculate how they will compare with those which are to come. Yet it may well be that our generation is one in which the struggle of forces is alike more complex and more uncontrolled than will be that of the future, that gradually the experience of years will guide Society to a clearer, calmer, steadier way of life, that there will be seen more plainly the true nature, structure and method of Society, and that this period in which we live and move will be looked back on as great in its dark struggle and giving birth to a new order of justice which will gain more and more complete acceptance throughout the world. If such be in any way the case how full of significance must be the study of our times, and the attempt to mark and measure the movement which is going The very ebb and flow of debate reflected in this volume, often seeming to show so little headway, has its own significance in revealing how gradually and with great labour opinion is being formed in the public mind. "The ideal is the truth of the actual." The task of winning this is one of great difficulty. The present volume, based on patient investigation of the main sources of evidence, is the first attempt by a comprehensive survey to examine how the idea of Social Justice is finding new forms of expression in two of the great States of the world, and it deserves a generous welcome.
