SIR,

I am directed to submit for the information of the Government of India the accompanying Report on the working of the Co-operative Credit Societies Act in the Central Provinces during the year 1906-07. The Report, which deals with the period of 15 months from the 1st April 1906 to the 30th June 1907, has been compiled in the form recommended by the last conference of Registrars, and attached to it are the four statements suggested by the Conference. Details have been given in the latter for individual Societies; but as these become more numerous, it will probably become necessary before long to compile the statistics by districts.

2. The Report gives a clear account of what may fitly be described as a period of remarkable progress At the commencement of the year only one Urban and eight Rural Societies were entered in the Registrar's books By the 30th June 1907, a Central Society had been registered at Kirnapur, two Urban Societies which were in reality Central Societies had been organized at Betul and Sihora, and three Urban and 55 Rural Societies had been formed. Twenty-four of the last named, together with the Central Societies at Sihora and Betul, had not started work during the year, but except in the case of 11 Societies in Sironcha this was due to the lateness of their registration, and not to lack of vitality. The number of members at the end of the year had increased to 2,870, and the number of loans made to 2,082. It is satisfactory to note that, with one or two exceptions, all the new Rural Societies conform, at any rate as regards their size, to the lines which were laid down last year by the Chief Commissioner as being those upon which the development of the Societies in the Central Provinces should proceed. Existing banks must still be regarded in the light of experiments, and it will of course be impossible for many years to come to evolve a system suitable for the who'e Province; but by a careful selection of the fit and rejection of the failures it should be practicable before long to ascertain the types of institutions best suited to various types of tracts and people, which may gradually tend to assimilation.

3. The actual working of the Societies during the period covered by the Report appears on the whole to give distinct cause for satisfaction. The Kirnapur Central Society, which belongs to a distinct type, modelled on the Central Banks in existence in the United Provinces, advanced Rs. 9,005 in loans to the members of its 12 affiliated Societies, and is reported to have made full use of its capital; the Harda Society, on the constitution and working of which unfavourable comments were made last year, has closed its trade in hundis and elected a number of b rrowing members; and the other Urban Societies are also reported to have done good work.

4. Of the Rural Societies there are now several distinct types in existence. The older Societies of Hoshangabad and Betul, with their large membership spread over a wide area, are reported to have done much good; but, as the Registrar points out, they approach least nearly to the co-operative ideal, and the provision of cheap money by semi-charitable contributions from landlords and other interested persons does more in the long run to encourage extravagance than thrift and co-operative effort. The Akola Societies have made good use of such capital as they could command; with a total capital of Rs 6,891, 250 loans of a total amount of Rs. 9,691-10-0 were advanced to their members. But they are reported to find a difficulty in raising all the capital that they require, and the experiment of starting a Central Bank at Akola to meet this want will be watched with interest. The same difficulty with regard to the supply of funds has so far prevented any progress being made in the upper taluqs of Sironcha, and in view of the special circumstances of this tract, where the cultivating classes are bound hand and foot to the village moneylenders, it may be necessary to meet the opposition of the capitalist classes by financing the Societies with Government loans. To judge from the remarks made in paragraph 12 of the Report, none of the above Societies appear to have succeeded in attracting investments from the hoards of the general body of their members, which must ultimately be the main source of capital for village Societies. Of the work of the Jubbulpore Societies, which are said to have been started, like the Balaghat Societies affiliated to the Kirnapur Bank, on thoroughly democratic lines, it is as yet too early to form any estimate.

5. Some interest attaches to the working of the caste banks, which are represented by the Gujar Bank at Sødalpur and one or two of the Balaghat Banks. It has been urged with some reason that the caste system offers a means of extending the co-operative ideal along the line of least resistance, and that where castes of widely varying social status are included in the same Society, equality, which is the main spring of co-operative effort, inevitably disappears. The Chief Commissioner agrees with the Registrar that for the present at any rate the type deserves encouragement, even if it be viewed only as an experiment.

6. A welcome feature of the Report is the satisfactory manner in which loans were repaid. This is no doubt largely due to prosperous seasons, and the improvement in what the Registrar terms "the revenue conscience;" but it may fairly be held to indicate also carefulness in the granting of loans, and an absence of the spirit of recusancy among the more influential members of Societies, which has elsewhere proved detrimental to their existence. Fair progress was made in the building up of reserve funds, though some misapprehension seems to exist among certain of the Societies as to what funds may properly be carried to this account. The Chief Commissioner considers it very important, with reference to paragraph 13 of the Registrar's Report, that the rate of interest charged to members should be on business principles and such as to enable the Societies to discharge their own debts on similar principles. If a Society can only pay its way because some of the money borrowed has been given it at cheap rates from philanthropic motives, that Society cannot continue its existence for very long.

7. Encouraging on the whole as the success attained has been, the partial failure of the crops which has occurred since the Report was written will, it is feared, impose a heavy strain on the Societies at a regretably early period of their existence. With their scanty reserves, their as yet untried stability, and

their limited access to the money market, every effort will be needed to enable them to tide over their immediate difficulties, and until this has been accomplished the formation of new Societies can only be undertaken with the greatest caution. If the Registrar is able to advise assistance to particular Societies, the Chief Commissioner will be prepared to give favourable consideration to his recommendtions.

REPORT ON THE WORKING OF THE CO-OPERATIVE CREDIT SOCIETIES IN THE CENTRAL PROVINCES AND BERAR FOR 1906-07.

I.--ADMINISTRATION.

This report, owing to the alteration, under the orders of the Government of The Annual Report. India, of the year to which it relates, deals with the period from 1st April 1906 to the 30th June 1907. Complaints have been made that it is difficult for societies to hold the annual general meeting after 30th June, in order to pass the accounts from which statements for the annual report are prepared. But it is open to them to close their own year of working at whatever date they like. If their accounts are kept up to date, it should be no difficult task to compile the necessary statements, nor is it a matter in which assistance from Government officials is in any way objectionable.

2. The post of Registrar was held up to 1st March 1907 by Mr. Gaskin, and by Mr. Sly up to the end of the year under report. Three The Registrarship. officers were on special duty in organizing or inspecting societies during the year: Mr. Bhat, Extra-Assistant Commissioner, in the Akola District, from January 1906 to June 1907; Mr. K. Anand Rao Sharma, from September 1906 to March 1907, for the organization of societics in the Sironcha Tahsil of the Chanda District, and Mr. Misbahul Osman has been on general inspection duty from 29th January 1907 up to the date of this report. His appointment is intended to last up to the time when a definite decision is come to by the Local Government as to the future administration of co-operative credit operations in the Central Provinces. The main difficulties that beset the question are the fact that societies are at present scarcely numerous enough to warrant the appointment of an officer of the same standing as in other and larger provinces: while the work is of a special and important nature, demanding much tact and judgment; and if the officer appointed is not qualified by his standing and experience to act in independent charge some arrangement is necessary under which his work can be supervised by a senior officer.

3. I may be permitted to add a word of personal explanation. I have not An explanation. held the post of Registrar during any portion of the year: and am hardly in a position to judge of the work of officers in other districts than that of which I myself held charge. At the same time I must admit the possession of strong views on the policy that is required, which it would be impossible, in discussing a subject in which I am deeply interested, to prevent from colouring my remarks. These opinions are not shared in all cases by other officers with not less experience of the subject and perhaps better qualified to judge of it than myself. I have high hopes of the future of our societies, and if this report may seem in places pessimistic, it is because their general success is so striking as not to require notice, while the future dangers to their working are less apparent.

II.-SOCIETIES.

4. One central society was registered at Kirnapur during the year, one urban society at Harda was working at the beginning

increase in societies. of the year, and during the year five urban societies (of which two were really central societies) were registered. The eight rural societies registered before the opening of the year had increased to 63 by its close. But of the 70 societies on the Registrar's books on 30th June 1907, only 44 were actually working. The societies registered but not working include 11 rural societies in Chanda, which did nothing owing to lack of funds, and a number of societies in Betul, Saugor and Jubbulpore, which were only registered just before the close of the year. No societies has thus greatly increased, and there is an active demand for more societies and for admission to the membership of existing societies. As Deputy Commissioner of Balaghat, I received applications for the formation of several new societies to be affiliated to the Kirnapur Central Bank, and there was, moreover, money forthcoming from local philanthropists and from the Court of Wards sufficient to finance them all. As responsible for the administration of the Kirnapur group of societies, I felt so strongly the danger to the societies in the case of a failure of crops sufficient to prevent the bulk of the members from repaying their borrowings of the year and the discredit which the resulting inability of the societies to meet their liabilities to outside creditors or to satisfy the demands of their own members in the following year would entail, that I declined to take any forward step till the reserve had attained sufficient proportions to justify it. Other districts also desired to expand or add to their societies, but my predecessor was of opinion that caution was needed and did not wish to receive applications from new societies, unless the members showed a spontaneous desire to form a bank.

5. The only means by which a society that lends out practically all its funds on the hopes of a single crop can recover from The famine danger. a severe seasonal calamity is, firstly, by the possession of a reserve sufficient to keep its credit unimpaired and to tide over immediate needs: and, next, by the growth of a spirit of co-operation strong enough to induce its members to submit to considerable sacrifices during the years following a famine in order to put the society in funds again. I do not think that either of these ends are likely to be attained within the next five years. The matter is likely to be a serious one in districts where large sums of money are being raised by a central bank from the general public to finance rural banks: the whole edifice rests ultimately on the ability of the individual member to repay his loan, and no additional resisting power to famines is added by any. extension that, does not cover areas depending on widely different agricultural conditions. For the above reasons, I would suggest that our policy should be one of great caution, save in areas protected by thoroughly reliable irrigation. The above remarks do not of course apply to urban banks.

6. The more noteworthy additions to the societies registered were as New societies. follows: ---

The Kirnapur Central Bank with its branch banks was started in the Balaghat District to finance a number of rural societies: the Burhanpur Urban Bank was started at the suggestion of the Hon'ble Mr. Miller, the late Chief Commissioner, as one of the measures necessitated by the distress arising from the severe fire that laid waste the city: fresh ground was broken in Jubbulpore by Mr. Crosthwaite, who had previous experience of co-operation work in Hoshangabad: a number of banks were started in Sironcha as part of the compaign against, the financial bondage in which the ryots of that tract were held by their moneylenders: and a start was made in the exceedingly promising field offered by the Berar Division.

The principle on which areas have been selected for the starting of work in the Central Provinces has been rather the need of the tract in question for cheap credit, the benefit likely to be received by the tract from the starting of a society and the interest taken in the co-operative idea by local officials. I am not sure if more progress would not have been made in the evolution of the co-operative idea, at a sacrifice perhaps of some immediate efficiency of management, if our choice had been determined more largely by the aptitude of the people themselves for co-operative management.

III.—WORKING OF SOCIETIES.

7. Several divergent types of central banks are now working in various Central banks. districts. The Kirnapur Central Bank is simply a collection of representatives of the branch banks, who pledge the joint security of all members to enable money to be borrowed more cheaply and, incidentally, maintain the accounts of the branch societies, which are thereby enabled to work on extremely simple and democratic lines. One of them, for instance, consists of eleven Mahars, the poorest and most depressed caste in the Nagpur country. This form of society, though the most logical development of the co-operative idea, cannot, however, be called into existence everywhere. At Sironcha, for instance, the representatives of branch societies refused to pledge their.

credit for, the , debts of other branch societies: so that it is now proposed to start an urban society to finance these rural societies. At Sihora, the central society consists entirely of a number of capitalists, who lend money at 9 per cent to the rural banks. A similar institution on a larger scale is being started by Mr. Mayne at Betul, with the hope of making hoarded capital available for financing rural banks; 72 per cent interest on shares and 6 per cent on deposits is considered high enough to attain this end, while leaving a margin of profit to the rural banks. These institutions are somewhat on the lines of the "organization societies" originally set on foot by Mr. Dupernex, though they are not so avowedly philanthropic in their objects. Central societies are proposed in Akola and elsewhere : and it is being realized more and more that a central"or urban society is needed to finance rural societies. An urban society has one advantage over a central society, in the greater scope it has for employment of repaid loans. In rural societies, for instance, rabi loans are often given out in October and repaid in May. A rural or central society has no means of employing this capital in between. Banias, I'understand, employ their own capital under similar circumstances in moving the grain crop. A rural society cannot at present do the same. On the other hand, the capital of central banks is regulated with reference to the demands of the rural banks: whereas these have to take their chance of getting loans from an urban bank.

The central banks, save Kirnapur, were all registered as urban banks under Section 29 of the Act. Kirnapur only was working during the year. Its accounts were not separately shown from those of its branch societies: but it apparently borrowed Rs. 500 from Government, Rs. 800 from Court of Wards, Rs. 1,000 from another society and Rs. 2,000 from non-members: it also received Rs. 678 from deposits and Rs. 127-8-0 from entrance fees. All this was lent out and recovered, and again lent out during the period under report, to its 12 branch societies. The other central banks had 49 members, with a nominal capital of Rs. 52,000, of which Rs. 14,500 were to be called up at once. The cash was usually kept with the leading local banker.

- 85. Of the six societies registered as urban, two were really central societies., The four other urban societies are situated at: Urban societies. Harda, Burhanpur, Balaghat and Badnur. The firstnamed society, which has been working longest, was started with the idea of assisting: small: traders and artizans, financing rural societies, and incidentally" employing its spare capital in the purchase of Government and other approved paper and doing ordinary, banking business. Owing to a misunderstanding of the provisions of the law on the part of its members and to a certain lack of supervision, the society contented itself with a single loan to a rural. society; elected practically no small traders or artizans as members, and concentrated its efforts on an active trade in hundis. All this has now been changed... The hundi business is being closed and a number of borrowing members of suitable classes are being elected. This result is mainly due to the tact and influence of the district officials. The Burhanpur society, which, alone of the urban. societies, received a loan from Government, has worked successfully throughout the year, a result owing partly to the presence of several energetic and publicspirited members and partly to the aid of Mr. Thakur, the Sub-Divisional Officer. The weak point of the society at first was its failure fully to employ its capital, with a consequent loss of interest i on this being pointed out by my predecessor, however, the Committee were quick to perceive and remedy the defect, and the society is now working to the full extent of its capital. The Balaghat society has done equally well : and I quote from its report a lew interesting cases where direct and obvious good resulted from loans made by it :---

(i) Gulab Khan took Rs. 250 for brick-making: they say he has made a very large profit, but I am content with the modest admission of Gulab Khan, according to which he made a cent per cent profit on the capital supplied by the society within a period of eight months or so.

- (iii) The new stationery shop of Gangadhar Rao was largely, if not wholly, financed by the society.
 -
- (v) Shaikh Gariba, though believed by some to be extravagant, has made a fair start with an advance of Rs. 72 in his tea, bread and pan-bida shop, containing a few bottles of soda water for casual purposes.
 - • • •
- (vii) Mainly with advances from the society, Chokhra Choleha Khatik (butcher) has made good bargains in his sheep and goat business."

A certain number of Government servants also belong to this society. They borrow either to pay off old debts or to buy stocks of cheap grain at harvest. At Betul, a society has been started solely for Government servants. It has worked well this year, and there seems little reason to doubt but that institutions of this class with ordinarily prudent management are bound to be a success. A similar society is being organized among the employes of the Secretariat Press, Nagpur.

The financial results of the working of urban societies were as follows :----

Omitting the societies that did not work for the whole of the year, Harda and Balaghat earned a net profit of Rs. 595-9-10 on their share capital of Rs. 10,916-8-0, or rather over 5 per cent. The reserve fund of the societies was Rs. 1,848-6-0 by the end of the year: but this was increased shortly after its close.

9. I now come to the most important part of my report, the working of rural societies. Unfortunately, it is a subject regarding which it is most difficult to form any satisfactory opinion without frequent personal inspections, extending over a long period. Only in such a way can the growth of popular opinion, the development of the co-operative spirit and of the organizing capacity of the members and committee, and the strengthening of the credit of rural banks, be estimated.

Of the 39 rural banks actually working during the year, the oldest established were the banks in Hoshangabad and Betul. Those in the Sohagpur tahsil of the former district were working well and will soon be able to manage their own affairs without any but outside help and supervision. The Harda societies, owing to quarrels and intrigues, were less successful, but give hopes of improvement. There are certain undesirable elements in these societies that require to be dealt with, and when that is successfully accomplished, I consider that the strong and democratic tenantry of Harda will develop their system of management very rapidly. The Betul societies continue to flourish and to add to their number and membership. These banks get over the difficulties that would attend the working of an ordinary society in a thinly populated tract inhabited by a poor and largely aboriginal peasantry by a constitution embracing a wide area and embodying a committee mostly composed of well-to-do men, who are also mainly responsible for financing the society. The institutions of both districts do a great deal of good, and, it may be, will ultimately lead to the development of the co-operative idea. But at present they are mere land-banks, run by the well-to-do classes, for the supply of cheap money to their poorer neighbours. European experience has proved over and over again that cheap money without the sense of personal interest in the society and the encouragement of thrift by cooperation, does in the long run more harm than good. An attempt was made to start a society on the more democratic lines advocated by the Hon'ble Mr. Miller at Sainkhera: the reason for its inability to work on these lines is stated to be the necessity of admitting a few of the leading malguzars of the tract owing to the inability of illiterate members to conduct the society on business lines. I presume that good reasons rendered it impossible to admit to membership a patwari, schoolmaster or other literate person to achieve the same end and to give the experiment a chance of success.

10. The Akola societies give promise of success. Unfortunately, they seem to have been started with the idea of having, so far Rural banks in Akola. Jub-bulpore, Chanda and Balaghat. as possible, a society in every portion of the district, which renders supervision difficult. In my opinion what is wanted at present is not so much to extend the knowledge of co-operation, as to discover the best lines on which co-operative societies can be run, to gain experience of the various difficulties, including the great difficulty of famine, likely to be encountered in the course of working, and to devise means for overcoming them. For this reason, close supervision of such societies as are already working is far more important than the opening of societies in fresh places. Another difficulty that besets the Akola societies is the lack of capital, and I agree with Mr. Jatar, the Deputy Commissioner, that it is desirable for a society to be able to meet the whole requirements of its members, so long as they do not require money for wasteful or improper purposes. It is proposed to start a central society in Akola to meet this end.

The Jubbulpore societies, recently started, comprise none but borrowing members. They are bound to carry all profits to reserve. Though they are entirely dependent on a central society for financial help, they are constituted on thoroughly democratic lines and are more nearly co-operative than the banks of most districts.

In Sironcha only two of the 13 registered rural societies are working, owing to lack of funds. The report does not contain sufficient detail to show how far the banks are managed by the borrowing members themselves or by lending and depositing members. It is to be hoped that the Deputy Commissioner will be able to fulfil his promise to inspect these banks next year: until the problems of finance and management are solved, much progress cannot be expected. There are special difficulties to be overcome in Sironcha: but the advantages to be gained are proportionately greater. I am not at all sure that the idea of lending out takavi to co-operative societics, proposed as an initial step by the late Commissioner, Nagpur Division, but nowhere, so far as I am aware, actually tried, may not prove the solution in Sironcha. At any rate, I think the idea worth trying. In the absence of available capital and in the face of the active opposition of the capitalist classes, it seems a perfectly legitimate way of forcing the closed door.

The Balaghat rural societies embody the theories which I adopted after my visit to the United Provinces. I, therefore, confine myself to remarking that they are run on extremely democratic lines, following as closely as possible those laid down by Mr. Hope Simpson, and have up till now succeeded at least as well as any other rural societies. A major irrigation project is now under construction in the Kirnapur tract; the villages protected by it will be a most desirable field wherein to extend the societies' operations.

11. The special type banks comprise the Gujar bank at Sodalpur in Special types. Hoshangabad and one or two caste banks in the Balaghat society. The Gujar bank is not doing as well as it might owing to a split in the caste: and the members now wish to bring in persons of other castes. The Balaghat banks are only incidentally caste banks: the great majority of members of a particular village or hamlet being of a single caste, it was thought likely to add to the strength and cohesion of the society if its members were confined to that caste. An objection may be taken to this as unfair; but I regard existing Lanks in the light of experiments and see no objection to eliminating obscuring factors from the materials to be experimented on. I hear from private sources that the Hoshangabad Mission propose starting a bank on partially co-operative lines among their converts and that the subject was discussed at a recent Mission conference. While Deputy Commissioner of Balaghat, I was asked to look through and criticise the detailed proposals. I consider that the scheme with a few modifications has every prospect of success.

12. Capital was raised partly through the agency of central banks, partly direct. Its sources were—loans from Government Capital raised and deposits Rs. 2,700; from Court of Wards Rs. 1,580; from nonmembers Rs. 500; share capital Rs. 16,060; deposits by members Rs. 9,021; entrance fees received during the year Rs. 384-4-0; miscellaneous Rs. 115-15-9.

The loans from non-members carried rates of interest varying from nothing to 9 per cent. In most cases, save possibly in Betul and Jubbulpore, these loans were more or less philanthropic : the motives which lead capitalists to advance such loans are well known and need not be repeated here. We shall not really begin to feel the pulse of the money market until our societies have weathered at least one famine and the central societies have got to work on a fairly large scale. Hitherto our demands have not entirely absorbed the money which is always available for philanthropic ends. Deposits by members consist in nearly all cases of sums, practically speaking, lert to the bank by wealthy members. In the Kirnapur group, the returns of which are excluded from the figures quoted above and discussed under the head of central banks, deposits are obligatory on all members at a certain rate per rupee of rental. These deposits may very well be treated wholly or in part as reserve Of course they are not reserves in the strict sense of the term; any real reserve must come out of the excess of actually realized profits over payments made or due, a fact which many societies, to judge by their by-laws, do not appear to realize. But if the members can be induced to look on these compulsory deposits and entrance fees as a sort of famine insurance fund, it will go far to avoid the difficulty which is likely to arise if the loans outstanding are rendered unrealizable by a severe loss of crops.

13. The number of loans given out by rural societies was 1,297 and their total amount Rs. 52,384-12-9. Besides this, the Loans. Kirnapur branch banks gave out Rs. 9,005 in 293 loans. Loans for seed-grain are almost invariably repayable out of the crop for which they are lent: loans for cattle in from one to three years: loans for social purposes or repayment of debt carrying high interest in longer periods. But by laws as a rule provide that not more than a small proportion of the Society's funds may be lent out on long-term loans. Not much has hitherto been done by rural societies in the way of loans for other than agricultural purposes; in a few cases loans have been made to repay debt or meet expenditure on social functions: but the desirability of granting loans for these purposes is admitted and a good deal is likely to be done in this way when more funds are available. No better check on social extravagance could be devised than by rendering the obligee's caste-fellows liable for the expenditure he incurs. In some societies, sureties from among the members are taken, but in the majority of cases the objections to this practice have not yet been overcome. It has been stated that if all the members of a society stand as sureties for one another, loans are thereby none the better secured. But sureties are not demanded for that reason': a surety is a guarantee that it is the direct personal interest of some one to see that extravagant sums are not borrowed and that loans are not misapplied and are punctually repaid.

The rate of interest varies from 9 to 12 per cent. per annum. This has not yielded large profits, owing mainly to the fact that in most societies money has to lie idle for several months in the year. The profits were Rs. 2,350-15-4 on a share capital of Rs. 16,060, but this high rate is due to the fact that a very large proportion of the loans are free of or on very low interest, while many societies have no share capital. Adding Rs. 538-12-6, the interest paid and due, to the profit of Rs. 2,350-15-4, we get a total of Rs. 2,889-11-10. This is only 9 per cent on the total working capital of Rs. 31,061: and considering that the rural societies will not be able to borrow much cheaper than at 8 or 9 per cent, so far as we can see at present, it seems likely that either the interest must be raised or the capital made more use of, if a reserve is to be built up in any reasonable time, or provision to be made for bad debts. Still, there is some reason to believe that the period under report being one of 15 months has caused the profit to look smaller than it really is, as only interest actually received is taken to profit, while interest paid and due is taken to loss.

14. Repayment was one of the most satisfactory features of the year's Repayment of losss. It is no doubt largely due to the improved revenue conscience of the last few years, and to a feeling on the part of the people that the money comes from Government. A corollary of this proposition is that, when famine years occur, members will expect the same liberal treatment from the banks that they have received from Government. This feeling will only disappear as the co-operative feeling grows and the banks attract the deposits of borrowing members.

Trouble was experienced only in the case of two Berar societies and in Harda. In the latter case some executive action was apparently taken to collect the outstandings. In the Akola societies, one or two members were turned out by one society, but the other seems to have treated the defaulters with excessive leniency.

There are no grain or produce societies in the Central Provinces.

IV.—RESERVE FUND.

15. The profits made by societies are so small that the building up of Accrual and disposal of remerves. Accrual and disposal of remerves. Accrual and disposal of remural societies at the end of the year were Rs. 1,848-6-0 and Rs. 1,002-7-5 respectively, against liabilities of

and Rs. 1,492-7-5 respectively, against liabilities of Rs. 29,182-12-5 and Rs. 32,105-7-0. The Hoshangabad societies are amongst the longest established in the provinces—here the reserves of the urban and rural societies are Rs. 1,806-6-0 and Rs. 974-3-1, against liabilities of Rs. 9,143-5-3 and Rs. 8,900-1-0. As already stated, many societies do not understand the true meaning of a reserve : money which does not represent a surplus over liabilities cannot be carried to reserve any more than it can be utilized for the payment of dividend. Several societies provide in their by-laws for the crediting of a certain portion of capital or of the entrance fees to reserve, and the statements show that they have credited more to reserve than they have earned as profit. This is illogical, though there is no harm in holding such sums in the form of liquid securities and not employing them in the regular business of the society, provided that the rate of interest earned is not thereby too much reduced. One or two societies were found on the other hand to be using their reserve in the same way as their working capital : and they were requested to keep' it in some sale form of investment.

V.—AUDIT AND INSPECTION.

16. Mr. Gaskin inspected three societies in Hoshangabad: the remaining Inspection by Registrar and three were inspected and audited by Mr. Misbahul staff. The Betul societies. Besides this, he reported on the desirability of proposed societies in Drug, Saugor and Narsinghpur.

The societies in other districts, save Chanda, were all inspected at least once by the Sub-Divisional Officer, Settlement Officer or Deputy Commissioner. I doubt if the present arrangements are adequate as regards audit. Members have a right to expect a thorough audit by a Government official once a year, and it may be advisable to appoint, as auditor, an officer who has power to inspect and give any explanation of rules and accounts that the members may wish, but not to pass orders.

VI.—RESOURCES.

17. This subject has been fully dealt with under the head of III .-- Working of Societies—Carital raised. I briefly recapitulate here the various sources of capital for all societies:— Amount and sources of capital.

Urban societies are much more nearly on a business footing than rural societies: they may fairly claim that they are beginning to attract capital, and a year or two more of successful working will put them in a position to compete in the open market for a considerable proportion of the money they want. They are not as a rule established in places where money is freely obtainable. Burhanpur is a decaying town, Balaghat is little more than a large village and the same is the case with Badnur.

VII.—WORK DONE BY SUPERVISORS, COMMITTEES, OFFICERS, AND MEMBERS.

Efficiency of committees and officers of societies.

18. In Hoshangabad the Sub-Divisional Officers have been appointed supervisors. The class of supervisors contemplated by the constitutions of European societies, viz., well-to-do persons unconnected with the societies but interested in their work,

are scarcely available in the Central Provinces, as they are taken into the societies as members; in most cases they lend money and take an active part in the internal management of the society. This state of affairs may perhaps change in time; but at present the supervisor class is practically non-existent. Office-bearers and committee members have borne the main burden of the work, and are generally well spoken of for their zeal, industry and readiness to listen to advice. It is reported, however, that the committee and office-bearers of one society in Hoshangabad have not been free from suspicions of favouritism and have displayed undue partiality in the allotment and recovery of loans and in the pay-ment of staff. The committee of one or two of the outlying Akola societies are reported to have been slack, but this is scarcely to be wondered at, considering how small and scattered the societies of this district are.

Urban societies are as a rule efficiently managed. Some difficulty was experienced in obtaining information for the reports from the Akola and Harda rural societies.

VIII.—DISPUTES AND LITIGATION.

19. No disputes had to be submitted to arbitration during the year. The Harda urban society had to sue the heirs of a member who died in debt to the society. No plea in any way bearing on the constitution of the society was urged by the defence. The case is not yet concluded.

IX.—ACTS, RULES AND BY-LAWS.

20. It would be well to provide for the registration of central societies under These are a special section other than section 29. Suggestions for legislation, preparation of model by-laws recognized institutions now and ought not to require the and rules. sanction of the Local Government. The next amendment of the Act might provide for this. Draft rules were submitted by my predecessor just after the close of the year for the sanction of the Local Administration. Model by-laws for the various classes of societies were also submitted for approval.

but Mr. Sly and most other officers consulted were of opinion that they are too elaborate for our societies; that their use should not be obligatory and that the societies should be allowed to frame their own by-laws on as simple lines as they liked, subject to the Registrar's approval in each case.

21. I consulted the Agent; Bank of Bengal, unofficially, regarding the annual statements. We were of opinion that one or two minor changes were desirable.

Column 2 of statement III is apt to mislead. It should include only interest received. There are two ways of dealing with interest due but not received. If strict accuracy is desired, the outstandings should be valued one by one, according to the likelihood of their realization, though this perhaps is more a matter for a statement of assets and liabilities. But it is far simpler, and in the case of societies like ours, far safer, to take simply interest actually received; it is very unsafe to pay dividends out of prospective receipts.

Columns 24 and 25 of statement IV seem unsuitable. Column 24 should not be profit or loss, but surplus or deficit. Column 25 "Reserve" should find a place among liabilities, and there should be a column on the assets side to show how reserve is held. Then the surplus or deficit column would come last as a balancing figure.

X.-ATTITUDE OF THE PUBLIC, ETC.

22. There are practically no places, save Sironcha, where the societies meet Popular view of societies. With any opposition from the money-lending classes. The passive or even sympathetic and helpful attitude of this class are partly due to the loyalty and readiness to further the aims of Government that characterise the capitalist body; to their sympathy in what they consider as a charitable movement, and lastly to the insignificant part taken hitherto in rural finance by the societies. The capitalist understands as little as the ryot the co-operative aims: as soon as it appears to him that the remedy that is being injected into the body politic is not a sterile vaccine, but contains the germs of a new life that is likely to permeate the entire rural community, the real attitude of the money-lender will be disclosed.

23. I take this opportunity of noticing the services of office-bearers of the Notice of official belgers. In Hoshangabad, Pandit Ramchandra Rao of Chipaner and Mr. Dube, Pleader, have done good work on the Harda urban society : Seth Moti Lal is responsible for the success of the Piparia bank. In Burhanpur, Seth Tikamdas has done well: in Betul, Rai Sahib Sitaram, Dinanath Patel, Rikhiram Patel and Sarawan Patel did good work as presidents of their societies. In Balaghat, Mr. Narain Rao Kelkar was the lead ng spirit of the successful urban bank: and Hari Patel of Mohara was of great assistance in the Kirnapur bank. The late Zamindar of Hatta and the Zamindar of Bhadra assisted the same bank with Joans on liberal terms.

Mr. Thakur, Sub-Divisional Officer, Burhanpur; Mrssrs. Slaney in Harda and Mehdi Hasan in Sohagpur, Mr. Bhat in Akola and Mr. Sunder Lal in Betul, gave much of their time to helping and supervising the various societies in their charge. Rai Bahadur Anant Lal took a large share in founding and supervising the Balaghat rural societies. Among the officers on special duty I can speak only of the work of Mr. Misbahul Osman, which was such as to justify his appointment. The officers of the Commission who took most interest in the co-operative credit work were Messrs. Crosthwaite, Mayne, Pantin, Jatar and Major Mauduit.
