I have the honour to submit the Annual Report on the work of the Bombay City Police for the year 1913 with the usual statements as appendices.

2. I was in charge of the office of the Commissioner of Police from the 1st January to the 2nd May 1913, and again from the 31st October 1913 to the close of the year. During my absence on leave Mr. R. MacTier acted as Commissioner of Police.

The office of Deputy Commissioner of Police, Criminal Investigation Department, was held by Mr. F. A. M. H. Vincent from the 1st January 1913 to the 30th January, and by Mr. F. C. Griffith from the 7th March to the end of the year. During the interval I was in charge of the office of Deputy Commissioner of Police, C. I. D., in addition to my own duties.

The office of Deputy Commissioner of Police was held by Mr. F. M. Gadney from the beginning of the year to the 15th November 1913, and thereafter till the close of the year by Mr. O. A. Harker.

3. Cognizable and non-cognizable cases reported during the year numbered 60,861 against 66,844 in 1912 and 55,528 in 1911. The subjoined table gives details of the total volume of crime in 1912 and 1913.

Cognizable Cases.

4. The total number of cognizable cases of all classes reported to the Police during the year was 40,492 against 46,752 in 1912 and 43,243 in 1911.

Under the Indian Penal Code (classes I to V) there were 7,995 cases against 7,858 in 1912 and 7,323 in 1911.

Under class VI, 32,497 cases were reported against 33,894 in 1912 and 35,915 in 1911.

5. Including 278 cases pending from the preceding year, there were 40,770 cases for disposal during the year under report against 40,972 in 1912 and 43,401 in 1911. Police Cognizable cases for disposal.

Of the total cases for disposal, 8,126 fell under the Indian Penal Code (Classes I to V) and 32,644 under Class VI.

Under the Indian Penal Code there is a comparatively small rise of 137 cases. This may be in some measure due to sustained work and registration of crime in the two new sub-divisions opened in January 1913 at Princess Street and Maharbaudi, as the volume of crime registered at other police stations was much the same as in 1912.

Under Class VI there is a very noticeable decrease of 6,297 cases, the decline being chiefly in the A, C and D divisions. "Cocaine" and "Hawkers" are the two main heads under which a decrease has occurred. As regards the former, the decrease arises in some measure from the prosecution and imprisonment of certain notable traffickers in the drug and also from the fact that the officers of the A'bkári Department have now been empowered to prosecute their own cases without reference to the Police. As regards hawkers, it has been noticed in one or two divisions that these classes have commenced to avail themselves more freely of the privilege accorded to them of plying their business in certain specified streets, and in consequence the police have not found it necessary to institute so many prosecutions.

6. The total number of excluded cases for the year 1913 was 551 against 298 in 1912 and 397 in 1911. Of these 299 fell under the Indian Penal Code and 252 under Class VI against 213 and 85 respectively in the year preceding. Of the 551 excluded cases 56 were declared to be false after being brought to trial as compared with 66 in 1912 and 50 in 1911. Police Cognizable cases struck off.

In 28 cases compensation ranging from one rupee to Rs. 50 was awarded to the accused by the magistracy under section 553 of the Criminal Procedure Code. The percentage of excluded cases to cases reported works out to 1.36.

7. The total number of cases pending at the close of the year was 364 against 278 in 1912 and 220 in 1911. Pending Police cases.

8. During the year under report 39,810 Police cases of all classes were classified as true against 46,348 in 1912 and 42,735 in 1911. Of these 33,225 resulted in conviction, which gives a percentage of 83.48 as compared with 91.29 in 1912 and 91.26 in 1911. True Police Cognizable cases.

Under the Indian Penal Code 7,615 cases were classed as true against 7,599 in 1912 and 7,086 in 1911. Of these 3,639 ended in conviction, which gives a percentage of 47.78 against 57.49 in 1912 and 56.13 in 1911.

Under Class VI 32,195 cases were classed as true. Of these, 31,536 resulted in conviction, giving a percentage of 98.10 as compared with 97.92 in 1912 and 98.52 in 1911.

The percentage of true cases to cases reported in 1913 stands at 98.31.

9. The total number of offences under all classes remaining undetected at the end of the year under report was 3,364 against 2,765 in 1912 and 2,446 in 1911. The percentage of non-detection works out to 8.32 against 5.96 in 1912 and 5.65 in 1911. The increase of 59 undetected cases falls chiefly under Lurking House Trespass, Theft and Criminal Breach of Trust, and the bulk of these undetected cases (*viz.* 385) were registered in the C division. The result is chiefly due to the fact that police stations on the new system were opened at Princess Street and Maharbaudi in January 1913, which laid the foundation of Undetected Police Cognizable cases.



better and more continuous registration of complaints. Scrutiny of the records of both these stations shows that a large number of cases were registered under Sections 406 and 408, Indian Penal Code, and that all petty cases, in which the value of the property involved was small, were duly brought on to the books of the station. Under the system introduced at these stations it is not easy for cases to escape registration and final classification.

**Result of Trial by classes.**

10. *Class I.—Offences against the State, etc.*—In this class there were 43 cases for disposal including 2 pending from the previous year, of which 31 ended in conviction. In 1912 there were 59 such cases and in 1911, 88.

*Class II.—Serious offences against the person.*—Under this heading there were 567 cases for disposal including 19 cases pending from the previous year, as compared with 520 in 1912 and 517 in 1911. Convictions were obtained in 280 cases. The increase falls chiefly under the following heads:—

*Class III.—Serious offences against person and property or against property only.*—Including 22 cases pending from the previous year, there were 1,259 cases for disposal, against 1,155 in 1912 and 1,139 in 1911. Convictions were obtained in 316 cases. The increase of cases falls chiefly under the head of Lurking House Trespass, serial No. 29.

*Class IV.—Minor offences against the person.*—In this category there occurred 55 cases against 66 in 1912 and 46 in 1911. Eighteen out of the 55 cases ended in conviction.

*Class V.—Minor offences against property.*—Including 88 cases pending from the previous year, 6,202 cases occurred for disposal against 6,181 in 1912 and 5,678 in 1911. The rise and fall of cases in this class is as follows:—

*Class VI.—Other offences not specified above.*—This class comprised 32,644 cases, inclusive of 147 pending from the previous year, as compared with 38,991 in 1912 and 35,935 in 1911. A conviction was obtained in 31,586 cases.

**Serious Crime.**

11. During the year 1913 the police registered 24 cases of murder and attempt at murder against 31 in 1912 and 25 in 1911. Of these 10 ended in conviction, one in acquittal, one case was withdrawn, 9 cases were undetected and 2 were pending at the close of the year. In one case the accused was declared a lunatic.

Five cases of culpable homicide occurred of which 4 ended in conviction and one in acquittal.

One case of infanticide was tried by the Sessions Court and resulted in the acquittal of the accused.

**Sessions Cases and Persons.**

12. The Sessions Court tried 56 cases against 47 in 1912 and 48 in 1911. Of these, 45 cases ended in conviction, 9 in acquittal, and 2 cases were withdrawn. These cases involved altogether 69 persons, of whom 54 were convicted, 12 were acquitted, while the charges against three were withdrawn.

13. I subjoin the usual statement of cases of suicide compiled by the Coroner of Bombay.

During the year the coroner held 440 inquests against 380 in 1912 and 401 in 1911. Fourteen inquests were held on the corpses of Parsis.

In accordance with the instructions contained in Government Resolution No. 5819, dated 16th September 1902, the Police disposed of 192 cases of simple accidental death against 222 in 1912 and 185 in 1911.

14. Including 143 cases pending from the preceding year, offences under special and local laws dealt with by the Police numbered 32,484 against 38,991 in 1912 and 35,935 in 1911. Of these 31,457 cases ended in conviction. Offences under Special and Local Laws.

The Police dealt during 1913 with 166 under the A'bkári Act, all of which with one exception ended in conviction. The bulk of these cases were cocaine prosecutions, the most notable case being one in which two constables of the C division arrested a Bania on suspicion with 200 grains of the drug in his possession, and eventually with the help of the superior staff discovered a further haul of 4,348 grains, valued at Rs. 815, in the house of another Bania. Another noteworthy cocaine case is mentioned below in the paragraph on the work of the Criminal Investigation Department.

15. The total number of direct magisterial cognizable cases was 8,787 against 8,803 in 1912 and 10,608 in 1911. Of these 8,094 ended in conviction, giving a percentage of 92.11. The total number of persons involved in these cases was 8,990, of whom 8,144 were convicted. Cognizable Crime, Direct Cases.

16. During the year under report 41,601 persons were arrested by the Police, exclusive of 286 arrested at the close of 1912, as against 44,933 in 1912 and 44,040 in 1911. Of these 39,744 persons were convicted. The percentage thus stands at 94.88 against 95.96 in 1912 and 96.53 in 1911. Under section 73 of the Bombay City Police Act, the Commissioner of Police cancelled 172 bail-bonds, as compared with 40 in 1912 and 27 in 1911. Statement A, Part II, Persons in Police cases.

Under the Indian Penal Code (Class I to V) 5,181 persons were tried and 4,268 were convicted, giving a percentage of 82.37 as compared with 87.41 in 1912 and 85.12 in 1911.

Under Class VI, 36,340 persons were tried of whom 35,476 were convicted, giving a percentage of 97.62 against 96.34 in 1912 and 98.18 in 1911.

At the close of 1913, 274 persons were awaiting trial against 286 in 1912 and 154 in 1911.

17. The number of non-cognizable cases reported direct to the Magistracy was 11,582 as compared with 11,289 in 1912 and 11,677 in 1911. With 14 cases pending from the previous year, the total number for disposal was 11,596, of which 4,146 ended in conviction. Statement B, Part I, Non-cognizable cases.

18. In these 11,582 non-cognizable cases, 15,630 persons were involved, of whom 4,134 were convicted. Statement B, Part II, Persons in non-cognizable cases.

19. The following table shows the various religious divisions to which 66,557 offenders in both cognizable and non-cognizable cases belonged:—

20. The total value of property alleged to have been stolen in Police cognizable cases amounted to Rs. 6,85,460 as compared with Rs. 5,79,579 in 1912 and Rs. 6,19,848 in 1911. The total value of property recovered was 2,31,155, which gives a recovery percentage of 33·72 as compared with 39·52 in 1912 and 47·17 in 1911. The bulk of the property stolen formed the subject of ordinary theft and of criminal breach of trust. The police of the D division acquitted themselves creditably in two cases of theft. In one case they recovered practically the whole of the stolen property three months after the commission of offence, and in the other, after arresting the accused in the Bhor State, they were enabled by dint of continuous enquiry to trace the property to six different receivers, all of whom were charged and convicted with the thief. The O Division managed to effect the arrest of a diamond broker, who had committed criminal breach of trust in respect of property valued at Rs. 46,000 and recovered more than 38,000 rupees' worth of stolen goods.

Criminal  
Investigation  
Department.

21. The strength of the Criminal Investigation Department, Bombay City, stood at the end of the year at 1 Superintendent, 7 Inspectors, 8 Sub-Inspectors, 2 Jamadars, 24 Head Constables, and 41 Constables.

One hundred and seven criminal cases were dealt with by the Criminal Investigation Department during the year, on their own initiative, and assistance was rendered to the Divisional Police in all cases of importance or special interest. The Criminal Investigation Department scrutinized 65 plays of which 61 were passed as unobjectionable, 2 were passed subject to amendment, and 2 were rejected.

There were no seizures of proscribed books during the year. Assistance was rendered on frequent occasions to the Mofussil Police and to the Police of other Presidencies and Provinces and also to the Excise Department.

Among the more interesting cases investigated by the Criminal Investigation Department may be included the following:—

(a) *The Gujarat Bank Case.*—One William Williams was charged was cheating and forgery in respect of certain documents pledged with the Gujarat Bank for Rs. 1,800 and 1,500. He was convicted under sections 420, 468 and 471 and sentenced to one year's rigorous imprisonment by the Sessions Court on the 2nd July 1913.

(b) *Messrs. Treacher and Company's Case.*—R. H. Bunnell, a native of Bristol, England, absconded after committing criminal breach of trust as a servant in respect of Rs. 1,163-8-0, the property of Messrs. Treacher and Company. He was arrested in England and was brought by Inspector Morris of the Criminal Investigation Department to Bombay for trial. He was convicted under section 408, Indian Penal Code, and was sentenced to 10 months' rigorous imprisonment in June and July 1913 on three separate charges.

(c) *Manilal Ambalal Yajnik.*—A native of Petlad, a bold and successful swindler and cheat, was arrested in May 1913 for cheating in respect of Rs. 500 and Rs. 350 and criminal breach of trust in respect of Rs. 252. He was convicted for two offences of cheating and one of criminal breach of trust and sentenced to 12 months' rigorous imprisonment in July and August 1913.

(d) *Small Causes Court Case.*—One Nathu Karson was arrested in July 1913 for cheating by personating a plaintiff in the Small Causes Court and for forging a document of the Court for the purpose of obtaining a warrant for execution. He was committed to the Sessions by the Chief Presidency Magistrate for offences under sections 471, 468 and 419, Indian Penal Code, and was sentenced by the Sessions Court to 2 years' rigorous imprisonment on each of the two charges.

(e) *"Captain" Harrison's Case.*—In this case one Harrison, an ex-officer of the British Cavalry, with many *aliases*, was prosecuted for having systematically defrauded a French prostitute whom he met in Madras after his release from jail on the expiry of a former sentence. Having fleeced his victim, Harrison sent her to a brothel in Bombay and drew on her earnings. He was put up on three charges of cheating and was sentenced to 6 months' rigorous imprisonment and a fine of Rs. 250 on each charge.

(f) *Ewart Latham's Forgery Case.*—This was a case in which a blank cheque was stolen from Messrs. Ewart Latham's premises, filled in for Rs. 10,826, a signature forged and the cheque cashed immediately after Messrs. Ewart Latham's premises had been destroyed by fire. One of the firm's employes was arrested and charged with the offence of theft, cheating and forgery for the purpose of cheating. The investigation left little moral doubt that the accused was also guilty of incendiarism, having fired the offices to cover the crime, but no substantial evidence could be obtained to support that charge. The accused was committed to the Sessions where the Jury, failing to appreciate the evidence, brought in a verdict of "not guilty". The presiding Judge discharged the accused, making severe comments on the lack of acumen and the perversity displayed by the Jury.

(g) *Framroz Maneckji Oomrigar's Case.*—An old offender named F. M. Oomrigar, who was undergoing a term of 5 years' rigorous imprisonment for forging a will, was sent to the J. J. Hospital for medical treatment. He absconded from the hospital but was subsequently arrested and convicted and sentenced to 2 years' further imprisonment. He was also charged with criminal breach of trust in respect of ornaments worth Rs. 2,000, convicted and sentenced to a further term of 6 months' simple imprisonment in May 1913.

(h) *The Doctor Street Cocaine Case.*—In this case two accused were arrested with cocaine valued at Rs. 17,150 in their possession. Both accused were convicted and sentenced to one year's rigorous imprisonment each. Gold medallions were awarded by the Collector of Excise to Khan Saheb M. H. Taqi and Khan Saheb F. M. Taqi for their action in this case.

(i) *Postal Money Order Cheating Cases.*—In these cases telegraphic money orders for Rs. 300 and Rs. 200 respectively from Bengal were fraudulently received by one Abdul Jabbar. He was aided and abetted by one Abdul Hassan. Both the accused were convicted and sentenced to 5 months' rigorous imprisonment each and further ordered to pay a fine of Rs. 125 each or in default to undergo one month's rigorous imprisonment.

(j) *The fraudulent marriage of a Koli girl to a Bania.*—In this case a Koli girl about 9 years of age was married to a Bania aged about 60 by three Hindus who falsely represented that one of them was her brother and that the girl was a Bania by caste. The complainant was induced in this way to part with Rs. 1,500 and to marry the girl. All three accused were charged and two of them were convicted and sentenced to 9 months' rigorous imprisonment each.

(k) *K. & N. Sub-Division Revolver Case.*—In this case a Pathan named Meer Alum Hussain was found to be in possession of two revolvers without a license. Both the revolvers were of German make. He was convicted and sentenced to one year's rigorous imprisonment.

In addition to the above, the Criminal Investigation Department were engaged in the latter part of the year in enquiring into the circumstances attending the financial crisis which led to the failure of a number of Banks. Cases were instituted against the Manager and Accountants of the Credit Bank which were *sub judice* at the close of the year.

Twenty-one foreigners were deported under Act III of 1864 during 1913. This number comprised 10 transfrontier Pathans (including 4 Pathans for whose deportation orders were received in 1912), 5 Russians, 3 Arabs, 2 Syrian Christians and 1 Persian.

The 2 Syrian Christians (mother and son) were engaged in traffic in women; they were identified as having previously been deported: and fresh orders were therefore obtained for their deportation.

Of the 5 Russians, 2 were identified as pimps engaged in the traffic in European women.

One Sikh deported from Hongkong was taken charge of and sent to his native place in the Punjab.

One male, 3 females and 9 children were repatriated to South Africa and Burma by the Criminal Investigation Department.

Three indigent Christians (1 female and 2 males) and 4 Indians (2 females and 2 males) were helped through the instrumentality of the Criminal Investigation Department, either with passages, money, or by admission into public charitable institutions.

The Muharram and Ganpati festivals passed off without trouble. The Criminal Investigation Department were actively engaged in connection with these festivals in keeping me informed of the trend of public opinion and feeling and with scrutinizing the mela songs for the Ganpati.

586 incoming and outgoing steamers were boarded by the Criminal Investigation Department during the year.

The Finger Print Bureau has maintained its efficiency. 4,930 slips were received during the year for identification and 1,426 were traced, giving a percentage of 28.9.

The total number of finger print slips on record at the close of the year was 39,303.

In addition to this work, the Finger Print Bureau took the finger impressions of 792 candidates for employment as sweepers in the Municipal Health Department, 24 of whom were found to be convicts.

The above statements and figures do not represent the whole activities of the Criminal Investigation Department. Much of their work is of a confidential nature and does not find its way into the Courts or public records.

**Preventive Action.**

22. During the year 1913 the Police placed before the Magistracy under the provisions of Chapter VIII of the Criminal Procedure Code 57 persons as against 53 in 1912 and 58 in 1911.

**New Sub-divisions.**

23. The two new sub-divisional stations at Princess Street and Mahabaudi worked satisfactorily throughout the year, and the Indian Sub-Inspectors at these two centres and in Colaba, Nagpada and Agripada prosecuted successfully 1,143 of the more straightforward cases during the year. Pending the building of new police stations at Gamdevi, Lamington Road, Hansraj Lane, Esplanade Police Court, and other places the reorganization scheme has come practically to a standstill. Arrangements are being made however to apply the scheme to the Water and Dock divisions, the quarters for which were completed at Mody Bay and Frere Road during the year under report and were occupied from the 1st January 1914.

Five new Indian Sub-Inspectors are expected from the Nasik Training School in June, and six more will then be sent there for an eighteen months' course of training. It is to be hoped that at least one new police station will have been built before the expiry of their term of training, as otherwise there will be serious difficulty in accommodating them with both work and quarters. Paidhoni could be made the headquarters of a new sub-division, provided that the accommodation scheme between Jail Road and Sandhurst Road is completed with reasonable despatch. At present the further development of the reorganization scheme is delayed for lack of buildings. The present D Division, for which new police stations are to be built at Gamdevi and Lamington Road, is particularly badly off in the matter of accommodation, and until proper police stations on the new model are provided it is difficult to ameliorate the internal administration of that area.

**The Arms Act.**

24. (a) In April 1913 it was decided to take a Census of the arms held by Europeans, Anglo-Indians and other exempted persons residing in Bombay. At first the undertaking appeared to present some difficulty, particularly considering the number of exempted persons, as from the records of the last Census it was computed that there were at least 16,082 exempted persons, of whom 10,434 were males, and the difficulty lay principally in devising a means of discovering their names and residences. With the aid of the Divisional Police this difficulty was surmounted and we have now on record a complete list of the weapons in possession of exempted persons. This with the present system of verifying the purchase of arms from dealers will give an approximate idea of how arms are distributed in the City at any time. To complete the list the names of the 264 Justices of the Peace and the 46 title holders, who are also exempted, had to be added and the number of arms in their possession ascertained.

The Census was successfully carried out with the following result:—

Holders of licenses granted by the Commissioner of Police to possess arms number 389 with 700 arms.

With regard to the number of arms purchased from dealers in Bombay, 1,241 references were made necessitating enquiries in almost all parts of the British Dominions. The system so far as it goes is satisfactory and until such time as all exempted persons, European and Indian, are required to register their arms at a Police Station it is the best that can be devised.

In the subjoined Table A the number of licenses granted under the Indian Arms Act for 1913 is given showing an increase of 118 licenses and a decrease of 99 licenses as compared with the preceding year. There were 15 new licenses granted to the communities shown in Table B (1).

Table B shows the communities to which the licensees belong (Table 1, item 6) and the 45 new licenses mentioned above are shown in Table B (1) distributed amongst the several communities. These 45 licenses cover 71 arms. A record of the cancelled licenses is shown in Table B (2) and the manner of their disposal is given in Table B (3). There were altogether 36 licenses cancelled involving 55 arms, 26 lbs. gunpowder and 31 persons.

At the close of the year there were therefore 399 persons possessing 711 arms, including theatrical companies many of which possess arms in excess of the quantity which would be considered reasonable for private persons. These theatrical arms are of an obsolete pattern.

Throughout the year the shops and godowns of dealers in arms and explosives were inspected and the periodical stock-taking showed that the books were carefully kept and agreed with the stock in hand. There were 25 prosecutions under the Act (involving 27 persons) of which 25 ended in conviction.

## Poisons Act.

(d) Under the Poisons Act there were 32 licenses renewed from the previous year. The stock and sale-books have been carefully kept. The retail sales were few.

## The Motor Vehicles Act.

(e) In the subjoined table E is given the number of motor vehicles registered, transferred, etc., throughout the year under review.

There were 540 cars registered altogether, i.e. 90 more than in 1912 and 128 more than in 1911, which brings the total number of cars running in Bombay City up to 1,810 approximately.

At the close of the year there were 158 Public motor vehicles plying for hire in the City and 319 licenses and certificates of competency were issued to the drivers of these cars. Most of these cars are up to date and of good manufacture and include such makes as the Napier, Minerva, Panhard, Daimler B. S. A., Siddley Deasy, etc.

Of the 9 cases shown in item 10 of the table, two were cases of rash and negligent driving, the remainder being purely accidental.

The District Magistrates, Poona and Sátára, were given the services of an officer of this department whenever required throughout the year for the purposes of examining public motor vehicles and testing intending drivers of such vehicles.

(f) The following table shows the manner in which accidents occurred to passengers, pedestrians and vehicular traffic in connection with the running of tram cars. Tram Cars.

There has been a reduction in the number of accidents both fatal and otherwise as will be seen from the table, and with regard to accidents to passengers and pedestrians alone, the number has fallen from 403 in 1912 to 324.

The localities in which most accidents occurred are Byculla (34), Hornby Road (27), Girgaum Road (23), Bhendi Bazaar (23), Parel Road (15), Ripon Road (15).

Grant Road and Null Bazaar are accountable for 4 accidents each, Paidhoni for 6 and Abdul Rehman Street for 7.

(g) During the year under review there were 12 theatres, 9 cinema theatres and 3 circuses licensed. For the Máhim Fair 2 cinematograph licenses were issued and early in the year 9 places of public amusement were licensed at the now defunct "Maidánia". Theatres.

That the popularity of the cinema shows has not waned may be gathered from the fact that during the year 4 new cinema theatres have been erected—one at Grant Road, 1 at Sandhurst Road, 1 at Null Bazaar and 1 at Bhendi Bazaar. They are of the usual corrugated iron type with the operating cabin, which is built of brick and cement, outside. The Novelty, Gaiety and Edwardes theatres were used for cinema shows throughout the year.

The theatres are in order, with sufficient exits and with fire appliances and a water-supply as good as circumstances will permit. Improvements are still being carried out.

Before renewing the licenses of theatres and cinematographs the buildings are subjected to an examination by the Executive Engineer, Public Works Department, the Electrical Engineer, the Chief of the Fire Brigade and by this office and no licenses are renewed until everything has been reported to be in good order. The telephone authorities attend to the telephone connections throughout the year. As in previous years the above officers have, whenever called upon, helped with advice and assistance in matters pertaining to theatres.

There were 285 performance licenses issued throughout the year. Of the 71 plays sent for review one only was found to be objectionable. Orders prohibiting the production of 8 films were issued.

**Pilgrims.** 25. During the year under report, 15,319 pilgrims left Bombay for the Hedjaz. The details of the Haj Season will be found in the report of the Protector of Pilgrims, which will shortly be submitted to Government.

**Fire.** 26. The total number of fires in the City in 1913 was 175, and the aggregate amount of the estimated loss of property was Rs. 23,45,143. The figures for the year preceding were :—

27. Two additional Constables were sanctioned during the year for patrol duty at night, round the Paper Currency Office (*vide* Government Resolution, Financial Department, No. 3064, dated 15th August 1913).

The population of the City according to the final figures of the census of 1911 is 979,445 and the proportion of true crime to population stands at 1 to 24.60 as compared with 1 to 21.22 in 1912 and 1 to 22.91 in 1911.

The proportion of true crime to each police unit stands at 14.04 as compared with 16.30 and 17.05 in 1912 and 1911, respectively.

**Statement E—  
Armament.**

28. During 1913 an additional supply of 42 Webley revolvers was received for the use of the Indian Sub-Inspectors of the Force; and one Webley and 12 Enfield revolvers, which had become unserviceable, were exchanged for the same number of the Webley pattern.

**Punishments and  
Rewards.**

29. During the year 384 officers and men were punished as compared with 399 in 1912 and 393 in 1911.

Of the total number punished departmentally 8 were Europeans and 346 were Indians. One European Sergeant and an Indian Sub-Inspector were dismissed, and the services of another Sergeant were dispensed with. As usual the majority of the punishments were of a minor character for small misdemeanours.

Two hundred and fifty-three men were promoted to higher grades in the ordinary course. The men mentioned under (g) above received small pecuniary rewards for exceptionally good or plucky work, while those under (h) received rewards from the public through the Commissioner of Police.

The title of Khán Sáheb was conferred during the year on Inspectors Mahomed Hussein Taki and Faizullah Mahomed Taki of the Criminal Investigation Department.

Police Constable No. 2212/D distinguished himself by tackling and arresting single handed a house-breaker armed with a knife who had already stabbed a watchman. The plucky action of Police Constables No. 1252/E and

No. 610/E in Madanpura has been separately reported to Government in my letter No. 3523—17 of April 1st, 1914. Police Constable No. 1789/D did good work in swimming out and rescuing a young Mahomedan girl from drowning near Chaupáti; while similar action on the part of Police Constable No. 998/D has been reported through Government to the Royal Humane Society. Police Constable No. 1896/K did excellent detective work in a case in which a gang of six Madrasis stole a box of coins from the General Post Office, and a house-breaking case in Fergusson Road was cleverly unearthed by the efforts of Police Constables No. 314/K and 1129/K. In various other cases Police Constables have acquitted themselves unusually well and have been duly rewarded.

30. Exclusive of Europeans the number of officers able to read and write has risen from 165 to 221, and of these 69 are literate in English. Literate Constables numbered 908 in 1913 as compared with 814 in 1912 and 732 in 1911. Of the 908 literate Constables, 48 are literate in English. Education.

The Haji Mahommed Haji Ismail Sobani Night School has been regularly attended by 35 Musalman Constables. They are taught English by an experienced graduate and two assistants, partly by the conversational method and partly by translation into the vernacular. I examined the school a short time ago and find that several of the men understand English fairly well and can converse in English on simple subjects, while those in the Senior Class are beginning to write letters and reports of crime in English. Their handwriting is in most cases very legible and well-formed. The teaching staff tell me that most of the men have improved in intelligence, and considering that when they first commenced attending the school in 1911 none of them knew a word of English, the present results reflect great credit upon the Superintendent, Mr. Ali Mahomed Munshi, and Mr. Reuben, the Senior Master, and his assistants.

The Head-quarter English School for Constables was opened on the 1st November 1912 with the previous sanction of Government. The number of men who attend it is now 200. Examinations have been held at the end of each term, *i. e.*, in April and October. At the outset one class was formed, which as a result of examination has now developed into three classes, namely, 2nd Standard (Junior) with 40 students, 1st Standard (Senior) with 70, and 1st Standard (Junior) with 90 students. At Professor Fraser's suggestion, Part I of the "Do and say method of teaching English" was introduced and was completed during the first term; Professor Fraser's first book in English by the direct method was introduced and is being read by the Senior 1st Standard, and his second book was introduced in the upper class during the third term. The men are making satisfactory progress. Lectures have been delivered twice a week to the men on their duty to the public, on hygiene and on the Police Act. At the request of Mr. Adilshah, the School Master, Dr. Sayad Shamsuddin Mahommadi delivered a lecture on tuberculosis with magic lantern slides, and two lectures on public health were given to the men by Mr. P. C. Pange.

Professor G. Nelson Fraser was good enough to pay a visit to the School and was satisfied with the progress so far made. Mr. Adilshah is considerably handicapped in his efforts by the number of men whom he has to teach. He has kindly allowed his son to teach one of the classes free of expense to Government; but I am convinced that if we are to make the School thoroughly successful, we must allow an extra teacher, as 200 men divided into three classes is too large a burden for one man. In spite of the fact that the men's regular duties are heavy and continuous, and that they have no time to study except while actually in class, yet they have made progress under Mr. Adilshah's auspices, and I am confident that in regular tuition of this character in English and in constant lectures on their duties lies the future advancement of the Constabulary to a wider mental outlook, greater self-possession, and a higher standard of manners. I therefore hope sincerely that some means may be found of providing for the cost of at least one additional trained teacher for this School. The men themselves are

receiving such encouragement to persevere as is possible by the grant of small rewards and prizes and by considering favourably the names of the most advanced, whenever promotions have to be made in the ranks.

The number of recruits enlisted during the year 1913 was 309 against 386 in 1912 and 245 in 1911. Great difficulty has been experienced in finding sufficient men to bring the force up to its sanctioned strength and to fill up vacancies, and were it not for the steady inflow of Maráthás from Ratnágiri there would be constant and serious shortage of Constables. Special recruiting parties have been sent to the Deccan districts, but have met with little or no success. The Ghati (*i. e.* the Deccan Marátha) is quite prepared to come to Bombay as a dock-labourer, water-carrier, smith, drain-cleaner, domestic servant, groom, peon, bullock-cart driver, musician, etc., but for some reason he is not so enamoured of service in the police as his confrere from Ratnágiri. As regards the Hindu from Upper India, known usually as the Pardeshi, there has recently been a marked decrease in applications for service which may be due to the prospect of higher wages, without the troubles of discipline, to be obtained in some of the larger works of public utility at present under construction in Bombay. In any case the Pardeshi makes a much less satisfactory policeman than the recruit from the Bombay Presidency, for apart from other failings he is in the first instance less educated, and he exhibits a tendency to become somewhat invertebrate and melancholic under the depressing effects of the Bombay monsoon. We have been able to obtain a fair number of Mahomedans from the Bombay Presidency and Northern India both for the Armed Police and Divisional Police as well as the Mounted Police. Such Marathas from the Deccan as do apply for service appear to have a preference for the last named branch.

**Health.**

32. The number of admissions into the Northcote Police Hospital during 1913 was 3,133 as compared with 2,546 in 1912 and 2,242 in 1911. Of the number of policemen admitted, 22 were suffering from tuberculosis. The daily average on the sick list was as follows :—

33. Arms, accoutrements and ammunition were regularly inspected and maintained in proper order.

Musketry practice was regularly held by the Head Quarter Deputy Inspector.

The safety revolver range in the compound of the Head Police Office is under construction and will be completed shortly.

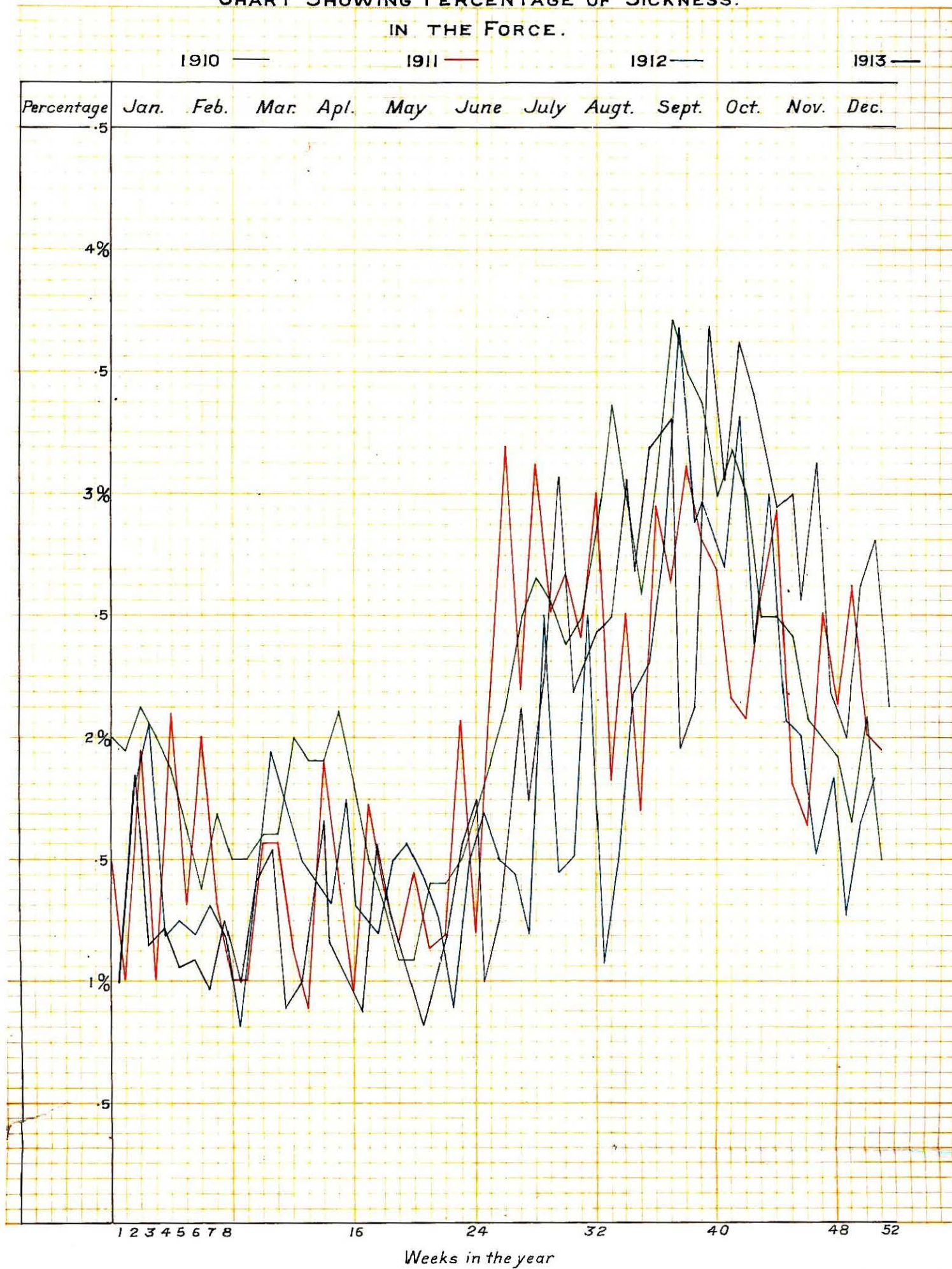
**Street Accidents.**

This shows an increase of 1,180 public conveyances (excluding motor vehicles) and an increase of 7 private vehicles. There is an increase of 102 motor vehicles.

Public conveyances consisted of 1,713 hack victorias, 65 hackeries, 10,500 labour carts, 15 hand carts and one single bullock cart.

During the year the Public Land Conveyance Department and the Divisional Police prosecuted 1,512 drivers for offences against the Act, while 9,703 drivers' licenses were suspended for varying periods, 5,120 drivers were warned by the department and 25 licenses were cancelled.

The Public Land Conveyance Department under the supervision of the Deputy Commissioner rejected 357 horses and 53 victorias as unfit for further use.

36. The Bombay City Police have as usual performed a good deal of work outside the strict scope of police duty. For example, the Criminal Investigation Department received information that a Malabari Mahommedan was attempting to sell two Mahommedan girls in the City for Rs. 80 and Rs. 40, respectively. The girls were traced and taken care of by the Police. Eventually the parents of one child were discovered in Malabar and she was sent back to them. The other child was placed in the Musalman Girls' Orphanage. Miscellaneous

In another case the Criminal Investigation Department was entreated to settle a case of incompatibility between husband and wife, coupled with cruelty on the part of the former. With the consent of both the parties, a Kazi was summoned, and after hearing the evidence on both sides a divorce was pronounced. As the wife was young and friendless she was placed temporarily in the Musalman Girls' Orphanage, and arrangements were subsequently made for her re-marriage with a more suitable husband.

In several cases people who have been stranded in Bombay have applied to the Commissioner of Police for assistance, and have been helped on their way by the collection of funds for the purpose from charitable residents of the City. Among these was an old Mahommedan from Cape Town, several women and children, a Turk whose passage was paid to Karachi, where he possessed relatives, and an Arab, his wife and two children who were supported for a few days and then given their passage money to Basra. In another case a mother and two children were provided with the means of reaching Bagdad, whither they were bound when misfortune overtook them. A married couple were assisted to Rangoon.

Details of the working of the Musalman Girls' Orphanage will be found in a separate report on that institution, to be shortly submitted to Government.

In all these cases I have been assisted by the officers of the Criminal Investigation Department; and such appeals as have been made to the charitable Indian public for funds in each case have invariably met with a generous response. After five years' experience I can safely say that for the relief of any case of distress, which is guaranteed by the Police Commissioner as really deserving, the residents of this City are prepared immediately to provide the requisite funds.

37. Nothing occurred during the year to disturb the harmonious relations existing between the Magistracy and the Police. The Magistracy

38. My thanks are due to the Divisional Police of all ranks, the Criminal Investigation Department, and the office staff for steady work throughout the year in their respective spheres. I am also indebted to Mr. F. C. Griffith and Mr. O. A. Harker, the Deputy Commissioners, for much assistance since I rejoined my appointment in October last.

**RESOLUTION.**—The rapid increase in genuine reported crime which had been a marked feature of the three previous years in Bombay City suffered a check in 1913. The number of true cognizable police cases under the Indian Penal Code, in 1909 as low as 4,552, had risen by 1911 to 7,086. In 1912 it was 7,599. In 1913 it showed an increase of 16 only upon that figure, the number being 7,615.

2. The explanation of the rapid increase in crime recorded in the last few years must be sought partly, no doubt, in the various changes which have taken place in the police force during those years. In 1910, three new sub-divisional police stations were opened, and have been worked on an improved system. A reorganization of the force commenced in 1912, and a gradual increase in the actual strength of the force has been carried out in the last few years. All these factors have contributed to increase facilities for the reporting and detection of crime. It is less easy, however, to account for the standstill at which the upward movement of the figures arrived in 1913. Two more sub-divisional stations were opened at the commencement of the year, and the actual strength of the force exceeded that reported in the previous year by 85 men. The rapid increase in registered crime in 1910 and 1911 was no doubt due only in part to the opening of the three new stations, and must be attributed largely to the improvement in registration which has been conspicuous not only in the city but throughout the Presidency. Increases due to this cause could not be expected to continue indefinitely. Nevertheless, the absence of appreciable growth in the crime register in 1913 is unexpected, and is probably due to temporary causes, the nature of which is obscure.

3. The total number of cognizable and non-cognizable cases reported to the police and magistracy during the year was 60,861, as against 66,844 in 1912. The number of cognizable cases reported to the police was 40,492, against 46,752 in 1912. Of these the great majority were under class VI, *i. e.*, offences under special and local laws, such as the City of Bombay Police Act and the Prevention of Cruelty to Animals Act, and other petty offences. The number of cases reported under class VI fell from 38,894 to 32,497. This decline more than accounts for the decline in the totals of cases reported, and is attributed to a decrease of prosecutions under the heads "cocaine" and "hawkers". The decrease under "cocaine" is reported to be due in some measure to the prosecution and imprisonment of certain notable traffickers in the drug, and partly also to the fact that the officers of the Abkari Department have now been empowered to prosecute their own cases without reference to the police.

4. During the year, 40,492 cognizable cases were reported to the police, 39,810 were classified as true, and 35,225 resulted in conviction. The number of convictions under the Penal Code (classes I to V) was 3,639, as against 4,369 in 1912. The percentage of convictions to true cases was 98.10 under class VI and 47.78 in cases under the Penal Code. The latter percentage has shown a decided downward tendency for a number of years past, the number of convictions, however, varying but little. This state of affairs is not so satisfactory as might be wished.

5. The percentage of true cases of all classes which remained "undetected" rose from 5.96 to 8.32. The bulk of the increase is traced to cases of lurking house-trespass, theft, and criminal breach of trust, in the C Division,

where the opening of two new police stations led to increased registration of complaints. Out of 24 cases of murder and attempt at murder, 9 were undetected, and 2 remained pending at the end of the year. As regards recovery of stolen property, although there was a slight increase in the absolute value of property recovered, the percentage of that recovered to that alleged to have been stolen fell from 39'52 to 33'72.

6. The number of officers and men punished was 397 as against 399, and the rewards granted fell from 1,499 to 1,127. It is observed that good service tickets were granted much less freely, and silver stripes more freely, than in the previous year. The percentage of literacy in the force continues to improve. The lectures and instruction in English which are being given to constables cannot fail to have beneficial results.

7. The number of recruits enlisted was 309 only, against 386 in 1912. Great difficulty is reported to have been experienced in finding sufficient men to bring the force up to its sanctioned strength, and the Commissioner makes some interesting remarks on the tendencies and preferences of the various classes from which the force is recruited. Marathas from Ratnágiri and Muhammadans both from the Bombay Presidency and from Northern India are the classes from which recruits are most readily obtained. Government consider it important, however, that the force should be recruited on as broad a basis as possible, and trust that the Commissioner will not relax his efforts to attract Ghati Marathas and Upper India Hindus into the service. The schemes for the construction of new police stations, the lack of which latter is referred to by Mr. Edwardes as delaying the progress of reorganization, are being pushed forward as rapidly as possible.

8. The police had, as usual, much work of a miscellaneous nature to carry out. There were 540 motor-cars registered during the year, and 319 licenses and certificates of competency were issued to drivers of public motor vehicles. There were 338 accidents, of which 9 were fatal, caused by motor vehicles, as compared with 1,421, of which 46 were fatal, caused by all classes of vehicles. The arms census threw a large amount of extra work upon the police during the year.

9. A few of the statistics quoted in this resolution give, at first sight, a not altogether favourable impression of the work of the police for the year. Statistics can, however, be as misleading in police work as in any other subject. The returns of the year under review probably give a far more accurate account of existing crime than was given by the reports of some years back. If convictions under the Penal Code decreased in number in 1913, it is at least satisfactory that true crime, so far as can be judged, did not increase. In a review of the year's work, it is impossible for Government to pass over the deplorable effects which were caused by the misconduct of a commissioned officer of the force. Government are satisfied, however, that the City police force as a whole is in a sound state of efficiency, and continues to do good work. Their acknowledgments are due to the Commissioner of Police for this result.
