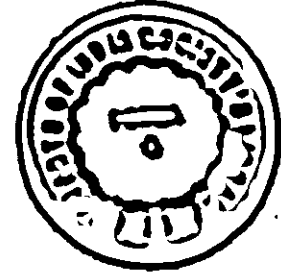

Sir,

I have the honour to submit the Annual Report on the working of Joint Stock Companies for the year ended 31st March 1921. The Returns prescribed by the Government of India are appended to the Report and the Statistics relating to the private Companies have, in accordance with the recent orders, been given separately in Appendix A.* As usual the Report deals with the Societies under the Provident Insurance Societies Act, 1912, and the Societies Registration Act, 1860 and also with the Companies under the Indian Life Assurance Companies Act, 1912.

The Indian Companies Act, 1913.

2. During the year under Report 180 New Companies were registered as compared with 208 in the year preceding. Of these, 179 Companies are limited by shares and 1 limited by guarantee. The former comprise 126 Public Companies and 53 private Companies. To the list one Company "The Salvation Army Property Company, Limited" registered in the Punjab was transferred and added. It is a company limited by guarantee and having no share Capital and having twelve members. The concerns registered during the last two years are agreeably to the recent orders classified as under:—

3. The above table shows a slight decrease in the number of new flotations. The causes given in explanation for the large increase last year were in operation for a greater part of the year and on the whole the number of new registration, is more than normal, but during the latter portion of the year under review owing to exchange disturbances and the tightness of the Money market the boom experienced in the early part of the year died down and there now seems to be less money seeking industrial investment, and fewer companies are being registered. It is probable that the Investor has now become rather more wary as to how he invests owing to the failure of some of the new companies floated last year to fulfil their expectations besides having less money for industrial investment owing to attractive Government Loans and the Calls, etc., on earlier investments.

4. Forty-seven companies ceased to operate during the year as compared with 31 in the previous year. Of the 47 Companies, 7 were wound up by Court, thirty-three went into voluntary liquidation and 7 were struck off the register as defunct under section 247.

5. Nine companies were dissolved during the year of these one was registered during the year but never actually came into operation. Two old companies closed their business and finally disappeared during the year. The remaining six were in course of liquidation on 31st March 1920 one of these was dissolved by Court and 5 were wound up completely by liquidators.

6. The total number of Companies working at the close of the year was 894 of which 875 were Companies having share capital and the remaining 19 were Companies limited by guarantee without share capital.

Capital.

7. The 179 share companies registered in the year under report had an authorised capital of Rs. 69,21,74,250 averaging over Rs. 38½ lakhs, against Rs. 1,33,41,43,518 average over Rs. 64 lakhs, in the preceding year.

8. Of the old Companies 21 increased their nominal capital by Rs. 1,01,79,000 as against 26 companies with an increase of Rs. 5,03,10,000 in the year preceding.

3. The above table shows a slight decrease in the number of new flotations. Capital.

7. The 179 share companies registered in the year under report had an authorised capital of Rs. 69,21,74,250 averaging over Rs. 38½ lakhs, against Rs. 1,33,41,43,518 average over Rs. 64 lakhs, in the preceding year.

8. Of the old Companies 21 increased their nominal capital by Rs. 1,01,79,000 as against 26 companies with an increase of Rs. 5,03,10,000 in the year preceding.

9. The returns received from old companies during the year show in the case of 206 companies an increase in the subscribed and paid up capital of Rs. 38,76,77,520 and Rs. 18,02,73,948 respectively as against Rs. 10,93,76,815 and Rs. 4,43,68,575 respectively in the preceding year.

10. Twelve companies reduced their capital during the year. The total reductions in the authorised, subscribed and paid up capital amounted to Rs. 2,25,000, Rs. 18,51,325 and Rs. 5,22,027 as against reductions of Rs. 95,73,075, Rs. 31,10,375 and Rs. 5,25,011 in the preceding year.

Alteration in the Number of Members.

11. The number of members in the case of companies limited by guarantee and having no share capital was increased by 12 and thus the number rose to 12,662.

Foreign Companies.

17. During the year 13 Companies incorporated outside British India established places of business in the Presidency and filed documents under section 277. A list of these Companies is given in Appendix B. The total number of these Companies at the close of the year rose from 229 to 242 on the register in my office.

18. There was an addition of two Societies to the list. A complete list of the existing Societies is given in Appendix C.

19. Of the 16 Companies operating under the Act at the beginning of the year "The Britania Life Assurance Company, Limited," went into voluntary liquidation. A list of existing Companies is given in Appendix D.

A list of the papers received from the Government of India for safe custody under section 27 is given in Appendix E.

Societies Registration Act, 1860.

20. The tendency of literary and charitable institutions to assume a corporate status has continued to be as great as in the previous year.

The number of Societies registered during the year was 22 as compared with 18 in the year 1919-1920. As usual a considerable proportion have been casual in the matter of filing the names of the governing bodies which is the only obligation imposed on them by the Act. The names of Societies registered during the year are given in Appendix F.

22. There is some improvement in the expeditious registration of mortgages or debentures under section 109 but great dilatoriness is still experienced in filing returns of allotments, Balance Sheets and Annual Returns under sections 104, 134 and 32. Ignorance of the provisions of section 101 and inattention to circulars of the office obliged me to refer many Companies to the Court for an extension of time. As regards Balance Sheets and Annual Returns I find that many Companies have for various reasons had to defer holding annual General Meetings and the Publication of accounts and in some cases I have exercised discretion and forbore to take action. There was only one prosecution under section 92 for publication of prospectus which resulted in a conviction and fine of Rs. 140.

Financial Results.

23. During the year under report the revenue from fees amounted to Rs. 1,11,299-3-6 against Rs. 1,44,955-3-6 in the preceding year. The statement below shows the amounts of realisations classified under different heads as contrasted with the figures in the previous year.
