The total increase over the last year's figures amounts to 48,874 which mainly falls under Class VI. In the year 1934 there was an increase of 26,877 as compared with the figures for 1933.

4. The total number of cognizable cases of all classes reported to the Statement A, Part I, police during the year was 140,162 against 109,814 Police cognizable cases. in 1934 and 97,917 in 1933.

Under the Indian Penal Code (Classes I to V) there were 6,813 cases against 6,894 in 1934 and 7,493 in 1933.

Under Class VI, 133,348 cases were reported against 102,920 in 1934 and 90,424 in 1933.

The total of Indian Penal Code crime (Classes I to V) for the year 1935 is the lowest since the year 1911 as will be seen from the following comparative statement. Compared with the year 1934 there is a decrease of 81 cases :---

To the continuous and systematic employment of preventive measures such as externments under section 27(1) and (2A) of the Bombay City Police Act and P. R. T. system, these results are largely due.

Compared with the year 1934, Class VI, the bulk of which represents Local Act cases, shows an increase of 30,428 cases, the total number for the year being 133,348 as against 102,920. The number of such cases taken up is in direct proportion to the number of men available and to their freedom from other pre-occupations, so that an increase is generally an indication that the force has found the time to deal with such cases, because it has not been otherwise engaged with strikes, disturbances and more serious forms of crime.

5. Including 1,801 cases pending from the preceding year and 65 cases of previous years again brought on to the register, Police cognizable there were 142.028 cases for disposal against 111.474

Police cognizable there were 142,028 cases for disposal against 111,474 in 1934 and 99,595 in 1933.

Of the total cases for disposal 7,541 fell under the Indian Penal Code (Classes I to V) and 134,486 under Class VI.

6. The total number of excluded cases for the year 1935 was 272 Police cognizable against 190 in 1934 and 212 in 1933; of these, 84 case struck off. fell under the Indian Penal Code and 188 under Class VI against 137 and 53 in the preceding year. Of the excluded cases, 17 were declared to be false as compared with 34 in 1934 and 35 in 1933. The percentage of excluded cases to cases reported works out to 0.19.

In 3 cases compensation ranging from Rs. 30 to 50 was awarded to the accused by the Magistracy under section 553, Criminal Procedure Code.

Six persons were prosecuted under section 182, Indian Penal Code, of whom one was convicted while the cases against the remaining 5 are pending.

7. The total number of cases pending at the close of the year was 2,095 as against 1,801 in 1934 and 1,615 in Pending police cases. 1933.

8. 139,642 cases of all classes were classified as true against 109,449 True police cognizable cases. In 1934 and 97,744 in 1933. Of these, 131,277 resulted in conviction, giving a percentage of 94.01 as compared with 91.61 in 1934 and 92.92 in 1933.

Under the Indian Penal Code (Classes I to V) 6,736 cases were classified as true against 6,672 in 1934 and 7,264 in 1933. Of these, 2,393 resulted in conviction, giving a percentage of 35.53 against 34.26 in 1934 and 34.64 in 1933.

Under Class VI, 132,905 cases were classified as true. Of these, 128,883 ended in conviction, giving a percentage of 96.97 against 95.33 in 1934 and 96.52 in 1933.

The percentage of true cases to cases reported stands at 98.32.

9. The total number of cases of all classes remaining undetected at the end of the year under report was, 3,372 Undetected police against 3,320 in 1934 and 3,622 in 1933. The percentage of non-detection works out to 2.37 against 2.98, in 1934 and 3.64 in 1933.

10. Class I—Offences against the State, etc.—In this class there were Result of trial by 109 cases for disposal including 16 cases pending classes. from the preceding year and 1 case of a previous year again brought on to the register, against 100 cases in 1934 and 117 in 1933. Convictions were obtained in 43 cases as against 45 in 1934.

There was no appreciable fluctuation under the head "rioting or unlawful assembly", the figures being 23 for 1935 as against 21 for the preceding year.

Class II—Serious offences against the person.—Under this head there were 1,224 cases for disposal including 216 cases pending from the preceding year and 8 cases of previous years again brought on to the register as compared with 1,239 cases in 1934 and 1,299 in 1933. Convictions were obtained in 421 cases as against 412 in 1934.

Class III—Serious offences against the person and property or against property only.—In this category there were 1,066 cases for disposal including 64 cases pending from the preceding year and 16 cases of previous years again brought on to the register, as against 1,187 in 1934 and 1,443 in 1933. Convictions were obtained in 239 cases as against 206 in 1934.

The head "Lurking house trespass etc." has mainly contributed to the decrease, 920 cases having been registered under this head as against 1,052 in 1934.

Class IV—Minor offences against the person.—In this class there were 45 cases for disposal including 5 cases pending from the preceding year, against 173 in 1934 and 37 in 1933. Convictions were obtained in 9 cases as against 38 in 1934. The large drop under this head is due to the fact that in the year 1934, 128 cases were registered under section 506, Indian Penal Code, during the general mill strike.

Class V—Minor offences against property.—Including 362 cases pending from the preceding year and 40 cases of the previous years again brought on to the register, there were 5,097 cases for disposal as against 4,802 in 1934 and 5,124 in 1933. Convictions were obtained in 1,681 cases as against 1,585 in 1934.

The head "theft" is responsible for an increase of 237, the cases registered in 1935 being 3,561 against 3,324 in 1934. A portion of this increase is however counterbalanced by a decrease of 44 under the head "cheating", the cases under this head having dropped from 401 in 1934 to 357 in 1935.

It is significant to note that Class V includes 527 cases concerned with cycles representing 1/13th of the total crime under Classes 1 to V. Of the 527 cases 313 fall under "theft", 213 under "Criminal Breach of Trust" and 1 under "cheating". Detection is very difficult in these cycle cases, particularly in those cases in which cycles are left by the owners uncared for in streets and public places. These cases also account, to a certain extent, for the non-detection of a large number of cases under this class as will be seen from the fact that 365 of the 527 cases remained undetected.

Class VI—Other offences not specified above.—This class comprised 134,486 cases inclusive of 1,138 cases pending from the preceding year as compared with 103,973 in 1934 and 91,575 in 1933. Convictions were obtained in 128,883 cases as against 97,975 in 1934.

11. There were 72 cases of murder and attempted murder including Serious offences. 10 cases pending from the preceding year and 1 case of a previous year again brought on to the register, against 67 in 1934 and 79 in 1933. Of these 20 ended in conviction, 12 ended in acquittal, 16 remained undetected (including 14 infanticide cases), 21 were pending at the end of the year, in 1 case the accused became a lunatic and in the remaining 2 the accused died before trial.

There were 13 cases of culpable homicide inclusive of 5 cases pending from the preceding year. Of these, 8 ended in conviction, 3 in acquittal and 2 were pending at the end of the year. In the 61 murders and attempted murders reported during the year. there were 14 cases of infanticide. The victims in the remaining 47 cases were 38 males, 9 females and 1 child.

In no case of infanticide was a conviction obtained.

The following cases are worthy of mention :---

• (1) Two Rampuri bad characters, Puttan Hassan and Munnekhan Alishah who lived by extorting money from singing girls were ordered to be externed from Bombay City. They somehow or other got to know that they were likely to be externed. In order to be revenged on the persons who, they thought, had given information against them, they visited one Ramzanbux Asgharalli whom they stabbed to death and also severely stabbed a singing girl named Pannabai who had also given evidence against them. They then absconded. Three days later, they were found in a room in Warden Road and arrested. They had had ample time to dispose of the knives and blood-stained clothes. These were eventually traced through the Police following information given regarding a certain motor car which had taken them away from the scene of the murder of Ramzanbux. Both accused were found guilty of murder and abetment and were sentenced respectively to death and transportation for life.

(2) On the 26th April 1934, a girl was reported at the Princess Street Police Station to be missing. Enquiries made failed to trace her and it was conjectured that the girl had been murdered or disposed of for immoral purposes. After all hopes of obtaining any clue to her whereabouts were practically given up, on the 11th of June 1935, two persons named Manibhai Gokul and Gokuldas Shamji were arrested on suspicion that they had been concerned in this affair. When examined, they claimed to be natives of Cutch, but this was suspected to be false as they did not have the usual Cutchi accent. Ultimately enquiries made at Porbandar, where the first clue regarding the movements of these 2 accused was obtained, and at a number of places in Gujarat led to information being received that a girl of the description of the missing child had been sent to the Rao Sahib Mahipatram Rupram Orphanage, Ahmedabad. Here she was eventually found 15 months after the original offence had been registered. Both accused were convicted and sentenced to 18 months' rigorous imprisonment under sections 369, 363 and 114, Indian Penal Code.

12. The Sessions Court tried 123 cases against 105 in 1934 and 141 in 1933. Of these, 94 cases ended in conviction, Sessions cases and 28 in acquittal and 1 was withdrawn. These cases involved altogether 159 persons of whom 120 were convicted and 37 were acquitted while the charges against the remaining two were withdrawn.

Including 1,119 cases pending from the preceding year, the offences under the special and local laws dealt offences under with by the police numbered 134,185 against 103,742 in 1934 and 91,322 in 1933. Of these, 128,626 ended in conviction. The bulk of these cases fell under the following Acts :---

Public Conveyances Act,

Bombay Prevention of Gambling Act, and

City of Bombay Municipal Act.

The continued efforts of the police to keep the crowded localities of the City reasonably free of hawkers who cause obstruction and ply their trade without Municipal licenses is responsible for the increase under both the Bombay City Police Act and the City of Bombay Municipal Act. The rise under the Bombay Prevention of Gambling Act is likewise due to the continued striving of the police to keep the various kinds of gambling under control, On the other hand the following Acts registered a decrease :---

During the year under report 716 children and young persons under the age of 16 years were sent by the Bombay City Police to the Umerkhadi Children's Remand Home. Of these, 265 were picked up under section 7 of the Bombay Children Act.

Beggars.—4,869 professional beggars were dealt with under section 121 of the Bombay City Police Act, while 47 beggars were externed under section 27(2), Bombay City Police Act. In the absence of a comprehensive and effective scheme for tackling the beggar problem in Bombay City, the police are doing what they can to minimise the beggar nuisance.

Betting and gaming.—The following is the summary of the work done by the Bombay City Police to suppress gaming in the City :---

(3) 1,791 duplicate certificates were issued.

15. The total number of direct Magisterial cognizable cases was 25,622 against 22,778 in 1934 and 19,562 in 1933.

Cognizable crime, direct cases. Of these, 24,561 ended in conviction, giving a per centage of 95.86. The total number of persons involved in these cases was 25,726, of whom 24,568

(5) *Pilgrim Season.*—The Muhammadan Branch worked in close cooperation with the Pilgrim Department during the Haj Season.

(6) Pilgrim passes to Iraq.—832 passes were issued to Muhammadans proceeding to Iraq on pilgrimage during the year as against 1,110 in 1934. 1,459 persons actually travelled on these passes as against 2,066 in the preceding year. In one case a pass was refused.

(7) Emergency certificates.—90 foreigners were recommended for Emergency Certificates during the year as against 117 in 1934.

(8) Recommendation for visas.-14 foreigners were recommended for visas as against 217 in 1934. The increase in 1934 was due to the applications received from a large number of circus artistes visiting Bombay.

(15) Theatrical Artistes.—Deposits were taken and guarantees of return passages enforced, in the case of 170 theatrical artistes as against 47 in 1934. They came to India via Bombay during the year to take up engagements. The guarantee deposits were necessary to ensure that these artistes were not stranded in India after the expiration of their contracts.

(16) Strikes.—During the year under report there were 19 industrial strikes as against 28 in the preceding year. The decrease in the number of strikes was largely due to the efforts of conciliation made by the Labour Officer appointed by Government.

(17) Prosecutions.—(a) Under the Indian Penal Code.—At a meeting held under the auspices of the Bombay Congress Socialist Party in April 1935 in observance of the "All-India Detenue Day" one Bhayyaji Kulkarni alias Kamalakar Gangadhar Kulkarni delivered a speech in Marathi which came within the purview of section 124-A, Indian Penal Code. He was convicted and sentenced to two years' rigorous imprisonment by the Chief Presidency Magistrate, Bombay, in May 1935.

(b) Under the Indian Press (Emergency Powers) Act of 1931.—With a view to checking the illegal activities of the communists in Bombay the following communists were prosecuted for disseminating unauthorised news sheets. They were sentenced by the Presidency Magistrates as mentioned below :—

- 1. Tukaram Krishna Sarmalkar, member of the banned Young Workers League, Bombay.
- On 14th February 1935 by the Presidency Magistrate, 2nd Court, Mazgaon, Bombay, sentenced to 6 months' rigorous imprisonment under section 18 (1) of the Indian Press (Emergency Powers) Act, 1931.

2. Vasudeo Ramchandra Birodkar, General Secretary of the Red Press Workers' Union, Bombay. On 29th October 1935 by the Chief Presidency Magistrate, Bombay, sentenced to pay a fine of Rs. 100 in default 6 weeks' rigorous imprisonment under section 18 (1) of the Indian Press (Emergency Powers) Act, 1931. He made an appeal against the order of the Magistrate but it was dismissed by the High Court of Bombay on 29th January 1936.

(c) Under the Indian Arms Act of 1878.—A foreigner arrived at this port with an automatic pistol and some ammunition which he failed to declare to the Customs. He was charged under section 19, clause (c) and (f) of the Arms Act, 1878. He was convicted and sentenced to pay a fine of Rs. 50 on each count by the Magistrate.

(18) Warning to the Press.—During the year, warnings were given under the orders of Government to 43 persons as against 36 in 1934 for non-compliance with the requirements of the law relating to presses, books and newspapers.

(19) Proscription of literature. 2.288 copies of proscribed literature were seized during the course of the year.

(21) Political situation.—During the year under report the political situation was more or less quiet. The Golden Jubilee of the Indian National Congress was celebrated in the city from December 27th 1935 to January 1st 1936. Most of the functions were organised at the Gokuldas Tejpal Patshala at Gowalia Tank Road, where the first Congress Session was held fifty years ago. All the functions passed off peacetully.

Crime Branch.

(22) Organisation.—During the year 1935, the strength of the Crime Branch remained the same as last year with the exception of the newly inaugurated *Modus Operandi* Bureau. The results achieved during the year have been most gratifying as will be seen from the figures given below :—

(22-A) Criminal cases.—During the year, the Crime Branch dealt with 232 cases under the Indian Penal Code (including 17 transfer cases from the mofussil) as against 213 cases in the previous year. Of these, 20 cases were magisterial enquiries as against 11 in the previous year. The 232 cases were investigated by the different branches as detailed below :—

(25) Gambling cases.—During the year, the Crime Branch took out 70 warrants as against 53 in the previous year out of which 58 were executed as against 41 in the year 1934; 12 were returned unexecuted as against the similar number in the previous year. 698 persons were arrested of whom 509 were convicted, 68 acquitted or discharged and cases against 121 were pending in Courts at the close of the year as against 300, 173, 40 and 87 respectively, in the previous year. 22 cases of street gambling were detected involving 63 persons of whom 41 were convicted, 9 acquitted and discharged and cases against 13 were pending in courts at the close of the year as against 32, 59, 42, 13 and 4 respectively, in the previous year.

(26) Interesting cases.—The following are some of the interesting cases detected during the year :—

(i) Colaba house-breaking case.—On the 5th of November 1935 house-breakers entered premises situated on Wodehouse Road and after breaking open cupboards, etc., decamped with jewellery valued at Rs. 5,590. Criminal Investigation Department officers and Finger Print Experts, who were quickly upon the scene of the crime, succeeded in obtaining a readable finger print which led to the arrest of a known criminal named Paul Bein. He confessed and pointed out his accomplice John Antone, a house-breaker with a bad record.

The property which had been divided into two equal shares had been disposed of by each accused in various parts of the City and single items were often found to have changed hands four to five times.

The investigating officers worked night and day as delay would have spelt failure. Over 45 witnesses were traced and examined.

The efficiency and speed with which this case was investigated may be gauged by the fact that within a week a complete recovery of the property was effected and all accused persons concerned were under arrest.

The two principal accused were sentenced to 3 years and $2\frac{1}{2}$ years imprisonment respectively while 7 receivers were fined sums ranging from Rs. 500 to Rs. 100.

(ii) Window bar cutting and hole boring cases.—During the year 1934 and part of 1935 it was observed that a number of cases were reported in which window bars were sawn through or holes drilled in doors. Matters reached a climax when a case of a similar nature involving property valued at Rs. 19,654 was reported from the Maharbouri area.

A careful search of records disclosed the fact that one Usman Raza Khan had been arrested sometime previously for a case of window bar cutting. It was also ascertained that the man had been released on bail by the court pending the hearing of his case.

A watch was kept on him, and his room located. He was arrested and a search revealed certain stolen property. In the meantime a comparison of prints found at the scenes of other crimes with that of the accused was made and found to tally in three cases.

The mother of the accused produced some G. C. notes and property given to her by the accused who on seeing the same decided to confess. Property collectively valued at Rs. 20,874 was recovered from numerous places in Bombay and Azamgarh and was identified by complainants in 15 different cases. The accused was convicted in all these cases and sentenced to an aggregate term of 4 years and $6\frac{1}{2}$ months' rigorous imprisonment. Three receivers were also convicted and sentenced to pay fines.

(iii) Kingsway house breaking cases .- During the latter part of 1934 and the first few weeks of 1935 an epidemic of house-breakings in the Hindu Colony at Kingsway caused considerable anxiety to all concerned. The number of buildings under construction in this area which has recently and rapidly become a thickly populated suburb, made detection a difficult matter. An habitual offender named Kazi Muhammad was arrested and some stolen property was recovered from the room of his mistress. His accomplice Gulam Husein whose prints had been found at the scenes of some of the crimes was caught after a long search. Property valued at Rs. 3,000 pertaining to 18 different cases was eventually obtained after a long investigation in which recoveries were made all over the city and also in Poona. The accused were convicted and sentenced to 51 and 31 years respectively and ordered to notify their residences on release. Four receivers were sentenced to pay fines ranging from Rs. 50 to Rs. 150.

(iv) Victoria drivers theft case.—A somewhat unusual type of crime consisting of theft from passengers' baggage whilst on their way to and from Railway Stations caused considerable anxiety to the police. In most cases the locks remained intact which diverted suspicion to servants who had helped to pack and unpack their masters' trunks. It was also impossible to locate where and at what time the crimes were committed.

One Ibrahim Ismail, a victoria driver, was arrested in the month of March for a similar offence but as no property could be traced to him he was discharged. For some time this type of crime ceased but again broke out in November 1935.

A watch was at once kept on the movements of Ibrahim Ismail and two of his associates namely Abdul Gaffar an ex-driver and Sultan Nizam another victoria driver. On the 18th November these two associates who had been driving about together were noticed attempting to dispose of some jewels. They were promptly arrested and gold ornaments and precious stones valued at Rs. 1,800 recovered.

Enquiries went to show that the property belonged to a merchant of Surat and had been removed from his trunk whilst he was being driven from Bombay Central Station to a hotel. The complainant identified all the property.

Many assorted duplicate keys were found and it was obvious that these two men and their companion Ibrahim were responsible for the series of such theft cases.

They were sentenced to 4 months' rigorous imprisonment each, deprived of their licenses and externed from this city.

(v) House breakings and thefts committed by a gang of Bohras.—In the month of August 1935 a Bohra woman living in Dongri section left Bombay on a visit. During her absence the house was broken open at night and property valued at Rs. 1,476 consisting of ornaments, clothes etc., stolen. Some finger prints found indicated as the culprit one Ibrahim Kadarbhoy, who had been twice previously convicted. From his description the Criminal Investigation Department succeeded within a week in arresting him. Another man Fakruddin found with him was also arrested. When the room of Ibrahim was traced, it was found on enquiry that two others. Khanalli and Muhammad Husein, who had been staying there had suddenly left Bombay apparently having come to know of his arrest. Muhammad Hussein one of the associates was traced to Sunnel in Indore State, but an officer who was sent there immediately found that Muhammad Husein had again left for Bombay. As the result of a telegram from Sunnel, Muhammad Husein was arrested as he alighted from the train in Bombay when Rs. 104 and a gold watch were recovered from him. The fourth man Khanalli was also traced in Bombay and arrested.

During the course of enquiries it transpired that this gang had committed a large number of house-breakings and thefts mostly from Bohra houses.

Stolen property from 7 house-breaking and theft cases amounting to Rs. 2.801 was recovered and the four arrested persons were convicted and sentenced.

(vi) Robbing Haj Pilgrims by Dhatura Poisoning.—During the Haj season a large number of poor pilgrims come to Bombay. Their paltry savings are not sufficient to pay their fares to Jedda, so they seek help from well-to-do persons and charitable institutions. In February 1935, some cases were reported in which poor Haj pilgrims were deprived of their savings in a clever manner. They were approached by one or two men who would decoy them to a solitary place under the pretext of obtaining assistance for them from some benevolent Seth or institution. The Pilgrims were then given tea or sweets which made them unconscious when they were robbed of their money and other belongings. In three such cases Dhatura was the poison administered.

A watch was kept for a gang suspected to be operating in the neighbourhood of the "Musafarkhana" where many Haj pilgrims stay, with the result that on 8th February 1935 a search was made of a temporary hut in that neighbourhood occupied by one Muhammad Hussain alias Pahilwan. This disclosed some burnt pieces of cloth, papers, a leather money bag and a cloth purse. Pahilwan was arrested and on this information two of his associates viz., Siddick Hussain and Chedi Rahimat were arrested. The purse and the cloth bag were identified by a Punjabi pilgrim as part of the stolen property. He also identified the accused as the men who had given him sweets. He had lost Rs. 90 of which a sum of Rs. 24 was recovered as the result of a statement made by the accused, who were sent up for trial and on conviction sentenced to 4 months' rigorous imprisonment each on 21st June 1935 for theft, there being insufficient evidence to support a charge of poisoning under section 328, Indian Penal Code.

(vii) American Cotton Exchange case.—In the latter half of the year 1933 two associations named "The Indo Foreign Cotton Exchange" and "The American Cotton Exchange" came into existence in Bombay ostensibly for the purpose of dealing in cotton but actually for the purpose of gambling in Teji Mandi on American Futures. They had taken the precaution to give such a semblance of legality to their transactions that the Registrar of Companies had no alternative but to grant them recognition and both the bodies were registered under the Company's Act. Thereafter both the organizations considered themselves immune from Police interference. As time went on however these associations began to send applications and informants to the Police making allegations against each other. The press and the public began to take an interest in their activities and to accuse the police of conniving at their existence. There was little doubt that the business carried on by both the associations was pure gambling but their articles of associations had been so drawn up as to make it very difficult for the police to distinguish it from . bona fide business. The highly technical nature of the transactions was another difficulty.

An officer from the Criminal Investigation Department was deputed to study the transactions and on his report a warrant was eventually issued to raid the American Cotton Exchange. This took place on 15th April 1935 when 262 persons were arrested and a cart load of books and other documents and each to the extent of Rs. 7,400 were seized.

The investigation and preparation of the case for Court was a huge task requiring a great deal of patience and perseverance. The Managing Director, who was the prime mover of the whole concern, was specially charged under section 117, Indian Penal Code, and was sentenced to 3 months' simple imprisonment and Rs. 250 fine (reduced in appeal to the fine alone). Out of the remaining accused 207 were convicted and fined. Cases against 16 persons are still pending. The total amount of fine inflicted was Rs. 7,555.

(viii) Hundi Fraud case.—On 30th April 1934 a complaint of cheating was lodged in respect of a false hundi for Rs. 3,372 alleged to have been drawn by a resident of Sholapur. The amount was paid by the complainant but enquiries made at the Bangalore Branch which was supposed to have drawn the hundi showed that it was a bogus one. A case was therefore recorded under section 420, Indian Penal Code.

Enquiries showed that two forged hundis purporting to have been drawn for Rs. 3,372 and Rs. 2,963 on firms of Bombay had been cashed. It was also learnt that a man giving the name of a well-known Bombay merchant had produced a forged letter.

Information regarding the wanted man was immediately circulated. A letter was written to the District Superintendent of Police, Sholapur, giving the full facts of the case and he was requested to trace the accused. The Sub-Inspector of Police, Barsi Town, learnt that one Harakchand Nemchand Baldotta was spending money lavishly.

On being questioned this man made a statement and property valued at Rs. 4,697-14-3 was recovered. Harakchand was arrested and the Bombay Police were informed. Two other persons who had assisted Harakchand in the commission of the offences were also arrested.

One of the accused had forged the two hundis as well as the letter of introduction. From the evidence of experts it was established that the handwriting on the forged documents was that of one of the accused persons.

Accused Harakchand Nemchand was committed to the Sessions and convicted under sections 467, 471 and 420, Indian Penal Code (three charges), and sentenced to 5 months' rigorous imprisonment and a fine of Rs. 1,000 or in default 6 months' rigorous imprisonment on each count. The case against one of the accused persons was withdrawn and the third accused died during proceedings in the Lower Court.

(ix) Ghanshamhdas Sawlaram's case.—On 3rd August 1934 an application addressed to the Deputy Commissioner of Police, Crime Branch, Bombay, was received from the manager of a Bombay firm alleging that their cashier Ghanshamdas Sawlaram had absconded having misappropriated Rs. 43,288–10–9.

As the result of a telegram sent to the Superintendent of Police, Sonthal Paraganas, Dumka, Bihar and Orissa, to arrest the accused and seize the property, if found, the Deoghar Police seized jewellery, cash, etc., and sent the same to Bombay. About a year later accused Ghanshamdas who had absconded surrendered to the police. Enquiries showed that he had misappropriated in all Rs. 39,786-15-3. He was convicted under section 408, Indian Penal Code, and sentenced to one day's simple imprisonment and a fine of Rs. 1,000 or in default 6 months' rigorous imprisonment. The accused made good the loss sustained by the complainant.

(x) C. P. DeCunha's case.—On 13th April 1933 one J. M. Miranda reported to the Police that C. P. DeCunha, a solicitor practising in the Bombay High Court, had committed criminal breach of trust as an attorney in respect of several securities and shares entrusted to him by the complainant and committed forgery of the complainant's signatures on some of the securities. A case under sections 409, 420, 467 and 471, Indian Penal Code, was recorded. Securities and 584 shares valued together at Rs. 90,000 in four commercial undertakings were misappropriated by the accused.

The accused had absconded from Bombay in March 1933 and taken refuge in Portuguese territory. He was arrested at Daman in October 1934 and he claimed, as a Portuguese subject, to be tried there. After protracted hearings in which all the Bombay witnesses were produced before the Judge, Court of Justice, Damaun, he was eventually convicted under sections 409, 420, 467 and 471, Indian Penal Code, on 23rd September 1935 and sentenced to 3 years' penal servitude and to pay a fine of Rs. 730 or in default one year's rigorous imprisonment. He was also ordered to pay Rs. 90,000 to the complainant and Rs. 3,000 to a witness in the case, who had been cheated by the accused in this transaction.

(xi) Spurious Drug Haul.—On the 11th May 1935, one P. B. Madon filed a complaint before the Presidency Magistrate, 5th Court, Dadar, Bombay, under sections 482, 483 and 485, Indian Penal Code, alleging that some unknown persons were manufacturing and disposing of spurious Squibbs Ague Specific. This complaint was referred to the C. I. D. for enquiry.

From enquiries it was ascertained that $4\frac{1}{2}$ gross of empty Squibbs Ague Specific bottles had been delivered by a bottle seller to a room in Laxmi Bhuvan, Fanaswadi, occupied by one Harakchand Purshottam Shah, who left Bombay shortly after.

On his return, the police arrested him, searched the room, and took charge of several articles found therein, among which were printing blocks used for printing labels of several well known patent medicines and specifics and thousands of labels. Shah's statement led the Police to a room in a building at Khetwadi where they found one Kamalnarayan Bhawani Dutt with printing blocks, labels and also six dozen spurious bottles of Squibbs Ague Specific.

Representatives of the patent medicines filed complaints and prosecuted H. P. Shah and K. B. Dutt and also B. W. Mahajan, at whose press the labels were printed and B. M. Narvekar alleged to have been the block-maker.

Several cases are still pending before the Chief Presidency Magistrate, Bombay. The following cases have been concluded :---

(28) Action under section 565 of the Code of Criminal Procedure.— 233 persons against whom orders to report their places of residence to the police on release from jail under section 565, Criminal Procedure Code, were dealt with during the year 1935 as against 144 in the previous year. Of these 29 were arrested for fresh offences committed by them. 67 disobeyed the orders out of whom 24 were re-arrested and dealt with under section 176 (2), Indian Penal Code, as against 23 in the previous year.

(29) Counterfeit Currency Notes.—During the year 1935, 63 forged and altered notes were sent by the Currency Office for enquiry as against 235 in the previous year. The cause of the decrease is attributed to the difficulty of producing a passable forgery of the new issues.

(30) Enquiries sent by Magistrates.—20 cases were referred to this branch for enquiry and report by the Magistracy during the year 1935 as against 11 in the previous year. Reports in 19 cases were submitted after investigation and one was still under enquiry at the end of the year.

(31) Modus Operandi Bureau.—This branch was started in the year 1935 with a staff consisting of one Inspector, one Manager and a few clerks. The bulk of the work up to the present has been the collection and filing of data regarding crimes and criminals. A whole time photographer has now been employed. Information regarding crime and criminals is being compiled. It is anticipated that when at full working strength with a more complete record, this department will prove an asset to the force. It has already been of great use in certain important cases.

(32) Prevention of Crime Branch-Organization.-During the year 1935 the Prevention of Crime Branch completed its third year of preventive work. On 6th April 1935, the Record Branch of the Crime Branch was also amalgamated to this Branch. The smooth working of the Branch reflects great credit on its hard worked staff which consists of the following :---

3 Head constable writers.

2 Head constables.

11 Constables.

2 Head Office clerks.

This small staff under one officer finds it very difficult to cope with the numerous items of work. The branch deals with the following preventive measures :---

(a) Working of the Criminal Tribes Act.

(b) Foreigners' Act.

(c) Externment under section 27 of Bombay City Police Act.

- (d) P. R. T. from Bombay.
- (e) Records.

(f) The branch also investigates cases detected by them and rounds up gangs of bad characters for externment and deportation. It has also effected some raids under the Gambling Act on notorious clubs and associations.

(i) Indian Penal Code and Local Act cases.—The Prevention of Crime Branch investigated 2 Indian Penal Code cases and 258 Local Act cases during the year 1935, the American Cotton Exchange Gambling Raid case being a notable one.

(ii) Foreigners deported out of British India.—27 persons were deported under section 3 of the Foreigners' Act III of 1864 during the year 1935 as against 18 in the year 1934. 12 returned deportees were dealt with under section 27, Bombay City Police Act. The cases of two foreigner deportees await the orders of Government. Three foreigner deportees were granted licenses to stay in British India and orders against one were cancelled.

(iii) Returned Foreigner Deportees.—50 persons who had been deported under the Foreigners' Act were traced as having returned to Bombay in contravention of deportation orders during the year 1935 as against 45 in the year 1934. These 50 undesirables were disposed of as under:—

- (a) 25 dealt with under section 4 of Act III of 1864 and re-deported.
- (b) 12 externed under section 27, Bombay City Police Act.
- (c) 3 given licenses to return to British India.
- (d) 10 deportees cases are pending.

(iv) Externment from Bombay City under section 27 of the Bombay City Police Act IV of 1902.—135 persons were externed under the provision of section 27-IV-02 as against 107 in the year 1934 and 20 externees were dealt with under section 128-IV-02 as against 19 in the previous year. The cases of 494 persons who were brought up for externment by the divisional police were also dealt with during the year as against 401 in the year 1934. The total number of persons externed under section 27 of the Bombay City Police Act during the year 1935 was 624 as against 508 of 1934 and 411 of 1933.

The additional powers under section 27 (2-A) of the Bombay City Police Act IV of 1902 given to the Commissioner of Police by Act XXXI of 1933 to deal with individual bad characters were found very useful and of the 624 persons externed during the year, 347 persons were dealt with under this sub-section as against 196 in 1934. The increasing use of this weapon in dealing with the criminal element of the city has had a marked effect on the general incidence of crime.

(v) P. R. T. System.-480 convicts were transferred to prisons nearest to their homes by making use of the P. R. T. system (vide Government Resolution, Judicial Department, No. 6986 dated 30th October 1901) as against 443 in the previous year. Of these, 271 were externees convicted under section 128-IV-02 for early return to this city.

(vi) Working of the Criminal Tribes Act.—The total number of registered members of criminal tribes in Bombay at the beginning of the year 1935 was 279. During the year 45 were added to the roll. Owing to cancellation, death, transfer outside Bombay, etc., 21 were removed from the Registers. The net number of registered members of criminal tribes in Bombay at the end of the year 1935 was 303 as detailed below according to tribes :—

14 persons were prosecuted under section 22 of the Criminal Tribes Act; 13 were convicted and the case against one was withdrawn, as against 18 dealt with in the previous year, of whom 17 were convicted and one discharged.

9 persons were dealt with under section 25 of the Criminal Tribes Act and were transferred to their districts as against 15 in the previous year. One Pasi was dealt with under section 21 (1) of the Criminal Tribes Act.

129 registered members of Criminal Tribes from other Districts came to Bombay on passes for employment, etc., and all of them returned, as against 114 last year, 25 of whom remained in the city.

67 registered members of the Pasis and Bhars Tribes came to Bombay on passes for employment from the mofussil during the year, of whom 59 have remained in Bombay as against 96 who visited Bombay in the previous year, 78 of whom remained in the city.

13 members of Criminal Tribes who are on probation are residing in Bombay.

15 persons were kept on the "D" list under rule 12 of the new Criminal Tribes Rules, during the year, of which 2 were subsequently registered during the course of the year and 13 remained on the "D" list.

2 registered members of Criminal Tribes were removed to a Settlement under section 16 of the Criminal Tribes Act (i.e., 1 Rajput Bhampta and 1 member of a mixed gang).

1,600 finger impression slips of Pasis and Bhars and other tribes were recorded during the year 1935.

(33) Pathan Branch.—This branch assisted the City Police in all cases where Pathans were concerned and also gave assistance to the mofussil police. Amongst the more important cases the Poona cases of robbery and escape, etc., of Mir Dad Pathan, the Princess Street and Maharbouri Murder cases and the Bhoiwada Dacoity case deserve mention, all of which ended in conviction. Valuable assistance was also rendered to the Special Branch in matters relating to Pathan residents, new arrivals, passports, etc. The Motor Vehicles Department were also assisted in like manner in verifying the characters of applicants for licenses.

This Branch was also busy during the year attending to complaints against Pathan money-lenders.

During the year the Pathan Branch obtained orders against 5 Pathans under section 27-IV-02. 9 Pathans were deported under section 3-III-1864 as foreigners and one was dealt with under section 4-III-1864. 14 persons were made P. R. T. to the jails nearest their homes under the P. R. T. system.

The Pathan Branch in spite of its small strength (i.e., 1 Inspector and 2 Head constables only) rendered valuable assistance to the Police and Shipping authorities in matters relating to Pathan and Punjabi seamen.

(34) Vigilance Branch.—The following is the summary of the work done by this branch during the year 1935 :—

(i) THE BOMBAY CHILDREN ACT, XIII OF 1924.

Section 7 (1)a.-46 destitute children were picked up under this section. Of these, 28 were sent to certified schools; 13 handed over to their guardians; 1 was declared a lunatic; 1 absconded from the J. J. Hospital and cases against three are pending.

Section 7 (1)f.—11 children were removed to the Children's Home from objectionable places.

Section 12.-1 case picked up under this section resulted in acquittal.

(ii) BOMBAY CITY POLICE ACT, IV OF 1902.

Section 121.—14 children were arrested for begging. Of these 3 were convicted (one was sent to a certified school); 3 handed over to guardians and cases against eight are pending.

DEPORTATION UNDER BOMBAY CITY POLICE ACT.

Section 27.-Six pimps were deported under this section.

(iii) Deportation under the Foreigners' Act.—One pimp was deported under section 3 of this Act.

(iv) THE BOMBAY PREVENTION OF PROSTITUTION ACT, XI OF 1923.

Sections 3 (soliciting).-215 cases were picked up under this section. Of these, 208 were convicted, 3 were acquitted and 4 are still pending.

Section 5 (living on earnings).-24 cases were dealt with under this section. Of these, 16 were convicted, 4 acquitted, 1 withdrawn and three are still pending.

(v) INDIAN PENAL CODE.

Section 292.-1 case which resulted in conviction.

Section 366-A.-1 case which is pending.

Section 372.-3 cases, of which one was convicted, one acquitted and one is pending.

Section 373.—One case which is pending.

.

Section 376.—One case which resulted in conviction.

21. During the year 1935, the police placed before the Magistracy under the provisions of Chapter VIII of the Criminal

Preventive action. Procedure Code 60 persons against 61 in 1934 and 75 in 1933. Of the 60, 35 were convicted and 12 were discharged or acquitted. Of the remaining 13 the cases against 4 were withdrawn while those against 9 were pending at the close of the year.

In all 624 persons were externed from the City of Bombay, 277 under section 27 (1) of the Bombay City Police Act being members of gangs associated for the purpose of committing offences and 347 under section 27 (2A), not being natives of Bombay City or the Bombay Suburban District and having been convicted more than twice of offences punishable under Chapter XII, XVI or XVII of the Indian Penal Code. 193 persons (of whom 117 were previously externed under section 27 (1) and 76 under section 27 (2A)) who returned to Bombay without permission were dealt with under section 128 of the Bombay City Police Act. In the preceding year 508 persons were dealt with under sections 27 (1) and 27 (2A).

585 persons wandering about between sunset and sunrise for the purpose of committing offences were dealt with under the provisions of section 112 of the Bombay City Police Act as compared with 670 in 1934.

These preventive measures have greatly helped the police in keeping the crime under control.

22. No new building schemes were undertaken during the year. Police Buildings. The scheme for providing, in the compound of the School of Art, a four-storeyed building with office accommodation on the ground and first floors and residential quarters for two Superintendents and four Sergeants on the 2nd and 3rd floors has been administratively approved by Government and the construction work will shortly be started.

23. The distribution of licenses granted under the Arms Act during the year is shown in tables A, B, B (1), B (2) and B (3) printed as appendices. New licenses granted during the year numbered 438 covering 641 weapons and the number cancelled was 483 covering 721 weapons. At the close of the year there were 6,315 licensed persons possessing 9,409 arms which shows a decrease of 45 in licensed persons as compared with the figures for the year 1934. All the arms possessed by any one person are entered in one license.

Of the 19 firms licensed to deal in arms, ammunition and military stores, 9 only are licensed to deal in ammunition of the prohibited bores, viz., seven Indian and two European; 13, including the above 9, deal in rifled arms and ammunition and breech and muzzle-loading guns and ammunition. Two deal in old arms, 2 in lead shot and 2 in swords.

During the year 3,103 references were made to verify arms and ammunition bought from dealers in Bombay.

10 persons were prosecuted for offences under the Act and all of them were convicted.

Under this Act, 395 licenses were issued. They are classified in table

Explosives Act. "C" appended to the report. Magazines, places for the manufacture of fireworks and blasting powder and other places licensed under this Act were periodically inspected and found to be maintained in accordance with the orders of Government.

11 persons were prosecuted under the Act, of whom 10 were convicted and 1 was acquitted.

The licenses issued under this Act, classified in table "D" appended Petroleum Act. to the report, show an increase of 43 compared with the last year's figures. Licenses granted for the storage of dangerous petroleum in quantities exceeding 40 gallons number 181 which is a decrease of 30 as compared with the figures for

the year 1934.

There are 146 underground tanks with pumps installed against 171 during the previous year.

4 persons were prosecuted under the Act, of whom 2 were convicted and 2 were acquitted.

Poisons Act. 111 licenses under the Poisons Act were granted. A statement submitted by the Bombay Electric Supply and Tramways

Tram cars. Company, Ltd., giving details of accidents to passengers, pedestrians and vehicular traffic in connection with the running of tram cars is appended to the report as table "F". The number of slight accidents show a decrease of 85 as compared with the figures of 1934 and that of the serious accidents a decrease of 6. There were 12 fatalities.

The amount collected in fees for the renewal of registration of these vehicles was approximately Rs. 7,64,686.

The figures of motor vehicles registered and re-registered in each district of the Presidency proper, the City of Bombay and the places outside the Presidency, during the year, are given in Table E (2), appended to the report.

There were 959 taxi cars licensed to ply for hire. These vehicles were thoroughly inspected in March and October. The taxi meters were carefully checked and complaints of overcharging were negligible. A stricter method of examining taxi meters has been introduced and all meters are now tested in accordance with the system employed by the Metropolitan Police, London.

76 lorries and 190 omnibuses were licensed to ply for hire. The number of taxi drivers' permits was 1,280; 119 permits were issued to drivers of public lorries and 203 were issued to drivers of omnibuses. 173 Conductors' permits were issued.

There were 4,720 motor accidents or 668 more than in the previous year. The figure includes accidents in which no injury was caused to persons; for instance, collisions with victorias, tram cars, labour carts, etc.

Out of this number 86 were fatal accidents resulting in 86 deaths or one more than in the previous year. The motor vehicles involved in such accidents were thoroughly examined by officers of the Motor Vehicles Department.

In 20 of the fatal accident cases the police were of opinion that the driver was at fault, and as one driver died after the accident, prosections were launched in the remaining 19 cases, with the following results :--

In 59 cases the police were of opinion that the drivers were not at fault or there was no evidence on which to charge them. In 7 cases the drivers concerned could not be traced.

Included in the above, the following 4 cases are worthy of special mention :---

(1) A taxi entering a side lane at night passed over three persons including a woman, sleeping in the lane with their heads towards its centre. The driver accelerated speed and disappeared. The woman died on the spot while the other two persons escaped with minor injuries.

(2) The driver of a car proceeding along Hornby Vellard, while engaged in conversation with its other occupants, lost control of the car which dashed through the wooden railings and fell on the rocks below with the result that the driver was killed on the spot and the occupants considerably injured.

(3) An unfortunate cripple beggar crawled in front of a taxi that had stopped to set down passengers. The driver not having seen the beggar on moving off drove over him with the result that he succumbed to the injuries.

(4) A Hindu male came by his death as a result of the most reprehensible and inhuman conduct on the part of the driver who while out for a joy ride with his friends mounted a foot path and ran over the deceased who became entangled in the understructure of the car and was dragged for some six miles. The driver did not stop the car when an alarm was raised or when his attention was drawn to the sound of a human voice from beneath the car. He was awarded the maximum punishment prescribed by law, viz., 2 years rigorous imprisonment, his licence was cancelled by Government and he was permanently disqualified from obtaining one in future.

Of the 86 fatal accidents, 26 occurred between 7 a.m. and mid-day, 27 between mid-day and 5 p.m., 27 between 5 p. m. and mid-night and 5 between mid-night and 7 a.m. The time of accident in one case is not known. In 17 cases the victims were children under 12 years of age. In 41 cases the age ranged from 12 to 40 years; in 11 cases from 40 to 50 years and in 17 cases the age was over 50 years.

Motor cars were concerned in 39 fatal accidents, light lorries in 18 and heavy lorries in 23. In 6 cases the vehicles were not traced.

Periodical inspections were carried out particularly of heavy motor vehicles whilst running on the roads. As a result 546 vehicles, i.e., 198 cars, 264 trucks, 8° iorries and 4 motor cycles were found to have serious mechanical defects due to overloading and faulty maintenance and the registrations of the rehicles were cancelled till the defects were rectified. In each case both the driver and the owner were prosecuted for using and permitting the use of a defective vehicle.

In addition to these road inspections 2,043 heavy motor vehicles, trucks and omnibuses were inspected at the Head Police Office. On an average each vehicle was twice inspected before certified as fit.

The registration of 24 heavy motor vehicles was permanently cancelled as these were found to be mechanically worn out and dangerous for use on the road.

In all there were 2,741 prosecutions under the Indian Motor Vehicles Act and the Rules thereunder during the year, of which 1,982 ended in conviction. The figures for the previous year were 2,501 and 1,543 respectively.

The number of driving licenses issued and renewed together with the number of duplicate motor driving licenses issued was 20,834; the fees thereby accruing amounted to Rs. 1,43,193.

In addition to their work in the City the Inspectors visited Poona every month to examine motor vehicles plying for hire and to test applicants for public motor licenses. The districts mentioned below were also visited by them during the year.

Omnibuses.—The Bombay Electric Supply and Tramways Company, Limited, plied their omnibuses over 8 different routes in Bombay City during the year. Last year the number of routes was 10 and the reason for this number being reduced to 8 is that three routes were combined into one, viz., the "A" route which runs the whole length of the island from the Afghan Church, Colaba, to Mahim. The omnibuses are kept in excellent condition and cover the routes to a scheduled time. 47 new omnibuses were licensed during the year.

On the occasion of the celebration of Their Majesties' Silver Jubilee, 68 officers and men (including Police Hospital and Head Police Office staff) were awarded Silver Jubilee medals. 29. Exclusive of Europeans the number of officers who can read and write stands at 166 against 164 in the preceding year. Of these, 147 were literate in English against 143 in 1934. Literate head constables and constables numbered 2,500 as against 2,103 in 1934. Of these, 349 have a knowledge of English as against 258 in the preceding year.

638 recruits came under training of whom 340 were allotted to Divisions, 23 resigned, 27 were discharged, while 248 continued under training at the close of the year.

The First Aid classes for officers and men were kindly arranged for by Dr. D. S. Bharucha, Honorary Secretary, Friendly Unions Ambulance Centre of the St. John Ambulance Association. 19 officers and 141 constables passed the examination in First Aid to the Injured.

We are indebted to Dr. D. S. Bharucha for his honorary work.

As compared with the figures for the year 1934 there was a decrease of 1 in the number of persons killed and an increase of 348 in the number of persons injured.

The increase in injured persons is shared by motor vehicles (277), other public conveyances (103) and private conveyances other than motor cars (48). Decreases occur with tram cars (34) and hack victorias (46). An analysis of fatal motor accidents for the last three years gives the following figures :-

and shows very little difference from last year, except in the case of untraced fatalities, which might be construed as an indication of the growing callousness of a section of the Bombay Motoring Community. The increase of two fatal accepts from motor vehicles in the year whilst regrettable could only be expected in view of the ever increasing traffic on the roads, and one can only be thankful that it was not greater, considering that the first ten days of the New Year produced no less than 7 such fatal accidents.

It is to be hoped that compulsory insurance for heavy motor vehicles and the increased taxation on them will result in a considerable reduction of those semi-decrepit commercial vehicles to which I referred last year, vehicles which even in spite of constant repairs rarely succeed in remaining in a mechanically sound condition for more than a short space of time.

Non-fatal accidents continue to increase, and must be expected to increase to some extent in proportion with the increase of motor vehicles on roads towards improving whose safety for the pedestrian very little in a material sense is being done. Inadequate and insufficient pavements, non-provision of definite parking places and consequent congestion of streets by standing vehicles, a dearth of traffic islands which both ensure a haven of refuge for the pedestrian and a uniform flow for the vehicle, non-improvement of street lighting to keep pace with modern conditions, all these are factors which contribute directly or indirectly to the growing toll of accidents to the citizens of Bombay. A further contributing factor is to be found in the legal acceptance of a plea of "error of judgment" when a risky piece of driving has led to a prosecution. The discharge of accused in such cases soon becomes widely known and probably has the effect of tempting certain motorists to take unjustifiable risks.

The public conveyances other than motor vehicles comprised 2,189 victorias, 1,515 labour carts and 214 hand carts.

During the year, the Public Land Conveyance Licensing Department and the Divisional Police prosecuted 12,072 owners and drivers of public conveyances other than motor vehicles for different offences under the Bombay City Police Act and the Bombay Public Conveyances Act. 542 drivers' licenses were suspended for varying periods while 17 licenses were either cancelled or not renewed. 259 horses were rejected as unfit for further use.

There were in all 8 cases of theft, criminal breach of trust, rash driving, etc., against hack-victoria, labour cart and hand cart drivers during the year. Of these 3 ended in conviction, 3 in discharge, while 2 were pending at the close of the year.

(e) During the year 1935, 207 South African repatriates arrived in Bombay under the Assisted Emigration Scheme and in accordance with the arrangement in force were paid bonus money and sent to their destinations by the police. 70 of such repatriates were permitted to return to South Africa, having refunded the money expended on them by the Union Government.

(f) The Bombay City Police Co-operative Urban Bank showed a slight improvement owing to certain facilities afforded to its members with larger holdings. There was an appreciable reduction in the number of resignations, while the membership increased from 1,827 to 2,087, the share capital from Rs. 2,62,653 to Rs. 2,75,546 and the monthly income from Rs. 1,500 to Rs. 1,800. Owing to the continuance of restrictions on indiscriminate borrowing coupled with the fact that the bulk of the Bank's funds has to be invested outside in gilt-edged securities at comparatively low rates of interest, the Bank could pay only 4 per cent. dividend on its share capital.

The Bank has built up reserves exceeding Rs. 60,000 and its financial position remains as strong as before. It continues to enjoy the destinction of being classed as "A" by the Registrar of Co-operative Societies, for which its capable Chairman Mr. W. W. Godwin deserves to be complimented.

 $\sqrt{(g)}$ Recruitment of depressed classes.—29 Mahars, 2 Mochis and 1 Chambhar were recruited during the year 1935. Of these, 1 resigned and 2 were discharged.

(\hbar) The Traffic Advisory Committee which was appointed in 1929 continues to be of great assistance in dealing with important traffic problems and with improvements in traffic control in the city of Bombay. A detailed report on the working of this Committee for the year 1934 was submitted to Government in October 1935; a report on its work during the year 1935 will be submitted in due course.

(i) This year the number of cases which took six months or longer for a decision to be reached in the Courts was 84 as against 54 in the previous year. (j) The following events of interest occurred during the year :-

(1) Of outstanding importance was the Silver Jubilee celebration of His late Majesty and Queen Mary. Bombay responded with marked enthusiasm and loyalty to this unique occasion. The illuminations were particularly fine and the crowded thoroughfares taxed the resources of the force to the utmost.

(2) His Excellency the Governor of Bombay honoured the Bombay City Police by reviewing them on the 3rd December and decorating 18 officers and men (Indian titles to 3 officers, Indian Police medal to 5 officers and men, Silver Jubilee medals to "10 officers unable to attend the investiture earlier in the year).

36. Once more I have great pleasure in placing on record my indebtedness to my Deputy Commissioners of Police and the other officers and men for their loyal co-operation and hard work during the year. The Office staff under its indefatigable and thoroughly reliable Superintendent Mr. Chhaganlal Maneklal Tijoriwala, M.B.E., I.S.O., did excellent work during this as in past years.
