PREFACE

Social security is one of the most important objectives of economic planning. It cannot be achieved unless the revenue of the State is substantially increased. Whatever the shape of the Indian Government in the postwar period, taxation must be kept up at a high level. The economic development of India and measures of social security both depend upon it.

The publication of the second part of the Bombay Plan advocating death duties has made the task of the Government easier for the levy of death duties as the opposition against them generally comes from the rich classes. If the death duty legislation is drawn up with the approval of an influential majority and if it is in harmony with the accepted economic and social concepts of the day, it will go down to the posterity as a good, just and moral tax. It will provoke the minimum of discontent and popular dissatisfaction if the Government can take the public into confidence by boldly declaring that the proceeds of the duty shall be 'ear-marked' for providing social security services to the hunger-stricken millions of India.

The object of this monograph is to present some of the broad social and economic principles underlying death duties. The Italian economist Rignano's The Social Significance of Death Duties (with an introduction by Lord Stamp) and Shultz's The Taxation of Inheritance contain useful information on this subject from various points of view. This monograph is mainly a summary and restatement of ideas which are the subject of agreement among professional economists.
