GOVERNMENT OF THE CENTRAL PROVINCES

(1) Reports by the Commissioners of divisions on the Land Revenue Administration of the Central Provinces for the year ending the 30th September 1934.

RESOLUTION

The revenue year 1933-34 was another period of difficulty and anxiety. The monsoon rainfall of 1933 was excessive and proved unfavourable to the kharif crops except rice. Heavy rain in the middle of September, followed by considerable showers in October, damaged the cotton and juar crops, particularly in lowlying and water-logged areas, those in many riverain villages of the Chanda and Wardha districts being destroyed by floods. In spite of the scantiness of the winter rainfall the prospects of the rabi crops were promising, but a period of severe cold and frost towards the end of January and the beginning of February damaged wheat crop considerably and minor rabi crops more extensively, particularly in low-lying and riverain tracts. Further damage was caused by rust and insect pests, and in the end the outturn of both the rabi and kharif crops other than rice was again below normal. Rice was returned at 13.5 annas (14.5) and cotton, juar and wheat at 8.6 annas (9), 11 annas (10.4) and 11.2 annas (9.8), respectively, the average outturn of all crops being only 87 per cent. (89 per cent) of the normal. There was no improvement in the prices of agricultural produce; on the contrary, a fall of about 15 per cent in the price of juar and wheat wiped out the advantage of the slight increase in the outturn of those crops. A small rise in the price of cotton followed the conclusion of the Indo-Japanese agreement, but the rise came too late and did not last long enough to benefit the actual growers.

- While in the rice area the economic position gave 2. no cause for concern, thanks to the long succession of good harvests, elsewhere in the Central Provinces agriculturists had again to contend with the cumulative difficulties of low prices and poor outturn. Nevertheless. indications are not wanting of a progressive adjustment to the conditions of the protracted depression. most encouraging feature was an increase of 406,262 acres, in the cropped area which was common to all districts and to all the more important crops. It is clear that, although the tightness of the rural money market may have brought about a curtailment of unproductive and ceremonial expenditure—a result which can be accepted as not unwelcome—it has not prejudiced agricultural operations. No demoralization has set in, and although their resources have diminished, cultivators still have the will and the capacity to make the best of their circumstances. In especial there have been no of distress among the labouring classes. Unfortunately the year was not a healthy one, and most districts in the Nagpur and Chhattisgarh divisions suffered from a severe epidemic of cholera. A large number of preventive inoculations was carried out, and the readiness with which the people adopted this precaution is an encouraging sign of the advance in public opinion about health matters.
- Government continued to do its best to ease the hardships of agriculturists. In the flood-stricken areas, in addition to the organization of private relief, Government forests were thrown open for the free extraction of grass, fuel, edible produce and building materials. Test works were started in a few places in one district, but evoked little response and were closed down after a short trial. Taccavi loans to the extent of Rs. 7.40 lakhs were distributed. Remissions and suspensions of land revenue were granted to the extent of Rs. 4.13 lakhs and Rs. 16.66 lakhs respectively, and general orders were issued directing that arrears of land revenue in excess of one year's demand should be remitted forthwith. Although the number of coercive processes issued rose from 6,893 to 7,737, the policy of not sing undue pressure on people genuinely unable to pay was adhered to strictly. Out of Rs. 18.50 lakhs of arrears and Rs. 1,31.56 lakhs of current demand, Rs. 4,57 lakhs and Rs. 1,20.11 lakhs respectively were collected, the percentage of the normal demand being 95 (94). No coercive

process was used for the recovery of taccavi. Out of Rs. 39.50 lakhs due for recovery only Rs. 5.91 lakhs were recovered, and the balance of Rs. 33.59 lakhs was left unrecovered, though for the most part unsuspended. The bulk of these arrears is due from the Jubbulpore and during the year districts Saugor a view to determining with initiated were and debtors the of capacity paying a suitable refixation of instalments The large amounts of land revenue and taccavi left uncollected at the end of the year bear unmistakable testimony to the leniency shown by Government in recovering its dues. Measures such as the exemption of minimum agricultural produce from attachment in execution of decrees by collectors remained in operation during the year.

Special enquiries were made into the oft-repeated complaint that proprietary shares or villages are changing hands for abnormally low prices, and these enquiries showed that there is no foundation for the idea. When Government investigated the possibility of buying villages in order to stimulate the market and enlarge its raiyatwari estate, it found that the prices at which they were obtainable were much in excess of anything that it could afford to pay as a business proposition.

Nor were Government's efforts confined to these administrative relief measures, which are after all undertaken normally in all times of difficulty. The constructive policy to relieve indebtedness, which began with the passing of the Debt Conciliation Act in the previous year, was continued. Debt Conciliation Boards were established at Balaghat and Narsinghpur in addition to those already appointed at Seoni and Khurai, and by the end of the year valuable experience had been acquired of the working of these new institutions. In all the four boards Rs. 31.72 lakhs of debt were reduced to Rs. 18 lakhs by the 31st March 1934, the percentage of remission being 43. The boards are growing in popularity, and their appointment has had the result not only of creating a more reasonable frame of mind in creditors but also of encouraging a certain amount of private conciliation. Legislation was undertaken during the year to deal with the reduction of accumulated debts and of future interest, to take power to reduce rents and revenue during the currency of a settlement, and to permit the transfer of occupancy holdings in favour of land mortgage banks, so as to enable this class of tenant to obtain long-term credit from the banks, the number of which has also been increased. All these measures were passed into law either during the year or soon after its close. The divisional reports bear witness to the fact that the people appreciate these constructive efforts of Government to mitigate their difficulties, and recognize that the cultivator's safest route is the path of law and order, and that his best friend is Government.

- On the whole the relations between landlords and tenants remained cordial. In the Bilaspur district the agrarian situation was further improved as the result of orders for the re-examination of the wajib-ul-arz entries regarding grazing rights, and it was possible to withdraw the punitive police. With the economic deterioration and the consequent difficulty of recovering rents the number of rent suits rose slightly to 26,073 (24,509), but this was inevitable in the circumstances of the year, and it is significant that ejectment suits declined from 283 to 216. Lambardars and kotwars also performed their duties well, in spite of the fact that the general depression added greatly to their difficulties. Patels in raiyatwari villages and mukaddams and their gumashtas continued to work satisfactorily. Although there was a slight fall from 32,731 acres to 31,815 acres in the area allotted in raiyatwari villages, and the area relinquished rose from 27,156 acres to 30,331, the condition of these villages did not show any marked deterioration. In the Nimar district the premium fetched at auctions was 43 (30) times the assessment. The question of improving the management of raivatwari areas is being further examined by Government. Thirty-five new village panchayats were established during the year, 23 of which were in the Chhattisgarh division alone. reports, however, again complain of the reluctance of these bodies to undertake administrative duties.
- 6. Consolidation operations made further satisfactory progress in Chhattisgarh, and a second chakbandi party was added during the year to meet the increasing demand. Since the introduction of the Act in 1926 consolidation has been completed in 520 villages, in which 1,065,939 khasra numbers have been reduced to 141,860. The cost remains at the low figure of Re. 0-4-0 per acre and the work continues to be self-supporting. Greater attention was paid during the year to the replacement of

missing traverse marks, but there is still scope for more intensive action in this matter in view of the large accumulation of missing and displaced marks. Government notes with satisfaction that the land record staff maintained its normal level of efficiency as is evidenced by the fewer punishments inflicted during the year.

7. Government has read with pleasure the names of the officers whose good work has been commended and records its appreciation of the unflagging patience and efficiency with which the Commissioners and Deputy Commissioners have administered their charges during another exacting year. Government's thanks are also due to Mr. Jayaratnam for his successful administration of the Settlement and Land Records Department during the year.

ORDER.—Ordered that a copy of this resolution and of the reports annexed thereto be submitted to the Government of India in the Department of Education, Health and Lands (Revenue), that copies be forwarded to all Commissioners and Deputy Commissioners, to the Commissioner of Settlements and Director of Land Records and that it be published in Part I of the Central Provinces Gazette.
