REPORT ON THE ADMINISTRATION OF CIVIL JUSTICE IN THE CENTRAL PROVINCES AND BERAR DURING THE CALENDAR YEAR 1940

[The figures in brackets denote the corresponding numbers in the previous year.]

A.—TRIBUNALS

High Court.—The number of Judges of the High Court Statement continued at six. The Honourable Mr. Justice Pollock proceeded No. 25. on leave from the 20th June 1940 and Mr. M. N. Clarke, I.C.S., officiated as Puisne Judge from the 18th August 1940 in his place. The Honourable Mr. Justice Niyogi was on leave from 2nd January to 14th April 1940, during which period Mr. W. R. Puranik, B.A., LL.B., Advocate-General, officiated as Judge.

- 2. District and Subordinate Courts.—The number of District Courts remained unchanged at nine. At the close of the year five posts of Subordinate Judges on the new scale were vacant in addition to four posts kept in abeyance, three Judges were on leave preparatory to retirement and one was officiating in a clear vacancy in the cadre of District Judges in which he has since been confirmed. Proposals to resume recruitment of Subordinate Judges were made and it is hoped to fill in a number of the vacancies during the current year.
- 3. During the year 17 [15] Extra-Assistant Commissioners 57 [58] Tahsildars and 45 [49] Naib-Tahsildars exercised Civil powers. The majority try only rent suits but in a number of isolated places they try petty money suits.
- 4. Distribution of Subordinate Courts.—Debt relief work which was undertaken by the Judges in addition to their regular work, threw a heavy strain on the cadre during the year. It was impossible to supply help at all places needing it and it was necessary to husband the available staff with the greatest care. This led to a substantial number of alterations in the arrangement of Courts. The linked Court system was discontinued between Nagpur-Saoner, Betul-Multai, Raipur-Baloda Bazar, Yeotmal-Kelapur-Wun, Morsi-Chandur and Khamgaon-Jalgaon of the places mentioned in last year's report and was introduced between Chanda-Warora, Jubbulpore-Mandla, Multai-Sohagpur, Raipur-Dhamtari, Amraoti-Chandur and Kelapur-Wun. Touring Courts continued to visit Rehli, Banda, Seoni-Malwa, Lakhnadon and Mungeli. A whole-time Court was opened at Sakoli and additional Judges both of the first and second class were provided as far as the cadre permitted at places requiring them.
- 5. Village Panchayat Courts.—61 [25] Village Panchayat Courts, 37 [22] in the Central Provinces and 24 [3] in Berar, were established during the year. 24 [13] Courts

were abolished. The total number of Courts functioning at the end of the year was 521 [502] in the Central Provinces and 514 [496] in Berar.

6. Training of Officers.—Mr. K. N. Subramanian was under training till the 2nd March 1940. Owing to the heavy demands on the cadre the number of Subordinate Judges undergoing magisterial training was reduced as a temporary measure from two to one.

- 7. Institution of suits in the High Court.—Of the two suits registered in the High Court one was transferred for trial under section 225 of the Government of India Act and the other, at first registered as a miscellaneous appeal, was subsequently ordered to be registered as a suit.
- 8. Institution of suits in Subordinate Courts.—Institutions in Subordinate Courts under the three main heads for the years 1936 to 1940 are given below:—

The Berar figures reflect the good prices obtained for cotton in 1939. Successive poor seasons had been forcing down the price of land and one good year's receipts led to a flock of pre-emption cases. It was even sufficient to stem temporarily the downward drift in suits for money and movables. As an illustration of the reaction of litigation to economic condition it is interesting to note that this, the first rise in litigation in Berar since 1933, follows the first really successful year since 1933. In the Central Provinces the downward drift in suits for money and movables continued as was expected and is shared by all districts. Rent suits increased considerably in Nagpur, slightly in Chhindwara and Wardha and decreased in other civil districts.

- 9. Institutions in Village Panchayat Courts.—Suits instituted in Village Panchayat Courts numbered 6,619 [6,539]. 6,512 [6,483] were disposed of. The decrees of Panchayat Courts were cancelled by Deputy Commissioners in 146 [237] cases. These figures exclude statistics of 60 Courts in the Yeotmal revenue district.
- 10. Valuation of suits.—The total and average value of suits Statement instituted during the year increased by Rs. 44,26,573 and Rs. 52 to No. 28 Rs. 20,166,168 [Rs. 15,739,595] and Rs. 242 [Rs. 190] respectively. Both rises are due solely to the filing of a number of exceptionally highly valued cases in Nagpur where total and average values increased to Rs. 78,17,764 [Rs. 33,15,064] and Rs. 509 [Rs. 236]. Elsewhere variations are relatively minor. The following table shows the figures for separate classes of Courts:—

Although disposals show an increase of 902, disposals by transfer increased by 3,853 and real disposals, i.e., disposals other than by transfer, were consequently lower by 2,951. The total number of suits disposed of after full trial decreased to 15,596 [17,886], 13,061 or 83.7 per cent resulting in favour of the plaintiff and 2,535 or 16.9 per cent in favour of the defendant. With the fall in the disposal of regular suits, rent suits assume a higher percentage value and this explains the increase in the percentage of cases disposed of by Courts of Subordinate Judges of the second class. The same reason coupled with the decrease in simple suits for money explains the decrease in the Courts exercising powers as Courts of Small Causes.

12. Durations.—The average durations in days of suits decided by the several classes of Courts during the year under report are given below:—

The figures are liable to violent fluctuations where they refer to cases severely restricted in numbers. Thus in the West Berar district the duration of cases in the Court of the District Judge decided on reference to arbitration was 2,928 [Nil] and in the East Berar district was 1,748 [37]. The inclusion in these small classes of a limited number of long pending cases thus produces a very large variation in the provincial figure. In the main class of cases, those decided after full trial, there was an improvement in duration except in the Courts of Subordinate Judges of the first class.

13. Pending files.—The following figures indicate the state of the pending files:—

There is a slight rise in pending files, the first recorded since 1933. That the increase is not greater is a matter of credit to the Judges in view of the shrinking of the cadre and the very considerable mass of Debt Relief work accomplished during the year.

- 14. The number of suits pending over six months and over one year was 5,014 [4,465] and 1,913 [1,722], respectively, but eliminating suits stayed was 3,688 [3,931] and 1,090 [1,350]. Nagpur has maintained the progress referred to in last year's report. In Hoshangabad where a fairly generous staff was provided a very substantial improvement was obtained as, eliminating stayed proceedings, suits over six months, one year and two years fell to 273 [832], 52 [126] and 21 [52] respectively. West Berar was more unhappily situated. Not only had the Judges to deal with a substantial increase in civil institutions but they had to cope with far and away the heaviest Debt Relief file in the province. It was impossible to provide all the help that could be desired and many of the Judges were seriously overworked. In these circumstances it is creditable that a slight reduction in active long pending suits can be recorded.
- 15. Conduct of trial.—Efforts to enforce a more correct procedure than that hitherto prevailing in the province continued throughout the year. District Judges comments indicate slow but steady improvement but do not minimise the difficulties of the project and display less of the rather facile optimism of previous reports. The general position appears to be that the drafting of pleadings is improving, their bulk has decreased, plaintiffs' replies are filed only when necessary and oral pleadings have almost died The instructions in Orders XI and XII are not much used. In certain cases Subordinate Judges objected that the enforcement of proper procedure, requiring amendment of pleadings, merely retarded the progress of cases. This attitude is entirely incorrect. Temporarily duration may be increased but eventually the proper procedure will be found the quickest procedure. In any case the proper procedure is that provided by law and, delays or not, must be followed.

An evil almost as great as that of defective pleadings was the general tendency to hear evidence piecemeal and to ignore the provision of the proviso to rule 1 of Order XVII. In 1939 instructions were issued for Judges to fix blocks of days in each month reserved for the recording of evidence. This is reported to have resulted in some improvement but there is no doubt that the evil still largely persists. The instructions in rules 120 and 121 of Civil Rules and Orders are still too much ignored and District Judges should impress them on their Subordinate Judges whenever occasion offers.

An interesting comment on the conduct of trials comes from Nagpur where the District Judge reports that while the junior Judges have successfully endeavoured to improve the standard of pleadings and to avoid the piecemeal recording of evidence, the Additional District Judges have done little and in some cases have virtually

ignored both the instructions issued by the High Court and the law on the subject. Whether the failure be due to slackness or to excessive rigidity of mind Judges against whom this complaint persists must understand that it is liable seriously to compromise their future.

- 16. Executions.—The total number of applications for execution before the Courts was 122,496 [120,196]. 99,644 [94,999] applications were disposed of during the year leaving a balance of 22,852 [25,197] pending, of which 3,601 [4,069] were over six months. Applications were wholly infructuous in 52.7 [55.4] per cent, partly satisfied in 14.4 [14.1] and fully satisfied in 12.7 [10.6] per cent of the cases. The amount realised in execution of decrees was Rs. 18,49,428 [Rs. 14,27,978]. Debtors were arrested in 218 [240] cases and imprisoned in 11 [10]. Movable property was attached in 4,424 [4,841] cases but sold in 565 [620] cases only. Immovable property was sold in 943 [1,088] cases. 4,864 [5,113] decrees were transferred to the Collector under section 68 of the Code of Civil Procedure.
- 17. Insolvency.—The number of insolvency petitions presented by debtors and creditors fell further to 339 [383] and 64 [90] respectively. The decrease requires no comment in view of the remarks made on the Insolvency jurisdiction in the report for the year 1937. Order of adjudication was passed in 295 [304] cases. 80 [80] petitions were dismissed under section 25, 24 [24] withdrawn under section 14 and 60 [78] were dismissed for death or default. Orders of adjudication of 370 [824] insolvents were annulled, 136 [262] insolvents were discharged absolutely, 33 [106] conditionally and 63 [48] after the expiry of the period of suspension.
- 18. One District Judge remarks that insolvency work in general is very poorly done and that Judges exhibit a regretable lack of understanding of and interest in the work. He finds that postadjudication work is often markedly unintelligent and dilatory. A similar criticism has been made before and the position appears to call for the attention of District Judges.
- 19. The system of appointing individual receivers from amongst the members of Bar is reported to be working satisfactorily everywhere, and it is to be hoped that the future will see improved liquidation and control of insolvents' estates. Rs. 226-11-10 was withdrawn from the Official Receivers' Remuneration Fund at Amraoti and Rs. 542-0-1 credited to the fund during the year. The balance in the fund at the close of the year was Rs. 3,154-9-5.
- 20. Guardians and Wards Act.—The number of estates under management and the number relinquished rose to 1,083 [1,056] and 89 [71] respectively during the year. 994 [985] estates remained under management at the close of the year. The complaints of previous years are repeated but under the existing law the Courts are often virtually powerless to improve matters. The enactment of far-reaching amendments to this unsatisfactory Act was suggested to Government during the year and if this is done the Courts will be in a better position to deal with existing defects.

- 21. Usurious Loans Act.—The provisions of the Act were applied by all Courts in suitable cases.
- 22. The Central Provinces Moneylenders Act, 1934 (XIII of 1934), and Central Provinces Reduction of Interest Act.—The Central Provinces Moneylenders Act is reported to be of great use and its provisions are widely applied in suitable cases and give substantial relief to debtors. The life of the Central Provinces Reduction of Interest Act ended on the 1st January 1940.
- 23. The Central Provinces Adjustment and Liquidation of Industrial Workers Debt Act, 1936 (V of 1936).—6 [7] applications were pending from previous year and 9 [11] were presented during the year. Of these 1 [Nil] was disposed of by discharge under section 22, 6 [10] petitions were disposed of by declaration under section 23, 1 [2] by death or default and 4 [Nil] were dismissed under section 14. At the close of the year 3 [6] petitions were pending. As pointed out in the report for the year 1937 the scheme of rehabilitation provided by the Act, has little attraction for the class of people for whom it has been enacted and there appears to be no prospect of its wide use.

C.—APPELLATE JURISDICTION

- 24. Appeals to Privy Council.—13 [13] applications for leave to appeal were pending at the beginning of the year and 12 [10] were filed during the year. 7 [10] were disposed of, leave being granted in 3 [5] and refused in 4 [5] cases. 18 [13] applications were pending at the close of the year. No appeals from the decisions of this High Court were decided during the year.
- 25. Appeals to Federal Court.—Two applications for leave to appeal to Federal Court were filed and disposed of during the year, leave being refused in both cases.
- 26. High Court of Judicature at Nagpur.—The table Statements below compares the figures of civil appellate work in the years 1939 Nos. 31 and and 1940:—

Institutions are the lowest since the High Court was created and for the first time since 1936 permitted a slight reduction in the pending files. The average duration of appeals from original and appellate decrees disposed of was 867.9 [713.1] and 520.2 [584.4] respectively. Continued attention was paid to the early disposal of those civil revisions which hold up proceedings in the lower court and by the end of the year the vast majority of interlocutory revisions filed prior to June 1940 had been disposed of.

27. 129 [88] appeals from original decrees, 345 [340] appeals from appellate decrees, 240 [167] appeals from orders, 536 [476] revisions and 9 [13] Letters Patent Appeals were disposed of after contest. The following table shows the manner of disposal by percentages:—

The percentage of decrees confirmed in first appeals shows a considerable improvement over the figure for 1939 (43.2 per cent). In other respects the variations from the previous year figures are not considerable and require no comment.

Institutions and disposals both decreased by 5.6 and 4.7 per cent respectively. There were 436 [444] regular and 58 [71] miscellaneous appeals pending over three months and 38 [31] regular and 5 [3] miscellaneous appeals pending over a year, of which 9 appeals were stayed. It is unfortunate that the rate of improvement in dealing with long pending appeals recorded last year has not been maintained but it has to be remembered that the slight improvement made was obtained despite the gathering weight of applications for revisions of the decisions of Debt Relief Courts to which for administrative reasons preference had to be given. The average durations of regular and miscellaneous appeals disposed of increased to 129.5 [112.3] and 124.2 [111.0] respectively. Duration could be substantially reduced if more satisfactory use were made of the provision of rule 11 (1) of Order XLI. An unexpected feature of the district returns is that the heavier the burden on the appellate judges the less use they appear to make of the power of summary dismissal. Thus in the West Berar and Nagpur divisions where the work has been heaviest the percentage of appeals summarily dismissed was under

I per cent and was much lower than in other districts where the work did not bear so heavily. Even making allowance for the personal factor that certain judges are more hesitant than others in dismissing summarily, this suggests that heavily worked judges, rather than deal with the appeals on admission, attempt to postpone the evil day by automatically and without adequate consideration posting the appeal for hearing parties. Such an attitude is of course short-sighted as temporary postponement of work is obtained only at the expense of eventually heavier work, and it is a matter to which District Judges should devote their attention at inspections.

29. Of 3,630 [3,808] regular civil appeals shown as disposed of in the preceding paragraph 22.5 [23.3] per cent were disposed of by transfer, 6.6 [8.0] per cent were summarily dismissed or not prosecuted, decrees were confirmed in 39.9 [38.2] per cent, modified in 12.9 [12.6] per cent, reversed in 13.9 [12.8] per cent and cases were remanded in 4.2 [5.1] per cent of the appeals.

D.—MISCELLANEOUS

30. By the close of the year the strength of the Bar had further increased to 2,434 [2,384], of whom 446 [452] were advocates. There were three complaints of professional misconduct against advocates and eight against pleaders, including two pending from previous year. Eight were either dismissed in default or for want of prosecution or sufficient proof leaving three pending at the close of the year. Relations between the Bench and Bar are reported to continue cordial.

The year under report was the first to which the revised rules governing the grant of pleaders sanads under clause (d) of the Second Schedule to the Legal Practitioners Act applied. So far there appears to have been little demand for such certificates.

31. Copying Branch.—The work in the branch increased, the total number of sheets filled in by copyists increased to 455,492 [411,334], of which 334,979 [311,921] were filled in at headquarters. The increase appears to be mainly due to the functioning of the Debt Relief Courts and led to the filling in of certain of the posts of copyists kept vacant in previous years. Rs. 589-8-0 [Rs. 597-3-0] was paid as section-writing charges during the year.

Procedure was provided by amendment of rules for the grant of urgent copies.

32. Records and Record Rooms.—The elimination of records is reported to be up-to-date in all districts. At Hoshangabad records are stored in three different rooms owing to insufficient accommodation in the main record room, and this increases the difficulty of control and administration. Rack space is reported to be sufficient at some places for only a very limited time and failing extension of record rooms it will be necessary shortly to adopt other expedients to meet the situation.

- 33. Working of Nazarat.—The sanctioned strength of process serving staff in the province was further reduced by two posts in the Nagpur district. In almost all districts the sanctioned staff appears to be in excess of requirements and a number of posts have been kept vacant. As this has been possible despite the service by the civil staff of Debt Relief processes it seems likely that there is room for further abolition of posts and steps are being taken to this end. The percentages of service of summonses and notices ranged from 81.5 [80.7] to 87.7 [85.0] and of warrants from 73.0 [76.1] to 89.7 [88.1]. Out of 139 [121] cases of obstruction to service reported during the year, 68 [50] were brought to trial, 23 ending in conviction, 2 in acquittal, 3 in discharge and 40 remained pending at the close of the year. A case of an attack on and robbery of a processserver by some persons in the Jubbulpore district was investigated and the accused were convicted under section 341, Indian Penal Code, and sentenced to pay a fine of Rs. 100 or in default to undergo simple imprisonment for one week.

The figures for 1940 include receipts in Debt Relief Courts for which no separate statistics were maintained. The system of inspection by Inspectors of Registration referred to in last year's report was discontinued in October 1940 as the expense of the system was incommensurate with the leakages detected. On the whole the Civil Courts emerged creditably from the ordeal but the leakages detected were sufficient to justify the continued vigilance of the Courts.

- 36. Buildings.—The new High Court building was occupied after the High Court vacation of 1940. The new Bar Room at Saugor was completed and it has been occupied by the members of the Bar. The provisions of adequate accommodation for the Bar continued to be a source of great difficulty at a large number of places.
- 37. Inspections.—The Honourable the Chief Justice visited Khandwa, Burhanpur and Amraoti during the year and the Honourable Mr. Justice Grille inspected the Courts at Sausar, Chhindwara, Sohagpur, Hoshangabad, Betul-Multai and Saoner. Owing to

technical difficulty about the provision of travelling allowance the inspection of certain Courts trying rent suits was under the order of the High Court deferred for one year. All the Civil Courts and offices due for inspection were inspected by the District and Sessions Judges.


