

When a state/country does as well as Kerala on the social front, it is natural to expect from it the ability to translate its social advantages of literacy, high life expectancy, low morbidity etc. into economic progress. Kerala however is not a case in point.

The state is home to a close 40 lakh unemployed people and yet oddly enough, Kerala observes, at an annual arrival rate of 2.35 lakh, an ever increasing in-migration for unskilled and semiskilled jobs from states like UP, Bihar, Orissa and West Bengal. A sample survey conducted by CDS (Centre for Development Studies, Thiruvananthapuram) concluded that migrants from West-Bengal, Uttar-Pradesh and Bihar constituted 40% of the sample workforce and that an average unskilled to semi-skilled labourer earns above Rs 350/day, six times national average of Rs 50-70 (the 4 month long survey was conducted in the districts of Thiruvananthapuram, Kochi, Trissur and Kozhikode). These labourers reach Kerala to work in varied sectors such as construction, jewellery, agriculture, hospitality, food processing etc. This influx is so pronounced that it has begun to impact the social fabric of the state; so if you're a Keralite visiting your hometown after a long time, the sights of Delhi-like flea markets, street vendors selling Bengali sweets and way too many men wearing pants (as opposed to Mundus/lungis) are bound to surprise (or perhaps even shock) you!

While on one hand Kerala struggles with chronic unemployment, on the other it welcomes migrants with (seemingly) open arms. How does one explain the dichotomous situation that Kerala is in? It's rather simple, Kerala struggles with educated unemployment. Effectively, the high literacy rate has "boomeranged" on Kerala by creating a glut of skilled labour that would not settle for less than a white-collar job. Economists like KK George refers to it as the "second generation" problem of growth. Kerala is fundamentally a remittance based economy; the state thrives on remittances sent by Malayalis engaged in semi-skilled or skilled jobs primarily in the gulf and the rest of the world. Remittance sent by Keralites has touched an annual figure of Rs. 60,000 crores. It shouldn't surprise us then that private expenditure on education and health in Kerala is highest in the country and far outweighs the public expenditure by the state in the two sectors!

Also, interestingly enough, data suggests that the remittances of over two million migrant workers provides indirect employment to about 4-5 million Keralites. The phenomenon of Gulf migration, which began in the 1970s, was taken for a panacea to the problem of unemployment by the government. This undue reliance on foreign jobs meant that the industrial sector in Kerala never took flight. There were other factors that were equally responsible for the mismanagement of the economic potential that industries and agriculture had such as the extensive communist regime, frequent bandhs and hartaals and tyrannous worker's unions.

Simply put, Kerala generates an able-bodied workforce that it does not have the means to employ. On the other hand, it faces severe labour shortage for agrarian jobs and such, simply because Keralites are too educated to take them up. The excess demand for the unskilled has led to daily wages in Kerala to rise above the national average by 5-6 times. Reports suggest that the immigrants from the north and north-east to

### The Suicidal Happiness

"Although one's own happiness protects one from suicide, the level of other's happiness is a risk factor," says Mary C Daly of the Federal Reserve Bank of San Francisco. She is one of the economists who has conducted a study and arrived at a startling conclusion. Its a mysterious paradox: the happiest states in the world have the highest suicide rates. The study shows that the states that rank high in 'life satisfaction' also have the highest suicide rates. Life satisfaction is the way a person perceives how his life has been and how they feel about it as they look into the future. It may be assessed in terms of mood, self-perceived ability to cope with daily life andmaking and managing relations with others. But, suicide as a scientific phenomenon is not understood properly by most individuals.

The study basically combines findings from two large and rich individual level data sets, one on suicide deaths and the other on life satisfaction. Human well-being is an important factor to be considered in the social sciences. Many developed countries around the world claim that the inmates of their territories comprise of happy and satisfied individuals. But the irony is that it is these countries which record the highest number of suicides each year if one goes by the WHO data. New Jersey ranks 47th in life satisfaction but it has a very low suicide rate. Hawaii is close to the top of the suicide list, in fact, fifth highest in the U.S but peculiarly enough it ranks 2nd in life satisfaction!

Personal unhappiness is far worse if we are surrounded by people who are relatively happy and satisfied with their lives. It is observed that misery is similar to wealth, both can be considered in relative terms. Human beings may judge their happiness or sadness relative to the misery or elation of others akin to the way in which people who have more money than the average feel poor in the company of wealthier individuals. Utah in the U.S is ranked 1st in life satisfaction but it has the 9th highest suicide rate. Researchers have come to the conclusion that countries like Sweden and Denmark which have greater equality in income distribution have higher suicide rates than the other similar nations. Therefore, countries such as Iceland, Ireland, Switzerland and Canada show relatively high happiness levels as well as high suicide rates.

India ranks 111 in the global happiness ranking list, much behind Bangladesh (108) and Pakistan (81) according to the World Happiness Report released by the United Nations General Assembly. But India ranks 46 in the world suicide rank list and Pakistan ranks 98 which further strengthens the paradox. Ultimately, the decision to commit suicide is influenced by relative comparisons and this explains the reason behind the existence of this peculiar paradox. The point is that inspite of the enormous amount of terrorist activities going on in Pakistan and the persistence of the threat to human life there, it still ranks higher than India in the World Happiness Report. This result can be questionable since its a little unfair to compare one country's happiness with the other because the languages, culture, political and socio-economic scenario and standard of living of different countries is different at any point of time. Yet there is no suitable explanation for the puzzling statistical evidence that in certain cases suicide rates actually drop during wartimes. As an economist one would state that the above findings indicate a positive relationship between a country's well-being and its suicide rates which leaves us with a point to ponder upon that residents of the happiest places on earth do not have the will to live on further! Public policy review anyone??

### Only C in Power

### How the B, R, I and S are left out of the 'Beijing Consensus'

When the term 'Washington Consensus' was coined in 1989 by the British Economist John Williamson there was global acceptance for it to a great extent due to the immense clout the IMF and World Bank held with regard to market based reforms. India as we know is no stranger to this. The expression carried significance at different levels. It was a consensus between two institutions, between many economists belonging to different countries and between multiple nations. Never mind the fact that the Washington Consensus was an instrument of influence for the United States and a couple of other nations of the west, it still was a form of general agreement.

The Beijing Consensus is however a 180 degree turnaround. The term coined to represent the Chinese development story involves no world organization like those in the Washington Consensus. It in fact involves no other nation. The Beijing Consensus is simply the People's Republic of China, Perhaps the most puzzling aspect of this expression. Why explicitly state it as a consensus if it really isn't one? Well most of us still look at China, the world's second largest economy as the next undisputed leader of this world (The United States will only unwillingly give up this honor). Also, its position as the leader of the glorified heroic group called the BRICS, a collective term for the emerging fab five: Brazil, Russia, India, China and South Africa asserts the shift of economic and financial power from the West to the East.

While the world has given much attention to the BRICS, they are often wrongly associated with the 'Beijing Consensus'. The recent summit

of these five nations in Brazil to setup the New Development Bank with USD 100 Billion to finance projects in nations that are subjected to strict and often harsh reforms by the Washington Consensus, can be described as great image building for China. While it is true that the BRICS carry only 11% of the influence in the World Bank, it is also true that the 'Chinese Development Bank', one of the four important banks in China, had outstanding overseas loans of over USD 200 Billion in 2012 (double the NDB's total capital and the highest in the world). China alone has been shelling out cash for infrastructure and natural resource projects in South America and Africa that value more than the USD 34 Billion loan limit set by the BRICS for their new bank.

The Chinese agenda is clear. Its domestic and foreign policies are aligned with rapid global expansion accompanied by the assertion of economic might. The BRICS while unquestionably significant in terms of challenging the western order that has been dominant since the end of the Second World War is only a public relations ploy by the Chinese. This author does not deny that these words show realism in its most conservative form. Global economic cooperation among the BRICS will remain second in China's priority list.

For Brazil, Russia, India and South Africa it must be understood that these nations will sadly not become part of any decision making group with China. Given the current economic and political climate, the establishment of the New Development Bank seems like fodder for the newspapers. While smaller nations can benefit from this bank, however in the long term its significance will reduce. Also, we are witnessing international cooperation lose its sheen, prominent now in the ineffectiveness of the United Nations and the rise of anti-EU parties in the European Parliament.

To sum up, in the Indian context, the NDB shouldn't be a cause to get excited. China being a significant player in the world today is free to pursue its own interest. India, on the other hand still relies on other nations for clout and support. What is needed is focus on regional development in the Indian Subcontinent, something that Brazil and South Africa and Russia (albeit forcefully) are already doing in their respective regions. A strong association with neighboring nations would create a strong consensus, which can stand up to the Washington and the (lone man) Beijing Consensus.

### **The Living Dead**

"And miles to go before I sleep, and miles to go before I sleep"

- Robert Frost

The fight to sleep. I quote Robert Frost, for a simple reason – there is lot left to accomplish and fight for in order to bring about the much argued question on the right to ask for permanent tranquil – death.

For quite some time now, the debate on the need for Euthanasia has gained momentum for a brief period and eventually fizzled out. On 16th of July 2014, the Supreme Court of India once again opened doors for elaborate discussions on the issue of Euthanasia, as there exists no formal judicial judgment on the same.

Before going ahead on this issue, it is desirable to familiarize ourselves with the terminology. "Causing the death of a person, who is in a permanent vegetative state with no chance of recovery, by withdrawing artificial life support is only an 'omission ( of support to life)' and not an act of killing" - The Supreme Court of India.

It is hard not to be perplexed by the complexity of this hypocrisy. On one hand, it seems completely justified to hang felons while on the other it is utterly unlawful to permit Euthanasia. A few decades ago, a curious case of a certain Aruna Shanbaug brought about this debate for a brief period. While on duty as a nurse at the King Edward Memorial Hospital, Aruna was sexually assaulted by a ward boy leaving her in a vegetative state for 41 years. After a hard fought battle with the Government, on the 7th of March 2011, the Central Government allowed passive Euthanasia (retracting medication) to be passed as a law (which in itself was a landmark judgement), but rejected a plea for active Euthanasia (death via lethal injections).

Should it be legalized or otherwise? The highlight of my next discussion lies in the economic sensibility. Is it morally right to hold on, when in a way, we are just wasting time and resources on a situation that will not improve? Wouldn't it end the much suffered misery of the patient as well as the family's? In the case of Aruna Shanbhug, she lies virtually blind, disabled and brain dead for four decades!

What would you do in such a predicament? The general acumen where euthanasia has found many supporters, is that it stops the person from having a bad quality of life. Pain and suffering would deprive a patient of a peaceful life and when the pain becomes unbearable it should be the patient's choice to decide whether it is the right time to let go or continue in hope for a better tomorrow. The quality of life and decision to live with the pain must solely be vested in the individual and no one else. Far be it for me to criticize anyone who thinks otherwise, but I'd urge you to question yourself on this issue.

From an interesting medical standpoint, countries such as Belgium and Netherlands have legalized Euthanasia and albeit the rise in numbers of patients opting for it, the medical organizations have extracted lemonade from dead lemons! A unique proposition in Belgium has not only enabled patients to exercise the law on Euthanasia but also persuaded them to donate organs which in turn saves lives of many others. This interesting turn of events has gained widespread popularity in countries practicing Euthanasia. If countries in Europe can, why mustn't India adopt similar carriage?

Whether you consider euthanasia to be justified depends on which side you take on a much broader ethical question: Are you a consequentialist or a deontologist?

Consequentialism, from a normative ethical standpoint, is one which states that an act which produces a favourable outcome for a larger group irrespective of the type of act, is moral and accepted. While in deontology, normative ethics define and obligate a person to fulfil his duty by the virtue of his moral actions.

The real question still lies in who you really are, a consequentialist or a deontologist? The rest is self-explanatory.

### **Constrained Freedom**

### FIFA-Jekyll Hyde

January 2014 marked a remarkable six months for Afghanistan when its football federation was bestowed the Fédération Internationale de Football Association ('FIFA') Fair Play Award. It began in August 2013 when the country hosted its first international friendly in ten years. In the following months, it held the second edition of the Afghan Premier League, wherein eight teams participated from across the country in front of packed stadia. Crucially, the attending spectators grew wider with women and families in the stands. It was a distinct coming together of people from various backgrounds. In September, at the South Asian Football Federation Tournament, they won their maiden title by beating India – a euphoric triumph given their resources.

For a country riddled with war, terrorism and political unrest, the global recognition was a stark, positive reminder of the ability of sport to defy turmoil and achieve progress. Indeed, the award represented the culmination of several highlights in Afghanistan's disrupted sporting history. Afghanistan's heartening football story stems from FIFA's Goal Programme. The global body's projects involved the construction of artificial turf pitches in Kabul and the establishment of the national association's offices. FIFA of course can claim genuine credit for many other initiatives. The organization implements development programmes across its 209 member countries. These programmes can be classified under technical support, development projects and performance activities. In China alone, FIFA aims to undertake 70 projects with an emphasis on women's football and educational programmes.

The unique character of football, simplicity blended with indescribable aesthetic value, gives FIFA the important position as the guardian of world's most beloved sport. The game has incomparable reach, so does FIFA. So naturally, while the organization commands an innate respect and freedom in its operations, it also carries perhaps a more significant burden of hope than any other international organization. Football symbolizes hope, and its official body receives implicit trust around the globe.

The latest World Cup in Brazil showed up the precarious functionary FIFA is seen/has grown to be. Granting Brazil its first home cup since 1950 was regarded as the homecoming of football. Yet hours before the first ball was kicked this summer, there were violent protests in the host cities. Demonstrators agitated against the vast spending the government had incurred in its preparations for the cup; this, keep in mind, from the passionate fans of the most successful footballing nation of all time.

The Daily Mail, a British daily, in an article this May, covered the issues surrounding the unrest prior to the tournament. Consider the 40,000 capacity Amazon Arena in the city of Manaus built at a cost of 171 million pounds. Having hosted four matches during the tournament, it had been let out to Nacional FC, a club whose reported average attendance is 1,963. Then National Stadium in Brasilia was built at a cost of 375 million pounds. We need to put this into context and note where Brazil stands as a developing nation. Spending such extravagant amounts on infrastructure with one-time utility gave understandable cause for grief to the Brazilian locals.

To put this into perspective, Victor Matheson ponders in online magazine 'FiveThirtyEight' whether costs incurred in hosting mega events, such as the World Cup, have paid dividends for past host nations. Germany spent just under 2 billion dollars on stadia infrastructure in 2006. Its Stadium Use Index, the number of times its stadia filled to capacity during the year, stands at 19. South Africa, host of the next edition, also spent a staggering 2 billion dollars. Its Stadium Use Index is a lowly 6. Further back, Japan-South Korea spent in excess of 4 billion dollars combined but has had average stadia filled 9 and 4 times a year respectively.

This ultimately brings us to the responsibility that FIFA has towards the overall welfare of society. Their insistence on presenting the premier sporting event in countries which have little or no infrastructure base imposes severe strains on the governments and its people. The motives behind such decisions have been questioned in the past, but especially so after Russia and Qatar were granted the rights of hosting the World Cup. Increasingly, the top brass of FIFA have opted for profit driven motives and have entirely discarded the history and prestige that embodiethe sport.

### What is globalization?

Globalization has been defined as the process of international integration arising from the interchange of world views, products, ideas, and other aspects of culture. The Educated Leftovers

Food leftover for Gozy and the gang is careers, the state-controlled media portrays something heard of. Leftover women- 'Leftover' used together with 'women' hits one hard though. Sheng nu, or leftover women is the uncomplimentary term which was coined in 2007 by All-China Women's Federation (a government organisation founded in 1949 supposedly to defend women's rights) to refer to urban, educated and unmarried women above the age of 27 years. The Ministry of Education of the People's Republic of China officialised the word by adding it to the national lexicon.

China faces high levels of gender discrimination in the form of dowry, domestic abuse, unequal job opportunities and social status. Surprisingly, the United Nations Development Programme's Human Development Report (2010) gave China a "Gender Equality Ranking" of 38, just below the US (37) and far above Brazil (80).

The enterprising women of developing China work their way up to acquire a proper education, many with a PhD, to get a job equivalent to those given to men. Their educational qualifications usually surpass those of the males in higher positions.

These women are considered unfit for marriage because they are too qualified in comparison to their partners. The surprise element is that despite having university degrees and thriving

them as worthless without a husband and children. China's Ministry of Education explained this tradition as a 'failure to find a husband' due to overly high expectations for marriage partners. The conservative and male-dominated Chinese society chooses to disrespect 27 and above, professional, unmarried women, instead of celebrating their achievements and giving them due respect. This contradiction results in a societywhereinfemalehigh-flyershavedifficulty infinding partners.

Acontroversial (read appalling) statement by the All-ChinaWomen's Federation in 2011, aday after International Women's Daywas said that, "Pretty girls do not need a lot of education to marry into a rich family. However, girls with an average or ugly appearance will find it difficult. These girls hope to further their education in order to increase their competitiveness. The tragedy is they don't realise that as women age, they are worth less and less. So by the time they get their M.A. or PhD, they are already old - like yellowed pearls." The irony is that this Federation was established to protectwomen's rights and interests.

This situation has led to most women opting to marry at a suitable age and forgoing a career to

Another paradox is that demographically there

are not sufficient women in China to marry millions of expectant grooms. However, this concept of 'Leftover Women' has been promoted so extensively over the last seven years that it has become a general practice. Statistically, 1 in 5 women between the age of 25-29 remain unmarried. In comparison, the proportion of unwedmenis1in3!

In spite of all this pessimism, several women are trying to empower themselves and others too. This fight for gender equality is proving fruitful with some women carving a different lifestyle as that of CEO's and government officials. Having accepted this idea, many women are happy

Chinese Communist Party founder Mao Zedong famously proclaimed, "Women held up half the sky", with the intention of encouraging women in China to be more involved in industrial activities. With the rapid development of China, the world is analysing the role of women in their economic, political and social sectors, making it an important aspect of consideration.

## **Philanthropy- Contradictions & Challenges**

Dear Readers,

This month as we celebrate yet another year of our independence, feel that for some of us independence is still a distant dream. It seems like we are part of an Orwellian science fiction novel where, on the one hand, we talk of progress in our society having achieved a few global milestones but, at the same time, we witness instances of concentrated poverty which has resulted in higher crime rates coupled with poor health care, underperforming public schools and social immobility in the form of a rigid caste-class structure across India.

Throughout history, key game changing efforts can be witnessed via collective giving and action. I feel compelled here to clarify what I mean when I use the terminologies "collective giving and action", "philanthropy" and "charity" synonymously. I do not mean consumerism by this, which thrives on this concept of making the world a better place through one's consumption. That we can term as "vicarious philanthropy"

Let us begin our discussion by understanding the genesis of Philanthropy. Two bold visions from two men who wanted to use their vast wealth to do good: John D Rockefeller and Andrew Carnegie. They made benevolence a business. "To promote the well-being of mankind throughout the world" and "to promote the advancement and diffusion of knowledge and understanding" was their motto. They remade personal charity into an organized, institutional enterprise modeled on corporate business practices. This 'new philanthropy' did not seek to provide direct relief to the diseased or impoverished, but instead looked towards systematic, scientific principles to cure the "root causes" underlying both physical illness and social problems. More recently, it is embodied in the form of the legislation mandating corporate social responsibility (CSR) for large corporations and promises to redefine the role of these philanthropists as more wealthy individuals emerge with wealth. The question we need to ask ourselves today is whether this 'private philanthropy' in our current democratic society can wield over public policy?

A piece called "60 minutes", an effort by Bill and Melinda Gates and Warren Buffett to persuade fellow billionaires to donate at least half of their fortunes during their lifetimes saw Azim Premji transferring 12.5 per cent of his holding in Wipro — worth \$2.2 billion — to a public charitable trust named after him. Here critics and journalists need to ask how these donors are accountable to the public. Who constitutes needy non-profits and how are these funds earmarked for them?

The philanthropic ecosystem comprises of donors, foundations, NGOs and the government. Thus, I agree that given the scale of the challenges, the state cannot address these issues all alone and that the private philanthropic capital is vital. However, the accountability, transparency and impact evaluation of such funding remains questionable to a large extent. At the same time, the recipients of such funding, the NGOs also create a gap in philanthropic success due to infrequent communication to its donors and the public at large. According to a recent report by Bain & Company, Inc., only 38% of the donors receive at least a quarterly communication from the NGOs they fund, while more than 60% do not receive regular communication and of those NGOs that communicate, the majority do not convey any information about the impact of their

Another important concern is the impact evaluation by NGOs. This can be guite hard since a quantitative assessment of qualitative issues such as gender justice, dalit empowerment et al, which are in essence subtle and intangible changes, cannot be quantified with limited resources that most NGOs function with. For this reason, developing a mechanism on what should be measured and, how and when the measurement should occur becomes imperative.

Trends in Philanthropy leave me jaded and complacent towards any changes that might occur in this sphere. However, you should not let this dampen your spirits. An example of true philanthropy can be seen in our very own city in the form SWaCH (Solid Waste Collection and Handling), an autonomous enterprise that provides front-end waste management services to the citizens of Pune. Thus, I sincerely believe that with a disruptive mindset and philosophy driven by entrepreneurial insights, philanthropy will remain true to its meaning.

### Horribly Convenient: The Pros And Cons Of e-Commerce

The meteoric rise of online retail and the recent venture of Amazon in India coupled with the speculated investment by e-giants like Wal-Mart and IKEA has made everyone raise a brow at the dynamics of e-commerce (Yes, Mr. Ratan Tata is anticipated to invest in Snapdeal now). Going by the textbook definition of the term, e-commerce entails any type of financial trading of products and/or services using computer network, mostly the internet, whereas the trade pundits posit it to be a market entering strategy.

Examining the dimensions of this industry will tell you that not only does it encompass the good stuff market like 'Flipkart' (in laymen terms, no puns intended) but also the unexplored and shady markets viz. 'sexual wellness', psychotropic drugs etc- larger the area, greater the pressure or in this case, room for exploitation. We all perceive the world differently, usually in contradiction to the beliefs of other people. A fundamental example of this is the concept of religion. Though every religion shares the same goal, each provides a different pathway, usually in contrast to the pathway suggested by another. Is Economics too different? Different schools of thought within economics provide principles on how to reach the same goal (Economic Development instead of being closer to God in this aspect) usually in complete contrast to the other schools of thought.

Karl Marx bellowed that Religion is the opium of the masses, But isn't it ironic that after his death he himself would be a prophet of a new religion, communism, which would ultimately shape up more than half l was the epitome of an above average, Indian school student, carrying a century in the near future?. His theory was based upon contradictions, yet it proves his followers made his teachings contradictory in itself.

> In conclusion, I affirm that to understand human decision making, it takes a tool so ridiculous that it fails in every attempt to do as such. A tool which is riddled with contradictions. A tool, which as it develops makes things more complex than simple. A tool that is basically human in nature. What can be more beautiful than that? The mixture of people and their tolerance levels are always in the brim to explode. The mosaic appears coherent from a distance but as one goes nearer to it, the differences stand out distinctly. One is intrigued and perplexed to find the asymmetric variations in the symmetric systems.

Theme: The Oxymoron

Travelling in the North East hilly regions is the supreme experience in itself. During my stay in Cherrapunji that receives the world second highest rainfall next to Mawsynram(a few kilometers away from Cherrapunji), I learnt that the region faces shortage of water in spite of the region receiving torrential rainfall throughout the year. The locals from the region have to travel to long distances to fetch water. The rainwater flushes into the lowlands of Bangladesh and cause flooding in the Northern Bangladesh. Interestingly, Cherrapunji has been described as the "the wettest desert on earth". (Source: Robin Clarke's "Water: The International Crisis").

Why the demands of people with fat pockets are to be met with people who have torn pockets? The migrant laborers working on construction sites, building housing complexes for others, struggle to build their own

With the maniacal rate of urbanization people from rural areas throng into cities dreaming of better jobs. Amputee cities lack infrastructure to sustain the burgeoning crowd, inevitably push people to work in the unorganized sectors with no or rare social benefits. They are the invisible workforce added to urban areas in order to do menial jobs for urban crowd. In a time, they themselves become the part of the chaotic urban crowd. What becomes of them? I don't know or may be there are no real answers to such questions.

The money distributed to rural areas comes from urban areas. The weak societies have their representatives chosen from the strong families. The major rivers that are the source of creation for the villages become the cause of destruction by swallowing the villages. The question that comes to the mind is what if the urban concrete jungle is constructed by urban people and not from the rural migrant laborer. What if the weak societies choose representatives among themselves? What if the final

goods produced in a country are not from the resources exploited from some foreign land?

Bangladesh consumes about 85% of its resources to produce products, which are not used by the countrymen but are exported to the western worlds. For example: the country is blessed with water sources in the form of rivers and monsoon rain. However, the water resource is abused in all forms possible to humans, for instance: more than 24nlitres of fresh water is consumed to produce one small piece of cloth in Bangladesh cramped factories. Most factories there have outdated power loom machines with the highest degree of inefficiency. The machine consumes comparatively more resources just to produce handful quantities of products. The clothes produced in the country are mainly exported to the western countries for a meager throw away prices. In my opinion, the price must include the variables of natural resources consumed like amount of water being wasted, which otherwise would have been utilized for domestic purposes of the countrymen. Isn't it an unfair system where the west is shifting all their low works to the less developed countries? It seems like concentrating all the westernized worldly filth into small pockets of lands and then shut down/ isolate that land from the rest of the western world.

This is not only observed in economically/military/socially-compromised nations but also with the huge military capacity country like India and China, which for many reasons have become the Factories of the world. The natural resources are exploited for the raw materials from the third world nations only to serve the western world.

The road to my village is not a picturesque view but that of gigantic monstrous vehicles randomly excavating the mother earth. From the window seat of the dilapidated bus, I am trying hard to recollect my childhood memories but alas could only think of Destruction-Exploitation-Bonded Labor-Invisible chains-Greediness-Pathless-Environment Degradation- Lost Innocence.It's a shame that these naked truths go

### Pink Revolution- A Catastrophic Development

India, a country whose economy has been predominantly agrarian, with 49% of its population deriving employment from agriculture and allied sectors, is facing the sword of pink revolution, a euphemism for the meat business. The Indian farmer who is highly dependent on his livestock for that extra income which enables him to survive during periods of low productivity is getting deep into poverty because of this pink revolution. On one side the government has been promoting livestock raising, with policies designed to increase the welfare of marginal farmers but simultaneously the economic reforms carried out by it in the context of meat industry, have turned India into a lucrative place for setting up abattoirs and sourcing meat cheaply by traders and exporters. It has led to an alarming rise in the number of illegal slaughter houses and cattle trafficking throughout the country. Despite the sentiments attached to beef, India today is one of the world's top beef exporters, second only to Brazil. Beef worth \$29m was exported in the last fiscal year.

The government is providing meat exporters huge subsidies .Estimates show that Agricultural And Processed Food Products Export Development Authorityprovides 25% to 60% subsidy on transport of meat ,pre cooling facilities,cold storage,brand publicity,packaging development and so on. The exporters are earning huge profits while polluting the water systems and taking away the traditional indian aesthetic values of life and nature. Cattle are intrinsic to agriculture, providing a second life to marginal farmers. There can be no justification for subsidising export of pink meat. It has led to milk shortage and a depleted live stock number. India which boasts of being the highest producer of milk in the world is facing a race against time to save its status of being the largest producer. The white and the green revolution which led to revival of indian economy is slowly being overtaken by pink revolution. There is no rationale for a policy which is depleting the livestock number.

The government is promoting livestock rearing with huge subsidies being given to farmers, so that they become self sufficient but it's policy of allowing cattle slaughter is creating a situation of panic among rural population. The ignorant farmer is selling his precious cattle to slaughter houses in search of some money but in the long run he is left with no source of livelihood. The subsidies given to these slaughter houses is allowing meat traders to acquire cattle from farmers even at high prices, thus luring them to sell their healthy cattle to abbatoirs. Carabeef, which is primarily the flesh of buffalo has resulted in dearth of buffalos. Their decimation has impacted the milk and dairy products market all over

The government has to make its stand clear, whether it wants India to be the largest exporter of beef in the world or it's rural population to be self sufficient and prosperous. The policy of subsidising meat exports is taking away the precious wealth of India, its livestock, which has been the back bone of rural employment. To make India the golden bird which it was once called, the government has to review its policy before it is too late. There is a need to preserve the high values attached to r living things in the hindu tradition. There is a need to preserve the cultural heri-

### **Livable Cities**

Almost one third of India's growing population is urbanized and spread across its fledgling cities. Urbanization is often talked about as a solution to a lot of problems in India. While there is a marked difference between living standards in a city when compared to a village, the moot question is, are our cities actually livable? 'Livable cities' is a concept that came about in the 1980s and has slowly changed the perspective of urban planners around the world.

### What is the concept of Livable cities?

Livable cities is a holistic concept that focuses more on people and how cities can add value to people's lives through ways that eventually lead to happier people and more importantly productive individuals. Do better standards of living alone guarantee a better life? That is a question a lot of researchers have pondered upon and the answer is often contrary to the expected. The problem lies in our attitude of treating the symptoms or the disease rather than the person as a whole. Think of a city as a massive home for a huge family. In our Indian cities, the majority of that family is unhappy because of the small problems in their home troubling them every day.

### **The Problems**

The first problem is what I would like to call the 'Environment around an Individual'. Ever wondered how a child from one home grows up devoid of compassion and a child from another grows up to appreciate artistic expression. The environment can have issues like a lack of playgrounds, lack of space for the elderly for recreation and to interact, shortage of psychologists and counselors, lack of sporting facilities and centers imparting life skills and the list simply goes on. It is impossible to involve a solution for every tiny problem when planning for a city but efforts need to be made to improve on such issues because they bring down an individual's quality of life. We may have above average standards of living but we rank really low on quality of life.

A second set can be clubbed into what can be termed 'Dampeners' Our cities are increasing in their sheer size every day. The urban sprawl

brings with it not only a lot of management headaches but also leaves a lot of people in the city at a disadvantage. It is ironic that we as a country advocate smaller states for administrative gains but are happy to expand our cities. Distances to workplaces, schools and colleges are increasing every year. Commuting issues have become a major dampener of happiness in a lot of lives. Then there are issues like pollution and a lack of proper waste management which have adverse impacts on health and significantly raise healthcare costs. Allergies from pollution and related factors have skyrocketed in the recent times with 30% of the population suffering from respiratory allergies. Sustainable solutions are the order and all civic agencies need to work in coordination which is rarely the norm in India. Our civic planners consider pedestrian issues really 'pedestrian'. Footpaths are sacrificed for wider roads leaving pedestrians helpless. Walking and cycling can only be encouraged with the necessary infrastructure in place. The focus while planning should be to move people rather than vehicles. Research shows that new roads and highways are cramped by vehicles completely in some years, widely known as induced travel Other dampeners also include a substandard grievance redressal mechanism. Policing can be improved by imparting soft skills to cops. 'Dampeners' lead to high stress levels and result in a population that is mentally unhealthy which will lead to direct or indirect costs to the government, for example, a higher crime rate and healthcare costs. So it's all the more imperative that civic planners keep

The city can transform into a place that is livable if planners take the protection of fundamental rights of everyone as the starting point. A playground is a child's right just as a polite cop is a law-abiding citizen's right. Just think about the past two days and remember how many times the city you live in denied you your fundamental rights. I am sure you will find one instance.

### **Genuine Imitation: A Theoretical Experience**

"10 ways to become successful and rich!", "7 ways to be more effective" and best of all "5 ways to make friends", well these are the kinds of self-help books available nowadays. You go to any bookstand in Pune today and it will be inundated with such books. So what is this? Why are we being sold the success stories of others? And why do we need to imitate the life of others?

All of us have been compared at one time or the other, with our peers, siblings or cousins. Not only this, we have even tried to read up the lives of others to get the shortcuts to success in life. But is life really a series of bullet points to follow? Well, not exactly. What may apply to one may fail to apply to others, and that's what exactly we fail to see.

Nassim Nicholas Taleb has quite clearly described this problem as simply a problem of statistical knowledge. People who become rich down as the top 5 things to do to be successful. But what we don't realise is that their cause of right place at the right time. But we fail to see so many others who couldn't make it though they must have tried the same.

In the same context, nations all over the world have been trying to copy each other's growth models or even propagating their models over the years. But why the genuine imitation here?

Soon after the financial crisis the Beijing Consensus came into picture, which promoted the mixed economy over the Washington Consensus, which propagates free exchange market related economy. The financial crisis didn't affect China much, mainly because it was under the supervision of the State. But are the Chinese right in selling their story?

Another example could be that of Japan. Developing countries have been trying to copy the Japan growth model. The Japan model – is rightly summed up by Michael Schuman, "To spur on the high levels of investment necessary to generate rapid growth, the model depends on state-directed subsidization to make investing in certain industries or sectors more attractive and successful write their success stories and less risky than it otherwise would be. people who fail... well we really don't get to Cheap credit is made available for industry or know their stories. So the people who make it to the state outright orders money to be invested the top analyse their lives and very conveniently in certain preferred projects. The exchange list down the things they think have got them rate is controlled to encourage exporters. All there.. Similarly, for companies that strive, sorts of subsidies, for energy, exports and so their factors are taken into account, and listed on, are dished out. Banks are not commercially oriented but act to a great degree as tools of government-development policy. All of these sucess could be luck or that they were at the methods funnel money, private and public, into industrialization, creating the astronomical growth rates we see again and again in Asia." (State source)

China and Japan are just two of the countries trying to highlight their models. Though China is seen as a ticking bomb that can explode any day due to the excessive involvement of the state, the Japanese scenario has more factors associated to its development than the copying countries realise. As Kenichi Ohno, puts it in his book, "The Economic Development of Japan", "the dynamism of Japanese society was the result of cumulative interaction between domestic and foreign systems in which internal institutional evolution and responses to foreign elements were repeated throughout history.'

Thus, as the heading suggests, imitating others, at micro or macro level is more of a theoretical experience; that means, it looks good in theory, but fails in practice. Chalking out bullet points for success may not go perfectly right for you. What we need is a more widened approach, where critical analysis should be done of all the factors taking also into account luck and randomness, before blindly embarking on the journey of imitating others. Not only this, copying fully the model of other countries doesn't always succeed because a country has a lot of complex intertwining of factors that can sometimes be hard to figure out. So maybe now its time to switch from Genuine Imitation to Genuine Innovation.

# The Divine Proportion


What connects Leonardo da Vinci's paintings, the Parthenon, the Pyramids, the music of Claude Debussy, and even the black hole? Don't scratch your head so much! It is a number! The golden number or 1.618 keeps cropping up wherever you look. It is there in the markings of a butterfly or even in the arrangement of leaves in a plant stalk.

Also called the golden section, the first definition of this number was written in Euclid's Elements as, "A straight line is said to have been cut in extreme and mean ratio when, as the whole line is to the greater segment, so is the greater to the lesser" in around 265BC!

Also the mathematical property this number possesses makes it quite popular with the mathematicians. It is the only number whose square can be produced simply by adding 1 and who's reciprocal by subtracting 1. If you take a golden rectangle - one whose length-to-breadth is in the golden ratio - and snip out a square, what remains is another, smaller golden rectangle! The golden ratio is also difficult to pin down: it's the most difficult to express as any kind of fraction and its digits - 10 million of which were computed in 1996 - never repeat!

Not only this, our brain has a special fascination with this number, as found out in psychological tests since the 19th century that when subjects are presented with the range of rectangles, they choose the ones which are in the golden ratio! So how do we find out this number? Simple. Think of any two numbers, then add the first and second number to get the third number, then a fourth number by adding the second and third, and so on. When you have written down about 20 numbers, calculate the ratio of the last to the second from last. The answer should be close to 1.6180339887!
