PREFACE

IN the long term economic development of the country the availability of trained manpower and adequate training facilities are vital factors in determining the measure of advancement that can be achieved. This calls for organized manpower planning. With this object in view, a Manpower Wing has been established in the Planning Division of the Finance Department of Maharashtra Government to conduct studies at the State level in manpower requirements, to assess the availability of trained personnel, to examine and suggest measures for increasing training facilities and generally to deal with problems connected with manpower.

The present study viz. "Studies in occupational Patterns of Engineering Personnel in Maharashtra State" is an official publication of the Wing. It is based mainly on basic data made available by the Employment Market Information Scheme of the Directorate of Employment, Bombay.

The rapid pace of industrialisation during the last decade has been accompanied by significant changes in the occupational structure of industrial employment. This has created difficulties in estimating and meeting manpower requirements over the vast range of projects and programmes which form part of our developmental planning. This study which relates to industry-wise distribution of workers according to occupations reveals what trades are of importance in the various types of manufacturing industries and establishes certain relationships between Engineers and Craftsmen as also *inter-se* relationships between various types of general craftsmen.

The study is expected to help in determining the Engineer and Craftsmen components of total employment likely to be generated as also the occupational distribution of such components so essential to formulation of manpower training programmes. It should also serve a useful purpose for employment counselling of fresh entrants into the employment market and provide data to Industry for estimating personnel requirements for expansion of existing units or starting of new ones.

STUDIES IN OCCUPATIONAL PATTERNS OF ENGINEERING PERSONNEL IN MAHARASHIRA STATE

1.0. Preliminary

The primary objective of manpower planning is to assess the requirements of trained personnel and to take prompt steps to ensure an adequate inflow of such persons to the labour force. The rapid pace of industrialisation during the last decade or so witnessed significant changes in the occupational structure of industrial employment. This has created inherent difficulties in the estimation of manpower requirements. The paucity of qualitative statistical data has been one of the major drawback in the evolution of stable norms, so essential for manpower reckoning. However, with relevant data now being made available by the Employment Market Information Unit of the National Employment Service and the Population Census 1961, an attempt has been made in these studies to analyse the occupational patterns in regard to engineers and certain categories of craftsmen, obtaining in the manufacturing and construction industries in the private and public sectors in Maharashtra State.

1.1. Object of the Study

2. After broadly assessing the employment likely to be generated by correlating investment-employment, output-employment ratios to the trends of capital formation, it is necessary to distribute the employment potential so obtained among the different occupations in order that demands for particular categories of personnel can be examined in the light of their availability and adequate steps taken to balance the supply and demand. One way of doing this would be to determine the relationship between engineers and craftsmen to total employment as also the *inter-se-ratios* among the various occupations. The object of the present studies is, therefore,—

(i) to ascertain the proportion of engineering personnel to the total labour force engaged in each of the manufacturing industries and constructions; and

(ii) to establish *inter-se-ratios* between the selected categories of engineers and craftsmen.

On the assumption that the occupational structure in a given sector of employment tends to remain fairly constant over a period of time, it is possible from such studies to lay a workable base for estimation of future requirements of engineering personnel, provided that no sudden changes in technological processes or in the pattern of economic development occur. 3. The conclusions drawn from such studies can be gainfully utilised in other ways also, such as for employment counselling of fresh entrants into the Labour Market, for highlighting trades likely to provide the greatest avenues of employment, etc. To industry, it can be a service, providing data for estimating personnel requirements for expansion of existing units or the starting of new ones.

4. A study of this type, entitled "Occupational Pattern in Manufacturing Industries, India, 1956", perhaps the first of its kind in the country, was conducted by the Planning Commission in its series of manpower studies. The exhaustive data presented in that study were further utilised by the Manpower Division of the Directorate General of Employment and Training as a base for its study, "Methods of Assessment of Training Requirements of Craftsmen for the Third Five-Year Plan."

In the latter study it was established that the proportion of skilled craftsmen to total employment in manufacturing industries in India was 13–10 per cent in 1956. The study further went on to establish *inter-se-ratios* among certain selected occupations in the skilled categories. These studies were conducted seven years ago. The pattern of employment along with techniques of production may since have undergone certain changes. Moreover, the data regarding occupational pattern reflected in the study pertained to all-India trends ; hence no State-wise conclusions could be drawn from them. As the pattern of employment in each State would vary according to its level of industrialisation and degree of mechanisation, it is felt that local studies of this nature based on more recent data will not only be enlightening but instructive.

5. In all, four studies in "Occupational Patterns" have been undertaken. They reflect the occupational patterns in different sectors such as (i) manufacturing industries in the private sector, (ii) all industries in the public sector, (iii) manufacturing industries in both sectors and (iv) construction industry in both sectors.

1.2. Concepts

6. The term "engineering personnel" includes not only engineers, who are degree or diploma holders but also craftsmen. For the purpose of these studies "Engineers" have been considered from the more important professions such as architecture, civil engineering, electrical engineering, mechanical engineering, chemical engineering and metallurgical engineering. Other • engineering categories such as mining engineers, technologists, etc., have been excluded from the purview of these studies. The categories selected from amongst "craftsmen" comprise some 28 occupations, most of which are basic engineering trades, generally considered to be common to a number of industries. The choice of occupations has been based on the occupational study conducted by the Directorate General of Employment and Training, referred to earlier. Training facilities exist in the State for most of these occupations under the "Craftsmen Training Scheme" and the "Evening Classes for Industrial Workers". Moreover, a number of them are also "designated trades" under the Apprentices Act, 1961. A list of occupations selected for the studies comprising engineers and craftsmen is given in the appendix at pages 32-33. 35-

1.3. Sources of information : their coverage and limitations

7. It was not intended to collect any statistical data afresh. The studies are based on information already available in the various Government publications. Since these data were not collected primarily for manpower planning, they had to be further processed to meet the requirements of these studies.

8. The first two studies, namely occupational pattern in manufacturing industries in the private sector and occupational pattern in the public sector are mainly based on occupational data collected by the Employment Market Information Unit of the Directorate of Employment, Bombay. The information is collected biennially—public and private sector undertakings being covered every alternate year—under the Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959. The information from the public sector used in the study relates to September 1960, whereas the data from the private sector pertain to September 1961.

9. All industrial establishments in the private sector, engaging 50 or more workers fall within the purview of the Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959. In 1961, about 1,900 establishments in the private sector employing about 7.87 lakh workers were covered by the Act. Of these, 1,313 establishments, representing 69 per cent of the total coverage and engaging 4.90 lakh workers or about 53.5 per cent of the total estimated employment filed the returns. It would, therefore, appear that even though the returns are statutory, the response has not been quite encouraging, as about 30 per cent of the undertakings employing about 46 per cent of the total number of workers have been left out of the coverage.

10. In the public sector, all establishments are required to file the biennial occupational return. Of the 2,910 establishments employing 8,72,419 workers in the public sector, 2,792 undertakings or 95.9 per cent, engaging 7,36,916

workers or 84.4 per cent of the total responded to the returns. The data in the public sector cover all activities, such as manufacturing, construction, mining, transportation, trade and commerce, but excludes agriculture.

11. Another usefull source of information utillsed in the remaining studies is the data provided by the Census of Population, 1961. The Census gives a broad picture of occupational employment in all sectors. The data cover all persons in the State who were gainfully employed. Such persons are distributed according to broad occupational families in various industrial activities in both the public and private sectors. The two studies bring out patterns of employment of engineering personnel in manufacturing and construction industries. In the former, however, occupational information is not available according to the various industries.

12. One of the limitations of these studies is that it has not been possible to distinguish between a graduate engineer and an engineer holding a diploma. Such a differentiation would have been helpful, particularly as the training requirements and the rate of outturn of degree and diploma holders are different. Another drawback is that, it has not been possible to identify engineers according to their professional qualification in such cases, where they may have been classified in the returns according to their functional designations such as, General Manager, Factory Manager, Works Manager, Works Superintendent, etc. However, despite the limitations, the studies on hand should provide sufficient data to enable a meaningful analysis to be made of the occupational structure in the various industries and sectors.

2.0. Survey Results :

2.1. Occupational Pattern in manufacturing industries in the private sector

13. The study covers employment in establishments engaged in manufacturing industries in the private sector employing 50 or more workers.

14. In all, 1,531 engineers were identified in a total employment of 3,22,319 persons. Engineers thus constitute 0.47 per cent of the total employment in manufacturing industries in the private sector. Industry-wise ratios of engineers to total employment are given in Table No. 1. The highest percentage of 7.84 is recorded in the manufacture of machine tools, followed by 4.00 per cent in the manufacture of and repairs to air transport equipment, including acroplanes and aeroengines. The proportion is fairly high *i.e.* between 3 per cent and 4 per cent in the manufacture of motor vehicles,

engine parts and accessories (3.80 per cent), heavy electrical machinery and equipment (3.31 per cent) and dyes, paints, colours and varnishes $(3.23 \text{ per$ $cent})$. The percentages are between 2 and 3 in industries such as production of edible fats and oils (2.08 per cent) and manufacture of structural wooden goods (2.62 per cent). The proportion of engineers in the total employment is between 1 to 2 per cent in respect of ten other industries, while in the case of the remaining industries it is less than 1 per cent or nil.

15. The total number of engineers is further distributed among the selected categories of engineers with a view to ascertaining their relative proportion in the total employment of engineers. The breakup will be found in Table No. 2. Mechanical engineers returned the largest proportion of 58.26 per cent, followed by civil engineers who constituted 21.75 per cent. Electrical engineers formed 11.24 per cent of the total employment of engineers. Others constituted 2.61 per cent of the total.

16. The study recorded in all 486 draftsmen in a total employment of 3,22,319 persons in the manufacturing industries in the private sector. Draftsmen thus constitute 0.15 per cent of the total employment.

17. Craftsmen in the occupations selected for the study constitute 50,207 persons in the manufacturing industries in the private sector giving an overall ratio of 15.58 per cent of the total employment. This ratio is higher than the all-India ratio of 13.10 per cent arrived at by the Directorate General of Employment and Training in 1956. This may, perhaps, be attributed to Maharashtra being comparatively an industrially advanced State. Industrywise ratios of crafstmen to total employment are given in Table No. 1.

The manufacture of machine tools again has returned the highest percentage of 93.41 per cent craftsmen to total employment. Since the selected occupations are basically of an engineering type, their weightage is particularly pronounced in the engineering industries such as metal, electrical, transport, general engineering, etc. Craftsmen constitute more than 50 per cent of the total employment in the following industries :--

Manufacture of iron and steel furniture (89.35 per cent), scientific, medical and surgical instruments (88.21 per cent), machinery except textile machinery (76.73 per cent), assembling and repairing of watches and clocks (75.78 per cent), electrical machinery, apparatus and appliances (69.25 per cent), metal products (63.49 per cent), heavy electrical machinery and equipment (62.14 per cent), batteries (58.37 per cent), textile machinery (57.87 per cent), motor vehicles, engine parts and accessories (56.65 per cent), repairing and servicing of motor vehicles (55.68, per cent) and manufacture of wood allied products (55.17 per cent). The proportion of craftsmen to total employment is very low, being less than 1 per cent in industries such as manufacture of food products, cotton weaving in handlooms, sawing and planning of wood, manufacture of common salt and the like.

18. The inter-se proportion of the selected occupations of craftsmen may be found in Table No. 3. Machine tool makers, machinists and related workers returned the highest percentage of 17.89, followed by machine tool operators comprising 17.73 per cent of the total craftsmen. Fitter machinists, tool makers and machine tool setters and fitter assemblers and machine erectors form about 10.3 per cent each. Other important occupations are mechanics repairmen (6.72 per cent) and carpenters, joiners and pattern makers (5.70 per cent). Occupations such as furnacemen, annealers temperers and related heat treaters, rolling mill operators, metal drawers and extruders, plumbers and pipe-fitters, electro-platers, dip-platers and related workers, precision instrument makers, electrical and electronic fitters and mechanics repairmen (radio) show less than 1 per cent of the total employment of craftsmen.

2.2. Occupational pattern in the Public Sector according to Employment Market Information.

19. The data relate to all public sector establishments engaged in nonagricultural activities, such as manufacturing industries, construction, etc.

20. In all, 9,164 engineers were shown to be employed forming 1:24 per cent of the total employment in the public sector. The *inter-se* proportion of the selected categories of engineers to the total number of engineers may be seen in Table No. 4. It would appear that Civil Engineers preponderate, constituting 63:11 per cent of the total number of engineers in the Public Sector. Electrical and mechanical engineers form only 6:96 per cent and 4:95 per cent respectively, of the total number of engineers in this sector. Others account for 24:82 per cent of the total. The comparatively high percentage in this category is mainly due to the number of surveyors, who form 24:12 per cent of the total.

21. Craftsmen number 41,264 in the public sector constituting 5:60 per cent of the total employment. The *inter-se* proportion of the selected occupations to the total number of craftsmen in the public sector may be seen in Table No. 5. Fitter assemblers and machine erectors and mechanics repairmen constitute 17:83 per cent and 17:63 per cent of the total craftsmen, respectively. They

• are followed in weight of numbers by carpenters, joiners and pattern makers (8.22 per cent) and machine tool operators (7.35 per cent). Other important occupations in this Sector are fitter machinists, tool makers and machine tool setters (6.32 per cent), other tool makers (6.68 per cent) and linemen and cable jointers (5.03 per cent).

22. In all 1,616 draftsmen are reported to be employed in the public sector. They thus form 0.22 per cent of the total employment in the public sector.

2.3. Occupational Pattern in Manufacturing Industries according to Population Census, 1961

23. The study covers employment in both public and private sectors in manufacturing industries other than household industry.

24. The Population Census, 1961, returned 5,514 engineers of various categories in a total employment of 13,04,335 persons in manufacturing industries other than household industry. Engineers thus constitute 0.42 per cent of the total employment. The ratio of different types of engineers to the total number of engineers is indicated in Table No. 6. Mechanical engineers form slightly more than half the number of engineers, whereas Electrical and Civil engineers, respectively.

25. As regards craftsmen, the Census recorded 2,59,175 persons from the occupations selected for this study. They constitute 19 79 per cent of the total employment in the manufacturing industries. The relative proportion of each of the selected occupations to their total number may be seen in Table No. 7. It is apparent that mechanics repairmen assume the highest percentage, namely, 18 08 per cent followed by carpenters, joiners and pattern makers, who form 17 82 per cent of the total employment of craftsmen. Other important occupations are fitter machinists, tool makers and machine tool setters (14 51 per cent) and machine tool operators (8 37 per cent).

26. There are 1,340 draftsmen in a total employment of 13,04,335 in the manufacturing industries, assuming approximately 0.10 per cent of the total number of workers.

2.4. Occupational Pattern in the Construction Industry according to Population Census, 1961

27. The study covers employment in the construction industry in both public and private sectors.

28. In all, 4,254 engineers were recorded in the Population Census, forming 1.81 per cent of the total employment. The relative proportion of selected categories of engineers may be seen in Table No. 8. Civil engineers form about 75 per cent of the total number of engineers, while Mechanical and Electrical Engineers constitute only 10.70 per cent and 2.63 per cent of the total respectively. "Others" constitute 11.70 per cent of the total. Among others, Architects alone form 7.43 per cent of the total number of engineers.

29. Craftsmen comprising the selected occupations assume 28:59 per cent of the total employment in construction. As compared with the ratio of craftsmen to total employment in the manufacturing industries, the ratio in construction appears to be unduly high mainly because of the preponderant number of bricklayers and masons in the total number of craftsmen in this industry. Table No. 9 gives the relative proportion of workers in each of the selected occupations to the total number in such occupations in construction. Bricklayers, plasterers and masons represent the single largest group, constituting 76:57 per cent of the total craftsmen. Carpenters and painters form 6:30 per cent and 5:63 per cent respectively, of the total craftsmen. The other occupations forming more than 1 per cent but less than 3 per cent of the craftsmen are fitter machinists, tool makers and machine tool setters, mechanics repairmen, plumbers and pipe fitters.

30. The Census returned 602 draftsmen in a total employment of 2,35,616 workers in the construction industry, constituting 0.26 per cent of the total.

2.5. Concluding observations

31. Normative studies in occupational patterns serve a useful purpose in that they not only help to determine the engineer and craftsmen components of total employment likely to be generated in a given sector, but also help to determine the occupational distribution of such components so essential to formulation of manpower training programmes.

32. The study reveals that in manufacturing industries in the private sector, engineers constitute 0.47 per cent and craftsmen 15:58 per cent of the total employment, respectively. Among engineers, Mechanical engineers comprising 58 per cent of the total number of engineers predominate, whereas Civil and Electrical Engineers form only about 22 per cent and 11 per cent of the total complement of engineers in this sector of employment. The *inter-se* proportion of certain selected occupations amongst craftsmen occupations, generally considered to be common to a number of industries, show that metal working trades such as machine tool makers, machinists and related workers and

machine tool operators form the largest group with approximately 18 per cent each of the total number of craftsmen employed. Fitter machinists, tool makers and machine tool setters, and fitter assemblers and machine erectors come next constituting about 10 per cent. each of the total craftsmen in manufacturing industries.

33. In public sector establishments, engineers assume 1.24 per cent and craftsmen 5.60 per cent of the total employment respectively. Among engineers, Civil engineers predominate constituting about 63 per cent of the total number of engineers. The concentration of Civil engineers in the public sector is attributed to the preponderance of construction activity in that sector. Amongst craftsmen, fitter assemblers and machine erectors, and mechanic repairmen each form about 18 per cent of the total number of craftsmen.

34. According to the 1961 population census, engineers assume 0.42 per cent of employment in manufacturing industries and 1.81 per cent of employment in construction. In manufacturing industries Mechanical engineers comprise little more than half the number of engineers, whereas Electrical and Civil engineers constitute about 22 per cent and 18 per cent of the total engineers, respectively. In the construction industry, Civil engineers compose about 75 per cent of the total number of engineers employed, whereas the Mechanical and Electrical engineers constitute only about 11 per cent and 3 per cent respectively of the total engineers.
