NATIONAL MALARIA ERADICATION PROGRAMME.:

Malaria is a very old diseases and a public health problem in the state. Most of the part of the state is hilly and communication links are poorly developed. The population of the state is not homegeneous, there are numerous tribes and about 90% of the population is engaged in Agriculture, plantation, settlement scheme, land reclamation etc. associated with extensive movement of people, which creates favourable condition for malaria transmission. The incidence of malaria cases was also aggravated because of continuous immigration of refugees from East Pakistan (Now Bangladesh).

With a view to reduce the incidence of malaria in the country the National Malaria control programme started functioning in India in the year 1953 with the objective of bringing down the india incidence of malaria to such an extent that this would not be regarded as a major public health problem ank any more.

After reviewing the activities of Namional Malaria Control
Programme, it was found that eradication of malaria from the country was
possible and the National Malaria Control Programme was switched over to
National Malaria Bradication Programme from April, 1958. The object of
National Malaria Bradication Programme has been as "the ending of transmission of malaria and reservoir of infection cases in a compaign
timited in time, carried to such a degree of perfection, that when it comes
to an end and there is no resumetion of transmission". Although the Malaria
Eradication Programme has k the following phases: - 1). Preparatory phase,
2). Attack phase, 3). Consolidation phase, 4). Maintenance phase, the National
Malaria Bradication Programme in India started functioning from Attack phase
treating the result achieved under Control Programme as end point of preparatory phase. In Trioura, the National Malaria Control Programme was launched in
Jyly, 1953 with of standard unit which was subsequently raised to one Unit.

Eradication Programme with effect from 1st April, 1958 with the objectives stated earlier. As per programme in the last year of attack phase surveilance activities were introduced which envisaged domicilliary visit at least once a fortnight for collecting blood smears from all fever cases and cases with recent history of fever irrespective of clinical diagnosis and impost presuntive treatment on having blood-smears and send all smears to the laboratory for microscopic examination. The malaria positive cases detected by microscopic examination are imparted radical treatment for 5 days as per scheduled doses.

The study was undertaken we at the instance of Director of Health Services vide their letter No.4(317)-MS/AC/71 dated 22-5-72. The field survey was started on the 4th May,1974 and was completed on the 9th June,1974 with the objectives noted below:-

Object of the Study: -

The programme covers the whole State and owing to our limited resources it is not possible to deal with all the aspects of the programme. In order to narrow down the area of study to a manageable presportion it was thought advisible to focus attention on the following aspects:

1. To enumerate different sorts of facilities provided to the people under the National Malarai Bradiction Programme. 2). To determine the extent of such facilities enjoyed by the people. 3). To ascertain the reaction, attitude of the respondents towards this Programme. 4). To assess the progress achieved in implementing the programme and 5). To study the problems of implementation of the programme at different levels.

Sampling design and Methodology: -

The National Malaria Era ication Programme Unit of Tripura with

its Headquarters at Agartala has been divided for administrative purpose into 4 Zones :- A. B. C. and D.

Dharmanagar and Kailashahar Sub-Divisions. Zone B with its Hd.cuarters at Teliamura covers 3 Sub-Units - Kamalpur, Khowai and Amarpur sub-divisions, Zone C with its Hd.cuarters at Agartaia covers 2 sub-units - Sadar and Sonamura sub-divisions and Zone D with its Hd. quarters at Udaipur covers 3 sub-units - Udaipur, Belonia and Sabroom sub-divisions. Each Sub-Unit has been sub-divided into a number of small sectors and each sector into a number of smaller sections, A section covers a number of villages weach of which consists of a number of households, the ultimate sampling units in the evaluation study.

For evaluation study the sampling design adopted is stratified multi-stage random sampling with household as the ultimate unit. From each of the 4 zones one sub-unit was selected. Thus Kailashahar in Zone A. Khowai in Zone B. Sonamura in Zone C and Belonia in Zone D were selected as sub-units. Then a list of sectors was prepared sub-unit-wise. 2 sectors were selected out of 5 in Kailashahar, 2 out of 6 in Khowai, 2 cut of 4 in Sonamura and 2 out of 7 in Belonia. Thus sector numbers 11 and 12 in Kailashahar, sector numbers 17 and 22 in Khowai, sector numbers 46 & 48 in Sonamura and sector numbers 56 and 59 in Belonia were selected. At the third stage sample sectors were selected from selected sectors. For this, a list of sections was prepared sector-wise for selected sectors and 2 sample sections were drawn from each. The sections so selected with the total number of villages in selected sectors are shown in the table below:-

For each of the above selected sections a list of villages was prepared and 10% of the villages were included in the sample for investigation. Then for each of the selected villages a list of households was prepared and nearly 25% of the households were selected at random for study. The whole scheme of sampling at various stages is given in the table below.

Salient feature of the Programme:

Example 2 Proceeded by a five-year National Malaria Control Programme 2 Example 2 Reserved starting in 1953, the National Malaria Eradication Programme was launched in 1958 with the objective of eradicating malaria from India in 7 to 9 years or by 1965 to 1967. In 1964 the schedule was revised to a termination date of 1970, in 1967, it was again revised to the present target of 1975.

The salient feature of the programme as implemented throughout the country is given below. The basic "principles" on which the programme was founded were :-

- 1. The indoor residual spraying of D.D.T. in all appropriate structures at appropriate seasons and intervals would reduce malaria transmission to a very low level in a few years.
- The institution of a system of "surveillance" i.e. detection and radical cure of the malaria cases and other remedial measures when the transmission levels were low, would result in the complete elimination of malaria.
- 3. The public health organisation in the country will assume responsibility for "vigilance" and undertake preventive action against re-establizers shment of malaria, once the elimination of the parasite has been achieved.

The programme was divided into several phases succeeding each other on the basis of careful evaluation.

Preparatory phase:

During which malaria surveys and epidemiological investigation would be carried out in some depth to enable formulation of the details of the action. This phase is generally expected to be of one year's duration. In the National Malaria Eradication Programme of India, the preparatory phase was not considered necessary because the country has already been under a nation-wide control programme for five years and it was thought that adequate information was available on the distribution and epidemiology of malaria for practically all places.

Attack phase:

The internal surface of all man-wide structures(human and animal dwellings) were to be sprayed with residual insecticides (D.D.T. being the first choise) at selected doses at appropriate intervals and seasons.

This phase was to last normally for three years. During the last year of this phase "Surveillance" was to be established.

Consolidation phase:

The insecticide spraying would be withdrawn and surveillance procedure carried out thoroughly. Active and passive methods were to be adopted for case detection and radical treatment of all parasite positive cases to be given by the staff of the programme.

Maintenance phase:

The entire vigilance was to be assumed by the basic public health organisation whose duty would be to keep watch for cases of malaria which may arise because of reintroduction, relapse or any other cause and to take prompt and effective remedial and preventive measures. For the execution of the National Malaria Eradication Programme, the entire area of the country was distributed among 390 Units (later increased to 393'25). The work was directed from the centre, but executed by the states with financial assistance from the centre.

At the central level, the programme was directed by the Director, National Malaria Eradication Programme with supporting technical and administrative staff at his Hd. quarters at Delhi. The Director was assisted by six Regional Coordinating Organisations located at Baroda, Bengalore, Hyderabad, Lucknow, Bhubaneswar and Shillong, each of which was under the charge of a Deputy Director.

At the State level the work was directed by the respective Directors of Health Services/Public Health with a full time state Malario-logist, (designated differently in different States) as the technical and administrative head.

The "units were the actual operating organisations on which the whole pyramidical editice was built. The unit, on an average, was expected to cover population of one million but there have been substantial variations, some units covering a population of over 1'5 million and a few even as low as 0'5 or 0'25 million. The unit was under the charge of a unit officer, variously designated as malaria officer, malaria medical officer etc.

Mostly they were medically qualified persons, % but in a few states non-medical personnel (University graduar in science) were appointed to these positions. In some states there were zonal officers looking after 3-4 Units and even Regional malariologists and entemologists, looking after the work of 7-10 Units.

Spraying squads and logistics of spraying:

Proper spraying operation depends on the size of the spraying squads according to the size of the area of operation. There were 44 spraying squads in Tripura during the year 1971-72 and 1972-73 (each squad comprising mf mmm of one mate and five labourers). Luring the year 1973-74, 74 squads were operating in Tripura and these are still continuing. The spraying operation is being conducted as per prescribed dose (generally 1 gram per sq.metre).

Date of spraying vary in different parts of our country. The apraying operation starts as early as March in some states. Generally two rounds of spraying operation are carried out - one during March to May (75 days) and another during August to November (for 75 days) in Tripura. During 1972-73 and 1973-74 spraying operation was started in Tripura a bit later than the xxx scheduled date mentioned above. Even in 1974-75 the first round of spraying operation, it is learnt, was started on the 1st May of 1974. Logistic of spraying is the most vital factor for effectiveness of operation. So timely spraying is essential.

Surveillance Activities:

Active surveillance was introduced in Tripura as desired by the Government of India, Ministry of Health as per recommendations of the Director, National Malaria Eradication Programme, Delhi in April, 1966. Spraying and Surveillance works are now in operation. The entire unit has been divided into 262 surveillance sections and 64 sectors. Villages of each section has been divided in 12 groups from 1 to 12 and one Surveillance Worker has been put as basic worker in each section. There are 12 field working days in a fortnight and the surveillance worker is to visit each and every group in specified working day and to put 4 questions and collect blood smears from all fever cases and cases with recent history of fever irrespective of clinical diagnosis and impart presumptive treatment by 4 aminoquinolines as per scheduled doses and put his dated intial in the house-cards or housestencil as a token of performance of his duty. The surveillance worker is to send blood smears at least twice in a week for laboratory examination. The xxx results of the examination would require to be communicated to the concerned Surveillance Inspector who is the sector in-charge, for imparting radical treatment for 5 days personally contacting the patient in his house. Administrative arrangement for implementation of the Programme:

The National Malaria Eradication Programme has been under implementation in Tripura since 1958 under the direct control of the Director of Health Services and the Malaria Officer is, in overall charge of works connected with the D.D.T. spraying and timely distribution of insecticides. He is supposed to be completely aquinted with all problems and different difficulties regarding surveillance activities and be responsible for immediate action whenever necessity arises in his unit.

For administrative convenience the State is divided into 4 zones and an Assistant Unit Officer is in-charge of each zone for proper functioning of the programme. Each Zone consists of some sub-units and each sub-unit has a number of sectors and sections. There are 60 sectors and 426 sections in Tripura under this programme. The main functions of the officials are given below in a nutshell.

Zonal Office: - Assistant Unit Officer is in-charge of each zone. He is responsible to the Malaria Officer in respect of proper implementation of surveillance work and spraying in his zone.

Sub-Unit:- Malaria Inspector is in independent charge of spraying and surveillance work in the sub-unit viz. sub-division. He is to submit various reports and returns in connection with this programme to his higher authority. Sector:- One Surveillance Inspector is posted in each sector as incharge of the sector. Each Surveillance Inspector will be responsible for the planning and execution of surveillance work by the surveillance workers under him. He will also be responsible for administration of radical treatment and for maintaining normal routine of surveillance work. He will maintain all records and data for surveillance procedure in his area and submit regular reports to the Malaria Officer.

Sections: One Surveillance worker is posted in each section. He will be responsible for surveillance work for a population of 10,000 residing in 2,000 houses. But this norm regarding coverage of population and houses is flexible in Tripura 2 of which is hilly where houses are scattered and there are immense difficulties of transport and communication. He will visit each house in his area once in a fortnight and record all mem necessary information.

He will collect blood smears from all fever cases in the households at the time of his visit. He x will administer a single dose treatment with 4-1 aminoquinoline drug to all fever cases after collection of the blood smears. He is to despatch blood smears with necessary particulars to the unit Hd.quarters for laboratory examination. A chart of the administrative unit of the programme is given in the Appendix No.1 and Appendix No.2 also indicates the staffing pattern of the unit during the year 1974-75.

Financial Aspect: -

Attach phase. The entire expenditure on the Attach phase and consolidation phase of Malaria Unit during the 4th plan xxxxxx period was treated as plan expenditure in the centrally sponsord sector subject to the deduction on the level of expenditure being incurred by the state Government in 1957-58 when the Malaria Control Programme was switched over to the National Malaria Bradication Programme which is the responsibility of the state government as a part of their committed liability. It has further been decided that the entire central assistance under the programme during the 4th plan period was to be treated as 100% grant to the state government and Union Territory Administration. Besides this, 90% of the expenditure is re-imburseable from the central Government as plan expenditure for Hd. quarters staff where maintenance phase unit is less than 1/3.

For proper implementation of this programme one difficult and boarder area spraying unit was sanctioned by the government of India for this state taking into consideration of the pecular geographical position and difficult topography. In view of the above position the unit is still functioning in Attach phase.

The Working Group on Health in the meeting held in New Delhi on the 7th October, 1968 recommended the provision of 127,000 lakks for the 4th plan period in order to strengthen this Unit. The actual Budget Provision and expenditure for the period from 1971-72 to 1973-74 is given below.

Progress of the Scheme:-

In Tripura the National Malaria Bradication Programme started functioning from 1st April, 1958 with one difficult and boarder Unit. Although, one unit is to cover one million population. Tripura was provided with one difficult unit while its population was less than a million at that time - considering various factors like its hilly area, dispersed population, undeveloped transport and communication facilities, its encirclement by erstewhile East Pakistan (Now Bangladesh), heavy continuous influx of refugees from East Pakistan etc.

Although there are four phases of the programme yet this programme is still in Attack Phase in the state. In Attack Phase residual insectid cidal spraying operation is the main weapon when timely total insecticidal coverage both qualitative and quantitative would cut down the transmission of malaria parasite. Entire Tripura was divided into four areas viz. (A) most difficult area with difficult communication, (B) difficult area with less difficult communication, (C) easy area with a bit difficult communication and (D) Road-side villages and urban area with easy communication. As per original logistic of spraying A and B areas will have to be rendred total insecticidal coverage with three rounds of spray and C and D by two rounds of spray so that the total cut down of transmission of malaria parasite may be achieved.

If this programme could run 3 to 5 years very effectively with total cut down of transmission, the programme may switch over to next phase of consolidation with introduction of Surveillance (both active and passive) in the last year of Attack phase.

But the performance of the programme in this state is unsatisfactory. Even the coverage of the programme is also not upto the mark as it is evident from the following table. Although the programme was designed to cover the whole area of the state yet it appears that the minute effort was mainly concentrated on the Boarder Areas as it was decided in the Indo-Bangladesh conference that the D.D.T. spraying operation will be confined to 10 miles boarder-belt of Indo-Bangladesh Boarder area. If this is the programme of the present spraying operation than it is natural that the areas beyond 10 miles boar or will as remain unsprayed and there is every possibility of transmitting malaria in the areas which are remaining beyond the boarder area. It is necessary to maintain spraying operation throughout the state with special emphasis on the Boarder Area in order to drive out the malaria from the state.

The spraying operation as implemented in Tripura from 1971-72 to 1973-74 is not satisfactory. During 1971-72 no large scale operation (except some selected places) was done. Data in respect of the progress of the scheme is presented here for the period from 1972-73 to 1973-74.

The above table invicates the coverage of spraying operation during the years under review. It is noticed that in these two years 50'9% houses/structures were left uncovered by the spraying squads. It means that a large area of the state was not covered by spraying operation and to that extent transmission possibility may remains in that areas. This is a vital point and care should be taken to cover the whole area, otherwise, it will defeat the vary objective of the programme.

A glance at the coverage of the programme in the selected subdivisions also reveals the same dismal picture, for instance, during 1972-73 percentage of areas uncovered by the spraying squads were 49'6, 57'6, 36'7 and 34'4 respectively in Khowai, Kailashahar, Sonamura and Belonia. However, the year 1973-74 marked an improvement in this respect in the selected subdivisions as the following table indicates.

Sarveillance Activities:

Surveilience operation plays an important role in the implementation of the National Malaria Eradication Programme. Surveillance worker who remains in the villages performs the most important job in the form of collecting blood slides from all fever cases. He bends all the collected slides to the Laboratory for examination. The following table indicates number of cases of blood smears collected, number of cases of blood smears examined and number of positive cases radically treated in 1971-72, 1972-73 and 1973-74 in Tripura.

From the above table it is noticed that the performance in the laboratory survices was very poor. There was usually a backlog of slides which would prevent timely administration of radical treatment. For example, the total backlog of unexamined slides for the year 1971-72 was 16'58% whereas it was 16'36% in 1972-73 and 25'48% in 1973-74. This indicates that the presentance of laboratory is not catisfactory.

and every microscopist can examine 50 blood-slides per day. This means 450 blood-slides can be examined per day in the laboratory. If we assume 260 working days in a year then a number of 1,17,000 blood-slides would be examined in a year as per norm of workload. But the relevant figures in the table fall far short of it. Again, it is coen that many of the positive cases found in different years have not been radically treated. This points out a serious lacuna existing in the implementation of the programme.

The position regarding the blood-smears collected, examined, positive cases and radical treatment given is also not very encouraging in the selected sub-divisions viz Khowai. Kailashahar, Emen Son Sonamura and Belonia as is evident from the following table.

It is seen from the above table that in all the years from 1971-72 to 1973-74, a large number of blood smears collected were left unexamined. Only in 1973-74 and that also in one sub-division gx viz Belonia that we find that the number of cases of blood smears collected tallied with the cases of blood smears examined. The poorest performance in regard to this matter was made by the sub-divisional unit in Sonamura in 1973-74 where as many as 45'69% of blood smears collected were left unexamined. This finding at the sub-divisional level corroborates our conclusion regarding existence of lacuna in the implementation of the programme made earlier.

As regards the treatment of positive cases it may be stated here that the number of cases given radical treatment indicates a dismal picture in all the sub-divisions except Sonamura during 1971-72. The position of cases given radical treatment should an improvement in the subsequent years except a slight decrease in Sonamura in the year 1972-73 and in Belonia in 1973-74.

<u>Performance of the National Malaria Eradication Programme</u> in the selecter villages:

We selected 60 virlages in four sub-divisions of Tripura.

Our field staff visited each of he these villages during May and June

(up to 9th June), 1974 and held discussion with the Malaria Inspectors,

Surveillance Inspectors and also with the selected respondents. Findings of the these meetings which constitute the basis of our report, are enumerated below.

Spraying Operation:

Table No. 7 indicates the number of selected villages sprayed and also number of selected villages left uncovered for the period from 1971-72 to 1975-74. It is seen from the table that selected villages of Sonamura sub-division were all covered by the operation in all the years referred to.

Performance in the slected villages, Belonia sub-division was the poorest of all where was many as 78'57% of villages were left uncovered by the spraying squads in 1971-72 and even in the subsequent years no appreciable improvement was marked. Spraying parformance in Khowai and Kailashahar sub-divisions during this period was also not upto the mark.

The above table indicates number of villages found sprayed on the date of investigation (4th May to 6th June, 1974) which was carefully selected at the end of prescribed spraying season in accordance with the logistic of spraying. It is reported that only 10 villages out of 16 in Khowai sub-division were found sprayed on the date of investigation. Number of villages found sprayed on the date of investigation in the remaining selected sub-divisions was nil. This shows that logistic of spraying is not ps properly adhered to in course of operation. This matter calls for urgent attention.

The above table indicates the number of households sprayed during 1971-72 to7 197x 1973-74. Performance of spraying in the households under Sonamura sub-division is not very encouraging. As regards Khowai and Kailashahar sub-divisions no information regarding the households sprayed during 1971-72 was available. The situation has improved to some extent in Khowai, Kailashahar and Belonia sub-divisions in the year 1973-74 and the performance of spraying at Sonamura sub-division was satisfactory as before.

Surveillance activities was started in Tripura in the year 1966. The entire unit has been divided into 64 Sectors and 259 Sections. One Surveillance worker is to worker has been but as basic worker in each section. Surveillance worker is to visit each and every house in every fortnight in order to enquire into fever cases. Generally 2000 houses with a population of 10,000 are under the jurisciction of one Surveillance worker. He is to put question to the villagers regarding history of fever cases and to collect blood smear and offer presumptive treatment as per scheduled doses and put his dated initial in the house card or house-stencil as a token of the performance of his duty.

In order to supervise or watch the activities of the Surveillance worker there is inspecting staff to supervise the activities of the Surveillance worker. We have collected data from the selected villages in order to know the number of visit made by the inspecting staff from 1971-72 to 1973-74 and these are presented in the table below.

Table No.11 indicates that number of villages visited by the Surveillance Worker was very poor in two sub-divisions viz Kailashahar and Sonamura where only 4.2% and 16.7% of the selected xx x villages respectively were covered by visit in 1971-72. The coverage by visit was satisfactory in Belonia and moderately

satisfactory in Khowai in that year. Some improvement was, however, made in respect of visit by the Surveillance worker in 1973-74 in Khowai, Kailashahar. But Sonamura recorded no progress in the matter while the situation in Belonia was as satisfactory as before.

As regards the visits made by the Inspecting staff the coverage was more or less satisfactory (for Sonamura, no relevant information was available). But it appears that visit by the Inspecting staff produced no effective result in streamling the work of supervision at surveillance work level.

Table No. 12 indicates number of blood smears callected, number of blood smears examined, number of positive cases and number of cases radically treated in our selected villages. It is observed that in all the years under review, more than 90% of blood smears collected were examined in all the sub-divisions except in Sonamura in 1972-73. Similarly almost all the positive cases of malaria detected were found to be radically treated.

An assessment of efficiency of spraying operation-respondent-views:

For on the mark snot warfk verification of coverage and effectiveness of spraying operation 889 households were selected for interview in 60 villages.

Information collected by the field staff from the respondents is analysed in the following paragraphs.

Awarness of the respondents regarding the objective D.D.T. spret spraying:

People's co-operation and awarness is the essential precondition on success of any welfare programme effective large section of our population. Table No.13 indicates the number respondents who are fully aware of the objective of D.D.T. spraying.

It is observed from the table that out of the total number of 889 respondents, 880 are aware of the objective of D.D.T. spraying. This shows that excepting few almost all the respondents know the purpose for which spraying operation is carried.

Respondents were questioned range regarding the coverage of spraying operation during three years viz. 1971-72, 1972-73, 1973-74 in their houses/structures.

Generally spraying operation is to be carried in two rounds in a year. But it is seen from the table number 14 that except in Sonamura sub-division only one round of spraying was performed. The table indicates a number of cases in which spraying was refused such cases being maximum in Khowai sub-division and minimum in Kailashahar sub-division.

Thus it is observed that kkk though people in general are aware of the objective of D.D.T. spraying they often refuse it on various grounds.

Reasons for refusal of D.D.T. spraying:

Reasons for refusal of spraying as gathered from the respondents are presented in the table No.15. It is seen from the table that difficulties in removal of utensils from the Kitchen constitute the main cause of refusal of spraying in all sub-divisions except Sonamura. In Sonamura sub-division this difficulty appears to be minimum. Difficulties in removing the articles from the bed-room appears to be second important reason for refusal of spraying. Spraying was also refused in a substantial number of structures because the respondents did not like to allow D.D.T. spraying in the store-room where, food grains etc. are preserved. Among other reasons is the fact that spraying is refused in harvesting time as most of the members remain engaged in the field and that there is an idea among some residents that spraying is not effective in eradication of mosquitos.

It is reported that majority of respondents are satisfied regarding quality of spraying. Only a few of the respondents ranging between 0'9 to 3'1% are of the view that the quality of spraying is not satisfactory.

Incidence of fever:

Incidence of fever is an important indicator of success of National Malaria Eradication Programme. We have made an attempt to assess the incidence of Malaria from the spot verification and information received from the respondent households. Generally, each Surveillance Worker has to collect blood smears in all cases of fever for detecting Malaria parasite. Reports from the respondents show an increasing number of fever cases in all sub-divisions from 1971-72, 1972-73, and 1973-74.

Eut number of patients having their blood examined fall fax short of the total number of fever cases in all the years in all sub-divisions. For example, in 1971-72 number of blood slides examined in Khowai, Sonamura, Kailashahar and Belonia are respectively 39,22,26 and 29 only against total number of fever cases numbering 173,310,353 and 296. Some improvement in the matter, however, observed in 1973-74.

No. of Malaria cases found on the date of investigation:

Table No. 18 indicates number of malaria cases found during investigation. It is seen from the table that number of villages effected by malaria was 3,5,8 and 1 in Khowai, Sonamura, Kailashahar and Belonia subdivisions respectively. Of the selected sub-divisions maximum cases of malaria are found in Kailashahar (16) and Sonamura (13).

Views of the respondents regarding the National Malaria Eradication Programme:

We sought the views and suggestions from the respondents regarding (1) D.D.T. spraying and (11) surveillance activities. These are incorporated in Table No.19. It is seen from the table that bulk of the respondents expressing views emphasised the need for increasing the funds of spraying operation. Second, in importance to the respondent is the need for timely and intensive spraying.

Regarding surveillance work also the respondents are in favour of increasing actual number of visit by the workers. Attention was also drawn by the respondents to the need for timely visit. A section of the respondents pointed that the result of blood examination should be communited to the families of the patients as early as possible.

Views of the respondents regarding the side benefits of D.D.T. spraying and also adverse effect of spraying were sought.

A large number of respondents in Sonamura and Kailashahar reported that spraying helped control of bugs, cockronches, white ants and other insects.xxxx No particular adverse effect, however, was mentioned by the respondents.

Surveillance work - progress in radical treatment.

In addition to collection of data regarding incidence of fever, it is the duty of the surveillance staff to arrange for the examination of blood and radical treatment.

Number of fever cases detected, number of blood smears collected, number of malaria cases radically treated for different periods are put in table Number 20. It is seen that during the last year in majority of fever cases detected, blood smears were collected. But there is some shortfall in treatment of malaria cases found. For example, during the last year only 14 out of 20 malaria cases in Kailashahar sub-division and 10 out of 13 malaria cases in Khowai sub-division were radically treated. Care should be taken to minimise the gap between actual number of cases of malaria and number of cases in which treatment is rendered.

Surveillance activities in the selected households.

One Surveillance Worker is posted in each section. He will be responsible for surveillance work in about 2000 houses having about 10,000 population. But these norms vary in difficult areas. He will visit each household in his area once in a fortnight and record all necessary data. He will collect blood smears for all fever cases in the households at the time of his visit as well as from any fever cases since his last visit.

From the above table it is observed that number of visits of the Surveillance Workers in the selected households is not at all satisfactory as the Surveillance Workers do not visit the households as per norm. From the above table it is also seen that number of visits made by the Surveillance Workers in the selected households of Kailashahar sub-division reveals a dismal picture. Number of visits made by the surveillance workers in the remaining sub-divisions namely, Khowai, Belonia and Sonamura are also not satisfactory in accordance with the norms. From the field visit it is also observed that the surveillance workers are mostly irrigular in their visit. House-cards and house-stencils, if any, are not properly dated exposing irregular visit from the side of surveillance workers. It is also rea revealed from the table number 21 that low number of collection of blood smears are the result of irregular visits.

Problems of implementation of the programme at different levels.

Tripura with an area of 10,477 sq. kms. is surrounded on three sides by Bangladesh and only one road-link connects Tripura with the District of Cachar (Assam). Tripura is surrounded by hills and dales and only 2/3 area of it is on plain land with a population of 15,56,342 as per 1971 Census. Transport and communication facilities are still in developing stage. As a result, the Nam National Malaria Eradication Programme can not cover the whole state. Transport difficulties of the unit also stands in the way of proper implementation of the programme throughout the State. The existing condition of the departmental vehicles is also not good and their services are not fully utilised by the Department.

Transport bottleneck makes it difficult to send men and materials to det different sub-units. It is learnt that the Annual requirements and wom consumption of D.D.T. in Tripura for the year 1971-72 to 1973-74 are given below.

From the above table figure of consumption of D.D.T. in different years it seems that many areas of the State remain unsprayed. The present spraying squads can not cope with the increasing number of population of the state. As per norm it is learnt that one pump is to cover 20 households per day. But in case of Tripura it may not be possible to maintain such a norm. For example at Khowai, 12-20 households were sprayed per pump per day and in Belonia and Sonamura it is 15-20 households per pump per day. It is also reported that storing difficulties and non-availability of mechine at the time of spraying also stand in the way of effective spraying. Malaria Inspectors are reported to be overburdened with duties of diverse nature. They are to supervise spraying squads, surveillance works, and other official business. So they desire to have an office staff for prompt disposal of works. Again, present system of appointment of workers is also not encouraging.

They are engaged on daily rate basis for the operational period. But they have to move from one place to another for operation without any T.A..

As a result the workers are reported to be not satisfied with their present job and their total output per day may not be satisfactory.

Laboratory Service:

One of the main defects in the surveillance operation is poor performance by the laboratory services. There is usually a backlog of slides which would prevent timely administration of radical treatment. For example, the total backlog of un-examined slides for the years 1971-72, 1972-73 and 1973-74 in Tripura was 16'58%, 16'36% and 25'48% respectively which will be evident from the table No.5. The laboratory services should be reviewed with the object of securing improvement in the methods of transport of slides from the field to laboratory and in the staining method and the microscope should be inspected and replaced where necessary. Attention should also be paid to the supervision, training and retaining of microscopists etc. Prompt examination and expedious relaying of examination would help in early improvement of radical treatment to malaria positive cases and help in undertaking remedial measures like mass survey, focal spray etc. which are effective weapons to combat the problems.

Surveillance activities:

Surveillance works were started in the year 1966 and the staff strength of the surveillance workers is not in a position to keep pace with the increasing number of population.

The staff strength of the Surveillance Workers should be increased proportionately with the increasing trend of population. During field zm survey it was learnt that the Surveillance Workers did not approach each and every household in a fortnight under their jurisdiction. As a result many households were left unattended. In course of field survey it was learnt that medicines were not supplied to the Surveillance Workers sufficiently and timely. They also reported that the present workload of each Surveillance worker is heavy and for that reason they can not visit each and every house as per noum. Again, some posts of Surveillance Inspectors are lying vacant in different sectors of the State. Another important factor is that there are also some posts of surveillance workers which are still lying vacant and the services of these basic workers were not available in different areas of the state. Besides other technical difficulties, all these difficulties and problems require immediate solution for proper functioning of the programme. Difficulties faced by the Surveillance Inspector and Malaria Inspectors of each selected Sub-Division regarding proper implementation of the Scheme are summarised in appendix No.3.

Conclusions:

1. Insecticidal coverage: -

- Residual insecticidal total coverage both qualitative and quantitative by two rounds of spray as per logistic of spraying will require to be achieved to as cut down transmission of malaria parasites which is so essential to reach the desired goal of Malaria Eradication.
- ii). The present spraying squads are quite in-sufficient in view of the increased population and number of structures. So it is desirable to increase the number of spraying squads for covering the whole State.
- iii). During spraying operations mechanics and spare parts should be available to all sectors so that spraying work may not suffer at the time of spraying.
- iv). Proper propaganda should be made to the villagers in order to minimise the number of refusal of households in the hilly areas.
- v). Supervision at all levels be geared up to have proper output per pump per day and uniform total coverage. Output per pump per day has come down to a considerable extent from the standard resulting in lose of man-power. Spraying squads require suitable augmentation to have complete coverage.

2. Surveillance activities:

i). It is reported that the present workload of the Surveillance workers is heavy. The number of posts of the Surveillance workers was not increased in accordance with the increased population. So the number of posts of the surveillance workers should be increased.

- 11). Vacant posts of the surveillance workers should be filled up early in order to strengthethe surveillance activities so also the posts of the surveillance Inspectors.
- Surveillance workers should put dated initial on finishing his job in each house and Surveillance Inspectors and member of other supervising staff should put their dated initial on finishing his supervision in redated colomns.
- iv). Domiciliary visit in each and every house by the surveillance workers as per programme be ensured so that no fever cases be left without collection of blood smears.
- v). Drugs are not readily xxx available at the time of presumptive doses in many cases. So the surveillance workers do not visit regularly. Hence regular supply of drugs is desirable.
- vi). Surveillance workers should despatch slides twice in a week to cut down time-lag between collection and sending of blood smears in the laboratory. The patients also desire to have their blood examination report as early as possible.
- vii). Surveillance Inspectors should gear up their field visit and radical treatment to all positive cases should be undertaken on having reports from the Laboratory without killing further time.
- viii). Stray cases of malaria were found in the selected villages (Table No.18). So surveillance activities must be gx geared up in order to maintain the norm of visit in every household.

3. Laboratory Services:

Normal output per day per technician be maintained. Total blood smears collected annually and the number of microscope in action by the technicians and surveillance Inspectors trained in microscopy and posted in maleria laboratory, do not justify backlog of slides remaining non-examined. Timely examination and timely despatch of results should be ensured.

- Every Malaria Inspector of our selected sub-divisions is of the sys opinion of having a car for smooth and speady work in different areas of the sub-unit.
- Pay and allowances of the field staff should be disbursed timely,
- It is reported that proper implementation of the Scheme has been handicapped by financial limitations. For more vigorous activities under the programme against malaria, financial outlay is required to be enhanced.
- The programme is still in Attack Phase in the State.

 Though started in 1958 it has not yet reached either consolidation or Maintenance Phase. It appears that the Programme has failed to make rapid strides in the State.
