Inclos'd are this Ship's Charter Party and Calculates of the Tonnage put on board her here & in Bengall which will shew you there remains $89:12:3:22$ to be supplied in Bales at your Place; should the Captain request for any Bales over and above his Charter Party Tonnage, you will act agreeable to the directions We sent you the 8th. January last year respecting the Princess Mary.

They will also guide you in ordering the survey to be made of Her Men & Warlike Stores, in demanding the Captain's Manifest of Private Trade, in cautioning him against Fire and keeping the Boats long on board with Bales in them and in receiving any money Captain Bookey may offer to pay into Your Cash.

Inclosed is also Copy of His Private Trade manifested in Bengall to be return'd to Us.

What Bales you may have remaining after the Shaftesbury is full, We would have you send up hither as opportunity offers.

Inclos'd is the List of Packing Stuff in the Bales We have put on board the Shaftesbury, which must be added to your own.

Advise us as early as you can when this ship will be ready to sail, that We may prepare & send you Her Dispatches.

HONBLE SIR & SIRS

We are to acknowledge the receipt of your favours of the 6th. December & 5th. January, the first We receiv'd by the Normanton the 22^d. Ultimo, and the Shaftesbury brought Us it's Duplicate the 27th. The Normanton sail'd from this Place for England the 18th. Instant: & the Shaftesbury left Fort S^t. David the 21st. neither of those ships took in their full Tonnage, and carried some Bales less than you expected as you have computed the Tonnage of our Bales [...] 5 $\frac{2}{3}$ to a Ton instead of five & one third 5 $\frac{1}{3}$ [...] to regard in future.

[...] the Princess Augusta brought Us Your [...] Observe the reason Your Honour & C^r. [...] number of Bales to this Place, We think [...] to Dispatch two Ships to England the beginning of September, which will be saving some months demorage and no doubt their Cargoes will be acceptable at the March Sale; as the Duke of Lorrain and the two Ships in September will require about five thousand Bags of Petre to Kintlage them & We have not now including the thousand Bags by the Princess Augusta above five thousand eight hundred Bags, We propose to return the Princess Augusta to you as soon as she can be unloaded, desiring you will return her to Us with saltpetre or if your stock on Hand will not admit of that, please to fill Her up with Rice; We shall send you about twenty chests of Treasure by Her and as much more by the Mercury, which is all We have in the Warehouse, but as We have had some large sums paid into our Cash for Bills of Exchange, we shall as We have opportunity, purchase a further quantity of silver or Rupees, but at present both are scarce here. We observe your sentiments as to the Arcot Rupees, and shall regard what you write Us as near as possible, to send two thirds of the money We send you in Bullion, and but one third in Rupees, all that We have coin'd this year has been Bar silver, and the Madrass Rupees we intend you by the Princess Augusta and Mercury are the produce of part of it.

... By this Vessel We send Your Hon^r. &c^t. some Letters We receiv'd from Bombay and Tellicherry they will advise You of their apprehensions that the King George Galley, the Britannia & Neptune's Prize Grab founderd in a storm the 10th. November last; we think there is reason to hope they may yet be safe, but as that was uncertain the 4th. December when their last Letter is dated, they have very earnestly pressed us, as We suppose they do Your Honour &c^t. to send them all the Men that can be spared from this side. We are very glad [...] in Your favour of the 6th. December [...] stated their desires by the large deta [...] Bombay for We much [...] you before all Your shi[ing ...] here and at Fort S^t. David [...] possibly send them any rec. [...].

The Duke of Lorrain arrived here the 23^d. Instant she left Canton, the 20th. November, the Augusta was to be dispatch'd for England from thence about the middle of December and the other two ships the beginning of Jan^{ry}. The Harrington left Malacca bound to Bombay the 1st. December.

Our last by the sloop Carolina bore date the 28th. September, and acknowledged the receipt of your Letters by the Galatea and George: You have copy of it inclosed.

Having since then referred the examination of the several Books and papers that [...] said Letters to Mess^{rs}. Morse and [...] Comm]ittee for affairs of the West Coast [...] for Us thereof have here also inclosed for Your [...] being generally approv'd and [...] are to have the same re [...] all; what further direct[ions ...] at this time to give in [...] thereof, and in reply to your abovemention'd Letters, you will find under the following Heads.—

FIRST CONCERNING SHIPPING.

When We last wrote you We intended the Princess Augusta to you at this season, but the Gentlemen in Bengall not having return'd her to Us so early as we expected, We have resolv'd on sending the George back to You & dispatch her thus early as the means most likely to prevent her making such long and tedious passages as she did the last Trip, and we expect that You contribute all you can towards preventing the like in Her return hither.

With respect to the protest you deliver'd Captain Smith on account of his ship not being able to sail sooner for Borneo, We think with the Committee that our Honourable Masters will expect it should have been done sooner, which We repeat here as a rule to You for the future in cases of a like nature.

Your several other Transactions taken notice of under this Head being consonant to the directions you have at several times receiv'd from England & this place We have no occasion to remark particularly thereon.

SECONDLY, GOODS FROM EUROPE OR FORT ST. GEORGE.

By the Somerset that left Bengall in November for Your place We suppose the Gentlemen there have complied with our request in sending You such of the stores You indented for as were procurable there. The George brings you [the] remainder as Invoice and Bill of Lading inclosed [. . .]

[. . .] after the so often repeated [. . .] on for the storekeeper Pay [. . .] compare their rem [. . .] the committee should still [. . .] remark that the storekeeper on [. . .]

There appearing so much reason to believe the deficiencies in Mr. Savage's Accounts have proceeded only from the causes assigned in your 19th. Paragraph We permit them to be wrote off.

The Treasure consigned us on the George came out agreeable to Invoice; We receiv'd also the Arcot Rupees paid in by Captain Westcott: As to the Exchange you were right in referring it to our Honourable Masters whom We have desired to signify their pleasures on the rate You brought them to account at, whether they shall think the Penny they are gainers thereby, comparing it with what they allow in the Bay is equivalent to their risque of the money hither.

Inclosed is Manifest of Goods licenced on the George.

THIRDLY, INVESTMENTS, FOURTHLY COUNTRY GOVERNMENT.

The larger produce of Pepper this year than last We look on as an instance that the proper care has been taken to encourage the growth of it, and the examples pointed out to us by the Committee of Fining the notoriously negligent and shewing favour to the industrious as means the most likely to conduce to that end; though We think the building Godowns at Manna, Bental and Ipoo (the usefulness whereof is very visible to us and which We with pleasure observe are selling about, will contribute not a little thereto, as thereby those valuable purposes may be served which We find recited in the Sultan's Letter to you of the 8th. and your Consultation of the 10th. October; We shall only repeat here what We have so often said before that the encreasing the Investment by the most proper and effectual Measures will always be esteemed the most acceptable [. . .] ce [. . .] plea [. . .] greatest Merit with our Honourable [. . .]

Observe you have made several orders for [. . .] such as relate to trusting the [. . .] &c^t. We approve, and the others also [. . .] only cautions to the People under You [. . . consider] able risques; but no more: and therefore [. . .] explain'd, for we do not think the good of the Settlement concern'd in them, and they seem to retrench that Liberty of Trade which our Honourable Masters allow to all their Servants in general.

FIFTHLY, FORTIFICATIONS, BUILDINGS, REPAIRS & REVENUES.

In the method you are fallen into of covering with Tyles, as a security against Fire you represent a want of Persons skilled in laying them which We hope you may furnish Yourselves with from Batavia, but We are at a loss to know what the sort of Tyles is, which We see charged at 16 Dollars a thousand, if they are of the sorts used here of which We send you some by the George, are excessive dear and would not cost us above half a Pagoda ₹ 1000, and We could supply you with sufficient from hence by the Company's Vessels, if the Persons with You who make the flat ones, cannot perform this sort of work.

As Teak is the most durable wood We would have none else used in Your Buildings and think it for the Company's advantage that you procure what you can from Batavia we send you by the George some Planks saw'd into Joices.

We concur in opinion with the Committee that it will be proper to continue the south East and China buildings as they are for the present servicable, till your other buildings are finish'd But not to lay out any thing considerable in repairs on

them. We have again represented to our Honourable Masters the great want you are in of slaves to forward those Works & hope they will take effectual means to supply you.

SIXTHLY, FACTORS, WRITERS, OFFICERS AND THEIR ACCOUNTS.

When you receive the produce of M^r. Innes's Goods you must pass the ballance to our Account.

The present state of our Garrison will not permit us to send you any Recruits nor have We been able to get any Arabs.

Captain Taylor's demand for the maintenance of the Transports and Slaves, which you referr'd to Us has been paid here.

We observe you have paid out of Lieutenant Horne's Estate a Debt due to Captain Eckman in full which was wrong since his Estate will not pay every body: besides it was an old Debt and by long prescription it has been the practice here to appropriate the Goods carried on any ship to pay the Money taken up at Respondentia for purchase of such Goods; For the future therefore you must avoid the like. If any Person dies with you who has no accounts with other parts of India you may divide his Estate, but if you have reason to beleive He is so indebted you should deferr making a dividend or any payment till a reasonable time has been allow'd for claims to be brought in from such places.

SEVENTHLY ACCOUNTS.

The several causes of the increase in your expences for the last Year pointed out to Us in the inclos'd Report appearing unavoidable We need not remark particularly on them, and shall only take occasion to remind You that our Hon^{ble} masters always esteem any savings in their Expences, a valuable service.

SUPPLEMENT.

HONBLE SIR & SIRS

The 7th. Instant we receiv'd your favour of the 4th. December wherein you advise Us of the storm which the Prince William and the Major part of Your Fleet met with the 10th. November last and your apprehensions that except the Europe Ship and the Gallivats which were arriv'd with you the rest were Lost, unless they were got down to Tellicherry; We are sorry to advise you that except the Rose Galley which left the Fleet when the storm came on, We have as yet receiv'd no news from thence of the rest, which gives us the more sensible concern because it is out of our power to send you any recruits from hence, Our Garrison being very thin of Europeans and the Topasses We have here would be of no service to you being little better than our common Cooleys: We are also to advise You that We have been assured from Arcott that the Morattas intend an Irruption into this Country and a large Body of them have actually enter'd Corrapa which borders upon this province: having for some time been apprehensive of their March this way, We wrote to the Gentlemen at Calcutta to send us some Europeans from thence if they could be spared, but they tell us they could not comply with our request, having sent a large detachment to your Island and should also be obliged to supply the Company's Ship Richmond that lost many Hands in her outward bound Passage, since it is out of our Power to send you an[y] Recruits from hence We are very glad you will receive so good a supply from the Bay, and We are not without hopes that you have long before this time had the satisfaction of seeing the missing [Vess]-els safe return'd to You. Our Northerly Wind[. . .]ed so far as this season that the [V ... Pac]ket to the Gentlemen at[. . .]. Days ago.

We observe by Your last that Hussanally Cawn the Nabobs youngest son is soon expected at Tivady, and your reasons why it may be necessary to make him a Present: It's but too well kown in the Province the Power which the Nabob's Sons assume to themselves independent of their father, and which has fixed a necessity of paying greater court to them, than to the Nabob himself: If We mistake not the Country about you is more particularly under the Government of Hussanally Cawn and it may be imprudent to let him pass by you a second time without sending some Persons to wait on him with a suitable Present and therefore We leave it to You to act in that respect as you see necessary & so We do in case the Nabob should also come your way, but as to him We are told he designs back to Arcot, and that he has actually left Allumparrah: We shall to day send you by Cooleys some Embossed Cloth and Velvets, which is all that We have in our Warehouse fit for Presents.

The 23^d. past We acknowledged the receipt of several Letters from you, since when We have received yours of the 14th. inclosing Your Cash and Paymaster's accounts, and desiring a further supply of twenty thousand Rupees: as to this last We cannot see that you can at present be in any immediate want for them, as the ballance of your cash in Rupees was by the last Account upwards of Eighty thousand and as the Southerly Monsoon, is now setting in, We shall [have . . .] many opportunities to supply you before you [. . .] We have some Gold in our Mint and [. . .] Madrass Pagodas so soon as they can be [. . .].

The [clo]th is not yet all sorted but we shall [. . .] account how it turns out; It has been [. . .] of from home, that such part of Your [. . .] Vizagapatam is too much conjeed: What you have sent up now white has the same fault, and You must take care in future to mend it.

By this Vessel, comes M^r. Thomas Saunders whom We have appointed Second of Council at Vizagapam and when the next ships arrive from Europe We hope to be able to spare you some more Covenanted Servants to assist in carrying on the Business at your Place.

Our Honourable Masters by the last ships have been pleas'd to order that the cash at all their Settlements should be lock'd up under three Keys, to be kept by the Chief and the two next in Council and the Ballance to be produced monthly upon reading the Cash Account: M^r. Simpson having been alone the last year it was needless to advise you thereof before, but now that We send Mr. Saunders, We direct that it be complied with except five thousand Rupees and two thousand Pagodas, which may be kept by the Chief alone for all ordinary occasions, but the whole Ball^{ce}. must be produced Monthly in Consultation.

In our Letter of the 13th. February last Year We recommended to you to allow all your Inhabitants without distinction a full Liberty of Trade and We must now also recommend to you a regular and impartial Administration of Justice as being not less essential to the welfare of the Place; and that there may be no complaints of any hardships either from delay or other Reasons: We direct that when any Person is confined in the Choultry, at his own House, or elsewhere, or put under the charge of Peons, the cause thereof shall be reported next Consultation, which Consultation shall be held within three days & the Person so committed to custody, shall be continued or discharged as shall be then agreed.

We permit you [to] pay M^r. Thomas Pitt the same allowances for Diet & [. . .] those in the same station have at Ingeram.

are in earnest, and will be able to execute what they have propos'd. We observe also they require an advance of fifty thousand Pagodas in their Hands; This is a large sum but as you are of opinion they may well be trusted with it, and that a less sum will not enable them to carry on the business, & have also as a further security engaged Irshapa Chetty to join with the other two, We have agreed to consent to your advancing them that Sum, & so We do that the Brokerage to be allow'd them on the several sorts of Cloth, be the same as the Merchants were allow'd last year; as to Blue Cloth the Company Indent but for three thousand Pieces, & we cannot consent to your receiving any more.

We observe what you write about providing Cloth at Salem, & the price of fanams being established there at $23\frac{1}{2}$ the Pagoda which used to be at $24\frac{3}{4}$ to 25, you impute this to Nanjan Chitty's engrossing them, but We wish it does not rather proceed from the baseness of the Pagodas of this Province, however that be the Company seem so well pleas'd with the Salem Cloth, that We are unwilling to drop it without We could be sure it would have that effect which you imagine by leaving off to provide any cloth there for a year. And as for the French Merchants we are of opinion, no agreement of this sort with them is to be depend[ed] on longer than they are in want of Money, which we are told is the case at Present.

The Company's Standard measure of the Long Cloths is seventy two covids long and two and six Inches broad and of the Salampores thirty two long & two and a Quarter broad, and the Buyers at the sale expect they should hold out that, and though the Company have not forbid taking in the O chop, the measure of which is

specified in the Invoices from Ingeram, yet they have frequently, and still continue to complain that the Ingeram Cloth does not hold out according to the Measure in the Invoice, You must be particularly carefull therefore to prevent all further complaint upon this Account.

You carry with you Musters out [of] the Warehouse of the Izzarees, Fine Long Cloths and Salampores: Of the first you seem to be in doubt whether you can procure above five hundred pieces in the Year, but if you can make up a thousand, th[ey] will be acceptable, you must however be sure to keep up to the Muster, what the Company complain of in th[ose] they have from hence, is, that they are too thin, & if tha[t] fault cannot be mended with you, We may as well provide them here. As to the Fine Long Cloth & Salampore we think you will not be able to procure more than We shall have [occasion for] and therefore We say, get all you [. . .] been a constant complaint of the [. . .] that it is ill cured & too soft [. . .] Fine Cloth is now generally apply [. . .] must endeavour to get the Thread [. . .] much as is ready to send us in August let it come up brown, but that which you send us in December must be cured with you, as We cannot hope to do it here in time to send home this season, & We hope you will be able to mend the defect complain'd of in the colour.

As you have instructions now to provide more sorts of cloth than formerly, you must be particular at the foot of your Letters to Us, how much you have of each sort embaled, at the Washers and Brown.

The Master of the Calcutta Sloop has orders to put you a shoar at Ingeram, and then to proceed to the Bay, you must not detain him longer than to land the Stores We send with you, as f Invoice and Bill of Lading inclosed.

M^r. Since our said L[et]ter of the 15th. February we have [had seve]ral discourses with our Merchants, relating to your [. . .] proposal that all Agents from the Madrass Mer[chants . . . em]ploy [. . . Chem]anackpollam, Warriar-[pollam . . .] sales [. . .] to the two first places [. . .] to be very fond of providing [. . .] necessary to getting in their Old [. . .] not to be brought to the giving up [. . .] have any opinion, that any [. . .] such as to be depended [. . .] they are too apt to make and evade them, as it suits their conveniency besides they say That it is not only the French & We who provide Cloth in that Country, but there are many Agents there also from the Dutch and Danes, as well as from the People of Porto Novo, and though all may not provide so good a sort as We do, yet that there is no doubt the Weavers will find full Employment; We wish We could think with you that the Pagodas which pass in the Country were all of them as good this Year as last, but We have very good reason to say that large parcels have been lately coin'd that are much worse, and though our seal'd Bags are kept as near to Eighty touch as the Judgement of our Shroff will admit of, yet our Merchants exchange them here for other Money which is as current in the Country, receiving a Batta upon our seal'd Bags from 1½ to 2½ P Cent, but whatever there may be in your reasons or our Merchants objections they tell Us positively, That if they are restrain'd from providing Cloth at Salem they cannot hope to make an Investment elsewhere, for what of the Company's Sorts is manufactured in this part of the Country is next to nothing, and though some Parcels of Cloth from Salem do sometimes come worse than at other times, yet that what is Manufactured at Warriarpollam and Chemanackpollam has of late been much worse in proportion; Indeed if We were to give credit to all that they tell Us, there would be no want of Cloth from Salem so long as there was Money to purchase it: however We beleive it certain that Country produces the best and largest quantities, and if there be any advantage accruing from the French being quiet there at present which We still impute rather to their want of Money than any other reason. We say our present thoughts are That We ought not to slip it and lose the opportunity of increasing the Investment especially as We wrote you before that it is a sort of Cloth the Company seem to be pleas'd with.

Caun till Chundah Said had withdrawn his claim though We think if the Braminy was with you We should consider whether it would be proper [to] deliver [him] up to either at least till it was made fully app[ear that he w]as ind[ebted] to the surcar.

You cannot be ignorant that it is no new thing among the Moors to say and threaten many things which they have no intention to perform, when they have any expectations it will have an Effect to extort Money, and there are never wanting those about them who know where to place their Agents in order to alarm those against whom their designs are levelled and therefore though it may be prudent for you to be upon your Guard yet outwardly We think you should seem to discredit the reports which are given out in his name, by imputing them to the contrivance of some idle fellows that delight in mischief, who have no other intention but to alarm & terrify your Inhabitants: We are otherwise inclined to beleive this is really the case because we observe none of these threats came directly from Hussain Ally Caun, He will be cautious how He gives any such thing under his own hand: We should not fail to send it directly to the Nabob, and in fine if he should contrary to our expectations begin any hostilities or otherwise molest your Affairs We doubt not We shall be able to make such effectual representation to the Nabob as will soon put a stop to his proceedings, We do not as yet think it proper to write about it to Arcot, beleiv^g. it will be denied that Hussain Alley Caun has any such thought or intention, & that it is a notion that proceeds only from surmise & the Apprehensions of our own people; however we are impatient till We hear the ten thousand Pagodas stopt at Wolendore is clear'd; If there be any delay in the matter you must let us know it that no time may be lost in making proper application to the Nabob.

Instant by the Princess Augusta and Bermudas Sloop, some days before which the Morattas enter'd this Province, and out off our Nabob and his Youngest son, with great part of the force he had with him, upon which his Eldest son who was Marching to his Assistance, but with only three thousand Horse turned back, and got with part of them into Velour, a Fort to the Southward of Arcot: The Morattas soon after enter'd Arcot, the Capital of this Province and have plunder'd it of every thing they could find, as well as some of the adjacent Towns, It is reported a Treaty is on foot between them and Subderally Cawn in order to their leaving the Province, but their demands are very high, and matters are far from being accommodated: some Parties of their Horse have been plundering several Towns within less than a days Journey of this Place, and We are informed they have sent people to look out, what Water there is towards the sea coast, and if matters are not soon settled at Arcot it is more than probable they will visit the Sea Ports. We have put ourselves in the best posture We can to resist any attempts they may make upon us, but as We are in want of Men & the Prince William arriving here the 21st. Instant from Bombay, and having on board about fourteen Men which were returning to you from Bombay, We have order'd them ashoar, and upon this Emergency We have Likewise taken twenty Men more ashoar of the Prince William's Ship's Compy We hope however to return these last soon on board again and to Dispatch her to you in about fifteen days: she has two Lack of Rupees on board for

your Presidency, which We advise You of that you may order the Sloops to meet her in Balasore Road, and take out such part of it as you think proper before she goes up the River.

The necessity of your entertaining as many usefull People as you can for the defence of your place is but too obvious and we are sorry the state of our own Garrison has put it out of our power to send you any assistance of that sort from hence, and We are as little able to send you a supply of the most usefull and necessary Stores you write for, till the arrival of our Europe Ships.

We have taken into consideration what you write about the Ditch round Your Fort, the Paymaster and Gunner's Survey, and their Report thereupon, We are very sorry so necessary a work as this is represented, and We beleive indeed to be so, should remain to be set about at this Juncture when it is to be wished all our Fortifications were compleat, and in the best repair, for though We are told the Morattas have agreed upon some terms with the Moors, in consequence whereof the Major part of their Forces are retired out of the Province, yet the Place where they are encamp'd is so near the borders, and will give them so easy an entrance again whenever they please, for which they will not want a pretence, and as their scheme seems to be to plunder and destroy wherever they can overcome, We think you ought not to omit any thing which may be necessary for your Security, and as what you propose is represented to be so and is also thought necessary to prevent the damage the Fort Wall would be subject to, if this work you propose be longer omitted you have our consent to set about it as soon as you can; We shall only remark that what the Paymaster and Gunner propose namely the raising the old Wall of the Ditch about three foot higher by way of a Breast work for small Arms, however proper it might be if you had a strong Garrison, appears to us at present to be not only unnecessary, but also may be inconvenient, for We take it the few Men you have to defend the Fort ought in case of action to keep within, and in that case a Parapet Wall would hinder the Effect of your Fire Arms from the Points and Curtains. We must not on this occasion omit to repeat our Honourable Masters directions, That whenever there is a real occasion for repairing their Buildings or Fortifications, you should always see that the work is substantially and well perform'd, and the Paymaster's Accounts upon these and all other occasions must be carefully examin'd every Month, the necessary previous directions being given him in Consultation in what manner to carry them on in order to prevent the Workmens lavishing their Money away in a needless manner and charging more for the Materials and workmanship than is equitable, and that some of the Council should have an Eye over the Work while it is carrying on as well as the Paymaster.

Having perused the account of Stores worn out and decay'd and Lost by weight last year you have our permission to write them off to Profit & Loss. You have also our consent to allow one Serjeant and three Corporals more to each Company.

HONBLE SIR & SIRs

Our last to your Honour & C^o. was the 24th. past by a Sloop and the Ship Ceres, This waits on you by our Honourable Masters Ship the Prince William on which We have loaden some Redwood as P^r. invoice and Bill of Lading inclosed. By mistake the Redwood of Princess Augusta was charged at 2 Pagodas P^r. Candy instead of 2½ which is rectified in the inclos'd Invoice.

This Province continues still in a very miserable condition: The Morattas after they had plunder'd every thing they could lay their hands on agreed to quit the Province upon condition of being paid a sum of Money: part has been paid them: But Subdar Alley Cawn, in whose name the agreement was made with them is under great difficulty how to raise the rest: however the Morattas are for the present retired out of the province, but at so small a distance that they may enter it again

when ever they please Reports are various as to their future proceedings, some say they intend to remain four months at Coloore a Province to the Westward till the Waters of the Kistna are fallen, which being swelled at present hinders their return to their own Country: Others that they design to take their rout through Misore & retake Tritchanopoly, which the Moors took possession of about three Years ago; In the mean time this province remains in Anarchy and Confusion, Subdar Alley Cawn continues still shut up in Velour with very few Horse, and wherever the rest are dispers^d. We hear of none any where in a Body which gives the Poligars an opportunity (which they make use of) to plunder & burn most of the Villages that belong to the Moors: In a word it appears to us there is nobody in the Province that has any inclination or indeed Power or Force to endeavour at a Settlement so that our only hopes are that Nazar Jung, son of Chiklas Cawn will take some order about our affairs, but as to him also Reports are various, some say He will himself be soon at Arcot. Others that He designs to stay four Months longer at Golcondah, but however that he has order'd two Munsudars to set out with a large body of Horse for this Province. This is all We shall trouble you with at present relating to the melancholly situation of these Parts where all business is at an entire stand and will continue so till somebody is fixed in the province that has Authority & power to settle it.

We have return'd the Twenty Men on board the Prince William that belong'd to her, but the Soldiers We propose to keep some time longer.

We had design'd this Ship to you some days sooner, but the Captain as well as ourselves was willing to see the new moon over in hopes that after it the Monsoon will be set in, and the Weather moderate about the point, and so safer to enter the River: Her stay here has given us an opportunity to advise you that the 12th. arriv'd our Honourable Masters Ship Princess of Wales Captain Hoxton; He was designed directly to the Bay, and having no Packet for this Place We demanded his reasons for coming in here, which He says proceeded from many of His Men being down with the scurvey: He left England the 25th. January in Company with the Wilmington for this Place, the Winchester directly for China: The Bedford for S^t. Helena and Bencoolen, and the Mountague for Mocha: Private Letters tell the Company have taken up Eleven Ships more for the different parts of India, but in all probability they will be late as the River had been frozen for about a month, so that no ship could stir, or any sort of work be done on board Her, besides there might be a difficulty in manning them, and it was also uncertain whether there might not be an Embargo; The War with Spain was declared in Form the 23^d. October last, but neither France or any of the other Potentates in Europe had taken part with either side.

Since writing the foregoing We have resolved to send the Military which We took out of the Prince William on board her again.

HOÑBLR SIR & SIRs

Our last to your Honour &c^r. was the 10th. April by two conveyances, We have since been favour'd with your severals of the 20th. & 28th. of that Month by the Pulteny & Prince William, the first arrived here the 17th. the other the 21st. May.

By a Letter from the Chief & Council at Tellicherry dated the 29 . April We are advised that the 23^d. of that Month the Bermudas Sloop arrived there from Bengall and the Grab which went out in company with her was also arriv'd upon the Coast, but it being so late in the season the Chief and Council write us they should be obliged to detain the Detachment that was sent on board them till the Rains were over.

We have receiv'd the Olibinum and Putchuck by the Prince William and shall give your Presidency Credit for the amount: The Company have not sent us any ship to go from hence to China this year, but a country ship will sail for Canton in a few days, and We beleive the owners will take these Goods off our hands.

A Sloop and the Ceres sailing for the Bay few days after the Prince William arrived here We took that opportunity to advise the Gentlemen there of the time she would leave this place and what Money was on board her, that the Sloops might be ready to meet her in Balasore road and to take out so much of the Treasure as they thought proper; The Prince William saild from hence the 14th. Instant: We should tell your Honour &c^t. she touch'd at Tellicherry in her way down the Malabar Coast, and deliver'd the Stores you design'd for that Settlement.

We observe what you write about James Flint, and we beleive the Owners of the Country ship bound for China will agree to carry him to Canton where probably the Company's supra Cargoes may have some directions about him.

The 12th. Instant came in here our Honourable Masters ship Princess of Wales & the 15th. came in also the Wilmington both from England, the first was design'd directly for the Bay, but put in here by reasons many of Her Men were down with the Scurvy: By the Wilmington We receiv'd a Packet from our Honourable Master's, and inclosed you have a List of Eighteen Ships which arrived in England the last season, and another List of the Ships taken up & design'd for the several parts of India; The Wilmington, Princess of Wales, Bedford, Winchester & Mountague left Portsmouth the 25th. January, and when the Compy wrote us the 2^d. of that Month; the other Eleven Ships were by agreement to be in the Downs the 23^d. & they hoped to get them away by the beginning of Feb^r. But the Captain's of these Ships tell us none of the others were got down even to Gravesend when they came away, being prevented by an exceeding hard Frost which continued with great severity when they left England: It was also apprehended there would be great difficulty in getting men and if they should succeed in that, it was doubtfull whether they could procure protection, so that it is to be fear'd they will be very late.

A War with Spain was declar'd in Form the end of October; Above an hundred and Thirty Ships of War were in Commission and they were busy in all the Docks getting others ready: All the other Powers in Europe continued neuter, in the Quarrel when these Ships came out, and it was hoped would remain so.

We advis'd your Honour &c^t. in our Letter of the 31st. January, that We had been assur'd from Arcot the Morattas intended an Irruption into this Country, We did however hope that the Moors would have prevented it, by paying them a sum of Money, and indeed their pretence for coming now was to demand their proportion

of the produce of the Country, which they said had not been regularly paid them: It is most reasonable to believe the Nabob intended to have compounded with them, from the small Force He carried with him, when He went to the Pass of the Hills, for except Ten thousand Foot [which your Honour &c. know are made but little account of in this Country] H[e ha]d not above Two thousand Horse, and our Accounts tell us the Moratta Army consisted of Forty two thousand Horse, under the Command of Two Generals Futta Sing, and Raugojee Bussorah. The 9th. May in the Morning the Nabob found himself surrounded by the Enemy, who killed him and his youngest son Hussain Alley Cawn, and soon put the rest of his Forces to flight; His Eldest son Subdar Ally Cawn who was marching to his assistance but with no more than three thousand horse hearing of his Father's defeat & death shut himself up in Velour with about Three hundred horse, and left the rest to shift for themselves: Those were afterwards extremely troublesome for dividing themselves into small parties under pretence of their want of subsistence, committed great ravages in several parts of the Country. There being no Force to Oppose the Morattas, and Futta Sing remaining at the Pass of the Hills with twenty thousand Horse, the remainder under Raugojee advanc'd into the heart of the Country, Lolla Petta lying first in the way they plunder'd and burnt that and soon after Arcot under went the same fate as well as Conjevaram and several other Towns there is no guessing at the value of the plunder they met with, but it is generally agreed to be very considerable; We had advices they intended to visit the Sea Ports, (where inded may Merchants & considerable Men in the Country [have] [r]etired with their Effects) and had actually sent their spies to enquire what Rivers there were and what Water was in the Tanks near the Sea Coasts, but all at once We were advised that Subdar Ally Cawn had patch'd up a Peace with them by the Mediation of His Brother in Law and some other considerable Moormen who were taken Prisoners at the Pass of the Hills. We know not certainly the Terms of the Treaty, nor the exact sum which it has been agreed to pay them, whatever it was part was paid down and some of the Mediators remain'd with the Morattas as Hostages for the rest: soon after the first payment they retired through the pass of the Hills and our last advices say they are some days March beyond them, We are also told that Nazar Jung son of Chicklis Cawn is on this side the Kistna with a large army, and has detached great part of it in pursuit of the Morattas; We shall not trouble you further with these sort of Advices which consist for the most part of flying reports and shall only add that this Invasion of the Morattas has so entirely broke the spirit and force of the Moors in this Province that thô Subdar Ally Cawn agreed with upon the treaty already mention'd with the Morattas He has not since done any one thing towards settling the peace and Government of the country, so that it remains in great Anarchy and confusion and the little Poligars are up every where plundering and burning all the open Towns, and these circumstances We find an entire stop to all [man]ner of Trad[e &] God knows when we shall find [an a]mendmen[t].

With these Peons We send a Packet directed to Your Honour &c. which We receiv'd few days ago from the Chief & Council at Anjengo.

We shall be obliged to Your Hon^r. &c. if you will let us know how much We are to Credit your Presidency for the Cost of the Princess Augusta.

The French give out they expect three hundred Recruits this year from Europe, but We take it they will be cautious how they weaken their Force at Pondicherry till there is some settlement of affairs in the Province, which as yet We have but little hopes will be soon; The French are also engaged in a dispute with the King of Tanjore about their Settlement at Carracal how long it may subsist We cant say, but

We believe their neighbours at Negapatam will endeavour to foment it as much as lyes in their power, so soon as We can learn they are making any preparations for your side We shall not fail to advise you of it, and are

One James Flint has his passage allotted on this Ship, whom we recommend to your Honour &c^t. to be sent to China from Your Place agreeable to the purpose Contain'd in a Paragraph of our Letter to the Honible Court of Directors of the 13TH. February 1739. 40 &^r. Harrington, copy of which comes inclosed.

COPY OF THE 23^D. PARAGRAPH OF BOMBAY GENERAL LETTER TO THE HONOURABLE COURT OF DIRECTORS & HARRINGTON DATED THE 13TH. FEBRUARY 1739. 40.

Par. 32^d. Captain Jenkins brought here on the Harrington from Canton by M^R. Rigby's direction, a Young Lad by name James Flint left there by him in China to learn the Language, (as We are inform'd) with your approbation, and We propose to return him thither by the first opportunity, in order to continue his application to that end, In which he has already had some success and Your Honours will please to give what further directions about him you may think proper, We being guided in sending him back there by our opinion that in time He may become very usefull to the English dealers there, If fitting care is taken of his Education in that country.

The 2^d. and 3^d. Instant We receiv'd the Original and Duplicate of your favour of the 23^d. May and agreeable to your request Captain Hoadly sent the Company's Packet on shoar here directed to Your Honour &c . which was open'd in his presence, and compared with the Lists, and the several Papers therein were found agreeable thereto, such of them as We think may be of any use to you before the Ship Arrives at Bombay, We have taken copies of and send them with this, as & List inclos'd ; second copies shall come in few days : After which we shall close up the Packet again and redeliver it to the care of the Captain.

As to the landing of the Treasure here for the security thereof We do not think neither indeed does the Captain that it would entitle the Ship to any Demorage all that he seem'd to desire was an indemnification in case any accident should happen between the delivering of it out of the Ship and receiving it on board again, and likewise to justify him to the Company for doing what in himself he had no Authority for : If by our Advices from home there had been reason to apprehend France had taken part with Spain in the War with England, We should perhaps have taken it upon ourselves to have order'd the landing of the Treasure here, but as there did not app[ear] to us any apparent danger upon that account We thought We might wait for advices from your Honour &c : We have since been in such a Situation here that it would have inclined us to have wish'd it on board again and are sorry to add we have yet some reasons subsisting which induce Us to forbear as yet sending for it on Shore.

We wrote Your Honour &c^t. very fully the 20th. past relating to the Irruption of the Morattas into this Country ; There remains a considerable sum yet due of that which was stipulated to be paid them upon which account their Vackeels at Arcot talk in very high terms. The Moratta Army which We advisd Your Honour &c^t.

consisted of upwards of forty thousand Horse under the command of Futta Sing and Raugojee has been since join'd with twenty thousand more under the Command of another General named Seedojee, They are now in the dominions of the King of Misore, and have raised great contributions; They seem inclined to march further to the Southward before they return again to the Northward; This province continues still without any Government, and without any Force to protect it; The late Nabob and his Sons were greatly indebted to their soldiers, who refuse to List again till they are paid their arrears.

Two days ago our Shroffs receiv'd Letters in five and thirty days from Delly, that tell us the great Rajah Savajee Sing, was Marching with a large Army to besiege Chicklas Cawn, in Agra. 'tis certain his son Nazar Jung who We expected in this Province, and was actually on this side the Kistna has repassed it and returned to Hydrabad, whether with intention only to protect the Deccan Country or that he designs to march on to the assistance of his Father is as yet uncertain.

Some time since We had a flying report that the Nabob of Patna had march'd an army against and killed the Nabob of Muxadavad; These Letters from Delly confirm the truth of it, and add that it was by the direction of Chicklas Cawn, with the first Report We were told Muxadavad was plunder'd which will keep us in pain for the Company's Settlement there till We receive advices from Calcutta.

We have as yet no news of the Duke's arrival on the West Coast, which is all that We have to add except the assurance of our being always.

June and We suppose will be Dispatch'd for England as soon as she could take in her Cargo.

The Duke Arrived at the West Coast from England the 9th. October, and was Dispatch'd for Benjar the 24th. November, but meeting the Marlborough in the Streights of Sunda who had been able to get little more than Fifty Tons of Pepper at Benjar, She return'd with her to Fort Marlborough, but the Gentlemen there, beleiving the Duke would meet with better success, they Dispatch'd her to Benjar again the 9th. January however with orders in case the Supra Cargoes could not purchase three hundred Tons of Pepper by the end of August or beginning of September they were then to dispatch her directly to the Malabar Coast, but if they should succeed in obtaining about that quantity they were then to return her to the West Coast to compleat her loading there.

The 20th. Instant the Jenny arrived from Mocha, by her We receiv'd a Letter from M^r. Waters Dated 20th. June: He writes us he had Instructions from Your Honour &c^r. not only to provide a cargo for the Europe Ship expected at Mocha, but also a further quantity to help out in filling up the Tonnage designed for your coast and He had accordingly complied with his Instructions, but as the Europe Ship was not arrived at Mocha, he concluded she had lost her Passage, and being in want of Money to pay for what he had purchased he had borrow'd thirty two thousand Dollars of M^r. Craddock & had given Bond for the same, which He desires We would discharge here, and which We have accordingly complied with, and shall Debt your Presidency for the Amount: M^r. Waters adds that he had taken up the Narcissus and should Dispatch her to Bombay with a Loading of Coffee by the 12th. July.

We take it for granted that the Mountague not being able to get to Mocha has bore away for Bombay, and doubtless you will have by her Duplicate of what the Company wrote You by the Royal Guardian, which you will probably receive before

We advisd you by a Sloop that sail'd the 21st. past that We should send you by the Jenny twenty Chests of Rupees on our Honible Masters Acco^t. accordingly We have shipped it on board this morning and Invoice and Bill of Lading for the same come inclos'd.

The 27th. past We receiv'd y^r. several favours of the 17th. March, 24th. April & 9th. May, the Gentlemen of Bombay have also wrote us for Ten four pounders, and one hundred Bolts of Europe Duck: The Guns we have ready to send them by the Royal Guardian, and We hope the Arrival of our Europe Ships will enable us to comply with their Indent for Duck.

We are very much surprized at the Deficiency in the Tutenaigue by the Princess Augusta, as that Ship is since arriv'd with you We doubt not you examined the Captain and officers about it; 'Tis most likely the Pieces wanting were left on board her in the hurry with which she was shifted in February last.

Our Shroffs had advices some time before We receiv'd yours that the nabob of Muxadavad, had been killed by the Nabob of Patna, & that this last acted by orders from Court, but 'twas uncertain whether from the Mogul or only from Chicklis Cawn.

Inclos'd Your Honour &c^t. have a Letter from the Deputy Governour & Council of Fort Marlborough, desiring that you will keep the Ship with you which they suppose will be order'd them by the way of Bengall. They add 'To us that by that means they should be able to make up the Duke's Charterparty Tonnage if she should not be able to get about three hundred Tons of Pepper at Benjar: Upon this we are to remark, That when they proposed you should not send a Ship to them from Bengall, They expected they were to dispatch the Bedford directly home and indeed so they are if they have hopes that the Edgebaston will meet with success at Borneo, but otherwise they are to send the Bedford or Edgebaston, which of them first arrives to Bengall: The Marlborough got but fifty Tons of Pepper at Borneo, and the Gentlemen at the West Coast being oblig'd to make up the remainder of her cargo it has doubtless render'd them less able to provide for a quantity of Tonnage this year; On the other hand if the Duke succeeds at Benjar it may give reason to hope the Edgebaston will too, and in that case they will only have the Bedford to Dispatch directly home, and perhaps considering the Quantity of Pepper the Marlbrô carried off, they will not be able to furnish this year more than will compleat the loading of one ship. What they may resolve of when they receive the Company's Orders by the Bedford We cannot guess, but it happend very unlucky that ship

put into Portsmouth or Plimouth & We read in some of the News Papers was order'd to remain there till the other ships called upon her, who were also to come out under convoy, and the Company had not obtain'd protections for them till the 12th. February, so that We apprehend they will be all late in India, and the Bedford and Edgebaston more so, as the first was to go to S^t. Helena, and the other to Madagascar & whether they will be able to send either of them to the Bay will depend much on their Arrival at the West Coast, but We shall have a better opportunity to give our Sentiments of this affair when We receive our next Letters from the Company.

The Duke arrived at Fort Marlbrô the 9th. October, and was dispatch'd the 24th. Nov^r. to Benjar, but meeting the Marlborough in the Streights of Sunda, the Supra Cargoes gave the Captain of the Duke an order to return back. They both arriv'd at Marlborough the 7th. December, the Duke was dispatch'd back again to Benjar the 9th. January, The Marlborough to England the 29th. January.

The Gentlemen of the West Coast advise Your Honour &c^t. that the Somerset sprang a Leak which renderd her incapable of proceeding to England and oblig'd the Captain to carry her to Batavia to be refitted there. She returned to Fort Marlbrô the 8th. June and We suppose would soon after be dispatch'd for England.

The Captains of the Princess Louisa and Hardwicke, tell us their reasons for coming here were, that several of their Men were down with the Scurvey.

We find the Captains of the other Ships had orders in case they did not arrive here by the last of August they were to proceed directly to the Bay, no doubt the Captains of the Durrington and Cæsar have the like orders, and all circumstances consider'd it is very probable they may be both too late to call here in that case you will please to open the Packets directed to this Place, and what Lead, Iron or Broad Cloth is consigned to us We beleive it will be more for the Company's Interest, that they should be disposed of with you, than to be at the Expence of sending them hither, We say the same with regard to any other Goods that may be consign'd to Us, except such as you shall beleive are intended for Garrison Stores, Those We desire you will send hither if possible, being very bare here of many things which are necessary, We do not know whether you will find upon either of those Ships any Gun Flints, if there be, you will please to send them to us, but otherwise as We have very few here, We desire you will supply Us with as many as you can spare out of Your own store.

By the Jenny We sent Y^r. Hon^r. & C^t. a Letter from the Deputy Governour & Council of Fort Marlborough relating to your Dispatching the Hardwicke from Bengall without sending Her to the West Coast, We wrote Your Honour & C^t. something concerning the same in our last and the Company having sent us copy of the 52^d. & 53^d. Paragraph's of their Letters to Your Presidency by the Princess Louisa, Hardwicke & Durrington, We take it, that you are thereby at Liberty to determine with relation to the Hardwicke as you shall judge will be most for their Interest.

It is proper here that we should advise your Honour &c^t. what Quantity of Bales We expect to have ready in the Month of Dec^r. and by the best Calculate We can make We reckon We shall then have two thousand two hundred 2200 Bales, which at Five Bales & one third $5\frac{1}{3}$ to a Ton, is somewhat more than Four hundred Tons, which we shall be able to fill up here. We desire you will acquaint the Captains of such ships as you send hither that they must expect no Saltpetre here & therefore whatever they think necessary to make their ships sailworthy they must take with you; The Wilmington having no Iron Kintlage has taken in here, One hundred & Eighty 180 Tons of petre and the Captain thinks she will go out at a very moderate draught of Water, and as these draughts will reduce our store to a small Quantity We desire you will supply us with as much more as you can spare for a stock against next season.

Inclos'd is our Warehousekeeper's Indent for Packing Stuff, which We desire you will supply us with as opportunitys offer.

The Hardwicke fell in company with the Bedford off the Cape the 5th. of last Month; This last left S^c. Helena the 5th. June and from thence We are advised the following ships were arrived.

The Shaftesbury arriv'd S^c. Helena the 29th. April, but as the Normanton was not there the 5th. June, We are under some uneasiness about her; All we can hope is, That she went into the Cape and as the Captain might be Advised of a War in Europe He would probably resolve to go home with the Dutch Fleet.

This comes by our Hoible Masters ship Princess Louisa, on which We have laden Eighty thousand 80000 Rupees and some Redwood as ¶ Invoice and Bill of Lading inclos'd.

We have coined here Eighty Chests of Bullion into Madrass Rupees, which We compute to be about one third of what is consign'd to you directly or would otherwise have been sent you from hence including therein what may be on board the Durrington and Cæsar which upon its arrival you will also keep with you. We have not coined any of the Silver into Arcot Rupees as We did not think it prudent to trust it in the Country Mints.

As this settlement will be in great want of Madeira Wine, We desire you will send by the Europe Ships what you may find consign'd to Us, also Ten Chaldron of Coales or more if you can spare them.

We expect some soldiers for this place on the Durrington & Cæsar which we desire may be sent us in December, being in great want of Europeans both here and at Fort S^c. We have not sent you any Timber or Plank by this Conveyance, because you have not sent us the Dimensions which you ought not to have omitted, nor can we set about the Gun Carriages till we know the size of Your Guns: We observe in your account Remains you have fifty four Iron and seven Brass Guns, let us know in your next Letter where they are Mounted.

We congratulate Your Hon^r. &c^t. on the Quiet your Province was in after the revolution in the Subahship, and We wish [we] could tell you there was any settle-ment that could be depended on of the Government of this Province; Nazar Jung has sent some marks of his favour to Subder Ally Cawn the late Nabob's son, but they are not such as give him any positive assurance of being continued in the Govern-ment, at the same time He is still deficient in the sum promised to the Morattas who yet continue so near us that the country is often alarm'd by their Motions.

We have read over the Deputy Governour's Paper deliver'd to your Board relating to the Disturbances occasion'd by the Disputes between the Right and Left hand casts. The behaviour of Vencatatchalum and his Robberies in this country, and the Murder of the Woman of the Right Hand cast at Cuddalore, and have Read also all the other] Papers, and shall now give you our opinion and directions thereupon as to the Woman who lost her Life We make no doubt from the several affidavids taken before the Deputy Governour Her Death was occasion'd by some blow, she receiv'd from some of the Left Hand Cast in a riot at Cuddalore, but as it is not plain, who the particular Persons were that gave her those Blows [however we] thought fit to order and direct, That a Fine be Levied from the whole Left hand cast of Five hundred 500 Pagodas, for it appears to us this Riot was in consequence of the first dispute in which it is confessed they were the first aggressours, We hope also this will be looked upon as some satisfaction to the Right Hand cast and render it more easy for you to accommodate the remaining differences, which subsist between them.

As to the behaviour of Vencatatchalum if it be as the Deputy Governour has represented it and what is set forth in the attestations taken before him, the most regular Method is to complain thereof to the Hovildars or other Gov^{rs}. of those parts of the Country, where He was guilty of the same, and to represent to them His Robberies and other behaviour, & if they will not punish him & take effectual measures to prevent the like in future, you shall look upon yourselves at liberty to take your own Measures.

Our Secretary wrote you yesterday by our order for the cost of the cloths you have sent hither on your runnin[g] contract & you must lose no time in complying therewith. We are

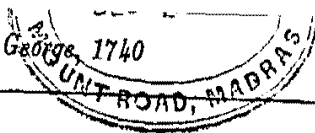

The George arrived with us the 16th. July, by her We received your Letter of the 9th. June and the 22^d. ultimo came in the Sloop Carolina with yours of the 11th. August to both which We shall reply by the George in J[*a*]nuary and at present only give answer to some Paragraphs as may more immediately require it.

Your Letter addressed to the President and Council of Fort William We forwarded thither soon after the receipt but as yet We are unacquainted with their determination in regard to your proposal to them of sending the ship directly from thence to Europe which might be designed you. If we are rightly inform'd they will have a large stock of Goods on hand and will be well able to provide for her, that We are of opinion they will readily come into it, the ships name is the Hardwicke, Captain John Hallet she arrived here the 20th. August and proceeded in a few days after for Bengall.

We observe that the Marlborough was disappointed of her full lading of Pepper at [Benjar] after having spent so considerable a Time [to so] little purpose, We hope the Duke will meet with [better success].

From what you wrote us by the [. . .] concerning the People of the 8 Dusans and your [having] enter'd into agreements with them so late, as in April, for their faithfull adherence [to the] Honourable Company We could little have expected they would so soon have given proofs of their Treachery, We are very sensible that S[*i*]dee Ibrahim who is at the head of them and to whom they are bigotted has for many years been wickedly inclined and has waited for an opportunity to put in execution his villainous purposes nor do We suppose he has wanted abettors, We are well pleased to find his secret Practices were so early discover'd and the Troubles they might have occasion'd so happily prevented, and since by this Accident, those People are removed from that part of the Country, who in no time can be said to have been well affected to the Interest of our Honourable Masters, We would recommend to you (as it is also near Marlborough) to have it repeopled with Persons from whom you may expect at least more sincerity & better service and let such Dupattys be appointed over them in whom you can place some confidence in order to make that part of the Country beneficial to the Honourable Company, and to preserve it in Tranquility.

If Sidee Ibrahim should return We would have you use Your utmost endeavours to destroy him and on no Account admit him to any Pardon for such repeated acts of Treachery [de]mand a [just re] sentment and we cannot [. . .]

good Policy to harbour [. . .], as to the People ma [. . .] drawn [away] by the in [. . .] deserve some lenity, and concerning them we shall only further say that as the 8 Dusans have always been looked upon as one clan, We think it will be most prudent to divide such as may be permitted to return in several other Parts of the Country, by which means they will be less able to enter into any Combinations prejudicial to the general Welfare and time may perhaps wear out or at least lessen their attachment which they have to each other.

As the Country has for several years been in peace We hope by your care and prudent management it will continue so and be yearly improving, it is not to be doubted that the increase of the Pepper Trade will raise the Jealousy of your neighbours, not that there will be wanting Instruments to increase and foment Divisions and disturbances, whose faith is held in so little Esteem, nevertheless We apprehend such agents will be able to make but little impression on the Bulk of the People as they well know their Interest is inseperable from the Companys.

Such part of Y^r. Indent as We could procure, We now send you by this ship, the George will bring You the remainder.

We also send you nineteen Topasses and eighteen Arabs to whom We have a[ward]ed two Months pay commencing the [. . .] obliged to keep the [. . .] Months as we have for [. . .] appointed of Listing any [. . .] Dispatching a ship to your Place several of them being marr[ied having] requested leave to carry their Wives [with then] to which We have consented in expectation [that] it may encourage them to stay with you [the] longer and save the charge of frequent Recruiting and of their Passage over they have [asked] to serve three years and We hope they [would] be of use to you being all able body'd Men. There comes likewise William Richardson E[nsign] who arrived here the 8^h. April 1738.

In case you are able to return this ship Princess Augusta soon after her arrival you must give the Captain orders to proceed directly hither, but should the services of your coast detain him with you so long as that in his return he ought to make this Coast to the Southward of Fort St. David you must then order him [to c]all in there to take in what Bales [the Deputy] Gov^r. & Council there may have [ready to] put aboard.

We shall now acquaint you that our Honourable Masters are pleased to write us that contracting with the Merchants is not the only thing necessary, they should be well looked after that they comply with their Engagements & that at the close of the year an Account must be drawn out in proper Columns wherein is to be inserted the number of Pieces of each sort contracted for with the value, what Money has been advanced and what number of Pieces have been brought in with their value, you must comply with this as near as you can & send us such account to go home in the Packets by our January Ships they are also pleased to write us that your [. . .] the same as the Salem but sold lower about two Shillings a piece [for] each number, that therefore endeavours should be used to get it cheaper: They observe that by what passed between you and us We both were sensible of its Inferiority so that the prices being alike surprized them: Here follows Copy of their 31st. Paragraph dated the 21st. of March last, We observe "with concern that our Servants at Fort S^t. David complain of a want of Merchants having " [but . . .] only engaged in our Investment. It would [give] great pleasure to " Us could some means be found out to engage a number of substantial Men to " reside within our Bounds, We are apt to think that it might be brought about by " granting them some Particular priviledges with respect to their several Casts, " which they are generally so fond of and at the same time are not detrimental to Us. " We recommend this affair to your particular and serious consideration. We are " told that Indigo may be cultivated at Fort S^t. David you will do well to make a " Tryal."

We have said in answer thereto that We should correspond with you concerning the Engaging a number of substantial Merchants to res[ide] within your bounds, and if that could be effected We thought it would not be difficult to engage them in the Company's business in the present method but We beleive it would too dangerous an Experiment to attempt it by [e]ndulging any of them with any particular Priviledges with respect to their Casts [for] both sides were too tenacious of their Rights [that we] apprehended the Trou[bles between the costs this year] [appear . . .] from one of the Company's Merchants [. . .] too much upon the privileges of the [. . .]. If you can point out to us any other Method that will answer the End proposed by the Company you will let us know it as soon as possible.

Concerning the Indigo we have said that it is the Growth of this South Coast, that a great deal is planted here and at Fort S^t. David on such Grounds as are too high to sow paddy on, & that in January we shall send some of the Different sorts for a Tryal. We would have you therefore purchase a Candy of three or four sorts, but that the freight may be the easier We beleive the higher prized to be the most acceptable if it be good in proportion.

Having some dispute with our Merch^{ts}. here relating to the cost of their cloth bought at Salem We would have you send us up as soon as possible copy of the accounts deliver'd in by Your Merchants of the cost of their specifying therein, the First cost whether they pay any Brokerage or only keep servants there; What Juncans they pay and how much at each place, what they charge for Oxen hire or other Land carriage; in fine as full and particular an account as you can give us of the First cost and all the different Charges till it is in Your Godowns.

M^r. Borlace Stacey Writer took his Passage to your place on the Sloop Carolina; He arrived here the 18th. August on the Colchester, and has been p^d. his salary here to the 25th. September with his Diet Money & allowances for the month of September.

We have permitted M^r. Henry Powny to stay here, his salary must be paid with you to the 25th. September & [his] other allowances to the 30th.

The Richard arrived here the 17th. of last Month and brought us yours of the 4th. together with Invoice and Bill of Lading for 136 B^s. of Calicoes upon which you must charge no more than the Accustomary Freight agreeable to what We wrote you the 27th. June, that Letter with an [ad]ditional one, under the same Date We intended you by Peons overland, but a Vessel being to sail for your place in few days they chose to go by sea & by the same Vessel namely the Brigantine Vencatashea Somanah Naquedah, our Secretary wrote you a short Letter dated the 4th. July to accompany Invoice and Bill of Lading for Wares sent you on her amounting to Pag^r. 930. . 8. 72 but as that Vessel was not arrived with you the 4th. September nor have we heard of her elsewhere upon the Coast we now send you the Duplicate of the Letters & Papers by Her.

Our Honourable Masters complain of the small Investment made at Vizagapat^m. in 1738 which the say will not defray a Factor's charge much less the Expence of a Settlement & that affairs must take a new turn there or We must [think] of withdrawing it: It is true Your Inve[stm]ent was larger last year, and We hope will increase this, but still it is so small that the Charges of the Settlement are very heavy upon it, and besides those, if We only add the Batta on the Madrass Pagodas (which [of] those last sent you was 11 $\frac{1}{2}$ Cent) to the [price] of your Cloth, it comes out more in proportion than what We buy this way.

We wrote you the 30th. August [by the] George, which ship We are told by some [of the] Northern Merchants was arrived with [you] but have received no advice from you or from the Gentlemen at Ingeram & Maddepollam how they propose to send their cloth up [. . .] in December and as the season is [. . .] orders that [. . .] George [. . .] River, Which We [. . .] in our Letter by her should be so soon as [the] new Moon in December is over, you [must] send her to Ingeram to take in what Clo[th] M^r. Prince has ready there; the Jenny th[. . .] in your River may bring up yours & [should] reckon M^r. Goddards vessel is at Mad[depollam] & will bring up [whatever] cloth he has. We say [you] reckon she is at [. . .] not been here but if he has no vessel the[re] ready to take in his cloth We hope you [will] be able to supply [him] with some proper convey[ance] that you may send him from Vizagapatam.

We have before advised You of the arrival of the Princess of Wales and Wilmington the Princess Louisa came in here the 12th. August, the Heathcote the 15th. the Colchester the 18th. & the Hardwicke the 30th. It is somewhat late to tell you this now, but We should not have faild to have done it sooner, if they had brought us advice of any material alteration in the State of Affairs [i]n Europe. Besides as the ships for you side were [on] their departure when these came out, We concluded some of them would be with you before any Letters from hence. The Durrington arrived here the 24th.
