Message from the Director

Gokhale Institute of Politics and Economics (GIPE) was established in 1930 by the Late Rao Bahadur R.R. Kale, M.L.C., as a centre for higher learning and research in Economics in remembrance of the great Indian nationalist leader Shri Gopal Krishna Gokhale. The Servants of India Society are the Managing Trustees of the Institute. The Institute has since then evolved into a premier centre of advanced study in Economics. Several faculty members and alumni of the Institute have distinguished themselves nationally and internationally as academicians, policy-makers and consultants.

Gokhale Institute of Politics and Economics has been widely recognized for its pioneering contributions in the subjects of Rural Development, Co-operation, Poverty Alleviation, Employment Guarantee, Crop Insurance, Planning, Federal Finance, Input-Output Economics, Agricultural Development, Irrigation and Demography and in several other areas related to the social and economic problems of India.

The excellence of GIPE as an institute of higher learning in Economics has been recognized both in India and abroad. The Reserve Bank of India, Ford Foundation, Planning Commission and Kamalnayan Bajaj Foundation have each instituted Chairs for distinguished faculties in Finance,

International Economics, Planning and Development, and Industrial Economics respectively at the Institute.

Although primarily a research Institute, GIPE is also renowned for its robust teaching programme leading to the award of M.A. and Ph.D. degrees in Economics, initially of University of Bombay and later of University of Pune. In 1993, the Institute was recognised by University Grants Commission as a Deemed to be University.

An important aspect of the Institute's evolution as a centre for higher learning and research in Economics is the increasingly inter-disciplinary approach to the subject. In accordance with this approach and to enhance its role as a Deemed to be University, the Institute launched two new Master's programmes in Financial Economics and Agribusiness Economics from July 2011. In addition, the Institute has considerably expanded its Ph.D. programme. The Institute has also initiated two student and faculty exchange programmes, one with the University of Goettingen and the other with a consortium of Canadian Universities under the Ontario-Maharashtra-Goa (OMG) initiative.

The Institute takes pleasure in presenting the Annual Report of its activities for the year 2012-2013.

About the Institute

Gokhale Institute of Politics and Economics is one of the oldest research and training institutes in Economics in the country. It was founded on 6th June 1930 with an endowment offered to the Servants of India Society by late Rao Bahadur R.R. Kale, Member of the Legislative Council from Satara. The Servants of India Society, founded by late Shri Gopal Krishna Gokhale, are the Trustees of the Institute. The Institute is registered under the Societies Registration Act, 1860, and the Bombay Public Trusts Act, 1950.

The object of the Institute has been to conduct research into the economic and political problems of India and to train research workers in these subjects. Under the pioneering leadership of late Professor D.R. Gadgil, its first Director, the Institute set the highest standards for quality research, teaching and training in various branches of Economics.

Keeping in view the eminence of the faculty, the contribution the Institute has made in teaching, training and research in economics, availability of physical infrastructure and potential of the Institute, the Government of India, on the advice of University Grants Commission, awarded the Institute the status of a Deemed to be University on May 9, 1993, the birth anniversary of late Shri Gopal Krishna Gokhale after whom the Institute is named.

Research

The main thrust areas of the Institute, which have developed over the years through financial assistance from various sources, are agricultural economics and rural development, population studies, input-output studies for planning and development, microeconomics, macroeconomics, monetary economics and finance, public economics and international economics.

Various ministries and public funding agencies, including the Government of Maharashtra and private foundations such as Sir Dorabjee Tata Trust financed research activities at the Institute in its early years. Subsequently, in 1954, the Union Ministry of Food and Agriculture established, and has supported since then, the Agro-Economic Research Centre of the Institute. During the early fifties, the Rockefeller Foundation made a substantial grant, spread over several years, for the conduct of a research programme in rural demography. By the time this grant period came to an end, the Union Ministry of Health, which had given grants for conducting some specific demographic studies in 1954-57, decided in 1964 to strengthen and expand the research work on population by financing, on a continuing basis, a Population Research Centre as an integral part of the Institute. Foundation gave very generous financial assistance for more than a decade beginning in the year 1956. Later, the Foundation, in collaboration with the Planning Commission, provided a separate grant for research and training in the areas of planning and

development, mainly devoted to input-output studies. The Planning Commission has also given an endowment grant to the Institute to establish a chair and a unit for promoting teaching, research and informed debate on all issues relating to Planning and Development. The above-mentioned chair is named the 'Professor D.R. Gadgil Chair of Planning and Development'.

In 1962, the University Grants Commission recognised the Institute as a Centre of Advanced Study in Agricultural Economics, and later, in 1964 as a Centre of Advanced Study in Economics. In 1977 the UGC, as part of its Area Studies Programme, established a Centre of Study of the Economies of East European Countries. In the same year, the Reserve Bank of India instituted a Chair of Finance. In 1989, the Ford Foundation gave a generous endowment grant to fund a Chair and to establish a section in International Economics to carry out research activities in international economics and related subjects. This grant also included support for the post of a Librarian and for acquisition of books and journals. Similarly, in 2005, the Kamalnayan Bajaj Trust gave a generous grant to fund a Chair of Economics.

The University Grants Commission, New Delhi, has sanctioned the Centre for Study of Social Exclusion and Inclusive Policy (CSSE&IP) in 2008 to carry out research and teaching in the areas of social exclusion, discrimination and inclusive policy.



Teaching

The Institute was initially affiliated to the University of Bombay, conducting the M.A. Programme in Economics and supervising the work of students working towards research degrees of that University. In 1949, with the establishment of the University of Poona, the Institute became a constituent recognised institute of the new University. Till 1993 the Institute functioned, for all academic purposes, as the Department of Economics of this University. With the decision of the University to establish a separate Department of Economics at its campus, the Institute, as a Centre of Advanced Study in Economics, was granted effective autonomy in 1986 in designing courses, teaching and examination of the M.A. degree in

Economics. As stated earlier, the Institute has been granted the status of a Deemed to be University by the Government of India with effect from May 9, 1993. The Institute now awards its own M.A. and Ph.D. degrees in Economics. After acquiring the new status, the syllabi of the courses offered at the Institute were thoroughly revised on the basis of the recommendations of a committee constituted for the purpose. Courses in the M.A. programmes of the Institute are being regularly updated on the recommendations of Board of Studies and Academic Council. At present the Institute offers three post-graduate programmes, viz., M.A. (Economics), M.A. (Financial Economics) and M.A. (Agribusiness Economics).

Training

In April 1989 the University Grants Commission selected the Institute and extended assistance to it for conducting refresher courses in Economics for in-service university and college teachers from the western region of the country. In 1994, a year after the grant of Deemed to be University status to the Institute, the UGC

extended the catchment area of the Institute for its refresher courses to the entire country. Since the inception of this scheme by the UGC, the Institute has been conducting UGC sponsored refresher courses for university and college teachers as well as workshops for government servants and others from across the country from time to time.

Research Centres at the Institute

The Institute has three research centres established by the Central Government and University Grant Commission.

Agro-Economic Research Centre (AERC)

The Agro-Economic Research Centre (AERC) Pune was established by the Union Ministry of Food and Agriculture in 1954. It has been an integral part of the Institute since its inception.

In 1962, on the basis of the quality and extent of work done by GIPE, its professional reputation, its contribution to research in agricultural economics and its potential for further development, the University Grants Commission selected the Institute as a Centre of Advanced Study in Agricultural Economics. Two years later the field of study of the Centre was expanded and it was redesignated as the Centre for Advanced Study in Economics.

The Centre also conducts studies allotted to the Institute by various agencies such as the Government of Maharashtra, NABARD and Planning Commission, Government of India.

The AERC has completed about 160 studies since its inception. Its activities cover Farm Business Surveys, studies related to Irrigation, Watershed Management, Rural Electrification, Village Surveys, Rural Credit, Agricultural Tenancy, Co-operation, Droughts and Famines, Crop Insurance, Agricultural Marketing, Agricultural Exports, Poverty Alleviation, etc.

A large number of these studies have made significant contributions to the field of agricultural economics and agricultural development of the country. These studies have been widely recognized by policy-makers and academicians and serve as benchmarks of excellence in their respective fields.

Population Research Centre (PRC)

Population Studies at the Institute predate the formulation of population policy, establishment of the family planning programme by the Government of India and founding of Population Research Centres. The Institute has played a pioneering role in conducting demographic surveys in India.

A demographic survey of Kolhapur city in 1945 made a lasting contribution towards evolving and establishing a standardized methodology of demographic surveys. A research centre in demography was set up at the Institute in 1949. This was the first of its kind in the country. The Union Ministry of Health and Family Welfare had given grants to the Institute for conducting specific studies during 1954-57. In 1964, the Ministry decided to strengthen and extend the research work on population by establishing a Demographic Research Centre as a part of the Institute. In 1978-79, in pursuance of the recommendations of the Demography Advisory Committee, the Centre was re-designated as a Population Research Centre for the State of Maharashtra. It has earned the distinction of being included in the category of 'fully

developed' centres according to the norms of the Ministry of Health and Family Welfare.

In the fifties, when no information on demographic issues was available, the Centre conducted demographic surveys and contributed in a major way to the area of survey methodology. After the launch of the family planning programme at the official level, the Centre contributed by actively participating in the implementation of the sterilisation programme and by undertaking communication-cum-action studies. Evaluation of the after-effects of vasectomy camps and acceptance of the loop as an IUD gave valuable inputs about the methods of family planning.

Various dimensions of the family planning programme at its different stages, starting with its communication methods and including several of its other aspects such as compulsion during the Emergency, adoption of spacing methods, maternal and child health, withdrawal of the targets, RCH approach of the programme, RTI/STI, client satisfaction and unwanted pregnancies have been studied by the Centre. The work of NGOs in the

field of family welfare has also been evaluated. In recent years, evaluation of the sterilisation bed reservation scheme, functioning of family welfare training institutions, ultrasound sonography centres and urban health posts has been carried out.

In the area of data collection, the Institute has independently carried out or participated in major surveys in 1980s and 1990s (NFMS, 1980; NFHS, 1992-93; and RCH Baseline Survey, 1998). Apart from evaluative and fact-finding surveys, many analytical studies are carried out. Recently a study on the cost of health care in public hospitals in

Maharashtra was completed. The Centre has just completed two rounds of a World Bank-sponsored research study on the quality of health care (client and provider satisfaction) in India/Maharashtra. The demography of India's tribal population is another recently completed research project. Currently, the Centre is involved in activities related to the strengthening of the Health Management Information System (HMIS), a new initiative of the Ministry to collect the district and facility level health data on a monthly basis.


Centre for the Study of Social Exclusion and Inclusive Policy (CSSE&IP)

CSSE&IP is a multi-disciplinary research centre established by the UGC in the year 2008 (as part of the UGC XI Plan) to carry out research and teaching in the areas of social exclusion, discrimination and inclusive policy. Its key objective is to conceptualize and define problems

related to discrimination, exclusion and inclusion based on caste, ethnicity and religion. It focuses on developing an understanding of the nature and dynamics of exclusion and discrimination at both theoretical and empirical levels.

Besides these three centres, the Institute also houses four prestigious Chair Professorships, viz.,

- 1. RBI Chair Professor of Finance for research and teaching in Monetary and Financial Economics (funded by Reserve Bank of India)
- 2. D.R. Gadgil Chair Professor of Planning and Development (funded by Planning Commission of India)

Seminars/Conferences/Workshops Organised at the Institute

During the academic year 2012-2013, the Institute organized seminars and workshops, details of which are as under:

1. XXXIV Annual Conference of the Indian Association for the Study of Population (IASP), December 13-15, 2012

The XXXIV Annual Conference of the IASP was held at the Institute during December 13-15, 2012. The staff of the Population Research Centre was instrumental in hosting the conference at the Institute. Dr. R. Nagarajan, Associate Professor, PRC, acted as the Local Organizing Secretary. About 200 participants representing universities, research institutions, Population Research Centres, NGOs, international donor agencies and government officials participated in the conference.

This conference comprised the inaugural session, two plenary sessions on thematic areas, parallel sessions for paper presentation, poster presentation, paper presentation competition for young demographers for the prestigious Dr. C. Chandrasekaran Award, General Body meeting of the Association, and valedictory session.

About 80 research papers were presented in various technical sessions. The authors included established demographers to young Ph.D. scholars. Most of the papers pertained to fertility, RCH, Health Status, Ageing and Migration. A few papers also dealt with methodological issues, programme evaluation and policy implications. Most papers utilized the available and recent data from Census, NFHS, DLHS, NSSO, IHDS and other sources. A few papers were based on micro level studies carried out in rural and urban areas. Three poster sessions were conducted as a part of this conference. About 60 posters were presented in these sessions, mostly by Ph.D. scholars.

The conference provided an opportunity for interaction among demographers, social scientists, programme managers and NGOs to deliberate upon various issues concerning population, health, gender and development. It also provided an ideal platform for young demographers and research scholars to present their findings to a wider audience to seek

suggestions. The conference was supported by contributions from UNFPA, UNICEF, ICRW, Asian Population Association, Central Statistical Organization, IIPS and Institute.

2. National Level Workshop on Koha – Library Management System

The Library of the Institute organised a national level workshop on "Library Automation using KOHA Open Source Software" from 30th Jun to 01st July, 2012. Resource Persons, Dr Sunita Barve (NCL, Pune), Dr Nanaji Shewale (Librarian, GIPE) and Mr Pramod Joshi (Information Scientist, GIPE) gave hands on training to the participants. 35 participants including one international participant, and GIPE library staff members attended the workshop. The workshop which was organised with a view to impart training on Koha (Open Source Integrate Library Management System) included installation and actual working on different modules of Library operations such as Acquisition, Cataloguing, Circulation, Serials Control, Opac and System Administration.

3. National Level Workshop on Drupal 7 – Content Management System

The Library of the institute organised a National level workshop on "Drupal 7: An Open Source Content Management System" on October, 26th-28th 2012. Resource Persons for the workshop were Dr Sunita Barve (NCL, Pune), Dr Nanaji Shewale (Librarian, GIPE), Mr Pramod Joshi (Information Scientist, GIPE) and expert from the IT industry. The workshop was attended by more than 30 participants from different parts of the country. Purpose of the workshop was to enrich the knowledge of the Library and Information Science professionals in the field of Content Management Systems. The participants were given hands on training on Drupal Installation, Setup and Configuration, Drupal Architecture, Drupal Themes, Modules, Blocks & Nodes, Drupal Core & Contributed Modules, etc.

4. 26th National Conference on Agricultural Marketing organized by Indian Society of Agricultural Marketing and GIPE, December 20-22, 2012.

The 26th National Conference on Agricultural Marketing was organized jointly by Indian Society of Agricultural Marketing and the Institute from 20th to 22nd December, 2012. It was attended by academicians and policymakers who presented their research findings in the Technical Sessions. The three themes discussed in the conference were (1) Rural Credit for globalizing farmers, (2) Price Policy and Agricultural Marketing Development (3) Export Potential of Agri-Commodities in India. The conference was inaugurated by Prof V.S. Vyas, Member, Prime Minister's Economic Advisory Council and Deputy Chairman, State Planning Board, Rajasthan. Prof V.M. Rao (formerly Professor at Institute of Social and Economic Change, Bangalore) delivered the presidential address titled "Price Support for

farmers: A Perspective from the Crossroads". In addition there was a Panel Discussion on "Recent Initiatives in Market Reforms: Issues, Challenges, Opportunities and the Way Forward.". A panel of experts discussed the potential of recent reforms in transforming agricultural marketing and bringing about benefits to farmers and consumers.

A special lecture on "Agriculture Marketing in Changing Scenario" was delivered by Shri Umesh Chandra Sarangi, IAS, Retd. and former Chairman NABARD. The Parthasarthy Memorial Lecture was delivered by Prof R.S. Deshpande, Director, ISEC. Shri Narayan Hegde, former President, BAIF, delivered a lecture at the Plenary Session.

The recommendations emerging out of the papers that were discussed in the technical sessions were presented by the chairpersons of the respective themes so that useful policy issues could be addressed to strengthen agricultural marketing.



Library Services

The Institute shares the Servants of India Society's Dhananjayarao Gadgil Library and has been mainly responsible for its development during the last eight decades. It is considered to be one of the foremost specialised libraries in India in the fields of Economics and related social sciences. It has 2,73,356 books and 373 journals and serials received on subscription, exchange, gift, and depository basis. It has completed its automation programme and is Web OPAC linked from the Institute's website.

GIPE Library started the digitisation work in Dec 2010 and till date more than 8000 books have been digitised. In collaboration with ISEC, Bangalore, the library has digitised more than 500 books during this year. All the digitised books are made accessible to scholars around the world through the Institutional Repository https://dspace.gipe.ac.in.

The library had initiated the process of bar-coding and pasting spine labels on books. By March 2013, the process was completed for the entire library collection.


With a view to keep the users abreast about new addition of books/journals to the Library and the contents of the newly received journals, the library publishes 1) monthly list of new additions and 2) fortnightly list of articles on India.

During the academic year 2012-2013, the Library subscribed to 373 periodicals which included 191 Indian journals and 182 foreign journals. The details are given below:

The Computer Centre

The Statistical Department

The statistical department helps the statistical research team at GIPE, which assists faculty members, researchers and students with data analysis.

The Computer Centre housed in the Statistical Department is well-equipped with hardware and software to support the research, teaching and training programmes of the Institute. A one-year Certificate Course on Computer Applications for Economic Analysis has been introduced for the past and present M.A. and Ph.D. students of the Institute to complement the training in Economics received by them at the Institute. The students are equipped with the latest analysis/analytical tools such as STATA, EVIEWS, SPSS, MATHEMATICA, etc., in a

specially designed certificate course which adds value and insight to theoretical learning.

In the computer laboratory, students have access to the Internet both for reference work and for communication. The most up-to-date resources for these purposes are at hand as the Institute subscribes to superior resource websites such as Britannica, JSTOR, Indiastat, Springer Link, etc.

Consultancy and guidance services in data processing in collaboration with the Indian Council of Social Science Research

In the Computer Section facilities for data processing are available to researchers. The Institute offers consultancy and guidance services in data processing in collaboration with the Indian Council of Social Science Research.



Publications

Since March 1959, the Institute has been regularly publishing a quarterly journal of Economics in English, Artha Vijnana. This journal publishes results of research work carried out in the Instituteas well as works of scholars from outside the Institute after a rigorous refereeing process. The journal achieved an important milestone in 2008 by completing its 50th year of continuous publishing. To celebrate the occasion, the Institute

published a Golden Jubilee Special Issue of the Journal (Vol. 50, No. 4, December 2008). The Institute also publishes research works in the form of working papers, books and mimeograph series. The R.B.R.R. Kale Memorial Lecture, organised by the Institute every year on the occasion of the Founder's Day, is published under the Kale Memorial Lecture Series.



Staff Quarters and Hostels


Student Activities


