## PREFACE.

THIS volume is revised under the directions contained in Punjab Government letter No. 2279-Rev., dated the 14th June 1928, and under the instructions received from the Director of Land Records in his letter No. 2112—1-29, dated 30th August 1928. Every effort has been made to collect figures for all tables. The figures for table No. 2 are not available as no meteorological laboratory exists in this district and table No. 9 has been omitted under Director of Land Records' letter quoted above. The Migration figures relating to the census of 1931 for table No. 8 also could not be had as no information was supplied by the Census Superintendent in his report. The prescribed uniformity has duly been observed.
