A NOTE ON STEAM PLOUGHING

SECTION I.

INTRODUCTION.

1. (a) In writing the following note on ploughing tackles, an endeavour has been made to state the general case in favour of their adoption in Bombay Presidency.

(b) Also to state the particulars of each system so that they may be compared, and that it will be possible for interested parties with little knowledge of these tackles to find which sort of tackle is most likely to suit their conditions. The subject is a complex one, varying not only with the style of plant adopted, but with all the many factors which go to form the conditions of working.

(c) The estimates and statements of advantages and disadvantages of each system are therefore necessarily only approximations, but they have been carefully considered and calculated, and are sufficiently accurate for purposes of comparison.

(d) I have tried to give answers to all the queries put to me by enquirers in the past and to anticipate other points which are likely to arise.

(e) It is not claimed that the opinions expressed are proved and positive facts.

They are merely the expressions of the writer's own convictions, formed after two years of careful consideration and investigation of all the facts within his reach in India and England, and after receiving the opinions of people with many years of practical experience in the working of power ploughing plants.

(f) All the estimates are based on figures supplied by Messrs. J. Fowler & Co., Ltd., of Leeds and Bombay, who are the oldest established and biggest firm manufacturing all such plants.

(g) Other firms have also been consulted, but I should prefer to deal with Messrs. Fowler, not only because they have longer experience, and make more varieties of implements than other firms, but also, and chiefly, because they have a branch in Bombay with expert men of long experience in charge, and are thus able to deal with all matters on the spot.

(h) I believe they are the only firm of steam plough and implement manufacturers with a direct branch in India.

(i) This very important subject of steam ploughing is beginning to excite a good deal of interest in India generally, and in this Presidency; and in the last two years I have received enquiries, and requests for estimates, from eleven large land owners who are considering the purchase of plants: but enormous areas need ploughing, which belong to cultivators whose holdings are too small for the individual owners to be able to contemplate the purchase of these expensive tackles.

EXPLANATION OF SYSTEMS OF PLOUGHING.

1. (a) In order to make the note intelligible to those with no previous knowledge of the subject, it is necessary to explain briefly the various systems on which power ploughing is done.

They may be classified in five principal systems as under :---

Page 3.—System I.—Direct traction implements.

A brief description and a sketch of each system is given.

Description of System No. I—Direct Traction.

This is the simplest (but not the most efficient) system of all.

The plant consists only of one ordinary traction engine with wide driving wheels and the plough or other implement to be used.

The engine propels itself to the field to be ploughed, the plough is attached by strong chains behind the engine, and it then works backwards and forwards across the field drawing the plough behind it.

At the end of the furrow the engine is steered round and returns across the field ploughing another furrow.

Or in some cases the engine goes round and round in ever increasing circles starting at the centre of the field.

Thus in all cases the engine has to travel over every foot of land ploughed.

No sketch is necessary to explain this.

Description of System No. II-Double Engine System.

This is the best and most efficient system in almost all conditions.

The plant consists of two similar self-moving ploughing engines, each fitted with special powerful winding drums, on which are coiled strong steel cables.

The plough used is a double ended implement with two sets of plough-shares, for working in either direction. When working in one direction the plough-shares for use in the other direction are raised up clear of the ground.

When the plough reaches the end of the furrows these shares are lowered automatically to the ground and the others, which had been working, are at the same time raised out of the ground.

The plough can then be pulled back in the opposite direction ploughing the next furrow.

These ploughs are known as balance (or anti-balance) ploughs.

To work the plough one engine moves to a headland on one side of the field, and the other engine to another headland on the opposite side of the field, the two engines stopping opposite one another, at any distance apart up to about 400 to 600 yards or less.

The cable from one engine is attached to one end of the plough, and the cable of the other engine to the other end of the plough.

On starting work the plough will be near one engine and 400 yards away from the other.


The distant engine begins to haul in its cable thus drawing the plough towards it, the other engine at the same time allowing its cable to be drawn off the drum by the plough.

When the plough reaches the distant engine, the latter stops winding the cable and the other engine begins to pull.

This reverses the plough as explained and it is steered by the ploughman into the next furrow (or set of furrows) as the other engine begins to pull. While one engine is pulling, the other engine (which is paying out rope) moves forward on the headland to the required position for the next furrows, so that the pull on the plough is always in a straight line.

ARRIGGETURAL ENGINEER. BENBAY, POONA This is the whole system of working and is perfectly simple.

The sketch attached illustrates it.

When the field is completed the engines move to opposite ends of the *same* headland and plough both headlands in this manner before leaving the work.

On shifting to another field the cables are disconnected from the plough, one engine draws the plough behind it (on road wheels) and moves to the new headland, the other engine also going to its new headland.

As soon as the cables are again hooked on to the plough they are ready to commence work.

Thus no time is wasted and the engines do not have to travel over the land to be ploughed but remain on the headlands.

Description of System No. III.—Round-about system with one traction engine fitted with double winding drums.

This is the next best system to the Double Engine system where deep ploughing is needed.

The plant consists of one self-moving ploughing engine fitted with special powerful double winding drums, on which are coiled strong steel cables. The drums when working wind the ropes in opposite directions, that is to say, one rope is being hauled in, while the other is being payed out.

The plough used is a balance (or anti-balance) plough for working in either direction, similar to that described in System II.

In addition to this there is a heavy self-moving automatic anchor. (System IIIa) or two of these anchors (System IIIb). See sketches.

Also one fixed corner anchor, and a number of rope porters or guides.

The method of working is as follows : --

System IIIa.-Triangular Arrangement. (See Sketch IIIa).

The engine moves on to one end of a headland, the movable anchor having first been moved either by the engine or by cattle to an opposite position on the other headland.

The fixed corner anchor is taken and fixed at the other end of the headland on which the movable anchor is fixed.


The longer of the two cables is now unwound from the engine and is carried round the pulleys of the fixed anchor and the movable anchor, and fastened to one end of the plough.

The other cable is then fastened direct to the other end of the plough.

At starting, the plough will be near the engine.

The engine, therefore, begins to haul on the long cable which goes round the anchors, at the same time paying out the short cable.

This draws the plough away from the engine and towards the movable anchor.

The movable anchor rests on wheels having deep discs which sink into the ground and offer the necessary resistance to the pull of the rope, and is fitted with tynes which prevent any movement along the headland until they are lifted by the rope.

As soon as the plough reaches this anchor, the tynes are automatically lifted, and as long as the engine continues to pull on the rope, the anchor will move sideways along the headland.

If the headland is crooked the anchor will need a man to steer it.

The anchor having now moved into position for the next but one furrow, the engine ceases to haul, moves forward opposite the next furrow, the gearing is reversed, and the engine again begins to work, this time hauling on the short rope and paying out the long one.

This reverses the action of the plough and draws it towards the engine.

Having reached the engine, the latter is again stopped, the plough is reversed, the engine reversed and hauling is resumed on the long rope, as at first, the ploughman steering so as to make a straight furrow in a direct line to the anchor.

This is the whole cycle of operations. When engine and anchor have reached the far end of their headlands, that is, as far as the fixed corner anchor, the tackle has then to be shifted and the fixed and movable anchors set in another position for the next field.

The system is, of course, much more troublesome than the double engine system.

System No. IIIb.—Rectangular Arrangement. (See Sketch IIIb).

This is another method of arranging the tackle, by means of which the engine need not move along the headland at all, but remains stationary in the corner of the field.

Two movable anchors are used, set opposite one another on each headland.

The engine stops at the other end of one headland, and the fixed corner anchor at the other end of the other headland.

The long cable now passes round the corner anchor and one movable anchor and is attached to one end of the plough.

The short rope passes round the other movable anchor and is attached to the other end of the plough.

By working the winding drums in alternate opposite directions, the plough is pulled to and fro between the two movable anchors, which move automatically as explained at the completion of each furrow.

I cannot see any advantage in this arrangement, and it requires two movable anchors, instead of only one, and a longer cable.

Also the pull on the plough is always indirect.

With either the triangular or rectangular arrangement of this system it is difficult and slow work to plough the headland after the completion of the field.



Description of System No. IV.—Round-about system with Portable engine and separate windlass.

In this system all the machinery has to be hauled into position for work by cattle.

The plant consists of one ordinary portable engine, one double drum windlass, two automatic movable anchors, two claw anchors, and one fixed corner anchor with rope porters to support the cable over rises in the ground.

The plant works with the same cycle of operations as the rectangular arrangement of System No. III.

The double drum windlass is connected to the engine in one of two methods, namely, either by a universal driving joint or by pulleys and belts.

If the former method is used the engine and windlass need not be set in very careful alignment with one another, as the universal joint allows for inaccuracy, but on the other hand results in heavy waste of power, and strain and wear on the joints. If a belt and pulleys are used for driving the windlass, the engine and windlass must be set in accurate alignment and level with one another, and at exactly the right distance apart.

Otherwise the belt will run off the pulleys and will slip.

To do this accurate setting in soft land would be a very lengthy and almost impossible task.

Also the weight of the engine, windlass, and movable anchors is great and it would be very difficult to shift them with cattle.

Cannot be recommended.

System No. V.—Bullock gear windlass system.

The plant consists of two similar windlasses, each fitted with gearing and poles for working with two pairs of bullocks.

Each windlass runs on a short section of rails on the headland.

A stout steel cable is wound on each windlass.

The windlasses are placed on opposite headlands and the cable of each is attached to one end of a balance plough, which is drawn to and fro between the windlasses in the same way as on the double engine system.

While one windlass is pulling the other is running free and allowing the cable to be drawn off it by the plough, as the pulling windlass draws it towards the other side of the field.

When the plough reaches one windlass, the plough is reversed and the other windlass begins to pull while the first one pays out the rope.

While paying out rope this windlass is moved forwards on its rails into position for ploughing the next return furrow.


The system is as simple and reliable as the double engine system, but is very slow and expensive, as the bullocks of one windlass are always standing idle while the other windlass is pulling.

When it is desired to move to another field, the windlasses are fitted with road wheels and hauled by the bullocks.

FAVOURABLE CONDITIONS FOR STEAM PLOUGHING.

2. (a) The general conditions under which cultivation by power is desirable may be briefly stated as follows :---

(1) Where deep ploughing is needed.

(2) Where large areas have to be dealt with.

(3) Where secondary operations are needed at once after deep ploughing.

(4) Where power cultivation is cheaper than other methods or does better work.

(5) Where cattle or manual labour is insufficient in any case to do the work otherwise.

(b) The successful use of such tackles depends mainly on good business organisation, competent mechanical handling, and supervision, and the collection of charges from the cultivators within a reasonable time.

REASONS FOR A GOVERNMENT DEMONSTRATION.

3. (a) When a plant has once been demonstrated as a paying concern, I do not think that a business company or syndicate will have any difficulty in meeting these difficulties or conditions, but for a private firm to start the initial enterprize would probably be very difficult.

(b) In the case of a Government owned plant the facts would be quite different.

The Agricultural Department has a large trained staff in the mofussil with a thorough knowledge of the districts, and of the land suitable for ploughing.

(c) They also possess considerable influence with the cultivators and a Government owned venture would at once inspire confidence among the people and make them willing to try the innovation.

This has already been proved by the amount of land offered for ploughing in the Ránnibennur Táluka. (See later.)

(d) The Agricultural Engineer, in association with Messrs. Fowler, could supervise the mechanical work and staff, and the collection of charges could be greatly simplified by the advance of tagavi loans to the cultivators to pay for the ploughing. These loans could be paid direct to the Government ploughing department and thus make certain of payment.

(e) There is thus every essential for the success of a Government owned plant, whereas a private plant would be looked at with suspicion (until proved) and the owners at first would probably have great difficulty in collecting their charges.

• (f) If through such difficulties, or through bad management, the first plant purchased proved a failure, it would probably ruin the owners, and, still worse, would almost certainly prevent or postpone for many years any further experiment.

(g) It is for these reasons that I strongly urge the advisibility and necessity of the purchase of a demonstration plant by Government.

After proving it successful, I believe there would be no difficulty in disposing of it (if so desired) to private owners.

(h) In support of the latter view I may mention that I am now corresponding with a gentleman in the Kolar Gold Fields, who wishes to do 400 acres of deep ploughing each year, besides secondary operations, and the levelling and terracing of land.

Such an owner would probably be glad to take over a successful plant at a reasonable price. There must be numbers of similar cases.

CULTIVATION OF LAND IN BOMBAY PRESIDENCY.

4. (a) The better cultivation of land is one of the most important subjects claiming the attention of agriculturists in India today.

(b) The very heavy soils met with in so many parts of this Presidency, and the deep cultivation necessary for sugarcane, garden crops, etc., offer almost insuperable difficulties, to the ploughing and subsequent treatment of the land, by cattle drawn implements.

(c) It is also well known that the number of cattle available for such work is much below that necessary to cultivate all the land which might be used to produce such profitable crops.

(d) But perhaps the most important work of all for which power drawn implements could be used, and for which cattle are useless, is the clearing and cleaning of open lands infested with that pest of agriculture—the deep-rooted hariali grass. (e) Besides this, these engines will do deep ditching for draining fields, and are capable of making open ditches 3 feet wide and 2 feet deep at a single operation; or mole drains at a depth of 3 feet.

(f) They can also do land levelling by drawing earth with special implements from the high to the low lands, work now done very slowly and laboriously by hand or cattle.

(g) They can also drive threshing machines, cane-crushers, pumps or any machinery when desired, and can draw heavy loads of produce, or timber and materials, to station or market at two or three miles per hour.

(h) Thus on a big estate work could probably be found to keep the engines going almost all the year round, instead of for only six months on ploughing, as shown in estimates.

Every additional day the plant can be worked, reduces the daily proportion of charges for interest and depreciation, which in the estimate amount to 30 per cent. of the total cost of working. The depreciation does not decrease in regular proportion to the days worked, as the plant is depreciating when standing idle for long periods.

THE ERADICATION OF HARIALI GRASS.

5. (a) To eradicate the hariali grass it is necessary to turn up the soil to a depth of at least 16 inches, and in the heavy soils in which this grass flourishes, it is quite impossible to plough to such a depth with direct cattle drawn implements.

The only way in which the cultivator can rid himself of it at present is by hand digging, an extremely laborious and expensive method.

The cost of this method, when thoroughly done to a depth of 16 inches, amounts to as much as Rs. 75 per acre, and for less effective shallow work to a depth of only 9 or 10 inches comes to about Rs. 40 (forty) per acre. (See page 71, Annual Report of the Dhárwár Agricultural Station for 1910-11.)

(b) There are hundreds of thousands of acres of excellent cultivable soil in the Deccan and Southern Marátha Country, which are rendered quite or almost useless by this hariáli grass. It will be shown later that it has been carefully estimated that this land could be thoroughly ploughed to a depth of 16 to 18 inches at a cost of about Rs. 15 per acre.

(c) Assuming for the moment that these figures are correct, it can be seen at once from the following figures that enormous advantage would ensue to the owners of such lands.

Large tracts of these hariáli infested lands lie in the Dhárwár, Sholápur and Ahmednagar Districts.

By thoroughly cleaning such lands their value is found to be increased by from 75 per cent. to 100 per cent. according to their condition, locality, etc.

(d) The Deputy Director of Agriculture informs me that in the Dhárwar District alone there are over 600,000 acres of land under cotton, of which more than half is on dirty land infested with hariali, needing deep ploughing, for which he is convinced the people would willingly pay Rs. 20 to Rs. 30 per acre.

(e) In estimates Nos. IIa and IIb given at the end of this note the double engine plant is shown as being able to plough about 1,000 acres per season.

(f) Thus in the Dhárwár District alone there would be sufficient of this cleaning work only, to keep 15 such sets going for 20 years.

There need be no fear therefore of being unable to find sufficient work for the first experimental set which may be purchased, and already in two villages of the Ránnibennur Táluka 850 acres have been offered for ploughing at a tentative rate of Rs. 20 per acre.

(g) It should be clear from the above remarks and from the estimates to follow, that there is a wide and useful field for the employment of such tackles, and it is generally admitted that any further considerable improvement in the Agricultural conditions of the Presidency, both as regards better cultivation of lands now under cultivation, and particularly bringing into cultivation present waste lands, depends chiefly on the ability to do deeper, more thorough, and quicker preparation of the land.

(h) From the first it was assumed that ploughing to 16 inches depth would successfully eradicate hariali, but in order to prove this beyond doubt, a demonstration has been made this year at the suggestion of the Director of Agriculture.

A very badly infested area of 13 acres, looking like a grass field, was selected at Dhárwár and was ploughed 14 inches to 16 inches deep with the Bajac plough.

The work was started in January and finished in April and by beginning of April the first part ploughed had weathered down so well that the owner began to cross plough and harrow with country implements in preparation of seeding.

The hariali was not removed by hand in any way.

A crop of potatoes was sown in June, and in August after some very heavy rain, which rather water-logged other fields, the crop was looking remarkably well, in contrast to the surrounding similar crops which had suffered from insufficient drainage, due to shallow cultivation.

At the same time the hariali was practically extinct, and the owner is delighted with the results.

Only occasional single blades of grass are to be found and the owner estimates that they can all be removed by hand at a cost of Re. 1 per acre.

SECONDARY OPERATIONS AFTER PLOUGHING.

6. (a) Deep ploughing for sugarcane has already been mentioned.

A very important point to consider in connection with deep ploughing, is the difficulty of conducting further operations to produce good tilth for seed beds on the very rough ploughed land.

(b) For sugarcane cultivation as at present done by indigenous methods, ploughing is done to a depth of not more than 12 to 14 inches and this only with great difficulty and by the use of a large team of bullocks, as many as four or five pairs of bullocks being frequently yoked to one plough. When this has been done the land is allowed to lie fallow for some time, and the weather will break down the heavy clods to a certain extent; but even after this, it is difficult for the bullocks to get across the rough land with the implements for the preparation of the land to take the seed, and such work is very damaging to the animals.

(c) All such secondary operations can be performed with ease by means of the steam tackle, at any time that may be convenient, if necessary, immediately after the ploughing.

COMPARISON OF SUGAR CULTIVATION IN INDIA AND THE HAWAIAN ISLANDS.

7. (a) In this connection the following figures recently given to me by Messrs. Fowler are of great interest.

I cannot vouch for these figures, but I do not doubt their approximate accuracy.

The figures for India have been verified.

(b) Sugarcane cultivation in the Hawaian Islands-

Average yield of sugar per acre 4 to 5 tons.

" ploughing 16 inches deep.

Maximum yield of sugar per acre 15 tons.

" ploughing 30 inches deep.

(c) Sugarcane cultivation in India—

Average yield of sugar (or gul equivalent) per acre $1\frac{1}{2}$ ton.

Average ploughing 10 inches deep.

Maximum yield of sugar (or gul equivalent) per acre (Poona District) $4\frac{1}{3}$ tons.

Maximum ploughing 14 inches deep.

The latter figures are given to me by Mr. Main, Deputy Director of Agriculture.

These comparisons speak for themselves and need no comment to point the lesson.

INVESTIGATION BY THE WRITER IN INDIA AND ENGLAND.

8. (a) I realized the importance of this matter as soon as I first had to consider it, some two years ago, and have done my best to collect reliable information and statistics about it.

(b) When on three months' privilege leave last autumn I spent about five weeks touring round England (at my own cost) to see different ploughing plants at work, and I corresponded with, and interviewed, various owners and makers of these plants to obtain statistics of work done and cost of plants.

PLANTS INSPECTED IN ENGLAND.

9. (a) I inspected plants at work at Leeds (Yorkshire), Gainsborough (Lincoln), Witham (Essex), Reading (Bucks), Chichester, (Sussex), Bosham (Sussex), and Portsmouth (Sussex).

Those seen at Gainsborough and Witham were direct traction oil motor tackles being tested. All the other plants were steam of the double engine system.

(b) I saw ploughing, cultivating, and harrowing operations in progress.

At one estate near Reading the engines were cultivating; stubble land of heavy dry soil to a depth of 10 inches with a 13 tyne cultivator covering 8 feet width and travelling at 7 miles per hour.

The land had never previously been ploughed to a greater depth than 8 inches.

After the first operation the fields were again cross-cultivated to break down the clods.

Then after weathering, a light horse harrow would do all that was necessary to prepare an excellent seed bed.

About 40 acres were being done per day of 14 hours and the owner of the plant was making a profitable business by hiring out the plant.

(c) At another place I saw sloping meadow land being broken for cultivation with a 6 furrow plough working to a depth of 6 inches.

This plough was travelling at 4 miles per hour and was ploughing 18 acres per day of 12 hours.

These figures will illustrate the kind of work being done in England by such tackles.

Very little deep ploughing is done in England as the crops grown, and the rainfall obtained, make it unnecessary.

PLOUGHING IN GERMANY.

10. (a) In Germany, however, where a great deal of beet sugar is grown there are some hundreds of sets of tackle at work.

(nearly all of the doubles engine system) ploughing to depths up to 16 inches.

(b) As an example of what is done there I quote from the report of Fr. Thomas, a steam plough contractor at Dalldorf, Prussia, who gives the following figures for his plant for the year 1908. Working from the middle of August to the end of November, in 86 working days, an area of 2,969 acres was ploughed to a depth of 35 c.m., equal to $13\frac{3}{4}$ inches or an *average* rate of $34\frac{1}{2}$ acres per day. This was in heavy beet land after a season of very severe drought.

The plant was a double, engine tackle of the largest size (140 I. H. P.) and was nine years old.

The figures for the previous eight years were as follows :---

These figures are most exceptional however and, I believe, are claimed to constitute a record for such work.

STEAM PLANTS NOW AT WORK IN INDIA.

11. (a) Unfortunately very few statistics of actual working results *in India* under similar conditions to those prevailing in this Presidency are available.

I have only heard of three such plants working in India.

(b) One of these is in Behar where it is giving excellent results although the plant is 30 years old and in very bad order.

It is a set of double engine tackle, but the boilers are at present being worked at only 70 lbs. per square inch instead of at 125 lbs. per square inch owing to their having become old and weak. The conditions, however, are quite different to those in this Presidency as the soil of Behar is sandy and the engines are being used only with a cultivator and not for ploughing. Here however with this very old tackle they are cultivating to a depth of 8 inches and do 15 acres in a nine hours working day.

The crops grown are sugar, indigo, etc.

(c) Another plant was recently in use at Katihar in Eastern, Bengal.

This consisted of an old 70 H. P. engine and was being used for ploughing by direct traction.

The results were not very satisfactory and the owners ordered a new set of 80 I. H. P. (K_5) double engine tackle (similar to that in estimates II*d* and *e*) for ploughing to a depth of 12 inches in sandy clay or stiffish loam.

This plant has now been at work for a month or two and is giving excellent results as below :—

The plant is ploughing to a depth of 14 inches in land covered with dense grass from 4 to 7 feet high, and in a working day of ten hours with only one set of men, is ploughing $7\frac{1}{2}$ acres per day.

It is expected that these figures will be somewhat exceeded when the men have become more proficient and accustomed to the tackle.

Note.-With the proposed Government plant I have estimated (estimate IIs and b) 8 acres ploughed per day of 14 working hours with two shifts of men to a depth of 16 inches.

(d) Another plant was purchased some few years ago by the Gwalior State, but, I understand, has not been very satisfactorily worked.

Unfortunately the State Durbar seems reluctant to give information on the subject, but, so far as I can ascertain, the original plant was a powerful set of double engine tackle.

It was used for drawing a heavy implement known as a 5 tyne knifer over very rough unbroken land covered with large stones and tree roots.

The plant seems to have been worked very rashly and was constantly breaking its cables owing to the knifer catching under big roots and the engine not being stopped in time, and also due to the use of cheap ropes.

As they only require to turn up the ground to a depth of about 8 inches and the land is fairly open and level, they have now purchased another set of engines for direct traction and have been recommended to convert the original set to direct traction.

With this system strong chains can be used to attach the plough to the engine and the engine driver will be able to see whenever he approaches a big root and have time to stop his engine, or the engine would only be pulled up, owing to its wheels being unable to grip sufficiently.

For work of this description under these conditions the direct traction system is the best, particularly with careless management as accidents are less likely.

I understand that with the original plant, when not broken, they were turning up ground covered with roots and stones, to a depth of 11 inches at the rate of 8 acres per day of 9 hours.

STEAM PLANT FOR PUNJAB GOVERNMENT.

12. (a) Another plant is about to be ordered by the Punjab Government for land reclamation work in the Alkaline lands of the Chenab Colony.

It is proposed to do mole draining and ditching with this plant.

As mole drains should only be made in one direction, it has been decided to use only a single engine for the purpose.

This engine will be stationary at one end of the field and draw the plough towards itself with a double purchase cable.

The plough will then be drawn back to the other end of the field by cattle and again pulled forward at the next position by the engine.

The plant consists of—

One K5 Compound engine with winding drums.

One mole draining plough weighing 2 tons.

One ditching plough to make trenches in one operation 2 feet deep, 1 foot wide at bottom, and 3 feet wide at top, weighing 3 tons.

Cost of plant Rs. 21,950.

The Punjab Government has sanctioned Rs. 40,000 for the experiment.

This work could also be done by the proposed Bombay Government plant if desired.

GENERAL REMARKS.

13. (a) Although the statistics available in India are so scanty, there are thousands of sets of these tackles at work in Europe, and the Colonies, and every case investigated shows that very much more work has been actually done, than has been assumed in the estimates below.

The latter have purposely been kept very low, so as to be on the safe side.

It is hoped that Government will arrange to purchase one set of double engine tackle as per estimate No. 11 and this is recommended primarily for use in the eradication of hariali in the Dhárwar or Sholápur Tracts.

If many further sets are eventually purchased by Government or by private enterprize, as I am confident they will be, there remain many other directions in which they can be most usefully employed, and where cattle are almost or quite useless.

(b) Granted competent business-like management, I do not think there is the slightest doubt of being able to make a steam plant a very profitable business enterprise, and assuming this view to be correct, it is evident that the benefit to agriculture would be immense.

This is a development of improved methods which, if successful, would at once mark a new epoch in the cultivation of the lands of the Presidency, and the prosperity of its agricultural classes.

SECTION II.—THE MACHINERY.

SELECTION OF POWER.

1. (a) The power for ploughing may be supplied either by a steam engine or a petrol or paraffin engine of the portable or traction type.

(b) Traction engines are almost essential for this work as will be shown later, so that this type only need be considered here.

(c) In Europe and the Colonies—particularly in Canada and also in the United States—the internal combustion motor has found a very considerable opening in this class of work, chiefly owing to local conditions and its cheapness, but for India it cannot be recommended.

(d) The oil-motor traction engine, if kept in thoroughly good order, will do very good work, but the large amount of vibration and dust to which traction engines, used for cultivation, are subjected, tends very quickly to throw the oil-motor out of adjustment, and continual attention is necessary.

Oil traction engines are also much more tricky to handle than steam traction engines, and in India there are very few men capable of running such machines satisfactorily.

(e) The steam traction engine on the other hand has many less parts liable to give trouble, its power is much more elastic, and it is easy to find men in India, trained in the use of steam engines, who could run the engines without difficulty.

CAPITAL COST AND WORK DONE PER DAY.

2. (a) Estimates of cost of plant and of working expenses for each of the first four systems are given, in each case taking engines of the same power, so that a fair comparison may be made. The estimates of cost of plant are approximate only, but are sufficiently accurate for comparison.

The estimates for the bullock geared implements are taken from actual experience with the Bajac plough now being used in the Dharwar District.

The estimates of area ploughed per day are based as far as possible on figures of actual work done by different ploughing tackles in all parts of the world and, where actual similar conditions are not available, on the careful estimation of Messrs. J. Fowler & Co. who have have had 50 years' experience in making and working such plants.

It is believed that these estimates of area ploughed are in all cases on the safe side and would probably be exceeded in actual work.

WORKING EXPENSES AND SEASON ASSUMED.

3. (a) In estimating yearly working expenses and total acreage ploughed for systems I and II, a working season of six months has been assumed (November to April inclusive), out of which 50 days are allowed for shifting tackle from field to field or village to village, for holidays, and for days when plant may be idle for repairs or other reasons.

This leaves 130 working days per season. The Deputy Director and I have gone into the matter carefully and believe this is a safe estimate, but is not likely to be much exceeded.

(b) For system III a further deduction of 10 days from the working season is made to cover the time which will be spent in collecting the anchors, porters, snatch blocks, etc., and resetting them around the area to be ploughed at the commencement and finish of each area ploughed.

This work would be done by the engine itself for quickness and ease.

(c) For system IV a further deduction of 20 days from the 130 days working season is made to cover the time spent in shifting the portable engine, the heavy windlass, the anchors, porters, and snatch blocks, and resetting them at a fresh area.

All this work must be done by the cattle and would prove almost impossible.

It is extremely doubtful whether the deduction made is sufficient, but as the system is not recommended, the accuracy of the estimate is not of great importance.

(d) For system V a working season of six months is assumed from which a deduction of 30 days only is made for holidays, accidents and shifting tackle, leaving 150 working days.

In this time the tackle will only plough an area of 38 acres so that very little shifting will be needed.

With this plant ploughing by direct traction it would not be possible to plough to a depth of more than 8 inches to 9 inches in black cotton soil. At greater depths the wheels of the engine would slip and it would be unable to haul the plough. 50 per cent. to 60 per cent. of the power of the engine is needed to propel itself.

It is estimated that this engine would plough 8 acres per day of 14 hours with two shifts of men to a depth of 8 inches.

Taking 130 working days total acres ploughed equals 8 by 130 equals 1,040, acres.

Cost per acre equals $\frac{8,650}{1,040}$ equals Rs. 8/5 per acre.

NOTE:—The double engine tackle could plough about 20 acres to 25 acres per day to this depth (8 inches to 9 inches) and the cost per acre would therefore be (taking 20 acres per day and 130 days) Rs. $\frac{15,125}{2,600}$ equal to Rs. 5/13/0 per acre. See estimate II(e).

It is estimated that this tackle will plough in black cotton soil to a depth of 16 inches to 18 inches at the rate of 8 acres per day of 14 hours with two shifts of men.

Taking 130 working days equal to 1,040 acres ploughed : cost per acre equals $\frac{15,125}{1,940}$ equals Rs. 14-8-0 per acre.

Or to a depth of 8 inches to 9 inches would plough 20 to 25 acres per day. Say 20 acres.

Cost per acre equals $\frac{15,125}{2,000}$ equals Rs. 5-13-0 per acre. See Estimate Ie.

In the above estimate no allowance is made for the very heavy item of shifting engine, windlass and tackle from place to place by bullocks.

This is indeterminate and might be a very large sum if possible at all.

The above plant is quite impracticable for India and is only shown for comparison and to answer any possible suggestions which may be and have been made, for the use of such tackle.

It is estimated that the above tackle would plough about 4 acres per day to a depth of 16 inches to 18 inches in black cotton soil working 14 hours per day with 2 shifts of men.

Assuming 110 days ploughing, total acreage ploughed equals 110 by 4, equals 440 acres. Cost per acre equals 9,200/440 equals Rs. 20-14-0 per acre.

Neglecting cost of moving plant.

The weight of the engine in the above estimate is about 8 tons and it would be impossible to move this by cattle on soft land.

The only way in which this system is practicable is to use a small engine and tackle working much more slowly.

This small plant would be still less economical than the large one estimated above, as will be seen from estimates No.  $IV_f$  and  $IV_g$  below.

The system cannot be recommended at all.
