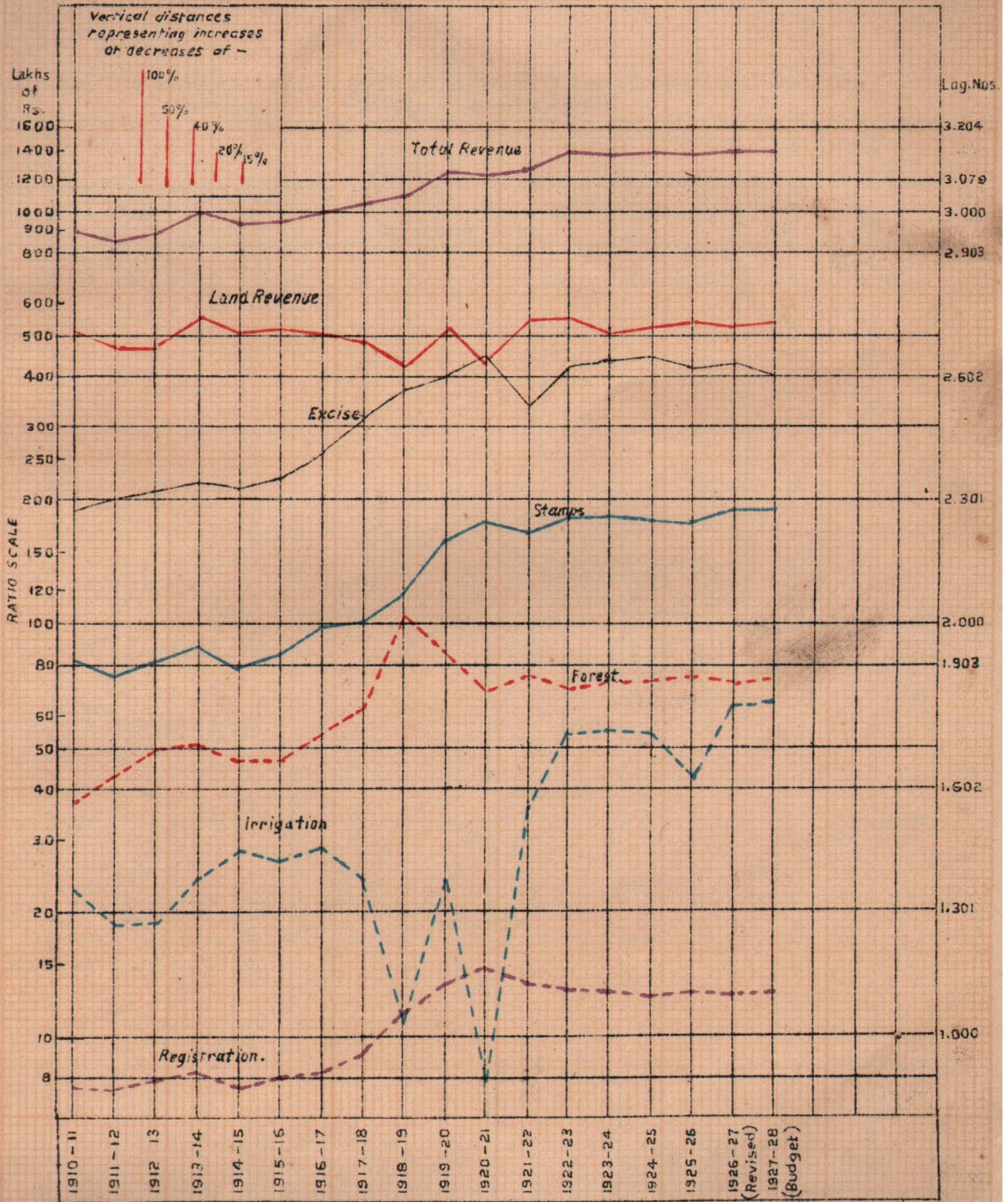

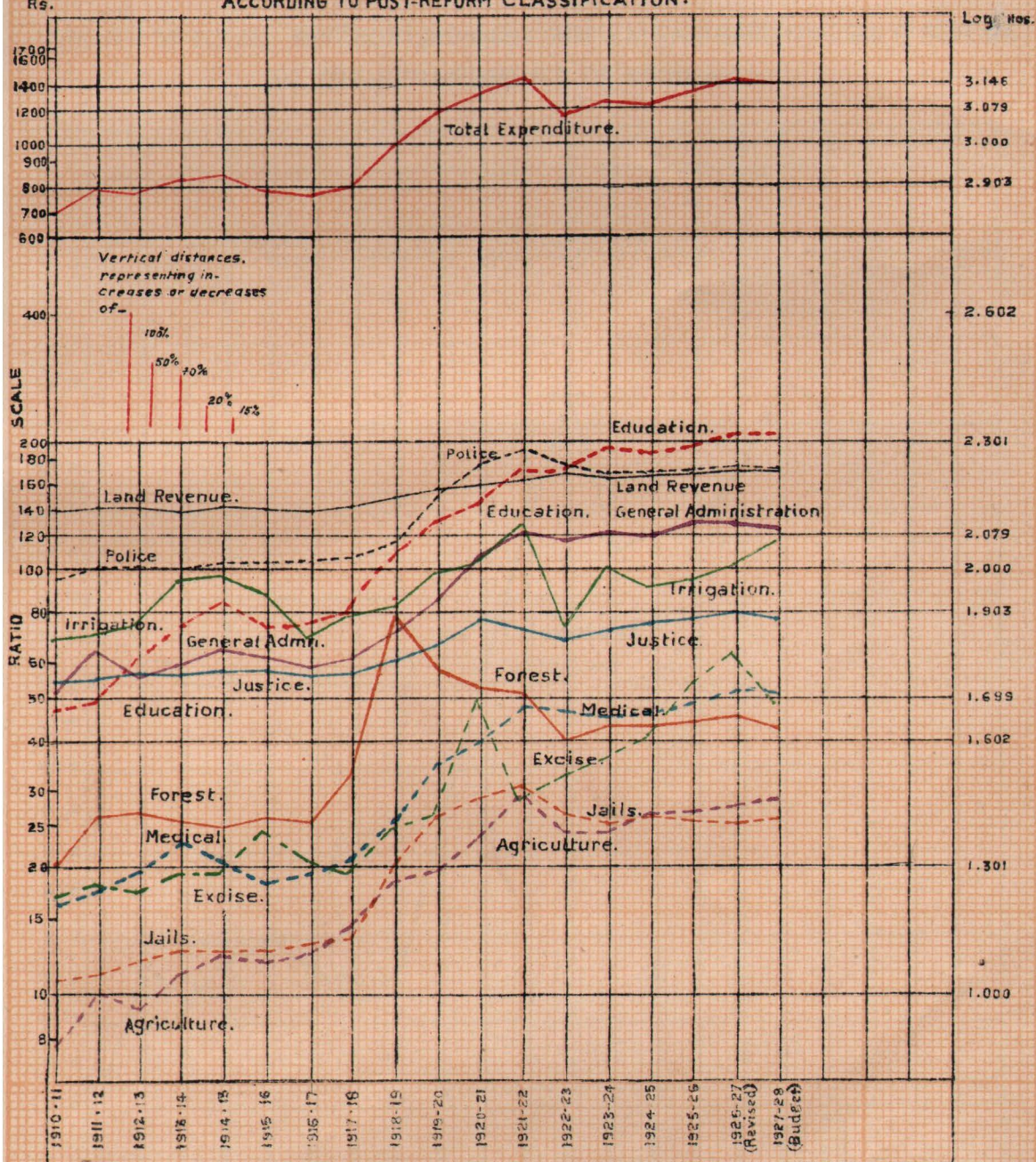

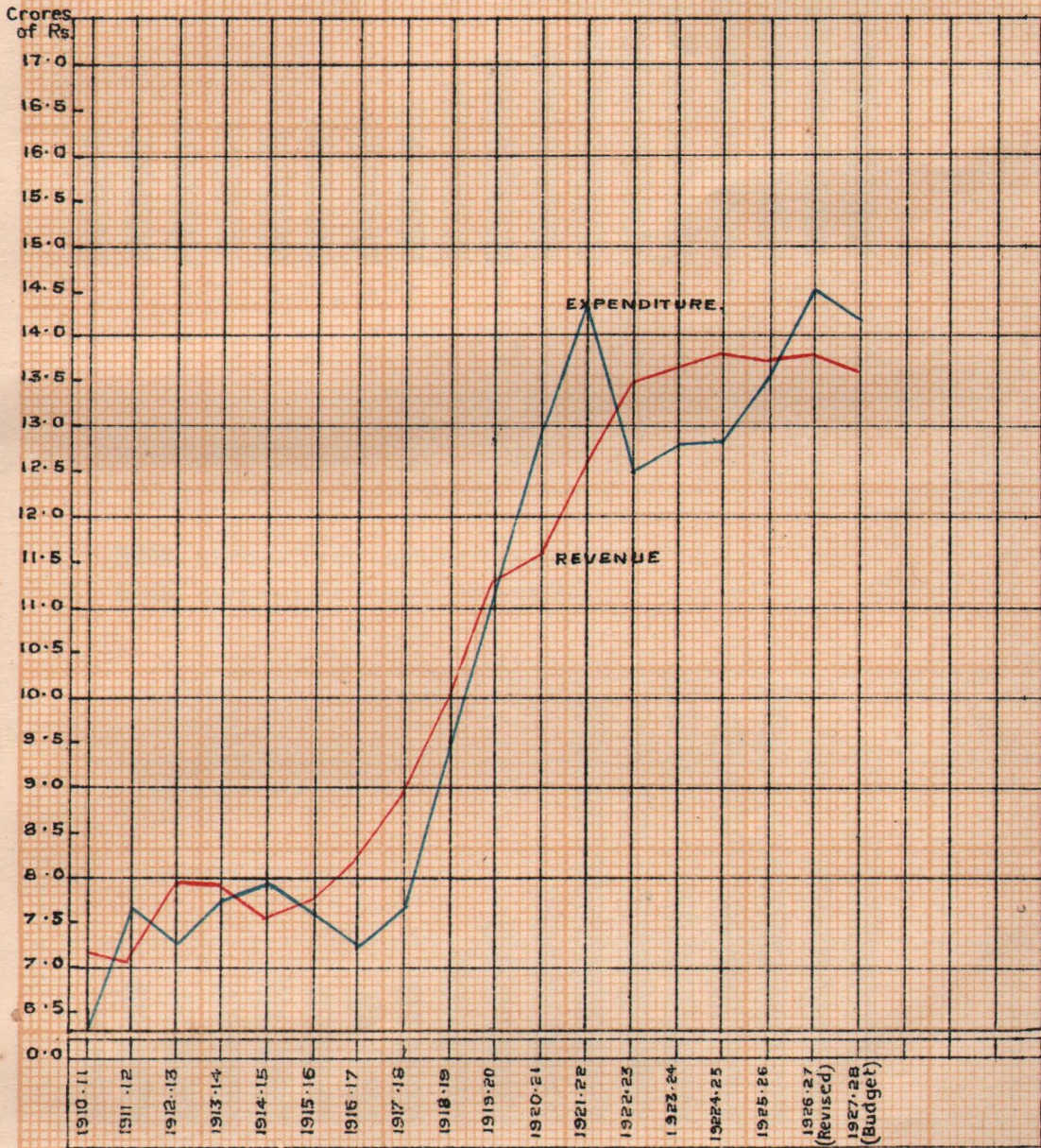

ACCORDING TO POST-REFORM CLASSIFICATION.



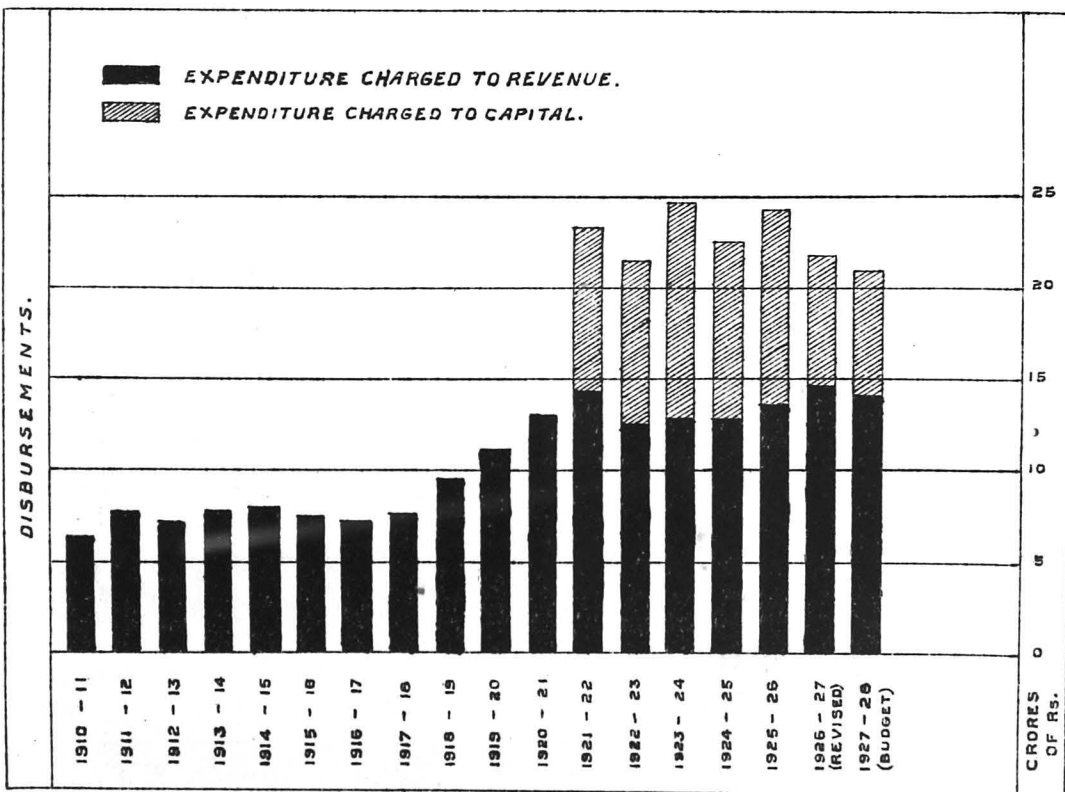
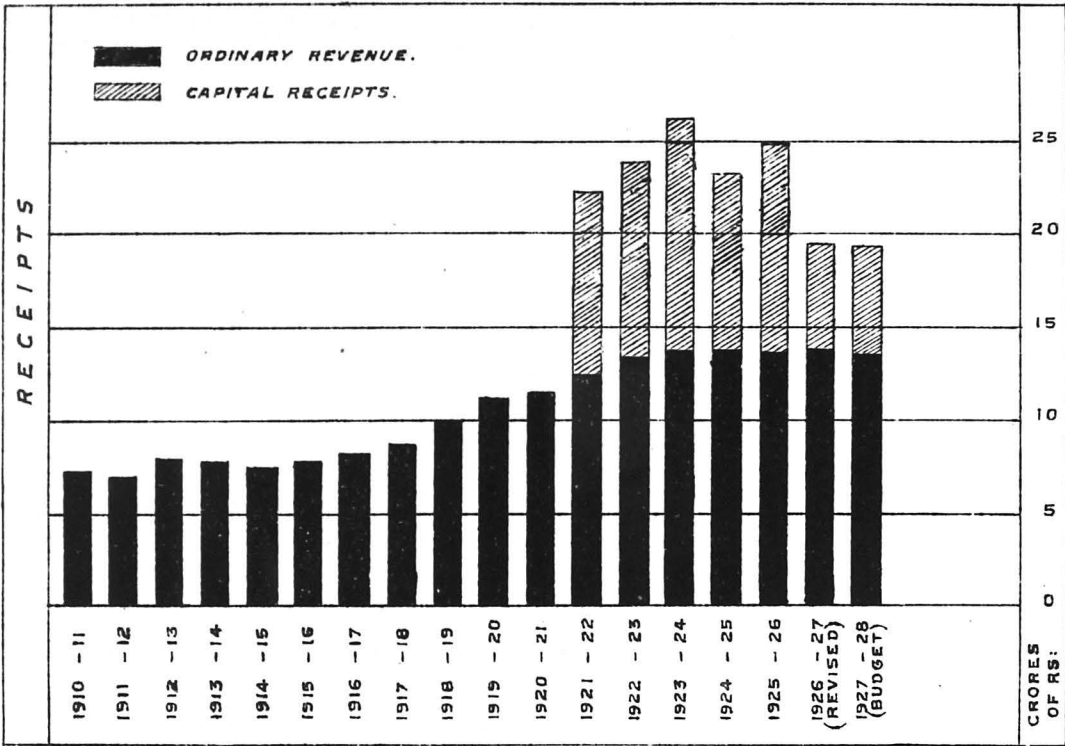

INTRODUCTORY NOTE

In last year's Blue Book I gave a detailed review of the provincial finances. It is unnecessary to repeat it, and I will comment very briefly on the main features of the year. For comparison I will give below the two statements A and B, which were shown in my statement last year, and bring them up-to-date.

It will be seen that the small deficit of 5 lakhs, which was anticipated in the Revised Estimates of 1925-26, has been converted into a small surplus of 9 lakhs. This improvement of 14 lakhs in the Revenue section of the accounts has been brought about by a net decrease of 34 in Expenditure in spite of a net decrease of

20 in Revenue. The details are as follow :—

The borrowed funds contained in our balances thus increased from 75 lakhs to 81 lakhs. The total increase in both Revenue and Capital sections amounts to 44 lakhs ; and the revised estimate of our closing balance for 1925-26 of nearly 619 went up to close on 664.

At the same time the closing balance of the Development Department which was put in the Revised White Book at 28 lakhs, has been raised to 70 lakhs. The reason for the increase is to be found in the restriction of the operations of the Department owing to pending inquiries.

Revised Estimates for 1926-27

On the basis of the 8 monthly figures the closing balance, which was estimated in the budget at 403, must be raised to 474. 44 lakhs of this is due, as I have explained, to the increase of 44 lakhs in the closing balance of 1925-26. The rest, *viz.*, about 26 lakhs, is the net result of an increase of 73 lakhs in the Capital section and an addition to the Revenue deficit of 47 lakhs. We budgetted in the current year for a deficit of 28 lakhs. This has now been converted into a deficit of 75 lakhs by a failure of revenues to the extent of 48 lakhs, against which we have a reduction of expenditure of 1 lakh. I give details of the main heads below :—

It will be seen that a number of these *plus* and *minus* items relate only to book transactions and cancel one another. It is possible that further reductions in expenditure will somewhat decrease the total deficit. The orders of Government restricting re-appropriations will only take effect in the last months of the year, and it is at present impossible to ascertain what savings will be obtained.

The closing balance of the Development Department as estimated in the revised 8 monthly estimates will amount to 49 instead of the 11 estimated in the budget for reasons similar to those I have given for the year 1925-26. This is in addition to the 4,74. The net result of these calculations is that our closing balance of 474 will contain 55 lakhs of borrowed money including savings from the amount lent to the Barrage from balances but excluding the Development balance which is all loan. I note briefly how this balance is disposed of :

238 will be the total sum in the Famine Insurance Fund :

55 is the saving in capital account and the remainder

181 lakhs is the balance available for use in the administration.

As much of it as possible will be placed in deposit with the Government of India and will earn interest. At present we have in deposit the following sums :—

1 crore for 1 year from 1st September 1926,
50 lakhs for 6 months from 1st December 1926,
and on account of the Development Department 40 lakhs for 1 year from 1st August 1926.

1927-28.

Opening with the ordinary balance of 474 we estimate total revenue receipts of 15,08 ; and we have budgeted for a total expenditure of 15,58 under the revenue heads. Under the Capital Account there will be a further net withdrawal from our balances of 54 lakhs of borrowed money so that our closing ordinary balance will be 370 of which 262 will be in the Famine Fund. In addition to the net balance of 108 we have what I may call the potential balance of the sum loaned to the Lloyd Barrage, which may be replaced by loan funds if the necessity arise.

The total of the demands against revenue has been reduced from 16,07 (the revised figure of the current year) to 15,58 ; and we expect to receive a total revenue of 15,08 as compared with the revised estimates of the current year of 15,32, the reduction being attributable to the head " Excise " under which in the current year we received considerable sums on account of the profit on liquor accruing from previous years. The reduction in demands has been distributed proportionally throughout the departments (with a few exceptions in favour of certain Transferred Departments).

The net result is a revenue deficit of 50 lakhs. It will be seen from the statement of new items that the demands of the departments have been severely cut down and only essential items admitted.

The Famine Fund.—At the beginning of the new year the fund will have reached the figure of 238 lakhs. In accordance with the expressed opinion of the Public Accounts Committee the Bombay Government have addressed the Government of India requesting that the annual contribution to the fund should be reduced from the figure of 63 lakhs to 33. Pending the arrival of the Secretary of State's orders on this application it is proposed to utilise a further 20 lakhs of the contribution in financing various irrigation works. The burden on the provincial revenues has been relieved to this extent. Meanwhile there is ample provision in the annual assignment for the continuation of the beneficent activities to which I referred in this note last year and to meet the demands of certain distressed tracts.

Development Department.—The provision made last year of 20 lakhs to meet interest and sinking fund on the sum of 3 crores, which was the estimated loss on the Back Bay Scheme has been repeated. In addition a further sum of 7½ lakhs has been provided from revenues to meet interest and sinking fund charges on the estimated loss of other schemes of the Development Department. This sum has been calculated actuarially as the amount required to extinguish a debt of 111 lakhs in 60 years, and will be utilised in payment of interest charges on loans taken by the Development Department from the Government of India.

Capital Expenditure excluding Development.—We intend to borrow during 1927-28 a total sum of 280 lakhs. The total loan programme amounts to 337 and the balance will be met from the savings in the current year's loan funds. Details will be found under the head " Disbursements ; Capital Account not charged to Revenue." 40 lakhs will be loaned to the Bombay Municipality as the last instalment of the loan sanctioned in the last year. Excluding this and with the exception of the very urgent works shown in the statement of new items, the entire sum is for works already in progress.

The only changes in the system of presenting the budget to which I have to draw attention are—

(i) the statement of new items sanctioned from savings during the year. These are no longer, strictly speaking, " new items " in respect of the budget for 1927-28, but have been included in this Blue Book in order to bring them prominently to the notice of the Legislative Council.

(ii) In accordance with the recommendations of the conference of Financial Representatives held at Delhi in 1925, a single grant will be asked for for expenditure in England, including the outlay of both the Secretary of State and High Commissioner, Reserved and Transferred subjects. It is understood that this procedure has now been adopted by all local Governments for reasons of practical convenience.

MEMORANDUM EXPLANATORY OF THE FIGURES UNDER EACH

II, Taxes on Income.

1. Under revised rule 15 of the Devolution Rules the whole cost of income-tax establishments is to be borne by the Central Government and the Provincial Government is to receive from the Central Revenues a sum calculated at the rate of three pies in the rupee on the amount by which the assessed income of the year is estimated to exceed the assessed income of the year 1920-21. It is unlikely that this Government will get anything on this account during the current and next years.

Revenue

2. *Revised Estimate, 1926-27.*—The season was on the whole favourable, but the decrease of 18,77 in the Revised as compared with the sanctioned estimate under “Ordinary Revenue and Miscellaneous” is mainly accounted for by the facts that—

- (1) the kharif crops were injured by heavy rains in Gujarat,
- (2) the rabi crops failed partially owing to the insufficiency of the later rains in parts of the Deccan and Karnatak districts and to the destruction by locusts in parts of the Sind districts and of the Ahmedabad district.

3. The increase in the Assessment of Alienated Lands *less* quit-rents in the revised estimate and next year's budget estimate as compared with the sanctioned estimate of the current year is chiefly in the central Division and is due to revision settlements. The sanctioned estimate of 45 for recoveries for service payments has been raised by 10 in view of the progress of actuals.

4. *Budget Estimate, 1927-28.*—The estimates for 1927-28 have been framed on those furnished by the local officers and have been modified by Government in view of the actuals of the last ten years. The next year's estimate is taken at 5,30,00, assuming that the next season will be a normal one.

Expenditure

5. *Revised Estimate, 1926-27.*—The revised estimate for 1926-27 under the major head stands at 66,93 as against the sanctioned budget of 69,64. The decrease of 2,71 is chiefly due to the fact that the provision of 2,00 for damages to Kolaba Khots will not be required during the current year. The full grant of 67 for "Construction and repairs of chavdis" will also not be utilised. The decrease is also due to savings in the pay of officers and establishments.

6. *Budget Estimate, 1927-28—Charges of District Administration.*—There is a decrease of 57 in the total grant under this minor head in the next year's provision as compared with the current year's budget. This is mainly due to reduced provisions having been made under "Pay Establishments, Allowances and Contingencies."

7. *Survey and Settlement.*—The budget for next year shows an increase of 4 as compared with that for 1926-27. The increase is due to the provision for grant of house-rent allowances sanctioned by the Legislative Council last year to clerks and others at Poona, for which no provision was made in the current year's budget under this minor head.

8. *Land Records.*—The decrease of 1,69 in the budget of 1927-28 as compared with the current year's budget is mainly due to reduced provisions having been made for field party establishments, for establishments in district survey offices, for akarband work, for travelling allowance and leave salary of officers and establishments and for office expenses and other miscellaneous items.

9. *Compensations.*—The decrease of 87 in the next year's estimate as compared with that of the current year is due to less provisions having been made under "Miscellaneous Land Revenue Compensations" and also for commutations, in view of the revised estimate of the current year and of the past actuals.

10. *High Commissioner—Stores.*—The budget provides for charges on account of freight and the value of European Stores for the Government Photozinc Press, Poona. The next year's provision shows a decrease of 9 as compared with the current year's estimate. This is due to a smaller amount being required for such purchase next year.

11. *Charges on account of Encumbered Estates.*—The charges on account of Encumbered Estates in Sind are covered by a contribution from the Encumbered Estates, the amount of which is directly deducted from expenditure. The amount of contribution is generally higher than the immediate charges, as an extra amount is recovered on account of contributions for leave salary and pension. The charges on account of Encumbered Estates for the year 1926-27 were estimated at 99 and the contribution to be recovered from the estates at 1,15. This accounted for a *minus* entry of 16 in the current year's budget. The recovery of pension and leave contribution provided for under this head has however been omitted from the revised estimate of the current year and the budget estimate of next year and has been credited to the head "XXXIII—Receipts in aid of Superannuation" as it is creditable to that head. The *minus* entry therefore disappears in the Revised Estimate and the Budget Estimate of next year.

Revenue

12. *License and Distillery Fees, etc.*—The decrease of 25,24 in the revised and of 27,74 in the ensuing year's estimate as compared with the current year's budget occurs mainly under (1) still-head duty, (2) country spirit vend and license fees, (3) toddy vend and license fees, (4) duty on Indian-made wines and spirits and (5) Opium vend and license fees, partially counterbalanced by increased receipts under excise pass fee on foreign liquor.

13. *Sale proceeds of Excise Opium.*—The ensuing year's estimate shows a reduction of 1,36 as compared with the current year's budget as the consumption of opium is on the decrease.

14. *Hemp Drugs.*—The consumption of ganja in the Presidency proper shows a considerable falling off as a result of the increase of the duty on the drug from Rs. 22-8-0 to Rs. 25 per seer with effect from 1st April 1926. This accounts for the decrease of 3,88 in the revised and of 3,30 in the ensuing year's estimate as compared with the current year's budget. Receipts from vend fees also show a falling off. The next year's budget takes into account the enhancement from 1st April 1927 of the duty on Ganja in the Presidency proper and Aden from Rs. 25 to Rs. 30 per seer and from Rs. 22-8-0 to Rs. 25 per seer in Sind.

15. *Profits from Government Commercial Undertakings.*—This minor head records the profit disclosed by the Profit and Loss Account of the Nasik and Khanapur distilleries and paid over to Government from the Personal Ledger Account of the distilleries. Hitherto this amount was included in the estimate under “Gain on liquor”. The account rules however require that as soon as the periodical Profit and Loss Account has been compiled and audited the resultant profit or loss should be incorporated in the public account, the amount of the profit being taken to the head “Profits from Government commercial undertakings”. The decrease in the ensuing year’s budget as compared with the revised is due to the fact that the latter represents the profit from the Nasik and Khanapur distilleries for the years 1924-25 and 1925-26 actually realized (*viz.*, 15 lakhs) and that estimated in the current year (*viz.*, 8 lakhs,) whereas the former represents the profit anticipated in 1927-28.

16. *Recoveries of indirect charges from commercial undertakings.*—This represents the direction and supervision charges recovered from the Nasik and Khanapur distilleries which were not hitherto shown in the accounts. The decrease in the ensuing year’s budget as compared with the revised is due to the fact that the latter includes recoveries for past years also.

17. *Recoveries of investments in Government commercial undertakings.*—Under this head are shown recoveries of capital charges such as sale proceeds of buildings, machinery, etc., pertaining to the Nasik and Khanapur distilleries, which do not require to be replaced, or excess receipts after replacements, and any return of working capital. The receipts are fluctuating.

18. *Fines, Confiscations and Miscellaneous.*—The decrease in the revised and in the ensuing year’s estimate as compared with the current year’s budget is due to the fact that the latter includes receipts from the Gain on liquor from the departmentally managed distilleries at Nasik and Khanapur. In the revised and next year’s budget these receipts have been shown under the minor head “Profits from Government commercial undertakings”. The decrease in the ensuing year’s estimate as compared with the current year’s revised is due mainly to the fact that the latter includes certain amounts at the credit of the combined Personal ledger Account on account of the Nasik and Khanapur distilleries and the Dhadgaon Outstill on 31st March 1924.

19. *Refunds.*—This is a fluctuating item and calls for no remarks.

Expenditure

20. *Superintendence.*—This minor head includes provision for the Commissioner of Excise, the Deputy Commissioner of Excise, who is also Personal Assistant to the Commissioner, and the Commissioner’s establishment. The small increase in the current year’s revised and in the ensuing year’s estimate is due mainly to the promotion of the Commissioner from the second to the first grade.

21. *Presidency Establishment.*—Under this minor head is shown the cost of the excise staff employed in the Town and Island of Bombay. The increase of 14 in the ensuing year’s estimate as compared with the current year’s budget and revised is due to the appointment of a senior officer as Superintendent of Excise, Bombay Sub-division, and to the employment of a larger staff in the Town and Island of Bombay.

22. *District Executive Establishment.*—The decrease of 37 in the revised as compared with the current year’s budget is due to savings in the provision for “Pay of establishment” partially counterbalanced by an increase under “Contingencies”. The revised estimate provides for the expenditure on the working of the Dhadgaon Distillery in the Akrani tract of West Khandesh which was hitherto taken to a Personal Ledger Account. The Account has been closed with effect from 1st April 1926 and the cost in connection with the distillery is now met from the ordinary revenue. This charge was not anticipated when the current year’s budget was framed. The decrease of 90 in the ensuing year’s estimate is due to a smaller provision under (i) Pay of establishment and (ii) travelling allowance and to a larger deduction for probable savings partially counterbalanced by provision for expenditure on the Dhadgaon Distillery.

23. *Cost of opium supplied to Excise Department.*—The decrease of 87 in the revised as compared with the current year’s budget is due to the reduction from

Rs. 28 to Rs. 26 per seer in the cost price of opium purchased from the Government of India. The increase of 87 in next year's estimate over the current year's revised is due to the fact that the quantity held in stock at the beginning of the year 1926-27 was higher than that estimated to be in hand at the beginning of the ensuing year and consequently a larger quantity will have to be purchased next year from the Ghazipur Factory than was purchased in the current year.

24. *Distilleries.*—The provision in the current year's budget was made for the purchase of the Godhra Distillery plant. Similar provision is not required in the ensuing year.

25. *Excise compensations.*—The increase of 6,57 in the revised as compared with the current year's budget is due mainly to the payment of arrears to certain Indian States for the lease of their abkari and hemp drugs revenue. The increase of 72 in the ensuing year's estimate as compared with the current year's budget is due to the revision of the amount of provisional payment made to certain States for the lease of their abkari and hemp drugs revenue.

26. *Investments in Government commercial undertakings.*—This minor head records (a) the capital expenditure at the Nasik and Khanapur distilleries and (b) the loss, if any, on Government commercial undertakings. The revised estimate represents the provision sanctioned by the Legislative Council in the July session of 1926. The decrease (7,07) in the ensuing year's estimate as compared with the current year's revised is due mainly to the absence of any provision for adjustment of the Personal Ledger Accounts of the two distilleries.

27. *Stores and Exchange.*—The variations are small and call for no remarks.

Revenue

28. The current year's revised estimate under "non-Judicial stamps" shows a decrease of 12,05, as compared with the budget estimate of 1,11,05. The latter estimate took into calculation an anticipated increase of 11,00 on account of the operation of the Indian Stamp (Bombay Amendment) Act, 1926 (Transfer of Property Tax) as also a normal increase in stamp revenue in anticipation of improved trade conditions. Neither of these expectations has been realised.

29. The current year's revised estimate under judicial stamps shows a decrease of 2,95 as compared with the budget estimate of 89,95. The budget estimate took into account a revenue of 10,00 expected from the operation of the Court Fees (Bombay Amendment) Act, 1926. The revised estimate shows that this anticipation has been nearly realised.

30. The next year's estimate under "Non-Judicial" stamps shows a decrease of 12,05 as compared with the current year's budget estimate of 1,11,05. The decrease is due to the fact that the next year's estimate is based on the revised estimate as it is anticipated that conditions next year will not differ much from those obtaining during the current year. The next year's estimate of 88,00 under "Judicial" stamps has been based lower than the current year's budget estimate by 1,95 in view of the current year's revised estimate.

Expenditure

31. In view of the progress of the actuals during the first eight months of the current year and assuming that the provision for the cost of stamps supplied from the Nasik Depôt will be fully utilised, the current year's budget of 3,51 has been adopted as the "Revised".

32. The next year's estimate shows a decrease of 1,93 as compared with the current year's budget. The decrease is due to the fact that allowance has been made for the recoveries which are expected to be made for the supply of stamps from the Bombay and Karachi Depôts to other provinces. No such recoveries are provided in the current year's budget as the Security Printing Press at Nasik was expected to supply stamps direct to all provinces with effect from the current year. As however the Press will be unable to issue stamps direct to all Provinces before the end of March 1928, stamps will still be required by the Provinces from the Bombay and Karachi Depôts. The decrease of 4 under charges for the sale of general stamps is due to the substitution of salaried vendors for licensed vendors in some places in Bombay City.

Revenue

33. *Timber and other produce removed from the forests by Government agency.*—The decrease (2,08) in the revised estimate is due partly to the abandonment of the project for the establishment of a saw mill at Bardipada (Dangs) and to the proposed closing down of the saw mill and departmental fellings at Karanjara (Dangs) with a view to the gradual extension of the system of sale of standing coupes (the resultant revenue being credited to minor head "Timber and other produce removed from the forests by consumers or purchasers.") The decrease is also due to low prices, to the unavoidable delay in the allotment of contracts for Donginalla fellings in the Kanara Eastern Division, to the inability on the part of some of the contractors in the same division to deliver the expected quantity of timber at the Kirwatti, Katur and Telgeri depôts, and to the cessation of the departmental working of the fuel depôts in the Kanara Southern Division.

The ensuing year's budget estimate is lower than the current year's sanctioned and revised estimates owing to the curtailment of departmental fellings in the Dangs and of the exploitation of fuel in the Belgaum, Kanara Central and Dharwar-Bijapur divisions, but shows a substantial advance on the actuals of 1925-26.

34. *Timber and other produce removed from the forests by consumers or purchasers.*—The revised estimate is higher (34) on account of better prices obtained for gurcharan and other coupes in North Thana, for teak pole coupes in the Kanara Northern and Belgaum divisions and for tali trees in the Sukkur Division and on account of the expected recovery of past outstandings of revenue in the Kanara Southern and Hyderabad divisions. The increase is partly counterbalanced by lower prices for coupes in the Central Circle.

The ensuing year's estimate is higher than the current year's sanctioned estimate owing to anticipated larger sales of coupes in the Dangs and to an improvement in prices of forest produce in the Central and Southern Circles.

35. *Miscellaneous*.—The increase (81) in the revised estimate is due to larger receipts from fines inflicted on contractors in the Northern and Central Circles and to larger realizations on account of rent for forest land given out for cultivation in Sind.

The budget estimate for 1927-28 follows the current year's revised with slight alterations.

Expenditure

36. *General Direction*.—The increase (5) in the revised estimate is due to the debit to this head instead of to "51-A, Miscellaneous adjustments between the Central and Provincial Governments" of the contribution made to the Central Government for the investigation of foreign markets for Indian timbers. The increase (4) in next year's estimate is due to a larger provision for stipends and cost of training of Rangers at the Forest College, Coimbatore.

37. *Conservancy and Works*.—The increase (39) in the revised estimate occurs in the Southern Circle where the sanctioned grants have been found insufficient for carrying out revenue producing works such as fellings according to working plans and urgent repairs to roads for the extraction of timber. The ensuing year's estimate is lower than the current year's sanctioned and revised estimate as smaller provision has been made for forest conservancy owing to the need for retrenchment.

38. *Establishments*.—The decrease (1,55) in the revised estimate is due to savings in the provision for leave salaries, reduction in the rates of travelling allowance, vacancies in the cadre of the Provincial Forest Service and to the temporary establishment not having been employed to the extent provided for.

The increase (77) in next year's estimate as compared with the current year's revised is due to the periodical increments of pay of officers and subordinate establishments and to the grant of permanent travelling allowance to Forest Guards in charge of rounds as sanctioned at the session of the Legislative Council held in July 1926.

40. The revised estimate for the current year shows a decrease owing to a further decline in land values. The next year's estimate provides for a small increase over the current year's revised in the hope that the values of land will rise.

Expenditure

41. The revised estimate shows a saving owing to the exercise of the most rigid economy in expenditure. The next year's budget follows the current year's revised estimate.

Receipts

42. The current year's revised estimate under "Entertainment Tax" shows an increase of 7 which is mainly due to increased receipts from theatrical entertainments and also from the M. C. C. Cricket matches in Bombay. The decrease of 3,05 in the revised estimate under the "Tax on Totalisator" is mainly due to the fact that the current year's estimate of 18,00 was a rough estimate not based on experience.

43. The next year's estimate under "Entertainment Tax" shows an increase of 36 as compared with the budget estimate of the current year. An increased provision has been made in view of the past actuals and of the revised estimate of the current year. The next year's estimate under "Tax on Totalisator" follows the revised estimate of the current year.

Expenditure

44. The current year's revised estimate is lower than the sanctioned estimate by 1. The decrease is under "Leave Salary" which has not been utilised. The next year's estimate is based on the current year's sanctioned estimate and calls for no remarks.

NOTE ON THE SYSTEM OF CAPITAL AND NON-CAPITAL ACCOUNTS
OF IRRIGATION WORKS MAINTAINED IN THE PUBLIC WORKS
DEPARTMENT

45. Irrigation works are divided into two main categories (1) works for which Capital accounts are kept and (2) works for which Capital accounts are not kept. All irrigation works, of which it is both desirable and possible to maintain accounts on a *quasi* commercial basis are included in the former category and those for which the maintenance of such accounts is either impossible or unnecessary, either because they produce little or no revenue or because owing to their restricted size it is not worth while examining the returns paid by each individual work, are put under the latter class. The important criterion in the case of a *quasi* commercial undertaking is whether the work is remunerative or the reverse and it is therefore essential for this class of works to maintain a Capital account, since it is only by reference to the amount of capital expended that the value of the results obtained can be determined.

46. The works for which capital accounts are kept are first divided to show (A) Irrigation and (B) Navigation, Embankment and Drainage Works, separately, each of which is again sub-divided into (1) Productive and (2) Unproductive Works.

47. The initial expenditure on the construction of an irrigation project for which Capital account is kept is charged to the Capital account of that project and such further expenditure after its completion as is necessary for the full development of the scheme is also added to that account.

48. The capital invested on the work includes (1) direct charges, *i.e.*, cost of works, Establishment and Tools and Plant, (2) indirect charges, *i.e.*, capitalised value of abatement of land revenue occupied by works and leave and pension allowances of establishment and (3) all arrears of simple interest, if any, *i.e.*, balance of total interest over net revenue. This capital cost is commonly known as "sum at charge".

49. As soon as the work commences to earn revenue a Revenue account is opened for it. The revenue derived from the work is credited to that account and annual maintenance charges are debited to it. The difference between the gross revenue earned and the maintenance charges is the net revenue on the work.

50. Turning to the sub-divisions Productive and Unproductive works it may be observed that if the net revenue from a Capital work is expected to repay after 10 years from its completion the annual interest charges on the capital invested, *i.e.*, sum at charge, at 6 per cent. or at such other rate as may be fixed by Government from time to time, the work is considered as "Productive", otherwise it is treated as "Unproductive". If any work for which a Capital account is kept and which is classed as productive fails at any time after the expiry of 10 years from its completion in three successive years to yield the relevant return, it is transferred to the Unproductive class. Similarly if a work though classed as unproductive succeeds in yielding for three successive years the relevant return prescribed for a productive work it is transferred to the productive class.

The same principle would apply to all extensions and improvements of an existing work.

51. The capital expenditure on irrigation works is booked in the accounts under one major head, *viz.*, "55, Construction of Irrigation, Navigation, Embankment and Drainage Works". Funds for these works may be provided from ordinary revenues, Famine Insurance Grants or from other sources outside the revenue of which the most important is loans, but the expenditure is booked under one major head "55" only. This major head is however intended to include only expenditure incurred from sources outside the revenue and it is therefore necessary to deduct from this head the capital expenditure defrayed from general revenues and to show it in the revenue section of the accounts. There will thus be two deductions in lump sums at the foot of the account of the major head "55" and the amounts thus deducted from this head are booked, without details of works, under the major head "16-A—Financed from Famine Insurance Grants" and "B—Financed from ordinary Revenues" according to the source from which funds are provided. The head "16" is therefore purely a transfer head. The net

total of the major head "55" after the deductions above referred to have been made, represents that portion of the capital expenditure on irrigation works which is financed from sources outside the ordinary revenues. In this budget all the expenditure is to be met from loan.

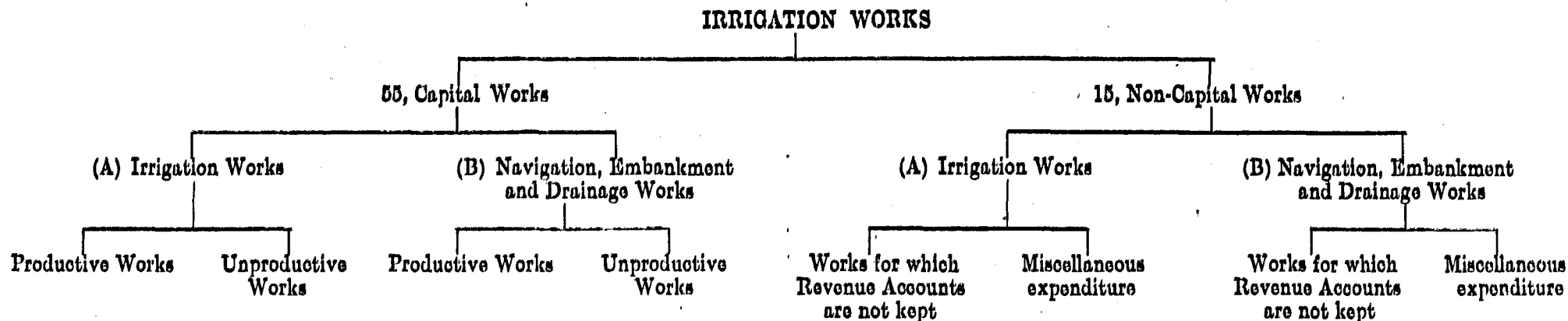
52. The revenue derived from irrigation works for which capital accounts are kept and the annual expenditure on maintenance and working expenses on those works are respectively credited and debited to the revenue account of those works under a separate Revenue head "XIII—Irrigation, Navigation, Embankment and Drainage works for which Capital Accounts are kept", the divisions and sub-divisions of this account also being the same as those under the corresponding capital expenditure head "55" mentioned above.

53. In the Budget Estimates of Revenue for Irrigation Works under the abovementioned head "XIII", the working expenses and maintenance charges of capital works are shown by a *minus* entry under *gross* revenue in order to show the estimated NET revenue, as the essential matter financial is the *net*, and not gross revenue. Although these working expenses are shown under the receipt head, they are, of course, treated in all respects as ordinary expenditure; they are subject to the same rules and conditions and, as in the case of other outlay, are included in the demand for grants.

54. There is one more *minus* entry to be made in the Budget Estimates of Revenue under the head "XIII" before the *net* revenue is shown and that is the "Refunds of Revenue". In the demands for grants, however, and for all purposes of sanction these refunds must still be treated as expenditure in order that the necessary sources and authority for their payment may be obtained.

55. The interest on capital expenditure met from ordinary revenue is shown under the head "14—Interest on works for which Capital Accounts are kept".

56. With reference to the second division of irrigation works, *viz.*, works for which *capital accounts are not kept* it may be observed that this division includes a very large number of works which, while collectively of great importance, are individually too small to make it worthwhile to maintain separate accounts for each. All expenditure upon such works whether upon the construction of new works or upon the extensions or improvements, maintenance or repairs of existing works—is accounted for under one major head "15—Other Revenue Expenditure". Since the works under this class are on a non-commercial basis and no capital accounts are kept for them there is no object in treating maintenance charges as a *minus* entry under revenue from these works as in the case of *quasi* commercial works, and therefore they are shown under the expenditure head "15". The only comparison here possible is that between the gross revenue (shown under Revenue head XIV) and the total expenditure of all kinds. In this division is also booked, under a separate sub-head, "Miscellaneous Expenditure" all expenditure upon the preliminary surveys of new projects and also the cost of famine surveys required for the preparation of the Famine programme. (The works in this division are financed from ordinary revenues of the year. Those works which have a protective aspect as well as surveys for the preparation of famine programmes may be financed from the Famine Insurance Grants.) The whole of the expenditure on all works under this class is, however, to be booked in the first instance under one major head "15" mentioned above without reference to the source from which the funds are provided and it is necessary, therefore, as in the case of the major head "55" for capital works, to deduct at the foot of the account of the major head "15" a lump sum showing the amount financed from the Famine Insurance Grants, the residue representing the amount financed from ordinary revenues. The amount deducted from this head is booked without details under a separate major head "15(1) Other Revenue Expenditure financed from Famine Insurance Grants" which is merely a transfer head. The revenue earned by this class of works is shown under the Revenue Head "XIV—Irrigation, Navigation, Embankment and Drainage Works for which no Capital Accounts are kept" and the refunds of revenue are deducted from the gross receipts in order to show the net revenue for the works. In preparing the Budget Estimate for this class of works, the refund of revenue, though shown under revenue by a *minus* entry, is included in the statement of demand for grants as is done in the case of the refunds of revenue on Capital Works.



Definitions.—“ *Capital Works* ” are works for which capital and revenue accounts are kept on a *quasi* commercial basis. The capital expenditure is accounted for under the head “ 55 ” and funds for the works are provided from three sources (1) Ordinary Revenue, (2) Famine Insurance Grants and (3) Loans or accumulated Surplus revenue. Revenue realised from them is credited to the head “ XIII ”.

2.—“ *Non-Capital Works* ” are works for which individually neither capital nor revenue accounts are kept either because they produce little or no revenue or owing to their restricted size. The expenditure on these is accounted for under the head “ 15 ”. Any revenue realised from them is credited to the head “ XIV ”.

NOTE SHOWING THE MAIN IRRIGATION WORKS COMPLETED
AND IN PROGRESS IN SIND AND DECCAN AND GUJARAT

SIND

Works in operation

57. The canal systems in Sind are entirely different from those in the Deccan. They are mostly very large and with the exception of a few perennial ones carry their supplies at present during the inundation season only. However when the Lloyd Barrage Scheme is completed it will be possible to feed these canals all the year round. Many of them are canals which existed before the advent of British rule and have since been improved.

58. *The Eastern Nara System.*—The first system to come into operation was the Eastern Nara, consisting of the large Mithrao Canal, and the smaller Eastern Nara, Thar, Hiral and Khipro canals. This system was opened in 1854, although its principal canal, the Mithrao, was not constructed until some years later. The system depends for its supply upon the Nara river which is fed from the Indus through a twelve mile cut, excavated in 1858-59, known as the Eastern Nara Supply Channel. About 86 lakhs of rupees have been expended on this system.

59. *The Begari and Ghar Canals.*—The Begari and Ghar Canals came next into operation in 1856 and about 31½ lakhs of rupees have been spent on these two canals. The former is the most important system north of Sukkur and is on the right bank of the Indus.

60. *The Fuleli Canal.*—The Fuleli Canal, the largest of all the Sind canals, was opened in 1861 and about Rs. 31½ lakhs have been spent on it. This is one of the few canals in Sind which carries any appreciable supply all the year round.

61. *The Desert and Sukkur Canals.*—Five more canals were added during the ten years from 1870 to 1880. Of these the two most important are the Desert Canal costing over Rs. 27½ lakhs and the Sukkur Canal, just above Sukkur, on which over 14¾ lakhs of rupees have been spent.

62. *The Jamrao Canal.*—In 1900 the Jamrao Canal came into being. This was an entirely new canal taking off from the Eastern Nara river above the Mithrao Canal already mentioned and it is assured of a perennial supply by a weir constructed across the Nara. More than Rs. 98½ lakhs have been spent on this work.

63. *The Mahiwah, Dad and Nasrat Canals.*—The Mahiwah, Dad and Nasrat Canals were next built at a cost of about Rs. 60 lakhs and were opened between 1901 and 1904.

There are many other small canals which are playing an important part in the irrigation of the lands in Sind.

Works under construction

64. *Lloyd Barrage and Canals Construction Scheme.*—The most important irrigation project which is now under construction in Sind is the Lloyd Barrage and Canals Construction Scheme. This project which is estimated to cost Rs. 18·35 crores was approved by the Secretary of State in April 1923, was passed by the Bombay Legislative Council in June and construction work commenced in July of that year. The scheme consists of a barrage across the Indus below the gorge at Sukkur, three canals on the right and four on the left bank each with a separate head regulator. The Right Bank System comprises the North Western Perennial and South Eastern Perennial (now Dadu) canals, and the Central Rice (now Rice) Canal. The Left Bank System comprises a great new perennial canal called the Rohri Canal, a perennial supply channel to feed the Eastern Nara river and the canals dependent thereon and two large high level canals for irrigating lands in the Khairpur State. The Barrage will, under the system of scientific control, give the necessary supply to each canal no matter how low the level of the water in the river may be. The actual direct expenditure incurred on this scheme to end of 1925-26 amounts to about Rs. 3·72 crores and about Rs. 158 lakhs will be spent in the current year. A detailed note regarding the progress of work on this scheme has been printed separately.

DECCAN AND GUJARAT

65. Irrigation conditions in the Deccan and Gujarat vary considerably from those in Sind. The cultivation chiefly depends upon rainfall and advantage is taken of irrigation mainly for growing valuable crops like sugarcane or to counteract the effects of drought. The larger irrigation schemes in this part of the Presidency always involve the construction of storage reservoirs on perennial rivers for feeding the canals supplying water to the fields. The principal irrigation works in the Deccan and Gujarat are mentioned below.

Works in operation

66. *Panjhra River Works, Kadwa River Works and Krishna Canal.*—The oldest of the Government irrigation works in the Deccan are the Panjhra River Works in Khandesh. They date from 1851-52 and were constructed at a cost of about 5 lakhs of rupees. Next to these among many small works are the Kadwa River Works in Nasik and the Krishna Canal in Satara Districts which came into operation in 1869. They were constructed at a cost of about Rs. 10½ lakhs and Rs. 9½ lakhs respectively.

67. *Mutha Canals.*—The Mutha canals have been constructed at a cost of about 65½ lakhs of rupees with a large storage reservoir, called Lake Fife, on the Mutha River at Khadakwasla near Poona. This system consists of two canals, the Mutha Right and Left Bank Canals. It came into operation in 1874-75.

68. *Ekruk Tank and the Hathmati Canal.*—The Ekruk Tank and the Hathmati Canal (which was the first and is still the most important work in Gujarat) came into operation also about this time and about 13½ and 13¼ lakhs of rupees have been spent on them respectively.

69. *Nira Left Bank Canal and Gokak Canal.*—The Nira Left Bank Canal which receives its supply partly from the Nira river and partly from its reservoir at Bhatgar (called Lake Whiting) on one of its tributaries, was built at a cost of Rs. 66½ lakhs and was opened in 1885. The Gokak canal, a small canal taking off direct from the Ghatprabha river without a storage work, was opened in 1884 and Rs. 14½ lakhs have been spent on it.

70. *Girna Canal.*—The Girna canal which is fed from the Chankapur tank was constructed at a cost of 20½ lakhs of rupees and was opened for irrigation in 1909.

71. *Godavari Canals.*—The Godavari Canals system includes a storage reservoir (Lake Beale) on the Darna river and a pick-up-weir at Nandur-Madhmeshwar and the Right and Left Bank Canals. This project has cost about 103 lakhs of rupees and was brought into operation in 1912.

72. *Pravara River Works.*—The Pravara River Works System comprises (i) a storage reservoir, called Lake Arthur Hill, on the Pravara river at Bhandardara, (ii) a pick-up-weir at Ojhar and (iii) two canals named the Pravara Right and Left Bank Canals. The project was sanctioned by the Government of India in 1907, the work was commenced in 1908 and both the dam and the canals have recently been completed. The capital cost of the whole scheme, including the dam, amounts to Rs. 151 lakhs. The masonry dam of the storage reservoir is 274 feet high above the river-bed at its highest point and about 1,600 feet in length. It is the highest dam in India and second highest in the world. The opening ceremony of this dam was performed by His Excellency the Governor of Bombay on the 10th December 1926 and from that date the dam is known as the "Wilson Dam."

In addition to the above schemes there are many other small canals and tanks which irrigate large areas of lands in the Deccan and Gujarat.

Works under construction

73. *The Nira Right Bank Canal project.*—The Nira Right Bank Canal project will, when completed, be the largest in the Deccan. It comprises the construction of the Nira Right Bank Canal, 109 miles in length, and a larger dam at Bhatgar on the Yelwandi river to replace the existing one mentioned under the Nira Left Bank Canal so as to increase the storage for supplying both the canals viz., the old Nira Left Bank and the new Nira Right Bank Canals. The work on

the dam and canals is approaching completion. It has however been possible from the last year to issue water from the canal to certain rabi crops. The total estimated cost of the scheme including direct and indirect charges and deducting salvage value of tools and plant is Rs. 483·97 lakhs. The expenditure incurred to end of 1925-26 was about Rs. 369 lakhs and the probable expenditure in 1926-27 is over Rs. 16½ lakhs.

74. *The Nira Valley Development project.*—The Nira Valley Development project provides for the complete development of irrigation in the Nira Valley. The Nira Right Bank Canal scheme with the enlarged storage at Bhatgar on the Yelwandi river aims at irrigating lands on the right bank of the Nira river. There is however large scope for extending irrigation on the existing Nira Left Bank Canal where there is a keen demand for a larger supply. This demand can be met by storing the water flowing in the Nira river from sources other than the Yelwandi by means of another dam to be erected on the Nira at Vir below the confluence of all the main tributaries and by enlarging the Nira Left Bank Canal to the maximum economical limits. This scheme combined with the Nira Right Bank Canal scheme is called the Nira Valley Development project.

The Nira Right Bank Canal system itself is estimated to cost Rs. 483·97 lakhs as stated above. The combined scheme is estimated to cost Rs. 619·77 lakhs. The extra cost will therefore be Rs. 135·80 lakhs which represents the cost of widening and remodelling the Nira Left Bank Canal and constructing the new dam at Vir. This project was approved by the Legislative Council in March 1924 and was finally sanctioned by the Secretary of State in November 1924. The work on this project was commenced in the last year and the probable expenditure on it to end of March 1927 will be about Rs. 8½ lakhs.

XIII—Irrigation, Navigation, Embankment and Drainage Works for which Capital Accounts are kept

Revenue

75. The revenue derived from irrigation works for which capital accounts are kept is classified under two heads, (a) direct receipts and (b) the portion of land revenue due to irrigation. The former includes sale proceeds of water supplied for irrigational and non-irrigational purposes, sale proceeds from canal plantations and of other canal produce (e.g., wood, grass, etc.), etc., and the latter, viz., (b), represents the irrigation share of land revenue.

The working expenses of these works for which capital accounts are kept are to be deducted from the total receipts of the two kinds mentioned above (which are termed "gross revenue") in order to show the *net* revenue earned by these works.

76. The budget and revised estimates of revenue for the current year with the actuals for the last year and the budget estimate of revenue for the ensuing year are as shown below :—

77. The revised estimate of gross revenue as compared with the budget estimate for 1926-27 shows a decrease of 3,78 which is wholly under 'Portion of land revenue due to irrigation' on account of deficiency of water in canals in Sind. The fall of 13 in the revised estimate of 'Working expenses' as compared with the budget estimate for the current year is due to transfer of funds by reappropriation from this head to the head '15' which was found necessary in order to meet the requirements for certain urgent works in Sind under that head.

78. The small increase in gross revenue of 1,72 in the budget estimate for 1927-28 as compared with that for 1926-27, which is wholly under direct receipts, is attributed to the revision of water rates in the Deccan and Gujarat and the extension of irrigation under the Godavari, Pravara and Nira Right Bank Canals. The comparison of the budget estimate for 'Working expenses' for the ensuing year with that for the current year shows an increase of 3,21 which is made up of 28 under 'Works', 1,10 under 'repairs', 1,19 under 'establishment' and 64 under 'tools and plant'. The increase under 'Works' is entirely due to the larger provision that has been found absolutely necessary for new works. During recent years on account of financial stringency several new works, though they were really necessary, had to be omitted from the budget. The necessity for such works cannot be ignored for a long time. The urgent need for all the new works has been fully explained in the list of new items of expenditure. The increase under 'repairs' is due to extra provisions required to be made for urgent special repairs to the Mahiwah, Ghar, Sukkur and Fuleli Canals in Sind and to the Nehr Tank of the Yerla River Irrigation Works in the Deccan and for the formation of the blocks on the Pravara Canals on which the block system of irrigation is to be introduced from 15th February 1928.

79. The provision for 'establishment' is made up of (i) the estimated cost of special establishments, such as survey establishment, revenue establishment, etc., and (ii) the percentage charges on the provisions made for works and repairs. Similarly the provision for 'tools and plant' includes the estimated cost of tools

required for survey works and the percentage charge on the provision for works and repairs. In the budget estimate for the current year the percentage charges for establishment and tools and plant were calculated at the rates of $21\frac{1}{2}$ and $1\frac{1}{2}$ per cent., respectively, on the provisions for works and repairs, whereas for the purposes of the next year's budget they have been adopted at the revised rates of 24 and 3 per cent., respectively, which have been based on the average of actuals for the last five years. The excesses under these minor heads are therefore partly due to the increased provisions made for works and repairs as explained in the above paragraph and partly to the increase in the percentage charges calculated at the revised rates.

**XIV—Irrigation, Navigation, Embankment and Drainage Works for
which no capital accounts are kept.**

Revenue

80. The revenue derived from irrigation works for which no capital accounts are kept is only from direct receipts, such as sales of water, plantations and other canal produce, etc., and no credit is afforded to this class of works on account of the portion of land revenue due to irrigation.

The budget and revised estimates for 1926-27 with the actuals for 1925-26 and the budget estimate for 1927-28 are as shown below :—

81. The increase of 25 in the revised estimate for the current year as well as the increase of 5 in the ensuing year's budget, as compared with the budget estimate for 1926-27, is due to variations in sales of water.

82. Under Rule 24 of the Devolution Rules the capital sum spent by the Governor-General in Council upon the construction of productive and unproductive irrigation works and of other works financed from loan funds is to be treated as an advance made to the Local Government from the revenues of India. This advance is to carry interest at the rate of 3·3252 per cent. per annum in the case of outlay incurred up to the end of 1916-17 and at 5·1979 per cent. per annum in the case of outlay incurred from 1917-18 to 1920-21. The amount of this interest comes to 32,07 and this amount is included separately under the head "19—Interest" as interest on the advance in respect of Irrigation capital expenditure. Since 1921-22 the capital expenditure on Irrigation is being met from the loans for general purposes and the amount of interest payable on these loans is also shown separately under the head "19—Interest". The head "14—Interest" is merely a *pro forma* head to show the interest liabilities met from revenues on Irrigation capital and credit of the amount shown as expenditure under this head is taken by deducting the same amount from the expenditure shown under the head "19—Interest."

The budget estimate of 64,06 for 1926-27 was framed as shown below :—

84. The decrease of 9,88 in the current year's revised as compared with the current year's budget is mainly due to transfer from this head to the head "16" of 10,00 for interest on Lloyd Barrage and Canals Construction to be met from Famine Insurance Grant. The decrease of 8,60 in the budget estimate for 1927-28 as compared with the current year's budget is also due to the same reason as given for the revised estimate for the current year.

**15, Other Revenue Expenditure financed from Ordinary Revenues
(Public Works Department)**

Expenditure (Reserved)

85. The works accounted for under this head can be financed partly from ordinary revenues and partly from the Famine Insurance Grant or Fund, since irrigation and embankment works having a protective aspect and famine surveys are legitimate objects of expenditure from that Fund. As the expenditure on all works for which capital accounts are not kept is to be booked in the first instance under this head without reference to the source from which the funds are provided it will be necessary to deduct at the foot of the account of this major head a lump sum showing the amount financed from the Famine Insurance Fund, the residue representing the amount financed from ordinary revenues. The amount thus deducted will be shown in lump sum under a separate major head "15 (1)—Other Revenue Expenditure financed from Famine Insurance Grants."

86. The budget and revised estimates under this head for the current year with the actuals for the last year and the budget estimate for the ensuing year are as shown below :—

87. The increase of 1,13 in the revised estimate under gross expenditure as compared with the budget estimate for 1926-27 under this head is due to an additional allotment of Rs. 1 lakh sanctioned for the Visapur Tank and transfer of funds by reappropriation from the head 'XIII' to this head in order to meet urgent requirements for certain works in Sind as already stated in paragraph 77.

88. Out of the total budget provision of 44,07 under this head for the next year, 25,00 will be financed from the Famine Insurance Grant and the residue, viz., 19,07, will be provided from ordinary revenues as indicated in the above table. The amount to be met from the Famine Insurance Grant has been provided under the head "15 (1)—Other Revenue Expenditure financed from Famine Insurance Grant". The budget estimate for the next year for gross expenditure under the head "15—Other revenue expenditure financed from ordinary revenues" as compared with that for the current year shows an increase of 12,03 which is made up of 6,63 under 'works', 1,88 under 'repairs', 2,56 under 'establishment', 58 under 'tools and plant' and 38 under 'pensionary charges'. The increase under 'works' is due to the provisions made for several bund works in Sind which are already in progress and to increased provision for the Visapur Tank. The abnormal inundation of the river Indus in 1924 has indicated the absolute necessity of strengthening the existing river bunds and raising them to the standard section of 4 feet above the H. F. L. and of constructing a chain of embankments on the left bank of the river from Khairpur State boundary to Hyderabad in order to avoid similar or worse disasters in future. The cultivation in Sind depends on irrigation and the safety of the irrigation system as well as the life and property of the people depend on these protective bund lines on both the sides of the river. It is therefore necessary to make sufficient provisions for these bund works already in progress and to complete them without delay. The increase under 'repairs'

is mainly due to the necessity of making a large provision of 2,45 for the completion of the Abad Marho Loop behind the Thahimani Abad Loop which has been started in the current year owing to the active erosion of the river very near to the Thahimani Abad Loop which is in danger of being eroded away.

89. The main reasons for the increases under 'establishment' and 'tools and plant' are the same as those already explained in paragraph 79.

90. The provision for 'pensionary charges' is made at the rate of 9 per cent. on the total cost of irrigation establishment and the increase under this head calls for no remarks. Formerly these charges were wholly provided for under the major head "45-Superannuation allowances and pensions"; but in 1923 the Government of India with the approval of the Secretary of State decided that pensionary charges of commercial departments should, with effect from 1st April 1923, be brought to account under the appropriate commercial heads concerned and that in the case of irrigation works they should be debited to the head "15," under the sub-head "(3) Miscellaneous Expenditure". The amounts actually paid on account of pensions are debited to the head "45" in the first instance and subsequently adjusted in the accounts by debit to "15" and credit to the head "45". Thus the provision made under the head "15" is to cover the ultimate debit raised in the accounts against that head.

91. The revised estimate for 1926-27 before transfer to 15 (1) stands at 3,96 as against the sanctioned budget of 7,76. This is due to the provision of 5,00 (included in 7,76) for minor irrigation works under the Superintending Engineer on Special Duty not being fully utilised. When the estimates were framed it was considered that large sums could be spent on famine projects already prepared for the Ahmednagar District. On investigation, however, it was found that these works were not suitable and more promising schemes on a smaller scale were undertaken. A saving of 3,80 is accordingly expected in this provision. The net budget for 1926-27 remains unchanged at 46, as the whole provision for minor irrigation works under the Superintending Engineer is eventually transferred to the head 15 (1).

The increase in the total provision from 7,76 in 1926-27 to 8,29 in 1927-28 is due mainly to the provision of 61 for survey charges and tools and plant (for which no specific provision was made in the current year), counterbalanced by a reduced provision of 82 against 92 for Commissioners' grants. The whole provision for items (1), (2) and (3) and half of the provision for item (4), *i.e.*, a total of 7,88 will be transferred to the head "15-(1)—Other Revenue Expenditure financed from Famine Insurance Grants." Thus the net provision under the head 15-A (Civil) will be 41.

93. The provision of 1,86 for item (1) in paragraph 2 is for the Superintending Engineer and establishment only. It does not include anything for works proper for which a provision of 5,00 is proposed in item (2).

94. A list showing the minor irrigation works likely to be proposed for construction during the year 1927-28 is appended. It will be seen from the list that the total probable expenditure is 7,80 ; but in view of the uncertainty of some of the projects being taken up during 1927-28 a provision of 5,00 has been made.

95. According to the revised system of irrigation accounts this head is intended to show the expenditure provided from the Famine Insurance Grant on irrigation works for which capital accounts are not kept. The whole of the expenditure on all such works is however booked in the first instance under the major head "15, Other Revenue Expenditure financed from Ordinary Revenues" without reference to the source from which the funds are provided and the amount financed from the Famine Insurance Grants is deducted by a lump sum at the foot of the account under that head. The amount thus deducted under the head "15" is booked, without details, under the major head "15 (1), Other Revenue Expenditure financed from Famine Insurance Grant." It is thus purely a transfer head.

16-A—Construction of Irrigation, Navigation, Embankment and Drainage Works financed from Famine Insurance Grants.

96. This head is intended to show the expenditure provided from the Famine Insurance Grants on irrigation works for which capital accounts are kept. The whole of the expenditure on all such works is booked in the first instance under the major head "55—Construction of Irrigation, Navigation, Embankment and Drainage Works not charged to revenue" without reference to the source from which funds are provided and the amount financed from the Famine Insurance Grants is deducted by a lump sum at the foot of the account under that head. The amount thus deducted under the head "55" is booked, without details, under the major head "16-A." It is thus purely a transfer head.

97. The provision made under this head at present is only in connection with the *interest* charges on the capital outlay on the Lloyd Barrage and Canals Construction Scheme. It has been decided, with the approval of the Government of India, to meet a portion of the interest charges not exceeding Rs. 10 lakhs for the first 20 years from the Famine Insurance Grants and a portion from the capital, if such a course is considered necessary. The following table indicates the provision made under the head "16-A" on this account.

Revenue

98. The ordinary revenue represents the interest received by the Local Government on advances and loans from the Provincial Loan and Advance Account. This account, the capital transactions of which are outside the ordinary budget figure, provides, for the grant of loans to agriculturists, to local bodies, etc. Interest on arrears of revenue and on provincial balances deposited with the Government of India are also credited to this head.

99. Item 1—The increase in the revised estimate for the current year for item (1) as compared with the current year's budget estimate is chiefly due to the inclusion of interest on advances newly sanctioned.

100. Item 2—Requires no explanation.

101. Item 3, 4, 8 (ii) and 9 (i)—Will be explained in the Development memorandum.

102. Item 5.—The receipt of interest on advances made for Development purposes to the three Presidency Corporations, viz., the Bombay Municipality, the City Improvement Trust and the Port Trust out of the funds borrowed from the Government of India is credited to this head. 94,05 represent the revised estimate of interest recoverable this year from these bodies. The increase in the revised estimate as compared with the budget is due to the fact that the Port Trust has to pay additional interest for 3 months of January to March 1926 owing to the change of the date for repayment of annual instalment from 2nd January to 31st March.

103. Items 6 and 7—The current year's budget provides 11,67 and 44 for interest on general provincial balances and Development Department balances respectively deposited with the Government of India. According to the rules then in force the Government of India were to pay interest at a uniform rate of 2 per cent. less than the rate at which they lent money. Since then the rules have been altered and they will now pay interest at 1 per cent. less than their lending rate in the case of deposits which are initially placed for a period of 12 months and more and at 2 per cent. less than their lending rate when the deposits are initially for a period less than 12 months. If the period of deposit covers portions of two successive years,

interest will be calculated at the rates of interest prevailing in those periods. The following table gives the details of interest on balances as provided in the budget and revised estimates of the current year :—

104. Interest on Provincial loans and interest payable to Central Government (a) on advances to the Provincial loan account, and on advances for Irrigation capital expenditure under Nos. 23 and 24 of the Devolution Rules, respectively, and (b) on other advances, is to be debited to "19, Interest on Ordinary Debt." Charges on account of management of debt and other miscellaneous charges are also debited to this head. Credit is given to this head under the divisions :—

107. Interest on other advances.—The figures against this item include interest on advances taken from Government of India for the Development Department purposes, for the requirements of the 3 local bodies in Bombay City and for ordinary purposes. They are distributed as follows:—

The decrease in the revised estimates as compared with the current year's budget is due to the fact that some portion of principal out of the loans drawn and utilised for other irrigation and other unproductive purposes was paid last year (see paragraph 114 under 21-Appropriation for Reduction or Avoidance of Debt). It is however mainly due to the fact that the budget estimate was based on interest for six months on a much larger amount to be drawn during 1926-1927 and at 5·15 and 5·75 per cent, whereas the revised estimate provides interest at 5 per cent. on 49,14 and at 5·25 per cent. on 62,84 from the time the amounts were placed at the disposal of this Government by the Government of India. The next year's budget provides interest for 12 months on the total advance of 1,11,98 of 1926-1927 and for six months on the proposed advance of 2,39,43. Since 1925-26 there are two rates of interest charged by the Government of India on loans advanced from the Provincial Loans Fund, one standard rate of interest for advances to be utilised for productive purposes and another rate higher by ¼ per cent. for advances to be utilised for unproductive purposes.

108. Deduct Interest transferred to Commercial Department.—The figures are explained under "14-Interest on works for which capital accounts are kept."

109. Deduct Interest transferred to Forest Department.—The figures represent interest on advances taken for forest capital outlay shown under "52-A, Forest Capital Outlay" which is debited to "8-Forests," as expenditure.

110. *Deduct Interest transferred to "55-Construction of Irrigation, etc.":—* According to the Lloyd Barrage Scheme sanctioned by the Secretary of State interest on the Capital Outlay is to be met out of Capital till the scheme becomes remunerative and interest to the extent of 10 lakhs is to be met from the annual grant of 63,60 for Famine Relief. The interest charges according to the revised estimates of the current year amount to 26,43 which include, besides 10,00 to be met from the famine grant, 2,07 for interest on the sum of 1,23 lakhs advanced to the scheme from the general balances. The next year's charges amount to 35,48 out of which 10,00 are to be met from the famine grant and 6,42 represent interest on the amount of 1,23 lakhs advanced from the general balance and on the amount previously financed from Provincial Revenues. In order to show correctly that all interest charges on the Lloyd Barrage Scheme are met from Capital, they are first transferred by deduct entry from "19-Interest" to "55-Construction of Irrigation" and 10,00 are thereafter re-transferred to the Revenue head 16-Construction of Irrigation—A. Amount financed from the Famine Insurance Grant. The interest on the amount advanced from general balances is debited to 55-Construction and its credit to Provincial Revenues is given under "19-Interest" by a deduct entry as there is no corresponding head on the receipt side to provide for such interest on amounts lent to Commercial Departments from the general balances.

111. *Deduct Interest portion of equated payments out of revenues in respect of commuted value of pensions.*—See paragraph 276 under "60, B—Payment of Commuted Value of Pensions."

112. *Deduct Interest on Government Commercial undertakings.*—Credit is to be given to 19-Interest by deduct entry for interest charged on the net capital of Distilleries managed departmentally as worked out at the beginning of the year after deducting depreciation charges up to the end of the previous year. The credit shown in the revised estimates includes 4,00 for 1924-25 and 1925-26 and 2,00 for 1926-27.

113. Item (1) will be explained in the memorandum of the Development Department. It includes 1,37 in the current year's estimate and 1,21 in the next year's estimate which are to be met from the general balances.

114. The advances obtained from the Government of India and now from the Provincial Loans Fund for general purposes have been divided into three classes: (a) Loans for Lloyd Barrage Scheme, (b) Loans for "Other Irrigation purposes", and (c) Loans for "Other Unproductive purposes", which will include all other loans for general purposes. It has been decided to repay them by means of annual equated instalments of principal and interest as was explained last year. The repayment scheme for (a) is not yet ready but those for (b) and (c) which are on 60 years' and 30 years' basis respectively had been submitted to the Government of India for approval along with other proposals in respect of advances made to the Bombay Port Trust, the Bombay Municipality and the Improvement Trust. In respect of the latter they have made certain suggestions and the whole programme for repayment is under consideration of Government. In the meantime actual repayment in respect of (b) and (c) commenced last year and the first instalment was paid on 31st March 1926. The estimates for the current and next years have been framed in accordance with the original programme. The actual repayment of principal is entered in the revenue portion of the account. But the amount provided under this head will be credited to the head "Appropriation for Reduction or Avoidance of Debt" (Receipt Side) under Debt, Deposits and Advances Section and will be finally paid to the Provincial Loans Fund through the head "Advances from Provincial Loans Fund" (Disbursement Side) under that section.

115. Since the repeal of Section 20 of the Sea Customs Act, 1878, by Act No. VIII of 1924, customs duty is being imposed on Government Stores imported on or after 1st April 1924. The Government of India give, in refund of the duty paid, an assignment which is credited to the head "XXXIX-A-Miscellaneous Adjustments between Central and Provincial Governments," but according to the orders of the Secretary of State customs duty realised from imports on capital accounts is to be utilised for redemption or avoidance of debt. In order to act up to these orders it is necessary to debit to the head "21, Appropriation for Reduction or Avoidance of Debt—Other Appropriation for Reduction or Avoidance of Debt" by per contra credit to the deposit head "Appropriation for Reduction or

Avoidance of Debt—Other Appropriation," an amount equivalent to the amount of duty charged to capital heads outside the revenue account. Hence 2,75 in the revised estimate of the current year and 2,42 in the budget estimate of next year out of the total assignment for this and next year respectively have been provided under this head, and a corresponding credit has been given to "Appropriation for Reduction or Avoidance of Debt" under "Debt, Deposits and Advances" section. The credits in respect of customs duty for the Lloyd Barrage and the Bombay Development schemes are being shown separately and being utilised in reducing the borrowings of the respective schemes. The effect of these adjustments is that though the capital cost of these schemes is increased by the amount of customs duty, the borrowing required for financing them is not increased.

116. *Staff and Household of the Governor.*—The decrease in the revised estimate as compared with the budget estimate of the current year is mainly under the unit “Pay of Officers” and is due to change in personnel under “Staff and Household of the Governor—Military Secretary” and partly under “Pay of Establishments” and “Contingencies”.

117. *Expenditure from Contract Allowance.*—The contract allowance of His Excellency the Governor was temporarily fixed at 1,08 for the last and current years. As this allowance is being reduced with effect from next year a smaller provision has been made in next year’s budget.

118. *Legislative Bodies.*—The decrease in the revised estimate of the current year is mainly due to savings in the provisions for pay of the President and the Deputy President, and for travelling allowance of the Members of the Legislative Council, on account of the dissolution of the Council early in the year. The decrease is however partially counterbalanced by increased expenditure for preparation of electoral rolls and expenses of general election. The decrease in the next year’s estimate as compared with the current year’s budget estimate is chiefly due to the absence of special provision for general election purposes..

119. *Civil Secretariat.*—The decrease in the revised estimate of the current year is due to savings anticipated in certain offices in the Civil Secretariat in the provisions for pay of officers and of establishments due to leave vacancies having not been filled up, to appointment of junior officers in place of seniors on leave and to the abolition of the post of Junior Assistant Secretary in the General Department of the Secretariat. The decrease is partially counterbalanced by the increase in expenditure in the Finance Department on account of Retrenchment Officer and his establishment. The next year’s provision is based on normal requirements. It also takes into account the cost on account of a special officer for six months of the next year for framing rules governing the conditions of service, pension, etc., of members of Provincial and Subordinate Services, etc.

120. *Local Fund Audit Establishment.*—The estimates under this head are under the control of the Government of India and are entered under the Central head “23—Audit”. The amounts entered in the current year’s revised and the next year’s budget represent the share of the cost of the Department to be paid to the Central Government by the Provincial Government. The decrease in the revised as compared with the current year’s budget is due to certain vacancies not having been filled up owing to want of properly qualified men.

121. *Commissioner of Settlements.*—The increase in next year’s budget over the current year’s sanctioned estimate is mainly due to the grant of consolidated pay of Rs. 3,000 per mensem to the Commissioner of Settlements. This pay takes into account the overseas pay which would otherwise have been drawn in England.

122. *Commissioners.*—The decrease in the revised estimate of the current year is chiefly due to savings anticipated in the provision for pay of establishment. The decrease in next year’s estimate is mainly due to lump deductions on account of probable savings under “Pay of establishments” and to smaller provision under “Allowances, Honoraria, etc.”.

123. *Charges of District Administration.*—The increase in the revised as compared with the sanctioned estimate of the current year is mainly due to an additional provision of 2,52 under “Assessment of Alienated lands less quit rents”. This debit is a book debit only, being counterbalanced by a corresponding credit under the head V, Land Revenue. The increase is also due to the adjustment in the current year of cost in 1925-26 and 1926-27 on account of Revenue officers and establishments in the Bombay Suburban Division hitherto

paid from the Development Funds but now debited to this head. The increase is partially counterbalanced by savings anticipated in the provision for leave salary of establishments.

The increase in next year's budget as compared with the sanctioned estimate of the current year is mainly due to the provision made under this head for Revenue officers and establishments in the Bombay Suburban Division and larger provision under "Assessment of alienated lands *less* quit rents". The increase is partially counterbalanced by smaller provisions made under "Allowances, Honoraria, etc."

124. *Discretionary grants.*—The decrease in next year's estimate is due to the fact that smaller provisions based on past actuals have been made.

Revenue

125. The principal source of revenue is general fees, fines and forfeitures. The increase in the revised estimate over the estimate for the current year and also the estimate for the next year is due to unforeseen receipts on account of sale proceeds of unclaimed and escheated property and also due to miscellaneous receipts, partly counterbalanced by less receipts on account of contribution from central revenues for work done by the Presidency Law Officers for the Government of India for the years 1921-22 to 1925-26. The decrease in the budget estimate for the next year as compared with sanctioned and the revised estimate is due also to less receipts from "Sheriff's fees" consequent upon an amendment in the High Court rules regarding payment of poundage to the Sheriff of Bombay.

Expenditure

126. *High Court*.—The decrease in the revised estimate as compared with the sanctioned estimate is due to High Court Judges on leave drawing their pay in England. The decrease in the estimate for the next year is due to the proposed discontinuance of the appointment of the temporary tenth High Court Judge for a part of the year.

127. *Law Officers.*—The increase in the expenditure in the current year is due to the heavy expenditure incurred for the payment of fees of Special Counsel during the first eight months.

128. The decrease in the next year's estimate is due to the several cuts applied to the fluctuating grants.

129. *Administrator General and Official Trustee.*—The increase in the revised estimate and the estimate for the next year is due to increased rent sanctioned for the office of the Administrator General, Bombay.

130. *Presidency Magistrates' Courts.*—The decrease in the revised estimate is due to savings in the provision for leave salary for officers and clerks and also due to less expenditure for contingencies. The increase in the estimate for the next year is mainly due to increments in pay of officers and clerks, and to normal provision for leave salary.

131. *Judicial Commissioners.*—The decrease in the revised estimate is due to less expenditure for leave salary. The decrease in the estimate for the next year is mainly on account of the discontinuance of the appointment of the fourth Additional Judicial Commissioner of Sind on the expiry of the period for which it has been sanctioned, partly counterbalanced by increased provision for contingencies.

132. *Civil and Sessions Courts.*—The increase in the revised estimate is due to increments of pay of officers and clerks and also to changes in the personnel. The decrease in the next year's estimate as compared with the revised estimate is due to lump reductions as a measure of economy.

133. *Courts of Small Causes.*—The decrease in the estimate for the next year is due to the discontinuance of the temporary appointment of the Additional Judge, Court of Small Causes, Karachi, with the effect from 1st March 1927.

134. *Criminal Courts.*—The increase in the revised estimate is mainly due to the creation of a temporary appointment of an Additional City Magistrate, Ahmedabad. The decrease in the estimate for the next year is due to reduced provision for contingencies.

Revenue

135. The increase of 33 in the revised estimate under head (1) is due to the credit of 43 being taken under "Hire of Convicts" on account of Convict labour supplied to the Yeravda Prison Press partly counterbalanced by less receipts expected under "Recoveries of transportation and jail charges from Indian States" and the increase of 25 under head (2) is due to larger demands for jail manufactures. The increase of 1,33 under head (1) in the next year's estimate over the current year's sanctioned estimate is due to credit being taken for the supply of Convict labour to the Yeravda Prison Press including arrears for two years.

Expenditure

136. The decrease of 1,17 in the revised estimate under head (1) is due to an anticipated saving of about 10 in the provision for "Pay of Establishment" and about 20 in the provision for "Allowances, Honoraria, etc." counterbalanced by a reappropriation of 15 for "Works"; the rest of the decrease occurs to a great extent in the provision for supplies to jails from the head "Jail Manufactures" owing to a fall in the prices of raw materials. The decrease of 40 in the revised estimate under head (2) is also due to a fall in the prices of raw materials. The increase of 15 in the revised estimate under head (3) is due to the reappropriation mentioned above which was found necessary in view of the original grant of 16 proving inadequate.

137. The decrease of 86 and 20 in the next year's estimates below the current year's sanctioned grants under heads (1) and (2) respectively is mainly due to the reduction made in the provision for contingent expenditure. No provision is made in the next year's estimate under head (3) as the charges for minor works and repairs up to the limit of Rs. 2,500 are debitable to head (1) and those exceeding that limit have been transferred to the head "41—Civil Works."

Revenue

138. The decrease in the revised for 1926-27 as compared with the budget for the same year and the decrease in the budget estimate for the year 1927-28 as compared with the budget estimate of the current year are chiefly under the minor heads "Presidency Police," "Fees, Fines and Forfeitures" and "Contribution for Railway Police." The decrease under the first two minor heads mentioned above is mainly due to less receipts anticipated under Fees recoverable for licenses granted under the Motor Vehicles Act, and the decrease under the third minor head is due to the discontinuance of the payment of the annual contribution on account of the cost of the Railway Police by the G. I. P. Railway, with effect from the 5th July 1925—the date from which that Railway has become a State Railway.

Expenditure

139. *Presidency Police.*—The decrease in the revised for 1926-27 as compared with the budget for the same year is chiefly due to the recoveries of arrears amounting to 1,78 made from the Bombay Port Trust on account of rental of the buildings in the Alexandra Dock Police Station and accommodation scheme, Dock Police lines between Raichur and Sholapur streets and of a chawl of 105 rooms in the compound of the Old St. Peter's High School at Reay Road occupied by the Dock Police constabulary.

140. *District Executive Force.*—The decrease in the revised for 1926-27 as compared with the budget for the same year is chiefly due to less expenditure under (1) "Pay of officers," (2) "Allowances, etc." and (3) "Contingencies," which is however partially counterbalanced by increased expenditure under "Pay of Establishment" owing to fewer vacancies in the Police force. The decrease in the budget for 1927-28 as compared with the budget for 1926-27 is chiefly due to lump deduction made under "Pay of Establishment" owing to the possibility of some reduction in the Police force, which is under the consideration of Government. The decrease is however partially counterbalanced by new provisions made on account of (1) purchase of tents for Police officers in Sind, (2) entertainment of Police guards for a new sub-treasury at Ahwa and (3) policing of the Criminal Tribes Settlements of Hurs in Sind.

141. *Police Training School.*—The decrease in next year's budget as compared with the current year's estimate is due to lump deductions made under "Allowances" and "Contingencies" on account of probable savings.

142. *Village Police.*—The decrease in the revised for 1926-27 as compared with the budget for the same year is chiefly due to less expenditure under "Pay of Establishment" and "Allowances" owing to vacancies in the force. The decrease in the budget for 1927-28 as compared with the budget for 1926-27 is due to more reductions made under "Pay of Establishment" and "Allowances."

143. *Railway Police.*—The decrease in the revised for 1926-27 as compared with the budget for the same year is due to less expenditure under the units (1) "Pay of Establishment" due to vacancies, (2) "Allowances, Honoraria, etc.," and (3) "Contingencies." The decrease in the budget for 1927-28 as compared with the budget for 1926-27 is due to less provisions made under the above-mentioned primary units.

144. *Criminal Investigation Department.*—The decrease in the revised for 1926-27 as compared with the budget for the same year is mainly due to less expenditure under "Allowances" and "Contingencies." The decrease in the budget for 1927-28 as compared with the budget for 1926-27 is chiefly due to more reductions made under "Pay of Establishment," "Allowances," and "Contingencies." The decrease is, however, partially counterbalanced by a new provision made for the entertainment of Sindhi Shorthand Reporters in the Sind Criminal Investigation Department.

145. Under the Reforms, ports, except such as may be declared to be major ports, and inland water-ways, including shipping and navigation thereon, so far as they are not declared to be central subjects, are Provincial subjects.

146. The first two minor heads relate to charges in connection with the Steamer *Jhelum* and the flat *Multan* which are used by the Commissioner in Sind for touring purposes.

147. Under the Reforms, the receipts in connection with the survey of inland vessels only and the cost of establishment thereof are to be treated as Provincial, while those for ocean-going vessels are to be treated as Central. Accordingly the expenditure in connection with the Marine Survey Department is treated as Central, 7 per cent. of the *net* cost being debited to Provincial. A provision of 4 on this account is made in the estimate under the third minor head.

148. The fourth minor head provides for the boat establishment of the Collector of Kolaba.

149. *Revised estimate for 1926-27.*—The decrease of 1 in the revised estimate as compared with the current year's budget is due to less expenditure in the Bijapur and Satara Museums.

150. *Budget estimate, 1927-28—Provincial Museums.*—The annual grant of 30 which was hitherto paid to the Prince of Wales Museum towards the maintenance of the Museum has been reduced by 5. The Museum also receives an annual contribution of 25 from the Bombay Municipality. This contribution is in effect a grant from Government as it was taken as a set-off against the Municipality's share of the city police charges which were taken over by Government in 1907. The decrease in next year's estimates as compared to those of the current year is mainly due to the reduction in the grant paid by Government to the Prince of Wales Museum.

151. *Revised Estimates, 1926-27.*—The increase in the current year's revised estimates as compared with the current year's Budget is due to larger receipts under "University" (7), "Secondary Schools" (9), "Contributions" (5), "Income from Endowments" (11), and "Recoveries of Service Payments" (12), counterbalanced by a small decrease (1) under "Special". The increase under "University" is due to the fee-receipts of the workshop classes of the College of Engineering, Poona, having been credited to this head counterbalanced by decreases in Arts and Professional Colleges, especially the Law College (owing to the opening of a private Law College at Karachi). The increase under "Secondary Schools" is on account of increased fee-receipts in the Government High School at Broach (owing to the duplication of the Middle school classes), the N. J. High School, Karachi (owing to enhancement in the rates of fees), and the Elphinstone High School, Bombay, and the Government High Schools at Nasik, Ratnagiri, Hyderabad and Mirpurkhas (owing to increase in the number of pupils), counterbalanced by small decreases in other High and Middle Schools, especially the Government Middle Schools at Ahmedabad and Surat owing to restrictions in the number of admissions as recommended by the Retrenchment Committee of 1922-23. The increase under "Contributions" is mainly due to the contributions of the District Local Boards in Sind towards middle school scholarships for Muhammadans. The increase under "Income from Endowments" is due to the crediting of interest on the Gujarat College securities to this head instead of under "Miscellaneous Adjustments between Central and Provincial Governments" owing to the handing over of the securities by the Government of India to this Government. The increase under "Recoveries of service payments" is based on the progress of actuals.

152. *Budget Estimates, 1927-28—University.*—The decrease of 3 next year under this head as compared with the current year's Budget is on account of the decrease in fee-receipts of the Law College on account of the opening of a Law College at Karachi counterbalanced by increased fee-receipts in the College of Engineering, Poona (owing to inclusion under this head of the fees of the workshop classes of the college (8)).

153. *Secondary.*—The increase of 6 under this head in next year's Budget Estimates as compared with the current year's figure is due to the same causes as those mentioned above for the increase in the current year's revised estimates as compared with the current year's Budget estimates.

154. *General.*—The following receipts are credited to this head :—

- (a) Contributions ;
- (b) Income from endowments ;
- (c) Miscellaneous receipts comprising mainly the following items :—
 - (1) Workshop receipts,
 - (2) Vernacular Final Examination fees,

- (3) London Chamber of Commerce Examination fees,
 (4) Drawing Examination fees at the Sir J. J. School of Art, Bombay,
 (5) Government scholarship examination fees,
 (6) The Secondary Teachers' Certificate Examination fees ;
 (d) Recoveries of service payments (*i.e.*, recoveries and refunds made in respect of pay and allowances or any other expenditure which is debited to a service head in the previous years).

The increase of 16 under this head for next year is mainly under " Recoveries of Service Payments " and has been explained under the revised estimates.

155. *Revised Estimates, 1926-27.*—The main alterations in the current year's revised estimates as compared with the current year's Budget are accounted for as follows : —

(a) The decrease under " University " is due mainly to anticipated savings owing (1) to some of the officers being on leave in England (from next year provision for the substitutes only is being made), (2) non-payment of compensatory allowance for the periods of vacations, and (3) one post of Assistant Professor of Geology being vacant, counterbalanced by increases owing to the payment of a building grant of Rs. 25,765 to the N. E. D. Civil Engineering College for a Power House and a special grant of Rs. 67,500 for equipment for the Royal Institute of Science, Bombay.

(b) The increase under " Secondary " is due chiefly to additional expenditure on account of grants to non-Government secondary schools counterbalanced by anticipated savings under " Government Secondary Schools " (4). In this connection it may be noted that pending a careful consideration of the whole question of the maintenance grant-in-aid to be paid to the Madressah-tul-Islam, Karachi, Government have sanctioned provisionally an additional grant-in-aid to that institution of Rs. 21,000 for the current year only which was not anticipated at the time the Budget was framed.

(c) The increase of 16 under " Primary " is due to transfer from the head " Inspection " to this head of amounts required for pay and travelling allowance, etc., of inspecting officers lent to Local Authorities, counterbalanced by the saving of the whole provision of Rs. 68,597 made in the current year for balance of building grant payable to Bombay municipality for primary schools, this balance having been paid to that body from savings towards the close of the last financial year.

(d) The decrease of 62 under "Special" is due to savings on account of (1) reductions in the value of stipends from Rs. 15 to Rs. 12½ per mensem in the Training Schools for men and women, (2) reductions of the posts of Principals of Training Schools for men at Ahmedabad and Dharwar from the Bombay Educational Service to the Subordinate Educational Service, and (3) savings in the allotment for scholarships in the Training Schools for Women, counterbalanced by extra expenditure on account of (1) award of selection grade to an officer of the Women's Branch of the Indian Educational Service, (2) award of three months' pay in lieu of three months' notice to the staff of the Pottery Section of the Sir J. J. School of Art as a result of its abolition.

(e) The decrease of 3,07 under "General" is made up as follows :—

(1) Decrease of 20 under "Direction" owing to allotment of Rs. 20,000 for Customs duty on imported stores having been distributed under the several other heads concerned.

(2) Decrease of 2,10 under "Inspection" due to (i) some of the Divisional Inspectorships being held by non-I.E.S. men and (ii) transfer of a portion of the Inspecting staff to foreign service under local authorities under the Bombay Primary Education Act, 1923.

3) Decrease of 77 under "Scholarships" owing partly to vacancies and partly to the fact that the new scheme for special scholarships for Backward classes could not be brought into full operation as anticipated.

156. *Budget Estimates, 1927-28—General Remarks.*—In view of the present extreme financial stringency and in order to keep the total estimates for next year under "31-Education—Transferred" within the rationed figure of 1,98,44 without reducing the provision for primary education, which should, in accordance with the established policy of Government, have a predominant share of the funds available for education, it has been found necessary to effect the following reductions :—

(a) An all-round 5 per cent. cut in the provisions for contingencies (except those of the Sir J. J. School of Art where a cut has been separately made) (21).

(b) Omission of all provisions for building grants to non-Government educational institutions excepting a small sum of 20 for building grants to primary schools of local bodies.

The above reductions have had to be made in order partly to make room in the rationed figure for certain new items (amounting to 3,21) of an obligatory nature which could not be postponed.

157. *University.*—The following are the important modifications in next year's estimates as compared with the current year's Budget under this head :—

(1) Provision of 50 for additional grant to the Bombay University in order to enable that body to carry out some of the urgent recommendations of the University Reform Committee.

(2) Provision for additional staff, contingent charges and equipment, etc., for the College of Engineering, Poona (2,12).

(3) Opening of the Inter-Science classes at the Deccan College, Poona (52).

(4) Furniture and apparatus required in connection with the proposed opening in 1928-29 of the Ismail College at Andheri (25).

(5) Increase in the annual grant for apparatus, etc., at the Royal Institute of Science (10).

158. *Secondary.*—The decrease under this head as compared with the current year is due to the total omission of the provision for building grants (40). The only other material alteration is the omission from this head of the provision for Government Anglo-vernacular Middle School for Girls, Dharwar, owing to its amalgamation with the Training College for Women, Dharwar, under which institution the requisite provision for the school is now made.

159. *Primary*.—The main alterations under this head as compared with the current year are the following :—

(a) A sum of Rs. 5,700 on account of prizes and scholarships to Muhammadan girls which was hitherto provided under Government Primary schools for Girls has now been transferred to the head "Grants to Local Bodies for primary education" as the amount has now been distributed in the form of additional grants to Local Bodies.

(b) The current year's provision of Rs. 6,28,200 for maintenance grants to non-Government primary schools has been reduced by Rs. 50,000 in the following circumstances. In future grants-in-aid to aided primary schools will not be paid by Government direct in the case of those Districts where Local Authorities have already taken over control of primary schools but by the Local Authorities themselves to whom special grants will be made for this purpose from the provisions under the head "Grants to Local Bodies for primary education". As there are considerable savings under the latter head the above reduction has been made in the next year's estimates.

(c) The provision for grants to Local Authorities for primary education has been increased from Rs. 1,01,60,300 to Rs. 1,02,05,700, the increase being made up of Rs. 5,700, the amount transferred here from the head "Government Primary Schools for Girls" and Rs. 37,000 being the extra provision for meeting the Government share of the normal growth of expenditure.

(d) The provision for the introduction of the scheme formulated by the Compulsory Primary Education Committee has been increased from Rs. 8,50,000 to Rs. 9,53,000.

(e) An increased provision of Rs. 8,95,000 against Rs. 8,32,500 entered in the current year's Budget has been made for grant to the Bombay municipality for the extension and improvement of primary education. The provision represents the maximum liability of Government on account of the scheme of expansion of primary education submitted by the municipality and approved by Government.

(f) No provision for building grant to the Bombay municipality has been made next year as the balance of the grant due to that body under the ten years' programme for housing some of its primary schools has now been paid off.

160. *Special*.—The changes under this head as compared with the current year are as follows :—

(a) The Anglo-Vernacular Girls' Middle School, Dhārwar, having now been amalgamated with the Training College for Women, Dharwar, the requisite provision (about 7) on account of the school has now been entered under this head.

(b) The present provision of 12 for building grants to non-Government special schools has been omitted.

161. *General*.—This head comprises the minor heads (a) Direction, (b) Inspection, (c) Scholarships and (d) Miscellaneous. Among important changes as compared with the current year are the following :—

(1) *Direction*.—The provision under this head has been reduced by 3 as the permanent Director of Public Instruction is expected to be on leave for a portion of the year.

(2) *Inspection*.—(i) A reduction of 14 has been made in the provision for travelling allowance in view of the past actuals. A cut of 5 approximately has also been made in the provision for contingencies.

(ii) The post of Inspector of Science Teaching in the Indian Educational Service has been held in abeyance for two years and therefore no provision has been made on this account excepting a small provision for a temporary substitute.

(iii) Reduction has also been made in the provision under "Inspection" owing to some of the Inspectors going on leave out of India.

(3) *Scholarships*.—A reduction of 39 has been made in the provision for scholarships in view of past actuals and having regard to the fact that there are always a considerable number of vacancies in the scholarships for backward classes.

(4) *Miscellaneous.*—(i) The existing provision of Rs. 3,480 for grant to the Y. W. C. A., Bombay, for providing physical training to lady teachers in girls' schools in Bombay has been omitted as it is found that there is no necessity for this arrangement any longer.

(ii) The provisions of Rs. 9,240 for the encouragement of literature and Rs. 5,000 for Departmental Publications have been reduced, respectively, to Rs. 6,000 and Rs. 3,000 in view of past actuals.

(iii) For the same reason the provision for organisation of physical training in schools and colleges has been reduced from Rs. 8,700 to Rs. 7,000.

(iv) A provision of Rs. 3,000 has been made for grant-in-aid to the Y. M. C. A. hostel, London.

(v) The provision for charges in connection with the Provincial Advisory Committee for Indian students in England has been transferred from this head to the head "University" as the Bombay University has undertaken the work of that committee in future.

(vi) The provision for examination charges has been increased from Rs. 47,000 to Rs. 51,150, the increase being on account of the Vernacular Final Examination charges owing to increase in the number of candidates. The additional provision will be covered by the additional fee receipts.

162. *Expenditure in England.*—The provision of 20 is on account of stores to be imported from Europe. Due to change in the procedure made with effect from 1926-27 the provision on this account which was formerly made in the High Commissioner's Budget is now included under this head.

163. *Exchange.*—The next year's provision under this head is on account of the loss due to exchange and is based on the cost of stores to be ordered through the High Commissioner for India.

164. *Revised Estimate, 1926-27.*—The increase of 5 under the head “General” is due to the promotion of the Inspector of European and English Teaching Schools to the higher grade.

165. *Budget Estimate, 1927-28.*—The total estimates show a decrease of two as compared with the revised estimates for the current year after making an increased provision of 3 for an additional grant-in-aid to the David Sassoon Reformatory on account of Municipal Taxes.

Receipts

166. *Medical Schools and College Fees.*—The decrease in the revised estimate for the current year as compared to budget estimate is due to general falling off due to (1) the restriction of admissions in the Grant Medical College necessitated by the limited facilities for teaching in the allied Hospitals and (2) to the opening of the Sunderdas Govardhandas Medical College in Bombay. For the same reasons the estimate for 1927-28 has been made at the reduced figure of 1,88.

167. *Hospital Receipts.*—The revised estimate for the current year is the same as the budget estimate for that year, *viz.*, 2,04. The estimate for 1927-28 has been placed at the slightly higher figure of 2,10 on the basis of progress of current year's actuals.

168. *Mental Hospital Receipts.*—The increase of 26 in the revised estimate over the budget estimate of 85 for the current year is due partly to increase in the number of paying patients and the anticipated receipts, amounting to 20, on account of the maintenance charges of lunatics belonging to other provinces and admitted into Mental Hospitals in this Presidency. The increase of 11 in the estimate for 1927-28 over the estimate for the current year is also due to the same causes.

169. *Refunds.*—The revised estimate of the amount for “*Deduct—Refunds*” during 1926-27 is 49 against the budget estimate of 2,24 for the purpose. The reduction of 1,75 is due to the fact that part of the refunds, equivalent to that amount, which were included in the budget estimate of 2,24 as being due to municipal and local bodies on account of the difference between the higher contributions made by them towards the pay of their dispensary medical officers and the lower rates subsequently sanctioned by Government on that account, were actually given to those bodies during 1925-26. The estimate for “*Deduct—Refunds*” during 1927-28 is placed at 15 against 2,24 in the budget estimate and 49 in the revised estimate for 1926-27 and the reduction is due to the exclusion from the 1927-28 estimates of the special refunds to municipal and local bodies which were included in the budget and revised estimates of 1926-27 (*viz.*, 2,09 in the case of the budget estimate and 34 in the case of the revised estimate) as mentioned above.

Expenditure

170. *Medical Establishment.*—The decrease of 49 in the revised estimate for 1926-27 as compared with the budget estimate for that year is in the provision for “*Pay of officers*” and is the result mainly of several of the appointments at present reserved for the Indian Medical Service not being filled by officers of that Service but by Bombay Medical Service Officers. The increase in the estimate of 1927-28 of 55 over the budget estimate and of 104 over the revised estimate for 1926-27 is due mainly to (1) the increments in pay earned by several officers, (2) officers with higher rates of pay being among the Reserve Medical Subordinates and (3) provision on account of Indian Medical Service officers, as against the Bombay Medical Service officers included in the revised estimate of 1926-27.

171. *Hospitals and Dispensaries.*—The revised estimate for 1926-27 is 28,20 against the budget estimate of 26,71 for that year and the increase is due mainly to the payment of 5,15 representing Government share of the expenditure on the new N. M. Wadia Maternity Hospital in Bombay, which has recently been completed and taken into use in pursuance of the scheme for increasing arrangements for Medical Relief in the City counterbalanced by anticipated savings in other grants. The budget estimate of 24,18 for 1927-28 is lower by 2,53 than the budget estimate and by 4,02 than the revised estimate for 1926-27 and it is due principally to the following reasons :—

(a) Omission of the non-recurring grant of Rs. 1,15,027 to the Bombay Municipality for the King Edward Memorial Hospital, which was included in the current year's estimates.

(b) Reduction in the provisions for contingencies by Rs. 1,13,551.

(c) Reduction of leave salary by Rs. 10,810.

(d) Omission of the house-rent allowance of Rs. 3,000 to the Superintendent of St. George's Hospital.

(e) Omission of the provision of Rs. 17,340 for the Technical Advisor for Orthopædics, as the appointment has been abolished.

(f) Omission of the provision of Rs. 50,000 for grants-in-aid to new dispensaries.

(g) Reduction of Rs. 12,000 in the provision for expenditure in connection with the application of the Lepers Act to certain parts of the Presidency.

(h) Omission of the provision of Rs. 5,000 for Hospital extension in the city of Bombay.

(j) Omission of the extra non-recurring expenditure on the new N. M. Wadia Maternity Hospital.

(k) Addition of the following items :—

(i) Rs. 12,284 (Additional amount for the extension at the G. T. Hospital).

(ii) Rs. 7,748 (Expenditure on local purchase of equipment for the new outpatient department and operation theatre at Sassoon Hospital).

(iii) Rs. 5,500 (Cost of electric energy consumed at the Civil Hospitals, Thana and Jalgaon).

(iv) Rs. 37,550 (Recurring expenditure of N. M. Wadia Maternity Hospital and other contingent expenditure).

(v) Rs. 2,400 (Grant to the Kurla Dispensary).

172. *Grants for Medical Purposes.*—The budget and revised estimates for 1926-27 are the same. The budget estimate for 1927-28 is 3,98 and the increase of 4 is due to the addition of 44 on account of additional grants to certain Nursing Associations counterbalanced by reductions, amounting to 40, in the grants to certain other Associations and the Hyderabad Medical School.

173. *Medical Schools and Colleges.*—The decrease of 54 in the revised estimate as compared with the budget estimate of 4,99 for 1926-27, is due to several posts at present reserved for the Indian Medical Service not being filled by officers of that Service but by members of the independent medical profession on a much lower scale of remuneration. The increase in the budget estimate for 1927-28 of 70 over the budget estimate and of 1,24 over the revised estimate for 1926-27 is due mainly to (i) increased pay earned by some of the officers, (2) provision on account of Indian Medical Service officers in some appointments, as against the non-Indian Medical Service officers included in the revised estimate for 1926-27, and (3) additional provision of Rs. 73,085 on account of equipment of the new laboratories at the B. J. Medical School, Poona, counterbalanced by the reduction of 10 in the provision for "Value of, and freight on, Europe Stores".

174. *Mental Hospitals.*—The revised estimate for 1926-27 is 5,53 against the budget estimate of 5,85 and the reduction is due to the appointment of Superintendent, Central Mental Hospital, Yeravda, being filled by an officer on lower pay than that budgetted for and the provision for contingencies being not required in full. The increase in the budget estimate for 1927-28 of 34 over the revised estimate and of 2 over the budget estimate for 1926-27 is due mainly to the following reasons :—

- (1) Provision at a lower rate of pay for the present Superintendent of the Central Mental Hospital, Yeravda.
- (2) Reduction of 19 in the provision for contingencies.
- (3) Addition of 32 on account of the cost of electric energy consumed at the Yeravda Mental Hospital and the purchase of cots for that institution.

Revenue

176. The sale-proceeds of quinine and contributions for public health purposes are credited to this head. The decrease in the estimates for next year as compared with the current year's budget estimates in item (1) is due to less receipts from the sale of quinine treatments. The increase in the total estimates for next year as compared with the current year's budget estimates is due to an increase of 31 under "Miscellaneous"—item (4)—on account of the credit of the value of surplus materials such as pipes, meter parts, etc., which are lying in the Poona Water Works Division and are treated at present as surplus without being brought on the stock account and which will now be brought on the stock account when the stock limit of the Executive Engineer, Poona Works Division, is raised. The corresponding debit is given to the expenditure side.

Expenditure

177. *Public Health Establishment.*—The expenditure shown under this minor head relates mainly to (1) the Director of Public Health and Assistant Directors and their establishments (2) the Inspectors of Sanitation and Vaccination

(3) charges of Public Health Laboratories, Poona and Sind and (4) the Sanitary Engineer and his establishment. The provisions for the Consulting Surveyor to Government and his staff and "Pilgrim Charges" which were hitherto being made under the minor head "Grants for Public Health Purposes" have been entered under this head. The increase in the revised estimates as compared with the current year's budget estimates is due to the transfer to this head of the above-mentioned provisions counterbalanced partly by savings mainly under the units "Pay of officers" and "Establishment." The increase in the next year's estimates as compared with the current year's budget estimates is also due to the same reason, the increase being counterbalanced partly by reduced provisions under Public Health Laboratories at Poona and Karachi.

178. *Grants for Public Health Purposes.*—The main items of expenditure recorded under this head are the following :—

- (a) Grants for special expenditure in connection with public health.
- (b) Grant-in-aid to local bodies in connection with the employment of Health Officers and Sanitary Inspectors.
- (c) Grants to Village Sanitary Committees.
- (d) Charges on account of development and town planning schemes.

Item (a).—The current year's provision for this item is 2,92. The revised estimates for the year include in addition 2,90 for a grant-in-aid to the Poona City Municipality on account of the Poona Drainage Improvement Scheme, 1st section. In the ensuing year's estimates a provision of 4,35 is made. It represents grants to Municipalities for water supply and drainage schemes to which Government have been definitely committed. The increase of 1,43 over the current year's budget estimate is mainly due to the provision of 2,04 made for grant-in-aid to the Poona City Municipality on account of the Poona Drainage Improvement Scheme, 1st section, partially counterbalanced by the decrease of 75 on account of discretionary grant to the Sanitary Board for minor sanitary schemes for which no provision is made in next year's estimates owing to financial stringency.

Item (b).—Government pay to local bodies, subject to certain conditions, grants-in-aid equal to two-thirds of the pay of Health Officers and half the pay of Sanitary Inspectors employed in mofussil towns under the revised scheme for the appointment of health officers and sanitary inspectors to the Municipalities. The current year's provision of 90 on this account has been repeated in the next year's estimates.

Item (c).—Government give grants to village Sanitary Committees in the proportion of one-fourth of their expenditure, the other three-fourths being contributed by local bodies and villages. The provision proposed for grants to committees next year is the same as the current year's, *viz.*, 54.

Item (d).—The current year's provision is 116 for town planning and town extension schemes. This includes a provision of 1,10 for payment of the contribution due to the Shikarpur Municipality on account of Government land included in the Shikarpur Town Planning Scheme. The next year's provision is 50 being the second instalment of the Government contribution payable to the Municipality on this account.

Besides the above items provision is made under this head on account of grants to Health and Sanitary Associations, grant-in-aid to Baby Week Celebration, etc. In the ensuing year's budget a provision of Rs. 2,000 is made on account of grant to Broach Sanitary Association and of Rs. 10,000 on account of grant-in-aid to Lady Wilson's Village Baby Scheme.

179. *Expenses in connection with bubonic plague, malaria and epidemics.*—The decrease in the revised estimates as compared with the current year's budget estimates is due to savings under certain provisions for inoculation against plague, etc., and for "other epidemics." The increase in the estimates for next year as compared with the current year's budget estimates is due to additional provisions made for prevention of Malaria in Bombay City, anti-malarial measures in the Dangs, sanitary and medical arrangements at Pandharpur Fair and building of huts in connection with the Infectious Diseases Ward at Dhond.

180. *Bacteriological Laboratories.*—The Haffkine Institute, Bombay, manufactures plague and other vaccines which are sold to public bodies and institutions all over India and in foreign countries. The receipts derived from the sale of these vaccines are shown as deductions in the expenditure of the Institute. The decrease in the revised estimates as compared with the budget estimates of the current year is mainly due to larger receipts from the sale of vaccines and on account of savings under pay of officers partly counterbalanced by an increase under contingencies. The decrease in the ensuing year's estimates as compared with the current year's budget estimates is due to larger recoveries on account of vaccines and partly on account of reduced provisions under pay of officers.

181. *Works.*—The provision made for next year is 4,23 against the current year's provision of 4,58. The decrease is mainly due to the reduction of 20 in the grant for current repairs and a lump reduction of 25 from the total under "Works" counterbalanced by a new provision made for "Workmen's Compensation."

182. *Expenditure in England—Stores.*—The decrease in the revised estimate for the current year as compared to the budget estimate is due to reduction in indents. This explains also the corresponding decrease in the provision for loss on exchange in the revised estimate.

Revenue

183. *Agricultural receipts.*—The Agricultural College and School fees, and sale proceeds of farm produce, cotton seed and implements sold by the Agricultural Department are credited to this head. The current year's sanctioned estimate provides for receipts from boring operations which should properly be classified under the debt head "Famine Insurance Fund" since the entire boring expenditure in the current year is being debited to the head 43-A, Famine Relief. This adjustment accounts for the decrease in the current year's revised estimate as compared with the budget. The increase in next year's estimate as compared with the current year's revised is due mainly to anticipated boring receipts (7) in non-precarious districts since the boring expenditure in these areas is to be debited to the head "34, Agriculture."

184. *Veterinary receipts.*—These consist mainly of fees paid at the Bombay Veterinary College.

185. *Recoveries of service payments.*—These are on account of cash recoveries for services rendered in previous years.

Expenditure

186. *Agriculture.*—The increase in the revised estimate is due mainly to the transfer from "34-D—Works" to this minor head of the provision on account of the expenditure (other than that on buildings and water-supply works) at the experimental agricultural station at Sakrand. The increase in next year's estimate as compared with the sanctioned estimate of the current year is due to the provision of 70 for boring operations by the Agricultural Department in non-precarious districts which is being charged this year to the head "43-A, Famine Relief", and of 1,35 for expenditure at the Sakrand station for which provision was entered in

the current year's budget under 34-D—Works, partially counterbalanced by a provision of 15 for the proposed Agricultural Show to be held in Ahmedabad as against the current year's provision of 50 for the Poona Agricultural Show, smaller provision for contingencies, larger lump sum deductions to allow for probable savings and the exercise of rigid economy in framing the estimates.

187. *Veterinary Charges*.—The decrease in the revised estimate is due mainly to savings anticipated in the provision for the pay of establishment, travelling and other allowances and purchase of serum. The increase in next year's budget as compared with the sanctioned estimate of the current year is due to the fact that two Indian Veterinary Service officers, who were on leave for a part of the year, drew their pay in England, and to a provision of 12 for a grant towards the construction of a Veterinary dispensary at Jacobabad, partially counterbalanced by reduced provision for travelling allowance and contingencies and lump sum deductions to allow for probable savings.

188. *Co-operative Credit*.—The decrease in the revised estimate is due to savings in the provision for the pay of the Registrar, pay of establishment, travelling allowance and contingencies and to larger recoveries of audit fees. The decrease in next year's budget as compared with the sanctioned estimate for the current year is due to smaller provision for the pay of the Registrar, temporary establishment, travelling allowance and contingencies and anticipated larger recoveries of audit fees, partially counterbalanced by a provision of 14 for additional audit staff.

189. *Works*.—The revised estimate for the current year is nil as 1,30 have been transferred to a new sub-head under "34-A, Agriculture", and 1,22 to "41, Civil Works" for buildings and works in connection with the water supply at Sakrand. For next year a provision of 1,35 has been made under the minor head "34-A, Agriculture" as stated above.

190. The receipts under this head are derived from the sale proceeds of cloth woven at the weaving demonstrations. The increase in the revised estimates for 1926-27 as compared with the budget estimates is due to the credit of 3 representing the sale proceeds of articles sent to London during the past years for exhibition at the British Industries Fairs held annually in London. The estimate of 2 for next year represents the sale proceeds of cloth woven at the weaving demonstrations.

Expenditure

191. The decrease in next year's estimates as compared with the current year's budget estimates is mainly due to the absence of any provision in the former on account of the Agricultural Exhibition and reduced provision on account of the Survey of Arts and Crafts. In the current year's budget estimates a provision of 5 is made on account of the former and of 8 on account of the latter.

192. *Examination fees.*—The fees on account of the following items are credited to this head—

- (1) Fees for Accountancy Diploma Examination.
- (2) Fees received by the Civil and Military Examination Committee.
- (3) Fees for the Sanitary Surveyors' Examination.
- (4) Fees for the examination of Health Officers.
- (5) Fees for examination for the grant of certificates of competency to Electrical Contractors and Wiremen.

The decrease in the first minor head is due to the transfer of the provision on account of "fees for renewal of competency certificates and Electrical Contractor's Licenses" to the minor head "Miscellaneous" and is also attributable to smaller number of candidates appearing for the different examinations.

193. *Fees for Inspection of Steam Boilers.*—The decrease in the next year's estimate is due to the estimates having been based on the past year's actuals.

Expenditure

194. *Inspection of Factories, Steam Boilers and Smoke Nuisances.*—The decrease in the revised estimate for 1926-27 as compared with the sanctioned estimate for that year is mainly under "Pay and allowances of officers". The decrease

in the next year's estimate as compared with the current year's estimate is mainly due to reductions under "Pay of officers", "Allowances and Honoraria" and "contingencies".

195. *Miscellaneous.*—The charges on account of "Labour Office", "Commissioner for Workmen's Compensation" and "Control of rent" are provided under the minor head. The decrease in the revised estimate is due partly to the savings under leave salary and pay of officers of the Labour Office and partly on account of less expenditure under "Controller of rent". The decrease in the next year's estimate is due to reductions made under "Allowances and Honoraria" and also "Contingent charges".

Revenue

197. The receipts consist mainly of rents of buildings, rents of electric and sanitary installations, tolls on roads and miscellaneous items. The increase of 60 in the revised estimate for 1926-27, as compared with the Budget estimate for the same year, is due to larger receipts in respect of rents of buildings and miscellaneous items partly counterbalanced by smaller receipts in respect of tolls on roads. The increase of 2,02 in the Budget estimate for 1927-28, as compared with that for 1926-27, is due to larger receipts in respect of rents of buildings and miscellaneous items and by an addition of 1,42 on account of receipts for cost of electric energy supplied to Government Departments and officers.

Expenditure

198. The increase of 1,21 in the revised estimate for 1926-27, as compared with the Budget estimate for the same year, is due to the additions of 1,26 for the Agricultural Station at Sakrand and of 2,97 for the bungalow of the Director of Development which has been transferred to the Public Works Department, partially counterbalanced by the transfer of 1,30 from "Transferred" to "Reserved" and anticipated saving of 1,65 in the provisions for stores, exchange and customs duty. The decrease of 4,38 in the Budget estimate for 1927-28, as compared with that for 1926-27, is due to the fact that although there are increases under certain minor heads they are more than counterbalanced by smaller provisions under other minor heads.

201. The provision of 8,59 for new works includes 5,00 to be kept at the disposal of the Road Board. The balance of 3,59 is intended for the major works shown in Statement E.

202. The increase in the revised estimate for 1926-27, as compared with the Budget estimate for the same year, is due to 1,30 to be transferred from "Transferred" to "Reserved" on account of expenditure on Government Houses. The increase of 1,31 in the Budget estimate for 1927-28, as compared with that for 1926-27, is due to larger provisions for works and repairs in connection with Government Houses.

203. The grant under 41, Civil Works—Provincial (Reserved) is distributed as under :—

NOTE ON THE METHOD OF BUDGETTING FOR PUBLIC WORKS
DEPARTMENT ESTABLISHMENT AND TOOLS AND
PLANT CHARGES

205. In this Province the Public Works Department establishment is not separated into two distinct branches to deal with Irrigation and with Roads and Buildings or "Civil Works". With the exception of the staff employed on the Lloyd Barrage and Canals Construction which is a self-contained unit with its own accounts and audit department, much of the ordinary establishment executes work in connection with both branches. The ultimate allocation of the cost of this mixed establishment to the various irrigation and civil works heads of account is therefore a matter of some complexity.

206. Up to 1923-24 separate demands were being made for Establishment and Tools and Plant charges under the various heads "XIII", "15", "55", etc. Provision on account of these charges was made on the percentage basis, *i.e.*, at the rate of 21½ per cent. on the cost of works and repairs for Establishment and 1½ per cent. on the cost of works and repairs for Tools and Plant. To that was added the total cost of Special Establishments debitable exclusively to each of the major heads. From the total estimated cost of all the Public Works Department Establishments and Tools and Plant the above provision, made under each of the other heads on the percentage basis, was then deducted and the residue was shown under "41, Civil Works". Thus the Audit Officer had to watch the expenditure on Establishment and Tools and Plant under a number of different major heads. This procedure resulted in intermediate booking of expenditure (pending final allocation) under different heads and gave rise to unnecessary trouble and correspondence between the executive and accounts offices. It was, therefore, suggested in 1923 by the Auditor General that all Establishment and Tools and Plant charges of the Public Works Department (excluding Special Establishments) should be included in one demand for grant under "41, Civil Works". This would facilitate the booking of expenditure as well as the appropriation audit. This procedure is being followed now. The details of the Public Works Department Establishment and Tools and Plant charges except those under the Lloyd Barrage and Canals Construction and special establishments are given in the detailed Public Works Department Budget for "41, Civil Works". These charges are summarised in an abstract at the end of the budget and they are then distributed under the various major heads such as "60", "XIII", "15" and "55" in such a way that the estimates may correspond as far as possible with the sum that will be finally debited to these heads. Each of these heads was up till now debited with 21½ per cent. on the estimated cost of works and repairs for establishment and 1½ per cent. for tools and plant. These percentage rates have however been increased to 24 for establishment and 3 for tools and plant with effect from 1st April 1927 in view of the average rates of actuals for the previous five years and in the ensuing year's budget provisions for establishment and tools and plant charges under the heads "XIII", "15", "55" and "60" have been made at the revised rates. In addition to that, each major head is debited with the whole of the cost of Special Establishments, if any, exclusively concerned with those heads. As the Lloyd Barrage and Canals Construction is a self-contained unit, the establishment on which is not employed on other works, it is debited with the total actual cost of its Establishment and Tools and Plant and not with the percentage cost on works and repairs. The residue, after deducting these provisions for the other heads, is taken to be the Establishment and Tools and Plant charges of "41, Civil Works". This distribution is, however, *pro forma* for budget purposes only. For the purpose of demand, the whole of the voted expenditure on Establishment and Tools and Plant was included under "41" in the year 1925-26. From 1926-27 the same procedure is being followed, with the exception that as the Lloyd Barrage and Canals Construction is entirely a self-contained unit with its own Audit Officer, it has been decided not only to debit it with the whole of its actual expenditure on Establishment and Tools and Plant but also to demand a separate grant for it under the head "55" under which all details of establishment are given.

207. After the year has expired and the final figures of expenditure on Works, Establishment, etc., have been worked out, the total expenditure on ordinary Establishment and Tools and Plant is distributed *pro rata* to the various Public

Works Department major heads in each Circle of Superintendence on the basis of the total expenditure on works and repairs in the Circle.

208. The demand under "41, Civil Works" is divided into two portions: "Civil-Works—Reserved" which consists of the demand on account of Government Houses only, and "Civil Works—partly Reserved and partly Transferred" which includes the rest of the demand. It is treated as partly Reserved and partly Transferred because, as explained above, it includes provision for Irrigation Establishment which is Reserved as well as for Roads and Buildings Establishment which is Transferred.

209. Under Schedule IV to the Devolution Rules the Government of Bombay is required to provide every year in its budget 63,60 for expenditure upon relief of, and insurance against, famine. The amount may be spent upon famine relief or upon the construction of protective irrigation works or other works for the prevention of famine. Any portion of the amount which is not so spent is to be transferred to the Famine Insurance Fund of the Province.

210. The opening balance of the Famine Insurance Fund on 1st April 1925 was 1,44,33 which increased to 1,95,32 on 31st March 1926 as explained below. Out of the statutory provision an amount of 44,28 remained unexpended at the end of the year. During the year interest of 6,50 was received from the Central Government on the balance of 1,44,33 and recoveries of 21 on account of certain famine expenditure was made. Thus a total addition of 50,99 was made to the Fund.

211. In the budget estimates of the current year a provision of 11,59 was made under "43-A, Famine Relief." But an expenditure of 14,95 is expected to be incurred this year. The increase is on account of famine fodder and relief of distress in the Poona, Ahmednagar, Satara, Panch Mahals, Thar Parkar, etc., districts. The decrease under "43-B, Transfers to Famine Insurance Fund" is due to larger expenditure under 43-A, which is partially counterbalanced by a smaller expenditure under 15 (1).

212. For next year out of the statutory provision of 63,60, provisions amounting to 42,88 are made under the following heads:—

The balance of 14,75 out of the statutory provision is provided under the sub-head "43-B, Transfers to Famine Insurance Fund" and has accordingly been shown in next year's estimates under "Debts, Deposits and Advances—Famine Insurance Fund (Receipt Side)".

213. The term for which the Legislative Council has agreed to the employment of the Water Diviner expires on 31st March 1927. Provision has been made for him and for his establishment, etc., for the whole of the next financial year, subject to the sanction of the Legislative Council.

214. Pending the decision of the question of the allocation of boring expenditure between "34, Agriculture" and "43-A, Famine Relief", the whole provision required for boring operations by the Agricultural Department was made in the current year's budget under "43-A, Famine Relief". It has now been decided to debit the cost of these operations in non-precarious districts to the head "34, Agriculture" and in precarious districts to "43-A, Famine Relief." Out of the total provision of Rs. 1,75,000 required for next year for boring a sum of Rs. 1,05,000 has been provided under "43-A, Famine Relief" and Rs. 70,000 under "34, Agriculture".

Revenue

215. *Contributions for pensions and gratuities.*—The current year's revised estimate shows a slight increase over the budget estimate. This is due to the credit under this head on account of leave and pension contribution from Excise menials which was hitherto being taken as reduction of charges under the head "6, Excise", and to the credit on account of passage contribution in respect of officers employed on Lloyd Barrage Project. The small increase in next year's estimate as compared with the revised estimate is due to the credit on account of leave and pension contribution in respect of Police supplied to private companies and the Security Printing Press at Nasik and to increase in the contribution from Excise menials and passage contribution in respect of officers employed on Lloyd Barrage Project.

216. *Commuted value of pensions.*—The small increase in the revised estimate as compared with the budget estimate is due to increase in the commuted value of pensions paid by this Government on behalf of other Provincial Governments on account of a larger number of pensions having been transferred to this Presidency for payment counterbalanced by a decrease in the commuted value of pensions paid by this Government on behalf of the Central Government which is based on

the actual number of pensions for which adjustments have to be made during the current year. The next year's estimate shows a decrease as compared with the current year's budget and revised estimates. This is due to the fact that approximate figures have been entered on the basis of expenditure incurred in the first half of the current year.

Expenditure

217. *Superannuation and retired allowances.*—The revised estimate for the current year and the budget estimate for the next year have been framed on the basis of the progress of actuals during the first eight months of the current year.

218. *Commutated value of pensions.*—The sanctioned estimate under this head included 1,25 on account of capitalised value to pensioners in respect of a portion of their pension. The provision on this account has been made in the revised estimate for the current year and budget estimate for next year under a new capital head "60-B, Payment of commuted value of pensions". The revised estimate has been taken at 2,10 instead of 1,68 in view of the additional expenditure involved by the transfer of annuity of a Civil Service pensioner to the Bengal Government.

219. *Equated payments of commuted value of pensions charged to capital.*—As stated in the foregoing paragraph the provision on account of commuted value of pensions is made under a new capital head "60-B, Payment of commuted value of pensions". Although provision for commutation is not made under the head "45, Superannuation allowances and pensions" the amount debited to the capital major head in each year is to be repaid from revenue by a system of equated payments spread over 15 years which are to include interest on the capital invested. A provision of 49 has been made in next year's budget to meet the debit on account of the equated payment in respect of the current year's commutation.

220. *Compassionate allowances.*—The increase in the revised estimate is due to the transfer of 20 on account of compensation under "Workmen's Compensation Act" from the head "47, Miscellaneous—Reserved" to this head. The next year's provision has been made on the basis of actuals of the past three years. It also includes 6 on account of compensation under "Workmen's Compensation Act".

221. *Covenanted Civil Service pensions.*—The increases in the revised estimate for the current year and the budget estimate for the next year are due to transfer of payment of annuity of Civil Service pensioners from other Provinces to this Presidency.

222. *Deduction on account of commercial Department pensions.*—Pensionary charges of commercial Departments are with effect from 1st April 1923 brought to account under the appropriate commercial heads of account concerned instead of being adjusted under the general head "45, Superannuation allowance and pensions". The revised estimate for the current year and the budget estimate for the next year have been framed on the basis of the last year's actuals. They also include credit on account of pensionary charges of Nasik and Khanapur Distilleries, the accounts of which are now kept on commercial basis.

223. *Deduct pensionary charges on account of Bombay Development.*—The decrease in the current year's revised estimate and next year's budget estimate is due to the retrenchment of establishment and also to the revision of rates of calculating the pensionary charges. These charges have been finally debited to the head "59, Bombay Development Scheme."

Revenue

224. The revised estimates for the current year under "Stationery receipts" and "sale of Gazettes, etc." are more than the sanctioned estimates on account of the unexpected increase in the demands for stationery, Gazettes and other publications, while the revised estimate under "other press receipts" is less than the sanctioned estimate on account of reduction of printing work in the press. The next year's estimate under "Stationery receipts" is higher than the revised estimate for the current year because the Administrative Officers of the School Boards (District Local Boards) and the District Superintendents of Police (for Conveyance Fund) are now indenting for Stationery articles from the Stationery Office. The next year's estimate under "sale of Gazettes and other publications" is based on the average receipts of the previous years and does not call for any remarks. The next year's estimate under "other press receipts" is more than the current year's revised estimate because in view of the control of Primary Education having been transferred to the Local Boards, the forms and envelopes required by the latter will now be supplied on payment. Some increased receipts are also anticipated under this head owing to the fact that certain Government undertakings, such as the Central Workshops, Dapuri, the Poona Water Works, etc. have been declared as commercial undertakings and will therefore be charged for supplies made to them.

Expenditure

225. The revised estimate for the current year under "Government Presses" is less than the sanctioned estimate on account of :—

(a) the absence on leave of the Superintendent, Government Printing and Stationery, for eight months and the consequent savings in his pay and allowances and those of the other officers in acting arrangements ;

(b) the transfer of the headquarters of the Superintendent, Government Printing and Stationery, from Poona to Bombay and the consequent savings in the provision for travelling allowance of the Superintendent, and in the charges for service postage stamps and the other expenditure in respect of the publications required by the Bombay customers ;

(c) vacancies in the establishments of the Government Presses and the consequent savings in the provision made for the pay and leave allowance of the members of the establishment ;

(d) the recent decision of Government that the Secretariat Departments and the Government officers requiring Government of India publications should pay for them and the consequent savings in the provision made for the purpose ;

(e) non-utilization of the provisions made for plague allowance and less expenditure on account of the bonus and dearness allowance ;

(f) less expenditure against the provisions made for the customs and import duty under "Superintendence" in view of the fact that customs duty is not charged on the paper on which import duty is recovered as was understood before ; and

(g) various economies effected by the Superintendent, Government Printing and Stationery, and the consequent reduction in contingent expenditure.

The revised estimate for the current year under "Printing at private presses" is less than the sanctioned estimate on account of the restriction of printing at private presses. The revised estimate under "Purchase of Stationery Stores" is more than the sanctioned estimate by 157 on account of the payment of the balance to be made to the Central Government on account of the Stationery Stores taken over by this Government. The revised estimates under "Expenditure in England" and "Exchnage" are less than the sanctioned estimates in view of the restricted demand for Europe goods.

226. The next year's estimate under "Government Presses" is more than the current year's revised estimate on account of :—

(1) increments due to officers and members of clerical and other establishments and the consequent increase in the provisions for their pay, leave salary and other allowances ;

(2) the provision of 1,43 on account of the cost of convict labour supplied by the Jail to the Yeravda Prison Press ;

(3) the provision of 15 made for the first time for consumption of electrical energy by the Yeravda Prison Press ;

(4) the provision of Rs. 1,300 on account of "Compensation under the Workmen's Compensation Act."

227. Out of the provision of 5,90 made for the purchase of Stationery Stores in the current year's budget, a sum of 50 has been earmarked for the work of the Bombay Legislative Council. It has been reported that the cost of printing work done for the Bombay Legislative Council from 1st April to 30th September 1926 comes to Rs. 17,585. Printing work was also done for the Legal Department and for the Returning Officers in connection with the elections and the cost of the same works out to Rs. 20,712. The total expenditure incurred for the Bombay Legislative Council thus comes to Rs. 38,297 up to the end of December 1926.

228. *Unclaimed deposits.*—The revised estimate for the current year and the budget estimate for the next year are framed on the basis of past actuals.

229. *Fees for Government audits.*—The increase in the revised estimate for the current year and the budget estimate for next year is on account of fees to be credited to Government for auditing the accounts of minors whose estates are in charge of the District Judges in this Presidency.

230. *Rents, rates and taxes.*—An amount of 3,39 stands included in the provision of 3,49 in the current year's budget for recoveries from the Government of India on account of arrears of rents, rates and taxes on central buildings paid to the Bombay Municipality on behalf of the Central Government. A part payment has been made by the Government of India which has been adjusted in the accounts for 1925-26. A provision of 6,73 has been made in next year's budget on account of the balance to be recovered from the Government of India. No credit has therefore been taken in the current year's revised estimate.

231. *Recoveries of service payments.*—The revised estimate for the current year includes 44 on account of the balance of claim against the Government of India in respect of charges incurred by this Government in the maintenance of relations with Indian states.

232. *Donations for charitable purposes.*—The increase in next year's estimate is due to increased grant-in-aid to the Society for the Prevention of Cruelty to Animals, Bombay, capitation grant to the Children's Aid Society and grant-in-aid to the Pandharpur Orphanage.

233. *Charges on account of vagrants.*—The revised estimate for the current year and the budget estimate for the next year have been based on the progress of actuals of first eight months of the current year.

234. *Special commissions of enquiry.*—The increase in the revised estimate over the budget estimate for the current year is on account of charges of the Fallow Rules Committee.

235. *Rents, rates and taxes.*—The sanctioned estimate which included provision for rents, rates and taxes to be paid to the Bombay Municipality on Provincial buildings was a rough one. It also included 1,35 on account of the difference between the old and the new award to be paid to the Bombay Municipality. The next year's estimate includes normal provision of 2,33 to be paid to the Municipality.

236. *Contributions.*—Government have undertaken financial responsibility to the extent of Rs. 38,530 for the trunk telephone line between Karachi and Sukkur via Hyderabad, *i.e.*, if the income derived by the Telegraph Department from calls falls short of this amount the deficit has to be made good by Government. This liability was undertaken as the telephone line is required for administrative purposes, especially in connection with the Lloyd Barrage and Canals Construction Scheme. The line was installed in 1925 and it was anticipated that sufficient use would be made of it by the public to enable it to pay its way. This anticipation has not been realised and the deficiency in 1925-26 amounted to 25 two-fifths of which, *i.e.*, 10, is debit to this head, the balance being debit to "55, Construction of Irrigation Works". The amount payable next year will depend on the income in the current year. A provision of 6 has been made for the purpose next year under this head.

237. *Miscellaneous and unforeseen charges.*—The decrease in the revised estimate is due to the transfer of funds from the provision for Reserve to other major heads for expenditure under those heads and surrender of 5,00 which is not likely to be utilised.

238. *Miscellaneous compensations.*—The current year's sanctioned estimate included 20 on account of compensation to workmen under the "Workmen's Compensation Act". As this provision has now been made under the head "45, Superannuation allowances and pensions", the revised estimate for the current year and the budget estimate for the next year have been placed at 1 respectively.

239. *Special commissions of enquiry.*—The increase of 27 in the revised estimate for 1926-27 is mainly due to the additional grants sanctioned under this head to meet charges of (1) the Committee appointed by Government to consider the question of transferring certain provincial roads and buildings to District Local Boards and (2) the non-official members' travelling allowance for attending the Conference of Local Boards and Municipalities. The excess of 4 in the budget estimate for 1927-28 over that for 1926-27 is due to the fact that the Committee referred to above will continue to work for some time during the year 1927-28.

240. *Contributions.*—The decrease of 23 in revised estimate for 1926-27 is due to transfer of the amount to the minor head “Special Commissions of Enquiry” by reappropriation. The decrease of 18,10 in the next year’s estimate is due to the transfer of 19,00 for grants-in-aid to Local Boards for local public works to the head “41, Civil Works” and to the decrease of 5 in the provision for subventions to Local Boards for their Chief Officers, etc., partly counterbalanced by a provision of 86 for local board elections, a provision of 8 for grant-in-aid to the Local Self-Government Institute and of 1 for grant-in-aid to the Mahableshtar Municipality for its extra expenditure on the roads within its limits.

241. *Miscellaneous and unforeseen expenditure.*—The decrease in the revised estimate is due to transfer of funds from the provision for the Reserve to other major heads for expenditure under those heads.

245. *Customs duty on imported Government stores.*—Since the repeal of the proviso to section 20 of the Sea Customs Act, VIII of 1878, Customs duty is being levied on all Government stores, with certain exceptions, imported into British India on or after 1st April 1924. The Government of India have however decided to give an assignment in refund of the duty paid by this Government on Government stores.

246. *Claim for the value of the old stock of stamps.*—At the Conference of the Financial Representatives held at Delhi in 1925 it was decided that the value of the stock of stamps held in the several stamp Depots on the introduction of Reforms on 1st April 1921 should be divided half between the Imperial Government and the remaining half between all the Provincial Governments. 250. The expenditure incurred by the Secretary of State is on account of sundry items, e.g., law charges in connection with Privy Council appeals, payment of leave and deputation salaries of Military Officers in Civil employ, outfit allowance of officers on appointment, etc. The increase in the current year's revised and next year's budget estimates under "Reserved" is mainly under the head "45, Superannuation Allowances and Pensions" due to the increased number of cases in which allocation of Military retired pay is being effected. 251. The expenditure incurred by the High Commissioner is on account of leave and deputation salaries, sterling overseas pay, etc., and for exchange thereon. The increase of -1,42 in the current year's revised as compared with the current year's budget under "non-voted" "Reserved" is chiefly under "Superannuation Allowances and Pensions" and is due to additional provision required to cover the amount chargeable to this Government by transfer from suspense in Central Government accounts in respect of sums advanced up to 31st March 1926 for commutation of proportionate pensions. 252. The head “8-A, Forest Capital Outlay charged to Revenue” has been opened to record transactions of a capital nature in accordance with the decision to classify, with effect from the financial year 1925-26, all expenditure in the Forest Department under “Revenue” and “Capital.” All forest expenditure of a capital nature is to be brought to account, in the first instance, under the major head “52-A, Forest Capital Outlay—not charged to revenue,” such portion as it may be decided to finance from revenue being transferred at the end of the year to the new major head “8-A, Forest Capital Outlay charged to Revenue.” Government have decided to meet in 1927-28 the entire expenditure shown under “52-A” from loan funds. 253. The provision of funds for capital expenditure on irrigation works for which capital accounts are kept is made under the head "55". The capital expenditure on these works may be defrayed from general revenues of the year or from the Famine Insurance Grants or from sources outside the revenues of the year, such as loans, accumulated balances of the previous years, etc.; but the major head "55" is intended to include only expenditure incurred from sources outside the revenues of the year, and for this reason provisions made from ordinary revenues of the year or from the Famine Insurance Grants are to be deducted in lump from the gross provision under this head and shown under a separate head "16", the residue representing the amount provided from sources outside the revenues.

254. The current year's budget and revised estimates with the actuals for the last year and the budget estimate for the ensuing year are shown below:—

255. In connection with the Lloyd Barrage and Canals Construction project a separate note is printed hereunder in which the revised estimate for the current year and the budget estimate for the ensuing year for that project have been compared with the budget estimate for the current year and reasons for the variations have been explained in detail. That note describes also the progress of expenditure on the project to the end of the current year as well as the works proposed to be carried out in the ensuing year, and full details thereof have been given in Appendix D to the note.

256. With regard to other works in Sind and Deccan and Gujarat there is a decrease of 84 in the revised as compared with the budget estimate for the current year and this is mainly due to a large saving of about Rs. 1½ lakhs on the grant for the Nira Right Bank Canal project. The reasons for this saving reported by the local officers are (1) less expenditure on the construction of distributaries than anticipated as the works are small and scattered, (2) delay in the execution of certain works on account of the necessity of admitting water into the canal and distributaries for cultivation in the rabi season of the current year, and (3) delay in the payment of compensation to the Bhore State for the lands acquired for the Lloyd Dam. A portion of the savings in question was however utilized to meet expenditure on certain urgent works in Sind which have been taken up in the current year.

257. The proposed expenditure of 19,92 in the ensuing year on works other than the Lloyd Barrage and Canals Construction also shows a decrease of 6,09 when compared with the budget estimate for the current year and it entirely occurs in the provision made for works in the Deccan. This decrease is mainly due to the completion of the Pravara River Works project for which no provision has been made for the next year and a smaller demand for the Nira Right Bank Canal project which is also approaching completion. The provisions made for works worth mentioning and included in the above mentioned proposed expenditure of 19,92 are as follows :—

All the above mentioned works are already in progress. The balance of the expenditure (5,09) is made up of the provisions of 73 for carrying out certain small improvements to canals in Sind and Deccan and reserve with Government for unforeseen requirements and of 4,36 for establishment and tools and plant charges based on percentage rates of 24 and 3 per cent. respectively on the cost of works.

NOTE ON THE BUDGET FOR THE LLOYD BARRAGE AND CANALS CONSTRUCTION SCHEME FOR 1927-28

I—INTRODUCTION

258. The history of the scheme is now already well known but it is necessary to repeat some brief particulars by way of explanatory introduction. The province of Sind is mainly dependent on canals for the supply of water for cultivation. In normal years out of the total cultivation, 90 per cent. is irrigated. There are several large canals in existence, but they carry their supplies during the inundation season only, and suffer very badly when the inundation is low or below the average. The scheme has been designed to give an assured perennial supply to the three main Canals and an assured kharif supply to the Central Rice Canal and the Khairpur State Feeders, East and West. It consists of a barrage across the Indus below the gorge at Sukkur, three Canals on the right and four on the left bank each with a separate head regulator. The right bank system comprises the North Western Perennial, the Central Rice (now Rice) and the South Eastern Perennial (now Dadu) Canals. The left bank comprises a great new perennial canal (Rohri Canal), a perennial supply channel to feed the Eastern Nara river and the canals dependent thereon and two high level canals for irrigating lands in the Khairpur State. The barrage will, under scientific control, give the necessary supply to each canal, no matter how low the natural level of water in the river may be. All the canals taken together will command some $7\frac{1}{2}$ million acres and enable about $5\frac{1}{2}$ million acres of crops to be irrigated annually. The total length of main canals and branches is nearly 1,600 miles and that of the distributaries 3,700 miles. The scheme is estimated to cost Rs. 1,835 lakhs including direct and indirect charges. It received the approval of the Secretary of State in April 1923, was passed by the Bombay Legislative Council in June 1923 and construction work commenced in July 1923. The progress since made on the work of each section of the scheme is explained below.

II—PROGRESS OF WORK TO END OF 1925-26

The Barrage Proper

259. The works carried out to the end of 1925-26 were mostly preparatory to the efficient execution of the main permanent works in the river as soon as the latter could be started.

The principal items of work done were as follows :—

(1) *Land—Acquisition of land on both banks of river for townships, work-yards, quarries and canal heads.*—This has been practically completed except for the part of the land required for the new supply channel of the Eastern Nara. This is being acquired as needed for work.

(2) *Permanent Work—Guide Banks.*—The upstream guide banks on both sides of the river were completed in 1924-25 and have now stood three flood seasons without any sign of damage or settlement. That on the left bank is 3 miles long, and that on the right bank (which is in continuation of the Sukkur Bunder wall) is about $\frac{3}{4}$ miles long.

The curved masonry retaining wall joining the bunder wall to the right bank has been completed.

(3) The works of the main barrage and regulators had not been started up to the end of 1925-26.

Service Works

(4) *Construction of broad gauge and narrow gauge service railways connecting all parts of works areas, on both banks, with the quarries, the main North Western Railway and the Barrage site—*

(i) Nearly 30 miles of broad gauge line have been laid and are in constant use.

(ii) About 10 miles of 2' gauge track have been laid and this was in constant use by the end of 1925-26.

(5) The necessary service roads and bunds on both sides of the river were completed and maintained and were in constant use.

(6) *Wharves*.—The construction of large wharves on either bank of the river was commenced. These wharves are each about 650' long and will carry broad gauge railway tracks to enable the barges and steamers to be loaded direct from the shore. They have since been nearly completed and will be finished in the current year. Portions have already been brought into use and are a great convenience to the work.

(7) *Buildings*.—To house the staff on the works, two townships on either bank of the river have been constructed. Each township is provided with a hospital, bazaar, market and institution. Both townships are occupied. The following units of buildings were completed upto end of 1925-26.

Compressor houses and other buildings at the quarries at Sukkur, Rohri and Kohistan.

Four Batteries of mortar mills driven by electric motors.

Steel structural shops for stone dressing.

Special Tools and Plant

(8) Large quantities of necessary plant were purchased, erected and brought into use upto end of 1925-26.

The principal items were :—

Railways—

10 second hand broad gauge locomotives.

509 second hand broad gauge wagons of various kinds.

6 new broad gauge wagons for heavy loads.

30 tipping wagons.

33 miles of broad gauge track.

10 miles of narrow gauge track.

360 new narrow gauge side tipping wagons.

Fleet—

2 Suction Dredgers, 20" diameter, the "Rohri" and "Ru'k" each complete.

1 Heave up boat.

10 Steel barges.

3 Jolly boats.

4 Motor launches.

Cranes—About 40 cranes of various descriptions.

Pumping plant—6 sets have been erected.

Pile Driving Plant—6 have been erected.

Stone Crushers—2 numbers each driven by an oil engine of 47 B. H. P.

Concrete mixers—2 Portable mixers of 14 c.ft. capacity each driven by an oil engine.

Block moulding plant—2 complete sets.

Air Compressors and Pneumatic tools of various sorts.

Diving gear—2 complete sets with air pumps, helmets, clothes and lamps.

Workshops—Complete equipment of lathes, drilling machines, milling machines, saw benches, grinders, power hammers and equipment for iron and brass foundry.

Works Water Supply—All necessary tanks staging pumping plant and distribution mains.

Mortar Mills—8 batteries of 6 pans each.

Steel Sheet Piling—About 12,400 tons have been received, unloaded and stacked and about 1,200 tons used in wharves.

Quarry Plant—This has been installed at Sukkur, Kohistan and Rohri Quarries.

Stone Dressing Plant—has been received and is under erection.

Left Bank System

Rohri Canal and Khairpur Feeders

The surveying and designing of the main canal, its branches and distributaries has been almost all been completed and very little of such work remains to be done now. The working estimates for these are now in hand. A very large area of land has been demarcated and progress has been made in land acquisition. Bricks have been manufactured and stacked at Kandiaro for the construction of a regulator and buildings there for which a reserve of stock of Rs. 75,000 has been sanctioned.

Much progress has been made on buildings. Ten first class and 11 second class bungalows have been under construction out of which some have been completed and others are nearing completion. Two bungalows for the office and residence of the Executive Engineer, No. 5 Division, at Hyderabad were purchased and 2 residential bungalows and offices for the Executive Engineer, No. II and III Divisions, at Nawabshah, 2 residential bungalows for the Chief Engineer and Superintending Engineer, Rohri Canal Circle, at Karachi, have been constructed and are occupied. Forty-two Sub-Divisional Officers' rest houses and 23 Sub-Divisional offices were under construction and most of them are completed. Seven Dragline excavators have been purchased and erected and they are working on the excavation of the main canal and branches. Two big Bucyrus machines have commenced the excavation of the Rohri Canal from its head and up to end of September 1926 they have completed it in a length of nearly 5 miles, having done about 573 lakhs c.ft. Up to end of March 1926 it was 3 miles or 370 lakhs c.ft. Similarly two big Ruston Machines have commenced the excavation of the main canal near Mehrabpur and have completed it in a length of 6 miles, having done about 494 lakhs c.ft. Up to end of March 1926 they had done $3\frac{1}{2}$ miles or 250 lakhs c.ft. The Khairpur Feeder East has been excavated by two Small Bucyrus Machines in a length of 8 miles up to end of September 1926, *i.e.*, nearly 273 lakhs c.ft. Up to end of March 1926 four miles or 143 lakhs c.ft. had been excavated. One Small Bucyrus Machine has been working along Nasir Branch from the regulator to the head of the branch and has also completed 1 mile of Escape No. 3 and 8 miles of Hyderabad Branch. The approximate quantity excavated by this machine is about 120 lakhs c.ft. The excavation work of some portion of the main canal near Mehrabpur and portions of some branches in Division No. 5 has been let out on contract to be done by manual labour and these works are progressing fairly well.

Eastern Nara System

The preliminary surveys and investigation work was completed. In the Puran Dhoro Division all the alignments of the main canal, branches and distributaries have been fixed, curves set out and the centre lines demarcated on the ground. The inspection path along the Nara from its head to Jamrao head has been almost completed. The work of containing banks was completed in a length of 14 miles above Jamrao Head and also from Jamrao Canal Head to Makhi Weir—also 4 Escape sluices costing about Rs. 60,000 have been completed. The Flood Diversion Bund has been also completed on both the right and the left banks of the Nara in a length of about 24 miles above Jamrao Head.

A good deal of work in connection with the construction of buildings has been carried out. Two 30-B Dragline Machines have been received and erected for the Mithrao Remodelling Division.

The excavation of the Khipro Canal has been started by Dragline Excavators and about 82 lakhs c. ft. of excavation done in $6\frac{1}{2}$ miles length.

The telephone line along the entire length of the Nara between Sukkur and Jamrao Head has also been completed. Gauges have been fixed at 11 places along the Nara. The "sangs" taking off from the Nara have been surveyed in a length of about 140 miles.

Right Bank System

Alignments of all the branches, distributaries, minors and valley lines have been finally completed in the North Western Circle and in the Western Circle the work of preliminary investigations and nicking out centre and boundary lines in connection with the main canal has been finished, while that of the distributaries was taken in hand and completed in some instances.

Fairly good progress was made on the acquisition of land but it was not completed.

The question of utilising part of the existing Pritchard Canal for the main *South Eastern* (or Dadu) Canal has also been considered and the proposal adopted. This change necessitated the giving up of a considerable area of land which was notified for acquisition but not acquired.

On the Dadu Canal some land was also relinquished on account of the above decision regarding utilization of the new Western Nara Cut.

Preliminary arrangements for the Railway bridges at Ruk and Arain were completed. Investigations for other bridges and regulators in the North Western Circle were also nearly completed in consultation with the Revenue and the Local Board authorities.

Buildings at Bagarji, Ruk, Garhi Yasin and Naraindas Village were completed finally; whilst satisfactory progress was made on the buildings at Shahdadkot and on the office building of the Executive Engineer at Garhi Yasin.

A start was also made on the buildings at Jahanshah.

The North Western Perennial Canal was excavated in a length of about $10\frac{1}{2}$ miles, the quantity excavated being 75 million c.ft. The excavation of the Central Rice Canal was also started and about $\frac{2}{3}$ mile has been excavated, the quantity excavated being 5.6 million c.ft.

In the Western Circle the erection of Dragline excavators has been completed.

Light Railway from Ruk Railway siding to boundary of North Western Perennial Canal has been laid in a length of about a quarter of a mile. Tube wells at mile $12\frac{2}{3}$ and $7\frac{1}{1}$ of Sukkur Canal were sunk. One well at mile $15\frac{7}{7}$ of Sukkur Canal was completed and another at chainage 82,000 of North Western Perennial Canal was started.

The two 50-B Bucyrus Dragline Excavators have been erected at Ruk and a little work done on the North Western Perennial Canal for the purpose of training the operators. The machines were then taken to Shahdadkot branch mile 6, where a start has been made on the excavation work.

III—PROGRESS OF WORK IN 1926-27

Lloyd Barrage Circle

260. All land will have been acquired. All buildings for which plans and estimates have been sanctioned in the townships and quarries will be completed.

All structures required in the works areas, such as lime kilns, erection of block-yard plant, erection of stone crushers, screens and bins at quarries, erection of mortar mills, sinking of tub well, and erection of high service tank and distribution mains for township water supplies, erection of further cooly lines, etc., will be completed. The Barrage wharves will be completed very shortly and railway lines laid thereon, as well as fuel oil storage tanks for supplying the floating plant and fleet.

All land and river plant as received will be erected, tested and brought into use, including further pumping plant, pile-driving plant, stone dressing machinery, floating cranes, barges, tugs, etc.

The electric transmission system is already almost complete and will be finished during the year. It comprises about 13 miles of transmission lines, composed of about 76 miles of copper conductors, 10 miles of galvanised iron guard wires and 380 steel poles. The broad gauge railways are practically complete, but a few new sidings will be laid during the year as required.

The narrow gauge track will be lifted and relaid and further track laid as required for works.

The design of the head regulators of all canals and of the approach channels and divide walls has been completely reinvestigated and such changes from the project proposals as were found desirable have been made to suit the alterations made in the canal working designs. Detailed estimates for the regulators could not be prepared till this lengthy investigation was completed. These estimates are now completed and indents for the cills and grooves of the regulators were sent to England during October 1926. These will be required as quickly as possible, but the gates themselves are not needed till the canals are ready to operate and will be ordered later on. In the meantime work on the cofferdams for the first season's work in the river, *viz.*, for the construction of the major portion of the Head Regulators on either bank, has already been started. Work is being carried on day and night, and will continue at full pressure. It is hoped nearly to complete the floors of the majority of the regulators by the end of March 1927 and work will go on continuously day and night till these are completed and the cofferdams removed, when the superstructure will be taken in hand.

The excavation of the Eastern Nara by dredger was started as soon as the river level was high enough to permit the dredger to make the cut of required depth. Owing to the presence of hundreds of buried trees which had been used many years ago to make wells and khuadas, progress was extremely difficult and slow, and a length of only 620 feet to the width required was completed before the river fell and the dredger had to be withdrawn.

It is evident that there has been considerable accretion of the river bank here for many years past and khuadas once on the river edge are now hundreds of feet in land. It is believed that they cannot extend beyond the old river bund and if so, progress will be much easier and faster when they have disappeared. The work of the Eastern Nara will probably be done by various means, *viz.*, partly by dredger, partly by dragline and partly by manual labour. The whole problem is being investigated as data and experience are gained. For the work on the regulators the quarries will be supplying stone, lime will be manufactured, sand brought from the quarries, mortar mills grinding mortar, blockyard plant moulding concrete blocks, stone dressing shop getting cut-stone ready for superstructure, and railways and fleet be busy the whole time moving materials.

The two steam tugs lay at Aden for some time owing to the monsoon and their absence greatly hindered all work in the river. A second-hand tug, the KALABAGH, has been bought recently, very cheaply, from the North Western Railway, but although she is extremely useful, she is not powerful enough for much of the work required, and in any case she must be laid up as soon as possible for a thorough overhaul.

The very protracted delays in the delivery of most of the plant already obtained seriously set back the testing of the same and the consequent ordering of further plant, besides delaying the works for which it was needed. With the strike situation in the United Kingdom deliveries have been very protracted and indefinite and such conditions are bound to react on the progress of works at Sukkur.

Rohri Canal and Khairpur Feeders

The survey work and building work begun and nearing completion to the end of 1925-26 will be completed during this year. Construction of two more rest houses at Tando Mustikhan and Saidad Jalbani and two more Sub-divisional offices at Ganbat and Saidad Jalbani has been started and some darogas' landhis and other establishment quarters, etc., will be taken in hand during this year. Excavation of the main canal is proceeding well. Khairpur Feeder East will be completely excavated during the current year and the two small Bucyrus Machines will be transferred to Division No. 5 Rohri Canal for commencing the excavation of main Rohri Canal near Oderolal. Two 30-B Bucyrus Diesel Machines have arrived and have been erected for the excavation of distributaries, etc., in Division No. 5. Indents for five 30-B Machines have been submitted and indents for two 50-B Machines are in transit and they are expected to arrive very shortly. All these machines will be utilised on excavating branches and distributaries.

Eastern Nara System

The remaining surveys and investigations will be completed and the building programme also will be nearly completed.

Containing banks above Jamrao Head will be taken up in a further length of about 20 miles of the Nara and it is hoped $\frac{2}{3}$ of it will be completed during the year. The containing banks between Jamrao Head and Makhi Weir are expected to be completed. The Flood Diversion Bund from Makhi Weir to Khipro Weir will be started.

The excavation of the Nabisar Branch in the Mithrao Remodelling Division will be continued during this year. The preparation of the project for the new cut (main Mithrao Canal) and distributaries *ex-Mithrao*, Nabisar and Naokot branches and Jamrao improvements is expected to be completed.

The earthwork of Sufi Branch and the Hiral Distributary is expected to be taken in hand.

The earthwork on the Khipro Canal will be in full swing.

Right Bank System

Preliminary work in the Western Circle will be completed.

Land acquisition for the main canals as well as for the branches will be completed and considerable progress made for the distributaries and minors.

Collection of materials for Warah Branch head regulator will be taken in hand. A start will be made on the railway bridges at Arain and Bagarji. Statements of all the regulators and bridges required in the North Western Circle have been prepared and are under consideration.

Buildings for the office of the Executive Engineer at Garhi Yasin will be completed. Efforts will be made to complete the Inspection Bungalow with its subsidiary buildings and Sub-Divisional Officer's rest house at Sujawal, which were started last year.

Buildings at Shahdadkot and Jahanshah will be completed while those at Bagodero and Kubo Saidkhan will be taken in hand and completed as far as possible.

About 80 million cubic feet of earthwork by Dragline Excavators on the main North Western Perennial Canal and Central Rice Canal will be done during this year. Excavation of Shahdadkot Branch which was started by the end of March last with two 50-B Bucyrus Draglines will be done from mile 5 to 12 and the machines then transferred to the Khirtar Tail Division for work on the main Khirtar Branch.

One No. 6 Ruston Dragline Machine is being tried on the Ratodero Branch. It will complete the first 4 miles of this branch and if found successful will be purchased by this Department to carry on the earthwork of the remaining length of Ratodero Branch.

The excavation of the Tail Distributary of Khirtar Branch and of some distributaries of Shahdadkot and Ratodero Branches has been taken up by manual labour.

Earthwork estimates for the Dadu Canal have been prepared. Those for the first 16 miles of the Central Rice Canal and North-Western Perennial Canal are nearly ready.

Earthwork estimates for some distributaries have also been made.

Excavation of canals by Draglines is in full swing in the Western Circle also. A contract for the excavation of the Dadu Canal by manual labour from mile 41 to 52 and 63-75 was taken up in November 1925 by a local contractor and good progress has been made.

IV—WORK PROPOSED FOR 1927-28

Barrage

261. The programme for this year provides for the completion of the canal head regulators and the construction of the under-water portions of the scouring sluices of the barrage on either bank, *i.e.*, for 5 spans on the right bank and 7 spans on the left bank, each ending with an abutment pier. It also provides for the excavation of the Eastern Nara Supply Channel. Quarries and stone dressing shops will be working at full output. Block moulding yards will be making blocks for regulators and barrage works in the river be in full swing.

Rohri Canal

Rohri Canal and Khairpur Feeders

Survey work, etc., and those buildings that were started previously will be completed during this year. Some further small buildings, such as Darogas' landhis, Hospital Assistant's quarters are proposed to be constructed. One more 30-B Machine and two 50-B Machines are proposed to be purchased for the excavation of canal branches during this year.

Eastern Nara System

The construction of two sets of buildings commenced in the Nara Supply Division will be completed. Land for banks and for Khipro Canal, Samarjo Branch and tail distributaries will be acquired.

Tree plantation in the first 14 miles length on both sides of the Nara will be carried out. Some widening of the Nara may have to be done during this year.

Earthwork in connection with the banks on both sides of the Nara in a length of about 30 miles will be continued.

Earthwork in connection with the Flood Diversion Bund from Makhi Weir to Khipro Weir will be pushed on.

The excavation of Khipro Canal and Samarjo Branch by Dragline Excavators will, it is hoped, be completed and a beginning will be made with the construction of regulators and bridges. The earthwork of Sufi Branch and the Hiral Distributary is expected to be completed and the remodelling of Chhorwah ex Thar Canal and that of the main Thar Canal will be started.

Excavation by Draglines of the Nabisar and Naokot branches will be wholly completed and that of some distributaries ex Mithrao will be started by manual labour.

It is also expected to start excavation of the New Cut to the Mithrao Canal.

Right Bank System

North-Western Circle

Land acquisition for the main canals and branches and distributaries will be completed.

The railway bridges at Arain and Ruk and the road bridges at Arain and Bagarji will be completed.

The following regulators and bridges will be started and partially completed :—

Head regulator over Warah Branch.

Cross regulator at mile 12 Shahdadt Kot and two head regulators for two distributaries taking off at that point.

Cross regulators at mile 6 of Ratodero Branch with head regulators of two distributaries.

Two road bridges over Ratodero Branch.

Three road bridges on Khirtar Branch.

Buildings at Bagodero and Kubo Saidkhan will be completed and those at mile 28 of Khirtar Branch will be taken in hand. Excavation of the Rice Canal will continue and approximately 100 million c.ft. of earthwork will be done.

The North-Western Railway diversion near Arain will be completed.

Excavation of Ratodero Branch from mile 5 to 10 will be completed. Excavation of two distributaries of Shahdadt Kot Branch and two of Ratodero Branch will be completed and the work on three of the former and two of the latter will be taken in hand.

The excavation of the Khirtar Branch and its distributaries will be in full swing and over 12 million c.ft. completed on Khirtar Branch alone.

A start will probably be made on the Manchur Drainage Scheme by ordering some dragline excavators for the earthwork in connection with that scheme.

V—ACCOUNTS

262. The scheme is classed under the head "55". This head is an expenditure head and there is as yet no revenue to be budgetted for. Certain miscellaneous receipts are recorded against the capital account. There is no regular source of these receipts. They are chiefly derived from the following :—

- (1) Sale of tender forms.
- (2) Sale of trees, fruit, grass, etc.
- (3) Sale of unserviceable stores.

In the current year such receipts will be about Rs. 10,000 and in the next year they are estimated at Rs. 2,500.

The expenditure includes works-charges (including cost of land, and special land acquisition, survey and classification establishment and other establishment charged to works), salaries of officers, establishment, ordinary and special tools and plant, reserve of stock under 'suspense' and a portion of interest charges to be met from capital.

Provision has also been made for construction of the Manchur Drainage and for the Rectangulation to be carried out by the Survey Department of the Government of India.

263. Taking the figures exclusive of interest charges the decrease of 45,04 in the revised estimate as compared with the budget estimate for 1926-27 is mainly due to the following reasons :—

(1) Reduction of 22,07 in English expenditure on stores which is probably due to the fact that on account of the coal strike compliance with indents has had to be deferred. This has apparently retarded the progress on certain works causing a further saving of 12,13 which has been recently reported by the Chief Engineer, Lloyd Barrage and Canals Construction.

(2) Saving of 7,52 on land compensation provided for in the budget which the Revenue Officer could not utilize.

(3) Saving of about 41 on the allotments made for head regulators on which work could not be done as was anticipated before.

(4) Saving of 1,75 on establishment which is mostly under travelling allowance and is due to economy in this expenditure. The saving is also partly due to the fact that less establishment was employed and some proposed new sub-divisions have not been opened.

(5) Saving of 66 effected on ordinary tools and plant by allowing only for the most essential articles.

(6) The balance of 50 is the saving under "Suspense" which was mainly due to credits to this head by debits to the works concerned.

The decrease of 10,66 in the budget estimate for the ensuing year as compared with the budget estimate for the current year is due to a smaller provision required to be made for English expenditure on stores as most of the plant and machinery has already been obtained.

The decrease in the revised estimate of "Interest charges" as compared with the budget estimate for the current year is mainly due to savings on the borrowings of 1925-26 which were available for expenditure in the current year. The increase in the provision for the next year over the current year's budget is due to increase in capital expenditure and calls for no explanation.

A—Preliminary Expenses.—This will consist of lining out of canals, branches and distributaries, clearing jungle in alignments and completing remaining surveys.

B—Land.—This provides for compensation to be paid for land to be acquired and includes the establishment employed on land acquisition and surveys.

C—Works.—This includes provision for work to be done on the main barrage and canal head regulators. The work of the floors of the barrage and head regulators and superstructure of regulators will be done.

D, E, G, H, M.—These form part of the programme of the scheme and comprise scattered works. There are no special remarks to be offered in this case.

K—Buildings.—Programme of this item of work will be further proceeded with. In most places buildings have been completed.

L—Earthwork.—This head includes provision for running expenses of all existing dragline excavators, of five new dragline machines, three motor lorries, excavation of Nara Supply Channel by dredger, and a certain amount of excavation by hand. Work of the containing banks along the Nara will be proceeded with. Mithrao New Cut will be excavated and remodelling of Thar Canal undertaken.

O—Miscellaneous.—Under this head provision has been included for the building of the new Hindu Burning ground at Sukkur.

Minor Branches.—This provides for constructing regulators on Navlakhi and Mehrabpur branches and their excavation and also excavation of Amurji and Gajra, Tando Adam and Alibehar branches.

Full details of the provision made for 1927-28 under the above-mentioned sub-heads of "I—Works" are given in Appendix D.

Special Tools and Plant.—Details of plant and machinery are given in a separate statement. They include regulator gates, provision for railway track, pontoons for dredger, cranes, pumping plant, mortar mills, quarry plant, stone dressing plant and excavator machines.

Establishment.—The provision for establishment for the ensuing year includes provision for the opening of two new Divisions, *viz.*, Nara Cut Division and Manchur Drainage Division, and some sub-divisions on account of expansion and development of works. Notwithstanding this the provision made for the next year is slightly less than the current year's grant and it is entirely due to a reduction of Rs. 1,54,200 made in the Chief Engineer's demand on account of anticipated savings which usually occur. The details will be found in the establishment budget, *vide* Appendix E.

Ordinary Tools and Plant.—Provision has been made for the ordinary tools and plant which will be required for the works in general going on in the various divisions. This head also includes provision for 1 paddle steamer and 1 motor life boat.

Suspense.—Under this head provision is made for probable *net* expenditure on stock materials which will be required for general purposes for the various divisions for which reserve stocks have been, or will be, sanctioned. These will include spare parts of Dragline Excavators, quarry machinery, also stock of *cut* stone which will be issued during this year.

Interest.—The total interest charges on the capital outlay on the project for 1927-28 are estimated at Rs. 35,48,000. Out of this amount Rs. 10,00,000 are to be met from the Famine Insurance Grant and the balance Rs. 25,48,000 from capital. It has been decided with the approval of the Government of India to meet interest charges up to Rs. 10 lakhs for the first 20 years from the Famine Insurance Grant and to meet a portion from capital also if such a course is considered desirable in any year.

266. *Item (1).*—According to the Poona Drainage Improvement Scheme, the funds for works chargeable to local bodies other than the Poona City Municipality, are found in the first instance by Government and are to be recouped by means of rent for the use of the common sewer, which is to be calculated so as to enable the capital with interest and depreciation charges to be recovered within a period of 40 years. A provision of 44 has been made next year for the purpose.

267. *Items (2), (3), (4), (5) and (6).*—According to the scheme mentioned above the cost of its second section is to be met entirely by Government except the cost of certain works, which is to be charged to the local bodies other than the Poona City Municipality on the condition mentioned in the above paragraph. The revised estimates for 1926-27 when compared to the current year's budget provision show a reduction of 1,59 which occurs mainly in the total provision for item (2). The apparent increase in the revised estimate of item (2) when compared to the budget estimate is due to the transfer of funds to it from item (5). The total provision of the Poona Drainage Scheme, second section, made in the next year's budget, is 5,44 of which the local bodies' share is 1,72. The provision of 5,44 is distributed as follows :—

273. *Items (1) and (2).*—In lieu of the military lands at Karachi taken up by Government in connection with the Artillery Maidan Development Schemes at Karachi, Government have to provide funds towards the cost of new plots and buildings for military purposes. This Government was required to make a contribution of 31,00 on this account. Of this sum, hitherto 26,26 has been paid (including 5,00 in the current year). It has been arranged to transfer the balance 4,74 before the end of the current financial year. Hence the revised estimate shows an increase as compared with the sanctioned grants shown under 56-A (Reserved).

274. *Item (3).*—In connection with the development of the Artillery Maidan it was necessary to acquire private buildings without which the scheme of development could not be proceeded with. The expenditure required for this purpose was 73 and the provision of 12 was not sufficient. The increase in the "revised" as compared with the sanctioned grant shown under "56-A" (Reserved) is due to this cause.

275. Next year it is proposed to resume two additional properties in connection with the development of the Maidan at an estimated cost of 12. It is also proposed to provide for advertisement charges with a view to facilitating the sale of the plots.

276. Hitherto provision for commuted value of pensions was made under the head "45, Superannuation allowances and pensions". From the current year all payments on account of commutation of pension whether made in England or India are to be brought to account in India on the books of this Government under a new capital major head "60-B, Payment of commuted value of pensions". The idea underlying the introduction of the new accounting procedure is that commutation, if otherwise in order, should not be postponed for reasons of difficulty about funds. The amount debited to the Capital major head in each year is to be repaid from revenue by a system of equated payments spread over 15 years which are to include interest on the capital invested. The equated payments in respect of each year are to commence from the year following that in which commutations are sanctioned. The total equated payments in respect of each year's commutation are to be debited to the Revenue head "45, Superannuation allowances and pensions" by credit to (a) the capital head "60-B, Payment of commuted value of pensions" for the capital portion of the payments, and to (b) "19, Interest on Ordinary debt" for the interest portion of the payments. In view of this a credit of 23 is taken under this head in the next year's estimate on account of the capital portion of the equated annual instalment towards repayment of the probable expenditure to be incurred during the year 1926-27.

279. A depreciation fund has been started in Government Presses with effect from 1st April 1926, with a view to meet, as required, the cost of the renewal and replacement of plant, machinery and furniture in order that the presses may be

kept automatically in an efficient working condition. The annual receipts of this fund which will consist of (a) the amount of depreciation on the value of the plant, machinery and furniture in use in the press during the year and (b) the book value of plant, machinery and furniture disposed of during the year, will be credited to the fund. This fund which will be treated as a deposit in Government accounts will be credited at the beginning of each financial year on the basis of the actual amount of depreciation during the previous financial year. Accordingly a provision of 70 as indicated above has been made in next year's estimate. 282. The Port Trust is repaying the loans, advanced to it out of the funds borrowed from the Government of India during 1921-22, 1923-24 and 1924-25 by equated instalments of principal and interest. The amounts shown above represent the principal portion included in such instalments.

The loans advanced to the Bombay Municipality have up to now been divided for purposes of repayment into two parts (i) for general purposes and (ii) for development purposes. Out of (i) it repaid 28,30 in lump sum last year and will begin to repay the balance by equated instalments from the current year. As for (ii) the Municipality has been requested to submit a definite programme of repayment. In the meantime it has arranged to repay this year a sum of Rs. 15,00,000 drawn by it for Mahim Development. This explains the increase in the revised estimate for the current year.

The Improvement Trust has commenced repayment of their loans from last year by fixed instalments of principal with accrued interest on the outstanding amounts.

The repayments to the Provincial Loans Fund of the principal corresponding to the payments by these local bodies will be made to the Government of India through the "Advances from Provincial Loans Fund" (Disbursement) (see paragraph 287 below).

284. The current year's budget as sanctioned by the Legislative Council in March last provides 80,00 for advances to be obtained from the Government of India for the Development Department, 1,20,00 for the Improvement Trust and the Bombay Municipality and 1,11,98 for other purposes. The Development figures are explained in the detailed memorandum of that department.

The amount of 1,20,00 included 70,00 for the Bombay Municipality, and 50,00 for the Improvement Trust. The Improvement Trust has borrowed a sum of 25,00 through the Banks instead of the 50,00 it originally wished to borrow from Government. This accounts for the decrease in the revised estimate as compared to the current year's budget. The 40,00 in the next year's estimate is the balance of the loan of 1,50,00 sanctioned to the Bombay Municipality during 1925-26 which the Municipality intends to draw next year.

The total capital expenditure next year for Irrigation including Lloyd Barrage and for general purposes amounts to 2,96,90 but it has been decided to advance about 6 lakhs to the Lloyd Barrage out of the general balances and further to utilise the anticipated savings of about 55 lakhs in the current year's

loan money for reduction of next year's borrowings. Besides, as explained above, the refund of customs duty will be utilised towards reducing the borrowing. Hence it is proposed to take an advance of 2,39,43 only for general purposes.

**MEMORANDUM EXPLANATORY OF THE FIGURES UNDER THE
MAJOR HEADS OF REVENUE AND EXPENDITURE RELATING
TO THE BOMBAY DEVELOPMENT SCHEME**

(All figures in this note are in thousands of rupees unless otherwise specified)

With a view to undertaking development works in Bombay City and adjoining areas, a Directorate of Development was established in 1920, as a Department of Government. The work of the Directorate fell under three heads, (a) the Back Bay Reclamation Scheme, (b) the industrial housing scheme, and (c) suburban development.

At the date of preparing this memorandum there had not been sufficient time for Government fully to consider the recommendations of the Back Bay Enquiry Committee regarding future operations on the Back Bay Reclamation Scheme. Pending a decision on these recommendations provision has been made tentatively for the working of the dredgers "Sir George Lloyd" and "Kalu", assisted by their respective boosters, the "Colaba" and "Jinga" for 24 hours a day during the usual dredging season. Provision has also been made for running five rakes of murum filling daily for eight months of the year, and three rakes daily for the four monsoon months. In accordance with decisions previously made the work on the reclamation will include the completion of block 8 by murum topping and of block 7 by dredged filling, the filling by dredged material of block 6 and of block 1 by dredged filling and by murum. Provision has also been made for anti-malarial and sanitary works in the reclamation area.

The programme of constructing tenements for the labouring classes, which Government finally decided to carry out, has been completed, and therefore no provision has been proposed in next year's estimates for original works in connection with these tenements. The work of supervision of repairs and maintenance of these tenements which was done formerly by the Superintending Engineer, Housing and Suburban Circle under this Department, has now been transferred to the control of the Chief Engineer, Roads and Buildings, Public Works Department, and placed in charge of the Superintending Engineer, Northern Circle. This has made it possible to reduce the post of Superintending Engineer in this Department.

The Suburban Schemes are carried on with great caution and with due regard to the condition of the land market. With the industrial housing tenements, the control of works in the suburban schemes has also been transferred to the Chief Engineer, Roads and Buildings, Public Works Department, with the Superintending Engineer, Northern Circle, in charge of them. The administrative charge of these schemes remains with the Development Department.

Owing to the curtailment of the activities of the Department, the Directorate together with the appointment of Director of Development, was abolished in January last.

The budget estimate for 1926-27 includes receipts on capital account such as sales of land, etc., whereas the revised estimate for 1926-27 and budget estimate for 1927-28 do not include such receipts in accordance with the orders of the Government, of India. In the revised budget for the current year, receipts from sale of a portion of the land in block 8 of the back Bay scheme to the military authorities and from the transfer of the Director's bungalow to the Home Department, and in the budget estimates for next year further receipts from sale of the balance of the land in block 8 to the military authorities, are taken into account, whereas when the budget estimates for the current year were framed, these receipts were not anticipated. 4. *Explanation of figures on the Revenue side*

Item (ii) in the revenue statement.—Interest under XVI—Interest.—The interest receipts consist of the share of interest charges receivable from the local bodies of loans granted to them from the Bombay Development Loan, and the income-tax payable on that interest, and also the interest on loans made under the state-aided building schemes, receivable from the participants in the schemes. In addition the budget and revised estimates for 1926-27 include interest due from the Government of India on the fixed deposit of Rs. 25 lakhs placed with that Government in November 1925 and the budget

estimates for 1927-28 include interest due on the fixed deposit of Rs. 40 lakhs placed with that Government in August 1926.

Item (iii) in the revenue statement—Receipts under XLII-Bombay Development Scheme.—In accordance with the orders of the Government of India, the receipts from sales of land in the revised estimates for 1926-27 and budget estimates for 1927-28, have been shown in reduction of capital expenditure under the head “59-Bombay Development Scheme” (Item 4 of the expenditure statement).

The receipts from the cotton cess are the amounts estimated to be realised under Act XX of 1920.

The receipts estimates for 1926-27 revised and 1927-28 budget do not include the realisations from the sale of the Director's bungalow to the Home Department and the anticipated realisations from the sales of fruits, grass, etc., and disposal of minor agricultural rights in properties acquired by this Department. These receipts being also of capital nature are shown in reduction of expenditure under “59-Bombay Development Scheme.”

Item (iv) in the revenue statement—Sinking fund deposits—The provision under this head is made up of the provision against “21-Sinking fund” on the expenditure side made in that year, *plus* interest receipts on deposits of sinking funds of previous years, which will be available for investment in the budget year; the revised estimates for 1926-27 and budget estimates for 1927-28 include, in addition, the realisations from the rebate of customs duty paid on stores imported by the Department. Provision for payment of this customs duty is included in the estimates of expenditure under “59-Bombay Development Scheme”, *vide* item 4 in expenditure statement, and as the rebate granted to the Department is to be utilised in reduction or avoidance of debt, it has been shown on the receipt side under the head “Appropriation for avoidance of debt”.

Item (v) in the revenue statement—Advances from Provincial Loans fund.—This item represents the estimates of borrowings from the Provincial Loans Fund for expenditure of the Development Department, and for loans to co-operative housing societies under the state-aided building schemes.

Item (vi) in the revenue statement—Assignment from provincial revenue. In order to maintain the finances of the Development Department on a solvent basis, it is proposed to make a subsidy of Rs. 27½ lakhs next year to the Department from provincial balances, which will be utilised partly in meeting a portion of the expenditure on the provision for sinking fund for the Bombay Development Loan, and partly in meeting interest charges on the borrowings of the Department. The estimated loss on the Back Bay Scheme, as valued a year ago and written back to the 1st October 1925, was Rs. 3 crores and the annuity required to pay interest charges and to provide a sinking fund for the amortisation of this sum of Rs. 3 crores in 60 years, is roughly Rs. 20 lakhs. The same amount has been again provided in the current year's budget. The balance of the subsidy of Rs. 7½ lakhs is the annuity required to pay similar charges for the anticipated loss on suburban schemes. When the current year's budget was framed, provision for amortising the anticipated loss on suburban schemes was not made. The amount of this subsidy is liable to revision from year to year according to the forecast of the financial position of the Department.

Item (vii) in the revenue statement—Loans and advances by Provincial Government—This represents the annual repayment instalment of the Bombay Port Trust of the advances taken by that body from the Bombay Development Loan, and the recoveries from co-operative housing societies and private individuals of loans given to them from development funds under the state-aided building schemes.

Explanation of figures on the Expenditure side

Item (1) in the expenditure statement—19-Interest.—This amount represents interest payable on the advances granted to the local bodies from the Bombay Development Loan, and the share of the local bodies of the management charges of that loan.

Item (2) in the expenditure statement—21-Sinking Fund.—Under the terms of the prospectus of the Bombay Development Loan, a provision equal to 1 per cent. of the total realisations from the loan has to be set aside every year towards the formation of an amortisation fund. The provision of Rs. 5·88 lakhs proposed under this head is explained in the note on budget figures affecting the Department, which is printed hereafter.

Item (3) in the expenditure statement—Sinking fund investment account.—This represents the investments made and to be made, out of the amount set apart as sinking fund during the year, and the interest accrued on the investments already made in past years.

Item (4) in the expenditure statement—59-Bombay Development Scheme.—This includes salaries of officers and establishments, work charges (including cost of land) and other miscellaneous expenditure of the Department as set forth in details in the appendices B, C, D, E, F, G and H hereto, and interest charges payable by the Department. All estimated receipts of capital nature are taken in reduction of expenditure under this head. In previous budgets, these receipts were not similarly shown in reduction of capital expenditure, but were shown under the revenue receipt head "XLII-Bombay Development Scheme". The change has now been made in accordance with the orders of the Government of India. A further change made in this budget is that the estimates of provision required for loans and advances to the local authorities for deposit contribution works are shown under the sub-head "D-Grants and advances to local authorities" *vide* Appendix H hereto; in previous budgets this was shown under the sub-head "A-Works and Acquisitions".

Item (5) in the expenditure statement—Loans and advances by Provincial Government.—This represents the estimates of loans proposed to be made to the public and to co-operative housing societies under the state-aided building schemes.

Item (6) in the expenditure statement—Appropriation for reduction or avoidance of debt.—This represents payment of advance interest on securities purchased from the amortisation fund of the Bombay Development Loan.

Item (7) in the expenditure statement—Repayment of previous years' borrowings.—This represents the value of the reclaimed land in block 8 of the Back Bay Scheme to be sold to the military authorities. It has been proposed to the Government of India that the value of this land should be set off against the borrowings of this Department from that Government during the years 1921-22 and 1922-23, and that it should not be taken in reduction of the current borrowings of the Department. These estimates are further explained in the note on budget figures affecting the Department, printed hereafter.

The increase in the opening balance is due partly to the fact that the actual gross expenditure under "59—Bombay Development Scheme" during 1925-26 was only Rs. 102·20, lakhs whereas the revised estimate on which the opening balance of Rs. 27·78 lakhs for 1926-27 shown in the budget estimates of the year was based, was Rs. 123·52 lakhs. This was due to retrenchment in expenditure during 1925-26 made after the revised estimates for the year were framed. The increase in opening balance was also due partly to certain receipts having been credited to this Department after the revised estimates were framed. These receipts could not be anticipated when the revised

estimates were framed. Of this opening balance of Rs. 70·15 lakhs, Rs. 25 lakhs were on fixed deposit with the Government of India, so that the actual balance in hand was Rs. 45·15 lakhs. In view of this large opening balance, nothing was borrowed for the expenditure of the Department during the first half of the year 1926-27, and a further sum of Rs. 40 lakhs was placed on fixed deposit with the Government of India in August 1926.

When the budget estimates for 1926-27 were framed it was anticipated that the payments due to be made to, and the amount due to be received from, the G. I. P. According to the arrangements proposed for the amortisation fund of the Bombay Development Loan, the sinking funds formed by the Bombay Improvement Trust and the Bombay Municipality for the advances received by these bodies from the Loan will be considered as part of the amortisation fund of the whole Loan. But as the sinking funds of these bodies will remain in their custody the annual contributions of the local bodies to the funds are not included, either on the revenue or expenditure side, in the budget estimates or the revised estimates for the current year for sinking fund deposits. The sinking fund deposits of these two bodies this year amount to Rs. 3.51 lakhs. Including this provision the amount available for investment this year according to the budget estimates and the revised estimates is Rs. 12.60 lakhs. These are made up as follows :—

Budget estimate of Rs. 9.09 lakhs includes Government contribution of Rs. 2.85 lakhs explained in the note below on the expenditure items, the Port Trust repayment instalment of Rs. 3.03 lakhs, and the interest amounting to Rs. 3.21 lakhs on sinking fund investments.

Revised estimate aggregating Rs. 9.88 lakhs includes all the items mentioned above, and in addition Rs. 79,000 on account of the rebate of customs duty on imported stores. When the budget estimates were framed it was not anticipated that the military authorities would be prepared to take over any portion of block 8 of the Back Bay Reclamation Scheme before the reclamation of the whole block was complete. The large increase in the opening balance of the year in the revised estimates, *viz.*, from Rs. 27.78 lakhs to Rs. 70.15 lakhs, has led to the increase in the closing balance shown above. Against the closing balance of Rs. 49.16 lakhs in the revised estimates, Rs. 40 lakhs have been placed on fixed deposit with the Government of India for a period of one year from August 1926. Therefore the closing balance in hand will only be Rs. 9.16 lakhs.

From the details of these receipts given in Appendix A hereto, it will be seen that the estimates of receipts next year from sales of water and electricity are nearly the same as the current year's revised estimates.

The estimated receipts next year from rents of properties are in excess of the revised estimates for the current year by Rs. 1 lakh. As stated in the explanation given above for the reduction in the revised estimate for the current year as compared to the budget estimate for that year, the revised estimates were reduced owing to the effects on the collection of chawl rents of the mill strike of the year 1925-26 having been felt in the opening months of this year. Moreover, negotiations are being made, and have in some cases been completed, for renting a number of chawls to large employers of labour—Government departments, railways, public bodies and private firms. This will lead to increased realisations from rent of chawls.

As explained in the foregoing note on revised estimates for the current year, the budget estimate of Rs. 20 lakhs for receipts from the cotton cess this year has been reduced in the revised to Rs. 17 lakhs, owing to the actual realisations from the cess during the first six months of the year having been less than the realisations during the same months of the previous years. The estimate of receipts next year is given at Rs. 20 lakhs; this estimate is based on the realisations from the cess during the previous years.

The revised estimate of Rs. 75,000 from Miscellaneous receipts includes Rs. 70,000 on account of receipts from the hire of broad gauge wagons to the G. I. P. Railway for seven months of the year up to October 1926. Thereafter these wagons ceased to be hired to the Railway as they were transferred to the Back Bay Scheme for running additional rakes of murum filling required for that Scheme. The balance of Rs. 5,000 is the estimated realisation from

items of petty miscellaneous receipts of the Department. The next year's estimate of Rs. 5,000 is the estimated realisations from such petty miscellaneous items of receipts. As the warehouse was very urgently required a supplementary grant was sanctioned by the Legislative Council at the last session and the work is in progress. It is therefore essential to construct a platform and ladders to the pumps, so that any repairs found to be necessary can be carried out immediately. Delay in the execution of such repairs would create serious difficulties as it means the stoppage of water supply not only to the Distillery, but also to the Security Press and the Jail. These are new pumps and when they were installed this provision was not made.

During the last rains the flood level was abnormal and the motors of the pumps had to be hauled up to a safe height to save them from going under the rising water.

The requirements of the Distillery and the Security Printing Press in regard to power are at present nearly equal to the capacity of one of the engine sets. The demand of the Security Printing Press is however gradually going up and it is likely to be higher next year after the currency press is built. In order to provide power to the dependent concerns without detriment to the work of the Distillery the expenditure in question is necessary. When the Jail wants electricity for lights, probably in April next, it is very likely that at times the demand for electricity will be more than what one engine can supply. To run two engines parallel without any hitch, two new pumping sets of greater capacity are required to deal with the larger outlet of water from the engine condensers.

Remarks.—The two existing sump wells are just sufficient to hold the sewage from the Distillery and the Security Printing Press buildings already erected. The sump wells originally constructed were designed with the object of meeting only the requirements of the Acetone Factory. When a Currency Press is added to the other Security Press buildings, the population, including workmen and labourers, will increase and all additional sewage will also run into these sump wells. The capacity of the present sumps is also low and in spite of the heavy strain put on them by the continuous pumping of the large accumulation of sewage in the sump wells it will not be possible easily to deal with the additional sewage without making provision for its disposal. The amount of Rs. 5,500 estimated for the work has been paid by the Government of India in connection with the Security Press.

The coastal warehouses dependent on the Khanapur Distillery cannot be supplied in the monsoon months and the quantity required for this period has to be supplied in the fair season, necessitating greater outturn for which sufficient accommodation is necessary. It is therefore proposed to increase the storage accommodation by partitioning one of the existing godowns and erecting two extra vats.

In a concern of the magnitude of the Nasik Distillery it is not possible to anticipate all expenditure of a capital nature and it is therefore absolutely necessary that the Commissioner should have a certain amount at his disposal to meet unforeseen and urgent requirements. The Commissioner has asked that a provision of Rs. 50,000 should be made annually in the budget on this account and Government have agreed to the proposal subject to financial exigencies.

Remarks.—The old baulkshed collapsed during the rains of 1923. There are six regulators at this place (*viz.*, on Desert Canal, Uch Rajwah, Tharu Rajwah, Thariri Rajwah, New Manjhi Rajwah and old Manjhi Rajwah) and a new baulkshed is absolutely necessary to store needles for all these regulators, as otherwise there is risk of their being stolen, the locality being very close to the British borders, the Baluchistan territory lying just on the other side of the Desert Canal. In absence of a baulkshed one or two men of the beldar establishment are engaged in turn to watch the needles with the result that their other beat work is neglected and consequently there is loss to Government. The construction of a baulkshed will save this.

The work estimated to cost Rs. 2,572 was administratively approved by Government in Government Resolution No. 6572, dated 10th November 1924, and the detailed plan and estimate have been technically sanctioned by the Superintending Engineer, Indus Right Bank Circle.

Remarks.—There is extensive rice cultivation between the Frontier Rajwah and the Desert Canal and there being no Subordinates' Inspection landhi to camp in, along the whole length of 23 miles of the Frontier Rajwah, it is in present circumstances impossible properly to inspect the canal during the inundation season. By constructing the Subordinates' landhi as proposed the inspection of the dangerous Dhoro portion of the canal, that is from miles 14 to 18, can be conveniently carried out. Innumerable leaks and breaches occur in this length and the presence of a subordinate is most essential during Abkalani. The conditions unquestionably warrant the construction of this landhi.

The work was administratively approved by Government in Government Resolution No. 5701, dated 31st August 1925, and the estimate therefor amounting to Rs. 8,604 was technically sanctioned by the Superintending Engineer, Indus Right Bank Circle.

Remarks.—There is large area of good land lying waste at the tail of Chitti and Rajib and it will be advantageous to widen and extend these canals and as the tail of Garang is being cut off by Barrage canals it is necessary to remodel all of them. The permanent raising of the water level above Sukkur due to the Barrage will render these canals difficult to remodel at any rate for some miles near their heads on account of sub-soil water level being raised permanently. The project in itself is therefore very urgent. The area bounded by the Sukkur Begari Bund on the east, Barrage canal on the south and west and Sind Canal on the north and north-west will conveniently come under the remodelled canals which will also have to irrigate land on the east of Ruk Jacobabad Railway line at present settled on Sukkurwah as desired by the Barrage authorities.

The contour survey for this project was administratively approved by Government in Government Resolution No. 3886, dated 12th January 1926, and the detailed estimate therefor amounting to Rs. 14,171 has been technically sanctioned by the Superintending Engineer, Indus Right Bank Circle. A conference of the Superintending Engineer, Northern Circle, the Collector of Kaira, the Executive Engineer, Kaira and Panch Mahals Division, the Mamlatdar of Matar, the Sub-Divisional Officer, Hathmati and Khari Cut Canals Sub-Division, and the representatives of the Kalambandi villagers of the Matar taluka was held at Navagam on the 19th April 1926 and after discussing the best “modus operandi” for the smooth and successful distribution of water between the Khari sluice and the Khari Cut a certain agreement was arrived at, which was unanimously accepted by the people. Remarks.—The work consists of (i) diversion of the Mudhi Channel with an aqueduct and superpassage near Mandal village, (ii) constructing a lining wall on Walkheda channel and (iii) improvements to Betwad channel. The Mudhi Channel almost surrounds the Mandal village and in the monsoon a great pool of water is formed at the main entrance of the village and great inconvenience is felt by the villagers in going in and coming out of the village. The diversion of this channel is therefore very necessary. The Walkheda channel is cut up at places by jungle water through several small water courses and a lining wall with an escape is therefore absolutely necessary to prevent damage to the channel bank and to save annual charges on its repairs. All the scour sluices of the Betwad Bandhara have gone out of order and it is impossible to close them and thus divert the water into the Betwad Channel. The scour sluices must therefore be set right immediately as the irrigators will not get sufficient water and loss of revenue will be the result. The work is therefore very urgent and necessary.

All these improvements have been administratively approved and estimates therefor, aggregating Rs. 5,544, technically sanctioned by the competent authorities.

Remarks.—The growth of irrigation on the Godavari Canals as compared with that forecasted is very rapid so much so that the area irrigated in the year 1922-23 on these canals was not only considerably higher than that estimated for that year in the project but also higher than that anticipated in 1928-29 when the Canals were expected to be fully developed. In these circumstances either the area to be irrigated on the Canals must be limited to a figure at about that for which the storage has been designed or the storage must be increased in order that in times of scarcity of rain, etc., standing crops may not have to suffer for want of sufficient water. The second alternative is obviously preferable as it will be a short-sighted policy if the first alternative were to be adopted. The existing storage at Darna Dam cannot be increased as that would mean the diversion of the Great Indian Peninsula Railway which would otherwise be flooded with a greater storage. The pick-up weir at Nandur-Madhmeshwar is also not capable of being further increased. It is therefore necessary to carry out detailed investigations for suitable additional tank sites for supplementing the existing storages in order to keep pace with the speedy growth of irrigation on these canals and the work is one of extreme urgency.

The estimate for the work amounting to Rs. 41,167 has been administratively approved by Government in their Resolution No. 6766, dated 19th November 1926.

As the land enclosed in the compartment is kalarish, the owner objects to the compartment being filled up above the level of the karia banks as otherwise water impregnated with kalar will find its way into his karia and on to his land and will ruin his cultivation. Last year no Khuada was allowed on the berm and the people had to suffer. It is therefore necessary to construct these pipe sluices in order to remove the complaints of the people.

The work was administratively approved and detailed plans and estimate, the latter amounting to Rs. 2,435, were technically sanctioned in the Indus River Commission Resolution No. 31-S.I.W.—5 (S.C.), dated 15th July 1926.

Remarks.—The office of the Superintending Engineer on Special Duty being “Executive” for purposes of accounts, detailed accounts are required to be prepared in accordance with the procedure laid down in the Public Works Department Code and all the documents and registers are to be maintained in the forms prescribed in the Book of Public Works Account Forms. The establishment work of the office is heavier than that of an Executive Engineer’s Office, where one clerk is detailed solely and wholly for establishment work. The establishment consists of 50 persons for whom salary bills and travelling allowance bills have to be prepared monthly and payments arranged for in different parts of the Deccan and Gujarat. Remarks.—At present several Rangers of the Dangs Forests have to send parties to Nawapur, Surat, Chikhli, Bardoli and Kalvan for receiving payment of cheques or for depositing money into a treasury. The cheques are of considerable value—up to about Rs. 7,000 in a single case. There is always great concern about the safety of the treasure in transit. Besides, the expense on travelling allowances and the time occupied by the staff in cashing cheques is considerable. Ahwa is the chief centre of the Dangs, and the distance between Ahwa and Chikhli, at which latter place there is a sub-treasury, is 54 miles. There is considerable risk in the staff going without adequate protection. If a treasury were maintained at Ahwa, police parties would only occasionally conduct treasure in and out of the Dangs. Government probably lose at present a large revenue annually owing to the waste of time of the subordinates in carrying money to the sub-treasury and back when they might be helpful in the exploitation of the forests. The figures of transactions for the year 1925-26 which would have taken place with a treasury at Ahwa are as follows :—

Remarks.—The Nasik Central Prison, which is at present under construction, is expected to be completed by March 1928. Some of the prisoners' barracks are however ready, and it is proposed to accommodate about 700 prisoners there from the Deccan Convict Gang at Visapur. The latter will be closed in June 1927 as the extramural work of the tank on which that gang has been so far employed will then be completed. A Superintendentship of a District Prison will therefore have to be abolished and an appointment of Superintendent of a Central Jail created. It is proposed to create the latter appointment about three months before the former is abolished, i.e., about the middle of March 1927, in order to enable the preliminaries connected with the opening of the new Central Jail at Nasik to be carried out. Remarks.—There has been in recent years a considerable increase in the clerical work in the Motor Vehicles Department under the Commissioner of Police, Bombay, especially owing to the introduction of the system of annual re-registration of motor vehicles, and with the yearly increase in the number of vehicles on the road, the work year by year grows in volume. The working arrangements in the office of the Commissioner of Police, Bombay, have been fully examined and Government are satisfied that the entertainment of 3 temporary junior clerks for a period of four months every year is necessary in order to enable it to deal efficiently and expeditiously with the increased volume of work. Remarks.—The New Satara Museum building was opened in the year 1925 and negotiations were going on between Government and the late Rao Bahadur Parasnis as to the future management of the Museum. Unfortunately owing to the sudden death of Rao Bahadur Parasnis the whole status of the Museum has to be reconsidered by Government. Pending the constitution of a Board of Trustees for the management of the institution, the Collector of Satara has been appointed to be a provisional curator in charge of the Museum. While considering the question of the future management of the institution, it has been suggested to Government that in return for a deed of gift donating to Government everything deposited in the Museum when the Collector of Satara sealed the doors after Rao Bahadur Parasnis' death, the Parasnis family should be offered a pension of Rs. 200 per mensem in perpetuity. Negotiations are still going on with the Parasnis family whether they are ready to accept the offer. In the meantime, it is proposed to provide a sum of Rs. 2,400 in next year's estimates.

Remarks.—Under the revised regulations and syllabuses sanctioned for the B.E. (Civil and Mechanical) Examinations and for the 2nd and 3rd year Workshop classes, Electrical Engineering has to be taught in addition to the old course. Physics is also to be taught in its technical aspects. This addition to the courses requires the strengthening of the Physics and Electrical Engineering Departments and Workshop. The present staff is sufficient to teach elementary work only but is unable to cope with the additional work thrown upon it by the revised course which was introduced in 1924. The number of students in the Workshop classes of the College of Engineering has increased of late and the revised course introduced in 1924 has also increased workshop practice for all college students. In the absence of the requisite staff the college classes are seriously handicapped.

The extra staff required for the college and the workshop is as follows :—

- 1 Demonstrator in Electrical Engineering on Rs. 200—10—250 per mensem ;
- 1 Electrician on Rs. 120—5—180 per mensem ;
- 1 Menial on Rs. 20 ;
- 1 Machine Attendant on Rs. 30 per mensem.

In addition to the extra staff referred to above, a non-recurring grant of Rs. 1,90,000 for the purchase of machinery and equipment is also necessary. Rs. 60,000 is for the Workshop, Rs. 1,20,000 for the Electrical Engineering Laboratory and Rs. 10,000 for the Mechanical Engineering Laboratory.

Remarks.—In order to encourage the boy scout movement in this Presidency, a post of Provincial Commissioner for Boy Scouts (now designated Provincial Secretary to the Bombay Boy Scouts Council), together with the requisite office establishment and other charges, was sanctioned for a period of two years in the first instance from 1st February 1921. The period of the appointment was subsequently extended by three years. In 1924-25 Government, with the approval of the Legislative Council, sanctioned a grant-in-aid of Rs. 15,000 per annum for a period of two years to the Bombay Boy Scouts Association in order to finance further expansion of the movement. Owing to the reversion of Mr. Miller, I.E.S., who was originally deputed as Provincial Secretary and the appointment by the Boy Scouts Association of a new Provincial Secretary, who was not a Government servant, Government decided in 1925-26 (1) that the Boy Scouts establishment could no longer be treated as a Government establishment and (2) that the financial assistance to be given by Government for the encouragement of the movement should be entirely in the form of a grant-in-aid to the Bombay Boy Scouts Association. It was then represented to Government that it was desirable to extend further the movement by (1) the appointment of full-time divisional organisers and (2) the holding of a Provincial Jamboree. It was further urged that owing to the very large increase in the number of scouts (from 4,000 to nearly 10,000), the grant of Rs 15,000 sanctioned in 1924-25 was insufficient to meet the cost of training scout masters, the publication of vernacular literature, etc.

Remarks.—As the Inter-Science examination has now been made an entrance test for the professional colleges, the demand for science teaching has increased considerably at the Deccan College. The lack of facilities for science teaching there, has resulted in a fall in the number of students on the rolls. The University Inspection Committee in their report on the Deccan College have also remarked that the exclusion of the teaching of science from the second year has produced a diminution in the attendance at the college in both the first and the second year classes and have recommended that the college be permitted to include within its courses those of Inter-Science. They consider that this need not involve the inclusion of the course for the Degree in Science, for students of the college who desire after passing the Inter-Science examination to proceed to the B.Sc. degree can find admission to the higher courses in other colleges including the Royal Institute of Science, Bombay. It is, therefore, proposed to introduce teaching the Inter-Science course at the college from next year. The non-recurring and recurring expenditure on this account is estimated as under :—

Remarks.—On the recommendation of the Commissioner in Sind, Government approved the terms on which the Karachi Municipality were to undertake the installation of water supply mains in, and disposal of sewage from, the Artillery Maidan estate. The Municipality, however, demurred to accepting the terms on the ground that the area in question was not included in the Municipal limits and that even if so included, it formed a private estate to which the Municipality was not bound to supply water and drainage facilities and also on the ground of inability to provide the funds required. In view of the objections of the Municipality, the Commissioner suggested that Government should make a contribution of Rs. 25,000 *ex gratia* to the Municipality for the construction of the large water main from the reservoir to the Maidan. Remarks.—The National Council for combating venereal diseases suggested the use of propaganda films for general public enlightenment as well as for the instruction of medical students, midwives, nurses, etc., in the treatment of venereal diseases. Venereal diseases are very prevalent in India and their ill-effects, both immediate and remote, can hardly be exaggerated. It has, therefore, been recommended by the Surgeon-General that the proposal of the National Council be given a trial. For this purpose it is proposed to obtain from the Council on loan the films (1) Gonorrhoea, (2) Syphilis, and (Venereal Diseases in Men) with a view to exhibit them for teaching and propaganda purposes. Provision has, therefore, to be made for customs duty, freight, insurance, cinema rent, travelling allowance and other incidental charges. These are estimated at Rs. 2,000. An amount of Rs. 2,000 has, therefore, been proposed in the ensuing year's budget.

At the last session of the Legislative Council several members had given notice of resolutions recommending the Broach Sanitary Association for a grant-in-aid from Government. Remarks.—The desirability of appointing an expert for anti-malaria research work in the Dangs was long felt. In 1924 at the request of the Collector of Surat and the Commissioner, Northern Division, Dr. J. A. Pinto, Assistant Director of Public Health, Gujarat Registration District, was asked to make a survey of conditions in that tract. With the spleen rate of 92 per cent. among children, which is almost a permanent condition, he considers the Dangs to be an intensively hyperendemic tract of country in the Bombay Presidency from a malarial point of view. The villages in the Dangs are practically surrounded by trees and most of them are in or near the jungles. The Dangs are not in British Territory but Government are prepared to undertake the care and administration of this extraordinarily backward area. It is therefore proposed to adopt measures for eradicating malaria in the Dangs. The most important anti-malarial measure recommended for the Dangs is the parasite control and is to be effected by suitable and efficient organisation. The Director of Public Health in consultation with the Surgeon General has submitted a scheme involving a total recurring expenditure of Rs. 8,740

and a non-recurring one of Rs. 24,200 ; the consideration of the whole scheme will take some time. In the meanwhile Government have decided that the existing dispensary at Ahwa should be utilized for distributing quinine free through the Forest officials as well as the missionaries working in the Dangs. The cost for the purchase of quinine required for distributing in the Dangs is Rs. 3,500 and it has therefore been proposed to provide the amount in the next year's estimate.

Remarks.—In view of the heavy infant mortality, 40 to 45 per cent. of which is recorded among infants under one month and as this is apparently due to unclean methods employed by untrained village *dais* in labour cases and the dirty instruments used by them when cutting the cord, a scheme has been evolved by the Lady Wilson Save the Village Baby Scheme Committee for the training of village *dais* and supplying them with (1) a pair of surgical scissors, (2) legatures to tie the cord, and (3) carbolic soap. The scheme was inaugurated during the last year and the Committee has applied for a grant-in-aid from next year. At present the work in this connection is carried on by Dr. DaGama, Assistant Director of Public Health, Central Registration District, but, as it grows, a special staff will be necessary for the purpose. The estimated approximate annual expenditure is Rs. 25,000, *viz.*, Rs. 6,500 for the special staff and Rs. 18,500 for the supply of outfits and the training of *dais*. Having regard to the great desirability and importance of the scheme the Surgeon General has recommended a grant equivalent to one-third of the actual expenditure up to a maximum of Rs. 10,000 and it is proposed that this should be sanctioned from next year.

Remarks.—Government have appointed a permanent advisory committee for devising and co-ordinating anti-malarial measures in the city of Bombay on the recommendation of the Conference of the members appointed by Government to discuss ways and means of carrying out the recommendations of Dr. Bentley for adopting anti-malarial measures in the City of Bombay. This Conference had recommended the appointment of an expert malariologist and a subordinate staff and had urged that their cost should be borne by Government. The recommendation of the Conference was not approved by Government and the President of the Corporation has been asked to report what action has been taken by the Corporation to carry out Dr. Bentley's recommendations and on receipt of this report the question of the appointment of an expert malariologist is to be considered further. The cost on account of an expert malariologist and his staff for re-survey is estimated at Rs. 25,000 and it has been suggested that it should be met by the local bodies concerned and Government proportionately. Government share would accordingly come to Rs. 6,250 and it has therefore been proposed to provide the amount in the next year's budget.

Remarks.—From year to year, Government have been meeting the charges amounting to Rs. 2,000 on account of the sanitary and medical arrangements. The Agents of the Great Indian Peninsular Railway and Barsi Light Railways were however asked to bear the whole or a portion of these charges as the arrangements are made for the safety of the pilgrims who travel by the Railways. After a prolonged correspondence the Railway authorities do not agree to accept any liability on account of this expenditure incurred by Government, as in their opinion the conditions at Pandharpur from where the pilgrims return are such as to favour the outbreak of infectious disease and with which the Railway administrations have nothing to do. Government have not yet finally accepted the opinion expressed by the Railway Authorities. It is therefore desirable that a provision of Rs. 2,000 should be made in the next year's budget to meet the charges.

Remarks.—The charges on account of the construction of buildings for veterinary dispensaries are borne by Government, the Local Boards and the Wadia Bequest Fund in the proportion of 1, 1 and 2 respectively. The share of the Wadia Bequest Fund is met from the contribution of Rs. 15,000 received annually from the Fund. On account of financial stringency no provision has been made in the current year's estimates for Government grants for the construction of dispensaries. As however a new building for the dispensary at Jacobabad was urgently required, a sum of Rs. 24,143, representing the full share of the Wadia Bequest Fund was allotted immediately in the course of this year; this sum together with the District Local Board's share was thought to be sufficient to erect the absolutely essential buildings and it was decided that a provision of Rs. 12,072 for the Government share should be made in next year's budget.

2. In the case of dispensaries built without the aid of the Wadia Bequest Fund, Government have decided to give grants equal to one-half of the cost of additions and alterations in cases in which the buildings were originally built either wholly by the District Local Board or partly from the Board Funds and partly from Government contributions. In pursuance of this undertaking a sum of Re. 463-8-0 is due from Government as half the amount of the additional compensation awarded by the Court for the land acquired for the veterinary dispensary at Sukkur. The total Government grant payable during next year therefore amounts to Rs. 12,536

Remarks.—In 1921 the Director of Agriculture proposed that Government should take over the Sangvi Cattle Farm of the Shirpur Agricultural Association with a view to paying special attention to the Tapti Khillari breed, Government having already started farms elsewhere for dealing with other important breeds. The farm is situated in the midst of a very fine grass country, and, in addition to being a bull-breeding farm, could harvest and store a very large quantity of grass for distribution in famine times. The assumption of the management of the farm by Government would have, however, entailed considerable additional expenditure which in view of the financial situation Government were unable to undertake. Government, however, sanctioned in 1923, on certain conditions, an annual grant of Rs. 800 to the Association in aid of the farm. The proposal that Government should assume management of the farm was repeated by the Director in 1925 but owing to financial stringency it could not be accepted. The Director has now placed the proposal before Government for the third time, in a somewhat modified form. The work to be done is beyond the finances or managing ability of the Association and the only alternative to taking over the farm is to stop the Government subsidy and allow the dispersion of the fine herd of Tapti Khillari Cattle which the Association has got together. The Director's proposal involves an annual expenditure of about Rs. 3,000, as shown below, against the present grant-in-aid of Rs. 800 :—

Remarks.—The present Manual of Co-operative Societies was published in the year 1919. Since then the co-operative movement in this Presidency has developed and spread in various new directions. Several of the model by-laws have been revised in important respects and a large number of new bye-laws have been framed. Many important circulars dealing with such subjects as improved banking methods, co-operative marketing, management of consumers' societies, purchase of agricultural requirements, etc., have been issued. It was therefore considered desirable that a revised edition of the Manual should be prepared. In the meantime a bill to amend the Co-operative Societies Act was introduced into the Legislative Council and when the Bill was passed into Law, new rules had to be framed thereunder. Pending the passing of the new Act, Mr. O. Rothfeld was asked to undertake the work of revising the Manual, with the assistance of his Personal Assistant, Rao Saheb G. H. Desai. As the work was done outside office hours it was proposed to give honoraria to Mr. Rothfeld and Rao Saheb Desai. The Act has since been passed and the rules thereunder have been framed and published provisionally. The Manual will therefore be ready for publication in the year 1927-28. The actual amount of the honoraria will be determined when the Manual is ready. In the meantime it is proposed to make provision in the budget at the rate of Rs. 750 for each of these gentlemen and of Rs. 300 for the person who will be entrusted with the work of preparing the index.

Remarks.—Under the Bombay Co-operative Societies Act it is incumbent on Government to have the accounts of every society audited at least once every year. The total number of societies on 31st August 1926 was 4,906. This number is expected to rise to 5,500 before 31st July 1927. The present number of auditors is 42, but out of these, 2 are working as assistants to the Special auditors, 1 is Deputy Assistant Registrar in Sind and doing no audit work, 1 is a reserve auditor, 1 is Auditor, Purchase and Sale, and 1 is Auditor, Welfare work. The last 3 and the 3 special auditors audit about 250 societies between them. There are also 7 sub-auditors who audit about 420 societies. Deducting these 670 societies there remain 4,830 societies to be audited by the remaining 36 auditors. The standard scale of audit is 100 societies per auditor. Twelve more auditors are therefore necessary, if the statutory responsibility of auditing the accounts of all the Societies is to be adequately carried out. As a measure of economy it is proposed that instead of 12 auditors, 2 auditors and 7 sub-auditors shall be appointed and that an attempt be made to work up the scale to 110 societies per auditor and 75 societies per sub-auditor. The latter will do the audit of smaller societies under the supervision of the auditors. As the sub-auditors are graded with second grade clerks and will not require clerks as auditors do, their employment involves less expenditure. Of the 2 auditors, 1 will be in the first grade on Rs. 200—10—300 and the other in the second grade on Rs. 150—5—200. The 7 sub-auditors will be on the usual scale of Rs. 105—5—140, the 2 clerks for auditors on Rs. 30—5/2—80, the 7 peons to auditors and sub-auditors in the Presidency proper on Rs. 16 and the 2 peons for the auditor and sub-auditor in Sind on Rs. 17 with house-rent and local allowance at Rs. 2 per mensem each. In order to maintain the proportion of senior posts it is proposed to create one appointment of auditor in the first grade, but his place will for the present be filled by an auditor in the second grade. Provision has been made for eleven months of the ensuing year.

Remarks.—In 1891 the Secretary of State sanctioned the grant of Sind allowance to Executive Engineers and Assistant Engineers (now called Assistant Executive Engineers) serving in the Upper Sind Frontier and Shikarpur Divisions on account of the unhealthiness and severity of the climate in those localities. This allowance was withheld from the Public Works Department officers serving in the then existing three Hyderabad Canals and the Eastern Nara Divisions. As a result of the recommendation of the Sind Irrigation Committee of 1892, however, the Government of India obtained the sanction of the Secretary of State to the grant of Sind allowance to all Executive and Assistant Engineers (now called Assistant Executive Engineers) of the Irrigation Branch serving in Sind (excepting to those who are natives of Sind) by way of compensation to them for long months of isolation and exposure to the hardships incidental to district travelling in hot weather and also on account of their liability to be called out at any time during the inundation. The latest rates of the allowance as fixed in 1908 were as under :—

The allowance was admissible to Irrigation Officers of both the Imperial and Provincial Branches of the old Engineering establishment serving in Sind except to natives of Sind who were excluded. The Provincial Branch of the old Engineering establishment has since been amalgamated with the Imperial Branch and organised into what is now known as the Indian Service of Engineers and the members of this Branch who were known as Assistant Engineers are now styled Assistant Executive Engineers. The term Assistant Engineers is now applied to the members of the new Provincial Service (Bombay Engineering Service) formed from the 1st February 1920 on a time scale of Rs. 250—20—750 on the recommendation both of the Public Service Commission and the Public Works Department Reorganisation Committee with a view to encouraging the study by Indians of Engineering as a profession and to attracting the best class of Indians to the service. As this service was brought into existence in

1920 the orders regarding the Sind allowance issued before that year are not applicable to the officers of that service and hence fresh orders are necessary in its case. As already stated above the Sind allowance is granted principally as compensation for the trying local climatic conditions of Sind but it also serves the purpose of assisting Government in obtaining officers from the Presidency proper who are willing to remain in Sind for a reasonable period. The members of the other Provincial services under this Government are already in receipt of it. It was also drawn by the members of the old Provincial Service of this Department (now merged into the Indian Service of Engineers). It is considered therefore that the members of the new service should also be admitted to its benefits. After taking into consideration all the above facts it is proposed to grant, with effect from 1st April 1926, Sind allowance at a uniform rate of Rs. 50 per mensem to all members of the Bombay Engineering Service serving in the Irrigation Branch whether appointed direct to it or promoted thereto provided that they are not natives of Sind or the Punjab and for so long as they serve in Sind. The total cost during the next year is estimated at Rs. 14,950. This amount has been distributed under the following heads:—

The expenditure is not required directly in the interests of the Forest Department but is intended to make these areas accessible for grazing during famine. Remarks.—The cost of construction of the Jharya-Pimpri Road including the bridge over the Khapri River in the Dangs is estimated at Rs. 1,54,525. The Dangs are extraordinarily rich in teak timber and are favourably situated with regard to railways and markets, but the internal system of roads is so incomplete that it is extremely difficult to get timber out to the railway. Although considerable improvements have been made of late years, many of the tracks are still badly graded and very difficult for bullock carts; they become knee-deep in dust early in the hot season, when carting has to come to an end; exploitation is therefore expensive and only a fraction of the legitimate output can be put on the market. A good system of roads will allow of a greatly increased output, which will amply repay the expenditure and give a very handsome profit in addition. The construction of the Jharya-Pimpri Section of the road will enable the Forest Department to carry over 5,000 tons of timber under the new Working Plan for the Dangs and a large quantity of other traffic. It is the most important administrative road in the Dangs. It is proposed to provide Rs. 10,000 in the next year's budget for the work.

Remarks.—There has been a considerable increase in the traffic in forest produce such as bamboos, timber, etc., owing to the application of Working plans and the coupe system of exploitation to the forests of the Vajpur Range of Baroda State. During the fair season much of this produce is floated down the river Tapti on rafts to Kadod and to other market places as far down-stream as Surat, as this method of transport is found to be cheaper than conveyance by carts. There are, however, several rocky obstructions in narrow passages in the channel of the river and at the rapids therein, which render the process of transport often difficult and risky. In order to afford all reasonable facilities for the traffic in question, it is necessary to improve the channel by blasting these obstructions. The majority of the rocks are situated in Baroda State, but some of the largest and most dangerous are to be found at Kakrapar in the Mandvi Taluka of the Surat District. The cost of blasting these is estimated at Rs. 9,904 though the work will not be directly of much benefit to the Bombay Forest Department it is proposed to debit the whole cost to the revenues of this Presidency, as it will be of public advantage and as the Government of Baroda have recently undertaken to complete the portion of the Subir-Nawapur Road lying within State limits according to the standard of the British section. The completion of this portion will facilitate the transport of forest produce from the Dangs and thus benefit this Presidency.

Remarks.—The extension of the Khanto embankment having been completed the small area lying below the tail of the Khanto Canal which was hitherto unprotected is now in no danger of being flooded by river spill and it requires to be provided with irrigational facilities and the Zamindars are very anxious for the extension of the Khanto Canal. These irrigation facilities can be extended to them at comparatively small cost by extending the canal for a length of 92 Takis. The total expenditure on the proposed extension will amount to about Rs. 6,000. The extension of the canal will irrigate an additional area of 930 acres which after deducting interest and working expenses will realise a net revenue of Rs. 1,019 annually and give a return of 16 per cent. on the capital invested. This small but very useful work has been long under contemplation. Complaints from the local zamindars have been persistent for some years past and have had to be ignored in favour of some other work, because funds were short. It is not desirable that these complaints should remain unredressed and it is therefore urged that the work should be carried out.

The work has been administratively approved by Government in G. R. No. 9310, dated 29th September 1926, and detailed plans and estimate therefor will be technically sanctioned by the S.E., I.R.B.C.; shortly.

In accordance with the scale laid down Government servants on pay above Rs. 200 stationed at Karachi were not eligible for the allowance, and thus they were at a disadvantage in respect of pay when compared with those drawing Rs. 200 and less per month. Government considered the question of extending the benefit of the allowance to those officers whose pay was over Rs. 200 per mensem and who were not in receipt of any other allowance. After careful investigation of the case, Government came to the conclusion that the best way to compensate these officers was by the grant of Karachi Local Allowance. Accordingly Government have sanctioned, with effect from 1st April 1926, the grant of the Karachi Local Allowance at 10 per cent. of their pay to those officers stationed at Karachi who draw more than Rs. 200 per mensem, but do not draw any compensatory local allowance. The cost during 1926-27 on account of this sanction comes to Rs. 6,637 as shown below :—

The Collector of Bombay has therefore been authorised to utilise, in special cases, the services of brokers when Government land in the Town and Island of Bombay is to be disposed of. Remarks.—As a result of the reorganization of the superior staff of the Excise Department the post of the Deputy Commissioner of Excise, Bombay Presidency, as an executive officer was abolished with effect from 1st April 1925, and with effect from the same date the Deputy Commissioner was appointed Personal Assistant to the Commissioner of Excise, the post of Personal Assistant in the cadre of Superintendents of Excise being abolished. As an executive officer, the Deputy Commissioner was in receipt of permanent travelling allowance at Rs. 225 per mensem, but he ceased to draw it in consequence of the change in his duties. The ordinary travelling allowance rules do not provide for the recoupment of expenditure incurred in connection with short inspection visits which an officer makes within the area of his headquarters station. The Deputy Commissioner is very often required to see sites for excise shops, to visit periodically the important warehouse at Sewree and to inspect the several laboratories where spirituous and medicinal preparations are manufactured. There are various other matters and enquiries which for want of time and absence from headquarters the Commissioner has to entrust to the Deputy Commissioner (Personal Assistant). During the year 1925-26 the distance travelled by the Deputy Commissioner on official business within the limits of the headquarters station was about 1,200 miles. In view of the considerable travelling which the Deputy Commissioner has to do Government have sanctioned the grant to him of a conveyance allowance of Rs. 60 per mensem with effect from 1st April 1925. The expenditure during the current year will be met from savings under 6, Excise.

Owing to the limited number of higher grade appointments in the Districts of Hyderabad, Larkana and Thar Parkar, the Collectors of those Districts represented to Government that it was not possible to arrange that clerks in Treasury Offices who have been trained in accounts should receive accelerated promotion. The Commissioner in Sind had therefore proposed that at least one-fourth of the total number of appointments in the Treasury Offices should be in the higher grades, and had accordingly recommended an increase in the higher grade appointments to the extent indicated below :—

Since then the third mahar has been performing the duties and receiving the whole remuneration of Rs. 30 per annum. The village officers are, however, unable to perform their manifold duties efficiently with the aid of only one mahar, and three mahars are found to be absolutely necessary. There is no maharki inam land assigned as remuneration for the officiators. As Satara is the headquarter station of the district, mahars and mangs there earn good wages, and the cost of living for men of this class is comparatively high. An ordinary labourer earns from annas ten to twelve a day as wages and it is therefore difficult to secure men for less than Rs. 12 per mensem to do the mahars' work. The employment of three mahars on Rs. 12 each per mensem has accordingly been sanctioned. The extra cost per annum comes to Rs. 402.

Remarks.—A number of families in most of the Settlements are fit for discharge on probation to be sent back to their original villages or to other places where they can find suitable work. In some cases they prefer to remain in the settlements though fit for discharge on probation. To meet this contingency free colonies have been established adjacent to the Settlements. It is desirable that settlement authorities should remain in touch with these colonies for some years since after care is essential to the success of the scheme. Where the Settlements nearest to the colonies happen to be those under the management of missionary societies, it is necessary to remunerate the latter for the additional work involved. Government therefore sanctioned grants to voluntary agencies at the rate of Rs. 4 per settler per annum for the first two years of probation subject to a minimum of 6 visits a year and at the rate of Rs. 3 per settler per annum subject to a minimum of 4 visits a year during the remaining 4 years of probation, the grants being liable to proportionate reduction if the prescribed minimum number of visits is not paid. The charge was met by reappropriation from the grants placed at the disposal of the Criminal Tribes Settlement Officer under "25-Jails and Convict Settlements—charges in connection with the Settlement of Criminal Tribes."

ITEM 28. Payment of grants to voluntary agencies managing the Criminal Tribes Settlements for the education of children of settlers discharged on probation.

Remarks.—As stated under the foregoing item arrangements have been made to remunerate Voluntary agencies managing Criminal Tribes Settlements for after care work in the shape of periodical visits to settlers fit to be released on probation who prefer to live in free colonies adjacent to settlements. It is now necessary to provide for the education of these probationers and their children. The Settlements in question (namely those at Sholapur, Hubli and Gokak Falls) maintain day Schools and also night classes for the older boys. It is not possible to remunerate them by a grant-in-aid in the usual way, since these schools have manual training classes attached to them which do not follow the ordinary curriculum, but are inspected by the Committee of Technical Instruction. Government have therefore resolved to remunerate these Voluntary agencies by an annual grant of Rs. 13 for each child attending the day school and Rs. 5 for each adolescent attending the night school. These rates compare favourably with the cost per pupil to Government in primary schools in the Central and Southern Divisions. The grants are payable only in respect of persons born of parents who are members of Criminal Tribes, and no Capitation grant is drawn for them elsewhere. The charge was met from the anticipated savings in the Capitation grants for Settlements to which the probationer families belonged.

Remarks.—Construction of buildings pertaining to Criminal Tribes Settlements is carried out departmentally as far as possible through Settlement labour in order to provide training in such work for the men employed, but in the case of important works expert supervision is necessary. The most economical way of obtaining this is to arrange for Public Works Department Sub-overseers to supervise such works out of office hours so that it may not interfere with their regular duties, and to remunerate them for this extra labour. The Criminal Tribes Settlement Officer has therefore been authorised to avail himself of the Services of the local Sub-overseers if and when necessary and to remunerate them by an allowance of Rs. 25 per mensem subject to a maximum of 5 such allowances at anyone time. The charge was met from the provision of Rs. 38,305 made in the current year's budget for Miscellaneous Settlement Expenses under "25-Jails and Convict Settlements—charges in connection with the Settlement of Criminal Tribes."

Remarks.—It was found by experience that the strength of the Police force consisting of 2 Head Constables and 6 Constables (armed) sanctioned for the Manmad Police Station in the Nasik District was insufficient and that the men were seriously overworked. In addition to the usual local prisoners in the lock-up attached to the Manmad Police Station, prisoners are received from the Railway Police, as the Mamlatdar of Nandgaon visits Manmad twice a month to try cases. Prisoners are likewise received for Dhulia Jail from the 3 Malegaon Police Stations, as well as the Satana, Jaikheda and Chandhor Police Stations. It was therefore essential to increase the Police strength at Manmad by 1 Head Constable and 3 Constables. The Head Constable was, however, spared from the Headquarters strength. The entertainment of 3 additional constables (armed) was accordingly sanctioned by Government, with effect from 6th May 1926. The extra charge involved during the financial year 1926-27 is met from the savings effected by the abolition of the treasury guard at Nasik.

Remarks.—The strong room in charge of the Treasury Officer at Thana was previously guarded by 2 head constables and 9 constables entertained to guard the Huzur Treasury. As the work of Huzur Treasury at Thana was subsequently made over to the Imperial Bank of India, who have opened a branch at Thana, the Treasury guard of 2 head constables and 9 constables was reduced from the date the branch of the Bank was opened. Although the actual treasury cash balance has been transferred to the Imperial Bank, stamps, opium, Government Promissory Notes, Court of Wards property and other valuables are still kept in the strong room in charge of the Treasury Officer. The present strong room is a very old building and to ensure the safety of the property stored therein it was essential that an adequate police guard should be employed. Government accordingly sanctioned the entertainment of 3 constables, with effect from the 23rd December 1926, as a temporary measure till a proper strong room for storing opium, stamps and other valuables is provided. The extra charge involved during the year 1926-27 is met from the savings available in the grants at the disposal of the District Superintendent of Police, Thana, under the head “26—Police—District Executive Force.”

Remarks.—Motor traffic has been permitted in Mahableshwar since 1925. Police and clerical establishments are therefore required to control it during the season and to collect fees under the rules. The establishment consists of one European Police Sergeant, two Head Constables, six Constables and one writing Mukadam and one Clerk. This is the minimum found necessary after two years' experience. It was proposed to meet the charge from the fees recovered under the Mahableshwar Motor Vehicles Rules. But this procedure had to be abandoned since it contravenes Article 1 of the Civil Account Code which prohibits the appropriation of receipts to expenditure. The charge is however fully covered by receipts credited to “XIX Police.” The extra charge is met from the savings anticipated in the provision made for temporary police establishments for the Poona and Satara Districts.

Remarks.—Motor traffic on ghat roads has grown to an enormous extent during recent years and passenger lorries in particular have been found to require more careful examination than is possible at present. It has therefore become necessary to supplement the services of the motor examiner lent by the Bombay City Police for this purpose in the interests of the travelling public. Two checking parties each consisting of 1 Sub-Inspector of Police and 1 head constable were accordingly sanctioned to supervise motor traffic in Poona and Satara Districts, during the Mahableshwar season, i.e., up to the 15th June 1926. Each of these parties was provided with a motor cycle and side car to enable them to work with speed and efficiency. The charge is met from the lump provision of Rs. 50,000 made in the current year's budget for additional police under “26—Police—District Executive Force.”

Remarks.—The armed police guard of two head constables and sixteen constables over the Sub-Jail at Nawabshah also served to guard the old Sub-Treasury which was in the same building. A new strong treasury room has since been constructed for Nawabshah in the Kacheri compound at a distance from the Sub-Jail and has been in use since 22nd November 1926. As it is not possible for the sentry over the Sub-Jail to guard the new strong room at the same time, Government have sanctioned the entertainment of an armed police guard consisting of two head constables and six constables with effect from the 22nd November 1926 for that purpose and have reduced the original combined Jail and Treasury guard by 4 constables. The extra charge involved during the year 1926-27 is being met from the savings effected by the reduction of two Sub-Inspectors and two Constables at the police stations at Karad and Umraj in the Satara District.

Remarks.—In 1920 Government constructed a new taluka office at Kario Ganwhar in Hyderabad District. The police station at Khorwah was removed to Kario Ganwhar in June 1924 in anticipation of the establishment of a taluka Headquarters there. But since delay occurred in the formation of the new taluka, the maintenance of the station there led to much inconvenience. Prisoners had to be taken long distances by road, water arrangements were poor and the village very small. The Commissioner has accordingly transferred the station from Kario Ganwhar to Tando Ghulam Haider in the same Taluka as a temporary measure pending the formation of the new taluka. It has however been found necessary to retain an outpost of two men at Kario Ganwhar, and this has been provided from the strength of the police station at Tando Ghulam Haider with the result that the remaining strength of one Sub-Inspector, one Mounted Head Constable and four Mounted Constables is insufficient for the work there. In the absence of any Criminal Court, within their beat, all the challans have to be sent to Tando Muhammad Khan and prisoners who are numerous to be escorted twelve miles to the nearest Magistrate. In these circumstances the entertainment of one head constable and four constables has been sanctioned by Government with effect from the 6th October 1926 as a temporary measure till the police force of the Hyderabad District is reorganized and the charge during the year 1926-27 is being met from the provision sanctioned for the Taluka Treasury and lock-up guard at Kario Ganwhar.

Remarks.—The School Leaving Examination Board has prescribed the new Science groups, *viz.*, (1) Botany and Zoology and (2) Physiology and Hygiene as alternative subjects with Physics and Chemistry for the School Leaving Examination. Arrangements already exist at present for the teaching of Physics and Chemistry in Government High Schools. It was considered desirable for the present to provide facilities for the teaching of the group “Botany and Zoology” in some selected Government High Schools on the following conditions, *viz.* :—

- (1) that there should be at least 15 students to take up the group ;
- (2) that the requisite accommodation should be available in the school buildings ; and
- (3) that the subject could be taught with the existing staff.

It was estimated that a sum of Rs. 280 (Rs. 30 recurring for contingencies *plus* Rs. 250 non-recurring for apparatus) would be required to provide the necessary facilities in a school. On the conditions stated above, the subject has been introduced in the N. J. High School, Karachi, with effect from September 1926, the charge Rs. 280 during the current financial year being met from savings in the budgeted grants. It has also been decided to provide the necessary facilities for the teaching of the subject in the Elphinstone High School, Bombay, with effect from June 1927, *i.e.*, the beginning of the next school year. The requisite provision has been made for the purpose in the budget for 1927-28. The question of the necessity and desirability of the continuation of the arrangements sanctioned for these two schools and their extension to other schools will be examined after some experience has been gained.

Remarks.—Under the revised regulations and syllabuses sanctioned for the B.E. (Civil and Mech.) Examinations and for the 2nd and 3rd year workshop classes Electrical Engineering has to be taught in addition to the old course. The subject of Physics is also taught in its technical aspects. This addition to the courses require the strengthening of the Physics and Electrical Departments and Workshops. The present staff is sufficient to teach elementary work only but is unable to cope with the additional work thrown upon it by the revised course which was introduced in 1924. The number of students in the workshop classes of the College of Engineering has also increased and the revised course introduced in 1924 has also increased workshop practice for all college students. In the absence of the requisite staff the college classes are seriously handicapped. Government have therefore sanctioned with effect from 1st November 1926 the expenditure shown below which is absolutely necessary and the requisite provision for which has also been made in next year's budget :—

The scholarships are not intended to cover the entire expenses of students but to give real relief to those who are not in a position to bear the total cost of the training. One scholarship is to be awarded during the current year to a cadet who has completed his preliminary training at the Dehra Dun Military College and has been nominated by His Excellency the Viceroy for admission to the Royal Military College, Sandhurst, and two scholarships will be awarded from next year.

The amount of these scholarships has been fixed at Rs. 1,000 per annum each. The scholarships are not intended to cover the entire expenses of the students but to give real relief to those who are not in a position to bear the total cost of the training. Remarks.—Government sanctioned in 1919 the grant of a conveyance allowance of Rs. 25 per mensem to those members of the Deccan College staff who were drawing Rs. 200 per mensem and under on account of the College being at a long distance from the city and on account of the staff being unable to stay near the College for want of accommodation, etc. The maximum limit of Rs. 200 fixed for the grant of conveyance allowance was based on a pre-revision pay when Assistant Lecturers used to get Rs. 200 as a maximum pay. In the revised scale of pay for the collegiate branch of the Subordinate Educational Service sanctioned by Government in 1921, the maximum which an Assistant Lecturer can now get has been raised to Rs. 350. The Director of Public Instruction represented to Government that the revised scale of pay applies equally to all Subordinate Educational Service members of the collegiate branch irrespective of the locality at which they are serving and that the embarrassment from which the Deccan College members drawing Rs. 200 suffer still remain, more especially as these officers do not get Compensatory allowance like the Bombay Educational Staff officers of Rs. 250 or over working in the college. He therefore requested that the maximum limit of Rs. 200 laid down for conveyance allowance might be raised to Rs. 350. As this request appeared to be reasonable to Government it was granted by them. This involves an additional cost of Rs. 600 per annum.

The bath-rooms themselves also require constant attention, while they are in use. It was therefore proposed to entertain two bath-room attendants, one male and one female, for this purpose and these have been sanctioned. An addition of Rs. 492 per annum to the contract grant of the Hospital has been sanctioned.

Remarks.—The new regulations for the M.B., B.S. degrees of the Bombay University require for Part II of the Final M.B., B.S. Examination instruction in Mental Diseases, consisting of a course of not less than ten lectures and demonstrations to be completed in a properly constituted Mental Hospital. This instruction used so far to be imparted by the Professor of Medical Jurisprudence, and the demonstrations were given at the Northcote Police Hospital. This is, however, not a 'properly constituted Mental Hospital', and the people detained in the Lunacy cells there are not certified lunatics, but persons, about whom the Commissioner of Police or the Presidency Magistrate requires an opinion as to their mental condition. It was therefore proposed that the Thana or the Yeravda Asylum might be utilized for the necessary demonstrations. After discussion with the Surgeon General, Government decided that the N. M. Mental Hospital, Thana, should be utilized as a training centre for mental diseases for the students of the Grant Medical College and that the Superintendent of the Hospital be appointed *ex-officio* Professor of Mental Diseases on the staff of that college on a remuneration of Rs. 15 per lecture, and the proposal has accordingly been sanctioned.

Remarks.—When Dr. Noronha, Lecturer in Pathology and Bacteriology at the B. J. Medical School, Poona, was first appointed, he was given to understand that there was a very strong probability of a professorship becoming available for him at the proposed Medical College at Poona, which was then under contemplation but which has not materialized owing to various reasons, and on that understanding he gave up his large practice in Bombay and accepted the post of the full-time Lecturer on Rs. 300—20—700. His services at the Sassoon Hospital and the Medical School have been of an entirely exceptional character and his retention during the period of reorganization which the School at present is going through, is very desirable. On these grounds the Surgeon General strongly recommended that Dr. Noronha should be granted an increase in his pay, and a personal pay of Rs. 170, in addition to the pay of the post, has accordingly been sanctioned to him with effect from the 27th October 1926.

Remarks.—Construction works to a large extent have already been undertaken by the Sanitary Branch which works are expected to extend over a considerable number of years. In addition to the direction of four Executive Divisions the construction and other works in the six separate sub-divisions in almost every one of which there is important construction work is controlled by the Sanitary Engineer to Government both as regards administration and execution. The volume of clerical work has consequently swelled both in magnitude and importance. In these circumstances the pay of the four permanent posts in the office of the Sanitary Engineer to Government has been revised on the line of the office of an ordinary Superintending Engineer and six temporary posts incumbents of which have been employed for periods varying from 10 to 15 years have been made permanent with effect from the 1st March 1926. 2. Under the Co-operative Societies Act, it is incumbent on Government to have the accounts of every society audited at least once in a year. The total number of societies on 31st March 1926 was 4,660 and the number will probably exceed 5,000 on 31st March 1927. The sanctioned strength of auditors on 31st March 1926 was 41. Out of these two are working as assistants to Special Auditors, one is a Deputy Assistant Registrar in Sind doing no audit work, one is a reserve auditor, one is Auditor, Purchase and Sale Societies, and one is Auditor, Welfare Work. The last three auditors, the Special Auditors and Sub-auditors audit about 550 societies, leaving 4,110 societies to be audited by the remaining 35 auditors. The standard scale of audit is 100 societies per auditor. It was therefore necessary to provide additional auditors so as to fulfil the responsibility under the Act.

3. The Special Auditor of Co-operative Societies, Bombay, had only one clerk on Rs. 30— $\frac{5}{2}$ —80. Owing to an increase in the number of societies the need for a second clerk was keenly felt for checking items, vouchers, etc., as well as for correspondence work. It will now be possible for the Special Auditor, with the assistance of the clerk, to take up two sets of audit at the same time.

4. The office of the Assistant Registrar of Co-operative Societies, Khandesh Division, was created in 1923 with one head clerk and two clerks. The other Divisions have one head clerk and three clerks. The number of societies in the Khandesh Division which was 481 in 1923, is increasing rapidly and in August 1925 stood at 669. The considerable increase in clerical work resulting from this rapid growth of the co-operative movement necessitated the entertainment of an extra clerk.

Khan, an Inspector on Rs. 100—10—150 in the Bombay City and Harbour Veterinary Department, was granted study leave in the year 1925 and joined the Royal Dick Veterinary College, Edinburgh, with the object of specialising in Anatomy. At the time of granting the leave no promise of promotion to a higher appointment was made to him, but in order to utilise his special knowledge for the benefit of students at the Bombay Veterinary College it was decided on his return in August 1926 that in addition to his duties as Inspector he should work as a “Demonstrator of Anatomy” at the College. Remarks.—The Thar Parkar District is subject to severe outbreaks of cattle diseases of various sorts. The district covers an extensive area and the only veterinary dispensary it possessed, viz., that at Mirpurkhas, was quite unable to meet its requirements. The District Local Board, Thar Parkar, accordingly resolved to open three new veterinary dispensaries at Umerkote, Jamesabad and Digri or Jhudo. There was formerly a dispensary at Umerkote, but it was closed in 1923, as the Board was not able to maintain it. As the need for more dispensaries was established, it was decided to open two new dispensaries in the current year, leaving the third to be opened next year. Under the rules for the working of the Civil Veterinary Department, Government give grants-in-aid to District Local Boards towards the maintenance of dispensaries and, in addition, bear the cost on account of the pay and allowances of the veterinary assistant surgeon in charge of the dispensary. The minimum Government grant fixed for a veterinary dispensary in Sind is Rs. 750 per annum. The cost of the veterinary assistant surgeons and the maintenance grants during the year will be as follows :—

Remarks.—When the general revision of pay of menials in the several Public Works Department permanent offices in the mofussil was sanctioned in the Government Resolution No. 1054, dated the 8th June 1925, the office of the Superintending Engineer, Deccan Irrigation Circle, was not included therein as it was not permanent at the time when the proposals of revision of pay were called for from the several officers. When this office was made permanent, one havaldar and two peons were made permanent on their then existing pay and one Ramoshi and seven peons were continued on temporary establishment. In the revision the number of the permanent menials in the office of the Superintending Engineer, Central Circle, was raised from three to seven.
