PREFATORY NOTE

The tables presented in this volume have been prepared mostly from the Population Tables published as Part II of the 1951 Census Report. These tables bring to prominence certain population characteristics which deserve study. The Census Report is based on these tables.

The tables have been arranged in seven series. There is also an index of non-agricultural occupations.

Series 1. There are eight tables in this series and these are devoted to general population. Distribution, density, variation, emigration, immigration and growth and livelihood pattern of population are presented in these tables.

Series 2. This series, consisting of four tables relates to rural population. Distribution in villages, variation, growth and livelihood pattern of people in the countryside are given.

Series 3. This series of seven tables exhibits the important characteristics of the urban population.

Series 4. The nine tables in this series are devoted to an analysis of the agricultural section of the population. Under agricultural classes are :—

- (1) Cultivators of land wholly or mainly owned and their dependants,
- (2) Cultivators of land wholly or mainly unowned and their dependants,
- (3) Cultivating labourers and their dependants,

- (4) Non-cultivating owners of land; agricultural rent receivers and their dependants.

The dependency status and subsidiary means of livelihood are studied in detail. An attempt is also made to correlate availability of land for cultivation to the size of the total population.

Series 5. There are seventeen tables in this series. These are devoted to the non-agricultural section of the population. Persons including dependants have been grouped under the following livelihood classification :—

- (5) Production other than cultivation.
- (6) Commerce.
- (7) Transport.
- (8) Other services and miscellaneous sources.

Dependency, economic status and subsidiary means of livelihood are analysed here. The distribution of persons in the several classifications of industries and services is also summarised.

Series 6. This series containing fourteen tables is devoted to family composition, marital status and age distribution of the population.

Series 7. This series with three tables relates to literacy and education.

Index of non-agricultural occupations.

This table gives the distribution of non-agricultural population (sex-wise and also district-wise) into the various groups and sub-groups of industries and services.

general population**

This table has been prepared from Table A II of Part II of the Census Report and the figures regarding registered births and deaths supplied by the Director of Public Health.

Prior to the integration of the two States, statistics were compiled according to the Malabar year and adjustments had to be made convert them to the Christian year.

The different heads in the table are explained below :

- 1 Mean population of decade is the arithmetic mean of the populations at the beginning and the end of the decade.
- 2 Growth of population during decade is the difference between the populations at the end and the beginning of the decade.
- 3 Mean decennial growth rate is $\frac{(2)}{(1)} \times 100$.
- 4 Registered births during decade is the total of births registered during the decade.
- 5 Mean decennial birth-rate is $\frac{(4)}{(1)} \times 100$.
- 6 Registered deaths during decade is the total of deaths registered during the decade.
- 7 Mean decennial death-rate is $\frac{(6)}{(1)} \times 100$.
- 8 Decennial rate of natural increase is mean decennial birth-rate—mean decennial death-rate.
- 9 Migration-cum-registration error is mean decennial growth-rate—decennial rate of natural increase.

**5.6 Comparison of the classification of the population by livelihood classes
at the 1951 and 1931 censuses**

This table has been prepared from Tables B I (Livelihood classes and sub-classes) and B II (Secondary Means of livelihood) in Part II of the Census Report, 1951 and Tables X—Occupation or Means of Livelihood, Part I—of the Census of India, 1931, volume XXVIII, Travancore Part II Tables and of the Census of India, 1931, volume XXI, Cochin.

There are two important points of difference between the occupational tables of 1931 and 1951.

(1) At the 1931 census, persons following an occupation or means of livelihood have been classified in Table X under three heads—(i) those having that as principal occupation (ii) those engaged in that as working dependants and (iii) those having that as subsidiary occupation. This classification will therefore give under each occupation, the number of persons who are self-supporting (principal occupation), the number of earning dependants in that occupation and the number of self-supporting persons who have that particular occupation as a secondary means of livelihood. Thus under each occupation, even though the numbers in the three heads are mutually exclusive, the numbers when all the occupations are taken together are not mutually exclusive.

At the 1951 census, persons have been classified as self-supporting, non-earning dependants and earning dependants. The persons classified under each livelihood class are those who have that means of livelihood as their principal means, and their dependants—both earning and non-earning. Thus the earning dependants here may obtain their income from any one of the eight occupations. The numbers here are therefore mutually exclusive.

Thus the figures for the two censuses are not strictly comparable.

(2) At the 1931 census, occupations are divided into 4 classes, 12 sub-classes, 55 orders and 195 groups. (Table X). At the 1951 census, there are 8 livelihood classes—4 agricultural and 4 non-agricultural. The non-agricultural classes have been further divided into 10 divisions, 88 sub-divisions and 211 groups.

The following statement gives the group-numbers of the 1931 census comprised in each of the 8 livelihood classes of the 1951 census.
