ADMINISTRATION REPORT

OF THE

IDAR STATE.

FOR THE YEAR 1926--27 ENDING 30TH SEPTEMBER 1927.

CHAPTER I.

General and Political.

- 1. The State of Idar, popularly known as "Nani Marwar", is situated in the north-east of Guzerat lying between 23°6′ and 24°30′ north latitude and Position. 72°49′ and 73°43′ east longitude. It is bounded on the north by the Native States of Sirohi and Mewar, on the east by the State of Dungarpur and on the south and west by the British District of Ahmedabad and the territory of Baroda.
- 2. The extreme length and breadth of the State are 96 and 58 miles respectively. It has an area of Area,

 1,669 square miles and a total population of Extent and
 202,811 souls, which gives a density of 122 Population.

 Population.
- 3. The average gross revenue and expenditure, inclusive of Average all alienations, worked out on the last five revenue and years and a half, is Rs. 16,47,379 and Rs. Expenditure. 13,01,314 respectively,
- 4. The State pays an yearly tribute of Rs. 30,340 to His Highness the Gaikwar of Baroda under the Tribute. denomination of Ghasdana while it annually receives Rs. 52,427 on account of Khichadi and other Raj Haks from its subordinate Jagirdars the tribute paying Talukas of the Mahi Kantha Agency and others.
- 5. The country is interspersed with hills and rivers, the principle of which are the Sabarmati, the Hathmati, the Meshvo and the Vatrak. The soil is rich and fertile Physical excepting the hilly tracts on the north and on Features. The soil is black cotton or light sandy. The average rain fall of the State is about 35 inches and the principal products are wheat, rapeseed, methi, makki, all sorts of pulses and oil-seeds, rice, sugarcane and cotton. Mango and Mahura trees grow in abundant quantity throughy the State.

The State is noted for its sand stone which far excels in texture, fineness and durability the Porbandar and Dhrangadhra Stone. The granite rocks at Idar are ascertained to be of the best quality. Bhetali boasts of lime stone quarries, the lime prepared from which is noted for its quality. "Oos" or "Kharo" of a high quality for preparation of soaps abounds in Himatnagar and Bayad Talukas. On the west, white clay on the Sabarmati bank lends itself best for the preparation of sizing material. The State has also mines of mica, asbestos and steatite. It also abounds in rich forests where teak wood, bamboos, babul and khakhras grow in abundance

The State is connected with a railway line from Ahmedabad which passes through 34 miles of Idar territory, terminating at Khed Brahma which is noted for its celebrated temples of Ambaji and Brahmaji, the latter having the only largest idol of Brahma in the whole of India.

6. Among the historical places in the State may be mentioned the town of Idar, the former capital of the State, which is enclosed on one side by a brick wall now

Historical range of hills which formed a natural protection in old days. There are celebrated Jain temples situated on Idar hills drawing Jain pilgrims from nearly the whole of Gujarat.

Khed Brahma and Shamlaji are among the principle places of pilgrimage and they attract Hindu pilgrims from Gujarat and other parts especially during the annual fairs. The Khed Brahma fair lasts from Maha Sudi 15th to Falgun Sudi 4th when traders from Mewar, Shirohi, Danta, Baroda and Ahmedabad gather in numbers for the sale of their wares. The fair at Shamlaji lasts from Kartik Sudi 11th to the end of that month and attracts a large number of people from adjoining States and British territory,

There is a leper asylum at Bhavnath which is another celebrated place of pilgrimage in the State. The waters of a Kund there are believed to be endowed with a healing property.

7. The present State of Idar was founded in 1729 A. D. by the two brothers, Maharajas Anand Singhji and Rai Singhji, Rathore Princes from Jodhpur, who acquired this territory by the valour of their arms and Consolidated it. Since then the territory of Idar has, except for a very short period when it passed back in the hands of the Raos of Polo and Rehwars ultimately ending in the re-conquest by Maharaja Shiv Singh in A. D. 1751, continued under the sway of the Surya

Vanshi (Solar race) Rathore Clan, who have the proud privilege of being the direct descendants of the hero of the great epic Ramayan. They were originally known as Rashtra or Rashtric meaning country or ruler. Rashtra was subsequently by general use crystallised into Rathore. Their earliest mention is found in the edicts of Ashoka as rulers of the Deccan. When the Deccan Kingdom broke up, it appears that they carved out a new Kingdom in Central India making Kanuaj as their capital. From there their decendants migrated into Western Rajputana and founded the principality of Marwar. In 1728 Anand Singh and Rai Singh, two brothers of the Raja of Jodhpur, accompanied by a few horsemen from Vamo and Palanpur and the Kolees of Godwara established themselves in Idar without much difficulty. The Rathod clan is said to be the last that effected a settlement in Gujarat by conquest. Anand Singh was the first Maharaja of Idar and the present ruler His Highness Maharaja Dhiraj Maharajaji Lt. Colonel Sir Shree Dowlat Singhji Bahadoor, K. C. s. I., the ninth to succeed to the Gadi of Idar. His Highness was born at Jodhpur in May 1878, and was educated at the Mayo College, Ajmer. He received his military training in the Imperial Service Cavalry, Jodhpur, and subsequently worked there as Squadron Commandant and Adjutant for some years. He also acted as Military. Secretary and Member of the Council at Jodhpur. He was adopted by His Highness Maharaja Dhiraj Maharaja General Sir Pratap Singhji Saheb, on his accession to the Idar Gaddi in 1902 and was put in charge of the administration of the State, which he carried on successfully, till the latter abdicated in 1910.

His Highness accompanied his father Maharaja Sir Pratap Singhji to England in 1902 to attend the coronation of His late Majesty King Edward VII, and was there made an A-D-C to the present King-Emperor, then H. R. H. the Prince of Wales. His Highness again visited England as Maharaja of Idar on the coronation of His Imperial Majesty King George V, and took part in all official functions, apertaining to the happy occasion.

His Highness was formally installed on the Gadi on 21st July 1911, and attended His Majesty's Coronation Durbar held at Delhi in the same year.

At the out-break of the Great war, His Highness at once offered his personal services to the Government, and placed all the resources of the state at their disposal. With the Idar State Imperial Service Despatch Riders, His Highness saw active service in Egypt.

On return from Egypt, His Highness was promoted to the Honrary rank of Lt. Colonel in the British Army, and was later

on created Knight Commander of the Most Exalted Order of the Star of India in 1920.

Besides the many concessions allowed to recruits, His Highness helped the Government with men, material and money to the extent of a sum of more than three and a half lacs.

The eldest Maharaja 8. His Highness has three sons. Kumar Shree Himmat Singhji, who is the Heir-Apparant, is in his 29th year. He acco-Heir apperent, mpanied His Highness to Europe, when the latter went to attend the coronation of the King-Emperor in London, and acted as Page to His Imperial Majesty at the Coronation Durbar, held at Delhi in 1911. He received his education in the Mayo College, Ajmer, where he had a most distinguished career and stood first in the Diploma Examination among the successful candidates from all the Chiefs' Colleges in India, winning the Viceroy's Medal. In addition to his other qualities of head and heart, he is a keen sportsman, and excels in almost all manly games, True to the inborn military spirit of the Rathore clan, he takes exceptional delight in discharging the duties as Colonel-in-Chief, Idar Sir Pratap Infantry.

His Highness' second son Maharaja Kumar Shree Man Singhji is in his 22nd year. He is a promising young Kumar, sturdy in habits, genial and affable in manners. A keen sportsman like the heir apparent, he stands by him as Commandant, Idar Sir Pratap Infantry,

Maharaja Kumar Madan Singhji, the youngest son of the Maharaja, is 16 years of age. He is also a keen sportsman and is developing himself into an outspoken gentleman and is being trained in Idar Sir Pratap Infantry.

9. The State is comprised in the Province of Mahi Kantha, a political division of the Presidency of Bombay. Political. It ranks third among the Native States of the Presidency and is the only First Class State in Mahi Kantha. Its Chief, who has the hereditory distinction of being styled as Maharaja, is entitled to a salute of 15 guns and enjoys plenary jurisdiction in matters both civil and political.

The relations of the State with the British Government and the neighbouring States and Talukas continued to be cordial and Satisfactory during the year under report.

10. Het Highness' Maji Bhatiyaniji Sahiba passed off at Domestic Jodhpur on 18th January 1927 to the great events.

- 13. His Highness' birthdate was celebrated with great eclat on 12th May 1927 when, besides releasing a few prisoners, sweets were distributed to schools and six scholarships for imparting higher education in His Highness' English and Vernacular of the total sum of Rs. birth-date. 100/- a month were announced. All arrears of revenue dues from cultivators till the end of Samwat 1975 were remitted and life pensions of Rs. 3/- each per month were granted to 15 deserving and destitute widows
- 14. The birthdate of His Majesty the King Emperor was His Majesty's celebrated with all eclat and pomp on 3rd June birthdate. 1927, observing it as a holiday throughout the State.
- 15. Rao Bahadur H. B. Kotak, B. A., LL. B., J. P., was appointed as Dewan with full powers and responsibility. Personnel of He took over charge on 21-12-26 and applied Administration. himself to the re-organisation of various State

departments. Consequently several important changes were made in the personnel of the heads of important departments (vide Appendix I).

- 16. His Highness the Maharaja Saheb was pleased to confer the privilege of wearing gold on the leg and the honour of double Tazim on Rao Bahadur Kotak on 1st February 1927.
- 17. In order to keep the officers and the general public acquainted with the various rules, regulations, circulars, orders, &c., passed from time to time, it was thought advisable to issue a State Gazette every month and consequently the publication of the Idar State Gazette was undertaken from 1st January 1927.
- 18. During the last week of July, Gujarat passed through a calamity which in the intensity and the extent of the damage caused was almost unparalied and unheard of within the memory of living men. Fortunately however, the ravages caused by the inclement torrents of rain in our State were not so destructive as in other parts of Gujarat. The area most affected was the southern part of the country through which the storm marched off. Though the damage to the crops was not appreciable, the sufferings of the poor were intense as the inclement torrents rendered homeless a good many of them. This necessitated a prompt action on the part of the State and His Highness the Maharaja Saheb showed his genuine feelings of deep sympathy for his subjects by contributing Rs. 10,000 from the State and Rs. 2000 from his personal purse to the Relief Fund started by the Dewan in a meeting of all castes and creeds which he lost no time in convening for devising measures to afford immediate and necessary help to the homeless destitutes. The collections to the fund amounted to Rs. 18,000/- When the distress on this side was brought to the notice of Sir Purshotamdas Thakurdas, Chairman, the Bombay Central Fund Committee, immediate enquiries were set on foot by him through the indefatigable worker Bai Vahaliben of Vanita Vishram of Bombay as a result of which Rs. 17,000/were sauctioned by the Committee and our grateful thanks are due in this connection both to Sir Purshotamdas and to Vahaliben, the latter again, regardless of her personal comforts and irasome travelling in the hilly tracts of the country, moved round and distributed necessary help to the needy in the shape of clothes, metal pots &c. It reflects the greatest credit on the State Relief Committee for agreeing to grant all help completely gratis and not as loans as formerly contemplated.
- 19. An old standing dispute pending for the last 20 years before the Agency between this State and Gabat Settlement with in re the fourth share of Vaje and Vase in the Agency Talukas. village of Vasadra under Idar, was referred back

to the Dewan for being gone into and settled satisfactorily whereuopn after going through the full record a satisfactory settlement was reached on 17th February 1927 and notified to the Agency which expressed itself gratified at it.

Similarly a dispute between Ambaliara and the State of nearly 10 years' standing was satisfactorily disposed of and reported to the Agency which acknowledged the Settlement with much pleasure.

Lastly a still older dispute of over 30 years pending before the Agency and characterised by the Political Agent as typical of unsatisfactory conditions existing in respect of such claims between the Taluka of Magodi and this State was amicably disposed of on 15th September 1927 and reported to the Agency which subsequently informed the State of Government's sanction thereto, with an expression of a desire from Government to settle other claims in a similar manner.

CHAPTER II..

Administration of Land.

20. The charge of the Revenue Department remained with Mr. Raisinghji till 7th January 1927 when he having resigned, Mr. Keshavlal O. Joshi was appointed as Revenue Commissioner of the State. He took over charge of the Department on 26th January 1927.

Mr. Gokuldas Devchand who was appointed as Assistant Revenue Commissioner, took over charge of his office on 24th January 1927. He worked in the office of the Revenue Commissioner till 19-5-27 when he was stationed at Idar.

- 21. The Idar State is devided into six Mahals for administrative purposes. Last year there were 9 Mahals which were for the sake of convenience reduced to six in the year under report and each Mahal was placed in charge of a Mamlatdar. Two Mahals viz Idar and Vadali were placed under the direct supervision of the Assistant Revenue Commissioner.
- 22. The total number of villages in the State exclusive of petty hamlets was 923 of which 383 are Khalsa, State villages:
 Khalsa, during the year of report as against 328 Khalsa, alienated and 550 alienated, 1 disputed and 44 co-shared last co-shared.

 year, showing an increase of 55 in Khalsa and consequent decrease in alienated as these villages were resumed from the Jagirdars who were allowed to draw a fixed monthly allowance during their life time on condition of service in lieu of the resumption of their villages by the State.

23. The cash assessment system which has found favour with the cultivators is in vogue in the State in most of the Khalsa villages. It was in force in 247 villages at the end of the year while the Bhagbatai Land Revenue system-a share in kind system-was in force in System. 93 villages. Revenue demands in six villages were recovered by actually measuring the land under cultivation and levying a fixed amount on acreage and in 37 villages the revenue demands were collected by fixed sums or Ankdas. The increase in the number of villages where land assessment prevailed during the year under report is due to the fact that there was Vighoti system already in force in some of the villages resumed by the State from Jagirdars and also to the introduction of cash assessment system in some Khalsa villages in lieu of the share in kind system.

The Vighoti system was in force in 37 alienated villages out of 494 during the year of report. The decrease in the number of villages where Vighoti system obtained is responsible to the fact that 13 such villages became Khalsa while the Bhagbatai system prevailed in 457.

Out of 44 co-shared villages, Vighoti obtained in 26 villages and Bhagbatai in 16 while revenue demand was recovered in 2 villages by actually measuring the soil under cultivation at a fixed rate of acreage.

24. The subjoined statement shows the work of the Survey Department during the year under report:—

As the work of the Survey Department was going on slowly owing to inadequate staff, it was thought necessary to strengthen it during the year under report by appointing new and experienced Mojnidars and Classers. A new Survey Superintendent was also appointed as the post was vacant.

25. The total area of culturable land under Khalsa Villages was 2,41,000 acres and under co-shared villages 37,000 acres, grand total being 2,78,000 acres of which 1,56,000 acres of land was occupied in Khalsa villages and 22000 acres in co-shared villages, leaving respectively 85000 acres of land in Khalsa and 15000 in co-shared villages as unoccupied during the year of report.

Land leased out during the year of report was 44271 acres as against 17134 in the last year and acreage of land relinquished was 10183 as against 9865 in 1925-26. This shows a satisfactory progress as regards the leasing out of unoccupied culturable land. Efforts are being made to bring in outside cultivators as there is a vast expanse of land lying unoccupied. Liberal terms are offered to cultivators intending to come and reside in the Idar State.

- 26. Land revenue demands of the State amounted to Rs.
 7,13,864 during the year under report owing
 to resumption and increased occupation of land
 as against Rs. 6,63,073 out of which Rupees
 land revenue.
 7,04,934 were collected as against Rs. 6,45,604
 last year. This shows a steady increase in
 the land revenue of the State.
- 27. There is only one Hazur Treasury at Himatnagar and no Sub Treasuries in Mahals. The necessity of opening the same in different Mahals is felt and the subject is under consideration. The opening of Sub Treasuries is likely to afford greater facilities in receiving and making payments and speed up the account work. Till the Sub Treasuries in the Mahals are opened a system of accounts suitable to the new requirements is introduced from the ensuing year in the Mahals that would serve the useful purpose of checking revenue demands and their proper recoveries.
- 28. Remissions granted during the year under report amounted to Rs. 12,928 as against 2,110 last year, leaving the total land revenue arrears to the extent of Rs. 1,97,884 at the end of the year as against Rs. 2,01,882 last year which shows a decrease in the amount of arrears over the last year's figures.

- 29. During the year ander report 418 notices were issued as against 396 last year but in no case the Coercive property of the defaulters had to be attached. measures for This is really satisfactory as no recourse had to be resorted to adopt any coercive measures.
- 30. The arrears of Taccavi advances and loans given from the Agricultural Bank amounted at the end Taccavi advances and loans of the last year to Rs. 4,393 and the amount ces and loans of fresh advances and loans given during the from Agricultural Bank.

 Rs. 127 on account of interest accruing due in the year brought the figure to Rs. 6,850. Out of this, only Rs. 267 were recorved, leaving Rs. 6,583 outstanding at the end of the year.
- 31. During the year under report 47 acres and 1 guntha of land was resumed from Barkhali lands against 9 acres and 7 gunthas last year.
- 32. There were 30 estates under State management at the close of the previous year. During the Estates under year of report 13 estates were placed under State attachment while 7 were relieved from it, management.

 leaving the number of attached estates at the find of the year at 36. The grounds for attachment of these estates were (1) minority of the present holders in 17 cases, (2) encumbered condition of the estate in 12 and (3) disputed succession or title in 7.

CHAPTER III.

Protection.

(a) LEGISLATION.

- 33. The proscription against Hindustan, Prajamat and Saurashtra papers and the order which necessitated in the case of a few Idarites previous permission to enter the State limits were abrogated soon after taking charge of his office by the Dewan. Existing rules regarding intestate succession were modified so as to make it optional for first fourteen heirs of the deceased to obtain an heirship certificate and a reduction of 50 per cent was made in the scale of fees levied in the case of agnates. In this connection it was further enacted that cognisance of such cases should be taken by judicial courts only.
- 34. With a view to secure uniformity and certainty of the prevailing laws and the procedure obtainable in various matters of litigation, the following British laws were introduced from 1st May 1927 mutatis mutandis:—

- (1) Criminal Procedure Code, Act V of 1898 with subsequent amendments.
- (2) Civil Procedure Code, Act V of 1908 amended upto date.
- (3) Indian Penal Code, Act XLV of 1860 amended upto date.
- (4) Indian Contract Act, Act IX of 1872 amended upto date.
- (5) Limitation Act, Act IX of 1908, amended upto date.

In this connection it was further notified that future amendments in case of the above mentioned laws would be applicable in State limits and that in other matters the spirit of British laws will be followed as far as possible.

The enactments that are in force in the State are specified in Appendix II.

There are separate rules also regarding opium, extradition and Border Court in force in the State.

35. It is much to be regretted that unwholesome activities of a few busybodies brought about a temporary prohibition of political meetings. It was confidently hoped at the time that better sense among the people would soon prevail resulting in cancellation of this measure and the measure was ultimately cancelled by orders issued soon after the close of the year.

(b) MILITARY.

- 36. The Idar Sir Pratap Infantry consists of one Company
 Class B (4 Platoons and Head Quarters) with
 Organisation. the total sanctioned strength of 150.
- 37. The strength of the Infantry at the close of the previous year was 108. During the year under report, 2 died, 2 were discharged on medical grounds, 19 at their own request, 7 as unlikely to become efficient soldiers and 9 on disciplinary grounds; 5 were tried by a Summary Court Martial and dismissed, 5 were struck off the strength for being absent without leave and 5 deserted; while 2 Indian Officers and 78 fresh recruits were enlisted. Thus the total strength at the close of the year came up to 134.

The Infantry is armed with Rifles short E. Y. 303 and Sword-Bayonets P/88-1-P.

38. No. 52 Naik Rughnathsingh, No. 90 L/Naik Maur Singh and No. 93 L/Naik Chander Singh were Courses of sent to attend the preliminary Command Course instruction. of Physical Training at Poona but they all

failed to attain the standard required for students selected to go in for a qualifying course at the Army School of Physical Training there.

No. 39 L/Naik Richpal Singh attended the preliminary course of physical training at the Southern Command Gymnasium, Poona, and attained the standard required for candidates selected to attend a qualifying course at the Army School of Physical Training, Ambala. He attended the 2nd I. S. F. Physical Training Course on 24-9-1927 at the Army School of Physical Training, Ambala, but failed.

A party of 4 N. C. O's, and 14 Sepoys attended a general course of training for five months with 10th Bn. 6th Rajputana Rifles, Nasirabad.

39. Major M. E. M. Mead, Assistant Military Adviser, Inspection.

Gujarat Circle, inspected the Infantry in March 1927 and offered very good remarks an extract from which is as under:—

"Every thing has and is being done to start this Unit on a sound basis. Both the Maharaja Kumar and his brother take a keen personal interest in it. I have every confidence that this Unit will within a year reach a high state of smartness and efficiency."

Captain J. F. Marindin, the present Assistant Military Adviser, Gujarat Circle, inspected the Infantry in September 1927 and made the remark that the training was being carried out on excellent lines and that the men were well up to standard.

Major A. S. Meek, c. M. G., Political Agent, Mahi Kantha, inspected the Infantry in September 1927 and was very much pleased at the efficiency of the Unit.

40. The cost of the Infantry during the year under report Cost. was Rs. 62,559 as against Rs. 38,822 in the preceding year.

Over and above the increased expenditure after the Infantry as shown above, Rs. 28,728/- were spent after building Military Lines and Officers' Quarters in the year.

(c) Police.

41. The services of Mr. T. B. Bhatt, Police Inspector in the Bombay District Police, were secured from the Inspector General of Police, Bombay, to fill up the post of the Superintendent of Police. Mr. Bhatt took over charge on 14-2-1927. The task before him was arduous both because the existing material in police force had to be re-organised and the finances of the State were not strong enough for the purpose. But yet a monthly

increment of Rs. 2500 was given to the State police with a view to increase its efficiency.

Mr. Moolsingh Jodha, the ex-magistrate, was appointed as Assistant Superintendent of Police and Mr. B. M. Pobaru, who had passed the police examination at Nasik School with credit, was appointed as an additional Inspector of Police.

Within a few months of his appointment i. e. in May 1927 Mr. Bhatt, assisted as he was by the just, fair and active help of Major Broughton, Assistant Political Superintendent, Hilly Tracts, Mewar, succeeded by tact and arduous labours in quelling the murderous feud between the Bhils of Poshina and Mewar. This incessant work for about a fortnight in the trying heat of the sun at Poshina unfortunately brought on him an attack of sunstroke from the effects of which he could not fully recover and therefore, much to our regret, had to retire soon after the end of the year.

42. The State police force in the year under report consist-Strength & ed of 19 Officers and 398 foot police, making a cost of total of 417 of which 340 were able to read State Police. and write in the vernacular.

The cost of the State police in the year amounted to Rs. 93,830/- as against Rs. 76,209/- in 1925-26, showing an increase of Rs. 17,621/- i. e. 23.1 per cent over the previous year.

- 43. The strength of the police in the Pattas of the sub-ordinate Jaghirdars exercising magisterial powers granted by the Durbar was 7 Fojdars, 17 Sowars and 95 footmen and the cost of maintaining them amounted to Rs. 12,684.
- 44. The village police comprised 429 mukhis and 128 Cho-Village police. kiyats of whom 294 were paid in cash, 237 by award of Baharkhali lands, and 26 partly in cash and partly by award of Bahrkhali lands.
 - 45. Thus the total strength of both the regular and village police came up to 1093 which gives a ratio of the total force to the total population and area of the State of 207.09 persons and 1.5 square mile to a policeman.
 - 46. Appendices V,VI and VII show the details concerning Work. the working of the police during the year under report as compared with those of the preceding year.
- 47. The number of offences reported to the Police in the year of report was 253 and the number of offenders traced out and apprehended by them was 362 as against 160 and 205 respectively in 1925-26. The number of persons sent up for trial was 362 which with the 130 persons sent up last year whose cases

were disposed of in the year under report, made up a total of 492 of which 196 were convicted and 205 were acquitted or discharged as against 81 and 102 respectively in the previous year. The percentage of convictions to the number of persons sent up for trial was 39.8 against 39.5 in 1925-26.

48. Among the 253 offences reported to the police in the Heinous year under report, there were 23 heinous offences offences. as against 21 in 1925-26 as shown below:-

49. The value of the property stolen during the year was Rs. 22.172 against Rs. 13,229 in 1925-26. Of this, property worth Rs. 6,459 was recovered as against Rs. 1,859, the percentage of property recovered to the property stolen being 29.1 against 14.05 in 1925-26.

(d) CRIMINAL JUSTICE.

50. In consequence of the Dewan being empowered to exercise the powers of a High Court, it was necessary to appoint an able and a competent hand as a Sessions Judge and a Judge of the First Appellate Court. A loan of the services of Mr. Ichhashanker K. Pandya, B. A. LL. B., with an experience of the judicial line, was therefore asked for from the Western India States Agency, the Junagadh State where he was serving as a Sar Nyayadhish having kindly agreed to spare his services. Mr. Pandya took over charge as Sar Nyayadhish here on 20-3-1927.

The number of magisterial courts in the State at the

close of the year under report was 14 as against 15 in the previous year. The continuance of a Second Class Magistrate's court at Himatnagar side by side with a First Class Magistrate's court being found superfluous, the same was abolished and the District Magistrate's powers were vested in the Sar Nyayadhish. The First Class Magistrate's court at Himatnagar was manned with a qualified L L. B. The status of the court of the Sabalpur-Bayad Taluka was raised from the grade of a Second Class Magistrate to that of a First Class Magistrate and a qualified LL.B. was selected to fill up that post. The convenience and the needs of the people at and about Idar necessitated the opening of a court at Idar and a First Class Magistrate's court with civil powers of a First Class Subordinate Judge was established early in the year and like the courts at Himatnagar and Sabalpur, a qualified LL.B. was also appointed there. The Magistrate at Bhiloda who exercised 3rd Class jurisdiction during the previous year was invested with 2nd Class powers with a view to enhance the facilities of the general public. As the practice of appointing a public prosecutor for each sessions case and appeal entailed hardship, a permanent post for the same was created, and a qualified High Court pleader was selected to fill up the post from among the local bar.

The number of courts exercising magisterial jurisdiction referred to above are as detailed below:—

(a) STIPENDIARY MAGISTRATES.

- 1 District Magistrate.
- 3 First Class Magistrates at Himatnagar, Idar and Sabalpur with powers to commit cases to the Court of Sessions.
- 2 Second Class Magistrates at Bhiloda and Vadali.

(b) Honorary Magistrates.

- 4. First Class Magistrates (Rajas of Chandarni and Kukadia, Raoji of Pal and the Jadecha of Dehgamda)
- 2. Second Class Magistrates (the Maharaj of Suvar and the Jadecha of Samera.)
- 2. Third Class Magistrates (Thakor of Derol and the Vaghela of Poshina.)
- 51. There were 60 cases involving 172 offenders awaiting trial in the several courts at the close of the previous year. 304 fresh cases involving 678 offenders were received during the year as against 153 cases and 375 offenders in 1925-26, making a total of 364 cases with 850 offenders for trial, of which 312 cases concerning 723 offenders were disposed of by the end of the year, leaving a balance of 52 cases with 127 offenders at the close of the year.

A reference to Appendix VIII will show that out of 723 offenders whose cases were disposed of in the year, 214 were convicted, 286 were acquitted, 164 were discharged, 31 were committed to the sessions and 28 transferred, died etc. leaving 127 persons for trial at the end of the year.

- 52. There were 3 cases of opium smuggling involving 1 Opium cases. offender in each. In two of them, the offenders were convicted and in one the accused got an acquittal.
- 53. There was one case with one accused pending before the sessions court at the commencement of the Sessions work. year. 16 cases with 31 accused came up during the year, as against 10 cases with 15 offenders in the previous year. Out of the 17 cases dealing with 32 accused, 13 cases were disposed of, leaving a balance of 4 cases involving 13 prisoners at the close of the year. Out of 19 prisoners tried before it, 9 were convicted and 10 were acquitted. The average duration of the sessions trial was 38 days as against 83 days in the previous year.
 - 54. Out of 17 criminal appeals filed during the year before Criminal the Sar Nyayadhish Court, 11 were disposed of appeals.

There was one appeal preferred against the Sar Nyayadhish' decision to the Mahekma Khas involving 3 prisoners during the year. This was disposed of confirming the decision of the lower court.

(e) CIVIL JUSTICE

the commencement of the year was 6, including Civil Courts. the courts of the Rajajis of Chandarni and Kukadia from whom civil powers were withdrawn during the year under report. An additional court was opened at Idar with the result that there remained in all 5 civil courts exercising jurisdiction shown against each in the table given below:—

original Suits making a total of 997. Out of these 859 were disposed of as against 361 during 1925-26, leaving a balance of 138 suits at the end of the year.

Of the said 826 suits, 7 related to landed property, 699 to monetally transactions and 120 to other rights.

The total value of the suits filed in the year amounted to Rs. 1,54,874/ against Rs. 85.050 in the preceding year.

57. There were 201 execution applications in arrears at the beginning of the year. 707 fresh ones were filed during the year as against 168 in 1925-26, Execution of making a total of 908, of which 679 were decrees.

disposed of, leaving 229 in arrears at the end of the year.

The amount recovered in execution proceedings in the year aggregated to Rs. 63,479 as against Rs. 16,184 in the previous year.

58. The Mahekma Khas had 5 appeals in arrears at the commencement of the year. Of these, 4 were Appeals.

Appeals. disposed of and 1 remained in balance. In 3 of the appeals disposed of, the decision of the lower court was confirmed and 1 was dismissed due to absence of the parties. There was no fresh appeal filed during the year.

The Sar Nyayadhish Court received 4 appeals during the year which with 1 in balance totalled 5. Out of these, 2 were disposed of, leaving 3 in arrears as the same were filed on the last day of the year. In both the appeals disposed of, the decisions of the lower courts were reversed.

(i) CIVIL POLITICAL SUITS AND APPEALS.

59. During the year under report the Sar Nyayadhish Court was the original court for civil political suits Courts. except with regard to boundary disputes and cases of Baharkhali lands which were heard and disposed of by the Survey Superintendent and the Revenue Commissioner respectively.

Appeals against the decisions of the above courts were entertained and disposed of by the Mahekma Khas.

60. The following table shows the original work done by the said courts in the year under report as compared with that in 1925-26.

61. The Mahekma Khas had 8 appeals standing over from the previous year, out of which 3 were dispased Appeals. of, leaving 5 in arrears at the close of the year. There was no fresh appeal preferred to it in the year.

62. The number of persons made over by the State to the British and other Native State authorities Extradition. during the year was 1 and 16 in 1 and 8 cases against 5 and 12 in 1 and 7 cases in 1925-26, while the number of surrenders made to the State by the above authorities during the year was 15 and 14 persons in 6 and 5 cases respectively as against 7 and 3 persons in 4 and 3 cases in 1925-26.

63. The system of extradition does not obtain fully between the Idar State and the neighbouring Border Court. States of Rajputana as it does between this State and the Britsh Districts and Native States under the Bombay Presidency. Consequently cases arising between this State and the States of Mewar, Shirohi and Dangarpur are disposed of by Border Courts composed of the

Political Officers on either side. It will not be out of place to remark that the Border Court system has outlived its time. The perpetrators even of the most beinous offences are according to present Border Court rules visited with a very light punishment and it is high time for all the border States to combine for devising a uniform extradition code. Negotiations with Mewar and Dungarpur Darbars are in progress and it is hoped that with the efficient co-operation of the British Officers concerned on both sides, a uniform agreement will not be difficult of obtainment.

Two Border Courts were held during the year under report one at Abhapur in February 1927 and the other at Kotra in May 1927. The former was presided over by Major A. S. Meek, Political Agent, Mahi Kantha, and Major G. Broughton, Assistant Political Superintendent, Hilly Tracts, Mewar, and the latter by Mr. A. M. Kadri, Senior Deputy Political Agent, Mahi Kantha, and Major Broughton from Kotra. The work disposed of by these courts is summarised in the subjoined table.

(h) Prisons.

- 64. As shown in Appendix XIII, there were 14 Jails and Lock-ups in the State during the year under report, including the Central Jail at Himatnagar. The Sar Nyayadhish is ex-officio Jail Superintendent.
- 65. The building of the Central Jail being found unaccomodating and insanitary and hardly worth the name of a jail, the construction of a new one was a sheer necessity. Two blocks each measuring 80 ft. by 20 ft. and four other cells for the exclusive use of female, under-trial and civil prisoners, together with separate arrangements for kitchens etc. were ordered to be newly built. But as the finances of the State could not permit all the expenditure at a time, one block was built during the year and it was arranged that the remaining plan should be executed early in the next year.
- With a view that the sanitation and food arrangements of the inmates of the Central Jail may be properly looked after and that they may have a free scope to ventilate their grievances,

if any, a Committee consisting of the marginally noted officers was appointed on 8-6-1927 and it was ordered that the Committee should meet in the Jail premises once every three months and report deficiencies and suggestions for improvement.

- 67. Uptil now the prisoners were em loyed in cutting wood, grinding corn etc. This needed a revision. It was necessary that some such training should be imparted to them as would make them more useful citizens and pursue better professions on their liberation. Arrangements were therefore made to teach them cane work. Moreover a small garden was laid out where they can have some insight in gardening and agriculture, the main stay of the people of the country.
- 68. The number of prisoners remaining at the end of 1925-26 was 33 and 290 prisoners were admitted during the year under report, making a total of 323 as against 161 in the previous year. Of these, 266 were released or discharged, leaving 57 in the jails at the close of the year.

The average daily attendance of prisoners in the Central Jail was 168.5 against 131.4 and the total daily average in all the jails came upto 233.3 against 217.1 in 1925-26.

69. The cost of maintaining the prisoners in the Central and other Khalsa Jails, exclusive of guard expenses, amounted in the year under report to Rs. 11,655 against Rs. 8,882 in the preceding year.

(i) REGISTRATION.

70. Appendices XIV and XV give a comparative statement of the registration statistics for 1925-26 and the year under report. They will show that there were 26 documents pending registration at the end of the previous year. 351 new documents were presented for registraton during the year under report as against 287 in the previous year. Out of the total of 377 documents, 347 were registered, registry was refused in 6 cases, and 24 remained unregistered at the close of the year.

The aggregate value of the registered documents during the year amounted to Rs. 1, 45, 763 against Rs. 1, 35, 942 in 1925-26.

There were three registration appeals preferred against the decisions of Sub Registrars, and all of them were disposed of.

The registration fees realized during the year amounted to Rs. 1431 as against Rs. 1125 in the preceding year.

71. A careful perusal of the several figures will show an abnormal increase in the various branches of litigation. This is due to the increasing faith of the people in the newly re-organised judiciary and the facility provided for seeking redress for their grievances. The figures themselves are eloquent enough and need no further comment.

(j) Municipalities.

72. There were 5 Municipalities in the State during the year under report as in 1925-26 yiz those at Himatnagar, Idar, Vadali, Bhiloda and Badoli. all of wich are at present being worked by State Officials. Both conservancy and lighting arrangements were in force at the first 3 places while the municipal work at the last 2 places was confined to conservancy alone.

The receipts and expenditure of the above municipalities in the year under report as contrasted with those of 1925-26 are shown in Appendix XVI.

CHAPTER IV.

Production and Distribution.

WEATHER AND CROPS.

73. The rainfall measured at different centers of the State during the year under report as contrasted with the average

rainfall of the last five years is shown below:-

It will be seen from the above statement that the rainfall during the year was far above the average, which was due to the abnormal downpour accompanied by severe storm in the latter part of July. These stormy rains did some damage to the standing crops. Much damage however was done to houses especially in the districts of Bayad and Sabalpur. The ravages wrought by the rains were fortunately considerably less as compared with the same in the adjoining districts of Gujarat particularly the Kheda District.

74. The monsoon as usual set in quite in time i. e. by the 20th of June but before the Khariff sowings were finished we had heavy and stormy rains in the latter part of July which damaged the young sproutings in several places. The principal crops affected were Bajree, cotton, til and paddy but cotton and paddy were re-sown by the ryots and the damage was thereby greatly minimised. The damage was also more than compensated by the Rabi crops such as wheat, rape-seed and gram all of which were sown extensively and which thrived well as the soil long retained moisture and the irrigation wells were full.

WAGES AND LABOUR.

- 75. There was no marked change in the scale of skilled and unskilled labour during the year of report and there was sufficient work for the labourers.
- 76. The prices of staple food grains as they obtained in the different months of the year are shown in Appendix XVIII from which it will be seen that a tendency towards lower prices has commenced.

Forests.

77. The area of the reserved forests of the State is approximately 30000 acres. The forest produce chiefly consists of teak, which is not of superior quality.

The income of the Forests amounted to Rs. 5,630 during the year under report and the expenditure to Rs. 5,091 as against Rs. 7,148 and Rs. 5,755 respectively last year.

- 78. Mr. J. V. Patel, who is experienced in forestry and lac cultivation, was appointed Forest Officer during the year under report. He was asked to study the local conditions and submit the working plans. There are many Babul, Khakhra and Bore trees in the kharaba lands and some of the forests of the State which have been uptil now used as fuel wood. The scheme is prepared to introduce lac cultivation and with this view a small experiment has been made during the year of report to attach lac insects to Babuls, Khakhras and Bore trees and if the experiment proves successful, and it is hoped it will, the trees considered useless at present and fit only for fuel wood will be utilised for lac cultivation extensively and made to yield a better return.
- 79. It is proposed to have a Forest Nursery wherein plants of Sandal, Eucalyptus, Kaju, Teak, Kokam and such other precious trees will be reared and planted at different places in the State Forests in suitable blocks and only those trees which find the soil and climate of the country congenial to their healthy groth will be propagated.
- 80. Uptil now no systematic cutting was done when trees were felled and any and every useful tree used to become a victim to the axe of a wood cutter. Many precious trees have thus been cut off and sold in the market as fuel wood. This sort of cutting at random has been now stopped and a coup system will be introduced.
- 81. The forests that still contain precious trees will be strictly reserved and it is under contemplation to have the forests demarcated for which a Surveyor is appointed.
- 82. The wood cutters are warned to resort to systematic cutting based on improved method as approved by the Forest Department of the British Government and efforts are being made to develop the Forests of the State side by side with agriculture as both these industries afford great scope and possibilities of future development.

Industries.

- 83. Agriculture is the chief and most important industry of the State and as such, its development requires the foremost attention as there is great scope for its development in the direction of extensive and intensive cultivation.
- 84. Efforts were made during the year of report to introduce a new variety of wheat Pusa No. 4 and No. 12 on a small scale. This wheat claims to be immune from rust and the experiment though made on a small scale proved to be quite satisfactory and successful. 480 lbs of wheat pusa No. 4 and No. 12 was ordered out from the Imperial Botanical Economist from Pusa, Bihar and

the seed was supplied to some enterprising cultivators. Country wheat was sown side by side with the result that while country wheat was attacked with rust, the above-mentioned varieties remained immune. As wheat is largely grown in the State if more seeds could be available from Pusa and if cultivators will take to it, they will be much benifited, the crops being practically insured against damage by rust.

- 85. Some seeds of English vegitables such as cabbages, knol-khol, cauli flower, tomatoes, chillies &c. were ordered out and supplied to cultivators and to Himatnagar and Idar State gardens. All these vegitables flourished well and yielded a satisfactory crop and found the soil congenial to their healthy growth.
- 86. The soil of the State is very fertile and all sorts of fruit trees can be grown here such as lemons, sweet or sour, oranges, citrons, mangoes of rich varieties, chikoo, pomgranates, sitafalis &c.

INTRODUCTION OF IMPROVED IMPLEMENTS OF AGRICULTURE.

- 87. Efforts were made to introduce improved iron ploughs such as BT2 and Kirlosker ploughs. To begin with 5 ploughs and I chaff cutter were ordered out during the year of report. Cultivators are allowed to make free use of these ploughs. To suit different kinds of soil different kinds of ploughs with suitable spare shares have been ordered out. These ploughs are given to enterprising cultivators with a view to demonstrate their working. The working of the chaff cutter was also demonstrated at Himatnagar to cultivators of the adjoining villages. They were quite satisfied with its working. We hope to order out more iron ploughs and other time and labour saving implements during the next year according as the demand is created. The cultivators of the Idar State are very backward in comparison with their neigh--bouring brothers of Gujarat as regards methods of cultivation and conservative in habits as they are, it will take some time before they will seriously take to improved methods of cultivation to which the Revenue Department is now devoting its attention.
- 88. Cattle breeding is an allied industry to agriculture and it also affords a great scope of improvement. According as the financial condition of the State improves, steps will be taken to develop this industry as well.
- 89. The industry which should first arrest attention of enterprising merchants is the establishment of oil presses in view of a large scale of growth of rapeseed and other oil seeds and also of an abundance of Mahura seeds.
- 90. Another industry that is almost dead and which is akin to agriculture is the weaving industry in the State. This

industry is in the hands of weavers principally Dheds who in competition of mill industry are struggling hard to keep up the industry. Introduction of improved fly shuttle hand looms and monetary help can save the industry from its present deplorable state.

- The noticeable feature of the year under report was to encourage the erection of one Ginning Factory at Jadar and one Ginning Factory and a Pucca Press at Himatnagar. An application to erect Ginning Factories and Pucca Press in the Idar State limits was received from one Mr. G. P. Vyas during the year of report which was followed by applications from Ahmedabad and Bombay whereupon all of them and also the owners of the Ginning Factories on the borders viz those of Vaktapur and Mahadevpura were called to discuss the terms of monopoly without which none came forward to erect the factory. After several meetings and full discussion the terms of the monopoly were settled and then the bid was taken by auction with a view to bring down as much as possible, the rates of ginning and pressing and thereby to afford advantage to the cultivators on the specific condition that no bidder for the factory would be at liberty to purchase cotton seeds and cotton in the State. Lowest bid was offered by Mr. Vyas rosulting in the benefit to the cultivators who had to pay much higher rates to outside factory owners and his application for monopoly was consequently sanctioned. A provision in the terms of the monopoly was made to the effect that 1/3 of the share capital can be subscribed by the Idar State subjects if they wished to do so and that the proprietor of the monopoly should publish a notice to that effect in the State Gazette. The work of erection of ginning factories and press was at once commenced by the monopolist during the year of report. The old ginning factory at Himatnagar was lying idle for sereval years past owing to keen competition and other causes and none had cared to start the industry in State limits.
- 92. The other industry in the State which needs mention here is stone quarrying industry. The stone of Himatnagar quarries is of very good quality but owing to the prevailing rates of royalty as it could not compete with Dhrangadhra stone in Ahmedabad and Bombay, the scale of rates of royalty had to be revised during the year of report as shown here below:—

The income from this source amounted to Rs. 28,602 during the year of report as against Rs. 34.178 last year. There is all round slackness in traffic and the demad for stone is also affected by the general slump as well as by cement competition.

Customs.

- 93. During the preceding year an experiment was tried to amalgamate the Customs with the Revenue Department with a view to economise expenditure after Nakadars or the collecting agency. As a result of the exiperiment it was found that the State had suffered a severe loss in income owing to the disappearance of an agency which was properly responsible for the collection. The Departments were therefore separated in the beginning of January 1927 with the result that within a few months of the separation there was an appreciable revival in the realisations.
- 94. The Taluka of Bayad, interspersed as it is with Agency and British areas, felt itself much handicapped in the development of trade and commerce by the existing system of collection of customs for import and export commodities. The cultivators and merchants of that Taluka made a personal demand to convert this levy into a fixed annual payment to be paid by cultivators on land, and by traders in a lump sum on an average of the preceding ten years' realisations, which request of theirs was granted to the satisfaction of all classes of people residing in that Taluka. But subsequently on the complaint of old cultivators that by the change the new cultivators were better off, the rate in the case of the former was lowered.
- 95. The principal articles of export in the year under review were Wheat, Maize, Til, Rapeseed, Castor-seeds, Methi, Tobacco, Gram, Mahura-seeds and flowers, Ghee, Gum, Cotton and cotton seeds while the principal imports were Jaggery, Sugar, Rice, Yarn, Cloth, Salt, spices, Coconuts Tin, Iron, Copper and brass vessels.
- 96. The fairs at Shamlaji and Khed Brahma which are held annually were held in the year under report as usual and both were well attended by pligrims and others. The former commenced on 15th November 1926 and lasted for 24 days while the latter opened from 16th February 1927 and continued till the 9th of the following month.

PUBLIC WORKS.

- 97. The Public Works Department needed a qualified hand and to secure a competent and energetic man to work as Chief Engineer, applications were invited. Out of the candidates who applied for the post, Mr. Rangildas H. Kothari, B. E., was selected as the best of the lot and appointed to the post. After his taking over charge on 1-4-1927, the Department was re-organised and the supervising staff adequately increased.
- 98. A provisional programme of Public Works is prepared wherein precedence has been given to useful new works. A scheme for the regular repairs to roads in the State has also been prepared and it is being carried out.
- 99. The total expenditure on Public Works during the year amounted to Rs. 89,548 as against Rs. 65,567 in the preceding year. The various details of the expenditure will be found in Appendix XIX.

Among the new works constructed in the year may be mentioned (1) Infantry Barracks with Kitchen and Dining Room, (2) Infantry Jamadars quarters, (3) A. V. School at Himatnagar, (4) Central Jail Block and Ward at Himatnagar, (5) Jail at Vadali, (6) Quarters for Civil Officers, (7) Chhapar for grass depot, (8) Customs Room at Vadali, aggregately costing Rs. 56,715. The repairs executed to the existing schools, Hospital and Dispensaries, Thana Buildings, Customs Nakas, Utaras and other State buildings including the Palaces cost Rs. 17,162 while the important road from Himatnagar to Idar which was first taken up for repairs during the year of report entailed an expenditure of Rs. 4,658.

Post Offices.

100. The number of letters and articles carried by the Durbar Postal Service during the year under report was 69,141 as against 53,031 in 1925-26 and the cost of the Postal Department amounted to Rs. 6,253 against Rs. 4,873 in the previous year, giving an average of 17.3 pies per postal article irrespective of its weight.

The number of Government Post Offices working in the State during the year was 16 as against 14 in the preceding year. Of these the two at Himatnagar and Idar are combined Post and Telegraph Offices while the rest are branch Post Offices only.

GENERAL CONDITION.

101. Owing to the favourable monsoon in the preceding year the economic condition of the people during the year under report showed signs of improvement. The cattle also fared well, there being plenty of fodder in the country.

CHAPTER V.

Revenue and Finance.

- 102. Mr. Sadashiv J. Dave who had served in the Account Department of the Ahmedabad Municipality was appointed as Treasury Officer in the beginning of January 1927.
- 103. A detailed statement of the total receipts and disbursements of the State for the year under report as compared with those for 1925-26 is given in Appendix XXII.
- 104. It may here be stated that there was an opening balance of Rs. 1,112 at the commencement of the year and when in December the Dewan took over charge, the cash balance in the Treasury amounted to Rs. 5,067 whereas the salaries of the staff were in arrears for the preceding six months which with the outstanding dues to be paid to creditors and others amounted to Rs. 4,95,446. In this tightened condition of the State's finances no improvement was possible unless a sum was available to pay off the salaries of the entire staff in the first instance and the previous debts. Accordingly a loan of rupees two lacs was requested from Govern. hnent which, through the active sympathy and support of the then Political Agent Major Meek, was promptly granted. The receipt of the loan, together with the recovery of revenues enabled a regular and systematic payment of salaries every month and it also enabled the State to clear away a large and substantial portion of its outstanding debts.
- 105. The year under report commenced with a balance of Rs. 1,112, The total gross receipts in the year from all heads of revenue amounted to Rs. 14,40,274 while the receipts on account of loan, deposits etc amounted to Rs. 4,90,386 which, with the opening balance of Rs. 1,112 made up a total of Rs. 19,31,772 on the credit side. The expenditure of the State in the year aggregated to Rs. 11,70,275 and the payments on loan, deposits and advance accounts to Rs. 5,67,196 making a total of Rs. 17,37,471 on the debit side and leaving the closing balance of the year at Rs. 1,94,301. Deducting the deposits etc of others included in this balance, the actual balance at the close of the year amounted to Rs. 1,07,984.

106. The revenue arrears at the close of the previous year amounted to Rs. 2,98,211 out of which Rs. 97,584 were realised and Rs. 12,063 were remitted in the year under report, leaving the balance of the past arrears at Rs. 1,88,564. Adding to this the arrears of the year under report amounting to Rs. 96,246, the total revenue arrears on 30-9-1927 aggregated to Rs. 2,84,810.

The other outstandings i. e. those due on account of advances and loans stood at the end of 1925-26 at Rs. 1,14,109. This was reduced by subsequent adjustments and cash receipts to Rs. 77,706. The fresh advances and loans given during the year under report amounted to Rs. 1,70,332 which brought up the total of these outstandings on 30-9-1927 to Rs. 2,48,038.

CHAPTER VI.

Medical relief and Vital Statistics.

(a) MEDICAL.

107. Dr. S. C. Sen L. M. & S., who was in charge of the Medical Department of the State having resigned his service in the State, Mr. Keshavlal V. Personnel.

Thakkar, L. M. & S., (Bombay) was appointed in his place as Chief Medical Officer of the State. He took over charge of the Department on 1-2-1927.

There are in all five medical institutions in the State viz the Civil Hospital and the Palace Dispensary Medical insti- at Himatnagar and the Dispensaries at Idar, tutions and Vadali and Bayad. All these institutions are their staff. The staff at Himatnagar consists of the Chief Medical Officer, one Sub Assistant Surgeon and six compounders, while each of the Dispensaries at Idar, Vadali and Bayad has one Sub Assistant Surgeon, and one compounder on its staff.

108. The total number of patients treated at all the institutions in the year under report was 15,560 out-Medical Relief. door patients and 45 indoor patients as against 12,018 outdoor and 58 indoor patients during the preceding year. The daily average of outdoor and indoor patients was 157.94 as compared with 149.23 in 1925-26. Of the total 15,560 patients treated in the year, 6,963 were treated at the Civil Hospital and Palace Dispensary at Himatnagar and 8,597 at the three Dispensaries in the districts. All the 45 indoor patients were treated at the Himatnagar Civil Hospital which has an accomposation for 6 in-patients. (Vide Appendix XXIII).

109. In the year under report there were 252 operations as Surgical against 290 of the preceding year. Of these Operations. operations two were major and 250 were minor as against 4 and 286 respectively in 1925-26.

- 110. The total number of postmortem examinations held in the year under report was 18 as against 5 Postmortem in the preceding year. Of these 18 examinations. Examinations. Twere done at the Himatnagar Civil Hospital, 5 at the Idar Dispensary, 3 at the Vadali and 3 at the Bayad Dispensary.
- 111. The principle prevailing diseases during the year were malaria, diseases of the respiratory system, diarrhoea and dysentery, skin affections and diseases.

 Prevailing diseases of the eye and the ear.
- 112. There were no cases of plague or cholera during the Epidemic year under report but there were 60 cases of diseases. small pox in the State of which 35 recovered and 25 proved fatal. No other infections disease was prevalent during the year.
- the year under report for sending indigent Hydrophobia persons bitten by rabid dogs for treatment to and Snake-bite. the anti-rabic centre at Ahmedabad but a limited advantage seems to have been taken of it and steps have been taken to give a wider publicity to the facilities provided by the Durbar in this behalf.

Lander Brunton's snake-bite lancets have been obtained and supplied to all the Dispensaries as well as to the Mamlatdars and school-masters in the State to afford relief in cases of snake bite. All the Dispensaries have moreover been supplied with a stock of Antivenene (snake-bite serum) ordered out from the Pasteur Institute at Kasauli.

114. The total expenditure of the Medical Department exclusive of vaccination charges, amounted in Cost. the year under report to Rs. 21,954-8-1 as against Rs. 21,206-8-3 in the previous year. The increase is due to the purchase of new Medical instruments and books and journals useful to the Medical Officers of the Department.

(b) Sanitation.

115. The towns of Himatnagar, Idar and Vadali and the villages of Badoli and Bhiloda have their own Municipalities and the sanitary arrangements in these places are supervised by their respective Municipal Officers. In villages of Bayad and Choila, the sanitation is looked after by the people themselves, who maintain an adequate number of sweepers to keep the villages clean.

In all other villages, the local police officers and Mukhi Patels have orders to get the house refuse and sweeping removed outside the villages and keep the villages clean.

The supply of drinking water during the year under report was ample at all the places. All the wells at Himatnagar, Idar, Vadali, Bayad and other principal villages were permanganated before and after the rains as a precautionary measure against cholera.

(c) VACCINATION.

Staff. The vaccination Department is under the supervision Staff. of the Chief Medical Officer and had on its staff one Inspector and 4 Vaccinators as in the preceding year.

Only the glycerine lymph made at the Vaccine Institute of Belgam is used for purposes of vaccination.

117. The number of persons primarily vaccinated in the Work done. year under report was 6,239 and of re-vaccinated 29 as against 5,925 and 3 respectively in the previous year, showing an increase of 364 in primary and of 26 in re-vaccinations.

Of the 6,239 primary vaccinations, 6,267 were successful and 22 unsuccessful while of the 29 re-vaccinations 27 were successful and the results in the remaining 2 were not verified.

118. The expenditure of the Vaccination Department during Cost. the year under report amounted to Rs. 2,464-9-9 against Rs. 2,115-10-0 in the previous year.

(d) VITAL STATISTICS.

119 The birth and death registration returns for the year under report as given in Appendix XXIV will show that there were 1201 births and 788 deaths registered in the year as against 1202 and 758 respectively in the preceding year.

The birth and death ratios per mille come to 5.3 and 3.4 as against 5.3 and 3.3 in 1925-26.

In view of the unwillingness of the wild Bhil population to supply information under this head due to prevalence of silly superstitions amongst them, the above figures cannot be regarded as quite accurate.

CHAPTER VII,

Education.

- 120. Mr. L. L. Mankad., B. A., worked as Educational Officer for a short period. As he was called by the Rajkot State, he having resigned the post, Mr. G. R. Palsule, B. A., B. Sc., L. T., was appointed as Educational Officer in May 1927 and the Department has remained under his charge since then.
- 121. The inspection of the State schools which, upto the end of the last year, was being done by the Deputy Educational Inspector, Mahi Kantha Agency, having been entrusted to the State in order to carry out the work of inspection satisfactorily, the Educational Officer has been given an assistant, who works as a travelling Educational Inspector. The Department has thus been trying to get more efficiency, diffusion and development of education in the Idar State by making regular inspections and giving proper directions.

122. Before increasing the number of State schools it was found necessary to equip the existing schools Schools. in a better way and so the number of State schools, in the year under report, remained practically the same, as in the previous year. The 52 schools maintained by the State can be classified as under:—

at present, education upto the sixth standard Idar English is being imparted in this institution. With a School. view to make it a complete High School, His Highness the Maharaja has been pleased to sanction a liberal sum for the purpose. For want of specious building and adequate number of boys in the higher classes, the idea of opening a High School had to be postponed last year. This year we have sufficient number of boys, who will be before long in the Matriculation class and also the extension at a cost of nearly

Rs. 20,000 of the building, will be completed by the end of May 1928. In June 1928 a complete High School with full equipment will be thrown open. The staff of the school is being replenished and competent graduates are being recruited to fill the vacancies. Two new graduates have already been appointed and qualified teachers will be added to the staff at an early date.

- 124. This school which was teaching only upto Std III has been sanctioned, under orders of His Highness Himatnagar to teach upto Std IV, by making adequate English School. improvements in the staff and other equipments. A new building worth Rs. 10,000 for this English School has also been built.
- 125. There are four girls' schools at Idar, Vadali, Choila and Bayad, and all of them did good work. Girls' Schools. The total number of girls studying in these 4 schools was 287 against 174 of the last year. Opening of two more girls' schools at Himatnagar and Tintoi has been sanctioned.

The total number of students studying at present in 126. various institutions in this State is 3612 against 3/420 3408 of the last year and 3137 of the year Attendance. before last, vide Appendix XXV. Out of 3612 students 3325 were boys and 287 were girls. The gradual increase in the number of students clearly shows that the people have begun to realize their responsibility of educating their children.

Their average daily attendance remained at 2833 as against 2614 of the last year. The percentage of the school going children as compared with the total population was 10 87. This percentage is rather low, but in course of time there is every reason to hope that it will be on the upward grade.

127. The total expenses of the Department, during the year under report, came to Rs. 32,330-10-7 against Cost. Rs. 30,860 last year.

Over and above these expenses the State has spent Rupees 13,000 over the construction of new school buildings and repairs to existing school buildings.

With the existing financial position of the State, it was not possible at once to go in for many more schools, but on a general review of the situation, when it was found that the quality of education imparted was not such as it should be, both because the schools were undermanned and the staff lowly paid, it was thought necessary more to concentrate on quality than on quantity by engaging more hands and improving the salaries of the staff.

It was also found necessary to equip the schools with necessary materials and also to improve such of them as were badly out of repair.

During the year under report furniture (including maps and books) worth Rs. 1,210 was purchased for the use of the schools and the same was supplied to schools that stood in good need of it.

In order to encourage education among his subjects His Highness has been kind enough to provide for free education both in Vernacular and English schools.

- 128. With a view to maintain discipline and enforce regular attendance an imposition of nominal fines for irregular attendance and re-admission has been improvised. The fines and fees thus realized are spent solely for the purpose of games and amusements of the school boys.
- 129. For want of a High School in the State in order to help deserving students desiring to go for School Scholarships. Leaving Examination, and for higer education both in English and Vernacular, scholarships worth Rs. 2,100 were sanctioned for the year. Out of the students that passed English VI Standard, four students desired to go for further studies and three of them were given a monthly scholarship of Rs. 15/- each. A scholarship of Rs. 25/- per month was given to a student attending the Gujarat College at Ahmedabad. A teacher who was serving in this Department was given a monthly scholarship of Rs. 15/- and sent to Premchand Raichond Training College, Ahmedabad. One female candidate was given a monthly scholarship of Rs. 15/- but unfortunately she could not get admission in the Mahalaxmi Training College and so she had to postpone her intention of going to the Training College.
- 130. Besides making education completely free, liberal help was given in the year under report to deserving poor students studying in the English School at Idar, for defraying their expenses at the Kesari Boarding House at Idar. The Kesari Boarding House has been managed by the Idar Prajakiya Vidyotejak Fund Committee and it received an annual grant of Rs. 420/- from the State. His Highness has been pleased to increase this grant from Rs. 420/- to Rs. 720/- since September 1927.
- 131. The boys in the Primary Schools also are made to take regular exercise and they generally play Physical Indian out-door games. Sanction has been Education. given to supply all the schools freshly with materials necessary for daily exercise.

132. The Department has paid no less attention to the scout movement which is now unanimously Boy Scouts. acknowledged to be very serviceable in all stages of life. During the year under report boys in English schools were trained in scouting and a teacher from the English School was specially given a scholarship for receiving training at the Scout Master's Class. Very soon we hope to have a scout-troop and every care is being taken to see that our troops will be a model Scout troop, that will be of great use on all occasions, whenever its services will be required and later on it is contemplated to have a similar troop of Girl Guides.

- of the State has been a steady effort made in various directions to improve the quality of education imparted in the various State schools. By way of encouragement teachers, whose work is found to be satisfactory, have been awarded prizes by the Department. It is hoped that such prizes will inspire other teachers to work more strenuously and to compete for the prize.
- 135. The Examination results and the visitors' remarks go to show clearly that the work done in the vernacular and English schools during the year under report was quite satisfactory. It may be mentiomed here with a sort of pride that during the last Vernacular Final Examination, out of 13 students sent from the various State schools, 10 students have come out successful, one of them standing first amongst all the successful candidates in the whole of the Northern Division.
- 136. The Annual Examination of the State schools were conducted by the Educational Officer assisted by the Educational Inspector and by the Head Master, Gabat A. V. School. The results of the examinations were on the whole satisfactory.

During the course of the year under report, several respectable gentlemen paid visits to different State schools and sweets and prizes worth Rs. 125 were distributed by them.

137. In September 1927, a prize distribution ceremony of the Prize State Schools was held at Idar under the presi-Distribution. dentship of the Political Agent, Mahi Kantha, Major A. S. Meek, c. M. G., who after giving away the prizes to the students, delivered a very interesting address as under:-

"I have listened with interest to the speech of the Educational Officer and it is with much pleasure I say a few words in reply.

First of all I would say how greatly I regret that His High. ness has been prevented by a slight attack of influenza from being present today, indisposition from which I hope, as we all hope, that he will speedily recover. I am particularly sorry that His Highness is not here with us for I felt very strongly a wish to show him here in public this afternoon my very keen sympathy with the work of progressive administration which he has initiated and is carrying on. His Highness has been subjected to malign and ungenerous attack, in certain quarters. That is a matter with which His Highness will deal in his own good time and I have no wish to examine it here; but I do wish today to show in public that as Political Agent I feel strongly for the Maharaja Saheb in this matter and that I stand with him. Whatever it be that we see published in certain newspapers we here all know that His Highness is carrying on an ordered and right administration which has the confidence of Government and of responsibly minded people who know anything of the facts. The State has as its Dewan an Officer with a fine record of achievement in State business and he is served by a band of qualified assistants. I was greatly impressed yesterday by the fine appearance and performance of the new company of State Infantry, young and full of promise for the future; and as is this unit of the Imperial State Forces so is the picture I have in mind of the Idar Stateembarked on a career of promise and of high usefulness.

To revert now to things scholastic which have been the theme of the Educational Officer's report I note with great pleasure the decision of the Durbar that a High School will be established. The State is a State of the country and of villages and possesses no large towns such as make particular demand for higher education. Nevertheless it is right that the Durbar should give facility for such higher education to those requiring it and its decision in this matter will be widely welcomed. I claim credit for the fact that the State has now its own complete control of its educational affairs in which formerly the Agency had concern, and I hope that under the new arrangements there will be a steady advance made. Much however cannot be immediately achieved, for educational facilities can only be extended as the financial position of the State permits; and the Jagirdars and the people must recognise this fact and learn to associate themselves with the Darbar in educational progress.

I am glad to see reference made to the Bhils who form an important element in the population of the hilly tracts. The

Bhils are still very backward but in Idar and neighbouring states there is strong evidence of advancement among them and I have found in my own special enquiries a steady progress in civilization among this primitive and attractive people who are gradually becoming more efficient husbandmen and taking to more settled life. I must express a hope that education to be imparted to them may not eradicate in them the good qualities which they possess. Here I would refer to the good work done by the Christian Missionaries in Idar Bhil country and to the broad minded attitude which has always marked the conduct of the Durbar in its relationship with this side of educational activity.

The attention being given to the training of boy scouts and to physical drill and games is all to the good and I hope that these features will in future be strongly prominent in the educational scheme. I would suggest to Maharaja Kumar Himat Singh who has shown such keen interest in the State Infantry that these are subjects in which he is specially competent to take a controlling hand. I would ask the Durbar to keep a close watch on progress being made elsewhere in finding a right form of instruction for the purely rural schools.

I conclude by assuring the Durbar of the interest and sympathy of the Agency in its educational work and I ask you to give three hearty cheers for His Highness in recognition of his announcement of the establishment of a High School."

138. Besides the State schools there were in the year under report 8 Sanskrit Pathshalas, 1 Anglo Private Vernacular School, 2 Madresas, and 5 Mission Institutions. Schools. All these institutions were conducted by means of private funds and had 720 pupils on their rolls during the year.

139. The number of Kumars from subordinate Jaghirs of Education of the State attending the Scott College at Sadra Kumars of during the year of report was 9 as against 1 in the preceding year.

The number of Kumars taking education in the various State schools in the year was 52.

CHAPTER VIII.

Miscellaneous.

LIBRARIES.

140. There are two libraries in the State, one being the

Wodehouse Library at Idar, which is free to the public and the other being the Durbar Library in the Palace at Himatnagar, which contains a large number of useful books on literature, science, history, philosophy and arts in English, Gujarati, Sanskrit and Hindi.

PRINTING PRESS.

- 141. There was only one private printing press working at Himatnagar in the year under report, owned by Mr. Gunvantrai Maneklal Vyas. It did the printing work of the State Gazette, State forms and circulars and other State work mostly in English and Gujarati as also other job work.
- 142. Our sincere thanks are due to Major A. S. Meek, Political Agent, Mahi Kantha, for the interest he took in the year under report in matters concerning the well-being of the State and also to our Departmental heads and staff for their cordial co-operation.
