RETURN to an Order of the Honourable The House of Commons,
dated 1 February 1854;—for,

A STATEMENT showing the Quantity of LAND under CULTIVATION in each of the Districts of the Madras Presidency, distinguishing the Quantity in Acres or Cawnies, of Land IRRIGATED, with the Amount in Rupees of the Government ASSESSMENT rated thereon, and the Quantity of Land in Acres or Cawnies, under DAY CULTIVATION, with the Amount of Government ASSESSMENT rated thereon; the Total LAND REVENUE in each District, Gross and Net; and the TOTAL AREA of each District in Acres or Cawnies, which are Barren, not Cultivated, or Alienated in Enam; also, an AVERAGE of the TOTAL AREA, in Acres or Cawnies, in the several Districts of the Madras Presidency, comprising Cultivated and Uncultivated Lands?"

"And, COPIES of all APPLICATIONS from the Government of Madras to the Government of India, and to the Honourable Court of Directors, during the Seven Years from 1847 to 1853, both inclusive, for Sanction for Expenditure for PUBLIC WORKS connected with the Improvement of the Country, or connected with the Revenue, Works, or Works of Irrigation, or for Works on which the Cultivation of the Country depends; together with Copies of the REPLIES and LETTERS from the Honourable Court of Directors and Government of India to the Government of Madras to such Applications, during the Seven Years from 1847 to 1853, both inclusive."
