Numerous additions and amendments have also been made to many of the Rules by Notifications published in the Gazettes from time to time. The Rules contained in this compilation have been carefully revised and corrected as near as can be up to date.

To facilitate reference, the compilation is divided into Parts, and a General Index of the whole has been added. In some of the Parts, a few important Resolutions of Government and Rulings of the High Court have been introduced, which are in themselves entitled to be observed as Rules.

The Rules are printed half-marginally to enable Revenue Officers to make all necessary alterations and amendments as may from time to time prove necessary.

The Rules made under Acts are, for greater distinctness, printed in larger type than Rules not made under any Act, as also Resolutions, Rulings, Notifications, Appendices, &c.

3. In addition to the fixed assessment, a cess not exceeding such rate as may be allowed by law will be levied under the Bombay Local Funds Act, 1869, or other law for the time being in force, for the purpose of providing funds for expenditure on objects of local public utility and improvement.

4. The Government rights to trees standing in lands which are now occupied, is hereby conceded to the occupants thereof, subject to the general exceptions entered in the margin and the special exceptions recorded in the settlement records.

The following Resolution by the Government of India is published in supersession of the Rules notified in the Bombay Government Gazette, dated 21st September 1871, page 1014:--

" No. 112.

Extract from the Proceedings of the Government of India in the Department of Agriculture, Revenue and Commerce, dated Fort William, the 6th February 1872.

[LAND REVENUE AND SETTLEMENTS.]

READ again-

Financial Department Resolution No. 557, dated 25th January 1870. Home Department Circular Resolution No. 229-39, dated 27th April 1870. Financial Department Resolution No. 1452, dated 23rd June 1870. Home Department Circular No. 427-36, dated 4th July 1870.

- RESOLUTION.

In the Resolutions quoted above it was ruled that the sanction of the Government of India should be obtained to the alienation of all Government land, whether actually paying; revenue or not, except grants of waste land made under the approved rules, and that Government land, whether paying revenue or not, should not be parted with save under the rules applicable to the expenditure of public money. It was also laid down that if the sale of small plots of escheated land for the benefit of local funds has not been duly sanctioned, it must be considered subject to the above restrictions.

- 2. Several local Governments and Administrations having represented the inconveniences arising from a strict adherence to these orders, the Governor General in Council, has been pleased to modify them as follows:-
 - 3. Lands to be disposed of will necessarily divide themselves into two classes First—Those which are the property of the State; Second—Those which, under competent authority, have been constituted the property of a municipality or other local body.
 - 4. Lands of the first class may be disposed of in various ways—

First—By sale at full market value;

Second—By sale on favourable terms—

to a public body or association, or to an individual, for a public purpose;

Third—By gift or grant to—

- (a) a public body or association, or to an individual, for a public purpose;
 (b) private individuals in remuneration for public services to be performed;
 (c) private individuals for their private benefit, without reference to future
- 5. As regards lands falling into the second of the above classes, which have been, under a competent authority, constituted the property of a local body, the Government of India will exercise no interference. It will be the duty of local Governments and Administrations to satisfy themselves that the lands in question have been transferred under proper authority, and this having been ascertained, the sanction of the local Government or Administration will be sufficient for the disposal of the lands.
- 6. As regards lands, the property of the State, such of them as are governed by the rules for the grant of waste lands, will continue to be dealt with under the rules on this subject in force for the time being.
- 7. As regards lands, the property of the State, other than waste lands, which are sold for full value, no reference to the Government of India need be made where the full value does not exceed Rs. 10,000. Up to this amount the sanction of the local Government, or Administration will in all cases be sufficient. The amount realized by the sale of the land should invariably be credited to the general revenues, and the sale should be duly noticed in the proceedings of the local Government or Administration.
- As regards the sale of lands on favourable terms, for a public purpose, in no caso should the recipient pay less than half the full market value of the lands granted; and whenever such full value exceeds the sum of Rs.1,000, the sanction of the Government of India should be previously obtained. The amount realized by the sale should in all cases be credited to the general revenues, and the sale should be noticed in the proceedings of the local Government or Administration.
- 9. As regards the gift or grant of lands, the previous sanction of the Government of India should be obtained in cases where the value of the grant exceeds Rs. 3,000, when

given as a site for the construction of Government schools, hospitals, dispensaries, or other

public works, at the cost of recognized local funds; where it exceeds Rs. 500, when given for any other public purpose, or to a private individual for services to be performed to the

State, or where it exceeds Rs. 100 when the services are to be performed to the community and in all cases of grants to individuals for their private benefit irrespective of any services to be performed.

In continuation of my circular Nos. 40 to 49, dated the 14th August 1871, making From the Government of Madras, No. 847, dated the certain enquiries in regard to the mineral rights of Government, I am desired to forward, for the information of His Excellency the Governor in Council, a copy of the Proceedings of this Department for August 1872, Nos. 26 to 37, and of the marginally noted correspondence with the Government of Madras and the Solicitor to Government.

2. I am to explain that, on consideration of the papers which are recorded in the Proceedings for August 1872, it appeared that no immediate action was necessary, unless Government had been prepared to resort to legislation—a course the desirability of which did not seem to be sufficiently established at that time. No general legislative, measure is now in contemplation, nor is it intended to institute in the Bombay Presidency any special enquiry as to the State's rights to minerals, unless, at any time, circumstances should arise which should render such an enquiry indispensable in the interests of those exclusive preeminent powers which belong to the State as representing the community at large. Such powers it is all the more necessary carefully to guard when there is reason to believe that they may be valuable. It is therefore thought expedient now to direct attention to the matter, and to request, first, that, subject to any instructions which may be received from the Secretary of State in connection with the reference that has been made to him by the Government of Madras in all future grants and leases of Government waste land for cultivation in the Bombay Presidency, full rights may be reserved to Government in respect of all minerals which may be discovered in or under such land; and, secondly that, in all cases in which minerals may be discovered in any place where there is ground for the belief the Government may be entitled to them, or may have a right to assess them to land revenue, a full enquiry may be made and the result reported. Rights of way and other reasonable facilities for working, getting and carrying away such minerals as may be found should also be reserved on behalf of Government or the assignees of Government in deeds of sale and leases of waste lands,

Whenever it is found possible to do so, the right of Government to the minerals should be asserted and reserved in all future settlements; and if in any case this is not possible, then, in such settlements, the reservation should take the form of a right to put a separate assessment on mineral produce. This last direction, however, is of course subject to any special peculiarities which may exist in the local revenue system.

4. It will be understood that, except in so far as the precautions above directed require, it is not intended in any way to anticipate future events. Should any case similar to that of the gold discoveries in the Wynaad arise elsewhere, it can be dealt with, as it occurs, on the analogy of the instructions which Her Majesty's Secretary of State may be pleased to give on the despatch of the 1st current.

RESOLUTION.—The instructions of the Government of India should be communicated to the Commissioners of Divisions and the Commissioner of Survey for information and

guidance.

GOVERNMENT OF INDIA.

HOME, REVENUE AND AGRICULTURAL DEPARTMENT, State rights in Minerals and Mining Leases.

From the Government of India to the Secretary of State for India,—No. 7, dated Simla, the 1st September 1879.

We have now the honour to reply to your Lordship's despatches marginally noted, concerning the rights of the State in minerals, and the terms No. 40, dated 10th May 1877. that should be imposed on gold mining leases on Government No.69, dated 10th October 1878. lands in the Wynaed districts of Madras. There has been delay in coming to a decision on these points, because we were obliged to take legal advice on some of the questions raised, and because we desired to ascertain the policy recently adopted in Australia regarding mining leases in the gold-fields of that continent.

- 2. Regarding the State rights in minerals, three distinct questions had first to be considered, namely:—
 - (1) whether the royal prerogative, as it obtains in England in respect to gold and silver mines, prevails in British India; and whether grantees of waste land are entitled to mines of gold and silver found thereunder, when the deed of grant is silent as to such mines;
 - (2) whether, apart from such prerogative, the Crown in India can assert a right to gold, silver, or other minerals on any other ground;
 - (3) whether, if both these questions are answered in the negative, the mineral resources of the land can be taken into account in assessing land-revenue.
- 3. The Madras Government, in their letter No. 320, dated 23rd January 1877, concurred with their Advocate General, and expressed an opinion that the royal prerogative regarding gold and silver mines did not prevail in India. They held that it would be impolitic, even if it were legally possible, to assert any Government right in the mineral resources of lands sold under the Waste-Land Sale Rules, or in lands held by certain ancient proprietors of the Malabar district. The Governor of Madras in Council advised also that the claims of ryots to the mineral wealth of their holdings should not be disturbed; and on this point His Grace in Council differed from the view expressed by the Madras Board of Revenue. The Madras Government pointed out that, if large numbers of gold-workers were to come to the mines, police and other expenses would be thrown on the Government, to meet which a reasonable royalty might properly be imposed. The Governor of Madras in Council also recommended that, until the policy of Government with reference to mineral rights in the soil was settled, all sales of Government land under the Waste-Land Sale Rules should be made subject to the reservation of the State rights in minerals found underneath those lands.
- We referred the three questions stated in the second paragraph of this letter for the opinion of our Advocate General, of our standing Counsel, and of one of the first layers in Calcutta. We submit copies of the opinions of these gentlemen for your Lordsbip's information. It will be seen that they all three agree that the prerogative of the Crown regarding gold and silver mines does not exist in India outside the presidency towns, and that grantees of waste land are entitled to mines of gold or silver found thereunder when the terms of the grant are silent as to such mines. While there is no doubt that all the prerogatives essential to the maintenance of the executive power, such as the right of making war, peace and treaties, are in force throughout British India, yet, as the right to mines of gold and silver is merely a fiscal prerogative, and is not essential to the maintenance of the executive power, it stands precisely on the same footing as the prerogative rights to whales and sturgeon wrecks, treasure-trove, waifs and estrays—cases in which no one we wait maintain that the Crown has any right in India apart from express legislation. Such pre-rogatives, in fact, belong to that part of the English Common Law which has arisen from, and is adapted to, merely local requirements, and is not therefore in force in this country. Moreover, since the Indian Legislature, in the Punjab Land-Revenue Act (XXXIII. of 1871) section 29, thought it necessary to declare that in the Punjab mines of metal shall be deemed to be the property of Government, and since, by the Ajmere Land-Revenue Regulation (II, of 1877), section 3, the Government is, with certain exceptions, presumed to be the sole owner of all mines until the contrary is proved, it would be inconsistent to contend that the prerogative right to gold and silver mines exists in India, as, if it did, there would have been no need for these express statutory provisions, or at least these particular metals would have been excluded in framing them. On these grounds, we consider that the opinion of the law officers may be finally accepted, and that whatever be the rights of the Government of India in the matter, no claim on the part of the State can be preferred on the ground of the prevalence in India of this royal prerogative outside the limits of the presidency towns. As to the right of grantees, the decisions in England are to the effect that mines of gold and silver will not pass by a grant from the Crown without express words granting them. We are, however, advised that the principle of such decisions is wholly inapplicable to India. When this principle was established in England, grants from the Crown of its land had the effect of impoverishing the Crown, being made from favour and without consideration moving from the grantee. But in India such grants have, it is believed, usually been made in consideration of a money payment, and have therefore had the effect of enriching the Crown. We are aware that this argument was used unsuccessfully before the Judicial Jommittee of the Privy Council in the case of Woolley vs. The Attorney Jeneral of Victoria, Law Reports, 2 App., Ca. 163, 165. But the reason why it failed was that the Common Law of England (including all the prerogatives and the consequences thereof) had been introduced into the Colony of Victoria, from which that appeal was presented. No such introduction, it is conceived, can be held to have taken place in this ceded and conquered country. The reason why in England grants from the Crown are

construed stricktly against the grantee is generally said to be that preregatives are conferred on the Crown for public use, and are therefore not to be understood as diminished by any grant beyond what it takes away by necessary and unavoidable construction. But where no such preregative exists, of course that reason ceases. We therefore consider that grantees of waste lands (whether or not the grants expressly comprise "all products both above and below the surface") are, in the absence of any provision to the contrary, entitled to mines of gold and silver found thereunder.

- In regard to the second question, whether the State possesses other general or special rights in minerals lying under lands which are private property, our Advocate General differs from the other two learned gentlemen who were consulted. Their opinions referred mainly to Bengal and the permanently-settled districts with the circumstances of which they were conversant. Mr. Paul considers that the State has rights in the minerals found in permanently-settled estates; while Messrs. Bell and Evans think that the State does not possess such rights. We consider that the latter is the opinion most likely to be taken by the Courts. And we are confirmed in this view by the practice of the past twenty years, whereby the Government or any private parties who desired to work coal or iron within the limits of a permanently-settled estate have been obliged to buy, or at any rate have bought, the right of so doing from the Zamindár of the lands underneath which such coal or iron might exist. Regarding the circumstances of other provinces, and the way in which State rights in minerals had been asserted or waived, enquiry was made from Local Governments in the year 1871. The replies to that enquiry are recorded in the Proceedings of the Revenue, Agriculture and Commerce Department for August 1872, Nos. 26 to 37, copies of which are now submitted for your Lordship's perusal. It appears from these papers that in most parts of the country no established law or practice was known upon the subject; and that, as no mines had been opened, no occasion had arisen to determine the rights of the State in respect to such property. In the North-Western Provinces, however, it had been ruled that, where the surface land had been declared private property, the ownership extended, in default of some distinct and special reservation, to what was below the surface. In newer provinces, on the other hand, such as the Punjab, there was no settled judicial precedent making mines and metal private property. And accordingly opportunity was taken to declare by legislation (section 2 of Act XXXIII. of 1871) that mines of metal in the Punjab and also in Ajmere (section 3 of Regulation II. of 1877) should be deemed to be the property of Government. Similarly, in the Central Provinces, at the time when proprietary right in their lands was conferred upon the landholders, the full right of Government to minerals was reserved under the provisions of the Settlement Code. So also in Berar, a notification issued by the Resident in 1868 concerning the settlement then in progress declared that "the prior right to all valuable things below the surface belonged to the State."
- 6. On the third point, namely, whether minerals belonging to private proprietors can be taken into account in assessing the estates of those proprietors to land-revenue, the Advocate General and the other learned gentlemen consulted are, in the main, agreed that when temporarily-settled estates, come under resettlement, the minerals, just like the other resources of such estates, constitute assets on which land-revenue may fairly be assessed. This practice has been already partially followed in provinces where miscellaneous items are reckoned into the village assets for the purposes of the assessment of land-revenue.

We have already noticed (paragraph 3 of this despatch) the views of the Madras Government and of the Madras Board of Revenue regarding the rights of ryots to all mines and minerals in their holdings. Seeing that different classes of tenure may be grouped under the generic term of 'ryotwári tenure,' we hesitate finally to accept, without further enquiry, the view that all holders of ryotwári lands are entitled to all mines and minerals under the holdings. Probably the jennies of Malabar, whose tenure is ancient, may be so entitled. But we shall ask the Madras Government to consider further the question of the rights of ordinary ryots in the minerals under their holdings.

- 7. Such being the opinions of the Law officers, and such being the reports or recommendations of the several Local Governments, we would advise your Lordship to answer the three questions summarised above (paragraph 2) thus:—
 - (1) The Crown has in British India no special prerogative over gold and silver mines outside the presidency towns; and grantees of waste land are entitled to mines of gold or silver found thereunder when the deed of grant is silent as to such mines.
 - (2) No general rule, applicable to all provinces, can properly be laid down, either that minerals and metals found in proprietary lands belong to Government, or that they do not so belong. Even in different parts of the same province, the law and the fact on this matter may be different. When the question arises in each province, it will have to be answered for that province only, in accordance with the practice of the Government and with judicial (or other) precedent. But in any province where proprietary rights have been a recent creation of the British Government, where their precise nature and extent are still unsettled, and where custom or practice about mines has not had time to grow up, advantage should be taken of favourable opportunity to declare by legislation that mines of metals in such provinces are State property.

(3) Mineral resources of temporarily-settled lands, where the proprietors are held to be the owners of such resources, may be taken into account at any resettlement as assets on which the public demand for land-revenue may be assessed.

Further, we should have no hesitation in proposing legislation, if necessary, to provide for raising from mining communities the expenses of special police, special communications, regulating the water-supply, or other special administrative arrangements which might be necessary for the protection or welfare of such communities. Such legislation would be in accordance with the principle adopted in section 14 of Act V. of 1861, where provision is made for enlisting special police for the protection of, and at the cost of, any manufactory or public work.

- 8. We have considered the proposal of the Madras Government that in future sales of waste lands the State should reserve full rights and property in all metals and minerals which may be found in such lands, and also all reasonable conveniences for working such minerals or metals, either by itself, or through other parties. We agree that it is expedient henceforward to sell or grant on lease waste lands subject to these reservations. We solicit your Lordship's sanction to our modifying the Waste-Land Sale Rules accordingly; and we enclose copy of a circular order we have issued, directing that, until your Lordship's orders are received, sales or leases of waste lands shall be made subject to such reservation of full State rights in mines and minerals, together with all convenient powers for getting the same.
- 9. Lastly, there remains the practical question, which requires early decision, namely, on what terms shall mining leases on Government waste lands in the Wynaad, Coorg, or adjacent auriferous tracts be given. We recognise the fact that it is of great importance to India that these gold sources should be worked to the best advantage; we admit that, if gold should be produced in large quantities, the effect of such production on the exchanges between England and India would be of great value; and we think that the terms as to royalty, area of mining leases, and the mode of working should be as liberal as may be possible without encouraging undue speculation. We learn from Mr. Brough Smyth that the most approved system of mining leases in Australia now is to let the land at a moderate rent (ten shillings) per acre, the lessee being bound to employ per acre, or per running yard of reef, a certain minimum quantity of labour on bond fide mining operations of an approved kind. If the lessee fails to fulful this condition, he forfeits his lease; and the terms of the mining lease make the Governor of the Colony the final arbiter, on such evidence as may be laid before him, whether a particular lessee has, or has not, failed to fulful the condition. In the early days of gold-mining industry in Australia, heavy fees (£3 and £2 per month) were charged for mining licenses. Subsequently an export duty was levied on gold taken from the colony; but latterly the Colonial Government of Victoria has found that the largest indirect advantages to the Colony are secured by making the mining leases simple and liberal, subject to the one condition that a certain quantity of labour is employed on bond fide mining operations for each acre leased.
- 10. Plans for levying a royalty on the ton of quartz raised, or for establishing a local office of assay and levying a royalty on the gold, have been proposed. But we consider that, for the present, while the industry is undeveloped, our object should be to make the terms of mining leases of Government lands as simple and liberal as possible. In order to prevent large areas falling into the hands of speculators, it has been suggested that a certain limit of available capital, or a certain quantity of (stamping or other) machinery, should be required per acre of land leased. But we are advised that these conditions have been tried, and have been found inoperative and unsatisfactory in Australia, and that the simple condition that a certain quantity of labour shall be employed per acre in band fide mining has been found to work best. For the present, therefore, we would propose to authorise the Government of Madras to grant gold-mining leases of Government lands, in lots of from one to thirty acres, for a term of ten to twenty years, and at a rent of five rupees an acre, subject to the condition that not less than five labourers are regularly employed per acre on bond fide mining operations in such manner as the Government may approve. The leases should be liable to forfeiture on failure of this condition, or failure to pay rent, as soon as either failure had continued for a period of six months; and should be renewable, at the lessee's option, on such terms as the then Government may settle, at the expiration of the original term. The Governor of Madras in Council would be declared to be in each case the final arbiter, whether the lessee had, or had not, fulfilled the conditions of his lease.

We would propose thus to leave wide discretion to the Local Government with reference to the term of each lease and the area comprised therein. We do not propose to levy any royalty or other tax, for the present, on the industry, because we deem it most important to attract capital to the Wynaad gold-fields. The cost of bringing machinery for quartz-crushing to the spot will be heavy; the pioneers of the undertaking will have to buy their experience in many directions; and it is very undesirable that the first ventures now to be made should be unsuccessful.

11. If your Lordship approves the foregoing sketch of the terms on which gold-mining leases of Government lands might be granted, we shall authorise the Government of Madras to act thereupon, and we shall cause draft leases to be drawn up by our legal advisers.

- 12. There is apparently ground for believing that some of the best gold reefs that are known in India lie in the estates of the Rája of Nellambor and of other private proprietors. The Alpha Gold Company's works were opened in the Nellambor lands. As yet the Rája has made his own terms with companies intending to carry on gold-mining; and at present we are not prepared to urge the Madras Government to undertake legislation with a view of compelling private landowners to give gold-mining leases on any particular terms, or against their will.
- 13. We shall be glad to be favoured with early instructions from your Lordship, not only on the subject of the terms on which mining leases should be granted in the Wynaad, but also on the three questions raised in paragraph 2 and answered in paragraph 7 of the present despatch. And we solicit your Lordship's confirmation of our orders directing that, in all future sales or agricultural leases of waste lands in any part of India, mines and minerals found on such lands shall be reserved to the State, together with all convenient powers for working and getting and carrying them away.

From the Secretary of State for India to the Government of India,—No. 35 (Revenue—Minerals) dated India Office, London, the 25th March 1880.

I have considered in Council your letter, with accompaniments,* dealing with the important questions of the general rights of the State to minerals Agricultural Department) of 1st in India, of modifications of the Wast-Land Rules necessary to secure these rights, and of the terms on which applications to mine in Government waste lands in auriferous tracts shall be complied with.

- 2. You point out that, regarding general State rights in minerals, three distinct questions have to be considered. In the first place, you hold, and I concur in your view, that the royal prerogative, as it obtains in England in respect to gold and silver mines, does not prevail in British India, at least outside the presidency towns. You proceed to infer that grantees of waste lands, whether or not the grants expressly comprise all products above and below the surface, are, in the absence of provision to the contrary, entitled to mines of gold and silver found thereunder. If this proposition be limited to grantees of waste lands "in fee simple" under the rules framed in different provinces in accordance with the instructions given by my predecessor, Sir C. Wood, in his despatch No. 14 of 1862, I do not dispute it. But I must point out that the expression "grantees of waste land," used without limitation, might be held to include persons who have received, under ordinary terms of settlement, the proprietary rights in lands formerly waste and unoccupied; and to such grantees this view does not apply.
- 3. As regards the second question, whether, apart from the prerogative, the Crown in India can assert a right to gold, silver, and other minerals found in proprietary lands, you are disposed to agree with Messrs. Bell and Evans that, in the permanently-settled districts, the State does not possess such right. This was the view arrived at by my predecessor, Sir C. Wood, after consideration of Mr. Millet's reports, dated 26th March 1842. But, without weighing this opinion against that of your learned Advocate General, I am disposed to think that, even if the legal right to minerals in permanently-settled estates could be established, it would not be desirable to enforce it. I agree with you that the indirect advantages resulting from making available the mineral resources of India are likely to be more valuable to the State than any direct returns; and I therefore consider that it would not be desirable to enforce the right of the State, supposing that such right can be established to mines in permanently-settled estates. Industries requiring skilled and scientific management and the extensive application of capital have flourished under the permanent settlement: and I apprehend that, speaking generally, the landholders of the Lower Provinces are sufficiently alive to their own interests either themselves to develop the mineral resources their estates may contain, or to afford facilities to others to do so.
- 4. This, however, does not apply to many other parts of India. I look upon it as pretty certain that the mineral resources of their lands will not be effectually worked by the present proprietors themselves of Madras or Bombay, or by the village communities of Northern India: and I apprehend that other promoters of mining enterprise would be likely to meet with considerable obstacles from intricacies of tenure and the difficulty of dealing with numerous small landholders. I consider, therefore, that care should be taken to reserve all State's rights to minerals which still exist. And I am of opinion, especially with reference to the views of the Madras Government mentioned in paragraphs 3 and 6 of your letter, that, in the absence of any distinct judicial precedent or of established law or practice, such rights should be presumed still to exist throughout India. I take it that the notion that payment of an assessment based on the agricultural value of land, and intended to cover the right of cultivation, conveys property in minerals below the surface of the soil is essentially a modern one, and would never have occurred to the Native Governments to which our own succeeded. I approve therefore of the instructions you proposed (paragraph 6 of your letter) to give to the Government of Madras on this subject. With regard to the other provinces, you state that no general rule, universally applicable, can be laid down, either that minerals

found in proprietary lands belong to the State, or that they do not so belong. But, speaking generally, in the North-West Provinces it was ruled, but not, as it appears, by judicial authority, that when the surface is private property, the ownership extends, in default of special reservations, to what is below the surface. The precise degree of authority possessed by this ruling should, however, receive further consideration. In the Central Provinces and Berar the full right of Government to minerals has been reserved at settlement, while in the

Punjab and Ajmere, and, it may be added, in the Bombay Presidency,* it has been declared by legislation that mines are the property of Government. You conclude therefore that whenever the question as to the right of the State to minerals found in proprietary lands actually arises, it will have to be answered for that locality in accordance with practice and precedent. But that where the nature and extent of proprietary rights are still unsettled, and where custom and practice regarding mines has been established, opportunity should be taken to declare by legislation that mines are State property. With these views I fully concur.

- 5. With regard to the third question, you consider that where proprietors of lands temporarily settled are held to be the owners of the minerals they may contain, such mineral resources may be taken into account for assessment on resettlement. In this view I concur; but request that care may be taken not to confer proprietary rights in minerals by including them among assessable assets where such ownership has not been proved previously to exist.
- 6. Upon the second point discussed in your letter,—the modification of the Waste-Land Rules suggested by the Government of Madras,—I agree with you that, in future, sales and leases of waste lands for agricultural purposes should be generally made subject to reservation of the full right of the State in mines and minerals, and of right of access and other reasonable conveniences for working them on behalf of Government, or the assignees of Government. I approve the circular you have issued on this subject, and sanction the necessary modification of the Waste-Land Rules.
- 7. Regarding the last subject discussed in your letter,—the terms on which applications to mine in Government waste land in Wynaad and similar auriferous tracts shall now be granted,—you point out that, if gold should be largely produced in India, the effect on exchanges would be highly beneficial, and that it is consequently of great importance that the gold sources in India should be worked to the best advantage. You consider therefore that the mining terms granted by Government should be as liberal as possible without encouraging undue speculation, and you deem it of importance thus to attract capital to the Wynaad gold-fields. You have ascertained that Australian experience is that the largest indirect advantage to the State is secured by making mining leases simple and liberal, on the one condition that a certain quantity of labour is employed per acre on bona fide mining operations. You propose therefore to authorise the Government of Madras to grant gold-mining leases of Government lands, in lots of from 1 to 30 acres, for terms of 10 or 20 years, at a rent of Rs. 5 per acre, on condition that not less than five labourers per acre are regularly employed on bona fide mining operations, in such manner as Government may approve. Power will be given to the Government of Madras to enforce fulfilment of these conditions, and the leases are to be renewable at the expiration of the original period on such terms as the Madras Government may then settle. You thus leave to the Government of Madras wide discretion with reference to the term and area of each lease, and you do not propose for the present to levy any royalty or other tax on the industry.
- 8. These arrangements appear to me to be judicious, and I approve them. With reference, however, to the last sentence of the preceding paragraph, and also to the last clause of paragraph 7 of your letter, I am of opinion that it should be made clear that for the term of leases now granted there will be no liability to any future royalty or other tax in addition to the rent, with the exception of any taxation which may hereafter be found necessary to provide, at the expense of mining communities,—the expenses of special police, communications, water-supply, sanitation, or other similar administrative arrangements needful for their own protection or convenience.
- 9. Finally, I have to observe that the arrangements you now propose appear to refer to mining operations in Government waste lands only. Should, however, it be decided that mineral rights in any owned or occupied lands in Madras are vested in Government, and should gold be discovered in any such lands, I presume that, with due regard to the rights of the cultivating proprietors, mining privileges will be granted on terms similar to those now approved for Government lands.

From the Officiating Secretary to the Government of India to all Local Governments and Administrations,—No. 1-40—48 (Mineral), dated Simla, the 15th May 1880.

In continuation of my Circular No. 2-11—19, dated the 1st September 1879, I am desired to forward copy of a despatch No. 85, dated 25th March 1880, from the Secretary of State for India, regarding rights of Government to minerals in this country. The policy of

the Government of India, as already announced, is generally approved, subject to certain additions to be noticed below.

- 2. The most important declaration contained in the despatch is that expressed in the fourth paragraph. Hereaften, except in permanently settled estates, it will be presumed throughout India that, in the absence of any distinct judicial precedent or proof of established usage, the State has a right to minerals.
- 3. Attention is invited to paragraph 2 of the despatch, under which the ruling that grantees of waste lands, whether or not the grants expressly comprise all products above and below the surface, are, in the absence of provision to the contrary, entitled to mines of gold and silver found thereunder, is limited to grantees of waste land "in fee simple," made in accordance with the rules framed upon the instructions given in Sir C. Wood's despatch No. 14 of 1862. Should any question hereafter arise in respect to grants of waste land made on other terms, Local Governments and Administrations will have to consider, in each class of cases, what is the specific effect of the form of grant regulating them as touching rights to minerals. The general ruling above quoted must be held not to apply to ordinary cultivating leases made in the course of settlement operations, or in the routine of district revenue work.
- 4. The direction in paragraph 5 of the despatch, to avoid conferring proprietary rights in minerals by including them amongst the assessable assets where such ownership has not been previously proved to exist, will be duly observed in making temporary settlements. The view of the Government of India, that where proprietors of temporarily-settled lands have been judicially held to be owners of minerals contained therein such mineral resources may be taken into account for assessment on resettlement, has been accepted by the Secretary of State. But, as explained in paragraph 2 above, in the absence of a judicial decision, the presumption will be that such landholders are not owners of the minerals underneath the surface of their lands.

5. With reference to paragraph 6 of the despatch, I am to request that the rules regarding the sale and lease of waste lands for agricultural purposes in force in

may be modified, so far as may be necessary, to make leases and sales under them subject to reservation of the full right of the State in mines and minerals, and of right of access and other reasonable conveniences for working them on behalf of Government or the assignees of Government. Full publication should be given to the modifications of rule made under these instructions; and copies of such orders as may be passed by the on the matter should be forwarded to this Department for information.

APPENDIX N.

Partition of Estates by the Collector.

- 1. In the division of an estate ordered by the decree of a Civil Court paying land revenue to Government, the Collector is bound by the rules laid down in section 113 of the Land Revenue Code whenever they are applicable. If a Court assigns rights in specified areas in survey numbers of less extent than the minima prescribed under section 98 of the Code, these rights cannot be registered in the Government accounts, or be otherwise recognized by Government. (G. R. 7052 of 23rd November 1881.)
- 2. When the division or separation of a share of an undivided estate paying revenue to Government is made by the Collector, under the orders of a Civil Court, in accordance with the provisions of section 265 of the Code of Civil Procedure, 1877, the following fees shall be levied (in addition to those prescribed at page 129 of the High Court Circular Book) as remuneration for travelling expenses bond fide incurred by subordinates in the Revenue establishment employed on such division or separation of estates:—

APPENDIX O.

No. 4213.

REVENUE DEPARTMENT.

Bombay Castle, 21st July 1881.

In exercise of the powers given by Section 55 of Bombay Act V. of 1879, the Governor in Council authorizes the Commissioner in Sind to fix rates for the use by landholders and others of water the right to which vests in Government, for the cultivation of rice on any land not assessed and entered in the Survey Registers as rice land.

- 2. The amount of such rate shall be subject to the approval of Government, and shall, after sanction, be notified in the office of the Mukhtyárkar of the táluka in which the land on account of which the rate is levied is situated.
- 3. Any person desiring to grow rice in land not assessed as rice land shall make an application in writing to the Mukhtyárkar or other officer duly authorized to receive such application, for permission to make use of the supply of water needful for growing rice, stating if he requires it for one year only or permanently; and if any person cultivates rice in such land without such permission he shall be charged with double the rate he would otherwise have been required to pay had he applied for and obtained permission.
- 4. All persons who now hold or may hereafter apply to take up lands assessed and recorded in the Survey Registers as rice lands, shall, as soon as possible after the publication of these Rules or on application to take up such lands, be tendered a list of such rice lands then being or about to be in their occupation, and rice shall not be grown on any number not included in such lists except on payment of the extra rate.

Without the special sanction of Government, the only form of security to be taken from treasurers or other officers of Government who are entrusted with the charge of public money shall consist of Promissory Notes (including Stock Notes) of the Government of India.

The Revenue authorities are, subject to the orders of Government, responsible for seeing that adequate security is taken from any of their subordinates (including all officers in district and sub-treasuries) who may be entrusted with the custody of public money.

APPENDIX H.

[See paragraph 2 of Special Instructions.]

Rules for taking up Land for Railway purposes (by the Government of India), issued 29th June 1861.

- 1. Land required for Railway purposes may be divided into 4 classes—A., B., C., and D. First, Class A.—Land which a Railway Company receives free of charge, under the contract with the Government for permanent occupation. Second, Class B.—Land also provided free of cost, but only for temporary occupation. Third, Class C.—Land which the Railway Company has to provide at its own cost. Fourth, Class D.—Land which does not come directly into the possession of the Railway Company at all.
- 2. Class A. will comprise the land acquired for the permanent works of a Railway, including the road with its bridges, &c., and all stations, workshops, permanent storehouses, and the like necessary for the line when opened, and which under the contracts is to be provided by Government, free of cost, to the Railway Companies. The occupation of this land by a Railway Company will be so far permanent that it will only cease when their contract is terminated or surrendered, and the whole lapses to Government. It is all provided free of charge.
- 3. Class B. will contain land essential for the execution of the permanent works of a Railway, but not required after the completion of the line in part or in whole. It also is provided free of charge—such as land for spoil banks, extra excavation to make banks, for river diversion, and for the storage of Railway materials held in stock by the Railway Company pending the construction of the line or their despatch to the works; * the occupation of this class of land will be temporary. On its restoration to the Government, the proper time for which will be settled in each case between the Railway Officers and the Consulting Engineer, it will be for the Revenue Officers to dispose of it to the best advantage of Government.
- 4. Class C. will contain the land which a Railway Company has to provide at its own cost. This is the land which is required for the provision or preparation of materials; for purposes contingent on the actual execution for the works on the line, or for other miscellaneous objects, which the Government recognizes as falling legitimately within the scope of the Railway Company's operations, though not giving the Company a claim to the provision of land free of charge. As a Railway Company is bound to pay for the construction of all works out of the Capital, receiving only from Government, without charge, the land on which the works stand, the provision of all materials, and the means of facilitating the execution of all works, are to be at the cost of the Railway Company.† It is proper to bear in mind, in fixing the rent, that this land will in part deteriorate by the use to which it is put and in part will not so deteriorate. In all cases, however, it will be most convenient to deal with the land, in the first instance, in the same manner. It will be taken possession of by Government, and handed over to the Railway Company for occupation at a fair rental. When the necessity for occupation ceases, the land will be given up again to Government by the Railway Company, the proper time for this being determined, as under Class B., by the Railway Officers and Consulting Engineer.
- 5. Class D. will contain that land which, being required in consequence of the works of a Railway, still does not come directly into the occupation of the Railway Company; it will be provided free of charge. It will be exclusively land for roads—either new roads leading to Railway stations, or to permanent storeyards or workshops, detached from the main works, diversions, or changes of old roads made necessary by Railway works.

^{*} This last sort of land is allowed free under the Right Honourable the Secretary of State's letter No. 25 of 30th November 1858.

[†] The following words were also in the original rules :-

[&]quot;In this class, therefore, will fall all land for brick-making, quarrying, ballast (1) for houses, for persons employed on the work, &c., so also land for houses for Engine-drivers, and the like on the line when opened, and for other similar purposes will come under Class C."

But H. M.'s Secretary of State for India thought that any particularization in the rule might raise questions as to the power of Government to alter or vary the terms of the contract (a power which the Government has no intention of claiming). It has, therefore, been thought best to give these words in a note, simply for the guidance of the officers of Government and parties interested, as to the construction which Government puts on the contract in regard to certain points of frequent practical application.

⁽¹⁾ In the original rules, the words "for roads to works in progress" here found place. They have now been struck out as calculated to mislead. It is clear a road may be required from a site used temporarily for storage of materials also itself in Class B. This would carry the road itself into the same class. A road from brickfield or quarry would be in the same category as the brickfield or quarry, viz., Class C. Whereas a road from a detached, but permanent, store-yard, although leading "to works in progress," would not the 'less come under Class D., should such road still be necessary after the completion of those particular works. Thus, generally, the circumstances of the tenure of land at the end of the road furthest from the railway will decide the class into which the road itself shall be placed.

- 6. Inconvenience is likely to arise if Railway Companies are permitted to hold land on their own account or otherwise than as above explained. By causing them to rent from the Government all land to which they are not entitled free, in the manner above explained, simplicity in the tenure of their property will be secured, which will be a matter of importance at a future time when the Railway may be transferred to Government. The determination of the value to be paid by the Government for any land not included in Class A., which might be held by a Railway Company, would certainly be, in such an event, a great embarrassment.
- 7. Houses, trees, tanks, or other property on land which is not provided free of charge, and for which special payment or compensation is necessary, will be paid for at once by the Railway Company. In the case of land provided free of charge, the materials, &c., derived from the "clearance" of the surface, which then will be at the expense of Government, will be disposed of by the Revenue Officers to the best advantage.
- 8. All land required for a line of Railway will be applied for in continuous portions; the plans will be drawn to a scale of 150 feet to the inch, and the measurements and areas will be recorded in accordance with the fiscal divisions of villages, estates, or mauzas, parganas, and zillas, in a schedule, of which a form is annexed, showing in detail the several classes to which the land belongs.
- 9. The several classes of lands will be coloured pink, yellow, purple and green, respectively, in the plans, and the exact purpose to which each parcel of land is to be devoted will be noticed in the schedule.
- 10. Detached portions of land should be referred to some fixed point on one of the main sheets, with such distances and compass or other bearing as will enable the land to be identified at once. A corresponding entry should also be made on the main sheet to draw attention to the detached portion.
- 11. The general correctness of the plans and schedules of the Railway Engineers being attested by the Consulting Engineer to Government, the application will be forwarded to, and dealt with as may be necessary by, the Revenue authorities under the orders of the Local Government. The Revenue Officers are to be held strictly responsible for the regular adjustment, by Railway Companies, of all charges on account of land to be determined in the manner above explained.
- 12. A complete set of land plans should be recorded in the Chief Engineer's Office of each Railway, and a copy forwarded to the Consulting Engineer to Government, by whom a duplicate will be given to the Revenue Board, which, in turn, will supply Collectors of districts with transcripts of parts included in their respective zillas. When it may be found expedient, in order to expedite the making over of the land, to employ a special Land Commissioner for this duty, the Railway Engineers should supply an additional copy of the land plan for the use of the Land Commissioner.
- 13. The Consulting Engineer to Government and local Revenue authorities will, respectively, be held responsible for the punctual fulfilment of the foregoing orders in the several departments, and for the careful record of plans in their respective offices.
- 14. All contemplated changes in the land in possession of a Railway Company should be promptly reported by the Railway Agent to the Consulting Engineer to Government, who will notify the same to the Local Government. It will be for the latter to see that the necessary steps are taken by the Revenue authorities for entering such changes in their records, and for carrying out all further proceedings that are requisite on such an occurrence.
- 15. It will be necessary for the Local Government to see that a correct register and record of title of all Railway lands is maintained, for the whole of such lands will one day revert to the Crown. Also, that all rents or payments for clearances, &c., chargeable on behalf of Government against the Railway Company are duly realized.
- 16. It is essential that there should be for each Railway one set of plans in a regular sequence to show all the land, and that the plans of each Railway Company's estate after they have once been prepared, should constantly be corrected, and always be maintained complete.

Extracts from Circular No. 27 of 23rd September 1869.

PUBLIC WORKS DEPARTMENT.

(RAILWAY.)

(Modifying the Rules issued in Circular No. 55 of 29th June 1861.)

RENT FOR CLASS C. LANDS.

- 1. The Government of Bombay represents that the rules laid down by the Government of India, as to the mode in which the rents for C. Lands should be calculated, will, if acted upon, lead to some loss of Government money, and recommends that rent should not, in all cases, be determined by the same rule.
- 2. The Bombay Government is of opinion that, for Government land leased for house building, a fixed rent, irrespective of the classification of the soil and district, or locality should be charged, and that, where money has been paid for the surrender of a lease, 5 per cent. on the amount of compensation should be added to the rent.
- 3. For land taken up for houses, from private owners, 5 per cent. per annum on the purchase-money is considered by the Bombay Government to be a fair arrangement.
- 4. For land required for ballast pits, quarries, &c., the Government of Bombay thinks that the Company should be called upon to pay the full amount spent for the acquisition of the property, plus a nominal yearly rent during occupation, the proceeds from the sale of the land, when surrendered, being credited to the Company. For Government land, a yearly rent should be charged to cover deterioration, in addition to the cost of resumption, if any. The Chief Commissioner of Oudh also points out that any possible deterioration of the C. Lands, by reason of the purposes to which they may be put, does not appear to have been provided for in the rules last issued. This was referred to in the Circular Orders of 1861, on the subject of Railway lands, and was not provided for in the last rules through inadvertence.
- 5. The references may be met by an additional rule, and the following rules should accordingly, be promulgated in supersession of those issued with Circular No. 2 R. of 1869:—
 - I.—The annual rent on lands in Class C. occupied by a guaranteed Railway Company, shall be fixed at 5 per cent. on the outlay incurred by Government in taking up the land, plus any revenue or rent payable to Government in respect of the said land.
 - II.—But in the case of land already belonging to, and in the occupation of the Government, the rent shall be fixed at 5 per cent. on the value of the land as estimated by the Collector,

- III.—In the event of the land being required for purposes through which its letting value will be diminished, the Railway Company, on relinquishing it, shall pay, in addition to any rent paid during the occupation of the land under the previous rules, the estimated difference between the actual value of the land when relinquished and the value that the land would have had if the rent remained at the amount that was paid during the occupancy of the Company.
- IV.—When land presented in free gift by a private individual for the purposes of a Railway is made over to a guaranteed Railway Company in Class C. no rent shall be charged by Government beyond the jama or revenue previously paid to Government for the land.
- 6. With reference to Rule III., it is observed that the real value of the land to the Government, before it was handed over to the Company, would be properly estimated on the basis of the rent charged for it. But when land has been actually paid for by the Company already, as in Bombay, no re-opening of the old transaction should take place, and the adjustment can be made when any land is given up.
- 7. Compensation paid for surrender of a lease, or any other charge, should be considered in fixing the rent. If the land is not in the occupation of the Government, and cannot be transferred to the Company without charge of any sort, it comes under Rule I.
- d. It is optional to the Government of Bombay to fix the rent under Rule II. at Rs. 5 per acre for agricultural land occupied by houses of the Company's staff, or at any other amount it may deem desirable.

APPENDIX K.

Extract from Circular No. 21 of 12th October 1881.

PUBLIC WORKS DEPARTMENT.

(RAILWAY.)

(Modifying Circular No. 10 R., dated 25th August 1878.)

Rules for acquisition of Land for State Railways.

- I. The general course of procedure laid down in the Public Works Code, Chapter XV., paragraph 92, is to be followed on State Railways.
- II. Railway officers shall not obtain possession of land whether by purchase, lease or on simple toleration, except through the proper Revenue authorities.
- III. Engineers in preparing land plans for submission will divide their applications under two heads, viz.
- Land required permanently, or land necessary for the railway when it is opened for public traffic, and when the works of construction are finished.—Such lands are the sites of bridges, embankments, cuttings, fences and other works, the cess or berm introduced for the sake of safety between the limit of the works and the adjacent spoil bank, bázár or side cutting; roads permanently required, such as those immediately in the neighbourhood of stations, over-bridges, under-bridges, or level-crossings on the railway; land or water required for the water-supply; land wanted for the preparation and reception of such materials as are used in maintenance, as ballast pits; land for the permanent diversion of water-courses; and all space permanently required at the stations, whether for traffic, storage, workshops, dwellings or recreation.
 - (b) Land required temporarily or land necessary to be taken up, but not permanently wanted.—Such land will be for loads for access to works while in progress, but which will subsequently be abandoned; land for side-cuttings and spoil banks occupied during construction; for the preparation and reception of materials used in constructing the railway, as brick fields, quarries, ballast pits, or the temporary diversions of streams and highways. The sites of such dwellings as will be occupied only during construction will also come in this class.
- IV. The land to be taken up permanently for the through line of railway will be in the first instance, sufficient for a double line, so as to allow of a cart road to exist parallel to the railway inside the fence. This road will be useful not only during construction for service purposes, but afterwards for access to the stations, for maintenance purposes, and for stacking materials.
- V. The boundary of the railway land permanently acquired is in every case to be considered as the outside edge of the ditch. Beyond the ditch a clear space or berm of not

less than 6 feet must be left free from the spoil bank or side-cutting nearest to the railway, the cutting or Lank being sloped off at an angle of not less than 2 to 1 to prevent any encroachment on this berm from the effects of weather. It will be seen from the section that the width of land to be permanently acquired for a line on the 5 feet 6 inch gauge will be for embankments 70 feet, for cuttings 76 feet, in addition to the width required in each case for the bases of the slopes. For a line on the metre gauge the widths will be embankments 64 feet, for cuttings 70 feet, in addition to the slopes.

VI. Land to be taken up temporarily will be principally for side-cuttings and spoil banks, and will generally adjoin the land required permanently; it will as a rule be also permanently taken up by Government and subsequently disposed of when no longer required.

Embankments under 3 feet in height will only require side-cutting on one side of the railway. Slopes of side-cutting will be generally 2 to 1 all round, but care must be taken to provide for exceptional cases when a flatter slope may be needed. Similarly, the contents of cuttings under 3 feet high will be laid to spoil on one side only. Side-cuttings should not be too deep;—a depth of 6 feet may be estimated for in calculating the width of land required for side-cuttings. They should be formed into well-defined tanks of moderate length; and should not as a rule be connected with each other or with adjacent water-courses. Valuable land should not be taken up for side-cuttings or for temporary purposes. A sufficient water-course should be provided at right angles to the centre line of railway for each culvert or bridge, and on either side of this water-course land will be left clear of the side-cuttings sufficient to prevent the water from the river running into the side-cuttings. The precaution of leaving land uncut in this manner is necessary to prevent the formation of a dangerous stream parallel to the railway.

VII. In the neighbourhood of towns or other places where land is above the ordinary value, the width of land to be taken for slopes, fence, &c., must be specially considered to secure economy.

VIII. All land will be applied for in continuous portions and shown when practicable mile by mile, or village by village, on each sheet. The plans will be drawn to a scale of 400 feet to an inch; the centre line of railway will be shown divided into chains of 100 feet, and all dimensions will be figured in feet. The name of each zilla, pargana and mouza will be shown on each sheet. On curves the tangential point on the centre line will be marked, and the radius of curvature given. The areas in acres, roods and poles will be recorded in accordance with fiscal divisions in a schedule in the form appended to these Rules, showing in detail the class to which the land belongs and the purpose to which it is to be devoted. Land required permanently will be colored pink; temporary land will be colored yellow.

- IX. Detached portions of land should be referred to some fixed point on one of the main sheets with distances and compass or other bearings, or such reference to the published maps of the neighbourhood as will ensure a ready identification of the land:—a corresponding entry should be made on the main sheet to draw attention to the detached plot.
- X. As a general rule, three complete sets of land plans and schedules will suffice for record, viz.,—one for the Engineer in charge of the railway; one for the Local Government or Administration; and one for the Revenue authorities; but should more be required, they will be supplied by the Railway Engineers.
- XI. The general correctness of the plans and schedules submitted by the Railway Engineer in charge being attested by the Engineer-in-Chief or Manager of the State Railway, the application will be forwarded to the Revenue authorities, and will be dealt with by them under the orders of the Local Government or Administration.
- XII. The land plans and schedules will be rectified from time to time as changes occur, and Local Governments will see that a correct register of all railway lands is maintained.
- XIII. When land is no longer required for the Railway, it will be re-transferred to the Revenue authorities and disposed of by them. All contemplated changes in the land occupied by a railway should be reported to the Local Government; and it will be for the latter to see that the necessary steps are taken by the Revenue authorities for entering such changes in their records and for carrying out all further requisite proceedings.
- XIV. In Native States all land will be obtained through the Political Agent, and the distinction of temporary and permanent need not be observed; but this will not make it the less incumbent on the officials concerned to see that all land not permanently required for the purposes of the railway is restored when no longer wanted, and to keep as complete records of the land retained for railway purposes in Native States as in British territory. Such plans and schedules as the Political Agent may require will be supplied by the Railway Engineers.

The following letter from the Officiating Secretary to the Government of India, Home Department, Public, No. 2—27, dated 4th instant, is published for general information:—

"A case has recently been brought to the notice of the Government of India, in which the Civil anthorities had proposed to cut a railway embankment with the object of letting off flood waters, the overflow of which threatened to cause much damage and loss. It seems desirable that district officers should be instructed not to order the destruction of any railway embankment or bridge, or other large work, whether it be the property of the State or of a private company, without first taking the advice of some responsible professional officer. As a rule, the engineering authorities charged with the control of the work concerned should be consulted.

2. I am accordingly directed to request that, with the permission of His Excellency the Governor in Council, you will be good enough to cause all Civil officers to be instructed in the sense of these remarks. In any case of difference of opinion respecting the property of the State, the point at issue should, if time permit, be promptly referred to the Government of India for decision."

A letter from the Government of Madras, No. 1542, dated the 24th April 1877, soliciting sanction to certain advances of small amounts made to the ryots of Bonvanka and Vundeyoor, in the Ganjam and Madura Districts, for rebuilding houses destroyed by fire; also requesting that general powers may be granted to that Government to make similar advances, subject to such restrictions as to amount and report, as may be deemed necessary.

A letter from the Government of Madras, No. 1728, dated 18th June 1877, asking confirmation of its orders authorising the Collector of Nellore to make advances to the newly established Municipality of Ongole, to be adjusted when the municipal taxes are realised: and for general sanction to such advances subject to adjustment within the year.

RESOLUTION.—By Resolution in the Financial Department No. 3649, dated 30th September 1869, the Governor General in Council decided that the particular sanction of the Supreme Government for each takávi advance was not necessary, and that it would suffice for the Local Government to obtain sanction for the disbursement of lump sums from time to time on this object.

- 2. These advances will, in future, be regulated by the Rules framed under the Land Improvement Act, 1871. The rate of interest under these rules is one anna in the rupee or 61 per cent. per annum.
- By Resolution in the Financial Department No. 191, dated 12th January 1876, the Government of India decided that, without the special sanction of the Government of India in the Financial Department, no loan of public money shall be made under the provisions of any special law bearing a less rate of interest than 4½ per cent., and no such loan shall be made otherwise, bearing a lower rate of interest than 6 per cent.
- 4. By orders in the Revenue Department No. 10, dated 21st March 1876, the Government of the North-Western Provinces was authorised to make advances, in any case of emergency for such purposes as the purchase of seeds, grain, &c., without interest, reporting the matter simultaneously to the Government of India.
- By Resolution in the Financial Department No. 1291, dated the 30th June 1876, it was declared that :-
 - 1st, no advances should be made without the general or special sanction of the Government of India, unless, in any case, the Local Government is empowered by law to make such advances without reference to the Imperial Government;
 - 2nd, regular provision should be made in the estimates for all advances, and no advance should be made without the special sanction of the Government of India, unless funds have been duly provided in the estimates and sanctioned by the Governor General in Council.

- 6. By Resolutions Nos. 1451, dated the 9th July 1873, 5206, dated 26th August 1874, and 465, dated 26th May 1876, Local Governments were authorised, under certain defined circumstances, to advance money without interest to public servants to enable them to build houses.
- 7. By Resolutions No. 8687, dated 30th September 1875, and No. 1870, dated 18th June 1877, provision was made for the immediate report to the Supreme and Local Governments of any default in the payment of interest upon a loan of public money or in the repayment of its capital amount, and for the levy of compound interest at 6 per cent upon overdue instalments. A Local Government receiving intimation of such default was also required to explain to the Government of India at once the causes of the default and the steps taken to remedy it.
- 8. The Governor General in Council considers it expedient now to subtitute the following amended and consolidated order for these scattered Resolutions, and, at the same time, to dispose of the two pending references from the Government of Madras, recited in the preamble.
- 9. Advances made under the Land Improvement Act, 1871, are regulated by rules passed by each Local Government with the approval of the Governor General in Council under authority of the Act. Provision for these advances may be made in the estimates of each year, without further sanction by the Government of India, as follows:—

If any Local Government or Administration wishes to make a larger provision than this, the previous sanction of the Government of India must be obtained. Sums thus provided in the estimates may be disbursed without any further orders by the Government of India than may, in any case, be required by the Local Rules under the Land Improvement Act. The yearly rate of interest fixed by these Rules is one anna in the rupee, or 6½ per cent; but the Local Government may, if in any case it considers it expedient for special reasons, reduce this rate to 4½ per cent, or remit due interest in excess of this rate.

- 10. The powers of the Local Government under the Local Public Works Loan Act,* 1871, are regulated by Rules published under the Act by Notification No. 3761, dated 18th October 1873.
- 11. Besides advances under the Land Improvement and Local Public Works Loan* Acts, it sometimes becomes necessary to make loans of public money for the relief of persons suffering from some temporary calamity, as for instance, the destruction of houses, or crops, or seed grain, or agricultural stock, by some calamity of season, or by fire, or flood, or for some miscellaneous object, such as that described in the letter from the Government of Madras, No. 1728, dated 18th June 1877, now read. The Local Governments are authorised to advance money in such cases at their discretion within the following limits:—

The yearly rate of interest upon such advances should ordinarily be, as for advances under the Land Improvement Act, one anna in the rupee, or 61 per cent.; but the Local Government may, at its discretion, for special reasons, make such advances at a lower rate of interest, or even without interest, or remit any part of the interest due upon such advances. It is not necessary generally to make any provision in the estimates for this class of advances the amount of which is never likely to be large, and cannot, ordinarily, be foreseen.

- 12. The following general Rules should apply, as far as the law and existing Regulations allow, to all the advances to which reference is hereinbefore made:—
- (a) The advances should be re-paid in not more than twenty equal half-yearly instalments including interest, the first instalment of principal to be re-paid six months after the loan is completely taken up.
- (b) Temporary advances to Municipalities should be re-payable in not more than twelve months.
- (c) A penal rate of compound interest not less than six per cent. should be enforced, as far as the law allows, upon all overdue instalments of interest, or principal and interest, and this should not be lightly remitted.

Now Local Authorities Loan Act, 1879, and the Rules published in Part VI. of this compilation.

- (d) Any default in the payment of interest upon a loan of public money or in the repayment of the principal, should be promptly reported by the Account Department to the Local Government, and, if the loan was sanctioned by the Governor General in Council, to the Supreme Government. A Local Government receiving such a report should, in the case of a loan sanctioned by the Governor General in Council, immediately explain the circumstances to the Government of India in the Home, Revenue, or Public Work Department, as the case may be, and the steps which it has taken to remedy the default.
- 13. No fresh orders are needed about building advances to public officers, which must be regulated, as heretofore, by the Rules in Resolutions Nos. 3123, dated 25th August 1871, and No. 5206, dated 26th August 1874.

Resolution of the Government of India, Financial Department, No. 3503, dated 5th October 1877:—

"READ again :--

The Resolution in this Department No. 2206, dated the 28th July 1877, laying down, in supersession of all old orders on the subject, the procedure for making loans and advances of public money, and for their repayment.

RESOLUTION.

In paragraph 9 of this Resolution, Local Governments were empowered to remit, to a certain extent, interest on advances made under the Land Improvement Act, 1871, but not any portion of the capital sum advanced. The Governor General in Council is now pleased to rule that, wherever the remission would involve a charge upon Provincial and not Imperial Funds, the Local Government may remit, at its discretion, any portion of the advance made under the Land Improvement Act, 1871, which may be found to be irrecoverable."

The following extract from the Proceedings of the Government of Bombay in the Revenue Department, No. 582, dated 3rd February 1879, is published for general information:—

Read the following Resolution of the Government of India, Financial Department, No. 184, dated 18th January 1879:—

READ again-

The Resolution in this Department No. 2206, dated 28th July 1877, laying down the procedure for the grant and repayment of loans of public money.

RESOLUTION.—By paragraph 11 of this Resolution, Local Governments and Administrations were empowered to make, at their discretion and for special reasons, small advances at 6½ per cent. interest, with permission to allow even a lower rate sometimes for such objects as the relief of individuals suffering from calamities of season, or for the provision of seed-grain or agricultural stock.

- 2. In some instances, however, Local Governments have, in anticipation of the approval of the Government of India, made larger advances than they were competent to canction and at a lower rate of interest than 6½ per cent.
- 3. His Excellency in Council consequently directs that no more such unauthorised advances shall thus be made in anticipation of approval, and that the rate of interest charged upon such loans shall not, without very special reasons, be reduced below 6½ per cent.
- 4. The Governor General in Council further is of opinion that in future all such loans shall be held to be made upon the security of the Provincial Revenues, which will be required to make good the principal and intrest if the debtor do not pay.

Special Rules under Section 41 of the Act for the Province of Sind.

- All words used in these rules and defined in Act VII. of 1878 (The Indian Forest Act) shall be deemed to have the meaning respectively attributed to them by the said Act.
- 2. No timber or charcoal shall be brought within the Municipal limits of the cities of Shikarpur, Sukkur, Rohri and Hyderabad except by the roads and landing-places below mentioned (namely):-

Sukkur, A'bad, Melani, and Shikarpur roada.

Landing-places.

3. No person shall remove any timber or charcoal from any Reserved or Protected Forest without a pass signed by the Forest Officer in charge of such Forest, or otherwise than in accordance with the conditions of such pass,

Every such pass shall specify—

Gidu Bandar road.

- (1) the quantity and description of the timber or charcoal which it covers,
- the name of the person removing such timber or charcoal,
- (3) the name of the Forest from which it is removed, and
- (4) its destination.
- 4. No person who wishes to remove any timber sufficient to make a cart or camel-load from any land which is not included in a Reserved or Protected Forest, shall remove the same from or to any place within twenty miles from a Reserved or Protected Forest, without obtaining from the holder or manager of the land, or if such land be Government waste land, from the Tapedar of tapa, a written certificate setting forth the quantity and description of the timber to be removed and the date of its removal.
- No person shall bring firewood or charcoal, the produce of any land not included in a Reserved or Protected Forest, for sale into the cities of Shikarpur, Sukkur, Rohri or Hyderabad without a pass signed by a Forest Inspector, or a Tapedar, and setting forth the quantity and description of the firewood or charcoal covered thereby.

6. Every person in charge of any timber or charcoal to which any of the last three rules is applicable, shall retain the pass or certificate relating to such timber or charcoal in his possession so long as the same is in transit, and shall, on demand, produce the pass or certificate for inspection by any Forest or Police Officer, and if such timber or charcoal is being conveyed into the city of Shikarpur, Sukkur, Rohri, or Hyderabad, shall produce the pass or certificate at the stations, called "Guard," established on the routes leading to those cities for examination.

APPENDIX C.

Memorandum on the Legal Position of Government in respect of Forests and rights to Trees as ascertained by the results of recent Suits.

The great principle which is recognized by the courts in all questions as to rights to trees is that the proprietary right to trees follows the property in the soil. Hence wherever it can be shown that land is the property of Government, the immediate inference is drawn that in the absence of any other circumstance which creates a proprietary right in the trees in the landholder the trees belong to Government.

2. Thus in the case of Govind Purshotam v. the Sub-Collector and Deputy Collector of Forests, Kolába, (C. Bom. H. C. R., 188, A. C. J.) Couch, C. J., said "this is a case between landlord and tenant. There is nothing to show that the tenancy confers any other right than

- that of occupying and cultivating the land for 30 years, as guaranteed by the settlement.

 * * The trees are timber trees growing on Government land, and the proprietary right to the trees is derived from the property in the land." The plaintiff's land had been surveyed and settled before the passing of the Bombay Survey Act of 1865, and section 40. of that Act did not apply to his holding, because that section had no retrospective effect. It was not contended that he held the land on any tenure or on any special terms, which implied proprietary right to the trees, and although he relied on Dunlop's proclamation* and on No. 10+ of the old Joint Survey Rules, it appears to have been considered that he was not entitled to the benefit of either of these. This case, which is the earliest of the reported ones of the Bombay High Court on this subject, was decided in 1869.
- 3. In an earlier case, that of Ruttonjee Eduljee Shet v. the Collector of Thána and the Conservator of Forests (10 W. R. 13, Pr. C.) the Privy Council followed the same principle. The plaintiff in that case held the village of Ghátkopur in the Island of Sálsette on a lease granted to him by the Collector of Thána in A.D. 1845, and he claimed the right under that lease to fell unassessed trees in the village, and to apply them to his own use. Their Lordships of the Privy Council said: "At the time when this lease was made, the whole of the land and all the rights connected with the land, subject to such claims as third parties might have upon it, belonged to the Government. The trees upon the land were part of the land, and the right to cut down and sell those trees was incident to the proprietorship of the land. The appellant (plaintiff) therefore * * * must ground his title to these trees and the right to cut them down either upon this, that it is a necessary incident of the lease by reason of the objects of the lease; or secondly, upon some positive law; or thirdly, under some custom to be incorporated in the lease; or fourthly, under the express terms of the lease." And as none of these circumstances, which might affect the general principle, appeared to their Lordships to have been established, they held that the case of the appellant entirely failed.
- 4. The first question that arises in every case of a disputed right to forests or trees is, therefore, whether the Government is the proprietor of the soil, or the alience (inamdar) or landholder. In the case of alienated lands the determination of this question sometimes raises difficult issues.
- 5. The leading case on this point is Váman Janárdan Joshi v. the Collector of Thána and the Conservator of Forests (6 Bom. H. C. R. 199, A. C. J.)

 Leading case as to construction of written grants from the State, when proprietary righs are claimed under such grants.

 In that case the plaintiff (an inámdár) claimed the right to deal as he pleased with the forests in his inám village on the strength of his original sanads from Angria and the Peshwa. It was held by Melvill, J. (Gibbs, J., concurring) that "in a contest of this kind it is surely most just that such a rule as that by which English Courts of Law are guided in the construction of grants from the Crown, should be applied in the most stringent possible manner; and that the plaintiff's sanads should not be construed as conferring a right to the forests, unless such right be conferred in clear and unambiguous terms," and that the sanads

ought to "show plainly and unequivocally that the proprietorship of the land of the village was granted to the plaintiff's ancestor." It was allowed, quoting Westropp J.'s learned judgment in another* case, that sanadi grants in inám, &c., are "generally speaking more properly described as alienations of the royal share in the produce of the land" (i.e., of the Government revenues) "than grants of land." The sanads in question contained no such words as necessarily indicated a grant of the property in the soil. They did not contain the words common in Maráthi sanads, when the property in the soil is granted, viz., "jal, laru, tran, páshán, nidhi nikskep," (i.e. water, trees, grass, wood stone and buried or concealed treasure.) It was therefore held that they conferred only a right to the revenues of the village, and did not operate as an alienation of the soil and therefore gave the plaintiff no right to the timber growing on the soil ("for," said Melvill, "the owner of the land is owner also of the timber which grows upon the land").

6. In the decision of the Conservator of Forests v. Nágardás Szubhágyadás, known as the Pigonde Case (High Court's Printed Judgments for 1875, pp. 325—332), the same principle was followed. The plaintiff in this instance was a khot of the Kolába District, and he claimed a right to the trees and forests of the villages of Pigonde to the extent of his 3th share in the khotki. But although the

suit related to a khoti village, the plaintiff based his claim on certain sanads, and the khot, considering that his rights were "laid down with sufficient distinctness in the documents thus propounded by him" did not go into the question of the general rights of khots,† and found that the sanads relied upon did not contain any such words as those above alluded to and were not intended to convey any proprietary right in the soil. This decision has since been confirmed on appeal by the Privy Council (L. R. VII. Ind. App. 55). In the judgment of Westropp, C. J., there is the following passage which states the opinion of the Court in very clear language:—

"In Vykuntat v. the Government of Bombay decided by my brother West and myself on the 1st May last, we pointed out that when the State grants a village eo nomine, without further words, the proprietorship in the soil does not necessarily, or even ordinarily, pass to the grantee, and that the latter only takes thereby the royal share in the produce of the village, or so much of that share as the sanad may purport to grant. Mr. Mountstuart Elphinstone is very clear on that point (see his History of India, 4th Edition, p. 74, note)."

There is no part of the judgment in the Kánara Land Assessment Case which states this point in these very distinct terms, but the parts of that judgment to which the Chief Justice has referred are stated by himself in a marginal note to be a 12 Bom. H. C. R. App. pp. 1, 33, 34 and especially 39, 40."

7. In this judgment in the Pigonde Case, Westropp, C. J., further observed, with reference to the rule of construction of grants from the Limitations of the rigid rule of Crown that he "adopted the rule laid down authoritatively on construction of written grants laid behalf of Her Majesty's Privy Council by Sir John Coleridge down in the leading case. in Lord v. the Commissioners of Sydney (12 Moor P. C. 497). that although their Lordships ' did not intend to differ from the old authorities in respect to Crown grants,' yet they held that 'upon a question of the meaning of words, the same rules of common sense and justice must apply whether the subject-matter of construction be a grant from the Crown or from a subject, and that it is always a question of intention to be collected from the language used with reference to the surrounding circumstances.' If those guides to a satisfactory construction fail, but not otherwise, the ancient rule that if the king's grant can enure to two intents, it shall be taken to the intent that makes most for the king's benefit ought to be applied." In Raoji Náráyan Mandlik v. the Mámlatdár of Ratnágiri (I. L. R. 1 Bom. 523), it was held that "if words are employed in a grant which expressly or by necessary implication indicate that Government intends that so far as it may have any ownership in the soil that ownership shall pass to the grantee," it is not permissible to any body to say that the ownership did not so pass, "unless there are in the grant such detailed provisions as show that such words are limited in their operation." §

[†] But although the general rights of khots were not considered in this case, Melvill, J., referring in his judgment in the Collector of Ratnagiri v. Raghunáthráo bin Rámájiráo Sarve (H. Ct.'s Printed Judgments for 1875, p. 324) to the decision therein said: "It has been decided in Regular Appeal No. 15 of 1869 (and in this decision we concur) that a khot has no right to cut timber, either as a khot, or by virtue of Mr. Dunlop's proclamation, unless he can prove the grant of a proprietary title in the land of the village."

note that it has been ruled that where there has been a formal adjudication of title, the right of the grantee depends, not upon the terms of the original grant, but upon the meaning of the order of adjudication. Thus in Vásudev Pandit v. the Collector

of Poona (10 Bom. H. C. R. 471), West and Nanabhai Haridas, J.J., held that the plaintiff's title rested, not upon the sanad granting the inam, but upon the construction of the decision passed by the Inam Commissioner under Rule 1, Schedule B. of Act X. of 1852, for continuing the village; and the words in the decision "baki darobast gáv chálváva" (let the whole remainder of the village continue) were construed as "an adjudication of all proprietary rights free from exceptions of any kind, except those specified." Original sanads which have of late years been superseded by summary settlement sanads would also, no doubt, upon a similar principle, be left out of consideration, the title of the inamdar be held to depend entirely upon the meaning of the latter sanads. These summary settlement sanads continue inam villages and lands for ever as "the private property" of the holders and it was held in the last-named case (10 Bem. H. C. R., 471), that it was an invasion of the right of an inamdar whose lands had been recognized by Government as his private property to quary stone or take sand from those lands without his permission or authority. What is there said of quarrying stone or taking sand would apply equally to cutting timber, all these rights being incidents of the general proprietorship of the soil.

9. Alleged proprietary titles are not always based upon written grants. In all cases, however, the spirit of the above rule of construction of grants Rules for investigation of claims not based on written grants. would, no doubt, be observed in weighing the value of any evidence that might be adduced against the Government. In the Kanara Land Assessment Case (12 Bom. H. C. R. 214, 215, App.) it was said that "if it be the duty of the Court not to enforce the written grant of the Crown unless it be clear and unambiguous, it is not too much to say that at the very least, it is equally incumbent on the Court to ascertain beyond doubt that the Crown has intended to part with its prerogative to which it has succeeded by right of conquest, when the evidence offered in proof of such an alienation is not any grant or sanad or any entry in a Government book *** but is sought to be spelt out against the Crown from the acts and statements of its officers.'

10. The right to trees in lands not held upon any inam tenure but under one or other of the ordinary ancient tenures of the country depends upon the same question, viz., whether the property in such lands Property in the soil of cultivated lands of ordinary landholders. belongs to the sovereign power of the State or to the land-holder. This question was very thoroughly considered in the Kanara Land Assessment Case. After a full review of the authorities, Westropp, C. J., and West, J., arrived at the conclusion in that case, that "the proprietary right of the sovereign derives no warrant from the ancient laws or institutions of the Hindus, and is not recognized by modern Hindu lawyers as exclusive or incompatible with individual ownership" (12 Bom. H. C. R. 53, App). Under the Muhamadans also the holders of cultivated lands were shown to have been regarded as the owners thereof (ibid, 53-57). Proprietorship in the soil was expressly recognized as existing in the bhágdári and narwádári villages in parts of Gujarát (ibid, p. 43)* and it was so strongly stated that there is reason to believe that the mirási tenure in the Bombay Presidency carries with it private property in the soil (*ibid*, pp. 46-7, 43, 50, 51 and 70) that there is little doubt that if the point had been directly in issue, it would have been held that mirásdárs also are proprietors; of their lands, just as it was held (ibid, p. 1, head note) that the mulavargdár in Kánara "enjoys an hereditary and transferable property in the soil."

11. But whatever may be the rights of ryots in respect of their cultivated lands, it is now clearly established that waste lands under the ancient Proprietorship of waste lands belongs to Government. Hindu and Muhamadan laws as well as under the British law now in force in this Presidency, belong to Government. This was clearly laid down in the Kánara Land Assessment Case (12 Bom. H. C. R., 57-9 App.), in Pendse's Case (High Court's Printed Judgments for 1879, p. 276), which will be more particularly referred to in the next paragraph, and in the Kánara Forest Case (I. L. R. 3 Bom. 583-4, 542 and 546-7). The two last-named cases are the two important suits in which respectively the rights of Government to trees in warkas lands in the Konkan and in kumri lands in Kanara have been recently contested.

12. In Wasudeo Bhaskar Pendse v. the Collector of Thana (High Court's Printed Judgments for 1879, pp. 274-287), the plaintiff sued " to Leading case as to rights in warkas land in the Konkan. establish his rights as against the Government to cut down all trees growing upon certain lands held by him in the Narsapur

^{*}Its existence in talukdari villages is recognized by section 20, Bombay Act VI. of 1862, as regards villages which have been managed by the Talukdari Settlement Officer, and a Government Resolution extended the same recognition to talukdari villages which did not come under management.

or Karjat táluka of the Thána district." He claimed a proprietary right in his lands by virtue of his being a sutidár, and he alleged that a sutidár in the Konkan was equivalent to a mirásdár in the Deccan. Melvill and Kemball, J.J., who decided the case, felt "no doubt that there is such a tenure as a suti tenure," but were unable on the imperfect evidence before them to determine "whether a sutidár in the Konkan has the same proprietary title in the soil of his estate as a mirásdár in the Deccan." But they deemed it unnecessary to decide this point, because (owing to a mistake in the conduct of the suit in the District Court) the plaintiff's right to the trees in his rice fields had been conceded by Government, and it was clear that it "was only in respect of plaintiff's rice fields that any sutitenure could be set up," the "warkas land never being entered in the Government accounts as suti, but being carefully distinguished from it."

- 13. The judgment of the High Court in this case was therefore limited to a consideration of the High Court in this case was therefore limited to a consideration of the High Court in this case was therefore limited to a consideration of the High Court in this case was therefore limited to a consideration of the plaintiff in his warkas lands. Warkas is defined in the judgment as being "land on which, in accordance with the mode of cultivation in the mode of cultivation as manure (ráb) on their rice fields. This and not cultivation is the use to which warkas land is ordinarily appropriated; but patches of such land or from time to time used for raising scanty crops of inferior grain." The important points determined with respect to such lands are:
- (1) that warkas lands must be regarded to all intents and purposes as waste lands and, therefore, according to the settled law concerning waste lands, belong to the State;
- (2) that neither the use, with the acquiesence of Government, of defined portions of such lands for obtaining manure, nor the occasional and sporadic cultivation for several generations of patches of such land can be held to create a proprietary title.
- 14. The claim in the Kanara Forest case (I. L. R., 3 Bom. 452—785) although of very much greater magnitude in its extent, was very similar in its nature to the above. Kumri cultivation consists in the clearing and cultivating of spots in the jungles or forests, which after a season or two are again abandoned for other similar spots. The judgments recorded by Green and West, J.J., in the case are extremely lengthy and complicated, and as the suit related principally to questions of a purely local nature, they have been summarized in a separate memorandum. But the following points of general applicability may be noted as having been determined in it (viz.):—
 - (1) That under British rule the principle from which we must start is that waste lands belong to Government (ibid, p. 584).
 - (2) That the levy of a tax does not necessarily make a proprietor, but that to levy money from a ryot on account of any land implies a knowledge that he is there and in some way beneficially connected with it (ibid, pp. 578, 586).
 - (3) That for whatever purpose land may be used, tacit acquiescense by Government in its occupation wherever definitely invited and plainly manifested, has the effect of creating decisive test of ownership (ibid, 578-79).
 - (4) That mere temporary occupation of spots in a forest "without appropriation of any spot for more than some months or a year" is not necessarily a property or possession (ibid, 581).
 - (5) That as there must be certainty in a grant as to the area conferred, so three must be certainty as to area, or at least as to the identity of the object occupied, if the occupation is to raise the presumption of a grant, or of acquiescence in a definite occupation. There must be the "essential elements of possession, a fixed, a definable, an exclusive occupation, * * * present to the perception of the parties" (ibid, 585).
 - (6) That the acquiescence of Government in the levy by another person of fees for the cultivation of land within limits which that person claimed as his own, and the fact of Government's refraining from levying such fees direct and assessing such person's income from the fees levied by him, must be held to mark Government's recognition of such person's ownership (593, 636).
 - (7) That "a property in the soil must not be understood to convey the same rights in India as in England." Under one system an ownership may subsist unimpaired side by side with a limited right in exercise of which acts may be done which under another system would be regarded as contradictions of any ownership (*ibid*, 715).

^{*}The plaintiff also made some attempt to establish his proprietary title on the ground of his being a "pánderpesha;" but the Court held that pánderpeshas had no greater proprietary rights than any other occupant, the only privilege they enjoyed being a certain remission of the Government assessment, and even that privilege had been discontinued since A.D. 1864.

15. Failing proof of absolute ownership of the soil, an attempt is sometimes made to Prescriptive or customary rights to trees in Government lands impossible.

Covernment lands in the Conservator of Forests (6 Bom. H. C. R. 201, 202, A. C. J.), Melvill, J., held (Gibbs, J., concurring) that the plaintiff could not acquire by prescription a right to dispose as proprietor of all timber growing on another's land. Again in Vásudeo Bháskar Pendse v. the Collector of Thána (High Court's Printed Judgments for 1879, p. 278) the same Judge. (Kemball, J., concurring) said, it is clear upon anthority that

1879, p. 278) the same Judge, (Kemball, J., concurring) said, it is clear upon authority that if the soil be the property of another, the plaintiff cannot, either by custom or prescription, acquire an unlimited right to cut down trees growing upon that soil. "A profit a prendre in another's soil cannot be claimed by custom, however ancient, uniform and clear the exercise of that custom may have been "and "an unlimited profit a prendre on another's soil cannot be claimed by prescription."

West, J., held to the same effect in his judgment in the Kanara Forest Case (I. L R. 3, Bom. 640-641), but he pointed out that "the right to cut timber is' nevertheless "separable as a legal notion, from the residual ownership with which it is usually joined in England; and in this country the reserve of the forests or of

But partial rights of individuals in or over trees not incompatible with the general ownership of Government and vice versa. timber trees of special value by the State in a grant of land is

a general and well understood incident of the estate thus granted. In Gujarát it is not unusual for the owner of trees and the owner of the soil in which they grow to be different persons. This custom may have sprung from the Mahomedan law. It does not necessarily follow, therefore, from the cutting of trees by the Government that the Government asserting an unqualified ownership of the soil, extruded every private claimant." That particular rights over, or in respect of, the trees in certain lands may exist without carrying with them an absolute right of property over the whole is illustrated in the Pigonde Case (High Court's Printed Judgments for 1875, p. 332), in which the Chief Justice said: "A practice for the khot to charge fees to other persons for cutting firewood does not, in my opinion, afford any solid ground for contending that he had any right to teak or other valuable trees. It might as well be contended that a right to firebote in England conferred upon the tenant a right to cut down oak and other valuable trees.

- 17. Both in the South Konkan and the Kánara Districts, certain proclamations (in the South Konkan Dunlop's proclamation of A.D. 1824, and in Kánara Harris' proclamation of A.D. 1823) are relied upon by Effect of Dunlop's and Harris' the landholders as giving them rights to timber. The two proclamations which are very similar are to be found quoted at 8 Bom. H. C. R., 2 A. C. J., and I. L. R., 3 Bom. 728, respectively. With respect to the former it was admitted for the plaintiff in the Pigonde Case and the principle of the admission was endorsed by the Court (see Kemball, J.'s judgment., p. 327) that unless a khot was proprietor of his land, it neither conferred upon, nor confirmed to, him any rights in the timber trees; and it was also held in the Kánara Forest Case that the latter related only to timber in proprietary estates (I.L. R., 3 Bom. 690-691). In the Collector of Ratnágiri v. Venkatráo Náráyen Sarve (8 Bom. H. C. R., 1 A. C. J.), it was argued on behalf of Government that Dunlop's proclamation had been cancelled by a subsequent Government notification issued in 1851; but it was held that Government cannot by issuing a subsequent proclamation. "that Government cannot, by issuing a subsequent proclamation, resume a grant made by a previous proclamation, inasmuch as it cannot, any more than a private person, without the consent of the donee, revoke a gift actually made."
- 18. In Vásudeo Bháskar Pendse v. the Collector of Thána, when it had been held in the first place that the warkas lands in dispute were the pro-Other special grants and recognitions of private rights to trees, perty of Government, and therefore that the trees standing on them were prima facie also the property of Government, the plaintiff endeavoured to establish his title in virtue of "special grants and recognitions made by Government from time to time." The decisions recorded by the Court upon the various points thus raised are only applicable to the district of Thana, and some of them, perhaps, to certain talukas only of that district, but as indicating the nature of the questions which arise in such cases, it may be useful briefly to state them here. The Court held that
 - in the Thana district, previous to the introduction of the Revenue Survey-
 - (a) the felling of teak trees was universally prohibited and the right of Government to do this was never questioned;
 - (b) the right to all other trees standing upon, or to be afterwards planted upon their own lands was conceded to the occupants;
 - (c) warkas lands were treated as Government waste and not as private lands;
 - the right of cultivators to take "rab" from warkes lands for manuring their rice fields was recognized; but
 - (e) they were prohibited from felling trees of certain specified descriptions, although permitted, as a favour, to cut common wood for domestic use but not for trading purposes;

- (2) there is considerable confusion about the introduction of the Joint Survey Rules into the Konkan, but Captain (now Colonel) Francis' order for introducing them must either be held to have been unauthorized and invalid, or else that order and a subsequent order issued by him for modifying Rule X.* must be taken as constituting a single proceeding, so that either Rule X. was not introduced into the Konkan, or it was introduced with a reservation of the rights of Government in certain trees;
- (3) the present intentions of Government and of the Legislature appeared from Government Resolution No. 6646, dated 27th November 1875, and from the Bombay Land Revenue Code Bill(a) to be to reserve teak and black-(a) See section 40 of the Revenue wood trees only, and therefore that the plaintiff's title to Code, which has since become law. cut trees in the warkas land of which he is survey occupant extends to all trees except these;

APPENDIX D.

Two questions have been submitted to Government for decision:

First-Whether any land other than forest land or waste land which is the property of Government or over which the Government has proprietary rights or to the whole or any part of the forest produce of which the Government is entitled can be constituted a reserved forest under the provisions of Chapter II. of Act VII. of

Secondly-Whether the rights referred to in Section 9 of that Act include right of way or right to a water-course?

- On the first question it is quite clear that Chapter II. relates to forest land or waste land described in Section 3 and to no other land.
- 3. Section 3 specifies what land it shall be lawful for the Government to constitute reserved forest; namely, forest and waste land belonging to Government. The words "any land" in Section 4 cannot include any other land than what it is lawful for the Government to constitute a reserved forest. The Government cannot notify cultivated lands, whether alienated or unalienated, as forest reserves, except by first acquiring all the rights of owner-ship and converting them into waste lands. The object of Section 10 is to meet the case of any claim that may possibly be made of private ownership in or over such forest land or waste land or any portion thereof as is notified under Section 4, and to empower the Forest Settlement Officer to exclude such land from the proposed forest or obtain a surrender of it from the claimant or acquire it under the Land Acquisition Act, 1870.
- With regard to any land other than forest land or waste land belonging to Government, if required for the purposes of the Forest Act, 1878, Section &3 provides that it can be treated as required for a public purpose and dealt with under the Land Acquisition Act, 1870. When such land has been so acquired it becomes with all rights in or over the same public property, subject always to the right of way and all other rights of the public or of individuals legally subsisting. If Government does not dispose of it in any other way or for any other purpose, it becomes waste land belonging to Government, and may be constituted a reserved forest in the manner provided in Chapter II of the forest Act.
- 5. On the second question right of way and right to a water-course are included in the rights referred to in Section 9.
- 6. The Forest Settlement Officer is appointed to inquire into and determine the existence, nature and extent of any rights alleged to exist in favour of any person in or over any land comprised within the specified limits of the proposed forest, and to deal with

^{*}No. X. of the Joint Survey Rules was as follows:—

"Proprietors of inam, judi and miras lands, having possession of the same, have the right of cutting down or otherwise disposing of all trees growing therein, and also holders of Government fields, of which they have been in uninterrupted occupancy from a period onterior to the age of the trees, or for a period of twenty years, or who have purchased the trees under the provisions of Rule 2."

"Clause 10 provides that the proprietor of a field has the right to cut down trees growing in the field. the same as provided in Chapter II. He has, therefore, two principal duties to attend to; first, to make a proper inquiry; and, secondly, to dispose of the claims in accordance with the provisions of the said chapter.

- 7. His enquiry is to be made not only into all claims duly preferred, but he is to search for the existence of any rights which are not claimed by examining Government records, taking the evidence of persons likely to be acquainted with any such rights, and personally surveying and mapping out the proposed forest.
 - 8. The rights so contemplated are classed as follows:-

(1.) Right of pasture.

(2.) Right to forest produce.

(3.) Right of way.

(4.) Right to water-courses.

- (5.) All other rights in or over any land.
- 9. Section 10 provides how the Forest Settlement Officer shall deal with the last class of rights.
- 10. Sections 11, 12, 13, 14 and 15 provide how the Forest Settlement Officer shall deal with the first and second classes of rights.
- 11. The third and fourth classes relate to certain incorporeal hereditaments or easements attaching to the land which is the property of Government. It is obvious that when once after due inquiry a claim to any such right is admitted, or when once the existence of any such right is discovered, the fact of the right is sufficiently established.
- 12. Where no claims are preferred in respect of these rights, it is undoubtedly the duty of the Forest Settlement Officer not to overlook their existence and not to neglect to make every possible enquiry to ascertain whether any such rights do exist. It depends on the Forest Settlement Officer to prevent any hardship occurring to villagers living near proposed forests in respect to the use of public pathways or of water-courses in the forests; and it is not likely that any such rights, where they are clearly defined and ascertainable, will become extinct through the operation of Section 9. Any right of this description which is so obscure as not to be claimed at the proper time, or to come to knowledge after careful search has been made, cannot be of much worth.
- 13. It is clearly the intention of the Legislature that all existing rights of way or to water-courses should be carefully ascertained and preserved intact unless it is found convenient to stop such ways or water-courses and substitute others for them, as provided by Section 24.
- 14. Any person who shall enter a forest except by such public or private way will be a trespasser. An unlawful entry on another's land is a trespass; but it is not an offence punishable under the Penal Code, which only contemplates the offence called "criminal trespass," i. e., trespass with intent to commit an offence or to annoy the person in possession. But unlawful entry on a reserved forest is a forest offence punishable under the Forest Act, 1878. (G. R. 3112 of 31st May 1881.)

APPENDIX E.

(Rules for the assignment of land for Kumri cultivation).

- (1) The period of fallow should never be less than ten years after cultivation for two.
- (2) Personal inspection should annually be made both by the Collector and the Assistant Collector with a view to ascertaining that the prescribed limits of the Kumri assignment in each case have not been exceeded.
- (3) Kumri assignments should, as far as possible, never be allowed within 100 yards of streams running as late as December, and on the upper third of the slopes of hills.

APPENDIX A.

Government Selections CXXXII, New Series, contains Colonel Etheridge's interesting narrative of the Bombay Inám Commission, dated 21st April 1873, which Government ordered to be published as a valuable work of reference, and gives a good deal of useful information on the subject of summary settlements.

See also Colonel Etheridge's Preface to his List of Saranjáms.

The following extracts are taken from the Judgment of the High Court, dated 12th June 1882, in a suit for partition of saranjam property, and will be found useful for reference:—

In Krishnarav Ganesh vs. Rungrav et al. (b) Westropp, C. J., said, "Sanadi grants ininam, saranjam, jaghir, vazifa, wakf, devasthan, and sevasthan, (b). 4 Eom. H. C., 1, A. C. J. are, generally speaking, more properly described as alienations of the royal share in the produce of land, i. e., of land revenue, than grants of land, although in popular parlance, and in this judgment, occasionally so-called." This observation has frequently been quoted with approval, and the principle involved in it was the foundation of the decision in Vaman Janardhan Joshi vs. The Collector (d). Ind. Law Rep., 1 Bom., 523.

(d). Westropp, C. J., repeated his former observation as being undoubtedly true, though he qualified it by adding that "if words are employed in a grant, (c). 6 Bom. H. C., 191, A. C. J. which expressly, or by necessary implication, indicate that Government intends that so far as it may have any ownership in the soil, that ownership may pass to the grantee, neither Government nor any person subsequently to the date of the grant deriving under Government, can be permitted to say that the ownership did not so pass." He then added "In the sanud in evidence here, whoseever framed it, was apparently determined that no ambiguity should exist as to what the force of the term "village" might be; and in order to be explicit, he added to the grant of the village in inám the words "including the waters, the trees, the stones, (including quarries), the mines, and the hidden treasures therein." Consequently, in that particular case the Chief Justice refused to hold the Pensions' Act applicable; remarking that "an enactment of a character so arbitrary as Act XXIII of 1871, which purports to deprive the subject of his right to resort to the ordinary Courts of Justice for relief in certain cases, ought to be construed strictly, and the Court should not extend its operation further than the language of the Legislature requires." But the principle that grants in inám are ordinarily to be regarded as grants of land revenue, and nothing more, is in no way weakened by the decision in that case.

If this principle be true as regards grants in inam generally, it appears to us to be specially applicable to grants in jayhir or saranjam.

Of these two terms Colonel Etheridge says in the Preface to the List of Saranjáms published by him as the same stood on the 1st August, 1874, "Under the Mahomedan dynasty such holdings were known as Jághír, under the Marátha rule as Saranjám. If any original distinctive feature marked the tenure of Jaghir and Saranjam, it ceased to exist during the Marátha Empire: for, at the period of the introduction of the British Government, there was no practical difference between a Jághírdar and a Saranjámdár, either in the Deccan or Southern Marátha Country. The terms Jaghir and Saranjám are convertible terms in these districts. The latter is now almost universally adopted. These holdings, being of a political character, were not transferable nor necessarily hereditary, but, as a rule, were held at the pleasure of the Sovereign. On succession a Nazrána was levied. When of a personal nature, they were termed Jat Saranjám, when for the maintenance of troops Fouj Saranjám."

Colonel Etheridge's observation that jághírs were not necessarily hereditary hardly conveys a correct idea of the fact. It would have been more correct, if he had said that jághírs were not necessarily grants for life only, but might occasionally be hereditary.

(c). Ind. Law Rep., 3 Bom., 186.

This is how the fact is stated by the Judicial Committee in Gulabdas Jagjivandas vs. The Collector of Surat (e), where, their Lordships say that a jaghír must be taken primá facie, to be an estate only for life, although it may possibly be granted in such terms as to make it hereditary. Similarly, in the Fifth Report from the Select Committee on Indian Affairs (page 86) it was said: "With regard to the jághírs granted by Mahomedans, either as marks of favour, or as rewards for public service, they generally, if not always, reverted to the State on the decease of the grantee, unless continued to his heir under a new sanad; for the alienation in perpetuity of the rights of Government in the soil was inconsistent with the established policy of the Mahomedans, from which they deviated only in the case of endowments to the religious establishments and offices of public duty, and in some rare instances of grants to holy men and celebrated scholars."

The circumstance that grants of this kind were ordinarily of so temporary a nature raises a presumption even stronger than that which exists in regard to inams generally that the grants were ordinarily grants of the land revenue, and not of the soil. And the best authorities on the subject agree in so defining the nature of jaghers and saranjams. Colonel Etheridge, in the Preface to which we have already referred, says: "It was the practice under former Governments, both Mahomedan and Maratha, to maintain a species of feudal aristocracy for State purposes by temporary assignments of revenue, either for the support of troops for personal service, the maintenance of official dignity, or other specific reason. Holders of such grants were entrusted at the same time with the powers requisite to enable them to collect and appropriate the revenue, and to administer the general government of the tract of land which produced it. Under the Mahomedan dynasty such holdings were known as jághír; under the Marátha rule as saranjám." Professor Wilson in his Glossary defines saranjams as "temporary assignments of revenue from villages or lands for the support of troops, or for personal service, usually for the life of the grantee; also grants made to persons appointed to civil offices of the State to enable them to maintain their dignity. They were neither transferable nor hereditary, and were held at the pleasure of the Sovereign." The term jághír he defines as "a tenure common under the Mahomedan Government, in which the public revenues of a given tract of land were made over to a servant of the State, together with the powers requisite to enable him to collect and appropriate such revenue, and administer the general government of the district." Mr. Steele (Hindu Castes, page 207) says: "Grants by the Native Government in Jaghir were either Fouj Saranjám, subject to the performance of military service, or Jat Saranjám, personal Jaghir. The subject of these grants were the whole or particular portions of the revenues of villages belonging to the Sirkar * * * * * Usually the grants depended on the pleasure of the Sovereign, and the fidelity of the grantee * * * * * * * They were not in general hereditary; sanads seldom exist; on the first grant it was usual to give the grantee a *Khat* or order addressed to the Government officers of the district." Mr. Neil Baillie, in his Essay on the Land Tax of India, says (page xliv) "The Jághir is, properly speaking, an order upon the Khiraj of particular lands, which are said to be granted by way of Jaghir. Two examples of it are given in the Appendix; and the terms in which they are expressed are worthy of attention. In both a sum of money, so many lakes of dams, is said to be bestowed out of a particular Pergunneh, the officers and inhabitants of which are directed to account for their just rents and dues of the Diváni (that is of the Civil Government) to the agent of the Jaghirdar, up to the sum specified, from which they are forbidden to withhold or deduct a single dam." He then goes on to say: "Though the Jaghir was, in form, an order for the payment of the Khiraj, there is no doubt that the Jaghirdar was treated, in some respects, as the Zamindar, or holder of the land. Thus No. IV of the Appendix is a Perwanneh, addressed to the agent of a Jaghirdar, in which he is required to do justice to a complainant; and though the purpose of the Jághír was to make a provision by an order on the revenue, yet this was said to be by way of Jaghir, as if some holding or taking of the land itself was necessary to give due effect to this object. The Jaghir is thus sometimes treated as an estate in land, not only in the Regulations, of the Indian Government. but also in the decisions of the Courts of Justice, and in this sense it is considered to be, essentially, an estate for life. There is reason however to think this view of the Jaghir to be erroneous. As an order for payment of the Khiraj to a particular person, it necessarily fell to the ground on his death, unless some other persons, by name or description, were included in the grant. Such other persons might be his children: and if a Jághir were granted to a man and his children, there seems to be no just reason why it should not pass' to them at his death; much less is there any just cause for suspecting the genuineness of a document constituting a Jaghir, because it contains such words as seems to have been done in the case above alluded to." We understand Mr. Neil Baillie as expressing in this passage a clear opinion that, although the etymology of the word jaghir has sometimes given rise to the idea that the term involves a taking of land, or an estate in land, and although a Jághírdár has been treated as having some of the powers of a land-holder, yet, in fact, the grant is nothing more than an assignment of land revenue. And the case of The East India Com-(7). 7 Moore's Ind. Apps., 555. pany vs. Syed Ali (f) shows that it was upon this ground that the Madras Government justified the resumption of jaghirs, when it assumed the Government of the Carnatic in 1801. At page 575 of the Report is the plea of the East India Company that "even when the language of the grants might seem to convey a proprietary interest in the soil, the grantees confessedly possessed no such interest, the subject-matter of the grant being a mere Jághír, or portion of public land revenue, together with the Government powers of collecting the same."

The authorities which we have quoted, (and none have been shown to us which support a different conclusion), may, we think, be taken as at least establishing that a grant in jäghär or saranjäm is very rarely a grant of the soil, and that the burden of proving that it is in any particular case a grant of the soil lies very heavily upon the party alleging it. If it had not been that in the present case, in which there is no sanad, a Division Bench remanded the case for the taking of evidence, we should have been disposed to say that such a contention could not be made out by any evidence except such a sanad as was produced in Ravii Narayen vs. Dadaji Bapuji already referred to.

The history of the manner in which Deccan saranjams were dealt with by the Government of India and the East India Company, when it succeeded to the Government of the Peshwa, is succinctly stated in Colonel Etheridge's Preface. The correspondence cited by him shows clearly enough that, when on the advice of Mr. Mountstuart Elphinstone, then Commissioner at Poona, it was determined that all saranjáms granted prior to A. D. 1751 should be considered hereditary; this concession was made, not as of right, but as an act of grace and State policy, and the Government reserved to itself the power of determining, whenever occasions might arise, the nature and extent of its own bounty. This reservation of the power of Government has been recognised in all the legislations on the subject since Mr. Mountstuart Elphinstone, as Governor of Bombay, framed his Code of Regulations Section 38 of Regulation XVII of 1827, provides that "land held exempt as Jaghir shall be liable to resumption and assessment under the general rules at the pleasure of Government." This is explained in Clause 3, Section I, Regulation VI of 1833, which says "Jághír or other lands held on service tenure are declared to be resumable at the pleasure of Government, under the forms laid down in Clause First, Section 38, Regulation XVII, A. D. 1827, it being understood that the expression used in the said clause, viz., "under the general rules" meant "such rules as Government may think proper to issue from time to time." Act XI of 1852, after providing for rules for adjudicating upon titles to exemption from payment of land revenue, says (Section 10): "These rules shall not be necessarily applicable to Jághírs, saranjams or other tenures for service to Government, or tenures of a political nature, the title and continuance of which shall be determined, as heretofore, under such rules as Government may find it necessary to issue from time to time." So, in Bombay Act II of 1863, which was an Act to facilitate the adjustment of unsettled claims to exemption from the payment of Government land revenue in those parts of the Bombay Presidency, which are subject to the operation of Act XI of 1852, Section 1, Clause 2, says: "The excepted cases, to which the authority of adjustment and guarantee vested in the Governor-in-Council by this provision shall not extend, are the cases of lands held as follows:-

1st. * * *

2nd. Lands granted or held as Jághírs or Saranjáms, or on similar political tenure."

And then, lest any quesion should be raised, (as was attempted to be raised in the argument in this case), whether the mere order of Government that land should be entered in the accounts under the heading "Political" is conclusive as to the political character of the grant, Section 16 of the Act goes on to say: "'Political tenure' is defined to be tenure created from, or dependent upon, political considerations, the existence of which shall be determined by the Government." So, in Bombay Act VII of 1863, which is a similar Act relating to districts not subject to the operation of Act XI of 1852, Section 2, Clause 2, provides that "lands granted or held as Saranjám, or on similar political tenure, shall be resumable or continuable in such manner, and on such terms as Government, on political considerations, may from time to time see fit to determine;" and Section 32 contains a definition of the term "political tenure," similar to that which we have quoted from Bombay Act II of 1863. The Regulations and Acts which we have cited show beyond all question that it is for the Government to determine how saranjáms are to be held and inherited, and that, if the Civil Courts had jurisdiction over claims relating to Saranjáms, they would be bound to determine such claims according to the rules laid down by the Covernment. It would, therefore, be useless to refer, as in this case we have been referred, to evidence tending to show that, under the Native Government, the ancestors of the parties dealt with their Saranjám villages as if they were proprietors of the soil, and partitioned the villages among their families. The questions which the Courts would have to consider would simply be, what are the terms of the grant by which the British Government continued the Saranjáms in general, or for this saranjám in particular?

It would appear that, under "the Saranjám Rules" an hereditary Saranjám is considered by the Revenue authorities to descend entire to the eldest representative of the last holder, and that, if the eldest son predeceases his father, his son takes precedence of the next surviving son of the last holder.

We have been informed that the only rules are those contained in the Preface to Colonel Etheridge's List of Saranjáms, to which we have so repeatedly referred. As the Regulations and Acts which we have quoted contemplate that jághirs and saranjóms should be continuable under general rules to be issued from time to time by Government, it seems strange that no rules should be forthcoming, bearing the authorisation of the signature of a Secretary to Government. We, must, however, take it that Colonel Etheridge speak, under the authority of Government, when he says in the Preface to which we have been referred, that succession to Saranjams is restricted to lineal male heirs in the order of primogeniture; and that the eldest son is the heir in the first instance. Colonel Etheridge says that in Saranjáms of the second class, if the eldest son of the first British grantee die before his father, but leave a son, that son, on his grandfather's death, is to be considered the second generation, and the whole Saranjám will be continued to him. But curiously enough, Colonel Etheridge does

not say whether the same rule of succession would be applicable to hereditary Saranjáms; and on this point, therefore, we are left without any distinct rule. The rule to which the Revenue Commissioner referred in 1865 as giving to the son of a predeceased eldest son a preference over his uncle is not forthcoming in the Secretariat; nor does Mr. Nairne in his Handbook mention any such rule, except that which we have already quoted from Colonel Etheridge's Preface, as applicable to Saranjáms of the second class. In the absence of a rule made by Government, the Courts would, if they had jurisdiction in the matter, be obliged to decide according to the ordinary rule of Hindu law applicable to impartible property; and although, as stated by Mr. Mayne in his work on Hindu Law (Section 461), there is rather a want of authority as to the rule to be adopted where an eldest son, who has never taken the estate, has died leaving younger brothers, and also a son, yet the Courts would probably hold that the grandson took in preference to his deceased father's eldest surviving brother.

As regards the question of the impartibility of a saranjám, the rule stated by Colonel Etheridge is in accordance with the orders conveyed in a despatch from the Court of Directors, No. 27, dated 12th December 1855. In para 20 of that despatch they say: "We agree with you that Saranjáms should not be sub-divided, but that the holders should be required to make a suitable provision for their younger brothers." A júghír, to which service is attached, is certainly not divisible, but descends to the eldest son —Hurlall Singh v. Jorasrun Singh (g), cited with approbation by Lord Kingsdown in 6 Moore's Indian Appeals, 125, and Rajha Nilmoney Singh v. Bakranath Singh, decided by the Privy Council, 10th March 1882. There is some evidence in the present case that the saranjám was originally given for the maintenance of a body of horse, and was, therefore, in its inception a jághír held for service. But independently of this and of any Government rule, the same principle would probably be applied to all saranjáms, on the ground stated by Mr. Mayne (Hindr Law, Section 393), that an estate, which has been allotted by Government to a man of rank for the maintenance of his rank, is indivisible as otherwise the purpose of the grant would be frustrated.

APPENDIX B.

No. 6018.

Extract from the proceedings of the Government of Bombay in the Revenue Department, dated the 25th October 1875.

READ the undermentioned papers:-

Letter from J. E. Oliphant, Esq., Acting Revenue Commissioner, S. D., to the Chief Secretary to Government, No. 5, dated 4th January 1875.

In continuation of my Memorandum No. 4307, dated the 24th November last, I have the honour to request you will favour me with the instructions of Government as to the course to be followed in cases in which the watan lands belonging to district hereditary officers and subjected to the summary settlement are purchased by parties (not members of the watandar's family) at auction sales under decrees of the civil courts. Such purchasers frequently make applications to have the lands entered in their names in the Government accounts, and the question for consideration is, whether or not their applications should be complied with.

2. As the right of Government to exact service from the lands in question has been commuted under the settlement effected by the late Mr. Gordon, I see no objection to enter the lands in the purchaser's names on their agreeing to pay in future the additional nazrána of one anna for each rupee of the assessment, as prescribed for adoptions out of the family of watandárs.

Memorandum from Colonel A. T. Etheridge, C.S.L, Alienation Settlement Officer, S. D., No. 28, dated 15th January 1875.

Referring to Government endorsement No. 163 of 12th instant, Colonel Etheridge has the honour to observe that he is very doubtful whether a purchaser's name should be entered in the Government accounts, as suggested by the Revenue Commissioner, in the case of a district watan disposed of at an auction. It seems to the Alienation Officer that the terms of the sanads issued under Mr. Gordon's watandári settlement will scarcely admit of this course. As there is a doubt, the question might perhaps be referred to the Legal Remembrancer.

Report by J. R. Naylor, Esq., C.S., on special duty, No. 176, dated 8th May 1875.

Clause 2, section 15, Bombay Act III. of 1874 (the Hereditary Officers' Act), enacts that any settlement for commutation of service made with the holder of any watan before that Act came into force, shall have the same force as if made under that Act. And clause 1 of the same section enacts that such settlement may be made "upon such condition whether consistent with the provisions of this Act or not, as may be agreed upon." The effect of this appears to be to legalise any terms that may be, or may heretofore have been, mutually agreed upon between Government and the holder of a watan, even though such terms may not be consistent with the provisions of the Act. But watan property does not cease to be watan property, because the duties, for the performance of which it was originally acquired, have been commuted for a money payment, and unless there be something in the terms of the commutation settlement inconsistent therewith, the law ordinarily applicable to such property still applies to it, I think, notwithstanding that Government have dispensed with the necessity for service.

- 2. Under this view, I am of opinion that section 5 of Bombay Act III. of 1874, which enacts that "no watandár shall, without the sanction of Government, sell, mortgage, or otherwise alienate or assign any watan or part thereof, or interest therein, to any person not a watandár of the same watan," is applicable to the watans of district hereditary officers whose liability to service has been commuted for a money payment, because, as far as I am aware, there is nothing in the settlements entered into with them to the contrary. I say as far as I am aware, because I find from Colonel Etheridge's narrative* of the Inám Commission (latter part of para. 69) that the sanads which have been issued "are not only not the same throughout the Presidency, but are not the same in all respects in the same division."
- 3. The only form of sanad which has come to my notice is that sanctioned originally by Government Resolution No. 2871, dated 25th August 1863, in the Revenue Department, for Poona and Sátára. The former portion of it has been since somewhat changed on the recommendation of the Legal Remembrancer, but the essential portion would appear from the standard form (Sanad 14), recently printed at the Central Press, after being sent to me for revision (vide Government Memorandum No. 4958, dated 16th September 1874), to have remained intact. It is as follows:—

"It is hereby declared that the said lands and cash allowances shall be continued hereditarily by the Baitish Government, on the following conditions: that is to say, that the said holders and their heirs shall continue faithful subjects of the British Government, and shall render to the same the following fixed yearly dues:—

"In consideration of the fulfilment of which conditions-

- "1st.—The said lands and cash allowances shall be continued without demand of service, and without increase of land tax over the above fixed amounts, and without objection or question on the part of Government as to the rights of any holders thereof, so long as any male heir to the watan, lineal, collateral, or adopted, within the limits of the watandar family, shall be in existence.
- "2nd.—No nazrána or other demand on the part of Government will be imposed on account of the succession of heirs, lineal, collateral, or adopted within the limits of the watandar family, and permission to make such adoptions need not hereafter be obtained from Government.
- "3rd.—When all the sharers of the watan agree to request it, then the general privilege of adopting at any time any person (without restriction as to family) who can be legally adopted, will be granted by Government to the watan, on the payment from that time forward in perpetuity of an annual nazrána of one anna in each rupee of the above total emoluments of the watan."

The above conditions, so far from being inconsistent with the provisions of the Hereditary Officers' Act, are, it seems, in strict accordance with section 5 of it, which prohibits a transfer of the watan property to any person not being a watandar of the same watan. And if the same conditions are contained in all the sanads alluded to by Colonel Etheridge, the variances being in other details only, I am of opinion that no portion of watan to which any such sanad applies can be alienated to any person other than a watandar of the same watan without the sanction of Government, and that the Collectors may lawfully, in case of any such alienation in the future, have recourse to the powers given to them by Sections X. and XI. of the Act, and in the case of alienations effected before the Act was passed otherwise than by the intervention of the courts, to the powers given them by Section IX. of the Act.

4. It cannot, I think, be said that the property of any watan to which a sanad containing the above conditions has been given, has been thereby converted into private property in the usual wide sense of that term, and if I am correct in supposing that similar conditions have been inserted in all such sanads, I would respectfully suggest that the latter part of the 1st para. of Government Resolution No. 4248, dated 24th July 1873, might perhaps be modified with a view of removing possible misunderstanding. The closing part of the Collector of Dhárwár's Memorandum of the 10th October 1872,* to which the Hon'ble Colonel Anderson took exception in para. 5† of his No. 970, dated 1st July 1873 (vide Compilation No. 1063 of 1873), appears also to have been correct, whilst

^{***} The above rules (proposed for the collection of judi on inam holdings) will apply to all kinds of inams in this district with such few modifications as would be necessary according to the different conditions under which the inams may have been continued; for instance, in the case of the district hereditary officers' lauds, the same rules would apply, with this exception, that the transfer contemplated in the rules should not be permitted when the transferee is some person out of the watandar's family; this is necessary, as these watans have not been made transferable private property." (Mr. E. P. Robertson, Collector of Dharwar's Memo. dated 10th October 1872.)

the rules proposed by the Collector of Dhárwár would act beneficially beyond all doubt, and with a definition of the share of each sub-inamdár, would give a much more secure and comfortable tenure to all inamdárs, freeing them from all chance of molestation from the misdeeds or machinations of their co-sharers; but Colonel Anderson cannot agree with the closing part of the Collector's memo, of the 10th October 1872, in making district hereditary officers' lands only an exception. It would appear very inexpedient to allow the permanent transfer to any person, not of the office family, of any lands now held on service tenure. When all liability for service has been commuted no such objection exists. It would be far preferable, considering their present status, to allow district hereditary officers to do what they please with their lands than to grant the same liberty to the patels and kulkarnis, which, however, does not appear to be objected to by the Collector of Dhárwár. To facilitate the scattering of patels' and kulkarnis' land would be a political as well as an administrative error, while it appears by no means certain that the same measure would not be a political advantage in the case of the district hereditary officers whose service is no longer required, and whose ancient family influence, which is still very great and little to the advantage of Government, would be decreased by the dispersion of their lands." (Colonel Anderson's Memo. No. 970, dated 1st July 1873.)

the latter's views are certainly not in accordance with those expressed in para. 4 of Government Resolution No. 3167, dated 19th September 1863.*

5. I should add that a similar question to that on which I am now reporting has been raised in the suit marginally noted, the defence of which was sanctioned in Government Resolution No. 5510, dated 17th October 1874, and in adverting to para. 9 of my Report No. 158, dated 13th October 1874, upon this suit, I must explain that Sections V. and IX. of Bombay Act III. of 1874 have placed the law as to the inalienability of watan property in a much clearer light than the vague provision of clause I.,

Section 20 of Regulation XVI. of 1827 did.

Memorandum from Aderji Jamsetji, Esq., Acting Alienation Settlement Officer, N. D., No. 306, dated 14th June 1875.

The queries put in Government Memorandum No. 2824, dated 17th May 1875, to the Revenue Commissioner, N. D., are:—

- (1.) Whether the same conditions have been entered in the sanads issued to the watandárs in the districts of the Northern Division as those stated by Mr. Naylor?
- (2.) Whether the entry of the names of purchasers of watans is not permitted in the Northern Division?
- 2. As regards the first query, the undersigned begs to append a memorandum showing the conditions of the sanads issued to the watandars in the different Collectorates of Gujarát.
- 3. In the remaining Collectorates of Khándesh, Násik, Thána and Kolába, the conditions of the sanads issued to the watandárs of those districts are the same as those stated by Mr. Naylor.
- 4. With respect to the second query, the undersigned begs to state that the entry of the names of purchasers of watans in the districts of Surat, Broach and Kaira has been permitted. A specimen of such entry is given below:—
 - "Haridás Navalrám, purchaser of Dhanshankar Lakhmishankar's hak."
- 5. Applications for the entry of the name of a purchaser or mortgagee of the watans mentioned in para. 3 of this memorandum have been rejected by this department.
- 6. The conditions of the sanads issued to the watandars of the Ahmedabad District admit of a purchaser's name being entered, provided the watandars have agreed to the payment of an annual nazrana of one anna in each rupee of the total emoluments of the watan.

Conditions of the Sanad granted to the District Hereditary Officers of Surat and Broach as per Government sanction No. 3929, dated 14th November 1867.

"The watan, of which the share specified in the schedule below given is a part, as now confirmed, shall be continued (subject to the condition of loyalty to the British Government on the part of the holders thereof) by the British Government without demand of service, and without any further deduction therefrom on that account, or any objection or question on the part of Government as to title, to whomsoever shall from time to time be the lawful holders thereof, but without affecting the rights and interests of other parties."

^{*&}quot;With reference to paragraphs 26 to 29 (of the Watan Commissioner's report), the Governor in Council agrees with Mr. Hart (vide extract † para. 4 of his report given below) in accordance with whose views the point therein referred should be disposed of. With a view to give practical proof of the desire of Government to increase rather than to diminish the share which those officers have hitherto had in the efficient administration of the country, Government will be glad to receive from the Commission list of any of these Hereditary Officers whom they, after consultation with the Collectors, would recommend to be gazetted as Honorary Magistrates, together with a draft of any rules they may think it desirable to lay down for regulating the proceedings of such officers in the execution of their functions, Great care should be taken in the selection of officers with regard, not only to their personal character and social position, but their capacity to appreciate the honour done to them and their class by their selection, ', Government Resolution No. 3167, dated 19th September 1863, para 4.)

⁺ Extract para. 4 of Mr. Hart's Report above referred to:—"There is only one other point on which the Revenue Commissioner considers any remark beyond the notice of his general concurrence necessary, and this is not a point of any importance as regards the financial part of the settlement. In paragraph 2s of the Special Commissioners' letter, they mention the desire of the zamindárs, that in order to keep up the recognition of the consideration in which they have been hitherto held by the community, 'they should be considered to have a right to sit in the kacheri.' This ought not to be assented to in such terms as to recognise their rights to frequent the Mamlatdars' kacheris, or interfere in the kacheri work, at their own pleasure, which might cause great inconvenience and abuses of various kinds, but that when they do attend, in pursuance of invitations such as are contemplated at the close of the Special Commissioners' 28th paragraph, or in pursuance of any legitimate business, they shall be treated with no less consideration in such matters, as being allowed to be seated, &c., than they have hitherto been. The Rovenue Commissioner believes that this is what is intended by the Special Committee, but has considered it right to notice the matter, trivial as it may appear, more particularly than they have done." (Mr. Hart's Memo, No. 2302, dated 24th July 1863.)

Conditions of the Sanad granted to the District Hereditary Officers of Ahmedabad as per Government sanction No. 234, dated 17th January 1867.

"1st.—The watan, as now confirmed, and below specified, shall be continued (subject to the condition of loyalty to the British Government on the part of the holders thereof) hereditarily without demand of service, and without any further deduction therefrom on account of service, and without objection or question on the part of Government as to the rights of any holders thereof, so long as there shall remain in existence any legal heir to the watan, whether lineal, collateral, or adopted, within the limits of the watandar's family, and whether descended in the male or female line.

"2nd.—When all the recorded sharers in the watan agree to request it, the general privilege of adopting at any time any person out of the watandar's family, who can be legally adopted, and of transferring the watan or any recognized share thereof, by sale, mortgage, &c., as private property, will be granted by Government to the watan on the payment from that time forward, in perpetuity of an annual nazrana of one anna in each rupee of the total emoluments of the watan as now confirmed, and from the date of the imposition of this nazrána the whole watan, or the recognized shares thereof, will be converted into private property, heritable and transferable in all legal modes."

Conditions of the Sanad granted to the District Hereditary Officers of Kaira, as per Government sanction No. 2376, dated 16th May 1872.

"This sanad is accordingly issued; and it is hereby declared that the emoluments of the said watan specified below shall, as now confirmed, be continued (subject to the condition of loyalty to the British Government on the part of the holders thereof) by the British Government in perpetuity, without demand of service or any further deduction therefrom on that account, and without any objection or question on the part of Government as to title. whether it shall have accrued in virtue of inheritance, adoption, transfer, or otherwise to whomsoever shall from time to time be the lawful holders thereof, but without affecting the rights and interests of other parties."

RESOLUTION.—The question raised by Mr. Oliphant is a very important one, and requires definite orders. But owing to the variety of agreements which has been made with watandars and to other causes, no distinct ruling of general application has yet been laid down.

2. Government are inclined to think that the rule laid down for Surat and Broach in Government Resolution No. 4425 of 16th December 1867 (a copy of which will be found in the précis attached), is the one which should be adopted everywhere, viz., that Government will not question alienations by district hereditary officers who have accepted the settlement, but that this course does not prevent parties interested from suing to set aside alienations as illegal. In that case it would be as well to forego the right to claim a nazrána of one anna on alienations or adoptions in which this has been stipulated for in the sanads. The amount of nazrána to be lost will be very small. If this course were adopted, the rule would be that the Collector should enter the names of alienees, if not objected to by the watandárs, on which point inquiries should be made. If the watandars object, the Collector would refuse to make the entry, and leave the parties to obtain decision from the Civil Court.

3. Government will, however, feel obliged by the Revenue Commissioners considering

the important question at issue thoroughly, and favouring them with their opinion upon it. Government would wish to be informed, at the same time, how far the condition has already been enforced of payment of nazrána where such a provision has been inserted in the sanads,

and whether any complications would follow the abandonment of it.

4. Mr. Naylor should be asked his opinion whether, if the question were decided in the manner indicated, it would be necessary to issue new sanads, or whether the decision would be a mere concession which the watandárs cannot object to; in other words, would an order merely directing the Collectors not to enforce certain stipulations in the sanads be cbjectionable?

5. Mr. Naylor should forward duplicate copies of his report to the Revenue Commissioners as well as to Government, in order that the Revenue Commissioners may have the benefit of his opinion when submitting their reports.

Resolution.—His Excellency in Council does not think it would be expedient to forego the nazrana of one anna, and it seems to him that the method least likely to cause difficulty would be to adhere strictly to the terms of the sanads in each case.

APPENDIX C.

Extract from reports of the Legal Remembrancer, quoted in Government Resolution No. 2318, Revenue Department, dated 8th April 1882.

- "Government have decided on several occasions that a daughter married out of a watan family is not by reason of such marriage divested of her rights and does not lose her statuz as watandar.
- "2. In the present instance it appears that the petitioner has already been recognized as representative watandár, and that under Section 51 of the Bombay Hereditary Offices Act, 1874, she appointed her husband to be her deputy. As Section 53 of that Act provides that none but a watandár shall be appointed as deputy the question is whether the petitioner's husband can be deemed to be a watandár, that is 'a person having an hereditary interest in a watan' within the meaning of that section.
- "3. The answer to this question must depend upon the decision of the other important question whether the watan property which a daughter inherits from her father is stridhan, and, therefore, transmissible to her heirs, or whether it is a limited and restricted estate only, that is to say, which she is entitled to enjoy for her life-time, and on her death devolves on the line of the last male owner, her father.
- "4. If the watan is regarded as stridhan it seems clear from the best authorities that on the death of the daughter her children are entitled to inherit it, and if she has no children, her husband will be her heir and on failure of him his nearest sapindás, which term includes, on the father's side, all blood relations within six degrees together with the wives of the males, and on the mother's side, those within four degrees. Consequently no objection could be taken to the appointment of the watandár's husband or one of his relations within those degrees as her deputy.
- "5. There is, however, a very great difference of opinion on the subject. The Bombay High Court have ruled that according to Hindu law on this side of India property inherited by a married woman from her father descends on her death to her own and not to her father's heirs (see I. Bombay High Court Reports, 209). Subsequently the same Court held that the property acquired by a married woman by inheritance, with the exception of property inherited by a widow from her husband, classes as stridhan and descends accordingly (see 6 Bombay High Court Reports, 1). Lastly it was decided in an elaborate judgment by Mr. Justice West (8 Bombay High Court Reports, 244) that the Mitákshara (which is the highest authority in this Presidency) recognizes only one class of stridhan and includes in that class all property acquired by a woman by inheritance, and if she has been married according to one of the approved forms, on her death childless, descends to her husband and his sapindás; but over stridhan acquired by inheritance her power of alienation is limited. So, too, in the latest case reported in Indian Law Reports (III. Bombay, 171) the Chief Justice (Westropp) held that the daughter had succeeded not to a qualified estate but to an absolute and several estate in her father's immoveable property.
- "6. On the other hand the rulings of the High Courts of Calcutta and Madras are quite opposed to the Bombay rulings, and have been entirely approved of by the Privy Council in Chotay Lall v. Chimno Lall (6 Law Reports Indian Appeals, 15). In commenting on Mr. Justice West's judgment the Chief Justice of the Calcutta High Court in this case pointed out that there was no substantial difference of opinion on the law between the Calcutta and Madras High Courts, and that they ought not to unsettle the law which had been received for the last fifty years on account of the opinion of a Judge of the High Court at Bombay, however learned he may be. The Privy Council observed that the question of the daughter's estate cannot be considered as 'res integra'; that the result appears to be that the Courts in Bengal and Madras have determined in a series of decisions that the daughter takes a qualified estate only, whereas in the Courts of Bombay there have been rulings and dicta in favour of the view that she takes the entire property. But 'their Lordships do not think it necessary, especially after their own decisions as to widows' estates, to go into an examination of the Indian cases. They agree in the conclusion of the Calcutta High Court affirming the law as stated by Sir William Macnaughton, that immoveable property acquired by a daughter by inheritance, on her death in default of issue male, goes not as stridhan to her husband or other heir but reverts to her father's heirs.'
- "7. It must be observed that this difference of opinion rests on a different interpretation of old and obscure texts. The original text of the Mitakshara, it is stated in the above judgment of the Privy Council, does not afford any foundation for the argument in favour of the right of the daughter to the entire interest in land acquired by inheritance, though the interpretation of the commentator, Vijnaneshvar, on which Mr. Justice West's reasoning rests, does. It seems, therefore, that there is a preponderance of decisions against the Bombay rulings. What would be the result of an appeal to the Privy Council from this Presidency it is not easy to say. Mr. Justice West observes that it is reasonable to suppose

that in such case his arguments would have much weight with their Lordships. In the Calcutta appeal, however, the Privy Council had an opportunity of weighing the Bombay rulings as they are carefully reviewed in the judgment of the Chief Justice Couch which was on appeal before their Lordships. The conclusion come to by their Lordships is that it was unsafe to open the question and unsettle a rule of inheritance affirmed by a long course of decisions.

- "8. The question of course now is whether Government should follow the law as stated by the Bombay High Court or as it is stated by the High Courts of Bengal and Madras, and recognize the female watandar's husband or his relative as having an hereditary interest in the watan.
- "9. In deciding this question it must be remembered that the Bombay rulings extend over a period of some twenty years and were laid down by Judges whose reputation for learning is beyond all question—Sir Mathew Sausse, Sir Joseph Arnould, and Mr. R. West, and have been followed and accepted as the law by the people of this Presidency. The Bengal and Madras rulings, though entitled to every respect, are not binding here, while the judgment of the Privy Council cannot be said to decide the question in its direct applicability to the people of this side of India,
- "10. On the next occasion of the question arising as it almost certainly will, the Bombay High Court Judges will have to decide it in the light of the Privy Council's decision, and it remains to be seen whether the High Court will adhere to its former view of the law as applicable to this Presidency or will alter it in accordance with the views of the Bengal and Madras Courts.
- "11. There is, therefore, no objection to the Bombay rulings being followed in the present instance, as it is clear the husband is otherwise fully competent to officiate as deputy for his wife. Government can safely leave it to the members of the original watandar's family on the death of the female representative watandar to contest with her husband or his relatives the question of the devolution of the watan estate now discussed.
- "12. In the case reported in the Indian Law Reports, Volume VI., Bombay Series, page 87, Bulákhidás v. Keshavlál, Mr. Justice Melvill says: 'In this Presidency, and especially in Gujarát from whence this case comes, the Vyavahára Mayukha is a principal authority, and on the strength of Chapter IV., Section 8, paragraph 10 of the Mayukha, it has become the established rule in this Presidency that daughters take by inheritance an absolute estate and not a limited interest as they would under the Mitákshara.' It seems from this remark that the interpretation of the Mitákshara which has been unhesitatingly adopted by the Privy Council must be accepted in this Presidency, but inasmuch as the Mayukha is a principal authority in this Presidency and more especially in Gujarát, we must fall back on the Mayukha which Mr. Justice Melvill declares to be a sufficient authority that daughters take not only absolute but several estates, and consequently, when not having any issue, may dispose of such property during life or may devise it by will."

Note 3.—If, in any such case, the rent, annuity, or remuneration is payable partly in money and partly in kind, and the money value of the portion payable in kind is not expressed, the registration fee will be charged at twice the amount of the ad-valorem fee chargeable in respect of the amount payable in money. And, if the rent, annuity, or remuneration is payable entirely in kind, and the money value thereof is not expressed, a fixed registration fee of Rs. 2 will be charged under Article iii.

Note 4.—If a patta or lease be given to a ryot, and the Kabuláyat or counterpart of such patta or lease be brought for registration at the same time as the patta or lease, the registration fee chargeable in respect of the two documents shall not be greater than the fee which would have been charged on the patta or lease alone.

XIV.—This license may be recalled by the Collector—

XV.—This license may be surrendered by the license-holder on his giving one month's notice to the Collector, and paying such fine not exceeding the amount of the duty for six months, or the loss caused to Government by such surrender, as the Collector way adjudge.

Should the Collector be satisfied that the reason for resigning the license is adequate, he may, with the sanction of the Commissioner, remit the fine.

XVI.—On the infringement of any of the above Articles or of any of the conditions imposed by the Opium Act, 1878, or by the Rules framed thereunder, this license and any other license or licenses that the holder may have obtained for the sale of opium, or for the manufacture or sale of any intoxicating drug prepared from the poppy, will be forfeited by will also be liable to the punishment prescribed by law for the specific offence committed.

APPENDIX A.

Government Notification No. 2365 of 8th May 1878:-

- His Excellency the Governor in Council is pleased to permit the direct importation of opium from Málwa into the Town of Bombay for retail sale in the said town by persons duly licensed there to retail opium subject to the following conditions:—
- (a). All opium so imported shall be subject to the rate of duty imposed, for the time being, on opium imported into the Presidency of Bombay for exportation by sea, and payment of the duty leviable thereon shall be made in accordance with the provisions of Rule 15 of the Rules under the Opium Act, 1878, for the payment of duty on opium intended for exportation by sea.
- (b). All opium so imported shall, on arrival at Bombay, be deposited either in the Government opium godown, or in the licensed shop of the licensed vendor importing the same.

[•]Notices in accordance with section 13 of the opium license Form E do not require to be stamped.

- (c). Opium deposited in the Government godown will remain there at the risk of the importer, who shall be at liberty to keep it in his own boxes and under his own keys and seals, and to remove it in reasonable quantities at a time to his shop as he requires it for use; but he shall not be entitled to have access to the godown except during office hours, nor without special permission from the Collector of Customs oftener than twice a week.
- (d). The quantity of opium to be removed from the Government godown shall on each occasion be presented to the officer in charge of the Opium Department of the Custom House for weighment and registration, and shall be covered by a pass in the Form C, attached to the Rules.
- 2. Licensed retailers in the Town of Bombay are further permitted to supply themselves with opium by purchase direct from wholesale dealers, provided that such purchase shall be by whole or half chest only; that the permission required by the proviso to section 10 of the Rules be in every case obtained; that the pass-port under which the opium was originally imported be produced before the Collector of Customs and Opium for endorsation and cancellation to the extent of the number of chests or half-chests purchased; and that opium so purchased be forthwith lodged in the licensed vendor's licensed shop, or in the Government godown for issue in the same manner as if it had been imported direct from Malwa by the licensed vendor.

APPENDIX B.

His Excellency the Governor in Council is pleased to rule that the Palanpur-Ahmedabad State Railway be the route by which alone opium from Baroda territory may be imported into the Bombay Presidency for transmission to the scales at Ahmedabad. All opium so imported shall be carried direct to the Government opium agency in the town of Ahmedabad—Government Notification No. 3340 of 29th June 1880.

APPENDIX E.

Resolution of the Government of India, No. 3689, dated 17th November 1879.

"Read the following telegram, dated 22nd October 1879, from the Agent, Governor General for Central India: —

'Collector Kistna issues passes unstamped to merchants for large quantity of opium to be imported from Indore. Merchants slip from Málwa with consignments evading scales and will often get away. This system will strengthen smuggling. No pass should be given for Málwa opium except through this office. If any Collector desires opium imported, requisition should be sent to Indore, not made over direct, as pass, by him to merchant.'

Resourtion.—Under several local rules and regulations, the import of opium from Málwa for local consumption is permitted under passes granted by Revenue Officers.

2. The Governor General in Council has resolved that no pass shall, in future, be thus granted excepting by the Opium Agent at Indore.

3. Officers desiring to authorize the import of Malwa opium, under sanctioned conditions, should accordingly address the Opium Agent at Indore, who will issue the required passes under such conditions, and with such precautions as he thinks necessary for the safety of the opium revenue which he supervises.

4. Each Local Government concerned will determine and inform the Opium Agent what officers are authorized to move him to issue passes under these orders."—Vide Government Notification No. 6465, dated 3rd December 1879.

- (b).—All opium so imported shall, on arrival, be deposited in the places specified below:—

Opium for Ahmedabad District—In the Stamp Depôt under the Huzúr Deputy Collector, Ahmedabad.

- (c)—Opium deposited as aforesaid will remain there at the risk of the importers, who shall be at liberty to keep it in their own boxes and under their own keys and seals, and to remove it to their shops at such times as the Collector may determine, and in such quantities at a time as they may require for use, not being less than the minimum quantity to be fixed by the Collector; they shall not be entitled to have access to the place of deposit except during office hours, nor without special permission of the Collector or other officer duly empowered by the Collector to grant such permission.
- (d)—The quantity of opium to be removed from the place of deposit shall on each occasion be presented to the officer in charge of the place for weighment and registration, and shall be covered by a pass in the Form C attached to the Rules.
- 2. Persons duly licensed to retail opium in any of the aforesaid two districts are further permitted to supply themselves with opium by purchase direct from wholesale dealers in Bombay, provided that such purchase shall be by whole or half-chest only, that the permission required by the provise to Section 10 of the Rules be in every case obtained, that the passport under which the opium was originally imported be produced before the Collector of Customs and Opium, Bombay, for endorsation and cancellation to the extent of the number of chests and half-chests purchased, and that the opium so purchased be forthwith transported to its destination and lodged for issue in the same manner as if it had been imported direct from Málwa.

Ordered, also, that this Resolution, together with the Statutes referred to in it, be published in the Supplement to the Gazette of India.

33 & 34 VICTORIA, CAP. 59.

An Act to render valid certain contracts informally executed in India.

[9th August 1870.]

Whereas by an Act passed in the twenty-second and twenty-third years of the reign of Her present Majesty, amending an Act passed in the twenty-first and twenty-second years of the reign of Her present Majesty, intituled "An Act for the better government of India," it was provided that any deed, contract, or other instrument made by the authorities therein named, for the purpose of disposing of real and personal estate in India vested in Her Majesty under the said last-mentioned Act, or of raising money on such real estate by way of mortgage, or of making proper assurance for that purpose, or of purchasing and acquiring any lands and hereditaments, or any interest therein, stores, goods, chattels, and other property in India, and of entering into any contracts whatsoever for the purposes of the said first-mentioned Act, may be expressed to be executed as on behalf of the Secretary of State for India in Council, by or by order of the Governor General in Council, or the Governor of Fort St. George or of Bombay in Council:

And whereas by an Act passed in the thirty-second and thirty-third years of Her said Majesty, it was recited that certain deeds had been issued for inam lands in the Presidency of Fort Saint George by the Inam Commissioner in the execution of his office in that respect, which, by reason of certain defects in the expression of the execution thereof, it was apprehended might be invalid; and provision was thereupon made by the said last-mentioned Act that the said title-deeds should not be deemed invalid by reason of such defects:

And whereas it is apprehended that other deeds, contracts, and instruments made for the purpose expressed in the said first-recited Act, besides such title-deeds as aforesaid, may be invalid or deemed invalid for the like reason, and such provision as aforesaid should therefore be made more general:

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same as follows:

Deeds, contracts, and instruments executed in India valid, notwithstanding certain defects of execution.

Council may deem it advisable to extend the operation of this Act, which is expressed to be executed by or by order of or on behalf of the Governor General of India in Council, the Governor of Fort Saint George in Council, or the Governor of Bombay in Council, or by any Lieutenant-Governor or Chief Commissioner, or any other officer for the time being entrusted with the government, charge, or care of any presidency, province or district of British India within the limits of their respective governments, provinces, or districts, and every deed, contract, or other instrument so executed in British India by any person authorised in this behalf by the Secretary of State for India in Council, shall be, and be deemed to have been as valid as if it had been executed in conformity with the provisions of the said first-recited Act; provided that such deed, contract, or other instrument has been in other respects duly executed according to the law in force at the date of its execution.

2. It shall be lawful for the Governor General, by Resolution in Council, from time to time to vary the form of the execution prescribed by the said first-recited Act for the deeds, contracts, and other instruments to which it relates, and to empower such anthorities as to him may seem expedient to vary it within the respective limits of their local jurisdiction; and deeds, contracts, and other instruments executed according to forms so altered shall have in all respects the like validity as if they had been executed according to the provisions of the said first-recited Act.

Government of India Act Amendment.
CHAP. 41.

An Act to amend the Act for the better Government of India.

[13th August 1859.]

Whereas an Act was passed in the Session holden in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, intituled An Act for the better Government of India: And whereas it has been considered that, under the Enactment in the Fortieth Section of the said Act, the local Governments in India and Officers intrusted with the Charge of Provinces or Districts there respectively cannot enter into and execute such Contracts and Assurances in India on behalf of the Secretary of State in Council as before the Commencement of the said Act they were respectively competent to enter into and execute on behalf of the East India Company, and it is expedient to give them such Powers: And whereas Doubts have arisen as to the proper Mode of the Execution of Contracts entered into by the Secretary of State in Council pursuant to the Provisions of the said Fortieth Section of the said Act, and it is expedient that such Doubts should be removed: And whereas it is expedient to alter so much of the Enactment in the Forty-third Section of the said Act as relates to the Mode of signing and countersigning the Drafts or Orders therein mentioned: Be it therefore enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows; that is to say,

Powers to execute Contracts vested in Government of India.

Governor of the North-Western Provinces now under the Presidency of Fort William in Bengal, respectively, or any Officer for the Time being intrusted with the Government, Charge or Care of any Presidency, Province, or District in India, subject to such Provisions or Restrictions as the Secretary of State in Council, with the Concurrence of a Majority of Votes at a Meeting, shall from Time to Time prescribe, are hereby respectively empowered to sell and dispose of all Real and Personal Estate whatsover in India for the Time being vested in Her Majesty under the said Act, within the Limits of their respective Governments, Provinces, or Districts, or to raise Money on any such Real Estate by way of Mortgage and to make proper Assurances for that Purpose, and to purchase and acquire any Land or Hereditaments, or any Interest therein, Stores, Goods, Chattels, and other Property in India, within the said respective Limits, and to enter into any Contracts whatsoever, within the said respective Limits for the Purposes of the said Act, and all Property so acquired shall vest in Her Majesty for the Service of the Government of India.

Mode of executing Contracts in Council may be named as a party to any such Deed, Contract, or other Instrument, and it shall be sufficient to use the Designation of Secretary of State in Council in such Deed, Contract, or other Instrument, and the same may be expressed to be executed on behalf of the Secretary of State in Council, by or by Order of the Governor General in Council, Governor in Council, Lieutenant-Governor of the North-Western Provinces, or other Officer intrusted as aforesaid, but may be executed in other respects in like Manner as other Instruments executed by or on behalf of him or them respectively in his or their official Capacity, and may be enforced by or against the Secretary of State in Council for the Time being; and neither the Secretary of State, nor any Member of the Council, nor any Person executing such Deed, Contract, or other Instrument, shall be personally liable in respect thereof; and all Liabilities, Costs, and Damages in respect thereof shall be satisfied and paid out of the Revenues of India.

APPENDIX.

Accounts.

- 1. Government Pleaders will draw their salaries, and their fees for criminal cases, and any special fees which may from time to time be sanctioned by the Remembrancer of Legal Affairs, or by Government, on submitting bills in the usual form to the proper Treasury Officer.
- 2. To enable them to meet the minor charges incident to the institution and conduct of the cases, whether civil or criminal, with which they are entrusted, the Government Pleader in the High Court shall be allowed a permanent advance of Rs. 500, and such of the District and Subordinate Government Pleaders as the Remembrancer of Legal Affairs authorizes to receive the same, shall be allowed each a permanent advance not exceeding Rs. 200. Only those Government Pleaders who have usually a large number of Government cases on hand shall be authorized by the Remembrancer of Legal Affairs to receive this advance.
- 3. Government Pleaders are to defray all the charges connected with each case as they arise, and to submit a bill for the same (and for their own fees in civil cases), as soon as possible, after each case has been other officer concerned in the case.

But when, as in the case of the Court-fee chargeable on an appeal in which the claim is for a large amount, a Government Pleader has to pay considerable sums out of pocket atonce, he may submit separate bills for such sums immediately, provided that the amount of any such bill shall not, in the case of the Government Pleader in the High Court, be less than Rs. 50, and of other Government Pleaders, Rs. 35.

A bill of charges submitted under the fist para. of this rule shall include the whole of the charges on account of the case for which it is submitted, and any sums which may have been already drawn on account of the case under para. 2 of this rule shall be shown at the end of the bill and deducted.

4. Every bill submitted by a Government Pleader under the last rule is to be forwarded by Legal Remembrancer.

Bills to be examined by Legal must be accompanied by vouchers, or by a copy of the Court's decree in support of every item contained in it.

The Remembrancer of Legal Affairs shall, if he passes the bill, countersign and forward it to the officer by whom it is to be paid. The Remembrancer of Legal Affairs is responsible for curtailing unnecessary, or exorbitant charges, and generally for controlling all expenditure incurred by Government Pleaders.

- 5. Postal and other general contingent charges may be drawn by the Government Contingent bills of the Government Pleader in the High Court on bills countersigned by the Remembrancer of Legal Affairs according to the rules in force for payment at the Presidency.
- 6. The Judges of the Courts to which District and Subordinate Government Pleaders are respectively attached, are authorized to cause their letters and packets to be franked as if they issued from their own offices, and also to pay any bearing charges on official covers which they may receive. The Government Pleaders shall be responsible that such letters, packets, and covers are bona fide despatched, or received, on Her Imperial Majesty's service only. District and Subordinate Government Pleaders shall not incur any contingent expenses apart from the necessary charges connected with the cases which they have to conduct.

- 2. The notices required to be issued under Sections 12 and 26 shall be in the Forms A and B appended to these Rules.
- 3. Every Manager appointed under Section 6 of this Act should make the enquiry prescribed by Section 12, and shall prepare the schedule of debts and liabilities, and the scheme for the settlement thereof required by Section 17 in the following manner.
- 4. He shall ascertain the principal sum or sums originally or from time to time lent by each of the creditors severally, and this sum or these sums, with 9 per cent. per annum simple interest from the time when the debt was incurred up to the date on which the order provided for in Section 8 of the Act is published, and no further, shall in each case be the amount awarded, but subject to the following conditions:—
 - I.—The amount of interest shall in no case exceed that of the principal.
 - II.—The heir in the second generation of the person who originally incurred the debt, to pay the principal only and no interest.
 - III.—The amount assigned in settlement of bonds held for services rendered by the creditor to be determined by the Manager after hearing evidence of the service in question.
 - IV.—No interest to be allowed on debts whose accounts to the satisfaction of the Manager are not produced.
 - V.—When the first principal is not satisfactorily proved, a deduction of 50 per cent. to be made from the amount of the debt as it stands at the first stage at which satisfactory proof of the existence of the debt is given.

 - VII.—Interest not to be allowed on account of debts in the absence of any specification that it shall be allowed.
 - VIII.—A claim supported by a decree of a civil court shall be subject to the same enquiry as any other claim; but in cases where it shall appear to the Manager that the suit was contested, and

that the amount awarded either on account of principal or interest by the decree does not exceed by more than 25 per cent. the amount which could have been awarded by the Manager, if no such decree had been passed, the amount so awarded may be allowed, provided rule 4, clause 1, be not infringed. But if interest subsequent to decree be claimed, it shall be calculated as if no decree had been passed.

- 5. All payments made by the Jágirdár or Zamindár to any creditor, or profits which have been enjoyed by such creditor towards the liquidation of any debt or liability before the settlement under the Act, shall be deducted from the principal sum of the said debt or liability, and interest on an amount equal to such deducted sum shall be disallowed from time of such payment or enjoyment, and the Manager shall be competent to decide on the amounts of profits realized under such enjoyment after examining such proofs as are presented to him.
- 6. Whenever a bond or decree or other claim has been transferred by sale, gift, or otherwise from the criginal holder to any other person, the present holder shall be called upon to support his claim, by the same proofs as if he were the original holder.
- 7. All admitted debts shall be satisfied proportionately in the following order:—

1st.—Money lent on the security of the estate.

2nd.—Decreed and bonded debts.

3rd.—Account debts.

- 8. If the principal of all the debts with simple interest at 9 per cent., shall exceed the amount which may be estimated to be available for the settlement of the creditors' claims as provided for in Section 11 of the Act during the period the estate shall be under management, then no interest shall be allowed on such debts as were not incurred by the present Jágirdár or Zamindár. If the amount be then still in excess of the aforesaid amount, the rate of interest to be awarded on the remaining debts shall be decreased until their amount falls within the requisite limit. For the purposes of calculation under this rule, (20) twenty years shall be taken as the limit of the period of management.
 - 9. In deciding what claims are admissible for settlement, and to what amount they shall be admitted, it shall be competent to the Manager to appoint a Committee of experienced Natives—consisting of three persons, of whom one only shall be in the service of Government—to assist him, and it shall further be competent to the Manager to reimburse the said Committee for their necessary expenses out of a percentage to be reserved on the rents and profits which the Manager may receive to cover all charges arising directly from the special nature of his duties.
 - 10. Provided, however, that if the creditors of any estate shall of themselves produce a schedule of the original sums lent by them severally signed by

the debtor, and both parties shall consent to the said schedule in presence of the Manager, it shall be competent to the said Manager to accept such schedule without further investigation, and to make it the basis of the settlement.

If the creditors shall agree to accept a sum of money from the Manager in immediate satisfaction of all their claims on any estate, and the Manager shall determine to borrow money from Governmentfor the purpose of meeting such payment, it shall be competent for the Manager, on receipt of the orders of the Commissioner in Sind sanctioning such loan, to order payment to be made to the creditors from the Government Treasury, provided that the creditors shall first severally sign receipts in full for all their claims on the estate, and that if any fraud is subsequently discovered to have been committed by any creditor, in respect to any money received by him under this rule, such creditor shall be liable to forfeit all sums so received, and all claim to further compensation for any debt due to him which may have been notified to the Manager for satisfaction under this Act. And all sums advanced by Government under this rule, shall be recovered from the estate in the same manner as other debts due, or liabilities incurred, to the Crown or Government may be recovered under this Act.
- 12. In estimating the amount of cash composition to be paid for admitted claims, the following points should be considered:—
 - (a).—The income of the debtor, the amount of the debt, and the probability that the creditor would have been able to recover his debt if this Act had not been passed.
 - (b).—The nature of this particular debt.
 - (c).—The period for which the debt had been outstanding.
 - (d).—The interest hitherto enjoyed by the creditor, the rate of interest originally fixed, and the proportion between the amounts due as principal and interest, respectively, at the present time.
- 31. Advances made with the object of facilitating the settlement of the claims against any Jágirdár or Zamindár's estate brought under the provisions of the said Act shall, when the Commissioner in Sind shall so direct, be chargeable with interest at the rate of (5) five per cent.
- 14. When the condition of an estate shall be found sufficiently prosperous, it shall be competent to the Commissioner in Sind to make such further awards beyond what is permitted by the previous rules as the circumstances shall seem to warrant.

THE FOLLOWING RULES ARE MADE BY THE GOVERNOR OF BOMBAY IN COUNCIL UNDER THE PROVISIONS OF SECTION 63 OF THE DECCAN AGRICULTURISTS RELIEF ACT, 1879, IN SUPERSESSION OF ALL PREVIOUS RULES ON THE SAME SUBJECT.

Rules regulating the appointment, suspension, dismissal and remuneration of District Inspectors and Village Registrars.

1. Every Inspector shall be appointed by and may be suspended or dimissed by the Inspector-General of Registration and Stamps; but shall not be dismissed without the sanction of Government being first obtained.

2. Every Village Registrar not being a Sub-Registrar shall be appointed by and may be suspended or dismissed by the Registrar; but shall not be dismissed except with the concurrence of the Inspector-General: provided that the first appointments of Village Registrars made after the publication of these Rules, shall be made subject to the approval of Government.

3. In addition to any fixed salary all Táluka
