INTRODUCTORY NOTE

The Revised Indian Trade Classification, 1965 (RITC) which is based on the standard International Trade Classification (SITC), Revised of the United Nations is in vogue since April 1965. It comprises nearly 5000 articles with 7-digit codes retaining the framework of the SITC—Revised up to the 5-digit item levels. The list is common for imports, exports and re-exports. Thereafter several proposals for changes in and additions to the list have been received from the trade as well as from Government Departments. Only in special cases, however, the desired amendments in the classification were carried out.

With the later developments and increasing diversification of the country's foreign trade and industry it has become necessary to revise the present RITC again keeping in view the current requirements of various Government Department, Export Promotion Councils, Chambers of Commerce and other important trade and industrial organisations in the country. Meanwhile the U. N. Statistical Office has amended SITC—Revised again in May, 1975 because of (a) the marked improvement in the international comparability of external trade statistics which has resulted since 1960 from the implementation by Governments and International Agencies of the Standard International Trade Classification—Revised, and (b) action taken by the Customs Co-operation Council to maintain the correspondence of its Brussels Tariff Nomenclature (BTN) with the SITC. The new UN trade classification is called the Standard International Trade Classification (SITC)—Revised 2. With a view to conforming to international practice, it has been decided to revise the Revised Indian Trade Classification (RITC) also on the basis of SITC—Revision 2. Accordingly the new Indian Trade Classification—Revision 2 has been drawn up and its framework at the levels of Sections and Divisions is same as in the old classification. In evolving individual commodity specifications, the 5-digit codes of the SITC—Revision 2 have also been fully adopted and each is subdivided into 7-digit headings according to current requirements of the country's trade and industry.

2. In cases where no sub-divisions after 4 or 5-digits (sub-group and item) levels of the SITC—Revision 2 have been made, the description of the articles has been repeated with 7-digit code (*i.e.* by adding 3 or 2 Zeroes as necessary). Relevant BTN Code Nos. have been shown against respective 4 or 5 or 7-digit Codes Nos. of the new classification. In a few cases, deviation from the SITC—Revision 2 have to be made to satisfy national needs. In those places, however, adequate indications have also been given so that there may not be any difficulty in correlating those headings with the corresponding SITC—Revision 2 items. For some articles, where a more detailed breakdown is required, new code nos. have been allotted for the concerned sub-group or item of the SITC—Revision 2. In all such cases blank spaces of the SITC—Revision 2 have been utilised.

The new classification contains 10 sections which are divided into 63 divisions as in the case of the previous RITC. These divisions are sub-divided into 239 Groups, as against 184 in the old RITC. These 'Groups' in the new classification have further been divided into 793 'Sub-groups' (4-digit level). Out of these sub-groups, 452 have been broken up into 1658 items, (5-digit level), 944 of which have been further split up into 4693 commodities (7-digit level). The total number of commodities separately specified in the ITC—Rev. 2, is 6660 (*including* 132 undivided sub-groups and 714 undivided items).

To facilitate proper classification of different commodities entering in the foreign trade of India, explanatory notes have been given at the beginning of each section.

An Alphabetical Index to the new classification (ITC. Rev. 2) covering all the commodities specified therein has been published separately as a special supplement to the Indian Trade Journal, dated 6th July, 1977.
