N O T E

The collection of Shri Gopal Krishan Gokhale (1866-1915) has been acquired by the National Archives of India, <sup>on the basis of</sup> ~~quest~~ permanent loan ~~from~~ from the Servants of India Society, Poona. Any quotations from these papers should be suitably acknowledged.

The papers, which cover the period 1889-1915 fall into two broad categories-letters written by Shri Gokhale and letters received by him. The number of the papers in the former group is smaller as Gokhale did not keep the copies of all the letters written by him. There are about 372 letters <sup>380</sup> and notes etc. written by Gokhale and these have been kept in File No.203(Parts one to five) of this list.

The rest of the collection comprises ~~A~~ letters received by Gokhale from eminent men like Sir W. Wedderburn, A.O. Hume, Dinshaw Wacha, Dadabhai Naoroji, S.N. Bannerjee, Pherozeshah Mehta, M.G. Ranade, R.C. Dutt, S.P. Sinha, G.V. Joshi, Bhupendranath Basu, Rabindranath Tagore, Motilal Ghose, Lajpatrai, R.N. Mudholkar, Sarojini Naidu, Aga Khan, Tej Bahadur Sapru and many other distinguished contemporaries.

Apart from the correspondence mentioned above, there are some subject files, that is, collections of papers on subjects like, Apology Incident (File No.12), Congress Compromise, (File No.119), Elementary Education Bill (File No.174), Indian Struggle in South Africa (File No.242) Islington Commission (File No.243), Political Testament (File No.428) etc. and some Diaries of Gokhale.

The entire collection has also been microfilmed in fourteen rolls. The number of files covered by each roll are as given below:
