

Incidence and extent of infestation of insects on stored food grains.

## FOREWARD

A large part of available information on agriculture, is usually to be found on government records. The difficulties and delays in their computation and publication are to be faced by almost all institutions and authors. In order to overcome this difficulty, Department of Agriculture has decided to cyclostyle them in the present form. This is the first of the series of such bulletins to follow. These bulletins- it is hoped- will make available information on agriculture in Gujarat State in the snortest possible time.

Many exaggerated reports of damage by insects and rodents to food grains have appeared in recent past. Persons connected with research and extension education of Plant Protection were not perturbed at such unwarranted, publicity conscious reports; but at the same time, they were keen to assess it on a scientific basis. The present bulletin is a result of such desire. More than anything else, this bulletin should set at rest, wild speculation incidental to exaggerated reports. Further, the bulletin will have justified its publication if it enables general readers to understand how scientific surveys are essential to know, hitherto ill-defined area of knowledge.

This survey is a work of many individuals. It is the result of collective efforts by the starf of the State Agricul--tural Entomologist, & statistical section of Department of Agriculture, whose efforts are greatly appreciated.

## THE INCIDENCE AND EXTENT OF INFESTATION ON FOOD GRAINS STORED BY THE CULTIVATORS IN GUJARAT STATE, YEAR, 1966.

In recent past considerable attention has been paid and public awareness created with regards to losses of food grains. Though, as in all agricultural products, insects take away a portion of man's efforts, the actual losses on this account have not been accurately assessed. The figures have ranged between wide extremities.

The introduction of grain rationing after World War II and consequent responsibilities of Government for storage of grains led to the necessity of its protection in scientific manner. The steps being taken to prevent such losses have led to minimising losses in storage. Such operations are regular features in Government godowns. However, the scientific storage and pest control measures for grains stored by farmers have not yet extended to farmers, who also store grains to considerable extent. It is also observed that farmers and consumers in Gujarat do take considerable care of their grains by traditional methods, however this observation may be true for certain categories only.

In absence of statistics and many exaggerated reports being circulated, Government of India appointed a committee to assess losses of food grains during post harvest handling and storage.

It was reported by the said committee that during storage, losses due to insects account for the maximum loss. The said committee worked out loss on the basis of loss in the food value. Quantitative loss caused by insects was quantamised on the basis that each kernel damaged by insects has lost on an average, half the food value. The committee felt that the insect damage varies between slight to considerable and the portion of remaining kernel has sizeable food value. The losses in various food grains due to insects in storage reported by the said committee are presented here below:-

In order to assess the insect infestation, the Department of Agriculture, Gujarat State conducted a survey in 1966. Since the objective was to creat a factual base for extension work in farmers, home, the survey was confined only to storage by farmers. The observations were confined to extent of infestation by weight and number of grains. Attempt was also made to assess incidence in relation to period of storage, and methods of storage used.

<u>Sampling Plan:</u> Sampling design adopted was one of two stage stratified random sampling with taluka asstratum, village in the taluka as a primary unit of sampling and a cultivator in the selected village cultivating more than 10 acres of land as an ultimate unit of sampling.

To keep the work load to managable size it was decided to select 5 villages from each of the talukas and from each selected village in the taluka, two cultivators were selected. The selection of villages in the taluka and the cultivators in the selected villages was done according to simple random

sampling method.

Organization of the field work:- The field work actually consis--ted of visiting the selected villages, selection of two cultivators cultivating 10 acres or more than 10 acres of land and drawing two samples of the grain stored for each type of grain. Instructions were issued to have one sample from the upper layer and the other sample from the bottom layer from the grains stored by the selected cultivators.

The field agency comprised of agricultural supervisors working in different schemes in the State viz:(i)Improvement of Agricultural Statistics, (ii) Special Supervisory cneck on Cotton, (iii) Cotton Development Scheme (iv) Oilseed Extension Scheme and (v) Tobacco Extension Scheme.

All the field workers were instructed to fill up the requir--ed prescribed schedules and send the samples of grains drawn in a fashion explained earlier, to the agricultural entomologist, Junagadh for identification of the stored grains pests and determining the percentage damage.

Necessary training was imparted at two centres viz:(i)Baroda and (ii) Junagadh wherein the field staff was trained in the conduct of the survey. The columns of the schedules were explained in detail so as to avoid ambiguity on any of the items.

The field starf was instructed to visit the selected villa--ges twice in a year. Once for the Knarif-stored food grains and second time for the rabi-stored food grains.

In all 1830 cultivators were selected from 915 villages for collecting required information and stored food grain samples. As against this information in the prescribed schedules could.

be collected from 970 cultivators from 915 villages. Thus percentage response works out to be 53%.

Samples could be collected irom 53% of the planned villages for Knarif crops while samples for rabicrops could collected only 7% of the villages. Due to unfavourable seasonal conditions during the year, failure of c-rops was extensive and hence cultivators did not have grains stored with them, which seems to have resulted in less number of total samples drawn. The samples of food grains were analysed for determination of pests responsible for the damage and percentage damage in relation to the period of storage.

### Discussion of the Results: -

The percentage damaged grains for grains stored for varied periods in respect of food grains, are shown in table No.1.The number of samples analysed for Bajri, Jowar, Wheat, Paddy and Maize were 1116,661,1075,245 and 83 respectively.

In case of Bajri the period of storage was considered from November onwards. Out of 1116 samples analysed as many as 13.71% as old as 18 months. 12.37% of the samples were of the samples werg to months old while only 0.5% of the samples were four months old. It can thus be seen t -hat Bajri grains are stored for periods ranging from 4 months to 18 months

and normal storage can be said to range from 5 months to 10 months.

In case of Jowar, the period of storage varies from 3 months to 19 months. However, in majority of the cases this period ranges from 3 months to 15 months. In as many as 17.55% of the cases, Jowar was stored for 15 months while in 16.79% of the cases it was stored for 11 months.

In case of Paddy, storage period varied from 6 months to 18 months and out of 245 cases, 51.84% of the cases and was stored for a period of 15 months, while in 28.16% of the cases it was stored for a period ranging from 11 months to 13 months and in 17.55% of the cases it was stored for a period ranging from 11 months to 13 months and an equal quantity was stored for a period ranging from 6 months to 9 months.

In case of Wheat, 1075 samples were examined and it was observed that, it is stored for a period ranging from 2 months to 16 months. In 28% of the cases storage period ranged from 2 months to 5 months, while in 31.72 % of cases it is found to have been stored for the period ranging from 6 months to 10 months while in 40.28% of the cases it is stored for the period ranging from 11 months to 16 months.

An attempt is also made to study whether the extent of damage and period of storage are associated or not. As can be seen from table No.2 period of storage and damage are positively correlated. In case of Bajri, Jowar and Wheat, the co-efficient of co-rrelation is highly significant, while for Paddy co--efficient of co-rrelation is non significant. This can be due to smaller number of samples collected and analysed.

This finding supports the common belief that the damage to stored grains varies in proportion to the period it is stored. <u>Mode of storing:-</u> The percentage grains stored in various cont-ainers is shown in statement No.3. It can be seen that storing the grains in earthen jars is the most common mode of storing grains. Storing in gunny bags ranks second. 78.47% of Mung grains and 85.40% of Math grains are stored in earthen jars, while 21.53% of Mung grains and 14.60% of Math grains are stored in gunny bags. Thus it can be said that for Mung and Math grains storing in earthe -n jars and gunny bags are the most common mode of storage. In case of Wheat grains 48.44% of the stored grains are stored in earthe -n jars while 25.61% are stored in gunny bags Metal containers and wooden bins are also found to have been used for storing 8.43 and 9.58% of the stored Wneat respectively.

In case of Paddy 51.59% is stored in earthern jars, while 14.29% and 18.70% are stored in tin jars and wooden bins respecti -vely. 9.81 and 2.18% are found to have been stored in "Palas" and Bamboo jars respectively.

In case of Bajri 64.01% stored in earthe-n containers and in 18.90% of the cases gunny bags are used. Metal containers and wooden bins account for 2.51 and 5.6% respectively.

In case of Jowar, storing in earthen jars, gunny bags and metal containers are the popular modes of storage and they account for 52.01%,27.64% and 13.00% of the grains stored respectively.

Major stored grains pests causing damage:- Percentage of samples of various stored food grains affected by different stored grains pests are shown in table 4. It is observed that Lesser grains bo rer is found to nave been present in 37.76% of the samples

of Bajri ,26.73% of Wheat. samples, 47.67% of Paddy samples,21.38% of /Rice samples and 33.43% of the Jowar samples. While Lesser grain. bo-rer and Rust red flour beetle are jointly found in 17.20% of of Bajri, 10.88% of Wheat, 5.81%/Paddy, 25.16% of Rice, and 9.59% of the Jowar samples. Lesser grain borer is observ-ed in combination with (i) Rust red flour beetle (ii) Rust red floor beetle and Rice weevil (iii) Rice weevil (iv)Saw toothed grain beetle (v) Pulse beftle (vi) Flea beetle and (vii) Angunmois grain mo-th in varying proportions. Lesser grain borer in combination with Rice weevil moth was noticed in 3.46% of Bajri 7.47% of Wheat, 3,88% of Paddy, 7.55% of Rice and 9.74% of

--- Jowar samples. It was also observed that 32.89% of Bajri samples, 47.37% or Wheat samples, 37.21% or paddy samples, 13.84%of Rice samples, 25.29% of Jowar samples and 5.63% of Math samp= -ples were free from presence of stored grain pests. In case of Rice, Rice weevil Rust red flour beetle, Saw toothed grain beetle were jointly observed in as many as 16.98% of the samples. Preventive measures: - Extent of various types of preventive measures being adopted by cultivators for preserving stored grains is shown in statement No.5. It is observed that in case of 48.86% of Bejri grains stored, 61.31% of Wheat grains,54.57% of Rice and Paddy grains, 64.57% of Jowar grains, 46.96% of Mung grains and 76.78% of Math grains no preservatives are used by while for the remaining, the cultivators the cultivators Luse Ash, Neem leaves, Kitox poweder, Washing soda, Castor oil and Tamarind leaves. Other types of preservativ--es were also found to have been used but the proportion seems to be negligible. Of all the preservatives used, the use of ash appears to be very prevalent. Ash is found to have been used as a preservatives in 31.32% of Bajri samples 1.17% of Rice, 6.76%

of paddy, 8.72 % of Jowar 47.59% of Mung and 23.22% of Math samples while BHC.was used in 6.14% of Bajri 12.47% of Wheat and 6.67% of Jowar samples.

Use of Neem leaves as a preventive measure seems common. As many as 13.87% of farmers use Neem leaves for the Rice or Paddy grains. Boric powder and Castor oil were also found to have oeen used for storing of 2.32% and 3.42% respectively of Wheat grains, 2.52% and 7.47% for Rice or Paddy grains respectively. The percentage of total production of grains used for seed, home consumption and male is shown for various crops in table No. 6.

It appears that as much as 67.80% of the production of Bajri crop is used for home consumption by cultivators and from the remaining 32.20% of the grains 4.92% is meant for seed purpose and 27.28% is sold in the market. In case of Paddy the pattern is similar to Bajri but a higher percent (5.60%) is kept for use as seed and 26.41% is for sale. In case of Wheat the pattern is slightly diffetent in as much as 11.19% is kept aside for seed, 62.61% is for family consumption and 26.20% is available for sale in the market. In case of Jowar crop as much as 74.81% is used for home consumption while 7.06% and 18.13% are ment for seed & sale respectively. In case of Mung and Math the pattern differs videly and a much larger proportion (62.25% and 44.94%) is sold in the market and comparatively lesser quantities/(32.58% and 46.60%) used for home consumption. While the quantity kept aside for seed constitutes 5.17% & 8.46% of the quantities stored. Conclusion \_\_ Damage to grains by insects and period of storage are positively correlated. The rate of increase in percents of grain damaged per month is maximum in case of Bajri, it being

0.7% for every additional month's storage, while Jowar ranks Wheat it is 0.23%. The average % of second with 0.5% rate. In case or incidence is 4.64% for Bajri, 3.77% for Jowar, 2.03% for Wheat and 0.71% for Paddy. In case of Maize it is as high as 9.84%.

As regards stored grains pests, Lesser grains borer is found to be most common.

As for pattern of disposal of grains on an average 7.06% of the production is kept aside for seed incase of Bajri and Paddy while in case of Pulses 5.81% is kept aside for seed. In case of Wheat it is 11% so far marketable quantity is concerned, it is about 26% to 27% in case of Bajri, Wheat, and Paddy, while it is 62.25% and 44.94% in case of Mung and Math respectively.
