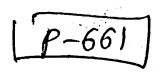

1 Introduction:

The agricultural sector of India has grown up considerably since independence. Upto mid-sixties, owing to various constraints, not only low value crops were dominating in the cropping pattern but production and productivity of crops were also very low. The situation has totally changed after the introduction of Green Revolution in Indian agriculture, which was introduced during the mid-sixties. While the production of foodgrains has increased from 72.35 million tonnes in 1965-66 to 211.17 million tonnes in 2001-02, a similar kind of trend is also noticed in the production of commercial crops like oilseeds, cotton, sugarcane, etc. Constructive policies/programmes introduced by the central and state governments during different plan periods have been considered as one of the main reasons for the substantial improvement in the production of various agricultural commodities.

While the growth oriented policies introduced by the government have been continuing though with some modifications across plan periods, the overall growth rate of agriculture has decelerated during the nineties as compared to the eighties at all-India level owing to certain constraints. As rightly mentioned in the National Agriculture Policy: 2000, "The pattern of growth of agriculture has, however, brought in its wake, uneven development across regions and crops as also across different sections of farming community and is characterised by low levels of productivity and degradation of natural resources in some areas. Capital inadequacy, lack of infrastructural support and demand side constraints such as controls on movement, storage and sale of agricultural products, etc. have continued to affect the economic viability of agricultural sector". agricultural growth plays a crucial role in improving rural employment and reducing rural poverty, the slow growth of agriculture has been a matter of concern among the policy makers in the recent years. In addition to our own domestic constraints, the problems arising out of WTO commitments and the influence of international policies pose a lot of challenges to the agricultural sector of the country than ever before. In view of the new policy changes that are taking place in the domestic and international front, there is a need to make some adjustments in the agriculture policy of the country/state to sustain the growth of

agriculture as well as to face the competition arising out of WTO commitments. Though the National Agriculture Policy: 2000 has underlined what needs to be done to improve the performance of agricultural sector for the country as a whole, not many states have attempted to formulate its own agriculture policy based on its strengths and weaknesses. It is in this context, in this study, an attempt is made to formulate agricultural policy for the state of Maharashtra keeping in view its strength and weaknesses.

2 Issues in Maharashtra's agriculture:

Though Maharashtra is one of the richest states in terms of per capita income, its agricultural performance is not very appreciable. Having accounted for about 12 percent of India's gross cropped area in 2001-02, the contribution of state's agriculture in the agricultural GDP of the country is only about 7.30 percent during the same year, mainly due to predominant cultivation of crops under rainfed condition and low productivity of crops. Keeping in view the importance of agriculture, the government of Maharashtra along with the support of Central government has taken a number of initiatives to improve the performance of agriculture over the years. As a result of initiatives taken by the government, the agricultural sector of Maharashtra has undergone lot of changes. But, still it is lagging behind in many parameters as compared to the national average because of various constraints (see, Table 1). The main problems faced by the agricultural sector of the state are:

- Low irrigation facility
- Low and erratic rainfall pattern
- Cultivation of crops predominantly under rainfed condition
- Improper distribution of irrigation water among different crops
- Predominant cultivation of low value crops
- Low productivity of different crops
- Mono-cropping pattern
- Low progress in Watershed Development Programme
- Wide regional variation in the development of agriculture
- Poor marketing and post harvesting facilities

Most of the problems mentioned above are one way or the other associated with the limited availability of irrigation. Despite giving substantial importance, both in terms of investment and policy input for the development of irrigation, the share of irrigated area to gross cropped area is only about 17 percent as of today. The low irrigation facility has been one of the serious problems of the state. Due to low irrigation facility, not only low value crops are cultivated predominantly in the state but the productivity of most of the crops are also very low as compared to the national average. Cultivation of low value crops coupled with the low productivity of crops reduces the income of the farmers, which adversely affect the standard of living of both farming and non-farming (landless agricultural labourers) rural communities.

The second major issue is related to crop pattern and productivity of crops. Because of low irrigation facility and wide variation in rainfall, farmers are forced to cultivate low value crops (coarse cereals and pulses) predominantly under rainfed condition. About 83 percent of cultivated area is under rainfed condition as of today. Since rainfed crops are generally affected by varied rainfall (moisture stress), productivity of different crops is very low in the state as compared to the all-India average. Mono-cropping pattern (example, sugarcane) followed in certain regions of the state has also affected the productivity of crops, which is another important issue of Maharashtra's agriculture.

The third important issue in Maharashtra's agriculture is poor growth of agriculture, which is the main outcome of low irrigation and productivity of crops. Though significant development has taken place in horticultural sector during the last decade, it has not made any significant impact on the overall growth rate of agriculture. While the share of agricultural sector's contribution to state's income declined from 34 percent in 1960-61 to 16 percent in 2001-02, the growth rate of the agricultural sector (state domestic product) decelerated from 3.70 percent per annum during eighties (1980-81 to 1990-91) to 2.72 percent per annum during nineties (1990-91 to 2001-02). The slow growth of agriculture is a serious issue from the point of view of rural employment and poverty, both of which are heavily dependent on agricultural growth.

The other important issue associated with Maharashtra's agriculture is poor marketing and post-harvesting facilities. Besides the domination of middlemen, it is predominantly traditional and does not have strong network of post-harvest services and infrastructural facilities. As result of this, not only the wastage is substantial but the losses are also enormous for farmers. Concerted efforts are needed to improve the marketing facilities.

In addition to the existing problems, the newer issues arising out of WTO commitments are further expected to pose different kinds of problems to the agricultural sector of the state. How to improve the growth of agriculture with these constraints? What are the areas in which government should focus mainly in the future? Is there any relationship between the policies introduced by the government and development of agriculture? What are the major constraints that limit the growth of agriculture in the state? Whether the government has taken initiatives to face WTO commitments? are some of the important issues which need to be studied thoroughly to make a proper agricultural policy that can be implemented for improving the performance of agricultural sector in the state. Keeping in view the issues raised above, the present study makes an attempt to formulate an agriculture policy for the state of Maharashtra by taking into account the policy inputs followed for the development of agriculture over the last forty years.

3 Objectives:

1. To review the available materials (including policy documents, five year plan documents at the center and at state level, policy statements

made at the state level, etc.) at the state level dealing with policy interventions after the formation of the state.

- 2. To identify the important constraints and review the efforts made by the State in the past to meet major challenges pertaining to agriculture and allied activities.
- 3. To record the state's response to the already formulated National Agricultural Policy, that is, to find out precisely how and where the state would like to suitably supplement, modify and re-articulate the National Policy in the local context.
- 4. To bring out the state's concerns as well as to record the state's views on the changing economic situation due to India's involvement with the WTO.
- 5. To assemble these views in the form of a meaningful policy requirement matrix, relating problems/issues to action points suggested/recommended.

4 Data and methodology:

This study has been carried out mainly using available secondary level information. The coverage of the study period is from 1960-61 to 2001-02. Data for this study have been mainly compiled from various five year plan documents (both centre and state), various committee and commission reports, Season and Crop Report of Maharashtra State (various issues), Districtwise Agricultural Statistical Information of Maharashtra State, Economic Survey of Maharashtra and India, various documents published by the Ministry of Agriculture, Government of India, New Delhi, http://agricoop.nic.in, http://agri.mah.nic.in, http://www.censusindia.net, etc. Recent data on Maharashtra's agricultural development have been directly compiled from the Commissionerate of Agriculture, Government of Maharashtra, Pune.

In order to understand the performance of the state's agriculture, a thorough analysis has been carried out on irrigation development, input use, cropping pattern, production and productivity of different crops using data from 1960-61 to 2001-02. One of the objectives of the study is to review the initiatives taken by the government during different plan periods to improve the performance of agriculture. For this, a detailed review has been done using the information collected from different five year plan documents, economic survey of the state, etc. A number of constraints which limit the growth of agriculture in the state over the last four decades. While highlighting the major constraints of Maharashtra's agriculture, the measures taken by the government to remove the constraints have also been presented using the information gathered from different plan documents.

5 Organisation of the study:

The study has five chapters. Chapter one, which is an introduction, presents a brief account on experience as well as emergence of agriculture policy in India, the major issues in Maharashtra's agriculture, objectives and methodology of the study. Chapter two deals with agricultural development of the state, wherein plan expenditure on agriculture and irrigation, workforce in agriculture, landholdings, rainfall, irrigation development, inputs use, land use pattern, cropping pattern, horticulture sector, production and productivity of crops and livestock sector of the state have been discussed in detail. Chapter three presents a detailed review on the initiatives (programmes) taken by the state government to improve the performance of agriculture since the third plan period. Important programmes introduced by the government have also been discussed in the same chapter. Chapter four brings out all the major constraints faced by the agricultural sector of Maharashtra. Chapter five presents the agricultural policy for Maharashtra's state including a policy matrix, which provides the strategies to be followed to improve the overall performance of the agricultural sector.

6 Agricultural policy for Maharashtra state:1

The policies that need to be followed in different areas of agriculture in Maharashtra state are presented below. Detailed policy matrix is presented in Appendix I.

6.1 Investment in agriculture and allied activities:

Adequate investment in agriculture is one of the pre-requisites for increasing as well as sustaining the growth of agriculture. However, the plan expenditure on agriculture and allied activities to the total plan expenditure has declined sharply from 30.87 percent in the third plan (1961-66) to 4.98 percent in the ninth plan period (1997-2000) in Maharashtra. Since the reduction in plan expenditure will affect the research and development activities pertaining to agricultural sector, it will have serious implications on the agricultural growth of Maharashtra in the future. Therefore, the state government (state planning commission) should take necessary steps to increase the plan expenditure on agriculture and allied activities to boost the growth of agriculture in the state.

¹ The study investigated various parameters of agricultural development, reviewed the programmes introduced by the government during different plan periods and also brought out the major constraints that hinder the growth of agriculture in Maharashtra. However, since the ultimate aim of the study is to formulate an agricultural policy for the state of Maharashtra, in this summary report we have presented only the major strategies that need to be followed for improving the performance of agriculture. Needless to mention that the strategies mentioned here are obviously emerging out from the analysis. Readers are advised to refer the main report of the study for detailed discussion on the various aspects of agricultural development in Maharashtra.

6.2 Irrigation development:

Low irrigation facility has been one of the major reasons for the poor performance of the agricultural sector in the state. Though Maharashtra state accounted for about 17 percent of India's total irrigation investment at the end of ninth plan period, its irrigated area to gross cropped area is only 16.38 percent in 2001-02, which is the lowest among the major states in India. In fact, out of 29 districts, 14 districts are having less than 15 percent of irrigation facility in 2000-01. The following strategies need to be followed to increase the irrigation facility First, adequate funds should be allotted to complete all the ongoing projects. If required, no more new projects should be sanctioned till the completion of all the on-going projects. Second, inspite of water scarcity, nearly two-third of irrigation water available in the state is used only by sugarcane crop, which accounts for only 2.60 percent of GCA in the state. This improper use of water can be adjusted by manipulating output price of crops and also by introducing volumetric pricing in canal water supply. Third, more attention should be given to improve minor-surface irrigation system (which have been neglected by the state) wherever possible through renovation and other developmental activities. Fourth, the projected (notional) cropping pattern should be strictly followed in each command area.

To sustain the groundwater irrigation development, the over exploitation of groundwater should be curbed through legal, institutional and technological options. Currently, out of 30 districts, as many as 13 districts are having over 80 percent of irrigated area through groundwater source alone. Drip method of irrigation, which is being increasingly adopted in the state, should be made mandatory in those regions where exploitation of groundwater is higher. To improve the water use efficiency and the overall performance of irrigation sector in the state, adequate steps should be taken to transfer the system control to Water Users' Association, as has been suggested by the National Water Policy.

6.3 Watershed development programmes (WDPs):

Maharashtra state has been implementing WDPs since 1982 to improve the performance of rainfed agriculture. As a result, area treated through WDPs has increased substantially. However, the achievements made (treated area as of March, 2002 was 3.15 mha) in this respect are not very appreciable when compared to the potential area of WDPs, which is about 20.36 mha. The average treated area from 1983 to 2002 comes to only 0.166 mha per year. With this current rate of growth, it may take more than 100 years to treat all the remaining potential area through WDPs. Therefore, keeping in view the importance of rainfed cultivation, necessary steps should be taken to bring all the potential areas under WDPs within 10 to 15 years by allocating more funds for the same. While selecting areas for treatment, priority should be given to those regions which have more drought prone as well as degraded area, as suggested by the 10th Plan Working Group on Watershed Development, Rainfed Farming and Natural Resources Management.

Presently, WDPs have been operated by different department/agencies in the state without coordination by any single agency. This does not allow us to know the overall working conditions of WDPs including utilisation of allocated funds. Therefore, there is a need to develop convergent approach between various departments to operate WDPs more efficiently, both in terms of utilisation of funds and identifying areas for treatment.

6.4 Rainfed cultivation:

Predominant cultivation of crops under rainfed condition is the main feature of Maharashtra's agriculture, as its irrigated area to gross cropped area is only around 17 percent as of today. Though the average rainfall of the state is higher than the national average, about 73 percent of districts (25 districts out of 34) receive normal rainfall less than the state's average. Besides reducing productivity of crops, this low and varied rainfall pattern increases the risk of farmers. In order to improve as well as to sustain the cultivation of rainfed crops, the state should focus more on watershed development programme and rainwater harvesting system. By introducing short-duration varieties as well as more location specific cropping pattern, the performance of rainfed cultivation can be improved and sustained.

6.5 Low value crops:

Though the cropping pattern has been changing in favour of high value crops in the state, this shift is not very impressive as compared to the national level change. During 2000-01, for instance, coarse cereals accounted for over 34 percent of GCA in Maharashtra, whereas the same was only 15 percent of GCA at all-India level. As a result of cultivation of low value crops, farmers' income (per ha) from agriculture is very low in the state. Since limited availability of irrigation is considered to be the main reason for this, greater attention should be given to utilise the available irrigation potential wherever possible. In those regions where utilisable irrigation potential is less, moisture availability can be increased through WDPs.

6.6 Cultivation of pulse and oilseed crops:

Pulses and oilseed crops have been predominantly cultivated (accounted for about 27 percent of GCA in TE 2001-02) in Maharashtra, mainly under rainfed condition. Productivity of these crops is relatively low in the state as compared to the national level average. Considering the importance of these crops, proper attention should be paid to increase the production and productivity of these crops by popularising the use of bio-fertilisers and bio-pesticides. Special efforts should also be made to cultivate these crops under inter-cropping method wherever possible. Proper marketing arrangements should also be made to procure the oilseeds and pulses from the farmers in order to encourage the cultivation of these crops.

6.7 Mono-cropping pattern:

Sugarcane, a water-intensive crop, has been repeatedly cultivated in Western Maharashtra over the last four decades. Pune and Kolhapur divisions together account for nearly 60 percent of state's sugarcane area even today. This mono-cropping not only affected productivity of sugarcane but also deteriorated soil quality and brought certain pests and diseases in this region. Unlimited supply of canal water and continuos support to sugarcane growers by sugar industries appear to be main the reasons for this mono-cropping. Supply of canal water to sugarcane by volumetric pricing may discourage the mono-cropping pattern.

6.8 Use of technological inputs:

There has been a substantial variation in the use of yield increasing inputs (fertilisers, HYVs) across regions in the state, which also acts as one of the constraints for agricultural growth. The use of fertilisers (per ha) is found to be very low in divisions like Konkan, Latur, and Amravati as compared to state's average. Besides this, wide variation in NPK ratio is also seen across regions in the state. While making efforts to improve the use of yield increasing inputs, proper mix of fertilisers should be promoted to sustain the soil fertility, through quality extension network. Clear-cut crop-specific and region-specific programmes/policies would bring desired results in this regard.

6.9 Horticulture development:

A significant growth has been achieved in area under horticultural crops between 1980-81 and 1997-98 in the state. In order to continue the same kind of growth in the coming years, it is essential to (a) diversify the crops to non-traditional area, (b) arrest the declaration recorded in area and productivity of certain crops, and (c) improve the post-harvesting infrastructure facilities.

Despite significant potential in different regions in the state, area under horticulture crops has not picked up in non-traditional areas, including Western Maharashtra. Therefore, required steps should be taken to increase the area under horticulture crops in those areas where sugarcane is predominantly cultivated so that surplus water can be transferred to other crops and other regions as well.

The growth rate of area under grapes, banana and most of the vegetable crops either declined or decelerated during the nineties as compared to the achievements made in the eighties. It is essential to examine why the growth rate of area under certain horticulture crops decelerated during nineties. Similarly, productivity of crops like orange and mango has also declined between 1990-91 and 2001-02 in the state. As the future growth of state's agriculture heavily relies on the performance of horticulture sector, the reduction in productivity is likely to affect the overall growth of the sector. By introducing tissue culture

varieties (wherever possible) and also by replacing new varieties where age-old crops/plants are cultivated, productivity of horticulture crops can be increased. There is also a need to examine the causes for decline of productivity of major horticulture crops, especially in those regions where productivity started declining.

As pointed out by various studies, there is also a need to improve the post harvesting infrastructure facilities (such as cold storage, cold chain, processing, packaging and marketing) to sustain as well as accelerate the present growth of horticulture sector. The state sector will have to play a larger role in establishing infrastructure facilities to promote horticulture sector in the state, as private individual farmers may not be able to create the same due to resource constraints. Involving private sector in marketing and processing activities as well as encouraging contract farming in the cultivation of horticulture crops may help to improve the availability of post harvesting infrastructure facilities.

6.10 Productivity of crops:

Though the state's contribution in the total production of different crops is substantial, except in the case of sugarcane and some horticulture crops, productivity of all other crops is very low in Maharashtra as compared to the national average (see, Table 2). Apart from reducing farmers' income, the low productivity of crops pulls down the over all growth rate of state's agriculture. More importantly, the growth rate in productivity of almost all the major crops either decelerated or declined during the second part of green revolution (i.e., 1985-86 to 2000-01). Wide variation in productivity of different crops across districts is also another feature of Maharashtra's agriculture. Since low irrigation facility and variation in rainfall are considered to be the important factors

responsible for low and varied productivity level, major initiatives need to be taken to increase irrigation facility wherever possible. In those areas where irrigation potential is low, watershed development programmes should be promoted. Introduction of drought resistance cum high yielding varieties, promoting balanced use of fertilisers (appropriate ratio of NPK) and a well designed location specific policies/programmes can help to increase the productivity of crops appreciably.

6.11 Marketing infrastructure:

A well-developed marketing infrastructure is essential to reduce post harvest losses and also to ensure better return to farmers. Though Maharashtra state has relatively more number of regulated markets, farmers continue to face lot of difficulties while selling their produce. Domination of middlemen in the market has been continuing due to inadequate marketing facilities. Therefore, as suggested by the National Agricultural Policy: 2000, the weekly markets under the direct control of Panchayat Raj institutions should be promoted and strengthened. Producers markets on the lines of "Rayatu Bazar" (as has been followed in Andhra Pradesh and Tamil Nadu) should be promoted across different districts in Maharashtra to reduce the exploitation by middlemen. Importantly, rural road network should also be strengthened to enhance the marketing facilities in the state.

On the whole, it appears from our analysis that, in order to improve the overall performance of agriculture, the government of Maharashtra should focus mainly on three areas: (a) irrigation development, (b) watershed development programme and (c) horticulture development. Once irrigation availability is improved, the other problems such as predominant cultivation of low value crops, wide variation in the use of yield increasing inputs, low productivity of crops, etc., can be solved to a great extent.

Foreword

The slow growth of agriculture recorded in the recent years has been a matter of concern among the policy makers, as agricultural growth plays a crucial role in improving rural employment and reducing rural poverty. Besides this, the problems arising out of WTO commitments and the influence of international policies pose a lot of new challenges to the agricultural sector of the country than in the past. In view of the new policy changes that are taking place in the domestic and international arena, there is a need to make some adjustments in the agriculture policy of the country/state to sustain the growth of agriculture as well as to face the competition arising out of WTO commitments. Though the National Agriculture Policy (2000) has underlined what needs to be done to improve the performance of agricultural sector for the country as a whole, not many states have attempted to formulate its own agriculture policy based on its strengths and weaknesses. While reviewing the major initiatives taken by the state during different plan periods, the study has underlined some of the important programmes introduced to improve the performance of agriculture. The study also brought out the major constraints that hinder the growth of Maharashtra's agriculture. After having analysed the growth performance of agriculture, the study suggests that the state should focus mainly on irrigation development, watershed development, and horticulture development to improve the performance of agriculture.

The findings and policy matrix of the study are expected to be useful to the policy makers for formulating policies focusing on Maharashtra's agricultural development.

Introduction

1.1 Introduction:

The agricultural sector of India has grown up considerably since independence. Upto mid-sixties, owing to various constraints, not only low value crops were dominating in the cropping pattern but both production and productivity of crops were also very low. But, the situation has totally changed after the introduction of Green Revolution in Indian agriculture, which was introduced during the mid-sixties. While the production of foodgrains has increased from 72.35 million tonnes in 1965-66 to 211.17 million tonnes in 2001-02, a similar kind of trend is also noticed in the production of commercial crops like oilseeds, cotton, sugarcane, etc. (GOI, 2002). Constructive policies/programmes introduced by the central and state governments during different plan periods have been considered as one of the main reasons for the substantial improvement in the production of various agricultural commodities.

While the growth oriented policies introduced by the government have been continuing though with some modifications across plan periods, the overall growth rate of agriculture has decelerated during the nineties as compared to the eighties at all-India level owing to certain constraints (see, Table 1.1). As rightly mentioned in the National Agriculture Policy (GOI, 2000), "The pattern of growth of agriculture has, however, brought in its wake, uneven development across regions and crops as also across different sections of farming community and is characterised by low levels of productivity and degradation of natural resources in some areas. Capital inadequacy, lack of infrastructural support and demand side constraints such as controls on movement, storage and sale of agricultural products, etc. have continued to affect the economic viability of agricultural sector". Since agricultural growth plays a crucial role in improving rural employment and reducing rural poverty, the slow growth of agriculture has been a matter of concern among the policy makers in the recent years. In addition to our own domestic constraints, the problems arising out of WTO commitments and

the influence of international policies pose a lot of challenges to the agricultural sector of the country than ever before. In view of the new policy changes that are taking place in the domestic and international front, there is a need to make some adjustments in the agriculture policy of the country/state to sustain the growth of agriculture as well as to face the competition arising out of WTO commitments. Though the National Agriculture Policy (GOI, 2000) has specified what needs to be done to improve the performance of agricultural sector for the country as a whole, not many states have attempted to formulate its own agriculture policy based on its strengths and weaknesses. It is in this context, in this study, an attempt is made to formulate agricultural policy for the state of Maharashtra keeping in view its strength and weaknesses.

1.2 Experience of Agricultural Policy:¹

In the post liberalisation scenario, the agricultural sector is posted at crossroads, where we have to shift from the highly protected regime to a more The agricultural reforms therefore, have to liberalised competitive regime. address the issues emerging in this phase of transition. One can broadly categorise four distinct phases in the development of agricultural sector of the country. The first phase beginning immediately after independence and culminating at 1964 was marked more with the concerns of food security but no significant break through was achieved on the technological front. This phase was influenced both by the indigenous thinking about growth/development strategies (Gandhian perspective) as also by the western process of industry centred growth borrowed from the experiences of the industrialised nations. This phase ended with the droughts of mid-sixties when food security became a prominent issue and acute poverty as well as meeting the famine conditions were among the major concerns for the planning bodies. This was the time when the book by Paddock brothers titled "Famine 1975" came to the stands (Paddock and Paddock, 1968). They argued that America will have to apply classical triage method, like doctors on the battlefield trying to make the best out of minimum resources. It was stated that America will have to decide which countries to save and which to sacrifice. The droughts of mid-

60s in a way awakened the country to accept a new technological package and this turned the tables. The era of technological change marked the second phase in the agriculture sector. Food security was achieved in major part of the country and the output growth in agriculture was contributed largely by productivity growth. This was followed by the third phase in which the externalities of the technological changes surfaced. These included the interregional across class inequalities created and perpetuated by localised impact of technological change and other contributing factors. This gave rise to a phase that was marked by highly protective regime with various subsidy schemes, wherein a large number of initiatives were taken for protecting farmers and weaker sections. The gain in the protected regime can be seen in the form of growth pattern and quality of However, this regime has caused a significant drain on the financial growth. resources of the state as well as put natural resources under great stress. It is also argued that this process had a telling effect on the production efficiency and allocative efficiency of the sector. In addition to this, it is being felt that severe environmental concerns emerged during this phase due to unchecked application of the technological inputs and indiscriminate use of water and land. The fourth phase is marked by the transition, wherein the agricultural sector is set to participate actively in the process of liberalisation by shedding the controls and leaving the contours of the protected regime. The sector is thus, confronted with two important challenges. First, the sector has to prepare for significant participation in international trade, and second it has to renegotiate with the changing domestic regime in an unprotected and competitive atmosphere. Now, we are at the threshold of the tenth plan confronted with certain problems and issues both on domestic front as well as on the liberalisation front and therefore, the situation is quite challenging.

1.3 Emergence of Agricultural Policy:

The emergence of agricultural policy in the Indian context can be traced from the official documents beginning from Foodgrains Policy Committee of 1943 (Gregory, 1943). The works of Maitra (1950), Mehta (1957) and Venkatappaiah (1966) are the important documents flagging the milestones in the making of

Agricultural Policy in the first two decades. Even beyond that the Report of the High Power Committee (1990) had made recommendations covering major sectors of agricultural economy. Various policy statements had come during the period 1966 till the Agricultural Policy Document of 2000. These include the initiative taken during the Prime Ministership of Shri V P Singh followed by another initiative. However, none of these could culminate into a full-fledged policy document for agriculture sector. Therefore, the only first authenticated policy document for agriculture sector is the National Agricultural Policy 2000. During the Tenth Plan period it is necessary to keep in view the lessons learnt through this experience. Last five decades witnessed broadly four important policy directions, namely (i) food security, (ii) institutions for agricultural administration, introduction and dissemination of technology, (iii) under-developed regions, classes, farmers and crops (iv) input and technology distribution.

The NRM sector cannot be separated from the agricultural policy perspective. Increasing population pressure on land, indiscriminate use of natural resources, advent of the new technology with little attention paid to sustainable use of natural resources and failure of the policy to recognise the importance of managing these resources have together lead to degradation and misuse of natural resources over the last 50 years. This has not only affected the regions which have directly contributed to growth but also the regions which were lagging in the process of growth. However, the two processes are different. In the first case, it was initiated due to indiscriminate use of technology whereas, in the other it culminated into surpassing the carrying capacity of land. Use of fertilisers, pesticides and water have caused land degradation though this at present is confined only to specific regions. But over the years, it has shown a significant increase. The degradation of forests and scant attention to the maintenance of bio-diversity have also been noticed during the last three decades. Among the immediate points of concern five issues deserve attention, namely, (i) indiscriminate use of fertilisers and pesticides, (ii) management of use of water and its quality, (iii) harvesting energy from natural resources without degrading them (rain water harvesting, wind energy, biomass), (iv) gene banks and careful

monitoring of bio-diversity, (v) careful application of new technologies and western model of development.

The plan documents over the last five decades made it quite clear that policy for agricultural sector is of prime importance to the plan and the steps taken could be seen from the Table 1.2. One expects a significant shift in the strategy during tenth plan. Keeping with this expectation the Approach Paper to the Tenth Plan makes it clear that "First, agricultural development must be viewed as a core element of the Plan since growth in this sector is likely to lead to the widest spread of benefits, especially to the rural poor including agricultural labour. Also, since the majority of women workers are engaged in agriculture, investments in this sector have enormous implications for gender equality and must be designed to have maximal impact on this dimension. The first generation of reforms concentrated on reforms in the industrial economy and reforms in the agricultural sector were neglected. This must change in the Tenth Plan" (Approach Paper to the Tenth Five Year Plan, GOI 2001).

1.4 Issues in Maharashtra's Agriculture:

Though Maharashtra state occupies relatively better position in terms of contribution to the total production of different commodities at all India level (see, Table 1.3), the agricultural sector of the state has been facing a number of different problems. The main problems faced by the agricultural sector of the state are:

- Low irrigation facility
- Low and erratic rainfall pattern
- Cultivation of crops predominantly under rainfed condition
- Improper distribution of irrigation water among different crops
- Predominant cultivation of low value crops
- Low productivity of different crops
- Mono-cropping pattern
- Low progress in Watershed Development Programme

- Wide regional variation in the development of agriculture
- Poor marketing and post harvesting facilities

Most of the problems mentioned above are one way or the other associated with the limited availability of irrigation. Despite giving substantial importance, both in terms of investment and policy input for the development of irrigation, the share of irrigated area to gross cropped area is only about 17 percent as of today. The low irrigation facility has been one of the serious problems of the state. Due to low irrigation facility, not only low value crops are cultivated predominantly in the state but the productivity of most of the crops are also very low as compared to the national average. Cultivation of low value crops coupled with the low productivity of crops reduce the income of the farmers, which adversely affect the standard of living of both farming and non-farming (landless agricultural labourers) rural communities.

The second major issue is related to crop pattern and productivity of crops. Because of low irrigation facility and wide variation in rainfall, farmers are forced to cultivate low value crops (coarse cereals and pulses) predominantly under rainfed condition. About 83 percent of cultivated area is under rainfed condition as of today. Since rainfed crops are generally affected by varied rainfall (moisture

stress), productivity of different crops is very low in the state as compared to the all India average. Mono-cropping pattern (example, sugarcane) followed in certain regions of the state has also affected the productivity of crops, which is another important issue of Maharashtra's agriculture.

The third important issue in Maharashtra's agriculture is poor growth of agriculture, which is the main outcome of low irrigation and productivity of crops. Though significant development has taken place in horticultural sector during the last decade, it has not made any significant impact on the growth rate of agriculture. While the share of agricultural sector's contribution to state's income declined from 34 percent in 1960-61 to 16 percent in 2001-02, the growth rate of the agricultural sector (state domestic product) decelerated from 3.70 percent per annum during eighties (1980-81 to 1990-91) to 2.72 percent per annum during nineties (1990-91 to 2001-02) (see, Table 1.4). The slow growth of agriculture is a serious issue from the point of view of rural employment and poverty, both of which are heavily dependent on agricultural growth.

The other important issue associated with Maharashtra's agriculture is poor marketing and post-harvesting facilities. Besides the domination of middlemen, it is predominantly traditional and does not have strong network of post-harvest services and infrastructural facilities (Mahendra Dev, 1996). As result of this, not only the wastage is substantial but the losses are also enormous for farmers. Concerted efforts are needed to improve the marketing facilities.

In addition to the existing problems, the newer issues arising out of WTO commitments are further expected to pose different kinds of problems to the agricultural sector of the state. How to improve the growth of agriculture with these constraints? What are the areas in which government should focus mainly in the future? Is there any relationship between the policies introduced by the government and development of agriculture? What are major constraints that limit the growth of agriculture in the state? Whether the government has taken initiatives to face WTO commitments? etc. are some of the important issues which need to be studied thoroughly to make a proper agricultural policy that can be implemented for improving the performance of agricultural sector in the state. Keeping in view the issues raised above, the present study makes an attempt to

formulate an agriculture policy for the state of Maharashtra by taking into account the policy inputs followed for the development of agriculture over the last forty years.

1.5 Objectives:

The specific objectives of the study are:

- 1. To review the available materials (including policy documents, five year plan documents at the center and at state level, policy statements made at the state level, etc.) at the state level dealing with policy interventions after the formation of the state.
- 2. To identify the important constraints and review the efforts made by the State in the past to meet major challenges pertaining to agriculture and allied activities.
- 3. To record the state's response to the already formulated National Agricultural Policy, that is, to find out precisely how and where the state would like to suitably supplement, modify and re-articulate the National Policy in the local context.
- 4. To bring out the state's concerns as well as to record the state's views on the changing economic situation due to India's involvement with the WTO.
- 5. To assemble these views in the form of a meaningful policy requirement matrix, relating problems/issues to action points suggested/recommended.

1.6 Data and Methodology:

This study has been carried out mainly using available secondary level information. The coverage of the study period is from 1960-61 to 2001-02. Data for this study have been mainly compiled from various five year plan documents (both centre and state), various committee and commission reports, Season and Crop Report of Maharashtra State (various issues), Districtwise Agricultural Statistical Information of Maharashtra State, Economic Survey of Maharashtra and India, various documents published by the Ministry of Agriculture, Government of India, New Delhi, http://agricoop.nic.in, http://agri.mah.nic.in, http://www.censusindia.net, etc. Recent data on Maharashtra's agricultural

development have been directly compiled from the Commissionerate of Agriculture, Government of Maharashtra, Pune.

In order to understand the performance of the state's agriculture, a thorough analysis has been carried out on irrigation development, input use, cropping pattern, production and productivity of different crops using data from 1960-61 to 2001-02. One of the objectives of the study is to review the initiatives taken by the government during different plan periods to improve the performance of agriculture. For this, a detailed review has been done using the information collected from different five year plan documents, economic survey of the state, etc. A number of constraints limit the growth of agriculture in the state over the last four decades. While highlighting the major constraints of Maharashtra's agriculture, the measures taken by the government to remove the constraints have also been presented using the information gathered from different plan documents.

1.7 Organisation of the Study:

The study has five chapters. Chapter one, which is an introduction, presents a brief account on experience as well as emergence of agriculture policy in India, the major issues in Maharashtra's agriculture, objectives and methodology of the study. Chapter two deals with agricultural development of the state, wherein plan expenditure on agriculture and irrigation, workforce in agriculture, landholdings, rainfall, irrigation development, inputs use, land use pattern, cropping pattern, horticulture sector, production and productivity of crops and livestock sector of the state have been discussed in detail. Chapter three presents a detailed review on the initiatives (programmes) taken by the state government to improve the performance of agriculture since the third plan period. Important programmes introduced by the government have also been discussed in the same chapter. Chapter four brings out all the major constraints faced by Chapter five presents the agricultural the agricultural sector of Maharashtra. policy for Maharashtra's state including a policy matrix, which provides the strategies to be followed to improve the overall performance of the agricultural sector.

Agricultural Development of the State

Maharashtra is one of largest states in India, both in terms of Gross Cropped Area (GCA) and population. While accounting for about nine percent of India's population, the state contributes over 20 percent in India's industrial output and about 13 percent in India's GDP in 2001-02 (GOM, 2003). The state also accounts for about 12 percent in India's Gross Cropped Area (GCA) in 1999-2000. Over the last forty years, the agricultural sector of Maharashtra has undergone lot of changes. In order to formulate a desirable agriculture policy, it is necessary to review the past agricultural development of the state. It is in this context, in this chapter, an attempt is made to review the development of agriculture in different areas in the state. Specifically, we review the plan-wise expenditure on agriculture and irrigation development, changes in rural workforce, land holding pattern, rainfall, irrigation, land use pattern, cropping pattern, input use (HYVs and fertilisers), production and productivity of different crops as well as livestock development in the state. While reviewing the development of different areas in agriculture, we try to underline the important areas in which more attention needs to be given in the future.

2.1 Plan Expenditure on Agriculture and Irrigation:

Investment in agriculture is essential for increasing as well as sustaining the overall growth of agriculture. Public sector investment in agriculture is essential because it stimulates private sector investment, as has been proved by various studies in India (see, Rath 1989; Mishra and Chand 1995; Dhawan 1998). Plan expenditures from three heads namely (a) agriculture and allied activities, (b) rural development, (c) irrigation and flood control generally have a direct bearing on agricultural growth. Table 2.1 presents the sectoral distribution of plan expenditure during different plan periods in Maharashtra. Altogether from third plan to ninth plan period, about Rs. 38150 crore (in current prices) have been

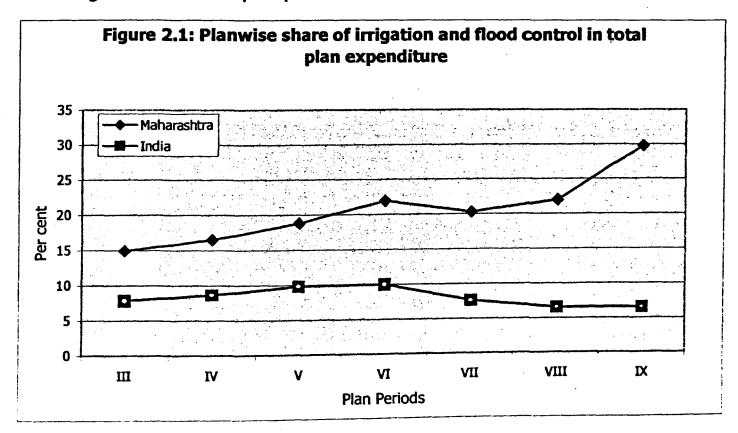

spent on the above mentioned three heads. Though these three heads altogether accounted for about 41 percent in the total plan expenditure from third plan to ninth plan period, the share of agriculture and allied services has sharply declined from 30.87 percent in third plan to 4.98 percent in ninth plan in Maharashtra. A similar trend is also noticed at the national level, where the share of agriculture and allied services has declined from 12.7 percent to 4.9 percent during the same period.

Unlike the agriculture and allied services, the plan expenditure in irrigation and flood control has sharply increased from 14.92 percent in third plan to nearly 30 percent in ninth plan in Maharashtra. This is in contrast to the national level picture, where the same share has declined from 7.8 percent to 6.5 percent during this period (see, figure 2.1). Considering the vast rainfed cultivated areas and also the importance of irrigation in agricultural growth, the state government has been giving top priority to exploit the available irrigation potential. This naturally requires more investment and therefore, investment in irrigation and flood control has increased substantially over the plan periods in Maharashtra. One needs to study how far this investment in irrigation has translated into irrigated area in the state. On the whole, unlike the national level picture, the total share of investment in agriculture and irrigation development has been increasing across different plan periods in the state.



2.2 Workforce in Agriculture:

Before analysing the development of various aspects of agriculture, let us understand the workforce involved in agriculture in the state. An analysis on the workforce would not only reveal the share of rural population relying on agriculture for livelihood but also help in making a proper agriculture policy for any state. Table 2.2 presents the distribution of rural workforce for Maharashtra as well as for India as a whole. It is evident from the table that despite achieving significant development in industrial sector in the state, the workforce (cultivators plus agricultural labourers) directly relying on agriculture has come down only marginally (by 1.93 percent points) between 1981 and 2001. This reduction is relatively lower as compared to the reduction observed at the all India level.

The relatively higher share of workforce still relying on agriculture in the state is mainly because of lower growth in non-farm rural employment opportunities (Narayanamoorthy, et al., 2002; Visaria, 1995). As one of the main factors responsible for the growth of non-farm rural employment is agricultural development, the predominant rainfed agriculture followed in Maharashtra would

not have stimulated the non-farm rural employment opportunities (see, Mahendra Dev, 1990; Fisher et al., 1997; Hazell and Haggblade, 1991). On the whole, the analysis reveals that the rural workforce relying directly on agriculture is still (in 2001) about 80 percent in the state. Therefore, while formulating policy for agriculture, adequate attention needs to be given to shift the workforce from agricultural to non-agricultural sector so as to improve the living condition of the rural workforce.

2.3 Land holding Pattern:

Land holding pattern of Maharashtra state is somewhat different from the all-India level. Though the proportion of marginal and small holdings has been increasing both at the state and the national level, the share of these groups in the total number of holdings is relatively lower in Maharashtra as compared to all-India level (see, Table 2.3). For instance, during 1990-91, marginal and small holdings accounted for about 63 percent of the total holdings in Maharashtra, whereas the same group accounted for nearly 78 percent at the all-India level. This means that marginal and small farmers are relatively lower in Maharashtra as compared to the all-India level. An interesting fact emerging from Table 2.3 is that there is a sharp reduction in large holdings in Maharashtra (from 10.38 percent in 1970-71 to 1.80 percent in 1990-91) as compared to the trend observed at the all-India level, where the same declined only from 3.93 percent to 1.59 percent during this period. Because of relatively lower number of marginal and small holdings in Maharashtra, the average size of operational holdings is found to be higher in the state as compared to the same at the all-India level.

2.4 Rainfall:

Monsoon rain plays a critical role in the agricultural development of the state, as over 83 percent of cropped area is cultivated under rainfed condition as of today. Maharashtra receives rainfall mainly through south-west monsoon, which starts during the first week of June and ends in October. Though the average rainfall of the state is relatively higher as compared to many states in India, its timeliness and spread across months as well as across different regions are not very much favourable. While the normal rainfall of the Konkan

division (about 2900 mm) is about 135 percent higher than the average normal rainfall of the state (1254 mm), the same is less by about 40 percent in Aurangabad division. Moreover, except 10 districts of the total 34 districts in the state, the normal rainfall of all other districts is less than the state's average normal rainfall (see, Table 2.4). This clearly shows how widely rainfall varies across regions in the state.

Apart from variation in the normal rainfall across districts, it also widely varies across *talukas* within a district/region. This not only discourages the farmers to adopt the required quantity of various yield increasing inputs but ultimately results in lower productivity most of the time. In view of the limited water potential as well as increasing demand for water from different sectors, the only option available before the policy makers is to implement sustainable rain water harvesting systems at a rapid pace through watershed development programme.

2.5 Irrigation Development:

Though the aspect of irrigation development is generally dealt within the Water Policy, we are of the opinion that comprehensive agriculture policy for any state cannot be formulated without considering irrigation development. Therefore, we have reviewed the development of irrigation before getting into cropping pattern, etc.

Considering the predominant nature of rainfed cultivation and wide variation in the rate of rainfall across regions, a significant emphasis has been given for the development of irrigation in the state by the policy makers since independence. Area under irrigation (GCA) increased from 1.24 mha in TE 1962-63 to 3.66 mha in TE 2000-01 in Maharashtra, an increase of about 2.89 percent per annum (see, Table 2.5). However, the utilisation percentage of irrigation is very low in the state. As of June 2000, about 4.769 million hectares of irrigation potential has been created in the state. Of this, only about 34.7 percent (1.654 mha) has been utilised. This is very low as compared to the utilisation percentage of the national level, which was about 89.45 percent at the end of Eighth Plan. Inadequate availability of funds for developing hardware aspects of irrigation such as construction of main canals and distribution systems are often cited as the main reasons for low percentage of utilisation.

In terms of investment on irrigation, Maharashtra state stands on the upper side of the ladder. Up to ninth plan period, for which we have comparable data, altogether Rs. 236.22 billion (in current prices) has been spent only on irrigation development. This accounted for over 17.36 percent of the country's

total investment on irrigation, which is about Rs. 1360.65 billion, excluding investment on CADA and flood control. As a result of large investment on irrigation, Maharashtra state accounts for about 34 percent (1229 dams) of the total number of large dams constructed in the country, as per the latest information available from CWC (2002).

Another important issue pertaining to irrigation is the relationship between investment on irrigation and area created from each plan period. We could see hardly any relationship between investment and area created across plan periods. During the sixth plan period, the state has spent Rs. 11.87 billion on MMI and created about 0.507 mha, by spending only about Rs. 23416/ha. But this has changed during seventh and eighth plan periods. With an investment of Rs. 23.92 billion during eighth plan period, the state could create only about 0.283 mha from MMI source. This means that the average investment required to create one hectare of irrigation increased to Rs. 84505 during eighth plan period. Incompletion of projects in time due to paucity of funds is identified as the main reason for poor cost efficiency (see, Gulati et al, 1994; Abbie et al, 1982; Deshpande and Narayanamoorthy, 2001).

Despite having largest number of dams and also storage (second highest in the country) capacity of 22.10 cubic km from the completed projects, in terms of achievements, the proportion of cultivated area under irrigation is only about 17 percent of gross cropped area (GCA) as of today, which is one of the lowest among the states in the country. One of the important reasons for the less proportion of irrigated area is that two-third of water available in the state is used only for sugarcane, which accounts for less than three percent of gross irrigated area in the state. Thus, it is clear that irrigation water is not used judiciously in the state.

Besides the problem of low development of irrigation, the created irrigation potential is also not equally distributed across regions in the state (see, Table 2.6). Data show that four divisions namely Pune, Kolhapur, Aurangabad and Nagpur together accounted for about 74.23 percent (0.780 m ha) of total surface irrigated area of the state during TE 2001-02. However, the distribution of area

under well irrigation across divisions is relatively better than surface source of irrigation. Except Konkan, Amravati and Latur divisions, the share of well irrigated area to total (net) well irrigated area is varied from about 12 percent to 25 percent in other divisions. Interestingly, the share of surface irrigated area is found to be higher in those areas where the share of well irrigated area is also higher, except Nashik and Nagpur divisions. As irrigation is one of the important factors which determine the income generating capacity of the rural population and also involves a large amount of public investment, the allocation of resources for irrigation development needs to be linked with the percentage of utilisation of irrigation potential across regions in the future.

One of the significant developments in Maharashtra's irrigation is the impressive growth in micro-irrigation (drip and sprinkler). Keeping in view the water balance of the state, government of Maharashtra has been promoting drip method of irrigation since 1986 through subsidy programmes. The area under drip method of irrigation (DMI) has increased from a mere 236 ha in 1986-87 to about 217 thousand hectares in 2001-02, an increase of about 57 percent per annum. As of 1997-98, for which we have statewise data, Maharashtra State alone accounted for over 50 percent of India's total drip irrigated area. Studies carried out in different crops using field survey data suggest that not only the investment on drip irrigation is economically viable but it also saves substantial amount of water (see, Table 2.7). Since DMI is highly suitable for almost all horticultural crops and the state also has lot of potential for the same crops, area under DMI can be increased by many fold by extending the promotional schemes currently followed by the state for another one decade or so. On the whole, despite having some positive development in DMI, the irrigation sector of the state has been facing serious problems which need to be addressed immediately to improve the performance of agriculture.

2.6 Coverage of HYVs:

One of the indicators of level of adoption of technology in agriculture is the use of HYVs in different crops. Though the use of HYVs is positively correlated with the availability of irrigation, farmers have been using the same even under rainfed condition because of the government's subsidy programmes and effective

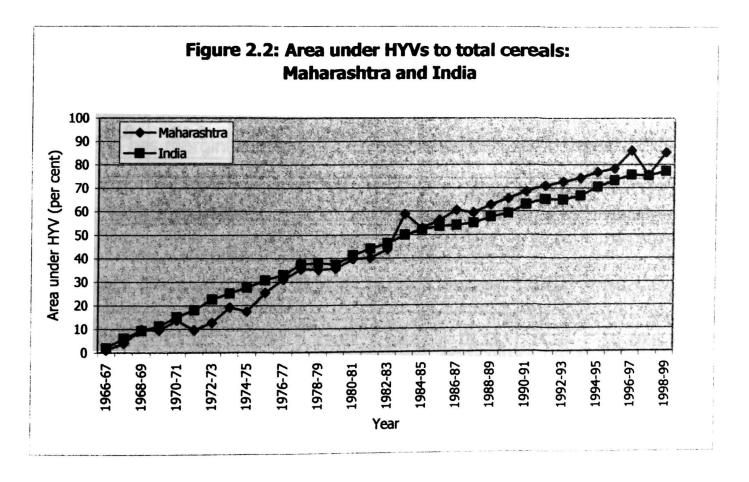

extension network. While HYVs have been used for different crops including non-foodgrain crops, data on the coverage of HYVs for non-foodgrains are seldom available even at the micro level. This does not allow us to find out the extent of adoption of HYVs in various crops, especially in non-foodgrain crops.

Table 2.8 presents the coverage of HYVs in major cereal crops for Maharashtra state and all-India. It is evident from the table that despite having low irrigation facility and wide variation in rainfall across different regions in Maharashtra, the percentage coverage of HYVs in cereal crops is found to be relatively higher in the state as compared to the national level average, especially since mid-eighties (see, Figure 2.2). This shows that farmers belonging to Maharashtra are fully aware of the importance of HYVs in crop cultivation. However, relatively higher coverage of HYVs in cereal crops does not reflect in the productivity of the crops, which is a major concern of the agricultural sector of Maharashtra (productivity of different crops is discussed separately in the same chapter). This is mainly because of predominant cultivation of HYVs under rainfed condition, where moisture stress often affects the yield of crops substantially. By introducing drought resistance cum high yielding varieties in different crops, productivity of crops can be increased to a larger extent.



2.7 Fertiliser Consumption:

Consumption of fertiliser of any state is mainly determined by factors such as availability of irrigation as well as area under paddy and wheat (NCAER, 1991; Vaidyanathan, 1994). While irrigation availability encourages the farmers to use higher amount of fertilisers for any given crop, paddy and wheat generally consume relatively higher amount of fertilisers. Despite having poor irrigation facility and less area under paddy and wheat, the consumption of fertilisers in the state is not very low as compared to the national level average (see, Table 2.9). While the consumption of fertilisers increased from 1.62 kg/ha in 1960-61 to 75.47 kg/ha in 2001-02 in Maharashtra, the same has increased from 1.93 kg/ha to 87.56 kg/ha at all India level during the same period (see, Figure 2.3). However, the consumption of K (Potash) is found to be relatively higher in the state as compared to the national average. There are two main reasons why the consumption of fertilisers is not very low as compared to the national average. First, sugarcane is intensively cultivated in the state, which consumes higher amount of fertilisers than many other crops. Second, high value horticultural crops such as grapes, banana, vegetables, etc, are also cultivated intensively in the state, which also require higher amount of fertilisers.

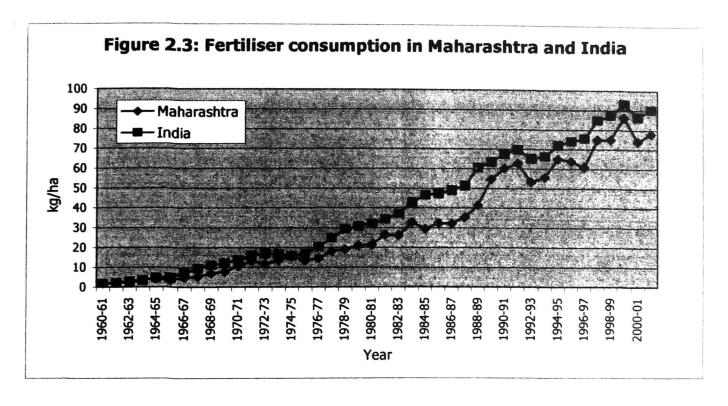

Recent research indicates that it is not only the amount of use of fertiliser which is important for increasing the productivity of crops but the method of

application (proper mix of NPK) and the time of application are also important. Due to less awareness as well as resource constraints, farmers are not able to apply fertilisers in time with proper mix. With the proper institutional credit support along with quality extension network, these constraints can be removed.



2.8 Land Use Pattern:

Land use pattern explains how effectively land resources are utilised for different purposes in a state. Development in irrigation and growth in population are the two important factors, which mostly decide the land use pattern of any state. Table 2.10 presents the detailed land use pattern of the state. Since crops are cultivated predominantly under rainfed condition in Maharashtra, net sown area (NSA) has marginally (by 1.07 percent points) declined between TE 1962-63 and TE 2001-02, which is somewhat different from the trend emerging at the national level. Despite having limited availability of irrigation facility, area cultivated more than once increased from about 5 percent of the GCA in TE 1962-63 to over 20 percent in TE 2001-02. In fact, area cultivated more than once increased nearly three times between TE 1982-83 and TE 2001-02. Intensive cultivation of annual crops such as sugarcane, horticulture crops, etc., could be the main reasons for this sharp increase. While there is no significant change in area under fallow, lands under cultivable waste as well as permanent pastures and grazing and land used for non-agricultural purpose has increased from about

7.06 lakh hectares in TE 1962-63 to 13.06 lakh hectares in TE 2001-02, an increase of about 85 percent. Urban agglomeration and continuous expansion of industrial sector could be the reasons for the substantial increase in land used for non-agricultural purpose. Despite a severe scarcity for land resources, altogether about 4.80 mha of lands are available in the form of cultivable waste, permanent pastures, land under tree crops and grooves, current as well as other follows. With a proper wasteland development programme, these lands can be brought under productive use, which may help to reduce the rural poverty in the state.

2.9 Cropping Pattern:

One of the important factors, which determine the cropping pattern is availability of irrigation. Owing to limited availability of Irrigation, which is only around 17 percent of GCA as of today, rainfed crops have been predominantly cultivated in Maharashtra, as reported in Table 2.11. However, the cropping pattern of the state has changed considerably over the last 40 years. Area under cereal crops declined by nearly 12 percent points between TE 1962-63 (55.60 percent) and TE 2001-02 (59.44 percent) mainly because of substantial reduction in area under jowar, which is the important foodgrain crop of Maharashtra. Though the productivity of pulse crops has been lower in the state, the total area under pulse crops has increased from 12.60 percent in TE 1962-63 to 15.75 percent in TE 2001-02. As the alternative crops suitable to rainfed condition are not available, farmers continue to cultivate pulse crops predominantly in the state.

Oilseed crops such as groundnut, soyabean, etc., have also been cultivated predominantly in the state. Despite a significant reduction in area under groundnut, area under the total oilseed crops increased marginally (increased from 10.11 percent to 11.43 percent) between TE 1962-63 and TE 2001-02. This is mainly because of impressive increase in area under soyabean since early 1990s. Since both pulses and oilseeds are mainly cultivated under rainfed condition and also the state has enormous potential for cultivating these crops, the policy makers should give top priority for promoting the cultivation of these crops.

Cotton is another important crop predominantly cultivated under rainfed condition in the state. Inspite of facing problems such as severe pest attack, increased cost of cultivation, low productivity and profitability, area under cotton has marginally increased between TE 1962-63 and TE 2001-02. This only shows that there is a tremendous potential for expanding the cultivation of cotton in the state. Measures such as introduction of pest resistance varieties (Bt cotton, etc.), improved cultivation practices, quality extension network and proper marketing network may help to improve the cultivation of cotton crop in the state.

Despite severe water scarcity in the state, area under sugarcane has increased nearly four times between TE 1962-63 (1.48 lakh ha) and TE 2001-02 (5.87 lakh ha) in the state. The share of sugarcane area in GCA has also increased from just 0.78 percent to 2.63 percent during this period. Though net returns per unit of water generated by sugarcane is very low when compared to most of the foodgrain crops (Rath and Mitra, 1989), estimates show that this crop alone consumes nearly two-third of irrigation water available in the state (World Bank, 2002). Continued support of the sugar industries (through state government) encourages the farmers to cultivate this water intensive crop. Keeping in view the water balance of the state, strict rules need to be enacted to discourage the cultivation of sugarcane under flood or conventional method of irrigation.

2.10 Growth in Horticultural Crops:

One of the significant changes that have taken place in the cropping pattern of the state especially in recent years is development in horticultural crops. Area under fruit and vegetable crops has increased by about 4.25 times (from 1.51 lakh ha to 6.42 lakh ha) over the last 40 years. That is, area under fruits and vegetables accounted for only about 0.79 percent in TE 1962-63, but the same increased to nearly 3 percent in TE 2001-02 (see, Table 2.11).

Within the group of fruits and vegetables, some significant changes have taken place over the years (see, Table 2.12). While the share of area under grapes, mango and cashewnut has increased, the share of orange and guava has declined. Similar kind of changes are noticed in vegetable crops as well.

However, the absolute area of all the fruits and vegetable crops has increased over the last forty years, barring potato (see, Tables 2.13 and 2.14). Suitable agro-climatic conditions, relatively higher profit from these crops, government support through EGS and other programmes, involvement of corporates in production and marketing of these crops, etc., are the main reasons for the substantial increase in area under horticulture crops in the state. Suitable infrastructure including marketing facilities would help further to exploit the enormous potential of horticultural crops in the state.

2.11 Production and Productivity of Crops:

Production of various crops has increased many fold in the state over the last forty years (see, Table 2.14). But the productivity of different crops is relatively lower in the state as compared to the all-India average, which is the major problem of Maharashtra's agriculture (see, Figure 2.4). As can be seen from Table 2.15, barring a few crops, productivity of all other crops is significantly lower in Maharashtra as compared to the all-India average. As mentioned earlier,

cultivation of crops predominantly under rainfed condition is observed as the main reason by various studies (Sawant, et al., 1999; Dev, 1987; Mitra, 1990). Data presented in Table 2.15 also clearly indicate the low coverage of irrigation in different crops in the state as compared to the national level average. Crops such as jowar, groundnut and sugarcane have higher coverage of irrigation in Maharashtra and therefore, the productivity of these crops is relatively higher in the state. Productivity of important crops such as gram, tur, cotton, etc., is very low in the state as compared to many states in India mainly due to poor irrigation availability (GOI, 2002).

Farmers' income cannot be increased unless the productivity of crops is increased significantly. While it may not be possible to provide irrigation for the whole cropped area because of limited availability of irrigation potential in the state, moisture availability can be improved in the rainfed areas through rain water harvesting system and watershed development programmes. Needless to mention that watershed development programme under operation in different parts of the state has already made significant impact on productivity of crops by increasing the water availability. By expanding the watershed development

programme in all potential areas in the state, not only the productivity of crops can be increased but the rural poverty can also be reduced in a sustained manner through agricultural growth.

2.12 Livestock Sector:

The livestock sector (animal husbandry and poultry) is one of the important allied activities of agriculture. By providing substantial income to rural households especially in the areas where agricultural growth is poor, it helps to reduce the rural poverty. The livestock sector of Maharashtra seems to be relatively stronger as compared to many states in India. As per the Livestock Census of 1997, the total livestock population of the state was about 35.39 million, which is about 10 percent of the country's livestock population (see, Table 2.16). Not only this, the growth rate of livestock population between 1972 to 1997 is also found to be higher in Maharashtra as compared to the same at the national level. This continued high growth of livestock population is possibly because of the following reasons. First, crop income is generally low in Maharashtra due to predominant rainfed cultivation, which may have stimulated the farmers to concentrate on allied activities. Second, the milk cooperatives are well developed in the state, which

must have helped the farmers to have more number of bovine stock. Third, supportive programmes introduced by the state government to improve the livestock economy may have also yielded good response from the rural community

The increased livestock population in the state has also been translated into the production of livestock products (see, Table 2.17). While the production of milk increased from 41 million tonnes in 1991-92 to 60.24 million tonnes in 2001-02, the production of eggs increased from 2260 million to about 3249 million during the same period in the state. A significant increase is also noticed in the production of meat as well as in wool in the state. The growth rate of Maharashtra state in the production of main livestock products like milk and eggs is also matching with the growth rate of the same products at the national level. The continued improvement in the livestock sector shows that there is a considerable potential for the livestock related activities in the state.

On the whole, our review on the development of agriculture in Maharashtra state shows that despite substantial improvement over the last four decades, the performance of the state is relatively poor in different parameters of agriculture as compared to the national level average. Limited availability of irrigation is one of the main factors responsible for the poor performance of agriculture in Maharashtra.

Major Initiatives Taken for Agricultural Development in the State

3.0 Introduction:

In order to improve the performance of Maharashtra's agricultural sector, a number of initiatives (strategies/programmes) have been introduced by the state and central governments during different plan periods. In this chapter, while highlighting the various programmes introduced in different plan periods, we try to assess whether the programmes have been introduced keeping in view the changing nature of agricultural economy in the state. This chapter is divided into two sections. Section one briefly highlights the various programmes introduced in different plan periods and the changes that have been taken place in it since third five year plan¹. Section two presents some of the important programmes introduced by the government in detail. Data/information compiled from various five year plan documents of Maharashtra state, Economic Survey of Maharashtra, Districtwise Agricultural Statistical Information of Maharashtra State and http://agri.mah.nic.in have been mainly utilised for preparing this chapter.

3.1 Programmes introduced during Plan Periods:

A number of different programmes have been introduced through various plan periods by the state keeping in view the importance of agriculture. In Table 3.1, we have summarised the various programmes introduced during different plan periods. As can be seen from the table, there has been a substantial change in the programmes that have been introduced during plan periods. Between third and fifth five year plan periods, special importance had been given for the research and infrastructural development including irrigation. Also importance had been given for the development of foodgrain crops. This was done because of the following two reasons. First, since basic infrastructural facilities are needed for accelerating as well as sustaining the growth of agriculture, a deliberate attempt

has been made by the planners to develop basic infrastructural facilities during the initial plan periods. Second, achieving self-sufficiency in food production was one of the major objectives of the planners during the sixties and seventies and therefore, importance was also given for those programmes that could increase foodgrain production in the state.

The programmes introduced in the recent plan periods, especially after sixth plan, are somewhat more specific than the earlier plan periods. Programmes focusing on the upliftment of tribal and other economically weaker sections of the farming community have been introduced between seventh and tenth plan periods. Similarly, considering the limited availability of water resources in the

state, watershed development programmes, users' participation in irrigation management and micro-irrigation (sprinkler and drip) have been introduced after sixth plan period to conserve as well as to improve the water use efficiency in the state. Keeping in view the changing nature of agriculture as well as demand from farmers, programmes focusing on agri-polyclinic, testing laboratories for fertilisers and insecticides, production and marketing of bio-pesticides as well as production of vermiculture have also been introduced during ninth and tenth plan periods. This in a way suggests that the initiatives taken by the planners/government to improve the growth of agriculture have been changing over the years according to the changing nature of agriculture.

While observing changes in the initiatives taken by the government across different plan periods, we could hardly see any special programmes focusing on marketing facilities. As the exploitation by middlemen is large in agriculture, a strong integrated marketing system by the farmers' cooperatives should be encouraged, as suggested by the Kolhe Committee on Agriculture Marketing (GOM, 1991).

Though the focus of the planners has been changing over the years depending upon the requirements as well as changing nature of agriculture in the state, the importance given to thrust areas has been continuing over the years. For instance, the thrust areas of the state are irrigation development, watershed development programmes, soil conservation programmes, horticultural development, special programmes for improving the production of pulses, oilseeds, sugarcane, cotton, etc. Programmes supporting these areas/crops have been noticed in all the plan periods that we reviewed for this study. In fact, well before the introduction of watershed development programmes (NWDPRA, etc.) by the central government at the national level, government of Maharashtra has introduced programmes to promote contour bunding, nala bunding and contour trenching in the third plan itself. The draft agriculture policy prepared by the state government has also highlighted the thrust areas to be focused in the future (see, Box 3.1). All this seems to suggest that the planners at the state level have introduced the policies/programmes as per the requirements of the state and in

some cases, much before the initiatives were taken at the country level (example, watershed development programme, micro-irrigation, etc).

Box 3.1: Highlights of Maharashtra's Agriculture Policy

The Agriculture Policy adopted by the State Government aims at the following:

- Development of the sector on a sustainable basis by using the available resources economically, efficiently and in an environmentally sound manner with a view to increase farmers' income and production.
- To envelop the needs of vulnerable sections, generate both skilled and unskilled employment and make a positive intervention towards poverty alleviation.
- To promote agriculture development on commercial and industrial lines.
- To prepare plan of action for full exploitation of the limited water resources.
- To improve the working of Agricultural Universities.
- To promote farm and infrastructural facilities for post harvest management, storage, transport, marketing and export to ensure that farmers will get due price for their produce.
- To improve the systems relating Agricultural Produce Market Committees.

3.2 Important Initiatives taken by the Government:

Over the years, a number of different programmes have been introduced by the state government to increase the agricultural growth as well as to improve the welfare of the farming community. The tenth five year plan document of Maharashtra has also highlighted some of the important strategies that need to be followed for increasing the production of agricultural commodities (see, Box 3.2). Of the various programmes introduced by the government, some are considered to be very important, which need special mention. Therefore, the highlights of the important programmes are discussed in detail in this section.

3.2.1 Irrigation Development:

As mentioned earlier, unlike many states in India, the proportion of irrigated area to gross cropped area is very low in Maharashtra (only about 17 percent as of today). Considering the importance of irrigation, major initiatives have been taken to increase the area under irrigation since third plan in the state. Initiatives were not only taken to increase the area under surface irrigation (major and medium projects) but also minor irrigation including co-operative lift irrigation development. From third to ninth plan, altogether Rs. 23515.35 crore (planwise)

expenditure on irrigation development is presented in Table 2.1 in Chapter II) has been spent exclusively for irrigation development by the state. As a result of continuous initiatives taken by the government, area under irrigation has increased from 1.24 mha in TE 1962-63 to 3.66 mha in TE 2001-02, an increase of 2.81 percent per annum. In terms of share of irrigated area to cropped area, it increased from 6.48 percent in 1960-61 to 16.38 percent in 2001-02 (GOM, 2003). Though the percentage of irrigated area to gross cropped area of the state is well below the national average, the growth rate of irrigated area (GIA) between 1960-61 and 2000-01 was found to be marginally higher (3.05 percent per annum) in the state as compared to the national average, where it increased by 2.65 percent per annum.

Box 3.2: Strategy for Agricultural Production during 10th Plan Period

The strategy for increasing agricultural production in the state will have following salient features;

- Since 1993-94 the *kharif* jowar production and productivity reached a new height. The production has become surplus. To maintain the pace between requirement and production, some area from this crop will be diverted to other crops viz. soyabean and pulses.
- Since the soybean crop is gaining popularity in the state, it is decided to increase area under this crop. As part of this strategy, soybean crop will be advocated as a preceeding to pre-seasonal and suru cultivation of sugarcane and as inter crop with cotton and tur.
- To increase the production of pulses and oilseeds, emphasis will be given on popularization of use of bio-fertilisers and use of bio-pesticides and diverting area from crop viz. cereals, cotton, wheat, etc. Special efforts will be made to bring more and more area under intercropping of pulses and oilseeds in cotton, jowar, and bajra.
- The low productivity of paddy in eastern Vidarbha has been a point of concern.
 The state government therefore, decided to lay more emphasis on increasing
 paddy productivity in this area by resorting massive production and use of blue
 green algae and green manuring.
- Considering scarce water resources, the State Government has attached highest priority to promote micro irrigation concept in the state. The encouraging response of drip and sprinkler irrigation system for horticultural crops, sugarcane and oilseeds led the State Government to formulate massive programme of drip irrigation through state resources.
- Productivity of cotton is also a matter of concern to the state government. The low productivity of this crop is mainly due to rainfed area, which is 97 percent, heavy incidence of boll-worm and lack of plant.

Further, deviating from the traditional practice, the government of Maharashtra has also established Five Irrigation Development Corporations (IDCs) to accelerate the completion of the irrigation projects. The Five IDCs are: (i) Maharashtra Krishna Valley Development Corporation, (ii) Godavari-Marathawada Irrigation Development Corporation, (iii) Vidarbha Irrigation Development Corporation, (iv) Tapi Irrigation Development Corporation and (v) Konkan Irrigation Development Corporation. These corporations have mobilized a total funds of Rs. 9777 crore through open market upto March 2002 and plan to raise an amount of Rs. 2114 crore during 2002-03. While nobody knows the economic viability of these investments, the targeted irrigation potential through these five IDCs is estimated to be about 3.38 mha (for details see, Table 3.2).

3.2.2 Micro Irrigation Development:

Micro-irrigation includes drip and sprinkler methods of irrigation. Since water is supplied directly to the root zone of the crops under drip method of irrigation, water losses occurring through evaporation and distribution are completely reduced under this method. As a result, micro irrigation technology not only increases water use efficiency but also productivity of crops by reducing moisture stress for crops. Keeping in view the water balance of the state, initiatives have been taken during seventh plan itself to cultivate the crops under micro irrigation system. Much before the initiatives taken by the central government, Maharashtra state government introduced a state sponsored programme in 1986 with a substantial subsidy component to promote microirrigation (see, Narayanamoorthy, 1996, 1997, 2001, 2003). As a result of these initiatives, farmers belonging to different regions of Maharashtra have been cultivating many crops (mainly horticulture crops) under drip method over the last 15 years in the state. Promising results noticed by the farmers through drip method of irrigation encouraged them to expand the area under this new irrigation technology in the state. At the end of March 2002, the total area brought under drip method of irrigation was 2,17,447 ha and 87,874 ha under sprinkler method of irrigation. Importantly, Maharashtra state alone accounts for over 50 percent of India's total drip irrigated area during 1997-98, for which we

have statewise comparable data. To promote drip and sprinkler irrigation, an amount of Rs. 432 crore (Rs. 332 crore for drip irrigation and Rs. 100 crore for sprinkler) have been distributed to the cultivators in the form subsidy by the government (GOM, 2003). By restructuring the existing subsidy programmes of micro-irrigation, all the potential areas available in the state can be brought under this new method of irrigation within a limited period of time.

3.2.3 Water Users' Association (WUAs):

Involving farmers in water management activities have been proved to be very useful for both the farmers and government in different countries (see, Easter 2000; Vermillion, 1997). The National Water Policy (1987 and 2002) also emphasized the importance of farmers in systems management. Realising the importance of farmers' participation, the government of Maharashtra has taken initiatives since 1992 to form WUAs by explaining its advantage. As a result of continuous efforts by the irrigation department, about 2472 WUAs have been functioning/registered/proposed at different levels, which cover an area of 7,97,587 ha as of December 2003. Besides this, the NGOs promoted *Pani Panchayat* has been working reasonably well in many drought prone and water scarce areas in Pune district (see, Deshpande and Reddy, 1990; Thakur and Pattnaik, 2002). In order to promote users participation in irrigation management in an effective manner, the state government has also introduced "Maharashtra Farmers' Management of Irrigation System Act-2003" by giving required legal standing.

3.2.4 Watershed Development Programmes:

Considering the predominant cultivation of crops under rainfed condition, the state government introduced schemes for promoting counter bunding, nala bunding and counter trenching during third plan itself, much before the introduction of Watershed Development Programmes (WDPs) at the national level. Though WDPs were introduced on a large scale in India during the seventh plan period (1985-86), it was introduced by the state government under

Employment Guarantee Scheme (EGS) in 1982 itself, which was known as "Comprehensive Watershed Development Programme" (COWDEP). The centrally sponsored NWDPRA was introduced for the first time during 1986 in Maharashtra. Currently, WDPs are being operated under 16 different budget heads supported by central and state schemes (see, Table 3.3). Of this, 10 budget heads are operated under state schemes. Between 1992-93 and 2002-2003, a total amount of Rs. 26005.48 million has been spent on WDPs. This has also been reflected in the achievement of area treated through WDPs as well. As of March 2002, about 8322 micro watershed projects have been completed and 18391 projects are under different stages of completion. In terms of area treated under WDPs, Maharashtra's share was about 11.45 percent in the total area covered at the country level, which is about 27.5 mha at the end of ninth plan period (GOI, 2001).

3.2.5 Horticulture Development Programme:

Horticulture crops have been cultivated traditionally in the state and therefore, special attention has been given for the development of horticulture crops since third plan. Programme has been implemented to promote horticulture crops by establishing nurseries to supply genuine and quality plants of various fruit crops to farmers alongwith subsidy. The horticulture development programme got a new fillip during 1990-91, when the same was linked with Employment Guarantee Scheme (EGS), which aims to accelerate the horticulture development activities by speedy coverage of new areas under fruits and vegetables. Fifteen fruits crops (mango, cashew, bor, coconut, chicky, guava, mosambi, tamrind, etc.) as well as spices, medicinal and aromatic plants are covered under this scheme. While all the farmers are eligible to become beneficiaries of this scheme, the minimum area to avail the subsidy per beneficiary is fixed as 0.20 ha and maximum of 2.00 ha. Under this scheme, for a period of three years, farmers belonging to the weakers sections (small/marginal/ SC/ST/NTs) would get 100 percent subsidy on labour and material cost and the other farmers would get 100 percent subsidy on labour cost and 75 percent on material cost. As of November 2002, the total area brought under this scheme was 10.14 lakh hectares and the number of farmers benefited was 13.52 lakh (GOM, 2003). The impact of EGS linked horticulture development programme has been mainly seen in crops like mango, cashewnut and orange, as the area of these three crops increased by 17.42 percent per annum between 1990-91 (1.23 lakh ha) and 2001-02 (7.71 lakh ha). Relatively higher amount of profit and continuous demand for horticulture crops helped the farmers to positively respond to the promotional schemes introduced by the state government.

3.2.6 Initiatives in the Field of Bio-Technology:

Importance of bio-technology in increasing the production of agricultural commodities has been very well recognised in the recent years. In crops like banana (tissue culture) and cotton (Bt cotton), the state has already made significant progress in terms of adoption. Recognising the important role to be

played by bio-technology in agriculture in future, the government of Maharashtra has announced its "Bio-Technology Policy: 2001" in January, 2002. The main objectives of this policy are:

- Making available to the cultivators various crop varieties which are high yielding, bio-technologically improved to resist famine and pests and having capacity to sustain in the present climate.
- Deciding definitions of bio-technological products.
- Giving incentive for establishing centres of excellence for research and development in bio-technology.
- Government's participation through share in the bio-technological products.
- Making efficient and multipurpose centres providing skilled manpower to the bio-technological industries.
- For extensive propaganda of the importance and benefits of biotechnology, to formulate new system of cooperation among the scientists, entrepreneurs, extension machinery, cultivators and consumers and to encourage the media research centres in agricultural universities to undertake specific projects, etc.

3.2.7 Initiatives taken towards WTO Commitments:

One of the important issues that has been under discussion since early 1990s is how to meet the problems and constraints arising out of India's WTO commitments. Many fear and also argue that unrestricted import of certain agricultural commodities, due to WTO commitments, would adversely affect the domestic prices of agricultural commodities and thereby reduce the farm income. Keeping in view the possible impact of WTO commitments on agriculture and to protect the interest of domestic farmers, the state has identified some thrust areas, which are presented below:

Creation of awareness among the farmers and also every section of the
economy regarding the opportunities available and the challenge posed
due to the World Trade Agreements and globalisation of the world
economy. The information about WTO is being disseminated by

- Agricultural Departments through various publications, website, workshops and seminars.
- Necessity of increasing productivity with quality to face the competition arising out of WTO commitments.
- Promoting post harvest technology to reduce wastage and improve the quality of various crops. Post harvest infrastructures right from grading to cold storage, cold chain, processing, packaging and marketing are needed to be strengthened.

In addition to these initiatives, some strategies have also been formulated for the tenth five year plan period to face the constraints and problems expected to emerge due to WTO commitments, which are presented in Box 3.3.

Box 3.3: Strategies to be adopted in view of WTO Commitments

The state has made tremendous progress in horticulture after the implementation of EGS linked horticultural scheme. Though the production has increased, the facility for processing, marketing and export of agricultural produce are the need of the time. To face the constraints emerging with the implementation of WTO, the strategy for the Tenth Five Year plan will be as under:

- 1. To adopt measures to face the constraints arising with WTO.
- 2. Use of bio-technology and information technology in agriculture development.
- 3. With the implementation of new technology and WTO development of human resources and revision in various legal act and rules wherever necessary.
- 4. Integrated and sustainable use of natural resources (water and forest), reduce the cost of cultivation and increase productivity, production, use of bio-technology and support for agri-processing.

Apart from the above mentioned developmental programmes, a number of crop specific programmes have also been implemented in different plan periods by the state with the support of central assistance. Some of the important crop specific programmes are National Pulses Development Programme, National Oilseed Production Programme, Intensive Cotton Development Programme, Schemes on Sustainable Development of sugarcane based cropping system, etc.

On the whole, our review on the initiatives taken by the state government for the development of agriculture suggests that the government has been taking conscious efforts keeping in view the changing nature of agriculture as well as recent development in agriculture, both at the state as well as at the country level. However, one does not clearly know how the programmes have been implemented at the field level and what kind of benefits these programmes have brought to the farming community living in different regions in the state. Evaluation studies focusing on each scheme can only bring out the real impact of various schemes on farming community.

Major Constraints in Maharashtra's Agriculture

4.1 Introduction:

So far, we have studied the development of agriculture as well as the major initiatives taken by the government during different plan periods to improve the performance of agriculture in the state. Despite various initiatives taken by the government to accelerate the growth of agriculture, the performance of agricultural sector in the state is not very impressive as compared to many states in India, owing to many constraints. The contribution of agricultural sector to the state's income has gone down from about 34 percent in 1960-61 to 16 percent in 2001-02 partly because of poor agricultural growth. But, on the other hand, the percentage of population relying on agriculture has declined only marginally between 1960-61 and 2000-01. There are a number of factors which limit the growth of agriculture over the years in the state. While it is difficult to discuss each and every factor that affects the growth of agriculture, we try to highlight the major constraints faced by the agricultural sector of Maharashtra in this chapter.

4.2 Wide Variation in Rainfall:

As mentioned earlier, over 83 percent of cropped area is cultivated under rainfed condition in the state. Therefore, monsoon rain plays a critical role in the development of agriculture. Though the average rainfall of the state is higher than the national average, nearly one-third area of the state falls under rain-shadow region where the rain is scanty as well as erratic (GOM, 2003e). About 25 districts out of 34 receive normal rainfall less than the state's average (see, Table 4.1). Not only this, the variation in rainfall across different blocks within the district as well as across different years is also found to be higher (see, Figure 4.1). This wide variation in rainfall acts as one of the major constraints in state's agriculture. An analysis shows that the productivity of agricultural commodities goes down sharply whenever there is a reduction in rainfall (Figure 4.2). This is because of the fact that foodgrains and other crops are cultivated predominantly

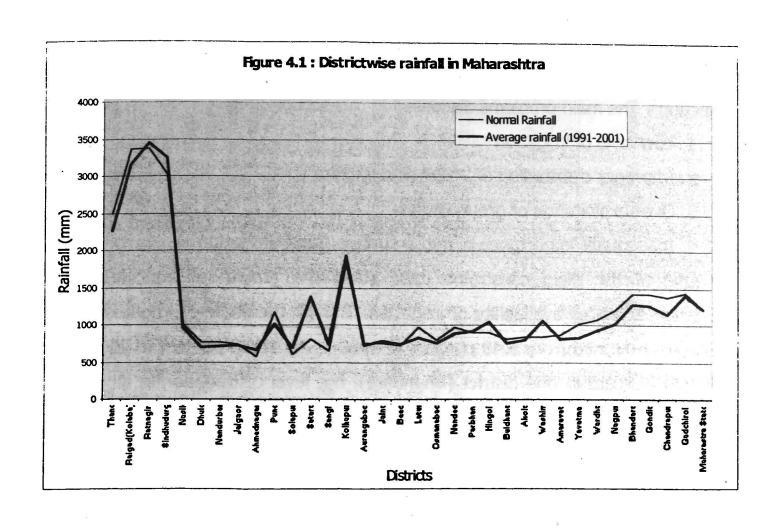
in those districts which receive relatively less-normal rainfall. As providing assured irrigation facility for all those districts which have low rainfall is very difficult because of limited irrigation potential, proper rainwater harvesting programmes (watershed development programme, etc.) would help to improve the productivity of crops and thereby the overall performance of agriculture.

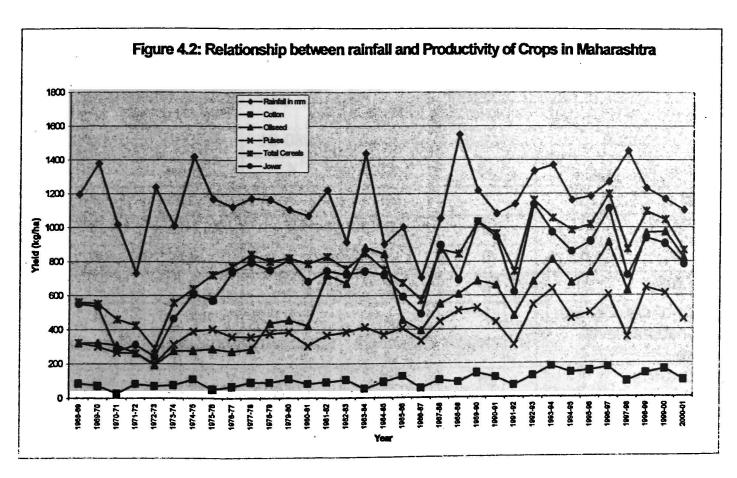

4.2 Constraints relating to Irrigation:

The irrigation sector of Maharashtra State has been facing various problems including financial problems over the last many years. Since our focus

here is to bring out the main constraints that limit the growth of agriculture, the problems associated with financial matters of irrigation sector are not discussed in this section¹. The main problems discussed in this section are:

- 1. Low level of irrigation
- 2. Improper distribution of water across crops
- 3. Over exploitation of groundwater
- 4. Inadequate importance to minor surface (tank) irrigation

One of the main constraints that affect the growth of agriculture in Maharashtra is limited availability of irrigation. Though the share of irrigated area to GCA has increased from 6.48 percent in 1960-61 to 16.38 percent in 2001-02 in the state, except in one district (Bhandara), the level of irrigation in all other districts is well below the national average even in 2000-01 (see, Tables 4.2 and 4.3). In fact, the percentage of irrigation is less than 15 percent in 14 out of 29 districts in 2000-01. This kind of situation is seldom seen in any of the states in India. The low level of irrigation as well as the erratic rainfall pattern often discourages the farmers to take up intensive cultivation in many regions in the state.

Inspite of limited availability of irrigation, the available irrigation water is not distributed properly across different crops, which is another important issue of Maharashtra's irrigation sector. Out of the total irrigated area of 3.55 million hectares available during TE 2000-01, foodgrain crops such as paddy, wheat, jowar and bajra together accounted for only 45.89 percent, while sugarcane alone accounted for over 18 percent. Pulses and oilseeds are the important crops in Maharashtra accounting about 28.33 percent of GCA in TE 2000-01, but these two crops together accounted for only about 14.50 percent of irrigated area during the same period (see, Table 4.4). Though the net returns per unit water generated by sugarcane is very low when compared to most of the foodgrain crops (see, Table 4.5), some estimates show that nearly two-third of irrigation water available in the state is used only by sugarcane, which accounts for only around 2.60 percent of gross cropped area (World Bank, 2002). Irrigated sugarcane area accounted for over 18 percent of GIA in the state, which is very high when compared to the national average of about 5 percent during 2001-02. Despite severe water scarcity in the state, area under sugarcane increased at the rate of over 2.62 percent per annum between TE 1992-93 and TE 2001-02. Recent data also indicate that the major share of additional irrigated area created in the state is still used for cultivating sugarcane crop. The predominant use of water for cultivating sugarcane crop limits the intensive cultivation of foodgrain and other crops in the state.

Over exploitation of groundwater is another important issue associated with the irrigation development of Maharashtra State. As per CWC (2002) data, though the state has utilised only 30 percent of its groundwater Irrigation potential (25.47 BCM per year), there has been a substantial increase in the exploitation of groundwater in the recent years mainly due to increase in number of wells, electrification of pumpsets as well as intensive cultivation of irrigated crops like sugarcane, banana, etc. District-wise data show that except six districts (mainly from the division of Konkan and Nagpur), the share of groundwater irrigated area to net (total) irrigated area is varied from 58 to 98 percent. Importantly, out of 30 districts presented in Table 4.6, as many as 13 districts are having over 80 percent of irrigation through groundwater alone. This clearly

suggests how intensively groundwater is used for cultivating crops in the state. The continued exploitation of groundwater has lead to failure of wells in certain parts of the state as the acquifer in hard rocks have limited quantity of stored water (Pathak et al., 1999). Unless steps are taken to reduce the exploitation of groundwater through legal, institutional and technological options, this will have serious implications on the future growth of agriculture in the state.

4.3 Cultivation of Low Value Crops:

One of the important reasons for the limited growth of agriculture in Maharashtra state is the predominant cultivation of low value crops. Though the cropping pattern has been shifting in favour of high value crops in the state in the recent years as compared to seventies and eighties, this shift is not very impressive as compared to the same at the national level (see, Table 4.7). For instance, coarse cereals (which are mainly low value crops) accounted for only

about 15 percent of GCA at all India level during 2000-01, but the same accounted for over 34 percent in Maharashtra. Similarly, the share of area under pulses has declined about 3 percent points at all India level between 1970-71 and 2000-01, but the same has increased by about 2.30 percent points in Maharashtra during the same period. Area under oilseeds and cotton² is also substantially higher in Maharashtra (a total of 25.38 percent of GCA in 2000-01) as compared to all India average (16.24 percent). The main reason for the predominant utilisation of low value crops in Maharashtra is the limited availability of irrigation. Therefore, greater attention needs to be given to accelerate the availability of irrigation and moisture (through watershed development programme) to shift the crop pattern in favour high value crops.

4.4 Variation in Input Use:

Substantial variation in the use of inputs (irrigation, fertilisers and HYVs) across different regions in the state is also one of the constraints for agricultural growth. As can be seen from Tables 4.8 and 4.9, the use of both fertilisers and HYVs significantly varies across regions in Maharashtra. The use of fertilisers is found to be very low in divisions like Konkan, Latur and Amravati as compared to the state's average. Poor irrigation facility coupled with the cultivation of low value crops are the main reasons for the low use of yield increasing inputs like fertilisers. Besides low use of fertilisers, improper application of fertilisers (N P K ratio) also affects the productivity of crops and thereby the growth of agriculture (see, Table 4.10). While making efforts to improve the use of yield increasing inputs through increased irrigation facility and moisture availability, proper use (mix) of fertilisers should be promoted through quality extension network.

² We are aware of the fact that oilseeds and cotton are generally treated as high value commercial crops. However, since these crops are cultivated predominantly under rainfed condition and also the productivity of these crops are very low in Maharashtra, we have considered them as low value crops for the purpose of analysis.

4.5 Mono-Cropping Pattern:

Predominant practice of mono-cropping pattern is also one of the problems of Maharashtra's agriculture. Sugarcane has been cultivated repeatedly in Western Maharashtra over the last four decades. Pune and Kolhapur divisions together account for nearly 60 percent of sugarcane area even today (see, Table 4.11). As a result of this undesirable practice, not only the soil fertility has deteriorated over the years but the productivity has also stagnated or declined due to certain pests and diseases associated with mono-cropping pattern. Unlimited supply of canal water for cultivating sugarcane crop and the support by the sugar industries for cultivating sugarcane are the two main reasons for the prevalence of mono-cropping pattern in the state. By introducing volumetric pricing for canal water, cultivation of sugarcane may be discouraged in those areas where the productivity is stagnating or has started declining.

4.6 Slow Progress in Watershed Development Programme:

With an aim to increase the production of crops in rainfed areas and to prevent the deterioration of natural resources, the government of Maharashtra started implementing watershed development programmes (WDPs) extensively

much before the introduction of centrally sponsored National Watershed Development Project for Rainfed Areas (NWDPRA). No doubt, as a result of concerted effort, area treated through WDPs has increased substantially in the state. However, the progress and achievements made in this respect are not very appreciable when compared to its potential area. According to the estimate of Directorate of Soil Conservation and Watershed Management (DSC & WM), the total potential area available for WDPs is about 20.36 mha (see, Table 4.12). Of this total area, only about 3.15 mha have been treated upto March 2002. This means that only 15.47 percent of potential area has been treated through WDPs since 1983, the year in which the state started implementing WDPs. The average treated area from 1983 to 2002 comes to only 0.166 mha per year. With this current rate of growth, it may take more than 100 years to treat all the remaining potential area, which is about 17.21 mha (potential area of 20.36 mha minus treated area of 3.15 mha as of March 2002).

Besides slow progress of WDPs, adequate importance has also not been given for those areas/regions, which has relatively more rainfed areas and less normal rainfall (see, Table 4.13). For instance, about 94 percent of area in Amravati division is rainfed, but only 12 percent of its area has been treated through WDPs upto 2001-02. This needs to be avoided and priority should be given to those regions which have more drought prone as well as degraded area,

as suggested by the 10th Plan Working Group on Watershed Development, Rainfed Farming and Natural Resource Management (GOI, 2001a).

Since Maharashtra State has over 83 percent of cropped area under rainfed condition and the rainfall is also low and varied in majority of the districts, highest priority needs to be given to treat all the potential area through watershed development programme as early as possible. Studies have shown that watershed development programme has made significant impact on production and productivity of crops besides changing the cropping pattern in favour of high value crops in different regions in India (see, Table 4.14)³. The future performance of agriculture in Maharashtra will heavily depend on the extent of coverage of watershed programme because of its limited irrigation facility.

4.7 Constraints in Horticulture Development:

Though significant growth has taken place in area under horticultural crops in the state between 1980-81 and 1997-98, the horticulture sector is not free from problems. The major problems that are expected to limit the growth of horticultural sector in Maharashtra are:

- Less diversification of crops in non-traditional regions
- Deceleration in area and productivity of certain crops
- Poor post harvesting infrastructure facilities

Despite significant potential for horticulture crops in different regions in Maharashtra, the growth in area under horticulture crops in non-traditional districts is not very impressive as of today. For instance, horticulture crops have been traditionally and also predominantly cultivated in districts like Ratnagiri, Nasik, Jalgaon, Ahmednagar, Pune, Solapur, Satara, Amravati and Nagpur. These nine districts accounted for over 57 percent of the total area under horticulture crops in the state during TE 1966-67 and these same districts have also accounted for almost the same share (nearly 56 percent) in 1997-98 as well (see, Table 4.15). Importantly, the share of area under horticulture crops has marginally declined between TE 1966-67 and TE 1997-98 (by over 2 percent points) in Western Maharashtra⁴, where water is heavily used for cultivating sugarcane. As mentioned earlier, since the limited availability of irrigation water is the main constraint for agricultural growth in the state, required steps need to be taken to increase the area under horticulture crops in those areas where sugarcane is cultivated predominantly so that the surplus water arising due to the cultivation of horticulture crops can be transferred to other regions or for other crops.

Though lot of euphoria has been created in the state quoting that linking of EGS with horticulture development programme has made significant improvement in the growth of area under horticulture crops, our growth analysis does not completely support this (see, Table 4.16). While the growth rate of area under

decelerated in almost all vegetable crops during the nineties as compared to the growth realised during the eighties. As future growth of agriculture in the state is heavily dependent on the performance of horticultural sector because of its natural advantages, it is essential to examine why the growth rate of area under certain horticultural crops decelerated during the nineties.

Another important problem associated with horticulture sector is declining productivity of horticulture crops. Productivity of important horticulture crops namely orange and mango has declined between 1990-91 and 2001-02 (see, Table 4.17). This is not an encouraging sign as far as the horticultural sector of the state is concerned. Reduction in productivity would not only affect the growth of the horticultural sector but would also affect the overall performance of agricultural growth in the state. Therefore, it is essential to examine the causes for declining productivity of major horticulture crops in those regions where productivity started declining.

Inadequate post harvesting infrastructure facility is another important constraint faced by the horticultural sector of Maharashtra. As most of the horticultural crops are easily perishable, post harvesting facilities such as cold storage, cold chain, processing, packaging and marketing are essential to avoid wastage. Studies have also pointed out the necessity of infrastructure facilities to sustain as well as accelerate the present growth of horticultural sector (Chengappa, 2003; Mahendra Dev, 1996). Farmers may not be able to create post-harvesting facilities on their own because it requires a large amount of capital. Therefore, the state will have to play a larger role in establishing infrastructure facilities to promote the horticultural sector in the state. Involving private sector in marketing and processing activities as well as encouraging contract farming in the cultivation of horticultural crops may help to reduce the problems associated with post-harvesting of horticultural crops.

4.8 Low Productivity of Crops:

Low productivity of different crops is one of the major problems of Maharashtra's agriculture. Except sugarcane and some horticulture crops, productivity of all other crops is found to be very low in the state as compared to the national average, as discussed earlier in chapter two (GOI, 2002). Low productivity of crops pulls down the overall growth rate of agriculture in the state, besides reducing farmers' income.

Apart from low productivity of crops, the growth rate of productivity of almost all the major crops either decelerated or declined during the second part of the green revolution period, i.e., 1985-86 to 2000-01 (see, Table 4.18). Importantly, productivity of sugarcane, which is an important irrigated crop in Maharashtra, has declined during the nineties as compared to the earlier decades (see, Table 4.19 and 4.20). Poor irrigation facilities, unfavorable soil and climate condition, variation in rainfall and mono-cropping pattern are some of the major reasons for the deceleration in productivity growth in Maharashtra.

In addition to low productivity and deceleration in the growth rate of productivity, wide variation in productivity of different crops across districts is also an another problem of the state's agriculture (see, Table 4.21). Though wide

variation is found in almost all crops, highest variation is seen in crops like paddy, bajra, tur, groundnut, total oilseeds and cotton. Available data also suggest that the gap in crop productivity among different districts is widened over the last 20 years in Maharashtra. A large number of districts still come under the group of very low level of productivity due to low rainfall and limited access to irrigation (see, Table 4.22). Though various policy measures have been introduced to improve the productivity of various crops, not much improvement has taken place in productivity over the last four decades in certain important crops. Therefore, in order to increase the productivity of crops in short span of time, more location specific policies/programmes need to be introduced, especially in those districts that have very low productivity in different crops.

4.9 Marketing Problems:

In addition to the above-mentioned problems, farmers of Maharashtra state have been facing inadequate marketing and post-harvesting facilities over the last several years. Though the level of spread of regulated markets is relatively better in Maharashtra, it could not solve the marketing problems faced by the farmers (Table 4.23). Due to inadequate marketing facility, the exploitation by middlemen from the farmers and post-harvest losses to farmers have been continuing. As mentioned in the National Agriculture Policy: 2000 (GOI, 2000), the weekly markets under the direct control of Panchyat raj institutions should be encouraged and strengthened. Producers markets on the lines of "Ryatu Bazars" (as has been followed in Andhra Pradesh and Tamil Nadu) should be promoted across different districts in Maharashtra to reduce the exploitation by middlemen from farmers.

On the whole, it is clear from the above discussion that the agricultural sector of Maharashtra has been facing a number of different problems over the last many years. It appears that among the various problems, limited availability of irrigation is one of the major problems, which hinder the growth of agriculture in the state.

Agricultural Policy for Maharashtra State

5.1 Introduction:

As mentioned in the earlier chapters, though Maharashtra is one of the richest states in terms of per capita income, its agricultural performance is not very appreciable. Having accounted for about 12 percent of India's gross cropped area (in 2001-02), the contribution of state's agriculture in the agricultural GDP of the country is only about 7.30 percent in 2001-02, mainly due to predominant cultivation of crops under rainfed condition. Keeping in view the importance of agriculture, the government of Maharashtra over the years has taken a number of initiatives to improve the performance of agriculture. As a result of initiatives taken by the government, the agricultural sector of Maharashtra has undergone lot of changes. But, still it is lagging behind in many parameters as compared to the national average (see, Table 5.1). Therefore, there is a need to make changes in the existing policies followed in the state to strengthen the agricultural sector in view of the recent changes in domestic and international front. It is in this context, in this chapter, we present the strategies that need to be followed to improve the overall performance of the state's agriculture in the future.

5.2 Investment in agriculture and allied activities:

Adequate investment in agriculture is one of the pre-requisites for increasing as well as sustaining the growth of agriculture. However, the plan expenditure on agriculture and allied activities to total plan expenditure has declined sharply from 30.87 percent in the third plan (1961-66) to 4.98 percent in the ninth plan period (1997-2000) in Maharashtra. Since the reduction in plan expenditure will affect the research and development activities pertaining to agricultural sector, it will have serious implications on the agricultural growth of Maharashtra in the future. Therefore, the state government (state planning commission) should take necessary steps to increase the plan expenditure on agriculture and allied activities to boost the growth of agriculture in the state.

5.3 Irrigation Development:

Low irrigation facility has been one of the main reasons for the poor performance of the agricultural sector in the state. Though Maharashtra state accounted for about 17 percent of India's total irrigation investment at the end of ninth plan period, its irrigated area to gross cropped area is only 16.38 percent in 2001-02, which is the lowest among the major states in India. In fact, out of 29 districts, 14 districts are having less than 15 percent of irrigation facility in 2000-01. The following four strategies can be followed to increase the irrigation facility in the state. First, adequate funds should be allotted to complete all the on-going projects. If required, no more new projects should be sanctioned till the completion of all the on-going projects. Second, inspite of water scarcity, nearly two-third of irrigation water available in the state is used only by sugarcane crop. which accounts for only 2.60 percent of GCA in the state (World Bank, 2002). This improper use of water can be adjusted by manipulating output price of crops and also by introducing volumetric pricing in canal water supply. Third, more attention should be given to improve minor-surface irrigation system (which have been neglected by the state) wherever possible through renovation and other developmental activities. Four, the projected (notional) cropping pattern should be strictly followed in each command area.

To sustain the groundwater irrigation development, the over exploitation of groundwater should be curbed through legal, institutional and technological options. Currently, out of 30 districts, as many as 13 districts are having over 80 percent of irrigated area only through groundwater source. Drip method of irrigation, which is being increasingly adopted in the state, should be made mandatory in those regions where exploitation of groundwater is higher. To improve the water use efficiency and the overall performance of irrigation sector in the state, adequate steps should be taken to transfer the system control to Water Users' Association, as has been suggested by the National Water Policy (GOI, 1987; 2002).

5.4 Watershed Development Programmes (WDPs):

Maharashtra state has been implementing WDPs since 1982 to improve the performance of rainfed agriculture. As a result, area treated through WDPs has increased substantially. However, the achievements made (treated area as of March, 2002 was 3.15 mha) in this respect are not very appreciable when compared to the potential area of WDPs, which is about 20.36 mha. The average treated area from 1983 to 2002 comes to only 0.166 mha per year. With this current rate of growth, it may take more than 100 years to treat all the remaining potential area through WDPs. Therefore, keeping in view the importance of rainfed cultivation, necessary steps should be taken to bring all the potential areas under WDPs within 10 to 15 years by allocating more funds for the same. While selecting areas for treatment, priority should be given to those regions which have more drought prone as well as degraded area, as suggested by the 10th Plan Working Group on Watershed Development, Rainfed Farming and Natural Resources Management (GOI, 2001).

Presently, WDPs have been operated by different department/agencies in the state without coordination by any single agency. This does not allow us to know the overall working conditions of WDPs including utilisation of allocated funds. Therefore, there is a need to develop convergent approach between various departments to operate WDPs more efficiently, both in terms of utilisation of funds and identifying areas for treatment.

5.5 Rainfed cultivation:

Predominant cultivation of crops under rainfed condition is the main feature of Maharashtra's agriculture, as its irrigated area to gross cropped area is only around 17 percent as of today. Though the average rainfall of the state is higher than the national average, about 73 percent of districts (25 districts out of 34) receive normal rainfall less than the state's average. Besides reducing productivity of crops, this low and varied rainfall pattern increases the risk of farmers. In order to improve as well as to sustain the cultivation of rainfed crops, the state should focus more on watershed development programme and rainwater harvesting system. By introducing short-duration varieties as well as

more location specific cropping pattern, the performance of rainfed cultivation can be improved and sustained.

5.6 Low value crops:

Though the cropping pattern has been changing in favour of high value crops in the state, this shift is not very impressive as compared to the national level change. During 2000-01, for instance, coarse cereals accounted for over 34 percent of GCA in Maharashtra, whereas the same was only 15 percent of GCA at all India level. As a result of cultivation of low value crops, farmers' income (per ha) from agriculture is very low in the state (see, Sawant, et al., 1999). Since limited availability of irrigation is considered to be the main reason for this, greater attention should be given to utilise the available irrigation potential wherever possible. In those regions where utilisable irrigation potential is less, moisture availability can be increased through WDPs.

5.7 Cultivation of Pulses and Oilseed Crops:

Pulses and oilseed crops have been predominantly cultivated (accounted for about 27 percent of GCA in TE 2001-02) in Maharashtra, mainly under rainfed condition. Productivity of these crops is relatively low in the state as compared to the national level average. Considering the importance of these crops, proper attention should be paid to increase the production and productivity of these crops by popularising the use of bio-fertilisers and bio-pesticides. Special efforts should also be made to cultivate these crops under inter-cropping method wherever possible. Proper marketing arrangements should also be made to procure the oilseeds and pulses from the farmers in order to encourage the cultivation of these crops.

5.8 Mono-cropping pattern:

Sugarcane, a water-intensive crop, has been repeatedly cultivated in Western Maharashtra over the last four decades. Pune and Kolhapur divisions together account for nearly 60 percent of state's sugarcane area even today. This mono-cropping not only affected productivity of sugarcane but also deteriorated

soil quality and brought certain pests and diseases in this region. Unlimited supply of canal water and continuous support to sugarcane growers by sugar industries appear to be main the reasons for this mono-cropping. Supply of canal water to sugarcane by volumetric pricing may discourage the mono-cropping pattern.

5.9 Use of technological inputs:

There has been a substantial variation in the use of yield increasing inputs (fertilisers, HYVs) across regions in the state, which also acts as one of the constraints for agricultural growth. The use of fertilisers (per ha) is found to be very low in divisions like Konkan, Latur, and Amravati as compared to state's average. Besides this, wide variation in NPK ratio is also seen across regions in the state. While making efforts to improve the use of yield increasing inputs, proper mix of fertilisers should be promoted to sustain the soil fertility, through quality extension network. Clear-cut crop-specific and region-specific programmes/policies would bring desired results in this regard.

5.10 Horticulture Development:

A significant growth has been achieved in area under horticultural crops between 1980-81 and 1997-98 in the state. In order to continue the same kind of growth in the coming years, it is essential to (a) diversify the crops to non-traditional area, (b) arrest the declaration in area and productivity of certain crops, and (c) improve the post-harvesting infrastructure facilities.

Despite significant potential in different regions in the state, area under horticulture crops has not picked up in non-traditional areas, including Western Maharashtra. Therefore, required steps should be taken to increase the area under horticulture crops in those areas where sugarcane is predominantly cultivated so that surplus water can be transferred to other crops and other regions as well.

The growth rate of area under grapes, banana and most of the vegetable crops either declined or decelerated during the nineties as compared to the achievements made in the eighties. It is essential to examine why the growth rate of area under certain horticulture crops decelerated during nineties. Similarly,

productivity of crops like orange and mango has also declined between 1990-91 and 2001-02 in the state (GOM, 2003). As the future growth of the state's agriculture heavily relies on the performance of horticulture sector, the reduction in productivity is likely to affect the overall growth of the sector. By introducing tissue culture varieties (wherever possible) and also by replanting new varieties where age-old crops/plants are cultivated, productivity of horticulture crops can be increased. There is also a need to examine the causes for decline of productivity of major horticulture crops, especially in those regions where productivity started declining.

As pointed out by studies, there is also a need to improve the post harvesting infrastructure facilities (such as cold storage, cold chain, processing, packaging and marketing) to sustain as well as accelerate the present growth of horticulture sector. The state sector will have to play a larger role in establishing infrastructure facilities to promote horticulture sector in the state, as private individual farmers may not be able to create the same due to resource constraints. Involving private sector in marketing and processing activities as well as encouraging contract farming in the cultivation of horticulture crops may help to improve the availability of post harvesting infrastructure facilities.

5.11 Productivity of crops:

Except sugarcane and some horticulture crops, productivity of all other crops is very low in Maharashtra as compared to the national average. Apart from reducing farmers' income, the low productivity of crops pulls down the over all growth rate of state's agriculture. More importantly, the growth rate of productivity of almost all major crops either decelerated or declined during the second part of green revolution (i.e., 1985-86 to 2000-01). Wide variation in productivity of different crops across districts is also another feature of Maharashtra's agriculture. Since low irrigation facility and variation in rainfall are considered to be the important factors responsible for low and varied productivity level, major initiatives need to be taken to increase irrigation facility wherever possible. In those areas where irrigation potential is low, watershed development programmes should be promoted. Introduction of drought resistance cum high

yielding varieties, promoting balanced use of fertilisers (appropriate ratio of NPK) and well designed location specific policies/programmes can help to increase the productivity of crops appreciably.

5.12 Marketing infrastructure:

A well-developed marketing infrastructure is essential to reduce post harvest losses and also to ensure better return to the farmers. Though Maharashtra state has relatively more number of regulated markets, farmers continue to face lot of difficulties while selling their produce. Exploitation by middlemen from the farmers have been continuing due to inadequate marketing facilities. Therefore, as suggested by the National Agricultural Policy: 2000 (GOI, 2000), the weekly markets under the direct control of Panchayat Raj institutions should be promoted and strengthened. Producers markets on the lines of "Rayatu Bazar" (as has been followed in Andhra Pradesh and Tamil Nadu) should be promoted across different districts in Maharashtra to reduce the exploitation by middlemen from the farmers. Importantly, rural road network should also be strengthened to enhance the marketing facilities in the state.

On the whole, it appears from our analysis that, in order to improve the overall performance of agriculture, the government of Maharashtra should focus mainly on three areas: (a) irrigation development, (b) watershed development programme and (c) horticulture development programme. Once irrigation availability is improved, the other problems such as predominant cultivation of low value crops, wide variation in the use of yield increasing inputs, low productivity of crops, etc., can be solved to a great extent.
