BULDANA - DISTRICT

A Socio - Economic Review

Introduction:

Physical & General Conditions:

1. Buldana District has been named after Buldana town which was selected as the seat of the District Heat Quarters in the year 1867. The District stretches out into the Deccan Plateau and lies between 19.51°, 21.17° North and 76.49° and 75.57° East. Situated at the West end of Vidarbha Region of the new Bombay State, the district is bounded on North by Nimar District of Madhya Pradesh, on the West by East Khandesh, on the south and south-west by Parbhani and Aurangabad Districts and on the east by Akola District. It covers an area of 3766 square miles, of which rural area accounts for 3754 square miles, thus being the fifth in point of size among the districts of Vidarbha region. The percentage of area of Buldana district to that of the total area of Vidarbha region works out to 10.2 while the percentage of population of Buldana district to that of Vidarbha region comes to 11.5. The total population of the district forms 1.4% of the total population of Bombay State while a portion of the district forms 1.9% of the total area of the state.

2. The entire region is one single administrative unit with two natural sub-divisions. Out of the five taluqs now forming the district, the taluqs of Mehkar and Chikhali lie on the Balaghat Plateau, while the rest of the taluqs, viz. Malkapur, Khamgaon and Jalgaon are in the Great Plain below known as the Payanghat. There are thus two natural sub-divisions which correspond closely with the administrative sub-divisions of the district. The edge of the Plateau where it falls abruptly into the valley is intersected by numerous deep ravines.

3. Buldana has no mountains worth the name except that the portion of the district lies on the plateau which has a considerable altitude. There are some hills and elevations of which Gawilgarh Hills are worth mention. The elevation of the three plain taluqs of Malkapur, Khamgaon and Jalgaon varies from 865 to 910 feet above the sea level while the elevation of Chikhali and Mehkar table land varies from 1736 to 2415 feet above the sea level. Buldana town itself is pleasantly situated at an elevation of 2190 feet. The altitude of the plateau region is of considerable utility and is useful to mitigate the rigours of climate. Extremes of heat and cold are comparatively less and Buldana town especially, can be compared favourably with any moderate hill station of some importance in the state.

4. The type of mountains in the district and their broad features would enable us to get an idea of the nature of rivers in the district. The Penganga which may be called the principal river in the district rises in the hills near Deulghat in Buldana District only. It flows in south easterly direction past Mehkar

and then enters Akola District so as to form the southern boundary of that district. It collects the drainage of Mehkar and partly of Chikhli taluqs and eventually falls into Wardha river near about Chanda. It may be pointed out here that the plateau and the hills in this region are only rain-fed and devoid of adequate vegetation as such the rivers which rise from them are not generally perennial; so is the case with the rivers in Buldana district. Penganga is almost dry in summer. The other river which runs parallel to and in a south-easterly direction is Kate or Lower Purna. It rises in the Ajanta hills to the west of the district and flows past Deulgaon-Raja, a little to the north and across Mehkar taluk and falls into Godavari. It is also dry in the hot season. Both these rivers are important tributaries of Godavari. The only perennial stream is in the Great Payanghat Plain and that is the River Purna which rises in the lower portion of the Gawilgarh hills in Amravati district. It flows across the northern part of the district to join Tapti in East Khandesh district. Its principal tributaries within the district are the Nalganga, the Vishwaganga, the Gyan and the Bari.

5. The flora of this district may conveniently be divided into two types following the natural sub-divisions viz., The Plains type and the hills type. The species that grow in the plains are the 'Babul', 'Nim', 'Murmati', 'Hiwari' etc., while 'Anjan' dominates the hills type. The other species that frequently occur in the hills are the 'Teak', 'Saldan', 'Damora', 'Lendia', 'Tiwas', and 'Ber'. Bamboo abounds in the Ambarwara Reserves and in the inaccessible ravines in the Ajanta Hills. The species found in the plains provide mostly fuel and a certain number of species mentioned above are common to both.

6. Buldana District is devoid of dense forest, hence it is not famous for wild animals. Certain reserves and forest blocks such as the Ambarwara Reserve in Satpura Hills, and Ghatbori forest etc. are the abodes of panthers, tigers and hunting leopards. The other common species found in the district are wild boar, wild dog, bear, blue bull, bison, spotted deer, jungle cat and wild birds.

Climate, Temperature and Rainfall:

7. The climate of the district in general is dry and hot but considered to be generally healthy. The mean maximum and the mean minimum temperatures in centigrades for months of January, May, July and November for the years 1955 to 1958 for Buldana Centre, are shown below:-

8. During these years the highest temperature recorded was 45.0 and the lowest was 11.00 C. These figures are typical of the Balaghat Plateau or the Mehkar and Chikhali taluqs only. There, the hot weather sets in late and the heat is never intense. The rainy season is pleasant and the cold weather is cool and invigorating. Buldana town itself is the coolest and the most pleasant district head quarters in Vidarbha region. The climate of the Payanghat or the taluqs of Khamgaon, Malkapur and Jalgaon affords a great contrast. The heat is intense in this region and specially in the months of March, April and May; it is perhaps as great as in the hottest part of India. The strong westerly winds which then prevail become intensely heated and exercise their parching influence.

9. Considering the available rainfall statistics for the last 45 years it appears that there is a gradual decrease in the rainfall of the district. An average annual rainfall of about 76 to 89 Centimeters was recorded during the decade ending 1931; whereas 71 to 81 Centimeters of rainfall was recorded during the decade ending 1931. The average annual rainfall during the years 1956 and 1957 was 68.55 and 64.24 Centimeters respectively while it is 87.03 Centimeters during the year 1958. Generally, more than the normal rainfall was recorded at all the 12 places in this district during the year 1958. The rainfall registered at the 12 stations for the period 1956 to 1958 is shown below:-

General Administration:

10. For administrative convenience, the district which consists of 1188 villages and 9 towns has been divided into five taluqs, Chikhali lying in the centre, Mehkar to the south, Malkapur to the north and Jalgaon and Khamgaon to the north-east. The five taluqs are further divided into twenty-six Revenue Circles. The taluqwise figures of number of villages and towns, urban and rural areas and population are given below:-

II. Mehkar is thus the largest in respect of area and Malkapur in population while Jalgaon is the smallest in both respects. The only other taluk in the neighbouring districts of Akola and Amravati which is sparsely populated and less than that of Jalgaon taluk is Melghat taluk in Amravati district; but the area of this taluk 1546 Sq.miles is the largest of all taluks in the three adjoining districts of Vidarbha and is more than three times that of Jalgaon taluk itself.

I2. Buldana town is the Head Quarters of the District. The Collector is the Head of the District. He is also the District Magistrate and District Registrar as well. He is assisted by ten Extra Assistant Commissioners who are known as Deputy Collectors in Maharashtra State in his day to day administration. Of these, a senior most is appointed as a Personal Assistant to the Collector and is stationed at the District Head Quarters. Another is an Additional District Magistrate and is stationed at Khamgaon. One Deputy Collector is designated as Treasury Officer with his Head Quarters at Buldana, two Deputy Collectors are designated as District Project Officer and District Village Panchayat Officer with their head quarters at Buldana. The remaining five are designated as Sub-Divisional Officers with their head quarters at Malkapur, Buldana, Mehkar, Jalgaon, and Khamgaon.

I3. These Officers are further assisted by five Tahsildars and fourteen Naib Tahsildars. The district is further divided as mentioned earlier into 26 Revenue Circles and each circle is looked after by a Revenue Inspector, assisted by a number of Patwaris, depending on the area and the volume of work in a particular circle. There are in all 523 Patwaris functioning in the district.

I4. It is customary to locate other offices of the Govt. at the district head quarters for facilitating coordination and smooth working of Government machinery. The following are the principal district officer in the district besides the office of the Collector and the District Magistrate.

Population:

15. The district is really a land of small villages and in the absence of numerous large towns and important industries, the nature of population is essentially agricultural. The bulk of the population of the district is either engaged directly in agriculture or is indirectly dependent on the land for means of subsistence. Like most of the districts in Vidarbha Buldana District is for all practical purposes a land of peasant proprietors. The proportion of population in rural areas is considerably high when compared to that of the adjoining districts of Akola and Amravati. The urban rural population percentage ratio in Akola and Amravati districts is 22:78 and 27:73 respectively while that of Buldana is 16:84.

16. The population of the district according to the 1951 Census is 870,168 of which 439,270 or 50.48 percent of them are males while 430,898 or 49.52 percent of them are females. The rural and urban population according to the same source is 726,571 and 143,597 respectively. The urban rural ratio works out to 16:84. The density of population in the district is 231/as against 204 in 1931. By density of population we mean the number of persons dwelling upon a unit area of land and the unit adopted in all cases is generally a square mile. This however, does not imply that the persons within this unit area are uniformly distributed over it. It all depends upon the natural features of the district, the type of soil, the rainfall, the climate and all these factors may be expected to have their effect upon the density of population. Although the rainfall is low in Buldana District, the rich soil productive of valuable crops, provides a maintenance for a large population. In fact, it is this factor alone which accounts for such a high density of population in the district. The density of population per square mile in Buldana is much higher than that of Vidarbha which is only 206 persons per square mile.

I7. The density of population in Malkapur, Khamgaon and Chikhali is considerably higher when compared with other towns of similar size in the district. It is because Malkapur and Khamgaon have large commercial and Industrial population. Chikhali has risen to the rank of a town in recent years while Mehkar and Jalgaon are still rural in character.

I8. The table above indicates comparative figures of population in the district with those of the previous censuses. The number of females per 1,000 males in 1901 was the highest (992), but it dropped considerably during the decades following. It made a slight recovery during the decade ending 1951 when it was 981 females per 1,000 males. The net variation between 1901 and 1951 is 252,178 which is much higher than that of all Akola District.

19. The classification of population into several livelihood categories is important in so far as it indicates in several ways the stage of economic development of the district concerned. Examining the above table we find that 77.3 percent of the population of the district are cultivators, cultivating labourers and their dependents while only 2.6% of the total population belongs to the non-cultivating owners of land, agricultural rent receivers and their dependents. On a further analysis of agricultural classes (77.3%) it is found that 40.4% of them are cultivators of land wholly or mainly owned and their dependents; 5.5% of them are cultivators of land wholly or mainly unowned and their dependents; while 31.4% of them are cultivating labourers and their dependents. The percentage of persons engaged in production other than cultivation comes to 6.7 and the percentage of persons engaged in commerce, transport, other services and miscellaneous services comes to 4.9, 0.68 and 7.7 respectively.

20. It may be observed from the table that a high %age of rural population belonging to agricultural classes are non-earning dependents, unable to support themselves by any means of livelihood. The percentage for this category in case of non-agricultural classes, both rural and urban is quite high when compared with those of self supporting and earning dependents.

21. It will be seen from the above table that the principal language of the district is Marathi. It is the mother-tongue of 83% of the population. Buldana possesses the largest proportion of Marathi speaking population from among the Berar districts. Next in the order of importance is Urdu mostly spoken by Mohammedans. Hindi comes next but the percentage of people who speak Hindi is quite negligible. So also Gujrati & Marwari.

22. Hindus form 79.7% of the population while Muslims accounts for 9.2 % of the population of the district. I.I % of the population belongs to the other religions. There are no persons belonging to Scheduled Tribes but the Scheduled Castes number 152,070 of which 73,905 are males and 78,168 are females. The rural and non-city urban population of Scheduled Castes is 138,184 and 13,886 respectively. The number of females amongst the Scheduled Castes per 1000 males is 1,057 and the percentage of Scheduled Castes population to the total population in the district works out to 17.47.

Forests:

23. Abundant forests are precious and add immensely to a country's natural wealth. Such forests are a national asset. They have a special significance in rural economy and national life as well. The benefits accruing from such forests are numerous but the most important ones are (a) they supply valuable timber, fuel and fodder (b) they ensure regular and adequate rainfall (c) they help to preserve valuable top soil and (d) they have moderating effect on the extremes of climate.

24. But nature has not endowed the district with such inexhaustible forest wealth; thus resulting in the low output and poor quality of forest products. It is here that the need to expand forest arises not only for fuel and timber requirements of the district and those of the adjoining districts but also for climate reasons for checking soil erosion. The growing of suitable trees and maintaining them is a necessity in the district for the intensive exploitation of minor and major forest products. If this is done, it not only provides gainful employment to numerous people but also enhances substantially the revenues of the district. Unless the existing forests are properly looked after according to the standards of Silviculture, trees do not thrive well and the danger to the extinction of forests is imminent sooner or later.

25. Although Buldana district is not in the dense forest belt nature has not deprived of her share of the forest wealth.

26. The total area of the forest in the district is 468.7 Sq.miles approximately 150 Sq.Miles more than that of the adjoining district of Akola. It is observed that the area shown under forests by the Land Records Department and that shown by the Divisional Forest Officer, West Berar Division, Akola for Buldana District, does not tally.

27. The total forest area of the district is 471 Sq.miles and the percentage of area under forest to the total geographical area of the district comes to 12.44. 'A' class forests occupy an area of 284.3 Sq.miles and 'C' class forests accounts for 147.2 Sq.miles. The area of Ex-Private Forests transferred to the Forest Department in the district is 39.5 Sq.miles. The 'A' class forests are supposed to be reserved for production of timber and fuel while 'C' class forest provides fodder grass and pastures

and pastures for cattle. The forest growth mainly consists of Teak, Babul, Anjan, Salai and Bamboos. The following are the reserve forests of the district—Geru-Matergaon Reserve, Ambarvara Reserve, Ghatbori Reserve, Bhangaon Reserve and North and South Andari Reserve, each occupying an area of 59,303; 34,492; 29,058; 9,012 and 22,198 acres respectively. The Ex-Private Forests originally belonged to the Jagirs of Bhingara and Kuardeo and they are located in the Satpura Hills abreast of Ambarwara Reserve.

As against the Revenue of 303,798 total Expenditure incurred during the year under report is only 182,550 which is about 60%. It will be seen from the table the Revenue derived from the issue of licences in respect of Grass Cutting and Grazing was highest both from the major and minor forest produce for the year 1958-59. Considering Quadrennium ending 1958-59 value derived from Timber in 1957-58 is highest. The total output and the value commanded from Timber in 1958-59 is comparatively less than that for the year 1957-58. Total Revenue is also less by 10% to that of the total Revenue of 1957-58.

Agriculture

The effect of the fertility of the land upon the movement of population is of great importance in an agricultural country. It has been already pointed out in an earlier chapter that the district is divided into two natural Sub-Divisions. The same natural sub-divisions also apply to the soil of the district. The uplands of the Plateau are known as the Balaghat Plateau and plain divisions is known as the Great Payanghat Plain. The uplands of Chikhali and Mehkar forming the Balaghat Plateau are less fertile than the other parts of the district. The taluks lying in the plain Malkapur, Khamgaon and Jalgaon are situated in the valley of the river Purna and the black cotton soil found there is famous for production of cotton. The soil of the plain is deep black loam and is commonly known as the Black Cotton Soil and is excellent for Rabi crops because it retains moisture for a considerable period.

3Q. The geological formation of the District is Deccan trap with intratrappean beds of shale, sandstone, and limestone. From the disintegration of the trap and these less prominent layers of non-crystalline rock can be traced the various classes of soil of this tract, varying from the very fertile deep loam of the plains commonly known as black cotton soil, to the shallow muram soils of the higher lands. The soil of the plain is largely a deep black loam, which cakes into a solid mass in the beginning of the dry weather and cracks freely in all directions later. These fissures run to a depth of several feet, and give the soil a reticulated appearance; hence the statement that black cotton soil ploughs itself. The soil of the higher land is lighter, more friable, and less subject to cracking. The depth of the black cotton soil varies from three to twenty feet. It reaches its greatest depth in the valleys into which it has been washed as a fine silt from the higher lands. The richest soil of the District is to be found in the valley of the Purna lying north of the railway. This soil, locally known as Bharkali, is of very fine texture, very retentive of moisture, becomes sticky when wet cracks freely in the dry weather, and is comparatively heavy to work. It is the soil par excellence for rabi crops. The largest stretches of it are found in strips about eight miles broad on each side of the Purna, but it is also found in the valleys of various sizes between the plateaux of the uplands. On the larger plateaux there are considerable areas of black soil of a slightly shallower type, which grows cotton, juari, tur, moth, mung, urad and bajara. The Chikhali and Mehkar taluks are famous for their wheat, which is grown in the lowlands between the plateaux. These lowlands being the only very fertile portions of the plateau tract have been under cultivation for a long period, and are now in places showing signs of exhaustion. Black cotton soil which is slightly shallower, and which contains a certain percentage of lime in a finely powdered state, is known as Kali. If there is a still higher percentage of lime present in the form of nodules about as large as peas, the soil is known as Morandi or Bhurki Kali. These soils containing lime are lighter to work than pure black cotton soil, less retentive of moisture and are less fertile. Much of the plain taluks and the lowlands of the plateau taluks consist of this Kali soil, the best of which is considered suitable both for Kharif and Rabi crops. On the broad plateaux of the uplands is found a shallow black or brown soil varying in depth from one to three feet. It differs from the black soil of the plain in having a muram subsoil. These upland soils are naturally drained and are friable and easy to work, but they are not sufficiently retentive of moisture to grow rabi crops well unless irrigated. The Kali soils of the plain, on the other hand, rest on a yellowish marly

marly subsoil. They vary in depth from five to twenty feet and are ~~not~~ retentive of moisture. The slopes of the plateaux are covered with muram which is too poor to produce anything except shrubs and inferior grasses. Poor hilly soils are ~~also~~ also to be found in the south of Khamgaon and Malkapur taluks, and in the north of Jalgaon taluk. A kali soil which presents an oily appearance when ploughed is known as tel chikni. Greyish patches of it are found in the best black soils of the plains, and can be distinguished both by their colour and by the fact that they are very retentive of moisture. Chopan is the name given to patches of greyish coloured marly soil found in certain fields; the soil and subsoil of these patches, being very impervious to water, become wet and sticky during the rains. Kharwan is the name applied to a soil which contains much saline matter. Dagri kali or gotar is a black soil of from one to three feet in depth, which is found in the vicinity of hills and which is interspersed with boulders. It gives fairly good crops of cotton and juari except in years of short rainfall. An alluvial soil made up of successive deposits of silt is known as malli. It is the very best soil for garden crops. Bhorandi or Khadki is the name given to the thin yellowish coarse soil of one foot or less in depth with muram or rock underneath. It is common on the highlands and grows poor crops of cotton, juari, bajra, moth and holga. Barad is the name given to the shallow soil of the higher lands of the plateaux; it is black brown, or reddish in colour, rests on rock or muram, and produces inferior crops of cotton, juari and gram; but the thinner soil of this type is generally cropped with bajra, moth, holga or other minor crops. Gawhar is the name applied to a black soil of any kind on which wheat can be grown. Land in close proximity to a village is called akhar, and the light-coloured soil of such land is known as pandri. The colour is supposed to be due to the chemical changes which take place in black soil when impregnated with much fermentable organic matter. Pandri is considered very good for tobacco and garden crops. Utaran is the term applied to sloping land. Land which has become exhausted by continuous cropping is known as hidbur, and land which is irrigated is called bagait.

Formation of soils:

31. In course of time trap rock on weathering breaks up into a reddish brown muram; this muram becomes more/finally reaches that stage in which it is known as black cotton soil. The grading process is largely due to the effect of water which carries the fine particles from higher to lower levels. The colouring matter is supposed to be one of the oxides of iron. These different classes of soils can be found in the different taluks though the terminology varies somewhat from taluk to taluk.

32. The economy of the district is deep rooted in agriculture as in other parts of the country. About 79.86% of the total population is dependent on agriculture. The total area under crops in 1958-59 is 17,25,634 acres and the percentage of area under cultivation to the total geographical area is 71.5. The following table gives a bird's eye-view of land utilisation in the district during the year 1956-57 to 1958-59.

33. The above table shows that about 71.5% of the total area of the land was under cultivation in the year 1958-59 and it was 2.5 more than the previous year. Of the remaining 28.5% of the land in 1958-59, about 12.5% is under Forest and 16.0% is occupied by permanent pastures, other grazing grounds, other fallows, barren land and cultivable waste etc. The total geographical area is shown II and I6 acres less than what it was during the years 1957-58 and 1956-57 and the decrease is contributed to the mistakes in old records.

34. Under the Grow More Food Scheme, large sums of money have been spent in the district under items noted below to effect not only land improvement but also to render all possible assistance to enable the cultivators to produce more and more food crops and cash crops as well, so as to improve their economic condition. The following table furnishes the amounts advanced under different Acts.

Agricultural Crops: -13-

35. The study of land utilization is important in order to obtain a fuller idea of the economic use of land. During the last four years and as a matter of fact during the past many years the area under cotton was the highest. Cotton is the principal crop and occupies more than 1/3 of the gross area under cultivation. The next important crop is Jowar which occupied an area of 590,230 acres in 1958-59 as against 568,568 acres in the year 1957-58. Jowar is grown on all the different classes of soil in the district.

36. Cotton is largely grown for sale and this staple holds the place of price as the principal article of export in the district. There is plenty of scope for greater exploitation of agricultural resources and cotton in particular, provided irrigation better seeds and manures are made available and modern methods of cultivation are introduced in the district on an appreciable scale. The district has taken remarkable strides in the sphere of food production and agriculture. This was due in part to the various Grow More Food Schemes and the implementation of Community Development & National Extension Schemes.

37. The following table gives the area under different crops during the years 1956-57 to 1958-59:-

38. The table shows the cultivation of Food Crops taken as a whole predominates in the whole of the district while more or less the same position holds good with regard to Cotton; about 53.8% of the area is under cultivation of Food Crops whereas cotton accounts for 37.5%. Bajri, Gram, Sugarcane Sesamum & Linseed are insignificant crops. Wheat occupied an area of 94,456 acres in 1958-59 and this staple food is largely grown in the plateau taluks of Chikhali and Mehkar than in the taluks of the plain. The area under wheat crop was the highest during the year 1956-57. So also the area under Groundnut showed considerable increase during 1957-58. Jowar and Wheat are sown for domestic consumption only.

39. Above table shows that there is a considerable progress in the installation of oil pumps and Electric Pumps. Number of Electric Pumps is trebled since 1956. Similarly, number of Tractors is also increased from 21 in 1956 to 54 in 1958-59. Considering the cropped area and the number of ploughs, it is observed that an average of 57 acres of land is under each plough. Similarly, the average for each pair of bullocks comes to 20 acres of land. It is estimated that there were 190,000 bullocks, which could be considered as working.

General:-

40. Monsoon commenced in the last week of June and continued till end of November. Rainfall during July and August was timely and normal. Condition of Kharif crops was satisfactory. Heavy rains in the last week of August and 1st week of September caused floods in Mehkar and Chikhali Tahsils and crops were damaged. 243 villages from Mehkar, 43 villages from Chikhali and 14 villages from Malkapur Taluks were granted suspension in Land Revenue. Kharif crops in the district except for Mehkar were satisfactory. Kharif crops were harvested during November and December. Average of Annewari was as follows:-

Cotton - 7.00, Jowar - 8.20 and Groundnut - 7.20.

41. As usual chilly crops were affected by Churda-Murda disease. Dahiya was also observed in the end of September in Mehkar and adjacent part. Rabi sowing was successful and crops were harvested between February and April, 1959. Average Annewari

Annewari was as given below:-

Wheat - 9.60, Gram - 9.50 and Linseed - 9.00.

42. As the rains were sufficient during the year no water scarcity was felt.

Scarcity and Famine:-

43. In 333 villages annewarī was below six annas. No scarcity or Semi scarcity was declared in any of the villages. However 8 road works were started from August, 1958 to July, 1959, under the seasonal employment scheme for providing works to the Agricultural labourers during the off season. Total expenditure incurred was Rs.47,000 and about 50,000 labourers were busy with these works.

Prices Labour wages:-

44. Financial condition of Agricultural classes was satisfactory the prices of Agriculture- Produce were a bit higher than those of previous year. The slight rise in the wholesale prices of agricultural produce and the cost of cultivation was due to general rise in the price's of all commodities.

Land Revenue:

45. Total Gross Land Revenue in 1957-58 -Rs.2,672,236 and in 1958-59 - Rs.2,672,259 Increase of Rs.23.

Demand in the fixed Land Revenue, shows an increase of Rs.50 as compared with the last year. This was due to the grant of leases, under Grow More Food Scheme. Total demand of Nazul Revenue shows decrease of Rs.27. This was due to cancellation of a few leases. There is no fixed demand under Fluctuating and Miscellaneous Land Revenue. However, total recovery under this head is Rs. 5,872/- which shows increase of Rs.8,717 as against the collection of previous year. This is because of sale proceeds of trees and Melon beds. Land Revenue per acre of cultivated land comes to Rs.I.60 & Rs.I.58 for the years 1957-58 and 1958-59 respectively. These figures for the entire Bombay State are Rs.2.21 and Rs.I.61 respectively for the year 1957-58 and 1958-59.

46. There are now 8 Seed Farms distributed all over the District Total acreage covered is 287.60 acres. Groundnut and Wheat seed were produced from A & B class Seed Farms. Cotton seed was produced in Cotton extension Scheme departmentally.

48. Due to shortage of manures and its increasing cost there is a demand for Town Compost. 8831 Tons of Town Compost was purchased against 7082 tons of Rural Compost. 569 villages have been benifitted from preparation 23,612 tons of Rural Compost covering about 4,267 acres.

49. Grow More Food Campaign:- Since commencement of this compaign an area of 18,900 acres of waste land was leased out for cultivation. An amount of Rs.5,040 was spent on compost pits which yielded an estimated quantity of 63 tons of compost manure. Chemical Fertilizers worth Rs.399,272 were distributed.

50. Crop Competition:- 27 cultivators took keen interest in the Jowar crop competition. The record crop obtained was 75 Mds.6 Seers per acre.

Soil Conservation:-

51. In nature soil formation is a very very long process and it takes thousands of years to form soil. This process is helped in nature by the agencies like water, wind, heat, biological sections etc. But if the normal balance is not kept up the most useful part of soil is lost off this process is called Soil-Erosion. The Soil-Erosion is a rapid process, as against the Soil formation. It is therefore necessary to conserve the soil by artificial means e.g. Contour Bunding, afforestation, improved cultural practices etc.

52. Soil Conservation activities have been started in Vidarbha area very recently. In Buldana District a new sub-division was started from I-4-1958. In this district out of 16 lakhs of cultivable area spread over five taluqs only about 10 lakhs of acres. (Light & Medium Soil) is suitable for Soil-Conservation work. This area is spread out over throughout the district, with some exception in each taluq. At present, work has been undertaken mostly in Development Block areas- i) Round about Khambgaon ii) Round about Motala and iii) Whole of Chikhali taluq. Eventhough the Sub-divisional was started I-4-60 regular activities commenced since I-8058. During the 1958-59 season much head way could not be done as most of the time was utilised in doing preliminary work. Bunding work was completed in 179 acres, and total expenditure incurred was Rs. 6,573 during the year under review.

53. In vidarbha since most of the area is an assured rainfall area with Annual Rainfall ranging from 30"-35" and with area rarely falling under the shadow of scarcity and unpervious rock sub-starts, soil conservation forms slight different aspect of technique than the rest of the Bombay State. The problem here is not of Soil Conservation and moisture conservation as in other areas, but it is of Soil Conservation cum Soil Drainage (Surface Drainage) with this objectd inview

in view technic of Soil Conservation has been slightly modified to Suit Local Conditions and to allow effective surface drainage of excess water as well as to conserve the soil as effectively as ~~as~~ possible. The Scheme in addition to the soil conservation also provides work for labour and landless people during out of normal cropping season and this helps the farmer and the labour in keeping in the ourselves engaged all the year round, without in any way handicapping thier own cropping programme.

Land Tenure:-

54. The objectives of land reform are two fold:-
Firstly, to remove such impediments upon agricultural production as arise from the character of the agrarian structure; and secondly, to create conditions for evolving as speedily as may be possible, an agrarian economy with high levels of efficiency and productivity. These aspects are interrelated, some measures of land reform bearing more directly on the Ist aim, others to a greater extent on the second. Thus, the abolition of intermediaries and the protection given to tenants are intended to give to the tiller of the soil his rightful place in the agrarian system and, by reducing or eleminating burdens he has borne in the past to provide him with fuller incentives for increasing agricultural production. Similarly, to bring tenants into direct relation with the state and to put an end to the tenant landlord nexus are essential steps in the establishment of a stable rural economy. The area of land available for cultivation is necessarily limited. In the past rights in land were the principal factor which determine both social status and economic opportunity for different groups in the rural population. For building up a progressive rural economy, it is essential that disparities in the ownership of land should be greatly reduced. Reduction of disparities in ownership of land is also essential for developing a co-operative rural economy, for co-operation thrives best in homogeneous groups in which there are no large inequalities. Thus, programmes for abolishing intermediary tenures, giving security to tenants and bringing tenants into direct relationship with the state with a view to conferring ownership upon them are steps which lead to the establishment of an agrarian economy based predominantly on peasant ownership. With the advent of the popular Government in 1946, a number of far-reaching and important legislative measures of agrarian reforms have been brought into force in the State. The Bombay Tenancy & Agricultural Lands Acts, 1958 (Vidarbha Region) came into force on 28th August, 1958.

Salient Features:

55. Although the scope of the law has remained unaltered,

remained unaltered, changes have been made in the provisions of the old law in such matters as rent, termination of tenancies, inheritance of tenancy rights, etc., and new provisions such as those in regard to economic holdings, ceiling area, purchase of land by tenants on the Tillers' Day, construction of water courses through the lands of others, etc., have been added. These changes constitute the salient features of the new law. A brief resume of the provisions of the new law pertaining to these features is given below:-

- (1) No tenancy of any land is liable to termination merely by efflux of time.
- (2) Maximum Rent:- Maximum rent payable by tenant shall not exceed (a) Three times the land revenue on the land in respect of which announcement or settlement has been made. (b) Four times the land revenue on land in any other case.
- (3) Liability of tenants:- Every tenant shall be liable to pay in respect of the lands held by him as tenant -(a) the land revenue (b) Canal Revenue (c) the cess levied under different local Government and Panchayat Act. But if the aggregate amount of i) Land Revenue ii) The cess payable and iii) The rent payable to the landlord exceeds the 1/6th of the produce of such land in that year, the tenant shall be entitled to deduct from the rent for that year the amount so in excess.
- (4) Termination of Tenancy:- The tenancy of any land held by a tenant shall not be terminated (a) unless such tenant-(i) Has failed to pay in any year the rent of such land for that year or ii) has done any act which is destructive or permanently injurious to the land. iii) has sub-divided the land iv) has sublet or failed to cultivate personally v) has used such land for a purpose other than agriculture and (b) unless the landlord has given 3 months notice.
- (5) Termination of tenancy for personal cultivation:- The landlord may after giving to the tenant one year's notice at any time within 2 years from the commencement of this act terminate the tenancy of the land held by a tenant other than an occupancy tenant if the bonafide requires the land for cultivating personally. This can only be done subject to the following condition-i) The land lord has no other land of his own or has not been cultivating personally any other land. He shall be entitled to take the possession of the land leased to the extent of 3 family holdings. ii) The income by the cultivation of the land which he is entitled to take possession is the principal source of income for his maintenance.
- (6) Restriction on transfers of Agriculture lands:- No sale, gift, exchange or lease of any land shall be valid in favour of a person who is not an agriculturist or who being

being an agriculturist, cultivate personally lands not less than 3 family holdings, provided collector may grant permission for sale, gift etc.

(7) Offences and Penalties:- Who ever contravances any provision of any of the section, such sections, or classes shall on conviction of each such offence be punishable with fine which may be extended to the amount of Rs.1,000/-.

56. The rates of assessment are determined in the following manner. The area to be dealt with is divided into groups homogeneous as to physical characteristics and economic advantages such as climate, rainfall, general, fertility of soil, communications and the like. For each of these groups uniform maximum rates are fixed. Maximum rates are the sums which would be leviable upon a field the ~~xxx~~ soil valuation of which is 16 annas. Thus if the maximum rates be Rs.3/- per acre upon a field the valuation of which was 8 annas would be Rs.1.50. and so on. By applying the maximum assessment rates to the soil valuation, the rate per acre on each field is arrived at. * Special rates are imposed on Rice and irrigated lands.

57. In a revision of settlement, the Settlement Officer reviews fully every circumstances shown in the past revenue History, prices, markets, communication, rents, sellings, lettings and mortgage value of land, vicinities of seasons and every other relevant fact indicating the incidents of previous assessments and the economic condition of the tract upon this indication, he basis his proposals for enhancement or reduction of assessment as the case may be.

Agricultural Holdings:-

58. Small and un-economic agricultural holdings have long been the most difficult problem in the development of the rural economy. There is general agreement that it is through re-organisation along co-operative lines that Indian Agriculture can become efficient and productive. During the second Five Year Plan it is proposed to take a series of measures which will lay the foundations for co-operative re-organisation of the rural economy. A study of agricultural holdings is of great significance because it indicates the soundness of farmer's economy.

59. The Bombay Prevention of Fragmentation and Consolidation of Holdings Act, 1947, seeks to cure the evil of excessive fragmentation or sub-division of agricultural holdings and to prevent its recurrence in future. Under this Act, "fragment" is an area of land less than the standard area fixed by the Government for any local area. Every such fragment is entered in the village records and to avoid future fragmentation, it is provided that no fragment can be transferred, except to the owner of a contiguous survey number

survey number or its recognised sub-division. No fragment can be leased to any person other than a cultivator of the contiguous plot; and no estate can be partitioned, so as to create a new fragment. The following table gives the agricultural holdings according to the size. The data is based on the 1953-54 Census of Agricultural Holdings.

60. It is seen from the above table that the number of occupants holding land below 10 acres is very large and amounts to 69.60 % of the total agricultural holdings. Maximum number of occupants come under the group of 2.5 to 5.0 acres which amounts to 20.4 % of the total number of holdings. Then comes the group of 1.0 to 2.5 acres with the % of 17.9 of the total number holdings. Number of occupants holding land more than 100 acres is very small and the % of this group to the total number of holdings is only 1.1. The % is 19.2 for the group of 10.0 to 25.0 acres while for the next group it is 7.1 only. 3.0 % of the total number of holdings come under 50 to 100 group of holdings.

61. Total area of 18,63,400 acres is distributed among 1,54,175 holdings. Out of this about 14,33,800 acres are under personal cultivation which amounts to 77% of the total area. Out of the remaining land of 4,29,600 acres about 1,68,000 acres are leased on cash rents to the total land leased out is 39 and it is 61 % for land leased on the basis of kind rent.

62. Non-mechanisation of cultivation has immensely enhanced the importance of live-stock in Buldana in particular and the country in general. The inadequate transport facilities in the district with special reference to rural area has indeed added to the worth and usefulness of live-stock.

63. The district possesses a distinct type of cattle known as the Khangaon breed which is supposed to be the largest and the strongest of the Berar breeds. It is, therefore, well suited for heavy work on the soils such as those found in Buldana. The buffaloes that are common in the district are of Nagpur and Malwa breeds. The following table gives an idea of Live-stock found in the district during the years 1956, 1957-58 and 1958-59.

64. The variations in the figures of Goat and Sheep may be due to the fact that the Shepherds being of Nomadic type move from place to place and at times they go out of the district boundary also.

65. There were 31 full fledged dispensaries during 1958-59 as against 9 in the previous year, 21 outlying dispensaries as against 17 last year. 4 Key village Centres, 4 Poultry units and 7 controlled Breeding Centres were operating during the year under review. There is one Artificial Insemination Centre at Buldana and Quarantine Stations were converted into full fledged Dispensaries. Cattle diseases were not of a virulent type. Position of Fodder was better as compared with that of last year. Milk supply was unaffected.

Irrigation:-

67. Where the mean annual rainfall is less than 50 inches, irrigation in one form or the other is essential for successful cultivation. However, when an agricultural country like India has to depend entirely on the monsoons, it is merely a gamble. Rainfall, as a matter of fact is often irregular and unequal and from the agricultural point of view, the most unsatisfactory feature of the rainfall is its liability to failure or serious deficiency. It has already been pointed out that the average annual rainfall in the district is less than 30 inches. Therefore, the need for and the importance of irrigation in the district need not be over-emphasized here. The following tables show the area irrigated by Minor Irrigation works during I955 to I959.

68. Out of the total cropped area of 1,725,634 acres 21,676 acres were irrigated which gives the percentage of 1.26 to the total cropped area. This area was also more than the area for previous year by 894 acres. Since 1953-54 the rise in area irrigated is 41.5%. In that year area irrigated was 15,317. In 1955-56 i.e. at the end of First Five Year Plan area irrigated was 17,442 and the rise in the area since that year is 24.3%. Main sources of irrigation are tanks and wells. On the completion of the Nalganga Project irrigation facilities on the large scale are likely to be afforded. Wheat, Sugarcane, Chillies and Garden crops are the main irrigated crops. Adequate utilization of available water was made during the year under report. From the table given above it is obvious that a very negligible increase in the percentage of area irrigated to the gross area under cultivation is achieved. However, condition are likely to be improved after the availability of water from Nalganga Canals.

Major Irrigation Project:-

69. Nalganga Project provides for the construction of an earthen bund across the Nalganga River near villages Sanglad Bk. and Khurd 3/4th mile downstream from Sangam in Malkapur Taluk. The length of the proposed dam will be 9300 Ft. and the maximum height of the dam will be 100.9 Ft. The length of the main canal will be 18.2 miles and that of the minor canals and distributaries will be 18.6 miles. The project will irrigate 43,000 acres of Rabi and Kharif crops. The Project which is estimated to cost Rs. 201 lakhs has spent so far (since beginning to the end of March, 1959.) Rs. 35.3 lakhs. This gives the percentage of 17.6 % to the total estimated cost.

70. Work of tank at Gaikhed was almost completed and total budget allotted was nearly exhausted. For Bandhara at Gangalgaon total expenditure since beginning is 47% to the

47% to the total estimated cost. Expenditure incurred on Bandhara at Amboshi is about 56% of the total estimated cost.

Industries and Employment:

71. Industries are the backbone of all advanced countries in the world today. The standard of living of a people largely depends upon the industrial development. Mere agriculture and raw materials do not help to raise the standard of living. Agriculture as a matter of fact cannot provide employment to the teeming millions in the country but various industries can absorb a sizeable population. It is a fact that even industries alone cannot absorb all the available man power in a country like India but they certainly help to decrease the burden placed on the land. It is from this angle, we see that the industries form the backbone of all advanced countries of the world today.

72. There are quite a few industrial towns in the district which are rapidly developing. A number of Ginning and Pressing factories oil mills and the second largest hydrogenated factory in Vidarbha is also located in the district. These factories employ some thousands of labourers every month. The list of factories in the district during the year 1958 is as follows:-

73. The statistical data given under paragraph 69 relates only to those factories that come under the purview of the Indian factories Act, 1948. The figures of labour employed in Cottage and Small Scale Industries is not available but in a country like India Small Scale and Cottage Industries are of great significance and must necessarily occupy a place of pride in the district. The importance of these industries in the economy of rural and

-25-

rural and agricultural India needs no greater emphasis and it is needless to say that these very industries are capable of augmenting the income of those engaged in agricultural operations by providing them gainful employment during the slack season.

74. As already mentioned earlier, the small scale and cottage industries in a country like India are of great significance. Their importance in the economy of a region hardly needs greater emphasis when it is realised that these industries not only augment the income of those engaged in agriculture by providing them with gainful employment during the slack season but also enable them to specialise in a particular trade suitable to their taste and talents.

75. It has not been possible to obtain the numerical strength of persons engaged in Small-Scale and cottage industries in Buldana district. Therefore, we rely on 1951 census figures which serve our purpose for the time being to illustrate roughly the man power engaged in these industries. The Bureau of Economics & Statistics, Bombay has planned a census of small industries and it might be possible to get upto date information soon. The tables below give the distribution of these establishments, the employment in textile and non-textile establishments.

76. The total number of establishments engaged in small scale industries as per 1951 Census was 1872, of which 1153 belonged to the non-textile group while 719 were textile establishments. There were 1043 handlooms in textile establishments. Both the textile and non-textile establishments, provided employment to 5459 labourers, of whom 3530 were male workers and the rest were female workers. The percentage of textile and non-textile establishments to the total establishments in small-scale and cottage industries is 30.4 and 69.6 respectively. The percentage of males and females to the total number of persons engaged in the small scale industrial establishments (1951) in the textile establishments works out to 50.1 and 49.9 respectively. The percentage of males and females to the total number persons engaged in non-textile establishments works out to 76.5 and 23.4 percent respectively. The percentage of workers in factories (1957) and small scale industries (1951) to the total population of the district works out to 2.4.

Mineral Products:-

77. The District is not known to have any mineral of importance except saline deposits and lead in the lake of Lonar. It appears from the District Gazetteer that the saline deposits were worked for sometime some decades ago and it was found that the working of these deposits was not profitable. Hence further exploitation of these deposits was abandoned.

Education:-

78. The district has taken remarkable strides in the field of education during the year under review. Mention may be made of the Community Project Administration and National Extension Service which are rendering a very valuable service, specially through the Social Education Organisers working in the development areas of the district in promoting literacy and accelerating its pace since the time of the inception of Community Development Programme. 79. The number of Primary Schools in the district during the year 1955-56 i.e. at the end of the First Five Year Plan was 871 and 36 for Boys and Girls respectively. At the end of the 3rd year of the Second Five Year Plan this number is 921 and 40 respectively. This shows the increase was 5.74% for Boys Schools and 11.11% for Girls School. The number of Boys and Girls enrolled in these Schools during the year 1955-56 was 53,442, 14,041 and 4,691 while the percentage increase in the number of admissions during the year 1958-59 was 11.1, 29.8 and 26.6 respectively. The increase in the admission of Girls student is considerable.

The percentage increase from the last year of First Five Year Plan to the Third Year of the Second Five Year Plan in the number of Teachers in Boys & Girls Primary School is 15.6 and 17.7 respectively. Average number of Students per teacher in the year 1955-56 was 28 & 30 for Boys & Girls Schools respectively. This number during the year 1958-59 for the Boys & Girls School is 27 & 33 respectively. 81. There are 2855 Teachers employed in Boys & Girls Primary Schools. Lady Teachers account for 98, which gives them only 3.4% to the total number of teachers. Percentage of trained teachers in Primary School comes to 57 which is considerably good. This percentage among Lady teachers is as

is as high as 70, and for gents it is 56.

82. In Girls Primary School total number of teachers is 179. Out of this only 7 teachers are gents and 5 of them are trained. Out of 172 remaining Lady teachers, 142 teachers are trained. The percentage of trained Lady teachersto the total number of teachers in Girls Schools comes to 79 while the percentage of trained Lady teachers to the total number of Lady teachers is 82. In both Boys & Girls Primary Schools percentage of trained Lady teachers is higher than that of Gents teachers.

83. Secondary education is an important link between primary and collegiate education. As the heading of the above table denotes, the secondary education comprises, middle and High School education. To many millions in this country, either middle or High School is the end of their scholastic career. No. of Middle & High Schools at the end of First Five Year Plan for Boys and Girls and for Girls only was 44 and 2 respectively, while this number during the year under review i.e. 1958-59 is 53 & 3. Percentage increase in the number of these schools for these two types is 20.4 & 50 respectively. At the same time the percentage increase in admission for Boys and Girls schools is 28.3 and for only Girls Schools is 17.6.

85. Percentage of Lady teachers to the total number of teachers in the Secondary School is 12.1 only. Percentage of trained teachers to the Total number of teachers is 39.3 only. Out of 727 Male teachers 264 are trained which gives 36.3 percentage among Male members. This percentage among Lady teachers is as high as 61.

86. Out of 827 teachers 38 account for Girls Schools. Only 3 Male teachers are included in the total number of 38 teachers. 87. Increase in percentage Expenditure of Primary Education from 1955-56 to 1958-59 is 74.6. This increase in percentage expenditure over the previous years is 10.5 only. Expenditure incurred per student in the year 1955-56 was Rs. 26.5. This figure for 1957-58 & 1958-59 was Rs.39.1 & Rs.39.9 respectively. Corresponding increase from the total strength

Total strength of the Students in the year 1955-56 to the total strength in 1958-59 is 15.7% as against 8.15% increase in total strength over the previous year.

88. Expenditure incurred per student of the Secondary Education was Rs.99.7 in the last year of the first Five Year Plan. This figure has decreased during the year 1957-58 giving only Rs.85.4 and 88.8 of expenditure per student. 13.9% is the increase in total expenditure on Secondary education from 1955-56 to 1958-59. This increase over the previous year is 8.1 only. Corresponding figures giving increase in total strength of the students over the year 1955-56 and 1957-58 are 27.8% and 4% respectively.

89. There are two colleges in the district. One Arts Science and Commerce College at Khamgaon and the other Arts College at Buldana. Total strength of these colleges is 941. Number of Boys & Girls students are 871 and 70 respectively. Total staff members employed are 38 which gives an average of 25 students per Lecturer. Total expenditure during the year is Rs.366,049 which shows 45.8% increase over the last year's expenditure. Total expenditure incurred per student comes out to Rs.389. For the previous year per student expenditure was Rs.279.

90. In the category of special Training-Three institutions are included. One is Basic Training College, the other is Carpentry School, both at Buldana and the third Tilak Rashtriya Vidyalaya at Khamgaon.

(A) Basic Training College:- Two types of courses are conducted- One year course for Matriculates and two years course for Non-Matriculates. Admissions are restricted to 50 & 150 respectively for these two courses. Expenditure during the year was Rs.157,682 which shows a decrease of 3.9% from that of the previous year.

(B) Technical School:- This is the only Institute imparting Professional and Technical education in the district. It is a carpentry school which conducts course of 3 years in carpentry. Expenditure on stipend and salaries is borne by the Government, while that on wood and tools by the Janapad Chikhali. The expenditure was of Rs.5,497. This was less by 15% from that of previous years.

(C) Tilak Rashtriya Vidyalaya - Khamgaon :- This school is recognised as a special school. In addition to the Academic courses; Course in Fine Arts such as Dancing, singing, Painting and Drawing, Sculpture and spinning and weaving is included. It is affiliated to Tilak Rashtriya Vidyalaya Poona. Total expenditure incurred during the year was Rs. 23,927 which gives Rs.247 per head.

91. In the category of Preprimary education, Balak

Balak Mandirs are included. During the year under report there were 16 Balak Mandirs in the District. Total strength of these schools was 656. Out of them 333 were boys and 323 Girls students. All the teachers (Numbering 27) were Lady members, 19 of them were trained which is 70% of the total strength. Average number of students per teacher comes to 24. Total expenditure was Rs. 31,960 which gives Rs. 48.7 per head. Government Grant given was of Rs. 10,295 which comes to 32.2% of total expenditure.

92. Basic Training:- In the year 1947-48, Basic Syllabus were introduced in the primary education by the then Madhya Pradesh Government. The combination of regular curriculum and three craft courses forms the Basic Syllabus. These crafts are:-

i) Spinning and weaving ii) Gardening and Agriculture iii) Cardboard and wood work. Schools conducting courses in these crafts are called Basic Schools. In the beginning 5 schools one from each taluk, were taken up for Basic Training. Four of them conducted training in Spinning and weaving both. In the year 1958-59, 15 additional Schools from Janapad were taken up for Basic Syllabus in Agriculture. Total number of Basic Schools in the District was 23.

93. This chapter on 'Education' will be incomplete if something concrete is not added to the review in respect of Backward Classes comprising mainly the Scheduled Castes and Scheduled Tribes and what the Government is doing in removing the Social disabilities. It was stated at the outset that the economic, social and cultural advancement of a community depends to a large extent on the availability of adequate educational facilities. Realising that the economic, social and cultural uplift of the masses belonging to the Backward Classes require extensive stage help in the form of education and training facilities, the Central and the state Governments are spending large sums of money on the spread of education of Backward Classes and providing them with special training facilities in professions to which they are specially suited.

94. Prior to the advent of Indian Independence, the number of students belonging to the Backward Classes attending schools was extremely poor. In Government Secondary Schools 25% seats in High Schools and 15% seats in Middle Schools were reserved for Backward Community students. Also 15% seats were reserved for Scheduled Tribes. They are exempted from tuition fees at all stages of education in Private Secondary Schools also. No discriminatory treatment is given to students of these communities in any of the schools in this district. Enrollment of Scheduled Castes,

95. Increase in the total number of students of Scheduled Castes over the previous year strength is 2.4% and 35.5% for Boys and Girls students respectively. It is a good sign that there is a remarkable trend in increase of Girls students in all the compartments of education. This percentage increase for Scheduled Tribes and other Backward Classes is for Boys and Girls as 21% and 97% and 26.5% and 55.8% respectively. There is a rise of 100% in the total strength of Girls from Scheduled Tribes for Primary education. For other Backward Classes this increase for Girls students in Primary is 64%.

96. 21 Scholarships of Rs.12 per month each were given to Backward Class students in High Schools and 8 similar Scholarships in middle schools. 97. It is clear from the above table, that the results are encouraging. For S.S.C. the percentage of successful candidates which was 36 in the year 1957-58 has increased to 49 in 1958-59.

98. Compulsory Education:

Compulsory Education for Boys and Girls was introduced in Urban areas(Towns) of this district as shown below:-

- 1) Buldana I925(Boys) I956(Girls)
- 2) Malkapur I935(")

In Rural Areas it was introduced in Mehkari and Jalgaon Taluqs in 1952 and 1955 respectively, covering ten villages in each. Compulsory Education was firstly proposed for the age group of 6-I4, but afterwards it was restricted to age group of 6-II only.

99. At the end of the year 1958-59 the total number of towns and villages under compulsion was 5 and 20 respectively. The total population in Urban areas under compulsion is 52755(Males) and 48919(Females) and of Rural area under compulsion is 25692(Males) and 25284(Females). According to latest census 5908 Boys and 705 Girls in Urban area and 2718 Boys in Rural areas were to be educated. But actually 5312 Boys and 656 Girls in 24 Urban Schools and 2227 Boys in 20 Rural Schools were taking the advantage under compulsory education for which 190 teachers (Urban I39 Rural 51) were engaged.

100. In the third Five Year Plan the District Development Board of this District has proposed to extend the Scheme in a compact area in the District for Boys and Girls of age group 6 to II for which 50 Administrative Officers are proposed to be appointed in Rural areas and three more for Urban areas. It is proposed to appoint 350 additional teachers during the Plan period and open 50 new schools for which(Administrative Officers & Teachers), the amount of Rs. 22,17,000/- will be required. Provision of additional Inspecting Staff consequent on introduction of compulsory education in a compact area has also been made for which the amount of Rs. 30,00/- is proposed.

I01. It is not necessary to stress that the present health services are inadequate. It is therefore of the top most priority to expand the existing health services to bring them increasingly within the reach of all the people and to promote a progressive improvement in the level of National Health.

I02. There is a greater need for the creation of more hospitals facilities, but in view of the high cost of these services, it is only possible to develop existing hospital services. It is also necessary to provide cheaper medical facilities.

I03. The Medical services in the state have been so built up as to answer the needs of the rural as well as urban areas. There is in each district a Civil Hospital which is a centpercent Government Institution. It is the centre of official system of Medical Relief and is a general hospital for the whole district. Subordinate to it are a number of Government Aided Dispensaries Scattered throughout the district. There are in addition special institutions like T.B., Mental & Leprosy Hospitals. The following table gives the statistical data pertaining to Medical & Public Health in the district during 1957 & 1958.

I04. It may be observed from the table that even though the number of Hospitals and Dispensaries is the same for the year 1957-58 and 1958-59. Staff position is improved. In Rural area, there is 80% increase in the number of doctors. Similarly, the increase in total number of Nurses is more than Centpercent. As far as Medical facilities are concerned, total number of beds, both for males and females are increased by 13.75% and 5.5% respectively. Number of indoor and outdoor patients treated per 1000 of the estimated population of 1958 comes as 8 and 392.

I05. Expenditure incurred per capital of the total patients treated during the years 1956, 1957 and 1958, is Rs. 0.75, 0.67 and Rs. 1.02 respectively.

I07. As indicated above death rate is increasing every year. In this table deaths by different causes are given. Excluding the other causes the percentage of death by Malaria is the highest which is 30%. Respiratory diseases with 10% comes next. Deaths by injuries shows the minimum percentage of 0.3% only. Deaths by causes not mentioned in the table account for 50% of the total deaths during the year.

I08. T.B. Sanitorium:- This Sanitorium was constructed in the year 1954. In addition to the medical treatment that is required for the cure, the natural atmosphere of Buldana proper, is also a considerable factor, for rapid recovery. Towards the total cost of Building & Equipment, Rs. 2.50 Lakhs were contributed by way of donations and an equal share was added to it by the Government. Initially there was accommodation for 50 beds, two general wards, with 21 Beds each and 8 Cottages. Patients with annual income of less than Rs. 1500, are admitted free. During the year under report (1958) 297 patients were given discharge and there were II deaths.

I09. National Malaria Eradication Programme:- The work under

The work under this scheme was already in force since 1953 in Jalgaon Tahsil being of High endemicity. Now the entire district is included under this scheme, and one independent full fledged unit has been formed, with Head Quarters at Buldana, since August, 1958. Four sub-units at different taluk Head Quarters were established almost immediately, Only Jalgaon and Chikhali Head Quarters were the exception. Jalgaon is included under Khamgaon sub-unit and sub-unit Chikhali has its Head Quarters at Buldana.

II0. As mentioned earlier, except Jalgaon, all the Tahsils are of Moderate endemicity. July-November is the transmission period in plain areas, whereas in Jalgaon Tahsil(Foot-hills areas of Satpura Ranges) the period extends to March. The two spraying are applied to plain areas(First round from middle of May to end of July. II-round -August to middle of October) but it is necessary to have 3 spraying rounds in Jalgaon Tahsils(III round-December-January) During the year under report, III round of spraying could be completed in Jalgaon whereas in other Talukas only one round was completed, leaving II round incomplete due to end of transmission period.

III. Family Planning:- At present there are two units, one at Shegaon and the other at Jalgaon. One Lady Health Visitor is appointed in the Centre, who to do the propaganda work. Operations for Sterilisation are performed at Shegaon and Khamgaon. Vasectomy operations are carried out either at Buldana or in different Camps whenever such camps are arranged.

II2. Primary Health Unit:- Only one independent Health Unit is established so far at Kinholi in Chikhali Tahsil. One unit consists of one Medical Officer, one Health Visitor, one Compounder, one Sanitary Inspector, Four Midwives, 4 Attendants (3 Male & 1 Female) and Four Beds in general ward and 2 beds for Maternity. Other three units are amalgamated with the dispensaries already in existence. Work of the primary health centre is twofold- preventive and curative. Preventive is achieved mainly by propaganda. Health visitor is to do that job.

II3. Health- Water Supply:- Only two towns Buldana and Shegaon in this district have the facility of pipe and water

pipe and water supply.Khamgaon town has it partially,All other places and in villages the source of Water Supply is mainly from wells and at places from the rivers.

II4. Small Pox and Cholera were the epidemics which have occurred in the District during the year 1958.Total number of anticholera inoculation performed during this period is 3,81,059.

POLICE & CRIME

II6. The primary functions of the police force are the prevention and detection of Crime,maintenance of Law and order,escorting pfisoners,guarding treasure and private and public property of which they may be placed incharge of prosecution of criminals,Besides these,it has other duties to perform such as control of traffic,service of summonses in criminal cases,destruction of stray dogs etc. which have been imposed upon it by law.Some other duties like passports and naturalisation enquiries are also entrusted to them for administrative reasons.

II7. The District Superintendent of Police is the head of police-force of the district.He is assisted by one or more Assistant or Deputy Superintendent known as such Divisional Police Officers,who look after the specified areas of the district.They in turn are assisted in their work by Circle Inspectors.A police station in a district is incharge of a Sub-Inspector who is assisted in his work by Head Constables and Constables.Following is the staff position of police force in Buldana district:-

II8. There are 22 Police Stations in the district. This gives an average of 54 villages per Police Station. The proportion of Police to area population and cognizable crimes investigated was one policeman to 4.55 Sq.miles, 1053 persons and 4.67 cognizable crimes investigated. Total expenditure incurred on Police Force was Rs.1,078,962 during the year under report.

II9. Political situation in the district was normal very few instances of alarming nature which threatened breach of peace between the various communities, took place. Police were not required to face any serious problems during the year. As usual staff was deployed for crop-protection duties with satisfactory results.

II10. Offenees reported during the year are 4250. These figures for the years 1957 and 1956 were 4023 & 4857 respectively. Eventhough there is increase in comparision with 1957 figures, it is under class VI only. Due to effective action by police, there is decrease under the heading classes I to V. Thus Police have taken action against the evil characters in Society by stepping up action under minor acts and by curbing down their activities in respect of I.P.C. Offences.

I23. There is considerable rise in cases under head, others which includes Prohibition cases also. Detection under prohibition has almost doubted. Notable case under excise Act was from Malkapur wherein Ganja worth of Rs. 61,000 was seized.

I24. The total number of Police Cognizable cases including those pending for disposal was 4359. The number of cases excluded as false or due to mistake of law was 24. The total number of cases pending at the year was 594; 81 with the police and 513 with the Magistrates. Out of 2878 Police cases decided by trial 2476 ended in conviction.

I25. Offences under local and special laws dealt with by the police totalled 2413. Of these 746 were brought to trial of which 212 ended in conviction.

I26. The value of property stolen in connection with cognizable cases was Rs. I32,688 as against Rs. I38,034 in previous year. The corresponding value of property recovered being Rs. 45,240 and Rs. 35,643 respectively. Percentage of property recovered in individual cases was 34.1% and 25.8% respectively for the years I958 & I957.

I27. In addition to other duties, the police served 19524 summonses and warrants, extinguished 26 fires, destroyed 1 stray dog, investigated 125 cases referred to them by Magistrate as well as 63 petty offences under the various minor acts, enquired into 67 Suicide, 90 accidents in district investigated 26 suspicious deaths and apprehended 4 Military deserters.

--:TRANSPORT & COMMUNICATION:-

I31. A developed system of transport of various types viz. Road, Rail, Water & Air transport are vital to the economic development and social progress of a country. An Agricultural and other marketable commodities of a particular region cannot be transported in the absence of a well-integrated and perfect transport system to a place where they are in greater demand and can fetch a better price ~~which~~ at the same time. In times of scarcity and famine, food and other essential goods cannot be rushed to the affected area, with the result, heavy damage is caused to both life and property. In addition to the Economic development the importance of roads has increased with the rising tempo of agricultural and industrial production and increase in the volume of trade and commerce with the nationalisation of road transport for passenger traffic, an urgent need has been created for additional as well as improvement to and modernisation of road system linking cities with rural areas. The state government has been making every effort to meet this need as expeditiously as possible.

I32. The district was devoid of all the means of communications prior to the construction of the Nagpur branch of the Central Railway in 1863 and 1864. The net work of roads in the district was 'Primitive'. Transport in the region was carried on by bullock-carts and even this transport was practically nil during the monsoons. There were no metal roads prior to 1870. The Automobile became an important vehicle of goods and passenger transport sometime after world war I. Improvement in transport and communications in the district is desirable for an efficient transport system will go a long way in facilitating the administration, trade and also draw tourist traffic to Buldana which is an excellent Summer resort. The Nagpur branch of the Central Railway connects only four important towns, of the district leaving aside the district head quarters and other important places on the plateau. The total length of the railway line in the district is only 55 miles.

I33. The Road Transport has not been nationalised in

nationalised in Vidarbha as is the case in the former Bombay State. The number of passenger buses, trucks and taxies is not available but the inadequacy of road facilities can be seen from the mileage of metalled and unmetalled roads in the district;

I35. It may be mentioned here that the Bombay Nagpur National Highways Route No.6 passes through Buldana District touching Malkapur, Motala, Nandura, Khamgaon. The total cost of maintenance during the year 1957-58 was Rs.506,516 and the cost per mile works out Rs.1555. The Road Mileage per 1000 Sq.Miles during the same year comes to 104. Total cost of maintenance during the year 1958-59 was Rs.465,432 and the cost per mile works out to Rs.1284. The total mileage per 1000 Sq.miles during the year under report comes to 114.

I36. POSTS & TELEGRAPHS:- At the beginning of the Second Five Year Plan the total number of Post Offices was 147 as against 224 at the end of the Third year of the II Plan. It gives the increase of 52.4%. Similarly total number of villages with-out Post Offices at the beginning of the II Plan was 1012 i.e. 85.2% of the total villages in the district were without the Postal Facilities. This number at the end of Third year is 962 i.e. 81% of the total villages are still without the postal facilities. Total Number of Broadcasting licenses issued during the 1958-59 is 1679. This shows a decrease of 143 over the licenses issued during the previous year. Percentage decrease works out to 7.85. Out of the total Radio Licences issued in the District Khamgaon Tahsil Accounts for 46% and Malkapur claims for 29% and other tahsils accounts equally for the remaining. 33% of the Telephone offices are in Khamgaon tahsil, while 31% of the combined Telegraph Offices are claimed by Khamgaon and Mehkar tahsil each. 137. Small Savings Scheme:- Unit consists of a District Organisor and a District Supervisor. There is also a Advisory Committee. Collector is the Chairman and M.P., M.L.As., Sub Divisional Officers and District Inspector of Schools are the members. Main collection period is October to March i.e. the harvesting season. The majority of the population is Agriculturist, and therefore it is possible to collect maximum amount during harvesting season only. For the rest of the period the Savings drive is pushed up through institutions,Offices etc. by Miscellaneous Agencies.

138. Agent are also appointed for the Savings drive. Agents are paid Rs.1.25 per hundred as commission. Persons from different walks are working as Agents. They are Government Servants (like Gram Sevak, Patwaris, Revenue Inspector) Primary Teachers, Individual, Grampanchayats, different Social Organisations etc. For the year under report, following is the classifications of Agents appointed:-

:CO-OPERATION:

140. The Character of economic development in India provides a great deal of scope for the organisation of co-operative society. The building up of a cooperative sector as part of the scheme of Planned development is, thus one of the important aims of national policy. An account of Co-operative activities in this district during the year under report is given below in brief.

141. General Progress :- During the year under report 111 Societies were registered while 41 Societies were either put under liquidation or amalgamated. Thus the total number at the end of the current year was 675 i.e. 11.6% increase over the previous year. Membership of all such Societies increased from 50,384 to 62,725. This gives the increase of 24.5% in total number of membership of the last year. All the villages are now covered under co-operative movement while population served is only 36%, as against 259 of the previous year. The credit can duly be achieved due to efforts and propaganda in Block Areas. Comparative progress of the co-operative movements is shown below:-

During the year tests as were prevalent in the old Bombay State were applied and a little percentage of Societies was placed in 'C' class which can only be considered not financially sound or due to heavy overdues.

144. Agricultural Primary Credit Societies:- The majority of the population in this district live's in villages and natural a very large number of Societies are primary credit societies. Such societies which were 517 in the last year increased to 555 during the year under report. The further break up is as follows:- 515 Agricultural Societies. 39 large sized societies and 1 Gram. Vikas. Total membership is 43,845 which gives membership of 80 per society was as against 63 of the previous year. Increase in membership over the previous year is 33.1%. This increase in membership can be attributed to the high rate of financing which varies from Rs. 20 to 30 per acre as against Rs. 15/- only in the old days. Working Capital increased from Rs. 87,35,676 to Rs. 1,22,79,135 while owned funds amounted to Rs. 23,82,510 against Rs. 17,36,041 of the previous year.

145. All the societies advanced short-term loans for Agricultural operations to their members which amounts to Rs. 64,37,370. A few small sized and almost all a large sized societies have undertaken distribution of Medium Term Loans and the distribution comes to Rs. 1,46,163. Thus the total loans advanced during the year under report come to Rs. 65,83,533. Average loan outstanding loans at the close of the year amounted to Rs. 1,03,39,039/. Out of this overdue loans are Rs. 25,04,604/. Percentage of overdues to the loans outstanding is 24% as against 28% of last year. There is a tendency in the increase of overdues and specifically heavy overdues are seen in Malkapur (Rs. 8.37 lakhs) and Buldana (Rs. 6.80 lakhs) Banks area while there are comparatively low in Khanggaon and Mehkar Banks area.

147. The number of societies was reduced from 581 in 1956-57 to 517 in 1957-58. Even then the same number of villages continued to be served as 81 societies had to be

had to be deleted due to formation of 14 Large Sized Societies.

147. On the whole it will be seen that a great stride has been made in the Agricultural credit movement, All the villages of the District were fully covered. Coverage of Agricultural population is 55%. Some Societies have done non-credit business and wherever possible have started godowning activities. There is a greater awakening on the part of the village leadership which is taking keen the mounting of overdues in a good Co-operative Societies and absence of effective linking of credit with marketing. Lack of supervision, want of sufficient number of secretaries can also be added to the weak points. Efforts are being made for removal of their defects.

148. Co-operative Central Banks:- The number of Cooperative Central Banks in Buldana District remained the same i.e. 4. These Banks are Tahsil Banks except the Khamgaon Co-operative Central Bank which has a jurisdiction over two Tahsils Khamgaon and Jalgaon. The membership of all the banks stands at 6,487 out of which 5,927 is individual while 560 is society members. Paid up share capital of these Banks is Rs.13.14 lakhs and is contributed as

149. Working Capital increased to Rs.132 lakhs while owned funds rose from Rs.17.99 lakhs to Rs.21.34 lakhs. Rs. 33.54 lakhs, which are held as deposits are made up of fixed savings and other deposits. Rs.11,265,300 are spent for loaning business, while Rs.8,197,312 are recovered. Outstanding loans at the end of the year were Rs.99.50 lakhs out of which Rs.25.15 lakhs were of overdues. Following statements indicates comparative position :-

150. The deposits had increased from Rs.28.54 lakhs to Rs.33.42 lakhs. The increase in deposits was uniform. In case of Mehdkar Bank the deposits continued to stand at satisfactory level, if compared to other Banks. All the Banks were making efforts to increase the deposits resources i.e. compared to the loaning operation. The deposits were only 25% of the working capitals. In view of the above deposit position the Banks had to depend largely upon the limits, sanctioned by the Vidarbha Co-operative Bank and Reserve Bank of India. The Banks on the whole were in a position to maintain adequate fluid resources. The Banks were able to meet the short Term demands of the increasing number of Agriculturists member of Primary Societies affiliated to them.

151. Land Mortgage Banks:- The number of independent Land Mortgage Banks remained two while the Malkapur and Buldana Co-operative Central Banks have Land Mortgage Section. The Buldana Co-operative Central Bank Ltd. started this section during the year under report. All the Banks continue to finance loans for long term purposes and during the year Rs.133,640 were advanced to members as against Rs.1.67 lakhs of the previous year.

153. Primary Land Mortgage Banks at Khamgaon and Mehkar and the section at Malkapur continued to work satisfactorily. The increase in membership and share capital was Rs.12.4% and 10.4% respectively. During the year 288 loan application worth Rs. 541,775 were received by Banks as against 1957-58 1,254 applications worth Rs.183,950 of the previous year. Finally 65 cases with Rs.133,644 were paid up of which Rs.111,640 were advanced a large number of applications were for repayment of old debts. This practice must be stopped as the same is not for productive purposes.

154. Reserve Net profits earned by Banks amounted to Rs.10,561 Buldana Bank section suffered a net loss of Rs.1,549,776

155. Agricultural Associations & Purchase & sale Societies:- The numbers remained constant at seven. The aim of the 6 associations is to supply seeds, manures, fertilizers and insecticides to members and individual cultivators as well.

Khamgaon & Jalgaon Agricultural Association adopted the Model Byelaws of the Purchase and Sale Union during the year under report. The other Associations had already adopted these laws. All these institutions(6 Purchase and sale unions and 1 Agricultural Association) have supplied seeds, implements and insecticides to the cultivators of worth Rs. 14.57 lakhs. Membership was 3,662 share capital was Rs. 1,067,906 and own funds were of Rs.490,687.

156. Co-operative Farming:- The number remained constant at 2. These two societies are (1) Co-operative Collective Farming Society at Amdapur in Chikhali taluk and (2) Shantinagar Co-operative Collective Farming Society at Chalthana in Jalgaon taluk.

157. (1) Amdapur Society with 10 Harijan members was formed on 10-6-1955. Land under cultivation is insufficient to feed the cultivators. Society has approached the Revenue Authorities for more land. Crops that were raised like cotton, jowar, urid and tur were of value of Rs. 467. Profit earned amounted Rs. 23 during the year.

158. (2) Chalthan Society was organised by Gandhi Smarak Samiti of 54 Nihal families who settled at this village. M.P. Bhoojan Samiti has allotted 400 acres of land. Members are Adivasis and they are economically and socially very backward and illiterate. They are unwilling to put hard work. Only 150 acres of land is under cultivation, Inspite of liberal Grants to the extent of Rs. 18,900 made by the Gandhi Smarak Samiti, the society is not functioning properly. At present there are only 14 persons in the society and now it has been decided to convert it into Gram Swaraj Society.

159. There are other societies functioning in the district, during the year under review. Mention may be made of 1) Societies for Welfare of Backward classes. 2) Rural & Urban stores - under consumers movement - 3) Dairy Society 4) low income group housing societies. 5) Non-Agricultural Credit Societies 6) Transport Societies and 7) Better living Society - at Sawargaon Dukare ff Chikhali Tahsil.

160. It will be seen from the previous paragraphs that a considerable progress has been made in the Agricultural Credit Sector, during the year under report. All the villages in the district have been covered. The increase in membership is commendable, and Loan Advances have also greatly increased. Banks have made adequate arrangements for distributing loans in rural area. Lending rates are reduced and protected tenants are now also admitted, as members.

161. Sarvodaya:- The Sarvodaya Scheme as adopted by the Government of Bombay in 1948 aims at the uplift of backward tribes in certain selected areas on the State. It was the result of a decision made by the Government of Bombay to perpetuate the memory of Mahatma Gandhi. The manner in which this was sought to be done was by promoting various activities associated with his constructive programme in a systematic and organised way in compact groups of villages located in backward parts of the State or in areas having a predominantly backward population. Each of these groups was to consist of 30 to 50 villages with more or less homogeneous social and economic conditions.

162. The Scheme is in operation in 29 districts of the State and covers a population of 10,26,962 in 1,288 villages and an area of 5746.9 square miles. In this district a Sar

a Sarvodaya Centre is started in the year 1957 at Jalgaon with 21 villages, 15,646 population & 216 sq.miles area. Activities under the heading of Agriculture, Education, Cottage Industries, Health, Leprosy Control, Youth Organisation, Rural Development, Prohibition, Small Savings, Bhoodan etc. are taken up.

LOCAL SELF GOVERNMENT:-

163. Municipal Corporations, Town Municipalities, District Local Boards, Janapad Sabhas, Notified Area Committees and Gram & Panchayats constitute important units of Local Self Government in the country. These organisations enable the people to run local affairs in a democratic and responsible way. They not only represent genuine self-rule but may be used as fields for democratic training.

164. There are at present 9 municipalities in Buldana district covering a total population of 143,597 which constitutes 16.49 per cent of the total population of the district. Of these, 3 municipal towns have a total population ranging from 5,000 to 10,000; 4 municipal towns have a population ranging between 10,000 and 20,000 whereas there are only two municipal towns with more than 20,000 and less than 50,000 population in the district. Mention may be made of some municipalities such as Mehkar, Jalgaon and Deulgaon-Raja which are predominantly rural but have municipalities because they happen to be the head quarters of taluks. This is true of Mehkar and Jalgaon municipalities in the district.

165. The function and power of all municipalities are well defined in municipal laws. The chief function of the municipalities is to provide primary and normal amenities to its citizens which include the provision of free and compulsory education, medical relief, sanitation and Conservancy, drainage, water supply, street lighting and public works such as play-grounds and parks. They also attend to the preventive aspect of public health and run health centres. Some of the big municipalities establish health centres where antenatal and prenatal and child care is provided.

166. The various items of amenities mentioned above entail a huge amount of expenditure. The municipalities require funds to finance these schemes. The sources of municipal revenue to meet its obligations are-- sanitary and conservancy tax, rents on various market places, slaughter houses, land buildings, licence fee on hotels, boarding and lodging houses, octroi and terminal taxes, licence fee from public conveyance including cycle registration fee etc. In addition to these, municipalities receive grants-in-aid and loans from government in specific cases as implementation of water supply and drainage schemes requiring huge capital which amount the municipalities can ill-afford to visit.

167. The total receipts of Rs.5,075,008 for all the Municipalities show an increase of 33% over the total receipts figure for previous year. Total Expenditure of all the municipalities in the district amounted to Rs.4,365,406 which gives the increase of 42%. Over the last years expenditure figure. However, the total savings showed a decrease of 6%. Over the last years total savings.

JANAPAD SABHAS:-

168. There are five Janapad Sabhas in Buldana district. The Chikhali Janapad Sabha is located at the District Head Quarters viz. Buldana and the rest are located at their respective taluk head quarters. These Janapad Sabhas are headed by a Chief Executive Officer who is usually a Sub-Divisional Officer of that sub-division.

169. The following table gives the receipts and expenditure figures for the year 1957-58 and 1958-59.

170. Total receipts for the year 1958-59 amounted to Rs.4,122,619 which showed an increase of 1.6% only over the previous year. Actual figure for expenditure during the year 1958-59 was Rs.3,449,453. Increase over previous year's expenditure is 4.9%. Total savings again showed a decline. Total savings amounted to Rs.673,166. This was less than the previous year savings by 12.5%.

:VILLAGE PANCHAYATS:

171. The rural progress depends entirely on the existence of an active organisation in the village which can bring all the people including the worker sections like Tenant Cultivators, Landless workers and artisans into common programme to be carried out with the assistance of the administration. Under the impact of new developments including the growth of population, land-reform, urbanisation, spread of education, increase in production and improvements in communication the village society is in a state of rapid transition, and therefore the development of village Panchayats on right lines has a great significance. In emphasising the interest of community, Village Panchayats can play a considerable part in bringing about a more just and integrated Social Structure in rural areas and in developing a new pattern of rural leadership.

172. Out of 1188 villages of Buldana district 673 villages are with population of 500 and below. More than 163 thousands people or 22.5% of the rural population live in such villages. There are 323 villages with population between 500 and 1,000. About 227 thousand people live in these villages constituting 31.3% of the rural population. More than half the rural population (i.e. about 54%) lives in villages with population below 1,000. Thus, whereverver, individual villages are no large enough to serve as units for Panchayats, a single panchayat is formed to some more than one village. The functions of Village Panchayats may be distinguished broadly between two groups. Administrative and Judicial. Administrative functions are (1) Civic (2) Development (3) Land Management & (4) Land Reform. Civic functions

-52-

Civic Functions include such tasks as village Sanitation, Registration of Births, deaths etc. Organisation of village watch and ward, construction, maintenance and lighting of village street etc. The judicial functions concern:- i) Administrations of Civil & Criminal justice ii) Enforcement of minimum wages for Agriculture workers and iii) Simple disputes pertaining to land.

173. What follows next is a brief account of Village Panchayats in Buldana district for 1958-59 :- Total number of Village Panchayats remained constant at 516. There was no addition of new Panchayats, only because even though the new law was in force, rules for the election were not framed, which delayed election and formation of new Panchayats. 532 villages are covered, with a population of 599,350 which is 82% of the total rural population. Average population per Village Panchayat comes to 1,161. Elections were contested in respect of almost all the Village Panchayats. In 27 Panchayat elections were unanimous. Out of 5,554 members 701 were nominated by the Collector. As the elections were governed by the Old C.P.& Berar Village Panchayat Act, there was no reservation of seats either for women or scheduled castes and tribes.

174. Average income of village Panchayat in the district comes to Rs.1,742. Ratio of the income from the taxes to the Government Grants is 1 : 2 (Recovery of taxes Rs.270,000 and Government Grants Rs.541,000). Expenditure under Main Heads comes to Rs.549,000. This figure for previous year was only Rs.287,000. The increase is due to development works undertaken by the Panchayat with the help of Land Revenue Grants. Average Expenditure per Panchayat come to Rs.1,069 against the income of Rs.1,742. Main items of Expenditure are given below:-

177. Recovery is satisfactory and can be attributed to the fact that development works carried out by the Panchayat have created a tendency among tax payers to pay off the taxes.

178. Nyaya Panchayats:- In the year 1949, 67 Nyaya Panchayats were constituted. General working of Nyaya Panchayat was almost satisfactory. The decision of the Nyaya Panchayats, being quick, cheap and generally in the nature of compromise with consent of the parties were acceptable to the litigants barring few exceptions.

Appears at the beginning COMMUNITY DEVELOPMENT

Demand 179. In the words of our Prime Minister, the Community Development Programme and the National Extension Services are the dynamo providing native force behind the Five Year Plan. The programme may be said to be the most significant and vital part of the Plan in the annals of Indian History exclusively meant for rural reconstruction. It is a device by which rural people help themselves to improve their own economic and social conditions. It is therefore evident that the most important concept of Community Development Programme is peoples' participation. In other words, self-help and mutual service; mobilisation and development of local community resources; organised and co-operative action and minimum state assistance are the guiding principles set out by this programme.

180. Ques The Community Development Programme was inaugurated in this country on October, 2, 1952 but it was inaugurated in Buldana district a year later. On 2nd October, 1953 five blocks were inaugurated in the district and they

are :- Nandura block in Malkapur taluk, Shegaon block in W Khangaon taluk, Chikhali block in Chikhali taluk, Jalgaon block in Jalgaon taluk and Mehkar block in Mehkar taluk. Although the last two named blocks were actually started on 2-10-53 they were placed in 1954-55 series of Blocks. The other two blocks inaugurated on 1-1-57 were Sangrampur block in ice Jalgaon taluk and Khangaon block in Khangaon taluk and on

On 1-4-54, N. D. Block was formed by the conversion of the old N. D. Block and on 1-4-58, Motala block in Malkapur taluk was added to the extension. Thus the total number of blocks operating on 1-4-58 were 8 in the district. The table below gives the information pertaining to the blocks.

181. It was stated earlier that the chief aim of the Community Development Programme is the building and development of India, 600,000 village and the farmers who are scattered in those villages constitute 80% of the population of India. The number of villages in Buldana as mentioned earlier is 1,188 and the rural population of these villages constitute 83.49% of the total population of the district. The programme, therefore, includes schemes for rapid increase in food and Agricultural production, intensive utilisation of fertilizers assistance in irrigation and animal husbandry, introduction of land reforms, promotion of education, formation of co-operative societies, construction of communications, providing better health and medical facilities etc.

182. It is seen from the above table that 944 villages out of a total of a 1,188 villages in the district have been covered by the Community Development and National Extension Service Programme on 1-4-58. In other words 74.6% of the villages in the district come under the Community Development and National Extension Service Pattern, 556,961 persons or 76.65% of the Rural population or 64% of the total population come under this programme covering an area of about 62% of the total area of the district.

183. Originally C.D.Programme provided the following stages for every Development Block:-

- (1) There was to be no pre-extension stage with regular state and Budget provision. It was expected ground work would be prepared by the Local Development Programme.
- (2) The National Extension Service Block was to be a permanent pattern so far as personnel was concerned and a provision of Rs.4 lakhs for a period of 3 years was made,
- (3) During intensive stages or Community Development Block stage there was to be a provision of Rs.12 lakhs for a period of 3 years.
- (4) When the Block reverted to the Post Intensive stage the permanent state was retained. A small amount of Rs.30,000 per year was also made.

184. On the basis of the recommendation of the Balwantrai Mehta committee Government of India ultimately adopted a revised pattern from April, 1958. According to this pattern there would be only three stages for each Block as follows:-

- (1) Pre-extension stage for one year with a Budget Provision of Rs.18,000 for doing only Preliminary work. A skeleton staff of one B.D.O., one Agricultural Extension Officer and five Gramsevaks were to be provided.
- (2) Stage I with a Budget Provision of Rs.12 lakhs for a period of 5 years without distinction as Extension and Intensive stage. Provision for staff was the same as in C.D.
- (3) Stage II which corresponded to the Post Intensive stage of old pattern but with a Budget of Rs.1.00 lakhs per annum. During this stage, staff of the N.E.S. pattern was to be retained. This new pattern was to be made applicable only to Blocks started in April, 1957 and thus Khangaon and Sangrampur of 57 series became stage I Block. Motala which was inaugurated in April, 1958 became automatically stage I. Thus now there are four C.D.Blocks, three stage I Blocks and one stage II or Post Intensive Block.

187. Progress of Physical Achievements under various activities sponsored directly or indirectly by the block office can be compared with the expected achievement to see exactly what is happening in the Block area. This will serve as an indicator to the administrators and also the implementing Authorities. As all the programmes launched by the Block Office are not of equal importance and equal intensity, some items are selected to observe the progress of work done under each of them. In all 29 items have been selected for the purpose of Index Numbers. The number of items under each major group is as follows.

Agriculture 5, Animal Husbandry -5, Irrigation & Reclamation -2, Health & Rural Sanitation-5, Education - 3, Communication-1 , Rural Arts & Crafts-1, Institutional Growth-6, People's Contribution -1

189. From the table given above it will be seen that Shegaon and Jalgaon Blocks have done excellent progress in Rural Arts & Crafts (with Index numbers 294 & 730 respectively for that head) Nandura has done poor work in Education (Index Numbers 19), Jalgaon Block shows poor performance in Education & Communication (with Index Numbers 22 & 0 respectively). From stage I Blocks Khamgaon shows poor performance in Animal Husbandry, Irrigation, Education and Rural Arts & Crafts while Sangrampur Block has poor achievements in respect of Irrigation, Education, Communication, Rural Arts & Crafts and People's Contribution.

ELECTRICITY:-

190. The consumption of Electricity is cited as an Index of Economic Development. During the first plan period per capita consumption of electricity has risen from 14 to 25 units. At the end of second five year plan it is expected that per capita consumption will increase from 25 to 50 units. For the development of industry on a decentralized basis and for the progressive use of underground water resources for agriculture, electrification in small towns and rural areas is extremely important. By the end of the first plan about 95% of towns with a population above 20,000 which are centres for the development of the adjoining rural areas.

191. Following is the position of electrification in this district at the end of March, 1959:-

Thus at the end of 1957-58 all the towns and six villages were electrified. Besides lighting, the power is utilised for Small industries, Cinema, houses and allied commercial purposes. Electricity has also been made available for lift irrigation as wells fitted with pumping sets. In addition to the 15 towns and villages mentioned above electricity will be supplied to the 16 villages during the Second Five Year Plan period.

192. Buldana, Deulgaon Raja and Mehkar are the towns where the electricity is generated with the use of diesel. Deulgaon Raja and Mehkar power houses are fitted with 3 generators, two of them of 75 KW and one of them of 28KW capacity. These two power houses are supplying the power to these two towns only. While the power house at Buldana which has got 3 generators, 2 of them with 100 KW and one with

with 70 KW capacity supplies power to Buldana & Chikhali towns and Kelwad (a village).

193. Other towns viz.Khangon, Shegaon, Malkapur, Nandura and Jalgaon are only receiving stations as supply from Khaparkheda Power Project is received there. These towns also supply some of the power to the nearest villages.

194. Power generated by diesel is rather costly and the charge per unit is 50 Nps as against 28 Nps per unit for the power from Khaparkheda. Also the consumer is required to pay a minimum charge of Rs.3.50 in case of diesel supply and Rs.2.00 in case of supply from Khaparkheda. In case of lift irrigation minimum consumption required is of Rs.300 per annum. Government shares the cost of consumption to make good the loss if the consumer fails to consume the minimum requirement. The limit to which Government helps the consumer is fixed to a maximum amount of Rs.150/- .

....

CINEMA HOUSES:

195. India is now one of the leading countries in Cinema Industry. Japan and America are [then] only two competitors in this field. It is one of the most powerful means of propaganda and cine films have captured both the rural and urban public as well. It is also one of the major item as far as receipts of the nation are concerned. Entertainment Tax and other allied duties on this industry are accounting for a substantial portion of our receipt sides.

196. In this district all the towns with the exception of Deulgaon Raja posses Theatres. In all there are 13 Theatres in this district. Buldana, Malkapur and Nandura towns have two each. Khangon has three and the rest one each. Average capacity of the Theatre is about 700 to 800 seats. Total income from entertainment tax during 1958-59 is about Rs. 1.50 lakhs.
