## Chapter 1

### Introduction

#### 1.1 Backdrop:

In India, the role of agricultural price policy and its instruments have time and again been reviewed and undergone changes depending upon the dynamics in the agricultural sector. Infact, India's price policy can be traced back to World War II, when the economy was facing severe food shortage which was accelerated by the Bengal famine, and the primary role of policy measures was to make food available to consumers at reasonable prices. The policy measures were mainly in the form of fixation of ceiling prices, procurement prices, zonal restrictions, stock restrictions, etc. Price policy was mainly consumer oriented and aimed at providing foodgrains to consumers at affordable prices so as to maintain the cost of living and control inflation.

With the setting up of the Planning Commission in 1950 soon after independence and the institutions of Five Year Plans, agricultural development assumed great significance. This was mainly due to the fact that the country was reeling under food shortage which had to be partially satisfied by emergency imports. Fortunately, a major breakthrough came about in technology in the mid sixties which came to the rescue of the food situation that was marked by acute scarcity. Agricultural researchers sought to reconstruct the structure of grain plants to promote higher yields. The new high-yielding, short duration, short-stem, fertilizer responsive, photo-insensitive varieties of seeds of wheat and rice had proved their potential and became available for cultivation. Hybrid varieties of maize, sorghum and bajra were also released and by 1966, high-yielding varieties of India's five major cereals had been introduced. These new varieties primarily based on irrigation and fertilizers increased the grain yield and not the stalks and were also short maturing which facilitated multiple cropping. The use of these high-yielding varieties of seeds along with complementary inputs signaled the beginning of a more dynamic agriculture, mainly described as "Green Revolution" which brought about dramatic increases in productivity of major cereals in 1970s and 1980s. Gradually, high yielding varieties were developed for fibre and oilseed crops also.

The use of new technology described above required heavy investment in agriculture and although its use led to huge productivity increase, the risk involved was equally high. The role of the government was to induce the farmers to adopt the new technology so as to accelerate food production and promote agricultural growth. Hence a number of measures were adopted such as massive investment in infrastructure, creation of appropriate financial institutions to provide credit to farmers and also equally important was price support by promoting a sound agricultural policy. There was thus a clear shift in the thinking of the policy makers with regard to price policy which was now marked by the producer's ascendancy so as to encourage use of scientific farm practices. However, although adoption of new technology had potential to greatly increase

yield levels, it could also create glut conditions in the market and thus depress prices. Therefore, it was thought that a long term policy on the price front would provide more assured income to farmers and thus encourage production response in desired directions. The government accordingly evolved a price support mechanism in the shape of an Agricultural Price Commission which was constituted in 1965. An important function of the Agricultural Price Commission since inception in 1965 was the announcement of Minimum Support Price (MSP) for major agricultural crops in advance of the planting season. MSP is viewed by the Commission as being in the nature of long term guarantee to the producers that any glut in the market which may be caused by excess production will not be able to depress their incomes to unduly low levels. Once the minimum price of a crop is announced, it is implied that the government is committed to purchase, at the announced level of support price, unlimited quantities of the crop concerned, irrespective of the size of the harvest and the level of market prices. Purchases by government agencies at minimum support prices is thus open ended and these prices set a floor below which market prices cannot fall. The price policy also aimed to check the rise in the cost of living, level of wages and industrial cost structure.

The underlying theoretical basis for the guaranteed support price has several elements such as price stabilization, improvement in agriculture's terms of trade and provision of insurance to the agricultural producer. The main purpose of declaration of MSP was to assure reasonable prices to the farmers, motivating them to adopt new technology and make investment in agriculture. In 1985, Agricultural Price Commission was renamed as Commission for Agricultural Costs and Prices (CACP).

## **1.2 Determination of Support Prices :**

The Government of India fixes the support prices for 24 agricultural commodities with a guarantee to farmers that if market prices fall below the support level, government agencies such as Food Corporation of India, Cotton Corporation of India, NAFED, etc. would enter the market and purchase any amount of quantities that are offered at support price. Presently, about 24 major crops are covered under minimum support price programme (paddy/rice, wheat, five coarse cereals, four pulses, eight oilseeds, cotton, jute, tobacco and sugarcane). In case of sugarcane, the minimum support price has been assigned a statutory status and has been called the Statutory Minimum Price (SMP). Market intervention is also another form of support policy of the government, where support is extended to horticultural crops whenever there is drastic fall in prices of these commodities.

The minimum support prices for major agricultural products are announced each year after taking into account the recommendations of the CACP. The CACP while recommending prices takes into account all important factors including cost of production, changes in input prices, input-output price parity, trends in market prices, inter-crop price parity, demand and supply situation of the crop, parity between prices paid and prices received by farmers, effect on industrial cost structure, effect on general price level, effect on cost of living and international

price situation. Thus the MSP is fixed by taking both demand and supply factors and the price structure finally evolved aims at developing a production pattern that should suit national requirements and also lead to rational utilization of land, water and other production resources. The CACP analyses the cost of production data for various states with respect to various agricultural commodities in consultation with the states. After a meeting with State Chief Ministers, the MSP is declared.

The support prices fixed by the government would not be considered as incentive prices to farmers unless prices are fixed at levels which would provide a sufficient margin of profit over total cost. Therefore the unit cost of production is an important consideration in the determination of support prices. The Commission mainly relies on the estimates of cost of cultivation/production generated under the Comprehensive Scheme for studying the cost of cultivation of Principal Crops by Directorate of Economics and Statistics. Under this scheme, state level estimates are generated from holding-wise data obtained from a sample. For the selection of holdings, a multi-stage stratified sampling design is used. While the data collection and tabulation are done by the designated State Agricultural Universities or Agro-Economic Research centres, final analysis of the data and generation of cost estimates are done by Directorate of Economics and Statistics. Since the 1984-85 season, the aggregate sample size is 9000 holdings. The cost estimates include both paid-out and imputed costs. The following are the cost concepts used by CACP:

**Cost A<sub>1</sub>:**

This cost includes all actual expenses in cash and kind incurred in production by the owner. The following are its components:

- i) Value of hired human labour;
- ii) Value of hired animal labour;
- iii) Value of owned animal labour;
- iv) Value of owned machinery labour;
- v) Charges of hired machinery;
- vi) Value of seed (farm grown and purchased);
- vii) Value of insecticides and pesticides;
- viii) Value of manure (owned and purchased);
- ix) Value of fertilizer;
- x) Depreciation on implements and farm buildings;
- xi) Irrigation charges
- xii) Land revenue and other taxes;
- xiii) Interest on working capital;
- xiv) Miscellaneous expenses like artisan payments

**Cost A<sub>2</sub>:** Cost A<sub>1</sub>+ rent paid for leased land

**Cost A<sub>2</sub>+ FL :** Cost A<sub>2</sub> + imputed value of family labour.

**Cost B<sub>1</sub>:** Cost A<sub>1</sub>+interest on value of owned fixed capital (other than land)

**Cost B<sub>2</sub>:** Cost B<sub>1</sub>+ rented value of owned land (net of land revenue) +rent paid for leased land

**Cost C<sub>1</sub>:** Cost B<sub>1</sub>+ Imputed value of family labour (evaluated at wages of attached farm servant)

**Cost C<sub>2</sub>:** Cost B<sub>2</sub>+ Imputed value of family labour (evaluated at wages of attached farm servant)

**Cost C<sub>2</sub>\***: Same as C<sub>2</sub> excepting all labour valued at actual wages or statutory wages whichever is higher

**Cost C<sub>3</sub>:** Cost C<sub>2</sub>\* + 10 percent of cost C<sub>2</sub>\* to account for the value of management input of the farmer.

The rental value of owned land is estimated on the basis of the prevailing rent in the village for identical land subject to the ceiling of fair rent given in the land legislation of the concerned state. The interest on owned fixed capital is worked out at the rate of 10 per cent per annum. The cost of production per quintal is worked out as the ratio of cost of cultivation per hectare to the yield on the farm. The total cost of cultivation per hectare is apportioned to the main product in proportion to the value of the main product in the gross value of output. The estimates are first generated for each size group of holding (simple average of individual holding in the size group) in each village cluster and then weighted average at the state level is worked out.

While determining the level of support prices for the next crop season, the cost estimates concerned by the commission pertain to the previous season or even to two or three earlier years. These cost estimates are projected for the year for which the price is determined. The cost of production is based on the projection of price indices for different inputs which are aggregated by assigning weights. The weights are the shares of input in total cost for the year for which cost estimates are available. In the case of inputs such as fertilizers, electricity's, diesel and irrigation, the prices of which are administratively determined, the latest rates are taken and it is assumed that these will prevail in the ensuing season, whereas in the case of other inputs, the prices are assumed to increase in line with recent trends. The changes in input prices are taken into account by building up input prices indices and combining these into a composite input price index. The prices have to be announced before the commencement of the sowing season but at this information on input prices which farmers will be required to pay is not available. Therefore the commission uses the latest information on input prices and projects them for the ensuing season. The commission monitors the changes in input prices, particularly the administrated prices after the submission of its report. In case revision in the price of some input takes place which is likely, the commission revises recommendation on support prices.

### **1.3 Objectives and Methodology of the study:**

From the above sections, the concept of MSP is clearly defined. The method used by CACP to calculate cost of production of agricultural commodities is also indicated. In the light of the above an attempt is made in this study to "initiate a research based policy advocacy on MSP of selected agricultural commodities". The state of Maharashtra is selected for the study. The main

objective of the paper would be to compare MSP with cost of production of selected major crops in Maharashtra. Further, the Maharashtra Agricultural Prices Committee Cell (APC) recommends MSP for crops produced in the state to CACP, New Delhi. An attempt would be made to compare these prices with the prices finally recommended by CACP.

After the Agricultural Price Commission was set up in 1965, several states formed their own price committees. The state of Maharashtra also followed suit and accordingly the Maharashtra State Agricultural Prices Committee Cell was established in 1970. The main objective of this committee is to recommend MSP for crops produced in Maharashtra to CACP after taking into consideration their cost of cultivation. In order to obtain data for working out the cost of cultivation of each crop, permanent machinery was created in four agricultural universities in the state in 1979. A three stage stratified random sampling technique followed under the Centrally Sponsored Comprehensive scheme is adopted under the state sponsored scheme. There are 280 clusters and each cluster consists of three villages. The operation-wise day to day data on cost of cultivation is collected from ten cultivators (two from each village) of each cluster. Usually, a period of three to four years is selected for data collection. While estimating the cost of cultivation, the state APC considers items of direct and indirect expenditure. The ten items of direct expenditure are hired human labor, bullock labor, machinery, seeds, fertilizers, expenditure on irrigation, insecticides, land revenue, insurance premium and other incidental charges. The items on indirect expenditure include depreciation on agricultural implements, rental value of land, interest on fixed and working capital, family human labor at 25 percent more than hired human labor, and 10 percent supervision charges on direct expenditure. There is a difference in methodology adopted by state APC as compared to CACP for calculating cost of cultivation. Some inputs such as interest on working capital, family human labor, margin on cost are given higher imputed values by state APC as compared to CACP. While fixing state support prices, transport and marketing charges are also included.

The study is based on primary and secondary data. A field survey is conducted in order to observe the cost of production of selected crops. The crops selected are paddy, jowar, redgram (arhar or tur), gram, cotton and soyabean. From Table 1.1, the share of crops in the cropping pattern in Maharashtra can be observed. It can be observed that the share of these crops in the cropping pattern of the state is 69.04 percent.

After selecting the above mentioned six crops, data on cost of production was collected from selected districts which can be observed from Table 1.2 (also refer Appendix A.1). For each crop, data was collected from a sample of farmers in the selected districts. Data was collected for the period November and December 2011.

Secondary data for the study is collected from various sources such as Commissionerate of Agriculture, Government of Maharashtra and Report of The Commission of Agricultural Costs and Prices, Ministry of Agriculture, New Delhi.

Data is compiled using tabular analysis. Graphs are presented to compare MSP with cost of production.

While framing conclusions, discussions with concerned government officials would also be made to understand their views on fixation of MSP. Chapter 1 which is an introductory chapter, is followed by chapter 2 which compares MSP fixed by the CACP with cost of production of selected crops. Chapter 3 deals with field survey and compares the cost of production of selected crops of sample farmers with MSP and price prevailing in regulated markets. In chapter 4 the broad policy recommendations have been highlighted.

## Chapter 2

### **Comparison of Minimum Support Price and Cost of Production**

Minimum Support prices can play an important role in the agricultural economy by providing stimulus to farmers regarding their farming decisions and also encourages them to invest more in agriculture. In this chapter an attempt has been made to compare the MSP with cost of production of selected crops in selected states in order to observe if MSP covers cost of production.

#### **2.1 Minimum Support Price for Various commodities:**

In Table 2.1, the MSP fixed for selected agricultural commodities is presented from 1990-91 to 2011-12.

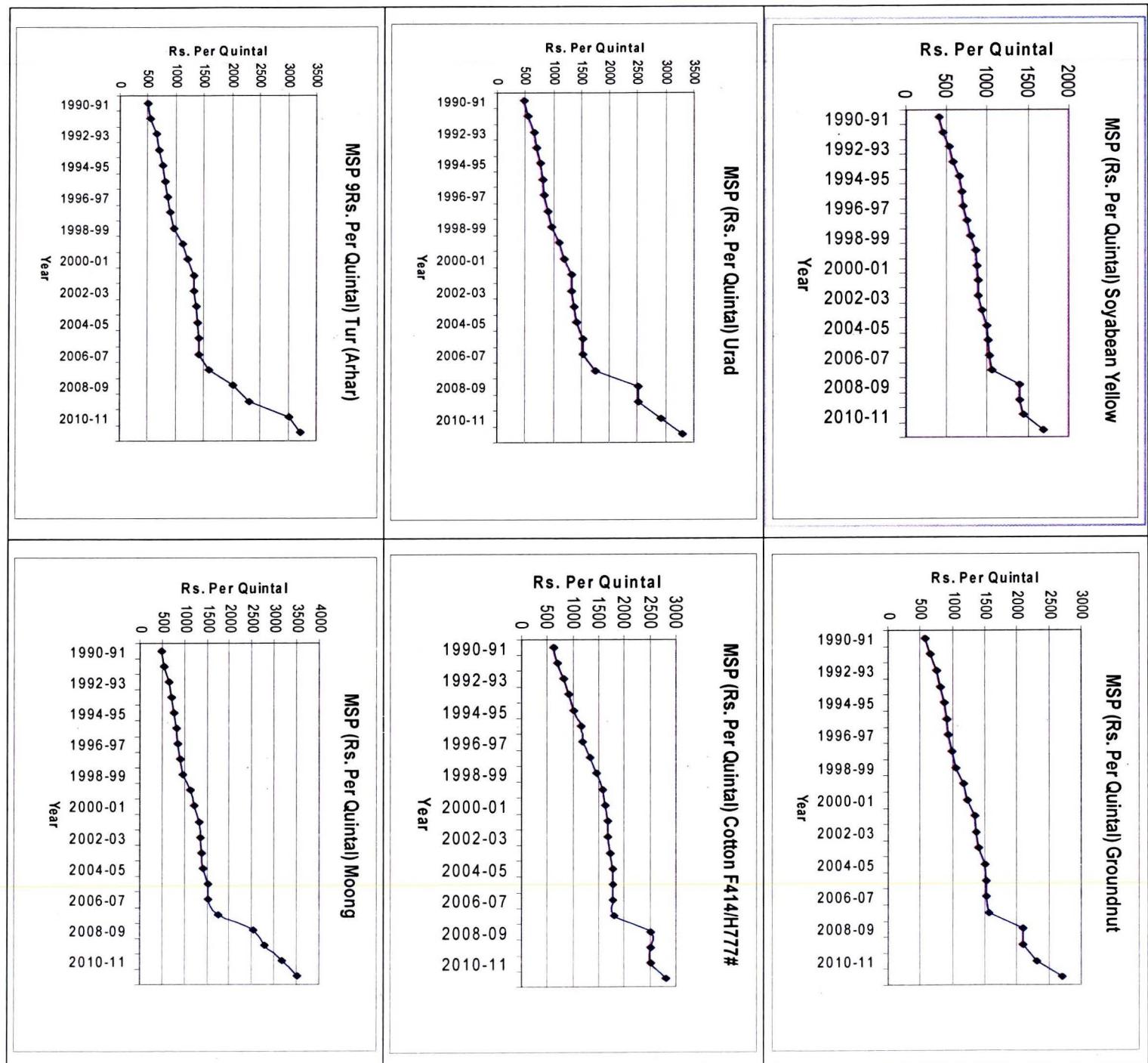




From Table 2.2, it can be observed that during the period 1990 -91 to 2011-12, MSPs grew at the rate of 6 to 8 percent by and large for most crops under consideration. Urad showed highest growth rate in MSP which was 11.16 percent per annum.

The cost of production of crops also showed an increase and comparison of MSP with cost is indicated in the next section for the years 2005-06, 2006-07 and 2009-10.




G.1 (A) Cost Estimates (Rs per quintal) for Paddy (2005-06)




G.1 (B) Cost Estimates (Rs per quintal) for Paddy (2006-07)




G.1 (C) Cost Estimates ( Rs per quintal)for Paddy (2009- 10)



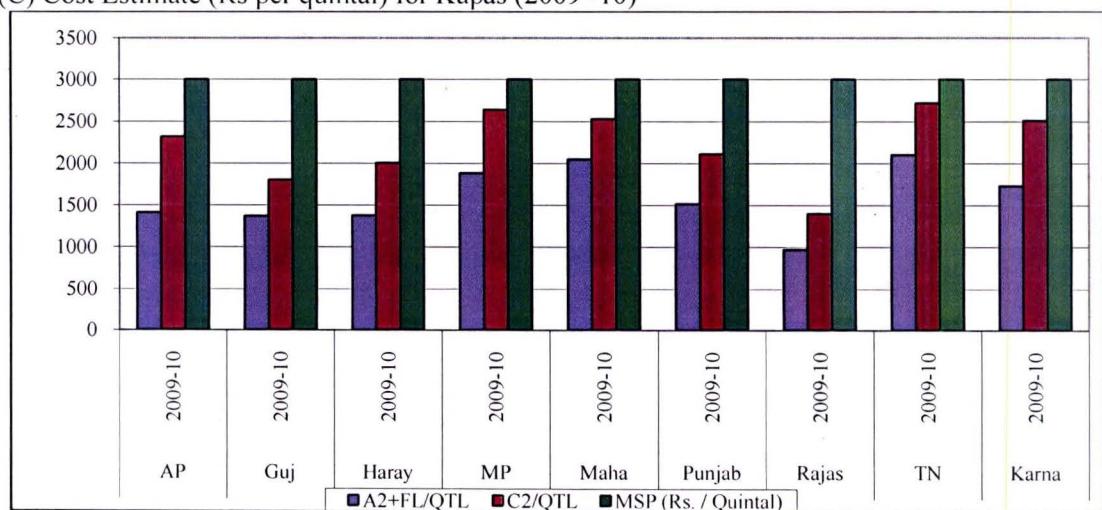
G2 (A) Cost Estimates ( Rs per quintal)of Kapas (2005-06)



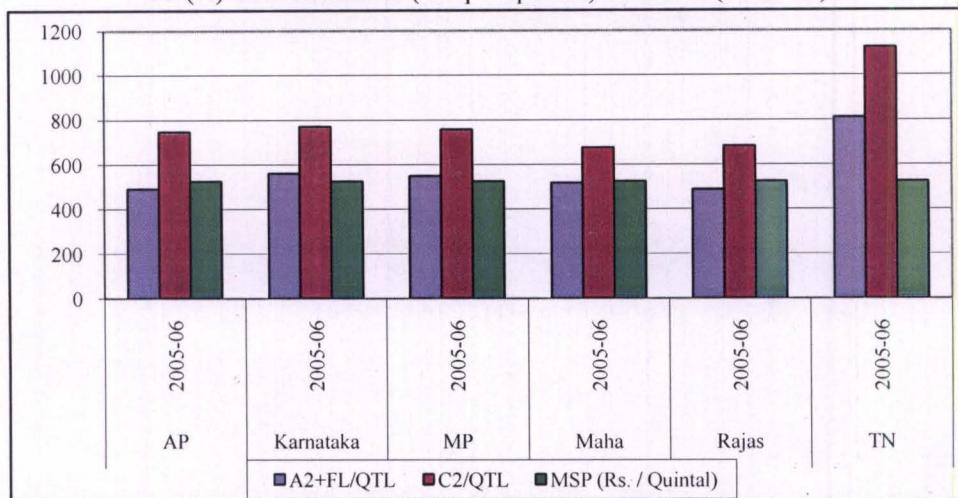

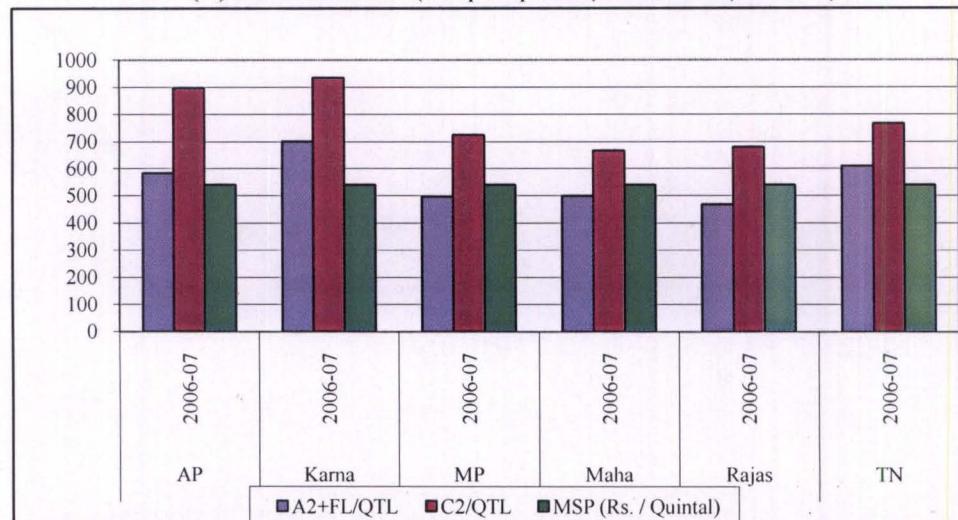
G 2 (C) Cost Estimate (Rs per quintal) for Kapas (2009 -10)



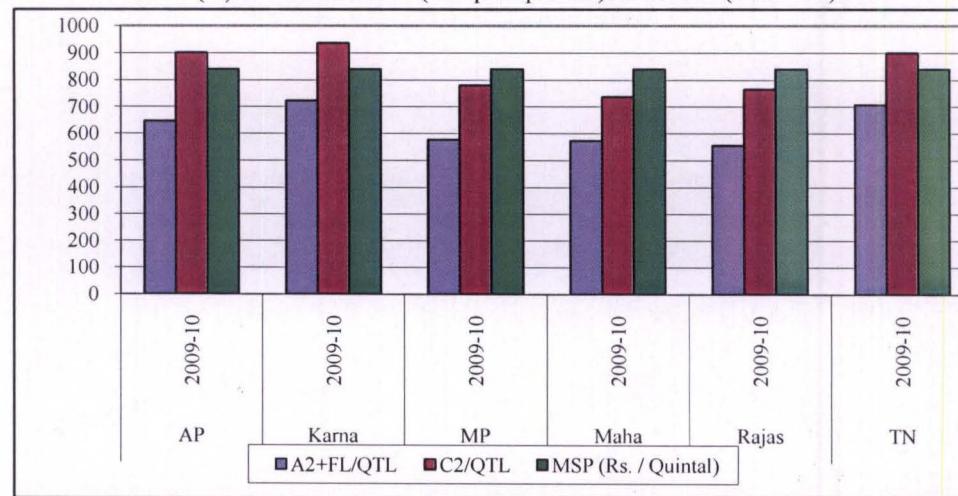

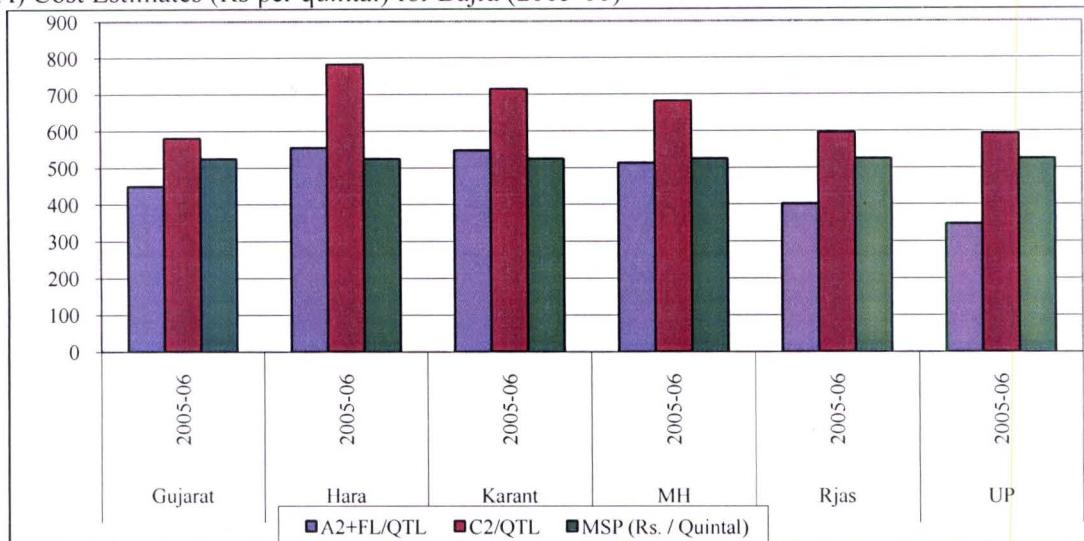
G 3 (B) Cost Estimates ( Rs per quintal) for Jowar (2006-07)





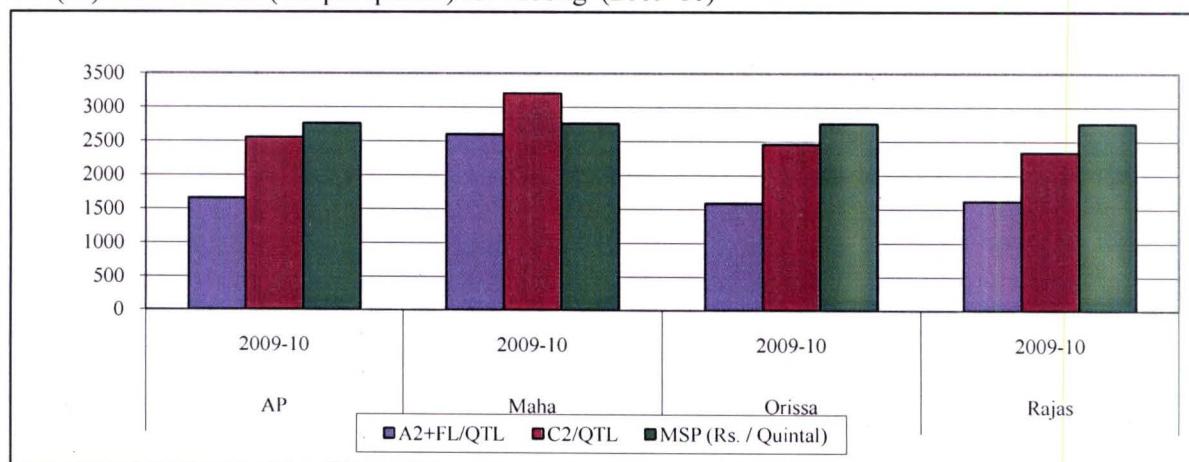
G 7 ( A ) Cost Estimates 9Rs per quintal ) for Moong (2005-06)



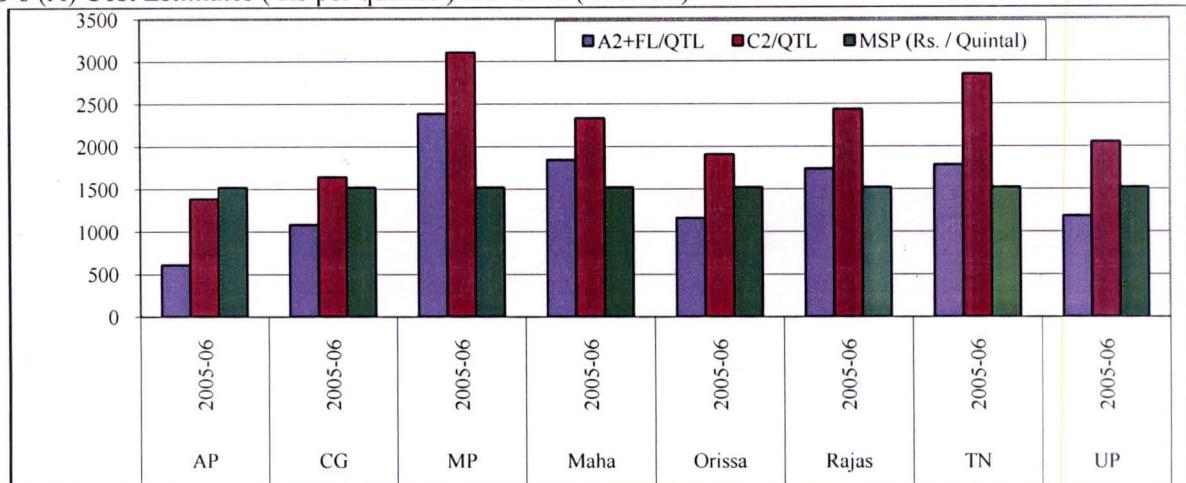

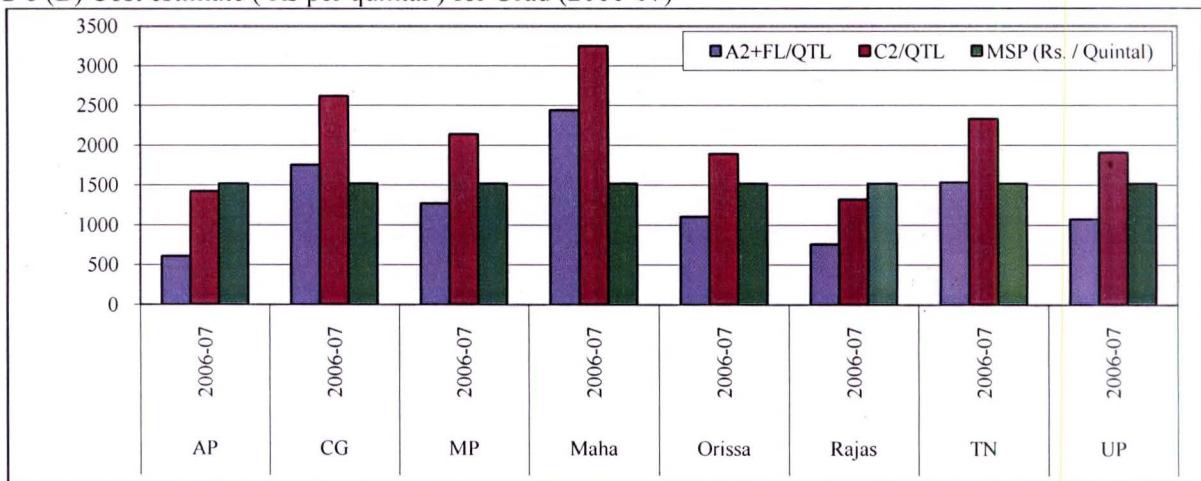
G 7 (C ) Cost estimate ( Rs per quintal) for Moong (2009-10)



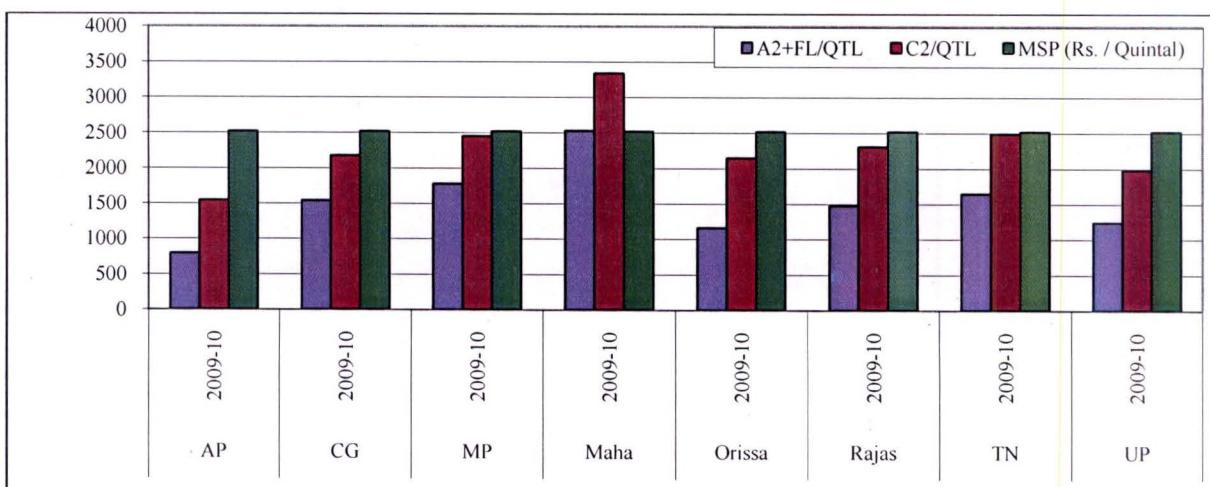
G 8 (A) Cost Estimates ( Rs per quintal ) for Urad (2005-06)



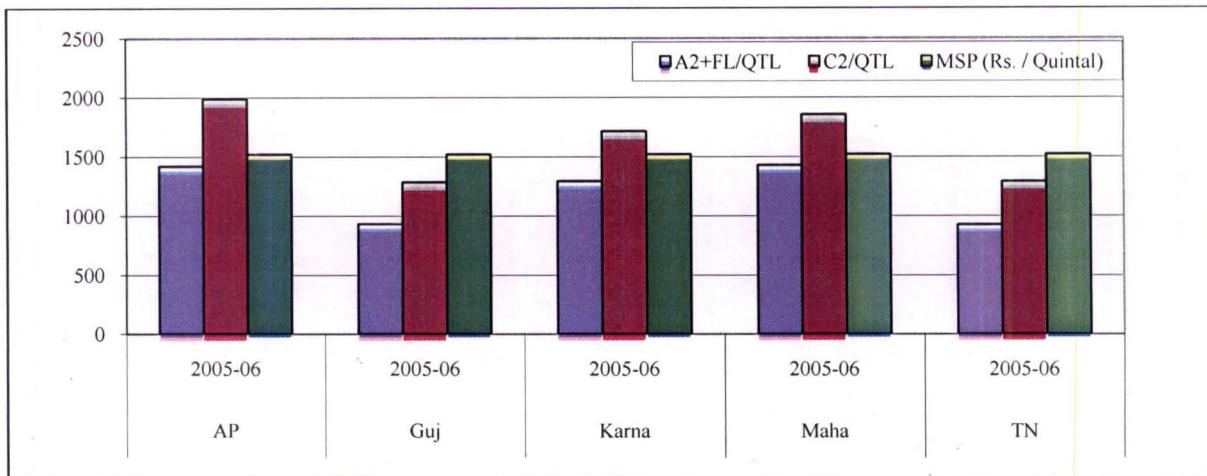

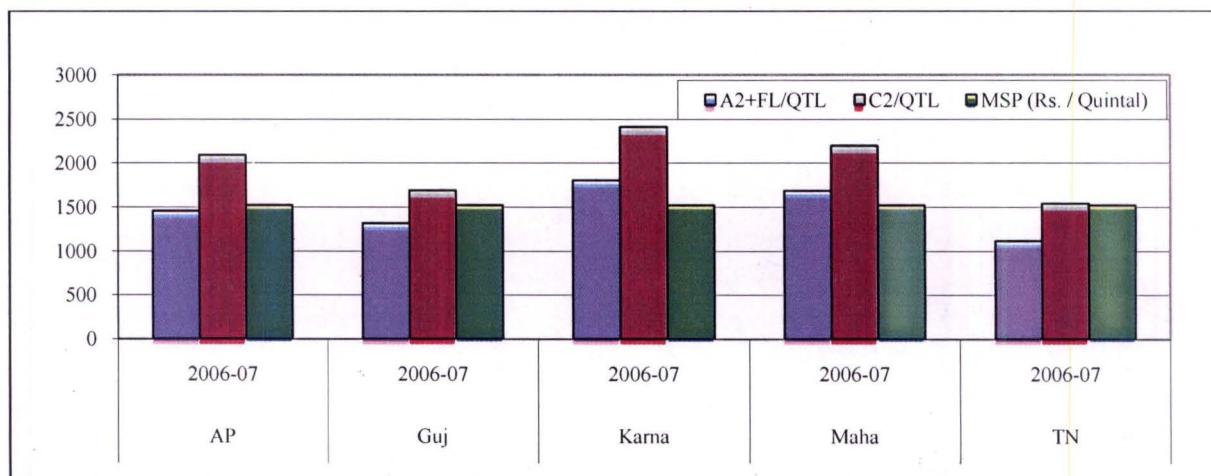


G 9 ( A ) Cost Estimate ( Rs per quintal ) for Groundnut (2005-06)



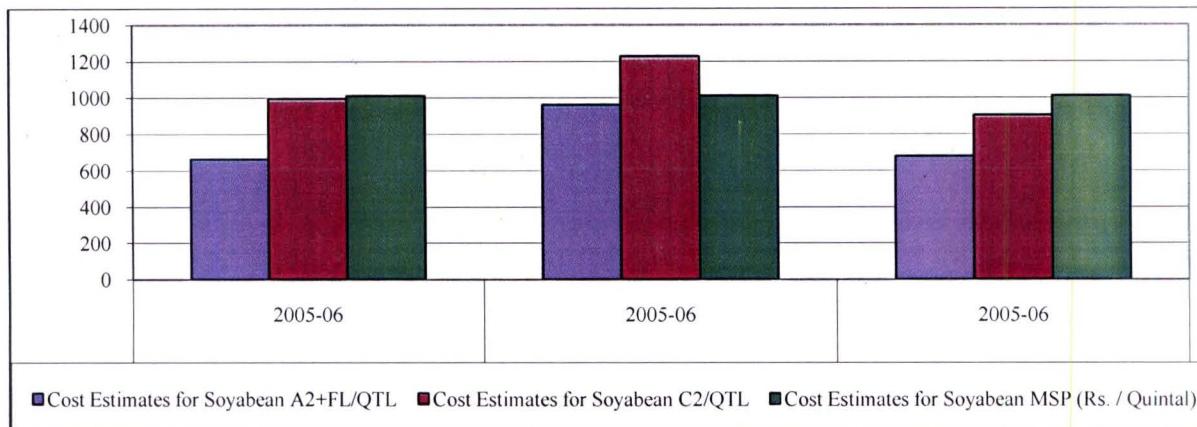
G 9 ( B ) Cost Estimate ( Rs per quintal ) for Groundnut (2006-07)



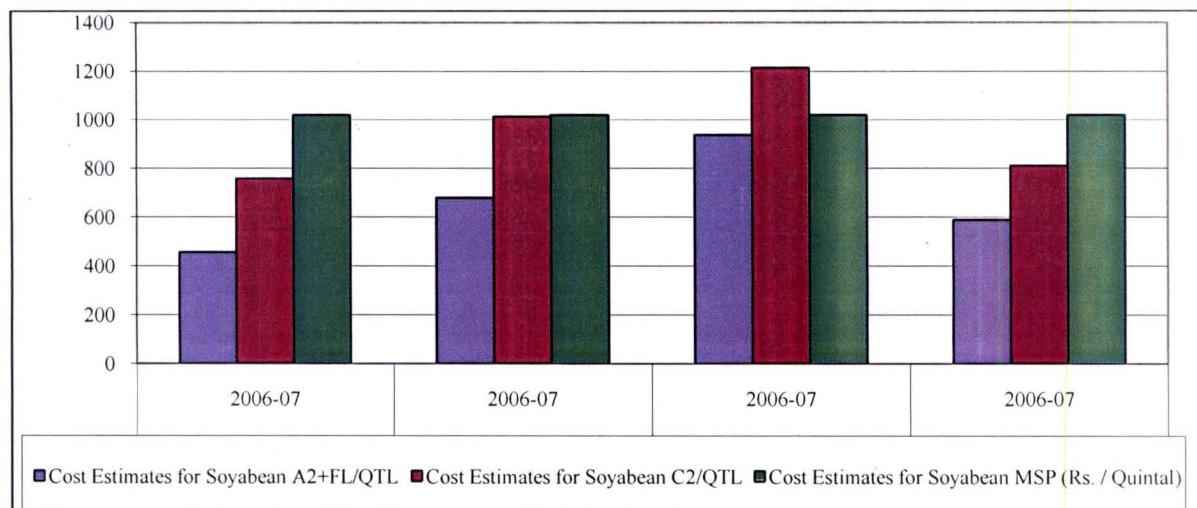
G 9 ( C ) Cost Estimate ( Rs per quintal ) for Groundnut (2009-10)



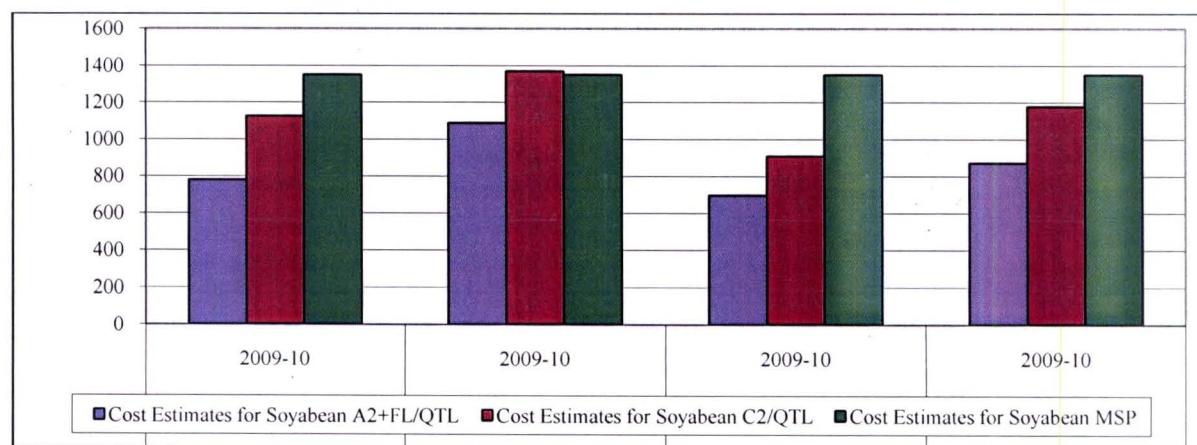
G 10 (A) Cost Estimate ( Rs per quintal ) for Soyabean (2005-06)

It can be observed from graphs G1 to G-10 and from Appendix A.2 that for 2005-06 and 2006-07, in case of cereals, by and large the MSP fixed by the government covered cost A2+FL. However, there are instances when A2+FL was not covered in some states such as bajra in Karnataka. Maharashtra also appeared to be a high cost state and cost A2+FL was not covered for paddy and bajra and ragi. With respect to maize also, cost A2+FL was not covered in 4 states in 2005-06.

In case of pulses, there are several states where cost A2+FL is not covered in 2005-06 and 2006-07. C2 is not covered in case of most crops for several states for 2005-06 and 2006-07. In Maharashtra in 2006-07, C2 cost is double that of MSP, for urad and moong. In case of tur, MSP did not cover A2 + FL or cost C2 in 2006-07 for the states of Maharashtra, Orissa, Tamil Nadu and Uttar Pradesh.

In case of groundnut in 2006-07, A2+FL was not covered in Karnataka and Maharashtra and in almost all cases for most selected states cost C2 was not covered. In case of soyabean, while A2+FL was covered in all selected states, cost C2 was not covered in Maharashtra. Since cost C2 is a larger cost concept and includes a number of cost items such as rental value of owned land, interest on value of owned fixed capital (other than land), it is obvious that these costs cannot always be covered while fixing MSP, especially in states which have low yields and high costs.

In view of the above, it may be noted that cost of production is not the only consideration in setting the MSP and it is also not feasible for the MSP to cover the cost of cultivation in states where this is too high. A consideration in setting the MSP is that it should encourage efficiency and its basic purpose is to guarantee that prices should not fall below some reasonable minimum. With this view, the CACP keeps certain parameters in mind and it is expected that the MSP recommended must cover cost A2+FL for all crops in every state and thus provide a floor which protects farmers against actual losses. However, there are instances when even cost A2+FL is not covered.

The CACP has projected the costs for 2009-10. It can be observed that for all crops and states in 2009-10, cost A2+FL is covered. In fact there are large instances when even cost C2 is

covered. This indicates that the government is making efforts to ensure that a floor price is assured to farmers so that their operational costs are atleast covered.

## Chapter 3

### **Economics of selected crops based on field survey in Maharashtra**

In chapter 2, a comparison was made between MSP and cost of production for major crops across several states. It was observed that there are instances when MSP does not cover cost A2+FL in 2005-06 and 2006-07. C2 cost is also not covered in several cases. In this chapter, an attempt has been made to note the cost of production of sample farmers in the state of Maharashtra, for six important crops namely paddy, jowar, red gram (tur), gram, cotton and soyabean and observe the net returns received by them. The weighted average price received by sample farmers is also compared with MSP.

#### **3.1 Cost of Production, MSP and Net Returns of sample farmers based on field survey:**

As mentioned earlier, primary data has been collected for six crops in selected districts from sample farmers. In case of paddy, Raigad district was selected and for jowar, Pune and Satara districts were selected. Latur was selected for gram and tur and Amravati district was selected for data collection for cotton and soyabean. In Table 3.1, the net returns per hectare are indicated, and in Table 3.2 and Table 3.3, the cost per acre and per quintal are observed alongwith their percentage share for the selected crops. From Table 3.1, it can be observed that across all crops the weighted average price received by sample farmers was higher than MSP. However, the per quintal cost was also high. Among all items of cost, the share of human labor is highest and ranged between 22 percent for soyabean to 39.35 percent for paddy. In case of paddy, cost of human labor along with animal labor accounts for 55 percent of total cost. In case of tur, human and animal labor account for 49 percent of the total cost. Jowar had relatively high costs for machinery (20 percent) and preparatory tillage (25.3 percent).

As far as total cost per acre is concerned, the cost of paddy was highest which was Rs 19761.48 per acre, followed by kapas which was Rs 17891.79/- per acre. However, the per quintal cost presents another picture. The per quintal cost of kapas is Rs 4170.58/-, followed by that of tur which is Rs 3367.30/- per quintal. Since the yield of paddy and jowar are much higher than that of other crops, their per quintal cost is also relatively lower. In case of kapas, the cost of manures and fertilizers was 15.65 percent. Further, kapas is a crop which is easily affected by a

number of pests which increases the expenditure on plant protection measures. The cost of plant protection in case of kapas is 11.18 percent and is Rs 466.41 per quintal.

From Table 3.1 it can be observed, that net returns per acre are negative for kapas to the tune of Rs 3000/- per acre. This clearly indicates that farmers are making losses in the cultivation of cotton. The per quintal cost of production is Rs 4170.58/- while the weighted average price received by sample farmers is Rs 3474.75/- per quintal.

The net income per quintal is also observed to be very low in case of soyabean which is only Rs 175.97 per quintal. While the cost per quintal of soyabean is Rs 1816/- the weighted average price realized by sample farmers is Rs 1993 /- per quintal.

Overall, it can be observed that out of the six crops studied, the cost of production is higher than MSP for three crops, namely tur, cotton and soyabean. The cost of production is higher by 5.2 percent in case of tur, 26.4 percent in case of cotton and 7 percent in case of soyabean as compared to MSP. The important point to note is that MSP has not covered even the operational costs of the sample farmers and if cost C2 were considered, the difference between cost of production and MSP would be even higher. In case of gram the weighted average price realized by sample farmers is lower than MSP. However, since the cost per quintal is 28 percent lower than the realized price, the farmers received a net income of Rs 687.84 per quintal.

The overall conclusion that appears from the field survey is that MSP has not covered the operational cost of production for paddy, tur, raw cotton and soyabean. In case of paddy, tur and soyabean, since the market price realized by farmers is higher than cost of production, the farmers did not incur losses. The case of kapas is however, disturbing, the cultivation of which is causing huge losses to farmers as market price and MSP are lower than cost of production. The cost of production is 20 percent higher than the realized price which is making the cultivation of cotton unviable. In case of gram, the market price realized by the farmers is lower than MSP but since cost of production is lower than realized price farmers earned a net income of Rs 3494.25/- per acre.




After having detailed discussion in a consultative workshop, it was felt that the cost of production should also be calculated taking into consideration Rs 300/- as daily wage rate just to understand what the potential cost of production could be. The same was attempted in the study. It was observed (see Appendix A.3.2) that after considering Rs 300/- as daily wage rate, the costs increased by 4 percent for paddy, 27 percent for jowar, 38 percent for tur, 33percent for gram, 45 percent for kapas and 41 percent for soyabean. Losses would therefore be incurred for tur, and soyabean while losses to cotton would further increase.

In the graphs presented below the cost of production, weighted average price of sample farmers, MSP and net income per quintal are indicated for the six selected crops in the field survey.

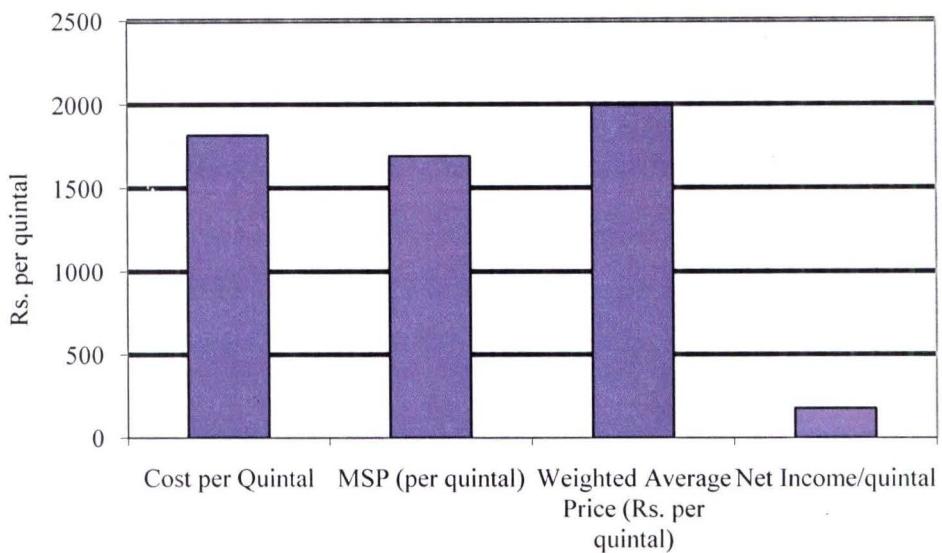
G.1 Jowar



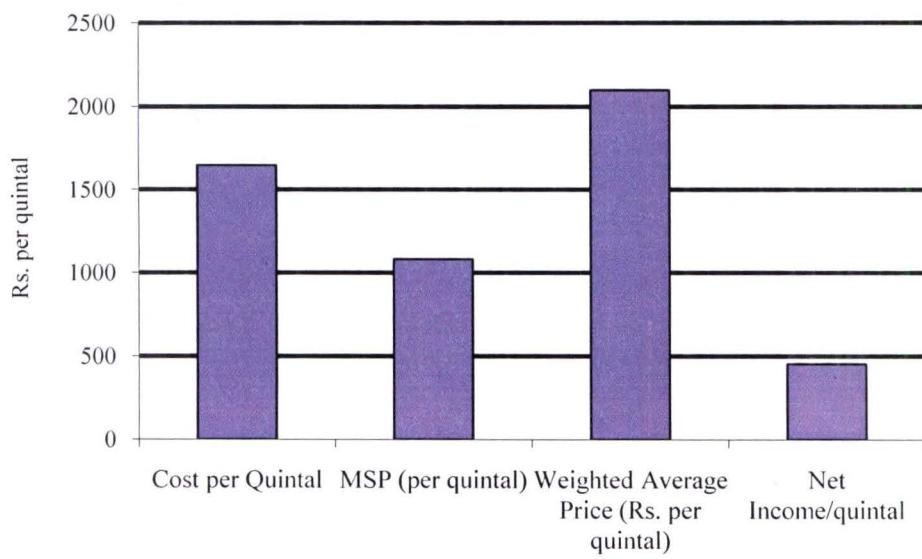
G.2 Tur




G.3 Soyabean



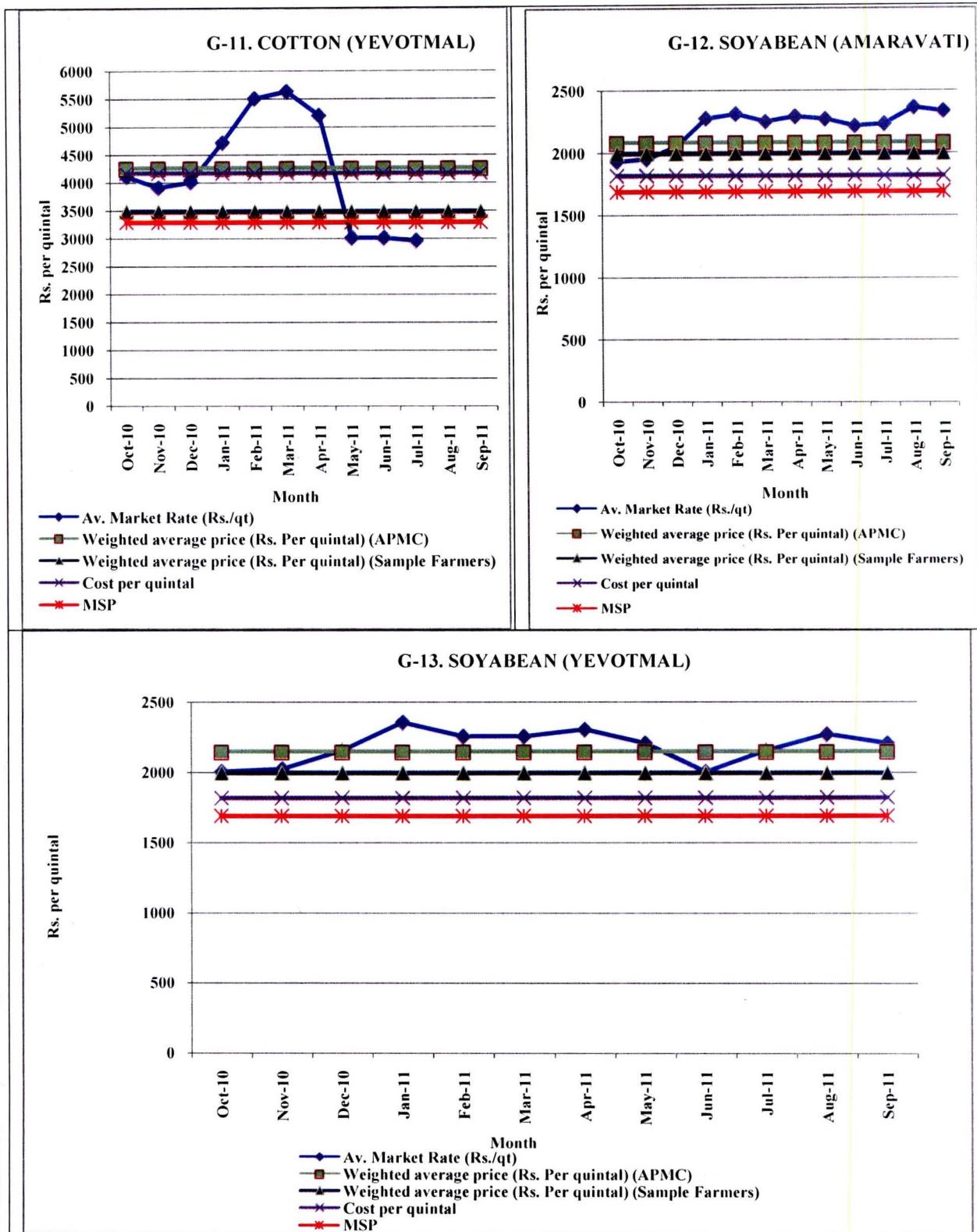

It can be observed from Table 3.5 that the price received by sample farmers in case of kapas and soyabean was lower than ruling market prices. Quality of produce may be one factor responsible for lower price or sale during peak season when prices are lower. In case of gram the price received by sample farmers was lower than MSP. It is possible that government agencies were not present in the market and hence farmers were forced to sell their produce at prices prevailing below MSP.

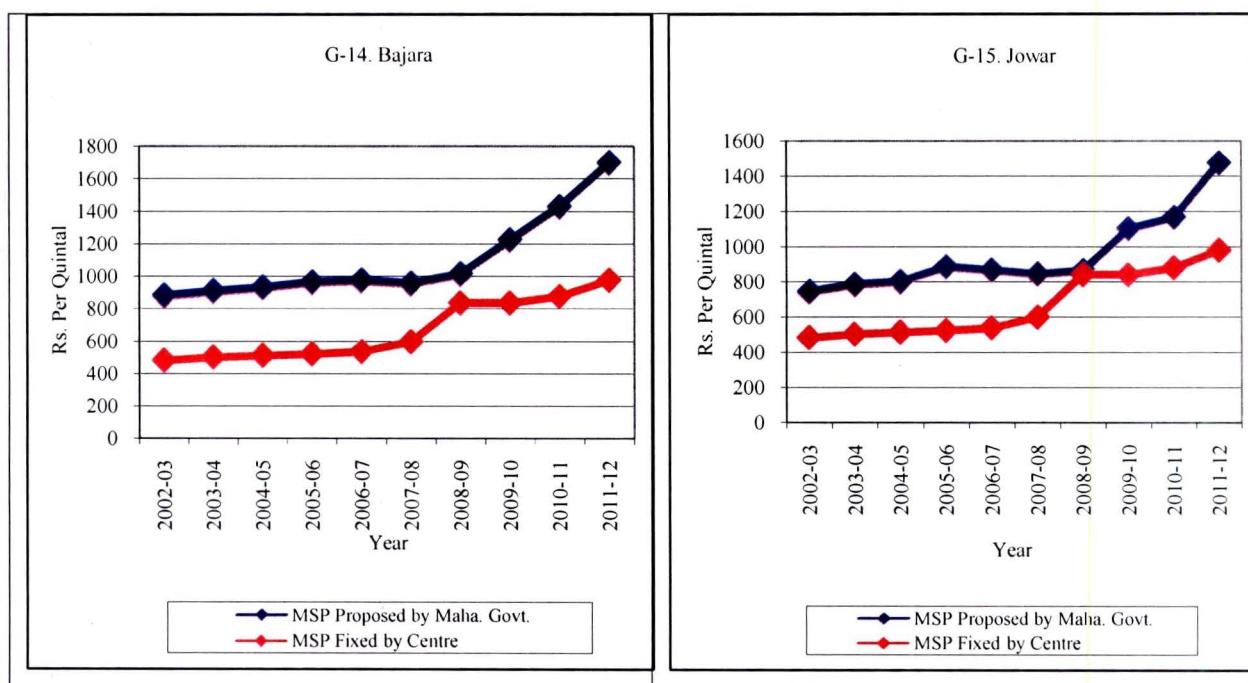


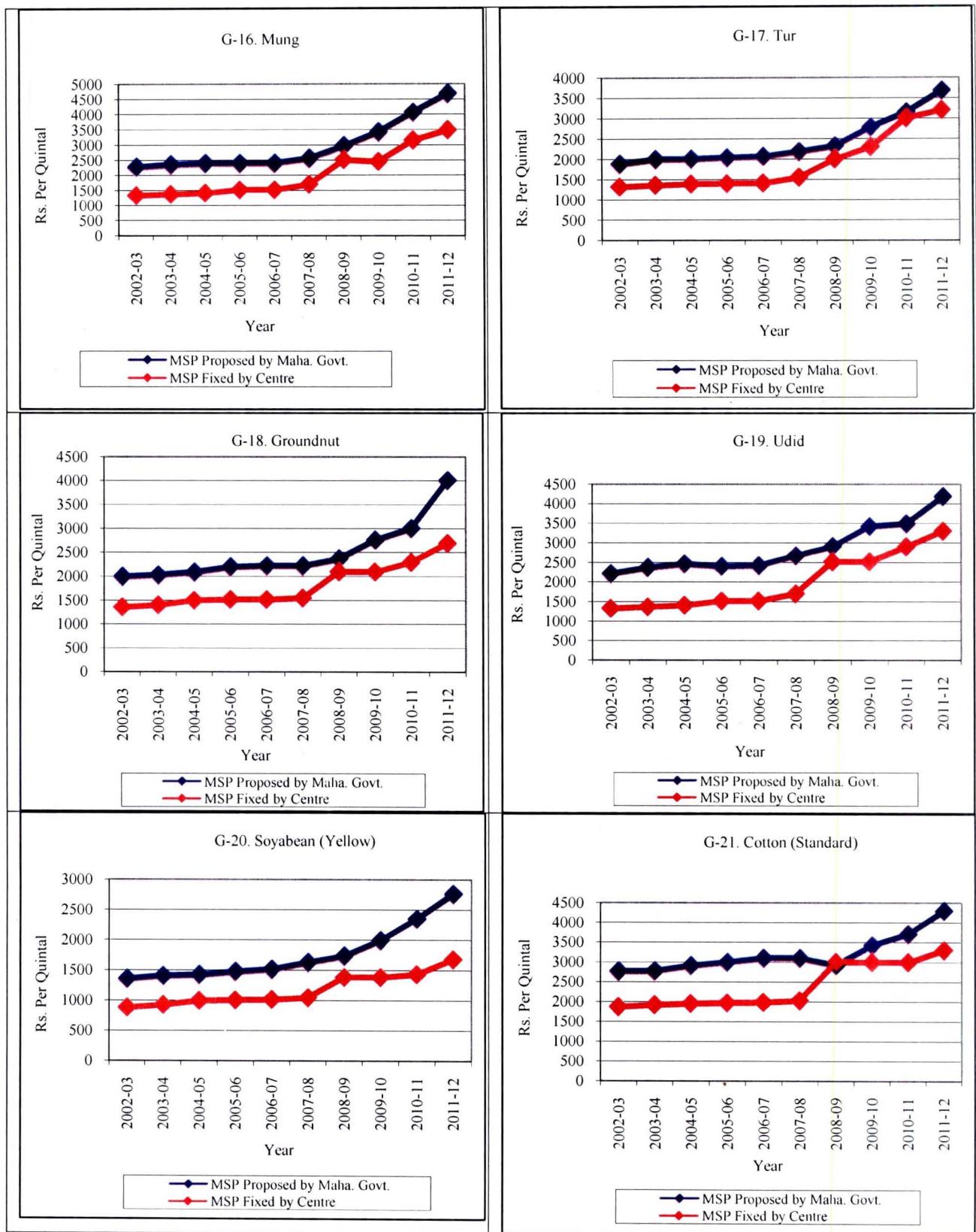


### 3.3 Comparison between MSP recommended by Maharashtra Agriculture Price Committee Cell and MSP fixed by CACP:

The main objective of the Maharashtra Agricultural Price Committee cell is to recommend MSP for crops produced in the state to CACP, New Delhi on the basis of cost of cultivation of crops produced in the state. Accordingly, the price recommended by Maharashtra state government to CACP for the period 2002-03 to 2011 -12, for 16 major crops is presented from graphs 14 to 26. It can be observed from the graphs that for every crop in every year, the price recommended by state to CACP is always much higher than that actually fixed. The percentage difference by which MSP declared by CACP is lower than price recommended by Maharashtra state is indicated in Appendix A.3.1. By and large the price recommended by Maharashtra state is 30 to 40 percent lower than that actually declared by Centre.

Since the MSP fixed by CACP is much lower than that recommended by the state, it can be concluded that Maharashtra is a high cost state. Agriculture in the state is mainly rainfed and due to lack of irrigation facilities, yield rates of major crops are low. Consequently Maharashtra has higher cost of production as compared to other states which have irrigation facilities. Hence support prices declared for the country as a whole may not cover cost of production of crops grown in unirrigated states like Maharashtra.

### **3.4 Comparison between Cost of Production for selected crops in Maharashtra and MSP:**

It was observed in the earlier section that Maharashtra is a high cost state. In this section an attempt is made to compare the cost of production of major crops in Maharashtra with MSP.

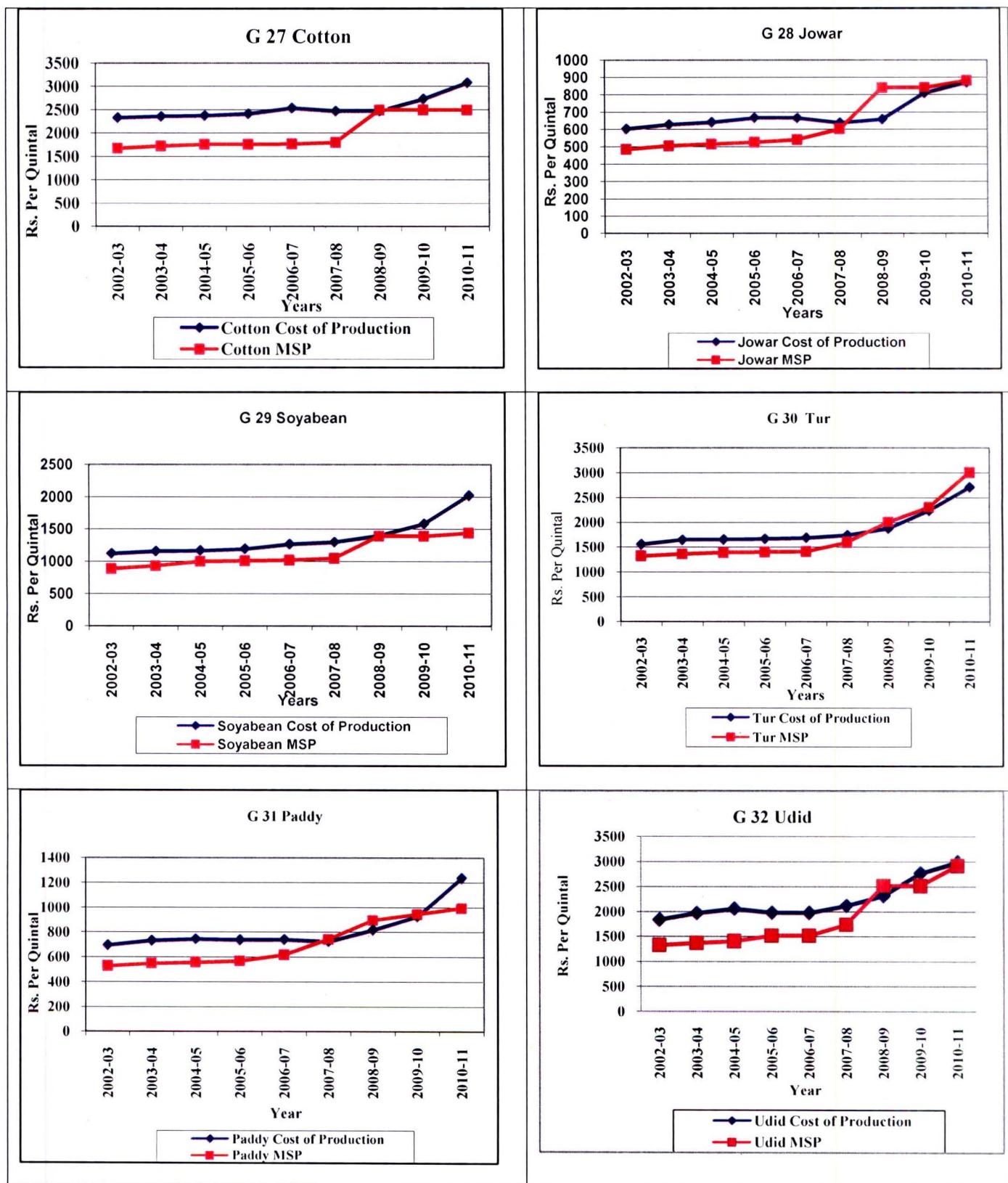

The data related to cost of production in Maharashtra is obtained from Maharashtra APC cell collected under the Cost of Cultivation studies. The data is presented in Table 3.6 and also indicated in graphs G 27 to G 32. It can be observed that for all six selected crops in almost every case, the cost of production is higher than MSP.

In case of cotton, in 2010-11, the cost of production was 22.68 percent higher than MSP. With respect to jowar and tur, which are major crops in Maharashtra, during the last three years, i.e from 2008-09 to 2010-11, the cost of production is marginally lower than MSP. In case of paddy, from 2007-08 to 2009-10, the cost of production in Maharashtra was lower than MSP fixed by the centre. However, the cost increased in 2010-11 and was about 24 percent higher than MSP. In case of soyabean in every year, the cost of production was higher than MSP and in 2010-11, the cost was as much as 40 percent higher than MSP.

A comparison between the cost of production in Maharashtra as indicated above with that of our sample farmers reveals that our sample farmers had a much higher cost for cotton, jowar, tur, and paddy as compared to the overall picture in the state. This indicates that the extent by which costs are higher than MSP in Maharashtra as indicated in Table 3.5, is only an underestimate. MSP therefore does not provide sufficient protection to farmers against crash in prices and Maharashtra is a high cost state due to low yield levels of major crops. The main purpose of MSP is to ensure reasonable prices to farmers, motivating them to adopt new technology and make investment in agriculture. Agriculture as an economic activity is however proving to be unviable for farmers in Maharashtra and if prices reach support levels, farmers will not cover their operational costs. Administration of MSP is equally inefficient and state agencies are not always present at the appropriate time. MSP therefore has its own limitations for states like Maharashtra.

## Chapter 4

### Broad Conclusions and Policy Implications

In order to promote agricultural growth and increase food production, the government of India has resorted to a number of policy measures. Such measures comprised of massive investment in irrigation (major, medium and minor irrigation), creation of appropriate financial institutions to provide timely short-term as well as long term- credit to farmers, and by and large investment in rural infrastructure. Equally important was also a price support policy and producer's ascendancy while framing price policy so as to induce him to use new technology. Accordingly the Agricultural Price Commission since inception in 1965 (renamed as Commission on Agricultural Costs and Prices in 1984) began announcing Minimum Support Prices for major agricultural crops in advance of the planting season. MSP is viewed by the Commission as being in the nature of long term guarantee to the producers that any glut in the market which may be caused by excess production will not be able to depress their incomes to unduly low levels. Once the minimum price of a crop is announced, it is implied that the government is committed to purchase, at the announced level of support price, unlimited quantities of the crop concerned, irrespective of the size of the harvest and the level of market prices. Purchases by government agencies at minimum support prices is thus open ended and these prices set a floor below which market prices cannot fall.

In view of the above, an attempt was made in this paper to observe if the MSP declared by the CACP, covered atleast operational costs in major states for major crops. Further, the focus of the study was Maharashtra on Maharashtra state in order to observe the cost of production of sample farmers and compare it with MSP as well as prices prevailing in the regulated markets. Further, the prices recommended by Maharashtra APC cell to CACP were compared to the MSP actually announced.

#### **The following policy implications emerge from the study:**

1. When the MSP for a crop is fixed, it is expected that it should atleast cover cost A2+FL, but not necessarily cover the full costs of the relatively high cost states. However, from the secondary data collected from the reports of CACP, it was observed that there are cases when cost A2+FL are not covered. For example, in case of pulses in 2005-06 and 2006-07, cost

A2+FL is not covered in several states. Thus in cases where MSP is lower than A2+FL even a floor is not provided to farmers which protects them against losses. The very purpose of MSP is to prevent any cash losses to farmers even in years of glut, so as to encourage them to use new technology. The CACP must therefore take necessary steps to ensure that atleast operational costs of farmers are covered.

2. The field survey conducted in several districts in Maharashtra for five crops, showed that MSP did not cover the operational cost of production for paddy, tur, raw cotton, and soyabean for sample farmers. In case of paddy, tur and soyabean, since the market price realized by farmers is higher than cost of production, the farmers did not incur losses. However, in the event of prices falling below MSP, the farmers would have incurred losses. Such situations must not arise and CACP should take into consideration such situations while recommending MSP to the Central government.
3. The field survey in Amravati district, showed that cultivation of *kapas* is causing losses to farmers as market price and MSP are lower than cost of production. The cost of production was observed to be 20 percent higher than realized price which is making the cultivation of cotton unviable. In fact, in 2011-12, there was an increase in acreage of cotton in the country by 9 percent as compared to the previous year i.e 2010-11. The state of Maharashtra has highest area under cotton in the country and accounted for 33.6 percent of country's area. The cotton area in Maharashtra is mostly concentrated in Vidarbha which is recently known as a "suicide belt". However, with decline in prices in 2011-12, farmers are likely to face falling profits or even incur losses. There is also a sharp decline in international prices as compared to 2010-11. There is a strong agitation by cotton farmers in Maharashtra for increase in MSP of cotton and they are reluctant to bring their produce for sale in hope of higher prices. High cost of production of cotton is therefore a cause of concern and is often quoted as a major cause of agrarian crisis in Maharashtra. In 2011-12 while the MSP recommended by state government was Rs 4285/ per quintal, the price fixed by centre was Rs 3300/-per quintal for long staple cotton while in case of medium staple the price fixed by centre was 32 percent lower than that recommended by state APC cell to centre. The cost of production in Maharashtra has also observed to be much higher than MSP. There therefore appears to be a case to increase MSP of cotton. Equally important is the need to increase productivity so as to reduce cost. Cotton cultivation in the state is mainly rainfed and due to

lack of irrigation facilities, the yield is very low. While yield of cotton in Maharashtra in 2010-11 is 351 kg per hectare, it is 659 kg per hectare in neighboring state of Gujarat. Other cotton growing states have also shown much higher yields than Maharashtra.

4. The field survey showed that in case of gram, the market price realized by sample farmers is lower than MSP, but since cost of production was lower than realized prices farmers earned a positive net income. However, this indicates that state agencies were not present in the markets to make purchases when prices fell below MSP. In case there was presence of state agencies, the farmers would have an opportunity to sell their produce at higher prices as MSP was higher than ruling market prices. Sale at MSP would have increased their net income. It is therefore necessary that when prices fall below MSP, the state agency such as National Agricultural Co-operative Marketing Federation, designated for pulses should enter the market and conduct procurement operations.
5. By and large, Maharashtra is a high cost state for all crops and prices recommended by State are far higher than MSP actually fixed by Centre. The state has highest area in the country for tur, which is almost 30 percent of the country's area and also contributes highest to the country's production. The net returns to farmers are however very low. Efforts must therefore be made to increase productivity of pulses by improving irrigation facilities besides providing price incentive to farmers.
6. Maharashtra has second highest area under soyabean, followed by Madhya Pradesh, but the cost of production is higher than MSP. Soyabean is an important non conventional oilseed in the state and contributes to about 13 percent of gross cropped area in the state. It is therefore necessary to increase productivity of the crop along with price support so as to induce farmers to cultivate the crop. It may be noted here that about a decade ago, the government had to rationalize duty structures to harmonize the interests of domestic oilseeds producers, consumers and processors. To protect the growers of oilseeds, import tariffs had to be increased so that domestic price could compete with international prices. With rise in incomes, demand for edible oils is increasing, and it is therefore important to increase productivity of soyabean. Besides increasing MSP, technology must also play a role in increasing productivity.
7. Technology is necessary for increasing production and building a sound agricultural economy. However, after production, marketing of produce is equally important and it is in

this context that MSP plays an important role. In order to ensure price stability, infrastructure facilities must be made available to farmers. Hence adequate number of procurement centres throughout the country must be set up so that farmers do not have to make distress sales. There are several states in the country where there is inadequate coverage of procurement operations and only limited farmers in certain states are able to benefit from the price policy of the centre. Further, there must be timely intervention by designated government agencies to purchase the produce at support prices in case open market prices fall below support level. If appropriate infrastructure is not available, farmers are denied the benefit of MSP and declaration of MSP remains merely a notional concept. Hence the government must ensure that there is timely intervention by state agencies whenever required.

Overall the study concludes that although MSP aims at setting a floor price below which market prices must not fall and it must cover atleast cost A2+FL, this has always not been the case. Maharashtra is a high cost state and prices recommended by state APC cell to Centre are much higher than that finally announced by centre. Infrastructure bottlenecks must also be removed so as to facilitate implementation of price policy and prevent distress sales.
