

INTRODUCTORY

This Committee is responsible, at the national level, for training of personnel in the Cooperative Sector. For this purpose, a three-tier Coperative training structure exists in the country. It comprises of Vaikunth Mehta National Institute of Cooperative Management, Poona, for Senior personnel, a net work of Cooperative Training Colleges for Intermediate personnel, directly administered by the Committee for Cooperative Training, and a number of Junior Centres to cater to the training requirements of the Junior personnel, primarily run by the State Cooperative Unions.

Essay and Debating Competitions.

- 2. A function also discharged by the Committee for Cooperative Training, is to enthuse interest amongst the students in the ideology and practice of Cooperation, and to inculcate in them a spirit of Cooperative leadership. For this, the Committee sponsors, every year, Essay and Debating Competitions on Cooperation. The Essay Competition is held at the University level only, while the Debating Competitions are held at two levels; Inter-Collegiate Debates organised by the Universities, followed by Inter-University National Debate on Cooperation held at the national level.
- 3. The Scheme, started in the year 1960-61, is now in operation for 15 years. For the first five years, the National Debate was held in Collaboration with Delhi University. The Debate now is held by rotation in different Universities, which offer to collaborate in this activity. The participation in these Competitions have shown increase, year after year. It is also heartening to note that several Universities have spontaneously come forward to host the Debate at the National level. The year-wise participation in the National Debates is given at annexure IV and the subjects discussed in the Debates and Symposium at Annexere V.
- 4. A step in the direction of educating the students in the principles and practices of Cooperation is that, the Committee also convenes a symposium on the eve of National Debate, in which eminent Cooperators, Government Officials concerned with the promotion of Cooperatives, Academicians and Economists participate.

5. Apart from the Universities, the Cooperative Institutions are also involved in this activity. The National Agricultural cooperative Marketing Fedration, in the year 1969-70, instituted a Running Shield for the best team, while the Maharashtra Rajya Sahakari Sangh donated the Runners Cup for the National Debate. During the current year two special cups have also been instituted by the Vaikunth Mehta National Institute of Cooperative Management, Poona and M.P. State Cooperative Bank for the best composite team of Hindi and English debators and best Hindi speaking team respectively. Besides, a large number prizes were also instituted by the local Cooperative Institutions.

NATIONAL DEBATE

- 6. The XV Inter-University National Debating Competition on Cooperation was organised in collaboration with Vikram University and Madhya Pradesh State Cooperative Union, at Ujjain, on 13th and 14th February, 1975. The subject of the Debate was "COOPERATION IS THE SYNTHESIS OF THE BEST IN SOCIALISM AND CAPITALISM".
- 7. The Debate was inaugurated on 13.2.1975 by Dr. Shivmangal Singh Suman, Vice-Chancellor, Vikram University. The inaugural function was presided over by Shri K.L. Shukla, Minister for Agriculture and Cooperation, Madhya Pradesh. Shri S. Sisodia, M.P., Chairman, Madhya Pradesh State Cooperative Union, welcomed the guests and participants.
- 8. Speaking at the inaugural function, the Vice-Chancellor called upon the students to adopt the Cooperative way of life. He said that the students can start their own Cooperative messes in the hostels, Cooperative Stores to meet their daily needs, books, stationery, clothes, ration etc., Cooperative dairies and even the Chemist shops. This, he said can provide poor students with employment opportunities and open new vistas to earn and learn. To equip the Youth with the basic tenets of Cooperation, the Vice-Chancellor also stressed the need of teaching of the subject, as an independent discipline, in the Universities. In this, he felt that National Cooperative Union of India, should collaborate at various levels in formulation of policies and materials for Cooperative education in the Universities.
- 9. The text of the speech of the Vice-Chancellor and address of the Minister are given at Annexures given I and II.

- 10. Of the 47 Universities which intimated their willingness to participate, by virtue of their organising Inter-Collegiate Debates on Cooperation. 40 Universities with 74 participants, however, could participate in the National Debate, Participation last year was 84 students from 43 Universities. The standard of the debate was of a very high order and the performance of young debators reflected deep study of the ideology and practice of Cooperation. The list of participants is given at Annexure VI.
- 11. The Teams from Bombay and Mysore Universities were jointly adjudged the best and were awarded the National Scrolls by the Committee for Cooperative Training. They also shared the Running Shield instituted by the National Agricultural Cooperative Marketing Federation. The Indian Institute of Sciences, Bangalore, got the Runners Cup donated by the Maharashtra Rajya Sahakari Sangh. The Rajasthan University was awarded a Special Cup, instituted by Madhya Pradesh State Cooperative Bank, for sending the best Hindi Team and the Ravi Shankar University received the Special Cup for the best composite Team of Hindi and English Debators, instituted by Vaikunth Mehta National Institute of Cooperative Management, Poona.
- 12. For individual merit, Shri Nalin Kumar Shastri of Magadh University won the first prize of Rs. 250/-; Kumari Shobha Rao of Mysore University secured the 2nd prize of Rs. 200/-; while the 3rd prize of Rs. 150/- was shared by Shri Atul John Rego and Francis Mathews, both of Bombay University. Shri Nalin Kumar Shastri also received the special prizes, instituted by the local cooperative Institutions, as the best Boy speaker, best Hindi speaker and best speaker against the motion; Kumari Shobha Rao got the special prize as best Girl speaker and the best English speaker; while Shri Francis Mathews received the special prize of best speaker speaking for the motion.
- 13. Special prizes were also awarded to Shri Ashok Dubey of Vikram University, Shri Suresh C. Joshi of Rajasthan University, Shri Srinivas Mohan of Nagpur University; and consolation prizes to Kumari Zehra Hamid of Ravi Shankar University, Shri Subha kirti Majumdar of Patna University, Shri Srinivas Rajagopal of Osmania University, Shri R. Haritha of Mysore University, Shri R. Vasudevan of University of Agricultural Sciences, and Shri Selwyn Sundaram of Indian Institute of Sciences, Bangalore.

- 14. Shri S.P. Bhargava, Chairman, Industrial Disputes Tribunal Indore, delivered the valedictory address on 14th Feburay, 1975. The prizes were distributed at the hands of Dr. Shivmangal Singb Suman, Vice-Chancellor, Vikram University. Shri V.K. Balakrishnan, Additional Member-Secretary, Committee for Cooperative Training, thanked the guests and participants. The text of the speech of Shri Bhargava is given at Annexure III.
- 15. The following were some of the other salient features of the National Debate:—
 - (i) The participants represented all corners of the country i.e. Kashmir University in the North to Madurai University in the South; Bombay University in the West to Bidhanchandra Agricultural University, Kalyani in the East. These included, 8 Agricultural Universities and the Indian Institute of Science, Bangalore.
 - (ii) Amongst the participants, 66 were boys and 8 girls. Forty-nine of the participants spoke in English and the remaining 25 in Hindi. Five Universities had sent composite teams of English-cum-Hindi speakers.
 - (iii) The participants represented different branches of study. The maximum of 14 participants were drawn from the Commerce faculty and 13 were from Agriculture. Other participants included, 9 from science group, two each from verterinary sciences and medicines and one from agricultural engineering. Forty of the participants were postgraduate students, 33 under-graduate students and one studying in an intermediate class.
 - (iv) The first prize was won by a student of Botany, second by a student of History, while third prize was shared by the students of law and a labour Insitute. Amongst the other prize winners, two were from science group, two from political science, one each from medicine, agriculture, sociology, law and journalism.
 - (v) The panel of judges comprised of Shri N.B. Lohani, Registrar, Cooperative Societies, Shri R.L. Gargava, Deputy Secretary (Admn.), M.P. Government, and Dr. A.U. Shaikh, Director, Vaikunth Mehta National Institute of Cooperative Management, Poona. Dr. Giri Raj Prasad Gupta, Head of the Commerce Department, Madhav College, Ujjain presided over the Debate.

- (vi) A Symposium was organised on the subject of 'REMOVAL OF REGIONAL DISPARITIES THROUGH COOPERATIVE SECTOR' for the benefit of participants. This was presided over by Shri S.S. Puri, I.A.S., Member-Secretary, Committee for Cooperative Training.
- (vii) M.P. State Cooperative Union, in collaboration with Vikram University, organised an exhibition on the progress of Cooperative movement in Madhya Pradesh. The I.C.A./NCUI project at Indore and branch office of IFFCO also displayed their exhibits. The Union also brought-out a special number of its journal, 'Sahkari Madhya Pradesh' on Youth and Cooperation to mark the event.
- (viii) The Regional office of the I.C.A., as usual, donated books for the first three speakers; the Ujjain District Cooperative Bank, the Ujjain District Cooperative Union, the Ujjain District Land Development Bank and Ujjain District Cooperative Wholesale Stores also instituted two special prizes of Rs. 75/- each. M.P. State Cooperative Marketing Federation instituted a consolation prize of Rs. 75/- and the M.P. State Cooperative Union three consolation prizes Rs. 50/- each.
 - (ix) The cooperative institutions in M.P. also spontaneously came forward to take care of local hospitalities of the participants and the guests. The Ujjain District Cooperative Union arranged an excursion trip for the participants to the historic places of ancient city of Ujjain.
 - (x) The Participants in the National Debate were given a set of free literature on Cooperation. The literature, apart from the publications of Committee for Cooperative Training, also included publications supplied by the Government of India, I.C.A. NCDC, NAFED, IFFCO and the M.P. State Cooperative Union. The list of books distributed is given at Annexure VII.
 - (xi) A cultural programme was organised on the evening of 14th February, 1975, in which students from participating Universities also took-part. The programme provided glimpse of culture in Madhya Pradesh and Rajasthan. The detailed programme of the Debate and Symposium is given at Annexure VIII.

(xii) The Symposium and Valedictory function were given coverege by the All India Radio, Indore.

INTER-COLLEGATE DEBATES

- 16. The Inter-Collegiate Debates on Cooperation, during the year, are reported to have been conducted by as many as 50 Universities. Of these, reports were, however available from 39 Universities indicating participation by 692 students. With reports still awaited from 11 more Universities, the participation, as compared to 42 Universities and 717 students, as in the previous year, both in the number of Universities involved and number of students participated is expected to show an improvement. The details of these competitions, indicating the names of Universities which conducted this debate, subject, participation and prizes awarded are given at Annexure IX.
- 17. The University at Madras kept the lead, with 51 students participating from 27 Colleges. The participation at the University of Nagpur was 44 students from 4 teaching departments and 18 Colleges. Except the central zone where only two Universities organised the Inter Collegiate Debates, the involvement in other zones was more or less the same. The participation of students was, however, higher in southern zone with 219 students, followed by western zone (178), eastern zone (144), eastern zone (123) and central zone (28).
- 18. In all 220 colleges, 56 teaching departments and 27 faculties had taken part in these competition. Of the 18 Agricultural Universities in the country, however, only 9 Universities, as against 7 in the previous year, conducted the debates during the current academic year.
- 19. The analysis shows that the competition continues to draw participants from different disciplines of study in the Universities. While the maximum of 255 students had been drawn from the Arts faculties, 156 from Commerce faculties, the Science faculties, with 147 students participating, have also shown keen interest in these competitions. There were also 78 students from Agricultural faculties, 22 students from Engineering, 17 from Law, 12 from Medicine, 3 pursuing studies in M.B.A. and 2 from Journalism. Amongst the participants, 584 were boys and 108 girls.
- 20. A total number of 111 prizes were awarded in these competitions. Most of these prizes i.e. 68 were secured by Arts and

Commerce students, while 19 Science students, 6 Medical, 14 Agricultural and 4 Law students have also figured amongst the prize winners.

21. The Committee for Cooperative Training awards University scroll to the best team in the Inter-Collegiate Debate, while a maximum of three prize amounting to Rs. 75/- Rs. 50/- and Rs. 30/- are also awarded for individual merit. As a part of the prize money, some books on Cooperation are also supplied to the winning students. The Committee issues merit/participation certificates to the winners/participants in these competitions. The detailed scheme is given at Annexure XI.

ESSAY COMPETITION

- 22. The reports of Essay Competitions on Cooperation have been received from 15 of the 25 Universities which had earlier agreed to conduct these competitions. This indicates the participation by 218 students. The position last year was that 15 Universities held the Essay Competitions in which 403 students had participated. The reports were, however, still coming in and as such the exact participation during 1974—75 was not yet available. The statements at Annexure X will show the names of the Universities, together with subject and participation in the Essay Competitions on Cooperation, held during the year 1974-75.
- 23. The Madras University continued to record higher participation of 58 students, which included 35 girls. The participation of girl students in the Essay Competition, as compared to Inter Collegiate Debates, also continued to be higher. The competition conducted by Udaipur University was execlusively participated by the girl students. A total number of 46 colleges, 13 teaching departments and three teaching faculties took part in this competition.
- 24. Eighteen prizes were awarded in the Essay competitions, of which 25 were secured by the boys and three by the girls. Undergraduates (10), however, out-numbered the post-graduate students (8) in bagging these prizes.
- 25. The scheme provides award of three prizes in the competition based on number of entries i.e. for 25 and more entories 1st, 2nd and 3rd prizes; 15 or more entries but not exceeding 24, 2 prizes of the value of 2nd and 3rd prizes and for 10 and more entries but not exceeding 14, one prize of the value of 3rd prize only. In special cases, where number of entries are below 10 but not below 5, a

consolation prize of Rs. 30 is also awarded. The detailed rules of the competition are given in the Annexure XII.

SYMPOSIUM

26. The symposium on the subject "REMOVAL OF REGI-ONAL DISPARITIES THROUGH COOPERATIVE SECTOR was organised for the benefit of the participants in the National Debate on 142.75. Shri S.S. Puri, Chief Executive, NCUI, and Member-Secretary, CCT presided over the symposium. The main speakers at the symposium were Shri Tara Chand Agarwal, Chairman, Madhya Pradesh State Land Development Bank; Shri P.R. Dubashi, Divisional Commissioner, Belgaum, Karnrtaka; Dr. K.C. Bhandari, Dean, Department of Commerce, Vikram University; Dr. G.P. Gupta, Head of Commerce Department, Madhav College, Ujjain; Shri R.P. Satpute, Managing Director, M.P. State Cooperative Bank; and Shri M.M. Batra, Managing Director, Madhya Pradesh State Land Development Bank. Some of the student participants also joined in the discussions.

There is, therefore, no ground for comparison between Cooperation and the other two systems. However, assuming that comparison is possible, it can be said that Cooperation commits itself to the same drawbacks as socialism and capitalism as for example economic wastage, inefficient allocation of resources; politicalisation etc. Cooperation can succeed only when there is cultural homogenity and absence of hierchy.

Principles of Cooperation may have to some extent synthesised the best in capitalism and socialism, but when we investgate its practical implications we find that the Cooperation has not been able to do away with the short comings found in capitalism and socialism.

The history of man-kind proves that both socialism and capitalism are ways of life that were adopted by Man long before, these concepts were actually defined. The salient features of these two systems have nothing to do with the basic principles of Cooperation, which is essentially an independent system.

SYMPOSIUM: Removal of Regional Disparities through Cooperative Sector.

Shri P.R.Dubbashi, Divisional Commissioner, Belgaum, Karnataka

It is not surprising to have regional dispartities in a large country, like India, in the process of development. These disparities are not only inter-state but also intra-state depending on several factors such as paucity of natural resources. Even though there may be adequate resources, the per capita availability may be extremely limited due to pressure of population. There are certain areas that are drought prone and where there is predominance of small and marginal farmers.

Such dispartities are also bound to exist, corresponding with the general economic disparities, in the Cooperative sector as well. Even within the States we find that Cooperatives are better developed in more prosperous districts, with better infra-structure, better facilities and leadership then in somewhat backward districts.

An attempt has been made to remove these disparities through planned economic development. For instance, in the rain shadow areas and drought prone areas, very recently programmes have been initiated, with the assistance of the World Bank, to make these areas less drought prone. Also where there is predominance of small and marginal farmers and agricultural labourers, SFDA and MFAL agencies have been set-up to help them.

Looking to the disparities also existing in the Cooperative sector, one has to conclude that as it has happened so far the Cooperative Development far from correcting these disparities have perhaps exceeded it However, Cooperative are accorded a very significant place in the agencies such as SFDA/MFAL. Special assistance is provided to the small farmers, the marginal farmers and the Agricultural labourers for setting up what is called functional cooperatives in the field of milk business, Sheep business etc. In drought prone areas there is an attempt to have afforestation water shed, community irrigation wells, lift irrigation to mobilise ground water resources and in this there is a significant role given to the Cooperatives,

whether they are Land Development Banks or any other type of Credit Cooperatives.

There are indeed shining examples of the tremendous contributions made by the Cooperatives, in the Green Revolution in Punjab, White Revolution in Guiarat and Sugar Revolution in Maharashtra. These can be reflected in other parts of the country as well. Supreme efforts, needs to be made by Cooperative Leadership at the highest ievel to transplant Cooperative achievement from some of the successful States to others and this has to be done through a deliberate process. Cooperative strategy of reducing disparities would be to work out blue prints of developments, no doubt adopted and adjusted, in an appropriate way to the comparatively backward States, deriving lessons from experience of the successful States. The National Cooperative Union, and other National level Cooperative Institutions, in various fields could play a crucial role in this. The Cooperative leaders from the under develop states could also be taken on study tours to cooperatively advanced areas to see and believe the magnificient achievement made in the Cooperative sector.

Dr. K.C. Bhandari Dean, Faculty of Commerce, Vikram University-Ujjain.

Cooperatives in the field of agricultural credit in Germany and Japan, Consumer activity in England, Sweden and USSR and farming in Isreal have contributed a great deal to the economic development of these countries. But in India, the movement is inhibited by official-dom and vested interests, which have brought bad name to the movement. If we have to correct the regional imbalance through Cooperative sector, we may first have to correct the movement iself.

Unemployment is our biggest malady today. Cooperation can play an important role in tackling the problem of unemployment. We can make use of the services of the unemployed educated people, engineers, technicians, doctors etc. in developing the weaker regions of the country. The Cooperative institutions could come out liberally with loans, with lower rate of interest, the state could provide facilities and equipment at subsidized rates. Thus, in this way we not only solve the problem of unemployment but also regional disparities.

Shri R.P. Satpute, Managing Director M.P. State Coop. Bank.

The Cooperative Sector, as the Principles enunciate has a limited purpose, where people with common purpose come together. The project like Amul or bigger projects through Cooperative Sector can not be copied every where. The Cooperative Sugar Factories in Maharashtra have created a class which in known as 'Kulaks' which certainly has not bridged the disparities.

There is also a wrong notion about the role of Cooperative The Cooperative Banks are Banks and not charitable institution, which can afford to dole out funds for merely meeting the requirements, may be of the small farmers. It has to ensure the repaying capcity and that the repaying capacity is generated. In the present context, Coperative Banks have been particularly striving to go to the people who are quite small. The Reserve Bank has put the condition for the Banks to finance the small people to the extent of 20% of the borrowings from higher institutions. Though no tall claim may be made in this behalf yet it can be said that to some extent the Cooperative Credit structure has been trying to bridge the gulf between the smaller people and bigger people and to that extent to cover up the areas where small people are more. Cooperatives have their limitations and even in other sectors like Cooperative processing and Industry it will be futitle to expect that Cooperatives will be able to do a very big job.

Cooperatives are democratic organisations, where all of us have got to be leaders and all of us have got to be participant. Therefore, merely producing a leadership—a leadership of high level is not—going to bridge the gap.

धाज के आयोजित परिसंवाद में चर्चा का विषय पूंजीवाद, सहकारिता तथा समाजवाद है, इन तीनों विषयों का भागस में कितना परस्पर सम्बन्ध है या इनमें क्या-क्या गुण श्रथवा दोष हैं। मैं इस चर्चा में न पड़कर कैवल सहकारिता के सम्बन्ध में कुछ कहूँगा। सहकारिता इस देश में स्वतन्त्र रूप से ही एक जानी मानी प्रणाली है। इसके परिणाम तथा प्रमाव सभी जानते हैं। हमारे देश की ग्रायिक स्थिति में बड़ी-बड़ी विषमतायें एवं ग्रसमानतायें हैं। जहाँ तक ग्रसमानतायों का प्रक्त है एक प्रान्त से दूसरे प्रान्त में तथा एक प्रदेश से दूसरे प्रदेश में कहीं कम है कहीं भिष्क परन्तु सहकारी क्षेत्र में कई ग्रसमानतायें होते हुये भी एक जटिल सा प्रक्त उत्पन्त होता है कि क्या जादू के चिराग द्वारा इस क्षेत्र से ग्रसमानता दूर की जा सकती है। लामकारी सहकारी संस्थाभों द्वारा क्षेत्रीय ग्रयवा प्रान्तीय ग्रसमानता शों को सफलतापूर्वक दूर किया जा सकता है। उदाहरण के लिये लघु किसान विकास संस्था तथा प्रान्तीय किसान भीर कृषि मजदूर संस्था जैसी स्कीमों को ग्रपनाकर जिनमें से छोटे किसानों को, दस्तकारों को सहायता मिलती है। ऐसी ही बड़ी-बड़ी विशेष प्रकार की संस्थाभों द्वारा सहकारी संस्थाभों को माध्यम बनाकर इन विषमताभों को दूर किया जा सकता है।

देश की विषमतामों का एक प्रमुख कारण होता है सत्ता भीर साधनों का एकीकरण। साधन भीर सत्ता का जहाँ केन्द्रीयकरण हो जाता है वहाँ विषमता बढ़ती है। पूंजीवाद विकेन्द्रित न होकर केन्द्रित करता है। समाजवाद भी सत्ता तथा साधनों का केन्द्रीयकरण करता है। सहकारिता में यह नहीं है। इसमें मानव व भौतिक साधनों का केन्द्रीयकरण है लेकिन शोषण नहीं है तथा सहकारिता हो एक उचित संस्था है जिससे प्रादेशिक विषमतायें दूर हो सकती हैं।

सहकारिता का पुन्नरोपन हम एक राज्य से दूसरे राज्य में नहीं कर सकते। महाराष्ट्र के सहकारी पौधे को हम मध्य प्रदेश में लगाना चाहते हैं तो शायद यह काम नहीं करेगा। मध्य प्रदेश के लोगों को भगर दिखाया जाये कि महाराष्ट्र में क्या हो रहा है तो वह जो सही समसे वही भपनायें।

INAUGURAL ADDRESS OF DR. SHIVMANGAL SINGH 'SUMAN', VICE-CHANCELLOR, VIKRAM UNIVERSITY

Hon. Minister for Co-operation, Shri Kishorilal Shukla, President of the Madhya Pradesh Rajya Sahakari Sangh, Shri Sawaisingh Sisodia, the devoted and zealous protagonists of Co-operative movement, the exuberant young participants, Ladies and Gentlemen:—

I deeply appreciate the honour that the National Co-operative Union has done to me by asking me to inaugurate the XV-Inter-University National Debate and the symposium on Co-operation. As you all know, this National Debate is being held under the joint and Co-operative auspices of Co-operative Training Committee of the National Co-operative Union, Madhya Pradesh State Co-operative Union and the Vikram University which has had the privilege and honour of hosting this National event. I, therefore, deem it my foremost duty to welcome you in this ancient-most city of learning and culture, where the great preceptor of Gita had his first lessons, I think it would not be out of place to mention that our great Vadic Rishis and Sages like Sandipini had forestalled the basic concepts of Co-operation from the very dawn of Civilization, as the panacea for the physical and spiritual ailments of the Society when they proclaimed:—

संगळ्ळ संवद्घ्वं संवो मनांसि जानताम्।

"Let us walk alike, talk and let our minds comprehend alike." Moreover we have been humble participants in this transcendental venture from the very outset and have been winners of the prizes in 1965-66, 1971-72 and 1972-73. We were awarded Runners Cup in 1971-72. Thus, you will bear with me that we have earned the right to host this Debate as dutiful cooperators. As one of the winner we had extended the invitation and I feel greatful as the same has been accepted.

At the time when the world is apparently drawn into the current of the twin politico-economic idealogies of Capitalism and Socialism, it is in the fitness of things that we pause for a moment to discover by open debate whether Co-operation, as such can serve as an effective and fruitful apparatus to ameliorate the living conditions of the weaker limbs of Society, who seemingly have lost the best of both the worlds. Objectives impossible of attainment by isolated individuals are sught to be achieved through the medium of Co-

operative effort. Institutions thus set up for self help through mutual help are the Co-operatives, practising the principle of 'All for one and one for all'. Co-operation is thus a voluntary effort by a group of persons having common interests and joint efforts towards improvement of their common lot-

In the Scandinavian countries especially, the Co-operative sector occupies a significant place in the national economy. 'Luzzaties' in Italy, producer's Co-operatives in France, multinurpose credit societies in Germany, Dairies in Denmark, Netherland and Ireland, Rochdale Pioneers of Britain, Industrial Co-operatives in Japan the Induses movement in China, the collective farming known as Kolkhoj's in U.S.S.R. to quote only a few, are not only beacons lighting up the path of Co-operative efforts but are a testimony of the spirit of man striving to overcome obstacles to his progress. Committed as we are to the philosophy and creed of democratic Socialism, Co-operation provides for a healthy ground to acheive that goal. Co-operation—one of the economic-miracles of the 19th Century is a synonym for and a nucleus to Democracy, Cooperation is the hope of the weak and the resourceless, downtrodden and the neglected. It makes the movement of the people. To quote Jacob Oake-

"Co-operation touches no man's fortune, seeks no plunder, causes no disturbance in Society, gives no trouble to statesman, it enters into no secret association, it needs no trade unions to protect its interests, it contemplates no violence and it subverts no order; it envies no dignity it accepts no gifts; nor asks any favour; it keeps no terms with the idle and it will break no faith with the industrious. It means self-help, self-dependence and such share of competance as labour shall earn or thoughts can win."

As things are, India is caught in the currents of economic malaise. Inflation is behaving like a drug which takes more and more doses to get the same kick. As articles of necessity grow dearer and scarcer (assisted by black-marketeers, hoarders and profiteers), there is demand for more emoluments from wage earners and other sections of the community, which in turn further boosts up the prices. Thus, we are drawn in a vicious circle of the worst order. Co-operatives can break this vicious circle, I am confident. The best agency to break this vicious circle are the youth of the country, because the bubbling energy of the youth cannot remain in vaccum. Either it can be channelised for constructive work or it is bound to

fritter away in distructive manouvers. In British days the youth had a challenge against imperialist domination and slavery. Their aspirations were symbolized in the form of Bhagat Singh & Chandra Shekhar Azad. Free India has however failed to fulfill their hopes and aspirations which has led to worst kind of frustration and chaos. The challenge of Co-operation can provide a positive and concrete ideal to fight for or else the country is bound to dismantle the present frame work and mould some new form nearer to its heart's desire. If the younger generation coming out of the portals of the Universities and colleges takes up the cause of Co operation and propogate its message, I have no doubt that a new dimension will be added to the movement. A great sociologist once observed 'Give me youth and I can make a new heaven and new earth'. Youth is a very wide term divided into different categories i.e. urban and rural, educated and uneducated, employed and unemployed, self-employed and inservice youth, farm and industrial youth, so on and so forth. But all the same youth in general is idealistic, sincere, sensitive, bold. emotional, compassionate, cosmopolitan, and susceptible to ideas, situations and environments with sense of comradeship, community life, mutual confidence, faith and understanding, and if inspired by idealism will work hard and think positively. There is other side of the picture too which needs to be examined with care and caution. The youth of to day are the leaders of to-morrow, as such it is essential that they should be taken into confidence and given opportunities to get themselves involved in various schemes of Co-operative movements.

To equip our youth with the basic tenets of co-operation, the teaching of Co-operation as an independent discipline in our Universities cannot be overemphasised. It is gratifying to note that over 50 Universities in the country provide for regular instructions in Co-operation at degree and post-graduate levels. And I feel proud to inform that at the Vikram University Co-operative principles at Home and Abroad are taught in the faculties of Commerce and Social Sciences, both at the degree and Post-Graduate levels. Besides this, we have also provided for a post-graduate Diploma in Co-operation in the Department of Applied Economics and Business Administration under the faculty of Commerce. I feel that National Co-operative Union should collaborate at the various levels in the plans and policies of Co-operative instructions in Indian Universities.

Coincidentally almost on the eve of this Debate, some of our students have started a Canteen on the basis of Co-operation,

without any help from the University or any Government agency. This is a pure voluntary adventure. During this short period they have catered successfully to the Inter-University Mahila Khokho Sports meet, M.P.: University Youth Festival and now have the privilege to serve the participants of the 15th Inter-University National Debate. Thus the augury of the Debate have proved to be a good man to my University. This Debate has given a new vision to me. Apart from its importance in agricultural or industrial sectors, I do realise that the movement of Co-operation can be taken up at every step, in all walks of life. As they say that charity begins at home, I do realise for the first time that there is ample scope for cooperatives in the Universities. We can have our own Dairy farms, Cooperative messes in the hostels, Cooperative stores for meeting daily needs, books, stationery, Clothes, ration and even a Chemists' shop. This can provide poor students with employment opportunities and open new vistas to earn and learn. Our University employment beareau can be more effective and worthwhile with the synergy through Cooperation. It has been rightly said the Cooperation is the real instrument to struggle against the exploitation.

Ladies and Gentlemen, with these words I inaugurate the National Debate and the Symposium and my hope is that the Universities assembled here and other intellectuals and Co-operators will play a catalytic role and make the most significant contribution towards growth and development of Co-operative movement in the Country. May you be blessed by the Deity of eternal time, Lord Mahakal, and may your fruitful deliberations surcharge us with new hope and action to enable us to deliver goods out of the present economic crises and chaos.

ज्यादातर यह झान्दोलन मिडिल क्लास व बड़े क्लास के किसानों को या दूसरे क्षेत्र में उनको ज्यादा लाभ पहुंचा रहा है और गरीबों के लिये ज्यादा सहका-रिता विभाग को ज्यादा कार्य करना है। दिक्कतें उसकी शायद होंगी वह ऋडिटवर्सी महीं है उनको उधार कैसे दिया जाये। ये दिक्कतें झापको हल करना चाहिये, थोड़ा खतरा उठाना चाहिये। सहकारिता विभाग को भी खतरा उठाना चाहिये और यही झाप सोग सब मिलकर के सचमुच सहकारिता विभाग को अच्छे दूढ़ नीव पर रखकर के काम करेंगे तो इसमें कोई शंका नहीं कि मारत के समाज का उत्थान इसमें होगा। नवयुवकगण सहकारिता में दिलचस्पी ले रहे हैं, कार्य कर रहे हैं, ऐसा न हो कि पुराने बुजुर्ग उनको घुसने न दें। वो जब आवें अडचनें पैदा करें। यह अक्सर होता है, चाहे वह सहकारिता का क्षेत्र हो चाहे राजनीति का क्षेत्र हो बुजुर्ग लोग नाम को तो कहते हैं कि हम लड़कों को कहते हैं कि झावें और काम करें लेकिन नवयुवक जब घुसने की

कोशिश करते हैं तो उनमें बाधायें डाली जाती हैं। धगर हम उनका सहयोग नेकर के उनको साथ लेकर के उनके जिये काम करना चाहते हैं तो जरा ध्यापक दृष्टि-कोण रखकर के धगर हम काम करेंगे, सहकारिता के मूल सिद्धान्तों को सामने रखकर के यदि जनता की सेवा करना चाहते हैं तो धवश्य कर सकते हैं।

VALEDICTORY ADDRESS OF SHRI S.P. BHARGAVA, Chairman, Industrial Disputes Tribunal, Indore.

The Chief Executive, NCUI, my esteemed friend Dr. Suman, friends and ladies.

I am thankful to you in no small measure for having given me this opportunity to express my mind to you on a subject of which I was least prepared. The notice, though short, I have already accepted and, therefore, I am advancing plea to excuse my short-comings which are bound to be many when I have not been able even to arrange my thoughts in the order in which I would like to put them to you. This is a subject on which I do expect and realise that I am possibly the only person here, who is least conversant with its merits and demerits but in other, but dignified language it may be said that I might be the most independent who can talk on the subject with a free mind without any bias this side or that side. Anyway utilising the opportunity, in whatever manner it is given to me, I would like to express my thoughts in a few words.

So far as the function is arranged in University, I would rather like first to say about what the University can do to achieve our national objective, to the onward march of this movement. I know that about five Universities in India have already started advance courses in the subject of Cooperation. I was happy to know that Vikram university has also prepared a syllabus for this advance subject. I would request my esteemed friend Dr. Suman to exert his wholesome influence on this so that from next year the boys and girls of M.P. desirous of acquiring knowledge in the branch, get all the facilities.

There can be multiple ways of helping the movement. The most advance will be to encourage the discussion of the subject even for the sake of discussion. On certain topics research could also be under-taken.

I would not like to grudge upon the topic which has been contested in the Debate and on which, as I am already told that, the Debate has indeed been of a very very high order. When the students

have prepared the subject carefully, I presume that most of the pros and cons of the subject have been covered and fully discussed.

Cooperation is not an idea which requires to be mooted for the first time in our discussion. It is an established fact that in so many states, so many institutions taking advantage of it, are trying to run it and are trying to become successful. Our duty, as patriots, citizens of the country would be to see that when there is a measure which can be of vast potentiality which may be of a eminent reform, it is a pleasure in which we have to take whole-some interest to make it a success.

From that spirit, let us understand our general position. In India, we feel, that atleast 30 to 35% of the population is under-fed. It is no exaggeration to say that the next higher slab is slightly better but still not, as can be looked upon with great pleasure or satisfaction. In the circumstances, the position we analyse is that ours is a country of vast population but with limited resources. The tendency of modern technology, wherever it is to substitute labour by capital, that is a course which obviously can not be adopted in a country of such a vast type as we are. In this situation we have to see that the factors which count for the productivity and lead ultimately to the standards of living of the population should be managed in such a manner that ultimately result is not satisfactory to one group but satisfactory to all. We have to see that our limited capital is utilised through the best way.

The second thing which we have to bear in mind is that many of our agricultural holdings are uneconomic and, therefore, hardly enough to sustain itself. In a situation like this, the only way on which we can depend is to strike the balance between the baring necessity, the limited capital and organisation of labour, arranged by these trained persons who can utilise these individual holdings. Let there be a strong group by means of Cooperation and by any other means.

Though to some extent, I have indicated myself to be in favour of the Cooperative movement, I want to emphasise that certain preconditions have also to be considered first, The pre-condition of which I am talking is that whatever we think of an institution, in terms of its being good or bad, the pre-conditions is that there must be character, there must be good management and there must be sincere workers. If these essentials are not met ultimately we can not hope to get good results. It is a very unfortunate part that

though we complain of scarcity in so many things, it is really a scarcity of character which should bother us.

To my student friends, I have only to say two things. They have been given credit for very fine speeches, for very fine preparation and very nice words. I will not be surprised, if amongst them we find some of the people, whom the future life of the nation may prove to be equals to Jawaharlai Nehru, Sardar Patel, Mahatama Gandhi.

If that is the position, then I would only say that persuade yourself to progress in life in an honest manner. Do not try to live with irrespective ways. Try to live as every single item of property that country possess today is an item of trust and must be cared for as if your sacred property.

Now with these words, I pray to almighty to assure you many years of life and I would leave it to you to act in spirit.

RULES GOVERNING DEBATING COMPETITIONS

1. **DEFINITION**:

- 1.1 For the purpose of these rules, "University" shall include the recognised Universities in India, institution having the status of a University and the National Council of Rural Higher Education.
- 1.2 "College" shall include educational institution running degree courses affiliated to the Universities and teaching departments of the Universities.
- 1.3 "Committee" means the Committee for Cooperative Training of the National Cooperative Union of India, New Delhi.

2. INTER-COLLEGIATE COMPETITION

Date & Participation:

- 2.1 Each University may organise an Inter-College Competition on a subject relating to Cooperation. The Competition may be held latest by the 15th December, 1974, unless otherwise permitted by this Committee. The date on which competition will be held will be notified by the University well in advance, under intimation to this Committee.
- 2.2 Every affiliated, constituent College, faculty of the University will be entitled to send only one team of 2 debators to this competition, one of them speaking for and other speaking against the proposition.
- 2.3 In order to qualify for the prizes under the Scheme, the minimum number of participating teams to the competition shall be ten.

Subject:

2.4 The subject for the debate, a topic relating to cooperation, will be prescribed by the University, who may also suggest suitable reference material on the subject for the benefit of the participants. The Committee shall be glad to render any advice required in this behalf if called upon to do so.

Panel of Judges:

- 2.5 A panel of three judges shall be consitituted by the University for evaluating the performance of the competitors. The panel may preferably include:—
 - (i) Head of the Faculty of Commerce/Economics/Cooperation,
 - (ii) A prominent non-official cooperator, and
 - (iii) A senior Cooperative Officer.

Prizes:

- 2.6 The scroll awarded by the Committee for Cooperative Training shall be presented by the University to the College/Department of the University, whose team is declared the best.
- 2.7 First, Second and Third Prizes of the value of Rs. 75/-, Rs. 50/- and Rs. 30/- respectively may also be awarded, in order of merit, on the recommendation of the panel of judges.

Provided that in case the panel of judges do not consider any participant suitable for the first prize, only second and or third prize may be awarded.

2.8 part of the prize shall be paid in cash and balance in shape of books on Cooperation to be supplied by the Committee.

Travelling Allowance:

2.9 The competititors in the case of non-residential University coming from the Colleges outside the University Head-quarters may be paid to and fro second class railway fare/ordinary bus fare. No other allowance, i.e. incidentals or daily allowance or clocal bus charges shall, however, be admissible.

Reports and Claims:

2.10 Expenditure incurred on prizes and travel cost, as admissble under the scheme, shall be reimbursed by the Committee on presentation of the report and claims in this behalf (Annexure-III). University shall present the report/claim of the competition in form D (1), in duplicate, to the Committee. The claim should be pre-receipted on a revenue stamp for the full amount of prize including cost of books to be supplied by the CCT and T.A. The details of T.A. claims of the participants may be furnished in form D (2.)

Certificates:

2.11 The winners in the Inter-Collegiate Debate shall be awarded certificates of merit by the Committee. The other participants in the debate may also be given participation Certificates.

3. NATIONAL COMPETITION:

Date, Venue & Subject:

3.1 The Committee may organise (sometimes in January) February, 1975) an Inter-University National Debating Competition on Cooperation in collaboration with the University and/or cooperative institution. The date venue of the competition and the subject for the debate will be notified later (sometimes in December, 1974).

Eligibility:

- 3.2 The University holding Inter-Collegiate Debating competition shall be eligible to participate in the National Debate through a team of two debators-one to speak for and the other against the proposition, to be indicated by the Committee. The participating debators shall bring with them letters of introduction from their respective Universities.
- 33 The team chosen for the national debate shall preferably include the winners in the competition held at the University level.

Panel of Judges:

3.4 A panel of judges for assessing the preformance of the

Debators may be constituted by the Committee in consultation with the University, where the National Debating Competition will be held.

Prizes:

- 3.5 The Committee shall award a National Scroll and a Running Shield to the University, whose team is adjudged the best. The Runners-up will get the Runner's cup.
- 3.9 First, Second and Third prizes of the value of Rs. 250/-, Rs. 200/- and Rs. 150/- respectively will be awarded for individual merit. Consolation prizes upto three of the value of Rs. 50/- each may also be awarded in the competition on the recommendation of the Panel of Judges. If the Cooperative institutions, in the State in which the National Debate is held, come forward with more prizes as was done in Madras in 1973-74, more prizes such as cups etc. could also be provided to the selected best debators.
- 3.7 Since the debates are held in English and Hindi, the prizes are to be awarded on the basis of best performance in both the languages put together. In case, however, the best three participants are not from both the languages, additional consolation prizes may be awarded to the best participants in the language which does not figure among the best three prize winners.
- 3.8 Part of the prize money shall be given in cash and the balance in the shape of books by the Committee.

T.A. etc.

3.9 The participants may be allowed second class railway fare from their respective University headquaters/home station to the place of the competition and back. In case of the places not connected by rail, ordinary bus fare may be granted. A daily allowance @ Rs. 6/- per day per head for the days spent in journey and on halt at the place of competition shall be admissible. This rate may be increased to Rs. 10/- in respect of the halts at the venue of competition if it is located at 'A' Class city.

Certificate:

3.10 While the winners shall be awarded the certificates of

merit, certificates of participation shall be issued to other participants.

4. RELAXATION AND INTERPRETATION:

- 4.1 Any relaxation in these rules can be introduced only with the prior approval of the Member-Secretary of the Committee.
- 4.2 In the event of any controversy arising out of the interpretation of the rules or any clarification needed in the absence of any specific provision to that effect, the interpretation given by the Member-Secretary of the Committee shall be final and binding on all concerned.

RULES GOVERNING ESSAY COMPOTITIONS

1. DEFINITION:

- 1.1 For the purpose of these rules, "University" shall include the recognised Universities in India, institutions having the status of a University and the National Council of Rural Higher Education.
- 1.2 "College" shall include educational intitutions running degree courses affiliated to the Universities and teaching departments of the Universities.
- 1.3 "Committee" means the Committee for Cooperative Traning of the National Cooperative Union of India, New Delhi.

2. ESSAY COMPETITION:

- 2 1 Every University may organise an Essay Competition on a subject relating to Cooperation, latest by the end of February 1975.
- 2.2 The University holding the competition shall prescribe some suitable topic on Cooperation for the contest. It may also suggest suitable reference material for the benefit of the participants. The Committee shall be glad to render any advice in this behalf, if called upon to do so.
- 2.3 The University shall notify the date for receipt of entries as also the subject of the contest, well in advance, under intimation to this Committee.

Eligibility:

2.4 Every student studying in a College/University, teaching departments shall be eligible to participate in the competition. The participant shall write an essay of about 3,000 words on the topic prescribed by the University.

2.5 The participant shall submit his/her essay to the University authorities by the specified date alongwith a certificate from the Principal/Professor/Head of the Department, as may be required by the University authorities to the effect that the essay has been written by the candidate himself/herself.

Evaluation:

2.6 Essays received for the competition shall be evaluated by a panel of three judges to be nominated by the University authorities. Professors teaching economics/commerce/cooperation may preferably be included in the panel of judges.

Prizes:

- 2.7 The Committee may award three prizes each of Rs. 100/-, Rs. 75/-, Rs. 50/- respectively to the participants categorised as first, second and third on the recommendations of the Judges. Out of the prize money, the Committee may supply some books on Cooperation.
- 2.8 The prizes shall be awarded on the basis of entries for the competition in the following manner:—

	No. of entries.	No. of Prizes
a)	25 or more entries.	First, Second & Third Prizes.
b	15 or more entries but not exceeding 24.	Two prizes of the value of Second & Third Prize only.
c)	10 or more entries but not exceeding 14.	One prize of the value of the Third prize only.

- 2.9 No competition will ordinarily be treated as valid unless the number of entries are 10. In exceptional cases, where the number of entries fall below 10 but not below 5, one consolation prize of Rs. 30/- may be awarded.
- 2.10 The decision of the panel of judges shall be final. A copy each of the winning essay shall be made available together with the docket sheet indicating the name of the participant, sex, class, years of study, name of the department/college, title of the essay etc., to the Committee

Reports/Claims:

2.11 The report and the claim of the Essay competition shall be sent to the Committee in proforma at Annexure-III, in duplicate, duly pre-receipted with a revenue stamp affixed for the full amount of prizes, including the cost of books to be supplied by the Committee.

3. RELAXATION AND INTERPRETATION:

- 3.1 Any relaxation in the terms and conditions of the competition shall be introduced only with the prior approval of the Member-Secretary of the Committee.
- 3.2 In the event of any controversy arising out of the interpretation of the rules, the decision of the Members-Secretary shall be final and binding on all concerned.
