CHAPTER I

APPOINTMENT OF THE COMMITTEE

1.1. The Government of Maharashtra, by Resolution, Industries and Labour Department, No. MWA. 2674/100982/Lab-III-A, dated the 3rd February 1975 (Annexure I) appointed under section 5(1)(a) of the Minimum Wages Act, 1948, a Committee to hold enquiries into the conditions prevailing in the employment in any industry in which any process of printing by letterpress, lithography, photogravure or other similar work or work incidental to such process of book-binding is carried on, and to advise Government in the matter of revision of minimum rates of wages in the said employment fixed under Government Notifications, Industries and Labour Department, Nos. (1) MWA. 2662/Lab-III, dated 31st December 1964; (2) MWA. 2662-(i)/Lab-III, dated 31st December 1964; (3) MWA. 2662-(ii)/Lab-III, dated 21st April 1965 and (5) MWA. 2662-Lab-III, dated 29th March 1966. By subsequent Government Resolution, Industries, Energy and Labour Department, No. MWA. 2674/535-Lab-7, dated 6th September 1975, Shri K. N. Pathare, Assistant Commissioner of Labour, Bombay, was appointed as Member-Secretary of the Committee in place of Shri M. V. Nikumbh, Assistant Commissioner of Labour, Bombay (Annexure II).

By Government Resolution, Industries and Labour Department, No. MWA. 2674/108501-Lab-III-A, dated the 9th April 1975, Shri M. N. By Government Resolution, Industries, Energy and Labour Department, No. MWA. 2675/298/Lab-5, dated 13th August 1975, Shri V. V. Patwardhan, President, Mumbai Mudrak Sangh, 263/F, Raja Rammohan Roy Road, Girgaum, Bombay-4, was appointed as Employer's Representative in place of Shri S. V. Daftari, President, Mumbai Mudrak Sangh, Bombay-4 (Annexure V).

- 1.3. Additions in the Committee.—By Government Resolution, Industries and Labour Department, No. MWA. 2674/100982/Lab-III-A, dated 29th March 1975, Shri J. W. D'Souza, Rose Manor, Ground Floor, Santacruz, Bombay-400 054 was appointed as additional representative of employers. By the same Resolution, Shri S. S. Acharekar, General Secretary, Industrial Employees Union, C/o. Government Central Press, Charni Road, Bombay-400 004, was appointed as additional representative of employees (Annexure VI).
- 1.4. Terms of Reference.—The Committee was appointed to enquire into the conditions prevailing in the employment in any industry in which any process of printing by letterpress, lithography, photogravure, or other similar work or work incidental to such process of book-binding is carried on, and to advise Government in the matter of revision of minimum rates of wages in the said employment fixed under Government Notifications, Industries and Labour Department, Nos. (1) MWA. 2662/Lab-III, dated 31st December 1964; (2) MWA. 2662 (ii)/Lab-III, dated 31st December 1964; (3) MWA. 2662 (iii)/Lab-III, dated 31st December 1964; (4) MWA. 2662-Lab-III, dated 21st April 1965 and (5) MWA. 2662-Lab-III, dated 29th March 1966.
- 1.5. Time-limit for submission of the Report.—The Committee was directed to submit its report within six months from the date of the Resolution No. MWA, 2674/100982/Lab-III-A, dated 3rd February 1975. The work of the Committee could not be started on account of Government Employees' Strike from 18th April 1975 to 26th May 1975 at the initial period of the formation of the Committee. Therefore, during the function of the Committee, it observed that it would not be possible to submit its report within the prescribed time limit and hence an extension for submission of the report by a further period of three months was requested. The Government accordingly extended the timelimit for submission of the report upto 3rd November 1975, vide its Resolution No. MWA. 2675/77/Lab-5, dated 31st July 1975 (Annexure VII). The Committee could not complete its work within the extended time-limit prescribed above as it had to visit about 20 centres outside Bombay. The visits to these centres could not be undertaken on account of extraordinarily heavy monsoon this year as also the change in the Member-Secretary. Hence, the Government was again requested to grant further extension upto 3rd May 1976. The Government granted the extension only upto the 3rd March 1976, vide Government Resolution, Industries, Energy and Labour Department. No. MWA. 2675/77/Lab-5, dated 31st July 1975 (Annexure VIII).
- 1.6. Procedure followed by the Committee.—The first meeting of the Committee was held on 14th March 1975 to consider the procedure to be followed and to draft the questionnaire to be issued to the employers, employers' associations and federations of employers and trade unions. The Committee discussed and approved the questionnaire in the meeting held on 8th July 1975. The Committee then decided to issue questionnaires (Annexures IX, X and XI)

to the employers associations, federations of employers and trade unions connected with the employment. The Committee then tentatively chalked out a tour programme of important printing centres with a view to make on the spot inquiry and interview the representatives of trade unions, associations of employers and persons interested in the enquiry. The questionnaire finalised by the Committee was divided into three parts:

- (1) Employers;
- (2) Employers' Associations, Federations and Trade Unions; and
- (3) Employees.

The questionnaire was prepared both in English and Marathi to facilitate easy understanding by all. The questionnaire was then issued to concerned associations, unions and individual employers. In addition, the investigators from Labour Commissioner's Office were deputed to visit printing presses personally at important centres and collect the required data for the use of the Committee.

^{1.8.} Publicity.—After the questionnaires were issued a press note was also issued through the Director of Publicity giving wider publicity for the purpose for which the Committee had been appointed and the employers, unions and associations were asked to submit replies to the questionnaire. Similarly, at the time of each tour programme separate advanced press notes were issued and persons interested in the enquiry were requested to appear before the Committee to record their views and evidence in the matter of revision of minimum rates of wages.

At each of the centres the Committee selected printing presses of different sizes and doing different kinds of work such as letter presses, litho presses, Government and semi-Government presses. The Committee, during the visits paid to the printing presses, observed the working conditions and made enquires regarding the rates of wages paid to the different categories of workers. The committee also inspected records maintained by the employers and ascertained from them information regarding type of machinery installed, type of work done by the presses, number of shifts worked, rate of wages paid and number of workers employed therein.

CHAPTER II

NATURE AND CONDITION OF THE PRINTING INDUSTRY AND MINIMUM WAGES THEREIN

- 2.1. The history of printing is an integral part of the general history of civilization. The principal vehicle for the conveyance of ideas during the past five hundred years, printing touches upon, and often penetrates, almost every sphere of human activity.
- As 'Adventure and Art' Gutenberg described his epoch-making invention in 1439; and 'Adventure and Art' have ever since remained the characteristic feature of the printed book—S. H. Steingberg.
- 2.2. In our country, particularly since independence, the standard of printing is much improved and the printers have been consistently striving to improve the quality of printing. The Governments are also encouraging efforts to create and develop quality consciousness amongst the printers and have been granting Awards for Excellence in Printing. In our State particularly, the Government itself is the biggest employer and has its own presses at Bombay. Poona, Nagpur, Kolhapur, Aurangabad and Wai employing about 5,000 workmen and has introduced developed techniques and sophisticated machinery for printing. The profile of Government printing itself is undergoing a radical change as the activities of our Government have also increased enormously in several directions. The Government has embarked upon vast programmes of economic development and social justice. Consequently, there has been spontaneous increase in the quantity and variety of printed materials in various forms. In our democracy, the Government has necessarily to make deliberate planned and sustained efforts to establish and maintain mutual understanding between itself and the people. In the circumstances, the printing industry becomes an important means of reliable and effective communication. the emphasis on spread of education, knowledge and information as well as commercial requirements, the printing industry should be increasing day by day, even in the private sector. The new techniques are replacing old. Similarly, new sophisticated and automatic machineries in big presses are replacing old wherever advance techniques in printing processes are utilised. It can be safely said that our State is in the vanguard of the printing industry in quality in our country.
- 2.3. There are more than 4.000 printing presses in the whole of the State, but the main concentration of the printing presses is in urban areas where there

is significant industrial and commercial growth rapidly taking place. In Bombay, Poona and Nagpur there are few presses which compete in quality printing even on an international level. They have most up-to-date techniques and machinery introduced in their processes. It is, therefore, evident that composing of types by hand has been shifting towards mechanical composition by mono-type or lino-type operation. By one or two presses which are owned by Industry such as Tata Press, a new process of photo-type setter is introduced. In Lithography, Calligraphy and Chromo lithography is replaced by camera operations using screens and filters for making deep etched plates on zinc, aluminium, microzinc for off-set machines which are capable of printing four colours at a time. One or two presses have perfected even diazo presensitized plates. The machinery in Quad Demy size is introduced for large poster printing and for magazine production. Web off-set are installed in few large presses. Manual operations in bindery are now mechanized particularly for folding, sewing, numbering, blocking and even for bookcase making. Inspite of modernization, as we go from urban areas to mofussil the main feature of the printing shop is the one treadle press where one compositor, one treadle pressman and one binder is a standard employment potential of the workers employed. Many a times, a workman employed in such printing shop is versatile and is capable of doing all types of operations for such printing shops. In some of such printing shops the employees are family members.

- 2.4. The Committee has observed there has been constant demand for highly skilled labour and a need for training of required skills in the Industry. Unfortunately, we are still lagging behind in required training facilities for skills and much reliance is on trial and error method while working. Because of advance techniques, the highly skilled labour requires inplant training for new techniques or higher skilled techniques. Besides the Government School of Printing Technology in Bombay, one private school at Pune, for some courses introduced in I.T.I. and in Secondary Schools, there are no facilities available for training in the Printing trades. Now because of implementation of the 20-Point Economic Programme and Employment Promotion Programme apprentices are being appointed in the printing presses compulsorily to the extent of about 2 per cent of the total employment. But the training system still continues on the floor shop by trial and error method. Many a times, such provisions for apprentices unfortunately are found misused.
- 2.5. The Government of Maharashtra being conscious of social justice, have brought about fixation of minimum wages for many industries where labour is found to be unorganised. The workers in the printing industry were brought in the ambit of the Minimum Wages Act, 1948 by then Bombay State Government since 1955. Thereafter Government of Maharashtra appointed the Second Committee for revision of minimum wages in the printing industry in 1963, unanimous recommendations of which are in force from 1st January

- 1965. This Second Committee for the first time fixed minimum wages for Vidarbha and Marathwada regions of the State and had been a pioneer in introducing scheme of special allowance in addition to the basic rate of minimum wages to neutralise the rise in cost of living. This special allowance is linked up with the Bombay Consumer Price Index for the Working Class (old series) for the whole State. But the rate of special allowance varies from zone to zone, in the State. There have been complaints of non-implementation of the minimum wages, but the rate of minimum wages have been implemented generally in the industry.
- 2.6. The Second Committee had divided the State into four Zones including Vidarbha and Marathwada regions. The zones comprised of the areas as follows:—

Zone No. I.—Greater Bombay.

Zone No. II.-Poona and Nagpur.

Zone No. III.—Sholapur, Kolhapur, Nasik, Nasik Road, Deolali, Deolali Cantonment, Malegaon (Nasik), Ahmednagar, Dhulia, Jalgaon, Bhusaval, Sangli, Miraj, Ichalkaranji, Barsi, Bhiwandi, Amalner, Madhavnagar, Koregaon (Satara), Pandharpur, Satara, Satara Road, Nandurbar, Ambernath, Chalisgaon, Karad, Manmad, Ratnagiri, Karjat (Kolaba), Pen, Panvel and Alibag, Amravati, Akola, Gondia, Chanda, Wardha, Yeotmal, Khangaon, Kamptee, Bhandara, Jalna, Latur, Parbhani, etc.

Zone No. IV.—Comprising of all other places not included in Zone I, Zone II and Zone III above.

2.7. As per the recommendations of the Second Committee for revision, the minimum wages including special allowance for various Zones for unskilled class since 1st January 1965 have been as follows:—

^{2.9.} Though the minimum wage is fixed for workers in the printing industry in Maharashtra State, all the workers are not necessarily benefited under this Act. The Central Government has two presses at Nasik Road employing about 7,000 workers whose wages and other service conditions are governed by the Government of India's Pay Commission's recommendations. The wages of the workers employed in printing presses of Government of Maharashtra

are fixed on the basis of the recommendations of the Badkas Commission. In case of non-working journalists working in the newspaper industry, wages are fixed under the recommendations of the Wage Boards appointed by the Central Government for the purpose. It is, therefore, very clear that the minimum wages fixed under the Minimum Wages Act, and enforced by the State Government, are mainly concerned with workers employed in the job printing presses in private sector. In private sector, wherever the workers are organised in trade unions, they have their settlements or awards by collective bargaining or through the machinery of conciliation and adjudication under the Industrial Disputes Act. 1947 and normally such settlements or awards have somehow granted more wages, than the present minimum wages depending not only on the capacity to pay of the individual concerns but also the bargaining power of the unions. Such settlements and awards are found in printing presses where more than 20 workers are employed. The settlements and awards between the management and the workers are existing mostly in Bombay, Poona and Nagpur among leading presses only, known for their size and capacity.

- 2.10. It was noticed that particularly bigger printing presses are found anxious to maintain production and also productivity. The Government Central Press in Bombay, under the auspices of Joint Management Council, made efforts regularly for increase in productivity and the workers there had co-operated in the efforts. The National Productivity Council had sent one team abroad for study of several facts of productivity in printing industry. There was seminar held in the School of Printing Technology in Bombay over the report of the team. What efforts were made to implement the recommendations of that team, are not known. The Committee feels, the implementation of the recommendations of that team are necessary so that the economic bias prevailing in printing industry can be done away with; technical development could be recognised and that would be to the mutual advantage of the employers and the workers and for recognition of the printing industry in total industrial development of the country.
- 2.11. The last Committee had recommended norms for minimum out-turn for working of eight hours a day. These are quite reasonable and the Committee strongly endorses their implementation. In this era, when emphasis is on discipline and production, implementation of such reasonable norms of production will help the industry and the workers in many ways in future. We observe that there can be co-operation from all concerned for implementation of such a constructive move.
- 2.12. Unfortunately, during the last three years in particular, the industry went through terrible strain and stress. There was shortage of paper and other raw materials. Prices had shot up beyond the reach and malpractices of on-money handicapped working of the industry. The State Government

nationalised printing of school text-books. The Government established Maharashtra State Bureau of Text-Books Production and Curriculum Research. The Text-Book Bureau took over the publication of all the school books unto X standard. No doubt the printing of text-books was mainly entrusted to private presses which helped few favoured presses to expand but the established nublishers were adversely affected and their printing presses suffered heavily. Some leading big industrial units have started their own monopoly printing presses. They do pay the workers employed in their printing departments on par with other workers employed in their units, wage rates of which are generally more than the minimum rates of wages fixed for the printing industry. But thereby continuous volume of print orders available to the printing industry are reduced. Moreover, restrictions imposed by the Government on printing of calendars, diaries in small sizes and on the use of art paper in general, have also reduced the quantum of print orders. This resulted in printing press owners unwisely indulging in cut-throat competition and thereby losing reasonable revenue otherwise available. The power shortage enforced during the last two years also affected the industry adversely. This whole situation resulted in dwindling of the profit position of many presses and caused some retrenchment of workers. During such desperate period we found certain unhealthy practices in the printing presses on the increase. To get the composing work done on piece-rate system and to divert binding work to the contractual labour within the premises or outside is on the increase so as to cut down the cost of production. The printing press owners were caught in such a situation where they could not take any action against the suppliers of paper and raw materials. The Government, therefore, had to intervene and an effort on all India basis was made particularly to lay down norms for paper production and certain grades of paper available to printing industry in private sector, especially for book printing and for manufacturing of exercise books at control rate. Since the introduction of emergency on 26th June 1975, the things are taking shape for good and prices of paper and raw material as well as consumer goods are coming down appreciably as may be seen from retail prices in shops and may soon be stabilised, providing relief to industry and the workers. This is hopeful situation and printing industry can and shall again leap forward for betterment and prosperity. We also hope appropriate opportunities and encouragements might be provided by the Central and State Governments to the industry and the industry will adopt better understanding towards the workers, soliciting their co-operation in discipline and production, and allowing to share their gains with the workers; will prove best service industry to the nation, which may be recognised as industry in priority sector in future.

CHAPTER III

CONCEPT OF MINIMUM WAGE

- 3.1. In modern welfare State, such as ours, consideration of social justice play a major role in shaping social, economic and industrial policies. The Directive Principles of State Policy embodied in Article 43 of the Constitution of India states." The State shall endeavour to secure, by suitable legislation or economic organisation or in any other way, to all workers, agricultural, industrial or otherwise, work, a living wage, conditions of work ensuring a decent standard of life and full enjoyment of leisure and social and cultural opportunities and, in particular, the State shall endeavour to promote cottage industries on an individual or co-operative basis in rural areas." This directive protects labour against the exploitation and assures an adequate means of livelihood as well as economic justice.
- 3.2. The International Labour Organisation has consistently pressed for the achievement of a minimum standard of living for workers. The International Labour Conference held in 1964 urged upon the Member-States to ensure adequate minimum living standard to all workers and their families, particularly, through dynamic minimum wage and social security measures, which systematically take account of economic growth and rising living costs. There has been growing recognition that raising and developing the quality of human resources is as essential to future development as is accumulation of capital. Hence, minimum wage determination has to be based on various socio-economic factors rather than left to the market forces of supply and demand.
- 3.3. The Whitley Commission examined the question of 'minimum wage' specifically in the light of International Labour Organisation Convention and observed, "In our view the Convention, in referring to trades in which wages are 'exceptionally low', must be regarded as having in view trades in which wages are low, not by comparison with western or other foreign standards, but by comparison with the general trends of wages and wage levels in kindred occupations in the country concerned...."
- 3.4. Popular Ministries which came into power in 1937, had appointed Committees to consider the question of minimum wage fixation. These Committees were generally in favour of minimum wage regulation. There was a full debate over the issue of statutory minimum wage in the Indian Labour Conference. A special Sub-Committee was appointed to scrutinise this issue. Ultimately, Minimum Wage Bill was introduced in the Central Legislative Assembly in April 1946 and the Minimum Wages Act was brought into force from March 1948.

3.5. "The passing of the Minimum Wages Act, 1948 is a landmark in the history of labour legislation in the country." This is observed by National Commission on Labour, of which Shri P. B. Gajendragadkar was the Chairman. The report of the Commission further states: "It recognises that the wages could not be left to be determined entirely by market forces. As we have already indicated once the minimum wage is fixed according to the provisions of the Minimum Wages Act, it is not open to the employer to plead his liability to pay the said wage to his employees. In other words, after the minimum wage is determined under the Act, the obligation of the employer to pay the said wage is absolute." In country like ours, where the number of unemployed persons is very large, the Legislature realised that if the rule of the market forces is allowed to prevail, it would be difficult to prevent sweating or exploitation of labour through payment of unduly low wages. It was to prevent this position that the law was enacted and specific provisions made for determining the minimum wages in respect of scheduled industries. The National Commission on Labour in its report, 1969, further contends—"A criticism against the Act has been that it does not define the term 'minimum wage'. While several States consider that the concept of minimum wage as currently applied to sweated industries needs no change, trade unions have urged that to avoid differences in interpretation by wage fixing authorities, 'minimum wage' should be spelt out in precise terms. Our examination has revealed that neither the Advisory Committees set up under the Act nor the State Authorities in charge of minimum wage fixation have followed a uniform set of principles while fixing or revising wage rates. They have mostly been going by their own assessment, over which the prevailing rates of wages have a firm hold.

The minimum wages may thus vary from region to region and even within the same region from time to time depending on particular situations. Prescribing some rigid criteria in regard to minimum wage fixation is, therefore, neither feasible nor desirable. It will necessarily have to be left flexible. We are further of the opinion that laying down a rigid cash equivalent of the content of a statutory minimum wage whose coverage is essentially transitional under conditions of development would not serve any useful purpose."

3.6. The Third Pay Commission in its report (1973) while recommending minimum remuneration to the Central Government employees has discussed the issue of minimum wage elaborately. It has observed that (para 24) it would be useful to recall here that the Second Pay Commission which, too, had examined the demand of the employees for a need-based minimum wage, according to the norms recommended by the 15th Indian Labour Conference, came to the conclusion that the monetary value of such a minimum wage would be out of tune with the level of per capita national income. Since the Report of the Second Pay Commission, several Wage Boards have examined similar demands from the employees. Without exception they came to the conclusion that such a need-based minimum wage could not be recommended,

being beyond the capacity of the industries to pay. The National Commission on Labour also expressed the view that the need-based minimum wage could be introduced by convenient and just phasing, keeping in mind the extent of the capacity of the employer to pay the same. (Para 25). The fixing of minimum wages should be in harmony with broad principles of policy relating to economic and social developments and particularly the achievement of rapid growth and equitable distribution of national income. Further, the minimum wage should be realistic, and it should be in consonance with the conditions prevailing in the country. One has to avoid the danger of setting premature and unwise minimum standards which the country and the economy can ill-afford. standards may raise expectations all round, and since they would be incapable of fulfilment because monetary wages would soon be eroded by a rise in prices. frustration would deepen all the more. The additional expenditure involved in fixing the minimum remuneration on the basis recommended by the 15th Indian Labour Conference, and the inevitable repercussions such a course would have on State Governments, Local Bodies, Universities, etc., would, in the aggregate, have a deleterious effect on the total budgetary resources. It would lead to drastic curtailment of developmental expenditure, and a slowing down of projects which would further aggravate the present unemployment situation in the country, to the solution of which the Government attaches paramount importance. Having regard to the prevailing level of wages in the agricultural sector and the general minimum level in trade and industry, except in certain organised private and public sector undertakings, which should be considered more as an exception rather than the rule, we feel that the adoption of the minimum remuneration based on the 15th Indian Labour Conference norms at this stage would be tantamount to a misdirection of resources.....We have. therefore, not found it possible to recommend that under existing conditions the minimum remuneration of Central Government employees should be fixed on the basis of the norms recommended by the 15th Indian Labour Conference."

- 3.7. In conclusion, the National Commission on Labour found that the quantum of monetary minimum wage calculated on basis of 15th Indian Labour Conference is not realisable in the near future.
- 3.8. In the year 1964 the Government of Maharashtra had appointed a "Norms Committee" under the Chairmanship of Shri B. S. Kalelkar. The said Committee discussed on page 28 of it's report Part I on subject of need based minimum wage. On studying various Awards by Industrial Tribunals and Arbitrators, the Industrial Tribunals in this State, have so far, in general expressed their inability to grant a need based minimum wage. In the case of East Asiatic Company vs. its workman, the learned Tribunal opined that the need-based minimum wage is an aim to be kept in view and could not be achieved in one stroke of adjudication proceedings.

In the Supreme Court judgement in Crown Aluminium Work's case (L.L.J.-1958 Volume I) it is observed that "there is, however, one principle which

admits of no exceptions. No industry has a right to exist unless it is able to pay its workmen at least a bare minimum wage."

It must be added here that theoretically no wage structure could or should be revised to the prejudice of workmen if the structure in question falls in the category of the bare subsistence or the minimum wage.

- 3.9. While revising the minimum rates of wages in the printing industry for the second time our Committee has taken a practical view. The last Committee had taken the following view while unanimously revising the rates of minimum wages for the printing industry in the State then.
- The Fair Wage Committee appointed by the Government of India in 1948 held that while the lower limit for the fair wage must obviously be the minimum wage; the upper limit was set by the capacity of the industry to pay. As regards the living wage the Fair Wage Committee found that there was general agreement that the living wage should enable the male earner to provide for himself and his family not merely the basic essentials of food, clothing and shelter but a measure of frugal comfort including education for children, protection against ill-health, requirement of essential social needs and measure of insurance against the more important misfortune including old age. would thus appear that the living wage would be the ideal to be attained through the stages of minimum wage and fair wage. The bare subsistence of minimum wage is a wage which would be sufficient to cover the bare physical needs of a worker and his family i.e. a rate which has got to be paid to the worker irrespective of the capacity of the industry to pay. The primary factor to be taken into consideration while fixing the minimum rates of wages should be the cost of minimum subsistence. The main consideration which is to be borne in mind is that the industry should be able to maintain production with efficiency and the fixation of the rates of wages should be such that there are no movements from one industry to another owing to the wide disparities and employment at existing levels is not only maintained but if possible increased. We agree with this view point.
- 3.11. Our Committee fully appreciates the need for reasonable revision of rates of minimum wages as existing at present. We have to balance judicially and realistically the needs of labour and needs of the industry to survive and develop in competetive economy. Hence our approach is one of compromise bearing in mind following criteria as suggested by Expert Committee appointed by International Labour Organisation to study the problems of developing economy including problems of minimum wage fixation. (1) Workers' needs, (2) Employers' capacity to pay, (3) Wages or income prevailing elsewhere in the country, (4) requirements of economic development. Naturally, the existing conditions of the industry and existing wage level in the industry are taken into consideration by us, while recommending the revision of rates of minimum wages for the second time.

CHAPTER IV

THE VIEWS OF THE EMPLOYERS AND THEIR ASSOCIATIONS

- 4.1. (1) The revision of minimum wages in the Printing Industry is not limited to mean, fixation of minimum wages at higher or upper level only, but it means that the whole matter is to be considered *de novo*.
- (2) There are different rates of minimum wages in the different zones of the State in the various Industries. In our industry, the minimum rate of basic wage has been coupled with the special allowance since July 1965. This has created imbalance and anomalous position. Hence the revision of minimum wages should be examined in the light of rates of minimum wages prevailant in cross section of different industries covered under the Act.
- (3) The financial position of the Printing Industry should be taken into consideration while revising the minimum wages, particularly profitability of the printing industry.
- (4) There should be no revision of the minimum wages as the rates are higher than other industries.
 - (5) The industry is finding difficult to cope up with the wage burden.
 - (6) The competition in the industry is of cut-throat nature.
- (7) The Government has taken care of the questions like Bonus, Gratuity, Provident Fund, Employment State Insurance Scheme and this should be borne in mind.
 - (8) Any revision upward will be of disadvantage to the industry.
- (9) The Committee should visit all places in districts and collect all possible information regarding industry in the Maharashtra State.
- (10) Because of implementation of 20 points economic programme declared by Prime Minister, the prices of articles are falling down, hence the question of revision of minimum wages should be postponed for 2 years.
- (11) Unless all the industries covered under the schedule appended to the Minimum Wage Act are provided with the special allowance, the minimum wages in printing industry should not be revised.
 - (12) The existing zones should not be changed.
 - (13) The existing classification of the categories should not be changed.
 - (14) The definition of each category is necessary to be made by job evaluation.

- (15) The last Committee had recommended the norms of production for many categories. This should be made conditional and linked up with minimum wages.
- (16) The printing industry is "service industry" and not manufacturing one. Moreover, the Government has done nationalization of school text books. Because of the rise in prices of paper and other raw material, the quantum of print orders is much reduced. These factors should be borne in mind, while revising minimum wages.
- (17) The Government should decide economic rates for the print orders to be executed by the private presses; keeping in mind, the minimum wages to be paid. The Government should not insist on tenders for printing.
 - (18) The Committee should also fix the rates for piece work.
- (19) The Committee should also take into consideration the minimum wage rates paid by the neighbouring States, so as to avoid unnatural competition.
- (20) The Government is supplying paper at control rate for manufacturing of exercise books, but the cost of production of exercise books in our State is higher than other States. Because of higher minimum wages in our State, the exercise books manufacturing units should be given special concession of lower rate of minimum wages.
- (21) The printing units which are not covered under Factories Act, 1948 should be excluded from the purview of the Minimum Wages Act.
- (22) The Government should take necessary action for providing In-Plant-Training Centres for skilled labour in printing industry.
- 4.2. Views expressed by employees or their Trade Unions.—(1) It is necessary to revise and increase the existing rates of minimum wages including special allowance as there has been tremendous increase in cost of living during the last decade and though special allowance has linked up with the Bombay Working Class Consumer Price Index, the rise in minimum wages has not been adequately compensated the rise in cost of living even at the ratio of 1965. The revision should provide adequate increase in the minimum wages fixed to compensate the rise in prices.
- (2) During the last decade, the difference in Cost of Living of the employees living in urban and rural areas is much reduced. Hence the difference maintained in minimum wages including special allowance for various zones in the State should be reduced adequately.
- (3) There should be only two zones viz., Zone I comprising of only Greater Bombay and Zone II comprising rest of Greater Bombay. Some Unions even suggested one zone throughout Maharashtra State fixing minimum wages of the unskilled category at Rs. 400 per month.
 - (4) The Minimum Wages Committee should also provide annual increments.

- (5) Unhealthy system of Contractual Labour and Piece Rate System should be abolished.
- (6) The workers interest should not be allowed to be suffered because of cut-throat competition among the Press owners.
- (7) Particularly, the skilled categories in the Printing Industry require higher degree of skilled and the techniques utilised are fast improving along with installation of sophisticated automatic machineries. Many hand operations are being replaced by mechanical operations. There is growing demand for quality printing. These factors should be borne in mind while revising minimum wages of skilled categories and weightage should be given for wider difference in minimum rates of wages between the classes of categories.
 - (8) There should be only two categories viz., highly skilled and skilled.
- (9) There should be adequate provision for training for skills in printing at every district including provision for In-plant training.
- (10) There should not be difference of more than Rs. 25 in all, in the rates of minimum wages for each Zone.
- (11) The small printing Shops are not covered under provisions of fringe benefits available under Labour laws stipulating Bonus, Provident Fund, State Insurance, Gratuity etc. Moreover, minimum quantum of bonus is reduced from 8.33% to 4% wherever the Act is applicable. These factors should be taken into account while revising and increasing minimum rates of wages.
- (12) Some unions suggested that Committee should provide production incentives Schemes based on scientific assessment of categorywise out-turn.
 - (13) The period of apprenticeship should be reduced.
- (14) The previous Committee had suggested minimum wages based on Bombay Consumer Price Index No. at 480 but while enforcing the revised rates of minimum wages the Government based the rates of Index at 500. The loss thereby should be compensated in revision.
- (15) Because of implementation of revised rates of minimum wages last time, no press is closed down but number of new printing presses have been increased. There should be very alert Government machinery provided for implementation of minimum wages and prompt action should be taken in complaints of non-payment of minimum wages.

CHAPTER V

RECOMMENDATIONS

- 5.1. The previous Minimum Wages Committee appointed by Government had brought to their notice, that while recommending the increase in the minimum wages they should also relate such increase vis-a-vis skills with minimum production standards. This Committee after much deliberation give same emphasis and request Government that production standard should be strictly implemented as recommended by the Committee. On the basis of this, the Committee recommends increase in the basic minimum wage. This Committee also points out that at this stage, it insists on production norms being made mandatory for the increases recommended, failing which it is the unanimous opinion of the Committee that production which relate with the implementation of the 20-point programme of the Prime Minister will not be done.
- 5.2. The Committee has observed that the minimum wages in the printing industry defer from State to State. Consequent to this, the neighbouring States where the minimum wages less than Maharashtra State, create unhealthy competition and thus take away fair share of printing outside the State. This has created unemployment in the printing industry and also a struggle for survival for employers. Government should not allow this kind of exploitation by the neighbouring States.
- 5.3. Our experience has been that on account of the extraordinary rise in the special allowance in the last few years, minimum wages as a result have not been and cannot be implemented realistically throughout the State. Therefore the Committee recommends that an Advisory Committee to see to the functioning and implementation of the minimum wages be appointed consisting of (1) Government nominee, (2) Nominee from Labour Commissioner's Office, (3) representatives on behalf of employers' side and (4) Three representatives on behalf of employees.
- 5.4. Facilities for the training in the craft.—Presently the Department of Technical Education has approved four different courses of training in the Printing Craft. In Bombay area the State Government has lately started with the help of the Central Government a regional School of Printing Technology. The total capacity of the school is 225 with about 50 new entrants every year. It conducts 3 years full time courses and part-time 4 years courses in

Letterpress printing and Lithography. Diplomas are awarded after the final examination. The graduates of the school mostly join the industry as Supervisors.

At advance certificate course in Composing and Printing has been conducted at two places in Bombay and Poona. It is again a full time 3 years course with the regional language as the medium of instruction. The intake is about 20 students every year.

5.5. Inter-State Competition.—The Association of employers have brought to the notice of the Committee serious competition the industry in the State is facing from their counterparts in the neighbouring States on account of prevelance of abnormally low wages there. The employers have urged that the State Government should make strong representation to the Central Government to call upon these State Governments to fix or revise minimum rates to fall in line with these prevailing in this State in order to eliminate Inter-State competition.

While making the recommendations the Committee has taken into consideration the various factors such as overall picture of the industry in different areas of the State, the nature of occupations, the skills involved in the various jobs, the variations in the cost of living, the extent of urbanisation and the principles underlying the concept of minimum wage. It is our firm opinion and conviction that unless the categories are classified scientifically and norms fixed therefore, it will not contribute to the growth of the industry and secure benefits to workers.

CHAPTER VI

SUMMARY OF RECOMMENDATIONS

Recommendations for the revision of the minimum rates of wages in any industry in which any process of printing by letterpress, lithography or photogravure or other similar work or work incidental to such process or book binding is carried on in the Maharashtra State.

Employers' recommendation on ceiling of Index Number to 1400 (maximum) in relation to its linking up with the Special Dearness Allowance

The Special Dearness Allowance was made applicable to Printing Industry only in Maharashtra State in 1965. At that time it was linked with the Bombay Consumer Index standing at 500.

However during the period of last ten years it has gone up by leaps and bounds and it stands now at 1340. No doubt the overall prices of essential commodities and other commodities have shot up immensely and therefore the Consumer Index Number has risen considerably.

But at the same time the Printing Industry in Maharashtra State which consists largely of small printers is unable to absorb these fantastic rises in the Special Dearness Allowance and the whole structure of economy of the Trade has come to a crucial dwindling stage which in our opinion is harmful to the existence and progress of the Industry.

We therefore earnestly recommend to Government to place a ceiling on the Consumer Index Number to 1400 and beyond that it should not be linked up with the Special Dearness Allowance which is in force at present.
