#### THE MADHYA PRADESH PANCHAYATS BILL, 1960

#### A Bill to consolidate and amend the law relating to constitution and organisation of Panchayats as units of local Government in rural areas in Madhya Pradesh.

Be it enacted by the Madhya Pradesh Legislature in the Eleventh Year of the Republic of India as follows:-

#### CHAPTER I—PRELIMINARY

(1) This Act may be called the Madhya Pradesh Short title, ex-1. Panchayats Act, 1960. tent and

commencement.

(2) It extends to the whole of Madhya Pradesh.

[(3) This section and section 389 shall come into force at once and the Government may by notification bring all or any of the remaining provisions of this Act into force in , respect of any area on such date as may be specified therein and different dates may be specified for different provisions of this Act and for different areas.

(3) This Act shall come into force on such date as the State Government may, by notification, appoint ; and different dates may be appointed for different areas and for different provisions of this Act.

- In this Act, unless the context otherwise requires,- Definitions. 2.
  - (i) "Adivasi Panchayat" means an Adivasi Panchayat established under section 98;
  - (ii) "Bench" means a bench of Nyaya Panchayat constituted under section 232:
  - (iii) "block" means such area in a district as the Government may, by notification, declare to be a block under section 110;
  - (iv) "Board" means a Conciliation Board constituted under section 201;
  - (v) "building" includes a hut, shed, or other enclosure whether used as human dwelling or for any other purpose whatsoever and shall in-clude wells, walls, verandahs, fixed platforms, plinths, door steps and the like but shall not include a tent or a temporary shed erected on ceremonial or festive occasions;
  - (vi) "Chairman" means the Chairman of a Zila Panchayat:
  - (vii) "Chief Executive Officer" means the Chief Executive Officer of the Janapada Panchayat appointed under section 151;

- [(viii) "Convenor" means a convenor of a Functional Committee elected under sub-section (4) or (5) of section 19;]
- [(ix) "Deputy Convenor" means a Deputy Convenor of a Functional Committee elected under subsection (4);]
  - (x) "Factory" shall have the meaning assigned to it in the Factories Act, 1948 (LXIII of 1948);
  - (xi) "Functional Committee" means a Functional Committee of a Gram [Sabha class II or Gram Sabha class III] Panchayat constituted under section
     [19] 39;
- (xii) "Gram Panchayat" means a Gram Panchayat established under section 17;
- (xiii) "Gram Sabha" means the Gram Sabha established under section [5] 4;
- (xiv) "Gram Sabha area" means the area comprised within the village or villages for which a Gram Sabha is established;
- (xv) "land" includes benefits arising out of land, houses and things attached to the earth, or permanently fastened to anything attached to the earth and also land which is being built upon or is built upon or covered with water;
- (xvi) "Municipal Law" means a law for the time being in force for the organisation and administration of municipalities, town areas, notified areas or municipal corporations in the State;
- (xvii) "Nyaya Panchayat" means a Nyaya Panchayat constituted under section 217;
- (xviii) "Nyaya Panchayat Circle" means the area or areas within the jurisdiction of a Nyaya Panchayat;
  - (xix) "nuisance" includes any act, omission, place or thing which causes or is likely to cause injury, danger, annoyance or offence to the sense of sight, smell or hearing or disturbance to rest or sleep of the community or which is or may be dangerous to life or injurious to the health or property or offends against public morality;
  - (xx) "occupier" means any person in actual possession of any land or building and includes an owner in actual possession, and a tenant or licensee, whether such tenant or licensee is liable to pay rent or not;
  - (xxi) "offensive matters" include animal carcasses, dung, dirt, sewage or putrid or putrifying substances and filth of any kind;
- (xxii) "owner" when used with reference to any land or building includes the person for the time being receiving the rent of the land or building or of any part of the land or building whether on his own account or as agent or trustee for any person or

society or for any religious or chalitable purpose, or as a receiver who would receive such rent if the land, building or part thereof were let to a tenant;

- (xxiii) "Panch" means a member of an Adivasi Panchayat, a Gram Panchayat, a Nyaya Panchayat or a Pargana Panchayat, as the case may be;
  - (xxiv) "Panchayat" includes a Gram Panchayat, a Janapada Panchayat and a Zila Panchayat;
  - (xxv) "Pargana Panchayat" means a Pargana Panchayat constituted under section 107;
- (xxvi) "Pradhan" and "Up-pradhan" means the Pradhan and Up-pradhan respectively of a Nyaya Panchayat;
- (xxvii) "Prescribed Authority" in any provision of this Act means such officer or authority as the Government may, by notification, direct to discharge the functions of a prescribed authority under that provision;
- (xxviii) "President" and "Vice-President" means the President and the Vice-President respectively of a Janapada Panchayat;
  - (xxix) "Public ferry" means a ferry used for the conveyance for hire of any passenger, animal, cart, carriage or other vehicle or goods;
  - (XXX) "Public market" means any market belonging to a Panchayat or acquired, constructed, maintained or managed by a Panchayat;
- (xxxi) "Public place" means any place, building or structure not being private property, which is open to use or enjoyment of the public, whether such place, building or structure is vested in a Panchayat or not;
- (xxxii) "Public street" means any road, foot-way, square, court, alley or passage, accessible, whether permanently or temporarily to the public, whether a thorough-fare or not;
- (xxxiii) ["Sarpanch" and "Upsarpanch" means the Sarpanch and the Upsarpanch of a Gram Sabha ;]
- (xxxiii) "Sarpanch" and "Upsarpanch" means the Sarpanch and the Up-Sarpanch respectively of a Gram Panchayat;
  - (xxxiv) "tax" includes a tax, toll, cess, rate, fee or other impost leviable under this Act, but does not include a fine;
  - (xxxv) "vehicle" includes a bicycle, rickshaw, tricycle, motor car and every wheeled conveyance which is used or is capable of being used on a public street;
  - (xxxvl) "water course" includes any river, stream or channel, whether natural or artificial;
- (xxxvii) "Zila Panchayat" means a Zila Panchayat established under section 173.

## CHAPTER II-GRAM SABHAS

[3. There shall be the following classes of Gram Classification of Sabhas:---

(i) Gram Sabha, Class I;

- (ii) Gram Sabha, Class  $\Pi$ ; and
- (iii) Gram Sabha, Class III.]

Establishment of [4. (1) The State Government may, by notification, Gram Sabha. establish—

- (a) a Gram Sabha Class I for a village or group of villages having a population exceeding 3,000;
- (b) a Gram Sabha Class II for a village or group of villages having, a population exceeding 1,500 but not exceeding 3,000;
- (c) a Gram Sabha Class III for a village or group of villages having a population of not exceeding 1,500.

(2) Notwithstanding anything contained in sub-section (1), the State Government may, by notification, for reasons to be specified therein—

- (a) establish a Gram Sabha of any class for any village or group of villages irrespective of the population thereof; or
- (b) declare a Gram Sabha of any class to be a Gram Sabha of a higher or lower class with effect from such date as may be specified therein.

(3) A notification under this section shall specify the class of the Gram Sabha and the name by which it shall be known and shall define the limits of the area or areas within its jurisdiction. Such notification shall be conclusive widence of the class to which the Gram Sabha belongs.]

Establishment of Gram Sabha.

4. (1) The State Government may, by notification, establish a Gram Sabha for a village or group of adjoining villages having population of one thousand or more:

Provided that the State Government may for special reasons establish a Gram Sabha for a village having population of less than one thousand.

(2) A notification under this section shall specify the name of the Gram Sabha by which it shall be known and shall define the lmits of the area within its jurisdiction. It shall also specify the population of village or group of villages to which it relates and it shall be conclusive evidence of the population of such village or group of villages for the purposes of this Act.

of 5. [(1)] A Gram Sabha [Class I] shall consist of all persons whose names are included in the list of voters prepared under section 7.

f (2) A Gram Sabha Class II or Class III shall consist of all persons whose names are included in the list of voters prepared under section 8].

[(3) A member of a Gram Sabha shall hold office for life:]

[Provided that if his name is removed from the list of voters under the provisions of the Act or the rules made thereunder, shall cease to hold office with effect from the date of such removal].

Constitution Gram Sabha. 6. (1) For every Gram Sabha area there shall be a List of voters of list of voters which shall be prepared in accordance with the Gram Sabha provisions of this Act under the superintendence, direction and control of the Collector or such other officer not below the rank of the Naib-Tahsildar, as may be authorised by him in this behalf.

(2) The State Government shall make rules consistent with this Act generally providing for the preparation, revision and correction of the list of voters from time to time and publication thereof.

7. (1) Subject to the provisions of sub-section (2) every List of voters of person who is qualified to be registered in the Assembly Roll Gram Sabha, relatable to the Gram Sabha area or whose name is entered therein and is ordinarily resident within the Gram Sabha area shall be entitled to be registered in the list of voters of that Gram Sabha area :

Provided that no person shall be entitled to be registered in the list of voters for more than one Gram Sabha area.

**Explanation.**—The expression "ordinary resident" shall have the meaning assigned to it in section 20 of the Representation of the People Act, 1950 (43 of 1950).

(2) A person shall be disqualified for registration in the list of voters of a Gram Sabha, if—

- (i) he is disqualified for registration in the Assembly roll;
- (ii) he is convicted of an offence under the Untouchability (Offences) Act, 1955 (22 of 1955), unless a period of five years or such lesser period as the State Government may allow in any particular case, has elapsed since his conviction.

[8. (1) Subject to the provisions of sub-section (2), List of voters every head of the family who is qualified to be registered Gram Sabhas in the Assembly roll relatable to the Gram Sabha area or Class II and whose name is entered therein shall be entitled to be registered in the list of voters of that Gram Sabha area :

Provided that if the head of the family does not desire to be registered in the list of voters he may nominate any member of his family qualified to be registered in the Assembly roll, in such manner as may be prescribed; and such member shall be entitled to be registered in the list of voters in place of the head of the family :

Provided further that if the family consists of more than 7 members, one additional member of the family who is qualified to be registered in the Assembly roll and is nominated by the head of the family in the prescribed manner shall be entitled to be registered in the list of voters.

Explanation.—For the purposes of this section—

(i) all persons who are inter-related and are jointly residing as members of a family shall be deemed to constitute one family;

- (ii) the eldest member of the family who is enrolled on the Assembly roll relatable to the Gram Sabha area shall be deemed to be the head of the family;
- (iii) where a person is residing alone within the Gram Sabha area, he shall be deemed to be a head of the family.

(2) A person shall be disqualified for registration in the list of voters of a Gram Sabha area of a Gram Sabha Class II or Class III if—

- (i) he is disqualified for registration in the Assembly roll relatable to such area;
- (ii) he is convicted of an offence under the Untouchability (Offences) Act, 1955 (22 of 1955), unless a period of five years or such less period as the Government may allow in any particular case has elapsed since his conviction.

(3) For the purpose of preparing a list of voters under this section, the authority specified in section 6 shall cause a register of families to be prepared and maintained in such form and in such manner as may be prescribed.]

Preparation and [9. The State Government shall make rules consistent revision of list of with this Act generally providing for the preparation, revision and correction of the list of voters from time to time and publication thereof.]

Election of Sar- [10. Every Gram Sabha shall elect from amongst its panch and Up-members, a Sarpanch and an Upsarpanch within such time Sabha.

Provided that if the Gram Sabha fails to elect a Sarpanch or an Upsarpanch within the time prescribed, the State Government shall appoint any member of the Gram Sabha to be the Sarpanch or Upsarpanch, as the case may be, thereof.]

Sarpanch and Upsarpanch of Gram chayat shall be ex-officio Sarpanch and Upsarpanch respectively of the Gram Sabha.

Terms of office of [11. (1) The term of office of the Sarpanch and Up-Sarpanch and Upsarpanch. In the sarpanch shall be co-terminus with the term of office of the Panchas of the Gram Panchayat.

> (2) After the expiry of the term of his office the Sarpanch shall continue to carry on the current duties of his office until such time as the election or appointment of his successor is notified.

(3) (a) As soon as may be after the election or appointment of a new Sarpanch is notified, the outgoing Sarpanch shall hand over to him the charge of office.

(b) If the outgoing Sarpanch fails or refuses to hand over charge of his office as required under clause (a), the prescribed authority may by order in writing direct the outgoing Sarpanch to hand over forthwith charge of his office and all papers and property in his possession as such Sarpanch, to the new Sarpanch. (c) If an outgoing Sarpanch to whom a direction has been issued under clause (b), fails to comply with the direction he shall on conviction be punished with fine which may extend to hundred rupees and shall be ejected forcibly if necessary from the office by such officer as may be empowered by the prescribed authority in this behalf.]

[12. The Sarpanch or Upsarpanch may resign his Resignation by office by giving notice in writing to the prescribed authority, Sarpanch or Upbut the resignation shall not take effect until it is accepted sarpanch. by the prescribed authority.]

[13. (1) On a motion of no-confidence being passed by Removal of Sarthe Gram Sabha by a majority of its members present and panch. voting, the Sarpanch or Upsarpanch against whom such motion is passed shall cease to hold office with effect from the date immediately next after the date on which such motion is passed :

Provided that no such motion shall be considered by the Gram Sabha unless the Gram Panchayat recommends the removal of the Sarpanch or Upsarpanch, as the case may be, from his office by a resolution passed by a majority of not less than two-third of the Panchas present and voting and such majority is not less than one half of the total number of Panchas constituting the Gram Panchayat for the time being.

(2) Notwithstanding anything contained in this Act or the rules made thereunder, a Sarpanch or an Upsarpanch shall not preside over a meeting in which a motion of no confidence is discussed against him but he shall have a right to speak and otherwise to take part in the proceedings of the Gram Panchayat or Gram Sabha.]

[14. (1) The prescribed authority may suspend from Suspension of office any Sarpanch or Upsarpanch against whom any cri-Sarpanch or Upminal proceedings have been instituted or who has been <sup>sarpanch</sup>. detained in a prison during trial under the provisions of any law for the time being in force.

(2) During the suspension of a Sarpanch under sub-section (1), the current duties of his office shall be performed by the Upsarpanch and in the event of both the Sarpanch and Up-Sarpanch being suspended, the prescribed authority shall nominate one of the panchas who shall perform all the duties and exercise all the powers of the Sarpanch and Upsarpanch during the period for which such suspension continues.]

15. (1) There shall be held at least two meetings of a Gram Meeting of Gram Sabha every year on such date and at such time and the place Sabha. as may be prescribed:

Provided that the Sarpanch may at any time on his own motion and shall upon a requisition in writing of not less than one-fifth of the total number of members or if required by the Janapada Panchayat or the Zila Panchayat or the Collector, call a meeting of the Gram Sabha within 30 days from the receipt of the requisition.

(2) For any meeting of the Gram Sabha, one-tenth of the total number of members of the Gram Sabha shall form the auorum:

Provided that no quorum shall be necessary for a meeting adjourned for want of quorum.

(3) Any officer authorised in this behalf by the Coffector by general or special order shall have the right to speak in, and otherwise to take part in the proceedings of a meeting of the Gram Sabha, but shall not be entitled to vote.

(4) Unless otherwise provided in this Act, the Sarpanch and in the absence of the Sarpanch, the Upsarpanch shall preside over every meeting of the Gram Sabha. In the absence of the Sarpanch and Upsarpanch, the members of the Gram Sabha shall choose one of the Panchas of the Gram Panchayat, if present, and if none of the Panchas is present, one of them to preside.

(5) If any dispute arises as to whether a person is entitled to attend a meeting of the Gram Sabha, such dispute shall be decided by the person presiding regard being had to the entry in the list of voters of the Gram Sabha area and his decision shall be final.

Gram Panchayat 16. (1) The first meeting of the Gram Sabha in every to place, before year shall be held [within two months from] not less than Gram Sabha three months prior to the commencement of the financial statement of accounts, etc. year, and the Gram Panchayat shall place before such meeting---

- (a) the annual statement of accounts;
- (b) the report of the administration of the preceding financial year :
- (c) the development and other programme of work proposed for the current financial year;
- (d) the last audit note and replies, if any, made thereto;
- (e) any other matter which the Janpada Panchayat, the Zila Panchayat, the Collector or any officer authorised in this behalf may require to be placed before such meeting.

(2) It shall be open to the Gram Sabha to discuss any or all of the matters placed before it under sub-section (1) and the Gram Panchayat shall consider the suggestions, if any, made by the Gram Sabha.

(3) A Gram Sabha shall carry out such other functions as the State Government may by general or special order require.

#### CHAPTER III-GRAM PANCHAYATS

#### I. Constitution

Establishment yat.

17. (1) For every Gram Sabha, there shall be a Gram and incorporation Panchayat [which shall be of the same class as the Gram of Gram Pancha- Sabha for which it is] constituted in accordance with the provisions of this Act.

(2) Every Gram Panchayat shall be a body corporate by the name of its Gram Sabha having perpetual succession and a common seal and shall by its name sue and be sued and shall subject to the provisions of this Act and the rules made thereunder have power to acquire, hold or transfer property, movable or immovable, to enter into contracts and to do all other things necessary for the purpose of this Act.

18. [(1) Every Gram Panchayat Class I shall consist Constitution of such number of members, not being less than 8 and not [Class I.] more than 16, as the Collector may determine.

(2) Every Gram Panchayat Class I shall be composed of-

- (i) elected members;
- (ii) Patel of the village in which the headquarter of the Gram Panchayat is situate;
- (iii) members co-opted or appointed, if any, under subsections (3), (5) or (7).]

(1) Every Gram Panchayat shall consist of such number of elected members as is specified in the Table below :—

(2) Every Gram Panchayat shall be composed of-

- (i) elected members;
- (ii) members co-opted or appointed, if any, under sub-sections (3), (5) or (7):

Provided that where a Gram Panchayat is constituted for the first time, the Gram Panchayat shall be composed of members appointed by the State Government and such members shall, except as otherwise provided by this Act, hold office for a term of one year from the date of the publication of notification of such appointment in the Gazette or till such further period not exceeding one year in the aggregate as the State Government may by notification, from time to time specify.

(3) [(i) If the elected members do not include a woman the Gram Panchayat shall co-opt a woman, who is a member of the Gram Sabha and is qualified for being a member of Gram Panchayat, to be a member of the Gram Panchayat;]

(i) If the elected members do not include a woman or include less than two women, the Gram Panchayat shall coopt such number of women who are members of the Gram Sabha and ane qualified for being members of the Gram Panchayat as would make the total number of women members at least two.

(ii) If there is one or more Co-operative Societies in the Gram Sabha area and the elected members do not include the Chairman of any such Co-operative Society, [the Collector shall appoint] the Gram Panchayat shall co-opt a Chairman of any of such Co-operative Societies who is a member of the Gram Sabha and is qualified for being a member of Gram Panchayat, to be a member of the Gram Panchayat.

(4) Each Gram Sabha area shall be divided into such number of wards and the number of members of a Gram Panchayat to be elected from each ward shall be such as may be determined by the Collector.

(5) Where there are members belonging to the Scheduled Castes or Scheduled Tribes residing within the Gram Sabha area, such number of seats shall be reserved for the members of Scheduled Castes or Scheduled Tribes on the Gram Panchayat as shall bear, as nearly as may be, the same proportion to the total number of seats in the Gram Panchayat as the population of the members of the Scheduled Castes or Scheduled Tribes in the Gram Sabha area bears to the total population of such area:

[Provided that such reservation shall be subject to the period specified in Article 334 of the Constitution of India, but the fact that the reservation of seats has ceased to have effect shall not render any person elected or appointed and in office immediately before such ceaser ineligible from continuing as a Panch during the rest of the term to which he was validly elected ;]

Provided [further] that in case no reservation of seats is possible as aforesaid due to small population of scheduled castes or Scheduled tribes, as the case may be, and the elected members do not already include a member of such castes or tribes, [the State Government may appoint] the Collector shall appoint a member of the Scheduled castes or the Scheduled tribes, as the case may be, to be a member of the Gram Panchayat.

(6) If any person is co-opted or appointed as a member of a Gram Panchayat in accordance with the provisions of this section, the total number of members of such Gram Panchayat as fixed under sub-section (1) shall be deemed to have been increased by the number of members so co-opted or appointed.

(7) If for any reason an election does not result in the return of the required number of persons qualified to be Panchas, the Government or the prescribed authority shall, as soon as possible, appoint from amongst persons qualified to be elected, such persons as are necessary to make up the required number and the persons so appointed shall, for all purposes of this Act be deemed to have been duly elected under the provisions of this Act.

[19. (1) Every Gram Sabha Class II and Class III Constitution of shall have the following Functional Committees for the Functional Compurpose of exercising such powers, discharging such duties II and Class III and performing such functions of the Gram Panchayat as Gram Sabhas. may be delegated or assigned to them by the Gram Panchyat:---

(1) Agriculture Committee.—For functions relating to agriculture, animal husbandry, minor irrigation, compost manuring, seed distribution and other matters connected with development of agriculture and live-stock.

(2) Industries and Co-operation Committee. -For functions relating to co-operation, small saving, cottage industries, rural housing, statistics and other allied matters.

(3) Education and Social Welfare Committee.—For functions relating to education including special education, health and sanitation including rural water supply and drainage, social welfare, women welfare, relief of distress crused by floods, draught, earthquake, scarcity, locust swarms and other such emergencies.

(4) Communication. and Works Committee.- For functions relating to communication and works.

(5) Taxation and Finance Committee.—For functions relating to taxation and finance.

(2) In addition to the five Functional Committees referred to in sub-section (1), a Gram Sabha may, with the approval of the prescribed authority, constitute one or more of such committees for any other matter not specified in the said sub-section.

(3) A Functional Committee shall consist of 15 members excluding members co-opted under this sub-section, if any, and shall be constituted by the Gram Sabha from amongst its members in such manner as may be prescribed :

Provided that if the functional committee so constituted does not include a woman, the committee shall co-opt a woman who is a member of the Gram Sabha and is qualified to be elected a member of the committee :

Provided further that if the functional committee so constituted does not include a member of the scheduled castes or scheduled tribes, the committee shall co-opt a person belonging to such caste or tribe, who is a member of the Gram Sabha and is qualified to be elected a member of the committee.

(4) Every Functional Committee of a class II Gram Sabha shall elect from amongst its members, a Convener and a Deputy Convener in such manner as may be prescribed.

(5) Every Functional Committe of a class III Gram Sabha shall elect from amongst its members, a Convener.

(6) No person shall be a member of more than two **Func**tional Committees : Provided that a person may with the permission of the prescribed authority be a co-opted member of more than two Functional Committees.

(7) The procedure for the conduct of business of the Functional Committees shall be such as may be prescribed.

(9) The Cham Panchayat may at any time withdraw the delegation or assignment of powers, duties or functions made under sub-section (1).]

- (i) Conveners and Deputy Conveners of Functional Committee elected under sub-section (4) of section 19;
- (ii) Patel of the village in which the headquarter of the Gram Panchayat is situate ;
- (iii) member co-opted or appointed, if any, under subsection (2).

(2) (i) If the Conveners and Deputy Conveners do not include a woman or a member of Scheduled Castes or Scheduled Tribes, the Cam Panchayat shall co-opt a woman or a member of such castes or tribes, who is a member of the Gram Sabha and is qualified for being a member of Gram Panchayat, to be a member of the Gram Panchayat ;

(ii) if there are one or move Co-operative Societies in the Gram Sabha area, and the Convener and Deputy Conveners do not already include a Chairman of any such Co-operative Society, the Collector shall appoint the Chairman of any of such Cocperative Societies, who is a member of the Gram Sabha and is qualified for being a member of the Gram Panchayat, to be a member of the Gram Panchayat.]

ronstitution of [21. (1) Every Gram Panchayat Class III shall be Fram Panchayat composed of—

- (i) Conveners elected under sub-section (5) of section 15;

- (e) has been dismissed from the service of the Government or any local authority for corruption or disloyalty to the State, unless a period of five years has elapsed since his dismissal; or
- (f) has directly or indirectly any share or interest in any contract with, by or on behalf of the Panchayat, while owning such share or interest; or
- (h) is employed as paid legal practitioner on behalf of the Gram Panchayat; or
- (i) is suffering from a variety of leprosy which is infectious; or [is a deaf, mute or a leper; or]
- (j) [fails to pay tax or fee due to Gram Panchayat within three months from the date on which the amount of such tax or fee is required to be paid under the provisions of this Act; or]
- (j) has not paid all taxes due by him to the Gram Panchayat at the end of the financial year immediately preceding that in which the election is held or co-option or appointment is made in spite of a demand notice of not less than thirty days made therefor; or
- [(k) is a servant of the Government or of any local authority; or]

(2) If a [member of a Functional Committee or a] Panch or a Sarpanch or an Upsarpanch of a Gram [Sabha] Panchayat having been elected, appointed or co-opted—

- (a) subsequently becomes subject to any of the disqualifications mentioned in sub-section (1) and such disqualification is not removable or being removable is not removed;
- (b) accepts employment as legal practitioner against the Gram Panchayat;
- (c) absents himself for more than four consecutive months from the meetings of the [Functional Committee or] Gram Panchayat unless leave not exceeding six months, so to absent himself, has been granted by the [Functional Committee or] Gram Panchayat;
- (d) absents himself from three consecutive meetings of the [Functional Committee or] Gram Panchayat or does not attend half the number of meetings held during the period of six months without the leave of the [Functional Committee or the] Gram Panchayat, [as the case may be];
- (e) fails to pay any arrears of any kind due by him to the Gram Panchayat in spite of a demand notice of not less than thirty days made therefor;

he shall subject to the provisions of sub-section (3), cease to be [a member or] a Panch or Sarpanch or Upsarpanch and his office shall become vacant :

Provided that where an application is made by [a member to the functional committee or by] a Panch, [a] Sarpanch or an Upsarpanch to the Gram Panchayat for leave to absent himself under clause (c) or clause (d) and [the Functional Committee or] the Gram Panchayat, [as the case may be] fails to inform the applicant of its decision on the application within a period of one month from the date of the receipt of the application, the leave applied for shall be deemed to have been granted by [the Functional Committee or] the Gram Panchayat, [as the case may be.]

(3) In every case, the authority competent to decide whether a vacancy has occured under sub-section (2) shall be the Collector, [The Collector] who may give his decision either on an application made to him by any person, or on his own motion. Until the Collector decides that the vacancy has arisen, the person shall not cease to be [a member] a Panch, Sarpanch or an Upsarpanch, as the case may be :

Provided that no order shall be passed under this sub-section by the Collector against any [member], Panch, Sarpanch or an Upsarpanch without giving him a reasonable opportunity of being heard.

(4) Any person aggrieved by the decision of the Collector under sub-section (3) may within a period of 30 days from the date of such decision, appeal to the Commissioner and the orders of the Commissioner in such appeal shall be final.

Explanation.—For removal of doubt it is hereby declared that a person ceasing to be a Sarpanch or Up-Sarpanch under this Section shall cease to be a Panch also.

Terms of office of 28. (1) The [members of a Functional Committee and Panchas [and Members of Functional Committee.] Panchas of a Gram Panchayat shall, save as otherwise provided in this Act, enter upon their [respective] offices with effect from the date of the first meeting of the Gram Panchayat fixed under sub-section (2) of section 28-A and hold office for a term of five years:

> Provided that the term of office of the outgoing [member or] Panch shall be deemed to extend to, and expire on the day preceding the date of the first meeting of the succeeding Gram Panchayat under sub-section (2) of section 28-A.

Provided further that the State Government may, by notification, extend the term from time to time for  $\varepsilon$  total period not exceeding one year in the aggregate.

[(2) The first meeting of the Gram Panchayat shall be held on the day fixed by the prescribed authority within four weeks from the date on which the election, appointment and co-option is notified under section 29.]

(2) If the Gram Panchayat fails to elect a Sarpanch or an Up-Sarpanch in accordance with this section, the Collector may, by order, direct the Gram Panchayat to elect the Sarpanch or the Up-Sarpanch within the period specified therein and on failure of the Gram Panchayat to do so, appoint any person eligible under sub-section (1) to fill the vacancy.

(3) The State Government may make rules for regulating the mode and time of election or appointment of the Sarpanch and the Up-Sarpanch.

30-A. (1) The term of office of the Sarpanch and Up-Term of Office of Sarpanch shall be co-terminus with the term of office of the Sarpanch and Up-Panchas of the Gram Panchayat.

(2) After the expiry of the term of his office, the Sarpanch shall continue to carry on the current duties of his office until such time as the election or appointment of his successor is notified.

(3) (a) As soon as may be after the election or appointment of a new Sarpanch is notified, the outgoing Sarpanch shall hand over to him the charge of office.

(b) If the outgoing Sarpanch fails or refuses to hand over charge of his office as required under clause (a), the prescribed authority may by order in writing direct the outgoing Sarpanch to hand over forthwith charge of his office and all papers and property in his possession as such Sarpanch, to the new Sarpanch. (c) If an outgoing Sarpanch to whom a direction has been issued under clause (b), fails to comply with the direction, he shall on conviction be punished with fine which may extend to one hundred rupees and shall be ejected forcibly, if necessary, from the office by such officer as may be empowered by the prescribed authority in this behalf.

(1) The Collector may suspend from office any Up-sar-Sarpanch or Up-Sarpanch against whom any criminal proceedings under Chapter V-A, VI, IX, IX-A, XXII and XVII and sections 302 to 305, 307, 312 to 318, 354 to 366-B, 373 to 377, 390 to 402 and 409 of the Indian Penal Code, 1860 (XLV of 1860) have been instituted or who has been detained in a prison during trial under the provisions of any law for the time being in force.

(2) During the suspension of a Sarpanch under subsection (1), the current duties of his office shall be performed by the Up-Sarpanch and in the event of both the Sarpanch and Up-Sarpanch being suspended, the prescribed authority shall nominate one of the panchas who shall perform all the duties and exercise all the powers of the Sarpanch and Up-Sarpanch during the period for which such suspension continues.

(2) A person who has been removed under sub-section (1) shall forthwith cease to be a member of any other Panchayat of which he is a member.

33. In the event of the death, resignation or disquali-Filling up of fication of a Sarpanch or an Up-Sarpanch, [a member of a casual vacancies. Functional Committee] or a Panch of a Gram Panchayat, or on his becoming incapable of acting before the expiry of his term of office, a casual vacancy shall be deemed to have occurred in such office and such vacancy shall be filled, as soon as may be, by the election, co-option or appointment, as the case may be, of a person thereto as a Sarpanch, an Up-Sarpanch, [a Member of a Functional Committee] or a Panch of a Gram Panchayat, who shall take office forthwith and shall hold such office for the unexpired term of his predecessor:

Provided that no casual vacancy except that of the office of Sarpanch shall be filled which occurs within a period of four months preceding the date on which the term of office of the person concerned expires.

#### II.—Conduct of Business

34. Subject to provisions of this Act, the procedure at a Procedure at meeting of the Gram Sabha [Functional Committee] and meeting. Gram Panchayat shall be such as may be prescribed.

35. (1) A Gram Panchayat shall meet for the transaction Meeting of Gram of business at least once in every month at the office of the Panchayat. Gram Panchayat and at such time as the Sarpanch may determine. In special circumstances the meetings of any Gram Panchayat may be held at any other public place within its jurisdiction.

(2) The Sarpanch may, whenever he thinks fit, and shall, upon a written request of not less than one half of the total number of Panchas call a special meeting.

(3) Notice of every meeting specifying the time and place thereof and the business to be transacted thereat shall be despatched to every member and exhibited at the office of the Gram Panchayat seven clear days before an ordinary meeting and three clear days before a special meeting.

(4) The quorum for a meeting of the Gram Panchayat shall be one half of the total number of members. If the quorum is not present at a meeting, the presiding authority shall adjourn the meeting to such time on the following day or some future date as it may fix. A notice of the meeting so fixed shall be posted in the office of the Gram Panchayat. The business, which could not be considered at the meeting so postponed for want of quorum shall be brought before and disposed of, at the meeting sc fixed or at any subsequent adjourned meeting whether there is quorum present or not; provided that not less than onefifth of the total number of Panchas are present.

(5) At every meeting of Gram Panchayat the Sarpanch and in his absence the Upsarpanch shall preside and in the absence of both, the Panchas present shall choose one from among themselves to be the Chairman for the meeting.

(6) All questions shall, unless otherwise specially provided, be decided by a majority of votes of the members present and voting. The Sarpanch, Upsarpanch, or Chairman as the case may be, unless he refrains from voting shall give his vote before declaring the number of votes for and against the question and in case of equality of votes, he shall give his casting vote.

(7) No Panch shall vote on, and take part in the discussion  $\alpha f$  any question coming up for consideration at  $\alpha$  meeting of a Gram Panchayat, if the question is one in which he has any direct or indirect pecuniary interest, other than an interest as a member of public.

(8) If it appears to any Panch present at a meeting that the person presiding at the meeting has any such pecuniary interest in any matter before the meeting for discussion as is referred to in sub-section (7) and a motion brought by him to that effect is carried, such person shall not preside over such meeting during the discussion and the meeting shall be presided over by any other person who would have presided, had the person so presiding been absent.

[36. No resolution of Panchayat shall be modified or cancelled within three months after passing thereof, except by resolution passed by not less than two-third of the total number of members at an ordinary or special meeting, notice whereof shall have been given fulfilling the requirements of sub-section (3) of section 35 and setting forth fully the resolution which it is proposed to modify or cancel at such meeting and the motion or proposition for the modification or cancellation of such resolution.]

Reconsideration of 36. No subject once finally disposed of by Gram questions disposed Panchayat shall be reconsidered by it within six months of by Gram Panchaunless the recorded consent of not less than three-fourth of its Panchas has been obtained thereto, or unless the prescribed authority has directed its reconsideration.

37. (1) Minutes shall be kept of the names of the members and of the Government officers, if any, present and of the proceedings at each meeting of the Gram Sabha, [Functional Committee,] Gram Panchayat or any of its committees and if any member present at the meeting so desires, of the

names of the members voting, respectively for or against any resolution, in a book to be provided for the purpose, which shall be signed as soon as practicable by the Sarpanch. Upsarpanch or Chairman of such meeting and shall, at all reasonable times, be open to inspection free of charge by any [member of a Functional Committee or] Panch or by any person entitled to vote at the elections to the Gram Panchavat.

(2) The minutes shall be in Hindi written in Devnagri [character] script.

"(3) A copy of the minutes shall, within fifteen days, be sent to the prescribed authority."

38. Any Panch may call the attention of the Sarpanch Interpellations to any neglect in the execution of the Gram Panchayat and resolutions. work, to any waste or misapplication of Gram Panchayat funds or property or to the needs of any locality within the Gram Sabha area, and may make such suggestions as may appear desirable.

#### **III.**—Subordinate Agencies

[(1) A Gram Panchayat Class I shall from among Appointment 39. of its members appoint the following sub-committees for the (sub-committee) purpose of exercising such powers, discharging such duties and performing such functions as may be delegated or asfunctional committees. signed to them by the Gram Panchayat :-

- (a) Agriculture Sub-committee.—For functions relating to agriculture, animal husbandry, minor irrigation, compost manuring, seed distribution and other matters connected with development of agriculture and live stock.
- (b) Industries and Co-operation Sub-committee.-For functions relating to co-operation, small saving, cottage industries, rural housing, statistics and other allied matters.
- (c) Education and Social Welfare Sub-committee.-For functions relating to education including social education, health and sanitation including rural water-supply and drainage, social welfare, women welfare, relief of distress caused by floods, draught, earthquake, scarcity, locust, swarms and other such emergencies.
- (d) Communication and Works Sub-committee For functions relating to communication and works.
  - (e) Taxation and Finance Sub-committee.—For functions relating to taxation and finance.)

(1) Every Gram Panchayat shall from amongst its members or members of the Gram Sabha constitute the mines. following Functional Committees for the purpose of exercising such powers, discharging such duties and performing such functions as may be prescribed :----

(a) Agriculture Functional Committee.—For agriculture, animal husbandry, compost manuring,

seed distribution and other matters connected with development of agriculture and live-stock.

- (b) Educational Functional Committee.—For education including social education.
- (c) Social welfare Functional Committee.—For social welfare, women and child welfare, removal of untouchability, relief of distress caused by floods, draught, earthquake, hailstorm, scarcity, locust swarms and other such emergencies, health and sanitation.
- (d) Taxation and Finance Functional Committee.— For planning, budget, account, taxation and other financial matters.
- (e) Communication and Works Functional Committee.—For communication, minor irrigation, rural housing, rural water supply, drainage and other public works.
- (f) Co-operation and Industries Functional Committee.—For co-operation, thuift and small savings, cottage and village industries, markets and statistics and other matters ancillary thereto.
- (g) General Functional Committee.—For local pilgrimages, fairs and melas, cattle pounds and other miscellaneous works."

(2) In addition to the [Five] Seven [Sub-committees] Functional Committees referred to in sub-section (1), a Gram Panchayat may with the approval of the prescribed authority, appoint one or more such [Sub-committees] Functional Committees for any other matter not specified in the said sub-section.

[(3) A sub-committee shall consist of not more than 5 and less than 3 members and shall be constituted in the manner prescribed.]

(3) A Functional Committee shall consist of seven members and shall be constituted in the manner prescribed:

Provided that the members of Social Welfare Functional Committee shall include a woman.

(4) No [Panch] person shall be a member of more than [two sub-committees] three functional committees.

(5) The procedure for the conduct of business of a [subcommittee] Functional Committee appointed under this section shall be such as may be prescribed.

[(6) The Gram Panchayat may at any time for reasons to be recorded in writing withdraw the delegation of assignment of powers, duties or functions made under sub-section (1).] (6) The provisions of sections 24, 27, 31, 32, 33, 316, 320, 322, 329, 330, 332, 335, 338, 339, 343 and 372 shall apply in case of a member of a Functional Committee who is not a Panch of Gram Panchayat, as they apply in the case of a Panch of a Gram Panchayat.

40. (1) The Sarpanch shall be directly responsible for car-Powers and dutie rying out the resolutions of the Gram Panchay It, passed by it of Sarpanch and for the purpose of carrying out the provisions of the Act and Up-sarpanch. shall exercise such powers and perform such duties of the Gram Panchayat as may be prescribed and in the absence of the Sarpanch, the powers and duties of the Sarpanch shall, subject to such conditions and restrictions as may be prescribed, be exercised and performed by the Up-sarpanch.

(2) Subject to the provisions of this Act and the rules made thereunder— $\rightarrow$ 

(i) the Sarpanch shall—

- (a) preside over and regulate the meetings of the Gram Sabha and the Gram Panchayat;
- (b) keep the records and registers of the Gram Sabha and Gram Panchayat in his custody;
- (c) exercise supervision and control over the acts done and action taken by all the servants of the Gram Panchayat;
- (d) operate on the Gram Panchayat Fund including authorisation of payment, issue of cheques and refunds;
- (e) issue receipts under his signature for sums of money received by him on behalf of the Gram Panchayat;
- (f) be responsible for the safe custody of the Gram Panchayat Fund;
- (g) cause to be prepared all statements and reports required by or under this Act;
- (h) exercise such other powers and discharge such other functions as may be conferred or imposed upon him by this Act or rules made thereunder;
- (ii) the Up-Sarpanch shall—
  - (a) in the absence of the Sarpanch preside over and regulate the meetings of the gram Sabha and the Gram Panchayat;
  - (b) exercise such of the powers and perform such of the duties of the Sarpanch as the Sarpanch may, from time to time, delegate in writing to him;
  - (c) pending the election of the Sarpanch or in case the Sarpanch has been continuously absent from the village for more than fifteen days or is incapacitated, exercise the powers and perform the duties of the Sarpanch.

41. (1) Subject to such rules as may be prescribed, a Gram Village Com-Panchayat may establish a Village Committee for any village mittee. other than the village in which the headquarters of the Gran. Panchayat under its jurisdiction is located, which shall consist of—

- (a) all the elected Panchas of the village, [in the case of a Gram Panchayat, Class 1 and all the members of Functional Committees elected from the village in the case of Gram Panchayat, Class II or Class III];
  - (b) such members not exceeding four to be nominated by the concerning Gram Panchayat, who—
    - (1) reside in the village area; and
    - (ii) have special knowledge or practical experience in respect of agriculture, co-operation or constructive work for village uplift.

(2) Every Village Committee shall have a Chairman nominated by the Gram Panchayat out of the elected [members or] Panchas of the village.

(3) Subject to the provisions of sub-sections (1) and (2) the constitution, term of office, duties and procedure and powers to be exercised by such Village Committees shall be such as may be prescribed.

Joint Committees 42. (1) A Gram Panchayat may, from time to time, join of two or more with any other Gram Panchayat, Janapada Panchayat, Zila Panchayat or any other local authority or with more than one such authorities,—

- (a) in appointing out of their respective bodies, a joint committee for any purpose in which they are jointly interested and in appointing a Chairman of such Committee; and
- (b) in delegating to any such joint committee power to frame terms binding on each such bcdy as to the construction and future maintenance of any joint work and any power which might be exercised by either or any of such bodies; [and]
- [(c) in framing and modifying rules for regulating the proceedings of any such committee and the conduct of correspondence relating to the purpose for which the committee is appointed.]

(2) If any dispute arises between local authorities acting under this section, the decision thereon of the State Government, or of such officer as it may authorise in this behalf, shall be final:

Provided that, where one of the local authorities is a Cantonment Authority, the decision of the State Government or of the Officer, shall be subject to the concurrence of the Central Government final:

# CHAPTER IV.—FUNCTIONS OF GRAM PANCHAYAT

Obligatory fune 43. - (a) sanitation, conservancy and prevention and abatement of nuisance;
- (b) construction, repair and maintenance of public wells, ponds and tanks and supply of water for domestic use;
- (c) construction and maintenance of sources of water for bathing, washing and for drinking by cattle and to maintain its purity;
- (d) development of agriculture;
- (e) construction and maintenance of public streets, latrines, drains, Gram Panchayat roads, culverts, bridges, etc. ;
- (f) lighting of village streets and other public places;
- (g) promotion of cottage industry;
- (h) promotion of co-operation;
- (i) (1) regulating places for disposal of dead bodies, carcasses and other offensive matters;
- (2) disposal of unclaimed corpses and carcasses [and unclaimed cattle];
- (j) cleansing of public roads, drains, bunds, tanks and wells and other public places or works;
- (k) removing of obstructions and projections in public streets or places and in sites not being private property, which are open to the enjoyment of public, whether such sites are vested in the Gram Panchayat or belong to Government;
- (1) management of cattle pounds and maintenance of records relating to cattle;
- (m) improvement of cattle and their breeding and the general care of the live-stock;
- (n) earmarking places for dumping refuse;
- (o) preparation of compost manure;
- (p) construction and maintenance of minor irrigation works;
- (q) registration of births, deaths and marriages;
- (r) maintenance of Gram Panchayat property;
- (s) help in the prevention of contagious diseases;
- (t) help in inoculation and vaccination and enforcement of other preventive measures prescribed by Public Health and Veterinary Departments;
- (u) prevention and removal of encroachment on public streets, public places and all other properties vested in the Gram Panchayat;
- (v) (1) extinguishing fire and help in the safety of property during outbreak of such fires;

## **REPORT OF THE SELECT COMMITTEE**

I, the Chairman of the Select Committee to which the Madhya Pradesh Panchayat Bill, 1960\* was referred, having been authorised to submit the report on their behalf, present this Report with the Bill as amended by the Select Committee annexed thereto.

2. The Bill was introduced in the Vidhan Sabha on the 7th April, 1960. The motion for reference of the Bill to a Select Committee was moved by Shri Ganesh Ram Anant, Minister, Social Welfare on the same day, was discussed in the House on the 7th and 8th April, 1960 and was adopted on the 8th April, 1960

3. The Committee held 13 sittings in all.

4. The first sitting of the Committee was held on the 29th May 1960 to draw up a programme of work. The Committee at this sitting decided to issue a press communique inviting suggestions or views on the Bill from persons or bodies desirous of doing so. Accordingly a Press communique was issued on the 31st May, 1960 inviting suggestions or views on the Bill on or before the 1st July 1960.

5. As a result of this step, eleven memoranda were received from various persons and bodies whose names are mentioned in Appendix I.

6. The Committee at their sittings held on the 18th, 19th and 20th July, 1960, had a general review of the provisions of the Bill.

7. The Committee considered the Bill clause by clause at their sittings held on the 6th, 7th and 8th September, 2nd, 3rd, 4th, 16th and 17th December, 1960, and 21st and 22nd January, 1961. The Committee at their sitting held on the 22nd January, 1961, authorised the Chairman to present the Report on behalf of the Committee.

8. The report of the Committee was to be presented to the House by the end of October, 1960 Session. The Committee were granted extension of time on the 4th October, 1960 upto first day of this Session.

9. The observations of the Committee with regard to the principal changes proposed in the Bill are detailed in the succeeding praragraphs.

10. Clauses 3 to 9-

- (gg) arrangement and distribution of improved seeds;
- (hh) promotion of social education;
- (ii) organising Village Volunteer Force;
- (jj) collection and maintenance of statistics;
- (kk) regulation of sale and preservation of meat;
  - (II) maintenance of public buildings, ancient and historical monuments other than those declared by or under law made by Parliament to be of national importance, grazing lands and forest lands vesting in or under the control of the Gram Panchayat;
- (mm) organising voluntary labour for community work;
  - (nn) assistance in the implementation of land reforms scheme;
  - (00) making arrangements for co-operative management of lands and other resources in the village, and organisation of collective farming, credit societies and multi-purpose Co-operative Societies;
  - (pp) maintenance of maternity home.

(2) In addition to the functions specified in sub-section (1), a Gram Panchayat shall—

- (i) perform such other duties and functions as may be entrusted to it under any other law for the time being in force; and
- (ii) carry out the directions or orders given or issued by the Government, the Collector or any other officer authorised by the Government in this behalf with respect to the measures for amelioration of the condition of the Scheduled Castes and the

Scheduled Tribes and other backward classes and in particular in regard to the removal of untouchability.

44. (1) Subject to the general control of the Government Discretionary and the Janapada and Zila Panchayats it shall be competent functions of Gram for a Gram Panchayat to make reasonable provision within the Gram Sabha area in regard to the following matters, namely :--

- (a) planting and nursing of trees on road-sides and other places;
- (b) construction and maintenance of Dharamshalas, Sarais, rest-houses, public ghats and camping grounds;
- (c) construction and maintenance of play grounds, clubs, gymnasiums, libraries, reading rooms, parks, etc.;
- (d) construction and maintenance of slaughter-houses;
- (e) relief of distress, destitutes and sick;
- (f) running of Community Centre;
- (g) reclaiming unhealthy localities;
- (h) looking after public health and safety ;
- (i) management and control of Hats, public ferries, agricultural and industrial shows and public festivals;
- (j) promotion of co-operative farming:
- (k) establishment of granaries;
- (l) regulating the keeping of pigs within the limits of Panchayat;
- (m) removal of weeds;
- (n) helping in the preparation of National Register;
- (o) promotion of social and moral welfare including prohibition, the removal of untouchability, the eradication of corruption and measures to discourage litigation and encourage arbitration;
- (p) construction and maintenance of houses for the conservancy staff of the Gram Panchayat.

(2) A Gram Panchayat may also make provision for carrying out within the Gram Sabha area any other work or measure which is likely to promote the health, safety, education, comfort, convenience, social or economic, or cultural wellbeing of the inhabitants of the Gram Sabha area.

(3) A Gram Panchayat may, by resolution passed at its meeting and supported by two-thirds of the total number of Panchas, make provision for any public reception, ceremony, or entertainment within the Gram Panchayat area or may make contribution towards an annual gathering or such other gathering of Gram Panchayats in the District or the State:

Provided that except with the previous sanction in writing of the prescribed authority, the Gram Panchayat shall not incur expenditure exceeding [rupees ten] twenty-five rupees on any such reception, ceremony, entertainment or gathering. Gram Panchayat not to be respon-sible for functions in certain cases.

45. Where the Government undertakes to perform any of the functions enumerated in sections 43 and 44, nothing in those sections shall be deemed to impose any duty or confer any power on a Gram Panchayat for performance of such function, unless the Government by general or special order entrusts such duty or delegates such power in respect thereof to the Gram Panchavat.

Provided further that where collection of land revenue and other dues is entrusted to a Gram Panchayat under clause (c) the State Government shall pay to the Gram Panchayat a commission at such rate as may be prescribed.

(2) The Gram Panchayat shall subject to such conditions as may be specified by the State Government have the power to do all acts necessary and incidental to the carrying out of the functions transferred, made over or entrusted to it under this section.

52. The Gram Panchayat shall have control of all village Power of Gram roads and bridges thereon, cart tracks, drains, tanks, wells and Panchayats as to other public places in the Gram Sabha area, vested in the Gram road, bridges, etc. other public places in the Gram Sabha area, vested in the Gram Panchayat under this Act or under any other law for the time being in force and may do all things necessary for the maintenance and repair thereof and may---

(1) No person shall erect any building or alter or add tion of buildings. to any existing building or reconstruct any building without the written permission of the Gram Panchayat and except in accordance with bye-laws made in this behalf under this Act. Such permission shall be presumed to have been granted if no refusal of such permission is communicated within [two months] thirty days of the receipt of the application.

> (2) Whenever any building is erected, altered, added to or reconstructed by any person without such permission or in any manner contrary to the byelaws made under subsection (1) or any conditions imposed by the permission granted, the Gram Panchayat may [whether any action taken or not against such person under section],-

- (a) direct that the building, alteration or addition be stopped ;
- (b) by written notice require, within a reasonable period to be specified therein, such building, alteration or addition to be altered or demolished as it may deem necessary for the promotion of public health or the prevention of danger to life or property; or
- (c) withdraw the permission.

(3) In the event of non-compliance with the terms of any notice under clause (b) of sub-section (2) within the period specified in the notice, it shall be lawful for the Gram Panchayat to take such action as may be necessary for the completion of the act thereby required to be done, and all expenses therein incurred by the Gram Panchayat shall be paid by such persons within such time as may be prescribed and in the event of his failure to do so within the aforesaid time shall be recoverable from him in the manner provided for the recovery of taxes under Chapter VII.

(4) An appeal shall lie to the prescribed authority from any order or direction or notice of the Gram Panchayat under sub-section (2) and the decision of the prescribed authority on such appeal shall be final.

(1) Notwithstanding anything contained in section 54. **Power of Govern**ment in regard to 53 Government may, in the interest of the general public and erection of build-after consulting the Gram Panchayat concerned, prohibit by ing. notification the erection of any building within a specified area within the jurisdiction of any Gram Panchayat except with permission granted by the Government or any Officer authorised by it in this behalf.

> (2) The grant of any permission under sub-section (1) may be subject to such conditions as may be fixed by the Govcrnment or by any officer as the Government may, by general cr special order, authorise in this behalf.

(3) Whoever erects any building contrary to provisions of sub-section (1) or the conditions imposed under sub-section (2) shall, on conviction, be punished with fine which may extend to one hundred rupees.

(4) The Government or the Officer authorised by it in this behalf, as the case may be, may demolish any building erected contrary to the provisions of sub-section (1) or in violation of the conditions imposed, under sub-section (2).

- (c) without written permission given to the owner or occupier of a building by the Gram Panchayat puts up, so as to project from any upper storey thereof, any verandah, balcony, room or other structure or thing in or over any public street or place or in or over or upon any open drain, gutter, sewer or aqueduct in such street or place, or contravenes any conditions subject to which any permission as aforesaid is given or the provisions of any byelaw made in relation to any such projection or cultivates or makes any unauthorised use of any grazing land, not being private property shall. on conviction, be punished with fine, which may

extend to fifty rupees, and with further fine which may extend to live rupees for every day on which such obstruction, deposit, projection, cultivation or unauthorised use continues after the date of first conviction for such offence.

(2) The Gram Panchayat shall have power to remove any such obstruction or encroachment and to remove any crop unanthorisedly cultivated on grazing land or any other land not being private property, and shall have the like power to remove any unauthorised obstruction or encroachment of the like nature in any open site not being private property, whether such site is vested in Gram Panchayat or not, provided that if the site be vested in the Government, the permission of the Collector or any officer authorised by him in this behalf, shall have first been obtained. The expenses of such removal shall be paid by the person who has caused the said obstruction or encroachment and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VII.

(3) The power under sub-section (2) may be exercised in respect of any obstruction, encroachment or projection referred to therein whether or not such obstruction, encroachment or projection has been made before or after the establishment of the Gram Sabha under this Act or before or after the property is vested in the Gram Panchayat,

(4) Whoever, not being duly authorised in this behalf, removes earth, sand or other material from, or makes any encroachment in or upon any open site which is not private property, shall on conviction be punished with fine which may extend to fifty rupees, and, in case of any encroachment, with further fine which may extend to five rupees for every day on which the encroachment continues after the date of first conviction.

(5) Nothing contained in this section shall prevent the Gram Panchayat from allowing any temporary occupation of, or erection in, any public street on occasions of festivals and ceremonies, or the piling of fuel in by-lanes and sites for not more than seven days, and in such manner as not to inconvenience the public or any individual or from allowing any temporary erection on, or putting projection over, or temporary occupation of any such public street or place for any other purpose in accordance with the byelaws made under this Act.

Powers to name ber buildings.

58. The Gram Panchayat may cause a name to be given streets and num- to any street and may also cause a number to be affixed to any building and in like manner may, from time to time, cause such name and number to be altered.

Removal of structures, trees, stc.

59. (1) If it appears at any time to the Gram Panchavat that any building or part thereof or any tree or branch of a tree is in a ruinous state or likely to fall or is in any other way dangerous to any person occupying, resorting to or passing by such building or the part thereof or the tree or branch of the tree, the Gram Panchayat may by written notice, require the owner or occupier of such building or tree, as the case may be,---

(a) to pull down, lop or cut down; or

(b) to secure; or(c) to remove; or(d) to repair;

such building or part of it or the tree or the branch of the tree, as the case may be, and to prevent all causes of danger therefrom.

(2) If it appears to the Gram Panchayat that the danger from a building or tree which is ruinous or about to fall is imminent, it may, before the period of notice expires, fence off, pull down, lop or cut down, secure or repair the said building or tree, as the case may be, or take such steps as may be required to arrest the danger.

(3) Any expenses incurred by the Gram Panchayat in this behalf shall be paid by the owner or occupier of the building or tree, as the case may be. On failure to pay, it shall be recovered as a tax under Chapter VII.

(4) No notice under sub-section (1) shall be issued without giving the owner or occupier, as the case may be, a reasonable opportunity of stating any objection, or adducing evidence, if any, and after being satisfied for reasons to be recorded in writing that the objection which is raised is invalid or insufficient.

60. (1) If it appears necessary to improve the sanitary Power as to condition of any area within its jurisdiction, or to check the sanitation, spread of any infective disease a Gram Panchayat may, by conservancy and written notice, require, within a reasonable period to be drainage. specified therein—

- (a) the owner or occupier of any hut or the owner of any privy to remove such hut or privy either wholly or in part;
- (b) the owner or occupier of any building to construct private drain therefor or to alter or to remove private drains thereof;
- (c) the owner or occupier of any land or building which contains a well, pool, ditch, pit, pond, tank or any place containing or used for the collection of any drainage, filth or stagnant water, which is injurious to health or offensive to the neighbourhood or is otherwise a source of nuisance, to cause the same to be filled up, cleansed or deepened or to cause the water to be removed therefrom or drained of or to take such other action therewith, as may be deemed necessary by the Gram Panchayat;
- (d) the owner or occupier of any land or building which needs to be cleansed or disinfected or cleansed and disinfected, to cause the same to be cleansed or disinfected or cleansed and disinfected to the satisfaction of the Gram Panchayat;
- (e) the owner or occupier of any land overgrown with vegetation, undergrowth, pricklypear, or jungle, which is in any manner injurious to health or dangerous to the public or offensive to the

neighbourhood or an impediment to efficient ventilation, to cause it to be cleared of the vegitation, undergrowth, pricklypear or jungle.

(2) If any work required by a notice under sub-section (1) is not executed within the period specified in the notice, the Gram Panchayat may itself cause such work to be carried out and may recover the cost of such work or part thereof from the owner or occupier referred to in sub-section (1) in the manner provided for the recovery of a tax under Chapter VII.

61. Subject to rules made under this Act a Gram Panchayat may prohibit the slaughter for sale of animals at any place within the Gram Panchayat area other than a place appointed for the purpose by the Gram Panchayat, and may by byelaws regulate the use of such places.

**Power for provid-** 62. (1) For providing the Gram Sabha area or any ing adequate wa- part thereof with water-supply pure and sufficient for public and private purposes, the Gram Panchayat may—

- (a) construct, repair and maintain tanks or wells and clear streams or water-courses;
- (b) purchase or acquire by gift or otherwise any tank, well, stream or water-course or any right to take or convey water within or without the area under its control;
- (c) with the consent of the owner thereof, utilise, cleanse or repair any tank, well, stream or water-course or provide facilities for obtaining water therefrom;
- (d) contract with any person for supply of water;
- (e) with the consent of the owner, set aside any private spring, tank, well or other place for the purposes of drinking, bathing or for washing clothes or animals or for any other purpose calculated to promote the health, cleanliness, comfort or convenience of the inhabitants;
- (f) do any other acts necessary for carrying out the purposes of this section.

(2) The Gram Panchayat may, by order published at such conspicuous places as it may think fit, with a view to give it publicity, set apart for the supply of water to the public or drinking or culinary purposes, any tank, well, stream, or water-course in respect of which action has been taken under clause (a) or (b) or (c) of sub-section (1) subject to any rights which the owner referred to in clause (c) of sub-section (1) may retain with the consent of the Gram Panchayat.

(3) The Gram Panchayat may, by order published at such conspicuous place as it may think fit, with a view to give it publicity, prohibit :---

- (a) bathing, washing of clothes and animals or other acts likely to pollute the water of any tank, well, stream or water-course set apart for drinking or culinary purposes under sub-section (2); and
- (b) the use of any source of water-supply for drinking or culinary purposes or for the washing of the clothes during epidemic.

Regulation of slaughter of animal.

63. The Gram Panchayat or any person authorised by it Powers and duties in this behalf may at any time by written notice require that with regard to the owner or any person who has control over any well, stream, sources of waterchannel, tank, or other source of water-supply shall, whether it is private property or not—

(a) if the water is used for drinking-

- (i) keep and maintain any such source of watersupply, other than a stream, in good repair; or
- (ii) within a reasonable time to be specified in the notice, cleanse any such source of water-supply from silt, refuse and decaying vegetation; or
- (iii) in such manner as the Gram Panchayat directs, protect any such source of water-supply from pollution by surface drainage; or
- (iv) desist from using and from permitting others to use for drinking purposes any such source of water-supply, which not being a stream in its natural flow is, in the opinion of the Gram Panchayat, unfit for drinking; or
- (v) if, notwithstanding any such notice under subclause (iw), such use continues and cannot in the opinion of the Gram Panchayat be otherwise prevented, close, either temporarily or permanently, or fill up or enclose or fence in such manner as the Gram Panchayat considers sufficient to prevent such use, such source of supply; or
- (vi) drain off or otherwise remove from any such source of water-supply, or from any land or premises or receptacle or reservoir attached or adjacent thereto any stagnant water which the Gram Panchayat considers is injurious to health or offensive to the neighbourhood;
- (b) within twenty-four hours of such notice, repair, protect or enclose in such manner as the Gram Panchayat may direct or approve, any such source of water-supply whether used for drinking purposes or not, other than a stream in its natural flow, if for want of sufficient repair, protection or enclosure, such a source of water-supply is in the opinion of the Gram Panchayat, dangerous to the health or safety of the public or of any person having occasion to use or to pass by or approrch the same.

64. If the owner or the person having control as aforesaid Ramedy on menfails or neglects to comply with any such requisition within the compliance with time required by or under the provisions of section 63, the directions insued. Gram Panchayat may, and if in the opinion of the Sarpanch to be recorded in writing immediate action is necessary to protect the health or safety of any person, shall at once, proceed to execu'e the work required by such notice, and all the expenses incurred thereon shall be paid by the owner of, or person having control over, such water-supply and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter VII: Provided that in the case of any well or private stream or any private channel, tank or other source of water-supply, the water of which is used by the public or by any section of the public as of right, the expenses incurred by such owner or person having control may, if the Gram Panchayat so directs, be paid [from the portion of] in whole or in part from the Gram Panchayat Fund.

Penalty for using water for certain purposes. 65. Whoever-

- (a) bathes in or defiles the water in any place set apart for drinking purposes by the Gram Panchayat or, in the case of private property, by the owner thereof;
- (b) deposits any offensive or deleterious matter in the dry bed of any place set apart as aforesaid for drinking purposes; or
- (c) washes clothing in any place set apart as aforesaid for drinking [or bathing]; or
- (d) washes any animal or any cooking utensils or wood, skins or other foul or offensive substance or deposits any offensive or deleterious matter in any place set apart as aforesaid for drinking purposes or for bathing or for washing clothes; or
- (e) allows the water from a sink, sewer, drain, engine or boiler, or any other offensive matter belonging to him or flowing from any building or land belonging to or occupied by him, to pass into any place set apart as aforesaid for drinking purposes or for bathing or for washing clothes; or
- (f) uses water from any source in contravention of the provisions of section 62;

shall on conviction, be punished with fine which may extend to fifty rupees and if the offence be a continuing one, with further fine which may extend to five rupees for every day during which the said offence is continued after the date of first conviction.

Abatement of nuisance from foul water. 66. When any pool, ditch, tank, well, hole or any waste or stagnant water, or any channel or receptacle of foul water or other offensive or injurious matter, whether the same be within any private enclosure or otherwise in the opinion of the Gram Panchayat is likely to prove injurious to the health of the inhabitants or offensive to the neighbourhood, the Gram Panchayat may, by written notice, require the owner of the same to cleanse, fill up, drain off, remove the same, or to take such measure as shall in its opinion be necessary to abate or remove the nuisance.

Power of Government to make rules regarding provision of water-supply,

67. The Government may make rules for conserving and preventing injury to sources and means of water-supply and appliances for the distribution of water whether within or without the Gram Sabha area and for regulating all matters connected with the supply and use of water, and the turning on or turning off and preventing the waste of water, and the construction, maintenance and control of Gram Panchavat waterworks, and pipes and fittings in connection with, whether it is the property of the Gram Panchavat or not. 68. (1) No person shall within the Gram Sabha area Regulation of set up, establish or use [continue or use] or allow to be setup established, [continued] or used, any place for the purpose of a market.

(2) The State Government may make rules to regulate the markets within the Gram Sabha area.

[69. A Gram Panchayat may, with the consent of Protection of owner or occupier of any land within the Gram Sabha area, undertake the protection of the crops standing on such land and recover the cost thereof from the owner or occupier thereof at such rates and in such manner as may be prescribed.)

70. (1) The Gram Panchayat may organise a village Village Volunteer volunteer force of able bodied males residing in the Gram Sabha Force. area between the age group of 18 to 50 under the command of suitable persons appointed by it for—

- (i) general watch and ward and protection of crops;
- (ii) meeting cases of emergency like fire, flood, breaking of an embankment or dam, outbreak of epidemic or any other natural calamity; and
- (iii) enlisting voluntary labour for carrying out works of public utility.
- (2) The Government may make rules for-
  - (a) meeting expenses of Village Volunteer Force;
  - (b) the training, discipline and good conduct of the members of the Village Volunteer Force;
  - (c) giving rewards to persons-
    - (i) who have given information of outbreak of fires and dacoites; or
    - (ii) who have rendered effective service to the force or such occasion;
  - (d) the speedy attendance of members of the force with necessary implements on the occasion of an alarm;
  - (e) sending the force to neighbouring villages outside Gram Sabha area for help in cases of emergency, if necessary;
  - (f) providing penalty for infringement of the rules by any member of the force;
  - (g) generally for the maintenance of the force in a state of efficiency.

(3) On the occasion of any such emergency, the Sarpanch or any person authorised by the Gram Panchayat, or the person in the immediate charge of the Village Volunteer Force may-

- (a) take such measures as may be necessary for the protection of life and property; and
- (b) call on the volunteer forces of neighbouring Gram Panchayats to render such assistance as may be necessary.

37

(4) The Sarpanch or any person authorised by the Gram Panchayat or the person in the immediate charge of the Village Volunteer Force or any member of the force shall not be held liable for damages on account of any act done by him in the bonafide belief that the doing of such act was necessary for the proper execution of his duties.

(5) In the case of any such emergency within the Gram Sabha area, the Sarpanch shall with as little delay as possible ascertain the facts as to the origin and cause of such emergency and shall make a report thereon to the prescribed authority.

(6) (a) A Gram Panchayat may also, by order in writing, call upon the members of the Village Volunteer Force to perform such labour on works of public utility which in the opinion of the Gram Panchayat are likely to benefit the village population and which the Gram Panchayat has undertaken to construct, maintain or repair.

(b) A person required to perform labour under clause (a) may have it performed by another person on his behalf or may commute such performance into a cash payment at such rates as may be determined by the Gram Panchayat.

[Certain sections The provisions of sections 53, 55, 56, 57, 59, 60, [71. to apply to Gram Panchayats, 61, 63 and 66 shall not apply to Gram Panchayats Class II Class II and Class and Class III unless the Government, by notification, applies III on notifica- all or any of such provisions to any or all Gram Panchayats of such class or classes.]

#### CHAPTER V.--GRAM PANCHAYAT FUND AND PROPERTY

Government may perty in Gram Panchayat,

72. (1) For the purposes of this Act, the State Government vest certain pro- may, by notification and subject to such conditions and restrictions, as it may think fit, to impose, vest in a Gram Panchayat open sites, vacant lands or grazing lands or public roads and streets, bridges, ditches, fences, wells, river beds, tanks, streams, lakes, nullahs, canals, trees or any other property in the Gram Sabha area vesting in the Government.

> (2) The State Government may resume any immovable property transferred to the Gram Panchayat under sub-section (1), without payment of any compensation other than the amount paid by the Gram Panchayat for such transfer and the market value at the date of resumption of any building or works subsequently erected or executed thereon by the Gram Panchayat:

> Provided that no compensation shall be payable in respect of buildings, structures or works constructed or erected in contravention of the terms of the transfer.

Transfer of im-73. No immovable property vested in or belonging to a movable property. Gram Panchayat shall be transferred by sale, gift, mortgage or exchange or by lease for a period exceeding three years, or otherwise except with the sanction of the State Government cr any officer authorised by it in this behalf.

74. Every contract made by or on behalf of a Gram Mode of executing Panchayat the value or amount of which exceeds fifty rupees contracts. shall be in writing and shall be signed by the Sarpanch and at least by one Panch.

75. A Gram Panchayat may, with the previous sanction of Power to comprothe prescribed authonity, compromise any suit instituted by or mise. against the Gram Panchayat or any claim or demand arising out of any contract entered into by the Gram Panchayat under this Act on such terms as it [shall] may deem fit.

76. (1) Every Gram Panchayat shall establish and maintain Gram Panchayat a fund called the Gram Panchayat Fund.

(2) The following shall form part of and be paid into the Gram Panchayat Fund, namely :---

- (a) the amount which may be allotted to the Gram Panchayat by the State Government;
- (b) the proceeds of any tax, cess, fee, toll, etc., imposed by the Gram Panchayat;
- (c) all sums received by compounding offences under this Act;
- (d) the sale proceeds of all dust, dirt, dung or refuse (including the dead bodies of animals) collected by the Gram Panchayat;
- (e) such portion of the rent or other proceeds of the property of the State Government as it may direct to be placed at the credit of the Gram Panchayat Fund;
- (f) sums contributed to the Gram Panchayat Fund by a Janapada Panchayat;
- (g) all sums received by way of loans from the Government or the Janapada Panchayat or by way of gift;
- (h) the income from or proceeds of any property vesting in the Gram Panchayat;
- such other sums as may be assigned to the Gram Panchayat Fund by special or general order of the State Government.

77. (1) Subject to the provision of this Act and the Application of rules made thereunder, all property vested in the Gram Pan-Gram Panchayat chayat under this Act, and the Gram Panchayat Fund shall Fund. be applied subject to the provisions and for the purposes of this Act, and the Fund shall be kept in such custody as may be prescribed.

(2) An amount allotted to the Gram Panchayat by the Government or any other person or local authority for any specific work or purpose shall be applied exclusively for such

work or purpose and in accordance with such instructions as the Government may either generally or specially issue in this behalf.

78. (1) The administration of the Gram Panchayat Fund Administration of Gram Panchayat shall, subject to the general control of the Janapada Panchayat, Fund. be in the hands of the Gram Panchavat.

> (2) All moneys at the credit of Gram Panchayat Fund shall be kept in the name of the Gram Panchayat in the nearest Government Treasury or Post Office Savings Bank or Co-operative Bank, and where there is no Government Treasury, Post Office Savings Bank or Co-operative Bank, then subject to such terms and conditions as may be prescribed, with a local banker or other person approved by the Government.

#### CHAPTER VI.-GRAM PANCHAYAT ESTABLISHMENT. BUDGET AND ACCOUNTS

#### I.-Establishment

Appointment Secretary.

79. (1) Every Gram Panchayat [Class I and every] of Gram Panchayat Class II or Class III] having an annual income exceeding five thousand rupees, shall have a Secretary who shall be a full time salaried officer of the Gram Panchayat.

> (2) A Gram Panchavat not falling under sub-section (1) shall have a part-time or full time Secretary who may be an honorary or salaried officer of the Gram Panchayat:

> Provided that two or more of such Gram Panchayats may have a common Secretary.

80. The Secretary of the Gram Panchayat shall be an exofficio Secretary of the Gram Sabha.

Gram Sabha. Appointment of

81. (1) Subject to the provisions of section 79 a Gram officers and ser- Panchayat may, with the previous sanction of the prescribed vants of Gram authority, appoint such other officers and servants as may be necessary for carrying out its functions and discharging its duties under this Act efficiently.

> (2) The duties of the Secretary and other officers and servants of the Gram Panchayat, their qualifications, method of recruitment, salaries, leave, allowances and other conditions of service including disciplinary matters shall be such as may be prescribed.

82. A Gram Panchayat may in accordance with the rules Establishment of Provident Fund. made under this Act-

- (a) establish and maintain a Provident Fund on behalf of its officers and servants; and
- (b) grant gratuity to any officer or servant subject to the previous approval of the prescribed authority.

- - '

83. (1) On a complaint being made by any person residing Enquiry into conwithin the Gram Sabha area that a vaccinator, Revenue Inspec- duct of certain tor, Patwari, Kotwar, Police Constable, Forest Guard or officiala. peon of any Government department has misconducted himself in his official capacity in the Gram Sabha area, the Gram Panchayat [may enquire into the matter and report the result of its enquiry] may collect and furnish the relevant information to the authority to whom the official is subordinate.

(2) The authority concerned shall enquire into [and report] the complaint in such manner and take such action thereon as it deems fit and shall inform the Gram Panchayat of the action taken.

(3) Nothing in sub-section (1) shall be construed as empowering the Gram Panchayat to summon the officials specified in the said sub-section or to exercise control, disciplinary or otherwise, over them.

#### II.-Budget and Accounts.

84. Accounts of receipt and expenditure of every Gram Annual estimates Panchayat shall be kept in such forms and in such manner as of income and expenditure. may be prescribed.

85. (1) Every Gram Panchayat shall prepare annually in Budget and such form and in such manner as may be prescribed, budget Accounts. estimate of its receipts and expenditure for the next financial year. The estimate shall be so prepared as to provide for a closing balance of not less than such amount as may be prescribed.

[(2) The Budget estimate prepared under sub-section (1) shall be placed before the Gram Sabha not less than three months in advance of the commencement of the financial year to which the budget estimate relates and the Gram Sabha shall consider the estimate and may approve it with or without modification:

Provided that no modification in the budget estimate shall be made so as to reduce the closing balance prescribed under sub-section (1).]

(2) The budget estimates prepared under sub-section (1) shall be placed before the Gram Sabha not less than seventy-five days in advance of the commencement of the p financial year to which they relate and the Gram Sabha shall consider he budget estimates and shall refer them back to the Gram Panchayat with recommendations, if any, within thirty days of its receipt.

(3) On receipt of the budget estimates from the Gram Sabha under sub-section (2), the Gram Panchayat shall consider the same and may approve the budget estimates with or without modifications before the commencement of the financial year to which they relate :

Provided that no modification in the budget estimate shall be made so as to reduce the closing balance prescribed under sub-section (1).

(4) If the budget estimates could not be finalised in accordance with the provisions of this section prior to the commencement of the financial year to which they relate, the budget estimates, prepared under sub-section (1) shall be deemed to be the budget estimates approved in accordance with the provisions of this section.

(5) A copy of the budget estimates as approved or deemed to be approved under this section shall be forwarded forthwith to the Janapada Panchayat and the prescribed authority.

(6) If it appears to the prescribed authority that the budget estimate, so approved or deemed to be approved is in any way contrary to the provisions of this Act or the rules made thereunder, it shall require the Gram Panchayat to modify it and the Gram Panchayat shall forthwith comply with such requisition.

86. Accounts of the receipts and expenditure of every Gram Annual accounts and Administra-Panchayat shall be made by the Secretary of the Gram Panchayat tion Report. or in his absence by such officer or servant thereof as may be authorised by the Gram Panchayat in this behalf, up to the last day of every financial year in such form as may be prescribed. The Secretary or such officer shall also prepare an annual report of the administration of the Gram Panchayat and shall place the accounts and the report for approval before the Gram Panchayat. The annual statement of such accounts together with the annual report as approved shall be sent to the Janapada Panchayat on or before such date and in such form as may be prescribed.

## CHAPTER VII.-TAXATION AND RECOVERY OF CLAIMS

Power to levy 87. (1) Every tenure-holder, tenant other than a sub-tenant and Government lessee shall be liable in respect of the land held by him within the Gram Sabha area to pay a cess to the Gram Panchayat for the purposes of this Act at the rate of ninteen Naye Paise per rupee or part thereof exceeding fifty Naye Paise on the land revenue or rent assessed or fixed on such land, whether or not such land revenue or rent or any portion thereof has been released, compounded for or redeemed or if the land is held rent free or at a reduced rent or on favourable conditions, on the rent fixed on such land.

> [(2) The State Government may, on a representation being made by the Gram Panchayat for reduction of rate of cess and on being satisfied that the financial position of the Gram Panchayat concerned justifies a reduction, sanction reduction in the rate of the cess to such extent. as it may deem fit, and such reduction shall take effect from such date as the State Government may specify.]

(3) The cess under this section shall be payable in such manner as may be prescribed.

Explanation.—In this section the expressions "tenure holder", "tenant", "sub-tenant", and "Government lessee", "land revenue" and "rent" shall have the meaning assigned to them in the Madhya Pradesh Land Revenue Code, 1959 (20 of 1959).

88. (1) Subject to the provisions of this Act and to such Other compulsory conditions and exceptions as may be prescribed, every Gram taxes. Panchayat shall impose the following taxes, namely :---

- (a) a tax on buildings;
- (b) [fees] a tax for cleansing private latrines payable by the owner or occupier of the houses to which the private latrines are attached when cleansing is done by the Gram Panchayat;
- (c) a lighting tax;
- [(d) a tax on cleansing of streets ;]
- (e) a tax on persons exercising any profession or art or carrying on any trade or calling within Gram Sabha area;
- (f) fees on persons exposing goods for sale in any market or place belonging to or under the control of the Gram Panchayat, or for the use of any building or structure therein;
- (g) fees on registration of animals sold in any market or place belonging to or under the control of the Gram Panchayat:

Provided that the tax under clause (a) shall not be leviable on the following buildings:—

- (i) building of capital value not exceeding one thousand rupees;
- Explanation.—In this clause "capital value" means the [cost of construction] present market value of the building inclusive of the price of land [at the time at which it was constructed.]
- (ii) building used exclusively for educational purposes excluding hostels;
- (iii) buildings used for charitable purposes;
- (iv) buildings used for public worship;
- (v) buildings belonging to the Union or State Government; and
- (vi) buildings belonging to the Gram Panchayat, Janapada Panchayat and Zila Panchayat.

(2) Notwithstanding anything contained in section 87 or clause (a) of sub-section (1), no person shall be liable to pay both the cess on land under section 87 and the tax on building under clause (a) and he shall be liable to pay the cess or the tax, whichever is higher.

Optional taxes.

89. [With the approval of the Zila Panchayat and subject to rule made under this Act.] Subject to rule made under this Act and with the previous approval of the Zila Panchayat a Gram Panchayat may by a resolution passed by the majority of two-third of its members, impose any of the following taxes, namely:—

- (a) tolls on vehicles and pack animals bringing goods for sale into the Gram Sabha area;
- (b) a tax payable by the owners of animals used for riding, driving, draught or burden or for dogs or pigs kept within the Gram Sabha area;
- (c) a tax on carts plying for hire, bicycles, rickshaws plyed in the Gram Sabha area;
- (d) fees for the use of Sarais, Dharamshalas, rest houses. slaughter houses and encamping grounds;
- (e) water rate where a regular water-supply system is maintained by the Gram Panchayat;
- (f) a drainage fee where the system of drainage has been introduced by the Gram Panchayat;
- (g) fees from persons practising the calling of buyer, broker, commission agents, weigher or measurer within the Gram Sabha area;
- (h) a fee provable by owners of vehicles other than motor vehicles where such vehicles are kept within Gram Sabha area:
- (i) a temporary tax for special work of public utility:
- (j) a general sanitary cess for the construction or the maintenance or both the construction and maintenance of public latrines and for the removal and disposal of refuse;
- (k) a fee on cart stands and tonga stands;
- (1) a fee for temporary erection on, or putting projection over, or temporary occupations of any public street or place;
- (m) a fee for grazing cattle on grazing lands vesting in the Gram Panchayat;
- (n) any other tax which the State Legislature has power to impose under the Constitution of India.

90. (1) The State Government may, by rules made under this Act, regulate the imposition, assessment and collection of taxes mentioned in sections 88 and 89 and matters ancillary

(2) No objection shall be taken to any assessment nor shall the liability of any person to be assessed or taxed be questioned ctherwise than in accordance with the provisions of this Act or of the rules made thereunder.

Appeal against 91. Any person aggrieved by the imposition of any cess, taxation. 91. Any person aggrieved by the imposition of any cess, tax, toll, fee or rate under this chapter may appeal to the prescribed authority in such manner and within such time as may be rescribed, and the decision of such authority shall be final.

Farming of 92. A Gram Panchayat may, by public auction or with market fees the previous sanction of the Collector by private contract, lease the collection of any fees imposed under clauses (f) and (g)

Power of State Government to regulate taxes. of sub-section (1) of section 88 and clauses (d), (k) and (m) of section 89:

Provided that the lessee shall give adequate security to the satisfaction of the Collector for the due fulfilment of the conditions of the lease.

93. (1) If, in the opinion of the Zila Panchayat the income Power of Zile of a Gram Panchayat is or is likely to be inadequate for the Panchayat in proper discharge of the duties imposed under this Act, the Zila matters of Panchayat may, by order in writing require the Gram Panchayat to take steps within six months of a date to be specified in the order to increase its income to such extent as the Zila Panchayat considers necessary, and if the Gram Panchayat fails to comply with the order, the Zila Panchayat may, by further order in writing, require it to levy or increase any tax, toll, fee or rate specified in section 89 subject to such maxima as may be prescribed.

(2) A Gram Panchayat may within such time, as may be prescribed, appeal to the State Government against an order made under sub-section (1) and pending such appeal, the State Government may stay execution of the order, and shall, after obtaining a report of the Zila Panchayat, pass such order as it thinks fit.

94. Any arrear of [cess] tax. [toll, fees or rate impos- Recovery of ed] or rent due under this Act shall be recoverable by the arrears. Collector as if it were an arrear of land revenue.

95. Any person evading the payment of any tax, toll, fee Penaity for or rate shall be punishable with fine which may extend to rupees evasion. fifty.

96. (1) If, on a complaint made to it, or otherwise, it power of Govappears to the Government that any tax levied by a Gram ernment in re-Panchayat is unfair in its incidence or that such levy or any gard to relief part thereof is obnoxious to the interest of the inhabitants of in taxes. the Gram Sabha area, it may, by an order, require the Gram Panchayat to remove the objection to any such tax within such time as may be specified therein, and on the failure of the Gram Panchayat to comply with the order within the time so specified to the satisfaction of the Government, the Government may, by notification and subject to such conditions or restrictions as may be specified therein abelish, suspend or reduce the amount or rate of any tax.

(2) The Government may, on its own motion or otherwise, after giving the Gram Panchayat an opportunity of expressing its views in the matter, by order, exempt from the payment of any tax in whole or in part any person or any class of persons or any property or description of properties subject to such conditions as max be specified in such order

# CHAPTER VIII - ADIVASI AND PARGANA PANCHAYATS

97. If in the opinion of the State Government the provi-Application of sione of chapters I to VII and EXVI IX to XXI are chapter. unsuitable for any local area by reason of the majority of its inhabitants being members of the schedule tribes it may, by potification, apply the provisions of this chapter to such area; and thereupon the provisions of the said chapters shall, except as hereinafter provided, no. apply to such area.

Establishment of Adivasi Panchayats. 98. (1) The State Government may, by notification, establish an adivasi Panchayat for any village or group of villages in the local area to which the provisions of this chapter have been made applicable under section 97. The notification shall specify the name by which the Adivasi Panchayat shall be known and shall define the limits of the area or areas within its jurisdiction.

(2) Every Adivasi Panchayat shall be a body corporate by its name specified under sub-section (1) having perpetual succession and a common seal and shall by its name sue and be sued and shall, subject to such conditions and restrictions as may be prescribed, have power to acquire, hold or transfer property, movable or immovable, to enter into contracts and to do all other things necessary for the purposes of this Act.

Constitution of 99. (1) An Adivasi Panchayat shall consist of a Sarpanch Adivasi Pancha- and such number of Panchas as may be fixed by the State Govyat. ernment.

> [(2) The Sarpanch shall be nominated by the State Government and the Panchas shall be elected in such manner as may be prescribed]

(2) The Panchas shall be elected in such manner as may be prescribed and the Sarpanch shall be nominated by the State Government from amongst the Panchas so elected.

Resignation by Sarpanch or Panch.

100. The Sarpanch of an Adivasi Panchayat may resign his office by tendering his resignation to the prescribed authority and a Panch may resign his seat by tendering his resignation to the Sarpanch.

Removal of Sarpanch or Panch. Panch for corruption, neglect of duty, continued absence from meetings, mioral turpitude or any other sufficient cause and may appoint the successor of the person so removed :

> Provided that no Sarpanch or a Panch shall be removed, unless he has been given an opportunity to show cause why he should not be removed from his office.

> (2) The Sarpanch or the Panch removed under subsection (1) may prefer an appeal to the Commissioner within thirty days from the date of the order of the Collector and the decision of the Commissioner thereon shall be final.

Administrative 102. The State Government may, by general or special functions of Adi- order, direct an Adivasi Panchayat to undertake within its vasi Panchayat. jurisdiction the control and administration of and to be responsible for any of the matters specified in sections 43 and 44.

Adivasi Panchayat Fund. 103. (1) Every Adivasi Panchayat shall establish and maintain a fund and into such fund shall be paid—

(i) all sums made payable to the Adivasi Panchayat by or under this Act or any rule made thereunder;

- (ii) all sums contributed by the State Government or any local authority or any private person;
- (iii) such other sums as the State Government may, by general or special order, permit to be paid into the fund.

(2) Subject to the provisions of this Act and any rules made thereunder, such fund shall be applicable only to the pay ment of charges and expenses incidental to the matters under its control and administration.

104. (1) An Adivasi Panchayat may exercise such Judicial func-tions of Adivasi criminal and civil jurisdiction as may be prescribed.

(2) In the exercise of its functions with respect to its criminal and civil jurisdiction, an Advasi Panchavat shall act according to justice, equity and good conscience and shall follow such procedure as may be prescribed,

(3) Any decision given by an Adivasi Panchayat in exercise of its criminal and civil jurisdiction shall be recorded on the report of the Sarpanch by the prescribed authority.

105. (1) In the event of the failure of the person ordered Recovery of to pay an amount by the Adivasi Panchayat within such time amounts due as as may be prescribed, the Sarpanch, in the case of a fine imposed arrears of land and the party entitled to payment under an order of the Adivasi revenue in case Panchayat, in any other case, may apply to the Collector for recovery of the amount, and the Collector shall, thereupon after hearing the person liable to pay, proceed to recover the amount as if it were an arrear of land revenue.

(2) The amount when recovered shall be remitted to the applicant.

106. An appeal shall lie against every decision of the Appeal. Adivasi Panchayat to the Pargana Panchayat constituted as hereinafter provided.

107. (1) There shall be a Pargana Panchayat for a group Constitution of of Adivasi Panchavats. Pargana Pancha-

(2) The Pargana Panchayat shall consist of a Sarpanch and <sup>yat.</sup> four Panchas who shall all be nominated by the State Government.

108. (1) The State Government may by general or special Power to apply order apply to any Adivasi or Pargana Panchayat such of the provisions of provisions of Chapter I to VII and IX to XXI as it may think Act. fit

(2) For the purpose of facilitating the application of any provision contained in any of the said chapters, the State Government may modify any provision, without affecting the substance thereof, in such manner as may be necessary or proper to adopt it to the circumstances of an Adivasi or Pargana Panchayat.

109. (1) The State Government may make rules to carry Power to make out all or any of the purposes of this chapter not inconsistent "ules. therewith.

Panchayat.

(2) In particular and without prejudice to the generality of the foregoing power, it shall have power to make rules with reference to the varying circumstances of an Adivasi Panchayat or a Pargana Panchayat—

- (a) for laying down the qualifications and disqualifications of voters and candidates, the manner of elections, the decisions of doubts and disputes, the authority who shall decide them, the liabilities of witnesses to answer questions, the evidence to be admitted, the procedure to be followed, the powers to be exercised by such authorities in making enquiries including power to indentify witnesses against criminal proceedings and to enforce orders made in such enquiries;
- (b) for laying down the term of office of the Sarpanch and Panchas of an Adivasi Panchayat and a Parguna Panchayat and for filling casual vacancies of any Sarpancha or Panch;
- [(c) for the procedure to be followed by a Panchayat in its meetings;]
- (c) for the procedure to be followed by an Adivasi Panchayat and a Pargana Panchayat in their meetings
- (d) for the procedure to be followed by an Adivasi Panchayat when exercising criminal and civil jurisdiction and by a Pargana Panchayat when hearing an appeal;
- (e) for the custody and administration of the funds and the manner of keeping the accounts and inspection and audit thereof;
- (f) for any matter for which no provision has been made in this chapter and for which provision is, in the opinion of the State Government, necessary.

# CHAPTER IX.-JANAPADA PANCHAYATS

#### I. Constitution.

Division of district into blocks. a district into blocks.

(2) A notification under sub-section (1) shall specify the name by which the block shall be known and shall define the limits of the area comprised therein.

Incorporation of Janapada Panchayat, 111. (1) For every block, there shall be a Janapada Pan-: chayat having jurisdiction over the block:

Provided that, unless otherwise expressly provided in this Act, every Corporation, Municipality, Town Area or Notified Area, shall with respect to the functions which a Municipal Corporation, a Municipal Council, Town Area Committee or a Notified Area Committee discharges under the Municipal Law, form a separate administrative area.

(2) Every Janapada Panchayat shall be a body corporate by the name of its block having perpetual succession and a common seal and shall by its name sue and be sued and shall subject to the provisions of this Act and the rules framed thereunder have power to acquire, hold or transfer property, movable or immovable, to enter into contracts and to do all other things necessary for the purpose of this Act.

112. (1) Every Janapada Panchayat shall consist of such Constitution of number of members not being less than 15 and not more than Janapada 25, as the State Government may, by notification, specify.

(2) Every Janapada Panchayat shall be composed of-

- (i) elected members;
- (ii) one member representing the Co-operative Marketing Society or a Co-operative Union, as the case may be, within the block;
- (iii) one Councillor representing each of the Municipal Corporation, Municipal Council or Notified Area Committee within the block elected by the Councillors of such authority from amongst themselves in such manner as may be prescribed:

[Provided that—

- (i) if the elected members do not include-
  - (a) a woman; or
  - (b) a member of the Scheduled Castes or Scheduled Tribes; or
- (ii) if there be no Co-operative Marketing Society or a Co-operative Union within the block;

the Janapada Panchayat shall co-opt---

- (i) (a) a woman; or
  - (b) a person belonging to such castes or tribes; or
- (ii) a representative of other co-operative institution within the block;

who is a member of a Gram Sabha within the block and is qualified to be elected a Panch of a Gram Panchayat within the block, to be a member of the Janapada Panchayat, and the members so co-opted shall be in addition to the number of members fixed under sub-section (1).]

(3) If the elected members do not include—

- (a) a woman or include less than two women, the Janapada Panchayat shall co-opt such number of women as would make the total number of women members at least two; or
- (b) a member of the Scheduled Castes or Scheduled Tribes, the Janapada Panchayat shall co-opt a person belonging to such castes or tribes.

(4) If there be no Co-operative Marketing Society or a Co-operative Union within the block, the Janapada Panchayat shall co-opt a representative of other co-operative institutions within the block. (5) No person who is not a member of a Gram Sabha within the block and is not qualified to be elected a Panch of a Gram Panchayat within the block shall be co-opted under sub-section (3) or sub-section (4).

(6) The members co-opted under sub-sections (3) and (4) shall be in addition to the number of members fixed under sub-section (1).

Exercise of powers 112-A. (1) Where a district is divided into blocks for of Janapada Pancha the first time under this Act, the State Government shall, yat pending its Con by notification, constitute for each block a committee consitution. Sisting of a President, vice-President and such number of members as it may deem fit and such a Committee shall be deemed to be a Janapada Panchayat for the purposes of the Act :

> Provided that no person shall be appointed as President or vice-President or member of such a Committee who is ineligible to hold such office in the Janapada Panchayat under this Act.

> (2) A Committee constituted under sub-section (1) shall continue to function for a period of one year from the date of publication of the notification under sub-section (1) or till such further period not exceeding one year, in the aggregate, as the State Government may, by notification from time to time, specify.

Division of block 113. (1) Subject to the provision of sub-section (2) the into constituencies. Government shall, by notification—

- (a) divide a block into constituencies;
- (b) fix the number of members to be elected from each constituency.

(2) The ratio between the number of the members to be 'elected from each constituency in a block and the population of that constituency as ascertained in the last preceding census, shall, so far as practicable, be the same throughout the block.

114. (1) For every block there shall be a list of voters which shall be prepared constituency-wise by the collector or any other officer authorised by him in this behalf in accordance with the provisions of this section.

(2) Every panch of a Gram Panchayat situate within the block shall be entitled to be registered in the list of voters of the block :

Provided that no person shall be entitled to be registered in the list of votors for more than one constituency.

(3) Every Panch whose name is registered in the list of voters prepared under sub-section (1) shall be eligible to be an elected member of the Janapada Panchayat.

115. The provisions of section 27 shall apply in case of a member, a President or a Vice-President of a Janapada Panchayat as they apply in case of a Panch, a Sarpanch or an Upsarpanch of a Gram Panchayat.

Preparation of list of voters.

Disqualification from membership.

116. Subject to the provisions of this Act, the election and Method of voting co-option of a member of a Janapada Panchayat shall be in for election. accordance with the rules made under this Act accordance with the rules made under this Act.

117. (1) The members of a Janapada Panchayat shall, members of save as otherwise provided in this Act, enter upon their Janapada Panrespective offices with effect from the date of the first meet- chayat. ing of the Janapada Panchayat fixed under sub-section (2) and hold office for a term of five years :

Provided that the term of office of the outgoing member shall be deemed to extend to, and expire on the day preceding the date of the first meeting of the Janapada Panchayat:

Provided further that the State Government may by notification extend the term from time to time for a total period not exceeding one year in the aggregate.

(2) The first meeting of the Janapada Panchayat shall be held on the day fixed by the prescribed authority within one month of [four weeks from] the date on which the election [and] or co-option as the case may be, whichever was last declared [is notified under section 120.]

118. Every Janapada Panchayat shall at its first meeting Election of or within such time as may be prescribed elect from amongst its President and members or from amongst the Panchas of the Gram Panchayat Vice-President. within the block a President and a Vice-President in such manner as may be prescribed :

Provided that if the Janapada Panchayat fails to elect a President or a Vice-President within the time prescribed the State Government shall appoint any member of the Janapada Panchayat or any Panch of Grain Panchayat within the block to be the President or Vice-President, as the case may be.

Provided further that if a Panch of a Gram Panchayat who is not a member of the Janapad Panchayat is elected as a President or a Vice-President, the total number of the members of the Janapada Panchayat fixed under section 112 shall be deemed to have been increased so as to include the President or Vice-President so elected and such President or Vice-President shall be deemed to be a member of the Janapada Panchayat for the purposes of the Act.

119. (1) The term of office of the President and the Vice- Term of office of President shall be co-terminus with the term of office of the President and Vice-President. member: of the Janapada Panchryat.

(2) After the expiry of the term of his office the President shall continue to carry on the current duties of his office until such time as the election or appointment of his successor is notified.

(3) (a) As soon as may be after the election or appointment of a new President is notified the outgoing President shall hand over to him the charge of office.

(b) If the outgoing President fails or refuses to hand over charge of his office as required under clause (a), the prescribed sutharity may by orden in uniting disast the second

to hand over forthwith charge of his office and all papers and property in his possession as such President, to the new President.

(c) If an outgoing President to whom a direction has been issued under clause (b) fails to comply with the direction he shall on conviction be punished with fine which may extend to hundred rupees and shall be ejected forcibly, if necessary, from his office by such officer as may be authorised by the prescribed authority.

120. Every election, co-option and appointment of a member of a Janapada Panchayat or a President and a Vice-President shall be notified by the [prescribed authority] Collector in the manner prescribed.

121. A member of a Janapada Panchayat may resign his office by giving notice in writing to that effect to the President and his resignation shall take effect from the date of its receipt by the President.

122. The President or Vice-President may resign his office by giving notice in writing to the prescribed authority but the resignation shall not take effect until it is accepted by the prescribed authority.

(1) The Government may, after such enquiry as 123.it may deem fit to make, at any time, remove a member President or Vice-President of a Janapada Panchayat-

- (a) if he has been guilty of misconduct in the discharge of his duties : or
- (b) if his continuance in office is undesirable in the interest of the public :

Provided that no member President or Vice-President shall be removed unless he has been given an opportunity to show cause why he should not be removed from his office.

(2) A person who has been removed under sub-section (1) shall forthwith cease to be a member of any other Panchayat of which he is a member.

**Removal of Presi-**[(1) A President or Vice-President may be removed 124. from his office by a resolution passed by the Janapada Panchayat by a majority of not less than two-thirds of its members present and voting, and such majority is not less than one half of the total number of members constituting the Janapada Panchayat for the time being. The removal shall take effect from the date immediately next after the date on which such resolution is passed.]

> (1) On a motion of no confidence being passed by the Janapada Panchayat by resolution passed by a majority of not less than two-thirds of the members present and voting, and such majority is more than one half of the total number of members constituting the Janapada Panchayat for the time being, the President or Vice-President against whom such resolution is passed hall cease to hold office with effect from the date immediately next after the date on which such resolution is passed.

(2) For the purpose of sub-section (1), a meeting of the Janapada Panchayat shall be held in the following manner :----

- (i) seven clear days' notice of such meeting shall be given to every member;
- [(ii) the President or the Vice-President, as the case may be, against whom a resolution is to be placed before the meeting, shall not preside over the meeting; and
- (iii) such President or Vice-President shall be given a reasonable opportunity to furnish an explanation.]
- (ii) the President or the Vice-President, as the case may be, against whom a resolution is to be placed before the meeting, shall not preside over the meeting but he shall have a right to speak or otherwise to take part in the proceedings of the meeting."

(3) If the office of the President becomes vacant under this Act, all powers and duties of the President, until the election or appointment of his successor, shall have been notified, be exercised and performed by the Vice-President, and if there be no Vice-President by such member as the Government may appoint in this behalf.

(4) The fact of the removal of the President or the Vice-President under sub-section (1) shall be intimated to the Zila Panchayat and to the Government and it shall be notified in the Gazette by the Government. The appointment of his successor shall, in the like manner, be notified in the Gazette.

125. In the event of the death, resignation, removal or Filling up of disqualification of a member, President or Vice-President of a casual vacancies. Janapada Panchayat, or his becoming incapable of acting before the expiry of his term of office, a casual vacancy shall be deemed to have occurred in such office and such vacancy shall be filled, as soon as may be, by election, co-option or appointment, as the case may be, of a person thereto as a member, President or Vice-President, who shall take office forthwith and shall hold such office for the unexpired term of his predecessor :

Provided that no casual vacancy except that of the office of the President shall be filled which occurs within a period of four months preceding the date on which the term of office of the person concerned expires.

#### **II.**—Conduct of Business

126. Subject to the provisions of this Act, the procedure **Procedure** at a meeting of the Janapada Panchayat and its Standing Com-meeting. mittee shall be such as may be prescribed.

127. (1) A Janapada Panchayat shall meet for the transac-Meeting of tion of business at least once in every month at the office of Janapada the Janapada Panchayat and st such time as the President may Panchayat. determine.

(2) The President may, whenever he thinks fit, and shall, upon a written request of not less than one-half of the total number of members, call a special meeting.

(3) Notice of every meeting specifying the time and place thereof and the business to be transacted thereat shall be dispatched to every member and exhibited at the Janapada Panchayat Office seven clear days before an ordinary meeting and three clear days before a special meeting.

(4) No business other than that specified in the notice relating thereto shall be transacted at a meeting except with the consent of two-third of members present.

[(5) The quorum for a meeting of the Janapada Panchayat shall be one-half of the total number of members. If the quorum is not present at a meeting, the presiding authority shall adjourn the meeting to such time on the following day or some future date as it may fix. A notice of the meeting so fixed shall be affixed in the office of the Janapada Panchayat. The business, which could not be considered at the meeting so postponed for want of quorum shall be brought before and disposed of, at the meeting so fixed or at any subsequent adjourned meeting whether there is quorum present or not; provided that not less than one-fifth of the members are present.]

(5) The quorum for a meeting of the Janapada Panchayat shall be one-half of the total number of members.' If less than one-half of the total number of members be present at a meeting at any time from the beginning to the end thereof the presiding authority shall, after waiting for not more than thirty minutes, adjourn the meeting to such hour on the following or some other future day as it may reasonably fix. A notice of such adjournment shall be fixed up in the Janapada Panchayat office, and the business which would have been brought before the original meeting had there been a quorum thereat, shall be brought before the adjourned meeting and may be disposed at such meeting or at any subsequent adjournment thereof, whether there be a quorum present or not.

(6) At every meeting of the Janapada Panchayat the President and in his absence the Vice-President shall preside and in absence of both, the members present shall choose one from among themselves to be the Chairman for the meeting.

(7) All question shall, unless otherwise specially provided, be decided by a majority of votes of the members present and voting. The Presidents, the Vice-President or Chairman, as the case may be, unless he refrains from voting shall give his vote before declaring the number of votes for and against the question and in case of equality of votes, he shall give his casting vote.

(8) No member shall vote on, and take part in the discussion of any question coming up for consideration at a meeting of a Janapada Panchavat, if the question is one in which he has any direct or indirect pecuniary interest, other than an interest as a member of the public.

(9) If it appears to any member present at a meeting that the person presiding at the meeting has any such pecuniary interest in any matter before the meeting for discussion as is referred to in sub-section (8) and a motion brought by him to that effect is carried, such person shall not preside over such meeting during the discussion and the meeting shall be presided over by any other person who would have presided, had the person so presiding been absent.

[128. No resolution of a Janapada Panchayat shall be [Modification modified or cancelled within three months after passing cancellation of thereof, except by a resolution passed by not less than twothird of the total number of members at an ordinary or special meeting, notice whereof shall have been given fulfiling the requirements of sub-section (3) of section 127 and setting forth fully the resolution which it is proposed to modify or cancel at such meeting and the motion or proposition for the modification or cancellation of such resolution.]

129. Every member of the Legislative Assembly of the Rights of cer-State representing the constituency which is wholly or partly tain members of included within the block, and who is not a member of the State Legislative Janapada Panchayat constituted for such block shall have the Assembly to right to speak in, and otherwise to take part in, the proceed- Janapada Panings of any meeting of the Janapada Panchayat, but he shall chayat not be entitled to vote at any such meeting. If a block is inge. comprised of more than one such constituency, the members representing all such constituencies shall have the rights conferred by this section.

130. (1) Minutes shall be kept of the names of the mem-bers and of the Government officers and members of Legislative Assembly, if any, present and of the proceedings of each meeting of the Janapada Panchayat and if any member present at the meeting so desires, of the names of the members voting, respectively for or against any resolution, in a book to be provided for the purpose, which shall be signed as soon as practicable by the President, Vice-President or Chairman of such meeting and shall at all reasonable times, be open to inspection free of charge by any member or any Panch of a Gram Panchayat within the block. A copy of the minutes shall be forwarded to the prescribed authority within fifteen days of the minutes being signed.

(2) The minutes shall be in Hindi written in Devnagari script.

131. Any member may call the attention of the President Interpeliations to any neglect in the execution of the Janapada Panchayat work, and resolutions. to any waste or misapplication of Janapada Panchayat funds or property or to the needs of any locality within the block, and may make such suggestions as appear desirable.

#### III.—Subordinate Agencics

Standing Committees of Jana amongst its members constitute the following Standing pada Panchayat. Committees, namely:--

- (a) Agriculture Standing Committee.—For agriculture, animal husbandry, minor irrigation, power, reclaimation including soil conservation and contour bunding and fisheries, compost manuring, seed distribution and other matters connected with development or agliculture and live-stock;
- (b) Co-operative Standing Committee.—For co-operation, thrift and small savings, cottage industries, rural housing, excise (temprance or prohibition) and statistics;
- (c) Education and Social Welfare Standing Committee.— For education including social education, health and sanitation including rural water supply and drainage, social welfare, women welfare, relief of distress caused by floods, draught, earthquake, scarcity, locust, swarms and other such emergencies;
- (d) Communication and Works Standing Committee.— For communication and works; and
- (e) Taxation and Finance Standing Committee.—For taxation and finance.]

"(1) Every Janapada Panchayat shall from amongst its members constitute the following Standing Committees, namely:—

- (a) Agriculture Standing Committee.—For agriculture, animal husbandary, power, reclamation including soil conservation and contour bunding and fisheries, compost manuring, seed distribution and other matters connected with development of agriculture and live-stock;
- (b) Education Standing Committee.—For education including social education.
- (c) Social Welfare Standing Committee.—For social welfare, women and child welfare, removal of untouchability, relief of distress caused by floods, draught, earthquake, hailstorm, scarcity, locust swarms and other such emergencies, temperence or prohibition, health and sanitation.
- (d) Taxation and Finance Standing Committee.—For planning, budget, accounts, taxation and other financial matters.
- (e) Communication and Works Standing Committee.—For communication, minor irrigation, rural housing, rural water-supply, drainage and other public works.
- (f) Co-operation and Industries Standing Committee.—For co-operation, thrift and small sav-

ings, cottage and village industries, markets and statistics.

(g) General Standing Committee.—For local pilgrimages, fairs and melas, cattle pounds and other miscellaneous work.

(2) In addition to the [five] seven Standing Committees referred to in sub-section (1) a Janapada Panchayat may, with the approval of the Government, constitute one or more such committees for any other matter not specified in the said sub-section.

(3) Every Standing Committee shall consist of the President of the Janapada Panchayat who shall be ex-officio Chairman of the Standing Committee and four other members to be elected by the members of the Janapada Panchayat from themselves in the manner prescribed:

Provided that a Standing Committee may, with the previous approval of the Janapada Panchayat, co-opt not more than two persons having experience or special knowledge of the subjects assigned to the Standing Committee.

Provided further that the members of the Social Welfare Committee shall include a woman.

(4) Every Standing Committee shall, in relation to the subjects assigned to it, exercise such powers and perform such of the functions of the Janapada Panchayat as may be prescribed.

(5) No person other than the President of a Janapada Panchayat shall be a member of more than [two] three Standing Committees at a time.

(6) The term of office and the procedure for the conduct of business of a Standing Committee shall be such as may be prescribed.

133. A Standing Committee of the Janapada Panchayat Emergency may, in case of emergency direct the execution or stoppage of powers of any work or doing any act which requires the sanction of the Standing Com-Janapada Panchayat and immediate execution or doing of which mittees. is, in its opinion, necessary for the health or the safety of public, and may direct that the expense of executing such work or doing such act shall be paid from the Janapada Panchayat Fund :

Provided that-

- (a) it shall not act under this section in respect of any matter falling outside its purview;
- (b) it shall not act under this section in contravention of any order of the Janapada Panchayat prohibiting the execution of particular work or doing of any particular act;
- (c) it shall report forthwith the action taken under this section and the reasons therefor to the President who shall lay it before the Janapada Panchayat at its next meeting.

> Powers and duties of President.

134. A Janapada Panchayat may require a Standing Committee to furnish any document including extract of the proceedings of a meeting of such committee which is in its custody and such committee shall comply with every such requisition.

135. The President of a Janapada Panchayat shall-

- (a) preside at the meeting of the Janapada Panchayat and all its committees ;
- (b) watch over the financial and general administration of the Janapada Panchayat and exercise general supervision and control;
- (c) submit to the Janapada Panchayat all questions which require its sanction.
- (d) exercise such other powers and perform such other duties as may be prescribed.
- 136. The Vice-President of a Janapada Panchayat shall-
  - (a) in the absence of the President, preside over the meeting of the Janapada Panchayat:
  - (b) exercise such powers and perform such duties of the President as the President may, from time to time, delegate to liim ;
  - (c) exercise powers and perform the duties of the President, pending the election of a President or during the absence of the President on leave or otherwise.

# CHAPTER X.—FUNCTIONS

Functions of Janapada Panchayat.

137. (1) Subject to the provisions of this Act and the rules made thereunder, and subject to general or special orders as may be issued by the State Government, from time to time, it shall be the duty of a Janapada Panchayat, so far as the Janapada Panchayat fund at its disposal will allow, to make reasonable provision for the following matters :-

- (i) Community Development.-The execution of all programmes under the Community Development in association with Gram Panchayats, Co-operative Societies, voluntary organizations and the public.
- (ii) Agriculture.—The doing of everything necessary to step up agricultural production and in particular-
- (a) multiplication and distribution of improved seeds;
- (b) procurement, distribution and popularisation of improved manure and fertilizers;
- (c) popularisation of improved techniques, methods and practices and improved implements;
- (d) achieving self sufficiency in green manure, composting of farm-yard manure;
- (e) encouraging fruits and vegetable cultivation;
- (f) reclamation of land and conservation of soil;
- (g) providing credit for agricultural purposes:

Powers and duties of Vice-President.

- (h) popularising of horticultural practices;
- (i) propagating and assisting in plant protection methods;
- (j) laying out demonstration plots, working out better methods of farm management;
- (k) bringing more acreage under irrigation by renovating and sinking wells, repairing, digging private tanks and maintaining Government minor irrigatios sources and supply channels;
- (1) utilizing more power for agricultural purposes;
- (m) exploiting underground water sources by sinking wells, filter points and tube wells;
- (n) tree planting;
- (o) growing of village forests.

(iii) Animal Husbandry and Fisheries.-

- (a) upgrading local stocks by introducing pedigree breeding bulls and castrating scrub bulls;
- (b) introducing improved breeds of cattle, sheep, pigs and poultry;
- (c) controlling contagious diseases by systematic protection;
- (d) introducing improved fodder and feeds;
- (e) establishing and maintaining artificial insemination centres, first aid centres and minor veterinary dispensarles;
  - (f) dairying and milk supply;
  - (g) developing inland fisheries;
- (h) educating the people about the importance of better cattle for both milk and draught.
- (iv) Health and Sanitation.—
  - (a) expanding existing medical and health service and bringing them within the reach of the people;
  - (b) establishing and maintaining primary health centres and maternity centres;
  - (c) providing protected drinking water facilities;
  - (d) ensuring systematic vaccination;
  - (e) controlling epidemics;
  - (f) providing drains and soakage pits for village and house drainage;
  - (g) encouraging the use of sanitary type of latrines and utilising human waste;
  - (h) popularising smokeless Chulas;
  - (i) supervising work in Government dispensaries and hospitals;
  - (j) enlisting peoples' participation for the improvement of such dispensaries and hospitals;
  - (k) securing the co-operation of the people and the Gram Panchayats during epidemics;
  - (1) implementing health programmes subject to the technical control of the district authorities concerned.

- (v) Education.-
  - (a) maintenance and expansion of primary and basic schools;
  - (b) establishment and maintenance of primary and basic schools;
  - (c) establishment of adult education centre and adult literacy centres;
  - (d) provision and improvement of accommodation for schools with peoples participation;
  - (e) taking of such action as may be necessary for the promotion of education for all children until they complete the age of 14 years.

(vi) Social Education.—The creation of a new outlook among the people and making them self reliant, hard working and responsive to community action and in particular:—

- (a) establishment of information, community and recreation centres;
- (b) establishment of youth organisation, Mahila Mandals, Farmers Clubs, and the like;
- (c) establishment and popularisation of libraries;
- (d) organization of watch and ward, with the help of Gram Panchayats;
- (e) encouragement of physical and cultural activities;
- (f) organisation of voluntary sanitary squads;
- (g) training and utilisation of the services of Gram Sahayaks.
- (vii) Communication and Public Works.---
  - (a) construction, repairs and maintenance of roads within the jurisdiction of Janapada Panchayat, but other than Gram Panchayat Roads;
  - (b) rendering such assistance as may be necessary for the formation and the maintenance of village roads which serve as feeders;
  - (c) repairs to Janapada Panchayat buildings and protection of movable and immovable property.

(viii) Co-operation.—The securing of economic development along democratic lines by the application of co-operation in its different forms and in particular:—

- (a) establishment of co-operative credit, consumers, housing, producers, industrial, farming, marketing and multi-purpose societies in order to serve the maximum number of families;
- (b) encouragement of thrift and small saving.

(ix) Cottage Industries.—Development of cottage, village and small scale industries in order to provide better employment opportunities and thereby raise the standard of living and in particular :—

> (a) the establishment and maintenance of production-cumtraining centres;

- (b) the improvement of the skill of artisans and craftsmen;
- (c) popularisation of improved implements;
- (d) implementation of schemes for the development of cottage, village and small scale industries financed by the Khadi and Village Industries Commission and All India Boards.

(x) Women and Child Welfare.—The implementation of [specifically] schemes specially designed for the welfare of children and women and in particular the establishment of women and child welfare centres, literary centres, crafts and tailoring and dress making centres and the like.

- (xi) Social Welfare.—
  - (a) implementation of Rural Housing Scheme;
  - (b) maintenance of disabled beggers and control of vagrancy;
  - (c) strengthening of voluntary social welfare organisation and co-ordinating their activities;
  - (d) propagation of temperance and prohibition.

(xii) *Emergency Relief.*—Provision of emergency relief through voluntary efforts in cases of distress caused by fires, floods, draught, earthquake, scarcity, locust swarms, epidemics and other natural calamities.

(xiii) Collection of statistics.—Collection and compilation of such statistics as may be found necessary either by the Janapada Panchayat, the Zila Panchayat or the Government.

(xiv) Self-Help Programme.—Formulation and execution of suitable programmes for stepping up production and for raising the incomes and standard of living, for the improvement of sanitation and for the provision of amenities for the people.

(xv) General.---

- (a) arrangement in connection with local pilgrimage and festivals;
- (b) organising and regulating markets, fairs and melas;
- (c) establishment and control of cattle pound;
- (d) welfare of Backward Classes;
- (e) promoting natural relations and co-operation among the Gram Panchayats within its jurisdiction;
- (xvi) Any other function with the approval of the Government.

(2) The State Government may, by an order, add to or withdraw any of the functions mentioned in sub-section (1) or direct the performance of any of such functions subject to such modifications or restrictions  $\varepsilon s$  may be specified therein.

Development functions.

of Janapada

**Panchayat** 

(1) Subject to such conditions and restrictions as 138. it may deem fit to impose, the State Government may entrust to the Janapada Panchayat the execution in the Block of the Community Development Scheme, including in particular, all measures relating to the functions enumerated in section 137.

(2) On entrustment of the functions specified under subsection (1), the Janapada Panchayat shall subject to the provisions of this Act and any general or special order passed by the State Government, execute the scheme and take all other measures necessary therefor.

General Powers Subject to the provisions of this Act and the rules 139. made thereunder and provisions of any other law for the time being in force, a Janapada Panchayat shall have power to do all acts necessary or incidental to the carrying out of the duties entrusted to it under section 137:

> Provided that when the Government undertakes to perform any of the functions enumerated in section 137, nothing in that section shall be deemed to impose any duty or confer any power on a Janapada Panchayat for performance of such function, unless the Government by general or special order entrusts such duty or delegates such power in respect thereof to the Janapada Panchayat.

140. Subject to the provisions of this Act and the rules made thereunder, every Janapada Panchayat shall supervise the working of the Gram Panchavats within the block and shall render such assistance within the limits of its resources as may be necessary.

141. A Janapada Panchayat may, with the sanction of the Zila Panchayat, turn, divert, discontinue or permanently close any road which is under the control and administration of or is vested in the Janapada Panchayat.

142. (1) Whoever—

- (i) builds or sets up any wall or any fence, rail, post, stall, verandah, platform, plinth, step or any projecting structure or things, or other encroachments or obstructions ; or
- (ii) deposits or causes to be placed or deposited, any box, bale, package or merchandise or any other thing :

on any part of any public street, or building, or in or over or upon any open drain, gutter, sewer or aqueduct in such street, land or building which vests in the Janapada Panchayat shall on conviction be punished with fine which may extend to [rupees twenty-five] two hundred and fifty rupees

(2) The Chief Executive Officer shall have power to remove any such obstruction or encroachment, and the expenses of such removal shall be paid by the person who has caused the said obstruction or encroachment, and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under Chapter XIII.

Janapada Panchayat to supervise working and to assist Gram Pancheof yats.

Power to turn, divert, discontinue or close roads.

Obstructions and encroachments upon public streets and lands.

Provided that, before proceeding to remove any such obstruction or encroachment, the Chief Executive Officer shall by a written notice call upon the person who has caused such obstruction or encroachment to remove it within a reasonable time to be specified in the notice, or to show cause why the same should not be removed.

(3) Nothing contained in this section shall prevent a Janapada Panchayat from allowing any temporary occupation of or erection on any public street which vests in it or is its property, on occasions of festival and ceremonies, or of the piling of fuel on any part of such road for not more than 15 days and in such manner as not to inconvenience the public or any individual.

# CHAPTER XI.—JANAPADA PANCHAYAT FUND AND PROPERTY

143. (1) For the purposes of this Act, the State Govern-Government may ment may by notification and subject to such conditions and vest certain restrictions as it may think fit to impose, vest in a Janapada property in Panchayat open sites, vacant lands or grazing lands or public Panchayat roads and streets, bridges, ditches, fences, wells, river beds, tanks, streams, lakes, nallahs, canals, trees or any other property in the block vesting in the Government.

(2) The State Government may resume any immovable property transferred to the Janapada Panchayat under subsection (1), without payment of any compensation other than the amount paid by the Janapada Panchayat for such transfer and the market value at the date of resumption of any building or works subsequently erected or executed thereon by the Janapada Panchayat:

Provided that no compensation shall be payable for buildings or works constructed or erected in contravention of the terms of the transfer.

144. No immovable property vested in or belonging to a Transfer of Janapada Panchayat shall be transferred by sale, gift, mortgage immovable or exchange or by lease for a period exceeding three years, or perty. otherwise except with the previous sanction of the State Government or any officer authorised in this behalf.

145. A Janapada Panchayat may with the previous sanction of the prescribed authority, compromise any suit Power to instituted by or against the Janapada Panchayat or any claim or demand arising out of any contract entered into by the Janapada Panchayat under this Act on such terms as it [shall] may deem fit.

146. (1) Every Janapada Panchayat shall establish and Janapada Panmaintain a fund called the Janapada Panchayat Fund. chayat Fund.

(2) The following shall form part of and be paid into the Janapada Panchayat Fund, namely :—

(1) all sums received on account of institutions and schemes transferred by the Government to the Janapada Panchayat;

- (ii) all sums allotted by the Government for the execution of the Community Development programme;
- (iii) all sums contributed to the Janapada Panchayat Fund by the Central Government, State Government, All India Bodies or other Institutions for the development of cottage and village industries, Khadi, Sik, and the like;
- (iv) donation and contribution received by the Janapada Panchayat from other local bodies or from the public in any form;
- (v) such percentage of land revenue, other taxes or fees as may be payable by the Government to the Janapada Panchayat under this Act or under any other law for the time being in force;
- (vi) the proceeds of any tax, rate, fee etc., which the Janapada Panchayat may, under any law, levy;
- (vii) the income from or proceeds of any property of the Janapada Panchayat;
- (viii) all interests, profits and other moneys accruing by gifts, grants, assignment or transfers from the Government or private individuals or otherwise;
  - (ix) all proceeds of land and other property sold by the Janapada Panchayat including sale proceeds of grass and produce of trees not vested in private individuals on the side of roads and on other public grounds under the control and administration of the Janapada Panchayat and of timber fallen or felled therefrom; and
  - (x) such other sums as may be assigned to the Janapada Panchayat Fund by special or general order of the Government.

147. (1) Subject to the provisions of this Act and the rules made thereunder, all property vested in the Janapada Panchayat under this Act, and the Janapada Panchayat Fund shall be applied for the purposes of this Act, and the Fund shall be kept in such custody as may be prescribed.

(2) Any amount allotted to the Janapada Panchayat by the Government or any person or local authority for any specific work or purpose shall be applied exclusively for such work or purpose and in accordance with such instructions as the Government may either generally or specially issue in this behalf.

Administration 148. (1) The administration of Janapada Panchayat of Janapada Fund shall, subject to the general control of the Government, Panchayat Fund be in the hands of the Janapada Panchayat.

> (2) Subject to rules framed under this Act all moneys at the credit of Janapada Panchayat Fund shall be kept in the name of the Janapada Panchayat in the nearest Government Treasury or Sub-Treasury and where there is no Government Treasury or Sub-Treasury in the nearest Post Office Savings Bank or Co-operative Bank, or with a local banker or other person approved by the Government.

Application of Janapada Panchayat Fund. 149. Subject to the previous sanction of the Government a Janapada Panchayat may make Grant-in-aid to any medical, Power to make educational or charitable institution or any other institution of public utility, within the block.

150. When a Janapada Panchayat has entered into an Arrangements arrangement, or made any promise, purporting to bind itself purporting to for a term of years or for unlimited period, to continue to any permanently or institution a yearly contribution from its property or from the for a term of Janapada Panchayat Fund, it shall be lawful for the Janapada years. Panchayat, with the sanction of the Government, to cancel such arrangements or promise or discontinue or to diminish such contribution, provided that it shall have given at least one year's notice of its intention so to do to the manager or managers of such institutions.

# CHAPTER XII.—JANAPADA PANCHAYAT ESTABLISH-MENT, BUDGET AND ACCOUNTS

#### I.—Establishment

151. (1) Every Janapada Panchayat shall have a Chief Appointment of Executive Officer who shall be appointed by the Government.

Officer.

(2) No person other than a servant of the Government shall be eligible for appointment as Chief Executive Officer.

(3) All Officers and servants employed by the Janapada Panchayat or deputed by the Government shall be subordinate to the Chief Executive Officer.

152. (1) Leave of absence other than causal leave may Grant of leave be granted, from time to time, to the Chief Executive Officer of absence and by the State Government, and casual leave may be granted to condition of serhim by such author'ty as may be prescribed.

(2) The conditions of service of the Chief Executive Officer shall be such as are applicable from time to time to the class of service to which the Chief Executive Officer belongs in the service of the Government.

153. (1) Subject to the provisions of this Act and the Other Officers rules made thereunder, a Janapada Panchayat may employ and servants such officers and servants as may be necessary for the efficient discharge of its duties:

(2) The qualifications, method of recruitment, salaries, leave allowances and other conditions of service including disciplinary matters of such officers and servants shall be such as may be prescribed.

154. A Janapada Panchayat may in accordance with the Establishment of rules made under this Act— Provident Fund.

- (a) establish and maintain a Provident Fund on behalf of its officers and servants; and
- (b) grant gratuity to any officer or servant subject to the previous approval of the prescribed authority

Deputation of Government servante.

Functions of

Officer.

(1) The State Government may depute to the service 155. of the Janapada Panchayat such servants of the Government as it considers necessary for the proper execution of the Community Development Scheme in the block.

(2) The terms and conditions of deputation of the servants of the Government including disciplinary control shall be such as may be determined by the State Government and the terms and conditions so determined shall be binding on the Janapada Panchayat.

156. Subject to the provisions of this Act and the rules Chief Executive framed thereunder the Chief Executive Officer shall perform the following functions :----

- (i) convene meeting of the Janapada Panchayat and its committees and maintain proceedings thereof;
- (ii) take action to implement the resolutions of the Janapada Panchayat:
- (iii) furnish the Janapada Panchayat with returns, statements, estimates, statistics or other information relating to the administration of the Janapada Panchayat, and reports on such matters and copies of documents in his charge whenever called upon by the Janapada Panchayat to do so;
- (iv) exercise supervision and control over the acts of all officers and servants of the Janapada Panchayat in matters of executive administration and in matters relating to the accounts and records of the Janapada Panchayat subject to rules or orders issued by the Government in this behalf ;
- (v) furnish to the Zila Panchayat and the prescribed authority a copy of every resolution passed by the meeting of the Janapada Panchayat or its committees :
- (vi) furnish any extract of the proceedings of the Janapada Panchayat or of any committee thereof or other documents or things, which the Commissioner, Collector or Zila Panchayat or any other officer authorised in this behalf, may call for;
- (vii) prefer, subject to the provisions of this Act and rules made thereunder, complaints in prosecutions by the Janapada Panchayat and initiate or conduct proceedings, civil or criminal on behalf of the Janapada Panchayat:
- (vii) take part in meetings of the Janapada Panchavat and speak thereat but shall not have right to vote or move any motion ;
- [(xi) such other functions as may be assigned to him by or under this Act or delegated to him by the Janapada Panchayat.]
- (ix) such other functions as may be-
  - (a) delegated to him by the Janapada Panchavat: or

# (b) assigned to him by the Government by or under this Act.

157. (1) Every contract or agreement entered into on behalf Mode of making of the Janapada Panchayat, shall be binding on the Janapada contracts. Panchayat only if the said contract or agreement is executed in accordance with the provisions of this section.

(2) In respect of matters which he is empowered to carry out under the provisions of this Act, the Chief Executive Officer may execute contracts or agreements on behalf of the Janapada Panchayat where the amount or value of such contract or agreement does not exceed five hundred rupees and he may execute such contracts and agreements on behalf of the Janapada Panchayat with the previous approval of the President where the amount or value of such contract or agreement exceeds five hundred rupees but does not exceed two thousand rupees and in all other cases, he shall execute a contract or agreement only with the approval or sanction of the Janapada Panchayat.

(3) Notwithstanding anything contained in sub-section (2), the Chief Executive Officer shall not execute any contract or agreement on behalf of the Janapada Panchayat for the purchase, sale, lease, mortgage, or other transfer of immovable property except with the approval or sanction of the Janapada Panchayat and subject to such rules as may be prescribed.

158. Where a Chief Executive Officer enters into a contract Report of coator agreement on behalf of a Janapada Panchayat, he shall report ract. the fact in writing to the Janapada Panchayat within 15 days thereof.

#### II.—Budget and Accounts

159. (1) The Chief Executive Officer shall, on or before Annual estimates the first day of January each year, cause, in the prescribed form of income and and manner, to be prepared and laid before the taxation and expenditure. Finance Standing Committee, an estimate of the income and expenditure of the Janapada Panchayat for the next financial year.

(2) The said committee shall, as soon as may be consider the budget estimates prepared by the Chief Executive Officer and make such modifications and additions thereto as it shall think fit and submit the same to the Janapada Panchayat not later than the thirty first day of January.

(3) The Janapada Panchayat shall, as soon as may be, consider the budget estimates as submitted by the Taxation and Finance Standing Committee and make such modifications and additions thereto as it may think fit and submit the same to the Zila Panchayat for approval not later than the tenth day of March.

(4) The Zila Panchayat shall thereupon take into consideration the said estimates and shall have power to assent, or to refuse to assent to any item of expenditure in the said estimates,

or to assent to any item of expenditure in the said estimates subject to a reduction of the amount specified for such item :

Provided that no estimate shall be approved unless provision is made therein for the Janapada Panchayat having at its credit at the end of the year a balance of not less than such amount as may be prescribed :

Provided further that if for any reason the budget estimates could not be finally adopted before the commencement of the financial year to which they relate, the budget estimates as prepared by the Chief Executive Officer or as approved by the Taxation and Finance Standing Committee if it has considered the said budget estimates, or the budget estimates as submitted for approval by the Janpada Panchayat, if it has considered the said budget estimates, shall be deemed to be the budget estimates for that year [until action it taken by the Janapada Panchayat or Zila Panchayat, as the case may be.] until the budget estimates or finally approved in accordance with the provisions of this Act.

"(5) A copy of the budget estimtes as approved or deemed to be approved under this section shall be forwarded forthwith to the State Government and the prescribed authority for information.

(6) If it appears to the prescribed authority that the budget so approved or deemed to be approved is in any way contrary to the provisions of this Act or the rules made thereunder, it shall require the Janapada Panchayat to, modify it and the Janapada Panchayat shall forthwith comply with such requisition."

Power of Jana- 160. Where the Zila Panchayat refuses to assent to any pada Panchayat item of expenditure in the said estimates or assents subject to a reduction of the amount of any such item, and the Janapada authorise expen. Panchayat is of opinion that the refusal or reduction would diture in certain affect the due discharge of its duties, it may request the State Government to authorise the expenditure considered necessary. and the State Government may authorise it to incur expenditure up to the said limit.

Annual accounts of income and expenditure.

Inspection of estimates and accounts.

Publication of abstract of accounts.

161. Accounts of receipt and expenditure of every Janapada Panchayat shall be kept in such forms and in such manner as may be prescribed.

The Janapada Panchayat shall keep at its office a 162. copy of every estimates as approved under section 159 and of every account made up under section 161 and any person residing in the block may at any reasonable time inspect any such estimate or account.

163. An abstract of every annual account of Janapada Panchayat showing the income of the Janapada Panchayat fund under each head of receipts, the charges for establishment, works undertaken, sums expended on each work, and balance, if any, of the fund remaining unspent, shall be prepared by the Janapada Panchayat and shall be published annually in such manner as may be prescribed.

# CHAPTER XIII.—IMPOSITION OF TAXES AND FEES, AND RECOVERY OF CLAIMS

164. Subject to the provisions of this Act and to such Levy of taxes conditions and exceptions as may be prescribed, every Janapada and form. Panchayat shall impose the following taxes, namely:—

- (a) a toll on new bridges constructed by the Janapada Panchayat;
- (b) a tax on theatres, theatrical performances and other shows for public amusement.

165. (1) The State Government may, by rules made under Power of State this Act, regulate the imposition, assessment and collection of Government to taxes mentioned in section 164 and matters ancillary there-regulate taxes. to.

(2) No objection shall be taken to any assessment nor shall the liability of any person to be assessed or taxed be questioned otherwise than in accordance with the provisions of this Act or of the rules made thereunder.

166. Any person aggrieved by the imposition of any tax Appeal against imposed under section 164, may appeal to the prescribed autho- taxation. rity in such manner and within such time as may be prescribed, and his decision shall be final.

167. Save as otherwise provided in this Act and subject Rents and Fees. to the rules made thereunder, a Janapada Panchayat may charge fees for any license or permission issued under this Act or for the occupation or use of lands or other property vested in it or maintained out of the Janapada Panchayat Fund.

168. A Janapada Panchayat may, by public auction or Farming of toll with the previous sanction of the Collector by private contract, or fees etc. lease the collection of toll or fees imposed under sections 164 and 167:

Provided that the lessee shall give adequate security for the due fulfilment of the conditions of the lease.

169. (1) The duty imposed by the Indian Stamp Act, Duty on transfer 1899 (II of 1899) on Instruments of sale, gift and usufructuary of immovable mortgage, respectively, of immovable property shall, in the case property. of instruments affecting immovable property situated within the block and executed on or after the date on which the provisions of this Act come into force within the limits of that block, be increased by one-half per centum on the value of the property so situated, or, in the case of an usufructuary mortgage on the amount secured by the instrument, as set forth in the instrument.

(2) For the purpose of this section, section 27 of the Indian Stamp Act, 1899 (II of 1899) shall be read as if it specifically required the particulars referred to therein to be set forth separately in respect of—

(a) property situated in the block; and

(b) property not situated in the block.

#### Penalty for evasion.

Record of arrear.

170. Any person evading the payment of any tax [to toll, rate or fees] shall be punishable with fine which may extend to one hundred rupees.

171. Any arrears of the tax [toll, rate or fees] imposed by the Janapada Panchayat under this Act shall be recoverable by the [prescribed authority] Collector, as if it were an arrear of land revenue.

Power of Government in matters of taxation.

172. The State Government may, after consultation with the Janapada Panchayat at any time by notification,—

- (a) reduce the rate of any tax [rate or fee];
- (b) exempt from the payment of any such tax, [toll, rate or fees] any person or any class of persons or any property or class of properties;
- (c) suspend or thereafter reimpose any tax, [toll, rate or fees];
- (d) abolish or thereafter reimpose any tax, [toll rate or fees];

subject to such conditions and restrictions as may be specified in the notification.

# CHAPTER XIV.—ZILA PANCHAYATS

# 1. Constitution

173. (1) For every district, there shall be established by the Government, by notification, a Zila Panchayat having jurisdiction over the district.

(2) Every Zila Panchayat shall be a body corporate by the name of its district having perpetual succession and a common seal and shall by its name sue and be sued and shall subject to the provisions of this Act and the rules framed therenuder have power to acquire, hold or transfer property, movable or immovable, to enter into contracts and do all other things necessary for the purpose of this Act.

Constitution of Zila Panchayat

۰.

- 174. (1) Every Zila Panchayat shall be composed of-
  - '(a) Presidents of the Janapada Panchayats within the district ;
  - (b) all members of [Parliament] the Lok Sabha representing Parliamentary Constituencies which either wholly or partly form part of the district;
- (b-1) all members of the Rajya Sabha returned from the State of Madhya Pradesh and ordinarily residing in the district.

Establishment and incorporation of Zila Panchayat.

- (c) all members of the State Legislative Assembly representing Assembly constituencies which either wholly or partly form part of the district;
- (d) district officers representing the Public Health including Public Health Engineering, Agriculture, Veterinary, Education and other Development Departments in the district as the Government may specify.

(2) The district officers referred to in clause (d) of subsection (1) shall have the right to speak at and otherwise to take part in, the proceedings of any meeting of the Zila Panchayat or any of its standing Committee but shall not be entitled to vote or move any motion or resolution thereat.

175. A member of a Zila Panchayat shall, save as other. Term of office wise provided in this Act, hold office so long as he continues to of members of hold the office by virtue of which he has become a member of the Zila Panchayat under section 174:

Provided that notwithstanding the dissolution of the [House of the People] Parliament or the Legislative Assembly a member representing a Paliamentary constituency or an Assembly Constituency shall continue to hold office till the election of his successor.

176. (1) Every Zila Panchayat shall elect from amongst Election of its members other than district officers referred to in clause Chairman and (d) of sub-section (1) of section 174 a Chairman and a Vice-Vice-Chairman Chairman within such time and in such manner as may be of office.

Provided that if the Zila Panchayat fails to elect a Chairman or a Vice-Chairman within the time prescribed, the State Government shall appoint any member of a Zila Panchayat other than district officers referred to in clause (d) of sub-section (1) of section 174, to be the Chairman or Vice-Chairman, as the case may be:

Provided further that no person shall be elected or appointed a Chairman or Vice-Chairman for more than one Zila Panchayat.

(2) Save as otherwise provided by this Act, the Chairman and the Vice-Chairman shall hold cflice for a period of five years:

Provided that the Chairman and the Vice-Chairman shall, unless the State Government otherwise directs, continue to hold office until his successor is duly elected or appointed and such election or appointment has been notified in the manner provided in section 177.

177. Every election or appointment of a Chairman and Notification of Vice-Chairman shall be published by the [prescribed authority] Collector in accordance with rules made under Chairman and this Act and they shall enter on their respective offices from Vice-Chairman. the date of such publication. Resignation by Chairman or Vice-Chairman.

Removal of Chairman and Vice-Chairman, 178. The Chairman or Vice-Chairman may resign his office by giving notice in writing to the Government but the resignation shall not take effect until it is accepted by the Government.

179. [(1) A Chairman or Vice-Chairman may be removed from his office by a resolution passed by the Zila Panchayat by a majority of two-third of its non-official members present and voting, which is not less than one half of the number of members other than district officers referred to in clause (d) of subsection (1) of section 174 constituting the Zila Panchayat, for the time being, and the removal shall take effect from the date immediately next after the date on which such resolution is passed.]

[(2) For the purposes of sub-section (1) a meeting of the Zila Panchayat shall be held in the following manner, namely:—

- (i) seven clear days, notice of such meeting shall be given to every member ;
- (ii) the Chairman or the Vice-Chairman, as the case may be, against whom a resolution is to be placed before the meeting, shall not preside over the meeting; and
- (iii) such Chairman or Vice-Chairman shall be given a reasonable opportunity to furnish an explanation.]

1) A motion of no-confidence may be moved against the the Chairman or the Vice-Chairman by any non-official memthe ber of the Zila Panchayat at a meeting specially convened for the purpose under sub-section (2), and if the motion is carnied by a majority of two-third of the non-official members present and voting and if such majority is more than half of the total number of non-official members constituting the Zila Panchayat for the time being, the Office of the Chairman or the Vice-Chairman, as the case may be, shall be deemed to have become vacant forthwith.

(2) For the purpose of sub-section (1), a meeting of the Zila Panchayat shall be held in the following manner, namely:—

- (i) the meeting shall be convened by the Secretary of the Zila Panchayat, on a requisition signed by not less than one-sixth of the total number of non-official members constituting the Zila Panchayat for the time being;
- (ii) the notice of such a meeting specifying the time and place shall be despatched by the Secretary, Zila Panchayat to every member ten clear days before the meeting;
- (iii) the Chairman and Vice-Chairman, as the case may be, against whom the motion of no-confidence is to be moved, shall not preside over the meeting, but he shall have a right to speak or to otherwise take part in the meeting.

Motion of no confidence against the Chairman or the Vice-Chairman. (3) If the office of the Chairman becomes vacant under this Act, all powers and duties of the Chairman, until the election or appointment of his successor shall have been notified under section 177, be exercised and performed by the Vice-Chairman, and if there be no Vice-Chairman by such member as the Government may appoint in this behalf.

(4) The fact of the removal of the Chairman or the Vice Chairman under sub-section (1) shall be intimated to the State Government and it shall be notified in the Gazette by the Government. The appointment of his successor shall in the like manner, be notified in the Gazette.

180. A casual vacancy in the office of a Chairman or Filling of a Vice-Chairman of a Zila Panchayat shall be filled, as soon as may be, by election or appointment of a non-official member of Zila Panchayat thereto who shall hold office for the unexpired term of his predecessor.

II.—Conduct of Business

181. Subject to the provisions of this Act, the procedure Procedure at a meeting of the Zila Panchayat shall be such as may be meeting. prescribed.

182. (1) A Zila Panchayat shall meet for the transaction Meeting of Zila of business at least once in every month at the office of the Zila Panchayat. Panchayat and at such time as the Chairman may determine.

(2) The Chairman may, whenever he thinks fit, and shall, upon a written request of not less than one half of the total number of members call a special meeting.

(3) Notice of every meeting specifying the time and place thereof and the business to be transacted thereat shall be dispatched to every member and exhibited at the Zila Panchayat Office seven clear days before an ordinary meeting and [three] four clear days before a special meeting.

(4) No business other than that specified in the notice relating thereto shall be transacted at a meeting, except with the consent of two-third of members present.

[(5) The quorum for a meeting of the Zila Panchayat shall be one half of the total, number of non-official members constituting the Zila Panchayat for the time being. If the quorum is not present at a meeting, the presiding authority shall adjourn the meeting to such time on the following day or some future date as it may fix. A notice of the meeting so fixed shall be affixed in the office of the Zila Panchayat. The business, which could not be considered at the meeting so postponed for want of quorum shall be brought before and disposed of, at the meeting so fixed or at any subsequent adjourned meeting whether there is quorum present or not; provided that not less than one-fifth of the members are present.] (5) The quorum for a meeting of the Zila Panchayat shall be one-half of the total number of non-official members constituting the Zila Panchayat for the time being. If there be no quorum present at a meeting at any time from the beginning to the end thereof, the presiding officer shall, after waiting for not more than thirty minutes, adjourn the meeting to such hour on the following or some other future day as it may reasonably fix. A notice of such adjournment shall be fixed up in the Office of the Zila Panchayat, and the business which would have been brought before the original meeting had there been a quorum thereat shall be brought before the adjourned meeting and may be disposed of at such meeting or at any subsequent adjournment thereof, whether there be a quorum present or not.

(6) At every meeting of the Zila Panchayat, the Chairman and in his absence the Vice-Chairman shall preside and in the absence of both the non-official members present shall choose one from among themselves to be the Chairman for the meeting.

(7) All questions shall, unless otherwise specially provided, be decided by a majority of votes of the non-official members present and voting. The Chairman, the Vice-Chairman or the person presiding, as the case may be, unless he refrains from voting shall give his vote before declaring the number of votes for and against the question and in case of equality of votes, he shall give his casting vote.

(8) No member shall vote on, and take part in the discussion of any question coming up for consideration at a meeting of a Zila Panchayat, if the question is one in which he has any direct or indirect pecuniary interest, other than an interest as a member of the public.

(9) If it appears to any member present at a meeting that the person presiding at the meeting has any such pecuniary interest in any matter before the meeting for discussion as is referred to in sub-section (8) and a motion brought by him to that effect is carried, such person shall not preside over such meeting during the discussion and the meeting shall be presided over by any other person who would have presided, had the person so presiding been absent.

[183. No resolution of a Zila Panchayat shall be modified or cancelled within three months after passing thereof, except by a resolution passed by not less than two-third of the total number of members at an ordinary or special meeting, notice whereof shall have been given fulfilling the requirements of sub-section (3) of section 182 and setting forth fully the resolution which it is proposed to modify or cancel at such meeting and the motion or proposition for the modification or cancellation of such resolution.]

of '183. No subject once finally disposed of by a Zila Pandis-chayat shall be reconsidered by it within six months unless the recorded consent of not less than three-fourth of its non-official members has been obtained thereto, or unless the prescribed authority has directed its reconsideration.

184. (1) Minutes shall be kept of the names of the members present and of the proceedings of each meeting of the Zila Panchayat and if any member present at the meeting so desires, of the names of the members voting, respectively for or against any resolution, in a book to be provided for the purpose, which shall be signed as soon as practicable by the Chairman, Vice-Chairman or any other person presiding at such meeting and shall at all reasonable times, be open to inspection free of charge.

(2) The minutes shall be recorded in Hindi, written in Devnagari script.

'(3) A copy of the minutes shall be forwarded to the prescribed authority within fifteen days of the minutes being signed.

# III.—Subordinate Agencies

185. (1) Every Zila Panchayat shall from amongst its Standing Commembers constitute the following Standing Committees, mittees of Zila

Panchayat.

- (a) Planning and Community Development Standing Committee—For Planning and Community Development;
- (b) Co-operation Standing Committee—For co-operation. food, agriculture, irrigation and power;
- (c) Industries Standing Committee—For cottage, village and small scale industries;
- (d) Education and Social Welfare Standing Committee— For education including social education and social welfare;
- (e) Finance Standing Committee-For Finance.

(2) In addition to the five Standing Committees referred to in sub-section (1) a Zila Panchayat may, with the approval of the Government, constitute one or more Standing Committees for any matter not specified in the said sub-section.

(3) (a) Every Standing Committee shall consist of the Chairman and the Vice-Chairman of the Zila Panchayat and five other members to be elected by the members of the Zila Panchayat from among themselves in the manner prescribed:

Provided that a Standing Committee may with the previous permission of the Zila Panchayat co-opt in the prescribed manner not more than two persons having experience and special knowledge of the subjects assigned to the Standing Committee.

(b) The Chairman of the Zila Panchayat shall be the Chairman of every Standing Committee.

(4) Subject to rules framed under this Act, every Standing Committee shall, in relation to the subjects assigned to it, exercise such of the powers and perform such of the functions of the Zila Panchayat as may be delegated or assigned to it by the Zila Panchayat.

(5) No person other than the Chairman and the Vice-Chairman of the Zila Panchayat shall be a member of more than two Standing Committees at a time.

(6) The procedure for the conduct of business at a Standing Committee shall be such as may be prescribed.

The Chairman and Vice-Chairman of a Zila Pan-186. chayat shall exercise and perform such powers and functions as may be prescribed.

187. The District Panchayat Officer or any other Zila Panchayas Gazetted Officer as the State Government may appoint [in this behalf] shall [not] act as Secretary to the Zila Panchayat.

#### **IV.**—Functions of Zila Panchayat

188. (1) Subject to the provisions of this Act and the rules made therounder, it shall be the duty of the Zila Panchayat to—

- (i) encourage the establishment and foster the development of the Gram Panchayat in the district;
- (ii) supervise and control the administration of Gram Panchayat in the district;
- (iii) examine and approve the budget of Janapada Panchayats in the district:
- (iv) distribute the funds allotted to the district by the Central or State Government among the Janapada Panchayats in the district;
- (v) co-ordinate and consolidate the Janapada Panchayar plans:
- (vi) secure the execution of the plans, projects, schemes or other works common to two or more Janapada Panchayats in the district;
- (vii) supervise generally the activities of the Janapada Panchayat:
- (vill) afford guidance or assistance to the Janapada Panchayats]
  - the demands for grants for special (ix) consolidate purposes received from the Janapada Panchayats and forward them to Government ;
  - (x) co-ordinate the inter block activities;
- (xi) bring to the notice of the Collector and the Commissioner of the Division in which the Zila Panchayat is situate serious irregularities, if any, committed by Gram or Janapada Panchayats;
- (xii) arrange supply of equipment like boring machines, bull dozers,, tractors, etc., to Gram Panchayats and Janapada Panchayats in the district on such terms as may be prescribed ;
- (xili) advise Government in all matters relating to the development activities;

Powers and functions of Chairman and Vice-Chairman.

- (xiv) advise Government on the allocation of work among the Gram Panchayats and Janapada Panchayats and co-ordination of work between the two bodies and among the various Panchayats themselves;
- (xv) advise Government on matters concerning the implementation of any statutory or executive orders specially referred by the Government to the Zila Panchayat;
- (xvi) collect statistics from the Gram and Janapada Panchayats and maintain them:
- (xvii) require any local authority to furnish information regarding its activities; and
- (xviii) exercise and perform such other powers and functions as the Government may, by notification, confer on or entrust to it:

(2) The State Government may, by order add to or withdraw any of the functions mentioned in sub-section (1) or direct the performance of any such function subject to such modifications or restrictions as may be specified therein.

189. (1) The Zila Panchayat or any of its Standing Com- or Standing mittee may at any time require the Secretary-

Zila Panchayat Committee may

- (a) to produce any record, correspondence or other require Secretary document which is in his possession or control documents. as Secretary :
- (b) to furnish any return, plan, estimate, statement, account or statistics concerning or connected with any matter appertaining to the administration of this Act [or the local Government of the blocks] within the district:
- (c) to furnish a report by himself, or to obtain from any of the officers subordinate to him and furnish with his own remarks thereon a report, upon any subject concerning or connected with the administration of this Act for the local Government of the blocks] within the district.

(2) Subject to rules made under this Act, every such requisition shall be complied with by the Secretary.

190. (1) The Zila Panchayat shall have power—

- (i) to call for any proceedings of a Gram Panchayat or Power to call Janapada Panchayat, or an extract therefrom or for proceedings any book or document in the possession or control of a Gram Panchayat or Janapada Panchayat, and any return, statement, account or report which the Zila Panchayat thinks fit to require such Panchayats to furnish:
- (ii) to require a Gram or a Janapada Panchayat to take into consideration :---
  - (a) any objection which appears to the Zila Panchayat to exist to the doing of any thing which is about to be done, or is being done by such Panchayat; OF

# (b) any information which the Zila Panchayat is able to furnish, and which appears to the Zila Pancluayat to necessitate the doing of certain things by the Gram or Janapada Panchayat;

and to make a written reply to the Zila Panchayat within a reasonable time stating its reasons for [not desisting from the] doing or not doing such things.

[(2) All or any of the powers given to the Zila Panchayat under sub-section (1) may be delegated by it to its Chairman, Vice-Chairman or the Secretary or any other Officer of the Zila Panchayat.]

Delegation of duties etc. 191. (1) The Zila Panchayat may delegate to its Chairman, Vice-Chairman or the Secretary, the duties specified in clauses (ii), (v), (vi), (vii), (x), (xii), (xvi), and (xvii) of section 188.

(1-a) All or any of the powers given to the Zila Panchayat under sub-section (1) of section 190 may be delegated by it to its Chairman, Vice-Chairman or the Secretary or any other officer of the Zila Panchayat.

(2) The Zila Panchayat may accept and utilize the services of any person who in the opinion of such Zila Panchayat is specially fitted to assist it in this behalf in an honorary capacity for the performance of any duties which may be delegated under sub-section (1).

#### V.—Zila Panchayat Fund

t 192. (1) Every Zila Panchayat shall establish and maintain a fund called the Zila Panchayat Fund.

(2) The following shall form part and be paid into the Zila Panchayat Fund, namely:—

- (i) all sums allotted by the Government for distribution to Janapada Panchayats for the execution of the community development programme;
  - (ii) all sums received by way of contributions from the All India Bodies or other institutions for the development of cottage, village and small scale industries and the like;
  - (iii) income accruing from trusts or endowments administered by the Zila Panchayat;
- (iv) such contributions as the Janapada Panchayats within the district may with the previous approval of Government, be required to make out of their funds to the Zila Panchayats;
- (v) such percentage of land revenue, forest revenue, other taxes or fees as may be payable by the Government to the Zila Panchayat under this Act or under any other enactment for the time being in force;
- (vi) such other sums as may be assigned to the Zila Panchayat Fund by special or general order of the Government.

Zila Panchayat Fund.

193. (1) Subject to the provisions of this Act and the Application of rules made thereunder, the Zila Panchayat Fund shall be applied Zila Panchayat for the purposes of this Act.

(2) Any amount allotted to the Zila Panchayat by the Government or any person or body for any specific work or purpose shall be applied exclusively for such work or purpose and in accordance with such instructions as the Government may either generally or specially issue in this behalf.

194. (1) The Administration of the Zila Panchayat Fund Administration of shall, subject to the control of the Government, be in the hand Zila Panchayat Fund. of the Zila Panchavat.

(2) All moneys at the credit of the Zila Panchayat shall be kept in the name of the Zila Panchayat in the nearest Government Treasury, Sub-treasury or Post Office Savings Bank or a Co-operative Bank.

#### V.-Establishment, Budget and Accounts

(1) Subject to the rules made under this Act, a Zila Officers 195. and Panchayat may, with the previous approval of the Government, servants of employ such officers and servants as may be necessary for the Zila Panchayat. efficient discharge of its duties.

(2) The gualifications, method of recruitment, salaries, leave allowances and other conditions of service including disciplinary matters shall be such as may be prescribed.

196. A Zila Panchayat may in accordance with the rules Establishment of made under this Act-

- (a) establish and maintain a provident fund on behalf of the officers and servants; and
- (b) grant gratuity to any officer or servant subject to the previous approval of the prescribed authority.

197. (1) The Secretary of the Zila Panchayat shall on or Preparation of before the fifteenth day of February each year, cause in the annual estimate prescribed form and manner, to be prepared and placed be- of income and fore the Zila Panchayat, an estimate of the income and expenditure. expenditure of the Zila Panchayat for the next financial year.

(2) The Zila Panchayat shall consider the estimate and may approve of it with or without modification and forthwith submit the same to the Commissioner and the State Government for information:

Provided that no estimate shall be approved upless provision is made therein for the Zila Panchayat having at its credit at the end of the year a balance of not less than such amount as may be prescribed.

(2-a) If it appears to the Commissioner that the budget estimate so approved is in any way contrary to the provisions of this Act or the rules made thereunder, he shall require the Zila Panchayat to modify it in conformity with such provisions and the Zila Panchayat shall forthwith comply with such requisition.

Provident Fund.

(3) If in the course of the year the Zila Panchayat finds it necessary to make any alteration in the budget estimate with regard to receipt or to the distribution of the amounts to be expended for the purposes of this Act, a supplemental or revised budget may be framed, sanctioned and submitted in the manner provided in sub-sections (1) and (2).

198. Accounts of receipt and expenditure of every Zila Panchayat shall be kept in such forms and in such manner ap may be prescribed.

199. The Zila Panchayat shall keep at its office a copy of every estimate as approved under section 197 and of every account made up under section 198 and any person residing in the District may at any time during office hours inspect any such estimate or account free of charge.

200. An abstract of every annual account of a Zila -Panchayat showing the income of the Zila Panchayat fund under each head of receipts, the charges for establishment, allotments to Janapada Panchayats and balance, if any, of the fund remaining unspent, shall be prepared by the Zila Panchayat and shall be published annually in such manner as may be prescribed.

# CHAPTER XV.—ADMINISTRATION OF JUSTICE

#### I.—Conciliation Board

Definition of dispute. 200-A. In this Chapter unless the context otherwise requires dispute means a dispute whether civil or criminal and includes an offence.

201. [(1) On the application of either party to a civil dispute, or of a complaint in the case of an offence cognizable by the Nyaya Panchayat, the Gram Panchayat having jurisdiction under section 203 shall subject to rules framed under this Act constitute a Conciliation Board to facilitate conciliation between the parties to such dispute.

(2) Every application for conciliation under sub-section (1) shall specify the names, description of the parties and the particulars of the dispute and shall be signed by the applicant.

(3) Notwithstanding anything contained in this section, the Gram Panchayat may constitute a Conciliation Board on the oral request of a party to the dispute or complaint in the case of an offence to the Sarpanch or Upsarpanch who shall ascertain from the parties the particulars referred to in sub-section (2' and get such request and particulars reduced to writing and obtain the signature of the party making the request thereof.

*Explanation.*—In this Chapter unless the context otherwise requires, for the purposes of this Chapter dispute means a dispute whether civil or criminal and includes an offence.]

- (i) Sarpanch [of the Gram Panchayat] or the Upsarpanch of the Gram Panchayat who shall be the Chairman of the Board, and
- (ii) [a panch] two Panchas of the Gram Panchayat, one to be nominated by each of the two parties:

Provided that the Sarpanch or Upsarpanch shall [not] be [qualified] disqualified to be a member of the Conciliation Board, if he is—

- (i) in any way connected with the dispute so as to have interest or stake involving general gain or loss therein;
- [(ii) the father, son, uncle, grandfather, nephew, brother, sister, wife or next cousin or sister or a party to the dispute:]
  - (ii) a near relation of the parties to the dispute and in the opinion of the Gram Panchayat is not a fit person to act as a member of the Board on account of such relationship:

Provided further that where both the Sarpanch and the Upsarpanch are [not] so disqualified the Gram Panchayat shall nominate one of the panchas of the Gram Panchayat who is not so disqualified to be a [member] Chairman of the Board in place of the Sarpanch or Upsarpanch.

[(2) As soon as may be after a Conciliation Board has been constituted for the conciliation of any dispute, the Gram Panchayat shall forward to such Board the application mede under sub-section (2) of section 201, or the papers pertaining to the oral request, as the case may be, for conciliation of the dispute.] (3) For the purpose of constituting the Board, the Sarpanch or Upsarpanch of the Gram Panchayat shall call upon each party to submit, within a specified time which shall not be less than three days, the name of the Pancha whom it wishes to nominate as member of the Board and after the receipt of the names, the Board shall be constituted by the Gram Panchayat:

Provided that if any party fails to nominate a Panch as member of the Board within the specified time the Gram Panchayat shall nominate any panch on the Board on behalf as such party.

(4) As soon as may be after a Conciliation Board has been constituted for the conciliation of any dispute, the Gram Panchayat shall forward to such Board, the application made under sub-section (1) of section 201, or the papers pertaining to the oral request, as the case may be, for conciliation of the dispute.

[203. In the case of an offence, the Gram Panchayat within whose jurisdiction the offence has been committed and in the case of a civil dispute the Gram Panchayat within whose jurisdiction the defendant resides, or works for gain, shall have power to conciliate, and Panchas of such Gram Panchayat alone can become members of the Board.]

203. In the case of an offence, the Gram Panchayat within whose jurisdiction the offence has been committed and in the case of a civil dispute the Gram Panchayat within whose jurisdiction, the defendant resides or carries on business or works for gain, shall have power to constitute a Board for the conciliation of such dispute from amongst its members in accordance with the provisions of this Act.

204. The [Conciliation] Board may hold its proceedings at any place within the jurisdiction of the Gram Panchayat.

205. (1) The Board shall fix a date, time and place of hearing and shall inform the parties concerned sufficiently in advance so as to allow reasonable time for appearance:

Provided that in case a party is a minor or a person under disability either his parents or lawful guardian shall be informed by the Board of the first date, time and place of hearing.

Explanation.—For the purposes of this section the expression "lawful guardian" includes any person who for the time being has the actual charge of or control over the minor or the person under disability.

(2) Each party to the dispute shall appear before the Board at the time and date fixed:

[Provided that a woman shall not be compelled to appear in person before the Board and may be represented by her duly authorised agent.]

Place of proceedings.

Jurisdiction.

Appearance of parties and proceedings. Provided that a woman or a minor or a person under disability shall not be compelled to appear in person before the Board and may be represented by her husband or her duly authorised agent or by his parents or lawful guardian, as the case may be.

(3) The proceedings shall not be open to the public, [but the husband of the party or parents or lawful guardian of the party, who is a minor or is a person under disability, may be present at the hearing.]

(4) Subject to the rules framed under this Act, the Board may impose a fine not exceeding ten rupees on any party failing to appear before the Board without sufficient cause.

(5) No legal practitioner shall appear on behalf of any party to a dispute in any proceedings before the Board.

206. Subject to the provisions of section 209 the [the] Proceedings and conciliation proceedings shall be oral and as far as possible conciliation. continuous and shall be concluded within one month of the date of reference.

207. The Board shall hear witnesses produced by the parties Producing of concerned or voluntarily appearing before it but it shall not witnesses, have power to summon them and no evidence shall be taken down in writing.

208. The Board shall have no power to administer an oath No administraeither to the party or witness. tion of oath.

209. (1) If compromise between the parties is effected. Result of it shall be reduced to writing and brought on record.

(2) The record shall contain-

- (a) the time and place of proceeding;
- (b) the names of the parties appearing, their lawful representatives [and guardians], if any;
- (c) a brief statement of the case of each party;

Provided that where a party is a minor or a person under disability, the compromise will not be binding on him unless the Board certifies that it is in his interest.

(2) A Nyaya Panchayat shall consist of such number of Panchas as the Collector may fix in respect of such Gram Sabha area situate within the Circle:

Provided that the total number of Panchas of a Nyaya-Panchayat shall not be less than five. (3) Every Gram Panchayat shall at its first meeting or within such time thereafter and in such manner as may be prescribed, elect from amongst the members of the Gram Sabha qualified to be a Panch of the Gram Panchayat and possessing the prescribed qualifications such number of members as Panchas of the Nyaya Panchayat as may be fixed under sub-section (2):

Provided further that if the Gram Panchayat fails to elect Panchas of the Nyaya Panchayat within the time prescribed, the Collector may appoint any member of the Gram Sabha qualified to be a Panch of the Gram Panchayat and possessing the prescribed qualifications, to be a Panch of the Nyaya Panchayat.

(4) The [High Court] Sessions Judge may confer on any Civil Judge having jurisdiction in the area in which the Nyaya Panchayat is situate the powers exercisable by him under sub-section (3) Provided that such powers shall not be conferred on any Civil Judge who is not confirmed and has not held a judicial office for a period of not less than three years.

(1) The [High Court] Sessions Judge may, at any Cancellation of time, for just and sufficient cause, cancel the jurisdiction jurisdiction, in of a Nyaya Panchayat with respect to any criminal case and may direct that while the question of such cancellation is under consideration, the proceedings before the Nyaya Panchayat in that case shall be stayed.

(2) The [High Court] Sessions Judge may, confer on any Civil Judge having jurisdiction in the district powers exercisable by him under sub-section (1).

253. (1) An order under sub-section (1) of section 252 Effect of such shall operate to restore the jurisdiction of such criminal court order. as would have exercised jurisdiction if this Act had not been passed.

(2) No order under sub-section (1) of section 252 shall affect the period of limitation specified in section 239.

#### CIVIL JURISDICTION

254. (1) Any suit of the following description, if its value Extent of civil does not exceed rupees one hundred shall be cognizable by a jurisdiction. Nyaya Panchayat:—

- (a) suits for ascertained sums;
- (b) a suit for the recovery of movable property or for the value thereof;
- (c) a suit for compensation for wrongfully taking or injuring movable property;
- (d) a suit for damages caused by cattle trespass:

Provided that no Nyaya Panchayat shall take cognizance of  $\rightarrow$ 

- (i) a suit for a balance of partnership account, unless the balance has been struck by the parties or their agents;
- (ii) a suit for a share or a part of a share under an intestacy or for a legacy or part of a legacy under a will;
- (iii) a suit by or against the state or a public servant for acts done in his official capacity or by or against any member of the Nyaya Panchayat before which the suit is filed;
- (iv) a suit by or against a minor or a person of unsound mind;
- (v) save as otherwise provided by this Act a suit cognizable by Revenue Court or a tribunal or authority appointed under any Act for the time being in force;

## (vi) a suit relating to any dispute or matter in respect of which the jurisdiction of a civil court is barred under any law for the time being in force.

(2) The State Government [or the prescribed authority] may, by notification [in the Gazette] direct that the jurisdiction of a Nyaya Panchayat shall be reduced or shall extend to all such suits of such value not exceeding five hundred rupees as may be specified in the notification.

(3) The State Government may, on the recommendation of the Zila Panchayat or otherwise, for reasons to be recorded in writing withdraw from a Nyaya Panchayat the power to take cognizance of all or any of the classes of suits, [made cognizable by the Nyaya Panchayat by sub-section (1)] cognizable by it under sub-section (1).

[(4) With the written consent of both parties recorded in the presence of the Nyaya Panchayat suits of the nature described in sub-section (1) up to such value not exceeding one hundred rupees as may be specified in the notification shall be triable by such Nyaya Panchayat.]

(4) A Nyaya Panchayat may, with the written consent of both the parties recorded in its presence try any suit of the nature described in sub-section (1), the value of which does not exceed rupees one thousand.

255. (1) Every suit instituted in a Nyaya Panchayat shall include the whole of the claim which the plaintiff is entitled to make in respect of the cause of action, but he may relinquish any portion of his claim in order to bring the suit within the jurisdiction of the Nyaya Panchayat.

(2) If a plaintiff omits to sue in respect of, or intentionally relinquishes, any portion of his claim, he shall be precluded from bringing any separate action whether before a civil court or a Nyaya Panchayat for, or in respect of, the portion so omitted or relinquished.

Place of institution. [256. Every suit under this Act shall be instituted before the Nyaya Panchayat within whose jurisdiction the defendant or any defendant in the suit resides at the time of the suit institution of he suit.]

**Place of institution.** 256. Every suit under this Act shall be instituted before the Nyaya Panchayat within whose jurisdiction the cause of action arises or the defendant or any of the defendants in the suit actually or voluntarily resides, or carries on business or personally works for gain.

[(3) The District Judge may, at any time, of his own motion or on an application filed by the person aggrieved within sixty days of the passing of the decree or the order, call for and examine the record of any civil case which has been decided by Nyaya Panchayat situate within the local limits of his jurisdiction, for the purpose of satisfying himself as to the correctness, legality or propriety of any decree or order passed, and as to the regularity of any proceedings of such Nyaya Panchayat and may, when calling for such record, direct that the execution of any decree or order be stayed. The District Judge may after examining the record, pass such order as he may think fit, and his order shall be final and no application for revision or review thereof shall lie:

Provided that no decree or order of a Nyaya Panchayat "shall be varied or reversed unless the party affected thereby has obeen given a reasonable opportunity of being heard:

Provided further that where in the opinion of the District Judge substantial justice has been done between the parties by the Nyaya Panchayat, no decree or order of the Nyaya Panchayat shall be modified or reversed merely on the ground of some irregularity or illegality.]

(3) The District Judge may, at any time, on his own motion or on an application filed by the person aggrieved by any decree or order of a Nyaya Panchayat situate within the local limits of his jurisdiction, within sixty days of the date of such decree or order, call for and examine the record of any civil case pending before or disposed of by such Nyaya Panchayat for the purpose of satisfying himself as to the correctness, legality or propriety of any decree or order recorded or passed, and as to the negularity of any proceedings of such Nyaya Panchayat and may, when calling for such records, direct that the execution of any decree or order be suspended. The District Judge after examining the record may pass such order as he thinks fit and his order shall be final and no application for revision or review thereof shall lie:

Provided that no order of a Nyaya Panchayat shall be 'varied or reversed unless the party affected thereby has been given a reasonable opportunity of being heard :

Provided further that where in the opinion of the District Judge substantial justice has been done between the parties by the Nyaya Panchayat, no decree or order of the Nyaya Panchayat shall be modified or reversed membry on the ground of some irregularity or defect in the constitution of the bench.

(1) The [High Court] District Judge may confer on any Civil Judge having jurisdiction in the area in which the Nyaya Panchayat is situate the powers exercisable by him under sub-section (3) :

Provided that powers under this sub-section shall not be conferred on any Civil Judge who is not confirmed and has not held a judicial office for a period of not less than three years.

266. (1) The [High Court] District Judge may, at any Cancellation of time for just and sufficient cause, cancel the jurisdiction of jurisdiction in a Nyaya Panchayat with respect to any civil case and may civil cases. direct that while the question of such cancellation is under consideration the proceeding before the Nyaya Panchayat in that case shall be stayed.

## PROCEDURE IN CIVIL AND CRIMINAL

## CASES

Institution of [269. (1) Subject to the provisions of section 238 and Civil or Criminal 256 any person who wishes to institute a civil or criminal case. (1) Subject to the provisions of section 238 and case triable under this Act by a Nyaya Panchayat shall make an application orally or in writing to the Pradhan or Up-Pradhan or in the absence of both to such other panch as may be nominated in this beha<sup>1</sup>f by the Nyaya Panchayat or in the absence of both, to the Secretary of the Nyaya Panchayat, together with such fed as may be prescribed.]

> (1) Subject to the provisions of sections 238 and 256 any person who wishes to institute a suit, case or other proceedings triable under the Act by a Nyaya Panchayat shall make an application orally or in writing to the Pradhan or Up-Pradhan of the Nyaya Panchayat having jurisdiction and in the absence of both to the Secretary of the Nyaya Panchayat, together with such fee as may be prescribed.

(2) In every suit the plaintiff shall state its value.

Register of application.

270. (1) Where a suit, case or proceeding is instituted orally or in writing the Pradhan, Up-Pradhan or [Panch] Secretary receiving the application shall record without delay the prescribed particulars in a register and the signature or thumb impression of the applicant shall be taken thereon.

(2) The Pradhan or Up-Pradhan or in their absence the Secretary of the Nyava Panchayat shall thereupon [appoint] constitute a Bench of a Nyaya Panchayat under section 232, refer the said application to that Bench for disposal, fix a date for the first hearing of the application before the said Bench and give notice of the said date to the applicant and to the members thereof.

Manner of procedure.

271. Every suit, case or proceeding instituted in accordance with the provisions of section 269 shall be brought before the Bench of the Nyaya Panchavat on the date fixed and the Bench shall, unless the Pradhan or Up-Pradhan is a member of it, choose one of their members to be the Chairman of the Bench who shall conduct the proceedings.

Power to summon witnesses, etc. 272. (1) In disposing of [cases] a case, suit or proceeding instituted under this Act or references made under section 287 or section 288. a Nvava Panchayat shall subject to rules made under this Act, have power to issue summons, to require the attendance of any person either to give evidence or to produce any document or to enter upon any land or to do such other act as it may consider necessary for the proper disposal of such [cases] case, suit or proceeding or references.

(2) A summons issued under sub-section (1) shall be signed by one of the members of the Bench or by the Chairman of the Bench and shall be served in the manner provided in rule made under this Act. (3) Any person receiving a summons or other process under sub-section (1) shall be bound to comply with the same.

273. Subject to rules made under this act a [A] Nyaya Power to issue Panchayat shall have powers [subject to rules made under this Act] to issue notice to the defendant or accused in any civil or criminal case instituted before it requiring him to attend at the time and place of hearing fixed and may require him to attend with his witnesses.

274. (1) If after the service of the notice provided for Non-appearance in section 273, the accused in a criminal case fails to attend and [a majority of] the bench trying the case is of opinion that he is evading attendance, the [Nayaya Panchayat] the Bench may apply to the Collector, who may compel his appearance before the bench as if the Collector were a Magistrate trying the case and the Nyaya Panchayat were his Court.

(2) When any accused person has been, under sub-section (1), compeller to appear before a [Nyaya Panchayat] the Bench it shall forthwith [take] record statement and thereafter his attendance shall not be deemed to be compulsory.

(3) If on the date fixed for the hearing of a criminal case or on any date to which the hearing may be adjourned, the complainant fails to attend, the [Nyaya Panchayat] Bench may either proceed to hear the case or decide it in his absence.

275. (1) If after the service of the notice provided for in Non-appearance section 273 the defendant in a suit fails to attend [and a of defendant. majority of the Nyaya Panchayat] and the Bench trying the suit is of opinion that he is evading attendance, [the Nyaya Panchayat] the Bench may either proceed to try the suit or decide it ex parte against him :

Provided that any defendant against whom a suit has been decided *ex parte* may, within thirty days from the date of such decision, apply, orally or in writing, to the [Nayava Panchayat] the Bench to set aside the order and [the Nyaya Panchayat] the Bench shall, if it is satisfied that the defendant did not receive due notice of the date of hearing or was prevented for any sufficient cause from appearing, set it aside and shall appoint a date for proceeding with the suit.

(2) If on the date fixed for the hearing of a suit or on any other date to which the hearing may be adjourned the plaintiff fails to attend, the [Nyaya Panchayat] the Bench may either proceed to try the suit or decide it in his absence or make an order that the suit be dismissed:

Provided that if on the failure of the plaintiff to attend, a suit is dismissed or decided, the [Nyaya Panchayat] Bench may reopen it if within thirty days from the date of such

dismissal or decision the plaintiff satisfies it that he was prevented by any sufficient cause from appearing, when the suit was called on for hearing.

(2) The parties to a criminal case triable by a Nyaya Panchayat shall appear personally before it, provided that the Nyaya Panchayat may, in any case, dispense with the personal attendance of an accused and permit him to appear by agent.

*Explanation.*—"Agent" in sub-sections (2) and (3) means a person authorized in writing to appear and plead for the party he represents, and recognised by the Nyaya Panchayat as fitted to be a representative, and shall be a relative, partner, or full-time servant of such party.

**Exemption:** from [278. [279. A Nyaya Panchayat shall decide any civil, criminal-case which it is competent to try, in accordance with any lawful settlement, or compromise or oath freely agreed to by the parties.]

279. (1) A Nyaya Panchayat shall in any case, suit or other proceeding before it, except where such case, suit or other proceeding is not fit for compromise, try to effect compromise between the parties to the dispute.

(2) A Nyaya Panchayat shall decide any suit, case or other proceeding which it is competent to try in accordance with any lawful settlement, compromise or oath fively agreed to by the parties, which shall be reduced to whiting.

280. A Nyaya Panchayat shall receive such evidence in Procedure and a suit, case or proceeding as the parties may adduce and may powers to call for such further evidence as, in their opinion, may be neces- ascertain truth sary for the determination of the points in issue. It shall be the duty of a Nyaya Panchayat to ascertain the facts of every suit, case or proceeding before it by every lawful means in its power and thereafter to make such decree or order, with or without costs, as may seem to it just and legal. (2) If the District Judge or the Sessions Judge, as the case may be, is of the opinion that the suit or the case is of such nature, difficulty or importance that it ought not to be tried by the Nyaya Panchayat or that the accused in a case ought to receive a punishment different in kind from, or more severe than, that which such Nyaya Panchayat is empowered to inflict, such court shall pass orders directing the plaintiff or complainant to the civil or criminal court, as the case may be, competent to take cognizance of such suit or case.

Summary trial 285. Notwithstanding anything contained in any other enactment for the time being in force, the Nyaya Panchayat shall, in the trial of the criminal cases or civil suits follow such summary procedure as may be prescribed.

**Power to inspect** 286. ## II

## (Translated form original Hindi)

The establishment of Panchayat Raj in the State has been much talked of but the bill for purpose leaves much to be desired by way of safequarding the fundamental rights, ensuing security, progress, and equality among the village folk. The Select Committee have introduced many valuable changes in the Bill such as the elimination of classification of Panchayats but there are still several changes which skilled place in the Bill.

Bin The first. Gram Panchayats are not to be on basis of adult franchise and the Panchas will be nominated by the Government and its term has been extended up to two years. This means that the Government have given the power of postplaning-election, for two years. Similarly in section 112 the Janapada Panchayats will be constituted by nomination which is an improper and reactionary move.

"The section 32 there is no specification of the grounds for the removal of a Puncha which will give officers a chance to act according to their own will. This clause should be deleted.

underschein a Gram Sabha area, if any person complains that a vaccinator, Revenue Jaspector, Patwari, constable, forest guard or chowkidar misbehaves in his official capacity in the Gram Sabha area, the Gram Panchayat could enquice in this case and convey the results of its enquiry to the concerned officers underschem Ahat official is working. This provision was proper but its effect would be imarked if the amon limit is accepted. Similar powers should have been conferred to the Janapadas in connection with school masters, nurses, compounders, head constables and police sub-inspectors. Zila Panchayats ought to have been conferred with similar powers in regard to the district officers. This only would have given the people some relief. In the present Bill Gram Panchayat has only the right of giving information.

In section 87 illere is a provision for the levy of a cess on land revenue of three annas. In comparison to other classes of people the condition of cultivators is pitiable and weak. The cultivator pays land revenue even if he cultivates a 'bigha' of land. Ho has to pay other taxes directly or indirectly. Therefore it would be an injustice to the cultivators to impose the cess on him. The cultivator is unable to be at this burden. This will be a kind of irritation to the cultivators. Hence it would be proper to delete this section.

In section 88 persons with megre income should be exempted from profession tax

In section 99 in the constitution of Adivasi Panchayat the Sarpanch should not be nominated by the Government but should be elected.

"In section 187 the Secretary of the Zila Panchayat is a Gazetted Officer, in plate of him the Collector of the district should be made the Secretary as has been done in Rajasthur."

In this Bill the G wernment has reserved some rights with it which should be given to the Panch yats. The Collector has been given so many powers that the Panch yats would a puppet in his hands.

di In section 301, 303, 304, 305, 314, 319 and 320 the powers which have been assigned to the Collector and other officers should remain with the Panchayats and concerned higher officials.

It is therefore necessary that many changes should be made in the Panchayat Bill to make it more advantageous to the people and to provide a strong foundation for real democracy.

We, the following members beg to submit our joint minute of dissent on the following clauses of the Madhya Pradesh Panch yat Bill as amended by the Select. Committee.

1. Clause 81(1) may be kept as it is in the original Bill. The words "may collect and furnish the relevant information" as inserted in the clause may be deleted.

Similarly after clause 153 of Chapter XII relating to Janapada Panchayat and clause 200 relating to Zila Panchayats new clauses on the lines of clause 83 should be added under which on receipt of a complaint in case of Janapada area against School Teacher, Vaidya, Compounder, Nurse, Head Constable, Police Inspector, and Naib-Tabsildar, the Janapada Panchayat should have right to enquire and report in the matter, also on receipt of such a complaint in the Zila Panchayat area, the Zila Panchayat should have the right to enquire Gircle Inspector, Hand Muster, Agriculture Assistant and report in the matter, also

3. In clause 87 of Chapter VII, a cess of 19 nP. per rupee of Land Revenue has been imposed. There has been difference of opinion amongst members as regards this item. Keeping in view the conditions prevailing in the various regions of the State, we have come to the conclusion that the cess should be imposed at 10 nP. per rupee instead of 19 nP. per rupee and on part thereof, at, 5, nP<sub>t</sub> per rupee.

## Explanation

The incidence of Land Revenue at present differs from region to region and in some region it is very high and in some very low. So long as this inequality is not removed it will not be adivisable to impose high rates of cess.

In Madhya Bharat the cess is 3 nP, in Vindhya Pradesh and Bhopal  $6 nP_i$ and in Mahakoshal it is 19 nP, per rupce of the Land Revenue. As it is essential to make the Panchayats self-sufficient, the rate of cess should be 10 nP, per rupce and at 5 nP, on part thereof.

## GENERAL

Power to instruct Nyaya Panchayat.

292. (1) The Government may authorise any Judicial officer or class of such officers to inspect the Nyaya Panchayat and instruct them in the performance of their duties.

(2) The State Government shall prescribe the channel through which and the authority to whom the reports of such inspection shall be submitted.

293. (1) The Government may, by notification disestablish a Nyaya Panchayat or change the limits of its jurisdiction :

Provided that no such notification shall be issued unless a notice of the proposal inviting objections from the persons likely to be affected thereby by a date to be specified therein has been published in the Gazette and the objections, if any, received have been considered by the State Government.

(2) On the issue of a notification under sub-section (1), disestablishing a Nyaya Panchayat, the following consequences shall ensue, namely :---

- (a) the Pradhan, Up-Pradhan and the Panchas of such Nyaya Panchayat shall vacate their respective offices;
- (b) all civil and criminal cases and other proceedings pending before the Nyaya Panchayat on the date of disestablishment shall be taken over by the District Judge or Sessions Judge, as the case may be, and transferred for trial and disposal to such other Nyaya Panchayat as he may deem fit, and such other Nyaya Panchayat shall, notwithstanding anything in [section 217] sections 217, 238 and 256 have jurisdiction to try and dispose of the cases so transferred; and
- (c) every employee of such Nyaya Panchayat whether permanent or temporary, shall unless he is offered some other employment on terms similar to those in force, entitled to recover from the [State Government] Janpad a Panchayat by way of compensation a sum equal to his existing pay and allowances for one month.

294. Whenever a Nyaya Panchayat is established or disestablished or there is a change in the limits of its jurisdiction, powers or name, the Zila Panchayat shall proclaim the facts and inform the Commissioner, the Collector, the District and Sessions Judge, the [District] Superintendent of Police, the Director of Panchayat and the Chief Executive Officer of the Janapada Panchayat concerned.

296. If, on the application of a decree-holder or the judge- Satisfaction of ment-debtor the Nyaya Panchayat, after enquiry finds that the adjustment of decree has been satisfied or adjusted, fully or in part, the Nyaya decree to be recorded. Panchayat shall record the facts in the prescribed register.

297. (1) If a decree remains unsatisfied for one month after Execution the due date or any amount payable under it remains unpaid for through Collecone month after the date when it fell due, and the decree-holder tor. applies to the Nyaya Panchayat for execution within one year from such date, the Nyaya Panchayat shall, after sending for the judgment-debtor and ascertaining that the decree cannot be satisfied otherwise and on recovery of the prescribed for certify accordingly to the Collector.

(2) On receipt of the certificate, the Collector shall, if the decree is for money, proceed to recover the amount as if it were an arrear of land revenue.

(3) If the decree is for any specific movable property, the Collector shall cause the said property to be delivered to the decree-holder, and in so acting he shall exercise all the powers of a civil court under the Code of Civil Procedure, 1908 (5 of 1908).

Explanation .-- In this section "decree-holder" and "judgment-debtor" includes a representative in interest.

298. The fine imposed in a case by a Nyaya Panchayat Recovery of fine, shall be recoverable as an arrear of land revenue. [as may be provided.]

#### CHAPTER XVI—CONTROL

299. The Government may, for the purposes of this Head of Act, appoint a Director of Panchayats and one or more department. Deputy Directors of Panchayats and may, by notification, delegate to such Director or Deputy Director, any of its powers, or any of the powers of the Commissioner, Collector or Zila Panchayat.

300. (1) The State Government may appoint as many Inspectors of persons as it thinks fit to be Inspectors for the purposes Gram and of inspection and instruction of Gram and Nyaya Panchavats Nyaya Panchaand for performing such other duties as may be prescribed. yata.

(2) No such Inspector shall inspect the records of cases disposed of by or pending before a Nyaya Panchayat.

301. (1) Any office bearer or officer of the Janapada General power of Panchayat or Zila Panchayat, the Director or Deputy inspection of Director of Panchayats or a Revenue Officer not below the work of Gram rank of a Tahsildar or such other officers as the Government may by notification empower in this behalf, may inspect the proceedings of Gram Panchayats.

- (2) Any such office bearer or officer may-
  - (a) enter on and inspect any immovable property occupied by a Gram Panchayat, or any work in progress under its direction;
  - (b) enter on and inspect any school, dispensary, or vaccination station under the control of any Gram Panchayat or any other institution maintained by or under the control of any Gram Panchayat;
  - (c) call for or inspect any document which may be, for the purposes of this Act, in the possession of or under the control of a Gram Panchayat;
  - (d) require a Gram Panchayat to furnish such statements, accounts and reports as he may think fit.

(3) A report of such inspection shall be submitted by such office bearer or officer to such authority as may be prescribed.

(4) The Gram Panchayat and its office bearers and the Secretary shall be bound to afford to the office bearers and officers aforesaid, such access at all reasonable times to Gram Panchayat property or premises and to all documents as may be necessary to enable them to discharge their duties under this section.

(5) Every requisition made under clause (c) or clause (d) of sub-section (2) shall be complied or caused to be complied by the Sarpanch without unreasonable delay and if any Sarpanch fails to do so without sufficient cause, he may, after a reasonable opportunity of being heard, be removed by the State Government.

302. The following shall be visitors of every Gram Panchayat—

- (i) all members of Madhya Pradesh Legislative Assembly and members of the Parliament residing in the district in which the Gram Panchayat is situate or the constituencies from which they have been returned form part either wholly or partly of the Gram Sabha area; and
- (ii) such other non-officials as may be appointed by the State Government.

303. (1) The office bearers of the Zila Panchayat, the Director or Deputy Director of Panchayat, the Commissioner, the Collector and such other officers as the State Government may by notification empower in this behalf, shall have power to examine the proceedings of any

Power of supervision, in respect of Janapada Panchayat, Janapada Panchayat within the district and without prejudice to the generality of the foregoing power may-

- (a) enter on and inspect any immovable property vested in a Janapada Panchayat or any work in progress under its direction;
- (b) enter on and inspect any institution maintained by or under the control of any Janapada Panchayat;
- (c) call for and inspect any document which may be for the purpose of this Act in the possession or under the control of such Janapada Panchayat or any subordinate authority thereof;
- (d) require such Janapada Panchayat to furnish such statements, accounts and reports as the person inspecting may think fit.

(2) The office bearers and the officers and servants of the Janapada Panchayat shall be bound to afford to the persons aforesaid such access at all reasonable times to Janapada Panchayat property or premises and to all documents as may be necessary to enable them to discharge their duties under this section.

304. (1) The Commissioner, Collector, Director or Inspection of Deputy Director of Panchayats and any other officer whom Zila Panchayat, the Government may empower in this behalf may enter on and inspect:—

- (a) any machinery or implements maintained by the Zila Panchayat;
- (b) any document which may be for the purposes of this Act in the possession or under the control of such Zila Panchayat or any subordinate authority thereof; and
- (c) require such Zila Panchayat to furnish such statements, accounts and reports as the person inspecting thinks fit.

(2) The Zila Panchayat shall be bound to afford to the officers referred to in sub-section (1) such access at all reasonable times, to its property or premises and all documents as may, in the opinion of such officer be necessary to enable him to discharge his duties under this section.

305. (1) The Collector, in respect of a Gram Power to Panchayat or a Janapada Panchayat and the Commissioner suspend execuin respect of a Zila Panchayat may by an order in writing etc. with a statement of reasons for making it suspend the execution of any resolution passed, order issued, or licence or permission granted, or prohibit the performance of any act which is about to be done or is being done in pursuance of or under cover of this Act or in pursuance of or under cover of any rule or byelaws made thereunder, if in his opinion:—

- (a) such resolution, order, licence, permission or act has not been legally passed, issued, granted or authorised;
- (b) such resolution, order, licence, permission or act is in excess of the powers conferred by this Act or is contrary to any law; or
- (c) the execution of such resolution or order or the continuance in force of such licence or permission or the doing of such act is likely—
  - (i) to cause loss, waste, or misapplication of any money or damage to any property vested in the Gram, Janapada or Zila Panchayat;
  - (ii) to be prejudicial to the public health, safety or convenience; or
  - (iii) to cause injury or annoyance to the public or to any class or body of persons; or
  - (iv) to lead to a breach of peace.

(2) Whenever an order is made by the Collector or the Commissioner, as the case may be, under sub-section (1), he shall forthwith and in no case later than ten days from the date of order forward to the Government a copy of the order with the statement of the reasons for making it, and the Government may confirm, set aside or modify such order in such manner and to such extent as it may deem fit.

306. (1) In cases of emergency, the Collector or any other officer authorised by the State Government in this behalf may direct or provide for the execution of any work or the doing of any act which a Gram Panchayat or Janapada Panchayat is empowered to execute or do, and immediate execution or doing of which is, in his opinion, necessary in the interest of general public, and may direct that the expenses of executing the work or doing the work shall be forthwith paid by the Gram Panchayat or the Janapada Panchayat, as the case may be.

(2) If the expense is not so paid, the Collector or any other officer authorised in this behalf may direct the officer in custody of the Gram Panchayat fund or the Janapada Panchayat fund, as the case may be, to pay such expense or so much thereof as is possible from the balance of such fund in his hands.

(3) The Collector or the officer as the case may be, shall forthwith and in no case later than ten days from the date of order report to the Commissioner every case in which he exercise the powers under sub-section (1), with a statement of reasons for making it.

Execution of work in certain cases. 307. (1) If at any time, it appears to the Zila Default in Panchayat that a Gram Panchayat has made default in the performance of performance of any duty imposed on it by or under this Act, it may order the duty to be performed within a specified period, and if the duty is not performed within the period specified, the Zila Panchayat, may appoint a person to perform it, and direct that the expense of such performance shall be paid by the defaulting Gram Panchayat within such period as the Zila Panchayat may fix.

(2) If the expense is not so paid, the Zila Panchayat shall direct the person in custody of the Panchayat Fund to pay such expenses, or so much thereof, as is possible, from the balance of such fund in his hands, and such person shall pay such expense or part thereof accordingly.

(3) If at any time it appears to the State Government [of any duty imposed in it by under this Act and that] or to any officer authorised by the State Government in this behalf, that a Gram Panchayat has made default in the performance of any duty imposed on it by an under this Act and that the Zila Panchayat has failed or neglected to take action under sub-section (1), the Government or the officer authorised, as the case may be, may take such action as could have been taken by the Zila Panchayat under subsections (1) and (2).

(4) The Zila Panchayat or the officer authorised, as the case may be, shall forthwith and in no case later than ten days from the date of order report to the Commissioner every case occurring under this section and the Commissioner may revise or modify any order made therein, and may make in respect thereof, any other order which the Zila Panchayat could have made.

308. (1) If any Janapada Panchayat or Zila Pancha-Default in per yat makes default in the performance of any duty imposed formance in on it by or under this Act, the Government may, by an order duty to Janain writing fix a period for performance thereof and in case pada Panchayat of default in performance within the period so fixed, may etc. appoint any person to perform it and may direct that the expenses arising from and incidental to the performance shall forthwith be paid by the Janapada Panchayat or the Zila Panchayat as the case may be.

(2) If such expenses are not so paid, the State Government may make an order directing the person having the custody of the balance of Janapada Panchayat Fund or the Zila Panchayat Fund, as the case may be, to make the payment either in whole or in part as is possible from such balance.

309. The person or officer appointed to take action on Powers of behalf of, or in default of a Gram Panchayat, Janapada officers acting Panchayat or Zila Panchayat under this Act, shall have in default of powers as are necessary for the purpose and shall be enti-Panchayat, Janatled to the same protection and to the same extent under or Zila Panchayat this Act as the Gram Panchayat, the Janapada Panchayat yat. or the Zila Panchayat or its officers or servants whose powers are exercised.

Power to disfor incompetence, default or abuse of powers.

(1) If at any time upon representation made or 310. solve Panchayats otherwise it appears to the Government that a Panchayat is not competent to perform, or persistently makes default in the performance of the duties imposed on it by or under this Act or any other law for the time being in force, or exceeds or abuses its powers or fails to carry out any order passed by the Government under this Act, the State Government may, by an order stating the reasons therefor published in the Gazette dissolve such Panchayat, and may order a fresh constitution thereof.

> (2) If after fresh constitution the new Panchayat other than Zila Panchayat continues to be incompetent to perform or to make default in the performance of such duties or orders or abuses its powers the Government may by an order stating the reasons therefor published in the Gazette, declare the Panchayat to be incompetent or in default or to have exceeded or abused its powers or to have failed to carry out Government orders, as the case may be, and supersede it for a period [to be specified in the order] not exceeding two years.

> (3) Notwithstanding what is stated in sub-sections (1) and (2) if in the opinion of the Government the conditions in the Panchayat other than a Zila Panchayat are such as to justify supersession straight way instead of first dissolving the Panchayat, the Government may by an order stating the reasons for taking such action, published in the Gazette, supersede the Panchayat for a period [to be specified in the order] not exceeding two years.

> (4) No order under sub-section (1) or sub-section (2) or sub-section (3) shall be passed until reasonable opportunity has been given to the Panchayat to furnish an explanation.

> (5) If in the opinion of the Government the circumstances of any Panchayat superseded under sub-section (2) or (3) are such as to justify the extension of the period of supersession specified under the said sub-sections, the Government may, from time to time, by an order stating the reasons therefor, published in the Gazette, extend the period of supersession for such further period as may be specified in such order:

(1) In the event of any dispute arising between Disputes between 317 two Panchayats or between a Panchayat and any other local Panchayats and authority established under the municipal law or any matter bodies. in which they are jointly interested, such dispute shall be referred to the Collector if both the bodies are situate in the same district and to the prescribed authority if they are situate in different districts and the decision of the collector or the prescribed authority thereon, as the case may be, shall be final.

(2) The Government may by rules made under this Act regulate the relations between Panchavats and Panchavats and other local bodies as aforesaid in matters in which they are jointly interested.

318. An appeal or revision shall lie against such Appeals orders of the Gram Panchayat, Janapada Panchayat, Zila revisions. and Panchavat and of other authorities under this Act. to such authorities and in such manner as may be prescribed.

(1) The Government or the Commissioner or any Control of 319other officer authorised in this behalf may call for and Government. examine the record of any proceeding under this Act of any subordinate officer and after such enquiry as is deemed fit. if the Government or the Commissioner or any other officer

for

authorised in this behalf, as the case may be, is satisfied that the order of the subordinate officer is contrary to law and has resulted in a miscarriage of justice, pass such orders thereon as the Government or the Commissioner or the officer authorised in this behalf deems just.

(2) No order under sub-section (1) shall be made to the prejudice of any party unless [he] such party has had an opportunity of being heard.

5. 320. (1) Where on an application of a Panchayat or otherwise the Collector is of the opinion that any person, who in his capacity as a member, officer, servant or Secretary or Chief Executive Officer of such Panchayat had in his custody any record or money belonging to the Panchayat after his removal or suspension from his office and is not likely to deliver such record or pay such money, the Collector may by a written order require that the record or money so detained be delivered or paid forthwith to the Panchayat.

(2) If any such person as aforesaid fails or refuses to deliver the record or pay the money as directed, the Collector may cause him to be apprehended and may send him with a warrant in such form as may be prescribed, to be confined in a Civil Jail till he delivers up the record or pays the money:

Provided that no such person shall be detained in confinement for a period longer than one calendar month.

(3) The Collector may—

- (a) for recovering any such money direct that such money be recovered as an arrear of land revenue and on such direction being given, such money shall be recoverable as an arrear of land revenue from such person;
- (b) for recovering any such record issue a search warrant and to exercise all such powers with respect thereto as may lawfully be exercised by a magistrate under the provision of Chapter VII of the Core of Criminal Procedure, 1898 (5 of 1898).

(4) No action under sub-section (1) or (2) or (3) shall be taken unless reasonable opportunity has been given to the person concerned to show cause why such action should not be taken against him.

321. (1) The Government may, by notification, delocate to any officer subordinate to it or to a Janapada Panchayat or a Zila Panchayat all or any of the power conferred upon it by or under this Act, except the powers under sub-section (5) of section 301 and the power to make rules.

(2) The Government may by notification confer on any officer, the powers conferred by or under this Act on the Director or Deputy Director of Panchayats, Commissioner or the Collector, as the case may be.

(3) The exercise of any power delegated under subsections (1) and (2) shall be subject to such restrictions and conditions as may be prescribed or as may be specified in the notification and also to control and revision by the Government or by such officer as may be empowered by the Government in this behalf. The Government shall also have power to control and revise the acts or proceedings of any officer so empowered.

322. In all matters connected with this Act, unless it General powers is otherwise provided in this Act or in the rules made there of Control. under, Commissioners, Collectors and any other officers authorised in this behalf shall be subject to the same authority and control as is exercised over them in matters connected with the Acts, creating them or their offices.

## CHAPTER XVII.—RULES, BYE-LAWS, PROCEDURE AND PENALTIES

(2) A rule may be general for all Panchayats or may be special for the whole or anyone or more classes of Panchayats, as the Government may direct.

(3) All rules made shall be subject to the condition of previous publication.

(4) All rules shall be laid on the table of the Legislative Assembly.

(5) In making any rule, the Government may direct that a breach thereof shall be punishable with fine which may extend to fifty rupees and in the case of a continuing breach, with fine which may extend to Rs. 5 for every day during which the breach continues after the first conviction.

325. (1) A panchayat may, and if so required by the Byelaws. Government shall, make byelaws consistent with this Act and with rules made thereunder for carrying out the provisions and intentions of this Act, and in particular and without prejudice to the generality of the foregoing power, it may make byelaws for the matters specifically mentioned for making of byelaws in the Act.

(2) In making a byelaw under sub-section (1), the panchayat may direct that a breach thereof shall be punishable with fine which may extend to fifty ruppes and, if the breach is a continuing breach, with further fine which may extend to five ruppes for every day during which the breach continues after the first Conviction.

(3) The power conferred under this section to make byelaws is subject to the condition of the byelaws being made after previous publication for such time and in such manner as the State Government may determine, and no byelaw shall come into force until it has been confirmed by the State Government.

326. (1) The State Government may, from time to time, make model byelaws for any matter in respect of Model byelaws. which a panchayat is empowered to make byelaws under this Act, and publish them in the Gazette for the guidance of panchayats.

(2) The State Government may, by order, require any Panchayat to adopt such of the model byelaws as may be specified in the order after modifying the same to suit the local conditions.

(3) If any panchayat fails to comply with a requisition made under sub-section (2) within six months of the making thereof, the State Government may apply to such panchayat the model byelaws specified in the requisition.

(4) The provisions of section 325 shall, so far as may be, apply to the adoption or application of byelaws under this section.

#### CHAPTER XVIII—MISCELLANEOUS

  - (b) any defect in the election, co-option or appointment of a person acting as a panch or member thereof: or
  - (c) any irregularity in its procedure not affecting the merits of the case.

Where any land is required for the purpose of 345. this Act, and the Gram Panchayat, the Janapada Panchayat or the Zila Panchayat, as the case may be, is unable to acquire it by agreement, the Government may at the request of the panchayat and on the recommendation of the Collector in the case of a Gram Panchavat and a Janapada Panchayat and of the Commissioner in the case of a Zila Panchayat proceed to acquire it under the provisions of the Land Acquisition Act, 1894 (I of 1894) and on payment by the Gram Panchayat or the Janapada Panchayat or the Zila Panchayat, as the case may be, of the compensation awarded under that Act, and of all other charges incurred by the Government in connection with the proceedings, the land shall vest in the Gram Panchayat, the Janapada Panchayat or the Zila Panchayat on whose account it has been so acquired

(2) The Panchayat shall not without the previous sanction of the Government transfer any land which has been acquired under sub-section (1) or divert such land to a purpose other than the purpose for which it has been acquired. - 큰 의 년 77

Nothing in this Act or any rule or byelaw made ebtain likences and hereunder shall be construed as requiring the Central Government or the State Government to obtain any permission »r licence in respect of any property of such Government or any place in occupation or under the control of such Gov-.rnment.

349-A. Notwithstanding anything contained in this Repayment of Ioana. Act, it shall be the duty of a Panchayat to apply annually out of its fund first such sum as may be required for the payment of any amoent falling due on account of any Ioan legally contracted by it.

350. [(1) The annual accounts of the Janapada Pancha-Audit of Panchayat yat and Zila Panchayat shall be subject to audit under the Accounts. Madhya Pradesh Local Fund Audit Act, 1933 (IX of 1933)].

(1) Notwithstanding anything containtd in section 3 of the Madhya Prådesh Local Fund Audit Act, 1933 (IX of 1933), the annual accounts of the Janapada Panchayats and the Zila Panchayats shall be subject to audit under the said Act and such Panchayat shall be liable to pay such audit fee as the State Government may, from time to time, specify in this behalf.

(2) The accounts of the Gram Panchayat shall be subject to audit by Government Departmental Auditors and the Gram Panchayat shall be liable to pay such audit fees as the State Government may, from time to time, specify in this behalf.

(3) Copies of the Audit Report of the Auditor on the annual account of the Panchayat under sub-section (1) or (2) shall be furnished to the prescribed authority in addition to the Sarpanch, President and the Chief Executive Officer, and Chairman and Secretary of the Zila Panchayat.

351. (1) The Sarpanch, President or the Chairman Panchayat authorias the case may be, shall forthwith remedy any defects or use to remedy defeirregularities that may be communicated by the prescribed strand report, authority or Local Fund Audit Department or the Departmental Auditors, as the case may be, and shall send a report to the prescribed authority of the action taken by the panchayat authorities concerned within a period of three months from the date of the receipt of the Audit Report :

Provided that if there is a difference of opinion betweep the panchayat authorities and the prescribed authority or the Local Fund Audit Department, or if the panchayat authority does not remedy any defect or irregularity within the said period of three months, the matter shall be referred to the Government within such time and in such manner as may be prescribed, and the State Government may pass such orders thereon as it thinks fit. The orders of the Government shall be final and the panchayat authorities shall take action in accordance therewith.

(2) If within any period fixed by an order made by the Government under sub-section (1), the panchayat authority concerned fails to comply with such orders, the provisions relating to defaults contained in section 313, shall with necessary modifications, be deemed to apply in this case and the Government shall act accordingly.

352. The irrecoverable sums due to a Gram Panchayat, Janapada Panchayat or Zila Panchayat shall be written off in such manner and by such authority as may be prescribed:

Provided that no sum exceeding five thousand rupees shall be written off without the sanction of the Government.

Prohibition remuneration members etc. of 353. No member of a panchayat or a Panch of a allowance of any kind whatsoever by the panchayat or the Nyaya Panchayat except with the previous sanction of the prescribed authority and in accordance with the rules made in this behalf.

Records of 354. Subject to rules made under this Act and on the Panchayats, etc., payment of such fees as may be prescribed, the records of open to inspec- Gram Panchayat, Nyaya Panchayat, Janapada Panchayat, and Zila Panchayat and any committee thereof shall be open to inspection to such persons as may desire it, and certified copies thereof shall be given to such persons as may apply for them.

Methods of serving documents. of any notice or other document under this Act or under any rule, byelaw or order made thereunder on any person to whom it is by name addressed shall be effected—

- (a) by giving or tendering the said notice or document to such person; or
- (b) if such person is not found, by leaving such notice or document at his last known place of residence or business or by giving or tendering the same to some adult member or servant of his family; or
- (c) if such person does not reside in the village of town and his address elsewhere is known to the officer directing the issue of such notice or document by sending the same to him by registered nost acknowledgment due; or
- (d) if none of the means aforesaid be available, by affixing such notice or document upon some

Writing off of irrecoverable sums due to Panchayat conspicuous part of the house, if any, in which the person is known to have last resided or carried on business or personally worked for gain.

(2) When any notice or other document has to be served upon any owner or occupier of any building or land, it shall not be necessary to name the owner or occupier therein, and the service thereof in cases not otherwise specifically provided for in this Act shall be effected either—

- (a) by giving or tendering the notice or document to the owner or occupier or if there be more owners or occupiers than one, to any one of them; or
- (b) if no such owner or occupier be found, then by giving or tendering the notice or document to some adult member or servant of the family or any such owner or occupier as aforesaid; or
- (c) if none of the means aforesaid be available, then by causing the notice or document to be affixed upon some conspicuous part of the building or land to which the same relates.

(3) Every notice which this Act requires or empowers a Gram Panchayat or Nyaya Panchayat or Janapada Panchayat or Zila Panchayat to give or to serve either as a public notice, or generally or by provisions which do not expressly require notice to be given to individuals therein specified, shall be deemed to have been sufficiently given or served if a copy thereof is put up in such conspicuous part of the Gram Panchayat or Nyaya Panchayat or Janapada Panchayat or Zila Panchayat office during such period and in such other public buildings and places, or is published in such local papers or in such other manner as the Gram, Nyaya, Janapada or Zila Panchayats may in this behalf direct.

(4) No notice or bill shall be invalid for defect of form.

(5) Whenever in any notice or other document served under this Act or the rules, byelaws or order made thereunder, a period is fixed within which any tax or other sum 14 to be paid or any work executed, or anything provided, such period shall, in the absence of any provision to the contrary in this Act or the said rules, byelaws, or orders thereunder, be calculated from the date of such service, or in the case of public notice under sub-section (3), from the date of its publication.

(6) When any notice under this Act, or any rule, or byelaw or order requires any act to be done for which no time is fixed, the notice shall fix a reasonable time for doing the same.

(7) In the event of non-compliance with the terms of the notice, it shall be lawful for the Gram, Nyaya, Janapada or Zila Panchayat or any officer authorised by it to take such rction or such steps as may be necessary for the doing of the act thereby required to be done, and all the expenses therein incurred by the panchayat aforesaid shall be paid by the person or persons upon whom the notice was served and shall be recoverable in the manner provided for the recovery of taxes, fines, etc., under this Act.

Any officer of the Planning and Development, of Commerce and Industry, Public Works, Forest, Education, Agriculture, Medical and Public Health, Law, Revenue, Panchayat and Social Welfare Department whom the State Government may by general or special order appoint in this behalf shall be entitled to attend any meeting of a Gram or Janapada Panchayat and advise and assist it on any matter affecting the work of his department.

357. (1) The State Government may subject to rules made under this Act, empower any Gram Panchayat or the Sarpanch or Up-sarpanch thereof or any Janapada Panchayat or the President or Vice-President thereof or any Zila Panchayat or the Chairman or Vice-Chairman or any member, officer or servant of such panchayats to accept from any person in respect of whom there is reasonable ground to believe that he has committed any act or omission punishable under this Act or the rules or byelaws made thereunder a sum of money not exceeding fifty rupees by way of composition therefor.

(2) On payment of such sum of money by the person accused of the offence, no further action shall be taken against such accused and if any proceedings in respect of that offence have already been instituted against him in any Nyaya Panchayat such payment shall have the effect of his acquittal thereof.

(3) Power under sub-section (1) to accept composition in respect of alleged acts and omissions may be given either generally or particularly in regard to specified acts and omissions or such as belong to a specified case.

It shall be lawful for the office-bearers of a Panchayat or for any member or officer authorised by such Panchayat in this behalf to enter for the purposes of this Act, between sunrise and sunset with such assistants as he may deem necessary, into and upon any building or land, for the purpose of making any survey or inspection they may be entitled to make for the purpose of executing any work authorised by this Act to be executed by them:

Provided that, except when herein otherwise provided, no building or land which may be occupied at the time shall be entered unless with the consent of the occupier thereof and without twenty-four hours' written notice thereof having been given to the said occupier:

Provided further that in the case of buildings used as human dwellings, due regard shall be paid to the social and religious customs of the occupiers.

(3) Such petition shall be enquired into or disposed of according to such summary procedure as may be prescribed.

360. When any fee has been imposed under this Act Power to expel or the right to collect it has been leased thereunder, any persons who reperson employed by the Gram Panchayat or Janapada fuse to pay Panchayat or any other prescribed authority or by the fees. lessee to collect such fees may, subject to the conditions of the lease, collect the fees or expel from the place for the use of which a fee is payable, any person who is liable to pay the fee but refuses to pay it.

361. (1) Whenever, under the provisions of this Act Gram Panchayat any work is required to be executed by the owner or occupier in default of of any building, or land, and default is made in the execu-owner or occution, of such work the Gram Panchayat or the Janapada pier may Panchayat, as the case may be, whether any penalty is or and recover is not provided for such default, may cause such work to expenses. be executed; and the expenses thereby incurred shall, unless otherwise expressly provided in this Act, be paid to it by the person by whom such work ought to have been executed and shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under this Act either in one sum or by instalments as the panchayat may deem fit.

(2) If the defaulter be the owner of the building or land, the panchayat may, by way of additional remedy. whether a suit or proceeding has been brought or taken against such owner or not, require, subject to the provisions of sub-section (3), the payment of all or any part of the expenses payable by the owner for the time being, from the person who then or any time thereafter, occupies the building or land under such owner; and in default of payment thereof by such occupier on demand, the same may be levied from such occupier, and every amount so leviable shall be recoverable in the same manner as an amount claimed on account of any tax recoverable under this Act. Every such occupier shall be entitled to deduct from the rent payable by him to his landlord so much as has been so paid by or recovered from such occupier in respect of any such expenses.

(3) No occupier of any building or land shall be liable to pay more money in respect of any expenses charged on the owner thereof, than the amount of rent which is due from such occupier for the building or land in respect of which Juch expenses are payable at the time of the demand made upon him, or which at any time after such demand and notice not to pay the same to his landlord has accrued and become payable by such occupier, unless he neglects or refuses, upon application made to him for that purpose by the panchayat, truly to disclose the amount of his rent, and the name and address of the person to whom such rent is payable; but the burden of proof that the sum demanded of any such occupier is greater than the rent which was due by him at the time of such demand, or which has since accrued, shall be upon such occupier:

Provided that nothing herein contained shall be deemed to affect any special contract made between any such occupier and the owner respecting payment of the expense of any such works as aforesaid.

Special provision for resolution of difficulties. [362. If the circumstances of any panchayat are such that in the opinion of the Government any provision of this Act is unsuited thereto, the Government may, by notification—

- (a) withdraw the operation of that provision from the panchayat;

- (d) any right, privilege, obligation or liability acquired, accrued or incurred by the Gram Panchayat of any of the Gram Sabhas amalgamated under section 364 shall be deemed to be the right, privilege, obligation or liability acquired, accrued or incurred by the Gram Panchayat of the new Gram Sabha.

Effect of splitting up. 364 s

368. (1) On the issue of a notification under section 364 splitting up a Gram Sabha into two or more Gram Sabhas the following consequences shall ensue, namely:—

- (a) all rules, byelaws and orders in force in the area of the original Gram Sabha immediately before such Gram Sabha is splitted up under section 364 shall continue to be in force in the areas comprised in the new Gram Sabhas, until altered, amended or cancelled in accordance with the provisions of this Act;
- (b) all powers and duties which are under this Act to be exercised or performed by the several authorities under this Act shall, until a Gram Panchayat is constituted for each of the new Gram Sabhas be exercised and performed by the Collector or such other officer not below the rank of a Tahsildar as he may direct:
- (c) all property vested in the Gram Panchayat of the original Gram Sabha shall. subject to any orders of the State Government, be held and

expended by the Collector for the purposes of the local government of the areas of the new Gram Sabhas; and

(d) until Gram Panchayats are constituted in the new Gram Sabhas, the Collector shall be deemed to be the representative of the Gram Sabha of the original Gram Panchayat for the purposes of suing or being sued or continuing pending suits or proceedings by or again. the Gram Panchayat of the original Gram Sabha.

(2) On the day on which the Gram Panchayats are constituted in the new Gram Sabhas, the Collector shall hand over the administration to the Gram Panchayat of each such Gram Sabha in respect of area under its jurisdiction.

369. (1) The assets and liabilities of the Gram Pancha-Apportionment vat of the original Gram Sabha shall in accordance with of assets and the provisions of sub-sections (5) and (6) be apportioned  $\frac{1}{Gram}$  Sabha to the several Gram Panchayats of the new Gram Sabhas. split up.

(2) The prescribed authority shall report on the following matters, namely:—

- (a) the assets and liabilities of the Gram Panchayat of the original Gram Sabha;

(3) The report referred to in sub-section (2) shall be submitted to the State Government which shall publish it in such manner as may be prescribed.

(4) Any person interested may make a representation to Government in writing against the proposals made in the report within one month from the date of its publication.

(5) On the expiration of the period specified in subsection (4) the Government may take into consideration the report of the prescribed authority and the representations received, if any, and pass such orders in respect thereof as it deems fit.

(6) The orders of the Government on all such points shall be final and shall not be questioned in any court of law.

(7) The Government may by notification delegate its powers under sub-sections (3), (4), and (5) [and (6)] to an officer not below the rank of a [Commissioner] Collector.

Suits by or against Gram of Panchayats new Gram Sabhas.

(1) On matters covered by the decision of the 370. State Government under the preceding section, the Gram Panchayats of the new Gram Sabhas shall severally be deemed to be the representatives of the original Gram Panchayat for the purposes of suing and being sued or for continuing pending suits or proceedings by or against the Gram Panchayat of the original Gram Sabha.

(2) In respect of matters not covered by the decision of the State Government under the provisions of the preceding section, the Gram Panchavats of the new Gram Sabhas shall jointly be deemed to be the representatives of the Gram Panchayat of the original Gram Sabha for the purposes of suing or being sued or for continuing pending suits or proceedings by or against the Gram Panchayat of the original Gram Sabha.

(3) If any dispute arises between the Gram Panchayats of the new Gram Sabhas as regards their respective liability or claim under a decree or order, the matter shall be referred to the Government whose decision shall be final.

When under section 364 a new Gram Sabha is 371.constituted by amalgamation of two or more Gram Sabhas ployees of Gram or where two or more new Gram Sabhas are constituted by splitting up an existing Gram Sabha, the pay and allowances, pension and retirement benefits, if any, of all permanent officers and servants or other employees of the [amalgamated Gram Sabhas or Gram Sabha splitted] Gram Panchayats of the Gram Sabhas amalgamated or Gram Sabha splitted up shall be the pay and allowances, pension and retirement benefits as in force immediately before the date of amalgamation or splitting up, as the case may be.

#### Disestablishment of Gram Sabhas.

372.(1) The Government may, by notification, disestablish a Gram Sabha:

Provided that no such notification shall be issued unless a notice of the proposal inviting objections from the persons likely to be affected thereby by a date to be specified therein has been published in the Gazette and the objections. if any, received have been considered by the Government.

(2) On the issue of a notification under sub-section (1), disestablishing a Gram Sabha, the following consequences shall ensue, namely:-

- (a) the Panchas, Sarpanch, and the Upsarpanch [and members of the Gram Sabha, the members of Functional Committees and Panchas] of the Gram Panchayat shall vacate their offices:
- (b) all rules, byelaws and orders in force in the Gram Sabha area shall cease to apply thereto:
- (c) all the property including the Gram Panchayat fund shall vest in the Government, and the

- (e) every employee of the Gram Panchayat whether permanent or temporary, shall unless he is offered some other employment on terms similar to those in force be entitled to recover from the Government by way of compensation a sum equal to his existing pay and allowances for one month.

373. (1) The Government may, by notification, signi-Notification of fy its intention to alter the limits of a block by including intention to therein any local area in the vicinity thereof or by excluding of blocks. therefrom any local area comprised therein.

(2) Every such notification shall define the limits of the local area which is intended to be included in or excluded from a block.

(3) Any inhabitant of the area or areas affected by a notification under sub-section (1) may, if he objects to anything therein contained, submit his objection in writing to the Government within sixty days from the date of the publication of the notification and the Government shall take his objection into consideration.

(4) When sixty days from the date of the publication of the notification have expired and the Government has considered and passed orders on such objections as may have been submitted to it within the said period, the Government may, by notification, include the local area or any part thereof in the block or exclude it therefrom.

374. On the issue of a notification under sub-section Power of Gov-(4) of section 373, the State Government may make such ernment to issue consequential orders as it may deem fit in respect of — consequential order with

Where a notification under sub-section (4) of section 373 has been issued excluding any area from the block and including any such area in other block, the Government shall, after consulting the Janapada Panchayats of both the blocks frame a scheme to determine what portion of the assets and other properties vested in one Janapada Panchayat shall vest in the other Janapada Panchayat and in what manner the liabilities of the Janapada Panchayats shall be apportioned between the two Janapada Panchavats and such scheme shall come into force on the date of publication thereof in the Gazette.

## ALTERATION IN THE LIMITS OF DISTRICT

375-A. On the issue of a notification under the Madhya Consequences of alteration in limits of Pradesh Land Revenue Code, 1959 (20 of 1959) altering the district. limits of a district, the State Government may make such consequential orders as it may deem fit in respect of the constitution of the Zila Panchayat, apportionment of assets and liabilities thereof and other ancillary matters arising out of such alteration.

## CHAPTER XIX.—ESTABLISHMENT OF GRAM SABHA FOR AREAS CEASING TO BE MUNICIPALITIES, NOTIFIED AREA OR TOWN AREAS.

379. When any local area ceases to be a municipality, Effect of a notified area or a town area by virtue of a notification establishment of issued under the Municipal Law and immediately following Gram Sabha for such ceasation a Gram Sabha is established under section 4 ceases to be for such area, then, as from the date of the establishment Municipal Comof the Gram Sabha (hereinafter in this section referred to mittee, etc. as the sperified date) the following consequences shall ensue, namely:—

- (a) the Municipal Committee, Municipal Council, Municipal Board, Notified Area Committee or the Town Area Committee, as the case may be, shall cease to exist or to function;
- (b) there shall be constituted for the Gram Sabha an interim Gram Panchayat consisting of persons vacating office as members of the Municipal Committee, Municipal Council, Municipal Board, Notified Area Committee or the Town Area Committee and the President or the Vice-President of the Municipal Committee, Municipal Council, Municipal Board or the Notified Area Committee or the Town Area Committee, as the case may be, shall respectively be deemed to be the Sarpanch and Upsarpanch of the interim Gram Panchayat;
- (c) the unexpended balance of the Municipal Fund or the fund of the Notified Area or the Town Area [Fund] Committee and the property (including arrears of rates, taxes rents and fees) belonging to the Municipal Committee, Council, or Board or the Notified Area Committee or the Town Area Committee and all rights and powers which prior to such notification, vested in the Municipal Committee, Council or Board or the Notified Area Committee or Town Area Committee shall, subject to all charges and liabilities affecting the same, vest in the interim Gram Panchayat as the Gram Panchayat Fund until a new Gram Panchayat is constituted in pursuance of the provision of sub-section (1) of section 380:
- (d) any appointment, notification, notice, tax, order, scheme, licence, permission, rule, byelaw, or form made, issued, imposed or granted under the Municipal Law before the specified date in respect of such local area shall, so far as it is not inconsistent with the provisions of this Act, continue in force and be deemed to have been made, issued, imposed or granted in respect of the Gram Sabha until it is superseded

or modified by any appointment, notification, notice, tax, order, scheme, licence, permission, rule, bye-law or form made, issued, imposed or ganted under this Act;

- (e) all budget estimates, assessment, assessment list, valuation or measurement made or authenticated under the Municipal Law immediately before the specified date and in respect of local area shall be deemed to have been made or authenticated under this Act;
- (f) all debts or obligations incurred and all contracts made by or on behalf of the Municipal Committee, Council, Board or the Notified Area Committee or Town Area Committee immediately before the specified date and subsisting on the specified date shall be deemed to nave been incurred and made by the Gram Panchayat in exercise of the powers conferred on it by this Act;
- (g) all officers and servants in the employ of the Municipal Committee, Council or Board or the Notflied Area Committee or the Town Area Committee, as the case may be, immediately before the specified date shall be officers and servants of the Gram Panchayat under this Act and shall, until other provision is made in accordance with the provisions of this Act, receive salary and allowances and be subject to conditions of the service to which they were entitled or subject immediately before such date:
- Provided that it shall be competent to the Gram Panchayat, subject to the previous sanction of the Government, to discontinue the service of any officer or servant, who in its opinion, is not necessary or suitable to the requirement of the Gram Panchayat service after giving such officer or servant such notice as is required to be given by the terms of his employment and every officer or servant whose services are discontinued shall be entitled to such leave, pension, provident fund and gratuity as he would have been entitled to take or receive on being invalidated out of service as if the Municipal Committee, Council or Board or the Notified Area or the Town Area Committee in the employ of which he was, had not ceased to exist:
- (h) all proceedings pending immediately before the specified date before the Municipal Committee, Council, Board, Notified Area Committee Town Area Committee or anyother authority as the case may be, shall be deemed to be

transferred to and continued by the Gram Panchayat or such authority;

- (i) all appeals pending immediately before the specified date before the Municipal Committee, Council, Board, or the Notified Area Committee, or the Town Area Committee, as the case may be, shall, so far as may be practicable be disposed of as if such local area had not been included in the Gram Sabha when they were filed:
- (J) all prosecutions instituted by or on behalf of the Municipal Committee, Council, Board or the Notified Area Committee or a Town Area Committee and all suits or other legal proceedings instituted by or against such Municipal Committee. Council or Board or Notified Area Committee or Town Area Committee or any officer of such Municipal Committee or any officer of such Municipal Committee Council or Board, Notified Area Committee or Town Area Committee pending on the specified date shall be continued by or against the Gram Panchayat as if such local area had not been included in the Gram Sabha when such prosecutions, suits or proceedings were institcted.

380. (1) The Collector shall within a period not exce. Term of office eding one year from the date on which the interim panchayat interim Gram has been constituted under section 379 take steps to consti-Panchayat and tute a Gram Sabha and a Gram Panchayat for such area.

(2) The members of the interim Gram Panchayat shall hold office until the date immediately preceding the date of the first meeting of the new Gram Panchayat.

(3) Any vacancy in the office of the interim Panchayat shall be filled as soon as it conveniently may be, by appointment by the Collector.

(4) All arrears of taxes, tolls, fees rents and rates vesting in the interim Gram Panchayat shall notwithstanding that such rates, taxes and fees cannot be levied under this Act, be recoverable in the same manner as is provided for the recovery of taxes provided in this Act:

Provided that steps to recover arrear of taxes, tolls, fees, rents and rates shall be taken within a period of one year from the date on which they vest in the interim Gram Panchayat.

(5) In other respects the provisions of this Act shall, *mutatis mutandis* apply to the interim Gram Panchayat and its members.

# CHAPTER XX.—TRANSITORY PROVISIONS

Definitions.

- 381. In this Chapter—
  - (a) "Janapada area" means the area for which Janapada Sabha is constituted;
  - (b) "Janapada Sabha" means a Janapada Sabha constituted under section 4 of the Central Provinces and Berar Local Government Act, 1948 (XXXVIII of 1948);
  - (b-1) "Kendra Panchayat" means a Kendra Panchayat established under the Madhya Bharat Panchayat Act, 1949 (58 of 1949);
  - (c) "Mandal Panchayat" means a Mandal Panchayat established under the Madhya Bharat Panchayat Act, 1949 (58 of 1949);
  - (d) "Tehsil Panchayat" means a Tehsil Panchayat established under the Rajasthan Panchayat Act, 1953 (XXI of 1953).

Assumption of powers of administration.

of 382. (1) The State Government, may with a view to facilitate the transfer of the administration of local Government from—

- (i) Mandal Panchayats to Zila Panchayats; and
- (ii) Janapada Sabhas and Tahsil Panchayats to Janapada Panchayats:

require the Collector to assume from a date to be specified by a notification, the administration and functions of the Mandal Panchayat and Janapada Sabhas and Tahsil Panchayats functioning in the district.

(2) On the issue of notification under sub-section (1)—

- (a) notwithstanding the repeal of the Madhya Bharat Panchayat Act, 1949 (58 of 1949), the Central Provinces and Berar Local Government Act, 1948 (XXXVIII of 1948) and the Rajasthan Panchayat Act, 1953 (XXI of 1953), all the powers and duties which could, by or under the said Acts, or any other law for the time being in force, be exercised or performed by or on behalf of the Mandal Panchayat, the Janapada Sabha, or the Tahsil Panchayat shall, until the administration is taken over by the appropriate Panchayat authority under this Act, be exercised or performed by the Collector and such officers as the Collector may direct as if the said Act had, in respect of any such matter, not been repealed;
- (b) all the Panchas of the Mandal Panchayat, all the members of the Janapada Sabha, and the Tahsil Panchayat shall vacate or be deemed to have vacated their offices as such Panchas or members;

(c) all property vested in such Mandal Panchayat, Janapada Sabha or Tahsil Panchayat shall subject to any orders of the Government, be held and expended by the Collector for the purposes of the Local Government of the areas over which the Mandal Panchayat, Janapada Sabha or the Tahsil Panchayat had jurisdiction.

(3) On the date on which an appropriate Panchayat authority comes into existence under this Act, the Collector shall hand over the administration to such Panchayat authority in respect of the appropriate area and the notification issued under sub-section (1) shall thereupon cease to have effect in respect of such area.

383. (1) If, on the assumption of the administration Powers of Collecunder sub-section (1) of section 382, the Collector finds that for to suspend order passed or agreement entered into by the Mandal or agreement Panchayat, the Janapada Sabha or the Tahsil Panchayat entered into by after the date of the publication of the Madhya Pradesh Mandal Panchayat, Janapada Panchayats Bill, 1960 (17 of 1960) in the Madhya Pra-Sabha, Tahsil desh Gazette is prejudicial to the interest of the Pancha-Panchayat, etc. yat which is to succeed such Mandal Panchayat, Janapada Sabha or Tahsil Panchayat, as the case may be, he may suspend the operation of the order or agreement and make a report to the Government for its orders.

(2) On receipt of the report under sub-section (1), the Government may, notwithstanding anything contained in such order or agreement, pass such orders as it deems fit continuing, modifying or rescinding such order or agreement.

(3) No suit or proceeding for damages or compensation in respect of any order or agreement modified or rescinded under sub-section (2) shall lie against the Government, Mandal Panchayat, Janapada Sabha, Tahsil Panchayat or any of their officers.

384. (1) The assets and liabilities of the existing Apportionment Mandal Panchayat shall stand transferred to the zila of assets and Panchayat. liabilities.

(2) The assets and liabilities of the existing Janapada Sabhas and Tahsil Panchayats shall, in accordance with the provisions of sections 385 and 386 be apportioned to the several Janapada Panchayats that may be constituted in a Janapada Sabha area or a Tahsil Panchayat area.

385. The Government shall for each district constitute Constitution of a Board of three persons at least one of whom shall be an Board to report official. The Board shall, subject to such instructions as on apportionment may be issued in this behalf by the Government, report on of assets and the following matters :--

(a) the assets and liabilities of the Janapada Sabha and Tahsil Panchayat;

.

- (b) the apportionment of the assets and liabilities between the Janapada Panchayats of the blocks into which the district has been divided:
- (c) the manner in which the existing officers, servants and other permanent employees of the Janapada Sabha and Tahsil Panchayat should be absorbed by the Janapada Panchayat or otherwise, if necessary, superannuated or compensated ; and
- (d) generally, on all matters incidental, supplemental and consequential to the formation of the Janapada Panchayats in place of Janapada Sabhas and Tahsil Panchayats.

Consideration of Board's report by State Government.

386. (1) The report of the Board referred to in the preceding section shall be submitted to the Government which shall publish it in the Gazette and in such other manner as it may deem fit.

(2) Any person interested may make a representation in writing against the proposals made in the report within one month from the date of its publication.

(3) On the expiration of the period specified in subsection (2), the Government shall take into consideration the report of the Board and the representations received, if any, and pass such orders in respect thereof as it deems fit.

(4) The orders of the Government on all such points shall be final and shall not be questioned in any court of law.

(5) The Government may, by notification, delegate its powers under this section to any officer not below the rank of a Collector.

Suite by or 387. (1) On matters covered by the decision of the against Janapada Government under the preceding section, the Janapada Panchayat. Panchayats concerned shall severally be deemed to be the representative of the Janapada Sabha or Tahsil Panchayat, giving such officer or servant such notice as is required to or for continuing pending suits or proceedings by or against the Janapada Sabhas or the Tahsil Panchayats.

(2) In respect of matters not covered by the decision of the Government under the provision of the preceding section, all the Janapada Panchayats in a Janapada area or Tahsil shall jointly be deemed to be the representatives of the Janapada Sabhas or the Tehsil Panchayats, as the case may be, for the purposes of suing or being sued for continuing pending suits or proceedings by or against the Janapada Sabhas or Tahsil Panchayats.

(3) If any dispute arises between two or more Janapada Panchayats as regards their respective liabilities or claims under a joint decree or order, the matter shall be referred to the Government whose decision shall be final. 388. (1) Notwithstanding anything contained in this Savings as to exist-Act or any rule or bye-law made thereunder, the pay and the permanent emallowances, pension and retirement benefits of all permanent officers and servants or other employees of the Mandal Fanchayat, the Janapada Sabha or the Tchsil Panchayat on the date on which this Act comes into force shall be existing pay and allowances, pension and retirement benefits.

(2) All or any of the permanent officers, servants or other employees serving under a Janapada Sabha or Tehsil Panchayat immediately before the coming into force of this Act, may, notwithstanding anything in the terms of their appointment or their conditions of service, be required to serve in or in connection with the affairs of any Janapada Panchayat or if suitable arrangements cannot be made for their absorption in the same Tehsil, in other Tehsils.

(3) Notwithstanding anything in sub-section (1) or (2) it shall be competent to the Collector, subject to the previous sanction of the Government to discontinue services of any officer or servant of a Mandal Panchavat, Janapada Sabha or Tehsil Panchavat, who in his opinion, cannot, be suitably absorbed in any other local body or who is not necessary or suitable to the requirement of the Zila Panchayat or the Janapada Panchavat, as the case may be after giving such officer or servant such notice as is required to be given by the terms of his employment and every officer or servant whose services are discontinued, shall be entitled to such leave, pension, provident fund and gratuity as he would have been entitled to take or receive on being invalided out of service as if the Mandal Panchavat. Janapada Sabha or the Tahsil Panchavat in the employment of which he was, had not ceased to exist.

388-A. (1) In this section "Block Development Offi-Consequences in recer" means Officer appointed by the State Government as gard to Kendra Pansuch for a Community Development block.

(2) On the date of the coming into force of this Act, the administration and functions of a Kendra Panchavat, shall vest in the Block Development Officer of the Block in which the Kendra Panchavat is situate till a committee is constituted in accordance with the provisions of section 112-A.

(3) Notwithstanding the reneal of the Madhya Bharat Panchayat Act, 1949 (58 of 1949).—

> (a) all the powers and duties which could, by or under the said Act, or any other law for the time being in force, be exercised or performed by or on behalf of the Kendra Panchavat shall, until a committee is constituted under section 112-A, be exercised or performed by the Block Development Officer and such other officer as the Block Development Officer may direct as if the said Act had, in respect of any such matter not been repealed;

- (b) all the members including the office-bearers of Kendra Panchayat shall as from the date of the coming into force of this Act vacate or be deemed to have vacated their offices;
- (c) all property vested in such Kendra Panchayat shall, subject to any orders of the Government, be held and expended by the Block Development Officer for the purposes of the local Government of the area over which the Kendra Panchayat had jurisdiction.

(4) The provisions of sections 383, 387, 390, 391 and 392 shall, so far as may be, apply to Kendra Panchayat as they apply to Panchayats mentioned therein.

### CHAPTER XXI—REPEAL AND SAVINGS.

Repeal and Savings. 389. (1) The Central Provinces and Berar Panchayats Act, 1946 (1 of 1947), the Central Provinces and Berar Local Government Act, 1948 (XXXVIII of 1948), the Madhya Bharat Panchayat Act, 1949 (58 of 1949), the Vindhya Pradesh Gram Panchayat Ordinance, 1949 (XXI of 1949), the Bhonal State Panchayat Raj Act. 1952 (II of 1953) and the Rajasthan Panchayat Act, 1953 in its application to. Sironj region are hereby repealed :

Provided that the repeal shall not affect—

- (a) the previous operation of the repealed Act or Ordinance or anything duly done or suffered thereunder ; or
- (b) any right, privilege, obligation or liablity acquired, accrued or incurred under the repealed Acts or Ordinance; or
- (c) any penalty, forfeiture or punishment incurred in respect of any offence committed against the repealed Acts or Ordinance ; or
- (d) any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability, penalty, forefeiture or punishment as aforesaid;

and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such negative forfeiture or punishment may be imposed as if this Act had not been passed :

Provided further that, subject to the preceding proviso, anything done or any action taken (including any appointment or delegation made, notification, notice, order, instruction or direction issued, rule, regulation, form, bye-law or scheme framed, certificate obtained, patent, permit or licence granted, registration effected, tax imposed or fees or rates levied) under the repealed Acts and Ordinance shall, in so far as it is in force immediately before the coming into force of this Act and is not inconsistent with the provisions of this Act, be deemd to have been done or taken under the corresponding provision, of this Act and shall continue to be in force accordingly, unless and until superseded by anything done or any action taken under this Act.

Explanation I.—For removal of doubt it is hereby declared that any rules or bye-laws made or anything done under the repealed Acts or Ordinance shall not be deemed to be inconsistent with the provisions of this Act merely on the ground that the procedure followed in making such rules or byelaws or doing such thing was different from that prescribed under this Act.

Explanation II.—Where any authority specified by or under the repealed Acts, ceases to exist after the commencement of this Act, the powers exercisable by such-authority under the repealed Acts, shall, for the purposes of this Act, be exercisable by such authority as the State Government may, by notification, specify in this behalf and the cases pending before the first mentioned authorities shall, on such notification, stand transferred to the authorities mentioned in such notification and be disposed of in accordance with the provisions of the repealed Acts.

(2) Notwithstanding anything in this Act,—

- (a) in the Mahakoshal region—
  - (i) all Gram Panchavats, Nyaya Panchavats, Adimjativa Panchavats and Pargana Panchavats established and constituted under the Central Provinces and Berar Panchayats Act 1947 (I of 1947) shall be deemed to be Gram Panchavats Nyaya Panchavats, Adivasi Panchavats and Pargana Panchavats respectively duly established and constituted under this Act ;
  - (ii) the Sarpanch. Upsarpanch and the Panchas of Gram Panchavats and the Chairman, Deputy Chairman and the Panchas of Nyaya Panchavats and the Panchas and Sarpanchas of the Adimiadiya Panchavats and Pargana Panchavats shall continue to function Sarpanch, Upsarpanch and Panchas of Gram Pradhan. Un-Pradhan and Panchavats and members Nyava Panchavats of and Panchas and Samanchas of Adivasi Punchavats and Pargana Panchavats for a period of one year from the date of coming into force of this Act or till such further period not exceeding one year in the aggregate as the State Government may from time to time by notification, specify; and
  - (iii) any vacancy occuring in the office of the office bearers mentioned in sub-clause (ii) during the period specified therein shall be filled in the manner provided in the repealed Act;
  - b) in the Madhya Bharat region :----
    - (i) all Gram Panchavats and Nyaya Panchayats [and Kendra Panchayats] established and

constituted under the Madhya Bharat Panchayat Act, 1949 (58 of 1949) shall be deemed to be Gram Panchayats and Nyaya Panchayats [and Janapada Panchayats] respectively duly established and constituted under this Act;

- (ii) the Gram Sarpanch, the Gram Upsarpanch and the Gram Panchas; the Nyaya Sarpanch and the members of a Nyaya Panchayat, and the Kendra Sarpanch, Kendra Upsarpanch and Kendra Panchas] shall continue to function as Sarpanch, Uusarpanch and Panchas of the Gram Panchayat; Pradhan and Panch of the Nyaya Panchayat [and President, Vice-President and members of the Janapada Panchayat] respectively for a period of one year from the date of coming intc force of this Act or till such further period not exceeding one year
  - in the aggregade as the State Government may from time to time by notification, specify; and
- (iii) any vacancy occurring in the office of any office bearers mentioned in sub-clause (ii) during the period specified therein shall be filled in the manner provided in the repealed Act ;
- (c) in the Vindhya Pradesh region:---
  - (i) all Gram Sabhas, Gram Panchayats and Nyaya Panchayats established and constituted under the Vindhya Pradesh Gram Panchayat Ordinance, 1949 (XXIV of 1949) shall be deemed to be duly established and constituted under this Act ;
  - (ii) the Sarpanch. Up-Sarpanch and members of Gram Sabha. the Pradhan. Up-Pradhan and members of Gram Panchavat and Sarpanch and Panchas of a Nyava Panchavat shall continue to function as Sarpanch. Upsarpanch and members of the Gram Sabha, the Sarpanch, Up-sarpanch and Panchas of a Gram Panchavat and the Pradhan and members of the Nyava Panchavat respectively for a period of one year from the date of coming into force of this Act or till such further period not exceeding one year in the aggregate as the Government may from time to time by notification, specify;
  - (iii) any vacancy occurring in the office of the office bearers mentioned in sub-clause (ii) during the period specified therein shall be filled in the manner provided in the repealed Ordinance;

- (d) in the Bhopal region-
  - (i) all Gaon Sabhas, Gaon Panchayats and Nyaya Panchayats established and constituted under the Bhopal Panchayat Raj Act, 1952
     (2 of 1953) shall be deemed to be Gram Sabhas, Gram Panchayats and Nyaya Panchayats, respectively duly established and constituted under this Act;
  - (ii) the Pradhan, Up-Pradhan and members of the Gaon Sabhas and Gaon Panchayats and Sarpanch and Panchas of Nyaya Panchayats shall continue to function as Sarpanch, Upsarpanch and members or Panchas of the Gram Sabha or the Gram Panchayat, as the case may be, and Pradhan and Panchas of the Nyaya Panchayats, respectively for a period of one year from the date of the coming into force of this Act or till such further period not exceeding one year in the aggregate as the State Government may from time to time by notification, specify; and
  - (iii) any vacancy occuring in the office of any office bearer mentioned in sub-clause (ii) during the period specified therein shall be filled in the manner provided in the repealed Act; and
- (e) in the Sironj region-
  - (i) all Panchayats established and constituted under the Rajasthan Panchayat Act, 1953 (XXI of 1953) shall be deemed to be Gram Panchayats and in respect of administration of justice to be Nyaya Panchayats duly established and constituted under this Act;
  - (ii) the Sarpanch, Upsarpanch and Panchas of the Panchayats shall function as such and in respect of the functioning as Nyaya Panchayat as Pradhan, Up-Pradhan and members of Nyaya Panchayat for a period of one year from the date of coming into force of this Act or till such further period not exceeding one year in the aggregate as the State Government may from time to time, by notification, specify; and
  - (iii) any vacancy occurring in the office of any office bearer in sub-clause (ii) during the period specified therein shall be filled in the manner provided in the repealed Act.

(3) All references made in any Act, Rules, Order or other instrument to the Acts and Ordinance repealed under sub-section (1) shall be read as if made to this Act.

(1) All debts and obligations incurred, all 390. contracts entered into with and all matters and things engaged to be done by or for the bodies mentioned in subsection (2) of section 389 before the date of coming into force of this Act shall be deemed to have been incurred. entered into with or engaged to be done by, or for, the bodles deemed to be established or constituted under this Act.

(2) All rates, taxes, and sums of money due to the bodies aforesaid immediately before the date of coming into force of this Act shall, as from the said date, be deemed to be due to the bodies deemed to be established and constituted in their place under this Act.

(3) All assets including the unexpended balance of the fund of the bodies aforesaid on the date of coming into force of this Act shall as from the said date, vest in the bodies deemed to be established or constituted in their place under this Act.

(4) All suits or other legal proceedings, civil or criminal, instituted by or against the bodies aforesaid may be continued by or against the bodies deemed to be established or. constituted in their place under this Act.

All employees belonging to or under the control 391. of the bodies mentioned in section 389 immediately before the date of coming into force of this Act shall be deemed to be the employees of the bodies deemed to be established and constituted in their place under this Act:

Provided that the terms and conditions of service of such employees shall not until altered by a competent authority, be less favourable than those admissible to them while in service of the bodies aforesaid.

392.Every suit, case or other proceeding pending and proceedings. before any body mentioned in sub-section (2) of section 389 before the date of coming into force of this Act shall as and from such date be heard and disposed of by the body deemed to be established and constituted in its place under this Act.

> 393. If any difficulty arises in giving effect to the provisions of this Act, the State Government may, by order, do anything not inconsistent with the provisions thereof which appears to it to be necessary or expedient for the vurpose of removing the difficulty.
