n the last day of the just concluded session of the two Houses, Karnataka legislators gifted themselves hikes in salary, perks and allowances without batting an eyelid. The Karnataka Legislature Salaries, Pensions and Allowances (amendment) Bill-2022 and the Karnataka Ministers Salaries and Allowances (amendment) Bill-2022 were passed by a voice vote amid the din raised by the Opposition Congress party members who staged a dharna. The bill added an extra feather to their cap with salaries and attendant allowances set to go up automatically every five years from now onwards.

The salary hike is a ritual that usually comes on the ultimate day of the session. Symbolic protests by members of the Left-if any of them are left at allhave marred the otherwise consensual decisions. But finally, everything ends on a happy note.

Everyone knows that legislators hold the state kitty in their hands and are entitled to gift themselves whatever they deem fit for the work they do. And they obviously feel no prick of conscience while awarding themselves benefits no ordinary Indian can even

The hike in monthly salary is understandable from Rs. 50,000 to Rs. 75,000 for the Chief Minister and from Rs. 25,000 to Rs. 40,000 for legislators. But the enhancement of house rent, house maintenance allowance, guest allowance, sumptuary allowance, travel allowance, and above all, raising of the monthly entitlement of petrol from 1,000 litres to 2,000 litres per month for ministers, is sure to raise eyebrows

Not to be missed is the point that there is no bar on many of them carrying on their professions as lawyers, journalists or chartered accountants during their non-session days. One wonders if a common Indian can dream of even a fraction of such hikes these rich lawmakers have approved for themselves without

Of late, the average duration of Legislature sessions has been dipping constantly. It is well below 70 days annually in most of the states.

Of the few days that legislators are supposed to meet and debate, much gets wasted in sparring, adjournments, closure of business after the customary obituary references, weekends, and pandemonium

Should not legislators be accountable for loss of precious transactional hours and the lack of business expected of them?

It is also pertinent to ask if the legislators can decide for themselves what they need to be paid and allowed to carry home as perks. A democratic polity without such scrutiny is likely to attract erosion of public trust and credibility.

Post-pandemic resilience of Indian agri exports

Agri exports have been increasing in the post-pandemic period. Concerted efforts are needed for sustaining the pace of growth and for creating a name for Indian agri products in global markets

During the pandemic, economic activity, especially trade flows across the globe, have been affected adversely. It is amply clear now that while there has been contraction of overall merchandise trade, global agri trade has remained much more resilient during the pandemic year 2020-21. In the case of India also, the figures indicate an increasing trend in value of agri exports during 2020-21. India has managed to remain integrated with global agri markets since the outbreak of the pandemic and benefited from this integration.

Rise in agri exports in 2020-21

The value of agri trade including agri and allied products in rupee terms which was around 2.52 lakh crores in 2017-18 and 2.75 lakh crores in 2018-19, dropped to around 2.52 lakh crores in 2019-20 due to lockdowns, but rose to around 3 lakh crores in the post lockdown period of 2020-21. This indicates that the pandemic created opportunities for our exports of agri products. It also underlines the need to maintain the pace of increase in exports for achieving the target relating to export growth.

 $Major\ commodity\ groups\ that\ led\ the$ growth in agri exports are food grains, spices, sugar, oilseeds sector products and horticultural products. Marine products and buffalo meat which were major items in the export basket till 2018-19 however registered a decline in the year 2019-20 and their exports could not reach earlier levels by 2020-21. Under food grains, though basmati rice has been the major item of export traditionally, exports of non-basmati rice have registered an increase after March 2020 as compared to the corresponding period of the previous year. As per the Agricultural and Processed Food Exports Development Authority (APEDA) data, our exports of non-basmati rice to a number of countries, including China, increased steeply. Wheat exports have risen by a massive 800 percent (over a small base) in value over the previous year, with Bangladesh accounting



and during the covid period as well. Other smaller commodity istered considerable increase are horticultural and oilseed sector products.

Weaker supply chains

This rise in agri exports immediately after the complete lockdown is attributed to opportunities that the pandemic created for Indian agricultural exports to developing and a few developed countries, many of which were adversely affected due to the pandemic-enforced weaker supply chains. Adverse weather conditions in countries like China was another reason for higher demand. Shipments of cereals were sent to a number of new countries besides the regular destinations.

Our production in this period was adequate for supporting the incremental demand. Estimates for the years 2019-20 and 2020-21 show an increase in the production of all major commodity groups. Our food grain production has crossed record 300 million tons mark in 2020-21 and production of other commodity groups such as oilseeds, sugarcane and some horticultural commodities has also recorded an increase

Looking ahead

Maintaining an overall stable export policy regime to provide incentives to agri exporters is essential. Arbitrary usage of trade instruments such as export bans and higher level of minimum export price of the commodity to be exported has frequently been observed, especially in case of commodities such as onion. The major objective of the government behind these has been managing the demand and supply imbalance and price levels in the domestic economy. These trade policy tools are often the easiest macro policy options available in the short run. However, this leads to disruption of exports and loss of trust in the international markets.

Apart from this, sustained efforts by government and non-government institutions are necessary for establishing Indian products in newly created forfor 50 percent of total wheat exports. trends pose is whether these would be eign markets for various agri commodi-Export of sugar as well as spices has sustained in the post-pandemic period ties such as food grains and for creating

segments such as horticultural and oilseed sector products. Diversification of the agri export basket by tapping the diverse production basket is also vital.

Efforts at increasing our exports would be fruitful when farmers are integrated into the global value chain to reap the benefits of international prices. One way to integrate small farmers with the value chain is by participating in collectives - cooperatives, companies, other organisations - that reduce the cost of marketing and improve bargaining strength. Such institutional mechanisms should be promoted. Supporting farmers for improving quality and for complying with global sanitary and phytosanitary standards is essential, particularly for perishable horticultural and livestock products. Connecting farmers to digital technologies for providing extension services and market intelligence is also required.

As suggested by the High Level Advisory Group on trade related issues, projecting demand and prices of commodities in future for appropriate sowing decisions needs to be promoted. Also, providing market intelligence to the agri exporters for supplying products to international markets facing shortages and for tapping new opportunities opened up due to the pandemic is critical. As recommended in the Agri Export Policy 2018, analysis of existing export-oriented infrastructure across value chains would be helpful for creating robust infrastructure for promoting agri exports. The recently announced budget for the year 2022-23 has focussed on the creation of rural infrastructure and delivery of digital and hi-tech services to farmers. This is expected to increase connectivity of the farmers with markets and reduce their costs. Also, initiatives such as promotion of usage of drones for agri activities, promotion of nutri cereals, funding for agri start - ups and processing activities and support to the FPOs are expected to increase various agricultural activities and strengthen supply chain for agri

Honouring black historical figures

Every year since 2016, a majority of congressional Democrats have published Facebook or Twitter posts recognizing Black History Month

growing share of congressional lawmakers have taken to social media each February to commemorate Black History Month, according to a Pew Research Center analysis of their Facebook and Twitter activity. Nearly two-in-three members of Congress (64%) mentioned Black History Month on Facebook or Twitter in February 2021, up from just 29% in 2015.

Previous research by the Center has found that Democratic lawmakers are more likely than Republicans to mention the #BlackLives-Matter hashtag on social media. The new analysis finds that Democrats are also more likely than their GOP counterparts to discuss Black History Month on social media.

In every year since 2016, a mahave published Facebook or Twit-

percentage points between 2020 and 2021, with 91% of Democratic lawmakers doing so last February. By contrast, fewer than half of congressional Republicans have mentioned Black History Month in each year since 2015. But that share has also risen substantially over that time period, including an increase from 29% to 36% between 2020 and 2021.

Black members of Congress have produced a sizable share of such posts in recent years. While Black lawmakers have accounted for 9% of members of Congress in the last two years, they accounted for a combined 35% of members' posts mentioning Black History Month in February 2020 and 2021. Black members of Congress are overwhelmingly Democrats.

When it comes to the specific language used in lawmakers' posts about Black History Month, "celjority of congressional Democrats ebrate" and "honor" have been two of the most commonly used ter posts recognizing Black History substantive terms. In addition to examining the terms used in lawmakers' posts about Black History Month, Pew Research Center identified the individuals, both historical and contemporary, who were referenced by the largest number of lawmakers in these posts. years also included the civil rights leader Martin Luther King Jr., abolitionists Frederick Douglass and Harriet Tubman, and Shirley Chisholm, the first Black woman in Congress

Other historical figures have been mentioned in these posts in response to recent events. For instance, NASA mathematician Katherine Johnson – who died on Feb. 24, 2020 - was the third mostmentioned figure in February 2020. And in 2021, the most-mentioned figures included Kamala Harris, who had recently been elected vice president, and John Lewis, a civil rights leader and member of Congress who had died in July 2020.

Members of Congress also differ by party when it comes to which individuals they have mentioned in their social media posts honouring Black History Month. Many

als appearing in the top 10 in both members. This includes references to individuals killed by police and whose deaths helped set in motion the 2020 Black Lives Matter protests, such as George Floyd (referenced by six Democrats and no Republicans in posts about Black History Month in February 2021) and Breonna Taylor (mentioned by three Democrats and no Republicans that month). Republicans, in turn, have often referenced Reconstruction-era Black politicians who served in Congress as Republicans, such as Hiram Revels (mentioned in 2020) and Joseph Rainey (in 2021). GOP lawmakers have also referenced contemporary conservative political or legal figures who are Black. Supreme Court Justice Clarence Thomas, for example, was mentioned by six Republican members of Congress in posts about Black History Month in February 2020 and February 2021 combined, but by no Democrats.
